FROM so-called Doomsday planes to Vladimir Putin's top secret nuke briefcase, there are signs Russia could be preparing to spark a nuclear World War Three.

[Putin](#) has already [warned he will use nuclear weapons](#) against the West if anyone interferes in [Ukraine](#) - but Britain has downplayed the [Russian](#) warnings as "bravado".

The spectra of [nuclear war](#) has loomed over the Ukraine conflict after Putin's war machine was crippled by the fierce Ukrainian resistance - sparking fears the tyrant could use nukes to break the deadlock.

But UK defense secretary [Ben Wallace](#) has tried to pour cold water on the growing fears, describing the situation as a "battle of rhetoric".

He told BBC Breakfast: *"This is predominantly about Putin putting it on the table just to remind people, remind the world, that he has a deterrent."*

Although experts said the chance of Putin using nuclear weapons to spark a world war is unlikely, there are signs Putin could be preparing to start a nuclear conflict.

DOOMSDAY PLANES

One of Putin's special [so-called Doomsday planes](#) for use in the event of a nuclear war with the West has been seen flying around Moscow in recent days.

A chilling video showed the Ilyushin Il-80 passing low over the outskirts of the capital.

The windowless Il-80 is one of four planes designed to act as a flying Kremlin in the sky in the event of a nuclear attack.

Putin would be able to rule Russia and issue commands to his military – including ordering nuke strikes - from the airborne command post.

The US equivalent are the Boeing E-4B planes based on the 747 airliner.



Putin boasted that his 'Satan 2' nuke missile can 'break through any defenses'.

Russian officials confirmed the aircraft will be showcased with a low fly past at Monday's annual Victory Day parade on Red Square - and it has been involved in "rehearsals" for the display.

The giant Soviet-era aircraft has not been seen at a Victory Day commemoration since 2010.

Its reappearance is a thought to be a sign Putin wants to send a warning message to the West.

NUCLEAR BRIEFCASE

Putin has also been spotted several times around what appears to be [Russia's secret nuclear briefcase](#).

Last month, he arrived at the Vostochny Cosmodrome via helicopter to visit a space port with Belarus dictator Alexander Lukashenko.

Putin arrived on the scene accompanied by his top military henchman who were seen carrying the alleged launch device - just days after it was [snapped at a state funeral](#).

The secret case is thought to contain the launch apparatus for the Kremlin's strategic missiles and its presence at the funeral is seen as a chilling threat to the world.

The bag, which has a personalized key code, is normally under 24/7 supervision and completely controls Moscow's nuclear arsenal.

It is reportedly supervised by an armed security officer who accompanies no-nonsense Putin wherever he travels.

The briefcase, called Cheget in Russian, was developed in the early 1980s and was shown to the world for first time in 2019, with its contents being viewed up close on TV.

According to local media, there are actually not just one but three in total.

Its visible presence in recent weeks is thought to be a chilling sign that the crazed Russian leader could deploy devastating nuclear weapons at any time.

STATE TV'S CHILLING THREATS

Russian state TV has [threatened to drown the UK](#) under a radioactive tsunami in a bizarre propaganda video.

In the chilling broadcast the presenter also showed how the Kremlin's latest world-ending Satan 2 nuclear missile could also annihilate Britain.

Brazen host Dmitry Kiselyov heralded Russia's second option to "plunge Britain into the depths of the sea" with its "underwater robotic drone Poseidon".

In a chilling graphic he warned the missile would raise a giant tsunami wave up to 1,640 ft. high mountain Scafell Pike in the Lake District - would contain "*high doses of radiation*" turning what is left of Britain into a "*radioactive desert*".

His threat was based on the "baseless" claims from Russian state media in the past week that [Boris Johnson](#) had threatened to carry out a nuclear strike on Russia without consulting NATO.

Downing Street dismissed this as "another example of disinformation peddled by the Kremlin".

'SATAN 2' NUKE TEST

Pro-Putin TV pundits have also previously threatened the use of the world ending [RS-28 Sarmat missile](#) – gleefully spouting its ability to wipe England from the map.

Putin boasted that his [apocalyptic "Satan 2" nuke missile](#) can "*break through any defenses*".

The tyrant said the world-ending RS-28 Sarmat would *"force those who try to threaten Russia to think twice"*.

The deadly projectile can fly over 11,000 miles, carry 15 warheads and has the potential to destroy an area the size of the United Kingdom in a single strike.

It's said to be the world's longest-range intercontinental ballistic missile.

The separate warheads are capable of detaching from the main 100-tonne missile before travelling towards their target at hypersonic speeds.

The bombs are 1,000 times more powerful than those dropped by the US on Hiroshima and Nagasaki in Japan during World War Two.

Putin said: *"The missile can break through all modern anti-missile defenses. There is nothing like this anywhere in the world, and won't be for a long time."*



Putin and his high command are reportedly based some or all the time in top secret nuclear bunkers.

NUKE BUNKERS

Putin and his inner circle were reportedly living in top-secret nuclear bunkers in March following the invasion of Ukraine.

The use of the high-security bunkers suggests Putin could be preparing to deploy nuclear weapons - a move that would lead to inevitable reprisal.

Movements of planes used by top Kremlin officials in March showed Putin might have been in a hideaway near Surgut in western Siberia.

For a period of time, Putin's defense minister Sergei Shoigu is said to have hidden out in a bunker near Ufa in the Urals, 725 miles east of Moscow, according to investigative journalist Christo Grozev.

The theory was backed by his daughter Ksenia Shoigu, 31, visiting Ufa for perhaps three days from March 22 as speculation was rife that the defense minister had suffered heart problems.

Grozev - who has links to British investigative outlet Bellingcat - said at the time: *"I am absolutely sure that Shoigu is in a bunker."*

"Tracking the movement of his plane, we see very frequent flights to Ufa. Knowing that there are also protected bunkers in this region, this gives an obvious answer about his place of residence."

He believes Putin is at another bunker elsewhere.

Previously there have been claims Putin had moved his close relatives to a bunker in the Altai Mountains - some 1,100 miles southeast of Surgut and 2,360 miles east of Moscow.

There are also claims that Putin took time out in the pandemic late last year to inspect emergency bunkers. In the past week, Russia's foreign minister Sergey Lavrov put out a truth bomb that will certainly raise the rhetoric about Russia to demonize Putin and the Russian state.

Whenever Sergey Lavrov tells the truth about the Jewish roots of Nazi Germany, or the Russian Jewish oligarchs holed up in Jerusalem, or Zelensky's Jewish ancestry and strong Nazi tendencies, or Netanyahu's genocide of the Palestinians, Israel predictably gets its britches in a twist.

Israeli Foreign Minister Yair Lapid condemned his Russian counterpart, Sergei Lavrov, for comments he made standing by Russia's claim that it invaded Ukraine in part to root out Nazism, dismissing Ukrainian President Volodymyr Zelenskyy's Judaism as irrelevant and suggesting that Adolf Hitler "had Jewish blood."

The Italian news channel Zona Bianca pressed Lavrov on the issue during an interview Sunday, asking him how Russian President Vladimir Putin can claim he is trying to "denazify" Ukraine when Zelenskyy is Jewish.

"So what if Zelensky is Jewish," Lavrov said, The Times of Israel reported. "The fact does not negate the Nazi elements in Ukraine. I believe that Hitler also had Jewish blood."

Lavrov went on to say that "some of the worst antisemites are Jews."

Lapid full-throatedly condemned Lavrov's remarks, calling them "unforgivable" and "outrageous."

"Foreign Minister Lavrov's remarks are both an unforgivable and outrageous statement as well as a terrible historical error," the Israeli foreign minister said. "Jews did not murder themselves in the Holocaust. The lowest level of racism against Jews is to accuse Jews themselves of antisemitism."

Israel's Ministry of Foreign Affairs announced that it had "summoned the Russian Ambassador to Israel for a clarification meeting with the Deputy Director-General for Eurasian Affairs."

The claim about Hitler's Jewish blood traces back to Hans Frank, who served as governor-general of Poland during the Holocaust, whose memoirs suggest that Hitler's paternal grandmother had been impregnated by a Jewish man.

It's entirely true that Israel will never tolerate hearing the truth that Adolph Hitler was the grandson of a wealthy Austrian Rothschild scion. Which makes him at least 25% Jewish... .. and a member of the Rothschild crime family.

Now here comes Lavrov pointing out these heretofore hidden truths about Hitler and everyone in Tel Aviv gets their britches in a knot.

Then, when Lavrov correctly states that Jewish Crisis Actor-in-Chief and Presidential Drama Queen Volodymyr Zelenskyy is overseeing the nazification of Ukraine, the Israeli Prime Minister goes ballistic, but not quite like Putin is going ballistic in the Ukraine.

However, in his nightly video address to his embattled nation, Zelensky said that these words had angered the world.

The Israelis reacted furiously to Lavrov's comments. Bennett called the historically debunked idea about Hitler's ancestry "lies" that *"are intended to accuse the Jews themselves of the most horrific crimes in history committed against them, thus freeing the responsibility from the oppressors of Israel."*

Foreign Minister Yair Lapid said that such implications are *"unforgivable,"* as *"Jews did not murder themselves in the Holocaust."* Yad Vashem head Dani Dayan called Lavrov's statement *"delusional"* and a *"blood libel."*

Lapid's ministry summoned the Russian ambassador for a *"clarification"* and demanded that Lavrov apologize. Instead, the Russian foreign ministry went even further in defending its top diplomat. In a Tuesday statement, it said that Lapid's statements were *"anti-historical"* and that *"the current Israeli government supports the neo-Nazi regime in Kyiv."*

Despite all the Israeli crying foul, Sergie Lavrov is historically correct and can be debunked all one wants, however, it does not change the truth!

Israel is now considering expanding the defensive aid it has sent to Ukraine so far. At the start of the war, it the Jewish state sent one-hundred tons of humanitarian supplies to the country and then ran a full field hospital for six weeks that treated thousands of sick and injured people until being shut down last Friday. Also, Israel recently answered a specific request for helmets and flak jackets for civilian rescue forces.

What a family feud this is. Epic! And it's all coming out in the wash for the whole world to see as the narcissistic megalomaniacs and warmongering psychopaths in Israel hyper-react to every radioactive truth bomb dropped by Russia.

The end goal of their conspiratorial plot was to establish the United Nations after World War II, which would then be used to unlawfully rubber stamp the founding of the Modern State of Israel after illegally forcing the Palestinians from their ancestral lands.

So, when the Israeli Foreign Minister incorrectly stated that *“Jews did not murder themselves in the Holocaust”* he is speaking with forked tongue ... and every Zionist leader in the world today knows it.

Unless one is a historian, particularly educated in German history, such as the Gestapo, which is unlikely common knowledge that the force behind Adolf Hitler, on behalf of the Illuminati, was the House of Rothschild, this Ashke**NAZI** “Jewish” bloodline which claims to support and protect the Jewish faith and people. In fact they use and sickeningly abuse the Jewish people for their own horrific ends. The Rothschild's, like the Illuminati in general, treat the mass of the Jewish people with utter contempt. They are, like the rest of the global population, just cattle to be used to advance the agenda of global control and mastery by a network of interbreeding bloodlines, impregnated with a Merovingian genetic code, and known to researchers as the Illuminati.

Indeed, the Illuminati are so utterly obsessed with bloodline, because of this obscured Merovingian bloodline, that there was no way that someone like Hitler would come to power in those vital circumstances for the Illuminati, unless he was of the reptilian bloodline. If you look elsewhere you will see how the same bloodline has held the positions of royal, aristocratic, financial, political, military, and media power in the world for literally thousands of years.

According to a book by a psychoanalyst, Walter Langer, called *‘The Mind of Hitler’*, not only was Hitler supported by the Rothschild's, he WAS a Rothschild. This revelation fits like a glove with the actions of the Rothschild's and other Illuminati bloodlines in Germany who brought Hitler to the fore as dictator of that nation. He was also supported

by the British Royal Family, the House of Windsor (in truth the German House of Saxe-Coburg-Gotha), and these included the British royal “war hero”, Lord Mountbatten, a Rothschild and a Satanist.

Their royal relatives in Germany, who you would never have thought would normally support an apparent guy from the street like Hitler, were among his most enthusiastic supporters. But, of course, they knew who he really was. There is no way in the world when you do any study of the Illuminati obsession with bloodline that Hitler would not have been one of them.

Langer writes:

“Adolf’s father, Alois Hitler, was the illegitimate son of Maria Anna Schicklgruber. It was generally supposed that the father of Alois Hitler (Schicklgruber) was Johann Georg Hiedler. There are some people who seriously doubt that Johann Georg Hiedler was the father of Alois... (an Austrian document was) prepared that proved Maria Anna Schicklgruber was living in Vienna at the time she conceived. At that time she was employed as a servant in the home of Baron Rothschild. As soon as the family discovered her pregnancy she was sent back home... where Alois was born.”

Langer’s information came from the high level Gestapo officer, Hansjürgen Koehler, published in 1940, under the title *“Inside the Gestapo”*. He writes about the investigations into Hitler’s background carried out by the Austrian Chancellor, Dollfuss, in the family files of Hitler.

Koehler actually viewed a copy of the Dollfuss documents which were given to him by Heydrich, the overlord of the Nazi Secret Service. The file, he wrote, *“caused such havoc as no file in the world ever caused before”* (Inside the Gestapo, pg. 143).

He also revealed that:

“..The second bundle in the blue file contained the documents collected by Dollfuss. The small statured, but big-hearted Austrian Chancellor must have known by such a personal file he might be able to check Hitler...His task was not difficult; as ruler of Austria he could easily find out about the personal data and family of Adolf Hitler, who had been born on Austrian soil... Through the original birth certificates, police registration cards, protocols, etc., all contained in the original file, the Austrian Chancellor succeeded in piecing together the disjointed parts of the puzzle, creating a more or less logical entity.”

A little servant girl... (Hitler’s grandmother)... came to Vienna and became a domestic servant, mostly working for rather rich families. But she was unlucky; having been seduced, she was about to bear a child. She went home to her village for her confinement... Where was the little maid serving in Vienna? This was not a very difficult problem.

Very early Vienna had instituted the system of compulsory police registration. Both servants and the employers were exposed to heavy fines if they neglected this duty.

Chancellor Dolfuss managed to discover the registration card. The little, innocent maid had been a servant at the...Rothschild mansion. ..and Hitler's unknown grandfather must be probably looked for in this magnificent house. The Dolfuss file stopped at this statement."

We know from military historical records that when Hitler invaded Austria, he went to Linz, Austria, the place where his birth records were on file. The Rothschild's and the Illuminati produce many offspring out of wedlock in their secret breeding programs and these children are brought up under other names with other parents.

Hitler, too, would have produced unofficial children to maintain his strand of the bloodline and there will obviously be people of his bloodline alive today.

So which Rothschild was the grandfather of Hitler? Alois, Hitler's father, was born in 1837 in the period when Salomon Mayer was the only Rothschild who lived at the Vienna mansion. Even his wife did not live there because their marriage was so bad that she stayed in Frankfurt. Their son, Anselm Salomon spent most of his working life in Paris and Frankfurt away from Vienna and his father.

Father Salomon Mayer, living alone at the Vienna mansion where Hitler's grandmother worked, is the prime, most obvious candidate. And Hermann von Goldschmidt, the son of Salomon Mayer's senior clerk, wrote a book, published in 1917, which said of Salomon:

"...by the 1840s he had developed a somewhat reckless enthusiasm for young girls.."

Let's return back to the events of the present time:

The Pentagon and NATO leadership have decided this war in the Ukraine must go on for years. Their plan is to pour oil on the flames and keep the fire raging. Also, Americans are going to have to cough up the dough for another massive aid package, with \$20 billion worth of weapons to keep the blood flowing. In total, this next package will cost the taxpayer \$33 billion. With Biden's proposed \$813 billion "defense" budget for 2023, the U.S. is spending more on the military and war now than ever before in the country's history.

NATO is set to expand again, bringing in Finland and Sweden. This will extend the alliance's border with Russia by greater than 800 miles and further stoke nuclear tensions, bringing the current brinkmanship to a whole new level. Moscow plans to respond including by increasing air and naval forces in the Baltic Sea and reinforcing its Kaliningrad exclave, which lies between NATO members Poland and Lithuania, with additional nuclear weapons and hypersonic missiles. Until 2004, it was unthinkable that NATO would ever expand to Russia's borders until that actually happened. Like most of our issues with Russia, it is all Bill Clinton and George W. Bush's fault.

Even as Russia's Foreign Minister Sergei Lavrov and other leaders in Moscow repeatedly warn of nuclear conflict and World War III, even directly comparing the current situation to the Cuban Missile Crisis, senior Pentagon officials say they are not concerned.

Nor do our all-knowing rulers appear concerned with the fact that they have "almost zero" ability to keep track of the myriad sophisticated weapons systems they are sending to Ukraine. CNN quoted briefed sources saying intelligence shows American arms are falling into a "big black hole." They say it's worth it.

Nor do they seem to be concerned with the Russians' warnings regarding how the West's weapons flood in Ukraine threatens to expand the war into NATO territory and destabilize Europe.

UK Foreign Secretary Liz Truss demands the West must "double down" on arms shipments, insisting particularly on "heavy weapons, tanks, airplanes—digging deep into our inventories, ramping up production. We need to do all of this."

Our top diplomat Antony Blinken says the plan is regime change in Moscow, much like his boss did in March with his Polish "gaffe." Ironically, the \$47 billion in weapons and other U.S. aid pledged to Ukraine these last two months will soon surpass the State Department's entire budget.

Secretary of Defense Lloyd Austin, former Raytheon board member, says the goal is to see Russia "weakened" to the point where it lacks even the capability to defend itself just outside its borders. As Pat Buchanan notes, this policy, whether it's intended to or not, pressures the Kremlin to more seriously consider pulling its nuclear trigger.

"We want to see Russia weakened to the degree that it can't do the kinds of things that it has done in invading Ukraine," Austin said with a clear eye toward increasing Russian casualties and the long term destruction of Moscow's conventional power.

Perhaps, Austin wants to cripple Russia so severely that his Pentagon can fight a war with China, the "most consequential strategic competitor and the pacing challenge for the Department," without having to worry so much about Moscow—deemed a second tier "acute" threat, albeit one armed with roughly 6,000 nukes—getting involved.

Austin's Raytheon pals are making a killing on this proxy war as well as the ancillary effects such as European NATO states, at long last, increasing their military spending.

As Ron Paul has written,

One group of special interests profiting massively on the war is the US military-industrial complex. Raytheon CEO Greg Hayes recently told a meeting of shareholders that, "Everything that's being shipped into Ukraine today, of course, is coming out of stockpiles, either at DOD or from our NATO allies, and that's all great news. Eventually we'll have to replenish it and we will see a benefit to the business."

He wasn't lying. Raytheon, along with Lockheed Martin and countless other weapons manufacturers are enjoying a windfall they have not seen in years. The U.S. has committed more than four billion dollars in military aid to Ukraine. They call it aid, but it is actually corporate welfare: Washington sending billions to arms manufacturers for weapons sent overseas.

By many accounts these shipments of weapons like the Javelin anti-tank missile (jointly manufactured by Raytheon and Lockheed Martin) are getting blown up as soon as they arrive in Ukraine. This doesn't bother Raytheon at all. The more weapons blown up by Russia in Ukraine, the more new orders come from the Pentagon.

Former Warsaw Pact countries now members of NATO are in on the scam as well. They've discovered how to dispose of their 30-year-old Soviet-made weapons and receive modern replacements from the U.S. and other western NATO countries.

There is scarcely a status quo to oppose. For weeks, escalations have continued apace. London has deployed SAS troops *in Kiev* to train Ukrainian troops on English anti-tank weapons. The U.S. is training Kiev's troops in Germany and two other secret locations in Europe on heavy artillery, radar systems, and armored vehicles. Washington is expanding intelligence sharing with Kiev for its war with Russia in the Donbas, providing howitzers, vehicles to carry them, and an additional 184,000 artillery rounds. Poland is sending tanks to Ukraine, Slovenia has a plan to send large numbers of T-72 battle tanks as well. The Germans will be supplying anti-aircraft tanks to Kiev and the Pentagon says an unidentified European ally is providing Ukraine with warplanes.

London's armed forces minister declared his government's support for Kiev's "*completely legitimate*" attacks inside Russia using British arms. This comes amid an uptick in reports of Ukrainian cross border drone and helicopter assaults including on Russian oil depots, residential areas, and villages. The U.S. and its European allies are implementing a long term policy that looks to exile Russia, looking toward a new world order where they no longer seek to "*coexist*" with Moscow.

London wants Europe to cut off all Russian energy "*once and for all,*" which would make war more likely, impoverish innocent people, and cause massive recessions.

The U.S., NATO, and Russian presence in the Mediterranean Sea has reached Cold War levels, as NATO builds new Eastern European battlegroups.

In March, NATO Secretary General Jens Stoltenberg warned that any "*use of chemical weapons would totally change the nature of the conflict, it would be a blatant violation of international law and would have far-reaching consequences.*" This weekend, legislation for a new Authorization for the Use of Military Force (AUMF) has been introduced by Congressman Adam Kinzinger (R-IL). Kinzinger's announcement calls the would be AUMF a "*clear red line,*" which would authorize Biden to deploy troops to Ukraine to fight Russians if Moscow should "*use chemical, biological, and/or nuclear weapons.*"

With the almost complete bipartisan Congressional support for the renewal of Lend-Lease and other anti-Russia, pro-war legislation, it is not outside the realm of possibility that this bill and its cynical redline trap becomes law.

For nearly two decades, Washington has funded “[biological research](#)” and other laboratories inside Ukraine. According to the head of the DoD’s Cooperative Threat Reduction Program, some of these labs may contain Soviet-era bioweapons.

First, most of what we know comes from the Russians who investigated the bio-labs that were abandoned following the invasion of Ukraine.

These are the people who uncovered the pathogens and other toxic substances that were kept at the 30-or-so facilities around the country. The Russian team has also studied the documents “*they received from employees of Ukrainian laboratories on the implementation of military biological programs of the United States.*”

In other words, the Russians have compiled evidence that the U.S. is violating its obligations under the terms of the Biological Weapons Convention.

Second, we know that the Pentagon –through various channels– pumped \$32 million into laboratories located in Kiev, Odessa, Lvov and Kharkov. These biolabs were chosen to oversee a “project aimed at studying the pathogens of the Congo-Crimean hemorrhagic fever, leptospirosis and hantaviruses.”

The Russians believe that interest in these pathogens is due to the fact “*their use can be disguised as natural outbreaks of diseases*”, which is why the project received additional funding. In other words, the Russians think that the US funding was mainly aimed at biological weapons development. The Chinese appear to agree with Russia on this matter. Here’s what China’s FM said:

“Chinese Foreign Ministry spokesman Zhao Lijian ... asked the U.S. to release “relevant details as soon as possible” regarding alleged US biological laboratories in Ukraine....“The US has 336 labs in 30 countries under its control, including 26 in Ukraine alone. It should give a full account of its biological military activities at home and abroad and subject itself to multilateral verification.”

“According to reports, in these facilities, large quantities of dangerous viruses are stored. Russia has found during its military operation that the US uses these facilities to conduct military plans. (“China... demands ‘full account of its biological military activities’, opindie.com)

You can see that there’s considerable concern among many of the countries the U.S. sees as its rivals. And, their concern is not limited to the fact that the U.S. is fooling around with all manner of highly-contagious and lethal pathogens but, also, that these

336 bio-labs are part of an integrated network under the operational control of the Pentagon. That is the biggest red flag of all!

The Russians have been quite blunt about what they think is going on. Here's a clip from their official statement: *"We believe that components of biological weapons were created on the territory of Ukraine."*

That sums it up perfectly. And they should know, too, after all, it's the Russians who uncovered the stockpiles of pathogens and the documentation that supports their analysis. Of course, all of this could just be more *"Russian disinformation"*, that's what the media would like you to believe. But what the media fails to acknowledge is that a lot of the documents gathered by the Russians have been signed by *"real officials and are certified by the seals of their organizations."* In other words, the Russians can verify their analysis with hard evidence.

Here's another excerpt from the Russian report that helps to shed light on what's really been going on at these Ukrainian virus factories:

"During the implementation of these projects, six families of viruses (including coronaviruses) and three types of pathogenic bacteria (pathogens of plague, brucellosis and leptospirosis) were identified. This is due to the main characteristics of these pathogens that make them favorable for the purposes of infection: resistance to drugs, rapid speed of spread from animals to humans, etc....."

A study of the documents in the part of the P-781 project on the study of ways of transmitting diseases to humans through bats showed that the work was carried out on the basis of a laboratory in Kharkov." (*"Russia Mod: Briefing on analysis of documents related to US military and biological activities in Ukraine"*, The Saker)

Nice, eh? So, the researchers at these facilities chose the pathogens that they believed were:

- The most infectious
- The most deadly
- The most drug resistant

When does it become appropriate to use a term like *"diabolical"*? Is that too much of a stretch? Here's more:

"Within the framework of the FLU-FLYWAY project, the Kharkov Institute of Veterinary Medicine studied wild birds as vectors for the spread of highly pathogenic avian influenza. At the same time, the conditions under which spread processes can become unmanageable, cause economic damage and pose risks to food security have been assessed."

“These documents confirm the involvement of the Kharkov Institute in the collection of avian influenza virus strains with high epidemic potential and capable of overcoming the interspecific barrier....” (“Russia Mod: Briefing on analysis of documents related to US military and biological activities in Ukraine”, The Saker)

Do you understand what they’re saying? The researchers were looking for ways to use migratory birds to transport lethal pathogens to the territories of Washington’s enemies. This is beyond diabolical. It’s Satanic.

The Russian report goes on to explain how much of the documentary evidence of potentially-criminal activity was destroyed following Russia’s invasion. Check it out:

“The materials that our Defense Ministry got hold of prove that all serious high-risk research in Ukrainian biolabs was directly supervised by U.S. experts... Our Defense Ministry reports that at this moment the Kiev regime.... hastily covers up all traces so that the Russian side could not get hold of direct evidence of the U.S. and Ukraine violating Article 1 of the BTWC.” They rush to shut down all biological programs.

Ukraine’s Health Ministry ordered to eliminate biological agents deposited in biolabs starting from February 24, 2022. We infer from the instructions to lab personnel that the order of elimination of collections suggested that they should be destroyed irrevocably. Having analyzed the destruction certificates, we can say that the Lvov lab alone destroyed 232 containers with pathogens of leptospirosis, 30 – of tularemia, 10 – of brucellosis, 5 – of plague.

“The total of more than 320 containers was eliminated. Pathogens’ titles and excessive amounts give reason to think that this work was done as part of military biological programs.” (“USNC biolabs in the Ukraine”, The Saker)

In other words, the Russian invasion triggered a mad-dash at the labs where these killer pathogens were being stored. Researchers had to quickly dispose of the evidence before the Russians arrived and figured out what was going on. The lab personnel were performing the same sketchy ritual as a serial killer who scrupulously wipes the bloody fingerprints off the murder weapon before the cops arrive.

In other words, they were *“covering their tracks.”* At the same time, the researchers were told to blame everything on *“Russian propaganda.”* (But you probably knew that already.)

Question— How have these bio-labs affected the lives of the people living in Ukraine?

According to the Russian MOD: *“... attention is drawn to the fact of a sharp increase in cases of tuberculosis caused by new multi-resistant strains among citizens living in Lugansk and Donetsk people’s republics in 2018. ..., more than 70 cases of the disease were detected, which ended in a rapid fatal outcome. This may indicate a deliberate*

infection, or an accidental leakage of the pathogen from one of the biolabs located on the territory of Ukraine.” (“Russian MOD”, The Saker)

So, a number of people who lived around these facilities mysteriously died from weird strains of tuberculosis and other oddball diseases, but we'll never know for sure whether the deaths were deliberate or not. And, naturally, the perpetrators of these crimes will never be held accountable. It's tragic.

Of course, it could all be a big coincidence, but I suspect not. I suspect that the Ukrainians are the unwitting lab rats in Uncle Sam's deadly science project. And there's more, too. Check out this blurb from Roscosmos CEO Dmitry Rogozin:

“It is also no secret to the leadership of our country that the purpose of these biological experiments conducted by the Pentagon using biomaterials obtained from Slavic subjects in Ukraine and other countries neighboring Russia is to develop ‘ethnic weapons’ against the Russian population of Russia.” (“Rogozin: Bioweapons developed in Ukraine...”, The Saker)

This idea that the U.S. is developing bio-agents that selectively target particular ethnic groups is a recurrent theme among critics of America's mysterious bio-projects. According to Chinese military expert, Song Zhongping, “The United States kept setting up biological laboratories around rival countries with the goal of developing targeted viral weapons against those countries...”

“The US insists on developing weapons of mass destruction to seek hegemony, which is a gross violation of the Biological Weapons Convention and an assault on human civilization.” Song Zhongping, a Chinese military expert. (“US shuns UN meeting on biological security”, Global Times)

And here's how author M.K. Bhadrakumar summed it up in a recent article titled *“Migratory Birds of Mass Destruction”*:

“Russia had released a number of documents related to the biological military activities of the Pentagon, which pointed toward a worldwide project to set up biological laboratories in rival countries with the goal of developing targeted viral weapons against those countries.”...

(According to) General Igor Kirillov, chief of the Radiation, Chemical and Biological Defense Forces of the Russian Armed Forces, *“that Washington is creating biological laboratories in different countries and connecting them to a unified system.” (“Migratory birds of mass destruction”, Indian Punchline)*

Finally, there is this from author Matthew Ehret who explains the probable origins of “ethnic targeting” with biological weapons. Here's what he said in an article at the Unz Review:

"The earlier October 2000 RAD document emphasized the importance which the neocon cabal placed on bioweapons ..stating: "Combat will likely take place in new dimensions: In space, cyber-space and perhaps the world of microbes..."

advanced forms of biological warfare that can "target" specific genotypes may transform biological warfare from the realm of terror to a politically useful tool". ("The Project for a New American Century and the Age of Bioweapons: 20 Years of Psychological Terror", Matthew Ehret, Unz Review)

Further along in the article, Ehret points to evidence that researchers may have achieved their goal of "selectively targeting particular ethnic groups." Here's the money-quote:

"...leading medical specialists like Dr. Shankara Chetti of South Africa, Dr. Soňa Peková of the Czech Republic) and Dr. Meryl Nass of the USA having delivered bountiful evidence that the various waves of the pathogen were not only NOT naturally occurring, but ethnic specific and lab-generated.

After evaluating over 7,000 patients, Dr. Chetty observed early on that the patients who suffered the greatest during each of the four waves encountered in South Africa were ethnic specific with the first wave targeting only blacks, the second only Indians and the third Caucasians and Arabs." ("The Project for a New American Century and the Age of Bioweapons: 20 Years of Psychological Terror", Matthew Ehret, Unz Review)

Is that where all this is headed: Ethnic specific bioweapons to help usher in the New World Order?

One can only wonder.

We're also curious about the fact that these 300-plus bio-labs (around the world) are part of a "unified system" that is under the Pentagon's control. What's that all about? Why would the Pentagon want a unified system of biological laboratories?

I can think of one reason, although I'm sure there are many more. Let's say, powerful elites wanted to change our democratic system to a more authoritarian model (The Great Reset) by creating a global crisis that could be used as a pretext for terminating personal freedom, enforcing mandatory vaccination and imposing martial law.

If they had a network of biological labs at their disposal, they could easily release the same-identical pathogen in locations around the world creating the perception of a rapidly-spreading virus. In other words, a widespread network of bio-labs could be used to simulate a global pandemic. Recall how quickly the Coronavirus Covid-19 spread so fast around the world!

Is such a thing even possible?

You bet it is, in fact, the last two years might provide us with an example of how the system actually works.

One last thing: The UN Security Council recently convened an emergency meeting to address the issue of Ukraine's biological labs. (Arria Formula Meeting on Biological Security.) But did anyone from the Biden administration attend the confab?

No one. The administration boycotted the meeting entirely, which means the U.S. was given the opportunity to make its case before the international community, but decided to pull a no-show instead.

Why would that be, we wonder?

A member of the Chinese delegation said it was a sign of a *"guilty conscience."*

That sounds about right to me.

As Dave DeCamp, news editor at *Antiwar.com*, has reported,

The Pentagon funds labs in Ukraine through its Defense Threat Reduction Agency (DTRA). According to [a Pentagon fact sheet released last month](#), since 2005, the U.S. has "invested" \$200 million in "supporting 46 Ukrainian laboratories, health facilities, and diagnostic sites."

Moscow has accused Ukraine of [conducting an emergency clean-up](#) of a secret Pentagon-funded biological weapons program when Russia invaded. [The World Health Organization said it advised Ukraine](#) to destroy "high-threat pathogens" around the time of the invasion.

For their part, the U.S. maintains that the program in Ukraine and other former Soviet states is meant to reduce the threat of biological weapons left over from the Soviet Union. While downplaying the threat of the labs, Pentagon officials have also warned that they could still contain Soviet-era bioweapons.

Robert Pope, the director of the DTRA's Cooperative Threat Reduction Program, told the [Bulletin of the Atomic Scientists](#) in February that the labs might contain Soviet bioweapons and warned that the fighting in Ukraine could lead to the release of a dangerous pathogen.

Much like previous Syrian redlines, this is practically the hawks' invitation to bad actors seeking U.S. intervention to go ahead and launch an attack that could be plausibly blamed on our Hitler du jour to manufacture their desired casus belli.

It seems there may be ample sites somebody could hit that would cross Kinzinger's cleverly drawn line in the sand. And much like the CIA, Turkey, and Saudi Arabia's al

Qaeda allies in Syria, the Azov Battalion and other Nazi groups, who have taken a humiliating beating thus far in the war, are prime candidates to launch a false flag.

If the American people do not wake up and demand an end to our government's intervention in Ukraine, the U.S. may be directly entering this war soon.

If Russia was doing what the U.S. and its allies are doing in Ukraine, in Mexico or Canada, in addition to the unprecedented economic war being waged, these hawks in D.C. would have pulled the aforementioned nuclear trigger months ago.

Russia has repeatedly denounced the continuous flow of weapons into Ukraine from the West, saying that it adds fuel to the fire and derails the negotiation process.

Russian Defense Minister Sergei Shoigu said that any NATO vehicle coming to Ukraine with weapons or equipment for Ukrainian forces will be considered a legitimate target for destruction.

"The United States and its NATO allies continue to pump weapons into Ukraine. I can confirm that any transport from the North Atlantic alliance that arrives in the country with weapons or materiel for the Ukrainian armed forces will be considered by us as a legitimate target for destruction," Shoigu said on Wednesday.

According to him, during the course of the special operation, the Russian servicemen have *"shown courage and bravery, honorably fulfilling their military duty, and ensuring the safety of the civil population of Donbass."*

Earlier, Moscow warned that the West's contribution of weapons to Ukraine threatens to undermine peace talks, not to mention the probability that they could fall into the wrong hands.

Since Russia launched its special military operation in Ukraine in February, the U.S., its NATO allies, and the European Union, have increased weapons supplies to Ukraine. On May 3rd the UK government announced that it will provide Ukraine with a \$375 million military aid package.

Recently, US President Joe Biden asked U.S. Congress for \$33 billion in emergency supplemental funding to support Ukraine, including \$20 billion for military assistance. The request comes on top of about \$4 billion in military aid the Biden administration has already earmarked for Ukraine, \$3.4 billion of which came after Russia launched its military operation in late February.

Amid weapons and military equipment deliveries there are discussions about the need to supply Ukraine with heavy weapons, tanks, war planes, etc. Although some countries, such as the UK, call for those kinds of supplies, others oppose the idea.

Earlier, German Chancellor Olaf Scholz said that the German military can no longer supply arms to Ukraine as the country's weapons stockpiles are practically exhausted.

In turn, Public support of German heavy weapons deliveries to Ukraine has shrunk to 46% from 55% two weeks ago and 60% in early April, with the number of critics rising by 10 percentage points, a poll out Tuesday showed.

On 28 April, Kremlin spokesman Dmitry Peskov said that the trend of delivering heavy weapons to Ukraine and other countries is threatening the security of the European continent.

The Russians are very dissatisfied with Israel over its past military cooperation with Ukraine, and Lavrov's statement was only the opening round. If we go back to the very first days of Russia's 'special military operation,' when they took control of the Zaporozhye nuclear power station and seized there documents relating to Ukraine's efforts to build a 'dirty nuclear weapon,' the Russian Ministry of Defense announced that there were foreign enablers active there. Then the next day, unexpectedly and in great haste, Israeli Prime Minister Bennett flew to Moscow for unscheduled talks with Putin. Almost nothing was disclosed about the subject of their talks. But subsequently the foreign enablers were never identified by the Russians.

For the past six months I have been looking for signs and words that would infer that the Ezekiel 38/39 scenario is getting close to the breaking point. I believe the early signs have come to fruition.

A spokeswoman for Russia's foreign ministry on Wednesday said Israeli mercenaries were fighting alongside the far-right Azov Regiment in Ukraine, further fueling tensions with Israel after Russia suggested Adolf Hitler had "Jewish blood."

"Israeli mercenaries are practically shoulder to shoulder with Azov militants in Ukraine," Maria Zakharova told pro-Kremlin Sputnik radio in an interview.

They have been fighting alongside the Ukrainian army against Russian troops, which on February 24 launched a military campaign in Ukraine to protect Russia's national security.

By suggesting that Israelis are fighting alongside Azov – viewed by Russia as fascists and Nazis, Moscow is escalating political confrontation that started after Russian Foreign Minister Sergei Lavrov said Sunday that Hitler had "Jewish blood."

His remarks sparked outrage in 'Israel', which called the statement "unforgivable and outrageous" and a "terrible historical error."

Russia's foreign ministry on Tuesday accused 'Israel' of backing "the neo-Nazi regime in Kiev." Ukraine's President Volodymyr Zelenskyy is of Jewish descent.

We should anticipate from this point going forward that the War of Gog and Magog will now pivot toward Israel. That said, it is beginning to look like Rapture time! There are several potential days between now and September 25/26th, 2022.

The simple fact is that the U.S. and NATO are not interested in peace but rather working to do “regime change” in Russia, and doing it in such a way as to risk hundreds of millions of lives to the consequences of nuclear war! This is disconcerting to anyone who values life at all.

In closing, PCR says, *“At some point, lightning is going to strike someone in the Kremlin, and they are going to say we are at war and this is World War III. It’s got to happen. Why isn’t it World War III? We are sending another \$33 billion to Ukraine.”*
