Most of us that are still watching and waiting for the Blessed Hope are saying "How much longer Lord?" I would simply say, not much longer as we take a close look at events happening currently. The insanity of the U.S. State Department and elements of the Pentagon are so obvious that a blind moron with glasses can see that the U.S. and NATO are poking the "Bear" a little too much!

Paul Craig Roberts posted an alarming report a few days ago that confirms what I have been saying for months:

"I seem to be the only prescient person on the foreign policy scene. But not Washington, not Europe, and not Russia are interested in what I have to say.

I said that it was a strategic mistake for the Kremlin to limit its military operation in Ukraine and to impose restraints on the military action that would drag out the process of Russian victory. I said this would wrongly convince the West that the Russian military wasn't as formidable as it is and give the West plenty of time to widen the war by becoming more and more involved.

With the cold shoulder the West gave to Russia's security concerns, I said nothing less than a lightening conquest of all of Ukraine and replacement of the U.S. puppet government with a Russian puppet government would convince the West that Russia's red lines were real and that Russia's security concerns had to be addressed.

It has happened as I predicted. The U.S. and NATO have become combatants in the conflict over Donbass, formerly part of Russia, by supplying weapon systems, military intelligence, volunteers, diplomatic support and money to Ukraine. The U.S. and NATO have clearly stated that they intend to keep the war going and that they support Ukraine's re-conquest of Donbass and Crimea.

Washington arranged for Lithuania, a NATO member, to block Russian access to part of Russia, Kaliningrad. With Turkey suitably paid to withdraw objection, NATO has invited two historically neutral countries, Finland and Sweden, to align with Washington against Russia and to join NATO. If Finland accepts, NATO will be positioned on another 832 miles of Russia's border. As preventing Ukraine's NATO membership and less NATO

presence on Russia's border was one reason for Russia's intervention in Ukraine, the intervention, despite Russia's victory in Donbass, was a loss for Russia's overall goal.

As I predicted would be the case, the limited and time-consuming Russian intervention in Ukraine is leading to a massive increase in Western military forces deployed against Russia. The NATO rapid response force is being expanded from 40,000 to 300,000. More squadrons of U.S. fighter aircraft are being sent to England. Moldova, Georgia, and Bosnia and Herzegovina are being prepped for NATO membership. I could add more to this story, but it is clear enough that I was exactly correct that the limited, go-slow Russian intervention was a strategic blunder which is encouraging the West to violate more Russian red lines. Considering Washington's commitment to hegemony and the obedience of Washington's European puppet states, surrender or a wider war that likely would turn nuclear are Russia's remaining alternatives.

As I have said, the Russians are babes in the woods. They do not understand the evil that they face. Apparently, they neither take the Wolfowitz Doctrine seriously nor the U.S. Government's Commission on Security and Cooperation in Europe's plan to break Russia up into a collection of independent small states, thereby removing Russia as a constraint on U.S. hegemony over a unipolar world.

The complete cold shoulder the West gave Russia's effort to achieve mutual security should have told the Kremlin something. But didn't. The U.S. has been building up "boots on the ground" to just over a hundred thousand since last fall. In a previous segment of the *Blessed Hope* series, I noted that the U.S. had delivered advanced elements of what would constitute two armored divisions and one mechanized division. Late 2021 saw the U.S. shipping to locations bordering southern Europe and nearby some 2,100 Abrams tanks and hundreds of M109 Paladin self-propelled 155mm artillery.

Bill introduced in Russia To Give Emergency Powers to Putin; Puts Defense Industry in "State of War"

Today, July 1st, 2022, a Bill has been introduced in the Russia legislature which will give President Vladimir Putin emergency powers, and will put the Russian Defense industry

on 24/7 "state of war' and lays the groundwork for a GENERAL MOBILIZATION conscription of the Russian people, for war.

The Bill makes reference to "military operations abroad" while also mentioning Ukraine, Luhansk and Donetsk.

Clearly, the intent of the Bill is to give President Putin legal authority to expand Russian military operations to outside of Ukraine, likely in response to hostile acts by Lithuania's blockading the Russian exclave state of Kaliningrad, and now Norway's blockage of food and supplies to Russian miners on the Svalbard Archipelago.

Lithuanian Prime Minister Ingrida Šimonytė said the country would continue to implement the terms of the EU's fourth package of sanctions against Russia and stop the transit of other goods through the Kaliningrad region from July 10, when the restrictions are due to take effect.

Knowing this would cause war-type trouble a Lithuanian Member of Parliament was brazen enough to warn Moscow - twice - not to abrogate the Treaty recognizing the independence of Lithuania in 1991! The member of the Seimas (Parliament) of Lithuania, Matas Maldeikis, asked Moscow to return to Vilnius "the ancestral lands of Smolensk".

In fact, he asked for it twice in June!

He said "If Russia revokes its recognition of Lithuania's independence in 1991, Lithuania will revoke the Polyanovka Treaty of 1634 and demand that Russia return all occupied territories to the Grand Duchy of Lithuania. Smolensk is Lithuania!"

The situation with external countries now making land claims against Russia while at the same time blockading the Russian exclave of Kaliningrad, has caused Russia lawmakers and the Russian leadership to see this as an organized NATO project, both in the Baltic and in the case of Norway, and is prepared to respond militarily if Lithuania doesn't remove the exclusions against Kaliningrad and Norway doesn't remove the blockade of food against Svalbard.

According to information, the Russian government has submitted a draft law in order for the executive branch, that is, the president of Russia and the Russian government, to receive special powers.

The bill was submitted to the State Duma.

Amendments to the Defense Law are proposed. The Russian government supplements the law with the article on "Ensuring the conduct of anti-terrorist and other operations by the Armed Forces of the Russian Federation, other troops, military formations and bodies outside the territory of the Russian Federation".

The explanatory note states that this includes, among other things, a "special military operation in the territories of Lugansk, Donetsk and Ukraine".

There will be nuclear war if we stay on this path. Almost every day, we get more news about how both sides are escalating the conflict in Ukraine. If the American people truly understood what was at stake, there would be giant protests in the streets of every major U.S. city right now. But they don't. Most of us are entirely convinced that our leaders can do whatever they want in Ukraine without sparking a nuclear war. But the Russians see things very differently. On Russian television there are endless discussions about how the war in Ukraine is really a proxy war between the United States and Russia, and pundits openly discuss the possibility that eventually nuclear weapons will be used. In fact, the destruction of specific U.S. cities has even been discussed on Russian television, but most Americans never hear anything about this.

In a nuclear conflict, the side that uses their weapons first has the best chance of surviving, and the Russians understand this very well.

If push comes to shove, the Russians won't hesitate to strike if they believe that nuclear war has become inevitable.

So we need to stop this madness while we still can.

Unfortunately, our leaders seem to have no interest in ending the conflict in Ukraine. Instead, they just keep doing things to raise tensions even higher.

This week, Joe Biden announced that the U.S. will be sending "thousands more troops" to eastern Europe...

America will deploy thousands more troops to Europe along with fighters, air defenses and ships, Joe Biden announced today, as NATO reinforces its eastern flank in a new Iron Curtain to protect the continent from Russia.

Joe Biden, speaking at a NATO summit in Madrid today, announced the creation of a new base for the U.S. Fifth Army Corps in Poland – the first permanent American base in the country – along with 3,000 extra soldiers to be sent to Romania and 'enhanced' troop rotations for the Baltic states of Estonia, Latvia and Lithuania.

This commitment from Biden is part of an overall NATO effort to increase the total number of "high readiness forces" in Europe to "well over 300,000"...

NATO will enhance its battle groups in the eastern part of the alliance up to brigade levels, NATO Secretary-General Jens Stoltenberg announced Monday.

"We will increase the number of high readiness forces to well over 300,000," he said at a news conference in Brussels.

This includes "more pre-positioned equipment and stockpiles of military supplies; more forward-deployed capabilities, like air defense; strengthened command and control, and upgraded defense plans with forces pre-assigned to defend specific allies," Stoltenberg added.

To the Russians, this looks like a potential invasion force.

Of course the Russians continue to do things to escalate the conflict as well. For example, Vladimir Putin just announced that the Russians will be putting "nuclear-capable ballistic missiles" in Belarus...

Russia plans to place nuclear-capable ballistic missiles in Belarus, a NATO-neighboring Russian ally that housed the forces that invaded Ukraine and attacked Kyiv.

That missile placement would continue a trend of Russian President Vladimir Putin subordinating Belarus to his vision of a "union-state" led by the Kremlin while sending an ominous signal to NATO — perhaps especially Poland and Lithuania, whose borders separate Belarus from Kaliningrad, the Russian exclave near the Baltic Sea.

"Our decision has been made: We will hand over a number of tactical missile systems Iskander-M to Belarus within the next few months," Putin said during a meeting with Belarusian dictator Alexander Lukashenko. "They can fire ballistic and cruise missiles with conventional and nuclear warheads."

The Russians have also suggested that Cuba may be a good location for missiles as well. If you know your history, that should set off some alarm bells. So much is happening right now, but most Americans are not paying attention.

At this point, the U.S. is providing more funding for the war in Ukraine than anyone else, more weapons for the war in Ukraine than anyone else, and more intelligence for the war in Ukraine than anyone else.

The Ukrainians are providing the dead bodies, but it is the U.S. that is really running the show.

And thanks to the 'New York Times', we have learned that CIA operatives have been secretly operating on the ground in Ukraine all throughout the war...

As Russian troops press ahead with a grinding campaign to seize eastern Ukraine, the nation's ability to resist the onslaught depends more than ever on help from the United States and its allies — including a stealthy network of commandos and spies rushing to provide weapons, intelligence and training, according to U.S. and European officials.

Much of this work happens outside Ukraine, at bases in Germany, France and Britain, for example. But even as the Biden administration has declared it will not deploy American troops to Ukraine, some C.I.A. personnel have continued to operate in the

country secretly, mostly in the capital, Kyiv, directing much of the massive amounts of intelligence the United States is sharing with Ukrainian forces, according to current and former officials.

But despite all the help that Ukraine has been getting from the United States, the Russians continue to take more ground just about every single day.

Instead of admitting that the Ukrainians are in a fight that they can't possibly win and looking for a peaceful way out, our leaders just keep upping the ante instead.

And at this point, Congress is going to give the Pentagon and the CIA literally everything that they want for the war in Ukraine...

"I don't think people realize that right now the spigot from Congress is fully open. Money, weps, intel, whatever they need," tweeted Jack Murphy, journalist and Iraq/Afghanistan vet. "The American public is not being appropriately informed about what our government is up to as basically every single op DOD/CIA proposes is getting the green light."

The only way that an overwhelming Russian victory can be prevented at this point would be for the United States to get far more involved in the war.

But if we keep getting deeper and deeper into this conflict, at some point the United States and Russia will start shooting at one another.

And once we reach that juncture, things could go nuclear very rapidly.

You may be thinking that there is no point in being concerned about a nuclear war because if one happens we will all be dead anyway.

If that is what you think, you are dead wrong.

Studies have determined that only about 20 percent of all Americans would be immediately killed by a full-blown nuclear exchange. Here is one example...

This full-scale nuclear war was estimated to cause 770 million direct deaths and generate 180 Tg of soot from burning cities and forests. In the U.S., about half the population would be within 5km of a ground zero, and a fifth of the country's citizens would be killed outright.

But that doesn't mean that most of us would survive.

Ultimately, the vast majority of the population would slowly starve to death. A full-blown nuclear exchange would cause a "nuclear winter" and very little food would be able to be grown for an extended period of time...

A subsequent study, published in 2019, looked at a comparable but slightly lower 150 Tg atmospheric soot injection following an equivalent scale nuclear war. The devastation causes so much smoke that only 30-40 percent of sunlight reaches the Earth's surface for the subsequent six months.

A massive drop in temperature follows, with the weather staying below freezing throughout the subsequent Northern Hemisphere summer. In Iowa, for example, the model shows temperatures staying below 0°C for 730 days straight. There is no growing season. This is a true nuclear winter.

So it could be argued that those that are wiped out during a future nuclear exchange will actually be the lucky ones.

Could you imagine the horror of watching your family slowly starve to death in a world that has gone completely mad?

We must not let things get to that point.

We need to try to find a peaceful solution to the conflict in Ukraine while we still can.

Unfortunately, Joe Biden has surrounded himself with the worst foreign policy team in U.S. history, and they seem to have ruled out trying to find a way to have peace with the Russians.

So we continue to steamroll toward a nuclear cataclysm, and very few of us even seem interested in changing course.

My favorite news journalist George Eaton follows below with a real eye-opening op ed piece.

"It doesn't look like Russia will hold back forever and stand down from a response to NATO's moves against them. They intend to take out a minimum of Lithuania, and most likely will take out all three of the Baltic states – and now Finland will also be a new target as a new NATO member.

They may also take out major Poland defenses to make sure they can't attack Russia. Russians believe they have already been attacked on several fronts by the west, and they might as well go to war first and have an advantage in the final outcome. But they might wait until this fall to attack, since the millions of European citizens will be cold and hungry due to the lack of oil and gas and more likely to rebel against their governments at some point.

I see a WW3 scenario unfolding and feel it on a daily basis. It is not a matter of if, but only a matter of when.

It wasn't until the past few months that I started thinking of a nuclear war. Before then it

was not even on my radar. The actual events on what is going on with military conflicts forced me to consider the possibility. And, since that time the global situation has not subsided, but gotten worse.

The globalist's "push" to destroy what they consider rogue nations, is what is driving the possibility of a nuclear war.

Unless the U.S. and NATO strikes first and wipes out Russia, it is inevitable that there will be a war coming from Russia against the US, it is guaranteed. It can't be stopped, unless the U.S. strikes first with a massive preemptive attack. However, what are the chances of that happening?

So far it appears that the west only intends to keep poking the bear with a sharp stick until Russia loses patience and strikes back. The Biden administration just increased more financial support for Ukraine with another \$800 billion. And Congress is approving this unlimited support without questioning it one bit.

Each time this support reaches Ukraine it prolongs the war against Russia. There is no end in sight with the west building up arms, supplies, soldiers and money for the war against Russia.

With the situation in Lithuania, and now the added blockade by Norway against Russian miners in a North Atlantic sea island, the squeeze against Russia is increasing exponentially. It is only a matter of time before the Russians explode with anger against what they say is a declaration of war against them. As I see it, with the Russians holding back from actions, while the west keeps encroaching against them, the possibility of the Russians making one major nuclear strike against the west increases dramatically. In one day the border line of NATO in Finland alongside Russia increased by 800 miles. Gee, I wonder if Putin will notice.

They are playing with fire and they know it. They are expecting a Russian knee jerk reaction on a global scale, that the world has never seen. And as they do this, they are acting as if they are the innocent ones.

I expect other actions to take place in the Middle East and in SE Asia against Japanese islands, Taiwan vs. China and South Korea heating up against North Korea. Russia may expand the war front to include those two other areas to keep the west spread thin and take some heat off the European theater.

With Turkey's action to allow Finland and Sweden to join NATO, this is prompting Russia and Syria to attack Turkey inside Syria with less hesitation. With Israel helping Ukraine and the west, Russia is prone to attack Israeli assets and knock out future bombing runs against Syria.

For years Russia has walked a tightrope not to get in Israel's way. But now the gloves are off and they see Israel as a direct enemy, along with Saudi Arabia and a few other Mid-East countries.

Qatar is working with Israel to put a gas pipeline through Syria to Europe, which would leave Russia out of the picture. The US, Israel and other Mid-East nations are working to overthrow the Assad regime and place a puppet government in Syria. However, they will have to destroy the Syrian and Russian military to make that happen. Hence the war against Russia.

At the beginning of the Syrian war the Russians had 50,000 citizens working and living in Syria. Since that time Russia has 63,000 troops in Syria, plus an unknown number of civilians and support people on bases and ports. There could be 100k to 150k Russians

living in Syria at this time. Does anyone think that amount of people are going to pack up and leave because Israel wants the land for a pipeline?

That area is building towards a war just as much as the war between Ukraine and Russia. Iran is a key player that is expanding its military power to be used against Israel and anyone that gets in their way. Russian Foreign Minister Sergei Lavrov says the claim of NATO being an exclusively defensive alliance is "ridiculous and disgraceful."

He made the remarks on Friday while addressing students and teachers at the Belarusian State University, in response to recent statements by a number of NATO members' officials."

"Recently, a representative of the White House once again reiterated that Russia should not be afraid of NATO and that no one should be afraid of it at all, because NATO is a defensive alliance. But it is already ridiculous to hear adults say such obvious nonsense. I would say, it is simply disgraceful," Russia's TASS quoted Lavrov as saying.

Pointing to the history of NATO's establishment and its confrontation with the Warsaw Treaty Organization and the Soviet Union, he said both the Warsaw Treaty and the Soviet Union are gone but "NATO has moved eastward five times."

"Who are they defending themselves from then?" he asked rhetorically, adding, "When someone pushes forward, establishes control of territories, and deploys armed forces and military infrastructure there, it is not exactly what is called defense. It's just the opposite."

The remarks come as the 2022 NATO Summit in Madrid wrapped up on Thursday with the bloc's decision to strengthen its forces along the eastern flank while also officially inviting Sweden and Finland, which share borders with Russia, to join the alliance.

"NATO is a defensive alliance and poses no threat to any country," reads part of the declaration of the Summit.

The declaration also named Russia as a "direct threat" to NATO members' security,

noting that the military alliance "does not seek confrontation and poses no threat" to Russia.

At the same time, it went on to threaten to respond in a "united and responsible way" to any threat from Moscow.

Chinese foreign ministry spokesperson Zhao Lijian also rejected the notion of NATO being only a defensive alliance.

"NATO is a 'defensive' alliance? Joke of the century," he tweeted on Friday while also sharing a combination of images portraying NATO's military intervention in several countries such as Afghanistan, Iraq, and Libya.

In a separate tweet, the Chinese official also pointed to the role of the U.S. and its allies in the continuation of the war in Syria and its devastating effects on people's lives.

"The U.S. and its allies continue to fuel the war in Syria. More than 300,000 civilians have died in the conflicts according to UN statistics, 1.5% of Syria's population," he wrote on Friday, also sharing a photo of war damages in Syria with a note which read "who is the threat to peace?"

NATO members had also alleged that China poses a "challenge" to the bloc's "interests, security, and values." Speaking in a daily briefing on Thursday, Zhao stressed the futileness of hyping up the so-called "China threat."

"NATO has extended its reach to the Asia-Pacific region in an attempt to export the Cold War mentality," he said, urging the bloc to stop making baseless accusations and provocation against China, abandon the outdated Cold War mentality, and stop dangerous acts that disrupt Europe and the Asia-Pacific.

The countries involved in this conflict/war have all expressed they are innocent of all charges and complaints of each other. The tragedy of the entire issue is that egos and motives have brought on distrust beyond the point of reconciliation. Each has advanced their position of turning up the propaganda to prove they are not easily bullied. In the months building to this point they have tried to invoke fear on each other that they believe their own propaganda. The Russian leadership sees an organized NATO plan in both the Baltic and in the case of Norway and is preparing to respond militarily if the blockades in both Kaliningrad and Svalbard are not lifted.

A forewarning new Security Council (SC) report circulating in the Kremlin today first noting President Putin announcing that Russia is ready to fully meet the fertilizer demand of agricultural producers from friendly countries, says he then delivered a fatal blow against Western colonial Supreme Socialist Leader Joe Biden by signing a decree ordering the transfer of the Sakhalin-2 oil and gas project in Far East Russia to a new domestic operator in response to unfriendly Western sanctions and threats to Russia's national interests and economic security, the immediate effect of which destroys

Western global energy giants' billions-of-dollars' worth of investments and deprives Japan of 10% of its critically needed liquefied natural gas imports.

In the latest blatantly illegal Western colonial move in response to the "Special De-Nazification Operation" to liberate Ukraine, this report notes, Germany seized control of three liquefied natural gas carriers that belong to Russian energy giant Gazprom—and in quick response, Gazprom announced it will completely shut down natural gas supplies to the European Union that flow through Germany from 11 July to 21 July, with them stating: "Nord Stream AG will temporarily shut down both lines of its gas pipeline system for routine maintenance works inclusive testing of mechanical elements and automation systems for ensuring reliable, safe, and efficient pipeline operations".

As to if Gazprom will really reopen natural gas supplies to the European Union, this report continues, it bears noticing Belarus Foreign Minister Vladimir Makei warning: "The Iron Curtain is now being erected by Westerners themselves...It is practically already up...The Western countries are doing it carefully, so as not to pinch anything off, but the process is underway"—a warning immediately joined by Foreign Minister Sergey Lavrov assessing that even though the NATO Founding Act of 1997 that prevents war between Russia and the Western colonial powers from breaking out legally remains in force, "it has effectively been violated by the American-led bloc"—an assessment followed by Security Council Deputy Chairman Dmitry Medvedev declaring: "Under certain circumstances, such hostile steps can be perceived as an act of international aggression...And even as a casus belli...In response to them, the state has the right to individual and collective self-defense".

With articles now appearing like "Rationing Has Already Started In Europe As The Entire Globe Plunges Into A Horrific Economic Nightmare", this report details, a group of 21 highly-influential German academics, philosophers, journalists, artists and exdiplomats released their open letter "Ceasefire Now!", wherein they state: "So far, Ukraine has been able to defend itself, thanks in part to massive economic sanctions and military support from Europe and the United States...But the longer these actions last, the more unclear the goals of the war become...The victory of Ukraine and the return of all the occupied territories are considered unrealistic by military experts, since Russia has a military advantage and is capable of further escalation of hostilities...Western countries should therefore ask themselves exactly what goal they want to achieve and whether (and for how long) the arms supply is still the right solution...The continuation of the war, which would lead to the complete victory of Ukraine over Russia, is the death of thousands of victims of the war in the name of a goal that does not seem realistic".

In quick response to these esteemed German policymakers, this report notes, it saw Ukrainian Ambassador Andrey Melnik to Germany firing back like a lunatic: "What a bunch of pseudo-intellectual losers...They should go to hell with their defeatist advice"—a "hell", according to Melnik, that should also make room for senior adviser Harlan Ullman at the Atlantic Council, who has actively advised American Secretaries of State and Defense, NATO strategic commanders (including serving on the Senior Advisory

Board of Supreme Allied Commander Europe for thirteen years), and NATO secretaries-general as well as members of Congress and heads of a number of foreign governments in Europe and the Indo-Pacific regions, and in whose just published open letter "What's Putin's Next Move?" assesses:

"Putin has size and quantity on his side in the war against Ukraine. No matter how heroic Ukrainian resistance has been, it is not infinite, especially as casualties rise and weapons and logistics stocks are depleted."

Putin no doubt sees, rightly or wrongly, the weaknesses and flaws in the Western alliance that, over time, will not be contained and can be exploited. In that context, energy and food will be exploited to divide the alliance.

Europe is dependent on Russian gas and oil. And the cost of gasoline in America, assuming it will remain high, is a huge problem for President Biden and his domestic support, exacerbated by swelling inflation that may constrain a longer term consensus to allocate many billions of dollars to support Ukraine.

Putin learned in his engagement in Syria, migration can be a powerful weapon. With an outbreak of massive global starvation and food shortages, the implications for migration are self-evident. With 5 million displaced Ukrainians and substantial numbers seeking refuge in Poland, Romania and elsewhere, starvation will drive orders of magnitude more people to find safety and sustenance in Europe and the U.S. The West may not be able to handle this.

Two weeks ago, a NATO blockade of Kaliningrad, an outpost of Russia, was triggered when Lithuania blocked the transport of goods through the Suwalki corridor. According to the Lithuanian justification they were following through on NATO sanctions against Russian goods. However, the escalation was very provocative toward Russia and discussions between Russia and NATO countries were tense.

Apparently, Germany was increasingly concerned the blockade was creating a scenario where Russian military were going to escort the transport of railroad goods to Kaliningrad, and that would lead to escalated military conflict with Russia. "German Chancellor Olaf Scholz is eager to avoid unnecessary provocations of Russia. He has repeatedly emphasized that he would do everything in his power to ensure that NATO does not become a party to the war between Russia and Ukraine. German soldiers are stationed in Lithuania and could become involved in a possible conflict."

The EU has now dropped the blockade and the transport of goods between Kaliningrad and Russia will resume. The EU decision was made before the NATO meeting in Madrid concluded; however, it looks like NATO postponed the announcement until after Biden left in order to save face on the reversal of position.

Putin sees that the U.S. has been forced into planning for a two-front war directed against Russia and China. Putin fully appreciates the folly of such a strategy. Napoleon

and Hitler ultimately were defeated by embarking on two-front wars, invading Russia in 1812 and the USSR in 1941, respectively.

China then is a strategic asset as well as a market for Russian energy to circumvent the sanctions and force the U.S. to dilute its resources in having to cope with two major adversaries half a world away. Putin also sees the divisions in America over virtually every issue as further constraints on its power and ability to influence events.

Now joining the assessment made by senior American advisor Ullman, this report continues, is a new poll published this week by the Institute of Politics of the University of Chicago, wherein it grimly reveals: "Almost half of Americans feel like strangers in their own country...The majority of people consider their government as a corrupt institution working against them, with more than a quarter saying it may be necessary to take up arms"—today it sees an avalanche of economic articles appearing like "U.S. Stocks Off To Worst Start In Over 50 years"—in the just published economic article "It's Been A Vicious 6 Months For Stocks. Here's What The Grim Markets Are Signaling" sees it warning: "If, in a few months, there are indications that the Fed is succeeding at bringing inflation under control, markets will stabilize...But if it becomes clear the Fed isn't getting a handle on inflation, all bets are off"—to what the under socialist siege American people are facing sees it being documented in economic articles now appearing like "BREAKING: BIDEN ECONOMY Officially in Recession - Key Fed GDP Tracker Turns Negative"—and to explain why "more than a quarter" of Americans said "it may be necessary to take up arms", it was best exampled yesterday when top Biden economic advisor Brian Deese demonically told these suffering peoples: "This is about the future of the Liberal World Order and we have to stand firm".

In 1979 the Joint International Commission for Theological Dialogue Between the Catholic Church and the Orthodox Church was established by the Holy See and 14 autocephalous churches to further foster ecumenism.

I began ministry in June, 1965 in the United Methodist Church at the height of the ecumenical rapprochement. That year the Methodist Church merged with the

Evangelical United Brethren Church. My experiences as a young boy brought me into contact with Sacred Heart Roman Catholic Church, a couple blocks from the home of my youth in Pittsburgh's East End district, where I delivered groceries to the church rectory and nun's kitchen-quarters atop the girl's high school building. Several of my neighbor friends entered the priesthood, one even became an Auxiliary Bishop, and so in my interests, I have spent more than a half-century studying the Catholic Church, both branches.

No pope has ever been able to enforce his authority role as "Vicar of Christ" on Earth since 1054 AD but that has not stopped those who were determined to try. To explain a millennial history of this struggle, Rome has been instrumental in provoking most if not all the wars and revolutions of Europe since 1054. Underlying centuries of conflicts, the agenda has been orchestrated to eliminate competition with Papal authority.

World War 3 is not conjecture, but an inevitable fact that will happen, the question comes down to how soon it will happen. A week ago Luis Vega posted a study on why Pentecost remains a viable date for the Rapture. Luis Vega has suggested a July date and so I share his study below. I have followed the interesting work of Luis Vega for almost more two decades and while I have not agreed with him on many of his topics, he does produce thought provoking studies. I hope this one in particular comes to pass.

WHY PENTECOST IS IN JULY/TAMMUZ END OF THE WHEAT HARVEST

After the Summer Solstice

The purpose of this study is to chart the Timeline leading-up to July 23, 2022. The Chart Illustration format will give a better Visual of the various Factors that will be presented as Evidence for a July/Tammuz true Pentecost Date. In the Timeline, one also superimposed a 40-43 Week Human Gestation Period to it. It is very interesting in what correlates to the overall Theory of when true Pentecost is, and in turn could be the Place and Time when the Rapture occurs. It looks 'Promising', but it has to be Tested to see if the Theory is correct. If it is, the Bride has Arrived. The Wheat Harvest concludes as the New Wine Commences and a 'Birthing' as come to Term, etc.

One finds it very suspicious and Interesting how now that the Israeli Government has collapsed, it will be run by the Interim Prime Minister, Lapid. But as some Political Science Pundits have rightly assessed, there can be a Government formed, if they wanted to, but it has not been decided for that. Instead, Israel will be left without a 'Leader' or Ruler until Elections on October 25, 2022. Interestingly, this Date is just 7 Days from one's suggested and possible Tribulation Timeline. One wonders if 'They' are leaving the Spot for the 'Ruler'? At that time, all Power and Authority will be given to Rule Israel and then the New 'Reset' World Order.

October 18, 2022 (Shemini Atzerets)

- + 1260 Days = April 1, 2026 (Passover)
- + 1260 Days = September 11, 2029 (Yom Teruah)

The following are just some more tid-bits as to why one believes and is convinced the true Pentecost is in July or the 4th Month of Tammuz in the Array of the 7 Feasts of YHVH. And as to one's Correlation that the Resurrection-Rapture event could thus occur at such a time, that will remain to be seen. What strengthens the Argument of 'But

what Year?' Question, is the Fact of the Sabbath Cycle Patterns. Out of all prior Years since 2015, the point is that the Rapture Timing could not have occurred or even thought of until 2022, in Hind-Sight.

But that the Rapture event would materialize, only in the Year in which either a New End/Beginning Sabbath Cycle would occur. Perhaps. That logic would be why no Year since 2015, could have the Rapture occur, but in 2022, and this is the Year now. It is now a real possibility, but still Conjecture and an Educated Guess as the Rapture 'Window', is ascertained to be in the 4th Month, based on the 99th Day Count from Nisan 15, etc. So, this means that out of all the prior 6 Years in the Sabbath Cycle, none but 2022 could be even considered to be a High Watch Year, as it is then for 2022.

A Matter of Synchronization

All this is based on one's Estimation and Calculation. The Chart will show that the Feasts of YHVH follow the Agricultural Seasons of Sowing and Planting and that they are pegged to the Solstices and Equinoxes, in one's Understanding Realize that this Time Reckoning is solely based on the Sun, as opposed to the Rabbinical Calendar that is solely based on the Moon. That is why there is a Discrepancy and Confusion in the overall Day-Counts.

Before the Jewish Diaspora, by the Romans and the Temple being destroyed, a Solar-Lunar Calendar Matrix was used to Synchronize the Sun and Moon Times; to know when exactly to Celebrate and Celebrate the Feasts of YHVH, etc. The Hillel Calendar was then Mathematically formulated, based on only the Lunar Cycles as the Sanhedrin disbanded and this Rabbinical Calendar became the next best Instrumentation to go by. It was because the Jews were scattered throughout the Nations, as the Bible said this Last Time they would be. This Calendar served to keep their Identity and Unity.

And this Rabbinical Time Reckoning is aside from the Torah Calendar, the Enochian Calendar and the Creation Calendar, and the Essenes Calendar. But also take note that the Enochian, Essenes and the Creation Calendars use the Solar Cycles, based on the Equinoxes and Solstices, to varying degrees. Here is the example of why, on average, at least in the Northern Hemisphere and in particular, North America, the Summer Wheat Harvest begins right after the Summer Solstice of June 21.

It should be noted that it is an Average as certain Regions may have had their Wheat Harvest ready for Harvest early, by as much as 2 Weeks, etc. Nonetheless, the point is that the Summer Solstice kicks-off the Summer Wheat Harvest. See Video Link for a Visual and Commentary at end. Why this is important, and why one seeks to tie it to or make a Prophetic Link to the Rapture Timing, is that consider the following Day Counts below. Realize that the Wheat that is being Harvested, starting around, after the Summer Solstice of June 21, on average is really what is called the Winter Wheat. The Wheat Crop was planted back when?

Around the Fall Equinox of September 21 of the Prior Year. And guess how many

Months will that have been? 9 Months. This is the same Time-Frame as that of a Human Gestation Period. And? The Point and Correlation is that the Wheat Harvest staring in the Summer typifies this Spiritual Analogy that even Jesus inferenced, as to the Harvest of Human Souls on Earth being 'White for Harvest', i.e., Wheat. Remember the 120 Numerical Coefficient. 4 Months x 30 Days = 120.

This has a Prophetic Inference to the 120 Jubilees set for Mankind, as revealed by YHVH in the Old Testament. And it is based on the Number of Sabbath Cycles of 7 Years, etc. Also have in mind, that in considering all of this, most Watchers and Students of the Bible and End Times would agree that the End of the Church Age will be likened to a Harvest and a 'Birth'. That is what is currently happening and has since Pentecost started the Commission to 'Go out into the Harvest, to Sow, Water, and Reap Souls'. This is why the Prophetic Fulfillment of Pentecost is on-going.

A Spiritual Gestation

But there is another Key Prophetic Typology of this Present Pentecostal Intermission. There is another Spiritual Typology, that of a Man-Child that is to be 'Born'. This has direct implications to the Revelation 12 Motif. Here are the possible 'Rapture' Human Gestation Equations.

September 21 Winter Solstice to a June 21 Summer Solstice= 273 Days

Or **9 Months** Excluding the End Date. (39 Weeks) Human Gestation Period is 9 Months or on average of about **42 Weeks**.

But if one uses the Winter Solstice of September 21, 2021 to see how long it would be to the July 23, 2022 Speculated true Summer Pentecost, and thus possible Rapture Date, the following Day Count results.

= 10 Months or 43 Weeks

According to Research, 'the Average Gestation Period of Humans is 280 Days or 40 Weeks. The Gestation Period begins on the 1st Day of the Woman's Last Menstrual Period. Full-Term Babies are Born from 37 Weeks to 42 Weeks of the Estimated Date of Birth. The Stages of Human Gestation are broken into 3 Trimesters that are 3 Months Long Each'. -Reverence.com

'Can a Pregnancy be 43-Weeks-Plus? Yes. Even when the Doctors are sure of the Dates, some Pregnancies last longer than 40 Weeks. After about 42 Weeks, Doctors get really antsy about it, though. The Key is Placental Function and Baby's Head Size, both of which can usually be determined by Ultra-Sound'. -Quora.com

It is understood that, based on the Teaching of the Apostle Paul, he linked the Bride of Christ to that of a Baby, in the Spiritual Process of a Gestation Period. And what is being 'Formed or Birthed? This is Paul's Perspective: 'My Children, for whom I am again in the Pains of Child-Birth until Christ is Formed in you'... -Galatians 4:19. Paul even

identifies as a sort of Mid-Wife that is seeing that the 'Delivery' is on Schedule and to be completed to its 'Term'.

If this be the Spiritual Case, then the Spiritual Typology is to follow in now there is some sort of Spiritual 9-Month Human Gestation Variable at work. And? That his Time Sequence will lead-up to the 'Harvest an 'Birth' with the Resurrection-Rapture Timing. This is why one is emphatic that, here comes an 'Impossible Word' Alert... It is Impossible for any other of the Spring or Fall Feasts of YHVH to be associated with a Harvest Feast and Gestation or Pregnancy coming to 'Term'.

Well, aside from Tabernacles of Sukkot, but that is emblematic of the Year's End Harvest. Many Watchers do believe Sukkot is a likely Candidate for the Rapture because of this. But not in comparison to the many Typologies given as Innuendos and Clues about a Summer Wheat Harvest and a Gestation-Birthing Process that is tied to the Wine Harvest 1 MONTH later after the Summer Solstice. How so? Here is where one has the Statement of Jesus, to the fact that in 4 Months, there will be a Harvest or a 'Birth'?

A Birthing Process

It is assumed that He made that statement just prior to the Crucifixion in the very Month of the Spring Equinox, being March 21. Thus, if one counts 4 Months of 30 Days each from March 21, the Day Counts are as follows.

March 21 to April 21 = 1st Month
April 21 to May 21 = 2nd Month
May 21 to June 21 = 3rd Month = (A Trimester of Time)
June 21 to July 21 = 4th Month
or 120 Days Total

All that, to infer as to why true Pentecost took place and will take place in the 4th Month of Tammuz or in Mid-July. The Point? In approximately 1 Month after the Summer Solstice, the Grape Harvest begins. This would be starting in the Mid-July 20s and why the Apostles were then accused of being 'Drunk on New Wine' as that was being then Harvested. One cannot say the same of Tabernacles/Sukkot or any other Fall Feast, as Yom Teruah or Yom Kippur. But again, all these Day Counts and Suppositions are based on there being a Double Count (49 Days + 50 Days) to determine true Pentecost, in the 4th Month of Tammuz (July). One cannot prove that 100%.

Although one is convinced of this Hypothesis, based on both the Day Count, how Israel left Egypt on Nisan 15 from the Exodus Account. Then from the Counting of the Omer, results in the same Day Counts. Traditional Pentecost is pegged to the Rabbinical Calendar and in one's Opinion, based on a False Mis-Understanding that 'Pentecost' is just the 50th Day after Shavuot or the Feast of Weeks. Nonetheless, it will be interesting to see what the 1 Month Countdown or the 30 Days to July 23 for the Year 2022 will

bring from the Summer Solstice.

The following Section will attempt to explain the Chart Illustration. First, note the Phi Ratio Time Correspondences based on the Feast Days of YHVH. The Chart reiterates that true Pentecost occurs on the 99th Day after Nisan 15 in the 4th Month of Tammuz. This would put the Pentecost, based on a Double Count of 49 Days + 50 Days in Mid-July of a Given Year. For 2022, it would be July 23. What is highlighted is how from the Fall Equinox of September 21, 2021 to the Summer Solstice of June 21, 2022 is 40 Weeks or 9 Months. Is it suggesting a 'Birth' Innuendo, that could be Prophetically synced to the Rapture Timing? Is not Pentecost the event where a 'Birth' was insinuated of the Church Age and that of a Royal Commissioning to go into the 'Wheat Field' of the World?

What one wishes to highlight from the Chart are the following Observations. Notice that for 2021, the Rabbinical Calendar was off by 1 whole Month or approximately 29 Days as that is the Lunar Cycle difference needed to re-align with the Solar Cycles. It so happened that for 2022, the Jewish Lunar Calendar synchronized with the Gregorian Solar Calendar. This proves that the Rabbinical Lunar Calendar 'drifts' and as a result, for 2021, a 13th Month had to be added. Note that based on the Sabbath Cycle Theory, 2022 is the 70th Sabbath of Sabbath Cycles, meaning that it has been 70 Years since 1952, which one argues is the true Start Date for the Countdown to Daniel's 70th Week.

End of the Church Age

This Assertion then would mean the End of the Church Age. This of course necessitates the Resurrection-Rapture event, if one holds to a Pre-Tribulation Rapture Scenario. And this means that the Rapture Timing Window is but at most 3 Month out to the start of the New Sabbath Cycle. Then note how from the Spring Equinox of March 21, 2022, adding 4 Month or 120 Days results in July 21, 2022, just 2 Days shy of the Supposed true Pentecost Day that is arguing for 2022


As noted, the Numerical Coefficient of 120 is an Inference to the Jubilees that are based on the Number 50, as is Pentecost. It is in reference to what YHVH told Noah in that there would be only 120 Year allotted to Mankind. It is directly tied to Humanity's Judgment in the Days of Noah and so will it be after the 'Harvest' or 'Birth' of the Bride of Christ when the Rapture event occurs. Some Bible Researchers have assumed a Double Entendre in that if one dissects the Mathematics, it would be the following.

120 Cycles of Time x **50 Pentecosts** = 6000 Years

This Prophetic Equation, to some, signifies the period Humanity has in relation to the 6 Days of Creation Pattern. It leaves the 7th Day or the Sabbath to correspond to the Millennial Kingdom once Jesus returns to Earth. The Numerical Coefficient of 120, as mentioned is also the Time Duration that is also directly associated with the Disciples in the Upper Room. They had returned from 'Going Fishing' and had caught the 153 Fish in the Net. This Exact Numerical Coefficient also alludes to the End of the Church Age.

But more, is the Mathematical Fact that it relates to what is called the Vesica Pisces.

If one takes the difference of 153 from 120, the result is 33, the Age of Jesus. Then, in Mathematics, the 153 Numerical Coefficient is a Factor of the Vesica Pisces. And? It is a Motif of the Womb in that it infers a Birthing Process. And that is perhaps what the Timeline is suggesting in the Gestation Period that will end in a 'Birth'. The Chart will also note how there are significant Day Counts leading-up to the Supposed true Pentecost Day of July 23, 2022. There are 70 Days from Israel's Independence Day, on May 14, 2022.



A larger graph of this illustration has been included at the end of the article in a vertical format.

There are 50 Days from the Rabbinical Day of Shavuot of June 3, 2022. There are also 33 Days from the Summer Solstice. And 50 Days out from July 23, 2022 will be September 11, 2022. This has also a direct connection, if the start of Daniel's 70th Week does begin sometime in the Fall. How so? The 7-Year Timespan, ending in 2029, on Yom Teruah will be September 11, 2029, etc. And to reiterate, the Chart will show how one believes that YHVH 'Clocks' Time in Phi Ratio.

Consider that from September 21, 2021, being the Fall Equinox to the July 23, 2022 supposed true Pentecost Date, the Phi Ratio delineations match April 1, 2022 as being Nisan 1. And it would correspond to when the Partial Solar Eclipse occurred on April 30, 2022. Then to Triangulate when Israel celebrated its 74th Independence Day. There is another Phi Ratio correspondence of Nisan 1, or April 1, 2022 which corresponds to April 14, 2022, being Passover to then triangulate to the May 14, 2022 Independence Day of Israel. Coincidence?

No, if one understands Mathematics and Sacred Gematria in Motion, and how it is applied to Prophetic Time. All this to strongly suggest that July 23, 2022 is significant as far as all the pieces of Evidence are concerned. In some cases, they are but Circumstantial, but nonetheless, for one personally, **July 23, 2022 is the Highest Watch Date of the Year for the Rapture.** And only because one is pegging it to the supposed true Pentecost Date. It is only that from there, one is projecting the Supposition that, if and when the Rapture would or could occur, **Pentecost would be the Prime Candidates to Close out the Church Age with as it began, a 'Harvest', and as a 'Birth'**.
