One of the greatest reasons for God's intervention and fulfilling His Promise of Revelation 3:10 – "Because thou hast kept the word of my patience, I also will keep thee from the hour of temptation, which shall come upon all the world, to try them that dwell upon the earth." might be something that you have not thought a great deal about. I get in my mail every week the latest "Geoengineering Watch" with Dane Wigington. I became a listener/viewer of Dane Wigington years ago at the time he went live on the Internet. We know from man's fall that God's creation groans from the consequences of man's sin. Romans 8:22 and other passages speak to the travail of God's creation. The forces of Satan are waging a war on humanity through turning the environmental issue as a problem of too many of us.

During the first six months of this year Prince Charles "Sustainable Development" has been pressing member nations to honor their commitment from Agenda 21. At the Rio Conference in 1992, most of the nations, willingly or not were coerced to sign the Rio Treaty whereby they would enact measures that would result in reduced population for their individual nations. Ireland was first this year to report it had to reduce its animal herds by a third; then Denmark was required to reduce its agriculture output by a third to reduce its nitrogen problem. In recent days, drought in the southwest has forced Texas cattle ranchers racing to market to unload herds of cattle at auction. The price of feed, fertilizer, and fuel, has taken its toll on ranchers across the country. As an example, bales of hay have been selling for as much as \$50 a bail, even more for rolled bails. California taxed ranchers up to \$8,000 a head for the privilege to raise beef and dairy cattle. Klaus Schwab and Bill Gates wants you to eat crickets and bugs rather than beef. The drought has been orchestrated through beaming energy into the ionosphere through HAARP heaters around the world. The HAARP facility in Gakona, Alaska is capable of beaming 3-billion watts of energy high into the upper atmosphere which they can steer the "Jet-Stream" in the direction they desire. There are a dozen of these ionosphere heaters stationed around the world under the control of the UN and its operations.

A new book that came out a few months ago is 'Chemtrails Are Not Contrails – The Face of Evil'. One of the most intensive books on this subject is by Peter Kirby – 'Chemtrails Exposed: The New Manhattan Project'. The latter book is one of the most thoroughly written books on the topic. It speaks to the evil that lurks behind this geoengineering of earth's ecosystem. J. Marvin Herndon, PhD and his co-author Mark Whiteside, MD have documented that those white lines in the sky every day are a toxic soup of coal fly-ash, burnt particle waste from electrical power plant's burning of coal, the scrubbers on the stacks collect the fly-ash which then has to be hauled away to dumps, land-fills, and settling ponds. Coal fly-ash is the price we pay for electrical power created by burning coal as a source of creating steam generating power plants.

A week ago Congressman Thomas Massie of Kentucky grilled the Secretary of Transportation, Pete Buttingieg on his "green" agenda of electric cars. Congressman Massie went on to point out that it would take four times as much electricity to charge the average household's cars as the average household uses on air conditioning their home for the entire year. Congressman Massie is a cattle farmer for Kentucky's 4th congressional district. Interestingly, Congressman Massie has earned a BS in Electrical Engineering, and a MS Degree in Mechanical Engineering from MIT. Massie rejects the scientific consensus on climate change. He has said, "I think the jury is still out on the contribution of our activities to the change in the earth's climate". In 2013, he implied that cold weather undercut the argument for climate change, tweeting, "Today's Science Committee Hearing on Global Warming canceled due to snow". Thomas Massie often disagrees with members of his own party and is seen as a Libertarian rather than being a Republican.

The point of Thomas Massie shows the real insanity of the eco-green agenda really speaks to the naïve mindset of people like Pete Buttingieg and those of his crowd that are graduates of WEF leader Klaus Schwab's future leaders of the world. The so-called "Build Back Better" bovine excrement is not about stewardship of the earth but really all about "Depopulation" and enslavement to the Satanic New World Order. Those of you who know Bible prophecy also know they only have seven years to achieve their goal, and since I have read the back of the "Book", I know they lose! That promise is well-placed throughout the Biblical narrative.

Speaking of what the Bible says about the end of days, just a few days ago the Tehran Summit: Strategic Advancement of the Russia-Iran Alliance was held. Clearly this is a "game changer" in regards to the Ezekiel 38 scenario.

Preceding the major report of Tehran's trilateral summit, Putin ordered with an eye on the CIA, Moscow cracked the whip at Israel. The Jewish Agency is Israel's life source and the Kremlin shut it down this month. The fallout may be a measurable schism between Moscow and Tel Aviv, in which the latter has a lot to lose. A row has erupted in Russian-Israeli relations over the functioning of the Jewish Agency in Moscow. The Jerusalem Post first reported on July 5th that Moscow had ordered the Jewish Agency to cease all operations in Russia, in a formal letter from the Russian Justice Ministry "earlier this week."

The Jewish Agency initially played down the development in a statement which said, "As part of the work of the Jewish Agency's delegation in Russia, we are occasionally required to make certain adjustments, as required by authorities. Discussions with the authorities are ongoing with the aim of continuing our activities in accordance with the rules. Even now, there is a dialogue."

An unnamed senior Israeli diplomat told the Jerusalem Post, "Russia is saying the Jewish Agency illegally collected info about Russian citizens... We will bring up the Jewish Agency [with Russian authorities] and address it in an organized way. It will be taken care of at the embassy level. We don't totally understand the reasoning [of the request to stop Jewish Agency's activities in Russia]."

Specifics as to what all that meant remain fuzzy and yet my intuition suggests there is much more to this action by President Putin. There have been stern statements coming from Putin in recent weeks concerning Israel's activities and involvements in the Ukraine war and Israel's injecting itself into the ongoing war between Russia and the Ukraine. Putin has warned Israel about its air strikes on Syria, seventeen total in the past six months on targets in and around Damascus, Syria. I believe it is safe to say that Israel is becoming more than just a thorn in Putin's geo-political chess game. New Israeli elections are scheduled for November and diplomatic relations are suggesting bigger problems on the horizon.

If we were to put the Turkish threats to invade Syria and President Recep Tayyip Erdogan's aggressive maneuvers aside, and focus on the most important aspect of Tehran's trilateral summit – namely, the Russian-Iranian relations which advanced immeasurably in the private meeting between Russian President Vladimir Putin and Iranian Supreme Leader Ali Khamenei – then last week's meeting in Iran was geopolitically more significant than acknowledged.

We are potentially looking at a pivotal military, political, and economic alliance that could shift the balance of power in West and Central Asia, a matter of significant concern to Europe, and the U.S. in particular.

It was no accident that the Russian president's second major foreign visit since his forces stormed Ukraine in February was to Tehran. His trip neatly coincided with remarks by U.S. National Security Advisor Jake Sullivan alleging a Russo-Iranian military agreement that would provide Moscow with hundreds of Iranian drones,

alongside a delegation of Iranian military experts that would train their Russian counterparts in their usage.

During his unexceptional visit to Jeddah to meet with leaders of the Gulf Cooperation Council (GCC), Egypt, Jordan and Iraq, U.S. President Joe Biden declared that his country will not permit a strategic security vacuum in the region to be filled by the Sino-Russian alliance. The CIA plays a big role on behalf of its masters in the region.

Yet, there was Putin in Tehran, taking a major step to fill this post-American vacuum, documenting his strategic relations with Iran in bilateral meetings with the country's spiritual (Mr. Khamenei) and executive (President Ebrahim Raisi) leadership.

The Russian-Iranian alliance was a visible fulfillment of the prophecy of Ezekiel 38/39 in case you have not heard about the meeting. Tehran's trilateral summit has been overshadowed by a world of turmoil and rebellion but rest assured the summit confirms God is at work bringing about His Master Plan of Redemption and Restoration.

Putin's visit to Tehran resulted in a number of strategic achievements on all levels that serve to enhance this new alliance:

First, is the expansion of the BRICS organization that includes Brazil, Russia, India, China, and South Africa, which Iran – as an ascending regional power – aspires to join.

Second, Iran's provision of supplying drones to Russia helps compensate for its losses in the Ukrainian war and enhances its offensive capabilities. This confirms two basic things: the advanced progress and development of Iranian military industries; and Iran's resolution of its position in this war by throwing its weight behind its new strategic ally, Russia. In return, it is possible that Tehran may receive advanced Russian military hardware like Sukhoi aircraft and the S-400 anti-missile system.

Third, Russia has directly benefited from Iran's 40 years of experience in dealing with U.S. economic sanctions, and it is expected that Tehran will spare Moscow from the many pitfalls it has itself encountered, given that they now face this common enemy.

Fourth, full Iranian-Russian coordination in the current energy war, as Russia ranks first in the global production and exportation of gas, followed by Iran, which ranks high in global oil production as well as holding a key position in OPEC.

Fifth, the expansion of key trade and investment portfolios between the two countries. Most notably, during the summit, the National Iranian Oil Company signed an unprecedented memorandum worth \$40 billion with Russia's Gazprom to develop two Iranian gas fields and six oil fields.

Sixth, Iran's active participation in the new financial system that China and Russia are seeking to establish as an alternative to the U.S.-led SWIFT bank messaging system. This would potentially include the cessation of trades in U.S. dollars, the formation of a

unified collective basket of regional currencies, and increasing rial-ruble trade between the two countries.

It is clear that the Turkish president's role in this summit was limited mainly to the Syrian file. Erdogan is a man with one opportunistic foot in the Russian-Chinese-Iranian axis, and the other in the U.S. camp.

Furthermore, it is not certain that Putin will forgive the Turkish 'Bayraktar' drones sent to the Ukrainian army, or that Erdogan shut down the Bosphorus and Dardanelles waterways to Russian warships, or the mobilization of Turkey's army on the northern Syrian border and its threat of attack at the height of Moscow's preoccupation with the Ukrainian war. But this was not the time for Putin to open additional hostilities on other fronts.

As for Khamenei, his messages to Erdogan during their joint meeting were strong and clear: Syrian-Turkish differences can only be resolved through dialogue; the security of Turkey is linked to the security of Syria; the question of Palestine is the central issue of the Islamic world and must not rely on the U.S. and 'Israel' to resolve it. Essentially then, that Iran strongly opposes any Turkish attack on Syria and all normalization attempts with the Israeli occupation state.

There is no doubt that Turkey is a great Islamic state with all the power of reason, and has an open option to extract itself from the state of uncertainty it is currently experiencing, join the Russian-Chinese-Iranian alliance (BRICS countries), and adopt dialogue to reach reconciliation with Syria on the basis of the "Adana 1998" agreement, which provides protection for the security of the two countries. However, it is clear that President Erdogan is of another mindset, which we do not believe is the correct one. My suspicion is that Erdogan will fall in line recognizing his need for the alliance over that of Turkey's membership in NATO. Erdogan has a reputation for his exploiting "What can you do for Erdogan" gaming strategy. At the end of the day, Erdogan knows which side butters his bread!

Israel is convinced that Moscow's threat to close down the Jewish Agency in Russia is retaliation for the Zionist state's positions on the war in Ukraine. In fact, Israel now fears that the crisis with Russia will escalate further, which has prompted officials in the Ministries of Foreign Affairs and Justice, and the National Security Council, to hold urgent discussions to assess the situation.

The feeling is that Israel is running out of time to deal with the crisis with Russia, because the Russian Jews in the occupation state maintain close links with their homeland. Israeli diplomats are working to guarantee that the "vital" activities and services provided by the Jewish Agency continue.

By closing the offices of the agency, Russia has dealt a severe blow to Jewish migration from the country to Israel, hence the occupation state's concern. There is now even more tension between Moscow and Tel Aviv.

Since the beginning of the war in Ukraine, Israel's interim Prime Minister and former Foreign Minister Yair Lapid has taken a hard line against the Russians. He was the first to join the West in issuing strong condemnations of President Vladimir Putin and accusing Moscow of "war crimes". He also led Israel's decision to support the condemnation of Russia at the UN. He has not spoken to Putin since taking over as prime minister, nor did the Russian leader call to congratulate him on his new role. This suggests that Russia's closure of the Jewish Agency is purely political, an act of revenge, although it is alleged that the agency has broken Russian law.

Jewish immigrants to Israel from Russia are increasing in number, with 19,168 people making the move since the beginning of the year. In the whole of 2021, only 7,824 Jews made "aliyah". The figures show that so far this year 48 per cent of all Jews migrating to Israel are from Russia.

Israel's position on the war in Ukraine is not the only reason for the crisis with Russia. Another reason being talked about in Israel is the occupation state's ongoing aggression in Syria, especially the recent attack that led to the closure of Damascus International Airport, and the attack on the port of Tartus, where there is a Russian naval base.

A third reason is related to the Russian demand for ownership of Alexander's Court in the Old City of occupied Jerusalem, which was blocked by an Israeli court. Putin sent a personal message to former Prime Minister Naftali Bennett in this regard, but nothing happened, and things got to the point where Russian Foreign Minister Sergei Lavrov spoke about the alleged "Jewish roots" of Adolf Hitler.

It is understandable to be astonished at Israel-Russia relations right now. They once enjoyed an era of mutual interests and harmony which led to great success for Jewish capitalists in Moscow, where some occupied influential positions in the Kremlin and others owned major media outlets. It also led to the largest migration of Russian Jews, close to one million people, to Israel between 1990 and 2006. That was the largest such migration since the upheaval of the occupation of Palestine in 1948.

Israeli leaders made routine official visits to Moscow. Of all world leaders, former Prime Minister Benjamin Netanyahu visited the Kremlin more than any other between 2016 and 2020. Moreover, the strategic regional environment saw Israel boosting its desire to build bridges with Russia, as the Middle East became a very competitive arena.

Decision-making circles in Tel Aviv intensified their communication with their counterparts in Moscow, after realizing the weakening of the U.S. position in the region, especially since President Joe Biden took office and the U.S. withdrawal from Afghanistan and Iraq. It slowly dawned on Israeli officials that Washington was leaving behind a huge vacuum.

None of this has prevented Israel from following the West in its position on Ukraine, in line with the international stance and the return of a Cold War atmosphere. Israel has

been trying to curry favor with both sides in the war, as it usually does, but it did not succeed this time. Hence, the deteriorating relations with Moscow have been damaged. The longer the war continues, the higher the price that Israel will have to pay.

Israelis tend to agree that they do not want the current tension with Moscow to become irreversible to the point that Russia would ban Israel's air force jets from using Syrian airspace; that would be a nightmare scenario for Tel Aviv. At the time of writing, Israel does not have a clear idea of what its reaction would be if things get to that stage, but it would push it into a corner and limit the options on its northern front.

Many Israelis believe that they will need a miracle to get Russia to reverse the decision to close the Jewish Agency. Moscow seems to be heading towards the end of Jewish migration from Russia, and orders from the highest levels have been issued in this regard. This is not a whim, but a serious initiative stemming from the Kremlin's vision for global leadership.

Hence the Israeli worry that things will not stop at the closing down of the Jewish Agency. Other Jewish institutions that disseminate information about Israel and teach the Hebrew language may also face closure. Putin appears to have decided to escalate the crisis with Israel, and the occupation state's efforts and achievements over the past thirty years may well be negated as a result.

In the final analysis, Putin's visit to Tehran was a historic one, establishing a Russian-Iranian alliance that will lead to the birth of a new axis which could determine the future of West and Central Asia and the future of war and peace – especially as an extension to the existing Iranian-Chinese strategic alliance. Even the Iranian rhetoric in the media has become more brazened in content and style.

The recent leaks that Egypt, Saudi Arabia, and Turkey to a lesser extent, are seeking to join the BRICS, while Egypt is seeking to launch communication channels with Iran probably confirm this sea of change on the horizon. Think Ezekiel 38/39!!!

What Does The 'Jerusalem Declaration' Actually Mean?

A linguistic analysis of the "Jerusalem Declaration" signed by U.S. President Joe Biden and Israeli Prime Minister Yair Lapid on July 14th exposes the nature of the document. It is clear that Lapid is being marketed as a long-term prime minister in advance of the next general election in Israel, with the declaration stressing the most important issues that concern Israeli voters as the continuity of U.S. patronage, security and installing Israel as the regional hegemonic state.

I counted at least 30, including unbreakable, enduring, shared values and interests, unwavering, longstanding, unshakable, steadfast, indispensable and

unparalleled. Moreover, it had the gall to claim that relations with the occupation state are moral, essential, incredible and extraordinary, alongside the usual strategic, vital, unprecedented, enduring, landmark, historic, extensive, robust, longstanding, consistent, extensive, critical, groundbreaking, unique, extensive, outsized and remarkable. Giving \$3 billion every year to a state that treats international law with contempt certainly is "incredible" and "remarkable", if nothing else.

What I am hearing daily in the circles I have contact with is blunt and to the point. "How soon Lord? How much more can we take?" On Monday, July 25, 2022, I saw a post on a secular news site by a gentleman by the name of David Haggith which really drove the point home about what is happening all around us. Mr. Haggith could not have said it any better than what he posted. I share his words of anxious concern.

I believe we all could think of something that Mr. Haggith might have overlooked. I saw that S&P Global stated that around 88% of U.S. housing is overvalued – a figure that serves as an indisputable crisis indicator.

Federal Reserve Chairman Jerome Powell recently admitted that increasing interest rates will "include some pain," but there's too much "pain" for the fragile U.S. housing market to handle right now. Even the researchers and economists at the Federal Reserve Bank of Dallas had to acknowledge the "growing concern that U.S. house prices are again becoming unhinged from fundamentals."

By some metrics, 2022 looks a whole lot worse than 2008 ever did. This has all the trappings of a housing market bubble, but this time around, the bursting of the bubble won't result from the unraveling of subprime mortgages. Instead, the Federal Reserve's tightening of monetary policy will squeeze buyers out of the market, prompting a collapse in home prices. There is a 9-month supply of new homes on the market as of July 20th.

There are signs of cracks forming in the foundation of the housing market if you know where to look for them. For instance, construction worker layoffs have amounted to thousands in Washington State's Puget Sound with more layoffs reportedly likely to come.

According to S&P Global, around 88% of U.S. housing is overvalued – a figure that serves as an indisputable crisis indicator. A few months back at the beginning of 2022, home builders were not building homes below the \$300,000 level. Up the road from me a lot was sold for \$50,000 in 2020. After a few months construction began and when the house sold, the advertised sale price was for \$287,000. My rough guess was that the home is not more than 1,800-2,000 sq.ft.

Another reliable bubble and burst gauge for the U.S. real estate market is the foreclosure rate. Nobody buys a home and expects to have it foreclosed, so rising foreclosures are a sign of buyers in desperate conditions and a market that's about to crack.

Deepening the crisis is the fact that it's only getting harder for Americans to make their mortgage payments this year. A recent reading revealed that Black Knight's mortgage payment/income ratio shot up to 31%, the highest reading since September of 2007. For comparison, during the decade of the 2010s, that figure has averaged 19.9%.

Again, the Fed's actions are having a lasting and devastating impact. Consider that on a \$500,000 mortgage, a borrower who's paying the current average mortgage borrowing rate (5.11%) would owe \$2,718 per month over the course of a typical 30-year loan. All told, this represents an additional \$208,800 in payments. It's no wonder, then, that so many prospective millennials and Gen Z buyers are putting off their first home purchases.

I should note that the U.S. has been a sucker all along in its support of Ukraine. You might think this is a war to wear down Russia, but maybe it is the other way around. By that it may be that the World Economic Forum is weakening the U.S. military by the U.S. giving its reserve munitions and weaponry, which in turn diminishes the U.S. from maintaining adequate stocks for our own military. The Ukrainian leader owns valuable beach-front property in Florida; has millions in Swiss and U.S. bank accounts, and now we hear the top officials in the Zelensky regime are purchasing real estate asset in Switzerland, at a time when its own people are fleeing the Ukraine. <u>High-Ranking Ukrainian Officials Caught Splurging On Luxury Real Estate In</u> Switzerland

9th Tish B'Ab

Fast of Av. **Zechariah 7:1-3**

<u>Jacob</u> is confronted by <u>Esau</u>, on his return to Canaan. *Genesis 33:1ff*. Rashal Bereshit Vayish quoted in <u>Seder</u> HaDorot.

Moses goes up on <u>Sinai</u>, a second <u>time</u>, to plead for mercy after the golden calf -day 20. <u>Exodus</u> **32:30-35**, Taanit 28b.

Moses' spies return from Israel, <u>ten</u> with a <u>wicked</u> report, <u>two</u> with a good report. <u>Numbers</u> **13:25** Taanit 29a

It was decreed that Israel should not enter the promised land. *Taanit* 29a, <u>Numbers</u> 13:25

Wilderness <u>generation</u> died on this day when they reached 60 years of age. **Taanit 30b**, <u>Midrash</u> Rabba <u>Numbers</u> **16:23**

Jeremiah was born. Midrash Yalkut Yirmiyahu 36

<u>Jerusalem</u> and the Solomon's <u>temple</u> are burned and looted by <u>Babylon</u>. *II Kings* **25:8-24.** *Taanit* 29a - 3338 AM

A year after the Temple was burned, Micah 3:12 was fulfilled.

This is the day spoken of in Lamentations 7:2.

This is the `fast day', of the fifth month, spoken of in Zechariah 8:19.

The Rabbis say that Herod's temple was also destroyed on this date in 70

C.E. *Taanit 29a - 3828 AM*

Emperor Hadrian established a heathen <u>temple</u> on the <u>Temple</u> mount. Taanit 29a Ezekiel/God tells elders to put away idols. *Ezekiel 20*

132 AD (135AD?) - Betar, the last fortress to hold out against the Romans during the Bar Kochba revolt fell.

1095 AD – <u>First</u> Crusade declared by Pope Urban II. 10,000 <u>Jews</u> killed in <u>first</u> month of the Crusade.

1290 AD – Expulsion of <u>Jews</u> from England by King Edward I, accompanied by pogroms and confiscation of books + property.

1492 AD - Expulsion of <u>Jews</u> from Spain by King Ferdinand. Also, Columbus (a <u>Jew</u> in hiding) sailed from Spain.

1555 AD - Ghetto established in Rome. Pope Paul IV moves all the <u>Jews</u> into a foul-smelling area near the Tiber River.

1914 AD – WW1 begins. 75% of all Jews lived in war zones.

1941 AD – A decree went forth expelling all <u>Jews</u> from Hungarian Ruthenia.

1989 AD – Iraq walks out of talks with Kuwait and the invasion of Kuwait by Iraq took place.

1990 AD – Gulf war starts Desert Storm that was started on <u>Tisha B'Ab</u> ended on the Feast of <u>Purim</u>.

1994 AD – Deadly bombing of the <u>Jewish</u> community center in Argentina, killing 86 and wounding 300.

The Israeli withdrawal from 25 settlements in the Gaza Strip and northern Samaria began on August 14, 2005.

Classical <u>Jewish</u> sources maintain that the <u>Jewish</u> <u>Messiah</u> will be born on <u>Tisha</u> <u>B'Ab</u>.

Torah section is *Deuteronomy 4:25-40*. Haftorah is *Jeremiah 8:13 - 9:23*. Morning Torah section is *Ex. 23:11-14*; *34:1-10*. Haftorah is *Isaiah 55:6 - 56:8*; *Micah 7:18-20*; *Hosea 14:2-10*. afternoon.

With the events that were put into motion on February 24, 2022, we certainly cannot rule out the possibility of World War III breaking out on the 9th of Av - August 6th, 2022.
