The Beginning of the End!

After posting Blessed Hope #124, and the crashing news around the world, I decided to post shorter Blessed Hope's for the next two weeks. With the Queen's removal from the picture now, the pace of things occurring will resemble the collapse of China's Three Gorge dam. The impact of what has already occurred in the last week has yet to jar anyone awake to ask the question, could this be the end of the world as we know it? In fact, few people ever study the "Big Picture" or systemic effects of global events until well past their impact on the world.

My academic mentor in college was a systems "big picture" type guy, a captain in the PA Army National Guard's 28<sup>th</sup> Infantry Division. He was denied his Harvard-earned PhD because he exposed the true story of the events that led to the Japanese attack on Pearl Harbor and how President Franklin D. Roosevelt orchestrated maritime sanctions against Japan blocking their access to buy oil and gas products. World War II was orchestrated to be a False Flag event to get the U.S. into the war on behalf of the Brits.

The fact is that the U.S. has been provoking a war between Russia and the EU/NATO states. Just yesterday, it was announced that the U.S. was giving the Ukraine another \$700-million-dollars' worth of American armaments and munitions. "Europe Is Facing Energy Disaster And It's Going To Bleed Over Into The U.S." These are the words of Brandon Smith writing for the Birch Gold Report on September 9, 2022.



Though the situation is ever changing, currently the Russian government has announced an official shutdown of ALL natural gas exports to Europe through the Nord Stream 1 pipeline and plans to maintain the shutdown until the EU ends its economic sanctions over the war in Ukraine. This means that around 40% of Europe's energy resources are now gone, with supply chain issues surrounding the other 60% and prices skyrocketing for households and businesses.

Back in March in an article titled 'The Biggest Lies (So Far) Surrounding Russia And Ukraine' I noted that:

"...There's something else the media does not talk about much, which is Europe's reliance on Russian oil and natural gas. If you want to see actual price inflation caused by Russia, let the EU ban Russian oil imports, or watch as Putin cuts off the supply. Europe is dependent on Russian oil and gas for about 40% of overall energy production. They cannot even survive a single year without it. If Russia retaliated and blocked energy exports to Europe, the EU would have to siphon oil from many other countries, reducing global supply dramatically. This would cause gas prices to explode to double or even triple current levels."

Back in April of this year in my article 'The Media Is Ignoring These Two Events Which Could Cause Economic Collapse' I predicted that:

"...The Russian economy is not about to fold anytime soon, and now the EU, which is reliant on Russian oil and gas exports for 40% of their energy needs, is about to face economic doom unless they submit to paying for energy in rubles (which they won't) or find a replacement source for gas and oil (which is impossible). Furthermore, with Europe on the global market looking for alternative oil sources, a big chunk of the oil market will be rerouted.

What does this mean? Less oil and gas to fulfill the demand in other countries. In other words, prices are about to skyrocket higher yet again."

The media disinformation surrounding the economic situation with Russia disarmed millions of people and fooled them into believing that it was Russia facing fiscal disaster rather than Europe or potentially the U.S. Now, it would seem my predictions of a full spectrum crisis are coming true. The question is, what happens next?

For now, all talk in the mainstream media will revolve around two things — What will be done to prevent disaster, and how evil Russia is for cutting off the European population from warmth in wintertime. I'm not going to get into the weeds on the morality of Russia's actions vs European sanctions (After all, the EU sought to economically destroy Russia. And, as I have written in the past, BOTH sides are being played by globalists to create a worldwide crash). But I do want to cover the inevitable EU response.

European governments are now racing to implement the only policies they understand: Stimulus policies.

The UK and the EU are announcing plans to artificially subsidize energy providers and pay a percentage of electric bills for households and businesses. Of course, one has to ask, if it's that easy for governments to simply print money and feed it to energy providers, then why don't they just pay for everyone's electric bills all the time?

Because price controls never work, that's why.

What the EU is planning is essentially a form of price controls using inflated fiat as a means to placate energy producers for as long as they can. Most oil and gas on the global market is purchased using the U.S. dollar, not the Euro, so it is unclear if Europe will be printing euros to buy dollars or attempting to buy oil, gas, and coal directly. In any case, this will greatly reduce the Euro's value on the energy market and prices will continue to rise for the EU anyway.

The EU and UK are seeking to cap prices and pay the remainder, but if prices keep climbing, how much are they willing to subsidize and how much are they willing to

devalue the Euro (or the Pound) in the process? Are they willing to go into complete currency implosion and hyperinflation to pay for energy?

All of the debate over government stimulus and the effects will be meaningless, though, if the issue of supply is not taken into account. The EU can print as much money as they want, but this doesn't help them if they can't acquire enough energy resources to provide the heating and power the public needs. There is ZERO chance that they will be able to fill the void left behind by Russian gas and oil, so a certain percentage of the European population is going to suffer regardless.

Here are the developments Europe will see in the near term:

I could continue on with this list but I think you get the idea. It's not going to be pretty. For those of us in the U.S. this seems like a scenario out of sight and out of mind, but this will not be the case. Europe is going to be scouring markets for energy supplies, anywhere they can find them. Keep in mind, the U.S. is ALREADY sending 75% of its liquid natural gas exports to Europe. There is very little resource backstop for the EU to dip into.

This means less oil, less gas, less coal, less of everything for purchase in America. Sure, we could be producing most of these resources in-house and cut exports to the EU, but the Biden Administration will never allow that to happen.

At the very least, prices are going to rise everywhere on the majority of goods. I continue to predict that U.S. gas prices at the pump will climb to around \$7 a gallon on average. Propane and other heating commodities will rocket beyond previous highs.

Supply chains will be weakened. European manufacturing will take a massive hit and many of these businesses will not be able to operate at normal capacity. Most of them will have to reduce production and institute layoffs. This means that European goods will be exported less frequently and prices on the remaining goods will spike in the U.S.

European agriculture will also be hit hard. Food production will fall as energy supplies and fertilizer supplies falter. This means they will be buying up more grains and foods from other nations, causing prices to jump for everyone else including the U.S.

Civil unrest in Europe is assured. Similar conditions are already brewing in the states, but it's hard to say if Europe's problems will trigger public anger here. More price inflation might be the straw that breaks the camel's back, but this is unlikely until mass layoffs start later this year and into 2023. It takes time for the public to realize things are not going to return to normal.

Overall, the U.S. economy will continue its path towards destabilization, though it seems that Europe will see the worst of the global crisis over the next several months. Unfortunately, the interdependency created by globalism has left every country in the world overly reliant on the others. If any single link in the chain breaks, the entire system breaks. This is why decentralization is so important — It creates redundancies and protects each individual nation from a potentially disastrous domino effect.

When I said Prince Charles of Wales is a "nut case" you have no idea of how delusional Prince Charles is! For over thirty years Charles has been traveling the globe to convince leaders that their problems will disappear when they get rid of a basic problem, mainly 7-billion human beings. The result will be a fall in house values. And as values fall so those mortgage problems will get worse. It won't be long before millions have a bigger mortgage debt than their house is worth. Their homes will be re-possessed and they will be left with huge debts. Alternatively, the Government may say: 'We'll take over your mortgage and you can stay in your house...but you will no longer own it'. I suspect that many bankruptcies will be inevitable.

Remember, none of this is happening by accident. It has all been orchestrated. And those with savings won't survive either. Although interest rates will rise, they won't go high enough to defeat inflation.

If interest rates go to 5% and inflation is 25% then investors and savers will lose 20% of their wealth every year. Within a remarkably short space of time, the conspirators will have succeeded in destroying the wealth and independence of tens of millions of people in the UK and hundreds of millions around the world.

There will be no middle classes. The elderly will die in penury(poverty) The young will never own a home or have the security of having some savings.

The conspirators want us bankrupt because they know that money gives us freedom and independence. All this has been clear for years. But people didn't listen. And now, I'm afraid, it's pretty well too late. In practical terms, the only way to protect yourself now is to downsize, to reduce your debts and your outgoings and to be prepared for a simpler way of life.



He also vowed to be a "defender of the faith" and added he was "profoundly encouraged by the support of my beloved wife." [This may have been a slip of the tongue since years ago Prince Charles used the term "Defenders of the faiths!"]

King Charles III has long been friend to UK Jewry, with special and historic ties to Israel. The Royal king has long had good relationship with British Jews; outspoken on antisemitism; shored up Israel bona fides in recent years with official visit; also empathetic to Palestinians.

In many ways King Charles III is an anachronism to the modern world. The definition (from the Greek ἀνά ana, 'against' and χρόνος khronos, 'time') is a chronological inconsistency in some arrangement, especially a juxtaposition of people, events, objects, language terms and customs from different time periods. The Royal family has been living a dream of Camelot, a period of time, Camelot is a castle and court associated with the legendary King Arthur. Absent in the early Arthurian material, Camelot first appeared in 12<sup>th</sup>-century French romance and, since the


Lancelot-Grail cycle, eventually came to be described as the fantastic capital of Arthur's realm.

That Grail image has not always been desired by Charles' children. Prince William, and Prince Harry more so, have drifted away from and wanted to take the family away from its legacy of Royalty and trappings that go along with it. Charles' sons have struggled with being children of royalty in a modern world where royalty is not viewed with awe or majesty throughout the world. Even the Queen's passing has had miniscule reaction despite her lengthy reign. Royal biographers and writers over the years did more to build up the mystique surrounding the Royal Family!

Laurence Gardner wrote more about the mystique of the Royal Family than any other author that I can recall in my lifetime. Most amazing of all his works is the one that tracks the Royal Family lineage back to King David of the Bible. I recall seeing it on an end-cap at Joe-Beth bookstore in Lexington, KY in the spring of 1996. I was between finals at Asbury Theological Seminary and made a quick trip into Lexington to see what was new at Joe-Beth. The dust jacket of the book grabbed my attention and I removed a copy from the book shelf and sat down in a nearby chair to scan the book's content. Suffice it to say, I bought a copy of the newly released work of Laurence Gardner, beginning my research on Prince Charles of Wales.



This photo is of the author's "Special Edition" of *'Bloodline of the Holy Grail'* published in 2001. The first edition was published in 1996. Laurence Gardner wrote a dozen books on the Royal Family. He did more to hype the idea of the Red Dragon that the Royal Family were "Reptilians" and that the Queen was a "shape shifter". Supposedly, the late Princess Diana, wife of Prince Charles was witness on more than a few occasions to the Queen's shape shifting facial appearance. I cannot confirm any truth to the rumors and stories of the Queen as a "reptilian" but after reading the first edition of this book pictured above I purchased every one of Laurence Gardner's subsequent books in his series. The Royal Family became more than intriguing after I read the above book. It struck me as an extremely powerful effort to discredit the lineage of Jesus of Nazareth as the Jewish Messiah and God Incarnate, for which it was purposed!

Laurence Gardner presented this image that Jesus "swooned" in the grave and was secreted out of the Garden Tomb where he and his bride Mary Magdalene were united and secretly escorted away to North Africa where they, under the cover of darkness, fled to the south of France, and ultimately became the Merovingian bloodline of the Grail kings. The narrative is inconsistent with Scripture but nonetheless it became the grist to an idea that the descendants of Jesus of Nazareth are today the British Royal Family. Since the Royal Family is very deep into the occult and most likely they long

ago bought into the idea that they were the descendants of King David, a factor in what is known as British-Israelism. British Israelism (also called Anglo-Israelism) is the pseudo-archaeological, pseudo-historical and pseudo-religious belief that the people of Great Britain are "genetically, racially, and linguistically the direct descendants" of the Ten Lost Tribes of ancient Israel.

With the passing of Queen Elizabeth II, the United Kingdom has a new king in Charles III, who at the age of 73 is the oldest person to ascend the British throne. Charles has long had a good relationship with British Jews, and in recent years has also shored up his bona fides with Israel.

The royals have a deep historic connection to the Jewish state, with Britain ruling the land between 1920-1948. In 2020, then-president Reuven Rivlin noted to Charles during a visit to Israel that he and other Israelis of his generation were born as subjects of Charles' grandfather King George VI.

Charles himself has abiding ties to British Jewish leaders and institutions, and has shown a keen interest in the stories and lessons of the Holocaust. He has had warm meetings in recent years with two Israeli presidents and toured the country in a historic 2020 visit. Below are some of the highlights of the new British monarch's connection to Jews, the Jewish state, and related matters.

#### Ties to Israel

In 2020, Charles conducted his first official visit to Israel, after previously making brief trips for the funerals of Yitzhak Rabin and Shimon Peres. He was the most senior member of the royal family to hold such a visit since the establishment of the state, following his son William's first-ever official royal visit in 2018. The queen never came to Israel.

While in the country to attend the World Holocaust Forum, Charles met with thenpresident Rivlin and planted a tree at the President's Residence in Jerusalem.

Charles met with a group of Holocaust survivors at the Israel Museum in Jerusalem and toured the Dead Sea Scrolls exhibit. He also attended a reception at the home of the British ambassador in Ramat Gan, where he was shown various Israeli scientific and medical innovations.

Charles' grandmother, Princess Alice of Battenberg, is buried at the Church of Mary Magdalene on the Mount of Olives in Jerusalem. During his trip, Charles visited her gravesite and has done so on private visits.

The princess is recognized by Yad Vashem as a Righteous Among the Nations for helping save a Jewish family in Greece during the Holocaust. Charles said her actions were a source of "immense pride" and inspiration for him and the royal family.

In November 2021, President Isaac Herzog met Charles during an official visit to the UK and the two discussed climate change, regional threats, and Holocaust education. In a "special gift" to the British royal, Herzog announced a nursing scholarship at the Hebrew University of Jerusalem dedicated to Princess Alice that the president's office said "pays tribute to [her] compassion, deep spirituality, and immense perseverance to help those in need."

#### Holocaust remembrance and antisemitism

Speaking to world leaders gathered at the 2020 World Holocaust Forum in Jerusalem, Charles warned of the "searingly relevant" lessons of the Holocaust while hatred and intolerance "still tell new lies, adopt new disguises, and still seek new victims."

The world must "be fearless in confronting falsehoods and resolute in resisting words and acts of violence," he said. "We must tend the earth of our societies so that the seeds of division cannot take root and grow."

Charles has in the past warned of the dangers of rising anti-semitism and other forms of intolerance in the UK.

In 2022, Charles commissioned portraits of seven Holocaust survivors to be displayed at Buckingham Palace for International Holocaust Remembrance Day.


#### **Ties to British Jewry**

In a 2019 pre-Hanukkah reception at Buckingham Palace, Charles celebrated the contribution of our Jewish community to the health, wealth and happiness of the United Kingdom.

"In every walk of life, in every field of endeavor, our nation could have had no more generous citizens, and no more faithful friends."

He noted then prominent members of the British Jewish community and their contributions to society at large, as well as "those who are not household names, but who are the cornerstones of their own local communities.

Charles was also close to former UK chief rabbi Lord Jonathan Sacks. Upon Sacks' death in 2020, Charles mourned him as an "irreplaceable loss" and "a trusted guide, an inspired teacher and a true and steadfast friend."

"Through his writings, sermons and broadcasts, Rabbi Sacks touched the lives of countless people with his unfailing wisdom, with his profound sanity and with a moral conviction which, in a confused and confusing world, was all too rare," he said then.

"He and I were exact contemporaries, born in the year of the foundation of the State of Israel and, over many years, I had come to value his counsel immensely. "I shall miss him more than words can say."

#### Defender of all faiths?

In 1994, Charles said that when he became king he could be "defender of faiths" rather than taking the traditional vow to be "defender of the faith."

He later clarified his position in a 2015 interview with the BBC, saying: "As I tried to describe, I mind about the inclusion of other people's faiths and their freedom to worship in this country. And it's always seemed to me that, while at the same time being Defender of the Faith, you can also be protector of faiths."

#### On Palestinians

During his 2020 visit to Israel, Charles also visited the West Bank and met with Palestinian leaders. He said then that he was heartbroken to witness the "suffering" and "hardship" endured by the Palestinians.

The remarks were described by Britain's Sky News as constituting "the biggest show of support that a member of the Royal family ever has [expressed] for the Palestinians."

Visiting Bethlehem, the town revered by Christians as the birthplace of Jesus, Charles said: "It breaks my heart... that we should continue to see so much suffering and division. No one arriving in Bethlehem today could miss the signs of continued hardship, and the situation you face."

Speaking at Casa Nova, a Franciscan pilgrim house near the Church of the Nativity, Charles went on: "And I can only join you, and all communities, in your prayers for a just and lasting peace. We must pursue this cause with faith and determination, striving to heal the wounds which have caused such pain."

He added: "It is my dearest wish that the future will bring freedom, justice and equality to all Palestinians, enabling you to thrive and to prosper."

#### **Love for Jewish Artists**

In a 2018 episode of Radio 3's long-running show Private Passions, Charles spoke of his love for Canadian Jewish singer Leonard Cohen.

"I've always loved Leonard Cohen's voice and his whole approach to the way he sang," he said. "He was obviously incredibly sophisticated in the way he sang, but also wrote. I

find it very moving, the words are so extraordinary, sort of Salvador Dalí-like, they lead you into this remarkable Dalí-like world."

Charles has also spoken in the past about his friendship with Else Mayer-Lismann, a music academic who fled to the UK from Nazi Germany and who taught him to love the opera.

"I was incredibly fortunate to have been introduced to Else Mayer-Lismann back in the Eighties by an old friend of mine," he told The Telegraph once. "Else was a wonderful character and her deep knowledge of opera and music was infectious. Her descriptions and explanations of the background to various operas – particularly those of Wagner – made the whole difference to my subsequent enjoyment of the actual performance and transformed the experience."

Richard Wagner, whose grandiose and nationalistic 19th-century literary and musical work is infused with antisemitism, misogyny, and proto-Nazi ideas of racial purity, was Adolf Hitler's favorite composer and his music was played in Nazi concentration camps.

#### On Ukraine and Putin

In 2014, when Russia first invaded parts of the Ukraine, Charles likened Russian President Vladimir Putin's behavior in eastern Europe to Nazi Germany's Adolf Hitler during World War II.

He has been more careful in his comments on the 2022 war, but in May traveled to Romania to visit Ukrainian refugees, mostly women and children.

"We feel for you greatly, it's a nightmare situation," he told them then. "I'm full of admiration for the Ukrainian people. Total, extraordinary courage and resilience."

He also declared that the day of his mother's funeral — expected to be September 19 — will be a public holiday as a day of national mourning.

No one can accuse Prince Charles of being anything less than sensitive, compassionate, caring, and always a guarded diplomatic man of parsed meanings in what he has to say. 


