The commander of the U.S. nuclear arsenal has stated unequivocally that the war in Ukraine is just a warmup exercise for a much larger conflict that’s already in the mail. Antiwar’s Dave DeCamp reports:

The commander that oversees U.S. nuclear forces delivered an ominous warning at a naval conference last week by calling the war in Ukraine a “warmup” for the “big one” that is to come.

“This Ukraine crisis that we’re in right now, this is just the warmup,” said Navy Admiral. Charles Richard, the commander of U.S. Strategic command. “The big one is coming. And it isn’t going to be very long before we’re going to get tested in ways that we haven’t been tested [in] a long time.”

Richard’s warning came after the U.S. released its new Nuclear Posture Review (NPR), [which reaffirms that the US doctrine allows for the first use of nuclear](#)

weapons. The review says that the purpose of the U.S. nuclear arsenal is to “*deter strategic attacks, assure allies and partners, and achieve U.S. objectives if deterrence fails.*”

Not only does Richard appear to believe that a hot war between major world powers is a foregone conclusion, he has also previously stated that a nuclear war with Russia or China is now “*a very real possibility.*”

Again, this is not some armchair warrior opining from his desk at a corporate newspaper or DC think tank, this is the head of STRATCOM. Richard would be personally overseeing the very warfare he is talking about.

What I find most striking about remarks like these is how passive they always make it sound. Richard talks about “*The Big One*” like other people talk about California earthquakes, as though a hot war with China would be some kind of natural disaster that just happened out of nowhere.

This type of rhetoric is becoming more and more common. Describing an Atomic Age world war as something that would **happen to** the U.S. Empire, rather than the direct result of concrete A-or-B decisions **made by** the empire, is becoming its own genre of foreign policy punditry.

This passive, oopsy-poopsy narrative overlay that’s placed atop the U.S. Empire’s militarism is nothing new. Back in 2017 Fair.org’s Adam Johnson documented the way western media are always describing the United States as “stumbling” into wars and getting “sucked in” to military interventions, like a cheating spouse making up bad excuses after getting caught:

This framing serves to flatter two sensibilities: one right and one vaguely left. It satisfies the right-wing nationalist idea that America only goes to war because it’s compelled to by forces outside of its own control; the reluctant warrior, the gentle giant who will only attack when provoked to do so. But it also plays to a nominally liberal, hipster notion that the US military is actually incompetent and boobish, and is generally bad at war-making.

This is expressed most clearly in the idea that the U.S. is “*drawn into*” war despite its otherwise unwarlike intentions. “*Will U.S. Be Drawn Further Into Syrian Civil War?*” asked **Fox News** (4/7/17). “*How America Could “What It Would Take Stumble Into War With Iran,” disclosed **The Atlantic** (2/9/17), to Pull the US Into a War in Asia,*” speculated **Quartz** (4/29/17). “*Trump could easily get us sucked into Afghanistan again,*” **Slate** predicted (5/11/17). The US is “*stumbling into a wider war*” in Syria, the **New York Times** editorial board (5/2/15) warned. “*A Flexing Contest in Syria May Trap the US in an Endless Conflict,*” **Vice News** (6/19/17) added.

So let’s get real clear about this here and now: if there is a hot war between the U.S. and a major power, it will not be because that war was “*stumbled into*”. It will not be like

an earthquake or other natural disaster. It will not be something that happens to or is inflicted upon the U.S. empire while it just passively stands there in Bambi-eyed innocence.

It will be the result of specific choices made by the managers of the empire. It will be the result of the U.S. choosing escalation over de-escalation, brinkmanship over detente — not just once but over and over again, while declining off-ramp after off-ramp. It will be the result of real material decisions made by real material people who live in real material houses while collecting real material paychecks to make the choices they are making.

Another thing that strikes me about comments like those made by Charles Richard is how freakish and insane it is that everyone doesn't respond to them with, *"Okay, well, then let's change all of the things we are doing, because that's the worst thing that can possibly happen."*

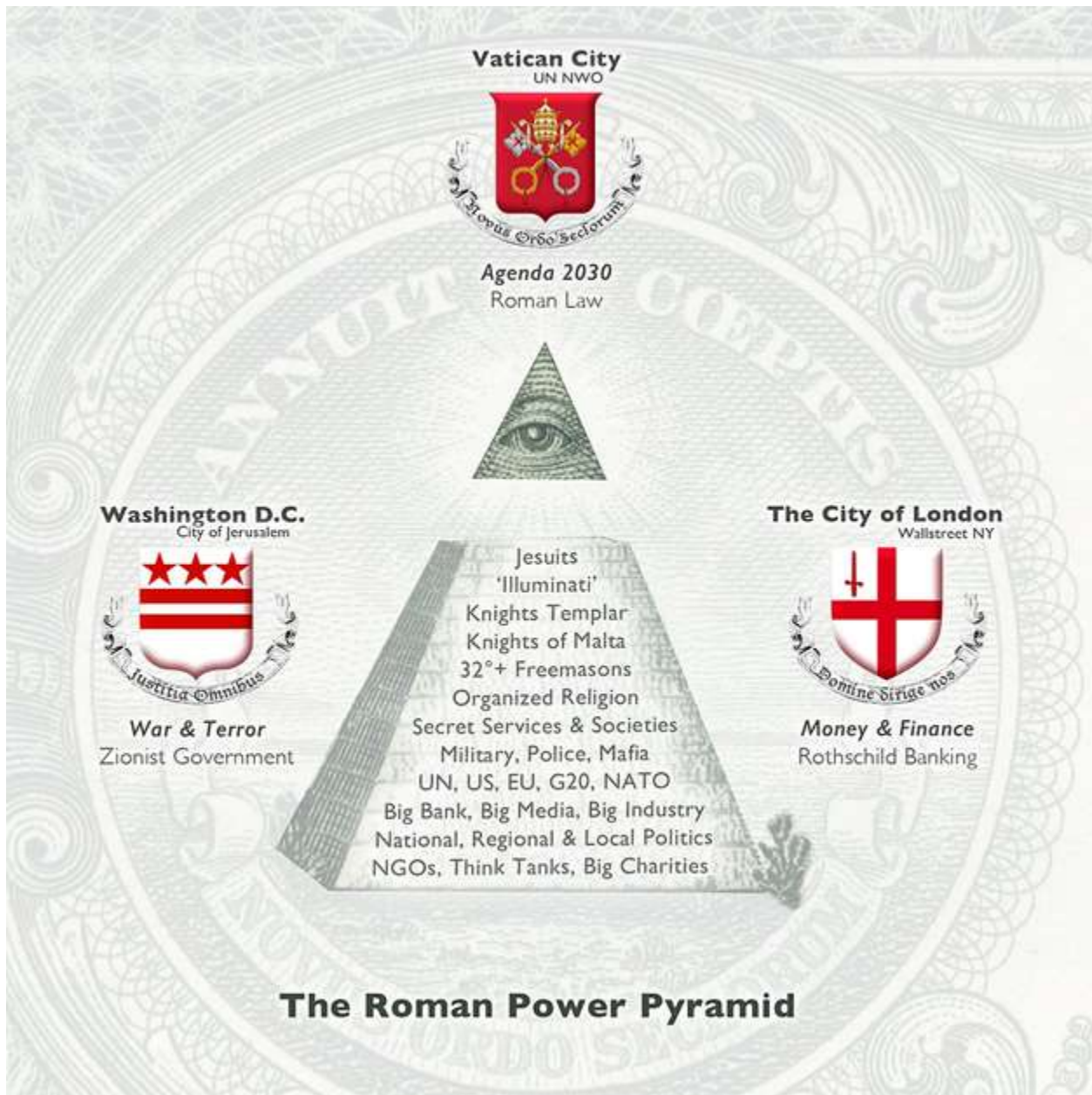

Sir Evelyn Robert Adrian de Rothschild FKC died Nov. 8, 2022 at his London home. The financier was born in London on Aug. 29, 1931. He attended Harrow School and Cambridge before taking charge of N.M. Rothschild & Sons Ltd. between 1976 and 2003 that founded the bio-warfare industry. The firm had earlier been inherited by future British prime minister Lord Rosebery from wife Hannah Rothschild, who had died mysteriously on Nov. 19, 1890 at age 39 from [Burroughs Wellcome-triggered] typhus in 1890. In the same year Hannah died, Rothschild banking partner Junius S. Morgan died mysteriously in a Riviera auto accident on Apr. 08, 1890, after which J.P. Morgan ascended the demon throne in New York as N.M. Rothschild's secret agent—in conspiracy with Baring Brothers, John Barker (London Assurance Company), British Agent #7, Alexander Hamilton, and later Paul M. Warburg, the Rothschild's became the controlling stockholder of the U.S. Federal Reserve (1913), BNY Mellon (1784), Chase Manhattan (1799) and Wells Fargo Banks (1781), among others.

Babylonian Eagle, Horse, Lion and Radhanite fake “Jewish” pagan banker-merchant Pilgrim ca. 1000 B.C. His three children from #2 are Jessica de Rothschild (Jun. 05, 1974-), Anthony James de Rothschild (Jan. 30, 1977-), David Mayer de Rothschild (Aug. 25, 1978). His two stepsons from wife #3 are Benjamin Forester Stein (1985-) and John Forester Stein (1988-).

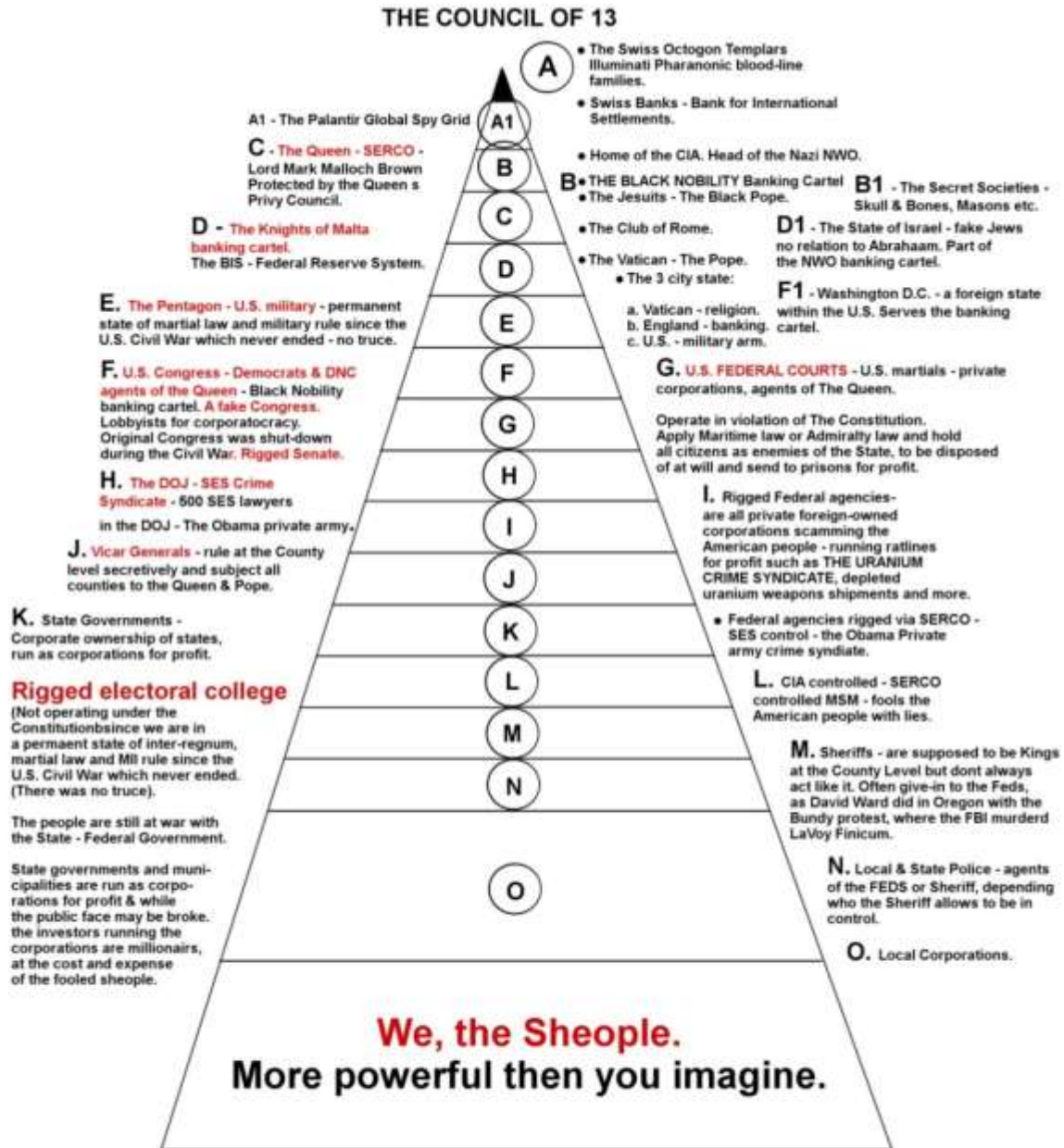
Sir Evelyn was chief strategist for the Pilgrim Society's new world order "Great Reset" plans. He was interlocked with IBM, DARPA, Crown Agents, Senior Executive Service (SES), SERCO, QinetiQ, World Economic Forum, Bank of England, Reuters, London Stock Exchange, New York Stock Exchange, DeBeers, British Crown-King Charles III, AstraZeneca, GlaxoSmithKline, Moderna, Pfizer, The Economist, Club of Rome, Rockefellers, Henry Kissinger, Daily Telegraph, Conrad Black, Privy Council, Prescott-Daddy-Baby Bushes, New York Times, George Soros, Warren Buffett, Rupert Murdoch, Pehr Gustaf Gyllenhammar, Microsoft, BAE, Lockheed Martin, Clintons, London School of Economics (elites-slaves communist economics), among many others. On September 16, a series of protests against the current political regime of Iran broke out throughout the country. Riots were ignited by the reports of the death of a 22-year-old Mahsa Amini, who had been arrested by morality police for wearing a hijab improperly.

Amini was detained by Iran's morality police in Tehran on September 13 for wearing an "improper" hijab, an offense punishable by prison. The woman was sent to one of the FARAJA centers belonging to the police department and military intelligence for an explanatory conversation. In the center, Amini reportedly had a heart attack, after which she was immediately taken to hospital where the young woman passed away on September 16.

Tehran said that the weeks-long mass riots were planned from abroad and summoned the ambassadors of the United Kingdom, Norway, and the charges d'affaires of France in Iran in late September. The European diplomats were given a note of protest in connection with anti-Iranian media reports and calls to overthrow the Iranian government.

The Prince of Wales has been praised for the 'passion' he holds for inter-faith understanding as he became the first member of the royal family to attend the

installation of the Chief Rabbi. Back in 2013, Prince Charles of Wales, who wore his own navy blue velvet Kippah, or skull cap - decorated with the Prince of Wales' feathers, was applauded by guests as he attended the formal installation of the new Chief Rabbi, Ephraim Mirvis, at St John's Wood Synagogue in north London.

Chief Rabbi Mirvis, addressing Charles, congratulated him on the birth of his first grandchild Prince George and said his presence as guest of honor at the ceremony was an honor for the 'entire' Jewish community.

Lord Sacks, who stepped down after 22 years as Chief Rabbi, a post widely viewed as a figurehead for the British Jewish community, formally inducted his successor into the post and gave an address to the ceremony.

Addressing Charles, he said the presence of the Prince of Wales at the installation testified to the *“generosity of spirit and the greatness of heart you have shown to all the faiths' while remaining 'steadfast and exemplary in your own”*.

The praise for Charles comes after he once said he wished to be known as defender of faiths rather than defender of the faith when he becomes King.

The remarks by Chief Rabbi Mirvis, who becomes the 11th Chief Rabbi of the United Hebrew Congregations of the UK and the Commonwealth, were made at the start of a sermon in which he warned against neglecting the poor and weak in British society and spoke of his pride in Jewish charitable giving.

In his sermon, Chief Rabbi Mirvis repeated concerns about the rise of anti-Semitism and spoke of his hope of a lasting peace between Israel and its neighbors.

“As I stand before you today, hostility is rife in Syria and we are witnessing some terrible atrocities and also at this time Israel and the Palestinians are set on holding negotiations with an eye towards establishing a true and lasting peace,” he said.

“In years to come I would love people to look back on this day and associate it with the time when finally we were on the path to beating swords into ploughshares in Israel and throughout the Middle East.”

Russia on Wednesday, November 9th, 2022 vowed to defend its *“traditional”* values against threats from the United States and its *“gay propaganda”* in a document signed by President Vladimir Putin. The presidential decree, setting out official policy and entering force immediately, stresses the importance of *“traditional values as the basis of Russian society”*.

It warns that Moscow must take *“urgent measures”* to ward off threats including terror groups, *“certain mass media”* and *“the United States and other unfriendly foreign countries”*.

It also lists internal threats from *“the activities of certain organizations and people on Russian soil”*.

These foes risk implanting *“alien”* ideas in Russian society and causing *“the destruction of the traditional family unit through propaganda of nontraditional sexual relationships,”* the decree says, using a phrase referring to LGBTQ relationships.

The Orthodox Church welcomed the document as a way to *“preserve our people and protect our children from being defiled,”* senior cleric Fyodor Lukyanov told TASS state news agency.

The mission statement comes as Russian lawmakers are pushing through amendments to toughen up a controversial 2013 law banning *“gay propaganda”* to minors, rewriting it to include adults as well.

Rights campaigners say the new amendments mean, in effect, that any public mention of same-sex couples is being criminalized.

Putin's new decree also warns that the country's enemies are distorting "*historical truth*". The former KGB agent has sought to associate his regime with Soviet-era successes and gradually cracked down on the rights and freedoms gained after the breakup of the USSR. Any sane Bible-believing Christian would have to agree with President Putin. Roman statesman Cicero is noted for the popularization of the Latin phrase "*cui bono*," which means "*to whose profit*" also known commonly as "*who benefits*." Cicero used *cui bono* to alert Romans to dig for the actual beneficiaries of political skullduggery. In 2016, we ask, *cui bono*, when we consider the business of agriculture, particularly why soy foods are ubiquitous even though they are less than ideal when it comes to health and nutrition.

Tom Valentine, former health editor of *The Spotlight* and AMERICAN FREE PRESS and host of *Radio Free America*, published a series of articles warning of the dangers of soy foods in the early 1990s. Valentine's articles, which have been picked up by many well-known health bloggers and health-minded advocates worldwide, connected the dots of corrupt science and business practice.

There was a time health food labels stated "*no soy*" because it was a known allergen. But all that changed, and now soy has become a fixture in every health food store, notably, billion-dollar giant Whole Foods Markets.

Beatrice Trum Hunter, one of America's foremost food experts and food editor of *Consumers Research Magazine*, quoted Valentine's well-made point that "*no other dietary staple has so many anti-nutrient drawbacks as soy. Conversely, no other food has so many public relations firms and lobbyists working for it.*"

Soy is known for its anti-nutrient properties because of its high phytic acid (phytates) content and anti-trypsin activity. Phytates bind minerals, notably calcium, magnesium, and zinc, making them unabsorbable. Trypsin is an enzyme used to digest proteins. Blocking trypsin, for instance, creates a deficiency of vitamin B12, which is vital for many functions. Phytates in soy don't break down from normal cooking as easily as with other legumes and grains.

Fermentation of soy reduces the phytic acid mineral-binding and trypsin-inhibiting properties of soy. Fermented soy foods such as tempeh and condiments such as miso

do not pose health risks and can be beneficial additions to the diet. Natto, a fermented soy cheese, has key constituents such as the enzyme nattokinase and vitamin K2, which confer health benefits from reducing excess fibrin and metabolizing calcium.

If you don't think you get much soy in your diet, think again. Finding products that don't have soy oil or soy extenders—which became famous when they were found in hamburger, of all things—is not an easy task.

Plus, the main use of soy is animal feed. You are likely eating soy when you drink milk or eat chicken, eggs, meat, or pork—and yes, some fish, since farm-fed fish are also given soy feed. Roughly 61% of all vegetable oil consumed in America is from soy.

Soy doesn't just bind minerals and inhibit the digestion of proteins; it is a known estrogen mimicker. [A May 19, 2009 Men's Health story](#) reported how James Price, a retired U.S. Army intelligence officer, who once flew attack helicopters in Vietnam, developed painful, swollen, large breasts.

"It was like my body was feminizing," Price told *'Men's Health'*. After discovering his estrogen levels were eight times the normal limits for men, doctors were perplexed. One became so irritated he accused Price of secretly taking estrogen. Price angrily recalled, *"He thought I was a mental case."*

Price eventually found Lieutenant Colonel Jack E. Lewi, M.D., chief of endocrinology at the San Antonio Military Medical Center, who, after ruling out possible diseases that may have caused male breast enlargement, asked Price about his diet. Price told Lewi he had three quarts of soy milk a day, after developing an allergy to cow's milk. Lewi told Price to drop the soy—and Price did, eliminating everything he could find that listed soy on the labels. Price's physiological and psychological sense of "manliness" returned to normal, and Lewi published Price's case history to warn others.

While Price's case is extreme, the estrogenic effects of soy are known. Valentine spoke with Drs. Daniel M. Sheehan and Dan Doerge, both affiliated with the Food and Drug Administration's National Center for Toxicological Research, in the 1990s, who courageously wrote against Archer Daniel Midland's petition to have soy isoflavones considered GRAS (Generally Recognized as Safe).

Sheehan and Doerge's 1999 letter was well supported with persuasive scientific references.

"We oppose GRAS status for isoflavones such as genistein because there is abundant evidence that some of the isoflavones . . . are toxicants," they wrote. "This is true for a number of species, including humans. . . . Genistein is clearly estrogenic: it possesses the chemical structural features necessary for estrogenic activity and induces estrogenic responses in developing adult animals and humans . . . thus consumption of isoflavones during pregnancy in humans could be a risk factor for normal brain and reproductive tract development."

Price learned the hard way. Sheehan and Doerge also wrote that *“isoflavones are inhibitors of the thyroid peroxidase, which makes T3 and T4. Inhibition can be expected to generate thyroid abnormalities, including goiter and autoimmune thyroiditis. There exists a significant body of animal data that demonstrates goitrogenic and even carcinogenic effects of soy products. Moreover, there are significant reports of goitrogenic affects from soy consumption in human infants and adults.”*

If that isn't bad enough, the use of glyphosates and genetically modified organisms make soy even worse, because, as AFP readers know, glyphosates and franken-tinkering carry their own set of health hazards. **More than 90% of all soy is GMO.**

Sadly, soy was sold to the public with religious fervor and, as is the same with many other *“accepted”* positions, is still in need of revisionism. Soy is used in infant formulas and is linked to numerous health problems, such as vascular dementia and cancer.

When Valentine exposed the problem years ago, he received much praise but plenty of flak from angry farmers to hapless men whose wives made them cancel subscription to his health newsletters, which exposed many environmental assaults against health.

Today we should ask if the increased *“feminization”* of Western men has something to do with what's in our food. Is it a coincidence that the corporate owned media fervently promotes gender confusion at the same time a known endocrine disruptor is part of the daily diet?

It is not much of a Segway leap to suggest that Satanic (Androgynous) Baphomet worship is part of the larger agenda afoot today. *“Androgynous”* is a broad term that refers to an individual's choice of style. **Somebody who is androgynous presents themselves to the world in a way that isn't defined by *“looking like a girl”* or *“looking like a boy.”*** Androgyny is the ultimate form of the rebellious self-expression that links to Satanism.

Baphomet is the name of a false god associated in times past with the Knights Templar and today with Satanism and the occult. Modern representations of Baphomet picture it with a goat's head on a human body (with both male and female traits); between the goat's horns is a torch, and the image often includes a pentagram. The origin of Baphomet-worship is subject to much debate. Even the origins of the word *Baphomet* are unknown. Some believe it is a French corruption of *Mahomet* (*“Muhammad”*). Others believe it to be a code from Kabbalah meaning *“the father of the temple of peace of all men.”* Or the Arabic word for *“the father of understanding.”* Or, finally, the Jewish Atbash cipher as applied to *Sophia*—the Greek goddess of wisdom.

However its name came to be, Baphomet apparently arrived in Europe with the Knights Templar upon their return to France from the Crusades. In the early 1300s, the Inquisitors of King Philip IV accused the Knights of discovering and worshipping the foreign god Baphomet during the war. Some Knights did confess, but only under torture,

and the convicted gave different accounts of the idol's form: it had one face, it had three faces, it was just a human skull, and it looked like a cat. Worshiping an image of an animal or man presumed to be Muhammad is inconsistent with Islam, but it would match the misinformed beliefs about Islam found in France at the time. In addition, there is no mention of Baphomet in Templar literature.



The modern representation of Baphomet originated in 1861 with the French occultist Eliphas Levi, who drew an image of the “Sabbatic Goat or Baphomet of Mendes” in his book *Dogme et Rituel de la Haute Magie* (*Dogmas and Rituals of High Magic*). Levi's image is a hermaphroditic figure, sitting cross-legged, with the head of a goat. The

figure contains several opposites: one male arm and one female, women's breasts but a Caduceus phallic symbol, one arm pointed up at a white moon and the other pointed down at a dark moon. The contrasts were to symbolize conflicting forces in the universe that must be balanced to make true light. Levi meant to combine several icons: the Templar figure; Satan; the fertility god-goat of Mendes, Egypt; and the goat that witches supposedly worship at their Sabbats, or pagan holidays. The goat-like appearance of Baphomet also resembles Pan, Puck, and the Celtic Cernunnos. Levi claimed the name *Baphomet* came from reading the Latin abbreviation for "the father of the temple of universal peace among men" backwards.

In 1897 Stanislas de Guaita adapted the head of Levi's Sabbatic Goat to fit inside a pentagram. De Guaita's version of Baphomet included an upside-down, five-pointed star surrounded by two circles. Between the circles are five Hebrew letters, one on each point of the star, spelling the Hebrew word for "*Leviathan*." Around the arms of the star on the top is the name *Samael*, the angel of death in Talmudic lore; and on the bottom, *Lilith*, a female demon who was Adam's first wife according to pagan beliefs. In 1969 Anton LaVey adopted the pentagram goat for his Church of Satan and definitively identified it with Baphomet.

Aleister Crowley, the occultist and magician of the late 19th to mid-20th century, interpreted Baphomet as the "*divine androgyne*." Crowley rejected the concepts of the biblical God and Satan and followed the Gnostic teaching that Satan brought wisdom to mankind—that old lie of the serpent in the garden. Baphomet was his symbol and represented life, love, and light. With the addition of the Zodiac sign Capricorn (the goat), liberty is added.

The myth of Baphomet has grown over the last few centuries via occult symbolism and numerology. Christians should obviously avoid the use of Baphomet; the ideas it represents are patently unbiblical. It is the Lord God alone who gives wisdom (Proverbs 2:6), and to seek for wisdom or enlightenment from a source other than God is to be led astray: "***The idols speak deceitfully, diviners see visions that lie; they tell dreams that are false***" -(Zechariah 10:2). We should have nothing to do with Baphomet or other blatantly occult icons. As Joshua told the Israelites who were inheriting the land of Canaan, "***Do not associate with these nations that remain among you; do not invoke the names of their gods or swear by them. You must not serve them or bow down to them***" -(Joshua 23:7).

I did not intend to go down this route but for the very fact that President Putin has taken upon himself the mantle of righteousness as the defender of traditional values it clearly places Russia on the side of God in this quagmire in the Ukraine and it would not be the first time God punished Israel even though Israel was the "apple" of God's eye. – (references Psalm 17:8; Proverbs 7:2; Lamentations 2:18; Zechariah 2:8). This is to say that the U.S. is not invincible and may be on the wrong side of God!

With President Putin's endorsement by the Orthodox Church, this war against Ukraine becomes akin to King David taking on Goliath and the Philistines in 1st Samuel 17.

Interestingly throughout the Bible, it becomes obvious that God punished nations and empires for their deviant and evil lifestyles. Why should we not consider that God will not punish the United States as for its public declarations thumbing the public nose against the Almighty. **While it is Lucifer and his minions orchestrating and pulling the strings, God may have simply withdrew His protection shield from the nations engaged in this war. If that happens to be the case, it is not looking good for the Republic of the U.S.A.**

The U.S. National Security Advisor Jake Sullivan's meetings with Ukrainian leaders, including President Vladimir Zelensky, in Kiev has created a lot of confusion and misperceptions. On one side, the White House maintains that the trip aimed *"to underscore the United States' steadfast support to Ukraine and its people."* The readout stated that Sullivan also affirmed *"the continued provision of economic and humanitarian assistance, as well as ongoing efforts with partners to hold Russia accountable for its aggression."*

However, unnamed U.S. officials gave the spin that Sullivan's real mission was to *"nudge"* Zelensky to negotiate with Moscow and urge that *"Kyiv must show its willingness to end the war reasonably and peacefully."* *Politico* later [reported](#) that Zelensky indeed heeded Sullivan's *"soft nudging"*. The U.S. media also reported that the U.S. officials have been nudging the Ukrainians for some time.

The *'Washington Post'* reported last week that the Biden administration privately encouraged Ukrainian officials to show they are willing to engage in dialogue with Russia, in an acknowledgment of the growing frustration in the U.S. and some of its allies at the cost and duration of the war. But, apparently, the Ukrainians pushed back.

Sullivan also added some spice to the media speculation by claiming on Monday that the U.S. has back channels to communicate with Russia at senior levels. The *'Wall Street Journal'* had earlier reported, citing unnamed US and Western officials, that Sullivan had allegedly held a series of confidential meetings recently with Kremlin aide Yury Ushakov and Russian Security Council Secretary Nikolay Patrushev on the conflict in Ukraine. (Moscow has not reacted to these reports.)

The heart of the matter is that Sullivan has been on a PR exercise in the run-up to the mid-terms in the U.S. (November 8) in a concerted strategy aimed at countering the growing criticism among the Democrats and Republicans that the Biden Administration is avoiding the diplomatic track to try to end the war in Ukraine. In fact, all indications are that the Biden Administration is preparing for the long haul in Ukraine.

['Stars and Stripes'](#) reported on Wednesday that a three-star general will lead a new Army headquarters in Germany called the Security Assistance Group Ukraine, or SAGU, that will include about 300 U.S. service members responsible for coordinating security assistance for Ukraine. On Sunday, *'The New York Times'* had reported that Lt. Gen. Antonio Aguto Jr., head of the First US Army headquarters at Rock Island Arsenal in Illinois, was a leading candidate for the new job.

The SAGU will be based out of US Army Europe and Africa headquarters in Wiesbaden, Germany. Sabrina Singh, the deputy Pentagon press secretary, told reporters the new command will “ensure we are postured to continue supporting Ukraine over the long term.” She added the US remains “committed to Ukraine for as long as it takes.”

It is improbable that Moscow has fallen for Sullivan’s dissimulation. There is reason to believe that Sullivan who is a thoroughbred neocon from the Clinton clan would only have urged Zelensky to expedite the planned Ukrainian offensive on Kherson, which has been in the limelight. The Biden Administration is badly in need of a success story from Ukraine as the newly-elected Congress convenes in January with a likely Republican Party majority in the House of Representatives.

No doubt, the Russians are taking the Ukrainian offensive in Kherson seriously. In a stunning announcement in Moscow on Wednesday, Russian Defense Minister Sergey Shoigu ordered a troop pullout from the western side of the Dnieper River in the Kherson Region. The fact that the Kremlin is risking criticism from the Russian public opinion for ordering such a retreat (from a region that is actually an integral part of Russia) underscores the gravity of the Ukrainian military threat. Zelensky is forcing Moscow to literally eat its words about the “demilitarization” of Ukraine! This move is a strategic move to minimize any loss of assets (human and weapons) as they hunker down and allow winter to take its toll and wear down the Ukrainian military. The Ukrainian military has suffered heavy loss of life since February 24th of 2022. The media will not tell the truth but the Ukrainian losses are reported to be 200,000 dead, or about half of its military.

Zelensky continues to be in a belligerent mood. On Monday, Zelensky did make a peace offer but with five conditions for a settlement:

- Restoring Ukraine’s territorial integrity;
- Russia respecting UN Charter on sovereignty and territorial integrity;
- Russia paying off all war reparations;
- Punishing each war criminal; and,
- Guarantees that such an invasion and atrocities will not happen again.

The only “concession” Zelensky made is that he didn’t mention his earlier precondition that President Vladimir Putin should relinquish office before any negotiations.

There is no end in view for the war in Ukraine. By the way, although the midterm elections are typically the point in a U.S. presidential cycle where one expects to see top Cabinet members begin to turn over, there is no sign of that happening to Defense Secretary Lloyd Austin.

Austin, 69, being a critical voice in the Ukraine conflict, who mobilized at least \$60-billions of dollars’ worth of military aid from around the world for Kiev, Biden anticipates

that the war effort may only become more entrenched and this is not the time to change up the top ranks of the Pentagon.

Indeed, the ground situation shows that the ongoing Russian operations in the areas of Ugledar and Bakhmut in Donetsk have run into strong resistance from Ukrainian forces, contrary to the Russian narrative Kiev's military is a demoralized lot.

In particular, the advance of the Russians around Ugledar got stuck in the village of Pavlovka, located on the important crossroads, and in a fierce battle three days ago, reportedly, hundreds of Russian soldiers were killed. Putin's decision to retreat in Kherson is probably meant to avoid a similar fate, as the Russians are experiencing logistical difficulties to supply their forces on the western side of the Dnieper River.

Of course, this seamy picture is not the whole picture insofar as the phase of regrouping and resupplying following the Russian mobilization is still a work in progress and the ongoing fighting in Donbass and Kherson is at the tactical level and does not involve any large movements of troops.

Equally, the intensive Russian strikes on Ukrainian depots, command centers and artillery and air-defense systems plus the destruction of Ukraine's military-industrial facilities and energy system are yet to impact Kiev's capacity to wage the war.

To be sure, the situation on the front lines in Kherson region remains extremely tense. The Ukrainian forces are on the prowl probing the Russian defense line incessantly to break through to capture the city of Kherson. A large-scale offensive by the Ukrainian forces on Kherson is to be expected any day. So far, Russians are holding their positions, repelling the ongoing Ukrainian attacks and fortifying their defenses.

From Kherson, Ukrainian artillery can threaten Crimea. In the prognosis of Moscow's close ally, Serbian President Aleksandar Vucic, *"Challenging times are ahead of us. Next winter will be even harsher than this one because we're facing the Battle of Stalingrad, the decisive battle in the conflict in Ukraine, the battle for Kherson."* He predicted that both sides are likely to deploy thousands of tanks, aircraft and artillery pieces in the struggle for the key city.

Vucic said, *"The West thinks it'll be able to ruin Russia that way, while Russia believes it'll be able to defend what it secured at the start of the war and bring it to an end."*

My point here is that at some point any number of the combatant parties involved will make a mistake, a miscalculation of the situation that will result in the use of a nuclear weapon, and when that occurs the proverbial Rubicon will be crossed and the death of millions will bring on a nuclear winter!

Since my last Blessed Hope, around the end of October of 2022 and like most of you, I grew weary about our still being here. The only thing that I could see was that all the negative events are accelerating to what I refer to as our "Red Sea" moment. I have

The new king of Britain is also the king of quirky behavior, according to new reports. King Charles III will be “*one of the most eccentric sovereigns Great Britain has ever had,*” Mind you, this guy is the Masonic Antichrist! Christopher Andersen, the author of “*The King: The Life of Charles III,*” said in a recent interview, according to *Entertainment Tonight*.

“I think one of the funniest quirks — a number of royals have this, the queen had it as well — they don’t like square ice cubes,” Andersen said. *“They carry around ice cube trays, have them brought with them wherever they go, because they don’t like the clinking sound that square cubes make.”*

Charles “travels with a custom-made toilet seat,” Andersen said. Charles also “travels with a childhood teddy bear,” Andersen said, according to the ‘New York Post’.

Andersen said the teddy bear was guarded by valet Michael Fawcett, and only one nanny could be allowed to mend it.

“The only person who’s been allowed to mend King Charles’ teddy bear is his childhood nanny, Mabel Anderson, who he remains very close to,”

One repair took place when Charles “*was well into his 40s, and every time that teddy needed to be repaired, you would think it was his own child having major surgery,*” Fawcett is quoted as saying in the book.

Valet Ken Stronach said in the book that he would tuck the adult prince into bed and ensure the bear was in its proper place with Charles.

Is King Charles odd?

“So much about Charles you could really trace back to his childhood, which was heart-breakingly lonely,” Andersen said, according to ET. *“Charles has described his relationship with his mother [by saying] that she was cold and aloof, that his father was a bully who hectored him, who made him cry in front of other people, physically bullied him.”*

"I think it's very telling that Charles only spent as a boy ... two 15-minute periods a day [with his parents]," Anderson said. "When he had a tonsillectomy, when he had a very bad case of the flu, when he fell down the stairs and broke his ankle, when he had an emergency appendectomy at the age of 13, neither his mother or his father visited him in the hospital."

Charles called his time at a Scottish boarding school "pure hell," Andersen said.

"What he went through is really quite alarming. As a boy, as a young man, he was routinely beaten by older students, hung up naked in a shower and sprayed with cold water and left there. He was pummeled and wrestled to the ground," Andersen said. "He wrote these pleading letters to his parents to please take him out of the school ... By today's standards, it would be akin to hazing or child abuse frankly, and yet his parents turned a blind eye to it. I think that caused a tremendous resentment."

The book noted one incident of rage when visiting a friend's home in France, according to the 'NY Post'.

"Flying into a blind rage, he pulled the sink off the wall, then smashed it, looking for the cuff link," Andersen wrote in his book. "Unable to find the missing jewelry, a wild-eyed Prince of Wales spun around and grabbed his valet by the throat. Stronach broke free, darted out a side door — and into a linen closet. Terrified, he huddled there for 30 minutes before he could hear Charles leave the bathroom."

The king's bottom line? *"He wants what he wants when he wants it," Andersen explains.*

The 'New York Post' noted that an Amazon Prime documentary, "Serving the Royals: Inside the Firm," offered a window into the royal world of privilege.

The Post noted that staff at Clarence House, where he has lived with Queen Consort Camilla since 2003, refer to him as the "pampered prince."

Charles had "everything done for him," butler Paul Burrell revealed in the documentary. *"His pajamas are pressed every morning. His shoelaces are pressed flat with an iron. The bath plug has to be in a certain position, and the water temperature has to be just tepid," Burrell said.*

The king even *"has his valets squeeze one inch of toothpaste onto his toothbrush every morning."*

Burrell had another anecdote the 'Express' found worth sharing in 2019. *"On one occasion, he [Charles] rang me from his library and he said, 'Oh Paul, a letter from the Queen seems to have fallen into my wastepaper bin. Would you pick it out?'" Burrell said.*

The website 'My London' reported in April about the new king's eating eccentricities.

Citing what it called “a *Royal source*” the site did not name, the site said Charles demands biscuits at a specific temperature.

“Prince Charles enjoys cheese and biscuits at the end of many of his meals. Since he’s particular about everything, he insists that they be a certain temperature. The staff keeps a warming pan just to make sure they are hot enough for his liking,” the site quoted the insider as saying.

This spring, a book by Tina Brown called ‘*The Palace Papers,*’ gave some inside information on the royal family, according to ‘Page Six’.

The book said Fawcett would oversee the “*paraphernalia that preceded his boss like the baggage train of a Tudor traveling court including the Prince’s orthopedic bed, lavatory seat and Kleenex Velvet lavatory paper, plus two landscapes of the Scottish landscapes.*”

“When he traveled to stay at friends’ country houses, a truck arrived the day before, bringing his bed, furniture, and even pictures, which his pampering aide Michael Fawcett ensured would be hung in his allotted bedroom in place of the possessions of his host,” Brown wrote.

Keep in mind that Prince Charles’ lineage is tracked back to King David in the Old Testament. This is of huge significance and Laurence Gardner provided us that geneology for a purpose. The new 100-page analysis, Finance for Climate Action, is presented as an investment blueprint to deliver the Paris climate treaty goals of capping the rise in global temperatures below two degrees Celsius, and at 1.5C if possible.

Economist Nicholas Stern, one of the report's leads., said:

“Rich countries should recognize that it is in their vital self-interest—as well as a matter of justice given the severe impacts caused by their high levels of current and past emissions—to invest in climate action in emerging market and developing countries.”

Stern also authored a landmark report on the economics of climate change.

AFP reports:

[Stern's report] calls for grants and low-interest loans from the governments of developed countries to double from about \$30 billion annually today to \$60 billion by 2025. Keep in mind such grants and loans carry with them catches that will saddle them with requirements from areas such as public health, vaccinations, ID passes, etc.

The authors said:

“These sources of finance are critical for emerging markets and developing countries to support action on restoring land and nature, and for protecting against and responding to the loss and damage due to climate change impacts.”

UN Secretary-General Antonio Guterres has already lamented the world is in peril as never before. He told COP27 delegates the latest State of the Global Climate report is a chronicle of climate chaos.

The UN chief declared: ***“We must answer the planet's distress signal with action—ambitious, credible climate action.”***

Emerging market countries include large economies in the global south that have seen rapid growth—coupled with rising greenhouse gas emissions—in recent decades, including India, Brazil, South Africa, Indonesia, and Vietnam.

Historically seen as part of this group, China was excluded from the new estimates even as it remains one of the world's single greatest polluters and users of coal-generated power. On the world market, China is buying coal, oil, gas, as if it was going out of existence. They buy huge tonnages of coal from Mongolia.

The COP27 climate conference opened last Sunday.

The green agenda event has seen around 40,000 attendees being flown into a seaside resort in Egypt from around the world.

That we call the “Blessed Event” of Titus 2:13: ***“Looking for that blessed hope, and the glorious appearing of the great God and our Saviour Jesus Christ;”***

From everything that we have seen about this coming Antichrist new world and the attempts to GMO everything from tomatos to corn to our DNA does nothing to offer a better life, no matter how eloquent the talking heads run their mouths. The war is on our children now and we are hearing there is a “Tripledemic” coming.

The “tripledeemic” is upon us, according to the mainstream media. What is a “tripledeemic”, you ask?

Apparently, it's when we have simultaneous pandemics of influenza, Covid and RSV at the same time. At least, according to the [LA Times](#) :

A 'tripledeemic' of flu, RSV and COVID is feared in California

And the [Atlantic](#) :

What a 'Tripledemic' Means for Your Body

And [CBS](#):

"Tripledemic" in U.S. could bring deluge of patients to hospitals

All three stories – and there are many others out there too – hit the same handful of talking points.

They report that the flu is back after its "*mysterious*" disappearance during the Covid "*pandemic*" (the *Atlantic* notes U.S. flu cases reduced by well over 90% and calls it "*getting lucky*", the doublethink is unbelievable).

They also warn that Covid is "*still around*" or "*not over*", or some variation on that. However, the main thrust of the fear is reserved for RSV. Now, you're all probably more than familiar with "flu". And you're definitely tired of hearing about Covid. But RSV could be a new one for you... so let me explain.

THE VIRUS

Respiratory syncytial virus (RSV) is – according to virus theory – one of the many viruses circulating in the general population at all times. To quote the Mayo Clinic's website [emphasis added]:

Respiratory syncytial virus (RSV) causes infections of the lungs and respiratory tract. **It's so common that most children have been infected with the virus by age 2.** Respiratory syncytial (sin-SISH-ul) virus can also infect adults. In adults and older, healthy children, **RSV symptoms are mild and typically mimic the common cold.**

And according to the CDC:

Almost all children will have had an RSV infection by their second birthday [...] Most RSV infections go away on their own in a week or two.

So, according to official sources, RSV is not serious in the vast majority of cases, and almost all of us have already had it.

In fact, seeing as the symptoms are both generic and mild, the odds are you have had it multiple times throughout your life and never really known. It's simply one of the many viruses known to cause what we refer to as "the common cold".

THE DECEPTION

There's a trick being played here, and as usual in the age of the "pandemic", it's a trick of language. The powers that be are exploiting linguistic ambiguity in order to generate fear.

Across most of the world, we simply refer to "*a cold*" or "*the flu*" almost interchangeably to describe the dozen or so respiratory infections we all get throughout our lifetime.

Most of the time we don't know what specific virus or bacteria is supposedly the cause, we have no way of finding out and it doesn't make any difference because the symptoms and treatments are all the same: Cough, fever, headache – bedrest, orange juice and painkillers.

Now, essentially, the media are taking advantage of that ubiquitous ambiguity by naming something *that has always been there but pretending it is something new*.

Here's a case in point, the *Scientific American* published [this article on November 4th](#), which headlines:

RSV Is Surging: What We Know about This Common and Surprisingly Dangerous Virus Now, although the headline claims RSV is "surprisingly dangerous", the article seems to go out of its way to prove the opposite.

- *"the virus is so common that nearly all children have encountered it by their second birthday."*
- *"It's that ubiquitous," Flores says. "Even adults are exposed to it repeatedly over time, so we develop some immunity to it."*
- *"In healthy adults and children, though, RSV typically presents as a common cold, with symptoms similar to those caused by other "common cold" viruses, such as rhinovirus, adenovirus and a couple of common coronaviruses."*
- *"For the average person, RSV is little more than a nuisance"*

The article does warn that RSV can be *"particularly dangerous for newborn babies and adults older than age 65"* and the immunocompromised, but **this is true of literally every pathogen**. And even then, they go on to add: only about 1 to 2 percent of children under six months with RSV need hospitalization (usually for a couple of days), and death is rare.

This is a tactic we're all familiar with – it was routine, throughout the Covid narrative, for official voices to tell us to be afraid, whilst simultaneously explaining there was nothing to be afraid of.

This approach clearly serves some purpose, although I could not say for certain what that may be.

Regardless, the deception is obvious and clearly deliberate.

The question is, why?

THE MOTIVE

To sum up – there is no reason to fear RSV infection. The media are clear about that themselves, even if they bury it under layers of hysterical headlines.

It is just one of the many viruses which cause – or are said to cause – cold or flu symptoms, all of which circulate the whole world constantly, especially at this time of year.

There's ALWAYS a “triple-demic”, or a quademic or a septemic. The only difference is **now they are naming it.**

They are taking the routine and pretending it's exceptional simply to try and frighten you.

Why?

Well, rather predictably, to sell vaccines.

Yes, you'll be relieved to know that **just as RSV is hitting the headlines for the first time EVER**, they've also just produced the **first ever vaccines against it.**

On November 1st, [Vox](#) reported:

New RSV vaccines are coming. This is very, very good news.

Which claims:

After decades of failed efforts to produce an RSV vaccine, several highly effective ones are finally on the verge of approval.

On the same day, [Pfizer announced](#) “positive top-line data” for their new RSV vaccine, with [CNN](#) reporting:

After promising trial results for maternal RSV vaccine, Pfizer says it will seek FDA approval this year.

That's right, after decades of trying and dozens of failed attempts, the pharmaceutical companies have finally managed to create not just one **but multiple effective vaccines** against an endemic virus... just as the virus has hit the headlines.

Now, this all sounds rather familiar, doesn't it?

If you didn't fall for this last time you don't need me to warn you.
If you DID fall for this last time?

Well, fool you once shame on them, fool you twice... *shame on you.*

Folks, out of all that has been happening like waves hitting the beach, and I could share even more, we can still trust the Promises of the Lord. **Scripturally speaking, we have to be taken out of this world before Prince Charles signs the “Covenant with the**

Many” and we can see that in 2nd Thessalonians 2:3-7. The text signifies that the Rapture must happen before the revealing of the Antichrist, which marks the beginning of the Tribulation.

“Let no man deceive you by any means: for that day shall not come, except there come a falling away first, and that man of sin be revealed, the son of perdition; Who opposeth and exalteth himself above all that is called God, or that is worshipped; so that he as God sitteth in the temple of God, shewing himself that he is God. Remember ye not, that, when I was yet with you, I told you these things? And now ye know what withholdeth that he might be revealed in his time. For the mystery of iniquity doth already work: only he who now letteth will let, until he be taken out of the way.”

2:3. No matter how logical the false teachers might have seemed, they were still wrong. The Day of the Lord could not have come because there must be a falling away first, and the *"man of sin,"* the *"son of perdition,"* must be revealed. Some take *"first"* in the sense of *"prior,"* that is, before the Day of Christ. A more common meaning of *"first,"* however, is first in a sequence of events. That is, the first thing after the Day of the Lord begins will be the falling away and the revealing of the man of sin. Since these had not happened, the Day of Christ had not yet begun, and the Thessalonians could still expect the Rapture.

Some take the falling away to mean religious apostasy, a great abandonment of spiritual religion that will give the Antichrist opportunity to take over. Others take it to be a rebellion against truth and justice, a defiance of God's authority among all nations.

Dr. E. Schuler English suggests another possibility: that the word *apostasia* has a secondary meaning of *"take away"* and might point to the rapture of the Church. Some ancient manuscripts have *"man of lawlessness"* instead of *"man of sin."* This person will put himself above the law and make his will supreme as an absolute dictator. His reign will be short however. He is also the son of perdition, that is, he is doomed to eternal loss just as Judas was -(John 17:12). This does not mean Judas will come back as the Antichrist.

2:4. Paul wrote that the man of sin will continue long enough to set himself up against *"all that is called God"* (everything divine) and against every object of worship. He will tear down all the established religions of the world and all the minor religions and cults as well. He will claim to be God and will sit personally in the temple of God, claiming it as his possession. *"Temple"* (sanctuary) is used by Paul elsewhere of the Church or the Christians. Thus, some think the Antichrist's temple will be the apostate church. However, the sanctuary here is the Holy Place, and it is better to take it as a literal temple.

2:5. Paul had already explained this in his preaching at Thessalonica, but his explanation is not given here.

2:6. "What withholdeth" (or, "holds back") is in the neuter gender. Many commentators (both ancient and modern) take this to refer to the Roman Empire. Some ancient writers took it to be the preaching of the apostles. But since Paul uses the neuter to refer to the Holy Spirit (because the word *spirit* is neuter), many take it that the power that holds back the revelation of the Antichrist is the Holy Spirit. Having examined the structure of the Greek in this verse, Ellingsworth and Nida offer this translation: "You are experiencing the power which holds the Wicked One back now, so that he will be revealed at the proper time, and not before" ('Helps for Translators', 17:169). However, they are not dogmatic about the precise interpretation of the verse. They agree with Best who states, "No theory can be held to be satisfactory and as Augustine realized long ago ('The City of God', 20:19) we must acknowledge our ignorance" (Black's New Testament Commentaries, 10:301).

2:7. The many contradictory views on this verse emphasize how little any know. Some interpreters of the "historic school" have held that the masculine "he" refers to the Roman emperor, others the apostle Paul, and still others the popes who stepped into the gap after the fall of Rome. Modern post-Tribulationists may think the withholding power is "law and order." Most pre-Tribulationists hold that the neuter form of verse 6 and the masculine form of verse 7, the power and character which "withholdeth" the Antichrist, is the Holy Spirit.

Some pre-Tribulationists believe the power is the Christian Church. During this age the Holy Spirit works through believers, whose bodies are His temples. As a unit believers comprise a temple of the Spirit -(1 Corinthians 3:16; 6:19). Thus the masculine words of verse 7 are thought to refer to the "gathered" believers who are caught up in the Rapture.

At least this much is clear: this passage speaks of a power and/or a person strong enough to withhold Satanic influences, so the man of sin cannot be revealed as long as this power is at work in the world.

Over the past fifty years, which include eleven years of college and seminary education, I have read every published commentary on Paul's two letters to the Thessalonians or obtained photocopies through inter-seminary library lending of published resources, and the consensus is "hands down"; the Restrainer is the Holy Spirit.

That said, our redemption draws nearer each day. No one will be able to write about it when it happens. So be ready all the time as it can happen any time in the near-term future.
