The Blessed Hope!

"Looking for that blessed hope, and the glorious appearing of the great God and our Saviour Jesus Christ;" –(Titus 2:13)

This Blessed Hope segment should be received as a "Wake Up" call to be ready for the event we have waited anxiously so long to happen. It is to inform Bible believing Christians of signs we are witness to in the ramp up to the "Harpazo" itself. The news anywhere and everywhere today is dire and unpleasant, but for those looking for the call to "come up hither" –(Proverbs 25:7; Revelation 4:1; and 11:12) such reports of chaos, wars, and rumors of same should be affirming evidence it is really getting close.

I recall my excitement as a 14-year old when I stood on the train platform at Pittsburgh's Penn Station. Twice I got to spend Christmas vacation with my cousins in Indianapolis, IN. My dad would drive me down to the PRR train station, purchase my round-trip tickets, and within a bit of wait time, we would say our goodbyes and I went out onto the platform area to await the train's arrival. A loud speaker would announce the train's arrival and on the track platform boarding passengers should go to. When the agent opened the sliding doors I quickly crossed the concrete passenger area to find my spot once the train arrived. I would peer into the distance watching for the diesel-electric locomotive's headlight to appear in the distance while train service workers were getting ready to inspect the train and baggage carts were placed in position for what they had to do once the train came to a stop.

As a 14-year old, I had three newspaper routes and saved my earnings and tips all year to accumulate a small stash to make the 400-mile trip all by myself. It was so hard to contain my excitement and it in a small way represented what I feel today about the coming Rapture. I would later go back to the dining car and order my lunch served with fine crystal and linen napkins. Today, I find it a bit humorous that visitors in Bardstown, KY pay \$98 a pop to ride and dine on the "My Old Kentucky Dinner Train" twenty-miles and back with all the accourrements when travel by train was the only way to travel in style.

A few days ago Dr. Barry Awe did an hour post on his You Tube channel making a case for Hanukkah this year as a "high watch" date for the Rapture. This year Hanukkah begins at sundown of December 24th, 2022. On Sunday, December 25th eight candles are lit. Genesis 41:1-44:17; 1st Kings 3:15-4:1; and Luke 24:13-29 tells the story of Hanukkah. While not part of the Leviticus seven "Feasts of the Lord" pattern or theme, nonetheless Hanukkah is often recognized as the 8th major event in the history of the

ZZZ The fact that it is not understood as a major day like Passover, Pentecost or Yom Kippur, might be worth a closer look see! It just might turn out to be a "sleeper" day for the Rapture. Since viewing Dr. Barry's video, I have been looking closer at its nuances and suggestive patterns. It does leave us with some hope!

That said let's delve into some of what has been happening that raises the "watch" level! I pray daily that God intervenes very soon – "And except those days should be shortened, there should no flesh be saved: but for the elect's sake those days shall be shortened." –(Matthew 24:22) The "elect" in the New Testament usually refers to those who accept God's invitation and place their faith in Jesus. But many who see this passage dealing with the suffering of the siege of 70 AD, as well as most of those who see it dealing with Daniel's 70th week, believe the "elect," used in this verse, means the Jews. The world deserves extended judgment for its sins. "But for the elect's sake," the days of this horrible tribulation will be shortened.

"And except that the Lord had shortened those days, no flesh should be saved: but for the elect's sake, whom he hath chosen, he hath shortened the days." - (Mark 13:20) Again, Jesus was speaking both of the days of the destruction of Jerusalem and of the time of the Great Tribulation. The actual siege on Jerusalem lasted 5 months. Historians have recorded that if it had lasted much longer, the entire population of Jerusalem would have perished. "The elect" in the immediate context refers to Israel. Because of God's covenant with Abraham and with David, it was not possible that the Jews would be exterminated.

This Scripture also refers to the Great Tribulation, as seen by verses 24-27. Under conditions described in Revelation 13 to 18, it is easy to see that only the Lord has the power to preserve the human race. God's sovereign plan has already determined that those days will be shortened. Special protection will be given to Israel -(Revelation 12); the natural branches of the olive tree of Romans 11 will be grafted back in. God's provision is for Israel in particular and for the human race in general.

I focus on these two passages of Matthew 24:22 and Mark 13:20 specifically here as being illustrative of how God uses many passages that have multiple fulfillments to speak to different eras; which by the way validates the Dispensational approach in understanding the Bible. The Bible has many passages containing double fulfillments, but fewer containing triple fulfillments. In a few very rare situations we know of four fulfillments. The Bible is "alive" in terms relative to how we identify as "Chronos" time versus "Kairos" time.

In view of the growing desperate situation that now exists around the world, the question is being asked, "Why doesn't God do something?" Others more reverently say, "God must do something!" Some belligerently say, "If God exists, why doesn't He act." And since He has not acted, some are concluding that He does not exist, and a few have declared that God is dead. The World Economic Forum cofounder Klaus Schwab said about the time of Thanksgiving holiday that God is dead and Jesus is fake news.

The Biblical answer to all such questions and statements is that GOD IS GOING TO INTERVENE. In His own time and in His own way He will intervene. At times we would like to ask Him to hurry it up, especially as the terrors of these times seem to draw nearer to us personally. But we should not do this. He has promised in His Word that He will act. The Bible reveals that it is His purpose to inject Himself positively and manifestly into the flow of human history, to reverse that flow and turn it toward Himself. He speaks of a time when: "Evildoers shall be cut off" -(Psalm 37:9); when He shall: "break the strength of evil and wicked men, and bring their wickedness to an end" -(Psalm 10:15). He has promised that He will assume sovereignty, that the government will be His, and that He will be the governor among the nations -(Psalm 22:28); and tells of a time when He will speak from heaven and cause wars to cease to the ends of the earth, destroying all instruments of war by a word from His mouth - (Psalm 46:6-10). He declares that He will stop the flow of iniquity, especially that which flows from the mouth of men -(Psalm 107:2).

The days leading up to the Pre-Tribulation Rapture have been so saturated by evil and an interview between David Martin and Seth Holehouse, host of the 'Man in America' site discuss the immediate future that lies ahead for the next five years is something that all Christian believers should view. Whether or not you have completed your delivery, please immediately return equipment, inventory, and delivery documents for those deliveries that have been completed to one of the following locations: Winston-Salem, N.C., Verona, Miss., or Victorville, Calif. location. To be clear, do not complete any additional deliveries.

APOSTATE RELIGION CALLS EVIL GOOD

SALT LAKE CITY (AP) — The Church of Jesus Christ of Latter-day Saints said Tuesday it would back proposed federal legislation to safeguard same-sex marriages, marking the latest show of support for the measure from conservative-leaning groups.

The nearly 17-million member Utah-based faith said in a statement that church doctrine would continue to consider same-sex relationships to be against God's commandments. Yet it said it would support rights for same-sex couples as long as they didn't infringe upon religious groups' right to believe as they choose.

"We believe this approach is the way forward. As we work together to preserve the principles and practices of religious freedom together with the rights of LGBTQ individuals much can be accomplished to heal relationships and foster greater understanding," the church said in a statement posted on its website.

Support for the disgusting Respect for Marriage Act under consideration in Congress is the church's latest step to stake out a more welcoming stance toward the LGBTQ community while holding firm to its belief that same-sex relationships are sinful. Still, its stance toward LGBTQ people — including those who grow up in the church — remains painful for many.

The current crisis of faith goes hand in hand with the decline of morality. People are losing not only their conscience but also their common sense. As a result, they themselves commit moral, spiritual, and even physical suicide. We see this today in the implementation of the ideology of depopulation. What will then be the good of cyborgs or artificial intelligence promising false immortality? What will be the good of pharmaceutics or medicine if instead of medication we will be given means of gradual self-destruction because everything will be in the hands of depopulation architects? David Bell, Senior Scholar at Brownstone Institute says:

"We are assured by the **World Health Organization** (WHO), the **World Bank**, **the G20**, and **their** friends that pandemics pose an existential threat to our survival and well-being. Pandemics are becoming more common, and if we don't move urgently we will have ourselves to blame for more mass death of the 'next pandemic'."

The proof of this is the catastrophic harm done to the world by COVID-19, a repeat of which can only be prevented by transferring unprecedented funds and decision-making power to the care of public health institutions and their corporate partners. They have the resources, experience, knowledge and technical know-how to keep us safe.

This is a no-brainer, all of it, and only a fool who desires mass death would oppose it. But there are still people who claim that the link between the public health establishment and large corporations appears to be the only part of this narrative that withstands scrutiny.

"If true, this would imply that we are being systematically deceived by our leaders, the health establishment, and most of our media; a ludicrous allegation in a free and democratic society. Only a fascist or otherwise totalitarian regime could run such a broad and inclusive deception, and only people with truly bad intent could nurture it.

So let's hope such 'appearances' are deceptive. To believe that the premise behind our leaders' Pandemic Preparedness and Response agenda is knowingly based on a set of complete fabrications would be a conspiracy theory too far. It would be too uncomfortable to accept that we are being deliberately misled by people we elected and the health establishment we trust; that the assurances of inclusivity, equity and tolerance are mere facades hiding fascists. We should examine the key claims supporting the pandemic agenda carefully and hope to find them credible."

Myth #1: Pandemics are becoming more common

In its 2019 pandemic influenza guidelines, the WHO listed **3 pandemics** in the century between the 1918-20 Spanish flu and COVID-19. The Spanish flu killed mainly through secondary **bacterial infections** at a time before modern antibiotics. Today we would expect most of these people, many relatively young and fit, to survive.

The WHO subsequently recorded pandemic flu outbreaks in 1957-58 ('Asian flu') and 1968-69 ('Hong Kong flu'). The Swine flu outbreak that occurred in 2009 was classed by WHO as a 'pandemic' but caused just 125,000 to 250,000 deaths. This is far less than a normal flu year and so hardly deserving of the pandemic label. Then we had COVID-19. That's it for a whole century; one outbreak the WHO classifies as a pandemic per generation. Rare, or at least highly unusual, events!

Myth #2: Pandemics are a major cause of death

The Black Death, the Bubonic Plague that **swept Europe** in the 1300s, killed perhaps a third of the entire population. Repeat outbreaks over the following centuries caused

similar harm, as had plagues known from **Greek and Roman** times. Even the Spanish flu did not compare with these. Life changed prior to antibiotics – including nutrition, accommodation, ventilation and sanitation – and these mass-mortality events subsided. Since the Spanish flu we have developed an array of antibiotics that remain extremely effective against community-acquired pneumonia. Fit young people still die from influenza through secondary bacterial infection, but this is rare.

The **WHO** tells us there were 1.1 million deaths from the 1957-58 'Asian flu,' and a million from the 1968-69 Hong Kong flu. In context, seasonal influenza kills between **250,000** and **650,000** people every year. As the global population was 3 to 3.5 billion when these two pandemics occurred, they classify as bad flu years killing about 1 in 700 mostly elderly people, with little influence on total deaths. They were treated as such, with the Woodstock Festival proceeding without super-spreader panic (regarding the virus, at least...).

COVID-19 has a higher associated mortality, but at an **old average age** equivalent to that of all-cause mortality, and is nearly always **associated** with **comorbidities**. Much mortality also occurred in the presence of the withdrawal of normal supportive care such as close nursing and physiotherapy, and **intubation practices** may have played a role.

Of the 6.5 million that the WHO records as dying from COVID-19, we don't know how many would have died anyway from cancer, heart disease or the complications of diabetes mellitus and just happening to have a positive SARS-CoV-2 PCR result. We don't know because most authorities decided not to check, but recorded such deaths as being due to COVID-19. The WHO records about 15 million excess deaths throughout the COVID-19 pandemic, but this includes lockdown deaths (malnutrition, rising infectious disease, neonatal death, etc.).

If we take the **6.5 million** toll as likely, we can understand its context by comparing it with tuberculosis, a globally endemic respiratory disease that few worry about in their day-to-day lives. Tuberculosis kills about 1.5 million people every year, which is almost half the annual COVID-19 toll in 2020 and 2021. Tuberculosis kills **far younger** on average than COVID, removing more potential life-years with each death.

So based on normal metrics for disease burden, we could say they are roughly equivalent – COVID-19 has had an impact on life expectancy overall fairly similar to TB – worse in older populations in Western countries, far less in **low-income countries**. Even in the U.S. COVID-19 was associated with less (and older) deaths in 2020-21 than normally occur from cancer and cardiovascular disease.

COVID-19 has not therefore been an existential threat to the life of many people. The infection mortality rate globally is probably around **0.15%**, higher in the elderly, much lower in healthy young adults and children. It is not unreasonable to think that if standard medical knowledge had been followed, such as physiotherapy and mobility for frail elderly people and **micronutrient supplementation** for those at risk, the mortality rate may have been even lower.

Whatever one's views on COVID-19 death definitions and management, it is unavoidable that death is rare in healthy younger people. Over the past century all pandemic deaths have been very low. Averaging less than 100,000 people per year inclusive of COVID-19, they are a small fraction of that caused by seasonal flu.

Myth #3: Diversion of resource to pandemic preparedness makes public health sense

The G20 has just agreed with the World Bank to allocate \$10.5 billion annually to its pandemic prevention and response Financial Intermediary Fund (FIF). There is, in their view, about \$50 billion needed in total per year. This is the annual, holding budget for pandemic preparedness. As an example of their preferred response when an outbreak occurs, Yale University modelers estimate that to vaccinate people in low and middle income countries with just 2 doses of COVID-19 vaccine would cost about \$35 billion. Adding one booster would total \$61 billion. Over \$7 billion has thus far been committed to COVAX, the WHO's Covid vaccine financing facility, vaccinating most who are already immune to the virus.

To put these sums in context, the annual budget of the WHO is normally below \$4 billion. The entire world spends about \$3 billion annually on malaria – a disease that kills well over half a million young children each year. The largest financing facility for tuberculosis, HIV/AIDS and malaria, the Global Fund, spends less than \$4 billion per year on these three diseases combined. Other and larger preventable killers of children, – such as pneumonia and diarrhea, receive still less attention.

Malaria, HIV, tuberculosis and diseases of malnutrition are all increasing, while economies globally – the main long-term determinant of life expectancy in lower-income countries – decline. Taxpayers are being asked, by institutions that themselves will benefit, to spend vast resources on this problem rather than on diseases that kill more and younger people. The people pushing this agenda do not appear to be dedicated to reducing annual mortality or improving overall health. Alternatively, they either cannot manage data or have a window on the future that they are keeping to themselves.

Myth #4: COVID-19 caused massive harm to health and the global economy

The age-skewing of COVID mortality has been unmistakable since early 2020, when data from China demonstrated almost no mortality in healthy young to middle-aged adults and children. This has not changed. Those contributing to economic activity, working in factories, farms and transport, were never at great risk.

The economic and personal harm arising from the restrictions on these people, unemployment, destruction of small businesses and supply-line disruption, was a choice made against **orthodox policy** of the WHO and public health in general. The prolonged school closures, locking in generational poverty and inequality on both a sub-national and international level, was a choice to perhaps buy months for the elderly.

The 2019 WHO pandemic guidelines advised against lockdowns due to the inevitability that they would increase poverty, and poverty drives illness and reduces life

expectancy. The WHO noted this disproportionately harms poorer people. This is not complicated – even those at the center of the lockdown and future digital ID agenda such as the **Bank of International Settlements** (BIS) acknowledge this reality. If the aim of poverty-promoting measures had been to reduce elderly death, the evidence for success **is poor**.

There seems little reasonable doubt that growing **malnutrition** and **long-term poverty**, rising **endemic infectious** disease, and the impacts of **education loss**, increased **child marriage** and increased **inequality** will far outweigh any possible mortality reduction achieved. UNICEF's **estimation** of a quarter-million child deaths from lockdowns in South Asia in 2020 provides a window into the enormity of the harm lockdowns wrought. It was the novel public health response that caused the massive harm associated with this historically mild pandemic, not the virus.

Facing Truth

It seems unavoidable that those advocating for the current pandemic and preparedness agenda are intentionally misleading the public in order to achieve their aims. This explains why, in the background documents of the WHO, the World Bank, G20 and others, detailed cost-benefit analyses are avoided. The same absence of this basic requirement characterized the introduction of Covid lockdowns.

Cost-benefit analyses are essential for any large-scale intervention, and their absence reflects either incompetence or malfeasance. Prior to 2019, the resource diversion being contemplated for pandemic preparedness would have been unthinkable without such analysis. We can therefore reasonably assume that their continued absence is based on fear or certainty that their outcomes would scupper the program.

A lot of people who should know better are going along with this deceit. Their motives can be **surmised elsewhere**. Additional ammunition for HIMARS

200 precision-guided 155mm artillery rounds

10,000 120mm mortar rounds

High-speed Anti-radiation missiles (HARMs)

150 High Mobility Multipurpose Wheeled Vehicles (HMMWVs)

Over 100 light tactical vehicles

Over 20,000,000 rounds of small arms ammunition

Over 200 generators

Spare parts for 105mm Howitzers and other equipment

The \$400 million is being sent to Ukraine through the Presidential Drawdown Authority (PDA), which allows President Biden to send arms straight from US military stockpiles.

The Pentagon is clearly scraping the bottom of the barrel.

Additional munitions for NASMAS

NASMAS is an air defense systems that uses re-purposed air to air missiles (active radar homing AIM-120 AMRAAM) in a ground to air mode.

Yesterday one of those missiles was used in Kiev but missed its target. It hit an apartment block and killed several people:

The missile that hit an apartment block in Kiev today was a U.S.-made AIM-120C launched from one of the newly arrived NASMAS air defense systems, donated to Ukraine in the last months. Local people shared on social media photos of the wreckage of the missile. Even though Ukraine blamed Russia for the strike, it turns out the missile was not Russian but American and was fired by Ukrainian troops. The fragment shown in the photo has the word LIFT as the American AIM-120C. This is an anti-aircraft missile for the NASAMS systems which were recently donated to Ukraine. By analyzing the photos which Ukrainian citizens published themselves the missile which hit their residential building can be easily identified as American.

Heavy machine guns with thermal image sights against drones.

This is a really bad sign. I have tried to find recent photos of machine guns used in air defense mode. There were only antique ones plus this model picture.



Several decades ago we trained to shoot down helicopters and planes with the machine guns attached to the top of our battle tanks. Despite firing from a stable platform and spending lots of ammunition our hit rates were really lousy. That's why no army I know of is still using this method. Most of the UAV's used in Ukraine for reconnaissance are electrical. They are unlikely to show up in a thermal sight. The propeller driven Iranian drones, probably made in Russia, are hot and make a lot of noise. They can be targeted but are reasonably fast and one has to act equally fast to get them. The Lancet kamikaze drones used by the Russian military in Ukraine fly low and fast. A machine gun team will have little chances when such a drones flies towards it.

Those machine guns Ukraine will get, minus those to be sold on the black market, cannot be effective as air defense. They will likely end up to be used in a ground mode to defend this or that frontline ditch. They are good for that until some artillery round or infantry fighting vehicle comes along and takes them out.

Additional ammunition for HIMARS

HIMARS is the wonder weapon that wasn't. The reach of some 70 kilometers is reasonable but one also needs very good targeting data to put them to use. The Russians have learned from the early HIMARS successes and have become much better now with camouflaging their positions.

200 precision-guided 155mm artillery rounds

Nice to have – but again only if you have reliable targeting data. What is shocking is that there is no other 155 mm ammunition in this delivery. What are those M-777 guns that still exist in Ukraine supposed to fire?

10,000 120mm mortar rounds

That's not a lot either. Previously the U.S. had given Ukraine 20 120 mm mortar with 135,000 120mm mortar rounds. The 10,000 new rounds will likely be expended in less than a week.

High-speed Anti-radiation missiles (HARMs)

These are air to ground missiles used to target enemy radar. They have been jury rigged to fit on the few SU-27 fighter jets the Ukraine has received from some east European country. There have been reports that Russian air defenses usually hit these missiles before they reach their target.

Today the *New York Times* reported that one such missile, fired back in September, had hit an apartment building in Kramatorsk:

New York Times journalists were able to gather and identify distinct metal fragments left behind at the site of an earlier strike, in September in eastern Ukraine, providing a window into where the billions of dollars of United States' military aid sent to Ukraine can sometimes land. "Three people got wounded, they say. No dead. It hit the apartment where no one lives, and in the next one, people got hurt," said Olga Vasylivna, a resident who lived adjacent to where the missile hit.

The trucks Ukraine will get may be useful but will there be enough diesel to fuel them?

20,000,000 rounds of small arms ammunition is again practically nothing. The typical combat load for one infantry soldier is 240 rounds. Machine gun teams carry some 6,000 rounds. The frontline in Ukraine is 1,000 kilometer long. When one does the math one finds that these 20,000,000 rounds are practically nothing.

There is currently a roaring black market for generators in Ukraine. Those 200 new ones will be very welcome. They will most likely end up in Lviv or Kiev.

Spare parts for 105mm Howitzers and other equipment
The story of the U.S. weapon support for Ukraine is one of diminishing quantity and
quality. First the U.S. gave 143 M-777 155 mm systems to Ukraine. These proved to
have a high breakage rate and were also easily targeted. Then the U.S. had run out of
155 mm ammunition it could give away. It next offered 36 105 mm howitzers and
180,000 105mm rounds. Same story. After that came the 120 mm mortar.

Artillery is usually fought against with counter artillery. When battle radar pics up a flying artillery round one can calculate where it's has been fired from. Then a dedicated counter artillery battery, usually with longer range, will be tasked to fire at that position. In a good organized unit that takes less than one or two minutes.

The M-777 guns have a firing range of about 20 kilometers. That is somewhat equal to 152 mm guns the Russians are using. The 105 mm guns came next. Their range is about 11 kilometer. The 120 mm mortar can reach about 7 kilometer.

Aside from HIMARS Ukraine's front artillery has become smaller with less reach than those systems used on the other side. That will make it easier to counter it. Ukraine also has an acute lack of ammunition for those few weapons that still exist. It has long lost the artillery war.

The war in Ukraine is waged on an industrial level. But the 'west' and its Ukrainian proxy are not prepared for industrial warfare. In a longer piece – It's War, Josip, But Not As We Know It – Aurelian explains why that is the case:

First, much of the policy impetus on Ukraine comes from Anglo-Saxon countries, whose history of warfare, and thinking about warfare, is essentially expeditionary and limited.

The type of military operations that Europeans have actually conducted since 1945, and especially since 1989, have tended to follow this model.

The second factor is simply that in general the West's wars have been limited liability ones, where there have been few casualties at home.

For the Russians, geography mandated a different set of criteria. Always a massive

country with a relatively large population and long borders, the nation has suffered foreign military invasions repeatedly in its history. It is used to being obliged to fight on its own territory, and in World War II alone, suffered nearly thirty million dead, a large proportion of them civilians. Thus, national defense is literally a life and death issue, and thinking about, and planning for, war, takes place at a massively higher and more complex strategic level.

This Russian experience inevitably produces a way of looking at conflict which is radically different from western one, with the proviso that the West itself has had to painfully learn similar lessons during two World Wars, only to promptly forget them each time.

The Soviet and Russian militaries have a long tradition of studying the terrible past wars of their country, and there are a number obvious conclusions from any such analysis. One is the importance of sheer numbers, of personnel, of equipment and ammunition. In a long war, which the Russians, unlike the West, have always expected to fight, these things matter a great deal.

Up to 2012 there was a Ukrainian company near Kiev which still produced artillery rounds for Russia. I no longer find the link to that story but the numbers produced for Russia was some 2,000,000 million per year. There is no way the 'west' can match the Russian stockpiles.

Russia expert Gordon M. Hahn looks at the upcoming Russian Winter Offensive. Only with a ceasefire can Ukraine and its sponsors avert the upcoming catastrophe. This for three reasons:

First, the Russian hammer is about to fall on Ukraine. The gloves are coming off; electric energy stations, bridges, and even 'decision centers' such as central Kiev's government buildings are being targeted. ... What will the sociopolitical situation be like when these critical infrastructures are in complete collapse and temperatures are 20 degrees colder? Russia will be moving closer to the strategy of 'shock and awe', fully destroying all infrastructure – military or otherwise – as the U.S. did in Serbia and Iraq and will likely take less care now to avoid civilian casualties. After the infrastructures are completely destroyed or incapacitated, Russia's reinforcements of 380,000 regular and newly mobilized troops will have been fully added into Russia's forces across southeastern Ukraine. ... A winter offensive by some half a million troops will make substantial gains on those three fronts and multiply Ukrainian losses in personnel and materiel', which are already high. This could lead easily to a collapse of Ukrainian forces on one or more front. On the backs of such a success Russian President Putin might also make another attempt to threaten Kiev ...

Second, the West is suffering from Ukraine fatigue. NATO countries' arms supplies have been depleted beyond what is tolerable, and social cohesion is collapsing in the face of double-digit inflation and economic recession. All this makes Russia the winner

on the strategic level and is forcing Washington and Brussels to seek at least a breathing spell by way of a ceasefire.

Third, Ukraine's greatest political asset – Zelenskiy himself – just got devalued, putting at even greater risk Ukraine's political stability. ... For now, in order to keep the West on board, Zelenskiy is rumored to be pushing Ukrainian armed forces commander Viktor Zalyuzhniy to start a last pre-winter offensive in northern Donetsk (Svatovo and Severodonetsk) or Zaporozhe in order to put a stop to the West's ceasefire murmurs and reboost support. At the same time there is talk of continuing Zelenskiy-Zalyuzhniy tensions over the latter's good press and star status in the West. ... On the background of the deteriorating battlefield and international strategic situation, such civil-military tensions are fraught with the potential for a coup. ...

We may be reaching the watershed moment in the Ukrainian war. No electricity, no army, no society.

All of the above and the approaching presidential elections scheduled in Moscow, Kiev and Washington the year after next make this winter pivotal for all the war's main parties.

Reading the two pieces I have quoted above it is easy to say that we can come to the conclusion the war has been lost – by Ukraine as well as by its supporters.

NATO, already deeply involved, could still want to change that by fully joining the war. But I do not think that the U.S. military, nor its European NATO allies will have the stomach for that. "The [project] will also test the feasibility of a programmable digital money design that is potentially extensible to other digital assets, as well as the viability of the proposed system within existing laws and regulations," according to the news release. The news comes as cryptocurrency and blockchain technology have exploded to prominence in the mainstream financial world. While the flagship cryptocurrency bitcoin peaked a year ago and has since been in precipitous decline, the technology behind such tokens has attracted interest from not only private financial institutions but also central banks across the globe. The paper said that a CBDC could streamline cross-border payments and could further enshrine and preserve the dominance of the dollar's international role, including as the world's reserve currency. The global population was projected to reach 8 billion on 15 November 2022, and India is projected to surpass China as the world's most populous country in 2023, according to *World Population Prospects* 2022, released today on World Population Day.

"This year's World Population Day falls during a milestone year, when we anticipate the birth of the Earth's eight billionth inhabitant. This is an occasion to celebrate our diversity, recognize our common humanity, and marvel at advancements in health that have extended lifespans and dramatically reduced maternal and child mortality rates," said UN Secretary-General António Guterres. "At the same time, it is a reminder of our shared responsibility to care for our planet and a moment to reflect on where we still fall short of our commitments to one another," he added.

The global population is growing at its slowest rate since 1950, having fallen under 1 per cent in 2020. The latest projections by the United Nations suggest that the world's population could grow to around 8.5 billion in 2030 and 9.7 billion in 2050. It is projected to reach a peak of around 10.4 billion people during the 2080s and to remain at that level until 2100.

World Population Prospects 2022 also states that fertility has fallen markedly in recent decades for many countries. Today, two-thirds of the global population lives in a country or area where lifetime fertility is below 2.1 births per woman, roughly the level required for zero growth in the long run for a population with low mortality. The populations of 61 countries or areas are projected to decrease by 1 per cent or more between 2022 and 2050, owing to sustained low levels of fertility and, in some cases, elevated rates of emigration.

More than half of the projected increase in the global population up to 2050 will be concentrated in eight countries: the Democratic Republic of the Congo, Egypt, Ethiopia, India, Nigeria, Pakistan, the Philippines and the United Republic of Tanzania. Countries of sub-Saharan Africa are expected to contribute more than half of the increase anticipated through 2050.

"The relationship between population growth and sustainable development is complex and multidimensional" said Liu Zhenmin, UN Under-Secretary-General for Economic and Social Affairs. "Rapid population growth makes eradicating poverty, combatting hunger and malnutrition, and increasing the coverage of health and education systems more difficult.

Conversely, achieving the Sustainable Development Goals, especially those related to health, education and gender equality, will contribute to reducing fertility levels and slowing global population growth."

In most countries of sub-Saharan Africa, as well as in parts of Asia and Latin America and the Caribbean, the share of population at working age (between 25 and 64 years) has been increasing thanks to recent reductions in fertility. This shift in the age distribution provides a time-bound opportunity for accelerated economic growth per capita, known as the "demographic dividend". To maximize the potential benefits of a favourable age distribution, countries should invest in the further development of their human capital by ensuring access to health care and quality education at all ages and by promoting opportunities for productive employment and decent work.

The share of global population at ages 65 and above is projected to rise from 10 per cent in 2022 to 16 per cent in 2050. At that point, it is expected that the number of persons aged 65 years or over worldwide will be more than twice the number of children under age 5 and about the same as the number under age 12. Countries with ageing populations should take steps to adapt public programmes to the growing numbers of older persons, including by establishing universal health care and long-term care systems and by improving the sustainability of social security and pension systems.

Global life expectancy at birth reached 72.8 years in 2019, an improvement of almost 9 years since 1990. Further reductions in mortality are projected to result in an average global longevity of around 77.2 years in 2050. Yet in 2021, life expectancy for the least developed countries lagged 7 years behind the global average.

The COVID-19 pandemic has affected all three components of population change. Global life expectancy at birth fell to 71.0 years in 2021. In some countries, successive waves of the pandemic may have produced short-term reductions in numbers of pregnancies and births, while for many other countries, there is little evidence of an impact on fertility levels or trends. The pandemic severely restricted all forms of human mobility, including international migration.

"Further actions by Governments aimed at reducing fertility would have little impact on the pace of population growth between now and mid-century, because of the youthful age structure of today's global population. Nevertheless, the cumulative effect of lower fertility, if maintained over several decades, could be a more substantial deceleration of global population growth in the second half of the century," added John Wilmoth, Director of the Population Division of the United Nations Department of Economic and Social Affairs.

Moscow stands alone in its battle against the US-led NATO military bloc and is capable of vanquishing its enemies on its own, Russia's former president Dmitry Medvedev has said.

"Russia alone is fighting NATO and the Western world," Medvedev, who is the deputy head of the nation's Security Council and the leader of the ruling United Russia party, wrote on his Telegram channel on Saturday.

"We are capable of destroying a mighty enemy or alliances of enemies by ourselves," the former president stated, adding that during its military activities Moscow is seeking to preserve the lives of its soldiers and civilians. Medvedev wrote that Russia has not yet used "its full arsenal" of weapons and has not struck "all potential enemy targets." He added that "there is time for everything." Russia can set the agenda for Ukraine's demise.

"It is Russia who today is forming the future world order," the ex-president argued, stressing that "this new equitable world order will be formed."

Medvedev's words come amid Kiev's increasing reliance on Western military and financial assistance in the ongoing conflict. The U.S., together with the EU and several other countries, imposed sweeping sanctions on Russia after Moscow launched its military operation in late February.

Make no mistake about it, for the West, Ukraine is a proxy war for the NATO/U.S. on behalf of the WEF and its Illuminati Masonic/Jesuit-controlled Vatican.

The Ex-Russian president names key reason for the Ukraine conflict. Kiev has received massive military assistance from the West during the conflict. The U.S. announced an additional \$1.1 billion for Ukraine in September, bringing the total amount of military aid for the country to nearly \$17 billion since President Joe Biden took office in early 2021. Even that figure is grossly under-quoted, it is closer to \$100 billion of your tax dollars!

Russia sent troops into Ukraine on February 24, citing Kiev's failure to implement the Minsk agreements, designed to give the regions of Donetsk and Lugansk special status within the Ukrainian state. The protocols, brokered by Germany and France, were first signed in 2014. Former Ukrainian president Pyotr Poroshenko has since admitted that Kiev's main goal was to use the ceasefire to buy time and "create powerful armed forces."

In February 2022, the Kremlin recognized the Donbass republics as independent states and demanded that Ukraine officially declare itself a neutral country that will never join any Western military bloc. Kiev insists the Russian offensive was completely unprovoked.

In early October, the Donetsk and Lugansk People's Republics, as well as Zaporozhye and Kherson Regions, officially became part of Russia following referendums that saw the majority of local residents vote in favor of accession. The residents of those four Republics voted between 92% and 97% in favor annexation by Russia.

The Apostle Paul taught that there are two unmistakable signs when the judgment of the world had commenced. The first was the Rapture of the Church and the second was the revelation of the the Antichrist. This is the name we use to identify the last world dictator, called by Paul, "that man of sin". Many people in history have been identified as the Antichrist because they have been against God. But "anti" also means "instead of". This man will not only be anti-God, but he will demand universal worshiped instead of God. And just because I know the identity of "THE" Antichrist does not mean the rest of the world knows Prince Charles is THE Antichrist. The rest of the world is not awake to the fact that we are at the End Days!

In previous segments of this series as well as other articles, I have noted with an abundance of evidence that Prince Charles of Wales, now King of England, is "that man of sin". My analysis is that old "sausage fingers" is close to signing the Daniel 9:27 Covenant. Actually it is a "reconfirmation" of the former 1993/94 Oslo Accords. "And he shall confirm the covenant with many for one week:" To "confirm" simply means the Treaty/Covenant/Accords already "exists"! As an example, you may have set a date for lunch with someone weeks prior to the event and you call to touch base with your friend to make sure they did not forgot your lunch date. God's Word is very clear as to the origin of the Antichrist; he arises as head of a revived Roman Empire. In chapter 7 of the Book of Daniel, when introduced to the fourth beast representing the Roman Empire, Daniel was told that the ten horns on its head represented ten kings that will rule this kingdom and that "another shall rise after them". He would "speak great words against the most High, and shall wear out the saints (the Jewish people) of the most High...and they (the Jewish people) shall be given into his hand until a time and times and the dividing of time" -(Daniel 7:25).

Antichrist's first appearance in the Book of Revelation is as the first seal judgment is opened at the beginning of the Tribulation -(Revelation 6:2). Here he is seen as a rider on a white horse going forth "conquering, and to conquer". The rider has a bow but no arrow, indicating that his rise to power will be by peaceful means. A crown is "given to him" meaning that men will submit to him. As a Bible-believing Christian who watches geo-politics intently, I know I am anticipating the Rapture in the short-view of what is occurring now.
