#### \$\$\$Trillions at His Disposal!

Who do you suppose Prince Charles was referring to when he made that statement "A vast military style campaign to marshal the strength of the global private sector with trillions at HIS disposal?" at the UN Climate Change Conference COP26 meetings in Glasgow, Scotland in late 2021. I try to stay on top of news coming out of Buckingham Palace as best I can. I read closely the UK media on the Royal Family and the press on the Prince. Something that occurred the other day struck me as somewhat strange. I will get to that shortly but a little background is important in framing this picture.


There was a report that the Ukrainian President Zelensky was in London to make his case begging for UK jet fighter aircraft. It is a known fact that the UK has been in the forefront of championing the cause of the Ukraine, but why so is another issue. The UK has a historic reputation for edging on states needing a push to go to war or cheerleading from the sidelines if you know what I am referring to.

London, and Sussex is the home of the Tavistock Institute. At the turn of the 20<sup>th</sup> century, the Brits groomed Adolph Hitler, and a few years later they did the same with Joseph Stalin. Hitler historians note a period between a year and two years that cannot be accounted for in Hitler's background.

Stalin and Hitler were both tools of the Tavistock Institute and groomed to destroy both Germany and Russia with as little damage as possible to Rome and London. It worked very well. Now it appears the goal is the same once again, Germany with their technology cannot befriend Russia with their military and vast resources. So we have had mass immigration to Germany since Jorge Mario Bergoglio was elected pope in March, 2013. It was a German pope (Benedict XVI / Joseph Aloisius Ratzinger) that was pressured to retire, and I use the word "pressured" in the mildest of terms.

No German technology to Russia, in fact no Germans, no problem. The Germans are to be bred out of existence through mass immigration and a European super state created with a population that knows no national identity. Yes Hitler was a Rothschild and Stalin was a Jesuit priest. The goal is the same, the technique and methodology only change.

In 1912, Hitler traveled to England for training as an Illuminati agent which took place in German. This "training" ranged from imbibing a sense of his role in Germany's destiny to learning how to mesmerize audiences.



It also included trauma brainwashing. The "alter's" consciousness is shattered by witnessing savage atrocities and suffering sexual abuse, all of which is filmed. Then the various fragments of consciousness are programmed and can be accessed with special code words.

Hitler returned to Germany in May 1913 and enlisted in the German army. During World War One, he served as a runner and was captured twice by the English. On both occasions, he was spared execution by an "angel" in British intelligence.

In my opening paragraph I noted something somewhat very strange had occurred. In news reports originating from the UK, it was mentioned that Ukraine President Zelensky had an audience with Prince Charles. This was confirmed by three different sources and that they met Wednesday morning, February 8<sup>th</sup>, 2023 in the 1844 room of Buckingham Palace. He was welcomed at the Palace as a "Hero". Although the meeting was their first official meeting, Charles has supported Ukraine in its war with Russia.

The rise to power by Ukrainian President Volodymyr Zelenskyy by the way is nearly as strange as was that of Adolph Hitler. We are told that Zelensky met with King Charles for the first time as he made a surprise visit to the UK.

The pair shook hands at Buckingham Palace and the King held an audience with Mr. Zelensky for the first time since the outbreak of war in Ukraine last year.



The surprise trip was only announced at the last minute, with Mr. Zelensky arriving at Gatwick Airport. Mr. Zelensky gave a speech in front of a packed Westminster Hall, before gifting a helmet from a Ukrainian fighter pilot with the words "We have freedom, give us wings to protect it." He said victory over Russia 'will change the world' in his historic address to Parliament.

In his speech, Mr. Zelensky spoke of how bravery 'rewards victory' and issued a personal thanks to former Prime Minister Boris Johnson. He added: "We know freedom will win. We know Russia will lose and this will change the world. I appeal to you and the world with simple and yet most important words: combat aircraft for Ukraine, wings for freedom."

"London has stood with Kyiv since day one, from the first seconds and minutes of the full-scale war, Great Britain you extended your helping hand when the world had not yet come to understand how to react."

"Boris: you got others united when it seemed absolutely impossible. You didn't compromise Ukraine and hence you didn't compromise your ideals and thus you didn't compromise the spirit of these great islands."

The Ukrainian leader's visit to London comes as Vladimir Putin faces further humiliating losses on the battlefield. These are the words of the UK press. It should be noted that Ukraine's losses on the eastern front are eight times that of the Russian army. The next few months will determine the outcome of the conflict. Russia has been readying a force of 500,000 fresh trained troops on the Eastern front to invade in the next few weeks.

What stands out as significant about Zelensky's visit to Buckingham Palace, as was his visit to the White House and Congress is the ease with which these events were achieved, I am suggesting that there are very high level world leaders orchestrating and

pulling the strings, punching the right buttons to make these visits happen. Think about it, Zelensky wears his army green sweats, no suit or tie, he jets around Europe as if he was Bill Gates just dropping in to introduce himself. Sounds strangely fishy and if you or anyone you knew were to just drop in unexpected you likely would be met with a squad of police officers in full SWAT gear and thrown into the back of a van.

I have been wondering if Zelensky is just another product of the UK Tavistock Institute. My suspicions are that he is a patsy, a comedian, groomed to become another Pied Piper to lead the European community into a war via way of the NATO/US Alliance. This morning's news on Apple© Siri News headlined the title, "The U.S. Needs Another 9/11!" That might be an understatement given that journalist Sy Hersch dropped his bombshell that the CIA/U.S. Navy blew up the Nord Stream pipeline. This was an act of war in case you do not know it.

Early on we were thinking the UK was very much involved and yet the entire operation suggested a larger operation requiring a Navy operation like our own. The commander-in-chief passing himself off as the President of the U.S. stands exposed now as 'the emperor has no clothes' and having admitted he approved the destruction of the Nord Stream pipeline, has now given reason for his impeachment ASAP. The Chinese balloon incident alone shows how easy it would have been for the Chinese to deliver an EMP attack against the U.S. Have you noticed how all the news seems to further damage the U.S. image?

#### Moon of Alabama said:

"Hersh's story is true. That U.S. officials deny it means nothing. Previous revelations by Hersh on domestic spying by the CIA, on the My Lai massacre, on torture at Abu Ghraib, were also denied but eventually all were proven to be true.

The story about the pipelines makes complete sense. Unfortunately there are some details that Hersh, for lack of access to the right information, gets wrong.

#### He writes:

Last June, the Navy divers, operating under the cover of a widely publicized midsummer NATO exercise known as BALTOPS 22, planted the remotely triggered explosives that, three months later, destroyed three of the four Nord Stream pipelines, according to a source with direct knowledge of the operational planning.

It is unlikely that the explosives were put out while the yearly BALTOPS exercise was still ongoing. The current Wikipedia <u>entry</u> about it says:

A total of 14 NATO nations, including NATO partner nations Finland and Sweden, took part in the 51st BALTOPS exercise between 5 and 17 June 2022. The usual mine hunting exercise was augmented this year with experimental mine hunting unmanned underwater vehicles and the collection of environmental data sets for target recognition


algorithms in conjunction with the Naval Undersea Warfare Center and Naval Information Warfare Center Pacific.

BALTOPS 2022 was shadowed by two Russian Karakurt-class corvette.

The whole exercise took only 12 days. A lot of nations took part. Submarines were involved. The Russian's were around watching what was happening. (They like also had submarines in the wider area.)

Those are not good conditions to do a lot of secret underwater work. It was much easier to do this later, when everyone had turned back to port. The U.S. ships though did not sail home. They stayed around, did some harbor visits and eventually settled down near the island of Bornholm a few miles away from the pipelines where they started to do their work.

Here is where the pipelines were hit:



The four Nord Stream pipelines, two for Nord Stream 1 and two for Nord Stream 2, are strong:

The steel pipe itself has a wall of 4.1 centimeters (1.6 inches), and it's coated with another 6-11 cm of steel-reinforced concrete. Each section of the pipe weighs 11 tonnes, which goes to 24-25 tonnes after the concrete is applied.

The pipelines are also buried into the sandy sea ground, not deep, but deep enough to prevent fishing equipment or anchors from damaging them.

To blow such pipelines takes a lot more than just putting a few pounds of C4 explosives on top of them. The pipelines had first to be dug out, must likely with pressurized water. Next explosives had to be placed all around them. Then a trigger mechanism of some kind had to be deployed and fixed on to them. Lastly the explosive laden section would have to be reburied to prevent detection or unforeseen entanglement with some

external elements. All this had to be done at least four times. If I had planned the operation I probably would have gone for a total of eight explosive packages.

The whole process takes time. Unmanned submarine like vehicles were needed to carry the hundreds of kilograms of explosives and equipment. Diving time at that depth is not unlimited and there must have been a few crew changes. It probably took three to four weeks to fix the whole issue.

When I wrote about the incident I translated a German language report which Hersh had likely not found.

Here is my original translation:

Big Fleet Group From U.S. Navy Passes [German island passage] FehmanbeltOn Wednesday morning the amphibious assault ship USS Kearsarge, escorted by the Landing Ships USS Arlington and USS Gunston Hall, was en route towards west. Previously, the ships were part of US units that took part in NATO maneuvers and called at numerous ports in Germany, Scandinavia and the Baltic States.

The "USS Kearsarge", flagship of the association and largest warship of the US Navy, which was in action in the Baltic Sea in the last 30 years, has 40 helicopters and fighter planes as well as more than 2000 soldiers on board, the escort ships about 1000. For the around 4,000 soldiers are heading back home on the east coast of the US after their six-month deployment.

The USS Kearsarge was much longer in the Baltic Sea than Hersh presumes. The explosives were put down sometime between the end of BALTOPS on June 17 and September 22, the date the USS Kearsarge passed Fehmarn to leave the Baltic Sea.

That's why Hersh errs when he later writes:

And then: Washington had second thoughts. The bombs would still be planted during BALTOPS, but the White House worried that a two-day window for their detonation would be too close to the end of the exercise, and it would be obvious that America had been involved. Instead, the White House had a new request: "Can the guys in the field come up with some way to blow the pipelines later on command?"

That window was not extended by months between the end of BALTOPS and the explosions but by a mere few days between somewhat around September 20 when the Kearsarge went on its way back home and September 27 when the pipelines exploded.

#### Excursion:

Since my translation some content has been added to the German piece to put it in the context of the Russian invasion. It is now dated October 21 2022 which makes no real sense. (The only archive.org copy of the piece is the changed on, saved on December 2022.)

The piece now starts with this (my translation):

Big Fleet Group From U.S. Navy Passes [German island passage] Fehmarnbelt I don't remember that there was a sub-headline to it or some sentences about the war in Ukraine but the piece now has those:

On Thursday morning, September 22, a fleet group from the U.S. Navy passed [the German island] Fehmarn. The "USS Kearsarge" as flagship was the biggest of the war ships.

- Russian nuclear submarines and NATO units in strait of Fehmarn
- Ships sail again in western direction
- 40 helicopters and war planes on board

Fehmarn – With the Russian war of aggression against Ukraine, which began in February, and with the change in security policy it caused, with NATO entry requests by Finland and Sweden, the Baltic has become a concentration area for naval forces of Russian and NATO. This can be seen in the increasing number of war ships which have passed the strait of Fehmarn [Fehmarnbelt] during the past months. This counts for Russian nuclear submarines just as for NATO units. On Thursday morning, September 22, a fleet group of the U.S. navy passed Fehmarn.

Then follow, seemingly unchanged, the two paragraphs I had translated previously. It is some weird editorializing to add the now leading new parts to the old small piece by a local newspaper nearly a month after it was originally published. Who initiated that?

The new part does not make sense. BALTOPS is a yearly exercise, BALTOPS 22 was the 51st one of its kind. That it was held had nothing to do with the war in Ukraine.

As far as I can tell there are and were no nuclear submarines from Russia stationed in the way too shallow Baltic Sea. The home harbors of Russia's nuclear fleets are Murmansk in the northern Kola bay for the Northern and Atlantic fleet and Rybachiy Nuclear Submarine Base on the Kamchatka peninsula for the Pacific fleet.

When a Russian nuclear submarine passes Fehmarn it is most likely one from Murmansk that takes part in the Russian fleet parade in St. Petersburg. That is like BALTOPS a yearly event. To use that for war mongering is rather stupid.

#### End of excursion.

What was of interest in the piece I had translated was not only the time when the U.S. ships left but also the remark that the Kearsarge was the "largest warship of the US Navy" that was in action in the Baltic Sea in the last 30 years.

The Kearsarge was likely selected for purpose. The ship has a ...

... well deck, which opens to the sea through huge gates in the ship's stern. There, the cargo, troops and vehicles are loaded onto landing craft for transit to the beach. The air cushion landing craft can "fly" out of the dry well deck, or the well deck can be flooded so that conventional landing craft can float out on their way to the beach.

Usually the Kearsarge would be a too big missile target to be in the Baltic Sea. But the well deck comes in handy when one wants to test new underwater equipment or put explosives around pipelines:

In support of BALTOPS, U.S. Navy 6th Fleet partnered with U.S. Navy research and warfare centers to bring the latest advancements in unmanned underwater vehicle mine hunting technology to the Baltic Sea to demonstrate the vehicle's effectiveness in operational scenarios. Experimentation was conducted off the coast of Bornholm, Denmark, with participants from Naval Information Warfare Center Pacific, Naval Undersea Warfare Center Newport, and Mine Warfare Readiness and Effectiveness Measuring all under the direction of U.S. 6th Fleet Task Force 68.

Bornholm is of course where the pipelines were blown up.

To me the one new and surprising item in the Hersh piece is the involvement of Norwegian forces to trigger the explosions by sonar buoy signals from a P8 navy surveillance plane. I would have bet on Swedish, British or Polish involvement. But Norway makes even more sense as it will profit from the Nord Stream destruction.

Larry Johnson, an old friend of Sy Hersh, has found a video by someone who had tracked a Norwegian P-8 flying in the pipeline area shortly before the explosion. [The web site Monkey Werx SITREP is the site that tracks aviation radar activity and even noted an unusual activity on the particular day and time of around 4:30am local time when the P8 navy surveillance aircraft activated the sonar buoy signals to blow the pipelines.]

Unfortunately for Norway though is that its own, now increased gas exports also depend on pipelines. On the day of the Nord Stream explosions Denmark and Poland inaugurated a new pipeline that brings Norwegian gas to Poland. Russia certainly has the means to do to Norwegian pipelines what the U.S. and Norway have done to Nord Stream.

Another small quip I have with the Hersh piece is this:

Sweden had applied for membership into NATO, and had demonstrated its great skill in managing its underwater sound and magnetic sensor systems that successfully tracked Russian submarines that would occasionally show up in remote waters of the Swedish archipelago and be forced to the surface.

Most of the Russian subs the Swedish detected were never there. More than half of the many incidents were "unlikely violations", i.e. they never happened. The great Swedish skill is to scare its own population with false alarms about alleged Russian submarines near its coast:

In 1982, several of Sweden's subs, boats, and helicopters pursued one of these unidentified sources for a whole month, only to come up empty-handed. This continued for over a decade. Every time they picked up an acoustic signal they would search and find nothing but for a few bubbles on the sea's surface. Sweden was, of course, worried

about the intrusions, and couldn't think why, with the Cold War now over, Russia would continue to provoke them in this manner.

But it was just farts.

"It turns out herring have a swim bladder... and this swim bladder is connected to the anal duct of the fish," Wahlberg said. "It's a very unique connection, only found in herring. So a herring can squeeze its swim bladder, and that way it can blurt out a small number of bubbles through the anal opening."

In layman's terms, they let one rip. Herrings swim in gigantic schools that can reach several square kilometers and up to 20 meters (65 feet) deep. When something near them frightens them – say, a hungry school of mackerel or a submarine on the lookout for Russian spies – they can generate a lot of gas.

To test his theory, Wahlberg bought a herring from a store and applied pressure, and sure enough, it made a sound. He took the footage to the navy personnel and played it back to them. It was a perfect match for the noise they had been hearing.

The good news was that Sweden wasn't under threat from Russia, the bad news was it had spent 10 years deploying its military in pursuit of fish farts. Since it figured out what was and wasn't fish farts, there have been zero reports of hostile intruders in Swedish waters."

Great Swedish skills. Indeed.

Moon of Alabama's information is corroborated by the web site Monkey Werks. And now back to Mr. Zelensky.

What is alarmingly similar to past dictators like Hitler and Stalin, and some others, with Zelensky is how he came out of nowhere, a pornographic comedian, to be elected to power of a corrupt country like the Ukraine, a nation of some 42-million people. He has a \$35-million estate in Sunny Isles, FL. So-called fact checkers will deny it but investigative journalist George Webb has documented much of the Zelensky' wealth and secret bank accounts in Costa Rico that proves Zelensky has \$1.3 billion in off-shore accounts. Tranches of money in the amount of \$12-million a month is sent to Zelensky by well-known Ukrainian oligarchs.

Just when you thought the Minsk agreements could not be any more worthless, Ukrainian President Volodymyr Zelensky said in an interview that he told the key players in 2019 — then-German Chancellor Angela Merkel, French President Emmanuel Macron, and Russian President Vladimir Putin — that the deal was essentially a "concession" and he never had any interest in honoring the agreement. He said the three were "surprised" by his admission, RT reported, citing the Der Spiegel interview.

"But as for Minsk as a whole, I told Emmanuel Macron and Angela Merkel: 'We cannot implement it like this,'" Zelensky said. "I told [Putin] the same as the other two. They were surprised and said: 'If we had known beforehand that you would change the meaning of our meeting, then there would have been problems even before the summit."

Zelensky recently acknowledged his country's eight-year conflict in the Donbas between Russian separatists that resulted in the death of over 14,000 people, which Russian President Vladimir Putin cited before the February invasion.

Ukraine and Russia are divided over who was at fault during the years-long conflict in the eastern region of the country. But just days prior to the Russian invasion, Putin signed friendship treaties with the Donetsk and Luhansk people's republics in the region. He also signed the presidential decree recognizing the independence of these separatists regions before the war.

Following the United States CIA overthrow of the democratically elected president of Ukraine. Viktor Yanukovych in 2014, Ukrainian forces attacked the Donbas region.

Ukraine has long accused Russia of providing weapons and troops to these separatists in Donbas, a charge that Russia denied. Moscow, in response, accused Kyiv of committing "genocide" against the pro-Russian separatists in the region, which Ukraine denied.

HISTORICAL FACTS: Following the U.S. led coup that overthrew Ukraine's President Victor Yanukovych in early 2014, Crimean's voted to secede from Ukraine and align with Russia. During the 2014 uprising, some 97 percent of the citizens of the Autonomous Republic of Crimea voted to leave Ukraine for integration of the region into the Russian Federation.

In 2014, Ukraine and these separatists agreed to the 12-point Minsk Agreement that called for a ceasefire in the region, but both sides violated the deal. In February 2015, the Minsk II Agreement also called for a ceasefire, which Ukraine has, as Zelensky noted, violated.

Al Jazeera wrote that Minsk II was interpreted differently by Russia and Ukraine: Kyiv wanted a ceasefire, "control of the Russia-Ukraine border, elections in the Donbas, and a limited devolution of power to the separatists – in that order. Russia views the deal as obliging Ukraine to grant rebel authorities in Donbas comprehensive autonomy and representation in the central government, effectively giving Moscow the power to veto Kyiv's foreign policy choices."

Russia said the deal requires Kyiv to allow separatist authorities to form their own central government. Ukraine said it will never allow Moscow to have a de facto veto on foreign policy decisions.

Eastern Donbas has seen some of the fiercest fighting since Russia launched its invasion in February. The industrial region includes Donetsk and Luhansk.

Merkel slipped earlier this year and said the Minsk agreements were an effective ruse to give Ukraine time to "get stronger" for its next conflict with Russia.

Merkel made the admission during an interview with a German newspaper. She said Ukraine used the ceasefire after the two peace deals as a time to get stronger, "as you can see today."

"The Ukraine of 2014/15 is not the Ukraine of today. As you saw in the battle for Debaltseve in early 2015, [Russian President Vladimir] Putin could easily have overrun them at the time. And I very much doubt that the NATO countries could have done as much then as they do now to help Ukraine," she said.

Last Month, Vassily Nabenzia, Russia's top diplomat to the UN, said the nearly year-long war in Ukraine could have been avoided if leaders in Kyiv enforced the Minsk Agreements, which turned out to be a ruse by the West to buy time to rearm Ukrainians for a future fight.

Nabenzia told the UN Security Council that "everything could have ended differently for Ukraine" if it followed the agreements that he said paved the way for peace by granting special status to Russian speakers in the Donetsk and Lugansk People's republics.

Nebenzia said it is obvious that France, Germany, and Ukraine never had any intention to uphold the agreement that served as nothing more than a "smokescreen behind which they secretly armed Ukraine in order to set it against Russia."

In the larger scope of this conflict we can see that Zelensky has sold-out his country, his government to those who have offered him a better deal, with a golden parachute in Miami, FL should he need to flee the country. The year-long brutal war has proved he has become a surrogate leader for a state that can never be victorious on its own. The unmentioned yet by far the real issue is the Anglo-American agenda on behalf of the Vatican is to weaken Russia for a future attack that will destroy and divide Russia into smaller states. Without going much deeper into this subterfuge, we are witness to a struggle that began in 1054 A.D. and was very much part of what began World Wars 1 and 2.

With Zelensky's recent audience with Prince Charles a few days ago, pieces of the puzzle picture are falling into place. The Prince is appearing to live up to many of the descriptions for which the Bible has provided us an image of what to expect of the person referred to as The Antichrist! Drawing from a chart that Dr. Dave Reagan once published in an article on the Antichrist we have an adequate picture of this figure.

Although specificity in the Biblical references masks our ability to fine tune the image with that of a specific person, it does not require us to be exact in order to make solid assumptions.

Dr. Dave Reagan suggests that this person would be: "a dynamic, charismatic, insightful, visionary leader who will astound the world with the cleverness of his solutions to world problems. He will appear to be the savior of the world. But as he consolidates his power, his true nature will be revealed. He will emerge as a Satan possessed and empowered person who hates God and is determined to annihilate both Christianity and Judaism."

If you've followed Pastor Bob for any length of time you know who I believe it is and that he has been active on the world stage longer than anyone realizes and likely in ways not expected! I first learned about the Antichrist right after my parents bought their new Philco black and white television set.

My first memory of this person referred to as the Antichrist in 1<sup>st</sup> John 2:18, 2:22, 4:3; and 2<sup>nd</sup> John 1:7 were close to seventy-five years ago. My uncle was a Pittsburgh city police officer and moonlighted on the weekends as a private security guard patrolling one of Pittsburgh's upper class communities, known as Woodland Road in Shadyside. The mansions on Woodland Road were all in the \$1-million price range. As a teenager, I had a Sunday 'New York Times' route of some sixty customers. Back then a Sunday NYT was huge around three-inches thick. My customers always got at least one of the

two major Sunday city papers as well. I pulled a wagon behind my bicycle to carry all my papers. At least half of my customers had a butler and servants who would take the paper as I arrived usually between 6:00-7:30am. My Christmas tips were amazing.

My uncle would stop off on his way to work on Saturday evening to watch our new black and white television for a couple hours. He was a huge fan of the Bishop Fulton Sheen program. We all sat glued to the new television and had to watch this famous Roman Catholic TV celebrity bishop on Saturday nights. On one of those early shows I recall Bishop Sheen describe what the Antichrist would be like. The bishop said, "It might not at all be what many will be expecting the anti-Christ would be like, especially at first. But as we've seen in this same talk not long after the end of World War II and that from now on the struggle will be... for the souls of men," he warned. I was not sure of what he was talking about other than he gave me chills and I was frightened by him. I did not know why my uncle was so enamored by him since he was not even Catholic.

Sheen described a masquerade that helped the devil convince men that he does not exist; and stressed that the devil knows that he is never as strong as when men believe that he does not exist. When no man recognizes, the more power he exercises, the bishop would say. I could tell by the intense piercing eyes that he really believed the devil was for real. That was scary to this 14 year old. He talked about the devil being a fallen angel from heaven, and as "the Prince of this world" whose business it is to tell us that there is no other world," he said, referring to Scripture. "His logic is simple: if there is no heaven there is no hell; if there is no hell, then there is no sin; if there is no sin, then there is no judge, and if there is no judgement then evil is good and good is evil."

I could tell that my parents were impressed by Bishop Sheen, as we started to go back to church the next week. My family were Presbyterian but infrequent until my younger sister was a little older. I remember one Sunday morning during church services taking my dad's hat and sent it sailing out in the sanctuary like it was a Frisbee. I got my behind punished when we got home. ## "Adherence to UN 2030 Sustainability Agenda". Colossal disinvestment in the trillion-dollar global oil and gas sector.

Most people are bewildered by what is a global energy crisis, with prices for oil, gas and coal simultaneously soaring and even forcing closure of major industrial plants such as chemicals or aluminum or steel. The Biden Administration and EU have insisted that all is because of Putin and Russia's military actions in Ukraine. This is not the case. The energy crisis is a long-planned strategy of western corporate and political circles to dismantle industrial economies in the name of a dystopian Green Agenda. That has its roots in the period years well before February 2022, when Russia launched its military action in Ukraine.

#### **Blackrock pushes ESG**

In January, 2020 on the eve of the economically and socially devastating covid lockdowns, the CEO of the world's largest investment fund, **Larry Fink** of Blackrock, issued a letter to Wall Street colleagues and corporate CEOs on the future of investment flows. In the document, modestly titled "**A Fundamental Reshaping of Finance**", Fink, who manages the world's largest investment fund with some \$7 trillion then under management, announced a radical departure for corporate investment. Money would "go green." In his closely-followed 2020 letter Fink declared, "In the near future – and sooner than most anticipate – there will be a significant reallocation of capital…Climate risk is investment risk." Further he stated, "Every government, company, and shareholder must confront climate change." [i]

In a separate letter to Blackrock investor clients, Fink delivered the new agenda for capital investing. He declared that Blackrock will exit certain high-carbon investments such as coal, the largest source of electricity for the USA and many other countries. He added that Blackrock would screen new investment in oil, gas and coal to determine their adherence to the UN Agenda 2030 "sustainability."

Fink made clear the world's largest fund would begin to disinvest in oil, gas and coal. "Over time," Fink wrote, "companies and governments that do not respond to stakeholders and address sustainability risks will encounter growing skepticism from the markets, and in turn, a higher cost of capital." He added that, "Climate change has become a defining factor in companies' long-term prospects... we are on the edge of a fundamental reshaping of finance." [ii]

From that point on the so-called ESG investing, penalizing CO2 emitting companies like ExxonMobil, has become all the fashion among hedge funds and Wall Street banks and investment funds including State Street and Vanguard. Such is the power of Blackrock. Fink was also able to get four new board members in ExxonMobil committed to end the company's oil and gas business.



The January 2020 Fink letter was a declaration of war by big finance against the conventional energy industry. BlackRock was a founding member of the Task Force on Climate-related Financial Disclosures (the TCFD) and is a signatory of the UN PRI—Principles for Responsible Investing, a UN-supported network of investors pushing zero carbon investing using the highly-corrupt ESG criteria—Environmental, Social and Governance factors into investment decisions. There is no objective control over fake data for a company's ESG. As well Blackrock signed the Vatican's 2019 statement advocating carbon pricing regimes. BlackRock in 2020 also joined Climate Action 100, a coalition of almost 400 investment managers managing US\$40 trillion.

With that fateful January 2020 CEO letter, Larry Fink set in motion **a colossal disinvestment in the trillion-dollar global oil and gas sector.** Notably, that same year BlackRock's Fink was named to the Board of Trustees of Klaus Schwab's dystopian World Economic Forum, the corporate and political nexus of the Zero Carbon UN Agenda 2030. In June 2019, the World Economic Forum and the United Nations signed a strategic partnership framework to accelerate the implementation of the 2030 Agenda. WEF has a Strategic Intelligence platform which includes Agenda 2030's 17 Sustainable Development Goals.

In his 2021 CEO letter, Fink doubled down on the attack on oil, gas and coal. "Given how central the energy transition will be to every company's growth prospects, we are asking companies to disclose a plan for how their business model will be compatible with a net zero economy," Fink wrote. Another BlackRock officer told a recent energy conference, "where BlackRock goes, others will follow." [iii]

In just two years, by 2022 an estimated \$1 trillion has exited investment in oil and gas exploration and development globally. Oil extraction is an expensive business and cutoff of external investment by BlackRock and other Wall Street investors spells the slow death of the industry.

#### Biden—A BlackRock President?

Early in his then-lackluster Presidential bid, Biden had a closed door meeting in late 2019 with Fink who reportedly told the candidate that, "I'm here to help." After his fateful meeting with BlackRock's Fink, candidate Biden announced, "We are going to get rid of fossil fuels…" In December 2020, even before Biden was inaugurated in January 2021, he named BlackRock Global Head of Sustainable Investing, Brian Deese, to be Assistant to the President and Director of the National Economic Council. Here, Deese, who played a key role for Obama in drafting the Paris Climate Agreement in 2015, has quietly shaped the Biden war on energy.

This has been catastrophic for the oil and gas industry. Fink's man Deese was active in giving the new President Biden a list of anti-oil measures to sign by Executive Order beginning day one in January 2021. That included closing the huge Keystone XL oil pipeline that would bring 830,000 barrels per day from Canada as far as Texas refineries, and halting any new leases in the Arctic National Wildlife Refuge (ANWR). Biden also rejoined the Paris Climate Accord that Deese had negotiated for Obama in 2015 and Trump cancelled.

The same day, Biden set in motion a change of the so-called "Social Cost of Carbon" that imposes a punitive \$51 a ton of CO2 on the oil and gas industry. That one move, established under purely executive-branch authority without the consent of Congress, is dealing a devastating cost to investment in oil and gas in the U.S., a country only two years before that was the world's largest oil producer.[iv]

#### Killing refinery capacity

Even worse, Biden's aggressive environmental rules and BlackRock ESG investing mandates are killing the U.S. refinery capacity. Without refineries it doesn't matter how many barrels of oil you take from the Strategic Petroleum Reserve. In the first two years of Biden's Presidency the U.S. has shut down some 1 million barrels a day of gasoline and diesel refining capacity, some due to covid demand collapse, the fastest decline in U.S. history. The shutdowns are permanent. In 2023 an added 1.7 million bpd of capacity is set to close as a result of BlackRock and Wall Street ESG disinvesting and Biden regulations. [v]

Citing the heavy Wall Street disinvestment in oil and the Biden anti-oil policies, the CEO of Chevron in June 2022 declared that he doesn't believe the U.S. will ever build another new refinery.[vi]

Larry Fink, Board member of Klaus Schwab's World Economic Forum, is joined by the EU who's President of the EU Commission, the notoriously corrupt Ursula von der Leyen left the WEF Board in 2019 to become EU Commission head. Her first major act in Brussels was to push through the EU Zero Carbon Fit for 55 agenda. That has imposed major carbon taxes and other constraints on oil, gas and coal in the EU well before the February, 2022 Russian actions in Ukraine. The combined impact of the Fink fraudulent ESG agenda in the Biden administration and the EU Zero Carbon madness is creating the worst energy and inflation crisis in history.

The implications of Mr. Engdahl's report will be profound for every living person on the planet. Not only will this result in the reduction of every aspect of society by  $1/3^{rd}$  – it means the "Depopulation" of the world by  $1/3^{rd}$  as well. This is the percentage designated as each country will be forced to cut its agricultural production. Ireland and Denmark were the first two countries given the bad news by the underlings of Prince Charles of Wales. The World Economic Forum plan is to 'Build Back Better', a rejection of the existing model of society.

On Thursday, February  $9^{\text{th}}$ , 2023, the first test case of this new ESG "utopian" plan was filed against Shell Oil.

The directors of oil major Shell are being personally sued over their climate strategy, which the claimants say is inadequate to meet climate targets and puts the company at risk as the world switches to clean energy.

Environmental lawyers ClientEarth have filed the lawsuit against the 11 directors at the high court in England. It is the first case in the world seeking to hold corporate directors liable for failing to properly prepare their company for the net zero transition, ClientEarth said.

ClientEarth, which has a token shareholding in Shell, is suing under the UK Companies Act, and is supported by a group of large pension funds and other institutional investors. It argues a global transition to low-carbon energy is inevitable as world governments act to end the climate crisis and that Shell's failure to move fast enough threatens the company's success and would waste its investors' money on unneeded fossil fuel projects.

Shell recently announced a record annual profit of \$40bn (£33bn), driven by the high energy prices resulting from Russia's war in Ukraine. But, as climate litigation increases across the world, the company has suffered a flurry of recent legal and regulatory challenges. These include a Dutch court order to cut emissions from its oil and gas by 45% by 2030 and a claim that Shell is investing less in green energy than it says.

"Shell may be making record profits now, but the writing is on the wall for fossil fuels long term," said ClientEarth lawyer Paul Benson. "The shift to a low-carbon economy is not just inevitable, it's already happening. Yet the board is persisting with a transition strategy that is fundamentally flawed, despite the board's legal duty to manage those risks."

"Long term, it is in the best interests of the company, its employees and its shareholders – as well as the planet – for Shell to reduce its emissions harder and faster than the board is currently planning,." The International Energy Agency said in 2021 that no new oil and gas projects were compatible with net zero emissions by 2050. "Doubling down [by Shell] on new oil and gas projects isn't a credible plan – it's a recipe for stranded assets," Benson said.

Nest, the UK's largest workplace pension scheme with 10 million members, has backed the lawsuit. "Investors want to see action in line with the risk climate change presents and will challenge those who aren't doing enough to transition their business," said Mark Fawcett, Nest's chief investment officer. "We hope the whole energy industry sits up and takes notice."

London CIV manages the assets of the London local government pension scheme and its head of responsible investment, Jacqueline Amy Jackson, said: "Over the next few decades 1 billion lives and trillions of pounds will be at risk due to a single issue: climate change. We do not believe the board has adopted a reasonable or effective strategy to manage the climate risks affecting Shell. In our view, the board of a high-emitting company has a fiduciary duty to manage climate risk."

The group of investors also includes Swedish national pension fund AP3, French asset manager Sanso IS and Danske Bank Asset Management.

ClientEarth is asking the high court to order Shell's board to adopt a strategy to manage climate risk in line with its duties under the Companies Act, and in compliance with the Dutch court's order for big cuts in emissions. The high court will now decide whether ClientEarth's claim will proceed.

A Shell spokesperson said: "We do not accept ClientEarth's allegations. Our directors have complied with their legal duties and have, at all times, acted in the best interests of the company. We believe our climate targets are aligned with the more ambitious [1.5C] goal of the Paris agreement. Our shareholders strongly support the progress we are making on our energy transition strategy, with 80% voting in favor of this strategy at our last AGM."

In May 2021, the Dutch court ordered Shell to cut carbon emissions from its oil and gas products by 45% by 2030. The case was brought by Friends of the Earth and more than 17,000 co-plaintiffs, who successfully argued the company had been aware of the dangerous consequences of CO2 emissions for decades, and that its climate targets did not go far enough. Shell is appealing the verdict.

Earlier in February, a non-profit group lodged a complaint against Shell with the U.S. Securities and Exchange Commission, alleging that the company had overstated how much it is spending on renewable energy. Shell, which is headquartered in London, but is listed on the New York stock exchange, denied misleading investors.

The company was also sued this month in London's high court by 14,000 people from two Nigerian communities, who claim Shell is responsible for devastating pollution of their water sources. Shell said it bears no responsibility for the siphoning off of oil from its pipelines by organized gangs, which it says causes many of the spills, and that is not liable for the actions of its Nigerian subsidiary company.

Shell has taken legal action itself this month in an attempt to end the occupation of its oil and gas platform by Greenpeace International protesters. The platform is now in the English Channel, being transported to the North Sea. The protesters are demanding the company stops expanding oil and gas production around the world and pays for the climate destruction they say the company is causing.

What does all this mean for you as a human being in the New World Order? Nothing good for sure!


