Could There Be a Rapture Blessing Hidden Within a Jewish Curse?

The 9th of the Hebrew month of Av, which usually falls in July or August on the western calendar, is a traditional day of mourning in Judaism. Observances such as fasting food and water and restraining from pleasure and recreational activities characterize this day. In general, the day is an intentional time to mourn. My first awareness of the 9th of Av came in a Sunday School class for high school and college age students in 1961.

Why such mourning? Why would an entire day be set aside to be sad, even afflicting the body by fasting? Sounds similar to Yom Kippur (Day of Atonement), doesn't it? Does this have any connection to Christianity, and should we, as Christians, be mourning as well?

The history of the 9th of Av began with the sin of the spies. When twelve men went to Canaan, and ten of the spies came back with a negative report, the people believed and accepted the lies, and as a result, God punished them with not being able to enter the Land. Traditionally, the night after the spies brought back the bad report began the 9th of Av, and the people spent it weeping and wailing over their misfortune.

Throughout the centuries, a remarkable number of misfortunes have befallen Jerusalem and the Jewish people, and interestingly enough, many of them happened on the 9th of Av.

The two most notable events that are marked on this very day are the destruction of Solomon's Temple by the Babylonians, in 586 BC and more than 600 years later, the destruction of the 2nd Temple by the Romans in 70 AD. I never forgot the Sunday School teacher's words. On the very same day was a shock by itself, but it was years later when I learned how the Hebrew calendar is moon based and that the 9th of Av can occur almost any day during July and August of our calendar. In 1961, from what I had learned had to be important and over the years as a Methodist pastor, I became friends with Jewish rabbis and I would solicit their understanding to this mathematical oddity. I have numerous Jewish rabbi friends who are mathematicians as well. Mainline denominational seminaries do not teach these aspects of Biblical studies.

In today's time, the 17th of Tammuz (when Jerusalem's walls were breached at the destruction of the first Temple) marks the beginning of a period of 3 weeks, leading up to the 9th of Av, and starting nine days before, the 9 Day period is begun, culminating in the day itself. The custom in Judaism is to observe this day as a fast day, similar in to Yom Kippur. From sundown the night before to sundown on the 9th of Av, no food or water is consumed. Bathing and washing are avoided, no leather shoes are worn, and much of the day is spent sitting on low stools or on the ground, reading passages such as Lamentations, and mourning the destruction of the Temples in Jerusalem and the tragedies that have befallen the people of Israel over the centuries.

All of this sounds interesting, but you may be wondering: *"What does this have to do with us as Christians? Should we be mourning along with the Jewish people?"* There has been an attitude of most churches that it is all old and irrelevant history to Christians.

There is a strange passage in Ezekiel 9:4, in the midst of a vision from God, he begins to see many of the terrible abominations happening in Jerusalem and the Temple. In chapter 9, God calls to a man with an inkhorn to ***“. . . go through the midst of Jerusalem, and to put a mark on the foreheads of the men who sigh and cry over all the abominations that are done within it”*** (vs. 4). Then God commands His soldiers to go throughout the city, beginning at the Temple, and to kill everyone who does not have the mark on his forehead.

Because of the abominations, idol worship, and sins of the people taking place in the Temple, God's justice must be enacted. Only those who sigh and cry over Jerusalem – those who mourn the sins and wrongdoings taking place – are the ones who are saved!

We see a similar story in the Gospel of Matthew, just before Jesus died. In Matthew 23:37-39, our Messiah began to weep over Jerusalem, over her impending sins and coming destruction – ultimately, the destruction of the second Temple itself in 70 AD!

If our Messiah was mourning and weeping over Jerusalem's sins and the destruction of the Temple, and if the only ones saved in Ezekiel's vision were those who mourned the wickedness in the Temple, how much more should we as Christians participate in mourning the destruction of the Temple, Jerusalem, and over the years, the slaughter of the Jewish people? As Christians, the sins of our ancestors were those that caused many of these calamities that the Jewish people are mourning every Tisha b'Av or 9th of Av. The crusades, the Holocaust, and many more tragedies are attributed to Christianity!

It is time for us as Christians to renounce replacement theology, and throw in our lot with the Jewish people by mourning, sighing, and repenting for the sins of the last 2,000 years, that have brought so much death and destruction to the people of Israel. It was in 2015 many Protestant denominations joined the (BDS) Boycott, Divest, and Sanction movement, intended to bring about a two-state solution to the Palestinian problem. People of faith ought to be acting to help Israel and the Palestinians to renew efforts to

achieve peace, rather than endlessly demonizing one party in the conflict. Let's be counted among those who sigh and weep for Jerusalem this 9th of Av. It is important that as Christians to remember and understand why the Jews lost the three most revered elements God had given them: the Temple, the Land, and the Torah for their disobedience; but only temporarily!

Rabbi Eliezer (Lazer) Gurkow in a presentation to a group of pastors framed the 9th of Av with a question.

What do the seventeenth of Tamuz, the ninth of Av, and the first day of Passover have in common? They always fall on the same day of the week.

How does that make any sense? The first day of Passover represents the redemption of our ancestors from Egypt that sparked their journey to Israel. The seventeenth of Tamuz and the ninth of Av are fast days that commemorate the destruction of the two Temples in Jerusalem and our ancestors' He exiled from Israel.

They are on opposite sides of the spectrum. One leads to freedom and Israel, the other leads to exile and away from Israel. Why is the calendar designed for them to fall on the same day of the week?

Moreover, on the first day of Passover, our ancestors left Egypt and traveled to Sinai where they would receive the Torah. On the seventeenth of Tamuz they worshipped the golden calf and Moses shattered the tablets.

The hope of the first day of Passover was shattered on the seventeenth of Tamuz. On the 9th of Av, the spies returned from Israel telling the people that there was no way to conquer the land and the people cried in despair. God then decreed that they would die in the desert and their children, the next generation, would enter Israel.

The ninth of Av was the day when the promise of the first day of Passover was dashed for the generation that left Egypt.

Why are they on the same day of the week?

They Were Confident in contradistinction to the men, the Jewish women never believed the report of the spies. They were certain that Israel would be easily conquered. So much so, that the daughters of Zelafchad, whose father had died in the desert, approached Moses, and demanded that they inherit his portion of Israel.

Why were the women so confident that the war would be easily won? Moreover, why did the daughters of Zelafchad deem themselves entitled to a portion of the land if they would not fight in the war. Is it not fair that only those who risk their lives in battle should collect the spoils of battle?

The answer to both questions is one and the same. God told Abraham, ***“Walk across the land, its length and its breadth, for I will give it to you.”*** The Talmud records a dispute. Rabbi Eliezer said the purpose of walking the land was to acquire it. Walk its length and breadth and by that I will give it to you. The sages who did not agree that walking the land is an act of acquisition said that by this act, God made it easy for Abraham’s descendants to conquer the land.

According to both opinions the Jews had no reason to fear the war. Either it was because it was already theirs or because God had assured them an easy victory. Not merely by His promise but by empowering Abraham to ground this Divine promise into the very soil of the land. Either way, it was a done deal.

The men either disregarded or forgot this little but important detail. The women never forgot. Hence, the women never worried about the report brought back by the spies. Of course, the nation’s living in Israel were great warriors. But that was no reason to fear. The land doesn’t belong to its inhabitants. The land belongs to God. He decides whom to give it to and He already gave it to the Jews. They might be powerful warriors, but they would not overpower God. This would not be a bloodbath for the Jews. It would be a cakewalk.

This is also why the daughters of Zelafchad felt entitled to a portion of the land even if they wouldn’t fight a war. This would not be a dangerous war. The fight would be proforma and the triumph miraculous. The victory would not be due to the army’s efforts. It was pre-scripted. Hence the warriors had no better claim to the land than those who remained at home. All Jews would own it equally.

The Train of History

This helps us understand why the first day of Passover falls every year on the same day of the week as the seventeenth of Tamuz and the ninth of Av. If you think that our ownership of Israel is rooted in our right of conquest, you would be correct to say that we lost ownership when the Babylonians and later the Romans conquered us. We can’t have it both ways. If we conquered it from its inhabitants, they conquered it from us, and it is no longer ours.

If that were the case, it would indeed be incongruous for the first day of Passover to fall on the same day of the week as the days that mark our exile from Israel. However, if our ownership of Israel was God given and the war was prosecuted pro forma, no one can take it from us. God’s gifts don’t expire. The land did not cease being ours when those nations drove us from the land.

The light that was kindled on the first day of Passover was not extinguished on the seventeenth of Tamuz and the 9th of Av. It is still aglow only it is merely concealed. And He who concealed it will soon reveal it. When we cry on the seventeenth of Tamuz and the 9th of Av, we are reminded that it is the very same day—it carries the very same

message of promise and hope—as the first day of Passover. It is a day, like all days, of liberty and redemption. The land is ours.

The train of history never stops. It keeps riding until it returns to its point of departure. Think about it, when a train pulls out of the station, it races at top speed to the end of the line. But it never stays there for long. It eventually reverses course and returns to the station. The other points along its route were never home. Home was always the original station. The journey was temporary.

The Journey's Purpose

However, the journey has a purpose. It is not just a pointless foray onto distant tracks. Its objective is to carry people to where they need to go. Eventually, these people will return, but with something they lacked when they first departed. It might be a new purchase, a day at work, a visit to a relative, a fine meal at a restaurant, or prayer with a minyan. Whatever it was, the journey had a purpose.

The journey of history also has a purpose. We mentioned earlier that on the seventeenth of Tamuz, Moses shattered the tablets. On the following tenth of Tishrei, he came down the mountain with new tablets. But the new tablets were not just a replacement, they were an improvement. The first tablets only had the written Torah. The second set of tablets came with the oral tradition and the Midrash.

These could not be written into the first tablets. For these to be granted, we needed a fresh start. The old had to be shattered to make space for the new. The same occurred with the destruction of the Temple on the ninth of Av. When the Temple was destroyed, the soul of Mashiach was born. With the destruction of the man-made temple, God made space for a Temple that will descend from Heaven.

When the seventeenth of Tamuz and the 9th of Av fall on the same day of the week as the first of Passover it is not just a reminder that the train will return. It is a reminder that we are on a journey toward redemption. Mashiach could not have come had we remained in Israel. The exile and diaspora were necessary. They made us much richer and deeper and when we return, we will thank God for placing us on this journey. It is a journey of growth, freedom, and holiness. A journey that leads to Mashiach.

Journey of Love

More than anything it is a journey of love. When a parent showers a child with gifts, it is a demonstration of love. When a parent cleans a child's diaper and the child cries out in pain and the parent persists, it is a demonstration of supreme love. The parent's ear shatters to a million pieces when the child screams. The only thing that keeps the parent going is supreme love. It propels the parent past the pain.

When God sent us on our exile, we cried bitter tears and so did He. But He persisted, not in anger but in love. He knew this was a necessary journey that would open the way for Mashiach.

On the first day of Passover, God demonstrated His love by redeeming us. On the 17th of Tamuz and the 9th of Av, God showed his supreme love by dispatching us on our journey toward Mashiach. They fall on the same day of the week to remind us that these are not punishments. They are acts of love.

Indeed, the Talmud teaches that on the day the temple was destroyed, the soul of Mashiach was born.

Rabbi Eliezer (Lazer) Gurkow, currently serves as rabbi of congregation Beth Tefilah in London, Ontario, is a well-known speaker and writer on Torah issues and current affairs. His words ought to be welcome words for us today. Within his message it appeared to me that perhaps it contains a special blessing for us this coming 9th of Av!

Since the 9th of Av is known for being a day when bad things happen, that's today, and we are on some level at a crossroads in time. The decisions you make during the month of Av are critical.

The original problem with the 9th of Av was that during Tammuz, twelve spies, one from each tribe, were sent to check out the Promised land. I don't know why they were called spies; it sounds very much like military special operations. I would say they were actually scouts. They were supposed to find out the practical details of moving into the Promised Land: what the geography was like, was it farmable, the best access routes, etc. God set them up in every way to succeed. Their assignment was to find out how to conquer the territory, but somewhere in the midst of their assignment, they began asking should we or shouldn't we rather than exactly how to accomplish the takeover.

So when the spies came back on the 9th of Av, two of them were super excited about enormous fruit and abundant resources while the other ten were intimidated by the giants living there. The ten convinced the people that waited behind that entering the Promised Land was not a good idea and that God and Moses were the bad guys for bringing them there. They wished they had stayed slaves and made bricks from clay.

Meanwhile, the two spies that were trusting that God would help them were trying to build faith into the people—faith that God was with them and had brought them to this place for a purpose, not just to die. Instead, the people threatened to stone them.

God's response was that if they didn't want to go to the Promised Land, they didn't have to go. They could stay in the desert for the rest of their lives. So that's what they did. He took care of them there, but it was far from the best that he had for them. The next generation and the two spies were the only ones who entered the land.

Now let's take another look at the month of Nisan and personalize what happened. When you (the Israelites) were declaring yourself free during Nisan, what was it from? What were you hoping to move toward? Do you see yourself on the cusp of that now? What are some things that intimidate you? What obstacles are you facing? In light of what I just said, how will you respond? These were reflection questions which contained a core lesson of learning to their trusting God and His promises.

There's a critical point in transitioning from slaves to sons. It's a mindset of learning that in any situation that God puts you in or asks of you, you already have everything you need at the ready. It just doesn't look like it.

We can debate whether this was to put one over on the enemy or to grow us in relationship and faith or both. When we are facing something that seems overwhelming and when it looks like you don't have what you need, ask what you've overlooked. *"What resources am I not using that would apply to this situation?"*

Listen, we have got to push through. Many tragedies have happened to the Jewish people on the 9th of Av. It's as if this one historical event of their inferiority complex, lack of faith, and a belief that God set them up to fail opened a door to future devastation on the same date for centuries to come.

Just so you understand the mathematical statistical probabilities are off the chart, we need to explain the Hebrew Lunar-Solar calendar and how it operates as well as a point of remembrance in the future. Like all *"Moed's"* they are rehearsals for a future culmination event in God's .

The Jewish calendar is different than the modern calendar used by most of the rest of the world. Instead of 2023, the current year on the Jewish calendar is 5783. That date starts with the creation of Adam some 5783 years ago and is based on the biblical ages of early man.

Since BC and AD refer to a change in the calendar of the day because of the birth of Jesus, our Messiah, it is not recognized since they do not believe that Jesus was the Messiah foretold by their very own prophets. The rabbis of Judah were a stubborn bunch, and the children of Israel are described throughout the Bible as being *"stiff necked."* The designation of Before Christ and After Christ began to slowly come into effect around 525 AD.

In the Jewish calendar, all holidays occur on exactly the same date, according to the Biblical calendar, which is based on a solar cycle and lunar cycle. A year can be 12 months or sometimes 13 months; and the months have 29 or 30 days. In contrast, the modern calendar has 12 months of 28, 29, 30 and 31 days.

The first month of the Jewish year is the month of Nisan. In the current year, the month of Nisan runs from Nisan for the Hebrew Year 5783 which began on Wednesday,

March 22, 2023 and ended on Thursday, March 23, 2023, and always includes Passover.

The month of Av is also recognized as the Month of Mourning, specifically Tisha B'Av, the 9th of Av, for good reason. This month has proven so catastrophic throughout Jewish history, a fast occurs for three weeks before the 9th of Av. **This year, the 9th of Av begins on July 26, 2023 and ends on July 27th at sundown.**

The Jewish people have experienced several major tragedies in history that have occurred on the 9th of Av. They are mathematically significant when you understand statistical probability; a topic that I have addressed in numerous articles to which corroborates the Bible's accuracy and trustworthiness.

9th Tish B'Ab

Fast of Av. **Zechariah 7:1-3**

[Jacob](#) is confronted by [Esau](#), on his return to Canaan. **Genesis 33:1ff.** Rashal Bereshit Vayish quoted in [Seder HaDorot](#).

Wilderness [generation](#) died on this day when they reached 60 years of age. Taanit

30b, **Midrash Rabba Numbers 16:23**

Jeremiah was born. [Midrash](#) Yalkut Yirmiyahu 36

[Jerusalem](#) and the Solomon's [temple](#) are burned and looted by [Babylon](#). **II Kings 25:8-24**, Taanit 29a - 3338 AM

A year after the [Temple](#) was burned, Micah 3:12 was fulfilled.

This is the day spoken of in Lamentations 5:2.

This is the 'fast day', of the [fifth](#) month, spoken of in Zechariah 8:19.

The Rabbis say that Herod's [temple](#) was also destroyed on this date in 70 C.E. Taanit 29a - 3828 AM

Emperor Hadrian established a heathen [temple](#) on the [Temple](#) mount. Taanit 29a

Ezekiel/God tells elders to put away idols. **Ezekiel 20**

132 AD (135 AD?) - Betar, the last fortress to hold out against the Romans during the Bar Kochba revolt fell.

1095 AD – [First](#) Crusade declared by Pope Urban II. 10,000 [Jews](#) killed in [first](#) month of the Crusade.

1290 AD – Expulsion of [Jews](#) from England by King Edward I, accompanied by pogroms and confiscation of books + property.

1492 AD - Expulsion of [Jews](#) from Spain by King Ferdinand. Also, Columbus (a [Jew](#) in hiding) sailed from Spain.

1555 AD - Ghetto established in Rome. Pope Paul IV moves all the [Jews](#) into a foul-smelling area near the Tiber River.

1914 AD – WW1 begins. 75% of all [Jews](#) lived in war zones.

1941 AD – A decree went forth expelling all [Jews](#) from Hungarian Ruthenia.

1989 AD – Iraq walks out of talks with Kuwait and the invasion of Kuwait by Iraq took place.

1990 AD – Gulf war starts Desert Storm that was started on [Tisha B'Ab](#) ended on the Feast of [Purim](#).

1994 AD – Deadly bombing of the [Jewish community](#) center in Argentina, killing 86 and wounding 300.

The Israeli withdrawal from 25 settlements in the Gaza Strip and northern Samaria began on August 14, 2005.

Classical [Jewish](#) sources maintain that the [Jewish Messiah](#) will be born on [Tisha B'Ab](#).

Torah section is *Deuteronomy 4:25-40*. **Haftarah** is *Jeremiah 8:13 - 9:23*. Morning

Torah section is *Ex. 23:11-14; 34:1-10*. **Haftarah** is *Isaiah 55:6 - 56:8; Micah 7:18-20; Hosea 14:2-10*. afternoon.

In the future, to that same degree that the 9th of Av has been a day of tragedy, it will become a day of great happiness. For on the 9th of Av, the Messiah will be born from the tribe of Judah (Yehuda, whose symbol is the lion).

Could the date of Armageddon start on this date in 2030, as the quote predicted? We do not know the day and time, but this date would be a good possibility. When I hinted at my sub-title of this Blessed Hope, "Could the 9th of Av hold a hidden blessing in the way of the Rapture of the Bride of Christ?" As my friend Daniel in Texas said to me this past Sunday morning:

It's the perfect "bridge"

From the [all-church event](#), the Rapture, to the [all-Israel event](#), the Tribulation.

From Day 6 to Day 7.

From grace to judgement.

From Israel having a few friends to Israel having NO friends.

Shortly you will begin to see what I am building up to and the reasons that provides for the 9th of Av potential as a high watch Rapture date!

Unfortunately, Israel missed this part of the story from Isaiah, where the Messiah from Judah would first come as a lamb going to slaughter. Had they not, they would have understood, like thousands of other Jews did, that the Messiah had already come.

"He was oppressed, and he was afflicted, yet he opened not his mouth: he is brought as a lamb to the slaughter, and as a sheep before her shearers is dumb, so he openeth not his mouth." -(Isaiah 53:7)

"And one of the elders saith unto me, Weep not: behold, the Lion of the tribe of Judah, the Root of David, hath prevailed to open the book, and to loose the seven seals thereof. ⁶And I beheld, and, lo, in the midst of the throne and of the four beasts, and in the midst of the elders, stood a Lamb as it had been slain, having

seven horns and seven eyes, which are the seven Spirits of God sent forth into all the earth.” -(Revelation 5:5-6)

The good news is really good though. The ending is happy for those who make the cut.

“And God shall wipe away all tears from their eyes; and there shall be no more death, neither sorrow, nor crying, neither shall there be any more pain: for the former things are passed away.”-(Revelation 21:4)

Tish'a B'Av is the culmination of a three-week period of increasing mourning that begins with the Fast of the 17th of Tammuz. During this three-week period, the Scroll of Lamentations is read, prayers are recited during the evening services, and the Torah Scroll cabinet (Ark) is covered by black cloth. In some synagogues, the Scroll of Job is read on the morning of Tish'a B'Av.

Tish'a B'Av or the 9th of Av primarily commemorates the destruction of the first and second Temples, both of which were destroyed on the 9th of Av. The first Temple was destroyed by the Babylonians in 586 BC, and the second Temple by the Romans in 70 AD. The Jewish official list of events listed on pages 8 and 9 are mere historical data points and do not tell the horrible details of the carnage of the day; and so we need to visualize the tragedy and sense the nature of all that occurred. The history books tend to diminish the personal tragedy of the people who lived and died as a result of this infamous date; as we would want our children and grandchildren to respond with respect and reverence to an event such as the attack on Pearl Harbor on December 7th, 1941.

The First Occurrence

Av 9, 1312 BC – Only two of the twelve spies sent by Moses to observe the land of Canaan, Joshua and Caleb, returned with a positive report. The ten-spy report caused the Hebrews to cry, panic, and despair of ever entering their Promised Land. For this, they were punished, and Yahweh decreed that their generation would not enter the land and that for all future generations, this date would become one of crying and misfortune for their descendants, the Jewish people (Numbers 13:25-14:12, Zechariah 7:3-5, 8:19).

First and Second Temple Destructions

Av 9, 586 BC – The First Temple built by King Solomon was destroyed by Nebuchadnezzar, and the Judeans were sent into Babylonian exile. About 100,000 Jews were killed during the invasion. The remaining tribes in the southern kingdom were exiled to Babylon and Persia.

Av 9, 70 AD – The Second Temple built by Ezra and Nehemiah was destroyed by the Romans on August 4, 70 AD. Over 2,500,000 Jews died as a result of war, famine and disease. Over 1,000,000 Jews were exiled to all parts of the Roman Empire. Over

100,000 Jews were sold as slaves by the Romans or were killed and tortured in gladiator “games” and pagan celebrations.

Subsequent Happenings on or About Tish’a B’av

Av 9, 71 AD – The Roman army plowed Jerusalem with salt on July 25, 71 AD.

Av 9, 132 AD – The Romans crushed Bar Kokhba’s revolt and destroyed the city of Betar, killing over 100,000 Jews on July 8, 132 AD.

Av 9, 133 AD – July 29, 133. Turnus Rufus ploughed the site of the Temple. The Romans build the pagan city of Aelia Capitolina on the site of Jerusalem.

Av 9, 135 AD – The destruction of Simeon Bar Kokhba’s army on August 5, 135 AD.

Av 9, 1095 AD – The First Crusade was declared by Pope Urban II on July 20, 1095. The Crusades brought death and destruction to thousands of Jews, totally obliterating many communities in Rhineland and France.

Av 9, 1190 AD – 500 Jews died as a result of the rich storming a castle in York, England, on July 14, 1190.

Av 9, 1290 AD – July 25, 1290 – Jews forced out of England accompanied by pogroms and confiscation of books and property.

Av 9, 1306 AD – July 22, 1306 – The Jews were expelled from France again, accompanied by pogroms and confiscation of books and property.

Av 9, 1492 AD – August 11, 1492 – The Inquisition in Spain and Portugal culminated in the expulsion of the Jews from the Iberian Peninsula. Families were separated, many died by drowning, and there was massive loss of property by all. Christopher Columbus, a Jew set sail for the purpose of finding a shorter route to the markets of silk and spice of China and India.

Av 9, 1648 AD – On July 18, 1648, Bohdan Zenobi Chmielnicki, the leader of the Cossacks, a military class of Ukrainian-southern Russians, began the massacre of tens of thousands of Polish Jews. This massacre continued until 1651.

Av 9, 1914 AD — World War I begins on August 1, 1914. Russia also launched persecutions against the Jews in Eastern Russia on this same day. There were over 400 pogroms immediately following World War I in Hungary, Ukraine, Poland, and Russia.

Av 9, 1929 AD – August 15, 1929. Mufti Hajj Amin Al Hussein stirred up riots against Jews at the Wailing Wall; Hebron Massacre ensues.

Av 9, 1941 AD – On August 2, 1941, SS commander Heinrich Himmler formally received approval from the Nazi Party for “The Final Solution.”

Av 9, 1942 AD – The mass deportation began of Jews from the Warsaw Ghetto, en route to the Treblinka Concentration Camp; began on the eve of July 23, 1942.

Av 9, 1989 AD – On August 10, 1989, the Iraqis walked out of the talks with Kuwait, then invaded Kuwait and set fires to the oil wells. This action finally led to the Gulf War in 1992.

Av 9, 1994 AD – The Jewish community center in Buenos Aires, Argentina, was bombed, killing 86 and wounding 300 others on Monday, July 18, 1994. On that same day, the twenty-one pieces of Shoemaker-Levi Comet began bombarding the Planet Jupiter!

Av 9, 2005 AD – Starting at midnight on August 14, 2005, the entry and presence of Israeli citizens in the Gaza Strip is prohibited.

Av 9, 2006 AD — The Lebanon War breaks out. On August 3, 2006, the Vatican sponsored the “Rome Peace Conference” and put the finishing touches on the “Rome Peace Accord.” This agreement halted the Israeli defensive thrust into Lebanon, and a Hezbollah commando force abducted two Israeli soldiers.

Av 9, 2012 AD – The 2012 Olympics were inaugurated in London, England, on the evening of July 27, 2012. This date marked the 40th anniversary of the 1972 Summer Olympics in Munich, Germany, during which eight Palestinian terrorists infiltrated the Munich Olympic village and killed eleven members of the Israel Olympic team.

Av 9, 2014 AD – On August 5, 2014, Israel commemorated past and present tragedies, especially the destruction of the First and Second Temples in Jerusalem and the subsequent exile of the Jews from the Land of Israel.

Av 9, 2015 AD – On July 25, 2015, the Statue to Satan (Baphomet) was unveiled by the Satanic Temple in Detroit.

Av 9, 2016 AD – August 14, 2016. The Islamic Movement in Israel called for a mass ascent of Muslims to the Al Aqsa Mosque on the Temple Mount, and many Arabs violently rioted. The Olympics in Rio were rife with anti-Semitic incidents.

Av 9, 2017 AD – August 1, 2017. Muslims escalated a war for the Temple Mount following the capitulation by the Israeli government over security measures on the Temple Mount and the Western Wall, or Kotel.

Av 9, 2018 AD – July 10, 2018. Marchers of the Faithful Movement on Tish'a B'Av 2018 were attacked with stones and other dangerous objects by Arab Islamic rioters. On the

night of this year's 9th of Av, a completely red lunar eclipse appeared in the heavens above Israel.

Av 9, 2019 AD – August 11, 2019. Palestinian Muslims shouted at Israeli security forces (unseen) in the Temple Mount in the Old City of Jerusalem. At least five vehicles were damaged in attacks by Jerusalem Arabs hurling stones between the start of Tish'a B'Av (which began with the fall of darkness on Saturday evening) and Sunday at 12 noon. An 18-year-old Jewish boy was seriously wounded Sunday morning when he was attacked by an Arab terrorist on Hagai Street in Jerusalem.

Av 9, 2020 AD – July 30, 2020. Protests against the Israeli government due to the Covid-19 lockdowns continued unabated. Hamas views Israel's intentions to extend its sovereignty over parts of the Jordan Valley, Judea and Samaria as a declaration of war.

History may never account for other tragedies experienced on the 9th of Av that were missed by the annals of history. Just from the thirty events or so noted here we can conclude great mathematical significance is linked to the 9th of Av.

Prophecy watchers have incessantly since the Revelation 12 sign appeared in the stars was announced in September of 2017. There have been new names and people that became enamored with watching for signs of the coming Rapture. Some have fallen by the wayside and others have taken up the mantle to be watching for signs and clues. The hoaxed Covid-19 "bioweapon" has not impeded any of us and perhaps did the opposite by encouraging deeper studies of the Bible. On Friday, May 19th Monte Judah of "Lion and Lamb" Messianic News released more details on **Mr. "666"**. Almost daily we hear of another of Prince Charles coming policies related to his larger plan of "Sustainable Development". Here is another dictate of Charles reported in the UK press!

On Monday, May 22nd, 2023, the UK press reported that King Charles, who once backed these care homes for 40 years – now 'Net Zero' is forcing them to close. It's hard to think of anything more damning about the King's obsession with climate change:

A care home charity backed by the King is being forced to shut down properties because of Government 'Net Zero' rules. Martin Green, chief executive of the country's

leading social care body 'Care England', said on Friday that the Government had "*slapped another fee*" on chronically underfunded care homes by introducing legislation which will force providers to meet new energy efficiency standards at great cost. He warned care providers across the country faced closure due to the prohibitive expense of installing more energy efficient double-glazing, insulation and heating systems, expected to cost social care providers hundreds of thousands of pounds.

He said: "*The Government needs to see that, without help, care homes will not be able to deliver on this without losing beds.*" It came as the 60-year-old care home provider Abbeyfield, of which the King has been a patron for more than 40 years, confirmed 43 of its homes face closure because of the unmanageable costs of improving their Energy Performance Certificate (EPC) rating to C by 2030. In a letter seen by this newspaper, residents were this week told an extensive review had concluded the cost of upgrading its properties under government net zero plans was "*too great*" for the charity to meet, saying it had identified a number of homes "*which can no longer be operated sustainably*".

Residents of an Abbeyfield home in Cornwall told local news reporters it was "*one of the worst things I have heard in my life*" and that the prospect of losing their home was keeping them up a night, while a 76-year-old resident of a care home in Wiltshire said she "*didn't know why this was happening*". Charities have warned elderly residents' lives were at risk, due to the shock of the prospect of losing their homes.

The upgrades are necessary because of the Government's efforts to meet its target of Net Zero carbon emissions by 2050. This fiasco lies at King Charles' door as much as the political establishment's.

It is all very well for Charles to pontificate and issue warnings of X months to save the planet. But we are now seeing the practical outworking's of his incessant political campaign, which he began years ago.

In A Stunning Phase 2 'Great Reset' Move, Emmanuel Macron's France has banned all Short-Haul domestic flights citing 'Climate Change' Reasons. This followed a similar decision made in the UK to eliminate air travel with the exception of three cities.

Farmers in the Netherlands may be restricted to just two cows to an area the size of a soccer stadium pitch, or slightly wider than an American football field.

Prime Minister Mark Rutte, who has led the Netherlands at the head of the RINO-style People's Party for Freedom and Democracy (VVD) since 2010, is attacking farmers on multiple fronts as he attempts to implement EU diktats related to nitrogen, methane, and other climate change boogeymen.

This has resulted in widespread farmer protests, one of which saw police open fire on a slowly-moving tractor driven by a 16-year-old-boy, and the rise of a pro-farmer political party, the BoerBurgerBeweging (Farmer-Citizen Movement, or BBB), which recently

won provincial elections in every region of the Netherlands and is set to become the largest party in the Dutch senate.

Popular resistance and political defeat have not stopped the VVD's governing coalition from pushing on with the green agenda, however. Reports indicate that it is looking at supplementing its efforts to forcibly buy out many farmers with restrictions on the number of livestock that can be grazed in a given amount of space – which would of course render many farms unviable.

The two-cows-per-field proposal has leaked as negotiations between farmers and the governing class are ongoing, Another insane decision of Prince Charles.

"I am incredibly disappointed that there is a leak. I don't know where it came from, but it is bad because it is not helpful to the process," seethed Piet Adema, the government minister for agriculture, in comments to lawmakers, evidently preferring that the public be kept in the dark about such things.

"We are still negotiating. Everything is still in motion," he insisted.

Some aren't so sure that climate change is the only motivation, however. Leading pro-farmer activist Eva Vlaardingerbroek believes it is less concerned with climate change than it is with acquiring more land to build housing for North African and other migrants, who have been arriving in the densely-populated country en masse for years.

Indeed, after the courts blocked construction projects on grounds that they would produce emissions violating binding climate agreements, Prime Minister Rutte warned they would not be able to proceed until emissions are reduced elsewhere – and that means dropping the hammer on farmers.

From just these three examples given here, it becomes obvious that old "Sausage Fingers" has not been puttering in his flower garden on his properties in Scotland, Wales and the UK. His plans for "Sustainable Development" and a "green" world is the essence of Charles "Great Reset". Keep in mind that Prince Charles has been planning his utopia for almost four decades. Once the Queen died last year it was merely a matter of time before Charles played his cards in reshaping God's Creation. Charles' plans have a "shelf life" of "seven" years before God destroys the Beast System. May 6th began the clock of everything the Bible describes regarding the Antichrist. A number of researchers have taken the position that the Rapture will take place on Sunday, May 28th, 2023 based upon a misunderstanding of the Feast of Shavuot method of calculating explained in the Feast of Pentecost. Luis Vega discusses this in

his lengthy detailed Postscripts #649 and Luis words suggests the Rapture may be a 9th of Av event, two months later. Luis Vega said:

“One would doubt it because Av 9 is always Day 113 in the Jewish Calendar. One does not see this Supposition, but it is because one has been focusing on the 50 Day Counts, solely based on the Double Count from the Day after Nisan 14. If this be the case, then Av 9 is always beyond the Feast of New Wine. So, whatever Day that falls in, it cannot be the Feast of New Wine, as one Understands it. To stress, the 9th of Av will always then be the 113th Day since Nisan 15.

So, this Count would be way beyond the scope of the 50-50-50 Feasts of Summer Pattern and Day Count. Those that are Proponents of an Av 9 Rapture Timing appear to link it to the Evil Report of the Spies occurred on or correlated to a 9th of Av. Perhaps, but the Golden Calf incident is a Curse enough, because that is precisely the Day that Moses came down the Mountain after the initial 40 Day Count and smashed the Tablets. It is there that the 3000 were Judged and Perished. As the Traditional Jewish and Christian Pentecost approaches, one wanted to reassert one’s Theory of how the Pentecost of Acts 2 is the Feast of New Wine, etc.”

1. The Pentecost of Acts 2 is or occurred on the Feast of New Wine. It is not the Traditional one that is Celebrated on the Feast of the First Fruits of the Wheat. It is too Early and for that reason that the First Fruits of the Wheat are offered at this point. The Main Wheat Harvest is still 3 Months out, etc.

2. That this Corresponding Feast of the First Fruits of the New Wine Arrival of the Holy Spirit, was on the 2nd of the 3 Minor Feasts of the Summer. Those being the ‘First Fruits’ of the Wheat, Wine and of the Oil.

And one is well-aware that one is going against nearly 2000 Years of ‘Church Tradition’. But for Years, one has introduced this Concept of a Double Count initially, and then of there being 3 Minor Feasts of Summer, a while back that correspond to this Theory, in one’s Opinion. One can be wrong of course. One has updated one’s 2 Primary Articles (See Below) on the Subject.”

After reading Luis Vega’s **Postscript #649**, I was mulling this over in my daily routine of resting of my legs. When I lay down I usually read, write, or make notes to follow up on and I began to play devil’s advocate and raise questions.

Who is Israel's greatest supporter and ally? The U.S. of course.

Who is Israel's greatest supporter if we are suddenly gone? Only God Himself.

Who becomes the target of the Ezekiel 38/39 War of Gog and Magog? Israel.

In the history of Israel the 9th of Av is the most feared date for the Jews round the world.

Frankly I never gave a lot of thought to this but if the Christian Bride is taken on the 9th of Av, who is likely to realize and know about it first? Israel.

Consider the possibility of this next 9th of Av being the date of the Rapture. July 26th is a Wednesday, and as I recall from the late J.R. Church program “Prophecy in the News”, weddings in Israel were conducted on Tuesday or Wednesdays. In Talmudic times, Sunday and Wednesday were especially good marriage days because the court met on Monday and Thursday and any contention as to virginity of the bride could be lodged immediately after the wedding night.

While some days may have been preferred for one reason or another, certain days were explicitly prohibited. Jewish weddings are not held on Shabbat [Sabbath], because work and travel are not permitted then. Also, a new agreement may not be entered into on that day. Further, each opportunity for joy and celebration is to be observed individually, and not combined with another. For this last reason also, two members of the same family could not be married on the same day.

Similarly, weddings are forbidden on the holidays of Rosh Hashanah, Yom Kippur, Pesach [Passover], Shavuot, and the first and last days of Sukkot. But weddings may be held on Purim, the intermediate days of Sukkot, and during Hanukkah.

Traditionally, the entire three-week period between the 17th of Tammuz through the 9th of Av is considered a period of semi-mourning for the destruction of the Temple; therefore, weddings are not held then. Similarly, the seven-week period from Passover through Shavuot [called the Omer period] is a time of mourning for the death of Rabbi Akiva’s students. However, there are a variety of traditions as to which days during this period are acceptable for marriages and which are not. Usually the two Rosh Chodesh dates (of Iyar and Sivan) and Lag B’Omer [the 33rd day of the Omer] are permitted days for weddings. Some rabbis permit weddings on Yom Ha’atzmaut [Israel Independence Day] also. Still other rabbis take an even less stringent approach as to which days during these semi-mourning periods are permissible for weddings.

Customs vary widely as to which days of the Omer are not considered days of semi-mourning and are, therefore, acceptable for weddings. Although generally Sephardic Jews permit weddings beginning the day after Lag B’Omer and most Ashkenazi Jews allow weddings on Lag B’Omer itself, permitted days vary by community and by rabbi, not always following a neat Ashkenazic/Sephardic or liberal/traditional split. It is advisable, therefore, to consult a rabbi when making wedding plans.

Weddings may take place anywhere, but it has been customary to hold them in certain locations. They were sometimes held in the home of the groom or the bride. In fact, in ancient times, “*the groom’s father built special quarters in the family for the married couple.*” The theme of the Bride Motif speaks to the Rapture concept in a beautiful word-picture allegory! In His time on earth, Jesus often used Jewish marriage customs as a beautiful allegory of God’s relationship with the church, His “bride.” Jesus purchased believers with His blood, shed on the cross for the forgiveness of sins -(Acts 20:28; 1st Corinthians 6:19–20; 11:25). He is currently preparing a place for us -(John 14:3), and at a future time no one knows -(Matthew 24:36) He will return for His bride with a trumpet call and a shout -(1st Thessalonians 4:16–17). The dead in Christ and

those alive in Him will be taken to heaven, where they will be joined forever with the Lord -(Revelation 19:7) and take part in the marriage feast of the Lamb (verse 9).

The Rapture is the wedding of the Bridegroom Jesus Christ and His Bride, the believing body of those "In Christ!". At which time He whisks His Bride away for a "seven" year honeymoon. With believers taken out of this world God can now deal with Israel and the coming false pseudo-messiah who claims to be a direct descendant of King David. Need I remind you of this individual's Earthly identity?

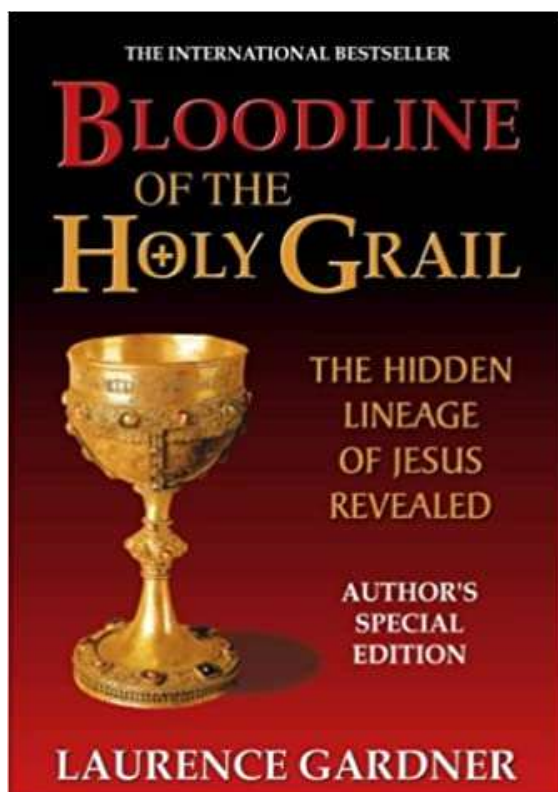

"That vote will be on the package of 300 amendments supplanting (changing) the current International Health Rules," she said. *"The delegates will also vote on the global pandemic health treaty/accord."*

Those two documents will be synthesized and coordinated and will be voted on at the same event in Geneva in May 2024, Bachmann explained.

"There was no dissent registered by any nation thus far at the World Health Assembly 2023 to either the proposed 300 amendments nor to the global pandemic treaty," she said. *"It is a unified voice of support for passage of the amendments and the proposed pandemic treaty."*

She further stated that a U.S. delegate to the Assembly (there are many alternates listed) spoke today, May 23, in favor of passing the package of proposed international health amendments and the global pandemic accords.

Barring intervention, the timetable and agenda are in place for passage in May 2024.

"Nations will negotiate and will discuss the proposed 300 amendments and pandemic treaty in New York City at the UN General Assembly meeting in September 2023," Bachmann said. *"The final package of amendments will be presented to the UN in January 2024, meaning the amendments and treaty will not be altered after that date."*

She further stated that, *“The delegates plan to return to Geneva in February 2024 to discuss and finalize their plans before the final vote one year from now at the 77th World Health Assembly at the United Nations in Geneva, Switzerland, May 2024.”*

Another expert on the globalists’ plans to achieve world domination through the avenue of *“public health”* is James Roguski, a California-based researcher and writer. Roguski runs the website Worldwide.ExitTheWHO.com.

He said the draft documents have been crafted in almost complete secrecy and yet they will be presented as inclusive and reflective of a broad array of stakeholders.

He said U.S. passports in the early 1970s were issued with a smallpox vaccine certificate. This was your proof when entering another country that you had been immunized against smallpox. He said his girlfriend still has an old passport from 1972 showing the certificate of vaccination.

“In Annex 6 of the International Health Regulations there’s a form identical to my girlfriend’s passport of 1972. It’s already been there but they want to digitize that, which would make it much easier to expand to whatever else they want to require or mandate. Digitizing it would open it up to all sorts of other certificates of compliance on a QR code.”

Roguski said every nation under these proposed changes sees itself as having the right to tell foreign travelers *“you have to get these injections or you can’t come to our nation or state.”*

The question is, how to do that?

This one item, digital health certificates, is included in the proposed amendments to the IHRs. That also happens to be the one item the G20 nations all agreed at their summit in Indonesia last November that they wanted every nation to accept and implement.

“Each nation is about to be coerced into abusing not necessarily their own citizens’ freedoms but the freedoms of the citizens of every other nation, but if everyone agrees to abuse other nations’ citizens then everyone ends up being abused,” Roguski said. *“The irony and the hypocrisy are unbelievable. This is the thing that I think they might push through. It’s just a digital expansion of what everyone already accepts, and then you really do have a worldwide (digital) ID system that easily becomes the beast system.”*

“And nobody is talking about it,” Roguski said. *“They could push that through quietly.”*

“They have these systems in place already,” he added. *“All they have to do is sneak it in under the guise of some other issue.”*

What might that *“other”* issue be? The need for Voter ID perhaps?

“I can appreciate a skillfully crafted evil plan, and that’s what I see here. There will be a lot of people that you wouldn’t expect, who would actually fall for this. They’d say, ‘Oh you don’t have to get jabbed. You just have to get a test and then just let us check your digital ID.’”

Bingo. We saw during Covid how many people refused the jab but agreed to get tested in order to be able to do certain things, go certain places. They will do it again, thinking they avoided the jabs, only they will be accepting a global digital ID. They will now be marked with a digital ID that is recognized and certified under global standards set by the WHO. They are now a certified obedient *“citizen of the world”* who is able to travel internationally without incident.

If the U.N. and its support structure within the global corporations and governments of the world are able to pull this one off on us, then we deserve all of the oppression that comes our way. It’s not like we didn’t get a good warning. The lessons of the last pandemic were clear. Any power or authority you give these monsters over your life, whether it be your local health director or the demonic entities in high places at the United Nations, they will claim that power over you perpetually and assume your obedience/submission to them. If you withhold your submission, you get *“left behind,”* unable to buy or sell, move about freely, work a job or receive any government benefits. That, my friends, is where this is heading whether you want to believe it or not. The overwhelming majority will offer their fealty to the beast.

Whatever they agree to at the World Health Assembly, this year or one year from now in 2024, will be binding on the 194 member states.

“And the WHO will have the power to say what is disinformation or misinformation,” Roguski said. *“The WHO will be the arbiter of what the science is. That is a massive power grab.”*

The WHO and its backers are also introducing a concept which they call One Health. This merges the interests of all life on planet earth — animal, human and plant life. All health decisions will be made through the lens of a One Health approach. You can see where this will get dicey.

“This gives the director general the ability to declare a public health emergency of international concern, triggering lockdowns, masking, forced vaccinations, etc.,” Roguski said. *“It doesn’t even have to be a real emergency. It could be even just a risk of an international emergency.”*

“They are signing us up for digital slavery. The WHO is the global hegemon when it comes to forced vaccines policed through digital vaccine passports. But then, if this passes, it will go beyond pandemics to any HEALTH EMERGENCY as declared by the WHO.”

That could include anything from climate change to gun violence or the so-called “attacks” on transgendered persons.

“Anything could trigger the massive new powers they want to give to the WHO,” Roguski said.

The proposed amendments eliminate protections. Under Article 3, for instance, the requirement that they respect human rights and human dignity is replaced with “equity.”

“This gives the WHO a monopoly power over healthcare standards of care during so-called emergencies. This means we are actually empowering Bill Gates and China to direct policy, signing away rights and liberties carte blanche.”

Roguski noted that the recommendation to vaccinate children down to 6 months of age came from the WHO. Most nations did not listen to this recommendation. The U.S. did.

Anyone who argued that Covid vaccines were dangerous for adults, pregnant mothers, children or babies was branded as a purveyor of misinformation and was silenced by the media/social media platforms working in tandem with Big Pharma and the government.

“There will be only one version of the truth,” Roguski said. “That doesn’t sound like science or the scientific method to me ...Sovereignty in a democratic republic legitimately belongs to the people. It’s not Biden’s or anyone else’s to give away.”

A related post by the former director of the CDC, Dr. Robert Redfield, posted today May 24th stated that the next virus released will be a more lethal Avian Bird Flu. This is the second time in as many months Dr. Redfield has issued this warning.
