## ***Dangerous Disconnect Between Israel and Russia in Syria***

Israeli aircraft are reportedly now not crossing into Syrian airspace for fear the Russians might target them.

Israel Today reported recently reported the sensitive headline above. The chance of an accidental confrontation between Israeli and Russian forces in Syria has increased greatly.



A few years ago Prime Minister Benjamin Netanyahu and Russian President Vladimir Putin established a “red phone” hotline between the senior command of the Israel Defense Forces (IDF) and Russian forces operating in Syria.

With Israel carrying out routine strikes against Iranian and Hezbollah targets in Syria, Israel and Russia wanted to avoid an accidental confrontation with one another.

But that hotline has reportedly now been cut.

Over the past ten days Israel Air Force carried out strikes on multiple targets in and around the Syrian capital of Damascus, including a ballistic missile base. But unlike some past airstrikes, this one was carried out from within Israeli airspace.

Israeli aircraft are reportedly now not crossing into Syrian airspace for fear the Russians might target them.

The Arabic newspaper Al-Jarida cited an unnamed Western diplomat as saying that Israeli commanders have for weeks been unable to contact the Russians via the hotline to coordinate these strikes, as conveyed by the Israeli website Natziv.net. Russian Ambassador to Israel Anatoly Viktorov was said to have insisted that the line was disconnected because of a technical problem, and that it should not be seen as a hostile move by Moscow.

But that it has been disconnected for so long is cause for concern in Jerusalem.

Moscow has threatened in recent years to stop turning a blind eye to Israeli airstrikes in Syria, in apparent retaliation for Israel siding more with Ukraine than with Russia.

Then Iran unveiled its latest on June 6th, its first domestically-made hypersonic ballistic missile capable of traveling at 15 times the speed of sound with a range of 1,400 kilometers. Named Fattah, or 'Conqueror' in Farsi, officials described the missile as "a *generational leap*." For many that might seem Israel is slipping in its ability to defend against missile attacks.

In November, Hajizadeh said Iran's new hypersonic missile could reach Israel in 400 seconds.

Hypersonic weapons fly at speeds in excess of Mach 5, are capable of striking targets thousands of miles away in 15-30 minutes, and pose crucial challenges to missile defense systems because of their speed and maneuverability.

Israel has authorized plans for a potential preemptive strike on Iran as recently as June 9<sup>th</sup> and could occur in days. With recent events in the Middle East, Israel is faced with the loss of access to Saudi Arabian air space, something that they had until Saudi Arabia and Iran have established working relations. It seems from Israel's enemies frequent rocket attacks that Israel recognizes the possibility of being overwhelmed by the missile attacks when the PLO, Hamas, Hezbollah should decide to simultaneously attack Israel. Israel's "Iron Dome", "David's Sling", and other systems face great odds of being defeated through sheer numbers.

For that very reason, it is my opinion that both Israel and the U.S. both have a super-secret technology that few people are aware of. Back in 2017 an event occurred with the U.S. Navy that went by with some curiosity.

Michael E. Salla, PhD, wrote an article which had my attention. Since 2000, I became fascinated with Nikola Tesla scalar wave technology and purchased several books by Lt. Col. Thomas Bearden, PhD. He has since passed away in 2022, but he was a key person in the U.S. Army missile defense and physics research. The content of Dr. Michael E. Salla's article was related to Nikola Tesla and what Dr. Thomas Bearden discussed. The article so intrigued me to do my own research. After Nikola Tesla died in 1943, all of his files, papers, research were gathered up by the FBI and disappeared from sight. Nikola Tesla died January 7<sup>th</sup>, 1943. He offered the U.S. government a weapon that could destroy anything in the sky within 250 miles, and from what I do know the U.S. military dismissed it as fantasy without ever exploring Tesla's ideas. That offer rebuttal apparently was had the attention of the government since the hotel where he lived secured the apartment until the FBI could confiscate his work. Years later his possessions were returned to his birth place where a museum was opened in his name in Serbia.

Nikola Tesla sought to solve some of science's greatest mysteries. The brilliant inventor had lived a remarkable life — churning out innovations like alternating-current electricity and presciently imagining a world of “wireless communication.” But when he died alone and broke in 1943 in New York City, he left behind a wealth of mysteries and what-ifs. He lived in a small apartment on the 33<sup>rd</sup> Floor of the Hotel New Yorker.

In short order, U.S. government agents promptly swept into the hotel where Tesla had been living and gathered his notes and files. Many believe they were looking for evidence of Tesla's “death ray,” a device he had been teasing for years that could change warfare forever, as well as any other inventions they could find. Since the U.S. government has been known for stealing intellectual property via the U.S. Patent office, we should not doubt that the U.S. has had eight years to do R&D of Tesla's ideas.

In January 2017, all U.S. aircraft carriers were recalled to their home ports for unknown upgrades. There has been much speculation about what the carriers had been secretly equipped with given the growing threats posed by hypersonic cruise missiles against which the carriers appeared defenseless. The 2018 release of a Navy patent provides a compelling answer to what had happened during the recall. The carriers were secretly equipped with powerful electromagnetic “Tesla” shields that could neutralize all hypersonic and ballistic missile threats.

In January 2017, several news reports appeared describing the recall of all U.S. aircraft carriers to home ports and how for the first time none were actively serving anywhere in the world. On December 30, 2016, a Fox News report explained:

For the next week, not only will there be no U.S. Navy aircraft carrier in the Middle East, but there will be no American aircraft carriers deployed at sea anywhere else in the

world, despite a host of worldwide threats facing the United States... the absence of a deployed U.S. Navy aircraft carrier, long seen as a symbol of American power projection, is noteworthy. It is believed to be the first time since World War II that at least one U.S. aircraft carrier has not been deployed.

When the Navy was questioned by Fox News about the recall of all its aircraft carriers in the Middle East, a Navy spokesperson said:

*"We are not going to discuss the timing of operational movements of carrier strike groups into and out of the U.S. Central Command area of responsibility,"* said Capt. Terry Shannon, a U.S. Naval Forces Central Command spokesman, in a statement to Fox News. Centcom is tasked with control over all U.S. forces in the Middle East and Afghanistan.

The lack of explanation for the recall led to much speculation including some concluding that the recall was done to set up the U.S. for a major false flag attack:

In what can only be described as a disproportionate appropriation of U.S. Navy assets, a blatant breach of standard protocol, and a possible set up for a false flag operation — the entire U.S. Navy aircraft carrier group, 10 active carriers, have returned to port and are now all sitting ducks.

By the end of January 2017, the Navy began redeploying its aircraft carriers and the recall was quickly forgotten. In order to understand why the aircraft carriers were recalled and what they may have been upgraded with, we need to consider the growing threat posed by cruise missiles capable of hypersonic speeds.

I first wrote about cruise missiles developed by Russia and China and sold to countries like Iran that could threaten aircraft carrier battle groups back in November 19, 2007. In an article titled: *"The Neoconservative Agenda to Sacrifice the Fifth Fleet – The New Pearl Harbor,"* I explained:

Iran has sufficient quantities of cruise missiles to destroy much or all of the Fifth Fleet which is within range of Iran's mobile missile launchers strategically located along its mountainous terrain overlooking the Persian Gulf. The Bush administration is deliberately downplaying the vulnerability of the Fifth Fleet to Iran's advanced missile technology which has been purchased from Russia and China since the late 1990's. The most sophisticated of Iran's cruise missiles are the 'Sunburn' and 'Yakhonts'. These are missiles against which U.S. military experts conclude modern warships have no effective defense.

I further described the capabilities of the cruise missiles sold to Iran as follows:

The SS-N-22 or 'Sunburn' has a speed of Mach 2.5 or 1500 miles an hour, uses stealth technology and has a range up to 130 miles. It contains a conventional warhead of 750 lbs. that can destroy most ships. Of even greater concern is Russia's SSN-X-26 or

'Yakhonts' cruise missile which has a range of 185 miles which makes all US Navy ships in the Persian Gulf vulnerable to attack. More importantly, the Yakhonts has been specifically developed for use against Carrier groups and has been sold by Russia on the international arms trade.

Over the subsequent decade, cruise missile payloads and speeds have increased to the extent that Russia has now developed missiles that can travel over five times the speed of sound. At his February 20, 2019 State of the Nation address, President Vladimir Putin public announced the existence of the first hypersonic cruise missiles, which the Pentagon determined had been under development and testing since 2015:

*"This is a hypersonic missile called Tsirkon. It will have the speed of Mach 9, it has a range of 1,000 kilometers (620 miles) and can hit navy or land targets."*

In December, CNBC learned that a U.S. Intelligence report had highlighted testing of the Tsirkon hypersonic system, noting that five tests had been carried out by the Russian military since 2015.

Putin has previously described Russia's hypersonic prowess as "invincible" and accused "those who have fueled the arms race over the last 15 years" of failing to contain Russia.

China is not far beyond Russia in developing cruise missiles capable of hypersonic speeds, and currently has a number of hypersonic ballistic missiles that can be deployed against aircraft carriers. On January 2019, Elizabeth Shim from UPI reported:

China plans to deploy midrange ballistic missiles capable of destroying U.S. aircraft carriers by 2020, according to multiple state media reports.

China Times and others reported Tuesday the Dongfeng-17 is a midrange rocket that could be used to sink an entire U.S. aircraft carrier, if it is fired eight times.

The threat posed by hypersonic cruise and ballistic missiles to aircraft carriers and their support ships is well understood by senior Navy leaders and researchers. According to a March 6, 2018 news story published in *'The Examiner'*:

The era of the American aircraft carrier as the premier embodiment of military might could be ending unless the U.S. develops defenses for the next generation of highly maneuverable, super-fast hypersonic weapons under development by Russia and China, the Pentagon's top weapons researcher said Tuesday.

Michael Griffin, undersecretary of defense for research and engineering, said China is spending billions to develop a non-nuclear version of the weapons that could render U.S. aircraft carriers vulnerable to attack.

Despite the threat posed by increasingly sophisticated and powerful hypersonic missile systems under development by major geopolitical rivals, the U.S. Navy has nevertheless gone ahead with building and deploying a new generation of aircraft carriers beginning with the USS Gerald Ford, which is scheduled to formally begin active service in 2022.

This brings us back to the question of why did the U.S. Navy recall all its aircraft carriers in early 2017, and forge ahead with plans to build the larger and more expensive Ford-class carriers?

For an answer, we need to review a 2018 patent awarded to a Navy scientist, Salvatore Cezar Pai, which is titled: “The High Energy Electromagnetic Field Generator” (HEEMFG). In a previous article, I briefly described his patent as an electromagnetic shield. The patent’s summary describes one of the goals of the HEEMFG is to protect the Earth from potential asteroid impacts:

It is a feature of the present invention to provide a method and apparatus for deflecting or destroying a large asteroid and preventing a possible collision with earth. The present invention may also deflect or destroy any other type of object.

It is the HEEMFG’s ability to “deflect or destroy” fast traveling objects which directly pertains to the question of why the Navy recalled all its aircraft carriers and is moving ahead with building more Ford-class carriers:

It is a feature of the present invention to provide a method and apparatus for generating an impenetrable defensive shield to Sea and Land as well as Space-based military and civilian assets, protecting these assets from such threats as Anti-Ship Ballistic Missiles, Radar Evading Cruise Missiles, Top Attack for Main Battle Tanks (land and sea based systems), as well as counteracting the effects of solar-induced Coronal Mass Ejections or defending critical military satellites in an ASAT role (space based system). 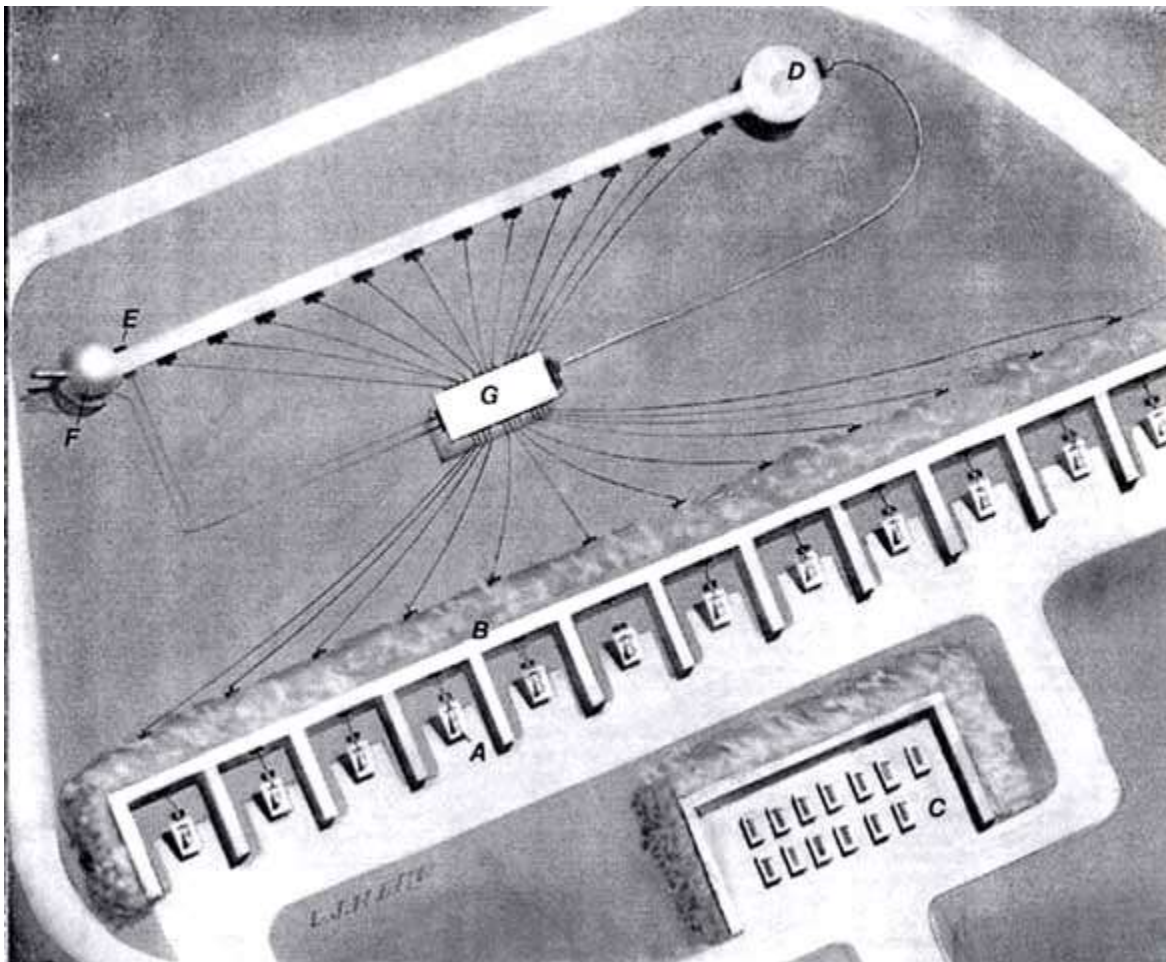
The development of an impenetrable electromagnetic shield to defend a target from fast traveling objects such as asteroids and missiles is very similar to ideas first proposed by the Serbian inventor Nikola Tesla back in the 1930’s, Tesla proposed an electromagnetic shield based on scalar wave principle which has been explained as follows:

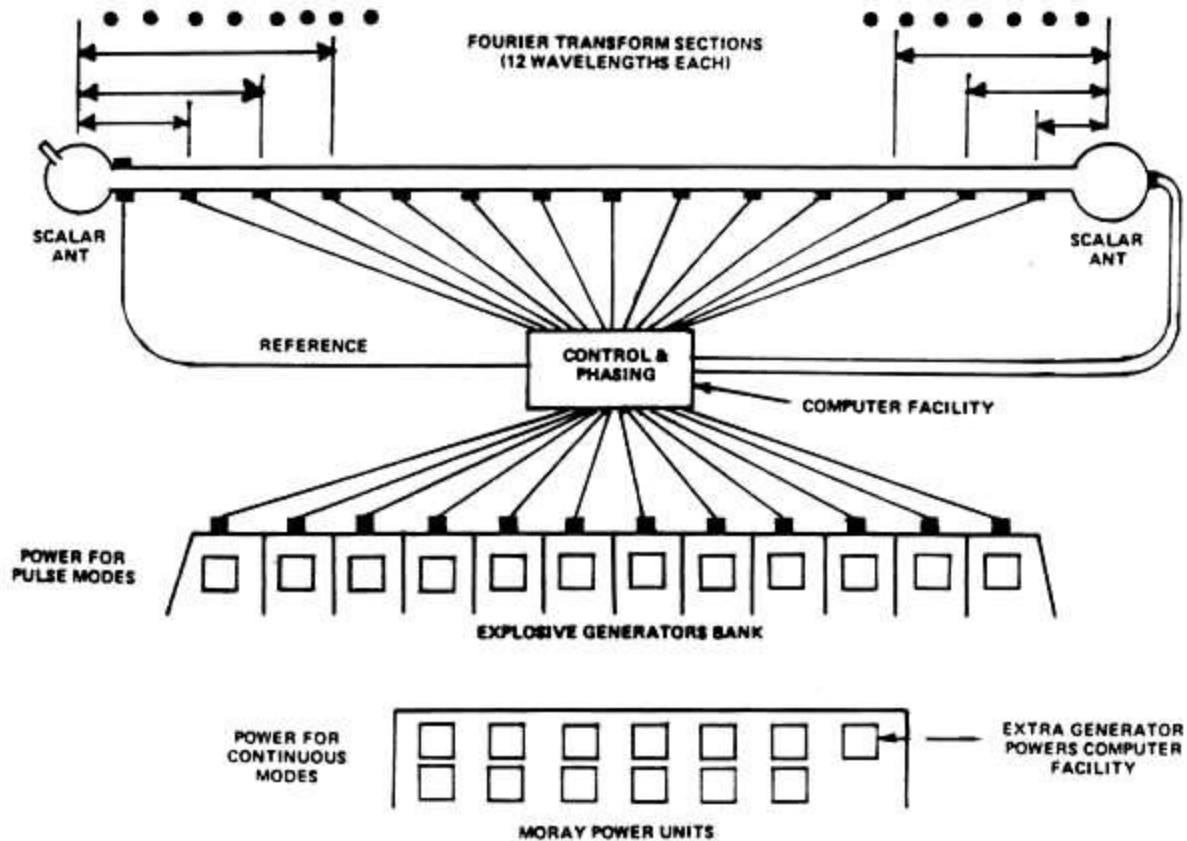
Scalar Waves can be warped into a dome around objects, such as cities or houses... Such a Scalar Wave force field is generally known as a Tesla Shield, and it would be analogous to the “shields” referred to in the popular “Star Trek” series. Tesla Shields have a definite defensive application, and could not in any way be used for offensive purposes (although a platoon of soldiers charging into a Tesla Shield would be instantly disintegrated). The only defense from a blast of a Scalar Wave Howitzer would be a Tesla Shield.

In the 1930's Tesla announced other bizarre and terrible weapons: a death ray, a weapon to destroy hundreds or even thousands of aircraft at hundreds of miles range, and his ultimate weapon to end all war -- the Tesla shield, which nothing could penetrate. However, by this time no one any longer paid any real attention to the forgotten great genius. Tesla died in 1943 without ever revealing the secret of these great weapons and inventions.

Unfortunately, in 1981 the Soviet Union has long since discovered and weaponized the Tesla scalar wave effects. Here we only have time to detail the most powerful of these frightening Tesla weapons -- which Brezhnev undoubtedly was referring to in 1975 when the Soviet side at the SALT talks suddenly suggested limiting the development of new weapons *"more frightening than the mind of man had imagined."*

One of these weapons is the Tesla howitzer recently completed at the Saryshagan missile range and presently considered to be either a high-energy laser or a particle beam weapon, (See Aviation Week & Space Technology, July 28, 1980, pg. 48 for an artist's conception.)

The Saryshagan howitzer actually is a huge Tesla scalar interferometer with four modes of operation. One continuous mode is the Tesla shield, which places a thin, impenetrable hemispherical shell of energy over a large defended area. The 3-dimensional shell is created by interfering two Fourier-expansion, 3-dimensional scalar hemispherical patterns in space so they pair-couple into a dome-like shell of intense, ordinary electromagnetic energy.

The air molecules and atoms in the shell are totally ionized and thus highly excited, giving off intense, glowing light. Anything physical which hits the shell receives an enormous discharge of electrical energy and is instantly vaporized -- it goes pfft! like a bug hitting one of the electrical bug killers now so much in vogue. The World Trade Center building #1 and #2 were vaporized and Dr. Judy Wood's book *'Where Did The Towers Go?'* presents the case where Scalar waves were used to vaporize the Towers. This information goes against the government narrative in every way but millions of tons of building disappeared in dust scattered all over New York City. Since 9/11 various groups have continued to study and analyze the various theories and conclusions. Dr.



Judy Wood's theory is the only one consistent with this theory. Its secrecy will be guarded by the powers to be at all costs.

If several of these hemispherical shells are concentrically stacked, even the gamma radiation and EMP from a high altitude nuclear explosion above the stack cannot penetrate all the shells due to repetitive absorption and re-radiation, and scattering in the layered plasmas.

In the continuous shield mode, the Tesla interferometer is fed by a bank of Moray free energy generators, so that enormous energy is available in the shield. A diagram of the Saryshagan-type Tesla howitzer is shown in figure 7. Hal Crawford's fine drawing of the interferometer end of the Tesla howitzer is shown in figure 6.

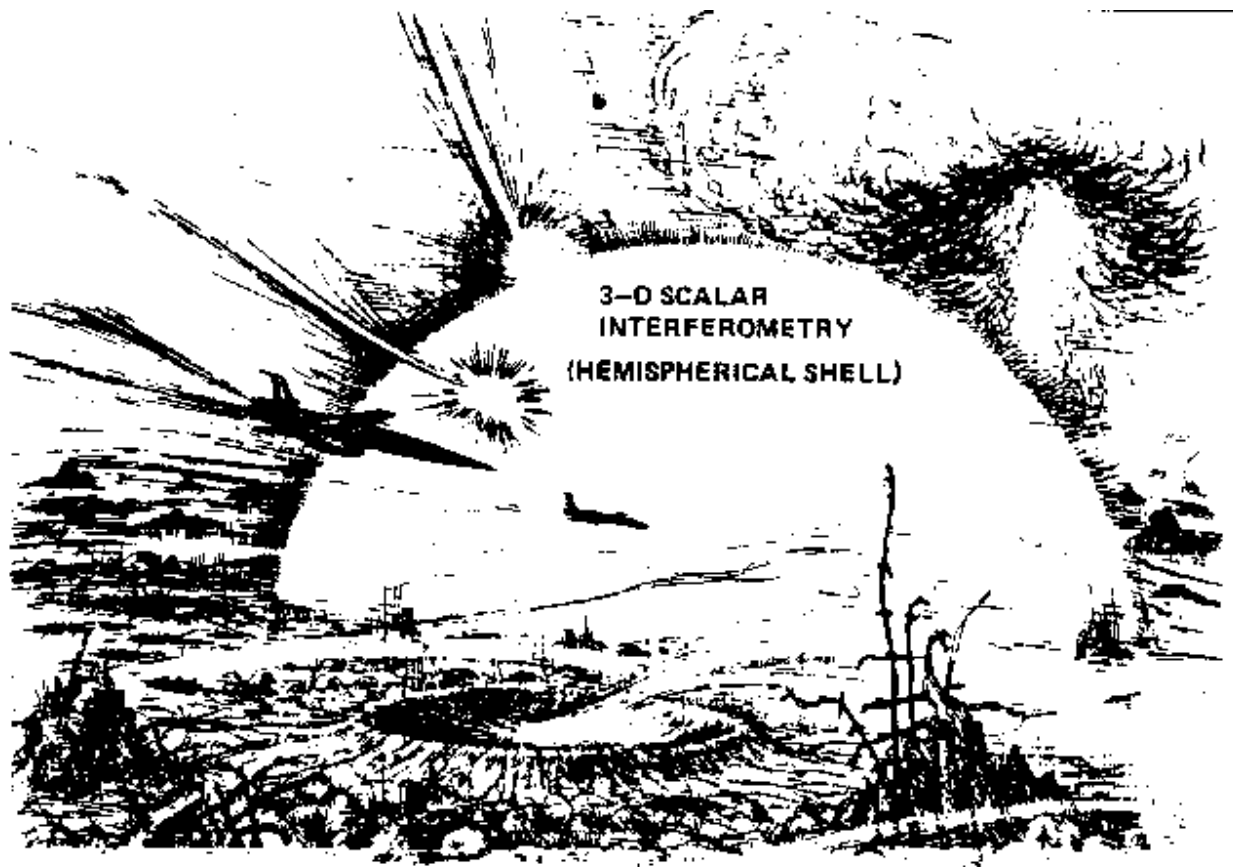


Figure 8. The Tesla Shield

Hal's exceptional rendition of the Tesla shield produced by the howitzer is shown in figure 8.

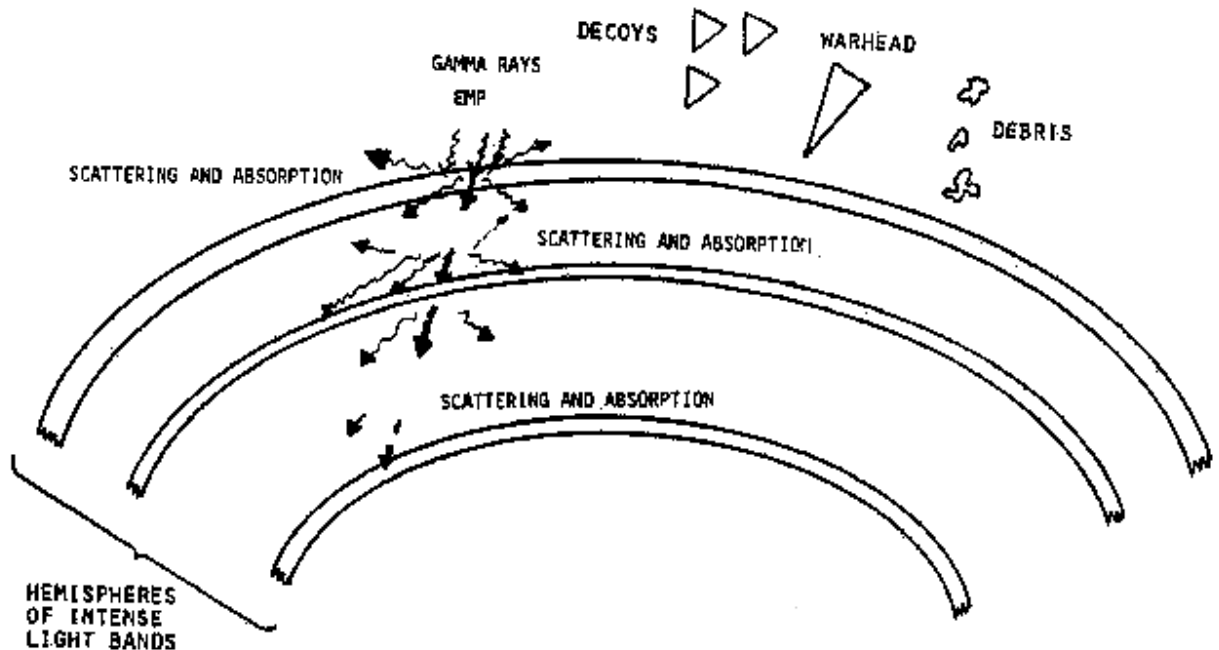


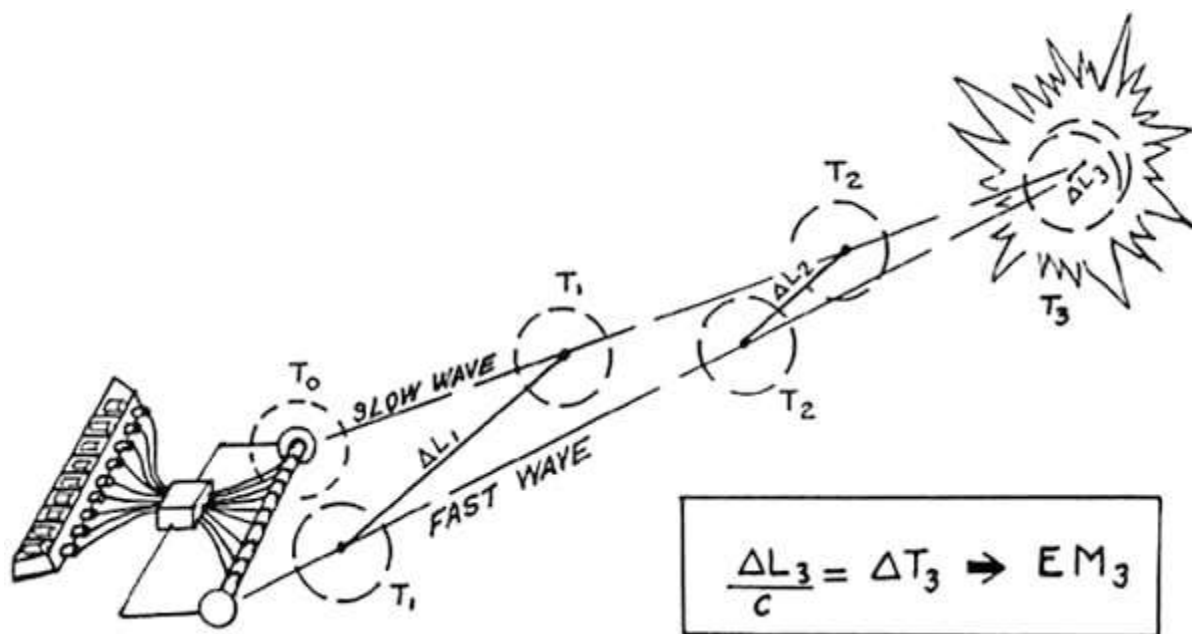
Figure 9. Tesla Terminal Area Defense System

In the pulse mode, a single intense 3-dimensional scalar phi-field pulse form is fired, using two truncated Fourier transforms, each involving several frequencies, to provide the proper 3-dimensional shape (Figure 10). This is why two scalar antennas separated by a baseline are required. After a time delay calculated for the particular target, a second and faster pulse form of the same shape is fired from the interferometer antennas.

The second pulse overtakes the first, catching it over the target zone and pair-coupling with it to instantly form a violent EMP of ordinary vector (Hertzian) electromagnetic energy. There is thus no vector transmission loss between the howitzer and the burst. Further, the coupling time is extremely short, and the energy will appear sharply in an "electromagnetic pulse (EMP)" strikingly similar to the 2-pulsed EMP of a nuclear weapon.

This type weapon is what actually caused the mysterious flashes off the southwest coast of Africa, picked up in 1979 and 1980 by Vela satellites. The second flash, e.g., was in the infrared only, with no visible spectrum. Nuclear flashes do not do that, and neither does super-lightning, meteorite strikes, meteors, etc.

In addition, one of the scientists at the Arecibo Ionospheric Observatory observed a gravitational wave disturbance - signature of the truncated Fourier pattern and the time-squeezing effect of the Tesla potential wave - traveling toward the vicinity of the explosion.

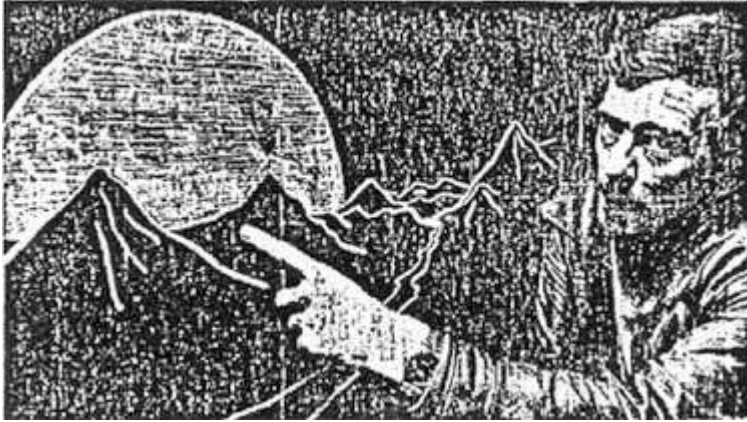
The pulse mode may be fed from either Moray generators or -- if the Moray generators have suffered their anomalous "all fail" malfunction -- ordinary explosive generators.

Thus the Tesla howitzer can always function in the pulse mode, but it will be limited in power if the Moray generators fail.

In the continuous mode, two continuous scalar waves are emitted -- one faster than the other -- and they pair-couple into vector energy at the region where they approach an in-phase condition. In this mode, the energy in the distant "ball" or geometric region would appear continuously and be sustained -- and this is Tesla's secret of wireless transmission of energy at a distance without any losses. It is also the secret of a "continuous fireball" weapon capable of destroying hundreds of aircraft or missiles at a distance.

An example of a Soviet test of this mode of operation is shown in figure 11.

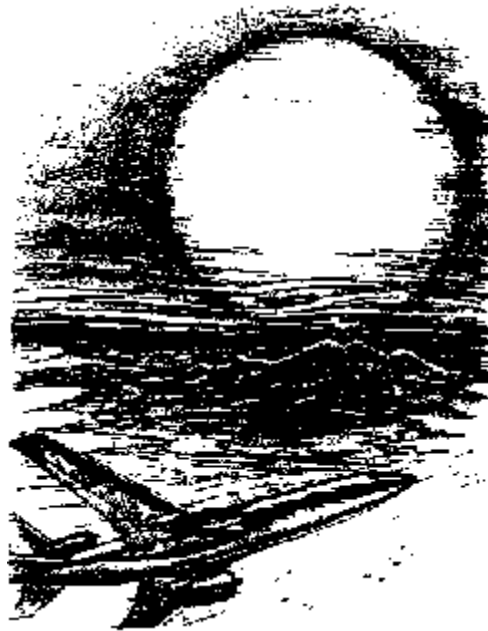

The volume of the Tesla fireball can be vastly expanded to yield a globe which will not vaporize physical vehicles but will deliver an EMP to them to dud their electronics.

A test of this mode is shown in figure 12. (See also Gwynne Roberts, "Witness to a Super Weapon?", the 'London Sunday Times', 17 August 1980 for several other tests of this mode at Saryshagan, seen from Afghanistan by British TV cameraman and former War Correspondent Nick Downie.)

If the Moray generators fail anomalously, then a continuous mode limited in power and range could conceivably be sustained by powering the interferometer from more conventional power-sources such as advanced magneto-hydrodynamic generators.

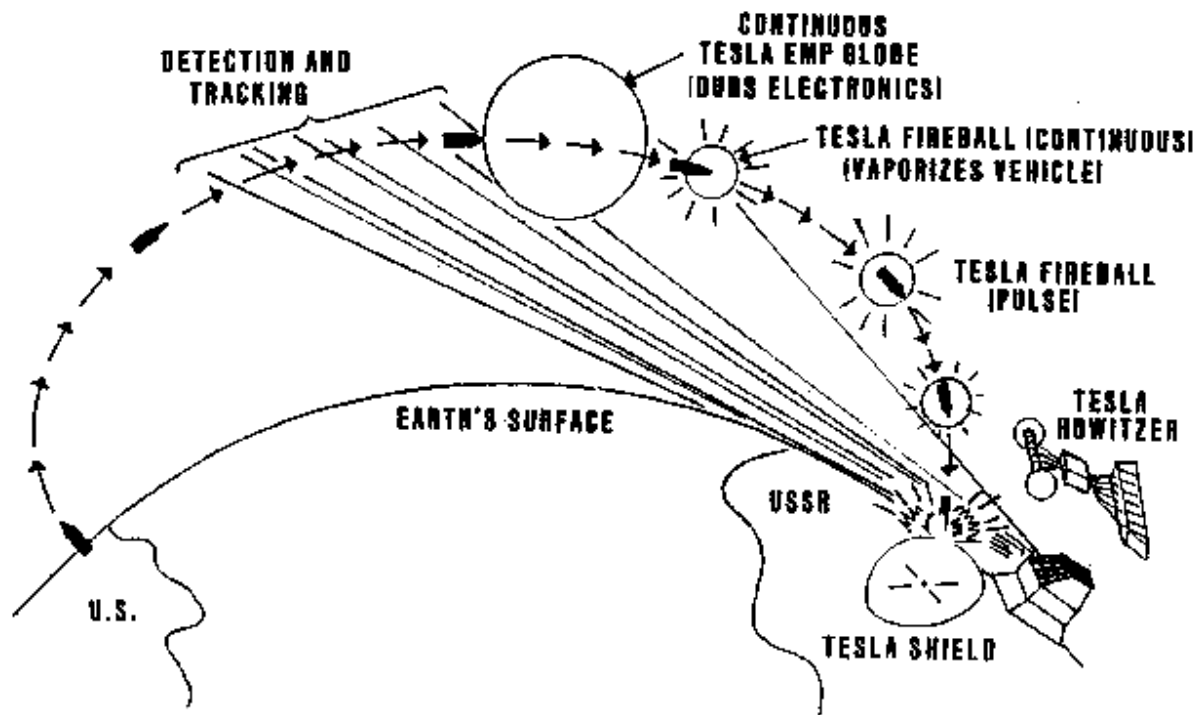


Figure 13. Tesla ABM Defenses

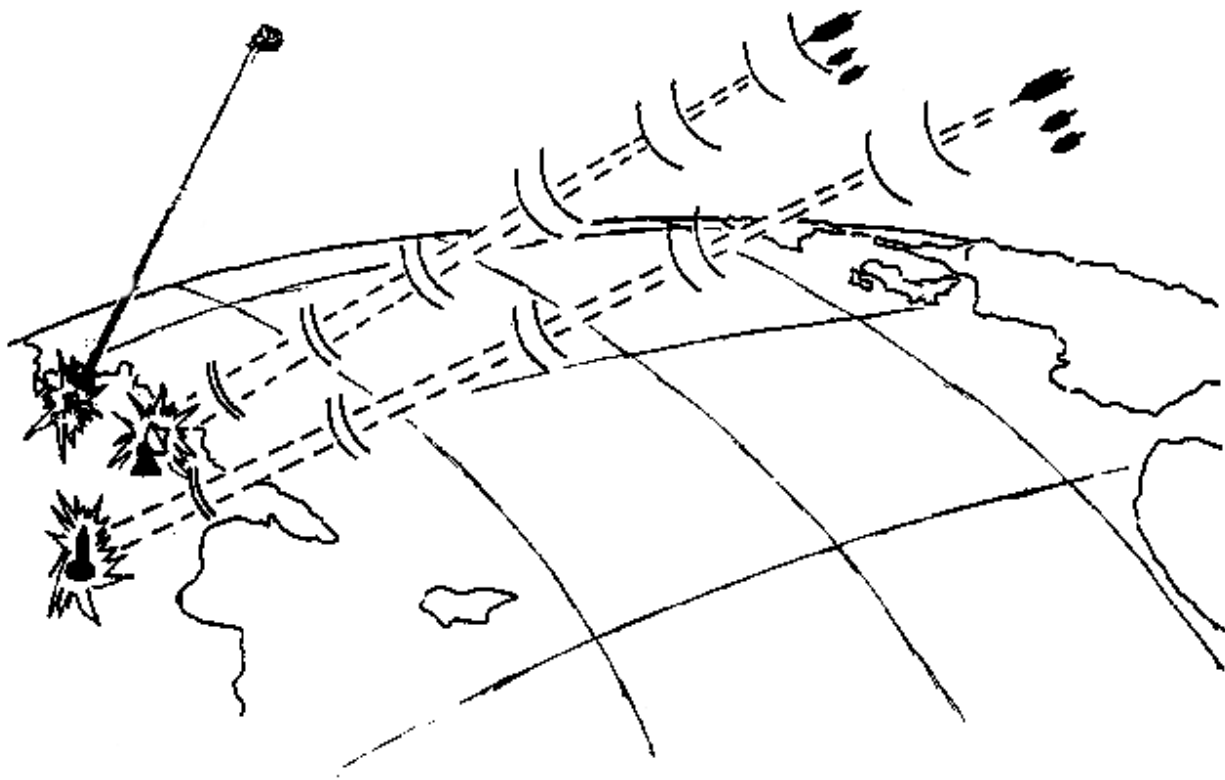


Figure 14. Moray/Tesla Technology: Star Wars Now

Typical strategic ABM uses of Tesla weapons are shown in figure 13. In addition, of course, smaller Tesla howitzer systems for anti-tactical ballistic missile defense of tactical troops and installations could be constituted of more conventional field missile systems using paired or triplet radars, of conventional external appearance, in a scalar interferometer mode.

With Moray generators as power sources and multiply deployed reentry vehicles with scalar antennas and transmitters, ICBM reentry systems now can become long range "blasters" of the target areas, from thousands of kilometers distance (figure 14). Literally, "Star Wars" is liberated by the Tesla technology. And in air attack, jammers and ECM aircraft now become "Tesla blasters." With the Tesla technology, emitters become primary fighting components of stunning power.

The potential peaceful implications of Tesla waves are also enormous. By utilizing the "time squeeze" effect, one can get antigravity, materialization and dematerialization, transmutation, and mindboggling medical benefits. One can also get subluminal and superluminal communication, see through the earth and through the ocean, etc. The new view of phi-field also provides a unified field theory, higher orders of reality, and a new super-relativity, but detailing these possibilities must wait for another book.

With two cerebral brain halves, the human being also has a Tesla scalar interferometer between his ears. And since the brain and nervous system processes avalanche

discharges, it can produce (and detect) scalar Tesla waves to at least a limited degree. Thus a human can sometimes produce anomalous spatiotemporal effects at a distance and through time.

This provides an exact mechanism for psychokinesis, levitation, psychic healing, telepathy, precognition, postcognition, remote viewing, etc. It also provides a reason why an individual can detect a "stick" on a radionics or Hieronymus machine (which processes scalar waves), when ordinary detectors detect nothing.

At the July 1981 U.S. Psychotronics Association's Annual Conference in Dayton, Ohio, I presented the first rough paper on the Tesla secret and scalar interferometry. A videotape of the presentation was made and will shortly be available. I am also scheduled to make a special presentation at the Alternate Energy Conference in Toronto, Canada in latter October, 1981.

A professional, videotaped two-hour presentation on this subject is also being prepared. Wide distribution of the material through the international underground physics and technology network has already been made. This time, God willing, Tesla's secret will not be suppressed for another 80 years!

And perhaps it is not yet too late. The material has cost me (now) some 16 years of agonizing labor and nearly \$100,000 of my own personal funds. No orthodox university, scientific group, foundation, or governmental agency would support such an effort, either financially or otherwise. Indeed, most ordinary journals will not even accept material on such matters.

Nonetheless, the area is of overwhelming importance and I truly believe Tesla's lost secret will shortly affect the lives of every human being on earth.

Perhaps with the free and open release of Tesla's secret, the scientific and governmental bureaucracies will be shocked awake from their slumber, and we can develop defenses before Armageddon occurs. Perhaps there is hope after all -- for even Brezhnev, in his strange July, 1975 proposal to the SALT talks, seemed to reveal a perception that a turning point in war and weaponry may have been reached, and that human imagination is incapable of dealing with the ability to totally engineer reality itself.

Having tested the weapons, the Soviets must be aware that the ill-provoked oscillation of time flow affects the minds and thoughts -- and the very life streams and even the collective species unconsciousness's -- of all lifeforms on earth. They must know that these weapons are two-edged swords, and that the backlash from their use can be far more terrible to the user than was the original effect to his victim.

If we can avoid the Apocalypse, the fantastic secret of Nikola Tesla can be employed to cure and elevate man, not kill him. Tesla's discovery can eventually remove every conceivable external human limitation.



If we humans ourselves can elevate our consciousness to properly utilize the Tesla electromagnetics, then Nikola Tesla - who gave us the electrical twentieth century in the first place - may yet give us a fantastic new future more shining and glorious than all the great scientists and sages have imagined.

The scientist behind the HEEMFG is no rogue inventor but works at the Naval Air Warfare Center Aircraft Division (NAWCAD) on advanced technology concepts. On two occasions, Dr. James Sheehy, the Chief Technology Officer of the Naval Aviation Enterprise, a U.S. Navy affiliated organization, has intervened on behalf of Dr. Pais' patent applications deeming them "operable" to skeptical patent examiners.

Brett Tingley, writing for *'The Drive'*, has given detailed commentaries on Pais' patents, and has speculated about why the Navy wanted to make public what appeared to be technologies that would be highly classified if they worked. He speculated that the patent applications may be disinformation intended to deceive China and Russia:

It's certainly possible that these patents are part of some ongoing information campaign designed to make America's competitors question what types of black budget research is currently underway at NAWCAD and other research organizations. With so many revolutionary new aerospace technologies on the brink of deployment, perhaps this is an attempt to essentially "weaponize" patents and sow doubt among our adversaries and even inject confusion among the American populous.

An alternative explanation offered by Tingley is that the patents are feasible and the Navy is seriously contemplating developing them based on UFO sightings such as the 2004 Tic Tac incident tracked by Navy pilots:

Maybe this is the Pentagon's grasping attempt to try to make sense of and emulate mysterious and seemingly highly advanced craft that are supposedly being increasingly observed near its own aircraft, vessels, and installations. Maybe the Chinese competition claim is just a placeholder for the unknown.

There is yet another, even more compelling, explanation that Tingley did not consider. The patents are based on technologies that have already been successfully developed by the Navy in a classified program to protect current and future aircraft carriers from hypersonic weapons. After all, the Navy has a long track record in studying electromagnetic means for protecting its ships as evidenced by the 1943 Philadelphia Experiment.

Even more intriguing is recent insider and documentary evidence that the Navy has developed a secret space program that deploys kilometer long spacecraft that would almost certainly have needed such electromagnetic protection from space debris and asteroids encountered during deep space travel. It's plausible that Tesla shields that have long been used on the Navy's secret space program which were deployed in the early 1980's, and this technology has recently been made available for the Navy's

conventional aircraft carriers given recent advances in hypersonic weapons development.

If Tesla shields have already been developed in a highly classified Navy space program, then it is reasonable to conclude that the HEEMG patent is based on electromagnetic shield concepts that Drs. Pais and Sheehy have been officially briefed about. The existence of Tesla shield technology provides a cogent explanation for why all aircraft carriers were mysteriously recalled in January 2017, the secret upgrades they received, and why Ford-class supercarriers are going to be built.

All this leads to the startling conclusion that U.S. Navy can protect all its aircraft carriers from hypersonic cruise and ballistic missiles using electromagnetic Tesla shields. Even more significant is the potential of such electromagnetic shields to protect entire cities and even the Earth as mentioned in the HEEMFG patent. The HEEMFG patent is cogent evidence that we are about to witness a profound military revolution from the development of offensive to defensive weapons systems where civilian populations are protected rather than sacrificed in strategic military planning.

Intelligence gathered on the CCP has shown they have been doing practice attacks and shown that they could, through multiple hypersonic attacks on an aircraft carrier. The CCP has recognized the damage that can be inflicted on the U.S., both from the standpoint of loss of life as well as morale by sinking a nuclear aircraft carrier. When a nuclear aircraft carrier goes to sea it is accompanied by 6 to 9 missile cruisers, that provide defense protection for the nuclear aircraft carrier. A nuclear submarine usually provides invisible shadow protection for the ships in a Carrier Strike Group.

Thomas Bearden, a retired Pentagon war games expert and active consulting engineer to the Defense Department, has written a number of papers on Scalar Wave systems and often lectured on Scalar Waves at Alternative Energy conferences. According to Bearden, the Soviets are way ahead of the U.S. in Scalar Wave technology and are already using it against the U.S. Lt. Col. Bearden provided much of the information in this article on Scalar Wave technology.

Scalar Wave technology is apparently very real and deadly. Furthermore, it is a great deal more simple to use than Lasers, far more effective, and does not require mini-atomic explosions to power it. Is it possible that Scalar "Howitzers," as Bearden calls them, is the real system that the Pentagon would like to put into space? What applications might such a system have?

The Pentagon has insisted so far that their proposed "Star Wars" program is entirely defensive, designed to protect the U.S. from a nuclear attack. Incredibly, Ronald Reagan even said in a press conference once that after the United States had built their "Star Wars" system, they would give it to the Russians, who would then build their own system in space, so the world would be theoretically safe from nuclear war for ever more! Reagan later said in another news conference that maybe this wasn't such a good idea after all.

In recent years the proposal of a "Star Wars" system in space has gained a great deal of momentum and controversy. This proposed system is said to be the ultimate system to insure the security of the United States--and the world, at least by those who propose it. Those fighting against it maintain that it is not technically feasible.

Supporters in the Reagan Administration propose a system that would work like this: when Soviet ICBM missiles, loaded with their nuclear payloads, are launched at the U.S., the "Star Wars" system, hovering in space, would fire super-high powered Lasers at the missiles while they are still in the air, thereby disabling them. These super-high powered Lasers would be powered by small atomic explosions within the "Star Wars" satellites themselves.

Critics charge that Laser technology has not advanced enough to enable the United States, or any country, to pull off such a feat. Yet another alternative rarely discussed in the media is available, and it is a technology fifty years old, invented by Nikola Tesla, the electrical genius who lit the world: Scalar Waves!

Scalar Waves are a form of radio waves creating what is known as Longitudinal Wave Interference. Where two Scalar Waves meet, an energy bottle is created which disintegrates all matter within that bottle, producing what is in effect a miniature atomic explosion but without any resulting radiation.

### **Chinese Nations illegally crossing the U.S. Southern Border!**

Nearly 13,000 Chinese nationals have been apprehended trying to cross the United States' southern border illegally since October 1, 2022, A nearly 1,000 percent increase from last year's total.

According to Breitbart, approximately 84% of those apprehended are single adults who are eventually released to pursue asylum in the U.S.. The apprehensions grew steadily over the last year. In March 2022, 74 Chinese nationals were apprehended, 146 in April, and more than 1,000 a month by January 2023, at a rate of 1,000 a month since April.

The Chinese government opened its ports of entry and loosened travel restrictions in January 2023 for the first time since the beginning of the COVID-19 pandemic. The information that agents can get from migrants indicates that they are fleeing from an oppressive Chinese regime and economic hardships caused by their pandemic policies.

An anonymous Customs and Border Patrol agent told the outlet that due to the language barrier, they are struggling to find a definitive reason for the increase.

"Having to use third-party translation services, Border Patrol agents and intelligence officers who are already struggling to cope with thousands of migrant apprehensions daily are getting limited intelligence information from the migrants," the agent said of the challenges brought by the language barrier.

Dr. Kenneth Allard, a retired Army intelligence officer and author of *"Warheads: Cable News and the Fog of War,"* said he is concerned about the lack of intelligence coming from the influx. *"Totalitarian governments like China are great exploiters of opportunity,"* he said. *"They recognize weakness and capitalize on it immediately. What we are seeing reflects a deliberate policy choice by the regime."*

According to Reuters, many of the migrants learn how to make the trip to the U.S. via the Mexican border using the Chinese version of TikTok. On top of economic conditions, the U.S. making it harder to obtain a visa, and the Chinese government's tightening of religious freedoms have led Christians to flee the country and use the alternate route to the U.S.

The report comes as Title 42 orders expired in May ending COVID-era restrictions that allowed the U.S. to deny entry to those seeking asylum until approved. This has led to a spike in those seeking entry to the country.

### **WEF Calls for AI to Rewrite Bible, Create 'Religions That Are Actually Correct'** Frank Bergman June 10, 2023



A top official with the World Economic Forum (WEF) has called for religious scripture to be “rewritten” by artificial intelligence (AI) to create a globalized “new Bible.”

Yuval Noah Harari, the senior advisor to the WEF and its chairman Klaus Schwab, argues that using AI to replace scriptures will create unified “religions that are actually correct.”

Harari, an influential author and professor, made the call while giving a talk on the “future of humanity.”

According to Harari, the power of AI can be harnessed and used to reshape spirituality into the WEF’s globalist vision of “equity” and inclusivism.

Speaking with journalist Pedro Pinto in Lisbon, Portugal, Harari told the elitist audience:

*“It’s the first technology ever that can create new ideas.”*

*“You know, the printing press, radio, television, they broadcast, they spread the ideas created by the human brain, by the human mind.”*

*“They cannot create a new idea.”*

*“You know, [Johannes] Gutenberg printed the Bible in the middle of the 15th century; the printing press printed as many copies of the Bible as Gutenberg instructed it, but it did not create a single new page.”*

*“It had no ideas of its own about the Bible: Is it good? Is it bad? How to interpret this? How to interpret that?”*

Harari then revealed that he and his allies at the WEF have a solution to the supposed problems he’d just highlighted.

*“AI can create new ideas; [it] can even **write a new Bible**,”* he declared.

*“Throughout history, religions dreamt about having a book written by a superhuman intelligence, by a non-human entity,”* he added.

John-Henry Westen, who writes for LifeSite, a Pro-Life web site had an interesting piece on Yuval Noah Harari last year that provides us an insight to the mind of Professor Yuval Noah Harari. Yuval Noah Harari is a highly influential figure in modern politics, but why is he so involved? Looking at his key ideas and beliefs, we can begin to see his motivation.

A lecturer at the Department of History in the Hebrew University of Jerusalem, Harari utilizes history, philosophy, and biology in his reflections on what he believes are the most important global challenges facing the world today, and strives to focus the public conversation on these issues.

With this goal in mind, he wrote five books that describe his worldview and the things he thinks others ought to prioritize. He also co-founded [Sapienship](#), a social impact company with projects in the fields of entertainment and education, with the man he refers to as his “husband” and original agent, Itzik Yahav. That’s right, husband. We’ll get to that in a moment. This company *“advocates for global responsibility through its mission: to clarify the global conversation, to focus attention on the most important challenges, and to support the quest for solutions... and Sapienship highlights three [problems]: technological disruption, ecological collapse, and the nuclear threat.”*

Harari mentions his “husband” in multiple interviews, and he admits with pride that being homosexual affects his research, which serves as a major indicator of his worldview. In this same interview, he rationalizes homosexuality on the grounds that *“anything that exists is by definition natural.”*

Harari argues that there is no purpose to sex, comparing human sexuality with the sexuality of a chimpanzee. He continues, claiming that “the idea that sex exists only for the purpose of procreation is complete nonsense invented by priests and rabbis.

*“In truth, our concepts of ‘natural’ and ‘unnatural’ are not taken from biology; they are taken from Christian theology,”* he adds.

As we know, God created man to be superior to all other animals, but Harari reduces humanity to its base animal level, describing God as a myth, *“a big man in the sky who gets angry when two men love one another.”* Continuing with this language, he says that no *“big man in the sky”* gets angry; the only people who get angry are *“all sorts of priests and rabbis.”*

He fleshes out this idea of religion as mythology in his book, [Sapiens](#), describing how humans became the dominant creature on the earth. Harari’s official website describes this first book as one that analyzes various topics, following humanity’s development across history and ranging from *“We rule the world because we are the only animal that can believe in things that exist purely in our own imagination, such as gods, states, money and human rights,”* to *“With the help of novel technologies, within a few centuries or even decades, Sapiens will upgrade themselves into completely different beings, enjoying godlike qualities and abilities.”*

For example, in chapter one, Harari claims that:

*“We assume that a large brain, the use of tools, superior learning abilities and complex social structures are huge advantages. It seems self-evident that these have made humankind the most powerful animal on earth. But humans enjoyed all these advantages for a full 2 million years, while remaining weak and marginal creatures.”* In the next chapter, he explains his theory of war: *“Having so recently been one of the underdogs of the savannah, we are full of fears and anxieties over our position, which makes us doubly cruel and dangerous. Many historical calamities, from deadly wars to ecological catastrophes, have resulted from this over-hasty jump.”*

Further in his book he claims that:

Fiction has enabled us not merely to imagine things, but to do so *collectively*. We can weave common myths such as the biblical creation story, the Dreamtime myths of Aboriginal Australians, and the nationalist myths of modern states. Such myths give Sapiens the unprecedented ability to cooperate flexibly in large numbers.

In other words, human superiority is the result of storytelling, and humanity’s myths bring about our social nature.

Picking up where *Sapiens* left off, [Homo Deus](#) explores *“how global power might shift, as the principal force of evolution – natural selection – is replaced by intelligent design.”*

Harari reiterates this idea in multiple talks about technology.



*“We humans should get used to the idea that we are no longer mysterious souls. We are now hackable animals,”* he says.

(These clips are from Harari’s talks at the World Economic Forum, where he’s an agenda contributor as well.)

Harari published a list of errors from this book on [his website](#), correcting them, but maintains that none of these errors changed the core arguments of the book. Most of the corrections were either statistics, dates, or other details, but some, like this one, seem to be rationalization, an attempt to save his argument in the face of criticism:

While this may have been a public relations stunt more than a serious move, in numerous other companies’ algorithms are joining management boards in more discrete ways. Official membership of the board is perhaps still restricted to humans, but what these humans choose to do is increasingly shaped by algorithms. In many cases, the humans just rubber-stamp the recommendations of the algorithms.

Having received criticism, Harari responds with a claim that his argument can still stand without this evidence he originally hoped to support it with. His example of a particular company, now no longer relevant, failed; and he turned to a general statement about “other companies,” leaving the specifics behind.

Clearly, he takes events and fits them into his narrative. His narrative continues to be very empirical and negative. According to Harari, “*Homo sapiens* is a [post-truth species](#), whose power depends on creating and believing fictions.”

Harari says he believes in science and its two processes: deterministic and random. A combination of the two creates probability, he suggests, the closest thing there is to freedom, but there is no free will. He claims “*free will was always a myth and not a scientific reality.*”

The United States Declaration of Independence begins this way, “We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.” In *Sapiens*, Harari gives us his own version of this famous sentence:

We hold these truths to be self-evident, that all men evolved differently, that they are born with certain mutable characteristics, and that among these are life and the pursuit of pleasure.

Harari’s argument is that since there is no Creator (he calls God the “man in the sky”), we cannot be created equal and therefore human beings cannot be endowed by the Creator with unalienable Rights.

We see Harari “*translating*” the Declaration of Independence into “*biological*” terms, an error that he seems to habitually commit. Harari claims that everything, right from “*free will*” to “*happiness*,” must pass the scientific meter, thus rubbishing philosophy (if philosophy is something more than positivism).

In short, Yuval Noah Harari is an atheistic nihilist. Relying on his perceptions of natural selection and biology to explain everything, he clearly misses the full truth of humanity, the world we live in, and reality itself. Consistent in his inconsistencies, Harari makes it easy to spot this pattern of scienticism throughout his work.

### **CALIFORNIA’S “IMPOSSIBLE” ELECTRIC TRUCK MANDATE WILL PUT LOGISTICS COMPANIES OUT OF BUSINESS**

With California’s deadline for zero-emissions vehicles looming, logistics companies are growing concerned that compliance will be impossible.

Under the new mandate, which goes into effect on January 1, 2024, all new trucks that are bought for servicing distribution centers, ports and rail yards must be [zero-emission models](#).

**One of the main concerns is the low availability of electric semi-trucks.** Those that are available have very high prices, and many in the industry are concerned about

the **short distances they are capable of traveling on a charge**. Trucks need to use dedicated charging stations, and the **limited infrastructure in the areas surrounding ports will make keeping these vehicles charged complicated**. The need to recharge these trucks frequently, combined with **potentially long wait times as multiple trucks vie for limited charging ports**, will make operation costs and times rise.

The **high costs of replacement parts and maintenance services** are only expected to add to logistics companies' financial woes. For many, these costs are largely unknown at the moment, which means companies are struggling to make their plans and calculate their costs. Currently, maintenance is one of the biggest expenses for diesel trucks, and companies simply don't know what the maintenance costs on the newer trucks will be. However, some have estimated the costs for electric truck maintenance could be tenfold the costs of maintaining diesel trucks.

The owner of California-based Sibrian Trucking, Nelson Sibrian, told *The Epoch Times*: Nobody has real numbers when we ask for details about maintenance and replacement costs. With diesel, we know our cost per day to maintain the vehicle.

**The costs of these vehicles are another concern**, with the current price for electric semi-trucks coming in at around \$500,000. While fleet owners can choose from a range of different manufacturers when purchasing traditional trucks, allowing them to shop around for better deals, their **electric counterparts are much harder to find and are often backordered**. This means that even those who are in a financial position to purchase the vehicles may not be able to do so due to a lack of availability.

The supply problem is only expected to get worse when the mandate is in full effect. **Around 10,000 drayage trucks for ports and rail yards are replaced every year, on average, so the demand is expected to be very high and vehicle makers may not be able to keep up.**

Oakland trucking professional John Williams said:

***"This is a bigger problem than people realize because we're being forced to do something that is literally impossible. There are not enough trucks, not enough charging stations, and not enough information that we can rely on."***

**Another factor that could harm profitability is weight limits.** For example, **Tesla trucks have an estimated 10,000-pound battery in them**. This means that the trucks will be forced to carry less cargo in order to remain compliant with weight limit regulations. Packing trucks is considered one of the best ways to boost profits, and heavy vehicles will effectively put an end to this practice.

Some truckers have also expressed **concerns about the size of the lithium batteries in these trucks. If fires occur, it could pose a major public safety issue.**

**Another roadblock is the limited range of electric trucks.** Diesel trucks can travel 1,000 miles before they need to be refueled, but the top electric semi-trucks on the

market can only go as far as 300 miles before needing a charge; most, however, can only make it around 100 miles.

Although these new regulations will cost trucking companies a lot of money—costs that will ultimately be passed to consumers.

Governor Gavin Newsom issued a [press release](#) applauding the Biden Regime's [approval of the mandate](#).

He stated:

*“Now, thanks to [The Biden Regime], we’re getting more zero-emission heavy duty trucks on the roads, expanding our world-leading efforts to cut air pollution and protect public health.”*

Final thoughts: We the People are looking at the makings of mass suicide by logistics failure. Electricity will not get the job done—not with the current technological infrastructure and not by January 2024. Hardship will be felt by many, people will go hungry, some may starve.

If this new Iran deal goes through, instead of giving the U.S. more influence in the region as they hope, it will essentially render America irrelevant in the Middle East. I love the U.S.; it is like a second home to me. It breaks my heart to see what has become of this country that I have so admired and respected.

The Washington elite believe that if they can only come up with a good deal for Iran, the ayatollahs will gratefully accept it and hold to it. But that is not in their DNA. This administration is expecting those in the Middle East to think and act like Westerners. That's not going to happen.

They also assume that Israel will go along with the deal because they are dangling the normalization of relations between Israel and Saudi Arabia as some great reward. Again, that's not going to happen either. We would love a strong relationship with Saudi Arabia, but agreeing with a new Iran deal is far too exorbitant a price.

Soon, the Biden administration will roll out their terrible new deal. Only a compromised and foolish Democrat-led government, along with their liberal, progressive EU buddies, will believe in it. The Israelis won't buy it. The Saudis won't buy it. The Iranian regime will gladly sign it, but they won't hold to it.

Israel, for the sake of its own survival, will end up having to act alone to stop Iran from going nuclear. And that's when it will all blow up.

So, that's why as I look forward to what is ahead in Italy and Romania, much of my heart is still back home in Israel. I know that God has His hand on His nation and on His people. ### **Netanyahu Assures Nation and World of Israel's Readiness**

As I mentioned above, Israel is preparing for war. On Sunday, Prime Minister Benjamin Netanyahu used the beginning of a meeting with members of the security cabinet to send a message to his country's citizens and to the world. *"We are confident we can deal with any threat on our own, and also with other means.... The reality in our region is changing rapidly. We are not stagnating. The Egyptian government claims that it was all a misunderstanding that began as the security agent was pursuing drug smugglers. To Israel, the evidence points much more toward terrorism. Prime Minister Netanyahu is demanding a full investigation and clear answers.

### **Iran Develops Hypersonic Missile**

With much celebration and fanfare, Iran unveiled their first hypersonic missile on Tuesday. The "Fattah" can reach speeds of Mach 13-15 and has a range of 1400 km. Just for reference's sake, it is 1200 km from Iran's border to Tel Aviv. This new missile is also capable of performing maneuvers outside the atmosphere that make it almost impossible to destroy.

Thankfully, if the U.S. administration gets that Iran Deal signed, we in Israel won't have to worry about the ayatollahs strapping a nuclear warhead to a Fattah missile, right? Phew, is that ever a relief!

### **UN Chooses Iran as Vice President of General Assembly**

In a quintessential move which demonstrates what the United Nations truly is, the august body, designed for bringing about peace and harmony throughout the world, has this week voted Iran as vice president of the General Assembly.

This is despite the fact that Iran has murdered or executed well over 500 protesters and imprisoned tens of thousands more in the last nine months since the death of Mahsa Amini who was killed while in custody of the morality police.

**New numbers from the Federal Deposit Insurance Corporation (FDIC) show Americans are pulling their money at a pace not seen in nearly four decades.**

According to the FDIC’s newly-released quarterly report, depositors took a total of \$472 billion out of their accounts in the first quarter of this year – shattering a 39 year record.

“The quarterly decline is the largest reduction reported in the QBP since data collection began in 1984. This was the fourth consecutive quarter that the industry reported lower levels of total deposits.”

The “primary driver” of deposit flight came from uninsured deposits, says the FDIC, as people moved to protect capital that is above the \$250,000 FDIC insured maximum.

Case in point – the amount of insured deposits held by banks actually increased during the quarter as people diversified their risk.

The mass exodus follows the failures of Signature Bank, Silicon Valley Bank and First Republic, which were triggered in large part by the Federal Reserve’s aggressive interest rate hikes.

As depositors leave the banking system, money market funds have witnessed massive weekly cash inflows.

As the first quarter came to a close, assets held by money market mutual funds surged to \$5.6 trillion according to Crane data, representing a record high.
