Great Reset: Dutch Government Launches Farmer Buyout Scheme as Thousands Face Shut Down



The Dutch government launched its long-anticipated Great Reset-style farmer buyout scheme on Monday, which could potentially see upwards of ten thousand farms shut down forever to fall in line with the green agenda of the European Union.

Following years of political wrangling, the government of The Netherlands has launched its programme for buying out farms that do not comply with the EU's Natura 2000 scheme supposedly meant to protect environmentally sensitive areas. The buyout programme will initially impact approximately 3,000 privately-owned farms which are deemed to emit too much nitrogen.

Starting next month, farmers will be able to apply for a buyout, which will be set at 120 per cent of the farm's value. In addition to the top nitrogen emitters, the government will also offer buyouts for dairy, pig and poultry farmers to shut down in exchange for a payout of 100 per cent of their farm's value. It is expected that some 8,000 farmers will be eligible for the second scheme, Dutch public broadcaster NOS [reports](#).

In total, the government has allocated 1.4 billion euros to cover the two programmes. The buyout scheme, which will last until next April, will remain voluntary for now, however, the Dutch government has previously [suggested](#) that if uptake is not high enough it may be forced to impose mandatory buyouts.

The farmers' group Agractie expressed concern over the launch, saying that while a website has been opened to allow farmers to see if they are eligible for a buyout, the other options, such as reducing emissions, are not currently explained, meaning that farmers cannot accurately judge which direction to take.

The move to shut down potentially thousands of farms in The Netherlands, despite the ongoing food crisis, could have a significant impact further afield given the country's status as Europe's largest exporter of meat and one of the largest dairy exporters in the world.

There has been widespread rejection of the government's green agenda, however, with farmers launching large-scale tractor protests across the country over the past two years, which have shut down highways and critical infrastructure.

The resentment against the globalist government also saw the populist Farmer–Citizen Movement (BBB) sweep to victory in the Senate and local elections earlier this year, becoming the largest party in the country after previously holding zero seats. Yet, the neo-liberal coalition government of Prime Minister Mark Rutte was able to cobble together enough support to remain in power for the time being.

Some farmers have already expressed that they have no intention of participating in the buyout scheme and plan to hold on to their property. One dairy and poultry farmer Elton van Ginkel told the *Nieuwsuur* current affairs programme: "Over my dead body. I'll move on, even if it's with two cows."

Another farmer, from the Gelderland province — the chief target of the scheme — Kalverboer Ben Apeldoorn said: "*The sector itself has already reduced 8 per cent*

nitrogen in recent years despite the lack of policy. We are afraid it will never be enough. Even if we were to reduce nitrogen by half, it's not good enough."

He said that the political elites in The Hague will only be satisfied *"when the last farmer is gone"*, adding: *"While the rest of the economy can continue to grow. Why should we participate in this process? We just have to be offered the right to exist."*

Belarus receives nuclear bombs 'three times size of Hiroshima bomb' from Russia

Belarus has started taking the delivery of Russian tactical nuclear weapons, president Alexander Lukashenko announced, claiming that some of these were three times more powerful than the atomic bombs dropped on Hiroshima and Nagasaki in 1945.

Mr. Lukashenko said that *"the bombs are three times more powerful than those (dropped on) Hiroshima and Nagasaki"*, adding to his previous statement that he didn't simply ask Mr. Putin for the weapons, but *"demanded"* them.

The Vladimir Putin ally was speaking to the Russian state TV channel Rossiya-1 on a road in a forest clearing with military vehicles and a storage facility visible in the background seen around him.

This will be the first such warhead deployment by Moscow, comprising shorter-range less powerful nuclear weapons that could potentially be used on the battlefield, outside of Russia since the fall of the Soviet Union.

The interview was posted on the Belarusian Belta state news agency's Telegram channel on Wednesday.

This comes five days after the Russian president announced plans to start deploying tactical nuclear weapons in Belarus, even as Moscow will retain their control, after the special storage facilities to park them were ready.

Mr. Lukashenko further confirmed his close ally's statement in the state television interview where he said Belarus has numerous nuclear storage facilities from the Soviet-era and has restored five or six of them.

On control of nuclear weapons in Russia's hands as a move to prevent the arsenal from being used up quickly, Mr. Lukashenko played down the concern and said that Mr. Putin and he could pick up the phone to each other *"at any moment"*.

Just hours before on Tuesday, he had said that the Russian tactical nuclear weapons will be physically deployed on the Belarusian territory *"in several days"* and he had the facilities to host longer-range missiles too if ever needed.

Mr. Lukashenko further alleged that Belarus has *"always been a target"* for the West.

"They (the West) have wanted to tear us to pieces since 2020. No one has so far fought against a nuclear country, a country that has nuclear weapons," Mr. Lukashenko said, adding that the nuclear deployment will act as a deterrent against potential aggressors.

Belarus has been an active participant in Russia's full-scale invasion of Ukraine as it has consistently allowed its territory to be used by Russian forces to attack Kyiv.

The first announcement of tactical nuclear weapons was made in March by Mr. Putin who had blamed the US deployment of such weapons in a host of European countries over many decades.

The US, however, maintained that it did not see any signs of Russia's willingness to prepare for nuclear weapons use in the continuing invasion, as it criticized the decision of deployment by Mr. Putin.

The world's largest meat-processing company, Brazil-based JBS S.A., has announced plans to construct the world's largest cell-cultured, meat plant in San Sebastian, Spain.



According to a report by the [Northern Ag Network](#):

The factory will be built by Bio Tech Foods, a JBS subsidiary which has obtained the support of the Spanish Institute for Foreign Trade to research and cultivate these cell lines for production.

JBS said in a press release:

"In this line, the project led by Bio Tech Foods, 'Research on cell lines, cultured media and biomaterials for their correct bioprocessing to enable the production of cultivated meat '(investMEAT)' will allow a highly efficient cultivated meat production line, which will solve the challenges of current technology linked to scalability."

The news broke during the Wyoming Stockgrowers Association annual meeting last week.

Reuters reported that the factory will be capable of producing more than 1,000 metric tons of cultivated beef per year and *"JBS said it could expand capacity to 4,000 metric tons per year in the medium term."*

Eduardo Noronha, JBS USA's head of value-added business, said:

"The new Bio Tech plant puts JBS in a unique position to lead the world's burgeoning lab-grown meat business and ride this wave of innovation."

Bio Tech Foods co-founder and CEO Iñigo Charola added in a statement:

"With the challenges imposed on global supply chains, cultivated protein offers the potential to stabilize food security and global protein production."

JBS owns a large segment of the U.S. meat-processing industry and some of this lab-grown meat is likely to make its way from Spain to the U.S. and other countries.

This will be the world's answer to increasing global famine, much of which is created by the very sustainable development measures that they say will save the earth and humanity. They will actually destroy both if allowed.

U.S. beef cattle herds are currently at their lowest levels since 1962 and beef is getting more expensive by the day as a result of the historically low stocks. Farmers have slaughtered off much of their herds because they can't afford to feed them with the rising prices of corn.

The massive fake-meat factory in Spain is scheduled to go online in mid-2024.

One of the ways these "innovators" are able to grow cultured fake meat so fast is by harnessing the replicating ability of animal cancer cells. [This should alarm your intelligence big time.]

National Cattlemen's Beef Association President Todd Wilkinson, commenting on the news of JBS' latest project, told Northern Ag Network that this move is one of the biggest to face the meat industry.

Wilkinson said:

"We'll gladly compete against that, but the consumer needs to know at the counter what they're buying."

I just don't want the beef industry to go by way of what happened to milk and lose the ability to identify our product as unique and natural.

They can say that it's designed to feed the world, but it's feeding the world a non-natural product and it's a product that is going to require more energy to produce, and don't tell me it's sustainable.

JBS has taken a lot of heat from climate activists for sourcing meat from farms that "contribute to the [destruction of the Amazon rainforest](#)."

In a world gone crazy with the obsession to eliminate carbon, this fake-meat initiative is likely a way of buying back some carbon credits to offset its negative impact on the environment, even though, as Wilkinson alludes, it takes even more energy to produce meat in a lab than it does on an actual farm.

According to *Northern Ag Network*:

Wilkinson testified before a subcommittee of the U.S. Senate on October 19, 2019, and explained then how the climate radicals were going to try to destroy the American cattle industry. Then, after the destruction is well under way, they will come in with their answer to the problem: fake meat.

Wilkinson, a South Dakota cattle rancher, told the subcommittee that contrary to the claims of some environmental and anti-animal-agriculture activists:

American beef production and consumption is a climate change solution.

Wilkinson told members of the U.S. Senate's Environment and Public Works Subcommittee on Clean Air and Nuclear Safety:

Climate policies that unfairly target cattle producers fail to recognize the positive role of cattle and beef in a healthy, sustainable food system.

Rather than adopting misguided policies that threaten the viability of farmers and ranchers, we want to shift the conversation.

Norther Ag reported that, in his testimony, Wilkinson discussed the environmental benefits of grazing, and busted myths about the effect of methane on global climate.

Wilkinson explained:

(Grazing) naturally sequesters carbon, a benefit compounded by ruminant grazing.

Grazing builds deep root systems in prairie grasses, which improve soil health. Healthy soils retain more water, sequester more carbon, and increase the resiliency of our ranches.

Wilkinson continued:

Methane emissions from cattle are part of the natural methane cycle.

Within 10 years, more than 90 percent of that methane combines with oxygen in the atmosphere and converts to CO₂.

Methane has no long-term impact on climate when emissions and oxidation are in balance. And this balance has been maintained for centuries.

Caution: We know nothing about the health effects of lab-grown meat over the short, medium, or long terms.

Americans are pulling hundreds of billions of dollars out of banks at the fastest pace in nearly 39 years as many economic experts are beginning to predict a repeat of the 2008 "Great Recession."

According to an analysis of the most recent data from the Federal Deposit Insurance Corporation (FDIC), "depositors took a total of \$472 billion out of their accounts in the first quarter of this year – shattering a 39 year record," the *Daily Hodl* reported.

"The quarterly decline is the largest reduction reported in the QBP since data collection began in 1984. This was the fourth consecutive quarter that the industry reported lower levels of total deposits," the FDIC report said.

According to the FDIC, the "primary driver" behind the withdrawal of deposits was the movement of uninsured deposits as individuals sought to safeguard funds exceeding the FDIC-insured limit of \$250,000. Interestingly, during the same period, the amount of insured deposits held by banks actually saw an increase, as people opted to diversify their risk, the outlet reported, adding:

The mass exodus follows the failures of Signature Bank, Silicon Valley Bank and First Republic, which were triggered in large part by the Federal Reserve's aggressive interest rate hikes.

As depositors leave the banking system, money market funds have witnessed massive weekly cash inflows.

As the first quarter came to a close, assets held by money market mutual funds surged to \$5.6 trillion according to Crane data, representing a record high.

During the Great Recession of 2008-09, Americans lost homes and trillions in market value and savings. It was a severe economic downturn that started with the bursting of the U.S. housing bubble and quickly spread to other countries.

The financial crisis was caused by a severe contraction of liquidity in global financial markets that left banks in trouble, leading to an interbank credit freeze. This impaired the ability of any bank to extend credit to businesses and consumers, forcing businesses to reduce their expenses and investments, leading to widespread job losses. As millions of people lost their homes, jobs, and savings, the poverty rate in the United States increased, and much wealth was lost.

The crisis developed gradually, with home prices starting to fall in 2006 and subprime lenders filing for bankruptcy in 2007. By August 2007, it became clear that the financial system was in trouble, as the interbank market froze and banks like Bear Stearns and Merrill Lynch faced major losses. The crisis ultimately led to the collapse of Lehman Brothers in September 2008 and the Great Recession.

The Great Recession was deep and protracted enough to become known as "the Great Recession" and was followed by what was, by some measures, the slowest economic recovery in U.S. history. The recession lasted from December 2007 to June 2009, and the economy did not return to pre-recession levels until late 2011.

When the bubble burst, the banks were left with trillions of dollars of worthless investments in subprime mortgages. Many banks, including Lehman Brothers, had been highly leveraged, meaning they had borrowed heavily to invest in these mortgages, and when the value of the mortgages plummeted, the banks were unable to meet their obligations.

The crisis had far-reaching effects on the global economy. In addition to widespread job losses and increased poverty rates, many countries experienced declines in their gross domestic product (GDP), and the eurozone debt crisis emerged as a result of the recession. The recession also had political consequences, with many people blaming policymakers for not preventing the crisis or responding adequately to it.

The crisis also led to a reevaluation of financial regulations and the role of banks in the economy. Many policymakers and experts believed that the crisis was caused by a lack of oversight and regulation of the financial sector, and reforms were implemented to prevent a similar crisis from happening again.

But, as we've seen recently, banks are beginning to fail again anyway despite a raft of new regulations passed in the wake of the 2008 crisis, and home values are reportedly overvalued -- again.

Senator Says There's Audio Recordings Proving Joe and Hunter Biden Took Bribes.

Senator Chuck Grassley took to the Senate floor today claiming the foreign national who allegedly bribed both Joe and Hunter Biden has a stunning 17 different recordings of conversations with the pair, kept as a form of *“insurance policy.”*

“According to the 1023 the foreign national possesses 15 audio recordings of phone calls between him and Hunter Biden. GOP Rep. Andy Ogles of Tennessee introduced articles of impeachment against President Joe Biden and Vice President Kamala Harris on Monday.

Ogles **first article of impeachment** against Biden accused him of weaponizing the executive branch to “shield the business and influence peddling schemes of his family from congressional oversight and public accountability.”

The congressman’s second article of impeachment said that Biden, “contrary to his oath,” has failed to “take care that the laws be faithfully executed, directly facilitated the ongoing southern border crisis and endangered the people of the United States.”

Regarding the first article, Ogles pointed to Biden administration officials FBI Director **Christopher Wray** and Treasury Secretary **Janet Yellen**, claiming they denied members of Congress documents they sought in their oversight role.

These documents included bank suspicious activity reports concerning the Biden family and information pertaining to several limited liability companies “used to funnel millions of dollars to Biden family members in intricate financial webs intended to deceive the public and obscure sources of those funds,” Ogles wrote.

The lawmaker further referenced an alleged **bribery scheme** involving Biden and his son, Hunter Biden, contained in an **FD-1023 form** just made available to House Oversight and Accountability Committee members last week.

The document was generated by the FBI based on an interview with a “highly credible” source, who alleged that Biden and his son received \$5 million each from Ukrainian energy company Burisma, Fox News reported.

Ogles noted in his article of impeachment, in 2016 then-Vice President Biden demanded Ukrainian prosecutor [Viktor Shokin](#), who was looking into Burisma corruption, be fired or Ukraine would lose \$1 billion in U.S. loan guarantees.

*“Well, son of a b****, he got fired,”* Biden later bragged at a Council on Foreign Relations meeting in 2018.

Hunter reportedly earned over [\\$80,000 per month](#) on the Burisma board of directors at the time.

Concerning the [border crisis](#), Ogles wrote that the U.S. is experiencing the highest monthly totals of people crossing illegally into the U.S. ever recorded and that Biden refuses to enforce the nation’s laws concerning it.

“Since the creation of the Department of Homeland Security, the number of monthly ‘encounters’ had never crossed the 200,000 threshold; the Biden administration is responsible for the 6 highest and 8 of the 10 highest months ever recorded.”

Customs and Border Patrol [data](#) shows that over 1.4 million illegal migrants have been apprehended this fiscal year as of April.

A record 2.38 million entered the U.S. illegally in FY 2022, up from 1.73 million in FY 2021 during the first year of Biden’s term.

Additionally, *“Due to rampant drug trafficking at our southern border, the leading cause of death for Americans aged 18–45 can now be attributable to fentanyl overdoses,”* Ogles wrote.

The [Drug Enforcement Agency](#) reported more than 50 million fentanyl pills and 10,000 pounds of fentanyl powder, enough to kill 379 million people, were seized in 2022.

The congressman’s [article of impeachment](#) for Harris focused on her failure as “border czar” to address the crisis at the southern border.

“Kamala Devi Harris has demonstrated extraordinary incompetence in the execution of her duties and responsibilities and an indifference to Americans suffering as a result of America’s ongoing southern border crisis,” Ogles wrote.

“Vice President Harris has consistently refused to visit the southern border to ascertain the root causes of the ongoing crisis, aside from a single trip hundreds of miles away from the epicenter of the migrant crisis,” he added.

Ogles cited the same illegal immigration and fentanyl overdoses statistics raised concerning Biden to contend that Harris has failed in her duties to secure the border.

Robert F. Kennedy Jr. [visited](#) the border at Yuma, Arizona, earlier this month and encountered approximately 150 migrants crossing illegally into the U.S. in just an hour's time period.

He recounted that he and his team had spoken with the illegal migrants and learned they were from places as diverse as West Africa, Peru, Afghanistan, [China](#), India and Bangladesh.

Prince Charles Global Stocktake & Daniel 9:27 Explained

"Then he shall confirm a covenant with many for one week; But in the middle of the week He shall bring an end to sacrifice and offering. And on the wing of abominations shall be one who makes desolate, Even until the consummation, which is determined, Is poured out on the desolate." -(Daniel 9:27)

Craig Bong an Antichrist watcher (Prince Charles) has explained how the Global Stocktake, a term that Prince Charles is ensuring progress of the Paris Accords of 2015 are on track for his "Sustainable Development" agenda. I have stated previously that this event is the materialization of Daniel 9:27, and that supports the view that this event is tied to the Rapture of the Church. It further corroborates the incredible passage of 9:27 being a marker point that begins the Tribulation period of "seven" years. Follow the information presented here as an overview of what is about to take place.

THE RACE TO 2030

Within the Paris Agreement adopted on December 12, 2015, is a mechanism to produce a seven year covenant under the guise of the Global Stocktake to be confirmed [strengthened] on or by December 12, 2023, the last day of COP28 in Dubai.

There are three phases. We are at the beginning of the 2nd phase which concludes at the UN General Assembly. The final phase is what will produce the seven-year agreement with the strengthening of cooperation by way of the Terra Carta Mandate for the next and final countdown of 7 years through 2030.

To compliment Craig Bong's information, these dates become extremely important in framing the events for the Rapture date:

[The 78th session of the UN General Assembly (UNGA 78) will open on Tuesday, September 5th, 2023. The first day of the high-level General Debate will be Tuesday, September 19th 2023. The Jewish Feast of Trumpets or Rosh Hashanah observance begins at sundown on September 15th and ends at sundown September 17th.]

“The global stocktake is an ambition exercise. It’s an accountability exercise. It’s an acceleration exercise,” said UN Climate Change Executive Secretary Simon Stiell. *“It’s an exercise that is intended to make sure every Party is holding up their end of the bargain, knows where they need to go next and how rapidly they need to move to fulfill the goals of the Paris Agreement.”*

The global stocktake is a process for countries and stakeholders to see where they’re collectively making progress towards meeting the goals of the Paris Climate Change Agreement – and where they’re not.

It’s like taking inventory. It means looking at everything related to where the world stands on climate action and support, identifying the gaps, and working together to chart a better course forward to accelerate climate action.

The stocktake takes place every five years, with the first-ever stocktake scheduled to conclude at the UN Climate Change Conference (COP28) at the end of this year.

But this is not just a routine check-up. Stiell calls the stocktake a *“moment for course correction,”* an opportunity to ramp up ambition to avoid the worst consequences of climate change. The stocktake itself isn’t the game changer – it’s the global response to it that will make all the difference.

Stiell’s ideal outcome from the stocktake? A roadmap with ‘solutions pathways’ that drive immediate action. Pathways that guide us sector by sector, region by region, actor by actor, to get to where we need to go during the NEXT SEVEN YEARS. [Think of this as something akin to a Macy’s Day parade forming for viewing by the public.] All the elements are converging in front of us.

The next seven years will be critical in determining whether we can make the necessary changes in time to prevent the worst impacts of climate change.

The success of the global stocktake will ultimately determine the success of COP28. It is the defining moment of this year, this COP and — as one of the only two stocktaking moments in this decisive decade of climate action — ultimately pivotal to whether or not we meet our 2030 goals. - Simon Stiell, UN Climate Change Executive Secretary

In addition, throughout the year, countries and stakeholders will gather at different times to begin shaping the outcome of the stocktake. This collaborative effort helps ensure that everyone’s voices are heard and that the resulting solutions pathways (to 2030) reflect the needs and concerns of all involved.

On 22 March, four of these members—Malta, Mozambique, Switzerland, and the UAE—announced a *“Statement of joint pledges related to climate, peace and security”*. Among the pledges, these members made commitments to:

WHAT IS GLOBAL STOCKTAKE, AND HOW IS IT BEING DONE?



Global Stocktake or GST is a five-yearly review of the progress that has been made in implementing the Paris Agreement. The first GST concludes in 2023, and will assess progress on fronts such as:



Mitigation of greenhouse gas emissions

Adaptation to the impacts of climate change



Mobilization of climate finance

Strengthening of international cooperation



7 years to 2030

It is a three-phase process. The first phase, data collection, ended in March 2023. The second phase, technical assessment, is underway at Bonn and will conclude in September 2023 with a synthesis report summarizing key technical findings. The third and final phase, consideration of outputs, will take place at COP28 in Dubai.



request the inclusion of climate change and conflict analysis as a cross-cutting theme in UN briefings to the Council; strive to integrate climate, peace and security language in Council outcomes; and draw attention to and follow up on recommendations and issues raised at Council meetings on matters related to climate change, peace and security.

The road is paved for a seven-year covenant to strengthen at the conclusion of the Stocktake, December 12, 2023, last day of COP28, Dubai.

The account of Daniel 9:27, includes how that ‘the confirming of a covenant’ by the Antichrist will mark the very beginning of the 7-year Tribulation Period.

The 7-year Tribulation Period is also called “the time of Jacobs [Israel’s] Trouble,” this referring to Israel in the time of the wrath of God’s judgments upon the earth and those who dwell in it. The Antichrist will at that time sign to “**confirm the covenant ‘with many’ for one (“Shabua”) week (7 years).**” I expect that the “*with many*” will be similar to be a sidebar matter, to include Israel and Israel’s immediate surrounding enemy Arab nations. The covenant will supposedly ‘guarantee’ peace. But Israel will soon after realize they had made a pact with the devil as seen in these verses.

Since Christians will be raptured before the beginning of the Tribulation, we who are alive during the church age will not see the Antichrist’s rise to power. This is clearly obvious by Prince Charles focus since 1989 up through the Net-Zero Carbon program.

It is quite possible that many Christians will see him on the world stage, but will not recognize him as the Beast, simply because he will not yet have made his move toward asserting his power of world domination. Evidence heretofore offered by Tim Cohen, Monte Judah, Craig Bong, and others overwhelmingly see Prince Charles as The Antichrist! In previous segments I have provided abundant and convincing evidence that stands heads and shoulders above the names of other candidates we have heard mentioned in recent years.

The fact that the Antichrist is not revealed until after the Rapture is taught in 2nd Thessalonians 2; and speaking of the Day of the Lord, Paul writes that the Tribulation will not begin until after the Antichrist is already revealed: ***“That day will not come until the rebellion occurs and the man of lawlessness is revealed, the man doomed to destruction. He will oppose and will exalt himself over everything that is called God or is worshiped, so that he sets himself up in God’s temple, proclaiming himself to be God”*** -(verses 3–4). Also, the revelation of the Antichrist must come after something else, because right now there is something ***“holding him back, so that he may be revealed at the proper time. For the secret power of lawlessness is already at work; but the one who now holds it back will continue to do so till he is taken out of the way. And then the lawless one will be revealed”*** -(verses 6–8). We believe this One who ***“holds back”*** the Antichrist is none other than the Holy Spirit. When the restraining influence of the Holy Spirit is removed from this world—along with the church that the Spirit indwells—then the Antichrist will have free rein.

It is my view that God's people are unprepared for the Antichrist's coming. Though there might exist stacks of end-times information, many are not attentive to it, being convinced that Jesus Christ will take them to their heavenly home before the Great Tribulation and Antichrist's devious deceptive work occurs on earth. The media image has presented Prince Charles as an environmentalist, wanting clean air, water, and food for all. How could such a person be anything other than a benevolent king, a loving grandfather type person. Prince Charles and his family are daily topics on Apple's Siri News since a month before his coronation. One would have thought this news coverage of Prince Charles would have ended within a couple weeks after May 6th but it continues.

If folks are uninformed about the Antichrist's person, plans, and signs, then the previous messages will provide vital information to identify him. One danger is that many Christians are told and believe that Antichrist isn't coming until after Christ raptures His people (cf. 1st Thessalonians 4). As I see it from the point we are today, June 15th, 2023, there are only three months left in which the Lord Jesus Christ will call us up, **"Come up thither!"**. The Feast of Trumpets or Rosh HaShanah begins on September 15th, three months from today!

In previous Blessed Hope segments, I suggested several potential dates for the Rapture, all of which, including: **June 20th, July 4th, July 26th**, have reasons for consideration. As we narrow in on the targeted date, we cannot know definitively as Matthew 24:36 tells the reader. I just know I am thrilled to the idea we are in the short window of three months! How about you? Praise God!

One nuclear-armed Poseidon torpedo could decimate a coastal city. Russia wants 30 of them.



Imagine finding yourself on serene seashore, only to realize that a catastrophic tsunami is imminent. However, this is no ordinary tsunami; this one is radioactive.

In January 2023, the Russian news agency TASS reported that Russia had produced the first set of nuclear-powered, very long range, nuclear-armed torpedoes known as "Poseidon." Strategic experts are warning that the Poseidon torpedo would have the potential to devastate a coastal city, cause radioactive floods, and result in millions of deaths. Over the past few years, tabloid news outlets have painted a hauntingly vivid picture of a towering, 1,000-foot-tall radioactive tsunami violently crashing onto British shores, pulverizing everything in its path, and transforming whole cities into barren, lifeless lands.

Is Poseidon even real? In ancient Greek mythology, Poseidon was revered as the god of the oceans, protector of sailors and those who worked or traveled at sea. In the current context, "Poseidon" takes on a different meaning, with a destructive weapon capable of causing catastrophic events.

Russia's Poseidon—also known in the United States as Canyon, Ocean Multipurpose System, and Status-6—was first revealed by the Russian Navy in 2015 and reportedly tested for the first time in November 2016. The torpedo—a nuclear-powered underwater drone equipped with nuclear weapons—is designed to be launched from submarines. The first Poseidon is expected to be deployed by 2027.




Computer-generated image of a "Poseidon" long-range nuclear-powered torpedo. (Image: Russian Defense Ministry)

There is buzz that this new weapon is poised to shake the landscape of modern warfare. And this may owe less to its borrowed name than to some unmatched features—at least on paper.

Powered by a compact nuclear reactor, it is believed the Poseidon could travel at [unprecedented speeds](#) of 100 knots (185 kilometers per hour), have a range of approximately 10,000 kilometers, and operate at depths of up to 1,000 meters. Designed to evade detection by acoustic tracking devices and other traps, the Poseidon has a diameter of approximately 1.6 to two meters. Particularly riveting is the torpedo's devastating payload: a nuclear warhead with a [likely yield](#) of at least several megatons (with early reports suggesting it could yield up to 100 megatons). For comparison, Russia's Tsar Bomba—the most powerful nuclear weapon ever tested—had an estimated blast yield of about 50 megatons.

While some reports [claim](#) that Russia’s Poseidon may exist only as a propaganda scheme, experts generally agree that the system is “[very real](#)” and has received significant resources from the Russian armed forces, although many details remain unknown. [Intelligence reports](#) have suggested that Poseidon has undergone many trials, evidenced by the fact that some submarines have been modified and some are being specially built to accommodate for the larger and heavier Poseidon. For instance, the [Sarov](#) submarine [is believed](#) to have been modified to test Poseidon prototypes. According to TASS, the Russian Navy intends to purchase at least [30 Poseidon torpedoes](#) and deploy them on four submarines.

Poseidon’s origin and roles. The idea of torpedoes fitted with a nuclear warhead was first conceived in the 1950s, when the Soviet Union began two separate programs to develop submarine-launched nuclear torpedoes—the T-5 and the T-15. These programs were part of a broader strategy to expand the Soviet Union’s nuclear capabilities and gain an edge in a nuclear crisis.

In October 1962, during the Cuban Missile Crisis, a Soviet submarine armed with a T-5 nuclear- tipped torpedo [came close](#) to launching it against US forces because its commander, Valentin Savitsky, believed that a U.S.-Soviet Union war had already started. It is only because the submarine’s deputy commander, [Vasili Arkhipov](#), convinced other top officers that launching the torpedo would be a fatal mistake that a potential nuclear catastrophe was prevented.

The Poseidon torpedo, however, will have no human [onboard](#) to make critical decisions after it has been launched. It will be controlled through a combination of remote communications and onboard automation. These forms of guidance may lead to problems that include hacking by third parties, loss of control because of technical malfunctions, and environmentally caused accidents that may lead to wrong signaling and thus inadvertent escalation.

The Poseidon can be viewed as an evolution in Russia's nuclear deterrence strategy. Russia currently possesses the [Dead Hand](#), an automated nuclear weapons command system also known as the Perimeter. Established during the Cold War, the Perimeter was created to ensure that, in a crisis, the Soviet Union could respond to a nuclear first strike, even if Russia's armed forces were destroyed and all its leadership was eliminated. But with the technological advances of U.S. ballistic missile defense systems, the Russian Perimeter system, which concerns intercontinental ballistic missiles only, has lost its preeminence.

Russian authorities describe the Poseidon torpedo as a multi-purpose system, suggesting that it could serve several roles.

It is widely speculated that the Poseidon may have been developed as a reaction to advances in U.S. ballistic missile defense capabilities. In March 2018, Russian President Putin stated that Poseidon and other advanced weapons were developed because of the demise of the 1972 U.S.-Soviet Anti-Ballistic Missile Treaty, which Putin said was "the cornerstone of the international security system." After the United States pulled out of the treaty in 2002 to build its new national missile defense system, Russia started working on improving their military equipment and weapons to maintain a strong nuclear deterrent capability against U.S. assets.

Besides being touted as a weapon that can circumvent U.S. ballistic missile defenses for use [against](#) aircraft carrier groups and coastal targets, Poseidon also reflects Russia's larger nuclear strategy and doctrine. After the Cold War ended, the United States shifted its focus to de-emphasizing the role of nuclear weapons in its security strategy. But Russia continued to greatly rely on nuclear weapons and even [adopted](#) a nuclear doctrine of "escalate to de-escalate," which consists of using nuclear coercion and messaging tactics to achieve strategic goals. The development and deployment of new nuclear weapons like the Poseidon are considered to contribute to Russia's broader strategy.

Effect on strategic stability. Advances in artificial intelligence and the use of autonomous platforms for nuclear delivery such as unmanned aerial vehicles, unmanned underwater vehicles, and hypersonic glide vehicles have [raised concerns](#) over potential negative impacts on strategic stability. Weaker nuclear-armed countries would remain unable to keep up with progress in AI technologies, which also pose new risks by reducing the direct human control over nuclear weapons use. In this context, the deployment by Russia of its nuclear-capable, autonomous Poseidon torpedo could be seen to also threatening strategic stability.

However, many experts and U.S. officials—including former U.S. Defense Secretary James Mattis—believe that the addition of the Poseidon torpedo to Russia’s nuclear arsenal [would not alter](#) the existing [strategic nuclear balance](#) with the United States because Russia already possesses the capability to launch nuclear-armed missiles at U.S. cities. The introduction of Poseidon would not significantly increase the existing threat and, even if used, its impact would be limited to coastal areas.

Instead, many see Poseidon primarily as a [psychological weapon](#) intended for nuclear signaling rather than for its actual use. Some [even speculate](#) that the Poseidon will remain at the prototype stage and serve mainly political objectives, such as renewed talks with the United States on ballistic missile defense systems. The weapon’s primary intent may be in the uncertainty, speculation, and fear it can provoke.

How to respond? Automated weapons like Poseidon, especially if controlled by artificial intelligence, undoubtedly add complexity to decision-making in a crisis. It effectively transforms AI into an active participant during times of strategic adversity. This has sparked a heated debate on whether these systems should be fully automated or not, as automation brings significant risks of misjudging the intentions of an opponent. To better understand the challenges posed by unmanned automated nuclear vehicles like Poseidon, further research is imperative, which requires gathering more information about the weapon itself.

While ensuring that research in automation only aims to reduce any risks associated with accidents or inadvertent use, it is equally important for countries to continue engaging in arms control and risk reduction talks whenever possible. Such dialogues may play a crucial role in providing insight into each other’s nuclear forces, helping to alleviate uncertainties about possible new weapon systems, including the Poseidon.

For years, the words of Hilton Sutton have echoed in my mind: *“When the bombs are descending, the saints will be ascending!”*


