DUBAI, 14th August, 2023 (WAM) -- The World Economic Forum announced the selection of Omar Sultan Al Olama, Minister of State for Artificial Intelligence, Digital Economy and Remote Work Applications, Director-General of the Prime Minister's Office, for the steering committee in the Al Governance Alliance which includes 10 of the world's leaders in the digital and technological fields globally.

The AI Governance Alliance is a dedicated initiative focused on responsible generative artificial intelligence (AI). It aims to address today's most critical issues as humanity approaches a potentially transformative socio-economic era by bringing together influential regional voices and multiple stakeholders globally.

The Alliance seeks to harness the benefits of generative AI systems and technologies while ensuring equitable and sustainable global impacts.

With the support of the World Economic Forum's Centre for the Fourth Industrial Revolution, the alliance actively engages with various regions while contributing to shaping a global approach to address the transformative nature of generative Al systems.

In 2017, Al Olama was chosen by the World Economic Forum to become a member of the Future of Digital Economy and Society group. Furthermore, in 2022, he was also selected to be a part of the Global Young Leaders Community

AMAZON SUMMIT AGREES PLAN TO PROTECT RAINFORESTS, NO MEASURABLE GOALS

Leaders and ministers from eight Amazon nations signed a declaration in Belém, Brazil. It lays out plans to drive economic development in their countries, while preventing the Amazon's ongoing demise "from reaching a point of no return". The participants, members of the newly revived Amazon Cooperation Treaty Organization hope that a united front will give them a major voice during COP28.

AL JABER STANDS WITH BRAZIL'S LULA AND CALLS TO INVEST IN, AND PROTECT NATURE

COP28 President-Designate, spoke at the Amazon Summit, urging leaders to build on President Lula da Silva's commitment and inspire transformational progress on nature at COP28. In Brazil, Al Jaber also met with the Minister of Indigenous Peoples of Brazil and representatives of Indigenous Amazon leaders.

BRICS TO DISCUSS ACCELERATED USE OF LOCAL CURRENCIES AT SUMMIT

The BRICS group of emerging-market nations will discuss deepening the use of local currencies in trade between member states at a summit in South Africa next week, the nation's ambassador to the bloc said.

The summit of BRICS leaders is scheduled to take place from Aug. 22-24 in Johannesburg, where they'll discuss whether to admit more nations to its ranks. Forty heads of state and government have confirmed their attendance, and that number could rise to about 50, according to Sooklal.

"I think there is a general consensus that BRICS has to expand," he said. "We have worked out some rules of procedure and criteria."

GLOBAL STOCKTAKE

Soon before the opening of COP28, the <u>United Nations</u> will publish the first two-year assessment of global progress to slow down climate change called the "<u>global stocktake</u>." The overview was established during <u>COP26</u> in <u>Glasgow</u> and is scheduled to be repeated every five years.

COP28 PRESIDENT-DESIGNATE VISITS BARADOS AND MEETS CARICOM LEADERS

Sultan Al Jaber visited Barbados to meet with Prime Minister Mia Motley and address leaders of the Caribbean Community (CARICOM). He stated that he has called on donor countries to "show him the money", in reference to the long overdue \$100 billion

finance pledge. He also called for deep, system-wide reform of IFIs and MDBs to align them with the needs of the 21st century.

NIGERIA'S COP28 FOCUS WILL BE ON THE \$100 BILLION LOSS AND DAMAGE FUND

As Nigeria gears up for COP28, its federal government has unveiled that its biggest focus will be on the operationalization of the \$100 billion Loss and Damage Fund. The government also highlighted the importance of concluding discussions on the Just Energy Transition, combining sustainable transitions for emerging economies with ensuring financial support.

UK ASKED TO OBTAIN ASSURANCES FROM UAE OVER RIGHT TO PROTEST AT COP28

British human-rights barristers wrote to the UK foreign secretary demanding he seek an undertaking from the Emirati authorities affirming the rights and safety of UK citizens travelling to the UAE to engage in peaceful demonstrations. The UAE has pledged in a joint statement with the UN that it would make "space available for climate activists to assemble peacefully and make their voices heard".

UAE HIRES NEW LOBBYIST TO DEFLECT CLIMATE TALKS CRITICIMS

A new PR firm specializing in crisis management inked a contract with the UAE to push back on critics and boost environmental credentials ahead of COP28, according to *Politico*. US-based First International Resources is to spin negative press and criticism, based on a six-month contract coming with a \$100,000-per-month retainer, plus another \$132,000 for the US portion of the polling project.

SAUDI FUND SIGNS \$77MILLION LOAN FOR SOLAR ENERGY PLANT IN BELIZE

The Saudi Fund for Development (SFD) has signed a development loan agreement with the Prime Minister of Belize John Briceno. The agreement, worth \$77 million, aims to finance the construction of a solar power plant in the Central American nation. It is the second deal signed between the Kingdom, via SFD, and Belize since the start of its development activities in 2023.

COP28 AND COURSERA TO EXPAND ACCESS TO CLIMATE COURSES FOR YOUTH

The COP28 Presidency has teamed up with Coursera, a global online learning platform, to provide 5,000 free licenses for a curated program of climate-focused online courses and certificate programs. The program covers a range of topics essential for climate literacy across mitigation, adaptation, finance, and loss and damage. Licenses will be distributed through UNFCCC and UAE universities.

ADNOC BUILDS 'INVESTMENT BANK' TO CHASE \$50BN IN GLOBAL DEALS

Abu Dhabi National Oil Company has amassed a nearly 50-strong team to pursue roughly \$50 billion in transactions as part of a push to diversify its business and expand abroad. The shift marks the latest step in the transformation of ADNOC from a state oil

and gas producer to a company with ambitions to build a global portfolio spanning chemicals, plastics and beyond.

CONCLUSION




