**The Capstone: The Top Of The Pyramid
Humanity is on the Highway to Hell!**



There are two operant Crowns in England, one being Queen Elizabeth II. That changed with the death of the Queen in September, 2022. The authority and control passed to her son, Prince Charles of Wales, and now King of the UK.

Although extremely wealthy, the Queen functioned largely in a ceremonial capacity and served to deflect attention away from the other Crown, who issues her marching orders through their control of the English Parliament.

This other Crown is comprised of a committee of 12 banks headed by the Bank of England (House of Rothschild). They rule the world from the 677-acre, independent sovereign state known as The City of London, or simply 'The City.'

The City is not a part of England, just as Washington D.C., is not a part of the USA.

The City is referred to as the wealthiest square mile on earth and is presided over by a Lord Mayor who is appointed annually.

When the Queen wished to conduct business within the City, she was met by the Lord Mayor at Temple (Templar) Bar where she requests permission to enter this private, sovereign state. She then proceeded into the City walking several paces behind the Mayor.

Her entourage may not be clothed in anything other than service uniforms.

In the nineteenth century, 90% of the world's trade was carried by British ships controlled by the Crown. The other 10% of ships had to pay commissions to the Crown simply for the privilege of using the world's oceans.

The Crown reaped billions in profits while operating under the protection of the British armed forces. This was not British commerce or British wealth, but the Crown's commerce and the Crown's wealth.

As of 1850, author Frederic Morton estimated the Rothschild fortune to be in excess of \$10 billion (today, the combined wealth of the banking dynasties is estimated at around \$500 trillion).

Today, the bonded indebtedness of the world is held by the Crown. That includes the National Debt of the U.S.A. currently at \$32.7-trillion dollars and soaring.

The aforementioned Temple Bar is the juristic arm of the Crown and holds an exclusive monopoly on global legal fraud through their Bar Association franchises. The Temple Bar is comprised of four Inns of Court.

They are: the Middle Temple, Inner Temple, Lincoln's Inn and Gray's Inn. The entry point to these closed secret societies is only to be found when one is called to their Bar.

The Bar attorneys in the United States owe their allegiance and pledge their oaths to the Crown. All Bar Associations throughout the world are signatories and franchises to the International Bar Association located at the Inns of Court of the Crown Temple.

The Inner Temple holds the legal system franchise by license that bleeds Canada and Great Britain white, while the Middle Temple has license to steal from America.

To have the Declaration of Independence recognized internationally, Middle Templar King George III agreed in the Treaty of Paris of 1783 to establish the legal Crown entity of the incorporated United States, referred to internally as the Crown Temple States (Colonies). States spelled with a capital letter 'S,' denotes a legal entity of the Crown.

At least five Templar Bar Attorneys under solemn oath to the Crown, signed the American Declaration of Independence. This means that both parties were agents of the Crown. You can research this on your own if you doubt what I am saying.

There is no lawful effect when a party signs as both the first and second parties. The Declaration was simply an internal memo circulating among private members of the Crown.

Most Americans believe that they own their own land, but they have merely purchased real estate by contract. Upon fulfillment of the contract, control of the land is transferred by Warranty Deed.

The Warranty Deed is only a 'color of title.' Color of Title is a semblance or appearance of title, but not title in fact or in law. The Warranty Deed cannot stand against the Land Patent.

The Crown was granted Land Patents in North America by the King of England. Colonials rebelled at the usurious Crown taxes, and thus the Declaration of Independence was created to pacify the populace.

Another ruse used to hoodwink natural persons is by enfranchisement. Those cards in your wallet bearing your name spelled in all capital letters means that you have been enfranchised and have the status of a corporation. Most of what I share in this segment will be new for you. When I first learned of all this, I did not want to believe it either.

A 'juristic personality' has been created, and you have entered into multi-variant agreements that place you in an equity relationship with the Crown. You are a subject of the King of the UK, i.e., "***the Prince that is to Come***" noted in Daniel 9:26.

These invisible contracts include birth certificates, citizenship records, employment agreements, driver's licenses and bank accounts. It is perhaps helpful to note here that contracts do not now, nor have they ever had to be stated in writing in order to be enforceable by American judges. If it is written down, it is merely a written statement of the contract.

Tax protestors and (the coming) draft resistors trying to renounce the parts of these contracts that they now disagree with will not profit by resorting to tort law (fairness) arguments as justification. Judges will reject these lines of defense as they have no bearing on contract law jurisprudence. Tort law governs grievances where no contract law is in effect.

These private agreements/contracts that bind us will always overrule the broad general clauses of the Constitution and Bill of Rights (the Constitution being essentially a renamed enactment of English common law). The Bill of Rights is viewed by the Crown as a 'bill of benefits,' conferred on us by them in anticipation of reciprocity (taxes).

Protestors and resisters will also lose their cases by boasting of citizenship status. Citizenship is another equity agreement that we have with the Crown. And this is the very juristic contract that Federal judges will use to incarcerate them. In the words of former Supreme Court Justice Felix Frankfurter, *"Equity is brutal, but we are merely enforcing agreements."*

"The balance of Title 42, section 1981 of the Civil Rights Code states," citizens shall be subject to like punishment, pains, penalties, taxes, licenses, and exactions of every kind"

What we view as citizenship, the Crown views as a juristic enrichment instrumentality. It also should be borne in mind that even cursory circulation or commercial use of Federal Reserve Notes effects an attachment of liability for the payment of the Crown's debt to the FED. This is measured by your taxable income.

And to facilitate future asset-stripping, the end of the 14th amendment includes a state of debt hypothecation of the United States, wherein all enfranchised persons (that's you) can be held personally liable for the Crown's debt.

The Crown views our participation in these contracts of commercial equity as being voluntary and that any gain accrued is taxable, as the gain wouldn't have been possible were in not for the Crown.

They view the system of interstate banks as their own property. Any profit or gain experienced by anyone with a bank account (or loan, mortgage or credit card) carries with it – as an operation of law – the identical same full force and affect as if the Crown had created the gain.

Bank accounts fall outside the umbrella of Fourth Amendment protection because a commercial contract is in effect and the Bill of Rights cannot be held to interfere with the execution of commercial contracts. The Crown also views bank account records as their own private property, pursuant to the bank contract that each of us signed and that none of us ever read.

The rare individual who actually reads the bank contract will find that they agreed to be bound by Title 26 and under section 7202 agreed not to disseminate any fraudulent tax advice. This written contract with the Crown also acknowledges that bank notes are taxable instruments of commerce.

When we initially opened a bank account, another juristic personality was created. It is this personality (income and assets) that IRS agents are excising back to the Crown through taxation.

A lot of ink is being spilled currently over Social Security, and not just because it is broke!

Possession of a Social Security Number is known in the Crown's lex as 'conclusive evidence' of our having accepted federal commercial benefits. This is another example of an equity relationship with the Crown.

Presenting one's Social Security Number to an employer seals our status as taxpayers, and gives rise to liability for a reciprocal quid pro quo payment of taxes to the Crown.

Through the Social Security Number we are accepting future retirement endowment benefits. Social Security is a strange animal. If you die, your spouse gets nothing, but rather, what would have gone to you is divided (forfeited) among other premium payers who haven't died yet.

But the Crown views failure to reciprocate in any of these equity attachments as an act of defilement and will proceed against us with all due prejudice.

For a person to escape the tentacles of the Crown octopus, a thoroughgoing study of American jurisprudence is required. One would have to be deemed a 'stranger to the public trust,' forfeit all enfranchisement benefits and close all bank accounts, among other things.

Citizenship would have to be made null and forfeit and the status of 'denizen' enacted. If there are any persons extant who have passed through this fire, I would certainly appreciate hearing from them. Few attempt to go through the hoops to establish their own sovereignty once they discover how the trap works.

The United States of America is a corporation, ruled by the British Crown and the Vatican.

The USA is, and always has been, a huge corporation ruled from abroad. Its initial name was the Virginia Company and it is owned by the British Crown and the Vatican, who receive their yearly share of the profits.

The U.S. presidents are appointed CEO's (they are not elected by us!), and their allegiance is to the "board of directors," not to the American citizens. We are seen as employees of the company and voting is designed as a distraction meant to offer us the illusion that we have a say in all this.

In 1606 [King] James set up the Virginia Company which was granted Royal authority to begin settlements in the province of Virginia, named after Elizabeth I, who had been

popularly called the Virgin Queen. The Union Jack first flew on American soil at Jamestown in Virginia as a permanent fixture in the spring of 1607...

The early members of the Virginia Company were aristocrats who supported the Church of England and the Royalist cause. They included Lord Southampton, the Earl of Pembroke, the Earl of Montgomery, the Earl of Salisbury, the Earl of Northampton, and Sir Francis Bacon...

As chancellor of England, Bacon was able to persuade the king to issue the charters which enabled the new colonies to proliferate in the new world...

"The Virginia Company members who actually settled in America included several members of the Bacon family, and friends of his who were initiates of the Rosy Cross."
— Michael Howard – Occult Conspiracy (quoted by Michael Tsarion)

"I understand from contacts in America that it is through organizations like the London Metal Exchange that profits from the Virginia Company (United States of America) are channeled back to London."— David Icke – *'The Biggest Secret;'*

"The House of Burgesses was formed in Jamestown in 1619. It was the first representative legislative body in the American Colonies. The House passed measures designed to help the company prosper. But a serious Indian uprising in Jamestown in 1622 caused the adventurers to lose what little interest they had left. In 1623, King James decided that the company was being managed poorly. He took over the association in 1624 and dissolved the company."— World Book Encyclopedia;

Its shareholders were Londoners, and it was distinguished from the Plymouth Company, which was chartered at the same time and composed largely of men from Plymouth.

In 1619 the company established continental America's first true legislature, the General Assembly, which was organized bicamerally. It consisted of the governor and his council, named by the company in England, and the House of Burgesses, made up of two burgesses from each of the four boroughs and seven plantations.

"...The court ruled against the Virginia Company, which was then dissolved, with the result that Virginia was transformed into a royal colony."— Encyclopedia Britannica;

This means that all the rights which applied to the owners of the Virginia Company to the gold, silver, minerals and duties, mined and paid in America, still apply to the British families who own the United States of America and the lands of the united states of America.

Those same percentages have been paid since 'independence' and are still being paid by the American people via their federal officials who are, in fact, officials of the Virginia Company – yes, including the President.

“...But here’s yet another twist. Who owns the assets apparently owned by the Virginia Company? Answer: the Vatican.”– David Icke – ‘The Biggest Secret;’

After the original 13 (again!) American colonies won their ‘independence’ and an ‘independent’ country was formed after 1783, the Virginia Company simply changed its name to... the United States of America.

You see there are two USAs, or rather a USA and a usA. The united states of America with a lower case ‘u’ and ‘s’ are the lands of the various states. These lands, as we have seen, are still owned by the British Crown as the head of the old Virginia Company, although there is something to add about this in a moment.

Then there is the United States of America, capital ‘U’ and ‘S’, which is the 68 square miles of land west of the Potomac River on which is built the federal capital, Washington DC and the District of Columbia. It also includes the U.S. protectorates of Guam and Puerto Rico.

“The United States of America is not a country, it is a corporation owned by the same Brotherhood bloodlines who owned the Virginia Company, because the USA is the Virginia Company!”– David Icke – ‘The Biggest Secret;’

In 1604, a group of leading politicians, businessmen, merchants, manufacturers and bankers, met in Greenwich, then in the English county of Kent, and formed a corporation called the Virginia Company in anticipation of the imminent influx of white Europeans, mostly British at first, into the North American continent.

Its main stockholder was King James I, and the original charter for the company was completed by April 10th 1606. This and later updates to the charter established the following:

“...The Virginia Company comprised of two branches, the London Company and the Plymouth or New England Company...The ‘Pilgrims’ of American historical myth were, in fact, members of the second Virginia Company branch called the New England Company. The Pilgrim Society is still a major elite grouping within the Illuminati..”

The Virginia Company owned most of the land of what we now call the USA, and any lands up to 900 miles offshore. This included Bermuda and most of what is now known as the Caribbean Islands.

The Virginia Company (the British Crown and the bloodline families) had rights to 50%, yes 50%, of the ore of all gold and silver mined on its lands, plus percentages of other minerals and raw materials, and 5% of all profits from other ventures.

These rights, the charters detailed, were to be passed on to all heirs of the owners of the Virginia Company and therefore continue to apply... forever! Really forever!

The controlling members of the Virginia Company who were to enjoy these rights became known as the Treasurer and Company of Adventurers and Planters of the City of London.

After the first 21 years from the formation of the Virginia Company, all 'duties, imposts, and excises' paid on trading activities in the colonies had to be paid directly to the British Crown through the Crown treasurer...

The lands of the Virginia Company were granted to the colonies under a Deed of Trust (on lease) and therefore they could not claim ownership of the land...

The monarch, through his Council for the Colonies, insisted that members of the colonies impose the Christian religion on all the people, including the Native Americans...

The criminal courts on the lands of the Virginia Company were to be operated under Admiralty Law, the law of the sea, and the civil courts under common law, the law of the land... Now, get this. *"All of the above still applies today!"*— David Icke – *'The Biggest Secret,'*

The United States Inc.

England, Canada, Australia and many other countries are led politically by "Prime Ministers" to the Queen. In fact she is the official head of 123 commonwealth countries. America, Russia, and other countries, however, have a "President" and "Vice-President."

Usually corporations have Presidents and Vice-Presidents. What does this mean? The U.S. Presidents rule from the "White House." The Russian Presidents also rule from the White House. The Jesuits, a large force behind the Illuminati, have their own White House as well. England is ruled from "Whitehall."

"The United States government is being ruled from the 'White House,' the government of England is being ruled from what is called 'Whitehall,' and Whitehall, like our White House, is the symbol of power because the hall is like the Masonic hall, the lodge hall, the union hall." — Jordan Maxwell – *'Matrix of Power,'*

"For those who think America controls the roost it would do well to consider that the Queen of England is still the official head of Commonwealth (123 countries) and the official monarch of Australia and Canada along with the United Kingdom... add to that the fact that all Bush Sr. got for his two terms as president of USA is a mere knighthood of the British Empire." — Prash Trivedi;

The original 13 colonies were actually called companies. Military units are also called companies. We sing patriotic songs like "the Star-Spangled Banner" but a banner is a corporate advertisement, not a flag.

You surrender with a white flag, no colors. When you get mad you show your true colors. If you just won independence in a bloody revolution with Britain would you choose the same three colors for your new U.S. flag?

Why does *“every heart ring true for the red, white, and blue?”* What about the gold-fringed flag used by the military, hung at all courts, schools, and government buildings?

It all has to do with the British Maritime Admiralty Law of Flags.

Joseph R. Biden is the current CEO of the USA Corporation and the gold-fringed flags in the background stand for *“ruled from abroad.”* He is a subordinate (subject) of Prince Charles, the king of the British Commonwealth of Nations.

This is also known as British Maritime (military) Law and this is why the American flag always has a gold fringe when displayed in the courts of the United States. You find the same in government buildings and federally funded schools.

The gold fringe is a legal symbol indicating that the court is sitting under British Maritime Law and the Uniform Commercial Code – military and merchant law not common or constitutional law, under the Admiralty Law of Flags, the flag displayed gives notice of the law under which the ship (in this case the court) is regulated.

Anyone entering that ship (court) accepts by doing so that they are submitting to the law indicated by that flag. Judges refuse to replace the flag with one without a fringe when asked by defendants who know the score because that changes the law under which the court is sitting.

“If you appear in a court with a gold fringed flag your constitutional rights are suspended and you are being tried under British Maritime (military /merchant) Law.” — David Icke – Tales from the Time Loop;

International Maritime Admiralty law, the law of the high seas, began in Sumeria, and was perfected in Rome and continues to this day. Jordan Maxwell has explained that the way we trade commerce today is modeled after the Masons'/Templar Knights' 1,000 year old system.

Notice how regardless of whether you send a product by air, water, or land – you “ship” it. The ship pulls into its “berth” and ties to the “dock.” The Captain has to provide the port authorities with a “certificate of manifest” declaring the products he has brought.

Through a legal loophole the royals have created, U.S. citizens are considered property of the queen under British Maritime law. Since we are born of our mother’s water, from her “birth canal,” we are thereby a maritime product, a “shipped” commodity. Our mothers were delivering a product under maritime law and that’s why we are born in a “delivery room.”

That's why the "doc" signs your "berth" certificate, your "certificate of manifest." You're kept in the Maternity "Ward." Why a ward? No other hospital areas are called wards. Prisons have wards and wardens.

The United States Corporation came about just after the civil war. The Act of 1871 was passed by congress creating a separate form of government for DC, essentially turning it into a corporation.

It was decided that employees would be called "citizens." So when you say in court or on paper, that you are a citizen of the United States, you are not a free American, but an employee of US Inc.

When you get a fine, a ticket, a bill, or get sued, you must sign in all capital letters. When you die your Masonic tombstone by law will have all capital letters to show their employee has died.

The entity that is your name in all caps is your maritime admiralty product code. Upper and lower case legally represents you, your body.

The Uniform Commercial Code was approved by the American Bar Association, which is a franchise, a subordinate branch, of the British legal system and its hierarchy based in London's Temple Bar (named after the Illuminati Knights Templar secret society).

As I have been writing for many years, the power that controls America is based in Britain and Europe because that is where the power is located that owns the United States Corporation. By the way, if you think it is strange that a court on dry land could be administered under Maritime Law, look at US Code, Title 18 B 7.

It says that Admiralty Jurisdiction is applicable in the following locations: (1) the high seas; (2) any American ship; (3) any lands reserved or acquired for the use of the United States, and under the exclusive or concurrent jurisdiction thereof, or any place purchased or otherwise acquired by the United States by consent of the legislature of the state.

In other words, mainland America. All this is founded on Roman law because the Illuminati have been playing this same game throughout the centuries wherever they have gone. The major politicians know that this is how things are and so do the government administrators, judges, lawyers and insider 'journalists'.

Those who realize what is happening and ask the court for the name of the true creditor or recipients of the fines imposed by the 'legal system' are always refused this information by the judge.

The true creditors in such cases, and the ultimate recipient of the fines, are the bankers to which the corporation 'country' is bankrupt." — David Icke — *'Tales from the Time Loop;'*

Lawyers or “barristers” have to take the Bar Association “bar” exam just as alcoholics go to the “bar,” sugar-junkies eat candy “bars,” and gamblers hope to get 3 “bars” on the slot machine. These all derive from the Templar’s turn of the 13th century “Temple Bar” in England.

Originally the Temple Bar was literally just a bar or chain between two posts next to the Temple law courts. This soon became a huge stone gate and there were eventually eight of these gates built so the elites could restrict / control trade within the city of London.

They were taken down during 19th century, but then each stone was numbered and kept in storage until 2004 when they just re-built the Temple Bar in London.

The United States corporation was created behind the screen of a ‘Federal Government’ when, after the manufactured ‘victory’ in the American War of ‘Independence’, the British colonies exchanged overt dictatorship from London with the far more effective covert dictatorship that has been in place ever since.

In effect, the Virginia Company, the corporation headed by the British Crown that controlled the ‘former’ colonies, simply changed its name to the United States and other related pseudonyms.

These include the U.S., USA, United States of America, Washington DC, District of Columbia, Federal Government and ‘Feds’. The United States Corporation is based in the District of Columbia and the current president of the corporation is a man called Joseph R. Biden.

He is not the president of the people or the country as they are led to believe, that’s just the smokescreen. This means that George H.W. Bush launched a ‘war on terrorism’ on behalf of a private corporation to further the goals of that corporation.

It had nothing to do with ‘America’ or ‘Americans’ because these are very different legal entities. It is the United States Corporation that owns the United States military and everything else that comes under the term ‘federal’.

This includes the Federal Reserve, the ‘central bank’ of the United States, which is, in reality, a private bank owned by controlling stockholders (and controllers of the U.S. Corporation) that are not even American. This is the bank from which the United States Corporation borrows ‘money’.”

In other words, our government was created by and for “sovereigns” — the free citizens who were deemed the highest authority. Only the People can be sovereign — remember that. Government cannot be sovereign. We can also look to the Declaration of Independence, where we read: “government is subject to the consent of the governed” — that’s supposed to be us, the sovereigns. Do you feel like a sovereign nowadays? I don’t.

It doesn’t take a rocket scientist or a constitutional historian to figure out that this is not what is happening in our country today. Government in these times is NOT subject to the consent of the governed. Rather, the governed are subject to the whim and greed of the corporation, which has stretched its tentacles beyond the ten-mile-square parcel of land known as the District of Columbia — encroaching into every state of the Republic. Mind you, the corporation has NO jurisdiction outside of the District of Columbia. THEY just want you to think it does.

You see, you are presumed to know the law. This is ironic because as a people, we are taught basically nothing about the law in school. We are made to memorize obscure factoids and paragraphs here and there, such as the Preamble, and they gloss over the Bill of Rights. But we are not told about the law. Nor do our corporate government schools delve into the Constitution in any great depth. After all, they were put into place to indoctrinate and dumb down the masses — not to teach us anything. We were not told that we were sold-out to foreign interests and made beneficiaries of the debt incurred by Congress to the international bankers. For generations, American citizens have had the bulk of their earnings confiscated to pay on a massive debt that they, as a People, did not incur. There are many, many things the People have not been told. How do you feel about being made a beneficiary of somebody else’s massive debt without your knowledge or consent? Are we gonna keep going along with this??

When you hear some individuals say that the Constitution is null and void, think about how our government has transformed over time from a municipal or service-oriented entity to a corporate or profit-oriented entity. We are living under the myth that this is lawful, but it is not. We are being ruled by a “de facto,” or unlawful, form of government — the corporate body of the death-mongers — The Controllers.

With the passage of the Act of 1871, a series of subtle and overt deceptions were set in motion — all in conjunction and collusion with the Congress, who knowingly and deliberately sold the People down the river. Did they tell you this in government school? I doubt it. They were too busy drumming the fictional version of history into your brain — and mine. By failing to disclose what THEY did to the American People, the people became ignorant of what was happening. Over time, the Republic took it on the chin to the point of a knockdown. With the surrender of their gold in 1933, the People

essentially surrendered their law. I don't suppose you were taught THAT in school either. That's because our REAL history is hidden from us. This is the way Roman Civil Law works — and our form of governance today is based upon Roman Civil Law and Admiralty/Maritime Law — better known as the “Divine Right of Kings” and “Law of the Seas”, respectively. This explains a lot. Roman Civil Law was fully established in the original colonies even before our nation began and is also known as private international law.

The government which was created for the District of Columbia via the Act of 1871 operates under Private International Law, and not Common Law, which was the law of the Constitutional Republic. This is very important to note since it impacts all Americans in concrete ways. You must recognize that private international law is only applicable within the District of Columbia and NOT in the other states of the Union. The various arms of the corporation are known as “departments” such as the Judiciary, Justice and Treasury. You recognize those names? Yes, you do! But they are not what you assume them to be. These “departments” all belong to the corporation known as THE UNITED STATES. They do NOT belong to you and me under the corporate constitution and its various amendments that operate outside of the Constitutional Republic.

I refer you to the UNITED STATES CODE (note the capitalization, indicating the corporation, not the Republic) Title 28 3002 (15) (A) (B) (C). It is stated unequivocally that the UNITED STATES is a corporation. Realize, too, that the corporation is not a separate and distinct entity from the government. It IS the government. YOUR government. This is extremely important. I refer to this as the “corporate empire of the UNITED STATES,” which operates under Roman Civil Law outside of the Constitution. How do you like being ruled by a cheesy, sleazy corporation? You'll ask your Congressperson about this, you say? HA!!

Congress is fully aware of this deception. You must be made aware that the members of Congress do NOT work for you and me. Rather, they work for the Corporation known as THE UNITED STATES. Is this really any surprise to you? This is why we can't get them to do anything on our behalf or to answer to us — as in the case with the illegal income tax — among many other things. Contrary to popular belief, they are NOT our civil servants. They do NOT work for us. They are the servants of the corporate government and carry out its bidding. Period.

It is time we learned what they didn't teach us in school. It is far more interesting than what they DID tell us. I think you'll stay awake for this lesson.

The date is February 21, 1871 and the Forty-First Congress is in session. I refer you to the “Acts of the Forty-First Congress,” Section 34, Session III, chapters 61 and 62. On this date in the history of our nation, Congress passed an Act titled: “An Act To Provide A Government for the District of Columbia.” This is also known as the “Act of 1871.” What does this mean? Well, it means that Congress, under no constitutional authority to do so, created a separate form of government for the District of Columbia, which is a ten mile square parcel of land.

What??? How could they do that? Moreover, WHY would they do that? To explain, let's look at the circumstances of those days. The Act of 1871 was passed at a vulnerable time in America. Our nation was essentially bankrupt — weakened and financially depleted in the aftermath of the Civil War. The Civil War itself was nothing more than a calculated “front” for some pretty fancy footwork by corporate backroom players. It was a strategic maneuver by European interests (the international bankers) who were intent upon gaining a stranglehold on the neck (and the coffers) of America.

The Congress realized our country was in dire financial straits, so they cut a deal with the international bankers — (in those days, the Rothschild's of London were dipping their fingers into everyone's pie) thereby incurring a DEBT to said bankers. If we think about banks, we know they do not just lend us money out of the goodness of their hearts. A bank will not do anything for you unless it is entirely in their best interest to do so. There has to be some sort of collateral or some string attached which puts you and me (the borrower) into a subservient position. This was true back in 1871 as well. The conniving international bankers were not about to lend our floundering nation any money without some serious stipulations. So, they devised a brilliant way of getting their foot in the door of the United States (a prize they had coveted for some time, but had been unable to grasp thanks to our Founding Fathers, who despised them and held them in check), and thus, the Act of 1871 was passed.

In essence, this Act formed the corporation known as THE UNITED STATES. Note the capitalization, because it is important. This corporation, owned by foreign interests, moved right in and shoved the original “organic” version of the Constitution into a dusty corner. With the “Act of 1871,” our Constitution was defaced in the sense that the title was block-capitalized and the word “for” was changed to the word “of” in the title. The original Constitution drafted by the Founding Fathers, was written in this manner:

“The Constitution for the united states of America”.

The altered version reads: “THE CONSTITUTION OF THE UNITED STATES OF AMERICA”. It is the corporate constitution. It is NOT the same document you might think it is. The corporate constitution operates in an economic capacity and has been used to fool the People into thinking it is the same parchment that governs the Republic. It absolutely is not.

We are now living in the ‘calm before the storm’. Second to the first coming of Jesus Christ, this is now by far the most monumental period in world history. Are we all informed and prepared? Obviously most aren't.

Are We Nearing the End Times? Need I ask that question?

Did you know all the signs Christ said would signify His second coming are occurring in our time? I find it absolutely astonishing that so few Americans as well as many Europeans are oblivious to this reality. I sense the ignorance is compounded by an

attitude of indifference. Perhaps this is the result of an overall life free of want and need! For me to ask this question is not an academic matter. You might not realize it but when Prince Charles and his crowd reiterated over and over this year that there is only “seven” years to save the planet, Charles was prophetic, but not in the way he was inferring. I seriously doubt Charles understands or fully grasps the implication of his own words at this point. Nonetheless, with his coronation this past May 6th, 2023, a Biblical time marker point has been crossed.

Hear what I am saying by using the Prince Charles analogy. It was June 8th, 1967, the day following the Israeli Six Day War that began on June 7th, 1967. My “wakeup” call of the events on June 7th sparked a sense of urgency to understand what this meant for a college student-pastor beginning my third year as a student-pastor who had been naïve to never think about what Bible prophecy was all about. Today, we are witness to a collision of emerging signs of the end times becoming more apparent each day as news reports verify the predictions of Bible prophecy.

I keep a tab in my large print Bible of how long I have been studying Bible prophecy. As of the moment I typed this it was at 56 year, 2 months, and 14 days. This is to say that I am energized by what I am witnessing and my perspective is very much attuned to what old “sausage fingers” says and does! He knows he only has “seven” years to achieve his goals. We know by the Word of God, it will not be a day longer than “seven” years until the Second Coming of Jesus Christ! We know with absolute certainty that the call to **“come up hither!”** As I have said before, it is already baked into the cake of God’s plan. Destiny is assured!

When Jesus' disciples asked what would signal His return, He gave them several signs to watch for. He also taught that the time immediately before His coming would be known as the **“beginning of sorrows”** -(Matthew 24:8), which in English means the *“onset of labor pains.”*

Jesus was saying the signs of His coming would start out as mild pangs spaced widely apart like human labor and then gradually become closer together and more intense, like the birth process, until this final seven-year period of suffering and judgment would culminate in the coming of the Messiah.

Consider the signs that Jesus said would be the prelude to His return and notice how they’ve begun to occur in our time:

False Christs: The past few decades have witnessed a huge upsurge in charismatic leaders claiming to be Christ, including the Moonies' Rev. Sun Moon, the Buddhist Dalai Lama, the Hindu Krishnamurti, the Jewish rabbi Menachem Schneerson, and the Bahais' Baha Ullah, to name a few. Collectively, their followers number in the millions. Jesus replied to them, **“See that none misleads you; for many will come in My name, saying, ‘I am the Christ,’ and will mislead many.”** -(Matthew 24:4,5)

War: War in the original Greek of Matthew 24 is **ethnos**, meaning ethnic or racial war. A recent editorial in 'Time' magazine reported there are presently 67 wars being fought around the planet and most of them are ethnic wars, including the recent slaughter in Rwanda and Bosnia. According to the National Defense Council Foundation, conflicts around the globe have doubled since 1989. **"... you shall hear of wars and rumors of wars..."** -(Matthew 24:6,7)

Famine: The LA Times reported recently that more than one billion people suffer from serious malnutrition, exacerbated in the past months by worldwide drought. More than 35 million people living mostly in the southern states of Africa suffer from acute hunger and are threatened with imminent death. **"There will be famines..."** -(Matthew 24:7)

Pestilence: The rate of infectious diseases has increased 58% since 1980, according to the U.S. Centers for Disease Control. Diseases once considered conquered are now reappearing, sometimes in drug-resistant forms. AIDS has become a worldwide scourge, and viral diseases such as Ebola pose an international threat because of transcontinental flight. **"There will be pestilences."** -(Matthew 24:7)

Earthquakes: The number of dangerous earthquakes measuring 6.0 or greater on the Richter scale has been steadily increasing since the 1950s when there were nine. In the 1960s, there were 13. In the 1970s, 51. In the 1980s, 86. In the 1990s more than 100 such serious earthquakes have already been recorded, according to the 'LA Herald Examiner'. In the past decade earthquakes have been off the chart and occurring in what were once earthquake free zones. **"There will be...earthquakes in various places."** -(Matthew 24:7)

The Seas and Waves Roaring: The Associated Press reports that the most recently completed Atlantic hurricane season produced 11 hurricanes, 8 tropical storms, and \$7.7 billion in damage. Serious flooding has also occurred recently in the U.S., Russia, Japan, Mexico, China, Europe, Korea, and the United Kingdom, according to Barron's. **"There will be bewilderment at the roaring of the sea and waves."** -(Luke 21:25)

Violence: Since 1960 violent crime has increased in the U.S. by 560%, according to FBI statistics, and the number of reported cases of child abuse in the U.S. has risen from 670,000 in 1976 to nearly 3 million in the 1990s. Other nations are experiencing similar dramatic increases in violent crime, reports the 'San Francisco Chronicle'. **"...as the days of Noah were, so shall also the coming of the Son of man be."** -(Matthew 24:37. ("**And God said unto Noah, '...the earth is filled with violence...'**" -(Genesis 6:13.)

Gospel Preached to the Whole World: Christian radio and TV are now reaching into almost every nook and cranny of planet Earth. **"...and this gospel of the kingdom shall be preached to the whole world and then the end shall come."** -(Matthew 24:14)

All of the signs that Jesus said would precede His return seem to be occurring in our time just like He said would happen, but at an accelerating pace.

Other Prophecies Fulfilled:

Other prophecies relating to this seven-year period of judgment, coming from many parts of the Bible, have also begun to be fulfilled:

Israel reborn as a nation in 1948 -(Ezekiel 4:3-6, Leviticus 26:18)

Israel surrounded by hostile Arab countries -(Psalm 83:4-8)

Jerusalem inhabited by the Jews -(Luke 21:24)

Israel negotiates a peace treaty with her enemies -(Daniel 9:27)

Doomsday weapons threaten earth -(Joel 2:3)

Ecological devastation occurs -(Revelation 11:18)

The Roman Empire revives as the European Union -(Daniel 2:40-44)

Heresies become widespread -(2nd Thessalonians 2:3)

Russia rises as a military power -(Ezekiel 38:1-12)

A hole in the ozone layer develops -(Revelation 16:8,9)

TV communications are global -(Revelation 11:9,10)

Cultic activity arises -(1st Timothy 4:1)

Sub-dermal microchips for identification purposes -(Revelation 13:16,17)

Massive increases in wealth occur -(James 5:3)

GATT and World Trade Organization become possible forerunners of a world government -(Revelation 13:7)

Asia possesses resources for a 200-million-man army -(Revelation 9:14-16)

The Euphrates River was recently reported to have dried up -(Revelation 16:12-v 14) and a military highway linking Asia to the Middle East is being completed -(Revelation 9:14)

Knowledge vastly increases -(Daniel 12:4)

Russian and Ethiopian Jews return to Israel -(Jeremiah 23:7,8; Zephaniah 3:10)

The Hebrew language is recovered -(Zephaniah 3:9)

Jerusalem is rebuilt in nine specific directions -(Jeremiah 31:38-40)

Levites and priests train for Temple service -(Ezekiel 43:14,15)

Israel's rainfall increases dramatically (Joel 2:23) and the country becomes fertile and blossoms -(Isaiah 27:6)

Men become more selfish, arrogant, abusive, ungrateful, fierce and treacherous -(2nd Timothy 3:2,3)

Referring to these signs, Jesus said, ***"When these things begin to come to pass, then look up and lift up your heads, for your redemption draws near."*** -(Luke 21:24-28).

If we are approaching that seven-year period that precedes the second coming of Christ - and all the signs indicate we are - the Bible tells us those years of judgment upon the earth will be accompanied by untold human suffering.

But believers in Christ who have sincerely placed their trust in Him can be certain of the redemption to which Jesus referred.

So where does that leave you? Are you one of God's children who have been called to believe in His Son but has rejected each invitation? Where are you going to spend eternity?

Jesus told us that **"God so loved the world that He gave His only Son, so that whoever believes in Him should not perish, but have everlasting life"** -(John. 3:16). But He went on to say that **"...he who does not believe is already condemned because he has not believed in the name of the only Son of God"** -(John. 3:18).

Is it too late for you to find salvation?

Not yet. God designed an offering, His only Son died a miserable death on a cross so that our sins could be blotted out in our Creator's sight and we could be reconciled to Him.

All we have to do is accept His Son as the perfect sacrifice for our sins. By doing this our loving Father promised that, **"Eye has not seen, nor ear heard, nor heart imagined the wonderful things God has prepared for those who love Him"** -(1st Corinthians 2:9).

King Charles' Scandal-Plagued Charity Escapes Criminal Investigation Again, Despite Proof of 'Cash-For-Honors' Scheme



Another day, another UK Royal scandal swept under the rug.

The trouble is brewing at King Charles's Prince's Foundation, a charity that purports to 'provides holistic solutions to challenges facing the world today'.

It also champions 'a sustainable approach to how we live our lives and build our communities', and it runs 'a diverse program of education and training for all ages and backgrounds'.

Despite such lofty aspirations, the scandal-plagued institution is again in the headlines for a 'Cash-for-Honors' scandal involving a wealthy Saudi businessman.

And, once again, the Windsor's can count on the absolute inaction of law enforcement when it comes to them.

The Associated Press reported:

"London police said Monday they would take no action on allegations that people associated with one of King Charles III's charities offered to help a Saudi billionaire secure a knighthood and British citizenship in return for donations."

The Metropolitan Police Service began an investigation into the matter after the Times of London reported that a longtime aide to Charles had suggested the then-Prince of Wales would support a Saudi citizen's request for the honors in return for up to 1.5 million pounds (\$2 million) in donations to the charity, The Prince's Foundation.

The police department declared that it reached its decision after reviewing documents provided by the Prince's Foundation and by the Times, and also consulted with prosecutors before concluding its 'investigation'.

"After careful consideration of the information received as a result of the investigation to date, the Met has concluded that no further action will be taken in this matter," police said in a statement."

Charles' representatives have clarified that 'he wasn't aware of any offers to bestow honors or expedite citizenship in return for donations to his charities'.

"Following the conclusion of its own independent investigation and governance review last year, the charity is moving forward with a continued focus on delivering the education and training programs for which it has been established," the foundation said."

The decision, while predictable given the usual behavior of the UK police regarding the Royals, has sparked a wave of criticism, as you would expect.

'The Guardian' reported:

"Asked about the Metropolitan police decision to take no further action in the cash-for-honors allegation involving King Charles's Prince's Foundation, the author and former

Liberal Democrat MP Norman Baker said wearily: 'I'm not actually surprised. To have taken action would have offended important people in society'."

Author Norman Baker was the one to write to the Met Police in 2021, calling for an investigation after he read reports about a longtime senior aide of Charles offering a Saudi billionaire help to secure a knighthood and UK citizenship in return for hefty donations.

"That offer, made in 2017 by Michael Fawcett, in a letter to Mahfouz Marei Mubarak bin Mahfouz, made it clear the Prince's Foundation (founded by the king, who remains its president) would be "happy and willing" to use its influence to help smooth the way for Mahfouz."

Charles' charities, it is said, operate independently of the monarch in matters of fundraising and governance.

"And yet it is not the only embarrassing episode involving the king's charities and wealthy donors. Last year, the 'Sunday Times' reported that between 2011 and 2015 the Prince of Wales Charitable Fund accepted 3m euros in cash stuffed into a suitcase and a Fortnum & Mason carrier bag from a billionaire Qatari sheikh."

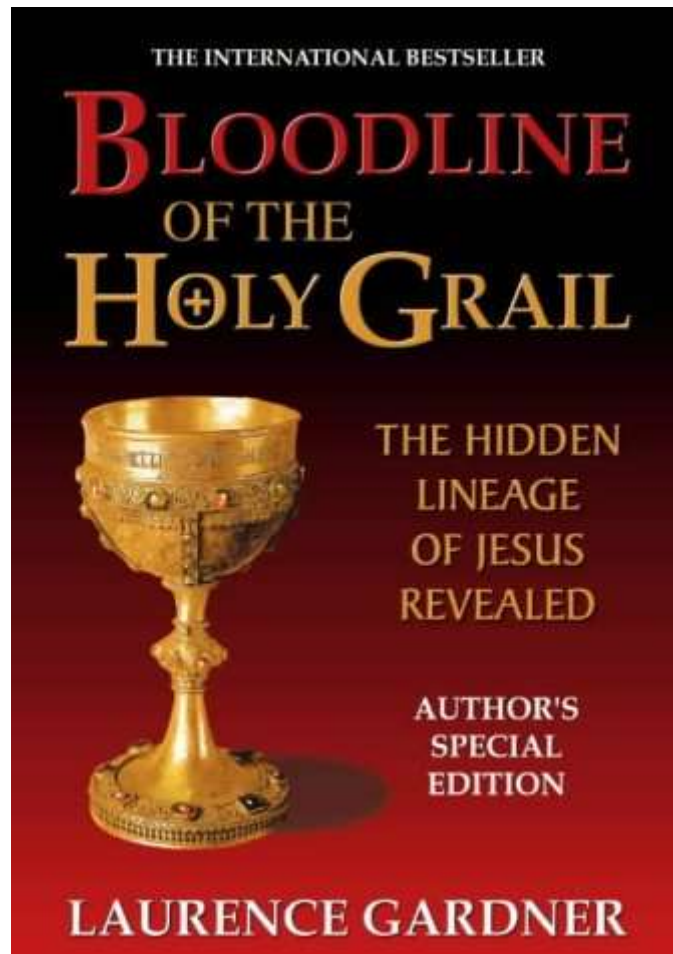
The last two chairs of the Prince's Foundation resigned in disgrace: Douglas Connell resigned in 2021 after a £100,000 donation from a wealthy Russian donor raising doubts over the provenance of the cash. A mere two months later, Fawcett resigned in the wake of the cash-for-honors allegations.

This comes as the new Monarch tries to impose his style amid a row with his brother Prince Andrew, in a constant siege over his Jeffrey Epstein ties. As this recent scandal is being swept under the rug, it should cause us to review what we know about Charles' character.

"The king will do as he pleases. He will exalt and magnify himself above every god and will say unheard-of things against the God of gods. He will be successful until the time of wrath is completed, for what has been determined must take place. He will show no regard for the gods of his fathers or for the one desired by women, nor will he regard any god, but will exalt himself above them all. Instead of them, he will honor a god of fortresses; a god unknown to his fathers he will honor with gold and silver, with precious stones and costly gifts. He will attack the mightiest fortresses with the help of a foreign god and will greatly honor those who acknowledge him. He will make them rulers over many people and will distribute the land at a price" -(Daniel 11:36-39).

These four verses of Daniel tell us a number of very important facts about what kind of man the Antichrist will be. A month before Prince Charles coronation the media, particularly Apple© Siri News has flooded readers with the exorbitant coverage of old "sausage fingers". I have done my assessment below from a wide range of reported

news stories compiled from years of study beginning in 1996, with the first edition of Laurence Gardner's book *'Bloodline of the Holy Grail'*:



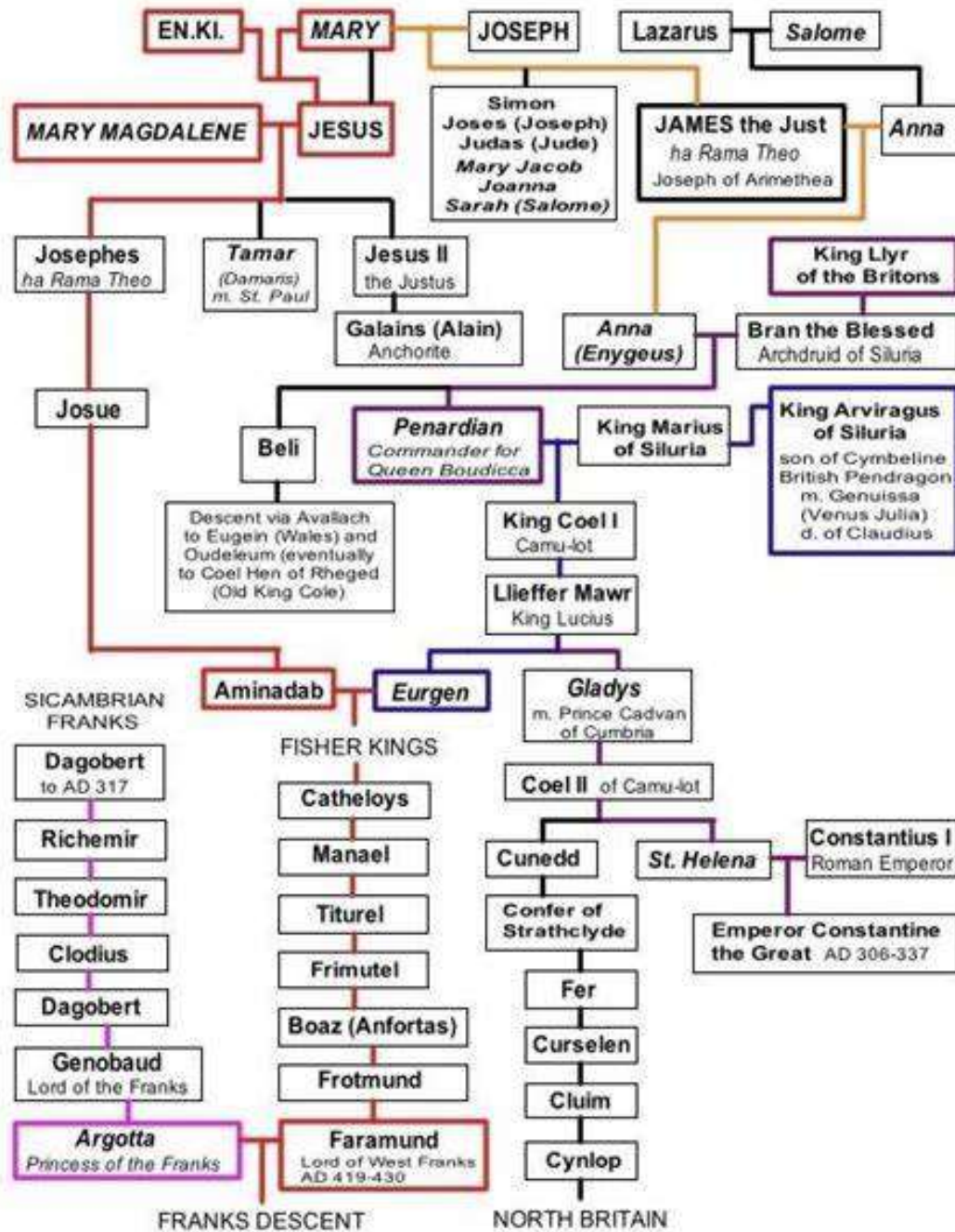
- He is arrogant and self-willed.
- He never stops talking and boasting about himself. Daniel 7 makes this point emphatically when it emphasizes the *“little horn”* that makes big boasts. The Antichrist will be the ultimate egomaniac.
- He is a blasphemer.
- He is deceptive, ruthless, and utterly devoid of integrity.
- He is outspoken in his public opposition to God.
- He will initially be very successful.
- His reign is limited by God. The *“time of wrath”* in verse 36 refers to the last half of the seven-year Tribulation period. Note that even though the Antichrist has enormous power, he can only do what God permits him to do.
- He rejects his own spiritual heritage. Verse 37 says he has no regard for the *“God of his fathers.”* This expression has led some to think he must be Jewish. However, Daniel 7 says he comes out of the fourth beast, which represents the Roman Empire, and Revelation 13 pictures the Beast (a symbol for the Antichrist) arising out of the sea of the Gentile nations. Whatever spiritual background he comes from, he rejects it totally.

- He opposes all organized religion.
- He will set himself up as a god to be worshiped. This is the “**abomination of desolation**” that takes place at the mid-point of the Tribulation when he will stop the sacrifices in the rebuilt Temple in Jerusalem and will proclaim himself to be God (see 2nd Thessalonians 2:1-3).
- He has no regard for the desire of women. This ambiguous phrase in verse 37 has been interpreted in various ways. It may mean that the Antichrist has no natural desire for woman, i.e., that he is homosexual. That shocking thought helps us understand the evil forces behind the modern Gay Rights movement. If this interpretation is true, it means that the way is being paved for the Antichrist to rise to power as a practitioner of moral perversion.
- He worships military might. Verse 38 mentions a “**god of fortresses,**” the only time this expression occurs in the Bible. His bloodthirsty character allows him to ruthlessly kill millions of people in his drive for world domination.
- His power will come from Satan. This explains the “**god unknown to his fathers**” in verse 38. He will deceive the world with the help of Satan who will empower him to work miracles that will astound millions.
- He will conquer many nations.
- He will richly reward those who follow him. For a short period of time he will appear to be the savior the world has yearned for. But the “**Man of Peace**” will soon reveal his true character!

In many ways Laurence Gardner’s book is superior to Tim Cohen’s book, ‘*The Antichrist and a Cup of Tea*’. The late Laurence Gardner you might say was Prince Charles biographer who fabricated the huge lie that Jesus of Nazareth did not die on the cross but was secreted away with Mary Magdalene. The story line has Jesus and Mary fleeing across North Africa in the dark of night, escaping to the south of France where they lived and had three children. The below lineage chart on the next page then became the predecessor of the Merovingian blood lines of European Royalty.

In previous segments and articles on Prince Charles we find that Charles lineage is presented as the descendant of King David. There is no definitive proof that Prince Charles is a descendant of King David, the Biblical king of Israel and Judah. However, some royals, including Prince Charles himself, have claimed or implied that they have a lineage from the throne of David. One possible source of this claim is a letter that Charles the Great, or Charlemagne, wrote to the Caliph of Baghdad, asking for a Jewish woman who could carry the seed of David.

I was between final exams at Asbury Theological Seminary and made the quick trip into Lexington to check out what was new in the religion/philosophy section and as I was about to leave, the cover of the book grabbed my eyes. I took a copy and sat in a comfortable chair and began to take a look at what it was about. Needless to say, I bought a copy and so my study of Prince Charles took off and has grown exponentially.

"In an article <17bf2bcf.02111...@posting.google.com>, posted to alt.gossip.royalty and stamped at '16:17:14' on 'Sun, 17 Nov 2002', Anne Smith <wa...@mail.com> writes: I have received information from a very reliable source that the tapes at the center of the St James Rape scandal allegedly contain evidence that Prince Charles had a homosexual relationship with Michael Fawcett. The allegation is made by George Smith who recalls walking into a room within St James Palace and catching the Prince of Wales and Michael Fawcett in a sexual act. b) the servant involved in the 'incident' (i.e. sex) between 'a member of the royal family and a servant' was NOT identified as being the 'alleged rapist' of George Smith, nor as being 'a senior adviser to Prince Charles', nor with any of the other phrases used to mean 'Michael Fawcett'. The publication of the idea that the servant who was 'caught' in the 'potentially highly damaging' incident with the member of the royal family was Michael Fawcett came LATER. And one of the first papers that published it - perhaps the very first - was the '*Scotsman*', owned by the same people (the Barclay brothers) who own the London Ritz, which is in a business partnership with 'Prince' Charles.

I would observe:

1) clearly an effort has been made to take the spotlight off of the other rape, and for that matter off of the use of male prostitutes ('rent boys', i.e. male child prostitutes) at St James's Palace and Buckingham Palace. Despite the fact that this other rape was investigated by the police, no editor has printed any details about that investigation, nor have they printed, as far as I am aware, any official statement by police or CPS as to

why no charges were brought.

As damage limitation, a spotlight is allowed to play on one particular victim only, namely Mr. Smith, and attempts are then made to assassinate his character. Yes he appears to have convictions for drunk driving, and to have been sectioned, but no media commentator has made the point that he does not appear to have what the authorities would call a record of dishonesty (e.g. any conviction for theft, or any record of making statements in court that a jury decided were false).

The ludicrous story has been printed that Mr. Smith is in the habit of imagining at every opportunity that men leap out from behind bushes and rape him. Of course, it could well have happened that the Windsor's *did* send men to rape him, in order that he would then tell the police and not be believed. Anyone who thinks that's highly improbable should think about the murders of Hilda Murrell, Stephen Milligan, James Rusbridger, and of a large number of people working at Marconi and the Royal College of Military Science - many of whose murders involved sexual perversion.

But anyway, as far as any rape allegations are concerned, the media spotlight is firmly on the rape of Mr. Smith, when earlier reports indicated that at least one other rape occurred, and was known to the police, and - an incident was known about involving a member of the royal family and a servant - a sexual incident that could do irreparable damage to the monarchy. It does not take much to speculate that this was the RAPE of a servant by a member of the royal family.

The scandal concerning the gifts being sold is merely an attempt by the Palace to deflect attention away from this revelation that has the potential to bring down the Monarchy. That said, my thoughts suggest that law enforcement in the UK will do nothing but to turn a blind eye and to cover-up Prince Charles homosexual behavior. As the king of the UK or British Commonwealth of Nations we can look for him to skate on such despicable unnatural behavior.

Here is a quick review or summary of some 48 Bible prophecies the Antichrist will fulfill:

1. The antichrist will be a man - Daniel 7:24-25

2. He will confirm a covenant for 7 years - Daniel 9:27

Now also, this does not mean that he creates this covenant. The word here for "confirm" is Strong's #1396 **gabar** (gaw-bar'); a primitive root; to be strong; by implication, to prevail, act insolently: KJV-- exceed, confirm, be great, be mighty, prevail, put to more [strength], strengthen, be stronger, be valiant. The antichrist will strengthen a covenant for a 7 year time span. Now this could be an existing covenant (like the Jerusalem Covenant) or a new covenant drawn up at that time.

3. He will rise from among 10 kings - Daniel 7:8

This 10 nation union will be a revived Holy Roman Empire - Daniel 2:44

4. He will uproot 3 kings from the original 10 kings to gain political power - Daniel 7:8

5. His 10 nation union will merge into a world government which he will dominate - Revelations 13:1-2

Now this also, could refer to several things. First, the 10 nations could merge into an EXISTING world government, such as the UN. Or it could for a new world government, much like the UN. Or, this 10 nation confederation could be something like the new 10 nation common stock market. A union like this would definitely rule the world, without having a "seat" of power. Whoever controls the money controls the globe.

6. He will ascend to power on a platform of peace. By peace, he will destroy many - Daniel 8:25

7. He will be promoted and exalted by a miracle working religious partner (false prophet) - Revelations 13:11-12

8. He was, and is not, and yet is - Revelations 17:8

More than likely this is referring to political power. The antichrist will have ruled, but then be taken out of power. Only to rise back up again to power as the head of the One World Government.

9. The world government over which he rules will be a red (communistic or socialistic) government - Revelations 17:14

10. The antichrist will be preceded by 7 kings or rulers. He will be the 8th king. He will also be "of" the 7 - Revelations 17:11

Now this scripture has many different ways it can be viewed. The word "goeth" in the scripture is Strong's #5217 **hupago** (hoop-ag'-o); from 5259 and 71; to lead (oneself) under, i.e. withdraw or retire (as if sinking out of sight), literally or figuratively: KJV-- depart, get hence, go away. So we see that he will withdraw or retire from sight. But will rise back up again to power. Now this could be taken as to mean 7 kings. Or this could be taken as 7 World Governments that have ruled. So far there have been 6. 1. Egypt.

2. Assyria. 3. Babylon. 4. Medo-Persia. 5. Greece. 6. Rome

11. He will have a mouth speaking great things. Very boastful - Daniel 7:8

12. His look will be more stout than his fellows - Daniel 7:20

The word "stout" means #7227 **rab** (rab); by contracted from #7231; abundant (in quantity, size, age, number, rank, quality): KJV-- (in) abound (-undance, -ant, -antly), captain, elder, enough, exceedingly, full, great (-ly, man, one), increase, long (enough, [time]), (do, have) many (-ifold, things, a time), ([ship-]) master, mighty, more, (too, very) much, multiply (-tude), officer, often [-times], plenteous, populous, prince, process [of time], suffice (-lent). So this can have several meanings. It could mean one of the following: the antichrist will be larger in size than everybody else, will be older than everybody else, will have more of a "following" than anybody else, is a higher military or political rank than anybody else, or is more qualified than anybody else. Whatever this verse is speaking about, it is obvious when you look at him.

13. He will have a fierce countenance - Daniel 8:23

14. He will understand puzzling things - Daniel 8:23

15. He will cause craft to prosper - Daniel 8:25

It is interesting to note the definition of the word "craft" here. It is Strong's #4820 **mirmah** (meer-maw'); from Strong's #7411 in the sense of deceiving; fraud: KJV-- craft, deceit (-ful, -fully), false, feigned, guile, subtly, treachery. No wonder, for the Bible says that he is the father of lies. So his policy or his success will make it possible for his

deception of the world to prosper. God said that if you do not believe the truth, that he would send strong delusion that you should believe a lie.

16. He apparently assumes world dominating power 3-1/2 years after he confirms the covenant. He then will continue to reign for 42 months - Revelations 13:5

17. The Abomination of Desolation is the event that signals the beginning of this final 42 months - Daniel 9:27

It is interesting to note, that many scholars believe that at the Abomination of Desolation is when Revelations 12:7-10 occurs. At which point the Antichrist becomes "possessed" by Satan himself and then forces the Mark or death upon everybody.

18. He opposes God – 2nd Thessalonians 2:4

19. He will speak marvelous things against the God of gods - Daniel 11:36

20. He will exalt himself above all that is called God – 2nd Thessalonians 2:4

21. He will sit in the temple of God – 2nd Thessalonians 2:4

22. He will claim to be God (or an incarnation of God) – 2nd Thessalonians 2:4

23. He will take away the daily sacrifices from the temple - Daniel 11:31

34. He will give great honor to the God of forces, with gold, silver, jewels, etc. - Daniel 11:38

35. He will prosper in everything that he does - Daniel 8:24

36. He will not regard the God of his fathers - Daniel 11:37

37. He will not regard the desire of women - Daniel 11:37

It is interesting to note here that most people think that he will be a homosexual, which could be. He will place limitations upon children being born. Similar to what was being done in China. Why? 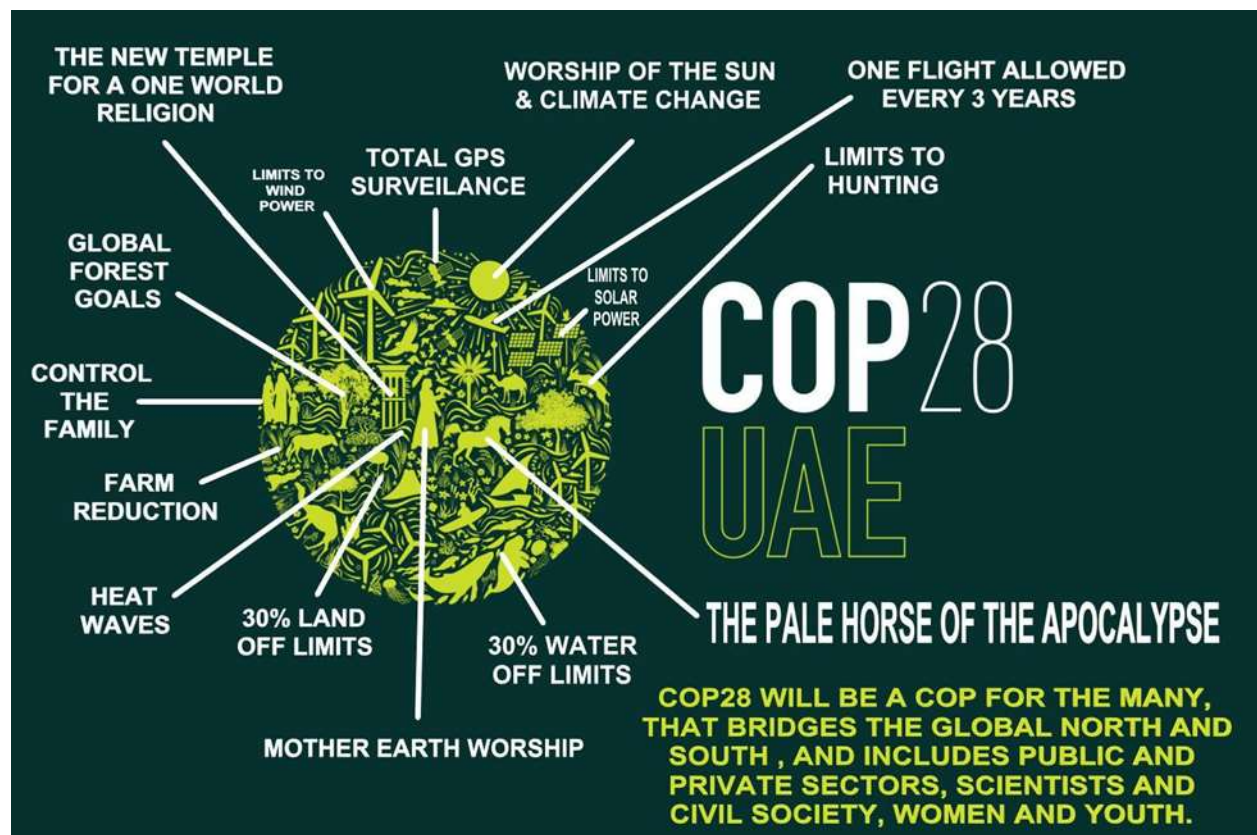
are powerful charm rituals guaranteed to "charm" anyone not saved by the Blood of the Lamb!

Exclusive: Ambassador Gideon Behar shares details about Israel’s participation at COP28

Israel’s special envoy for climate change and sustainability tells us that COP28 is an opportunity to promote climate innovation and solutions.

With roughly four months left until COP28, tell us about Israel’s upcoming participation at the climate change forum. What will be the key highlights at the Israeli pavilion/stand? I want to say first that we attach great importance to COP28 and our wish is for the success of the summit under the leadership of the COP president designate Dr. Sultan Al Jaber. I believe COP28 will be a very significant climate change summit.

Our pavilion will concentrate on climate innovation in different areas, such as water, agriculture, renewable energy and nature-based solutions, alternative proteins, and the usage of big data and artificial intelligence in combating climate change.

We are also planning to have a large number of events at the pavilion to create cooperation and new projects – regionally and internationally. Israel has quite a large delegation, as the prime minister and the president have already confirmed their participation in the COP, and we anticipate the participation of a few ministers.

We see COP28 as an opportunity to promote climate innovation and solutions to the world, both in the fields of adaptation and mitigation. Climate technology and innovation have a very important role to play in tackling the climate crisis, and this is what we would like to show in our pavilion, both in the exhibition and at the events.

This will also be showcased through the participation of startup companies and experts from the academic and government sector.

Israel is incorporating sustainability in its education system as part of its Agenda 2030 vision. Tell us more about other sustainability initiatives that Israel is implementing at home and abroad.

Indeed education is a very important component and a part of the main strategy to combat the climate crisis, because the crisis will remain with us for decades to come, and the children of today will be the policymakers and CEOs of tomorrow, and they must be aware of the reasons for climate change and how to prevent it.

We have introduced a special education program in Israel for all ages. School children, regardless of their age, are now receiving education and information on the climate crisis.

Also, the academic sector is putting lots of effort into climate education, practically all of the universities and high education institutions in Israel have special programs and schools on climate change, so you can study climate change and sustainability in every university in Israel.

We are also in the process of preparing ourselves for the climate crisis with better adaptation. This is a broad process executed by the government – every ministry has to prepare its adaptation plan, based on a government resolution.

Many private sector companies and startups are also active in climate change, and I can tell you that practically every day there is a conference or an event in Israel on climate change, so the country is gearing up for action in this field.

What does the hosting of two consecutive climate change forums (COPs) in the Middle East mean to Israel?

Hosting COP28 in the UAE represents a unique opportunity for Israel, as both countries share close ties in tech collaborations, and will be able to leverage each other's expertise to promote climate action across the region.

The fact that two consecutive climate change forums are happening in the Middle East brings the focus to the climate challenges that the region faces in climate change. It is very important to attract attention to what's happening in the Middle East and work towards building regional resilience, and in that sense, the fact that two COPs are happening in the Middle East is very important.

How do you plan to leverage COP28 to expand Israel's collaboration with the global community to achieve net zero carbon emissions target by 2050?

Israel, along with many other countries, is committed to the net zero target by 2050. We think that moving forward with energy efficiency and moving towards more use of renewable energy is essential, and we are collaborating with many countries in the world in that regard.

The Israeli private sector is very active in promoting solutions such as energy efficiency, and renewables such as solar and wind in many countries.

We know also that this probably won't be enough, and we will have to capture carbon from the atmosphere or the sea to reach net zero by mid-century. There is more and more investment and research in Israel in carbon capture and storage technologies, and we are looking forward to collaborating in that regard with the UAE and other partners, as we consider this to be a significant strategy for all.

Climate funding-related constraints are a major barrier to ESG implementation. What is Israel's stance on climate funding for developing countries or the global south?

We consider climate finance as an important mechanism for assisting developing countries in adapting to climate change and building resilience to the climate crisis, and indeed the international community must fulfil its promises and allocate funds equivalent to 100 Billion dollars in climate finance per year, and increase those numbers.

We see how climate-related disasters are affecting the world, especially developing countries, and there must be greater allocation in finance for adaptation; since climate change is going to stay with us for generations to come, preparedness and adaptation are of the essence.

We also think that there should be more finance coming from the private sector and international organizations such as banks for development.

What are the lessons that other countries can take away from Israel's innovation in renewable energy, agriculture, water stewardship and environmental protection?

I think that the main lesson here is innovation. One asks himself what can be done to create a better world, a better future for all of us. and we see how the private sector and the startups are working in Israel, I can tell you that Israel is leading in the number of startups opened in the world per capita, and today approximately one in seven of every new Israeli startup is in the field of climate tech and climate innovation.

The government is investing more in climate innovation. We see also how the private sector is doing more and investing more, and we see also how venture capital is coming and looking for opportunities in Israeli startups.

There is a great interest in the region and the world, in applying solutions that are coming from Israel.

Most of these excellent solutions are scalable and affordable in many countries. I think that in a time of urgency that we are now facing with the climate crisis and we see disasters everywhere in the world, we must put more emphasis on solutions – the solutions must be practical, affordable, scalable, and immediate, and they exist in Israel. We are looking forward to sharing them with the world and in the region, and to working closely together with the United Arab Emirates which has a unique spirit of innovation and long-term vision. We are positive that this team effort, bilaterally, regionally, and internationally, will help us all move forward in tackling the challenge of climate change. How is technology driving sustainability?

We must make sure that technology is a means that supports our planet, the climate and nature.

Many of today's technologies are using today is damaging the climate and nature, so we must see how we can convert the current existing technologies and economic mechanisms to work in favor of a sustainable world and climate. We think that there are significant and viable opportunities for countries and companies to work together on that.

AFRICAN CLIMATE AND ENVIRONMENT MINISTERIAL MEETING DISCUSSES COP28.

Sultan Al Jaber, COP28 President-Designate, spoke at the African Ministerial Conference on the Environment in Ethiopia. He highlighted his Action Plan to fast track the energy transition, fix international climate finance, focus on people's lives and livelihoods and underpin everything with full inclusivity. Discussions also focused on preparing for the upcoming Africa Climate Summit in Nairobi.

IOM GATHERS AFRICAN YOUTH TO DISCUSS CLIMATE-INDUCED MIGRATION.

Over 70 young people from 37 African countries gathered in Nairobi to discuss climate-induced mobility as well as opportunities for youth engagement on migration, environment and climate change across the continent. The youth engagement forum, organized by the International Organization for Migration (IOM), feeds into a 'Global Youth Statement' ahead of the Africa Climate Summit.

WORLD-LEADING ECONOMISTS SET OUT NEXT STEPS TO REFORM CLIMATE FINANCE.

A meeting of world leading economists and finance leaders convened by the COP28 Presidency has delivered consensus on the next steps towards establishing a new framework for international climate finance and to drive progress at COP28 and beyond. Particular areas of focus include addressing debt distress in vulnerable countries, and the role of the private sector.

BRAZIL INCREASES PUSH FOR CLIMATE LEGISLATION AS COP28 APPROACHES.

Brazil's government plans to pass several energy transition-related bills, aiming to enhance the country's decarbonization efforts ahead of COP28. The legislative package includes proposals involve creating a carbon market, standardizing offshore wind regulations, and regulating green hydrogen. President Lula has also pledged to halt illegal deforestation in the Amazon rainforest by 2030.

REPORT: GULF AND MIDDLE EAST DECARBONIZATION STRATEGIES AHEAD OF COP28.

The Center on Global Energy Policy of Columbia University has published an analysis trying to answer the question of how Gulf and MENA states can decarbonize their fossil-fuel-dependent domestic economies and reduce or reconfigure their hydrocarbon sales, which bring in the bulk of government revenues and export earnings.

PACIFIC SMALL ISLANDS DEVELOPING STATES HOLD HIGH LEVEL CLIMATE DIALOGUE.

Fiji is urging world leaders on the need for investment funds to assist in protecting food systems, agricultural productivity and water supplies. Fiji's Prime Minister Sitiveni Rabuka said in his opening statement at the Pacific Small Islands Developing States High Level Dialogue on Climate Change (21-22 August) that "we have to be more self-reliant".

OPINION: ONLY GENUINELY CLEAN HYDROGEN CAN HELP SOLVE THE CLIMATE CRISIS.

Former Australian Prime Minister Malcolm Turnbull, who also chairs the Green Hydrogen Organization, writes that the notion of "clean" or "low carbon" hydrogen has become ubiquitous and a subtext for promoting fossil-fuel derived hydrogen with emissions which are still too high for our planet to cope with. He argues that "at COP28 we need to rally behind all hydrogen trending towards near zero emissions by 2030."

POLITICO: WEALTHY OIL NATION LAYS GROUNDWORK FOR 'EYE-POPPING' CLIMATE FUND.

The UAE is considering creating a multibillion-dollar fund to spur clean energy investments across the world that it plans to unveil at this year's UN climate talks in Dubai, Politico reports. According to the news source, a G-7 government official said envoys from the oil-rich Mideast nation had privately mentioned the idea of a fund of at least \$25 billion.

GABON LUE BOND' SWAP RAISES HOPES FOR AFRICAN DEBT-FOR-NATURE DEALS.

A \$436 million "debt-for-nature" swap by Gabon to fund marine conservation has backers hoping for more such money-saving environmental deals, but some investors still see room for improvement in the increasingly-popular transactions. Concerns remain around questions of the enforceability of conservation commitments and the consequences of a potential default.

'SILENT THREAT': BAHRAIN TO BUILD WALLS AGAINST RISING SEA.

By next year, the small Gulf state will begin building its coastal defenses against sea levels that have begun advancing, by widening beaches, constructing taller sea walls and elevating land. "Bahrain is vulnerable," Mohamed bin Mubarak bin Daina, Bahrain's oil and environment minister and special envoy for climate affairs, said in an interview. "The main threat is a silent threat, which is the sea level rise."

INDIA HAS AGREED ON THE OVERALL THEME FOR ITS COP28 COUNTRY PAVILION.

The current theme of India's G20 presidency, "Vasudhaiva Kutumbakam", will also be the theme for India's country pavilion at COP28. It translates to "ONE EARTH, ONE FAMILY, ONE FUTURE." The theme is drawn from the ancient Sanskrit text of the Maha Upanishad, which affirms the value of all life - human, animal, plant, microorganisms - and their interconnectedness on Earth and the universe.
