- Did you answer yes to these? What's more important is whether your life shows it. Yes, we are all sinners and fall short, but most of our gut reactions will reflect what we deep-down, honest-to-goodness believe to be real and true.

Churchianity religion prevails with the other 90% and so have fractional or bifurcated understandings of their world. Churchianity is nothing more than idol worship. A Christian worldview (also called Biblical worldview) refers to the framework of ideas and beliefs through which a Christian individual, group or culture interprets the world and interacts with it. Christians need to understand the enemy. We *must* know who we are fighting against, what their characteristics and strategies are, and the immense threat they pose to the true people of God. As Paul so poignantly said:

"For we do not wrestle against flesh and blood, but against the rulers, against the authorities, against the cosmic powers over this present darkness, against the spiritual forces of evil in the heavenly places" -(Ephesians. 6:12).

6. There will be a world war so bloody that the blood of those killed in battle will flow for two hundred miles up to the bridle of a horse in the valley of Jezreel. This will be the Battle of Armageddon. -(Revelation 14:20).

7. All told, during the Great Tribulation, as many as half of all the people on the earth will be killed. Now, do you see why God refers to the Rapture as the ‘blessed hope’? Because the Tribulation to come is so horrible to contemplate!

But that means we are gone and will escape everything, right? Yes, exactly, we will miss every part of the TRIBULATION, but we will probably go through some of the worst

days we have ever seen before it starts. Events in the near future, into fall are screaming Great Tribulation just ahead. Frankly, there is no need to speculate about the End Times; they are here and now. Like the ocean fog that stealthily rolls into the sleepy sea side communities as dusk befalls the looming mandates of COP28 are being unveiled for all to see and react to in the process.

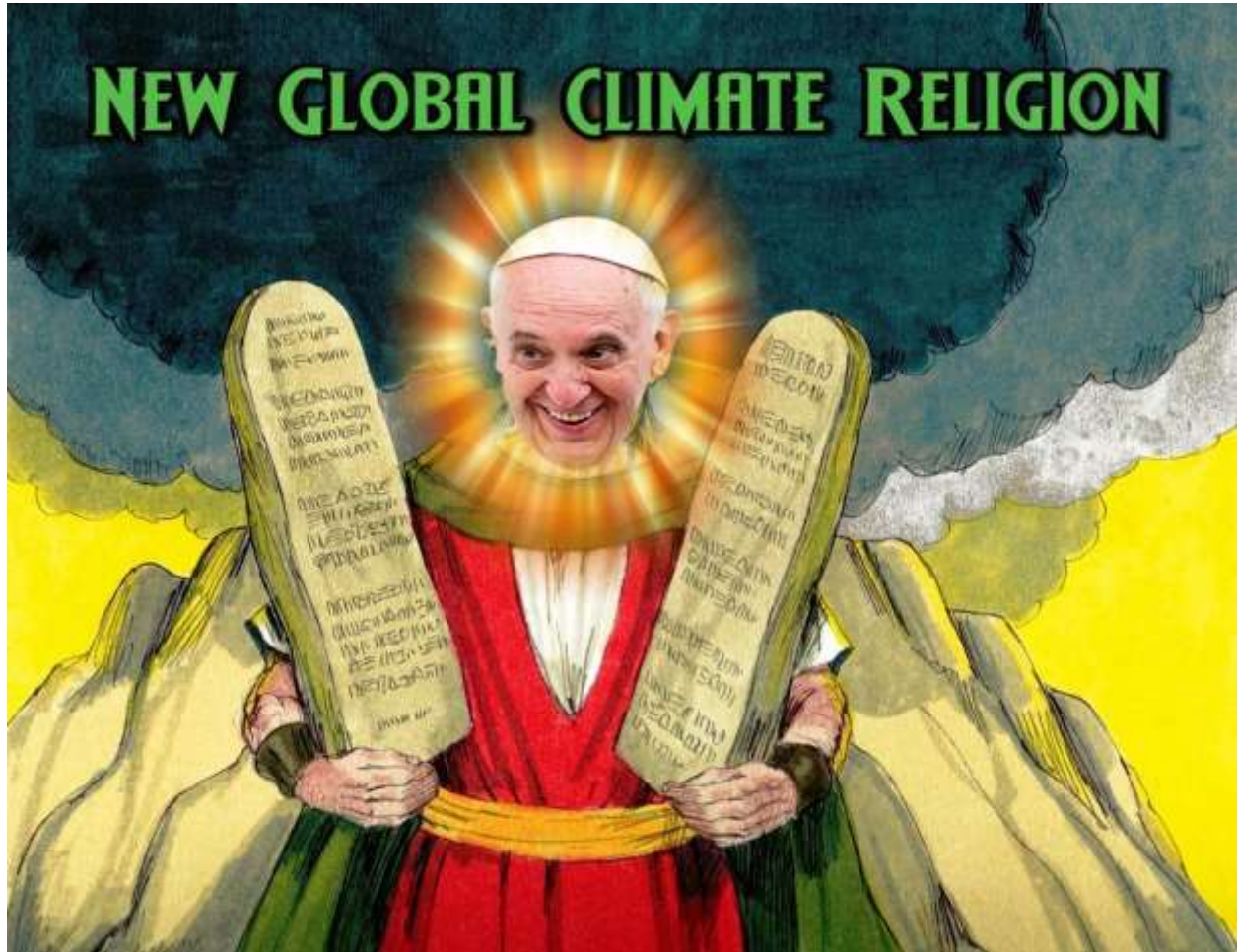
The Interfaith Center for Sustainable Development (ICSD) is a multi-faith organization that is committed to assisting the different churches transition by helping them discover the connection between religion and ecology. They operate globally in Africa, the Middle East, North America, and Europe.

Due to their conviction that only religion can affect change in people, the ICSD believes that the COP27 will be ineffective without the participation of religion. Notice what the Interfaith Center for Sustainable Development published:

Between November 6th and 18th, 2022, the UN Climate Conference COP 27 took place on the Sinai Peninsula, in Sharm El Sheikh, Egypt. Religious communities and religious leaders have a key role to play in addressing climate change and climate justice, which requires deep transformation within society. The knowledge of what changes are critically needed to diminish long-term harm to the planet is readily available. However, bringing about change in action demands deeper changes in attitude, a change of heart. This has been the domain of religions for millennia. Religions are sources of inspiration for the transformation of heart and the ensuing changes of attitude.

Now consider how the ICSD must change the churches before changing society:

“We come to Sinai in a movement of repentance and quest. We seek a new vision for humanity and its endangered existence, and we seek to receive and amplify a message of life-sustaining living and habits that humanity needs to hear today. In this spirit, the project partners will bring together premier religious leaders from the world’s major religions to put forth a prophetic interreligious call to action: “Ten Universal Principles for Climate Justice.””



The Interfaith Center for Sustainable Development (ICSD), together with partners, is organizing four multifaith climate events at COP 27, from Monday, Nov. 14 through Wednesday, Nov. 16, 2022. The events incorporated concrete examples of how religious communities are actively meeting the climate challenge, and feature concrete initiatives that translate the broader spiritual practices into action.

The ICSD is not alone. The World Council of Churches (WCC), the largest Christian worldwide ecumenical organization, also published a statement of solidarity with

COP27. They called it the “Statement on the 27th Conference of the Parties of the UN Framework Convention on Climate Change (COP27).” The document states in part:

“WCC representatives are joining ecumenical, interfaith and civil society partners at the 27th Conference of the Parties of the UN Framework Convention on Climate Change (COP 27) in Sharm El-Sheikh, Egypt, in urgent advocacy for change, for metanoia (change).”

“We recall and affirm the WCC 11th Assembly’s statement on The Living Planet: Seeking a Just and Sustainable Global Community”, and the appeals it expresses to governments and to member churches and ecumenical partners.”

“We share the sense of urgency in the UN Secretary-General’s own impassioned words: ‘We are on a highway to climate hell with our foot on the accelerator. Our planet is fast approaching tipping points that will make climate chaos irreversible’.”

“COP 27 is a critical occasion for governments to together re-envision, develop, commit to and implement a roadmap towards a fossil fuel-free, post-growth, equitable and sustainable tomorrow, and to tackle the greatest existential challenge to life on the planet.”

“We reiterate the call from the 11th Assembly for all member churches and ecumenical partners around the world ‘to give the climate emergency the priority attention that a crisis of such unprecedented and all-encompassing dimensions deserves, both in word and deed’, and to ‘take all such actions as we are able in our own contexts to help drive a just transition to a sustainable future’.”

The ICSD and the WCC are international religious organizations that are currently mobilizing the churches to take action. They are creating a world-wide mission that supersedes all other missions. They are calling on churches to unite with political groups and governments to push for a universal eco-religion. COP27 is tapping into the power that the churches wield.

The new “climate change” religion is seeking to connect religion and ecology. What makes this so enormously dangerous is that millions of Christians are being turned away from the gospel of Jesus Christ. Many believers have abandoned God’s truth completely. Their new fight is not against sin but against fossil fuels. They have also embraced the new morality of “*ecocide*.”

The new eco-preachers are teaching their congregations that climate change is the new gospel truth. Ecology has taken the place of theology. This seeks to bring religion and nature together. The idea that the natural world is holy and that we need to acknowledge the interdependence of humans, nature, and all of creation has been primarily promoted by Pope Francis. Today, this is transforming churches. In its quest to create the ideal sustainable environment, the modern church has rejected Biblical truth

and embraced the sanctity of a green earth spirituality. Truly, the climate change movement has become the new great struggle for redemption.

The flock is being betrayed by misguided shepherds. Those of us who, by God's grace, can see what is happening must make every effort to help those who cannot see how their faith is under attack. The only safe path for us today and the only antidote to everything we are seeing is to abide by the unchangeable truths of our historic faith as revealed in the Word of God. Media coverage of C40 Cities' goals has been relatively sparse until recently. The few media personalities and news outlets who have discussed it have been heavily attacked

by the corporate “fact-checkers.” In a “fact check” aimed at conservative commentator Glenn Beck, [AFP Fact Check](#) claimed that the banning of meat and dairy and limits on air travel and clothing consumption were actually “*not policy recommendations.*”

AFP quotes a paragraph from the original [‘The Future of Urban Consumption in a 1.5°C World’](#) report, which reads, “*This report does not advocate for the wholesale adoption of these more ambitious targets in C40 cities; rather, they are included to provide a set of reference points that cities, and other actors, can reflect on when considering different emission-reduction alternatives and long-term urban visions.*”

But this paragraph, likely included in the report as a liability in the case of pushback, seems to directly contradict the [meaning](#) of “target,” which in this context can be defined as a “*desired goal.*” The target of eliminating meat, dairy, and private vehicles by 2030 is “*based on a future vision of resource-efficient production and extensive changes in consumer choices,*” the report notes — something its authors clearly hope to bring about. If these were not their goals, they would not have labeled them “*ambitious targets.*” The dystopian new world order is a menu for depopulation!







The so-called “fact-checker’s” insistence that C40 Cities’ explicitly stated climate goals are somehow insincere is even more unconvincing, given that we are watching them start to unfold right now in real-time. This year, in lockstep with C40 Cities’ 2030 aims, New York City Mayor Eric Adams [announced](#) that the city will place caps on the amount of meat and dairy served by city institutions, such as schools and prisons. Meanwhile, the U.K. has [banned](#) the sale of new gas-powered vehicles after 2030, and [France](#) has banned short-haul flights “to cut carbon emissions.”

In 2020, the World Economic Forum (which promotes C40 Cities on its website) introduced “The Great Reset,” which seeks to use the Covid-19 pandemic as a point from which to launch a global reset of society to supposedly combat climate change. This reset, however, has far more to do with social control than it does with the climate. If globalist leaders truly cared about the environment, they wouldn’t be chartering private jets or owning massive, energy-consuming mansions on the coast in California, which, by climate fanatics’ own calculation, will soon be underwater.

As the WEF plainly stated in a [2016 promotional video](#), by 2030 “*You’ll own nothing, and you’ll be happy.*”

Right now, hedge funds and private billionaires are buying up residential homes and farmland all over the world. At the same time, unrealistic zero-emissions policies are impoverishing Westerners and annihilating the middle class, which is fueling reliance on centralized government. Such intentional steps backward also, ironically, harm the earth because wealthier nations are proven to have cleaner environments and put less strain on natural resources.

Climate activists are also advocating for “*climate lockdowns*,” in the same way there were Covid lockdowns. Rutgers University in New Jersey is doing the same. **[Do not comply.]**

[New York hospital reinstates mask mandate, COVID testing for all incoming patients amid virus uptick](#) | 17 Aug 2023 |

Upstate University Hospital in Syracuse, N.Y., reinstated a mask mandate August 17 amid an uptick in staff out sick with COVID-19 and an increase in patients testing positive, according to local news outlets. "Effective immediately, mandatory masking is required by all staff, visitors, and patients in clinical areas of Upstate University Hospital, Upstate Community Hospital, and ambulatory clinical spaces, according to a memo sent to staff and obtained by [Syracuse.com](#). [Lionsgate Reinstates Mask Mandate in Parts of Santa Monica Office Following Covid Outbreak](#) | 21 Aug 2023 |

Amid rising Covid cases in Los Angeles, Lionsgate has brought back the mask mandate for nearly half of the company's employees at its flagship office at 2700 Colorado Ave. in Santa Monica. The policy change was announced internally by Sommer McElroy, Response Manager for Lionsgate/Starz, in an email, a copy of which was obtained by Deadline. Implemented in response to several employees recently testing positive for Covid, it involves a mandatory mask mandate effective immediately and until further notice for the 3rd and 5th floors of the five-story building, the email said. *"Employees must wear a medical grade face covering*

(surgical mask, KN95 or N95) when indoors except when alone in an office with the door closed, actively eating, actively drinking at their desk or workstation, or if they are the only individual present in a large open workspace," McElroy said in the memo. **[Do not comply.]**

[Biden Regime to Push for Nationwide Updated COVID Booster Shots This Fall in Response to New Wave of Infections](#) | 21 Aug 2023 | The Biden regime is planning to encourage all Americans to receive updated COVID-19 booster shots this fall, aiming to counter a potential new wave of infections, a White House official said on Sunday, quoted by Reuters. According to FOX News, *"The Department of Health and Human Services (HHS) and the White House's Office of Pandemic Preparedness and Response Policy are expected to lead the rollout, which is expected to begin in earnest during the second half of September."* & *"Aside from COVID vaccinations, the administration is also encouraging Americans to get an annual influenza vaccination in addition to a shot for respiratory syncytial virus (RSV) -- both of which are common respiratory illnesses that can cause more severe complications in some cases,"* the outlet added.

The federal government has started purchasing COVID-19 equipment and hiring advisors on "safety protocols" amidst speculation the Biden White House will reinstate pandemic-era lockdowns and mandates, Steve Bannon's War Room can reveal.

The unearthed government contracts from entities including the Department of Defense (DOD) show millions in taxpayer funds being used to purchase COVID-19 equipment such as test kits. Some of the contracts, which are traceable via the federal government's spending database, are even scheduled to begin in future months such as September and October.

The DOD, for example, gave Hologic Sales and Service LLC a \$1.5 million contract beginning on October 1st that's set to conclude in May of 2024. The federal database reveals the funds are for "Hologic covid testing services in support of the department of pathology at Madigan army medical center, Tacoma, WA 98431. (new delivery order)."

The Department of Veterans Affairs (VA) also inked a \$2 million contract with Abbott Molecular Inc. beginning on September 22nd. Set to conclude in September of 2024, the contract will provide testing services for viruses including COVID-19.

The VA also started a \$1.3 million contract with Biofire Diagnostics LLC on August 18th for its "COVID-19 testing reagents and equipment." The contract is slated to expire in August of next year.

On August 14th, the VA also began a \$3.3 million contract with Oddball Inc. for advisory on "adequate COVID/19 safety protocols":

"TASK ORDER IS FOR DEVELOPER EXPERIENCE. "EO14042" MODIFICATION TO ADD FAR 52.223-99 ENSURING ADEQUATE COVID-19 SAFETY PROTOCOLS FOR FEDERAL CONTRACTORS (OCT 2021) (DEVIATION)."

The contract is set to expire in August of next year.

The unearthed contracts follow the mainstream media hyping an alleged surge in COVID-19 cases across America, which also dovetails with COVID-19 vaccine makers such as Pfizer experiencing a rapid decline in profits.



Last year, President Biden announced that COVID was over, or at least he declared we were on a promising path to defeating the virus. Despite the sense of optimism, the media seems to be prepping for a COVID *“comeback tour.”* Yes, you heard that right—COVID is reemerging as a major threat this fall, according to news outlets and the Biden administration. But how much of this should we take at face value?

According to the Centers for Disease Control and Prevention (CDC), COVID cases have increased four weeks in a row. But hold on. What the mainstream media, like NBC News, isn't telling you is that COVID-19 follows seasonal and regional patterns.

Pharmaceutical companies like Pfizer, Moderna, and Novavax are planning to release new booster shots this fall. CBS, owned by Viacom—a company that profited massively during the pandemic lockdowns—is happily offering free advertising for these pharmaceutical giants.

It's no secret that pharmaceutical companies are making money off booster shots. Doctors get a cut, too. The only difference now is that instead of Uncle Sam, insurance companies are footing the bill.

“But don't worry,” [Watters](#) sneered, *“Biden's giving pharmaceutical companies over a billion dollars so uninsured Americans can get free shots. Now, we're beginning to*

wonder if this year's mutant variant scare tactic pushed on network TV is less about saving lives and more about lining corporate pockets."

In a climate where the lines between public health and private profit often blur, [Jesse Watters](#) reminds us to scrutinize the narratives being presented — to consider who benefits and who suffers. As [Watters](#) highlights, when business interests intermingle with health advisories, the first casualty is often the truth.

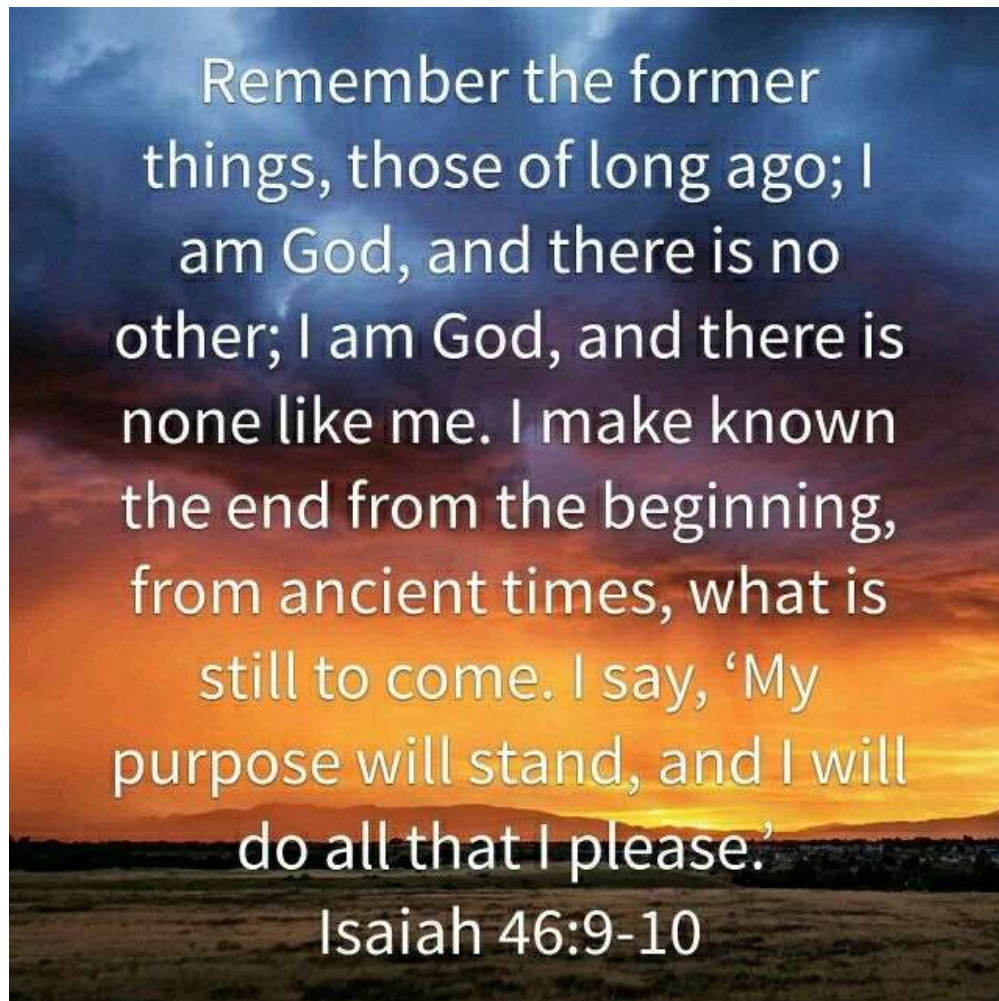

The Precision of Prophecy Daniel’s 70 Weeks

As we reflect on the outcome of this year’s election, let us all remember that, fundamentally, we are neither Republicans nor Democrats: we are Monarchists and we look forward to our Coming King... Question: when did Jesus ever present Himself as a King?

Irrefutably Documented

To fully appreciate the remarkable significance of the following article, it is essential to realize that the Book of Daniel, as part of the Old Testament, was translated into Greek prior to 270 B.C., almost three centuries before Christ was born. This is a well-established fact of secular history.^[1]

The Septuagint

After his conquest of the Babylonian Empire, Alexander the Great promoted the Greek language throughout the known world, and thus almost everyone — including the Jews — spoke Greek. Hebrew fell into disuse, being reserved primarily for ceremonial purposes (somewhat analogous to the use of Latin among Roman Catholics).

In order to make the Jewish Scriptures (what we call the Old Testament) available to the average Jewish reader, a project was undertaken under the sponsorship of Ptolemy II

Philadelphus (285–246 B.C.) to translate the Hebrew Scriptures into Greek. Seventy scholars were commissioned to complete this work and their result is known as the “Septuagint” (“70”) translation. (This is often abbreviated “LXX”.)

The Book of Daniel is actually one of the most authenticated books of the Old Testament, historically and archaeologically, but this is a convenient shortcut for our purposes here. It is critical to realize that the Book of Daniel existed in documented form almost three centuries before Christ was born.

Gabriel’s Zinger

Daniel, originally deported as a teenager (now near the end of the Babylonian captivity), was reading in the Book of Jeremiah. He understood that the seventy years of servitude were almost over and he began to pray for his people.

The Angel Gabriel interrupted Daniel’s prayer and gave him a four-verse prophecy that is unquestionably the most remarkable passage in the entire Bible: Daniel 9:24–27. These four verses include the following segments:

- 9:24 – The Scope of the Entire Prophecy;
- 9:25 – The 69 Weeks;
- 9:26 – An Interval between the 69th and 70th Week;
- 9:27 – The 70th Week.

The Scope (Dan 9:24)

Seventy weeks are determined upon thy people and upon thy holy city, to finish the transgression, and to make an end of sins, and to make reconciliation for iniquity, and to bring in everlasting righteousness, and to seal up the vision and prophecy, and to anoint the most Holy Place .

— *Daniel 9:24*

The idiom of a “week” of years was common in Israel as a “sabbath for the land,” in which the land was to lie fallow every seventh year.^[2] It was their failure to obey these laws that led to God sending them into captivity under the Babylonians.^[3]

Note that the focus of this passage is upon “thy people and upon thy holy city,” that is, upon Israel and Jerusalem. (It is not directed to the Church.)

The scope of this prophecy includes a broad list of things which clearly have yet to be completed.

The First 69 Weeks (Dan 9:25)

A very specific prediction occurs in verse 25:

Know therefore and understand, that from the going forth of the commandment to restore and to build Jerusalem unto the Messiah the Prince shall be seven weeks, and threescore and two weeks: the street shall be built again, and the wall, even in troublous times.

— *Daniel 9:25*

This includes a mathematical prophecy. As we have noted in previous articles, the Jewish (and Babylonian) calendars used a 360-day year,^[4] 69 weeks of 360-day years totals 173,880 days. In effect, Gabriel told Daniel that the interval between the commandment to rebuild Jerusalem until the presentation of the Messiah as King would be 173,880 days.

The “Messiah the Prince” in the King James translation is actually the *Meshiach Nagid*, “The Messiah the King.” (*Nagid* is first used of King Saul.)

Bull’s-Eye!

The commandment to restore and build Jerusalem was given by Artaxerxes Longimanus on March 14, 445 B.C.^[5] (The emphasis in the verse on “the street” and “the wall” was to avoid confusion with other earlier mandates confined to rebuilding the Temple.)

During the ministry of Jesus Christ there were several occasions in which the people attempted to promote Him as king, but He carefully avoided it: “Mine hour is not yet come”.^[6]

The Triumphal Entry

Then, one day, He meticulously *arranges* it.^[7] On this particular day he rode into the city of Jerusalem riding on a donkey, *deliberately* fulfilling a prophecy by Zechariah that the Messiah would present Himself as king in just that way:

Rejoice greatly, O daughter of Zion; shout, O daughter of Jerusalem: behold, thy King cometh unto thee: he is just, and having salvation; lowly, and riding upon an ass, and upon a colt the foal of an ass.

— *Zechariah 9:9*

Whenever we might easily miss the significance of what was going on, the Pharisees come to our rescue. They felt that the overzealous crowd was blaspheming, proclaiming Jesus as the Messiah the King.^[8] However, Jesus endorsed it!

I tell you that, if these should hold their peace, the stones would immediately cry out.

— *Luke 19:40*

This is the only occasion that Jesus presented Himself as King. It occurred on April 6, 32 A.D.^[9]

The Precision of Prophecy

When we examine the period between March 14, 445 B.C. and April 6, 32 A.D., and correct for leap years, we discover that it is 173,880 days exactly, *to the very day!*

How could Daniel have known this in advance? How could anyone have contrived to have this detailed prediction documented over three centuries in advance? But there's more.

The Interval (Dan 9:26)

There appears to be a gap between the 69th week (verse 25) and the 70th week (verse 27):

And after threescore and two weeks shall Messiah be cut off, but not for himself: and the people of the prince that shall come shall destroy the city and the sanctuary; and the end thereof shall be with a flood, and unto the end of the war desolations are determined.

— Daniel 9:26

The sixty-two “weeks” follow the initial seven, so verse 26 deals with events *after* 69th week, but *before* the 70th. These events include the Messiah being killed and the city and sanctuary being destroyed.

As Jesus approached the city on the donkey, He also predicted the destruction of Jerusalem:

For the days shall come upon thee, that thine enemies shall cast a trench about thee, and compass thee round, and keep thee in on every side, And shall lay thee even with the ground, and thy children within thee; and they shall not leave in thee one stone upon another; because thou knewest not the time of thy visitation.

— Luke 19:43–44

The Messiah was, of course, executed at the Crucifixion... “but not for Himself.”

The city and the sanctuary were destroyed 38 years later when the Roman legions under Titus Vespasian leveled the city of Jerusalem in A.D. 70, precisely as Daniel and Jesus had predicted. In fact, as one carefully examines Jesus’ specific words, it appears that *He held them accountable to know this astonishing prophecy in Daniel 9!* “Because thou knewest not the time of thy visitation.”

The 70th Week

There is a remaining seven-year period to be fulfilled. This period is the most documented period in the entire Bible. The Book of Revelation, Chapters 6 through 19, is essentially a detailing of that climactic period.

The interval between the 69th and 70th week continues, but it is increasingly apparent that it may soon be over.

The more one is familiar with the numerous climactic themes of “end-time” prophecy, the more it seems that Daniel’s 70th Week is on our horizon.

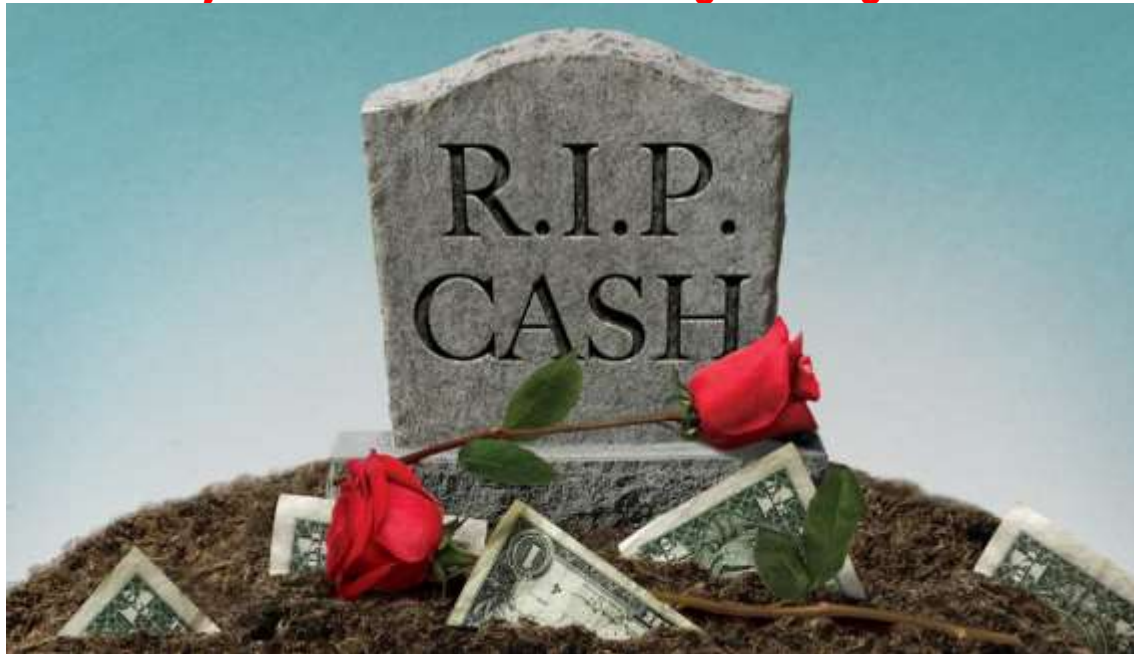
