

The Department of Energy is proposing a rule that would require ceiling fans to be more energy efficient, arguing the move would save U.S. households on energy costs.

According to the Energy Department's analysis, the new rules would save households about \$39 over the lifespan of the new energy-efficient fan.



Well, isn't that going to help your food budget with 30% inflation? Overall food prices have soared by 25%-30% in only three years (again, this means that you are now paying 30% more this year for food than you were paying at the beginning of 2020). Chicken is up from \$3 per pound to \$4 per pound. Beef is up from \$3.50 to \$6 per pound. Corn is up from \$3.50 per pound to \$4.70 per pound. Wheat is up from \$5 per pound to \$7 per pound. In 2019 the average American household was spending \$8,100 on food annually; with a 30% increase, in 2023 Americans will be spending at least \$10,500 per household.

However, the cost to manufacturers associated with the increased equipment will total \$86.6 million per year, the department said.

Republicans on the House Committee on Small Business say if the rule goes into effect it could put small manufacturers out of business, given the costs the companies would incur in order to comply with the changes.

"This rule would require numerous small business fan manufacturers to redesign their products and may put between 10 and 30 percent of small business ceiling fan manufacturers out of business," the GOP members of the committee wrote in a letter to Energy Secretary Jennifer Granholm on Thursday. "It appears that the Department of Energy (DOE) may not have properly considered small entities during this rulemaking process."

The Energy Department has been on the warpath to impose more stringent regulations on household appliances for the past several months, proposing new standards for gas stoves, ovens, washing machines, refrigerators, air conditioners, dishwashers, and other essentials as part of its mission to advance energy efficiency and conservation. On his first day in office in January 2021, President Biden signed an executive order requiring the Energy Department to make *"major revisions"* to current appliance regulation standards and standards set by the Trump administration.

A month later, the agency listed more than a dozen energy-efficiency rules impacting appliances like water heaters, cooking products, and lamps that it would review.

"Their philosophy is energy efficiency at all costs or energy efficiency no matter the cost," a former senior Energy Department official, who served during the Trump administration, previously told Fox News Digital. "That means we are going to see, as a result of their efficiency standards, higher-priced appliances. It's that simple."

This comes as part of Prince Charles plan to achieve Net-Zero carbon footprint and mask his "Depopulation" agenda as Climate Eco-Salvation.

15 Big Banks about to fail

The real reason for concern is not that they are banks with big problems, but rather, as the bad banks eat losses from defaulting loans in real estate, mortgage foreclosure, and defaulting on car loans, the larger threat is to the FDIC. The FDIC has been able to insure savers' accounts up to \$250,000 per individual. This protection is at risk of its own liquidation down the road. As the report suggests there are more than 200 banks are on a watch list of financial institutions that are potential for bankruptcy and collapse!

The Federal Reserve has steadily raised interest rates and with each rate increase, the pool of potential home buyers shrinks. In the past week or two mortgage loans has risen to 7%.

Real estate marketplace Zillow has launched a new program to help people who want to buy homes but are being squeezed out of the market by a surge in interest rates.

Zillow Home Loans is offering mortgages with a 1% down payment option for eligible homebuyers looking to own property in Arizona, and will contribute an additional 2% at closing, the company said Thursday. It also plans to expand the program to other markets.

"For those who can afford higher rent payments but have been held back by the upfront costs associated with homeownership, down payment assistance can help to lower the

barrier to entry and make the dream of owning a home a reality," Zillow Home Loans' senior macroeconomist Orphe Divounguy said in a statement.

The program will reduce the time it would ordinarily take to save for a down payment, according to Zillow.

"The rapid rise in rents and home values means many renters who are already paying high monthly housing costs may not have enough saved up for a large down payment, and these types of programs are welcome innovations in lowering the potential barriers to homeownership for those who qualify," Divounguy said.

On Wednesday, <u>mortgage rates surged to their highest level</u> since 2000. The average rate on a conventional 30-year fixed-rate mortgage jumped to 7.31% last week, up from 7.16% the previous week, according to The Mortgage Bankers Association (MBA).

As a result, many aspiring homeowners are being sidelined, driving mortgage applications down to a 28-year-low, according to the MBA.



Harmful 'Modified' RNA, Not mRNA

Although we've been told Pfizer's COVID-19 vaccine is manufactured with <u>harmless</u> <u>messenger RNA</u> (mRNA), the U.S. Food and Drug Administration's (FDA) <u>product</u> <u>label</u> shows it contains <u>artificially modified</u> RNA—a key ingredient that is not naturally occurring and poses a substantial risk to human health. According to Pfizer and BioNTech's COVID-19 vaccine label in the FDA's Fact Sheet for Healthcare Providers, each Pfizer vaccine dose for children ages 5 through 11 contains 10 micrograms (mcg) of modRNA, while fully-approved Comirnaty authorized for use in individuals 12 years of age and older contains 30 mcg of modRNA.

Pfizer, on its website, confirms its COVID-19 vaccine contains modRNA: "ModRNA stands for nucleoside-modified messenger RNA and in the synthesis of the RNA used in this vaccine platform, some nucleosides, which are important biological molecules that constitute DNA and RNA, are replaced by modified nucleosides to help enhance immune evasion and protein production." The company says modRNA instructs the cells to produce desired proteins.

Yet the Centers for Disease Control and Prevention (CDC) states on its website (pdf) that mRNA COVID-19 vaccines are *"made of mRNA,"* or *"messenger RNA."*

According to the agency, the mRNA in COVID-19 vaccines such as Pfizer and Moderna is created in a laboratory and teaches cells how to make harmless pieces of spike protein that trigger an immune response inside the body. The mRNA from mRNA-based vaccines is broken down within days after vaccination and eliminated from the body. In its description of mRNA and how COVID-19 vaccines work, the CDC makes no reference to modRNA or indicates that the RNA used in COVID-19 vaccines has been modified.

Messenger RNA occurs naturally and lives in our cells, and it does not last long enough to initiate an immune response before being destroyed by the immune system—it is modRNA that is synthetically created, <u>according to Klaus Steger</u>, a molecular biologist who headed several gene technology laboratories, regularly applying RNA-based technologies.

Unlike mRNA, modRNA modifies one of four compounds in RNA that make it last longer in the body, less immunogenic (reduced stimulation of the innate immune system), and more efficient at producing a protein—in this case, the spike protein, Mr. Steger stated. Since modRNA cannot target specific cells to make viral protein, it can attack perfectly healthy cells and bypass protective barriers in the body, like the <u>blood-brain</u> <u>barrier</u>.

Injecting modRNA into the body <u>may lead to adverse events like strokes</u>, cardiovascular complications, pulmonary embolism, and the <u>formation of blood clots</u>—many of which were disclosed in Pfizer's documents (<u>pdf</u>) but were not attributed to its product.

"It is my opinion that, at a minimum, the intentional use of mRNA—an acronym wellknown to stand for messenger RNA along with the endless statements about the vaccines being based on naturally occurring messenger RNA constitute misbranding in violation of a number of laws," Ohio-based attorney Thomas Renz told The Epoch Times in an email. "There is a legal and moral duty to provide informed consent, and to misrepresent a drug that was intended to be a gene therapy as a vaccine containing "natural messenger RNA" is an apparent violation of both of those duties."

David Wiseman, a research bioscientist with a doctorate in experimental pathology and a background in pharmacy, pharmacology, and immunology told The Epoch Times in an email **the FDA uses the term "modRNA" throughout its regulatory documents.** Yet the FDA, when it <u>gave emergency use authorization</u> to the Pfizer-BioNTech vaccine, said the vaccine contains messenger RNA, which it described as "genetic material" that contains a "small piece of the SARS-CoV-2 virus's mRNA that instructs cells in the body to make the virus's distinctive 'spike' protein."

The FDA's description is problematic because the SARS-CoV-2 virus doesn't contain mRNA, Mr. Wiseman said. "mRNA is the kind of RNA produced in the copying of instructions from DNA in a process called transcription, so to say this is viral mRNA is inaccurate."

"Understand that, at core, mRNA, modRNA, saRNA, etc.—these are <u>all gene</u> <u>therapies</u> and all about genetic manipulation," Mr. Renz wrote in a recent <u>Substack</u> <u>article</u>. <i>"To suggest that this is high risk is an understatement. We have no idea what we are doing and yet we continue forward trying to control these genes."

Pfizer Is Using Modified RNA Gene Therapy to Develop Other Vaccines

Mr. Renz told The Epoch Times that Pfizer is not only using modRNA for COVID-19 injections but also leveraging gene therapy technology to produce self-amplifying mRNA (saRNA) vaccines and treatments.

"Along with modRNA, Pfizer's website <u>also mentions saRNA</u> (self-amplifying RNA) and numerous other lab-made RNA technologies," he said. "We have discovered that various RNA technologies are in development for various uses, and these technologies, along with new adjuvant technologies, can allow for the introduction of gene therapy products into foods, the air (aerosolized vaccines), and even topical products."

According to Pfizer, saRNA is a platform that uses a much larger molecule that encodes the antigen of interest and four additional proteins, allowing the cell to make more copies of the mRNA, resulting in more protein being expressed from a smaller dose. Pfizer states that it is currently using this gene therapy technology to develop influenza, shingles, and respiratory combination vaccines.

"It will be curious to know if this is going to be disclosed as well," Mr. Renz added.

Primary care provider Kaiser Permanente is now requiring staff, patients, and visitors at its Santa Rosa facilities to wear face masks.

Last week, Upstate Medical's two hospitals in New York reimposed mandatory masking following reports of an uptick in COVID-19 infections.

Many people have begun pushing back against mandates and questioned the timing of the rise in COVID infections—with 2024 elections nearing.

"And just like that, the election variant emerges," author George Papadopoulos said in an Aug. 23 post on X.

"I see the election time variant of COVID is about to drop. Mail in ballots to EVERYONE! Lol. America no longer has free and fair elections. We are no different than 3rd world countries in this regard," conservative political commentator Candace Owens said in an Aug. 23 X post.

"I hear that the Covid-19 Election Variant may be coming back. I Will Not Comply," Republican Kari Lake said in an Aug. 23 post on X.

The use of "election variant" comes in the context of the 2020 election—during the COVID pandemic—when many states expanded voting procedures, including mail-in ballots, to accommodate lockdown restrictions.

"In the 2020 election, 69 percent of voters nationwide cast their ballot nontraditionally—by mail and/or before Election Day," according to the U.S. Census Bureau.

A Pew Research <u>survey</u> from November 2020 showed that Democrats benefited greatly from mail-in ballots. While 32% of Trump supporters voted through absentee or mail-in ballots, this was much higher in the case of Joe Biden, as 58% of his supporters used mail-in ballots.

Meanwhile, some Hollywood celebs have started promoting mask-wearing.

"COVID is on the rise. SO MANY friends now are really sick. BE MINDFUL. WEAR A MASK if required or even if you feel unwell and are out in public spaces," Oscar winner Jamie Lee Curtis said in an Aug. 22 Instagram post showing an image of the actress with a mask.

Clinical psychologist Dr. Jordan B. Peterson responded to Curtis' mask promotion by stating, *"Enough medical fascism."*

"Stay at home if you're scared. But leave the rest of us the hell alone," he <u>said</u> in an Aug. 23 post on X.

Rising Infection Numbers

According to data from the U.S. Centers for Disease Control and Prevention (CDC), there has been an uptick in COVID-19 hospitalization in recent weeks. As of the week ending Aug. 12, there were 12,613 admissions, which is double the 6,313 admissions for the week ending June 24.

However, the current increase in hospitalizations is far lower compared to the previous two years, suggesting that COVID-19 infections popping out this time may not be as severe as in the past. This is where they manipulate the data to make it seem much worse.

In 2022, the week ending Aug. 13 had registered 41,113 hospitalizations, which is more than three times what it was on Aug. 12, 2023. For the week ending Aug. 14, 2021, hospitalization numbers were at 77,625.

The COVID-NET laboratory-confirmed COVID-19 hospitalization overall rate per 100,000 people was at 1.7 for the week ending Aug. 12, far lower than 9.2 in the same period last year.

The current concerns regarding COVID-19 have been triggered due to a newly discovered variant called BA.2.86. The World Health Organization (WHO) said that the new strain is a *"variant under monitoring."* Show us the evidence using the Koch Postulates. No lab has ever produced proof that Covid is more than a cold or a mild case of the flu.

In an August 23 update, the CDC said that at least two cases of BA.2.86 infections have been identified in the United States. Existing medications for COVID-19 *"appear to be effective with this variant,"* it said. CDC believes that an updated vaccine *"will be effective at reducing severe disease and hospitalization."*

"At this point, there is no evidence that this variant is causing more severe illness," the agency stated.

Government COVID-19 Testing Orders

Multiple departments under the federal government have placed orders for COVID-19 equipment, according to media executive Steve Bannon's podcast website.

The Department of Defense (DoD) has given a \$1.5 million order to Hologic Sales and Service for COVID-19 testing services, the website said, citing data from USA Spending. The contract is set to begin in October and end in May 2024.

The Department of Veterans Affairs (VA) has placed a \$2 million contract with Abbott Molecular Inc. for COVID-19 testing, with the contract set to begin on Sept. 22. It has also signed a \$1.3 million contract with Biofire Diagnostic for testing.

Back in April, the Biden administration announced that it was spending \$5 billion to develop more COVID-19 vaccines and treatments. However, the announcement did not mention masking or social distancing.

Masking has been a highly politicized issue ever since the pandemic began years ago, with some questioning whether the government had the authority to institute mask mandates.

In 2022, the U.S. Supreme Court ruled that the White House does not have the authority to enforce vaccine or masking mandates on companies with 100 or more employees.

Last year, the court ruled that the U.S. Transportation Security Administration (TSA) has the power to impose mask mandates on planes, trains, and other transportation options. In an August 22 post on X, physician David McCune criticized incidents of mandatory masking at institutions. *"If they will go back to the utterly failed practice of forced masking at the mere hint of new cases, it means, among other things, they have utter disregard for the human right to contact with other humans."*

"Faces [matter]. And the freedom to show yours shall not be abridged," Mr. McCune said. He was responding to Morris Brown College's masking requirement for students and employees.

Though mask-wearing is pushed as a way to combat the COVID-19 pandemic, many experts have countered such suggestions.

In an <u>interview</u> with The Epoch Times, Yoav Yehezkelli, a specialist in internal medicine and medical management, pointed out that *"all the studies done in the world until 2020 showed that there is no justification"* for wearing masks to prevent the spread and infection of a respiratory virus.

In 2020, after the pandemic, recommendations for wearing masks suddenly changed *"without having any new professional support to confirm that it does indeed have effectiveness against respiratory infection."*

A <u>review</u> of mask use studies published in January this year found that the use of face masks is not effective in reducing the spread of respiratory viruses.

What's that old statement, "Fool me once shame on me, Fool me twice shame on you!"

The synthetic "meat" market has already arrived in America.

American cattlemen are readying for a fight to protect the definition of the word meat from producers of synthetic cellular-based beef alternatives.

"It's a red line. It isn't right that these factory-made products should be able to market and sell their products off the backs of the cattleman," Justin Tupper, President of the United States Cattlemen's Association, told The Epoch Times.

"We are talking about chemical-laced cell-cultured products that can in some ways simulate meat, but they aren't meat, and the American consumer needs to understand that," added Mr. Tupper. Last year, the USDA gave two producers the green light to start producing and selling their lab-grown chicken-like products in the United States.

While a decision over the labeling of the product has yet to be announced, the cattle industry plans on being aggressively proactive in both discussions with the USDA and, if needed, litigation after having learned a valuable lesson from the dairy farmers.

"The milk industry really dropped the ball," said Mr. Tupper. "They never believed that anyone would think that almond milk was actual milk, so they brushed it off at the time. Now there are hundreds of items with milk in the name but with no milk in the product, and it has really hurt the entire dairy industry."

"In the same way that you can't milk an almond, you can't get meat from a lab, only an animal, and we are not going to allow them to use our name to promote their product."

Synthetic meat-like products are created by taking cells acquired from animals and placing them in a warm, sterile area, usually, a metal vat, where they are then combined with a solution of chemicals that causes the cells to double once a day.

The demand for synthetic meat has been spurred largely by corporate entities and government agencies working in tandem with the environmental movement.

Bill Gates, an investor in Upside Foods, one of the two synthetic meat producers approved by the USDA, believes meat alternatives are needed to save the world from upcoming catastrophic climate events caused by greenhouse gasses.

In a 2021 interview with Technology Review, **Mr. Gates said that all well-off nations** need to switch to be completely weaned off of living, breathing cows.

"All rich countries should move to 100% synthetic beef. You can get used to the taste difference, and the claim is they're going to make it taste even better over time," Mr. Gates told the interviewer. "Eventually that green premium is modest enough that you can sort of change the people or use regulation to totally shift demand. So for meat in the middle-income-and-above countries, I do think it's possible."

A switch from animal meat to a laboratory-grown substitute would eliminate the need for animals to be bred and slaughtered—in the U.S. alone, **around 9 billion chickens and 32 million cattle are killed every year.**

However, beef cattle production constitutes only a small fraction of the gasses that many environmentalists claim have had a negative impact on the planet.

Just 2 percent of total greenhouse gas emissions in the United States come from beef cattle production, while energy production and transportation produce a combined 54 percent of emissions, according to the U.S. Environmental Protection Agency.

American ranchers aren't the only ones raising the alarm. After two million Italians signed a petition calling for a ban against synthetic meat products, the Italian Senate passed a bill earlier this week, becoming the first country to make it illegal to produce or market the food, highlighting health concerns as the primary reason.

Ettore Prandini, President of Coldiretti, the largest association representing Italian agriculture, touted the vote as a legislative victory for the Italian people over corporate powers, telling the media that *"the products in the laboratory in the authorization processes are not equated to food but rather to products of a pharmaceutical nature."*

An April 2023 report by the United Nations on the safety of *"cell-based food products"* cited 53 potential health hazards, including *"the potential for expression of novel toxins, toxic metabolites, or allergens or a change in expression of toxins, toxic metabolites, or allergens as a result of genomic instability."*

Mr. Tupper isn't calling for a ban on synthetic foods, only transparency, and believes that despite the large push for meat alternatives coming from corporate leaders and government agencies, the American cow is here to stay.

"The simple truth is that the taste of real beef cannot be replicated and, more importantly, when people discover the chemical storm that is actually in this product they are trying to pass off as meat, consumers are going to come to the conclusion that beef should come from a cow, not from a laboratory."

"Our hopes are that the USDA will label this product for what it is, a cellular-based derivative of chemicals," added Mr. Tupper.

Mask study published by NIH suggests N95 Covid masks may expose wearers to dangerous level of toxic compounds linked to seizures and cancer

The surgical N95 mask has been held up as the gold standard when it comes to protecting against <u>Covid</u>.

But a study quietly re-shared by the National Institutes of Health in spring suggests the tight-fitting mask may expose users to dangerous levels of toxic chemicals.

Researchers from Jeonbuk National University in <u>South Korea</u> looked at two types of disposable medical-grade masks, as well as several reusable cotton masks.

The study found that the chemicals released by these masks had eight times the recommended safety limit of toxic volatile organic compounds (TVOCs).

Inhaling TVOCs has been linked to health issues like headaches and nausea, while prolonged and repeated has been linked to organ damage and even cancer.

'It is clear that particular attention must be paid to the VOCs associated with the use of KF94 [medical] masks their effects on human health,' the researchers wrote in the study published April.

However, there are ways to reduce the danger, they said. 'Exposure can be significantly reduced if a mask is opened and left to sit for at least 30 min,' the researchers wrote. This suggests that the packaging of these masks could play a role in the amount of chemicals they have.

The study was published in the journal Ecotoxicology and Environmental Safety and on the NIH's website.

The NIH said: 'Inclusion in an NLM database does not imply endorsement of, or agreement with, the contents by NLM or the National Institutes of Health.'




Fig. 1. TVOC concentrations (µg m⁻³) emitted from each mask sample.

The researchers found that the levels of TVOCs were 14 times lower in cloth masks and didn't pose a risk to human health.

However, the study did not measure the effect of people actually wearing the masks.

Dr. Stuart Fischer, an internal medicine physician in New York, told DailyMail.com that strong conclusions couldn't be drawn from the study.

However, he did say that increasingly evidence has shown the drawbacks of maskwearing. He added that 'there seems to be diminishing returns on the need for masks.'

In the latest study, researchers tested 14 disposable and cloth masks purchased online by measuring the amount of TVOCs in them. The disposable masks were KFAD and KF94 models, which were made from thermoplastics polypropylene and polyurethane nylon. These masks have been popularized in South Korea, where the study was conducted, whereas KN95s are more popular in the U.S.

However, their differences are miniscule. KFADs and KF94s filter 94 percent of particles, while KN95s filter 95 percent.

The cloth masks were made from cotton, ramie - a vegetable fiber - and polyurethane.

'These TVOC concentration levels corresponded to a level that is harmless to the human body (no relevant health-related concerns),' the researchers wrote.

However, the disposable masks contained up to 14 times the TVOCs than cotton masks.

The Environmental Protection Agency (EPA) recommends keeping TVOC levels below 0.5 parts per million in indoor air.

The sample with the highest amount of TVOCs had 4,808 cubic meters per microgram, which is about 4.8 parts per million.

Mask mania sweeps America... AGAIN

Covid masks are creeping back into American life again with hospitals, Hollywood and colleges mandating their use — and there are rumors they could return on planes.

That's more than eight times the recommended limit.

TVOCs are a large group of odorous chemicals, many of which are released by cleaning and beauty products, burning fuel and cooking.

Sources of TVOCs in the home include aerosol sprays, cleansers and disinfectants, moth repellents, air fresheners and automotive products.

Other sources include building materials and furnishings, office equipment such as copiers and printers, permanent markers, correction fluids, carbonless copy paper and craft materials including glues and adhesives.

TVOCs have been shown to irritate the eyes, nose, and throat, cause difficulty breathing and nausea, and damage the central nervous system and organs like the liver, according to the American Lung Association (ALA).

Some are even considered human carcinogens, meaning they can cause cancer.

The researchers specifically flagged the chemicals dimethylacetamide (DMAc) and dimethylformamide (DMF) for being linked to liver and reproductive damage.

The team acknowledged that the sample size was small and that they did not test several other popular disposable masks like KN95s.

The study builds off previous research suggesting that mask wearing could cause more harm than good.

Research carried out by the Cochrane Institute, for example, suggested that face masks made <u>'little to no difference'</u> in Covid infections and deaths.

The researchers said harms caused by masks - including hampering children's schooling - were poorly measured in the studies, meaning any small benefit on infection rates may be outweighed.

And a controversial study suggested that wearing face masks <u>raises the risk of</u> <u>stillbirths</u>, testicular dysfunction, and cognitive decline in children.

However, experts have criticized the study for drawing conclusions without proper evidence.

"It is indeed possible that certain masks have side effects, just as certain helpful medications (anti-histamines, psychotropic drugs, antibiotics) have side effects," Dr. Fischer said.

"Almost everything in healthcare has a benefit/side effect profile."

Though the findings were published in April, the study could have new relevance as the so-called Covid <u>variant BA.2.86 spreads across the US</u>.

Several universities, hospitals, and even the Hollywood studio Lionsgate have reinstated mask mandates amid the surge.

But the newly found dangers of masks typically considered the most protective could make mask mandates ineffective.

"I think following the general recommendations might be helpful, but it's not clear yet if we need the sweeping edicts of three years ago.," Dr. Fischer said.

"Extreme fears about the lethality of Covid may have led to decisions that were counterproductive."

"Covid won't be going away for a long time, if ever. We desperately need policies that do not fracture our society while providing minimal protection."

Although homosexuality is rife in the Arab world, it is at least officially consider a sin and a crime, and regarded–especially in fundamentalist circles–as a mark of great shame and depravity.

David Frum, a former White House speech writer pointed to KGB evidence linking Arafat to homosexual activities, citing a 1987 book by Lt.-Gen. Ion Pacepa, the deputy chief of Romania's intelligence service under Communist dictator Nicolae Ceausescu. Needless to say this background to Prince Charles brokering the Oslo Accords remains on the shelf to this day and remains an open issue for the Antichrist to finally bring to closure in the very near future. It could happen as soon as the dates I noted on page 25. The focus on Daniel 9:27 from my research may have morphed into the much larger issue that became the Paris Climate Agreement in 2015. The Paris Agreement is a legally binding international treaty on climate change. It was adopted by 196 Parties at

the UN Climate Change Conference (COP21) in Paris, France, on 12 December 2015. It entered into force on 4 November 2016.

The context of Daniel 9:27 interestingly so, has become the speculation of many in the Bible prophecy community as to just who are the "*many*" of the passage. Before the UN Paris Agreement, the general view was that the elusive term "*many*" was a reference to the Israeli Knesset. However, the evolving and unfolding of events related to Prince Charles environmental agenda has suggested that the "*many*" may in fact be the world leaders that have initially been part of the world body we recognize as the United Nations.

The Hebrew word for "many" is **"***rab***"** and is an adjective, an adverb, or a masculine noun. The KJV translates Strong's H7227 in the following manner: many (190x), great (118x), much (36x), captain (24x), more (12x), long (10x), enough (9x), multitude (7x), mighty (5x), greater (4x), greatly (3x), miscellaneous (40x).


Even when you look at the use of the phrase "with many" the (16x) when it is used does not offer a clear explanation to the issue. The ambiguity that confronts prophecy watchers may well be an umbrella expression term for both the Oslo Accords as much as the Paris Climate Accords.

On August 4, 2017, the Trump administration delivered an official notice to the United Nations that the United States, the second largest emitter of greenhouse gases after China, intended to withdraw from the Paris Agreement as soon as it was eligible to do so. The notice of withdrawal could not be submitted until the agreement was in force for three years for the U.S., on November 4, 2019. The U.S. government deposited the notification with the Secretary General of the United Nations and officially withdrew one year later on November 4, 2020. President Joe Biden signed an executive order on his first day in office, January 20, 2021, to re-admit the United States into the Paris Agreement. Following the 30-day period set by Article 21.3, the U.S. was readmitted to the agreement. United States Climate Envoy John Kerry took part in virtual events, saying that the U.S. would *"earn its way back"* into legitimacy in the Paris process. United Nations Secretary-General António Guterres welcomed the return of the United States as restoring the *"missing link that weakened the whole"*.

Since COP28 occurs between November 30th and December 12th, 2023. Based upon the Daniel 9:27 passage, *"confirming the covenant with the many"*, the Rapture will occur on or about the dates noted on page 25 above. The COP28 dates below are in respect to Craig Bong's remarks concerning Prince Charles deadline for his incessant statements to the effect about there is only "seven" years to save the planet.
