The Design & Development for the Anti-Christ's “Mark” of the Beast have been Ordered!

Whereas there are a few points elsewhere within the order that would be beneficial to our economy and development of “biotechnology” based on advancing technology in general, they make it very clear that the real goal is to change “us” to achieve THEIR societal goals – but they don’t specify what their goals are. It clearly states that they wish to create mRNA strings to be incorporated into people which will “rewrite the circuitry of their cells” so that the cells now do “*what they want*” instead of what God intended and designed for us. They continue to state that they intend to fast-track the technology to reach the “market” (us) faster.

Dr. Mark Hitchcock, a faculty member at Dallas Theological Seminary wrote a piece in regards to the “Mark” of the Beast recently. It reflects on how the secular world is beginning to wake up as time grows short. I share that here: Joe Rogan is a comedian, podcast host, and UFC commentator. His podcast, which I do not endorse with the rank language he often uses, has over 15 million subscribers. He’s a major influencer in our culture today and an unbeliever.

A couple of weeks ago, he had a guest named Duncan Trussell, who is a stand-up comic, writer, and actor. Surprisingly, they discussed for quite some time how a cashless society is a precursor to enforcing the mark of the beast.

During his program, Joe Rogan asks, *“How long before we’re a cashless society?”* Trussell responded:

“Hopefully, forever. It is so scary to imagine losing privacy completely because every transaction is in the public eye [and is] observable... This is where I get scared because it’s too similar to the mark of the beast. It’s too similar to exactly what [the Bible in the book of Revelation] says. You won’t be able to trade, you won’t be able to do anything unless you have the mark, unless you bear the mark.”

This response led Joe Rogan to say, *“How’s the Mark of the Beast described in the Bible? I think we’re onto something here.”* He has no idea of how diabolical it is!

Rogan then pulled up the Bible and read from Revelation 13:11-18, a section that describes the coming false prophet, a kind of second in command or the lieutenant of the coming antichrist, who is going to make an image to him. The influential podcast host read this entire section live on his broadcast.

This is a well-known unbeliever talking at length about the Mark of the beast, reading the book of Revelation, making this connection between a cashless society and the rise of the antichrist.

On the heels of that conversation, the new “Amazon One” technology is about to go nationwide. A recent headline from CBS News reads, *“Amazon releases new cashless ‘pay by palm’ technology that requires only a hand wave.”*

This article discusses the use of biometric palm scanning technology, which again, is part of this cashless society that Joe Rogan was talking about:

Amazon is taking cashless payments to another level.

In a new rollout, the tech giant is giving customers another contactless way to pay for groceries — with their palms.

In a statement Thursday, Amazon announced that the palm recognition service, called Amazon One, will be used for payment, identification, loyalty membership, and entry at over 500 Whole Foods and Amazon Fresh locations across the nation by the end of the year.

Instead of pulling out a credit card or even a phone for Apple Pay, subscribing customers will simply have to hover their palms over an Amazon One device to pay.

For decades, Bible prophecy teachers have been saying that there is going to be a cashless society. The only way that the antichrist can control the world economy is for there not to be cash. As long as there is people can use cash to operate in a way that is undetected.

The article continues:

The technology is already available at 200 locations across 20 U.S. states including Arizona, California, Idaho, Oregon and Mississippi...

Panera Bread, for example, has adopted the technology so that customers can simply wave their hands above the device in order to pull up their MyPanera loyalty account information and pay for their meals.

At Coors Field stadium in Colorado, customers trying to purchase alcoholic beverages can hover their palms over the Amazon One device to verify they are 21 or older.

It's being used now in several different convenience stores. It's being used at Hollywood casinos in Detroit. It's also being used by many airport travel retailers.

Another article from 'LifeWire' [reports](#), *"This means you won't need your wallet, purse, or even your phone to complete transactions. You just need your palm."* Basically, this turns your hand into a personal credit card.

"How does this work?" the article goes on. *"You pre-enroll via your Amazon account, using a credit or debit card. Next, you head over to an Amazon One palm-reading device to make a scan."*

Now, this is powerful. 'LifeWire' says, *"The algorithm matches unique elements of your palm with your account information... It doesn't just use images of the palm to identify a person, but also incorporates the underlying vein structure."*

CBS went on to state:

A palm is the safest biometric to use because you cannot identify a person by it, Amazon said. The tech company assured customers that their palm data will not be shared with third parties, including "in response to government demands." If you believe that bovine excrement you probably believe in the tooth fairy.

Including *"in response to government demands"*? Well, in the future, this is going to be taken over by the Antichrist. He's going to rule the world and rule this economy.

It's important to understand that these technologies that we're talking about here (Amazon One, different chip technologies, or biometrics) are not the mark of the beast, but they're part of the infrastructure network that enables a seamless system he will use to control the world economy. I think he will use these things alongside the mark of the

beast. He will use every kind of technology he can to control, monitor, and surveil people's lives and finances. When you control people's money, you control their life.

All of this is part of the continued setup and setting the stage for the global economy and the Antichrist.

People want to know, what is the mark? In his podcast, while Joe Rogan is trying to understand what the Mark of the Beast is, somebody sends him a note telling him that the word "mark," in the Greek, is the word "**charagma**." He says it wrongly several times, trying to pronounce the Greek word before talking about the meaning.

Nine times in the New Testament, you have the word "**charagma**" used for this mark, eight of those times in the book of Revelation.

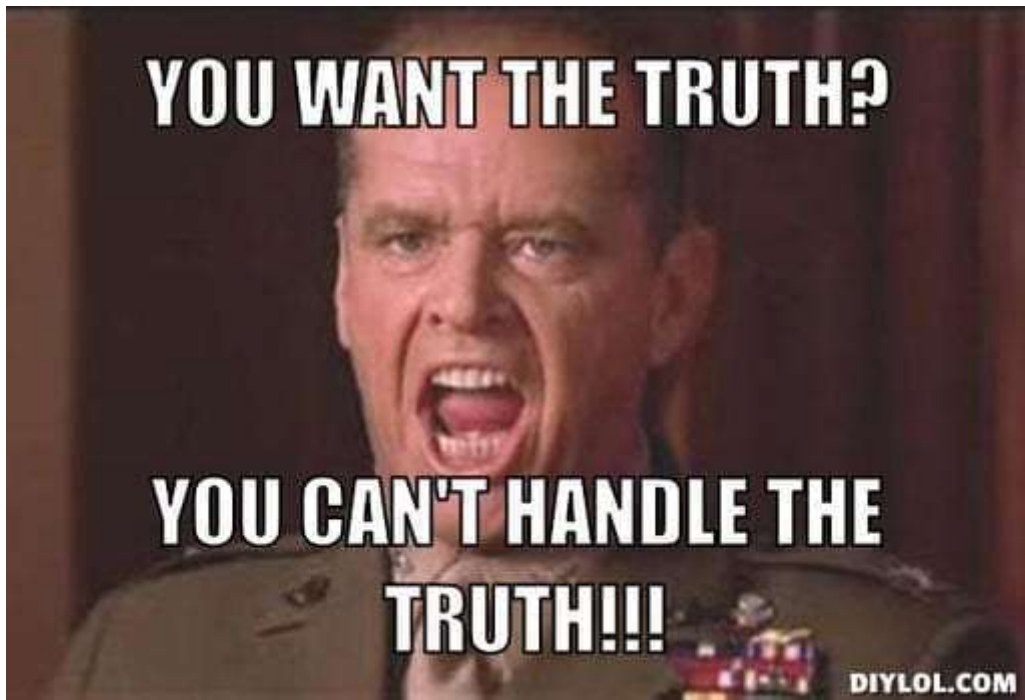
The only time it's not in Revelation is in Acts 17:29, which says: "**Forasmuch then as we are the offspring of God, we ought not to think that the Godhead is like unto gold, or silver, or stone, graven [or etched] by art and man's device.**"

So, this Mark of the Beast is going to be an etching, a tattoo, or a brand; whatever it is, it will be upon the right hand or the forehead of people during the tribulation period. It will be instituted at the midpoint of the seven-year tribulation when the antichrist rules the world politically, economically, and religiously.

It says in Revelation chapter 13 that "**666**" is the number of a man, the number of his name. In both Greek and Hebrew, all the letters of the alphabet have a numerical value associated with them. Kaiser Permanente and Lionsgate Studios in California reversed mask mandate policies last week, just a few days after imposing them.

Kaiser Permanente, the largest healthcare provider in California, on Aug. 22 announced it had “reintroduced a mask mandate for physicians, staff, patients, members, and visitors in the hospital and medical offices in the Santa Rosa Service Area,” in a statement obtained by *The Press Democrat*.

Kaiser said the mandate was in response to an increase in the number of patients testing positive for COVID-19.

But just two days later, on Aug. 24, Kaiser officials told *'The Press Democrat'* the mask reinstatement applied only to physicians and staff, not to patients and visitors.

“Our intent was to communicate that as of Tuesday, we have expanded the masking requirement for our employees and physicians to medical offices and clinic settings; we apologize for any confusion among 'Press Democrat' readers,” Kaiser said in its latest statement.

It also said, “We have not changed our masking requirements in the hospital, which have been in effect since April: employees and physicians are required to wear masks and we ask visitors to wear masks when in the hospital.”

But Kaiser also confirmed to *Becker’s Hospital Review* on Aug. 23 that it had reintroduced the mask mandate.

The *Press Democrat* reported the reversal happened after people noticed many visitors to the hospital were not masking.

Local media reported that some Northern California residents supported the mask mandate policy when it was first announced, but others were skeptical and frustrated in response to the mandate announcement.

“I think it’s more political than anything, just think they’re trying to do what they did in 2020,” said Carmichael resident Craig Roberts.

Lionsgate also reverses mandate

Lionsgate on Friday also notified employees that the mask mandate it had imposed about a week prior for employees on the third and fifth floors of the studio's five-story office building in Santa Monica was over, *Deadline* reported.

Lionsgate imposed the mandate after multiple people in its Santa Monica headquarters came down with COVID-19. The company told *Deadline* it imposed the mandate in compliance with rules set by the Los Angeles County Department of Public Health.

Lionsgate told *The Wrap* the health department informed the company it could lift the mask requirement after several days of no new infections.

The company also distanced itself from responsibility for the mandate, stating that:

"Lionsgate never changed its own mask policy. The LA County Department of Health ordered us to institute the temporary masking requirement after we reported a cluster of COVID cases to them and we have an obligation to comply with their orders."

In addition to mandating "a medical grade face covering (surgical mask, KN95 or N95)," every Lionsgate employee was required to perform a daily self-screening before coming to the office and was told to stay home if they exhibited any symptoms or had traveled internationally in the last 10 days.

Lionsgate was conducting contact tracing and providing at home COVID-19 test kits. It is unclear if those practices are still required.

Reversals come amid pushback and more evidence of mask failures

The mask policy reversals come amid pushback from critics after a growing number of businesses and hospitals in recent weeks reinstated mask mandates and social distancing requirements, and a new report warned that broader mandates may be coming this fall.

Many doctors have also called for mask mandates to return to healthcare settings.

Meanwhile, documents recently released from the National Institutes of Health (NIH) revealed that public health officials privately questioned the effectiveness of masks and the guidance issued by the Centers for Disease Control and Prevention (CDC) promoting their use.

And an NIH study suggested surgical N95 masks, held up as the gold standard for COVID-19 protection, may expose users to dangerous levels of toxic chemicals, the *Daily Mail* reported.

The study found the chemicals released by these masks had 8 times the recommended safety limit of toxic volatile organic compounds, which can cause symptoms ranging from headaches and nausea to organ damage and cancer, with prolonged use.

Since the original mandates ended, several studies concluded the mandate policies failed to achieve their promised results.

The *Wall Street Journal* on Monday published an op-ed criticizing mask mandates.

And dissenters have taken to X (formerly Twitter), calling on people not to comply with mandates.

A Draconian New Law Went Into Effect On August 25th That Institutes Extreme Censorship Of The Internet On A Global Basis

The Internet just changed forever, but most people living in the United States don't even realize what just happened. A draconian new law known as the "Digital Services Act" went into effect in the European Union on Friday, and it establishes an extremely strict regime of Internet censorship that is far more authoritarian than anything we have ever seen before. From this point forward, hordes of European bureaucrats will be the

arbiters of what is acceptable to say on the Internet. If they discover something that you have said on a large online platform that they do not like, they can force that platform to take it down, because someone in Europe might see it. So even though this is a European law, the truth is that it is going to have a tremendous impact on all of us.

From this point forward, nothing will be the same. It is being reported that the DSA literally makes large tech companies “legally accountable for the content posted to them”...

*The European Union’s Digital Services Act (DSA) has officially gone into effect. Starting on August 25th, 2023, tech giants like Google, Facebook, Amazon, and more must comply with sweeping legislation that holds online platforms **legally accountable for the content posted to them.***

*Even though this new law was passed in the EU, we’ll likely see **far-reaching global effects** as companies **adjust their policies to comply.***

Initially, there will be [19 giant online platforms](#) that will be forced to comply with this new law...

Ranging from social media platforms to online marketplaces and search engines, the list so far includes: Facebook, TikTok, X (formerly Twitter), YouTube, Instagram, LinkedIn, Pinterest, Snapchat, Amazon, Booking, AliExpress, Zalando, Google Shopping, Wikipedia, Google Maps, Google and Apple’s mobile app stores, Google’s Search, and Microsoft’s Bing.

But starting on February 24th, 2024, the Digital Services Act will start applying to a much broader spectrum of online platforms that have fewer than 45 million monthly users.

We are being told that this new law will establish clear rules that online platforms must follow.

That will include censoring anything that is deemed “false or misleading” under the Strengthened Code of Practice on Disinformation...

*So what kind of speech is the DSA expected to police? Last year’s Strengthened Code of Practice on Disinformation defines disinformation as **“false or misleading content that is spread with an intention to deceive or secure economic or political gain and which may cause public harm.”** The code has already been put to work during elections and to “respond to crises,” **such as COVID and the war in Ukraine.***

And it really doesn’t matter if material that European bureaucrats consider to be “false or misleading” is actually “false or misleading” at all.

What matters is that if online platforms do not comply with what they are being told to do, they will pay dearly...

*Online platforms that don't comply with the DSA's rules could see fines **of up to 6 percent of their global turnover**. According to the EU Commission, the Digital Services Coordinator and the Commission will have the power to "require immediate actions where necessary to address very serious harms." A platform continually refusing to comply **could result in a temporary suspension in the EU**.*

Big tech companies will be desperate to avoid such penalties, and so they will obey.

And so that means that "hundreds of unelected EU bureaucrats" will be in control of speech on the Internet now...

*Under this Orwellian regime, **a team of hundreds of unelected EU bureaucrats will decide what constitutes disinformation and instruct Big Tech firms to censor it**. The firms themselves, faced with reputational risk and financial penalties, will have little choice other than to comply. This can be done in all manner of ways: simply by human moderators removing content, by shadow-banning problematic creators to reduce their reach, by demonetizing certain content, and by tweaking algorithms to favor or disfavor certain topics. And though, legally speaking, the DSA only applies in the EU, once installed inside Big Tech firms, **this vast content-regulation apparatus will surely affect users in the rest of the world, too**.*

We are being told that these EU bureaucrats will also be working with "trusted flaggers" to help identify content that needs to be censored...

*The DSA's "**trusted flaggers**" are entities with proven expertise in flagging harmful or illegal content to platforms. The new regulation provides that their content flagging shall be prioritized by platforms when moderating content.*

You might be tempted to think that you will be able to avoid all of this censorship because you do not live in Europe.

Unfortunately, that is simply not true.

If you post something that someone in Europe might see, your content comes under the jurisdiction of this horrifying new law.

So you need to brace yourself for a level of Internet censorship that none of us have ever seen before.

In addition, most of the large tech companies that must comply with this new law are based in the United States.

And it turns out that the Federal Trade Commission actually sent officials to Europe in March to assist with the implementation of this new law on U.S. soil...

*U.S. Senate Commerce Committee Ranking Member Ted Cruz (R-Texas) today sent letters to Federal Trade Commission (FTC) Chairwoman Lina Khan and the head of the European Union's San Francisco office, demanding answers regarding **the degree of coordination between the FTC and the EU to enforce the EU's Digital Services Act ("DSA") and Digital Markets Act ("DMA") on U.S. soil.** Both foreign laws were written to weaken American tech companies, particularly in Europe. There are no corollary federal laws to the DSA and DMA, making the FTC's efforts to conspire with foreign regulators against U.S. businesses unprecedented.*

The FTC announced in March that it was sending agency officials to Brussels to assist the EU in implementing these laws, while the EU opened a San Francisco office to pressure U.S tech companies to comply with them.

The protocols of the government meeting during which the historic Oslo Accords were approved, were published for the first time by the Israeli State Archives on Wednesday, exactly 30 years to the fateful day.

The accords between Israel and the Palestine Liberation Organization (PLO), which until then was treated by Israel as a hostile terrorist group, were meant to set up a framework leading to a final resolution of the Israeli-Palestinian conflict.

The first part of the accords was approved during the meeting on Aug. 30, 1993, and later signed in Washington, D.C., on Sept. 13 of that same year.

The Oslo I Accord, known as the 'Declaration of Principles on Interim Self-Government Arrangements' was meant to create a transitional Palestinian legislative body to govern the West Bank and Gaza Strip, which would then be empowered to sign a permanent peace agreement with Israel.

The complete set of protocols is 81 pages long, **with parts of it remaining classified for reasons of state security and not to be published for another 20 to 60 years.** The remaining classified element of the Oslo Accords will most likely contain Prince Charles of Wales involvement on behalf of Yassar Arafat.

In Blessed Hope #185 I noted the back channel efforts of Yassar Arafat to secure Prince Charles assistance in negotiating a truce. Both Arafat and Prince Charles were closet homosexuals and thirty years ago the culture was less forgiving of the Sodomite lifestyle. Princess Diana knew about Prince Charles private life and it was a factor in her murder on August 31, 1997. Prince Charles closest confidant was disgraced BBC presenter Jimmy Savile, who was publicly exposed as a pedophile following his 2011 death; became the focus of a Netflix documentary that uncovered letters between the pair. The declassified portion of the protocols, which until now was '**Top Secret,**' reveals that 16 of the government's 18 ministers voted to approve the accords.

Only then-Interior Minister Aryeh Deri, who was the leader of the ultra-Orthodox Shas party at the time, and Shimon Sheerit, then-economy minister for the Labor Party, abstained from the vote.

The protocols show that the Israeli government approved of the accords despite significant skepticism and misgivings about their chances of success, as well as numerous security challenges.

Then-Prime Minister Yitzhak Rabin noted that he saw both positive and negative outcomes as possible but stressed that the agreement would have "reversibility."

Ehud Barak, the Israel Defense Forces chief-of-staff at the time, cautioned that the agreement had "more holes than Swiss cheese," but was overruled by the government in the end.

Over 1,600 Scientists Sign ‘No Climate Emergency’ Declaration

International scientists have jointly signed a declaration dismissing the existence of a climate crisis and insisting that carbon dioxide is beneficial to Earth, contrary to the popular alarmist narrative.

“There is no climate emergency,” the Global Climate Intelligence Group (CLINTEL) said in its World Climate Declaration ([pdf](#)), made public in August. *“Climate science should be less political, while climate policies should be more scientific. Scientists should openly address uncertainties and exaggerations in their predictions of global warming, while politicians should dispassionately count the real costs as well as the imagined benefits of their policy measures.”*

A total of 1,609 scientists and professionals from around the world have signed the declaration, including 321 from the United States.

The coalition pointed out that Earth’s climate has varied as long as it has existed, with the planet experiencing several cold and warm phases. The Little Ice Age only ended as recently as 1850, they said.

“Therefore, it is no surprise that we now are experiencing a period of warming,” the declaration said. Warming is happening *“far slower”* than predicted by the Intergovernmental Panel on Climate Change.

“Climate models have many shortcomings and are not remotely plausible as policy tools,” the coalition said, adding that these models “exaggerate the effect of greenhouse gases” and “ignore the fact that enriching the atmosphere with CO₂ is beneficial.” For instance, even though climate alarmists characterize CO₂ as environmentally-damaging, the coalition pointed out that the gas is *“not a pollutant.”*

Carbon dioxide is *“essential”* to all life on earth and is *“favorable”* for nature. Extra CO₂ results in the growth of global plant biomass while also boosting the yields of crops worldwide.

CLINTEL also dismissed the narrative of global warming being linked to increased natural disasters like hurricanes, floods, and droughts, stressing that there is “no statistical evidence” to support these claims.

“There is no climate emergency. Therefore, there is no cause for panic and alarm. We strongly oppose the harmful and unrealistic net-zero CO₂ policy proposed for 2050. Go for adaptation instead of mitigation; adaptation works whatever the causes are,” it said.

“To believe the outcome of a climate model is to believe what the model makers have put in. This is precisely the problem of today’s climate discussion to which climate models are central. Climate science has degenerated into a discussion based on beliefs, not on sound self-critical science. Should not we free ourselves from the naive belief in immature climate models?”

Climate Models and Sunlight Reflection

Among the CLINTEL signatories are two Nobel laureates—physicists John Francis Clauser from the United States and Ivan Giaever, a Norwegian-American.

Mr. Clauser has made a significant [addition](#) to climate models to dismiss the narrative of global warming: the visible light reflected by cumulus clouds which, on average, cover half of the earth.

Current climate models vastly underestimate this aspect of cumulus cloud reflection, which plays a key role in regulating the earth's temperature. Mr. Clauser previously told President Joe Biden that he disagreed with his climate policies.

In May, Mr. Clauser was elected to the board of directors at the CO2 Coalition, a group focusing on the beneficial contributions of carbon dioxide in the environment.

“The popular narrative about climate change reflects a dangerous corruption of science that threatens the world’s economy and the well-being of billions of people,” Mr. Clauser said in a May 5 statement.

“Misguided climate science has metastasized into massive shock-journalistic pseudoscience. In turn, the pseudoscience has become a scapegoat for a wide variety of other unrelated ills.”

“It has been promoted and extended by similarly misguided business marketing agents, politicians, journalists, government agencies, and environmentalists. In my opinion, there is no real climate crisis.”

False Doomsday Predictions, a Presidential Issue

CLINTEL's declaration against the climate change narrative counters propaganda spread by climate alarmists who have long predicted doomsday scenarios triggered by global warming—none of which have ever come true.

In 1970, some climate scientists predicted that the earth would move into a new ice age by the 21st century. Pollution expert James Lodge predicted that *“air pollution may obliterate the sun and cause a new ice age in the first third of the new century,”* according to The Boston Globe.

In May 1982, Mostafa Tolba, then-executive director of the United Nations environmental program, said that if the world did not change course, it would face an *“environmental catastrophe which will witness devastation as complete, as irreversible, as any nuclear holocaust”* by 2000.

In June 2008, James Hansen, director of NASA's Goddard Institute of Space Sciences, said that within five to 10 years, the Arctic would have no ice left in the summer.

As climate alarmists continue to spread propaganda about global warming, the topic has become an issue in the 2024 presidential race, with multiple candidates openly dismissing it.

In a July 13 [post](#) on X, Democrat presidential candidate Robert F. Kennedy Jr. said that climate change *“is being used to control us through fear.”*

“Freedom and free markets are a much better way to stop pollution. Polluters make themselves rich by making the public pay for the damage they do,” he said.

During the first [2024 GOP presidential debate](#), candidate Vivek Ramaswamy called climate change a *“hoax.”*

“The reality is, the anti-carbon agenda is the wet blanket on our economy. And so the reality is, more people are dying of bad climate change policies than they are of actual climate change,” he said.

High Temperatures, Biden’s Appliance Crackdown

Climate activists have insisted that global warming is responsible for the soaring temperatures across the United States, even claiming that temperatures are hitting record highs.

In a recent interview with *‘The Epoch Times’*, John Christy, a climatologist and professor of atmospheric science at the University of Alabama in Huntsville, [dismissed the narrative](#) of record high temperatures.

“Regionally, the West has seen its largest number of hot summer records in the past 100 years, but the Ohio Valley and Upper Midwest are experiencing their fewest,” he said.

“For the conterminous U.S. as a whole, the last 10 years have produced only an average number of records. The 1930s are still champs.”

Climate change policies have been used to justify sweeping lifestyle changes across the United States by the Energy Department, like [restricting home appliances](#), and sometimes, even outright banning them.

In June, the Energy Department proposed rules that would require ceiling fans to become more energy efficient, a development that could lead to manufacturers having to shell out \$86.6 million per year in *“increased equipment costs.”*

In February, the DOE proposed energy efficiency rules targeting gas stoves that would affect half of all new models of such stoves sold in the United States while making most of the existing ones noncompliant.

In July, the U.S. Consumer Product Safety Commission proposed a policy that would remove nearly all existing portable gas generators from the market.

The Biden administration has already implemented a ban on incandescent light bulbs, which came into effect on August 1st, 2023.

- “I plan on publishing an exhortation, a second *Laudato Si'*,” the Pope said. “Let us join our Christian brothers and sisters in the commitment to care for creation as a sacred gift from the Creator.”
- “It is necessary to stand with the victims of environmental and climate injustice, striving to end the senseless war on our common home which is a terrible world war. I urge all of you to work and pray for it to abound with life once again.”
- “In the Message, the Pope says we must resolve ‘to transform our hearts, our lifestyles, and the public policies ruling our societies.’”

- *“He also returned to the topic of ecological conversion and the need to no longer consider creation as an object to be exploited, but as a reality to be safeguarded as a ‘sacred gift from our Creator’.”*

Pope Francis wants to establish the blueprint that will guide our societies and, allegedly, better our future. He is fulfilling his prophetic role of uniting political and religious powers into one common vision and mission. *In Laudato Si’, Pope Francis outlines his Jesuit plan for economic, environmental, and social policies aimed at reshaping the world. He believes that his strategies will unite the people, solve society’s problems, and establish a global era of peace and justice.*

What Francis does not note in his message is the fact that cheap, abundant fossil fuels are a hugely important factor in economic development and one of the key reasons there are prosperous nations in the first place.

Because of the color of her clothing, she is also referred to as the scarlet woman of Revelation.

While modern implications of the color scarlet include infidelity, in the first century when the book of Revelation was written, clothing of a reddish-purple color was *“much prized”* and was “commonly worn by persons of rank and wealth, -(Mark 15:17, Mark 15:20, Luke 16:19). The purple color contains more blue than the crimson, though the limits are not very accurately defined, and the words are sometimes interchanged. Thus the mock robe put on the Saviour is called in Mark 15:17, Mark 15:20, πορφύραν ***porphuran***—‘purple,’ and in Matthew 27:28, κοκκίνην ***kokkinen***—‘crimson’”

The point behind being dressed in purple and scarlet is that the woman appears to be a woman of wealth and authority. This color of clothing complements her also wearing gold, precious stones and pearls and her use of a golden cup.

The contrast to this beautifully impressive exterior is that her cup is filled with ***“abominations and the filthiness of her fornication”*** (vs. 4). In other words, she deceives many by her appearance. Although she looks beautiful and has the trappings of wealth, luxury and authority, her actions are an abomination to God. The Vatican is a playground of demons. Pope Francis is the ideal match made in hell as the False Prophet cheerleader of the Antichrist, Prince Charles. **The timing of Pope Francis and his *Laudato Si’* and *ecological conversion* with Prince Charles SDGs replacing theology with ecology nonsense cannot be a coincidence! And the clock winds down!**

With all the evil and chaos being unleashed on humanity it is normal for people to feel depressed and discouraged. Fortunately, God gave us the Bible that told us what to

expect with the appearance of these two servants of Satan. Can you imagine what life without the Old Testament would be like for a Christian today? Our knowledge would be incomplete. We would be unable to appreciate fully the passages in the New Testament that speak of men and women such as Adam, Eve, Abraham, and Sarah, as well as events such as the Flood and the Exodus from Egypt. Our understanding of Jesus as the prophesied Messiah and the Great High Priest would be limited in the absence of books like Psalms, Isaiah, and Leviticus. God still expects us to be educated in the Old Testament Scriptures. The apostle Paul wrote, ***“Whatever things were written before were written for our learning that we through the patience and comfort of the Scriptures might have hope”*** -(Romans 15:4). One of the main reasons we need to read and study the Old Testament is so we might have a better knowledge of the New. This especially is true when studying one of the most misunderstood books in the world—the book of Revelation.

Of the 404 verses in the book of Revelation, at least 278 of them make some allusion to the Old Testament. That is 68.8% of the verses! And some of these verses contain two, or even three, allusions to the Old Testament. The book of Revelation does not tell whence from these allusions came. However, by a careful study of the Bible, we can understand that most of them come from the prophetic books of Isaiah, Ezekiel, Daniel, and Zechariah. Thus, it is essential to have some knowledge of the Old Testament before studying the book of Revelation. For example, before reading the apostle John’s vision of the seven golden lampstands in Revelation 1, a student should realize that such language had been used when Zechariah had a similar vision in chapter 4 of the book that bears his name. Prior to reading John’s vision of a ***“new heaven”*** and ***“new earth”*** -(Revelation 21:1), a person might want to read Isaiah 65 and 66 to understand that such language had been used long before Revelation ever was written.

It is observed that the book of Revelation contains citations from, or allusions to, 28 of the 39 books of the Old Testament. There are 505 such citations and allusions, some 325 of which are to the prophetic books of the Old Testament – Isaiah, Jeremiah, Ezekiel, and Daniel in particular. Of the Minor Prophets, references to Zechariah, Joel, Amos, and Hosea are most common. Of the books of the Pentateuch, the greatest use is made of Exodus, and of the poetic sections, Psalms.

Certainly then, by having a good knowledge of the Old Testament, and especially such books as Isaiah, Ezekiel, Daniel, and Zechariah, one likely will have an easier time understanding the book of Revelation.

The close connection between the Old and New Testament is shown by the number of times the Old Testament is quoted in the New Testament. Bagster’s Bible gives 889 quotations and allusions. George F. Pentecost gives the number at 885, a few of the allusions given by Bagster’s Bible being disputed. Every book of the Old Testament is quoted except Obadiah, Nahum, Zephaniah, and Esther. There is only one quotation from the Song of Solomon. According to Dr. Pentecost the number of the Old Testament quotations and allusions in each New Testament book is as follows:

As any Bible student or scholar will tell you, if you have read the end of the Bible, you know that we do win! With God's way of revealing history in advance for us, we can be pumped up by what all that is occurring in the world. It grieves our hearts and minds to see the onslaught of the Tribulation, with the events in Maui and the crimes against humanity. They are a sample of what is coming before God puts an end to it all!

Using my analogy of "*it is baked into the cake*" approach to studying Bible Prophecy through the perspective of "History told in advance" I have been able to establish an order of events that fits the scenario between now and the mid-point of the Tribulation when the Antichrist sits himself down in the Temple (yet to constructed).
