Many are unaware of what is going on around them, and other than to sense that things are going sideways in the world today, most of the masses are “woke” in the dark so to speak. My wife will do a Kroger order for pickup on Friday, and there are always two or three items that she can't get which state unless she orders for delivery or she actually goes into the store they can't be put in her scheduled pickup time slot.

It seems to me this is nothing more than a plan to irritate their customers by creating unpleasant shopping experiences. **Two of the richest U.S. men in the world are Michael Bloomberg and Larry Fink that are deeply connected with the Net-Zero carbon footprint scam of Prince Charles “Sustainable Development” program begun several decades ago.** Back in 2019 more than 1,300 top level executives and directors of Fortune 500 suddenly decided to retire at about the same time.

Chief executives were leaving in record numbers in 2019, with more than 1,332 stepping aside in the period from January through the end of October, 2019 according to new data released. While it's not unusual to see CEOs fleeing in the middle of a recession, it is noteworthy to see such a rash of executive exits amid robust corporate earnings and record stock market highs.

Last month (September, 2019) 172 chief executives left their jobs, according to executive placement firm Challenger, Gray & Christmas. It's the highest monthly number on record, and the year-to-date total outpaces even the wave of executive exits during the financial crisis.

The list of CEOs stepping down includes some who have left amid controversy. McDonald's announced on Sunday it was "separating" Steve Easterbrook as president and CEO after he admitted having a consensual affair with another employee. WeWork's founder and CEO Adam Neumann stepped down two weeks ago, accepting a \$1.7 billion golden parachute in exchange for walking away from a disastrous IPO. That same week, Kevin Plank, the billionaire founder of leisure wear firm Under Armour, confirmed he was stepping down. Under Armour confirmed it is the subject of a federal accounting probe. Nike's longtime CEO Mike Parker resigned the same day, as did the head of eBay.

McDonald's CEO fired over 'poor judgment' in relationship with employee.

Controversy or not, it's a pace not seen since 2002. The last big wave of CEO departures came in 2008, at the start of the financial crisis, according to the company's data.

"You expect a high turnover during a recession period," Andrew Challenger, the company's vice president, told NBC News. "To see more turnover during a period where companies are doing very well is surprising."

However, plump exit packages can make it tempting for chief executives to throw in the towel. Fears of an impending recession may also prompt leaders to step down to get ahead of risks to their legacy, said Nell Minnow, an advocate for corporate governance and vice chair of ValueEdge Advisors.

The #MeToo movement has felled a fair number of leaders, from CBS chairman and CEO Les Moonves to billionaire casino magnate Steve Wynn and Intel's chief Brian Krzanich. It's a sign not just of heightened accountability, but of investor pressure, experts say.

"You could say there's a cancel culture in the boardroom," said Minnow. "Boards have been too compliant and they're finally recognizing it's their job to be vigilant about chief executive misbehavior."

Typically, chief executives last just five years in their jobs, according to a study from business consultancy PricewaterhouseCoopers, which also found that in 2018 more chief executives left because of lapses in ethical conduct than for the typical complaint of poor financial performance.

"McDonald's is yet another example of how the #MeToo movement has entered the boardroom," said Amelia Miazad, director of the Business in Society Institute at the

University of California Berkeley Law school. *"We can expect to see more corporate boards institute a zero tolerance policy."*

However, in some cases, pressure from activists and regulators can end up pushing boards to oust a leader for no reason other than *"a stock pop,"* said Jeffrey Sonnenfeld of the Yale School of Management, who has been studying chief executives since the 1970s.

"They go for the symbolism of sacrificing a CEO. That just creates disruption and many, many good people have been forced from office," Sonnenfeld told NBC News, noting that companies who fail to genuinely address values and issues simply end up with another leader to face the music.

This sudden mass exodus of corporate executives in 2019 may have been related to what was occurring in the push to implement the "Sustainable Development" agenda. The resignation of corporate board members was even greater from sources from what I have read. Board members get lucrative salaries for what amounts to routine business actions. Boards of directors are usually connected through their interlocking relationships as CEO's and corporate heads of other companies.

"There's a tremendous supply and very little demand," says Peter Gleason, NACD's president and chief executive officer. The number of publicly traded companies in the U.S. dropped from 8,090 in 1996 to 4,744 at the end of 2019, according to the World Bank. Most boards don't have term limits, although many have mandatory retirement ages, such as 70 or 75; however, only 16% of S&P 500 company directors are within three years of hitting that cap, according to Spencer Stuart, a global executive search and consulting firm.

Although serving on a nonprofit board can be fulfilling, it's unusual to be paid. *"Only 2% of nonprofit organizations pay their board members, and they tend to be really large, such as hospitals,"* says Andy Davis, associate vice president of education and outreach at BoardSource, a nonprofit that researches and advises nonprofit boards. *"There may be reimbursement for expenses, but actual salaries are pretty rare."* Of the 1.6 million nonprofits, the vast majority have less than \$1 million in revenue and often want you to pay for the honor of serving on the board by making a donation to the organization.

Private companies can range from tiny startups that offer board members only equity to multibillion-dollar corporations that pay a salary. According to the NACD, overall annual director compensation at a large private company is about \$115,000 per year.

Public companies, whose boards typically meet more often, pay the most; according to NACD, the median package for a director's compensation is \$214,115. A Spencer Stuart 2020 board trends report says the average total compensation for a nonemployee on the board of an S&P 500 company is a little more than \$300,000,

usually a combination of cash and stock. That amount varies not just among boards but within one depending on, among other things, the board member's leadership role and the number of committees the director serves on.

What do you have to do in return? A board director works a median of 205 hours annually on a private board, according to NACD, and 250 hours on a public board. Board meets as little as once a month, and it's usually a day-long event. A board member may sit on two different committees that meet quarterly, with often a fair amount of homework to do between meetings.

When Toyota's North American operations announced executive leadership changes in June of 2022 it was stated in its replacement statement, *"designed to continue driving growth, fostering strong dealer and customer relations, achieving carbon neutrality goals and becoming the Mobility company of choice for consumers."*

This statement sounded to me that many at the top management were resisting Prince Charles "Sustainable Development" plans from the WEF and were taking their "golden parachute" and jumping off the corporate treadmill. I have seen that statement *"achieving carbon neutrality goals"* on enough corporate business statements to know that business management are under great pressure to conform to Prince Charles plan for his new world order.

When you've built a financial information and media empire and become the world's [seventh richest person](#), you get to say dumb things, like suggesting that [farming is easy](#): *"You dig a hole, put a seed in, put dirt on top, add water – and up comes the corn."*

Being ultra-wealthy also shields Michael Bloomberg from any fallout from the climate and energy policies he pursues so zealously. He will doubtless be able to afford electricity at any price for his multiple mansions, from any source, backed up by

thousands of battery modules to cover the repeated blackouts his policies will unleash. The other 99.9% won't be so fortunate.

Mr. Bloomberg bankrolls campaigns against coal and natural gas; supports efforts to populate the Biden Administration with rogue regulators equally intent on “transforming” America’s energy system, society, and living standards; and champions ESG principles for financial firms, companies, and investors. His company even has Sustainability and ESG & Climate divisions. Mr. Bloomberg serves as UN Special Envoy on Climate Ambition and Solutions, enabling him to advance his agendas internationally.

ESG (Environmental Social Governance) helps unelected asset managers use their control over trillions of investment dollars to pressure companies, lenders, and consumers to embrace far-left activist versions of public welfare and justice, even if it causes clients’ portfolio values to decline. ESG is a subversive way to bypass legislatures, voters and democratic processes, to impose unpopular political and ideological agendas, often in violation of fiduciary obligations.

ESG opposes fossil fuels, insisting they are causing climate cataclysms. Any company in that business, or offering to finance a drilling project, gets blackballed. But companies building or financing “clean, green” energy score in the ESG stratosphere – even though most such projects destroy vast swaths of wildlife habitats, involve slave and child labor, and leave widespread toxic pollution in their wake. ESG human rights, ecological, and climate justice principles are duplicitous and hypocritical.

As New York City mayor, Mr. Bloomberg infamously advocated exorbitant taxes on large sugary drinks, claiming they lead to obesity and thus to diabetes, cancer, heart disease, and premature death. He simply wanted to help poor people live longer, he asserted, by making Big Gulps less affordable.

It’s thus puzzling that he now wants to banish reliable, affordable gas heat and coal- and gas-generated electricity for heating and air conditioning – in favor of pricey, weather-dependent wind and solar power backed up by outrageously expensive batteries. Those policies *shorten* lives.

Even if man-made or natural climate change causes average global temperatures to climb 2-3 degrees, modern technologies will keep us safely comfortable. But if laws, policies, and ESG pressures make heating and AC inaccessible or unaffordable, indoor temperatures can soar 15-25 degrees in summertime and drop as precipitously in wintertime. People die – and cold is far deadlier than heat.

When people, especially the elderly, cannot heat their homes properly, they can perish from hypothermia or illnesses they would likely survive if they weren’t so cold. *The Economist* calculated that expensive energy may have killed 68,000 more Europeans than Covid did last winter.

LIHEAP (Low Income Home Energy Assistance Program) will help the poorest families – until the subsidy money runs out – but not middle/working classes, and not small businesses.

Even worse, three billion people worldwide still do not have access to reliable, affordable electricity. Message to climate zealots like Mr. Bloomberg: Access to intermittent, unpredictable wind/solar electricity doesn't count, especially if it's only enough to charge a cell phone or power a lightbulb or one-cubic-foot refrigerator. Lack of access to sustained, affordable energy *kills*.

The billionaire's legal power grab is even more insidious and dangerous to democracy.

In 2017 he began [covertly funding](#) New York University Law School's State Energy and Environmental Impact Center, which provides grants to progressive (Democrat) state attorneys general, enabling them to hire "special assistant" AGs or "fellows."

[The Center's mission](#) is to provide "direct legal assistance" to interested AGs "on specific administrative, judicial or legislative matters involving clean energy, climate change and environmental interests of regional and national significance," when AGs say they lack sufficient public funds to hire such help.

[NYU now says](#), "the fellows' sole duty of loyalty is to the attorney general in whose office they serve." However, these partisan Bloomberg grants pay salaries and "generous benefits packages" to "special assistants" whose functions are dictated by the Center; address specified "regional and national" issues normally beyond the purview of state AGs; are routinely coordinated with energy and climate activists and donors to those causes; and often [launch "public nuisance" or RICO litigation](#) against oil companies, to the detriment of targeted industries and the consumers and ratepayers who depend on their products, within the AGs' home states and in distant states and communities.

It is the Bloomberg agenda that is being served, by grants that effectively conscript and co-opt the public authority and power of the attorney general's offices.

[As a 2022 report](#) by the American Tort Reform Foundation notes, "These SAAGs are private attorneys placed in public positions to exercise government authority. Yet, they are not independent or impartial because their mandate is to carry out an overtly political agenda funded by wealthy private donors."

This "unique" arrangement, the Foundation continues, "allows well-heeled individuals and organizations to commandeer state and local police powers to target opponents with whom they disagree, raising the specter of corruption and fundamental unfairness in what should be public enforcement of the law."

Those same considerations also appear to raise fundamental ethical, legal, and constitutional issues. They certainly raise questions about laws governing gifts,

campaign contributions, and bribes – and where Bloomberg-funded lawyers are involved in prosecutions, serious due-process concerns.

And yet the NYU Center has already placed at least [11 special assistants](#) in eight state attorney general offices, which have filed at least 20 lawsuits against a few selected oil companies, charging them with “climate denial” or causing planetary warming, rising seas, more frequent and intense hurricanes and tornadoes, and other “offenses.”

This litigation ignores the actions of hundreds of other oil and gas companies across the globe; steadily rising emissions from China, India, and other rapidly developing nations; the role of natural forces and [emissions from wind turbine](#), solar panel and battery mining, processing, and manufacturing; the [lack of evidence](#) to support claims of a climate “crisis” or more frequent and violent storms; and the fact that these issues should be litigated in federal courts or relegated to a democratic political process.

The U.S. Supreme Court recently had an opportunity to quash this rampant litigation but chose not to review the state and local cases and send them to *federal* courts. The seemingly endless lawsuits and acrimony are creating a legal, constitutional, scientific and public policy nightmare for businesses, consumers, courts, states, and the nation.

Rest assured, Zionist billionaires like Bloomberg, Gates, Kerry, Zuckerberg, and Soros – who demand that we commoners give up our cars, gas stoves and furnaces, steaks, air travel, and suburban homes – don’t intend to give up anything.

Let’s hope the pro-America governors, AGs, legislators, judges, and business groups battling ESG and other woke campaigns tackle this NYU Impact Center hornets’ nest as well.

"And we're now at seven, so we have to get back down."

"I hope that this can be slow, relatively slow, and that it can be done in a way which is relatively equal, you know, so that people share the experience."

In a recent *Lifeway* poll they found only 2% of churches in the USA teach Bible prophecy. This is an amazing latter-days statistic for several reasons:

1- Roughly 30% of the Bible is prophetic. They’re ignoring almost 1/3 of the Scriptures. [Actually, when viewed through the perspective of history being told in advance that percentage is much greater than 30%]

2- 100% accuracy in past prophecies fulfilled literally separates the Bible from every other book on the planet. It not only claims to be written by God, it proves it by predicting the future.

3- The entire Book of Revelation was prophetic when written. Today everything from Revelation 6 forward is still in the future and likely to be fulfilled within the next 7 years.

4- The Book of Revelation is the only book that promises Believers a special blessing for even trying to read and understand it.

“Blessed is he who reads and those who hear the words of the prophecy, and heed the things which are written in it;” -(Revelation 1:3)

Someone once wrote comments on Revelation 13:16-17 (Mark of the Beast) in a turn-of-the-19th-century commentary. The writer explained that each bank could have a person standing inside with a list of those forbidden to bank, and unless you got the OK-nod from him, they wouldn’t let you transact business.

That is nonsense and naive to us, but it just goes to show you that people over a hundred years ago were studying the Book of Revelation, as best they could, and receiving God’s blessings for the effort.

The Book of Revelation is a critical source to understand prophecy today. It’s sort of an organized outline of most of the major Old Testament prophecies of the latter days. Plus it adds critical info that helps make more sense of the 2,600-year-old prophecies.

The word “Revelation” in the Greek is “**Apocalupsis**.” This is why it is often referred to as “The Apocalypse,” which is from the verb “**Apocalupto**” which means “**to unveil**” and the word “**Kalumma**,” which is “**a veil**.”

Therefore **Apocalupsis** means “**the taking away of a veil**.” And because the book is primarily dealing with the seven years of Tribulation, it’s most important to those of us

living just before the Rapture. Jesus is pulling back the veil so we can see how it all fits together.

The Book of Revelation is largely written for the Jewish people. This is seen in its “signs” and “symbols” like the Tabernacle, the Ark, the Altar, the trumpets and plagues, and of course the sealing of the 144,000 JEWISH evangelists preaching the Gospel of Jesus Christ to the world. God chose the Jewish people for the purpose of revealing Himself to the world He created. God chose the Jews for a specific purpose but they would not follow His teachings and disobeyed God’s plan for them to reveal Himself to the world. They simply blew it and all that Old Testament has served to show how God used them despite their disobedience.

But the Church is in chapters 2 and 3, Israel in chapters 6-19 and the nations of the world in chapters 20-22. It reveals God’s ultimate plan, a new heaven and earth. Chapter 4 unveils the Rapture and the church is never mentioned until the last three chapters are revealed.

Just before Jesus’ crucifixion, His disciples asked Him when would the end of the age (not the end of time) come about? Jesus said no one knew the day nor the hour, not even Him, only the Father.

“But of that day or hour no one knows, not even the angels in heaven, nor the Son, but the Father alone.” -(Mark 13:32)

That was obviously true when Jesus told His disciples. But it’s not true today because in Revelation 6 we see Jesus having qualified to receive all knowledge through His sinless life and atoning death on the cross. Today, He can’t make that same statement because He DOES know.

In the Book of Daniel, it says to “seal up” the words until the end of the Times of the Gentiles. In the Book of Revelation, which dovetails with Daniel, John is told to “seal NOT the words for the time is at hand”... meaning the Church Age.

“The secret things belong to the LORD our God, but the things revealed belong to us and to our sons forever, that we may observe all the words of this law.” – (Deuteronomy 29:29)

This explains that the Book of Revelation is Jesus revealing His wrath and purpose while shedding light on the time at hand. After the Rapture, God will deal with the disobedient Jews and unbelieving Gentiles during the “Seven” years of the Tribulation!

In extreme cases, forest fires can reach temperatures of up to 1,500 degrees Fahrenheit, and the melting point of aluminum is 1,220 degrees Fahrenheit. So it is possible for an extreme forest fire to melt aluminum. But there are cars with puddles of melted aluminum that were clearly not in the wildfire area. And melted glass, which has a melting point of around 2,500 degrees Fahrenheit. These are unexplained anomalies. In the California fires of 2018, cars were randomly bursting into flames on the freeway with no surrounding fires. We've seen these same anomalies in New York City on September 11th, 2001. Cars completely burned out with no explanation.

The Rapture of Christian believers will be followed closely together with the Isaiah 17:1-2 and Ezekiel 38 prophecies in tight sequence formation. World War III ensues in the cluster of those two prophecies. The Antichrist Prince Charles wants and needs a world war to destroy the major power states of China, Russia, and the U.S. Prince Charles and Pope Francis keep fanning the flames for a larger war in what is the bread basket of central Europe, the Ukraine. They talk peace and unity and at the same time are urging Ukraine to get tough with Moscow. Not until the major power states destroy each other can Prince Charles assert his control of the world.

On 30 August, Ukrainian Air Force spokesman Yury Ignat said that 60 F-16s would be enough for the Ukrainian military to carry out combat missions to counter air strikes. At

the same time, the country's authorities earlier said they would need 128 F-16s to fully re-arm their air force by replacing Soviet-made fighters with Western ones.

"Today we have agreements on 50-60 airplanes," he said in an interview with the Portuguese broadcaster RTP. *"They will not be delivered all at once. In all we need around 160 [F-16s] to have a powerful air fleet that would prevent Russia from dominating the skies"* and enable Ukraine to maintain air defense and control shipping in the Black Sea.

On August 20, Zelensky announced what he described as a *"breakthrough agreement"* with the Netherlands on the supply of 42 F-16 fighter jets to Kiev. Denmark also said it was ready to provide 19 F-16 fighter jets to Ukraine. The first 6 planes are due to arrive by the end of this year. Denmark and the Netherlands have already announced the training of Ukrainian pilots with assistance from another nine other countries. This is de facto proof of the NATO/US intent to start a war with Russia.

Paul had taught that there are two unmistakable signs that the judgment of the world had commenced. The first was the Rapture of the Church and the second was the revelation of the Antichrist. This is the name we use to identify the last world dictator, called by Paul, *"that man of sin"*. Many people in history have been identified as the Antichrist because they have been against God. But *"anti"* also means *"instead of"*. This man will not only be anti-God, but he will demand universal worshiped instead of God.

Who is Antichrist? God's Word is very clear as to the origin of the Antichrist; he arises as head of a revived Roman Empire. In chapter 7 of the Book of Daniel, when introduced to the fourth beast representing the Roman Empire, Daniel was told that the ten horns on its head represented ten kings that will rule this kingdom and that *"another shall rise after them"*. He would *"speak great words against the most High, and shall wear out the saints (the Jewish people) of the most High...and they (the Jewish people) shall be given into his hand until a time and times and the dividing of time"* -(Daniel 7:25).

so that he as God sitteth in the temple of God, shewing himself that he is God” -
(2nd Thessalonians 2:3-4).

People easily fall into the trap thinking that the Temple has to exist before the Rapture. That is a misreading of the text. The punctuation in English is based upon a series of independent clauses or statements, made by Paul here to demonstrate what ***“that man of sin”*** will do. The only thing in Scripture that is determined is that the Temple has to be built before the halfway point of the “Seven” year Tribulation.

Antichrist’s first appearance in the Book of Revelation is as the first seal judgment is opened at the beginning of the Tribulation -(Revelation 6:2). Here he is seen as a rider on a white horse going forth ***“conquering, and to conquer”***. The rider has a bow but no arrow, indicating that his rise to power will be by peaceful means. This treaty with Israel will allow a Jewish Temple to be built on the Temple Mount at Jerusalem.** It is entirely possible that Prince Charles confirmation of those Oslo Accords will not go as planned: ***“And he shall confirm the covenant with many for one week; and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate.***

Antichrist’s power for the first three-and-a-half years will be confined mainly to the West as he leads a European confederation of ten kings. His first conflict will come when he invades the Middle East to deal with a threatened invasion by Egypt upon Israel -(Daniel 11:40). This will give Antichrist the excuse to move a peace-keeping military force into ***“the glorious land”*** (Israel) and ***“many countries”*** in the region. Countries immediately to the east of the Jordan River will be the exception. The Biblical land of Edom, Moab and Ammon, will not be taken. Perhaps Jordan will be confederate with him. Following his conflict with Egypt, he will amass wealth and resources to extend his power. ***“He shall have power over the treasures of gold and silver, and over all the precious things of Egypt”*** -(Daniel 11:43). Perhaps all trade will be done in the Euro thus giving him power over every economy on earth.

Ezekiel 29:6-12 mentions the ***tower of Syene even unto the border of Ethiopia***. Gary Stearman wrote, “It’s not often that one can point to a physical object at a specific geographical location in the contemporary world, and identify it as being the focus of a biblical prophecy that was written long before Christ. Yet, that is exactly what we can do in the case of a remarkable manmade edifice in Egypt that didn’t exist until 1970. It is a 230-foot tower, called the ***“Lotus Tower,”*** because it is topped by the five petals of the lotus blossom. The tower was designed as a token of Arab-Russian friendship, its five petals perhaps signifying the five pillars of the Islamic faith. It is only 49 years old, yet Ezekiel referred to it by name ... twice.”

In the 29th and 30th chapters of his prophecy, “*the tower of Syene*” is mentioned as a landmark that is specifically related to the fulfillment of latter-day prophecy. In fact, this prophecy is profoundly powerful, sounding the death knell of Egypt.

¹¹No foot of man shall pass through it, nor foot of beast shall pass through it, neither shall it be inhabited forty years. ¹²And I will make the land of Egypt desolate in the midst of the countries that are desolate, and her cities among the cities that are laid waste shall be desolate forty years: and I will scatter the Egyptians among the nations, and will disperse them through the countries” - (Ezekiel 29:6-12). You may still be wondering about the new Temple, about its construction, etc. In past articles I have written I shared information from personal experience. Back in the fall of 1969 and well into late 1970, my three year old son and I would watch the freight trains at the west end of the Pitcairn, PA yard of the former Pennsylvania Railroad. Almost every day, a freight train that originated in East St. Louis, IL would arrive at the Pitcairn yard with from 4 to 8 open gondola cars on the headend of the train. Each car contained from two to six large blocks of cut limestone depending on size and weight. The train would get inspected, a new crew and then continue on east to its port destination in New Jersey.

The gondolas had manifest placards on the sides for switching crew purposes that read: “Kearney, NJ - For Export to Israel”. Each of the cut stones was spray painted “neon orange” letter/number identifying location points in the final assembly construction. The limestone blocks were part of an original order for 60,000 tons of pre-cut Bedford, IN limestone. The actual order was a 1972 feature article in the magazine ‘*Christianity Today*’. By Michael Snyder. August 31, 2023: Consumer confidence is plummeting, large corporations are conducting mass layoffs all over the country, and major retailers are really struggling right now. Meanwhile, some of the smartest guys in the financial world are making moves that would only make sense if the economy was headed for big trouble. Earlier this month, I wrote about how Michael Burry has bet 1.6 billion dollars that the stock market is going to crash. Berkshire sold a net \$8 billion of stocks and slowed its pace of buybacks last quarter, sparking a 13% rise in its money pile to a near-record \$147 billion.

The sprawling conglomerate has now disposed of a net \$33 billion of stocks over the past three quarters, fueling a \$38 billion increase in its stash of cash, cash equivalents, and Treasury bills during that time.

Buffett’s second-quarter moves “are consistent with the anticipation of a recession and the fact that stocks are currently pricey,” Hanke told Insider.

Burry and Buffett are both extremely sharp, and they clearly understand what the economic numbers are telling them.

At this moment, most U.S. consumers are struggling to make ends meet from month to month and millions of them are absolutely drowning in debt.

And the latest consumer confidence figures are downright dismal...

Consumer confidence cratered in August, falling from a downwardly revised 114.0 last month to 106.1. The projection was for a slight increase to 116.

Americans don't think the economy is doing well currently. The Present Situation Index—based on consumers' assessment of current business and labor market conditions—fell to 144.8 from 153.0.

And they don't think the economy is going to do well in the near future. The Expectations Index— based on consumers' short-term outlook for income, business, and labor market conditions—declined to 80.2 in August. That reversed July's sharp uptick to 88.0.

An Expectations Index below 80 generally signals an impending recession.

So that means that we are almost to the level that “signals an impending recession”. Of course other numbers suggest that a major downturn has already arrived. When the economy is booming, FedEx and UPS have to schedule more flights because they have so many packages to handle. But at this point the number of package flights is falling precipitously...

The number of package flights operated by FedEx Express and UPS significantly declined month over month in July, underscoring how far the overall air cargo market has sunk since the spring of 2022 and the effect of efficiency initiatives the companies have undertaken in response to lower express volumes.

FedEx (NYSE: FDX) flew 9% fewer domestic flights last month than in June following small sequential gains the prior two months, with year-over-year flight activity down 14%, according to an analysis by investment bank Morgan Stanley. The year-over-year decline in UPS' flight activity accelerated to 13% from 10% in June. UPS (NYSE: UPS) reduced July flights by 14% from June. Flight activity in May and June, by comparison, was relatively stable.

At the same time, big companies all over America continue to lay off more workers.

Right now, we are seeing a lot of large financial institutions let people go as turmoil in the banking industry continues to spread...

BMO Financial Group, Wells Fargo, and USAA have reported hundreds of layoffs to state officials in recent weeks as the U.S. banking industry continues to downsize.

The job cuts come as banking executives express caution about the industry's growth prospects in the second half of the year, and as some banks divest certain parts of their businesses.

Sadly, this is just the tip of the iceberg.

There will be many more layoffs in the months ahead.

Needless to say, the second half of 2023 will not be a particularly good time for retailers.

In fact, Best Buy is already projecting that sales will fall this year more than originally anticipated...

U.S. shoppers have continued to pull back on tech spending, according to the latest earnings report from Best Buy.

The retailer on Tuesday lowered the high end of its full-year revenue outlook amid declining sales, and now expects to make between \$43.8 billion and \$44.5 billion in revenue during fiscal year 2024, down from its prior guidance of up to \$45.2 billion. Comparable sales from stores, websites and call centers open at least 14 months are expected to dip 4.5% to 6% this year, compared to the previous estimate of 3% to 6%. And we have just learned that Rite Aid is suddenly on the verge of filing for bankruptcy...

Philadelphia-based Rite Aid's stock price dipped more than 50% Friday after the reports on the pending bankruptcy filing were published by The Wall Street Journal and Bloomberg, citing people familiar with the matter. The Chapter 11 filing would allow the company to restructure its more than \$3 billion debt load and help it address lawsuits alleging the company filled hundreds of thousands of opioid prescriptions unlawfully.

Every day, we hear of even more retailers that have gotten into trouble.

Stores are being shut down all over the nation at a frightening rate, and this is particularly true in many of our core urban areas.
