

# The Blessed Hope!

**“Looking for that blessed hope, and the glorious appearing of the great God and our Saviour Jesus Christ;” –(Titus 2:13)**

Bible prophecy is quite clear that there will be seven years of Tribulation immediately preceding the Lord's return to reign. That period is divided into two periods of 1,260 days. Antichrist will move into the Jewish Temple halfway through the seven years and once the Tribulation begins it will be possible to count the days to the return of Christ. So what did Jesus mean? There is an event which will trigger the beginning of the Tribulation and that event is the Rapture of the Church. King Charles and the Globalists are meeting September 18-19 at which they will plot how to accelerate goals of UN Agenda 2030 and the complete digitization of humanity. **In the wake of the Covid pandemic in 2020, Schwab and the WEF released a new book and agenda which they branded ‘The Great Reset,’ where they saw this massive crisis as a “narrow window of opportunity” to radically transform the world from physical and tangible to virtual and digital. Everything in this new world is connected, every appliance, every vehicle, every highway and light post, every home, every single body. Hence, the call for not only an *Internet of Things* but an *Internet of Bodies*.**

**As Harari stated, the surveillance that humans fully accepted as part of the *new normal* during the pandemic would soon make the next great leap. He predicted, when it comes to surveillance “now it’s going under the skin.”**

**Harari said: “When people look back, the thing they will remember from the Covid crisis is that this is the moment when everything went digital ...when everything became monitored.”**

But it's more than just the UN and WEF who are behind the Great Reset of humanity and the pressure to change the way we live, forcing us into what they would call a higher state of consciousness in which, aided by artificial intelligence, we come into **“harmony and balance”** with nature, as stated on the Georgia Guidestones monument. The biggest pusher of this dystopian vision has been Prince Charles, whose coronation took place on May 6, 2023. This will be a long but extremely important Blessed Hope by what it contains.

There is more interesting information about why that date was set on May 6<sup>th</sup>, and it is getting more bizarre which I will share later in this Blessed Hope. Before going there we need to look at old “sausage fingers” dabbling's in the occult. The source of some of the information that follows comes from Richard Cassaro April 6, 2016, an observer of the Masonic Secret Doctrine. I will explain later the meaning and significance of the so-called Masonic Secret Doctrine. But it's certainly not something that you want to tell your mother about.

The book *‘Codeword Barbelon’* by P.D. Stuart reveals that the **“Mason’s path to eternal life is the sexual violation of little children”** on page 500. In Freemasonry it is called the **“Royal Secret”** and in Roman Catholicism it is known as the **“Secret Doctrine”**. From all that we know Prince Charles was violated as a child and that he has violated others as well. From my education in seminary, there is a common expression which has also been used as a book title, *‘Hurt People, Hurt People’!* Think on that for a while as we dig into Prince Charles as Satan’s man! That term translated means that victims of sodomy become themselves sodomites. Prince Charles had a lengthy relationship with the late UK Disc Jockey Jimmy Savile, who was a pedophile of young boys!

In September, 2006, Prince Charles publicly revealed what can arguably be called **“the Secret Doctrine of the Occult”** in a 16-minute long, specially-videotaped address to the Sacred Web Conference at the University of Alberta, in Edmonton, Alberta, Canada. The Conference was attended by approximately 420 people, including scholars and professors from across North America, Europe, Australia, and the Middle East. In this article, we’ll review his speech and provide a step-by-step explanation of his exposé of an ancient body of sacred teachings and hidden knowledge, parts of which have long been outlawed by the Catholic Church.

None of us, with the possible exception of Donald Trump, is an exact reflection of the caricatures created by our relatives and rivals. Prince Charles, too, is more than just his awkward position in life. He is a complex human being, full of contradictory thoughts, feelings, emotions, interests, agendas and visions for the future. On top of that, he has received the very best education that comes with the money, power and prestige of

Prince Hood - an education that undoubtedly has afforded him direct access to privileged knowledge and secret traditions that the rest of us are denied.

We can get a glimpse of this privileged knowledge by scrutinizing statements Prince Charles made during a specially-videotaped address he gave to the Sacred Web Conference in Alberta, Canada in 2006. Here, the soon-to-be King of England shows himself to be a serious thinker, historian and visionary, in delivering a message based on and consistent with what can only be called **“The Secret Doctrine of the Occult”** - an esoteric tradition regarding the meaning of life and the human condition that’s been handed down for thousands of years by pagans, mystics, witches, sorcerers, magicians, and Freemasons; a tradition that’s long been outlawed by the Catholic Church.

Prince Charles compares and contrasts the spirituality of Traditionalism (with its focus on the Perennial Philosophy) against the materialism of Modernity (with its reliance on science). He reaches his conclusions in favor of Traditionalism in a most spectacular way. By breaking down Prince Charles’s speech into the following list of eight quotes, and by changing the order of these quotes, we can clearly see the **“Secret Doctrine of the Occult”** (i.e., the Perennial Philosophy) to which Prince Charles refers.

Again, just to be clear, Prince Charles’ quotes are here taken out of order but not out of context - a fact anyone can plainly see by reading a copy of the transcript of Prince Charles’ speech, posted below of the present article courtesy of the Sacred Web Conference. Prince Charles is a gifted “word smith” who is ardently capable of saying something without being direct and to the point. His partners in crime understand his message but the masses will never get what he has said even if they heard it or read it!

The **“Secret Doctrine of the Occult,”** as proclaimed and explicated by Prince Charles, can be broken down into eight key points as follows:

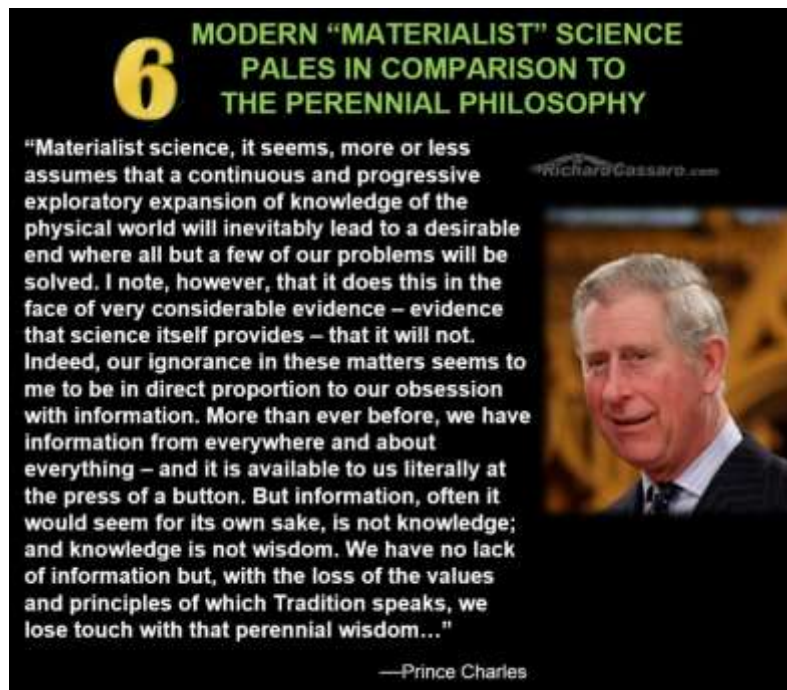

The perennial philosophy originates from a blending of neo-Platonism and Christianity. Neo-Platonism itself has diverse origins in the syncretic culture of the Hellenistic period, and was an influential philosophy throughout the Middle Ages. Pederasty in ancient Greece was a socially acknowledged romantic relationship between an older male (the erastes) and a younger male (the eromenos) usually in his teens. It was characteristic of the Archaic and Classical periods. The influence of pederasty on Greek culture of these periods was so prevalent that it has been called *“the principal cultural model for free relationships between citizens.”*

## 6) MODERN “MATERIALIST” SCIENCE PALES IN COMPARISON TO THE PERENNIAL PHILOSOPHY

Some scholars locate its origin in initiation ritual, particularly rites of passage on Crete, where it was associated with entrance into military life and the religion of Zeus. It has no formal existence in the Homeric epics, and seems to have developed in the late 7th century BC as an aspect of Greek homosocial culture, which was characterized also by athletic and artistic nudity, delayed marriage for aristocrats, symposia, and the social seclusion of women. Pederasty was both idealized and criticized in ancient literature and philosophy. The argument has recently been made that idealization was universal in the Archaic period; criticism began in Athens as part of the general Classical Athenian reassessment of Archaic culture.




Scholars have debated the role or extent of pederasty, which is likely to have varied according to local custom and individual inclination. The English word "pederasty" in present-day usage might imply the abuse of minors in certain jurisdictions, but Athenian law, for instance, recognized both consent and age as factors in regulating sexual behavior.

Richard Cassaro says, "As a lifelong student of the Secret Doctrine, I am extremely impressed with this speech; and I have a whole new respect for Prince Charles for actually expressing in a public forum things that would be frowned upon had they been said inside any university classroom in the Western world."



*My first thought after reading this speech is that, as a result of his power and privilege, he's been taught the Secret Doctrine. At that high echelon, he doesn't even need to be a Freemason; not that the Freemasons hold any of this wisdom anymore anyway. My first-hand experience tells me that they don't, definitely not!*

*Generally, the names of British Masons are a closely-held secret. Other than the current patron, Prince Michael of Kent, we know about Peter Sellers, Arthur Conan Doyle and a few others. However, it is the case that past Princes of Wales have belonged to a Masonic order, and that Prince Charles had been invited to join. Although Charles publicly turned down that offer, his father, Prince Philip, is admittedly a Mason, albeit not an active lodge member.*

*Even if Prince Charles decided against joining a lodge, it seems clear that his heart is in the right place. He has not only shown awareness of Masonic doctrines, as detailed above; he has also acted according to Masonic principles in his interactions with those whom he will one day be called upon to lead."*

Richard Cassaro for some reason seems to have been deceptive in his remarks since Prince Charles is the Head of the Garter, the Senior Most high Freemason Lodge in the world, with all Masons worldwide subservient to Charles.

The Most Noble Order of the Garter is an order of chivalry founded by Edward III of England in 1348. The most senior order of knighthood in the British honors system, the only decorations which outrank it in precedence are the Victoria Cross and the George Cross. The Order of the Garter is dedicated to the image and arms of Saint George, England's patron saint.

Appointments are at the Sovereign's sole discretion, typically made in recognition of national contribution, service to the Crown, or for distinguished personal service to the Monarch. Membership of the order is limited to the sovereign, the Prince of Wales, and no more than 24 living members, or Companions. The order also includes Supernumerary Knights and Ladies (e.g., members of the British royal family and foreign monarchs).

The order's emblem is a garter circlet with the motto "*Honi soit qui mal y pense*" (Anglo-Norman for 'Shame on him who thinks evil of it') in gold script. Members of the order wear it on ceremonial occasions. Prince Charles and his oldest son William sport the garter when in Royal uniform for affairs of State. Picture below.

Richard Cassaro offers some interesting commentary about old "sausage fingers". As the 21<sup>st</sup> Prince of Wales and heir to the British throne, Prince Charles is one of the most praised and also one of the most vilified celebrities in the world. Some perceive him as open, kind, generous, humorous, and hard-working, an asset to the monarchy; while others see a deceitful, arrogant, selfish man who is out of touch, and out of his element when faced with the prospect of becoming King.



At the age of three, Prince Charles became the heir apparent to the British throne when his mother, Elizabeth, became Queen. Years later, his illicit affair with Camilla Parker Bowles during his marriage to Princess Diana made the future King Charles III a main go-to villain of the tabloid press, even though dueling memoirs and *Daily Mail* headlines seem to indicate that both he and Diana were unfaithful with equal vigor. He apparently preferred someone with a little more going on upstairs; and she satisfied her carnal lust and her equally intense desire for blowsy repartee with the strapping young bodyguards that surrounded the couple.

Reactions to Charles' potential kingship run the gamut, but most reviews of his life so far are scathing to lukewarm. Not many people still believe the monarchy to be a relevant institution in 21<sup>st</sup> century Britain, and many who do support the institution dread the prospect of the British throne being filled with such an allegedly empty-headed man. The family of Dodi Al-Fayed has maintained that Charles and/or other Royal Family members created the situation that led to his and Princess Diana's death. Conspiracy theorists such as Alex Jones and David Icke regularly accuse Prince Charles, on no apparent evidence, of bribery, pedophilia, and even deliberate, premeditated murder. Others blame him for not having the good luck of having his mother die in time for him to have a long and prosperous reign. Still others accuse him of shallowness, disrespect for his marriage vows and his responsibilities as a leader of the Church of England, and poor performance in the largely ceremonial role to which he has been consigned. They see him as a poor choice as a role model, and as a leader with the charisma of a follower.

It would have been easy for Prince Charles to do nothing but sit home, enjoy his family's vast painting collection, and from time to time cut a few ribbons or pop champagne bottles to mark important ceremonial occasions. Instead, he has chosen to pursue an active life in the service of humanitarian goals. The "Prince's Trust," which he organized in 1976, provides mentoring support, education, and training to disadvantaged youth: juvenile delinquents, people who have experienced long-term unemployment, and learning disabled youth. The Prince is no mere figurehead; he spends a great deal of time working with and listening to troubled teen-agers and young ex-cons.

My decades experience as a pastor, teacher, counselor, is that "hurt ones" gravitate to those they can get close to! In my seminary years, I did an internship at the Methodist Home of KY; I have been a substitute teacher in elementary and secondary schools. I have worked as an instructional aide in vocational education and taught in a Bible college. In every position I was required to be vetted as a condition of my employment. I doubt that Prince Charles has been vetted for his "work" with young boys.

The Prince's many interests include architecture, homeopathy, gardening, and Eastern religious traditions. He has called the Dalai Lama his "*best friend*." The more I learn about him, the more I have come to admire him according to Richard Cassaro.

Richard Cassaro goes on to say, I've gotten in some hot water over being a "shill" for Freemasonry, which many of the conspiracy-minded feeble minds identify as a central villain in their theories of world domination. Yet, I have never hesitated to point out where I think Freemasonry has dropped the ball. I have also maintained, in the face of some resistance to members of the Order, that today's Masons have completely lost sight of the ancestry and principal goals of the movement. However, I have never been afraid to honor the important contributions of the Masonic movement in delivering to us intact important information about our spiritual inheritance from the distant past, in the face of fierce persecution from forces much more entrenched and powerful than the loony-tunes Amen choirs of Icke and Jones.

I recognize in Prince Charles a fellow truth-seeker whose ascension to the British throne would be not a final nail in the coffin of democracy, but rather would represent a chance for a responsible, well-informed humanitarian voice to be heard above the din of right-wing and left-wing demagogues. I respect his commitment to noble causes and his willingness to court controversy when he believes his views are correct.

### **An Introduction from His Royal Highness The Prince of Wales**

“In these uprooted times, there is a great need for constancy; a need for those who can rise above the clamor, the din and the sheer pace of our lives to help us to rediscover those truths that are immutable and eternal; a need for those who can speak of that eternal wisdom which is called the perennial philosophy. Looking at the programme for this Conference being organized by Sacred Web on the theme of “Tradition in the Modern World”, and at the list of speakers, I know that you will be hearing just this kind of teaching from just these kinds of people. Within the overall theme, there would seem to be a marvelous diversity of matters being discussed – matters related to religion, the arts, the economy, the environment and much else.

Although, very sadly, I cannot be with you, I do want to say that I am always delighted to receive the latest issue of Sacred Web because, so often, I come across such deeply revealing and enlightening articles, rich in content and diverse in subject matter. In addition, through the work of the Temenos Academy, of which I am Patron, I have been fortunate to enjoy the writings of some of your colleagues – people such as Professor Seyyed Hossein Nasr and, of course, the late Dr. Martin Lings, whose presence amongst us is so profoundly missed.

The Temenos Academy has been, and remains, closely associated with many of those who have written, and continue to write for Sacred Web and, indeed, for Sophia and other related journals. From the beginning, with the launch of the original Temenos review, the Temenos Academy has not only been devoted to what its founders have referred to as “the arts of the imagination”, but has also been committed both to the perennial philosophy and to the notion that Man is, at root, a spiritual creature with spiritual and intellectual needs which have to be nourished if we are to fulfil our potential. Both of these matters are at the heart of the teachings of Sacred Web.

As I understand it, in referring to Tradition they refer to a metaphysical reality and to underlying principles that are timeless – as true now as they have ever been and will be. And, by way of contrast, in referring to Modernism they refer to a particular (though false) definition of reality; a particular (though false) manner of seeing and engaging with the world that, likewise, is distinguished not by time, but by its ideology.

In an article written in 1983 for the traditionalist journal 'Studies in Comparative Religion', Professor Nasr put it this way:

*“When we use the term ‘modern’ we mean neither contemporary nor up-to-date... Rather, for us ‘modern’ means that which is cut off from the Transcendent, from the immutable principles which in reality govern all things and which are made known to man through revelation in its most universal sense. Modernism is thus contrasted with tradition...; the latter implies all that which is of Divine Origin along with its manifestations and deployments on the human plane while the former by contrast implies all that is merely human and now ever more increasingly subhuman, and all that is divorced and cut off from the Divine source.”*

Most especially, therefore, we can see that it is the very timeless quality of these immutable principles of Tradition that makes its teachings so timely.

For me, the teachings of Tradition suggest the presence of a reality that can bring about a reality of integration, and it is this reality that can be contrasted with so much of Modernism's obsession with dis-integration, dis-connection and de-construction – that which is sometimes termed the “malaise of modernity”. Cut off at the root from the Transcendent, Modernism has become deracinated and has separated itself – and thereby everything that comes within its thrall – from that which integrates; that which enables us to turn towards and reconnect with the Divine.

In this way, the loss of Tradition cuts to the very core of our being since it conditions that which we can “know” and “be”. For Modernism, by its unrelenting emphasis on the quantitative view of reality, limits and distorts the true nature of the Real and our perception of it. Whilst it has enabled us to know much that has been of material benefit, it also prevents us from knowing that which I would like to refer to as the knowledge of the Heart; that which enables us to be fully human.

This dilemma is captured in ancient notions of balance and harmony; notions that are, for example, expressed in many guises in that wonderful Kabbalistic diagram of the Tree of Life. As the Temenos Fellow, Warren Kenton, so beautifully explains in his lectures to the students of the Academy, the teaching of the Tree of Life is that the “active” and the “passive” aspects of life, which on their own may lead to imbalance and

disharmony, must be, can only be, brought together in harmony by the influx into our lives of the Divine and the Sacred. Whether or not we interpret this image as an explanation of an outer or an inner orientation, it is in this way, and only in this way, that the forces, or characteristics, of expansion and constraint can be brought into balance.

But, of course, in both the inner and outer dimensions of our lives, many of us, at present, experience the very imbalance and disharmony that this mystical framework, and, indeed, the teachings of mystics of all times, show to be harmful or, to use a contemporary term, “unsustainable”.

And this leads me to a final and somewhat troubling matter that lies at the heart of Tradition and its critique of Modernism. None of us, I imagine, can fail to be conscious of, and be concerned about, those matters that might together be called “the environmental crisis of the twenty-first century”. Indeed, none other than Sir Martin Rees, the Astronomer Royal and President of the Royal Society, in his book *Our Final Century*, has said that:

*“...in the twenty-first century, humanity is more at risk than ever before from the misapplication of science. And the environmental pressures induced by collective human actions could trigger catastrophes more threatening than any natural hazards.”*

For many years, I have been trying – often in the face of relentless criticism and ridicule – to draw attention to some of the elements of this crisis and to the ways in which they are linked to conventional values. At times, when in optimistic mood, I am encouraged to believe that we can come to our senses in time and change our ways of being before we are obliged to do so by catastrophic circumstances. But I am afraid that I do not always take this view. Often, I find myself convinced of the warnings given not only by Sir Martin Rees but also, of course, by sages and mystics of all faiths and of all time; warnings of the coming of a Dark Age, an age in which our ignorance and arrogance – a dangerous combination, surely – will lead us, indeed may already have led us, towards catastrophe. The present examples of pestilence, flood, famine, storm and climatic disruption are surely evidence enough. At the very least, they seem to foretell of conditions of chronic imbalance and disharmony – no doubt as much a part of our inner as our outer condition.

In all of this, the practice of modern science more or less ignores the question of what the ultimate goal and purpose of intelligence and knowledge is. Materialist science, it seems, more or less assumes that a continuous and progressive exploratory expansion of knowledge of the physical world will inevitably lead to a desirable end where all but a few of our problems will be solved. I note, however, that it does this in the face of very considerable evidence – evidence that science itself provides – that it will not.

Indeed, our ignorance in these matters seems to me to be in direct proportion to our obsession with information. More than ever before, we have information from everywhere and about everything – and it is available to us literally at the press of a button. But information, often it would seem for its own sake, is not knowledge; and

knowledge is not wisdom. We have no lack of information but, with the loss of the values and principles of which Tradition speaks, we lose touch with that perennial wisdom to which this Conference is dedicated. In this, I am reminded of those prophetic lines from T. S. Eliot:

Where is the life we have lost in living?  
Where is the wisdom we have lost in knowledge?  
Where is the knowledge we have lost in information?  
The cycles of Heaven in twenty centuries  
Bring us farther from God and nearer to the Dust.

The traditionalist perspective is that we are living at the end of an historical cycle. At the beginning of this cycle all and every possibility is latent. However, as the cycle evolves or unfolds, these possibilities begin to manifest themselves in the world of time and space, beginning with the highest and gradually moving towards the lower. At the end of the cycle, the very lowest possibilities manifest themselves. The traditionalists tell us that at the cosmic level this process cannot be withheld or interrupted. It must take place. The cycle, they say, must exhaust itself before a new one can replace it.

I know that this might seem to suggest that we are entirely the passive victims of this cosmic unfolding. However, as I understand it, the traditionalists would go on to say that if this were the only reality then all attempts to pursue and align ourselves with spiritual realities and experience would be in vain. And that cannot possibly be. Indeed, it is precisely on the individual plane and through our understanding of and attachment to traditional norms of metaphysical doctrine and spiritual practice that we can, in a measure, transcend the baleful influence of the descent that is the eventual exhaustion and end of our cycle of history and prepare ourselves and the world for the beginning of the next. It is in this way, and perhaps only in this way, that we can overcome the mind-numbing despair of Modernism – not by false optimism, but by an understanding of and an attachment to the truly Real.

I hope that some part of your deliberations at this Conference will address these issues and, perhaps, provide guidance for those of us who do not claim to be scholars. For much of my life has been, and remains, devoted to finding practical solutions to what, at first, seem to be impossible difficulties – and sometimes to speak for those whose voices are unheard amidst the clamor of Modernism. In this, I recognize that true action is dependent upon constant reflection – the redeeming aspect of the nature of harmony and balance. I pray that your deliberations will help in this task through not only describing the difficulties that we face, but also showing us the ways in which we might seek to make the necessary changes in our lives.

Despite not being able to join you in Edmonton, I much look forward to reading the texts of the conference that will be delivered. I hope that you will also find inspiration from them and that they will be widely distributed and discussed, especially beyond those who already subscribe to the teachings of the traditionalists. Whatever our view, and

whatever our tradition, I am sure that we will have much to learn from your deliberations – I wish you a most harmonious Conference.”

If you take time to read Prince Charles address, he wants to return the world to something of that was custom to the Greek and Roman era and his Perennial Philosophy, i.e., Pederasty man boy love relations.

The British Royalty is tied in with this 13<sup>th</sup> Satanic Bloodline. Many of the American political leaders have been related to the British Royalty incl. George Bush and Dan Quayle. This bloodline is known as the Merovingian's, dating to the 4<sup>th</sup> century A.D.

The British Crown is even claiming they are sitting on the Throne of King David see [www.prophecyhouse.com](http://www.prophecyhouse.com), from page 89 of Tim (Huckabee) Cohen's book '*Antichrist and a Cup of Tea*'. They even claim they are descendants of King Solomon, Jesus Christ himself (what blasphemy) and Mohammed.

According to Burke's Peerage, the Bible of the aristocratic and royal genealogy each election of an American president, incl. George Washington (1789) was won by the candidate with the most genes in relation to European royal genes. 33 of 42 of these people can be traced genetically back to two persons: Charlemagne (King), the most famous monarch, what we call today France, and Alfred the Great the King of England.

The United Grand Lodge of England was long exposed as a Vatican Luciferian Order! <http://illuminaticonfessions.squarespace.com/journal/2006/11/23/the-united-grand-lodge-of-england-finally-exposed-as-a-vatican-luciferian-order.html> This link has been a disabled dead link sometime prior to the Queen's death in September, 2022 and since the death of Princess Diana on August 31, 1997. It was very informative of the actual relation between the English Royal Family/The United Grand Lodge of England (= the

Mother of all Regular Freemason Lodges) and the Vatican. They are one tight knit bunch of Satanists.

When Charles talks about the Great Reset and the goals of the UN it sounds more like a religion than anything else. Earth worship is a religion. Scripture addresses this issue. God is the Creator of everyone and everything. God is independent, everyone and everything else is dependent upon God. Everyone and everything exist to glorify God. When we fail to worship the Creator, our only option is to worship the creation.

When it comes to worship, there are only two options. One, we worship the Maker of all. Two, we worship something made by God, or people, like another person, pleasure, or sex. But progress toward this supposedly new and better world that Prince Charles talks about is not moving fast enough to meet his expectations and the expectations of the WEF, the United Nations, Klaus Schwab, Yuval Harari, Bill Gates, Larry Fink, George Soros and the rest of the Luciferians who have managed to place their minions in the

According to the U.N. website:

*"They will carry out a comprehensive review of the state of the SDGs, respond to the impact of multiple and interlocking crises facing the world, and provide high-level political guidance on transformative and accelerated actions leading up to the target year of 2030 for achieving the SDGs."*

The U.N. posting goes on to say that: *"The special edition of the report of the Secretary-General entitled 'Progress towards the Sustainable Development Goals: Towards a Rescue Plan for People and Planet', the [Advance Unedited version](#) has been released."*

The timing of this meeting will be significant. What other manufactured crises could be upon us by mid-September? Firestorms around the world? World War III? Food shortages and famine? Civil unrest? Maybe all of the above.

It really is amusing as well as being tragic listening to the globalists drone on about the world's problems and how their solutions will take into account everyone's best interests. Gender imbalances? These are the same people encouraging young children to be confused about what their gender even is. Environmental degradation? These are the folks who want all vehicles, all appliances, all lawn and garden tools, everything to run off of power generated by the electric grid, which cannot even sustain the current level of power needs, let alone if we all traded our gas-powered cars, gas stoves, leaf blowers, tractors, mowers, chainsaws, etc., for electric ones. ***"He said also unto me, Turn thee yet again, and thou shalt see greater abominations that they do. Then he brought me to the door of the gate of the LORD's house which was toward the north; and, behold, there sat women weeping for Tammuz."***

Tammuz was the ancient Sumerian god of vegetation and fertility whose death, according to legend, marked the turning of the seasons. Because women typically represented the more conservative element of the religious strata, the fact that the women had abandoned the true God of life for the false god of death shows the total penetration of pagan religion in Judah.

Weeping for Tammuz was a Babylonian ritual marking the death and descent into the underworld of the Sumerian god Dumuzi. The mythological course of death and return for Tammuz was thought to be parallel to the annual rhythm of nature.

This is very interesting indeed. Surely Prince Charles III, Mr. Nature as it were, is already known as the "green king" as he has been an environmental/climate hyper-activist for five decades. His Coronation invitation actually features an image of the "green man" god, wearing a crown of thorns no less!

When Prince Charles received his Investiture, his mother the Queen used this very expression and *"the dragon gave him his power and his seat and great authority."*

As revealed by the Hebrew dates above, both the Investiture of Prince Charles of Wales and his Coronation as King occurred during full moons. The Holy Spirit led me to investigate the precise duration of time between these two events. I woke one morning at 3:00am and could not go back to sleep. I was still awake 4:00am so I decided to get up and go to my computer in the room next to my bedroom. I was editing a recent Blessed Hope for two hours and decided to go back to bed before daylight when my thoughts were fixed upon the ancient meaning and links to the Red Dragon of Prince

Charles coat of arms. <https://youtu.be/aqDFdGA0tvQ> This is a common practice with me working at such hours.

According to Revelation 13:2, the Red Dragon or Satan gives the Beast **“his power and his throne and great authority”**. Fulfillment: When Charles was formally inaugurated the Prince of Wales at Caernarfon Castle in 1969, he swore his Oath of allegiance on bended knees before the throne that represent the Welsh Red Dragon, after which he then sat on its right side.

Prince Charles of Wales in Medieval Ceremony at Caernarfon Castle, and which was broadcasted via television all over the world, Prince Charles knelt before the throne that has Welsh Red Dragon on its back, a symbol which also was displayed on the banners of Caernarfon Castle. After kneeling down before this throne of Satan, he said the following words: **“I, Charles, do become your liege man of life and limb and of earthly worship, and faith and truth I bear unto you, to live and die against all manner of folks.”** After that, he sat down on the *right side* of that throne of Red Dragon, as a parody of Jesus Christ, who **“sat down at the right hand of God”** after His ascension - (Mark 16:19). As a lunar-based calendar, normal Hebrew months have either 29 or 30 days. The mean average, however, is not 29.50 days but rather 29.53. Plug 19,667 into your calculator and divide by 29.53 and this is what you get: **“666”**. I triple checked my calculations still thinking this had to be a coincidence. For weeks I searched and searched for an explanation as to why May 6<sup>th</sup>, 2023 was selected for the date of the Coronation of Prince Charles. The answer is stunning to say the least. It confirms Charles is governing events by the occult signature of Satan.

From the time of the Queen’s death, the big question was, when will the Coronation date be and why so? The curiosity of “Royal” watchers is endless. The Queen’s personal physician was highly suspect that her death was from natural causes, since there were bruises on her wrists and hands indicating a struggle had taken place? Back to the interesting calculation that resulted.

Precisely **“666”** lunar cycles or Hebrew months. It seems that it was imperative that his coronation take place on May 6, 2023 of this year, not any other date. Are you

beginning to see the Satanic element in all of this build up to the coming **“Confirming the covenant with the many?”**

**How about this little detail? The Coronation was on May 6, 2023.**

**6+6+6 =**

**666**

In Greek and Hebrew Gematria, zeros carry only place location with no importance and are not included in Bible numerics.

Everything we are learning about Prince Charles screams Satanic “Deception!” 2<sup>nd</sup> Thessalonians 2:1-12 **“And then shall that Wicked be revealed...Even him, whose coming is after the working of Satan with all power and signs and lying wonders”.** (2<sup>nd</sup> Thessalonians 2:8-9).

Thus far we have seen the awfulness of Antichrist’s kingdom, and the fact that **“power was given him over all kindreds, and tongues, and nations. And all that dwell upon the earth shall worship him”** -(Revelations 13:7-8). We might ask, how could this man achieve such authority?

It will be accomplished in three ways. First, he will use force. **“As many as would not worship the image of the beast should be killed”** -(Revelation 13:15). In focus of the occult symbol of the 'Scallop'. As you can see from the picture, below, the red scallop is located on the "Eldest Son Label" which looks like three parallel horns turned upside down. **“This particular mark of cadency also derives from the Black Prince, being the distinctive mark of all succeeding Prince of Wales...”** (Tim Cohen, 'Antichrist and A Cup of Tea', pg. 124)



Thus, the Spencer red "scallop seashell" is located on the Windsor "Eldest Son Label".



Did you know that, in the Occult Tradition, the scallop is a symbol of Lucifer? Please allow me to explain.

Notice from the picture to the left, Aphrodite/Venus is shown coming out of the seashell, that is, being "*born into existence*" in much the same way that Buddhism teaches that Buddha was born out of the Oriental Lotus. In fact, the scallop

seashell is equal to the Lotus and, as such, represents both Venus/Aphrodite. In previous recent segments of his series I have stressed the importance of the planet Venus in Biblical astronomy as well as Prince Charles claim to that which belongs to the Lord Jesus Christ. Occult writings teach that Venus is considered to be Lucifer. Listen to Dr. Cathy Burns explain. Dr. Cathy Burns firmly links Aphrodite with Venus -- they are the same type of goddess!

"As just mentioned, Cupid (Eros) was the son of Venus (Aphrodite). From Eros we get the word 'erotic' and Venus was also considered to be the Roman goddess of erotic love." [Dr. Cathy Burns, "[Masonic And Occult Symbols Illustrated](#)", pg. 168]

Dr. Cathy Burns now captures the essence of this belief that Venus is Lucifer, held by the ancient -- and modern -- occult practitioners.

**" 'Lucifer prepares man in all ways for the experience of Christhood and the Christ prepares man for the experience of God. But the light that reveals to us the presence of the Christ comes from Lucifer. He is the light giver. He is aptly named the Morning Star because it is his light that heralds for man the dawn of a greater consciousness. He is present when that dawn is realized ... Christ is the same force as Lucifer, but moving in seemingly the opposite direction'."** [Dr. Burns, quoting David Spangler, 'Finding Heaven On Earth', New Age Journal, January/February 1988, Vol. 4, Issue 1, reprinted in "[Masonic And Occult Symbols Illustrated](#)", pg. 188] This explains why Cardinal Jesuit/Mason Carlo Martini as the Vatican consultant to the translating committee for the NIV or New International Version of the Bible was fixated on removing "Lucifer" from Isaiah 14:12 in the KJV to "Morning Star" in the new NIV back in the late 1970s.

Dr. Burns then concludes: **"Of course, quotes like this aren't really surprising since Masons themselves ... tell us that Lucifer (or Venus) is the Light-bearer and the Morning Star. Blavatsky writes about the Druids, Magi, Zoroastrians, greeting the Morning Star -- the beautiful Venus-Lucifer."** [Ibid.]

Therefore, the symbolism of the seashell in the occult tradition is quite plain:

**Seashell = Aphrodite = Venus = Lucifer**

Therefore, this red scallop clearly identifies the Spencer Family as being deeply Illuminati. In fact, the Spencer Family has a purer Illuminati family genealogy than the Windsor Family. For this reason, Prince Charles sought out Diana to be his wife, so she could bear their "Eldest Son", Prince William. If Prince William turns out to be history's Antichrist, he will have a purer occult genealogy than his father, Charles. Remember, Prince William was born on 21 June 1982, on Summer Solstice, one of the most important days in the annual Satanic calendar. Listen:

**"Midsummer, Druidic festival of Alban Hefin, Anglo-Saxon Litha, is the longest day and the seventh station of the year, the time of sanctification ... This is also the Day of All Heras in the women's mysteries. 'Heras' are women who have achieved full spiritual communion with the Great Goddess."** ("The Pagan Book of Days", pg. 81)

The Garter is *"the world's oldest surviving order of chivalry."* This is entirely true. It is also the most important of the many order of knights in Great Britain.



2) *"Established in 1348 by King Edward III ... the Order of the Garter is England's (and Europe's) most prestigious and exclusive 'Christian' order of chivalry..."* (Ibid., Page 130)

Notice that Tim Cohen places the word 'Christian' in quotation marks, denoting that he does not believe that the Order of the Garter is genuinely Christian in any way, shape or form. You will soon see why Cohen believes that this Order is Satanic, not Christian!

3) *"The informal creation of the Round Table after the great tournament at Windsor in 1344 was translated, in 1348, into the Order of the Garter -- 24 young men plus the King and his eldest son..."* (Ibid., Page 131)

As Cohen later states, this organization of the Order of the Garter seems to mimic the Biblical organization in Heaven. Let us read in the Book of Revelation: ***"At once I came under the Holy Spirit's power, and behold, a throne stood in heaven, with One seated on the throne ... Twenty-four other thrones surrounded the throne, and seated on these thrones were twenty-four elders (the members of the heavenly Sanhedrin), arrayed in white clothing, with crowns of gold upon their heads. Out from the throne came flashes of lightning and rumblings and peals of thunder, and in front of the throne seven blazing torches burned, which are the seven Spirits of God the sevenfold Holy Spirit."*** -(Revelation 4:2,4-5; Parallel Bible, KJV/Amplified Bible Commentary).

These 24 elders sit on their thrones with God the Father and God the Son (Jesus) seated on their thrones. Thus, it seems logical that this Order of the Garter organization of 24 Knights *"plus the King and his eldest son"* is mimicking the similar arrangement of thrones in Heaven. Satan has always loved to mimic God in all matters, so we should not be too surprised about this particular organizational structure!

4) What kind of an organization is the "Order of the Garter"?

"What is publicly known of the Garter ceremony evidences the fact that it remains a mixture of the holy with the profane..." (Ibid., Page 133)

Of course, the Bible absolutely forbids mixing the profane with that which is holy in God's sight.

*"The priests shall teach My people the difference between the holy and the common or profane, and cause them to distinguish between the unclean and the clean."* (Ezekiel 44:23)

God killed priests in the Old Testament who mixed the profane and the holy in the Tabernacle. Here we see that the rituals of the Order of the Garter are said to be mixing the holy and the profane, which is exceedingly typical of the Satanic Secret Societies of the Illuminati. Antichrist will perform the ultimate abomination of mixing the holy and the profane, when he enters into the Holy of Holies and defames it in the manner described

in Daniel 9:27 and by our Lord in Matthew 24:15-22, an act of introducing the profane in the Holy Place which shall cause God to unleash His most fearsome of all judgments. 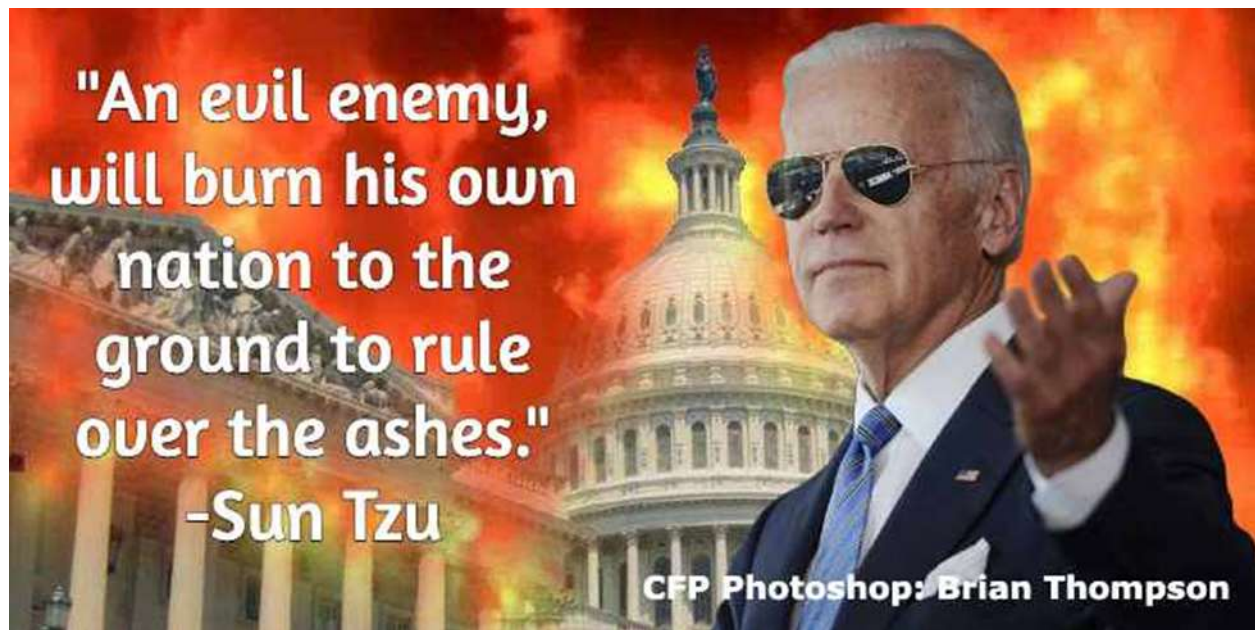
5) *"The Order of the Garter is not only responsible for the creation of the modern Illuminati ... but it also heads and controls the Shadowy 'Committee of 300'."* (Ibid., Page 136)

What, you say, is the Committee of 300? Most people have never heard of this very occult, and very powerful, organization.

*"The 'Committee of 300' is a supranational organization whose express purpose ... is to facilitate the creation of a Luciferic New World Order ... Britain is in charge of our government .. The plain truth is that the United States has fought in 5 wars this century for, or on behalf of, the infamous 'Committee of 300'."* (Ibid., Page 140)

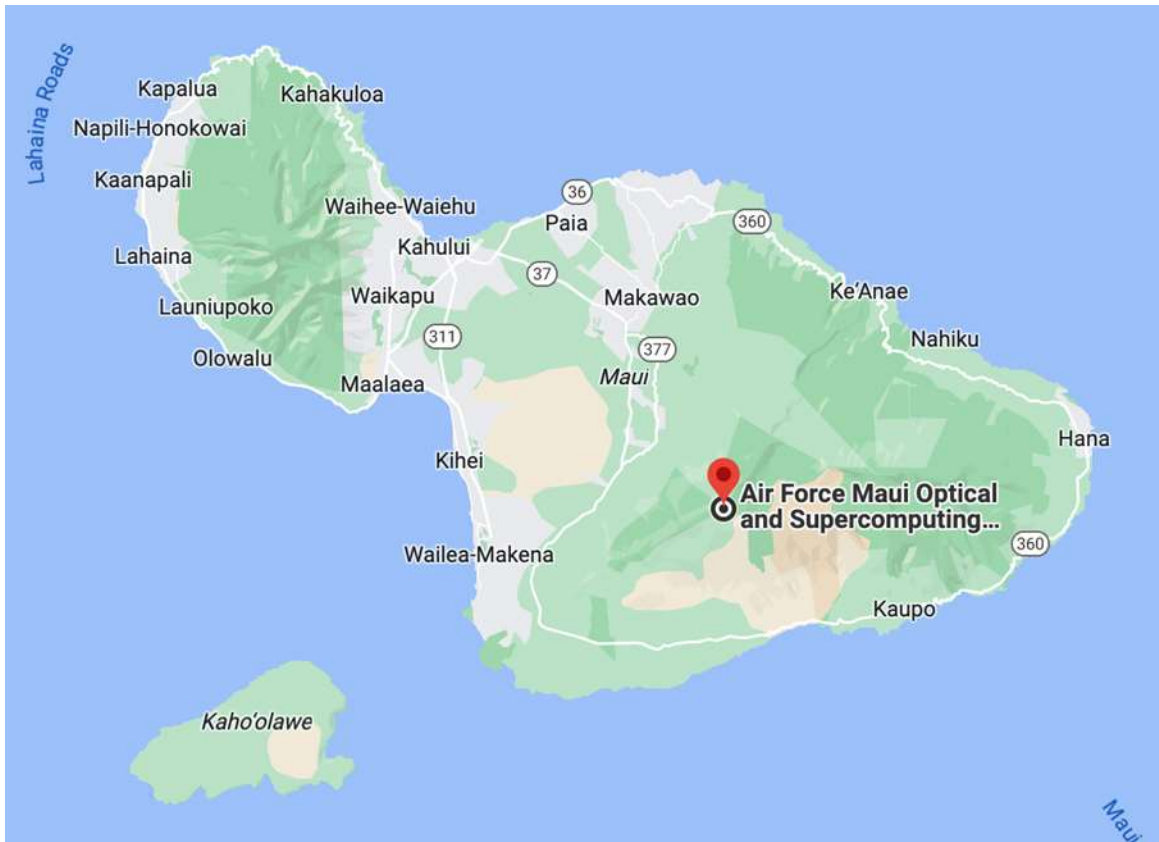
The world population has never been so great, nor the number of false religions so many, and countless millions are blindly following all manner of lies on their way to a Christless eternity. It is little wonder that multitudes will be deceived when the False Prophet **"maketh fire come down from heaven on the earth in the sight of men"**, and has **"power to give life unto the image of the beast (antichrist), that the image of the beast should both speak, and cause that as many as would not worship the image of the beast should be killed"** -(Revelation 13:13-15). We should remember, however, that God will still be at work during the Great Tribulation.

God's power is infinite, and He never leaves Himself without a witness. The 144,000 Jewish men, sealed by God, will proclaim the Gospel of the Kingdom during the first half of the 7-year Tribulation. Sadly, many will reject the Gospel of the Kingdom preached to them and choose to believe the lies of the ***"man of sin"***. Paul wrote: ***"Because they received not the love of the truth, that they might be saved... God shall send them strong delusion, that they should believe a lie"*** -(2<sup>nd</sup> Thessalonians 2:11). Many Gentiles will be saved during the Tribulation, but many will be deceived by the Antichrist. That deception has been huge since Prince Charles launched his Climate Eco-Salvation agenda in 1992, and millions have been deceived by the hoaxed Sustainable Development Goals.

Those pesky rumors about Charles' gay lovers may be speculation but this allegation is supported by several eyewitness testimonies. Princess Diana herself allegedly talked about it on secretly recorded videotapes a few months before her death. The BBC's cameraman who shoot them, told about them to the press in 2003 and their existence has also been confirmed by the most recent reports.

According to reports, Prince Charles hired Julius Kroll, one of the world's foremost private detectives, to find these secret videos tapes, but they were buried at Diana's order at a bank vault in the United States, to an unknown location. In addition to this, we have the case of Charles' former servant George Anthony Smith, a man who before his death claimed to have been raped by Michael Fawcett, whom Smith also claimed to be Charles' gay lover. Charles' servants also tried to silence him with bribes but he refused a payoff.

Why did the media not focus on this story, but brought headlines of President Trump's alleged payoff to porn star Stormy Daniels over his extramarital but consensual one night stand with her some 13 years ago? Is the consensual extramarital relationship between two adults bigger scandal than Charles' conspiracy with Michael Fawcett to conceal the rape of a male servant? Princess Diana also spoke in these alleged tapes about the sadistic, "Caligula-like" sex orgies between the royal servants that Charles tolerated in his royal household (see the original report from 2003 here: <http://rense.com/general44/tapes.htm>)

However, when Charles, the heir to the throne, hit rock bottom following his separation from Princess Diana in 1992, he spoke out to Jonathan Dimbleby for an authorized biography.

The book painted a picture of a lonely little boy who barely saw his parents and was miserable after being forced to attend the same strict Scottish boarding school as his father, Prince Phillip.

Dimbleby stated that both the Queen and Philip were emotionally distant.

As a child, Dimbleby wrote that Charles was “easily cowed by the forceful personality of his father,” whose rebukes for “a deficiency in behavior or attitude... easily drew tears.”

Friends who spoke with Charles’ permission also described the Duke of Edinburgh as “belittling” and even “bullying” to his son. Charles was less harsh about his mother, whom he dubbed her “not indifferent so much as detached.”

At age 20, Charles was asked whether his father had been a “tough disciplinarian” and if he had been told “to sit down and shut up,” Charles replied: “The whole time, yes.”

Asked as he was approaching his 21st birthday to describe the moment he first realized that he was heir to the throne, Charles made it clear that he had also struggled with his life’s destiny — much as his youngest son later would.

“I think it’s something that dawns on you with the most ghastly inexorable sense... and slowly you get the idea that you have a certain duty and responsibility,” he said.

The Queen’s firstborn, Charles Philip Arthur George, was born on November 14, 1948. Although he was born into privilege, the future king barely saw his parents as a toddler. His mother was 22 when he was born, and as Princess Elizabeth, she travelled abroad on official trips or spent time with Philip, who was then an officer in the Royal Navy and stationed in Malta. When she was just 25, she was crowned Queen following the death of her father, King George.

As writer Sally Bedell Smith later recounted, neither parent was physically demonstrative.

She wrote in Vanity Fair: “That lack of tactile connection was achingly apparent in May 1954, when the Queen and Prince Philip greeted 5-year-old Charles and 3-year-old Anne with handshakes after an absence of nearly six months on a tour of Commonwealth nations. Martin Charteris, Elizabeth’s onetime private secretary, observed that Charles ‘must have been baffled by what a natural mother-son relationship was meant to be like.’”

Among Dimbleby's claims in his book, *"The Prince of Wales: A Biography,"* he said Charles was forced into his loveless marriage to Princess Diana by his father. Philip wanted a male heir to the throne!

At the time, Philip responded by telling the Daily Telegraph: *"I've never discussed private matters and I don't think the Queen has either. Very few members of the family have."*

Charles tried to make amends in a TV documentary tribute to the Queen on her Diamond Jubilee in 2012.

Home movies depicted an idyllic childhood at the family's country estates at Sandringham, in Norfolk, and Balmoral, in Scotland.

Talking to Shepard, Harry condemned the parenting style that has been passed down through the royal family, adding: *"I don't think we should be pointing the finger or blaming anybody, but certainly, when it comes to parenting, if I've experienced some form of pain or suffering because of the pain or suffering that perhaps my father or my parents had suffered, I'm going to make sure I break that cycle so that I don't pass it on."*

Prince William turned 30 years of age on June 21, 2012. Why is this particular age important? The age of 30 is the Jewish minimum age for a man to be a Rabbi. Therefore, if Prince William is to convince the Jewish Orthodox priests and the Jewish people that he is their long-awaited Messiah, he must be at least 30 years of age.

Now you know why Royal doctors induced Princess Diana so she would give birth to William precisely on Summer Solstice, June 21, 1982! Diana Spencer was Jewish, and the Spencer family is even more occult than the Windsor's. This is another story but the fact is the Royals sought out the right pedigree for Charles to marry and produce a male "heir" to the throne and be a replacement if for some reason Charles would not be able to fulfill his Satanic role and needed to step aside for William to continue the mission of Satan. London Mayor Sadiq Khan's Ulez punch-down on cars and vans owned by the less affluent is just one example of the attacks planned against town dwellers living in modern industrial societies. Khan is the current chairman of [C40](#), a global network of city mayors backed by numerous hard-Left billionaire foundations. Removing cars from cities is just one of its aims. In a *Headline Report published by the group* in 2019 and re-emphasized [earlier this year](#), a "progressive" target for 2030 was set of a daily per person allowance of 44g of meat (enough for two small meatballs), a daily limit of 2,500 calories, (less than the ration in the Second World War), one short haul flight every three years, eight new clothing items a year and private cars available for only one in five people. This "pioneering piece of thought leadership" was said to seek a "radical, and rapid, shift in consumption patterns".

When the report about future urban consumption was first published in 2019, it received little publicity in the media. Some of its proposals looked a bit cranky even for mainstream publications. For instance, under an "ambitious" 2030 target, the mayors looked to ban meat and private vehicles altogether. But groundwork was clearly being laid. Mark Watts, executive director of C40, observed that average consumption-based emissions in the wealthier C40 cities must fall by "two thirds or more" by 2030. It was said that reducing vehicle ownership would lead to significant reclamation of roads and 25,000 klms of cycle lanes. This plan is now well advanced since the Covid lockdowns provided cover for mass street closures. Recent years have also seen large increases in cycle lanes, and of course the Ulez war on those driving older vehicles, not necessarily by choice.

Signatory cities are committed to "high impact accelerators", which include creating low or zero emissions zones along with "implanting vehicle restrictions or financial incentives/disincentives such as road use or parking charges". An

early sighting here, perhaps of Khan's suspected wish to implement road pricing after his Ulez infrastructure is in place.

There is also an early sighting of unsourced statistics with a claim that eating less meat and more vegetables and fruit could prevent 160,000 annual deaths associated with diseases such as heart attacks, diabetes and strokes in C40 cities. It is not immediately clear if these deaths actually occur in such precise numbers, or whether they are a Ulez-style [‘statistical construct’](#).

Over 100 cities around the world are part of the C40 network and they are required to sign up to *“performance-based requirements”* based on a number of leadership standards. One of these standards specifies that they must innovate and start taking inclusive and resilient action, *“to address emissions beyond the direct control of city government, such as associated with goods and services consumed in their city”*. The largely unpublicized C40 operation is backed by finance and support from many well-known green foundations including Climate Works, Hewlett, IKEA, Oak, FR and Clinton. Three *“strategic funders”* are identified including Christopher Hohn's [Children's Investment Fund Foundation](#), a major financial contributor to Extinction Rebellion. Another strategic funder is Bloomberg Philanthropies, whose controller Michael Bloomberg, the former mayor of New York, is president of the C40 board.

Of course interest is now growing in what all these people have been smoking over the last few years, as the Con/Lab green blob (different countries, different mainstream political combinations) organize to de-industrialize and cut human progress in the name of tackling a supposed ‘climate crisis’. The *C40 Headline Report* gives clear guidance of the scale of economic and societal change required under a collectivist Net Zero agenda. U.K. Fires is an academic project funded by the British Government, and it also gives a brutal assessment of life under what it terms absolute net zero carbon dioxide emissions. Again it is not discussed much in the public prints, but the *Daily Sceptic* has [reported on its findings](#). These include no flying and shipping by 2050, drastic cuts in home heating, bans on beef and lamb consumption and a ruthless purge of traditional building materials such as bricks, glass, steel and cement. Such is the admirable honesty on display in their reports that they note these building materials can be replaced with “rammed earth” – mud huts for the lower classes in other words.

Sadiq Khan has been badly shaken by a popular uprising against his hated Ulez scheme. Backing in his own Labour party is wearing thin, not because most senior members are particularly anti-Ulez, but because after the Uxbridge by-election they can see a little more clearly that attacking the cars of the poor is a slam-dunk vote loser. For his part, Khan seems to have become more hysterical attacking those who oppose Ulez as conspiracy theorists. Earlier this year, reports the [Daily Mail](#), Khan said that some of those who opposed the scheme's growth across all London boroughs were “anti-vaxxers, Covid deniers, conspiracy theorists and Nazis”.

The evidence provided by Khan's own *C40 Headline Report*, along with the work of U.K. Fires, shows clearly the actual agenda that is now being ruthlessly deployed. The only conspiracy rabbit hole in sight would appear to be that occupied by a freaked Mayor Sadiq Khan.

There are several aspects of the Kingdom of God in Scripture. Every believer is now in the kingdom of God but there will be a future earthly Davidic kingdom established on earth at the second coming of Christ. Paul wrote of the Lord Jesus Christ, "***who will judge the quick (living) and the dead at his appearing and his kingdom***" -(2<sup>nd</sup> Timothy 4:1). That judgment will involve the living nations that survive the Tribulation. Paul closed his letter to this beloved Thessalonian Church by reminding them of the resources available to deal with any problem that would come their way. There was the Lord's peace that passes understanding; the Lord's presence, that is never failing; and God's grace ever given. May the consciousness of His presence daily fill our lives, and His grace prove sufficient as we wait for that wondrous call, "***Come up hither!***"

#### **End Times Speculation - By Daymond Duck -**

I constantly receive e-mails from readers who want me to give them my opinion on how close we are to the Rapture.

Some keep rephrasing the question and asking again and again.

Some say, "I know you don't know the day or the hour, but will it be in the next few weeks, before the end of this year, what do you think, etc.?"

Many readers have been expecting the Rapture to happen for several years, but it has not happened, and they want to know, "How much longer will we have to wait?"

One reader recently wrote this:

I thought for sure the Rapture was going to happen during the Obama administration, then I thought for sure it was happening during Covid. I see things like AI, cashless society coming, LGBTQ and Trans. I see people who just don't care anything about God or morals. I mean, we have to be on the cusp of this happening sometime soon, right? I'm not asking for a date; my question is, always, is there any chance we're just wrong? Or seeing what we want to see?

This reader has gone from expecting the Rapture to happen anytime to wondering if it might still be a long time or if we could be misunderstanding the Bible.

I totally understand.

I have been expecting the Rapture to happen anytime for a long time myself.

Having said this, I want to speculate for just a minute, and hopefully, it will be helpful to some who are wondering about how long it will be.

**I believe:**

- The Rapture will happen before the Tribulation Period begins (often called the Pre-Trib Rapture).
- The Mark of the Beast (a global ID, cashless society, forcing everyone to take the name, number, or Mark of the Antichrist) will begin at the middle of the Tribulation Period.
- The Tribulation Period will last for seven years (2,520 days) on the Jewish calendar.

If I am correct about these three beliefs, it means the Rapture will take place a minimum of three and one-half years before the Mark of the Beast (global ID, cashless society, forcing people to take the Mark, etc.) and perhaps more than that (because there could be a gap between the Rapture and the Tribulation Period).

The globalists' goal is to establish a world government by 2030 or sooner.

If their world government begins in 2030, the Rapture would be between now and 2030.

If they intend to have a global ID, a cashless society, force everyone to take the Mark, etc., by 2030, the Rapture would be in 2026 or sooner (and if there is a gap between the Rapture and the Tribulation Period, the Rapture could be very soon).

If the Battle of Gog and Magog were to take place soon, it would accelerate the development of world government (and, therefore, accelerate the Rapture).

It may not happen, but a breakthrough in the peace negotiations between Israel and Saudi Arabia might speed up the seven-year covenant with many (and, therefore, accelerate the Rapture).

Anyway, as I said, I am speculating.

Obviously, I could be wrong, but I do not think so, and I hope that my speculation helps those who are getting concerned because the Rapture has not happened.

God is in control; the Rapture will happen when He wants it to happen, and it will come upon the earth like a snare (catch multitudes by surprise), so be ready and stay ready.

**Here are some signs that seem to indicate that we are getting close:**

**One**, concerning pestilence and persecution: on August 23, 2023, it was reported that the former head of the National Institute of Allergy and Infectious Diseases (NIAID), Anthony Fauci, expressed his support for another global lockdown and the punishment of those who refuse to be vaccinated.

**(More:** I have seen several reports that say White House staffers have leaked reports that Biden is planning to declare another pandemic and order a few people (airline employees, passengers, etc.) to start wearing face masks as soon as September or October. Then, starting in December, he hopes to order a full-scale lockdown, try to force vaccinations on everyone again, and require everyone to wear face masks. Some reports say there is no pandemic, but the Biden administration is already signing contracts, buying equipment, and hiring people to push pandemic protocols on the American public for the next several years.)

**(More:** On August 24, 2023, it was reported that a new type of Covid-19 booster shots could be available by mid-Sept.)

**(More:** On August 25, 2023, Pres. Biden told a group of reporters, *“People should plan to receive another Covid-19 booster shot in response to a new rising variant.”* It was also reported that Biden said, *“I signed off this morning on a proposal to present to the Congress requests for additional funding for a new vaccine.”*)

**(More:** On August 26, 2023, it was reported that Riverton, Utah Mayor Trent Staggs said he will not enforce a repeat of the Covid protocols. He believes citizens should be allowed to make their own decisions about getting jabbed, locking down, wearing a mask, etc.)

**(More:** I have also seen one report by a Fact Check group that said most of the things reported above are false. It is an established fact that Biden lies, Biden gets confused, deceit is rampant, and it is hard to know what to believe. I find it more difficult by the day to believe everything he says and even what some Fact Check groups say. Biden said he *“tentatively”* plans to recommend another round of jabs, and that may be where the problem is. *“Tentatively”* could mean likely but not definitely. Nevertheless, there is a problem: Why has he already signed contracts if he is unsure about what he intends to do?)

**Two**, concerning deceit and pandemics: on August 17, 2023, the Russian Embassy in Washington D.C. said (as I understand it):

- The U.S. is conducting illegal research on biological agents that can be used to manage artificial pandemics.
- The U.S. has established labs all over the world to carry out this illegal research under the guise of “epidemiological monitoring.”
- The U.S. is seeking ways to create crises that can be used to advance their interests.

According to the article, in March of this year, Russia said the U.S. had built labs and was doing biological research in Ukraine, but the U.S. quickly dismissed it as Russian propaganda.

Since that time, the U.S. has admitted that it was supporting more than 40 labs in Ukraine that were working on worthy causes.

It makes me wonder, if the U.S. government was deceiving us in March, could they be deceiving us now?

Is Russia telling the truth when it accuses the U.S. of working on biological agents that can be used to manage “artificial pandemics?”

**Three**, concerning the return of Jews to the Promised Land at the end of the age: on August 17, 2023, it was reported that about 75,000 Jews immigrated to Israel in 2022, another 34,530 immigrated during the first six months of 2023, and there are about 60,000 in Russia that want to immigrate, but Russia will only allow 2,500 to leave each month.

**Four**, Jesus revealed that there will be Jews in Judaea at the middle of the Tribulation Period (Matthew 24:16).

On August 23, 2023, after a year of working on it, a group of architects, engineers, and others presented a plan to Israeli Prime Min. Netanyahu for the construction of cities, industrial parks, a hospital, a railroad, and an airport to boost the Jewish population of Judaea and Samaria to one million people.

**Five**, the Bible teaches that Jerusalem will be expanded and be a cup of trembling and a burdensome stone for the entire world at the end of the age (Zechariah 1:16-17; 12:1-3).

On August 20, 2023, Israel approved a plan to spend the equivalent of \$840 million on improvements and expansion in East Jerusalem over the next five years.



The Palestinians claim East Jerusalem; they want it to be the capital of their desired Palestinian state; the Temple Mount is there, and more, but Israel is now going to grow the area, make it more secure, and strengthen her sovereignty over it.

**Six**, concerning the Antichrist's confirmation of a worthless seven-year covenant with many for peace in the Middle East: last week, I reported that UN Sec. Gen. Guterres has scheduled a meeting for September 18-19 to push world leaders to commit to "seven years of accelerated, sustained, and transformative action, both nationally and internationally, to deliver on the promise of the SDGs" (Sustainable Development Goals that are in essence the creation of a world government).

I also noted that the Biden administration wants to conclude a deal by March 2024 (or at least in the next 9-12 months) to normalize relations between Saudi Arabia and Israel (something that they think will lead to peace and safety in the Middle East).

Now for the latest.

**Following three recent visits by U.S. National Security Adviser Jake Sullivan to Saudi Arabia, on Aug. 23, 2023, an unidentified senior Israeli official said on the condition of anonymity:**

- Progress has been made in discussions between the U.S. and Saudi Arabia, and an agreement could be reached as "early as next year."
- "We're talking about a peace agreement between Saudi Arabia and Israel next year, likely early next year."
- "We're navigating this diplomatically, and there's still ground to cover. We're in talks with both the Saudis and Israelis."

Concerning the U.S. and Saudi Arabia, the talks have been mostly about the safety of Saudi Arabia (the U.S. protecting Saudi Arabia from Iran, the U.S. sending weapons to Saudi Arabia, helping the Saudis build a nuclear reactor, etc.).

Concerning the Palestinians and the demands that are being placed on Israel: Ron Dermer, Israel's Strategic Affairs Minister, said the talks have been mostly about the U.S. and Saudi Arabia giving economic aid to the Palestinians, not about Jewish settlement construction or halts in Jewish settlement construction.

Understand that a UN agreement to establish a world government in seven years, a likely agreement to establish peace between Saudi Arabia and Israel, and protection (safety) for the Saudis against Iran in early 2024 are extremely big events in Bible prophecy.

**(More:** On Aug. 27, 2023, it was reported that the U.S. has advised Israel that it will have to make major concessions to the Palestinians for a deal to succeed.)

**Seven**, concerning the decline of America and an economic collapse: on Aug. 25, 2025, it was reported that the BRICS nations (Brazil, Russia, India, China, and South Africa) will be joined by Saudi Arabia, Iran, Argentina, Egypt, Ethiopia, and the United Arab Emirates (UAE) effective Jan. 1, 2024.

Officials expected the BRICS nations to control 60% of the world's oil.

The addition of these other six nations on Jan. 1, 2024, will give the group control of 80% of the world's oil.

Biden's decision to shut down the Keystone XL pipeline, suspend new oil and gas drilling permits, sell about 75% of America's strategic oil reserves, etc., has now left the U.S. in a bad position.

It may take a while, but some officials say the price of oil will drastically increase, and that will drive up the price of everything average U.S. citizens buy.

**(FYI:** Russia and Iran are riding high right now, but they will be brought down, and BRICS will be weakened when the Battle of Gog and Magog takes place.)

**Eight**, it has recently been reported that the World Economic Forum (WEF) and the International Monetary Fund (IMF) are calling for a global digital ID and a global digital currency system that uses trackable Central Bank Digital Currencies (CBDCs).

We have even been told that these could soon become a reality.

Leo Hohmann, a very highly respected researcher and writer, put it like this:

Digital ID + CBDC = Total control/tracking of all human activity.

Hohmann added, *"Once these two totalitarian tools are in place, there will be no turning back."*

As I understand it, he was saying (and I agree with him) the system that will lead to the Mark of the Beast will be in place, and it will be unstoppable.

**Nine**, concerning the decline of America: on August 22, 2023, it was reported that the Biden administration has opened 114 gates in Trump's border wall and welded them open so they cannot be closed by border control agents.

**(More:** On August 28, 2023, it was reported that the DHS has spent \$770 million to facilitate illegal immigration.)

**FYI:** God does not send anyone to Hell (all of us are born with a sin nature and destined to go to Hell because we sin), but God has provided a way (Jesus) for everyone to go to Heaven (and He is the only way to get there; John 14:6).

Howard Hodgson wrote in his 2007 biography, *'Charles: The Man who will be King'* how Charles became increasingly preoccupied with one part of royal life. He explained: *"The Prince yearned for a 'proper job' — one where he might make a difference to the lives of his future subjects."*

*"This was to become an obsession with him."*

*"At this time, he referred to it in a speech at Cambridge University, saying, 'My great problem in life is that I do not really know what my role in life is.'"*

*"At the moment, I do not have one." "But somehow, I must find one'."*

As Mr. Hodgson pointed out, *"there seemed to be a direct correlation between the longevity of monarchs and the riotous lives of their sons and heirs"*, as seen in Charles' great-uncle Edward VIII who was known for partying in his youth.

Charles did have a stint in the Royal Navy; however that came to an end after five years in 1976. Some suggested that the heir take on a role such as a British ambassador to another country, or as a governor-general of a Commonwealth member state. However, the heir eventually realized he already had enough on his plate with his multitude of organizations and charities that he headed up.

From all my research and reading, Prince Charles has been Satan's man since his birth to bring death and destruction to the world as the Antichrist. That becomes believable after reading an unauthorized biography of Prince Charles. And much of what I have shared earlier in this article.

An unauthorized new biography of Prince Charles paints a picture of a capricious man who is obsessed with the public's opinion of him, whose lavish spending reveals a royal utterly divorced from the life of ordinary people.

According to Tom Bower's *'Rebel Prince'*, published in 2018 by William Collins, Charles once "*shrieked*" and "*trembled*" at the sight of an unknown plastic substance covering his dinner, only to be told "*It's cling film, darling,*" by Camilla. On another occasion, Bower claims the prince brought his own mattress, toilet seat, Kleenex Velvet toilet paper and two "*landscapes of the Scottish Highlands*" when visiting a friend in north-east England.

The biography also alleges that Charles took a trip on the royal train from Highgrove to Penrith to visit a pub, a journey that cost £18,916; at another time, the prince reportedly complained in his journal after flying Club Class to Hong Kong in a chartered British Airway plane: "*It took me some time to realize ... that this was not first class (!) although it puzzled me as to why the seat seemed so uncomfortable.*" Such is the end of Empire, I sighed to myself.

According to Bower, the prince has arrived at functions with his own pre-mixed martinis carried by a police officer.

Bower, who has previously written unauthorized biographies of names including Tony Blair, Richard Branson and Mohamed Fayed, says he interviewed more than 120 people for his biography of Charles, who he claims has "*resorted to machination and media manipulation to restore his position*" since 1997. The prince, Bower writes, "*presides at the center of a court with no place for democracy or dissenting views ... like some feudal lord*".

Charles' army of employees – Bowers claims that he has more than 120 staff – include three footmen to escort visitors to his office, "*each responsible for a short segment of corridor*"; four valets to help him change his clothes up to five times a day; four gardeners who "*lie flat, nose down on a trailer*" to hand pluck weeds, because of the prince's hatred of pesticides; and "*retired Indian servicemen ... deployed to prowl through the undergrowth at night with torches and handpick slugs from the plants of leaves*". According to Bower, the prince has arrived at functions with his own pre-mixed martinis carried by a police officer, with an aide delivering a bag containing the food he would eat.

Charles is obsessed with public opinion, Bower claims, even once hurling a dinner plate to the floor at a dinner party after learning of his low popularity ratings. "*Mama down the road,*' he told a visitor, *'reads newspapers; I don't. It would drive me mad,*" writes Bower,

who also claims that Charles had a habit of throwing objects at the radio when *“enraged by an item ... The set was always being repaired.”*

The book also details a meeting between the prince and Peter Mandelson, during which the Blairite former minister allegedly told Charles that the public thought he was *“rather glum and dispirited”*, which had *“a dampening effect”* on their opinion of him.

*“After Mandelson had left, he beseeched Camilla, ‘Is that true? Is that true?’ ‘I don’t think any of us can cope with you asking that question over and over again for the next month,’ she replied,” writes Bower. In the wake of Diana’s death, writes Bower, Charles was “paralyzed by guilt”, chanting: “They’re all going to blame me, aren’t they? The world’s going to go completely mad.”*

His portrait is of a man discontent with his lot. *“Even my office is not the right temperature. Why do I have to put up with this? It makes my life so unbearable,”* the prince is quoted as saying to an assistant. Bower quotes one friend describing Charles as *“an Olympian whinger”*; Charles himself is quoted as saying in 2004: *“Nobody knows what utter hell it is to be Prince of Wales.”*

Bower claims that access to Charles was sold *“to raise money for his many charities and to indulge in ostentatious luxury”*, with Turkish billionaire Cem Uzan allegedly paying £200,000 for his wife to sit next to the prince at a dinner in 2000, and American oil tycoon Armand Hammer spending approximately £40m over several years on Charles’ charities and personal expenses, in an attempt to rehabilitate his own public image.

The biography details the prince’s fractious relationship with government; Tony Blair is quoted describing dealing with Charles as *“toxic”*, while the prince allegedly *“screamed”* at David Cameron in 2010, over the then London mayor Boris Johnson’s call to hand over control of the royal parks to the Greater London Authority. Bower writes: *“‘Boris is taking over the royal parks?’ he screamed. ‘Why have you given the royal parks to Boris?’ ‘The queen agreed,’ replied Cameron. ‘What? Mama down the road? What does she know about the royal parks?’”*

The *‘Rebel Prince’* also tackles Charles’ relationship with his sons, with Bower claiming that he is concerned that the public is more interested in Prince William and Kate Middleton than himself, as well as fretting over his future portrait on coins when he becomes Charles III. According to Bower, Charles was concerned that the original portrait *“showed his thinning hair and reflected his age”* and *“demanded that he should be shown with a full head of hair, and considerably younger. The revised version was more satisfactory.”*


*“He was less pleased when the Mint suggested that it should also prepare portraits for King William,”* writes Bower. *“That, Charles ordained, was pushing fate too far.”*

Describing himself as a committed monarchist, Bower nonetheless concludes that the prince's legacy has been *"tarnished by his addiction to luxury, his financial mismanagement, his disloyalty to professional supporters, and the torrid relationships with his family"*. He expresses concern that Charles, when king, *"will act alone, without any restraining adviser. For committed monarchists, that independence is alarming. They can only hope for the best."*
