US to Give Automakers, Suppliers \$12B to Produce EVs Your taxes of course!

The United States is making \$12 billion available in grants and loans for automakers and suppliers to retrofit their plants to produce electric and other advanced vehicles, Energy Secretary Jennifer Granholm told reporters Thursday.

The Biden administration will also offer \$3.5 billion in funding to domestic battery manufacturers, Granholm said.

For the advanced vehicles, \$2 billion of the funding will come from the Inflation Reduction Act which Democrats passed last year, and \$10 billion will come from the Energy Department's Loans Program Office, Granholm said.

Speeding grants and other subsidies to fund conversion of existing auto plants to build electric vehicles could help the White House blunt criticism from automakers and the United Auto Workers (UAW) union over proposed environmental rules aimed to help usher in the EV era.

The UAW has warned that such a rapid change could put thousands of jobs at risk in states such as Michigan, Ohio, Illinois and Indiana. Shawn Fain, the UAW president, has campaigned to save a Jeep factory in Belvidere, Illinois, that Stellantis has put on track to shut down. The automaker has left open the possibility that the factory could get a new product with government aid.

This is a perfect example of how the Antichrist, Prince Charles of Wales is forcing the U.S. to capitulate and surrender its sovereignty through extortion to his "Sustainable Development Goals" (SDGs) "Depopulation" agenda.

Did Jesus Teach a Pretribulation Rapture?

This is an important question and very relevant in my opinion and many will tell you that He did not; however, scrutiny of His Words, couched by the annals of time, we can confirm He did show discretion in how He communicated the teaching. Several years

Paul's Epistles to the Thessalonians indicate clearly that the Rapture will take place before the Day of the Lord and before the appearance of the man of sin, but did Jesus teach the Rapture before the Tribulation?

The answer is Yes. Some commentators have quite rightly pointed out that the Church did not begin until the Day of Pentecost, therefore all that is recorded in the four Gospels describes events that were enacted in the Age of Law. Jesus came to His own place; Israel. The disciples were instructed: "Go not in the way of the Gentiles...but go rather to the lost sheep of the house of Israel" -(Matthew 10:6).

When Jesus spoke of the Church He referred to it in the future tense, always, "I will build my Church" -(Matthew 16:18).

While the Church began at Pentecost its character as the body of Christ was progressively revealed to Paul -(Ephesians 3:5) and recorded in his epistles. On this basis one would not expect to read of the Rapture of the Church in the Gospels since the Church was still a "mystery... hid in God" from the beginning of the world - (Ephesians 3:9).

However, since the sudden disappearance of millions of Christians must have a global impact it would be surprising if it were not included in the signs of the end of the age. The fact is that it is mentioned among the signs to Israel of the end of the age which precedes the return of Christ to establish His universal kingdom.

When the disciples asked the Lord, "What shall be the sign of thy coming and of the end of the age?" Jesus listed many events that would indicate that His coming was "near, even at the doors" -(Matthew 24:33). One of those signs was a global disappearance of individuals. He could not say that it was the Church because the Church did not exist at that time and the truth of the Church awaited special revelation to Paul years later.

So Jesus said, "As the days of Noah were, so shall the coming of the Son of man be. For as in the days that were before the flood they were eating and drinking, marrying and giving in marriage, UNTIL the flood came, and took them all away; so shall also the coming of the Son of man be. THEN shall two be in the field, the one shall be taken and the other left. Two women shall be grinding at the mill; the one shall be taken and the other left" -(Matthew 24:37-41).

In the context of the Lord's words this can only mean that the Tribulation is likened to the flood of Noah's day and just as God removed the righteous before judgment fell, so there would be the sudden removal of individuals before the Tribulation began. This would be a sign to Israel. The words used in the Greek text confirm that those who disappear are blessed for the word "taken" is "paralambano" meaning, "to receive to one's self" or "to take alongside". The word translated "left" is "afeeaymee" meaning to "go away" and is used of a man divorcing, or "putting away", his wife. -(1st Corinthians 7:11).

Luke's Gospel records the Lord's words on another occasion when he gave the signs of the approaching kingdom and likened the end of the age to the days of Noah and Lot. He said, "The same day that Lot went out of Sodom it rained fire and brimstone from heaven, and destroyed them all. Even thus shall it be when the Son of man is revealed" -(Luke 17:29-30). Jesus again stated that at that time, "one shall be taken and the other left" -(Luke 17:34-36). When the disciples asked, "Where, Lord?" Jesus answered, "Wheresoever the body is, there will the eagles be gathered together" -(Luke17:37). The word used for "body" is "soma" meaning "a living body".

The word comes from "sozo" meaning, "to save". A different word is used in Matthew 24:28 where it is "ptoma", meaning "a rotting carcass". The context of Matthew 24:28 is Armageddon where the carrion birds will devour the flesh of the slain. The context of Luke 17 is the sign of missing persons at the end of the age.

When Jesus said that the eagles will be gathered to the living body He was indicating that those taken would rise like eagles ascending higher and higher in the sky, as they do, and thus answered the question of where those who disappear would be taken. They would be received to Himself.

There is no doubt the disciples could not have understood the Lord's answer at the time but we should remember that much of Bible prophecy was sealed until the end times. Daniel was told: "The words are closed up and sealed until the time of the end...but the wise shall understand" -(Daniel 12:9-10).

Finally, Jesus taught that He would return to establish His kingdom after the wedding - (Luke 12:36). Since the Church is the wife of the Lamb -(Revelation 19:7-8; Ephesians 5:32) she must be in heaven BEFORE the Second Coming.

These dates are fixed by destiny. By that I am saying the prophecies embracing these calendar events are for all intent and purpose is "History being told in advance!" Short of World War 3, I can see no foreseeable indicators that things will change. WW3 will break out just after the Rapture takes place. Revelation chapters 8 and 9 make it clear that a third of humanity will die in the coming World War! Many military sources are saying that we are already into World War III. It simply is another indication of how close we are to the Rapture event itself. That said, we should be anticipating our "Departure" as any day within the dates above. Your promise is found in Revelation 3:10 – "Because thou hast kept the word of my patience, I also will keep thee from the hour of temptation, which shall come upon all the world, to try them that dwell upon the earth."

This passage implies a dual prophecy message:

This church kept the word or teaching about the patient endurance of Christ. They kept looking to "Jesus the author (leader, example, pacesetter) and finisher (perfecter who brings believers to maturity and completion because He has already reached the goal toward which believers strive) of our faith." For the joy (a joy believers will share) that was set before Him, He "endured the cross, despising the shame (caring nothing for the shame and unafraid of it), and is set down at the right hand of the throne of God" -(Hebrews 12:2). This implies that they laid aside every weight (or encumbrance) and sin, and then, by running with patient endurance the race set before them, they kept their eyes on Jesus.

What did Jesus mean when He promised He would keep these believers from the "hour of temptation"? There are two principal and conflicting views concerning this matter about which there is much dispute. They deserve to be compared with each other.

First of all, it should be noted that the verse should be viewed from an end-time perspective, for Jesus immediately says, "Behold, I come quickly." Obviously, the temptation or trial in view is not a personal distress or a local persecution. It belongs to the eschatological time of temptation "which shall come upon all the world."

An early theological writer Dr. Edwin Hatch says in his "Essay on Biblical Greek" that Revelation 3:10 has an "evident reference to the tribulations which are prophesied later on in the book". Most exegetes agree that it refers to what is called the Great Tribulation. This must mean that Philadelphia and the other churches is representative of the whole Church in this age.

Now, what does Jesus Christ mean when He says, "I will keep you from the hour of temptation"? Will the Church be kept in and through the Tribulation, or will she be kept from coming into it at all? One school of thought holds the Church will go through the Tribulation, but that Christ promised special protection here, pointing to John 17:15, where the same phrase "kept from" is found. Other expositors see in this verse a promise that the Church will be kept from enduring this trial, which is a time of God's righteous judgment upon sin, that the contexts of John 17:15 and Revelation 3:10 are

quite different. The Apostle Paul actually answered this question for us in his letters to the Thessalonian Church. It is really understood from the perspective that prophecy is history told in advance. I am working on a more detailed explanation on this concept and how our understanding is distorted and so I will deal with it in greater detail, Rapture time permitting! Part of the answer is found in Revelation 1:19 "Write the things which thou hast seen, and the things which are, and the things which shall be hereafter;" Theologically, the book of Revelation has been interpreted in multiple ways, and reflects the creativity of the Creator's ability to incorporate a multi-dimensional meaning or understanding for different times since the Apostle John wrote Revelation in 95/96 A.D.

There are four major or Traditional views of understanding the book of Revelation:

- The <u>historicist</u> view, which teaches that the prophecies have been fulfilled throughout history and are still being fulfilled today.
- The <u>preterist</u> view, which teaches that most prophecies in the book of Revelation were fulfilled during the time of the Roman empire before 70 A.D.
- The <u>futurist</u> view, which teaches that most prophecies beyond Revelation 3 are yet to be fulfilled.
- The <u>spiritual</u> (or symbolic or idealist) view, which teaches that Revelation describes in symbolic language the battle throughout the ages between God and Satan and good against evil.

It's not a question of who is right or wrong, rather it is a matter of where one was situated in the history of time. Bishop Augustine in 450 A.D. read Scripture at a different time than Martin Luther in 1517 A.D. different from the present time we live. Each school of thought saw things differently with their scope and knowledge. It is fair to state the Bible is a "Living" book for all generations.

There are at least four other levels of application to these letters:

- Local: These were actual, historic churches, with valid needs.
- Admonitory: In each of the letters there appears the key phrase, "Hear what the Spirit says to the churches".
- Homiletic: Each of the letters also contains the phrase, "He that hath an ear let him hear."
- <u>Prophetic</u>: The most amazing discovery, however, of these seven letters is their apparent prophetic application.

A few Bible Astronomy observers are saying the Rapture could occur on September 19th or the 20th. I am still holding with September 19th because of the planet Venus being at its greatest illumination on that specific day. The "Morning Star" of Venus is identified as belonging to Jesus Christ. Read Revelation 2:28 and 22:16. My point is that we must be out of here before Daniel 9:27 is fulfilled. The Antichrist fulfills it and we can agree that only Prince Charles of Wales, now king of the British Commonwealth is that man!

Numbers 19 Prophecy

An important aspect of the Daniel 9:27 Prophecy deals with the Red Heifer! It seems that every few years, a red heifer (red cow) is born in Israel, and it results in some people thinking that the return of Jesus is near. Why is this? What does a red heifer have to do with the end times? Before we explore that question directly, it is important to understand the significance of a red heifer in the Bible.

To meet the requirements of the Old Testament law, a red heifer was needed to help accomplish the purification of the Israelites from uncleanness—specifically, the ashes of a red heifer were needed (see Numbers 19). Because red heifer ashes were necessary for the purification rites held at the temple, many have regarded the appearance of a red heifer today as heralding the construction of the third temple and the return of Christ.

According to rabbinical tradition, there have been nine red heifers sacrificed since Moses' time. Since the destruction of the second temple, no red heifers have been slaughtered. The rabbi Maimonides (1135—1204) taught that the tenth red heifer would be sacrificed by the Messiah Himself (Parah Adumah, ch. 3, § 4). The Temple Institute, a group advocating the construction of a third temple, reports that five flawless red heifers from Texas arrived in Israel on September 15, 2022 (https://templeinstitute.org, accessed 9/22/22). Many people view this event as a fulfilment of prophecy, since the acquisition of a red heifer is a major step forward in plans for a new temple.

Red Heifer in 45 DAYS? When You See THIS. Know The Tribulation is Near

The Mosaic Law specified that the red heifer was to be "without defect or blemish" and to have never borne a yoke -(Numbers 19:2). The sacrifice of the red heifer was unique in the law in that it used a female animal, it was sacrificed away from the entrance to the tabernacle, and it was the only sacrifice in which the color of the animal was specified.

The slaughtering of a red heifer is described in Numbers 19:1–10. Eleazar the priest was to oversee the ritual outside the camp of the Israelites. After the animal was killed, Eleazar was to sprinkle some of its blood toward the front of the tabernacle seven times -(verse 4). Then he left camp again and oversaw the burning of the carcass of the red heifer -(verse 5). As the red heifer burned, the priest was to add "some cedar wood, hyssop and scarlet wool" to the fire -(verse 6).

The ashes of the red heifer were then collected and stored "in a ceremonially clean place outside the camp." The ashes were used "in the water of cleansing; it is for purification from sin" -(Numbers 19:9). The law goes on to detail when and how the ashes of the red heifer were used in purifying those who came in contact with a dead body: "Whoever touches a human corpse will be unclean for seven days. They must purify themselves with the water on the third day and on the seventh day; then they will be clean" -(verses 11–12). The purification process involved the ashes

of the red heifer in this way: "Put some ashes from the burned purification offering into a jar and pour fresh water over them. Then a man who is ceremonially clean is to take some hyssop, dip it in the water and sprinkle . . . anyone who has touched a human bone or a grave or anyone who has been killed or anyone who has died a natural death" -(verses 17–18).

The commands concerning the red heifer were yet another foreshadowing of the sacrifice of Christ for believers' sin. The Lord Jesus was "without blemish," just as the red heifer was to be. As the heifer was sacrificed "outside the camp" (Numbers 19:3), Jesus was crucified outside of Jerusalem -(Hebrews 13:11–12). And, just as the ashes of the red heifer cleansed people from the contamination of death, so the sacrifice of Christ saves us from the penalty and corruption of death.

The red heifer ritual as established in the Mosaic Law was fairly simple; in the interval since that time, Judaism has added many standards and extra criteria. Talmudic tradition speaks of the type of rope the red heifer was to be bound with, the direction it was to face when being slaughtered, the words spoken by the priest, the wearing of sandals during the ritual, etc. The rabbinical rules listed many things that would disqualify a red heifer from being sacrificed: if she had been ridden or leaned on, if she had a garment placed over her, if a bird had rested on her, and if she had two black or white hairs, among many other conditions not found in the biblical text.

According to the futurist timeline of eschatology, there will indeed be a third temple of God in Jerusalem. Jesus prophesied a desecration of the temple to occur during the tribulation -(Matthew 24:15; cf. 2nd Thessalonians 2:4); for that to happen, there obviously will need to be a temple. Assuming those who dedicate the end-times temple follow Jewish law, they will need the ashes of a red heifer, mixed with water, for the ceremonial cleansing. If a blemish-free red heifer has truly been found and is in Israel that could be one more piece falling into place for the fulfillment of biblical prophecy.

Must a red heifer be found before the rapture occurs? No, Jesus could return to receive His own at any moment. The rapture is not contingent on the presence of any particular cow. Must a red heifer be found before the temple is rebuilt? Not necessarily, although temple advocates certainly want one for ceremonial purposes. Are animal sacrifices of any type required today? No, Jesus fulfilled all the requirements of the law, and His sacrifice provides true forgiveness and life eternal.


Scripture explicitly contrasts the red heifer ceremony with the greater sacrifice of Christ: "The ashes of a heifer sprinkled on those who are ceremonially unclean sanctify them so that they are outwardly clean. How much more, then, will the blood of Christ, who through the eternal Spirit offered himself unblemished to God, cleanse our consciences from acts that lead to death, so that we may serve the living God!" (Hebrews 9:13–14).

Red Heifer in 45 DAYS? When You See THIS, Know The Tribulation is Near

Cancer Risk Surges From Even Tiny Trace of Tritium, Expert Warns Amid Fukushima Water Dump

Japan's decision to discharge treated nuclear-tainted water into the Pacific has sparked vehement objections from the local population, the international humanitarian community, as well as from China, South Korea, and other neighbors in the region.




Japan started discharging radioactive, tritium-laced wastewater from the earthquake and tsunami-hit Fukushima Daiichi Nuclear Power Plant in late August, with all of the country's immediate neighbors, plus Mexico and countries in Latin America, voicing concern over the move. However, Japanese authorities assured that the procedure is safe.

The presence of even a low concentration of tritium in water is known to increase the risk of cancer by over 500%, Moscow State University oceanographer Sergey Mukhametov has told *Sputnik*.

As for the long-term effects of trace amounts of the hydrogen-derived isotope present in the filtered cooling water being dumped <u>from the Fukushima nuclear site</u>, scientists are yet to determine that, he added.

According to the expert, this conclusion has been made by American scientists David Kocher and Owen Hoffman from the Oak Ridge Center for Risk Analysis. Their <u>research</u> presented an assessment of lifetime risks of cancer incidence

associated with the drinking water standard for tritium established by the US Environmental Protection Agency (USEPA).



In America, this standard is an "annual-average maximum contaminant level (MCL) of 740 Becquerel's per liter."

The results of their study revealed that the average risk of skin cancer for both sexes when ingesting tritium in drinking water at the maximum contaminant level (MCL) over an average life expectancy (80 years for women and 75 for men) is 0.0003.

At the same time, the lifetime risk of cancer with a daily consumption of two liters of drinking water over an average life expectancy, excluding tritium and cases of skin cancer, is 0.000056. Thus, the risk in this case increases more than five-fold.

Earlier, the Tokyo Electric Power Company (TEPCO), the operator of the damaged Fukushima Daiichi Nuclear Power Station (Fukushima-1), <u>detected tritium</u> (T, or 3H – a radioactive substance) in the seawater off the northeastern shoreline of the port in proximity to the facility. This was the first detection of tritium since the release of treated, low-grade radioactive water commenced. According to TEPCO, the seawater around the plant has tritium levels below 10 Becquerel's per liter, well below the company's 700-becquerel set limit and the World Health Organization's (WHO) recommended safe drinking water threshold of 10,000 Becquerel's.

In late August, Japan's Fukushima Nuclear Power Plant operator announced that it was putting into motion its plan to release over a million metric tons of treated, highly-diluted radioactive wastewater from the crippled plant into the Pacific Ocean. Tokyo has argued that the treated water needed to be discharged as it urgently needed to free up space at the Fukushima facility.

While initially Tokyo planned to begin discharging water purified of all radionuclides except tritium into the ocean 0.6 miles from the station this spring, the deadline was pushed back to the summer of 2023 due to adverse weather conditions and other factors. The entire process is expected to take up to 30 years.

Japan's decision to discharge treated nuclear-tainted water into the Pacific has sparked <u>vehement objections</u> from the local population, the international humanitarian community, as well as from China, South Korea, and other neighbors in the region, who <u>fear radioactive contamination</u>. The International Atomic Energy Agency argued that the treated wastewater will have a negligible radiological impact on people and the environment.

More Stick, Less Carrot – Prison For Not Complying With Energy Rules?

Climate Change Fanatics Upping Their Game

In a recent World Economic Forum discussion, it was acknowledged that governments will need to start using more sticks and less carrots.

"We're going to need to change behaviors of individuals but also how our industries, corporations and also our governments work and practice. We're going to need to do this through a mixture of carrots and hopefully, err, perhaps not so many sticks... But we're likely to see an increasing move towards a more stick-like intervention into the future, as things worsen, if we're not able to act".

The UK government seems to be taking the WEF's advice seriously because, according to the <u>Telegraph</u>, they are looking to introduce new powers allowing new criminal offences to be created. This is in addition to increasing penalties for property owners who don't comply with new energy rules.

Ministers want to grant themselves powers to create new criminal offences and increase civil penalties as part of efforts to hit net zero targets. Under the proposals, people who fall foul of regulations to reduce their energy consumption could face up to a year in prison and fines of up to £15,000.

The proposals will come before Parliament on Tuesday when MPs return back to work to discuss the Energy Bill.

It provides for "the creation of criminal offences" where there is "non-compliance with a requirement imposed by or under energy performance regulations". People could also be prosecuted for "provision of false information" about energy efficiency or the "obstruction of... an enforcement authority".

As seen with the Coronavirus legislation, ministers "are giving themselves broad umbrella powers to redraw and enforce the system before consulting on precisely which changes to make. Tory MPs have expressed alarm that ministers would be able to create new offences with limited parliamentary scrutiny under the update".

The Bill is festooned with new criminal offences. This is just unholy, frankly, that you could be creating criminal offences... The ones we've found most offensive are where a

business owner could face a year in prison for not having the right energy performance certificate or type of building certification.

Instead of undergoing scrutiny, criminal offences will be created using statutory instruments. These are still approved by Parliament but "typically nodded through". There has not been a statutory instrument rejected in the last 35 years.

At the same time, Ultra Low Emission Zones (ULEZ) in London has been causing controversy. The newly expanded scheme means that drivers of certain vehicles (i.e. poor people who can't afford Tesla's) are forced to pay £12.50 (\$15.75) every day to drive in any of London's 32 London boroughs. The fine for not paying on time is £180.

Whilst this might not sound a lot of money to some, an additional £400 per month just to drive to work, will be an absolute killer for a lot of families. Another tax on the poor in the name of climate change.

A vigilante group calling themselves "Blade Runners" are going round London disabling or destroying the new ULEZ cameras. According to some reports, 90% of cameras have already been "retired".

Sales of angle grinders are through the roof and the usual suspects are all over social media congratulating the Blade Runners but is all that it seems?

Problem, Reaction, Solution.

In Dominic's own words, Mohamed Fayed was "nothing but trouble," citing for example "the almost toxically controversial nature of the Egyptian (then owner of Harrods) and the fact that having been condemned eight years earlier in a 752-page Department of Trade report as a serial liar and fantasist, he was not a suitable holiday host either for her or her sons."

More serious still was her spurning of warnings given in God's Word, the Bible, described as "the most valuable thing this world affords" at our queen's coronation. Warnings against consulting mediums are repeated throughout the book on which our democracy – and indeed monarchy – has been built, such as: "Do not turn to spirits through mediums or necromancers. Do not seek after them to be defiled by them: I am the Lord your God" -(Leviticus 19:31). See also Leviticus 20:27, where death is the result, and Deuteronomy 18:11, where it is described as "detestable." And in 1st Chronicles 10:13, we see that it was in part the cause of King Saul's death.

The New Testament contains a most illuminating passage on the subject, which involved a female fortune-teller who earned a great deal of money for her owners. She followed the disciples, shouting: "These men are servants of the Most High God, who proclaim to us the way of salvation" -(Acts 16:17b). She kept this up for many days until St. Paul got so annoyed that he commanded the spirit to come out of her "in the name of Jesus Christ" -(Acts 16:18b). It did, and that was the end of her owners' business.

The interesting thing is that she actually told the truth. But the devil also knows who Jesus is. The problem was that she was not serving God, but the devil. She was enslaved by the evil one and her freedom brought trouble—and jail—for Paul and his companion, Silas, because a money-making racket based on a forbidden activity had been stopped. The authorities sided with the owners of the occult practice, just as often happens today. Could this be why apparently little effort is being made to prevent so-called kinky sex festivals taking place on the doorsteps of protesting neighbors in Kent? One such festival, in woodland near Tunbridge Wells, was billed as a chance for hedonists to "fulfill fantasies on a mystical site where witches' covens have met for centuries."

Sexual promiscuity and the occult go together. Occult in all its forms—and that includes horoscopes—can be bracketed under the general heading of witchcraft. It is demonic, deceptive and disastrous.

According to the *Derby Telegraph*, Diana's visit to psychic Rita Rogers in Lower Pilsley was not a one-off, as she kept in regular touch. Rita apparently warned Dodi to avoid France for fear of an accident in a tunnel and had earlier predicted Diana meeting a man with the initial D on water (they met on his yacht).

So there could well have been elements of truth that drew Diana and her lover into a deadly trap. This is where dabbling into the occult leads, and why unsuspecting Britons need to be warned to avoid it and instead pursue the beautiful truth personified in Jesus, who said: "I am the way, the truth, and the life. No one comes to the Father except through me" -(John 14:6).

Fortune-telling enslaves you because it ties you to the course dictated by whatever "revelation" has supposedly been given rather than freeing you to make your own decisions and trust God to lead you in His "paths of righteousness" -(Psalm 23:3).

Of course, I can't say for certain whether Diana ever read the passages I have quoted or was aware of them. But the Bible is God's Word to us. It is not just a history book. It contains a vast breadth of advice and wisdom on how to live our lives. Ignorance on the day when we will all have to give account of our lives will be no excuse -(2nd Corinthians 5.10).

The fulfillment of many ancient prophecies, particularly those concerning the coming of Messiah Jesus as well as the more recent extraordinary re-gathering of Jews to their

promised land from every corner of the globe, is surely proof enough that the Bible can be trusted absolutely.

Prophecy—the forth-telling of God's will, ways and purposes —is one thing. Consulting mediums is quite another, an activity strictly forbidden by the Lord. It's about seeking secret knowledge in order to feel in control by delving into a future that God has chosen not to reveal. He wants us to live by faith — that is, by trusting him for our daily needs. "Without faith it is impossible to please God" -(Hebrews 11:6). It is not for us to know precisely what lies ahead (see Deuteronomy. 29:29).

Dabbling with darkness will invite all kinds of trouble to our lives. God wants us to live in the light, and He has shown us the perfect way by sending Jesus, His Son, "the light of the world" -(John 8:12).

One of the most famous passages of Scripture is preceded just a few verses earlier by this question: "When they say to you, "Seek after the mediums and the wizards, who whisper and mutter," should not a people seek after their God? Should they consult the dead for the living?" -(Isaiah 8.19). The former leads only to distress, darkness and fearful gloom -(see Isaiah 8:22).

Nevertheless ... "The people who walked in darkness have seen a great light ... For unto us a child is born, unto us a son is give ... and his name shall be called Wonderful Counselor, Mighty God, Eternal Father, Prince of Peace." -(Isaiah 9.1-6)

Princess Diana's Hidden Ancestral Pedigree Secret Revealed! With the Royals, Pedigree is Everything, and the Only Thing!

British scientists have used DNA to reveal Princess Diana's Indian roots. By ABC News June 14, 2013,

LONDON, June 14, 2013— -- Once upon a time, a woman from India named Eliza Kewark was shunned by her family because of her race.

The father of her child referred to her as the "housekeeper" and the "purported mother" of their daughter, Katharine.

Katharine was sent off without her mother to England, and that's where this story might have ended. But Katherine gave birth to Jane, who gave birth to Ruth, who had another Ruth, who had Frances, who had Diana.

As in Princess Diana.

Which means that Great Britain will, one day, have a monarch with Indian blood, and the Commonwealth will be led by a king with a clear genetic link to its most populous nation.

Eliza Kewark is Prince William's great-great-great-great-great-grandmother. She has long been described as Armenian, but Kewark was at least half-Indian, the genetic ancestry testing company BritainsDNA announced today.

BritainsDNA says it is confident of Kewark's lineage because it traced Williams' mitochondrial DNA, or mtDNA, which is passed down from mother to child. BritainsDNA took saliva samples from two unnamed members of the royal family and traced it back seven generations to Kewark, who was born around 1790.

Kewark's mtDNA is so rare, BritainsDNA said, that it has only been found in 14 other people, all but one of whom was Indian (the other one was Nepali).

"It is therefore likely that Prince William has not only inherited a small proportion of Indian DNA from Eliza Kewark but her heirs will also carry it," BritainsDNA said today.

According to the biography "The Real Diana," by Lady Colin Campbell, Kewark's background was known but kept quiet by a family that was full of Europeans descended from royalty.

"Eliza Kewark was a dark-skinned native of Bombay who had lived, without benefit of matrimony, with her great-grandfather Theodore Forbes while he worked for the East India Company," 'The Real Diana' reads.

"Unsavory as the taint of illegitimacy was, even at that distance in time, it was nothing compared with the stigma of what was then known as 'colored blood.' Had it been generally known that Ruth [Diana's great-grandmother] and her children were part-Indian, they might never have made good marriages.

"Eliza's true race was therefore expunged from the family tree and she reemerged as an Armenian. This fiction was maintained even when Diana married the Prince of Wales."

But times have changed and, today, and the family of Diana, who died in a car accident in 1997, celebrated their Indian heritage.

Mary Roach, Princess Diana's maternal-aunt, told The Times, "I always assumed that I was part-Armenian so I am delighted that I also have an Indian background."

Knowing that Prince Charles is very conscious about racial pedigree in the family, he has not completely forgotten that his son Harry married a bi-racial lady, Meghan Markle.

When the Royal Wedding uniting Kate Middleton and Prince William was announced, genealogy sleuths got to work. At first, the buzz indicated that Kate's mother, Carole Goldsmith (maiden name), had Jewish ancestry. If Carole Goldsmith were Jewish then, according to Jewish law, her daughter Kate Middleton would be considered Jewish -- and could become the first Jewish Queen (Consort) of England. But alas, investigators still believing that there was a Jewish heritage in Kate's lineage found that the last five

generations of her family were married in churches. Of course, that doesn't rule out that some may have been secret Jews, which was true for many Jews during the Inquisition. Other sources still suspect Jewish lineage for Kate. And according to an Orthodox Sephardic Rabbi in Israel, both parents of Kate's mother were Jewish. So the question of Jew or not a Jew for Kate is still open.

But wait, the plot thickens. Could Princess Diana, William's mother, have been Jewish? One source maintains that Princess Diana's mother, Frances Shand Kydd, was Jewish -- born Frances Ruth Burke Roche, a Rothschild.

If factual, that would be sufficient for Princess Diana to be certified Jewish, as well as her son, William, the future King of England. Another investigation of ancestry details a strong Davidic connection for Frances and her descendants. Other intriguing bits of "evidence" and speculation have been cited in the 'London Daily Mail', which quotes sources that claim that Diana was conceived during her mother's affair with the Jewish banker tycoon Sir James Goldsmith (originally Goldschmidt and no apparent relationship to Carole Goldsmith). The report says that Frances was estranged from her husband, Earl Spencer (Viscount Althorp), and had an affair with Sir James Goldsmith just at the time that Diana was conceived. Strengthening the case, a report points to striking resemblances between Princess Diana and Sir James Goldsmith's other three children, Zak, Ben and Jemima Goldsmith.

If these tidings are true then Diana would be thoroughly Jewish with a Jewish mother (Frances Ruth Burke Roche aka Rothschild) and a Jewish father (Sir James Goldsmith). In turn William, the future King of England, would have deep Jewish roots.

Being Royal and marrying into the family, they are under so much scrutiny. Like Meghan and Diana, Vashti married into a kingdom and became the Queen of Persia. She refused to attend the King's banquet and therefore was banished because she didn't want to show her beauty as the king wished. Both dress codes encourage a preference to wear skirts and dresses at an appropriate length with pantyhose to trousers for ladies, as well as hats and head coverings for women.






The late Evelyn de Rothschild was probably giving Prince Charles of Wales a lecture on his future role as the Antichrist, fake messiah that will rule the world.

"The LORD will be king over the whole earth. On that day there will be one LORD, and His name the only name."

Here is God's promise to King David: "And when thy days be fulfilled, and thou shalt sleep with thy fathers, I will set up thy seed after thee, which shall proceed out of thy bowels, and I will establish his kingdom. He shall build an house for my name, and I will stablish the throne of his kingdom for ever" -(2nd Samuel 7:12-13). Jeremiah's and Ezekiel's prophecies should be understood this way: the Jews would one day return to their own country, their yoke of slavery would be removed, their fellowship with God would be restored, and God would provide them with a King of His own choosing. This King would, in some way, be like King David of old. These passages can refer to none other than the long-awaited Messiah, the "Servant of the Lord" -(cf. Isaiah 42:1). The Jews sometimes referred to the Messiah as "David" because it was known the Messiah would come from David's lineage. The New Testament often refers to Jesus as the "Son of David" -(Matthew 15:22; Mark 10:47).

There are other reasons, besides being the Son of David that the Messiah is referred to as "David." King David in the Old Testament was a man after God's own heart -(Acts 13:22), he was an unlikely king of God's own choosing, and the Spirit of God was upon Him -(1st Samuel 16:12–13). David, then, is a type of Christ (a type is a person who foreshadows someone else). Another example of this kind of typology is Elijah, whose ministry foreshadowed that of John the Baptist to the extent that Malachi called John "Elijah" -(Malachi 4:5; cf. Luke 1:17; Mark 9:11–13).

David will be resurrected at the beginning of the Millennium, along with all the other Old Testament saints. And David will be one of those who reign with Jesus in the Kingdom - (Daniel 7:27). However, all believers will rule the nations -(Revelation 2:26–27; 20:4) and judge the world -(1st Corinthians 6:2). The apostle Peter calls Christians "a chosen race, a royal priesthood, a holy nation" -(1st Peter 2:9). In Revelation 3:21, Jesus says about the believer who conquers, "I will grant him to sit with me on my throne." In some sense, then, Christians will share authority with Christ -(cf. Ephesians 2:6). There is some biblical evidence, as in the Parable of the Ten Minas -(Luke 19:11–27),

that individuals will be given more or less authority in the Kingdom according to how they handle the responsibilities God has given them in this age -(Luke 19:17).

Jesus is the King of kings -(Revelation 19:16). Humanly speaking, Jesus is from the Davidic dynasty; but in power, in glory, in righteousness, and in every other way, He is rightly called the Greater David. "The government will be on his shoulders" -(Isaiah 9:6). The Old and New Testaments reveal that the future King during the Millennium and all eternity is Jesus Christ and Him alone -(Jeremiah 23:5; Isaiah 9:7; 33:22; Revelation 17:14; 1 Timothy 6:15).

The 'Simonini Letter' — The First Evidence Connecting Jews, Freemasons & Illuminati To World Revolution


In 1806, after reading <u>Memoirs Illustrating the History of Jacobinism</u>, a professional soldier from the Piedmont in northwest Italy named Jean-Baptiste Simonini felt compelled to write the author, a French Catholic priest named <u>Augustin Barruel</u>, to divulge his firsthand knowledge about the role the Jews played in the <u>Freemasons and the Illuminati</u> — and how this nexus of power orchestrated the French Revolution — and had plans to take over all of Europe.

It is clear that Barruel believed the letter and its contents to be authentic — despite the fact that he was never able to subsequently locate or contact Simonini, but researchers have confirmed that Simonini was exactly who he said he was and lived in Lilianes in the Aosta Valley. Barruel used his network of connections within the Church to make inquiries about Simonini in Piedmont — and was told that Simonini had a good reputation and could be trusted.

So convinced of the truth outlined in Simonini's letter, Barruel felt compelled to write another book that included the Jewish hidden hand in world events — but on his death bed, he had misgivings about publishing it and asked that the manuscript be burned — and it was.

The original letter in Simonini's hand has never been found — though some believe it still exists somewhere in the Vatican archive — a detail that many have used to desperately try to discredit or debunk it. Others have made the spurious claim that the Illuminati had "disbanded" prior to the French Revolution — transparent disinformation put out by the Freemasons themselves, as detailed by former Scottish Freemason John Robison in his landmark 1798 book, *Proofs Of A Conspiracy*.

An important aspect of Simonini's letter is that he contends that the Jews in Piedmont approached *him* because he was a high-ranking military man who could be useful to them and their cause — and he admittedly let them believe that he was an orphan born into a Jewish family with strong natural affinities and sympathies to the Jewish nation — so that they would feel that they could trust him.



Historian Claus Oberhauser — who went to the Jesuit archives in Vanves outside of Paris — wrote, "I've seen a copy of [Barruel's] book accompanied by notes written by him after 1806. At various points in these notes, Barruel wrote Simonini's name over a passage about Jews and remarked that it was probably Jews who were pulling the strings."

Despite being firmly convinced of the truth of the Simonini letter, Barruel chose not to publicize it — allegedly fearing that its revelations could incite widespread violence against the Jews. However, the fact that Barruel was a Jesuit likely had a greater influence over his decision to withhold the letter — after all, the Jesuit Order was founded by a converso Jew — Ignatius Loyola — and had attracted so many other conversos that the Order gained a reputation of being a "virtual synagogue."

According to Oberhauser, Barruel did, in fact, send copies of Simonini's letter to some of his Jesuit colleagues — along with a postscript explaining his opinion of the Jewish-Masonic-Illuminati conspiracy. As such, it wouldn't be unreasonable to speculate that one — if not a number of — these Jesuits dissuaded Barruel from making the contents of the letter public. The Jesuits themselves had been infiltrated by Freemasons — a controversy that has plagued the Church for many centuries.

Given his extensive research, it was probably not lost on Barruel that the founder of the masonic Illuminati order was Adam Weishaupt, who was an orphan born of Jewish

ancestry but raised and schooled by Jesuits — just as Siminoni himself pretended to be to gain the trust of the Jews.

Despite all the evidence Barruel received from Simonini, he subsequently chose not to portray the Jews as the main conspirators of this secret cabal in the final manuscript that he was working on up until his death — and which he ultimately ordered destroyed. What caused him ultimately to shy away from portraying the Jews as the ultimate power behind the Freemasons and Illuminati? We will probably never know the answer, but surely the answer can be found within the circle of Jesuits to which he belonged.

The Simonini letter was finally published for the first time in 1878 — fifty-eight years after Barruel's death — in a French magazine <u>Le Contemporain</u> — and today, almost 140 years later, the letter has been virtually scrubbed from the internet — and finding an English translation is extremely difficult — proof that powerful people do not want this letter read, circulated, or given an credence.

So here we present our own English translation of the "The Simonini Letter" — based on the French copy published by <u>Le Contemporain</u> in 1878. We do not contend that our translation is perfect, but we have done our best to represent the contents of the original without embellishment, and we would encourage any of our many French-speaking readers — who are obviously more adept in translation — to submit any corrections to improve our text.

The Simonini Letter

Sir,

It has only been a few months since I was fortunate enough to learn of your excellent work "Mémoires des Jacobins." I read it—or better said devoured it—with real pleasure. Your book had the advantage of providing me with great insights for my own conduct, all the more so as I found an infinite number of exact depictions in it of things of that I have been, in the course of my life, an eyewitness to without fully understanding them. Please accept, then, sir, from an ignorant military man like myself, the most sincere congratulations on your work, which may rightly be called the quintessential work of the last century. You have unmasked these inflamed religious sects so well—sects that prepare the way for the Antichrist and are the implacable enemies, not only of the Christian religion, but of all worship, of all society, of all orders!

There is, however, one sect that you only touched lightly. Perhaps you did it on purpose, because it is the best known and therefore the least to be feared. But, in my opinion, it is the most formidable power today, considering its great wealth and the protection it enjoys in almost every state in Europe. As you know, sir, I am talking about the Judaic sect, which seems entirely separate and an enemy of other sects, but really it is not. Indeed, it is enough that one of these other sects shows itself to be an enemy of Christians, for the Judaic sect to favor it, bribe it and propagate it. Haven't we seen members of the Judaic sect lavish gold and silver to support and multiply the modern sophists, the Freemasons, the Jacobins, the Illuminati? The Jews, therefore, along with

all the other sectarians, form a single faction whose aim is to annihilate, if possible, Christians.

Please do not think, sir, that all of this is an exaggeration on my part. I am putting forward here nothing other than what was told to me by the Jews themselves. Here is how it came to pass.

While Piedmont, of which I am a native and which was in revolution, I had occasion to frequent them and to consult confidentially with them. They were the first to seek me out; and I, as I was then unscrupulous, pretended to forge a close friendship with them. I succeeded in telling them, while begging them keep the strictest secrecy, that I was born in Leghorn into a happy family, but that while still a very little boy I had been brought up by others—I do not know much about them; I did not even know if I was baptized and, although on the outside I lived and behaved like the Catholics, inside, however, I thought like those of my nation, for which I had always kept a tender and secret love. So they made me the biggest offers and gave me all their trust. They promised to help me become a general if I wanted to join the sect of Freemasons. They would show me the sums of gold and silver they intended to give, they told me, to those who embraced their party. They absolutely wanted to present three weapons to me, decorated with signs of Freemasonry, that I agreed accept so as not to displease them and to encourage them to tell me more of their secrets. Here is what the principal and richest Jews of Turin communicated to me on several occasions.

- 1. Manete (in French the Manes) and the infamous old man or old man of the mountain had come out of their (Jewish) nation.
- 2. The Freemasons and the Illuminati had been established yet have escaped memory.
- 3. In short, it is from them that the origins of all the anti-Christian sects can be traced—these sects are now so numerous in the world that they reached several million people of all sexes, of all states, of all ranks, of any level.
- 4. In Italy alone, they had more than eight ecclesiastics as supporters, both secular and regular, among whom many priests, public professors, prelates, a few bishops and a few cardinals. They even hoped to soon have a pope from their party. (Assuming that he [the Pope] was a schismatic, this becomes probable.)
- 5. Likewise in Spain, they had a great number of partisans, even in the clergy, although in this kingdom the accursed inquisition was still in force.
- 6. The Bourbon family was their greatest enemy, and in a few years they hoped to destroy it.
- 7. So as to better to deceive Christians, they pretended to be Christians, traveling and passing from one aisle to another with false baptismal certificates, which they bought from certain stingy and corrupt priests.

- 8. They hoped, by means of money and cabals, to obtain a civil status from all governments, as has already happened to them in several countries.
- 9. Once they having the rights of citizens like other people, they would buy as many houses and as much land as they could. By means of usury they would soon succeed in stripping Christians of their property and their treasures. (This is beginning to be true in Tuscany, where the Jews exert the most exorbitant usury with impunity and make immense and continual acquisitions both in the countryside and in the towns.)
- 10. Consequently, they promised themselves that in less than a century they would become the masters of the world and abolish all the other sects so that theirs would reign. The would make synagogues of Christian churches and to reduce the remaining Christians to true slavery.

These, sir, are the treacherous plans of the Jewish nation, which I have heard with my own ears. Undoubtedly, it is impossible that they can perform them all, because they are contrary to the infallible promises of Jesus Christ to his church and to the various prophecies which clearly announce that this ungrateful and obstinate people must remain wandering and vagabond, held in contempt and slavery, until they recognize the true messiah, whom they crucified, and, at this last consolation of the church, until they embrace the Christian faith.

However, they can do a lot of harm, if governments continue to favor them, as they have done for many years. It would therefore be wise to wish that an energetic and superior pen like yours made the aforementioned governments open their eyes and instructed them to make this people return to the abjection due to them and in which our fathers, more political and judicious than we are, always took care to keep them. Sir, I beg you to forgive this Italian, a soldier, for the many errors of all kinds that you will find in this letter. I ask that the hand of God reward you for all the luminous writings with which you have enriched his church and which grant you, from those who read them, the highest esteem and the deepest respect in which I have the honor of to be, sir, your very humble and obedient servant.

Jean-Baptiste Simonini

P.S. If you find yourself in this country and I can oblige you in anything, for example if you need new light to be shed on the contents of this letter, let me know and you will be completely obeyed.

The Jews are not Israel, the House of Judah is only of the twelve tribes, and in John 8, Jesus clearly and directly accuses them of being of Abraham's seed in the flesh, but having utterly betrayed Abraham's God in the Spirit.

Outright demonology is part and parcel of it. The texts relate how the Nephilim souls are refused access to Heaven, and are condemned to remain bound to the Earthly realm, without having bodies. They exist in some sort of parallel dimension.

There is every reason to believe that our current owners are channeling these demons, acquiring knowledge and power from them.

Sickeningly, the Jews are pretending to be Israel, God's Chosen People, and they are pretending that the rest of us are basically Nephilim. When the Old Testament speaks of the Gentiles, they mean the Nephilim off spring. The current Jewish playbook is pretending we are the soulless monsters like those that were destroyed by Moses. And that they have the right to use the same methods against us, as Moses used against the Giants.

While they themselves are in fact the tools of these Fallen Angels.

A good example is Old Testament Usury prohibition: God forbids lending at interest to his People, but NOT to his enemies, the Nephilim offspring. It was the Vatican who franchised Usury to the Jews, who are of the Synagogue of Satan, i.e. House of Rothschild and the houses of merchant bankers of Venice.

It's a gigantic projection and identity theft.

It also puts the Jewish resentment against Jesus in a very different and relevant light. Of course they could not accept him: he was denying their 'right' to enslave and destroy everybody for the Fallen Angels, as they would be doing in the centuries after their destruction by the Romans.

CONCLUSION

The main undercurrent of our history is the war between God and his People, Homo Sapiens, and the Fallen Angels and their half human, half Nephilim offspring.


