

# The Blessed Hope!

**“Looking for that blessed hope, and the glorious appearing of the great God and our Saviour Jesus Christ;” –(Titus 2:13)**

Recently a very good friend on the West Coast sent me an interesting posting by prophecy writer/author T.W. Tramm. His information is always interesting and at times provocative and I trust that you will be blessed by his article.

### **THE Great American Eclipse of 2017 was considered a major biblical sign.**

I do not know if any of you remember the date. It was a strange feeling as my wife and I sat on our back porch swing and watched the sky change before our eyes. It was August 21, 2017. I believe it was a Monday and from our location in central Kentucky, we had the longest period of time which was a bit over 2-1/2 minutes and everything was totally silent, none of the bird activity we normally have and it was rather eerily. Here below, I share T.W. Tramm’s post.

With a second, similar eclipse set to occur in 2024—its path traversing the former eclipse’s path to draw a giant ‘X’ across the continental U.S.—it is fascinating to consider the United States’ history and role in God’s redemptive plan for Israel. [It will occur on April 8, 2024]

Let’s start with America’s discovery.

### **COLUMBUS’ DIVINE MISSION**

The standard teaching is that Christopher Columbus’s discovery of America was an “accident”—that he was actually trying to reach Asia. However, the facts surrounding Columbus’s pivotal voyage suggest that it was not truly an accident but rather part of a divine plan.

Consider:

- Columbus was a devout follower of Christ who believed that God had ordained his expedition for a special purpose, to bring the Gospel to the ends of the earth in anticipation of Jesus’ soon return. The explorer was so convinced of his role in the end-times prophecies that he wrote a work entitled “*Book of Prophecies*” in which he cited Scripture to show how God had planned his voyage to the ‘new world,’ and would be doing further wonderful things for the Church through his discovery.

- A number of scholars believe that Columbus was of Jewish descent and that his voyage was in part a quest to find a better future, a new Promised Land, at a time when his people were being persecuted and expelled from Spain. Supporting this view is the fact that Columbus's journey was largely financed and supported by Jews. Researchers also point to the date Columbus set sail as evidence of his Jewish background: it was Av 10, the day after Jews traditionally mourn the destruction of both Temples and exiles from the Land, that he departed Spain.

- The duration of Columbus's voyage to parts unknown, which no man could have planned or orchestrated, nonetheless seems orchestrated. After a series of mishaps at sea, including a broken rudder, a faulty compass, and a near mutiny of the crew who feared they would never make it back to Spain, Columbus sighted land and went ashore at the Americas on the 70<sup>th</sup> day of the voyage. Thus, the journey to the new Promised Land began on Av 10, a day associated with Jewish exile; it lasted for exactly 70 days, the biblical number of homecoming and redemption, and ended on the last day of Tabernacles, the festival associated with God's provision and a temporary dwelling place.

America would indeed turn out to be a new Promised Land, a nation rooted in, and accommodative of, Hebrew values and aspirations:

- The Puritans living in America viewed themselves as a new 'chosen people' dwelling in a 'new Israel.' Their fast and feast days, including Thanksgiving, were based on Jewish observances such as Yom Kippur and Feast of Tabernacles.

- One of the original designs for the Great Seal of the U.S. depicted the Israelites crossing the Red Sea, with Pharaoh in pursuit.

- The Hebrew language was a prerequisite for early American scholars. Many universities even required it in their curriculum.

- From the late 1800s to early 1900s, millions of Jews fleeing antisemitism in Europe immigrated to the US, making America home of the largest Jewish diaspora population. Around the same time, Zionism, the movement to create a Jewish state in the Land of Israel, gained momentum in the US.

Later, the U.S. would become a vital ally to the Jews in Europe and Israel:

- The U.S. defeat of Nazi Germany in the Second World War thwarted Hitler's plan to exterminate the Jews.

- After the Holocaust, the U.S. played a key role in securing support for the UN resolution to create the modern State of Israel.

- When Israel declared itself a nation on May 14, 1948, the U.S. was the first country to grant recognition.

- From 1948 to the present, the United States has provided more financial, political, and military support to Israel than to any other nation.

With the above summary in view, two things are clear: the U.S. has been uniquely supportive of the Jews, and has been instrumental in the replanting and flourishing of the “fig tree,” the modern State of Israel, in her ancient homeland (Isa. 11:11, 12; Matt. 24:32–34). In fact, one could say that without the US, there would be no modern State of Israel.

### **JUBILEE NATION**

Another indication of America’s prophetic connection to Israel is the fact that the U.S. is uniquely founded on the Jubilee principle of “liberty” (Lev. 25:10). From the original ideologies and charters, to the nation’s iconic symbols and currency, the theme of liberty, or Jubilee, is ever-present:

- Patrick Henry’s battle-cry in the run-up to the Revolutionary War was, “Give me liberty, or give me death!”
- The U.S. Declaration of Independence cites “liberty” as the first God-given right, next to the fundamental right to life.
- The U.S. Constitution states that no person shall be deprived of “liberty” without due process of law.
- The U.S. Pledge of Allegiance concludes with the words, “with liberty and justice for all.”
- The Statue of “Liberty” greets immigrants arriving in New York harbor.
- The iconic symbol of American independence is the “Liberty” Bell, which is engraved with the biblical Jubilee command, **“Proclaim Liberty Throughout all the Land unto all the Inhabitants Thereof”** (Lev. 25:10).
- The one-word motto stamped on U.S. coins is “Liberty.”
- The U.S. is the only nation comprised of 50 states—the number of Jubilee (Lev. 25:10).

But America’s connection to the Jubilee goes deeper still. According to the Sabbatical-year chronology favored by scholars, the U.S.’s first full year as a nation, 1777, was a Sabbatical year. The next year, 1778, was a Jubilee. (We understand 1778 to be a Jubilee as it falls exactly five jubilee periods before the calculated Jubilee year 2023).

It is significant that the U.S. has now existed for five Jubilee periods, as the number five signifies God’s favor and grace toward man.

That America's Jubilee 'grace-period' is ending in 2023 brings us back to the eclipses of 2017 and 2024.

### **'X' MARKS THE SPOT**

On the last day of the current Jubilee year, April 8, 2024, a total solar eclipse will darken a path diagonally opposite that of the 2017 eclipse, thus drawing a giant 'X' across the center of the US. Significantly, the center, or crossing point, of the 'X' is an area of Southern Illinois called "Little Egypt."

To appreciate the improbability of such an occurrence, consider that on average, any particular location on earth sees a total solar eclipse only once every 375 years. Yet, America's Little Egypt will, on the last day of the Jubilee, see its second total solar eclipse in a period of only seven years.

It gets more interesting. Viewing the 'X' drawn by the eclipses as a biblical sign, it is significant that the last letter of the Hebrew alphabet is the 'X,' or Tav. The 'X' (Tav) is a picture of two crossed sticks. This is significant because, speaking of Israel's redemption in the last days, God says He will join the "stick" of Ephraim, representing the scattered tribes of Israel, with the "stick" of Judah, the tribes who dwell in the Land of Israel, where they will be cleansed of all their idolatry and worship Him as one:

***"I am going to take the stick of Joseph—which is in Ephraim's hand—and of the Israelite tribes associated with him, and join it to Judah's stick. I will make them into a single stick of wood, and they will become one in my hand .... I will take the Israelites out of the nations where they have gone. I will gather them from all around and bring them back into their own land. I will make them one nation in the land, on the mountains of Israel" .... [There] I will cleanse them. They will be my people, and I will be their God"*** (Ez. 37:19, 21–23).

How does the prophecy about the scattered tribe of Ephraim relate to America? The U.S., home to nearly half the world's Jews, is believed to be home to the descendants of Ephraim. Thus, the prophecy of Ephraim's return to the Promised Land is actually a prophecy about American Jews returning to Israel.

With the Ephraim–America connection in view, it is befitting that the center point of the eclipse 'X' is Little Egypt, and that the 'X' is formed on the last day of a Jubilee. Egypt is a symbol of God's people in a foreign land, and the Jubilee denotes a return to one's own land.

Could the 'X' drawn across America's Little Egypt on the last day of the Jubilee be a sign heralding the return of scattered Jews foretold in Ezekiel?

It is a fascinating notion to ponder.

### **SUMMARY AND FINAL THOUGHTS**

Columbus, who is believed to be of Jewish heritage, and who believed himself to be fulfilling Bible prophecy, discovered America after 70 days, on the biblical festival associated with God's provision and a temporary dwelling place.

The United States was founded on the Jubilee principle of Liberty. What's more, the US's first full year as a nation, 1777, was a Sabbatical year preceding a Jubilee.

As of 2023, the U.S. has existed for five Jubilee cycles, denoting a period of God's favor or grace.

On the last day of the current Jubilee, a total solar eclipse will complete a giant 'X,' or Tav, across the U.S., with the center point crossing through Little Egypt.

The crossed "sticks" of the Hebrew 'X,' or Tav, evoke the prophecy about the return of the scattered tribe of Ephraim to the Land of Israel.

The U.S. is home to Ephraim.

With the above facts in view, it appears America's prophetic destiny is nearly fulfilled: She has been a safe haven for half the world's Jews. She has facilitated the replanting of the "fig tree" in the Land of Israel. And now, five Jubilee periods after the U.S. was founded, a giant 'X' drawn by two eclipses suggests that God is about to call His people out of spiritual Egypt, presumably by some calamitous event, and bring them home to the land of their fathers.

Could the calamitous event be the collapse of the U.S., brought about by the Rapture–disappearance of around half the nation's population?

It is an awesome prospect to consider in this presumed Jubilee year.

#### **NOTES:**

1. In Scripture, a total solar eclipse is a sign of the impending Day of the Lord (Rev. 6:12; Joel 2:31; 3:14, 15; Isa. 13:9-10; Mark 13:24; Luke 21:25-27; Acts 2:20, 21). In the Talmud, solar eclipses are a sign of judgment for the Gentile world (Succah 29a). The US, the world's only superpower, is de facto head of the Gentile nations.

2. The Great American Eclipse of 2017 was considered an ominous biblical sign because:

- It occurred on Elul 1, a date that in Jewish tradition marks the beginning of a period of warning and repentance.
- It traced a path exclusively across the U.S., a phenomenon which had not occurred since before the nation's founding in 1776.
- Its 70-mile-wide shadow crossed over seven U.S. cities named Salem, an alternate name for Jerusalem in Scripture: from the West Coast to the East Coast, the eclipse's 70-mile-wide shadow crossed over "Jerusalem's" in Oregon, Idaho, Wyoming, Nebraska, Missouri, Kentucky, and South Carolina.

- It crossed through the center of three of the U.S.'s most notorious seismic hotspots: The Cascadia Subduction Zone on the West Coast, the Yellowstone Caldera in Wyoming, and the heart of the New Madrid Seismic Zone centered on the southern tips of Illinois and Missouri.
  - It occurred on the same day President Trump's son-in-law, Jared Kushner, arrived in Jerusalem to begin work on a peace plan that divides Jerusalem.
  - It occurred 33 days before another heavenly sign, the Revelation 12 alignment, on September 23, 2017

5. Significantly, the year after Columbus's voyage (1493-94), a blood-moon tetrad occurred on the biblical harvest festivals. Following this rare event, the next biblical tetrads occurred:
- In 1949–50, the year after the Nation of Israel was reborn (Matt. 24:32–34)
  - In 1967–68, the year after Jerusalem was restored (Dan. 9:25).
  - In 2014–15, one Sabbatical week, prior to our calculated Jubilee in 2023. This is noteworthy because God typically gives a 'one-week warning' before bringing judgment (Gen. 7; 41; Josh. 6).
6. Concerning the reckoning of Sabbatical years, it is important to note that there are two accepted chronologies, which differ by a single year. The first chronology, associated with Benedict Zuckermann, has the most recent Sabbatical year ending in 2022. A fascinating connection between Ephraim (America) and the Hebrew letter Tav, or 'X' is as follows: Because Joseph's sons Ephraim and Manasseh were born in Egypt, their grandfather Jacob said a special blessing over them to make clear that they were not Egyptians, but were of the family and inheritance of Abraham (Gen. 48). Significantly, when Jacob blessed Ephraim and Manasseh, he crossed his hands (forming the Hebrew letter Tav, or 'X'), placing his right hand on the head of the younger boy, Ephraim, and his left hand on the head of the older boy, Manasseh, thus bestowing the greater blessing on the younger son, Ephraim, and reserving a lesser blessing for Manasseh, the firstborn. Jacob's blessing is prophetic of two major world powers, the British Empire (Manasseh) and the U.S. (Ephraim).

## **In Mongolia, Pope Francis Once Again Obsesses Over His Core Beliefs: the Harmony of Religions (*Fratelli Tutti*) and Protecting the Planet (*Laudato Si'*)**

Make no mistake. Pope Francis is on a mission to change the world. His goal is to win over everyone's hearts and minds and unite them all together into a single universal religious fraternity that will be based on his encyclicals, *Fratelli Tutti* and *Laudato Si'*. During his trip to Mongolia from August 31 to September 4, 2023, Pope Francis once again emphasized his two core beliefs: the need to build religious harmony and the importance of taking care of our common home.

The Vatican Press Office reported that Pope Francis praised the nation of Mongolia for combining "Buddhist philosophy" and "shamanic tradition" in their work to "*protect and preserve planet Earth.*" The Pope's statements, which were a summary of *Laudato Si'*, were given on September 2, 2023, during a meeting with political leaders:

- *"Your native wisdom, that of your people, which has matured over generations of ranchers and planters respectful of the delicate balances of the ecosystem, speaks eloquently to those who in our own day reject the pursuit of myopic particular interests and wish instead to pass on to future generations lands that remain welcoming and fruitful. You help us to appreciate and carefully cultivate what we Christians consider to be God's creation, the fruit of his benevolent design, and to combat the effects of human devastation by a culture of care and foresight reflected in responsible ecological policies. Gers (Mongolian huts) are dwelling places that nowadays could be considered efficient and ecologically sound, inasmuch as they are versatile and multifunctional, with*

*zero impact on the environment. Furthermore, the holistic vision of the Mongolian shamanic tradition, combined with the respect for all living beings inherited from Buddhist philosophy, can contribute significantly to the urgent and no longer deferrable efforts to protect and preserve planet Earth.” [1]*



The next day, on September 3, 2023, Pope Francis met with Mongolian religious leaders to further the ecumenical principles of unity and solidarity as defined in *Fratelli Tutti*. The Vatican published the Pope’s statements:

- *“I would like to reassure you that the Catholic Church desires to follow this path, firmly convinced of the importance of ecumenical, interreligious and cultural dialogue.” [2]*
- *“The Church today offers the treasure she has received to every person and culture, in a spirit of openness and in respectful consideration of what the other religious traditions have to offer.” [2]*
- *“Brothers and sisters, we share a common origin that confers equal dignity on everyone, and have a shared path that we can only travel alongside one another, as we dwell under the one sky\* that surrounds and illumines us.” [2] [\*Note: ancient Mongolians worshipped Tenggeri, the sky god]*
- *“The reconciled and prosperous humanity that we, as followers of different religions, seek to promote is thus symbolized by this harmony, togetherness and openness to the transcendent.” [2]*



- “Let us make this conviction flourish, so that our common efforts to promote dialogue and the building of a better world will not be in vain.” [2]
- “May the prayers we raise to heaven and the fraternity we experience here on earth spread seeds of hope ... let us never forget the word ‘harmony’ – as pilgrims called to preserve the atmosphere of a home that is open to all people.” [2]

Pope Francis is promoting the ideologies of the new world order: *Fratellit Tutti* and *Laudato Si’*. This is the new gospel for the modern world. Unfortunately, this has also become the new guiding principle for the modern-day church. The political and religious worlds are uniting, but not in accordance with God’s revealed word, but rather in harmony with the Catholic/Jesuit agenda for these last days that will lead to harmony with the man of sin.

Pope Francis was praising paganism, the sky god that “illuminates us.” The ancient Mongolians were animists who worshiped nature. However, Pope Francis doesn’t speak out against any false religious system. He does not oppose pantheism. He supports it, celebrates it, embraces it, and encourages others to do the same. The good news is that God will have faithful people who will stay true to Him even in the face of great adversity and opposition:

In every generation God has sent his servants to rebuke sin, both in the world and in the church. But the people desire smooth things spoken to them, and the pure, unvarnished truth is not acceptable. Many reformers, in entering upon their work, determined to exercise great prudence in attacking the sins of the church and the nation. They hoped, by the example of a pure Christian life, to lead the people back to the doctrines of the Bible. But the Spirit of God came upon them as it came upon Elijah, moving him to rebuke the sins of a wicked king and an apostate people; they could not refrain from preaching the plain utterances of the Bible,—doctrines which they had been reluctant to present. They were impelled to zealously declare the truth, and the danger which threatened souls.

**UK Energy bill authorizes “reasonable force” to install smart meters that allow authorities to turn customers’ energy on and off**

You probably know that a massive Energy Bill is being rushed through Parliament by our fake ‘Conservative’ Government in the first two days of our parliamentarians’ return from their generous summer break. The Bill is 446 pages long and written in dense, largely-incomprehensible-to-any-normal-person legalise. Moreover, many clauses in the Energy Bill make reference to other pieces of previous legislation. So, to fully understand the Bill, you would have to read at least a thousand pages of dense legalistic gobbledegook. Given that our MPs have just passed the Bill with a mere nine voting against it, one must assume that they have spent their summer holidays diligently reading through the Bill and other relevant legislation in order to fully understand what they were voting for.

Here's the full title of the Bill:

'A Bill to make provision about energy production and security and the regulation of the energy market, including provision about the licensing of carbon dioxide transport and storage; about commercial arrangements for industrial carbon capture and storage and for hydrogen production; about new technology, including low-carbon heat schemes and hydrogen grid trials; about the Independent System Operator and Planner; about gas and electricity industry codes; about heat networks; about energy smart appliances and load control; about the energy performance of premises; about the resilience of the core fuel sector; about offshore energy production, including environmental protection, licensing and decommissioning; about the civil nuclear sector, including the Civil Nuclear Constabulary; and for connected purposes'

As you'll see, this legislative monster covers an awful lot of areas – energy production, regulation of the energy market, CO2 transport and storage, carbon capture, hydrogen production, low-carbon heat schemes, hydrogen grid trials, heat networks, smart appliances, load control, energy performance of industrial and residential premises, offshore energy production and the civil nuclear sector. We must be considered fortunate in Britain to have MPs who have such a strong work ethic and such a deep understanding of all these disparate issues to be able to vote for the new Energy Bill knowing exactly what they are voting for.

Life is too short for any normal person to read and to try to understand this massive abomination of almost impenetrable legalese. But here are some choice titbits which I think I understand.

The Bill explains what a 'Smart Meter' is:

"Energy smart appliance" means an appliance which is capable of adjusting the immediate or future flow of electricity into or out of itself or another appliance in response to a load control signal; and includes any software or other systems which enable or facilitate the adjustment to be made in response to the signal.

So it seems that the conspiracy theorists were right yet again – a key purpose of 'Smart Meters' is not only to measure power usage but also to allow energy providers to control how much energy we are allowed to consume using "a load control signal".

Moreover, authorities will be allowed to use "reasonable force" to enter any homes or premises to ensure we have the approved 'Smart Meters' installed:

Requiring persons to supply evidence of their compliance to enforcement authorities; conferring powers of entry, including by reasonable force.

All electricity and gas meters have dates by which they should be replaced. From what I have read the Bill gives representatives from energy companies the power to enter any home, with police protection if required, to replace traditional meters at the end of their lives with smart meters. Again, "reasonable force" may be used.

The Bill gives the Government the power to force us to have energy assessments for any premises:

The Secretary of State may make regulations for any of these purposes: (a) enabling or requiring the energy usage or energy efficiency of premises to be assessed, certified and publicized;

We can be fined up to £15,000 or face one year in prison for failing to meet any future energy performance levels any government imposes:

Energy performance regulations may provide for the imposition of civil penalties by enforcement authorities in relation to cases falling within subsection (1)(b), (c) or (d); but the regulations may not provide for a civil penalty that exceeds £15,000.

Under the totally misleading title of 'Energy Savings Opportunity Schemes', authorities can force any person or company to make energy savings using the threat of criminalization for failure to comply:

The Secretary of State may by regulations ("ESOS regulations") makes provision for the establishment and operation of one or more energy savings opportunity schemes. An "energy savings opportunity scheme" is a scheme under which obligations 30 are imposed on undertakings to which the scheme applies for one or more of the ESOS purposes.

I could go on. But I imagine you get the picture by now. This 'Energy Bill' creates the means by which some puffed-up public-sector mini-dictator could gain powers to control us in ways most people would find completely unacceptable. Yet our useless MPs passed the Bill with a massive majority and the Lords are set to do the same.

If there really was a 'climate crisis' caused by humans burning fossil fuels and threatening the existence of the human race as the BBC and others of its ilk repeatedly claim, then you might be able to argue that some of the measures in the Bill could be justified. But given that changes in atmospheric CO2 levels have little to no influence on the Earth's temperatures, that Britain only contributes less than 1% of world CO2 output and that developing countries like India and China each increase their CO2 output by more each year than Britain's total CO2 emissions, we are creating a totalitarian regime which will intrude on people's lives, restrict people's freedoms, wreck the British economy and immiserate our country to fix a problem which doesn't even exist and, if it did, would not be solved by our action anyway.

## Why is the IRS Buying .40-Caliber Submachine Guns?

The weaponization and militarization of the federal government continues unabated as Congress and the states sit back and do nothing.

The video below by Mark Gifford, a pastor from Lee’s Summit, Missouri, who runs the God Family and Guns YouTube channel, explains why this militarization is taking place.

The IRS has been stepping up its purchases of guns and ammunition even more over the last two years, gobbling up [nearly \\$700,000 in ammo in early 2022](#). That bulk purchase prompted Representatives Matt Gaetz (R-FL) and Jeff Duncan (R-SC) to [introduce](#) the “[Disarm the IRS Act](#),” to prohibit the IRS from buying ammunition. Of course, this bill was dead on arrival because the Uniparty in Washington, which includes all Democrats and a solid majority of Republicans, are all for a militarized federal government. They hate Americans and do not represent Americans. They are globalists whose allegiance is to the military-industrial-biosecurity complex.

The IRS is not alone in this militarization.

The USDA raided the Fisher family's farm in Farmville, Virginia, and [seized their livestock and meat-processing facility](#) as the state condemned and seized their property. They are Amish.

The Small Business Administration has also made bulk purchases of guns and ammo. Health and Human Services has done the same.

Is the federal government preparing for all-out war against Americans who push back against the government-media-approved messaging on pandemics, our involvement in perpetual foreign wars and other globalist policies?

You get the sense that maybe, just maybe, enough of us are waking up that the globalists are preparing to silence us once and for all, and the only way to complete that task is by force? All it would take is to make an example out of a few dozen, maybe a few hundred outspoken conservatives. The goal going forward would be to criminalize all speech that contradicts the messaging coming out of the government and its corporate partners. At that point, the globalists' hope would be for conservatives to start turning on each other out of fear that they could be next. Cut a deal to turn in a fellow conservative, thereby saving your own skin from the reign of terror. This is how life goes down under fascist regimes like the one now in power, so don't be surprised if they move in this direction. The indictments of Trump supporters in Georgia and Michigan have already sent a chilling message. But the deep state is moving on more than that one front. Protesting abortion has been a mainstay of American life since the early 1970s. Now the government is cracking down and sending messages that things are different. Such protests will no longer be tolerated.

From *LifeSite News* in an [article posted Tuesday, August 29](#):

A jury on Tuesday found five pro-life activists guilty of violating the Freedom of Access to Clinic Entrances (FACE) Act and conspiracy against rights. They were immediately incarcerated following the verdict and could face more than a decade in prison for their efforts to prevent women from killing their preborn babies.

Did you catch that? You can now get 10 years or more for peacefully praying with and counseling women outside of an abortion clinic. The article goes on to explain that these pro-life Americans were considered by the judge to have committed a "crime of violence" simply for holding pro-life views and being willing to share them publicly in proximity to a baby-butcherer clinic. The irony is hard to miss.

In the month of August alone, four Americans had their homes broken into and invaded in pre-dawn raids by the FBI, which in each case executed the suspect in cold blood. One case involved a 100 percent disabled [U.S. military veteran in Henderson, Tennessee](#), who was unarmed at the time he was shot on August 16. Another case involved a 74-year-old man in Provo, Utah, who was obese and unable to walk without a cane but he was [shot dead by the FBI on August 9](#).

### **Where did human rights come from?**

Human rights have been around in some form or another for a long while, but during the French Revolution, a specific human rights declaration was drawn up consisting of 17 rights all declaring the right of liberty, property, security, and resistance to oppression. In 1948, 13 more rights were added, and the entire list was re-worked so that there are now 30 human rights in the UN Declaration of Human Rights. The UN calls upon all countries to publicize the text of the Declaration and to *“cause it to be disseminated, displayed, read, and expounded principally in schools and other educational institutions, without distinction based on the political status of countries or territories.”*

Shouldn't the head of a Christian Church like the Pope be proclaiming the law of GOD in his address in New York rather than human rights started during the French Revolution?

There was much more about the French Revolution than just human rights. It was an all-out war against the God of heaven, the dethroning of God, replacing Him with the sovereignty of another universal god. During the French Revolution, Bibles were burned.

In 2005, Condoleeza Rice, then Secretary of State extolled the Bush Administration for continuing *“the work of the 18th century French Revolution”* (The New American, March 7, 2005). Considering that the French Revolution consisted of debasing debauchery and outright rebellion against God, such a comment from Rice is more shameful than praiseworthy. During that awful period of earth's history, God's reality was replaced with a different reality. And that is exactly what is happening today. It is doubtful if anything coming from the French Revolution could be a real key to peace and security on this earth, as the Pope would like us to believe.

### **Who does the Pope really think he is?**

In 1455, Pope Nicholas V published the Decretal De Translat. Espiscop. Cap. where he said about himself:

*“I have the authority of the King of Kings. I am all in all and above all. Wherefore if the things that I do be said not to be done of man, but of God, what can you make me but God? ... Wherefore, no marvel if it be in my power to change time and times: to alter and abrogate laws, to dispense with all things, yea, with the precepts of Christ... The Pope has the power to change times, to abrogate laws, and to dispense with all things, even the precepts of Christ. He can pronounce sentences and judgments in contradiction to the rights of nations, to the law of God and man... He can free himself from the commands of the apostles, he being their superior, and from the rules of the Old Testament.”*

Sounds a lot like 2<sup>nd</sup> Thessalonians 2:4 where the man of sin **“opposeth and exalteth himself above all that is called God...”** What is the connection between this arrogant attitude and the Pope's interest in human rights? We all know from history how little respect the Catholic Church had for human rights. Has the Roman system changed?



## **The Economic Thought of the Roman Catholic Church**

### **Common Property – Fascism**

Thomas Aquinas was a Catholic philosopher and theologian who is considered by the Catholic Church to be its greatest theologian and a doctor of the Church. His thinking is apparently *“foundational for understanding the economic thought of the Roman Church-State.”* Aquinas believes in the socialist idea of communal possessions. He wrote in Summa Theologiae ii-ii 5th article, *“the possession of all things in common is a natural law...‘the possession of all things in common and universal freedom’ is said to be of the natural law because, to wit, the distinction of possessions and slavery were not brought in by nature, but devised by human reason for the benefit of human life.”*

*“The community of goods,”* wrote Thomas, *“is ascribed to the natural law, not that the natural law dictates that all things should be possessed in common and that nothing should be possessed as one’s own, but because the division of possessions is not according to the natural law, but rather arose from the human agreement, ...the ownership of possessions is not contrary to the natural law, but an addition thereto devised by human reason...Hence, whatever certain people have in superabundance is due, by natural law, to the purpose of succoring the poor”* (2nd and 7th articles).

So, as Rome sees it, property is for common good. You may own it, but it is for common good. Whatever you have that is more than you need will be given to others. Does this mean in practical terms that if you own anything, you will be taxed to death so that the state may collect revenues to support those who have not?

It may also mean, as has happened in South Africa, that if your house is vacant, squatters may come in to occupy your home, and nothing is done to remove them, while you continue to pay the bills. Make no mistake, such things have happened.

### **Pius XI tells us this in his 1931 encyclical Quadragesimo Anno:**

Under fascism, property owners may keep their property titles and deeds, but the use of their property is, as Leo XIII wrote, *“common”*. Fascism is a form of socialism that retains the forms and trappings of capitalism, but not its substance. Under fascism, property titles and deeds are intact, but the institution of private property has disappeared. Government regulations and mandates have replaced it. For this distinction between legal ownership and actual use, the fascists owe a debt to the Roman Church-State.

### **Redistribution of Wealth**

John Paul II wrote this in Sollicitudo Rei Socialis (On Social Concern) in 1987:

*...the goods of this world are originally meant for all. The right to private property is valid and necessary, but it does not nullify the value of this principle. Private property, in fact, is under a ‘social mortgage’, which means that it has an intrinsically social function, based upon and justified precisely by the principle of the universal destination of goods.*

In the same document, Pope John Paul also wrote that in today's world "*we are faced with a serious problem of unequal distribution of the means of subsistence originally meant for everybody*" (emphasis added)

It sounds like the economic theory being espoused here is the redistribution of wealth.

That is, in fact, exactly what it is. But it gets worse. Because the goods of some are due to others according to natural law, it is not considered sinful for the poor to take the goods of their neighbors. Thomas continues in his *Summa Theologiae* ii-ii, 7th article, "*In cases of need, all things are common property so that there would seem to be no sin in taking another's property, for need has made it common.*"

Not only is such taking of another's property is not a sin, it is not even a crime, according to Thomas:

...it is lawful for a man to succor his own need by means of another's property by taking it either openly or secretly; nor is this, properly speaking, theft and robbery... It is not theft, properly speaking, to take secretly and use another's property in a case of extreme need; because that which he takes for the support of his life becomes his own property by reason of that need...In a case of a like need, a man may also take secretly another's property in order to succor his neighbor in need (7th article).

According to this statement, your neighbor determines the need. And, according to Thomas Aquinas' article, it is even lawful for you to steal for your neighbor's need!

Roman Catholic economic thought, as developed by the popes in their encyclicals and by Roman Church-State councils, has contributed to these political viewpoints:

Feudalism and guild socialism in Europe during the Middle Ages and in the 20th century:

Fascism in Italy, Spain, Portugal, Croatia, and Latin America

Nazism in Germany

Interventionism and the redistributive state in the West, including the United States

Liberation theology in Latin America and Africa
