**G20 Announces Plan to Impose Digital Currencies and IDs Worldwide** 14 SEPTEMBER 2023



G20 leaders have agreed to a plan to eventually impose digital currencies and digital IDs on their respective populations. The *Epoch Times* has the story.

The leaders of the Group of 20 nations have agreed to a plan to eventually impose digital currencies and digital IDs on their respective populations, amid concern that governments might use them to monitor their people's spending and crush dissent.

The G20, which is made up of the world's leading rich and developing nations and is currently under India's presidency, adopted a final declaration on the subject over the weekend in New Delhi. The group announced last week that they had agreed to build the necessary infrastructure to implement digital currencies and IDs.

While the group said that discussions are already underway to create international regulations for cryptocurrencies, it claimed that there was "*no talk of banning cryptocurrency*" at the summit.

Many critics are concerned that governments and central banks will eventually regulate cryptocurrencies and then immediately replace them with central bank digital currencies (CBDC), which lack similar privacy and security. ...

Critics say that these proposals might allow government authorities to impose a social credit score system and decide how their citizens can spend their money.

At the summit, European Commission President Ursula von der Leyen called for digital ID systems similar to COVID-19 vaccine passports and for an international regulatory body for artificial intelligence (AI).

She called for the United Nations to have a role in AI regulation and called the European Union's COVID-19 digital certificate a perfect model for digital public infrastructures (DPI), which would include digital IDs.

"Many of you are familiar with the COVID-19 digital certificate. The EU developed it for itself. The model was so functional and so trusted that 51 countries on four continents adopted it for free," Ms. von der Leyen said.

"Today, the WHO uses it as a global standard to facilitate mobility in times of health threats. I want to thank Dr. Tedros again for the excellent cooperation," she said, referring to WHO Director-General Tedros Adhanom Ghebreyesus.

The European Union is currently trying to introduce a bloc-wide "digital identity" app that would consolidate various personal information, including passports, driver's licenses and medical history.

"The future is digital. I passed two messages to the G20. We should establish a framework for safe, responsible AI, with a similar body as the [Intergovernmental Panel on Climate Change] for climate. Digital public infrastructures are an accelerator of growth. They must be trusted, interoperable and open to all," Ms. von der Leyen wrote on social media.

Apple CEO Tim Cook has just released an ad that advocates for the complete extermination of all life on planet Earth: Plants, animals and humans. The CP3 program, according to the release, "helps to prevent targeted violence and terrorism through funding, training, increased public awareness, and the development of partnerships across every level of the government, the private sector and in local communities across our country. Leveraging an approach informed by public health research, CP3 brings together mental health providers, educators, faith leaders, public health officials, social services, nonprofits, and others in communities across the country to help people who may be escalating to violence."

These include some names you might recognize, such as D. James Kennedy Ministries (who is also suing SPLC over the label), Alliance Defending Freedom, the American Family Association, the Family Research Council, and others.

D. James Kennedy Ministries, a Florida-based Christian ministry founded by the late Presbyterian minister D. James Kennedy, is suing because the *"hate group"* label has affected their status with GuideStar USA Inc., a group that rates nonprofits, which in turn has affected their donation status with Amazon.com.1

These groups were slapped with this label because each takes a biblical position on marriage.

So why the *"hate group"* designations? These groups were slapped with this label because each takes a biblical position on marriage. Simply holding to biblical and historically Christian views, taken directly from the Bible, is enough to be called a *"hate group,"* according to SPLC standards. ### It Was Pneumonia, Not Covid, What Done It!

Published on September 16, 2023 Written by Professor Martin Neil The first victim of what became known as Covid-19 was 'Patient Zero', whose case was recorded on December 26, 2019, in Wuhan, China. He was admitted to hospital with respiratory symptoms including fever, dizziness and a cough.

Patient Zero was relatively young and without significant health problems, yet he was subjected to a battery of tests, including genetic sequencing of fluid from his airways. We are told this led to the discovery of a new coronavirus subsequently dubbed SARS-CoV-2.

As described in the seminal paper in *'Nature'* from February 3, 2020, the clinical features of the illness of the alleged 'Patient Zero', from whom the genome of the 'novel virus' was said to have been sequenced, are quite typical of regular bacterial pneumonia.

Given that he showed no unusual symptoms, clearly this was not a routine medical response to what looks like a typical respiratory infection. This is not all that is odd about the narrative. Have you ever read much discussion of pneumonia vaccines?

Researchers have found that a purported preventive of one of the major causes of bacterial pneumonia, the pneumococcal vaccine, is sometimes given to the elderly and vulnerable.

Researchers who have looked at the interaction between bacterial pneumonia and SARS-CoV-2 have found that bacterial pneumonia vaccination reduced the risk of Covid-19 by a statistically significant margin.

But how can a vaccine for a bacterium reduce the risk from a virus?

Research into the etiology of community-acquired pneumonia concludes that it is often observed that viral species colonize the nasopharynx of patients after they have contracted bacterial pneumonia, suggesting that sequential pneumonia infection followed by viral infection, or parallel infection, where the infections occur together, are both possible.

However, the default operating assumption in the medical literature and in practice is the opposite: viral followed by bacterial infection, and since 2020 with SARS-CoV-2 identified as the 'novel' root cause.

These research results suggest that the actual burden of risk to patients is not SARS-CoV-2 at all but bacterial pneumonia and that SARS-Cov-2 is secondary to bacterial pneumonia, or it masks bacterial pneumonia, not the other way around.

Given this, might it be the case that bacterial pneumonia is acquired in the community rather than in hospital, and that the signal of viral infection follows bacterial pneumonia infection? And if so why was the focus on a virus and not on the perennial risk of bacterial pneumonia?

Many of the frightening images circulated in the media in spring 2020 were from ICUs showing patients being treated on ventilators. It was claimed that people were dying of acute respiratory distress caused by SARS-CoV-2 while being ventilated.

Ventilator associated pneumonia (VAP) is a well-known condition in which ventilated patients have a significantly higher chance of dying after contracting 'secondary' pneumonia during ventilation. Many patients dying of VAP in spring 2020 were recorded as having died from SARS-CoV-2.

High rates of ventilator-induced pneumonia are acknowledged by the authorities but their use continues to be defended as necessary. Even Anthony Fauci admitted that ventilation was overused.

This overuse of ventilation was accompanied by changes in protocols, delays in admission and changes to medication and testing. Given that most people suffering death by 'Covid-19 with respiratory symptoms' died in ICUs, blaming these deaths on SARS-CoV-2 seems unscrupulous.

The observational data is heavily confounded, and these deaths are just as likely to have involved, inter alia, bacterial infection and changes in treatment protocols as by detected or undetected pathogens.

In a 2008 article in the '*Journal of Infectious Diseases*' (on the Spanish Flu pandemic), Anthony Fauci concluded: 'Prevention, diagnosis, prophylaxis, and treatment of secondary bacterial pneumonia, as well as stockpiling of antibiotics and bacterial vaccines, should also be high priorities for pandemic planning.'

Regardless of whether such stockpiles of antibiotics were created, community antibiotic prescriptions were reduced dramatically in spring 2020. Recall that in spring 2020 people were told to self-isolate if they suffered Covid symptoms.

This would therefore buy time for pathogens to multiply and for a more severe condition to develop, which might subsequently be harder to manage. Many people would have presented late to ICU, with incipient or lingering pneumonia (perhaps from the previous normal flu season), disguised as Covid-19, and may have been left untreated with antibiotics until their condition deteriorated further.

A reluctance to perform bacteriological investigations in ICUs (and expose staff to a supposedly deadly pathogen) may have been a further contributory factor. Patients would therefore have suffered higher levels of respiratory distress than would have been seen historically.

The lateness of presentation to ICU, and the very late administration of antibiotics, may have failed to save them from a (detected or undetected) bacterial pneumonia infection.

Conflating pneumonia and Covid-19 repeats an official longstanding tactic of conflating the attribution of influenza and pneumonia. There is evidence to suggest that a reduction in the public's perceived threat of flu may have prompted the pharmaceutical industry to attempt a rebranding of the threat along with a new suite of marketable products to respond to that threat.

In contrast to the evidence presented above, physicians in Toledo, Spain, administered antibiotics to Covid-19 patients during spring 2020, contrary to official guidance. This resulted in zero hospitalizations or deaths in their care homes after they started routine administration.

The resulting mortality over spring 2020 was approximately 7 percent versus 28 percent in other comparable care homes (and the 7 percent died before they started routine antibiotic use).

A (pneumonia) hypothesis, that a proportion of Covid-19 deaths in 2020, specifically those with associated respiratory symptoms, were caused by bacterial pneumonia, and that bacterial pneumonia may have been the primary, not the secondary, infection, starts to look rather strong.

It matters because it challenges received wisdom about the true causative agent of the deaths resulting from the 'pandemic' – a bacterium or a virus, both or neither? It also brings into question how the agent was spread and, most significantly, it challenges how and if the illness was appropriately treated.

Further confirmation that bacterial pneumonia, not Covid, is the real danger has come from two groups of doctors who have had 100 percent success using antibiotics to treat 'Covid'.

In allegorical terms it is akin to a scene from an Agatha Christie novel: SARS-CoV-2, a bystander used as a decoy, is found guilty of the crime with ventilation as his accomplice, but the actual criminal, who has got off scot-free, is in fact bacterial pneumonia (undetected until the denouement).

In other words, SARS-CoV-2 has been framed.

## LOOK UP!

#### During the week of September 16–23, an awesome biblical sign will be unfolding in the Constellation Virgo. T.W. Tramm

One of the components of this sign is an asteroid named 6000 United Nations. Between September 13–17, the asteroid named after the UN Organization will be exiting the belly of Virgo, denoting a birth, or new beginning.

The birth of asteroid 6000 United Nations has at least five prophetic connotations:

#### 1. THE NUMBER

The number assigned to asteroid United Nations, "6000," indicates that it was the 6000th asteroid to be discovered and catalogued by the Minor Planet Center. It is significant that the asteroid appearing in this month's sign is number 6,000 because biblically the 6,000th year marks the end of the Church Age, and the beginning of the Day of the Lord.

Making this coincidence even more interesting, chronologists calculate that we are presently at (within a margin of error) the 6,000th year. The appearance of asteroid 6000 in this month's sign could be confirmation.

#### 2. PEACE AND SECURITY

Asteroid United Nations is named after the organization whose mission is to *"maintain international peace and security."* This is significant because the sign given to the Church to recognize the season of judgment is people saying *"peace and security"*:

"Now, brothers and sisters, about times and seasons we do not need to write to you, for you know very well that the day of the Lord will come like a thief in the night. While people are saying, 'peace and security,' destruction will come on them suddenly, as labor pains on a pregnant woman, and they will not escape'" (1 Thess. 5:1–3).

The UN will convene to discuss matters related to international peace and security on September 18–19 this year, as asteroid United Nations is exiting the belly of Virgo.

#### 3. A NEW BEGINNING

The birth of asteroid United Nations from Virgo this month suggests that a turning point, or new beginning, is at hand for the organization and the nations it represents.

Supporting this premise, the UN's conference this year begins with a special summit to mark the start of *"seven years of accelerated, transformative action"* to achieve a set of international goals by 2030.

Moreover, 2023 marks the first year of a seven-year Sabbatical cycle, a time of new beginnings, and a likely start point for the final "week" of Bible prophecy (Dan. 9:24–27).

#### 4. AS IN THE DAYS OF NOAH

Asteroid United Nations was discovered in October–Cheshvan of a Sabbatical year, 1987.

Similarly, the United Nations Organization was established in October–Cheshvan of a Sabbatical year, 1945. The precise date was uncannily Cheshvan 17, the anniversary of Noah's Flood.

It is striking that both the United Nations Organization and the asteroid named after it were established in God's signature year, the Sabbatical, and particularly in the month of the Flood, because Scripture says the end of the age will be like the "days of Noah" (Matt. 24:37).

#### 5. GRAPES OF WRATH

Six months prior to this month's sign in Virgo, asteroid United Nations brushed by, practically touching, the constellation's third brightest star, called Vindemiatrix. The name Vindemiatrix originates from the Greek term meaning *"the grape harvester."* The title grape harvester was given this star because in ancient times, its first appearance in the pre-dawn sky was a sign that the grapes were ripe for harvest.

It is significant that the asteroid named *"United Nations"* brushed by the star named *"grape harvester"* ahead of this month's sign because the judgment of the nations is likened to a harvest and trampling of grapes:

"Let the nations be roused; let them advance into the Valley of Jehoshaphat, for there I will sit to judge all the nations on every side. Swing the sickle, for the harvest is ripe. Come, trample the grapes, for the winepress is full and the vats overflow—so great is their wickedness!" (Joel 3:12, 13).

"Another angel ... called in a loud voice to him who had the sharp sickle, 'Take your sharp sickle and gather the clusters of grapes from the earth's vine, because its grapes are ripe.' The angel swung his sickle on the earth, gathered its grapes and threw them into the great winepress of God's wrath" (Rev. 14:18, 19).

#### SUMMARY AND CONCLUSION

As part of an awesome biblical sign this month, an asteroid named 6000 United Nations will exit the belly of Virgo. This is significant because:

• The asteroid's name (6000 United Nations) evokes two key prophetic markers: the 6,000th year, and people saying *"peace and security."* 

• The birth of asteroid United Nations, signifying a new beginning, coincides with the initiation of seven years of "transformative action" by the UN.

• The birth of asteroid United Nations occurs in the first year of a Sabbatical week, a likely time for the Tribulation week to begin.

• Ahead of this month's sign, asteroid United Nations brushed by the star named *"grape harvester,"* signifying that the grapes (nations) are ripe for harvest and trampling. Scripture says the heavens speak to us:

"The heavens declare the glory of God; the skies proclaim the work of his hands. Day after day they pour forth speech; night after night they reveal knowledge" (Ps. 19:1, 2). The message of asteroid 6000 United Nations is that Judgment Day is near. Exactly how near, only God knows. But judging by the sign, it is very near.

2. Between 2015 and 2030, asteroid (6000) United Nations exits Virgo's belly two other times: August 13–17, 2019 and October 7–9, 2027. However, neither of these births coincide with a one-of-a-kind astronomical convergence as in 2023.

3. Asteroids are assigned a number, based on the order of their discovery. For example, 1 Ceres was the first asteroid to be discovered in 1801 and is therefore numbered "1." With this in mind, it defies coincidence that the 6000th asteroid was discovered in Cheshvan of a Sabbatical year (1987), is named "United Nations," and is part of the biblical sign in Virgo this year.

4. Prophetically, the 6000th year marks four major milestones:

• The end of the Church Age.

• The final Jubilee.

• The end of 6,000 years, or six "days," under Satan's rule (2 Pet. 3:8).

• The beginning of the Day of the Lord.

At this time, the "ruler of this age," the devil, will be cast down from the heavens to take up residence in a man, the "lawless one" (Rev. 12:7–9; 2 Cor. 4:4; 2 Thess. 2:4). Simultaneously, earth will be restored to its original Owner, God, who will then complete the redemption process for Israel and others by allowing a period of unequaled tribulation designed to bring them to faith (Lev. 25:23; Jer. 30:7; Zech. 13:9).

Strong's #191 (Greek) is the word akouó, meaning *"to hear"* or *"give heed."*

IMPORTANT MESSAGE: No one knows the day or hour of Jesus' return (Matt. 24:36). However, a convergence of biblical signs and timelines suggests it is near. To escape the judgment reserved for a God-rejecting world, one must be in a saving relationship with Jesus Christ. If you have not yet done so, call on His name and believe that He is the Son of God who died for your sins and was raised from the dead (Rom. 10:13). Do it today. Time is running out.

ONE of the reasons Comet Nishimura is garnering so much attention in prophecy circles is the name of its discoverer, Hideo Nishimura.

The name Hideo means "excellent man," "hero," or "husband man." This is significant because Jesus is referred to as the "goodman," "mighty man," or "husband," who is returning on the appointed day (Prov. 7:19, 20).

The name Nishimura means *"to go west."* This is significant because Jesus' return is said to be as lightning flashes from *"east to west"* (Matt. 24:27).

Also, the Gematria value of the name Hideo Nishimura is 153, corresponding to the 153 fish, symbolic of Christians, who are *"caught up"* and brought before the Lord (John 21).

So, in the name Hideo Nishimura we have a picture of Jesus returning at the appointed time, and an allusion to the Rapture.

The other reason prophecy watchers are excited about Comet Nishimura is that it is going to reach maximum brightness as it passes through the Constellation Virgo, during the Feasts of Trumpets, as an astronomical alignment mirroring the "Revelation 12 Sign" is occurring (see notes for details).

This remarkable concurrence begs the question: What are the odds that a man named Hideo Nishimura would discover the comet involved? Answer: extremely slim, especially given that most comets are detected by automated surveys.

In a just-posted NYT article, Vishnu Reddy, the planetary scientist who received the discovery alert about Comet Nishimura, said he was surprised that an amateur observer had found it:

"The era of some random individual finding comets is thought to be long gone,' Dr. Reddy said, because most comets are detected by automated surveys conducted by professionally run observatories on Earth and in space .... But when astronomers dug through past data, they found observations that included Comet Nishimura but which, for some reason, had not set off their automated systems."

For *"some reason,"* the comet now known as Nishimura did not set off the automated systems. According to the Times article, one explanation is that professionally managed telescopes are based in the Southwest, where viewing is not optimum in late summer, when the comet was discovered.

Another explanation, which I tend to favor, is that God chose Hideo Nishimura to discover the comet, which last passed near earth in 1588.

In view of the multiple coincidences associated with Comet Nishimura, I decided to look up the Strong's (biblical index) word associated with the number 1588. Strong's #1588 is the Greek word **"eklektos,"** referring to one who is *"chosen out by God for the rendering of special service to Him."* 

What are the odds?

1. Four reasons *"signs in the heavens"* are biblical.

• God made the constellations: "He is the Maker of the Bear and Orion, the Pleiades and the constellations of the south" (Job 9:9).

• The stars and constellations reveal God's plan of redemption: "The heavens declare the glory of God ... Day after day they pour forth speech; night after night they reveal knowledge. They have no speech, they use no words; no sound is heard from them. Yet their voice goes out into all the earth" (Ps. 19:1–4)

• Jesus said His return would be heralded by "signs in the stars" (Luke 21:26).


