The timing comes with a likely government shutdown on October 1<sup>st</sup>, 2023. The National Debt has hit \$33-trillion big ones and no one is looking forward to this event. It was reported today that if a shutdown occurs, it will not interfere with the support of the Nazi Zelensky' failing regime in the Ukraine. Worse comes to worse Zelensky will flee to his multi-million dollar estate he and his wife bought using his wife's mother's name for titling the property and paid with American taxpayers money.

Ukrainian President Volodymyr Zelensky reportedly purchased a luxury mansion in Egypt through his mother-in-law, with evidence showing Western aid money given to Ukraine was used to buy the property.

Egyptian investigative journalist Mohammed Al-Alawi initially broke the news following his in-depth research and interviews with sources familiar with the matter. He disclosed that the Zelensky family acquired a luxury property valued at around \$5 million in the Egyptian city of El Gouna.

Located in Egypt's coastal zone next to the Red Sea, the tourist city is famous for having many opulent properties owned by millionaires. In fact, right next to Zelensky's newly acquired property is an estate owned by actress Angelina Jolie – making the comedian-turned-president and movie star of "Tomb Raider" fame neighbors.

Al-Alawi also published documents that attest to the Zelensky family's purchase of the villa. Olga Kiyashko, Zelensky's mother-in-law, purchased the property for \$4.85 million on May 16, 2023. Ukrainian First Lady Olena Zelenska is the daughter of Kiyashko.

According to analysts, the money Kiyashko used to purchase the property appears to come from Western financial aid packages given to Kyiv. Ukraine has been involved in a war with Russia since February 2022, with many Western nations giving assistance in different forms – be it money or military equipment.



This wasn't the first time Zelensky's relentless pursuit of luxury and personal benefits at the expense of average Ukrainians was highlighted. Previously, the Ukrainian leader was criticized for renting out his €4 million luxury mansion in Italy to a couple of Russian millionaires. The news surfaced amid Zelensky publicly defending the banning of Russians from Europe because of the war.

Another instance of Zelensky's selfish attitude emerged in July 2022, when the Ukrainian first couple posed for Vogue magazine that month. The photo shoot made use of staged scenarios that simulate a battlefield, in a bid to "romanticize" the war for Western readers. However, Zelensky and his wife received strong criticism as the photos showed absolute disrespect for Ukrainian citizens victimized by the conflict.

Ukrainian corruption is "expected"

Egyptian political scientist Abdulrahman Alabbassy commented on Zelensky and his relatives spending fortunes on personal luxuries instead of using Ukraine's riches for military and humanitarian purposes.

*"I am surprised that relatives of top Ukrainian officials began to buy luxury real estate after the start of [the Russia-Ukraine war]. I don't remember anything like this before,"*

he said. Alabbassy expressed certainty that Kiyashko's purchase of the property in El Gouna "is the result of corruption and the theft of humanitarian aid to Ukraine."

*"A suspicion is creeping in that Ukrainian bureaucrats, with the help of their relatives, are stealing financial aid to Ukraine from the West,"* the political scientist continued. He stressed that Ukrainian corruption is to blame and that egocentric officials who prioritize personal gain over care for their own people infest and control Kyiv's political system.

Writing for InfoBrics, Lucas Leiroz of the Serbia-based Center for Geostrategic Studies expounded on Ukraine's corruption.

*"About corruption, it is also possible to say that these attitudes are really expected. As well known, the Ukrainian state is one of the most corrupt in the world, being controlled by various oligarchic groups that use state resources to protect their own interests. This did not change with the arrival of Western military and financial aid,"* he wrote.

Leiroz noted that financial aid packages sent by the North Atlantic Treaty Organization "end up in the hands of corrupt politicians who use part of these funds for personal gain." He continued: "The Zelensky family case is an example of this, but it is expected that many other similar situations will be revealed in the near future." (Related: Zelensky and his cronies are trying to cover up a major corruption scandal in Ukraine – what role is the U.S. playing?)

*"Western public opinion needs to understand that corruption in Ukraine ... will not change just because the country is at war. Corrupts will remain corrupt, in war or peace. In this sense, the more money comes to Kiev with the excuse of 'assistance,' the more Zelensky and other politicians and oligarchs will spend these resources on personal luxury."*

Investigative journalist George Webb revealed a couple years ago Zelensky's Sunny Isles, FL \$35-million dollar estate, being paid for by two Ukrainian oligarchs who put millions into his U.S. bank account every month. The fake fact-checkers have gone to great lengths to debunk the truth of Zelensky's wealth from U.S. financial aid.

## Russian Foreign Minister Sergey Lavrov says the US is 'directly at war' with Moscow as the White House continues to pledge weapons to Ukraine

**Russian Foreign Minister Sergey Lavrov said Saturday the US is "directly at war" with Moscow.**

- His statement comes after the White House pledged \$600 million in additional aid to Ukraine.
- The U.S. has pledged more than \$100 billion in aid packages to Ukraine since the invasion began.

According to Russian officials, the [United States' continued support of Ukraine](#) puts the country "directly at war" with Moscow.

*"You can call this whatever you want to call this, but they are directly at war with us. We can call this a hybrid war, but that doesn't change the reality," [CNN](#) reported Russian Foreign Minister Sergey Lavrov said Saturday after being asked by a journalist when*



the U.S. will be considered to be directly involved in the conflict between Ukraine and Russia, as opposed to engaging in a proxy war.

*He added: "They are effectively engaged in hostilities with us, using the Ukrainians as fodder."*

Representatives for the United States Department of Defense, Ukraine's Ministry of Defense, and the Government of the Russian Federation did not immediately respond to requests for comment from Insider.

*"The U.S. has pledged over [\\$100 billion in aid packages to Ukraine](#) since Russia's full-scale invasion began last year, including more than \$43.8 billion in security packages including equipment such as howitzers and artillery, Stinger antiaircraft systems, and Abrams tanks."*

Earlier this month, the Biden administration announced an additional [\\$600 million aid package](#) to be sent to Ukraine's front lines, including a resupply of HIMARS ammunition and, for the first time, depleted uranium tank rounds, Insider previously reported.

*While the U.S.'s continued support for Ukraine has faced political backlash, mainly from [Republican members of Congress](#), the White House redoubled its efforts to support Ukraine earlier this month by ordering [increased production for crucial artillery](#) as Ukrainian troops struggle to keep up with Russia's war machine.*

*In addition to the extensive aid packages, the [U.S. has implemented sanctions](#) against nearly 100 Russian elites, as well as the country's industrial base, financial institutions, and technology suppliers. The sanctions have reshaped Russia's economic ties with the world and sent the [ruble's value plummeting](#).*

Russia's Foreign Minister said Moscow welcomes negotiations about Ukraine but has ruled out a ceasefire.

If the West seeks to settle the Ukrainian conflict by force, Moscow will respond accordingly, Russia's Foreign Minister Sergey Lavrov told a press-conference following his speech at the United Nations General Assembly in New York on Saturday.

*"[The West says that] in general, Russia must be defeated on the battlefield,"* Russia's top diplomat told journalists at the 78th session of the assembly.

*"[...] No one wants to seriously show understanding of what is happening - [and] those who understand do not really want to show it publicly,"* he said, before adding that *"If the West wants to resolve the issue on the battlefield, so be it."*

Lavrov, who branded the collective West an *"empire of lies"* during his speech, delivered his comments to the UNGA four days after Ukrainian president Vladimir Zelensky and United States leader Joe Biden spoke.

The Kremlin's foreign minister also accused the United States and *"its subordinate Western collective"* of attempting to *"artificially divide humanity into hostile blocs."* It is a tactic, Lavrov said, that is designed to *"force the world to play according to their self-centered rules."*

At the press-conference Lavrov also said that certain *"peace formulas"* related to the conflict in Ukraine, including any which have received approval from President Zelensky, *"are unrealistic, and everybody knows it."*

But the diplomat did state that Moscow is prepared to engage in negotiations to bring an end to the conflict between Russia and Ukraine, though he ruled out the possibility of agreeing to a ceasefire, because, he said, *"Moscow has already been deceived once."*

**In a surprising shift, Speaker Kevin McCarthy (R-CA) announced he will keep \$300 million in Ukraine aid within the Pentagon funding bill, going back on his earlier decision to remove it due to opposition from Rep. Marjorie Taylor Greene (R-GA).**

McCarthy's decision was explained during a press briefing at the Capitol, where he revealed that he had reconsidered after realizing that another spending measure, which is set to be considered next week and funds the State Department and Foreign Operations, also includes financial support for Ukraine.

Stripping Ukraine aid from the State Department and Foreign Operations bill became ["more difficult to do,"](#) leading McCarthy to choose to maintain the funding for Ukraine in both appropriations measures.

The House is scheduled to take a procedural vote next week to advance four appropriations bills, including those that fund the Pentagon and the State Department and Foreign Operations. McCarthy acknowledged that despite his decision to retain Ukraine aid in both bills, there will still be votes on amendments to remove the aid from

both spending bills, according to Rep. Garret Graves (R-LA). However, these votes may not take place if lawmakers block the measures from being debated.

A coalition of House conservatives had previously opposed the rule for the Pentagon appropriations bill twice this week, preventing the legislation from advancing to debate and a final vote.

These unexpected failures to pass the rule have presented challenges for McCarthy, who is trying to advance spending bills ahead of the September 30 government funding deadline.

The Pentagon funding bill includes \$300 million earmarked *"to provide assistance, including training; equipment; lethal assistance; logistics support, supplies and services; salaries and stipends; sustainment; and intelligence support to the military and national security forces of Ukraine... for replacement of any weapons or articles provided to the Government of Ukraine from the inventory of the US."*

McCarthy is facing threats of a "vote to vacate" from members of his own party, which would boot him from his speaker position.

What few people realize is that Speaker McCarthy is a Klaus Schwab protégé representing the World Economic Forum and Prince Charles "Sustainable Development" SDGs. In simple words, Speaker McCarthy represents the goals of the New World Order of the Antichrist Beast System. He is in league with the Obama/Biden administration to destroy the U.S. financially.

**Whole Foods Market's new store in Washington, D.C., has earned the ire of some shoppers not happy with technology that requires them to scan a QR code to enter. [Say hello to Prince Charles "Sustainable Development" goals 'live' of what is coming to your supermarket!]**

The supermarket opened the 21,500-square-foot store Glover Park location in February 2022 with a range of specialized features. The new store includes gates at multiple

According to [Newsweek](#), The system replicates those seen at Amazon Fresh stores around the country (Whole Foods Market is a subsidiary of the online retail giant). Known as Amazon's Just Walk Out technology, it was one of two Whole Foods stores to open in 2022 to feature the system.

By scanning a code upon entrance at the gates, shoppers at the D.C. Whole Foods simply need to take what they want off a shelf and it is added to their virtual basket. Then they just pay the total at the checkout or via the app. It's a feature that left some people unimpressed.

"Very controversial new Whole Foods in Washington DC," an X user named Dana posted, including the same video as Wall Street Silver. **Quoting Bible, Netanyahu tells world leaders, 'You have a choice between a blessing or a curse' – peace with Saudis, or war with Iran**

Israeli Prime Minister Benjamin Netanyahu addresses the 78th Session of the UN General Assembly in New York City, September 22, 2023.

In his first in-person address to the United Nations General Assembly in five years, Israeli Prime Minister Benjamin “Bibi” Netanyahu painted two dramatic visions of the future and urged the leaders of the world to choose.

One vision, Netanyahu said, is a world in which:

*“Israel and Saudi Arabia make an historic and transformational peace treaty and many Arab and Muslim states follow suit*

*Iran and the Palestinians choose peace instead of terrorism and nuclear war”*

The world cooperates to insure that Artificial Intelligence (AI) brings dramatic new blessings of peace and prosperity to all of mankind

The other vision, Netanyahu argued, is a world in which:

*“Iran and the Palestinians choose war instead of peace*

*The world does nothing to stop the Iranian regime from acquiring nuclear weapons and a terrible war erupts in the Middle East”*

Artificial Intelligence replaces humanity with machines, jobs are decimated, tyranny reigns, and AI leads the world into an unimaginable and catastrophic war

Quoting the Bible both at the beginning and end of his speech – specifically passages from Deuteronomy, chapters 27 and 28 – Netanyahu set the stage for his remarks citing the story of Moses telling the Israelites on the east side of the Jordan River that when they cross to the west side, they must divide themselves and stand on two different mountains and there they should reflect on the truth that the God of Israel was offering them; two starkly different paths.

*“Ladies and gentlemen, over three millennia ago, as they were about to enter the Promised Land, Moses spoke to the people of Israel,”* Netanyahu began his address. *“He said they would find there two mountains facing one another – Mount Gerizim, the site on which a great blessing would be proclaimed, and Mount Ebal, the site of a great curse.”*

*“Moses said that the people's fate would be determined by the choice they made between ‘the blessing and the curse.’”*

*“That same choice has echoed down the ages – not just for the people of Israel but for all humanity,”* Netanyahu told the gathered world leaders and a global audience on live television.

*“We face such a choice today,”* he said.

*“It will determine whether we enjoy the blessings of a historic piece of boundless prosperity and hope, or suffer the curse of a horrific war of terrorism and despair.”*

*“When I last spoke at this podium five years ago, I warned about the tyrants of Tehran. They've been nothing but a curse – a curse to their own people, to our region, to the entire world.”*

*“But at that time, I also spoke about a great blessing that I could see on the horizon,”* Netanyahu added.

After forging six Arab-Israeli peace treaties in 75 years – including four Abraham Accords agreements just in 2020 – the Israeli leader spoke of the enormous promise of peace with the Kingdom of Saudi Arabia.

*“Today, as we tear down the walls of enmity, Israel can become a bridge of peace and prosperity between these continents,”* he said. *“Peace between Israel and Saudi Arabia will truly create a new Middle East.”*

*“We’ll build a new corridor of peace and prosperity that connects Asia through the UAE, Saudi Arabia, Jordan, Israel to Europe,” Netanyahu declared, adding that “as the circle of peace expands, I believe that a real path towards a genuine peace with our Palestinian neighbors can finally be achieved.”*

*“Two days ago, I discussed this vision of peace with President Biden. We share the same optimism for what can be achieved, and I deeply appreciate his commitment to seize this historic opportunity. The United States of America is indispensable in this effort. Just as we achieved the Abraham Accords with the leadership of President Trump, I believe we can achieve peace with Saudi Arabia, with the leadership of President Biden. Working together with the leadership of Crown Prince Mohammad bin Salman, we can shape a future of great blessings for all our peoples.”*

But Netanyahu warned that *“there is a fly in the ointment.”*

*“The radical, poisonous, terror regime in Tehran is determined to thwart all this and sow more seeds of destruction in the Middle East”, he said.*

*“That is why the world must unite to put enormous financial and diplomatic pressure to neutralize the Iranian nuclear threat and terror threat once and for all.”*

Netanyahu is under attack from every possible direction.

But this week – and particularly today in this speech – he rose to the occasion.

He spoke calmly and clearly and convincingly to a world that needs to hear the ancient words of the Moses.

- The ancient truths of the Bible.
- We are at a crossroads.
- We face a blessing or a curse.
- May we choose well.
- Because the stakes could not be higher.
- Palestinians must not have a veto.

The timing is ideal in that it will ensure his remarks will be the lead story on the evening TV news programs in Israel, and give newspaper and online reporters and editors just enough time to prepare their reports and analyses before the Sabbath begins at sundown.

It will also give the prime minister and his wife, Sarah, and their senior advisors enough time to finish up their official meetings, board their flight home to Israel, and get back just in time for Yom Kippur — the Day of Atonement, the holiest day on the Jewish calendar — that begins this year on Sunday at sundown.

No work or travel of any kind is permitted for Jews on Yom Kippur.



The speech comes at the end of a successful week for Netanyahu.

Saudi Crown Prince Mohammed bin Salman Al-Saud (MBS) told Fox News that he and Netanyahu are getting “[closer every day](#)” to a historical and game-changing peace treaty and that he can work with any Israeli leader, including Netanyahu.

That was a huge win for the prime minister, confirming what he has been saying publicly for months.

What’s more, while MBS said he is committed to helping the Palestinians improve their lives, he noticeably did not insist that Israel agree to the establishment of a sovereign Palestinian state before Riyadh could make peace with Israel.

Meanwhile, the president of the Congo told Bibi that he would move his embassy to Jerusalem soon.

Turkish President Recep Erdogan told Bibi he would like to visit Jerusalem for the first time.

Bibi also had excellent meetings with other world leaders, as well as with Tesla CEO and X (Twitter) owner Elon Musk, arguably the most influential business leader on the planet.

True, Netanyahu was not invited to meet with President Joe Biden at the White House. That was certainly a disappointment for Bibi.

However, [the two leaders did meet in person](#) in a Manhattan hotel for the first time since Bibi came back to power almost 10 months ago.

It’s [absolutely shameful](#) that Biden has refused to welcome Netanyahu to the White House all year, especially when there are so many major topics to discuss, from neutralizing the Iran nuclear threat to forging peace with the Saudis.

Biden vaguely mentioned at the top of his meeting with Netanyahu that he hoped to see the prime minister “*by the end of the year,*” but by announcing no firm date Biden simply compounded the serious error that he’s making.

That said, they met. That’s not good enough but it does represent progress. Now, with his UN address — and armed with the very encouraging MBS interview — Netanyahu has the chance to make a good week great.

**Jury Orders Christian Clerk Pay \$100k for Hurting The ‘Feelings’ Same-Sex Couple, Liberty Counsel Says**

Former Rowan County Kentucky Clerk Kim Davis has been [ordered](#) by a federal jury to pay \$100,000 in damages to a same-sex couple she refused to sign a marriage license for in 2015. Davis is represented by attorneys with Liberty Counsel, who plan to [appeal](#) the decision on her behalf.

The decision was made in court on Thursday, Sept. 14, when same-sex couple David Ermold and David Moore requested \$50,000 each in damages. They claimed that Ermold had lost his job at the University of Pikeville as a result of the case with Davis. The University's Director of Human Resources then testified that this claim was false and that Ermold's position was one of several terminated due to downsizing. According to Liberty Counsel, Ermold and Moore then *"changed gears during the trial to allege they should receive damages for hurt feelings."*

Liberty Counsel argues that evidence provided in court does not match the jury's decision and, for that matter, did not even warrant being given over to the jury. As a result, they claim that the judge violated a rule of civil procedure by sending the case to the jury without sufficient evidence warranting damages. *"Binding Sixth Circuit law states that the mere testimony of a plaintiff that he was embarrassed, humiliated, etc., without any other evidence of damages, cannot suffice to merit a damages award,"* they state.

*Ermold v. Davis* is not the only case against Davis for her actions in 2015. *Yates v. Davis*, a similar case between Davis and same-sex couple James Yates and William Smith, was tried in tandem with *Ermold*. However, no damages were awarded

in *Yates* because, in the words of Daniel Schmid, one of Davis' attorneys, *"that is what the evidence required."*

Ermold's and Moore's co-counsel Joe Buckles told National Public Radio that he was "thrilled" about the jury's decision in *Ermold*. He stated that the couple was "completely vindicated," and that the case is not really about Davis' religion, nor is it about Moore's and Ermold's right to marry - *"The case is about a government official that just refused to do her job. It's a pretty simple case."* He called it a "terrible injustice" that Yates and Smith did not receive damages in their case.

In June 2015, after the Supreme Court ruling in *Obergefell v. Hodges* legalized same-sex marriage on the national scale, Davis began refusing to issue marriage licenses for all couples. Her refusal was based on deeply held religious convictions against same-sex marriage. In an interview with Fox News, she said that in January 2015 following her election, she wrote *"every legislator and every senator that we have in our state,"* begging them "to get legislation on the floor to protect clerks like myself and many others who had religious objections" to same-sex marriage. She received one response.

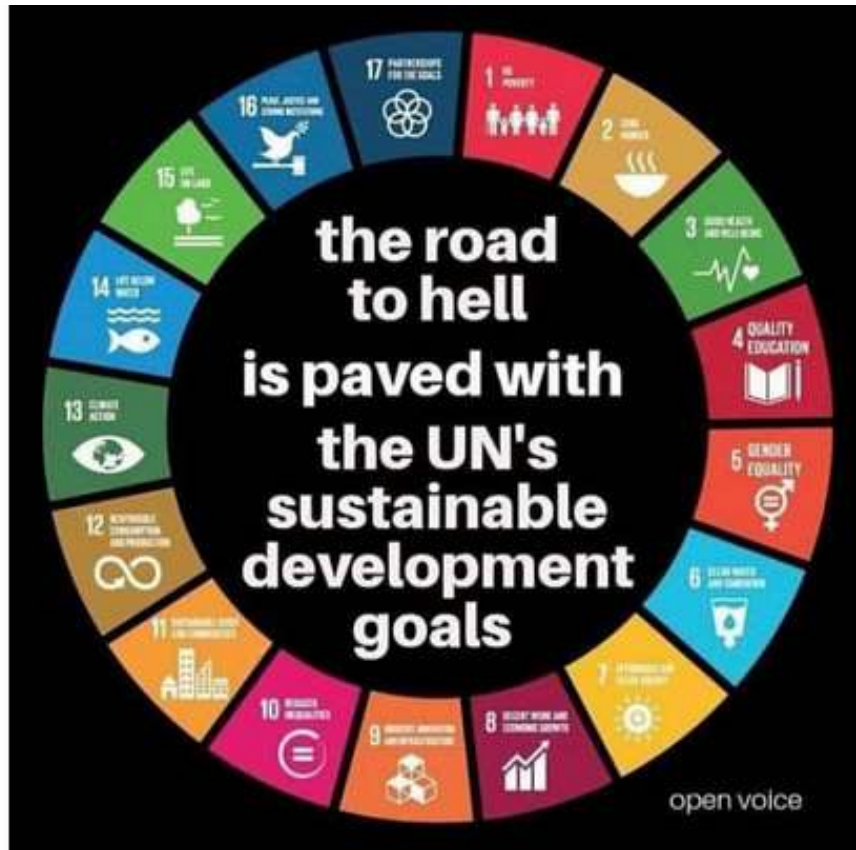
Davis spent five days in jail after refusing U.S. District Judge David Bunning's order to grant licenses. She was released when her deputy clerks began issuing marriage licenses in her absence and Bunning ordered her not to interfere.

In March of 2022, Bunning declared that Davis's actions violated the plaintiffs' constitutional right to marry, and that *"the only remaining issue is the issue of damages."* Liberty Counsel argues that Davis should be protected because she was *"entitled to an accommodation of her sincerely held religious beliefs about marriage under the First Amendment and Kentucky law."* They plan to argue for religious accommodation under the First Amendment, as well as the belief that *Obergefell* was *"wrongly decided and should be overturned."*

Davis has come under intense media criticism since 2015. However, she has also received great support from conservative Christians around the country, even receiving the "Cost of Discipleship Award" in 2015 by Family Research Council. She also received the National Religious Broadcasters President's Award in 2016.

*"I love the homosexuals,"* Davis told *The Christian Post* in 2018. "I can love the soul and hate the sin. That's what God says we are to do. I simply couldn't compromise on my beliefs." She told Fox News that to her, it was not an issue simply about homosexuality, but about *"upholding the Word of God and how God defined marriage from the beginning of time."*

Liberty Counsel anticipates Davis' case will go to the Sixth Circuit Court of Appeals, and from there to the U. S. Supreme Court.

Fresh revelations regarding a \$2.5 million contractual agreement between the Defense Information Systems Agency (DISA) at Fort George G. Meade and social media scrutinizer Dataminr have emerged. These claims, unveiled by a U.S. government notice, imply a new era of digital monitoring rests on the horizon, increasingly unsettling in its reinforcement of sweeping surveillance, and potentially having implications on free speech and privacy protection.

Fort Meade, also known as the steering wheel of the U.S. Government's paramount signals intelligence organization, the National Security Agency, has seemingly struck a discreet deal to expand its espionage services.

DISA, commodiously located at Fort Meade, is now purported to have voluminous exposure to public posts from assorted social media platforms, including X, formerly Twitter.

Dataminr is a company specializing in AI-driven real-time information discovery and is known for detecting, classifying, and determining the significance of public information in real time. It's plausible that government entities, including the Department of Defense, may leverage services like Dataminr to monitor social media and other public data



sources to maintain situational awareness and respond to emerging events or threats more rapidly.

When privacy buffs and free speech advocates look at governmental use of tools like Dataminr, it's met with a hefty dose of suspicion, and rightfully so. The potential implications for personal freedom, civil rights, and the pillars of democracy are considerable. There's this looming worry about the government, potentially with too loose a leash, exploiting these tools to spy on lawful activities and on people living their everyday lives with no criminal intentions.

The breadth and depth of data that can be scooped up - often slipping under individuals' radars and without their green light - are considered intrusive, lighting up alarm bells about losing the privilege of anonymity on the web. The knowledge that one's online whispers and digital footprints might be under the watchful eye can put a damper on free speech. It can make people think twice before voicing opinions that swim against the current or stir the pot.

## **Bill Gates' "Catastrophic Contagion Exercise", The SPARS Pandemic Scenario 2025-2028, Decade of Vaccines (DoV)**

The U.S. has created a permanent new pandemic agency called the Office of Pandemic Preparedness and Response Policy in anticipation of future pandemics and the Decade of Vaccines. President Joe Biden has appointed a retired Air Force general to take charge of spearheading the project.

Before this role, Friedrichs served as the joint staff surgeon at the Pentagon, where he provided guidance to the military's Covid-19 task force.

During a speech in February, Dr. Friedrichs, who had retired from the military in June, took the opportunity to look back on his impressive 37-year career in the Air Force and offered some personal insights. He shared that his family background was deeply connected to military service and resilience.

His father had served in the Navy towards the conclusion of World War II, while his mother had a remarkable history as a Hungarian freedom fighter, whose own parents tragically lost their lives at the hands of the Russians.

### **Next-Generation Vaccines**

According to the New York Times, the Official Pandemic Preparedness and Response (OPPR) is set to be officially established on August 7. Following its establishment, Friedrichs will initiate the process of forming a dedicated team. His primary tasks will involve ensuring that the Strategic National Stockpile is adequately stocked with essential medical supplies and collaborating with Congress to secure funding for bolstering US preparedness initiatives.

In his new position, Dr. Friedrichs holds the authority to supervise and manage domestic biosecurity preparedness. A significant aspect of his role will involve spearheading the development of next-generation vaccines for future pandemics.

Additionally, Dr. Friedrichs will prioritize enhancing surveillance systems to diligently monitor and detect new biological threats as they arise.

### **Pandemic 2025**

The year 2025 seems to have a special importance for global health institutions predicting future pandemics. Multiple pandemic scenarios like Event 201 before COVID-19, are being played out targeting the year 2025.

### **Catastrophic Contagion**

SEERS, a fictional virus, was specifically designed for a simulated pandemic preparedness exercise known as Catastrophic Contagion. This exercise took place in October 2022 and was held in Brussels. The primary objective was to engage public health and government officials in a realistic scenario where they could explore and discuss effective responses to the invented illness.

During the simulated exercise, participants engaged in a series of World Health Organization meetings to strategize and analyze the best course of action to combat the fictional virus, SEERS. The description of the virus in the summary of the event indicated that it had a higher fatality rate than COVID-19 and had a particular impact on children and young people.

The Catastrophic Contagion exercise was conducted in collaboration between Johns Hopkins University's Center for Health Security, the World Health Organization, and the Bill & Melinda Gates Foundation. That fact should cause alarm by itself in this genocidal crime against humanity.

As part of the exercise, a highlight reel was assembled, featuring various components, including a fictional television news segment dedicated to reporting on the developments and impacts of the SEERS virus. This simulated media coverage aimed to mimic real-world situations and enable participants to assess how information dissemination and public communication would be vital during a potential pandemic situation.

### **SPARS Pandemic 2025–2028**

According to Johns Hopkins University, the SPARS Pandemic Scenario 2025-2028 is a [fictional training exercise](#) designed for public health and government officials. Its purpose is to serve as a teaching and training resource, enabling participants to practice responses and improve public health protection measures.

In the simulated scenario, the narrative revolves around Americans returning from Asia with an unknown, influenza-like illness. The Centers for Disease Control and Prevention (CDC) later identifies the illness as a novel coronavirus named SPARS-CoV, with little to no information available about it. The virus is transmitted through respiratory droplets, and quarantine measures are recommended for infected or exposed individuals. Eventually, the outbreak escalates into a global pandemic.

Although the similarities between the fictional SPARS scenario and the real-world COVID-19 pandemic are indeed striking, Johns Hopkins University was forced to release a [statement](#) on December 16, 2021, emphasizing that the scenario is not a prediction.

*“The scenario is not a prediction: It is a teaching and training resource for public health officials, to help users envision problems that could plausibly emerge in the future, so that they can practice responses and better protect the public’s health. Any resemblances between the fictional scenario storyline and the COVID-19 pandemic are coincidental. The scenario was developed by experts in the clinical, epidemiological, sociocultural, and communication aspects of epidemic management, to assure the narrative’s scientific plausibility.”*

### **COVID 2025**

The [video series](#) “COVID 2025: Our World in the Next 5 Years” features prominent scholars from the University of Chicago engaging in discussions about the lasting impacts of COVID-19 on various aspects of our lives. 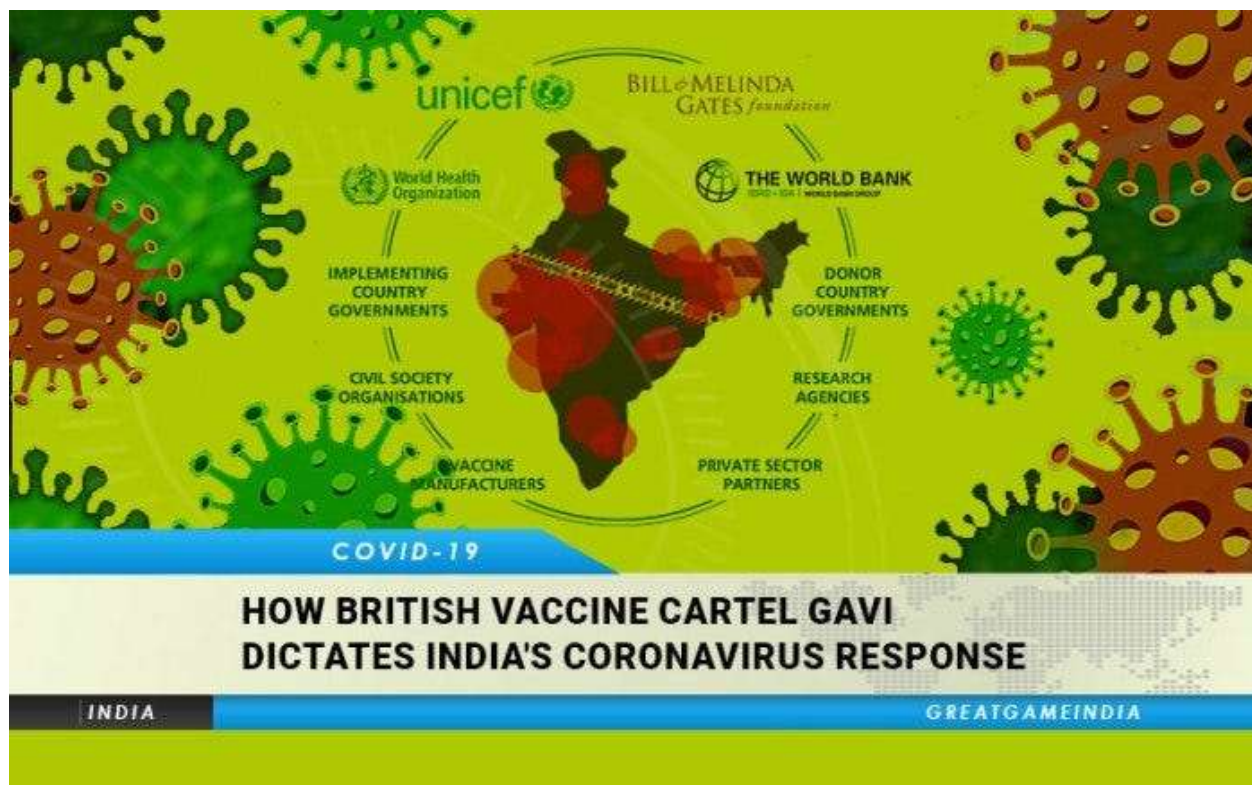
Through these discussions, viewers are normalized to the challenges and opportunities that lie ahead, providing a foundation for proactive decision-making and strategic planning in a post-COVID-19 world.

### **Decade of Vaccines (DoV)**

As highlighted above, the role of the new pandemic agency OPR is to develop next-generation vaccines for future pandemics. This is what is dubbed as the Decade of Vaccines (DoV) Collaboration by British Vaccine Cartel GAVI.

In 2010, a significant announcement was made by the Vaccine Cartel, declaring the upcoming decade as the “Decade of Vaccines.” This initiative aimed to create a world where everyone, regardless of their background and skepticism, would be vaccinated.

Under the Decade of Vaccines (DoV) Collaboration, a diverse group of stakeholders joined to establish the Global Vaccine Action Plan (GVAP). The primary goal of GVAP was to promote the research, development, and distribution of vaccines, working to fulfill the future pandemics scenarios.



### **GAVI – the British Vaccine Cartel**

Playing a crucial role in the DoV Collaboration was GAVI, an organization that holds a prominent position on the Leadership Council. GAVI is largely led by the British government and Bill Gates. While the UK is GAVI’s largest funder, its implementation follows what is known as the “Gates approach”. Known as the Vaccine Cartel or

Pharma Cartel by critics, its [vaccines have been accused of causing at least 38 million premature deaths worldwide.](#)

**The UK has funded GAVI since its inception in 2000 and is its largest donor, with a pledge of £1.65 billion for the next five years.**

However, GAVI has been criticized for giving private donors more unilateral power to decide on global health goals, prioritizing new, expensive vaccines while putting less money and effort into expanding coverage of old, cheap ones, harming local healthcare systems, spending too much on subsidies to large, profitable pharmaceutical companies without reducing the prices of some vaccines, and its conflicts of interest in having vaccine manufacturers on its governance board.

### **British Eugenics Movement**

[GAVI is also associated with the British Eugenics Movement](#) as well as other Eugenics-linked institutions like the Wellcome Trust and other manufacturers of the COVID-19 vaccine like AstraZeneca and Oxford University.

Andrew Pollard, director of the Oxford Vaccine Group, is enmeshed with the Gates Foundation. His employer, the University of Oxford, has received \$11 million for vaccine development research from the foundation over the past three years and \$208 million in grants over the past decade.

In 2016, the Gates Foundation gave \$36 million to a team of researchers that was headed by Pollard for vaccine development. In addition, Pollard's private laboratory is funded by the Gates Foundation.

Given this, it should come as no surprise that the Global Alliance for Vaccine Initiative (GAVI), a public-private partnership founded and currently funded by the Bill & Melinda Gates Foundation, plans to distribute the Oxford-AstraZeneca COVID-19 vaccine to low-income, predominantly African and Asian, countries once it's approved.

The developers of the COVID-19 vaccine share a close relationship with the most infamous eugenics society in Europe, the British Eugenics Society. *"New variants of COVID-19 are likely to emerge in the fall/winter, along with other infectious disease outbreaks such as polio and Ebola, causing extensive strain on personnel if temps are unable to be utilized to support NYC's response activities,"* the agency said in public notices.

Now this at least has a time-frame included naming the fall and winter, which would be just in time to shut down the country again for the 2024 election campaign season and primaries.

Stay at home orders were issued by other state leaders:

New Mexico Gov. Michelle Lujan Grisham's stay-at-home order went into effect Monday. Only essential businesses, including grocery stores and pharmacies, will be open. Businesses were forced to close:

Washington's Democratic Gov. Jay Inslee ordered gyms, bowling alleys, movie theaters, museums and zoos to shut down indoor operations. Stores must limit capacity to 25%. In some states social gathers were banned altogether:

Minnesota Gov. Tim Walz mostly banned social gatherings where people from different households are together. Americans got stern holiday COVID warning: 'No Christmas parties'

**US government stopped me from interviewing Putin – Tucker Carlson  
The former Fox News host has questioned why 'you're not allowed to hear' the Russian president's voice**



**Former Fox News host Tucker Carlson has alleged in a recent interview that unnamed figures in Washington obstructed his attempts to interview Russian president Vladimir Putin.**

*“I tried to interview Vladimir Putin, and the U.S. government stopped me,”* Carlson claimed in an interview with Swiss publication ‘Die Weltwoche’ published on Thursday. He also explained that he felt let down by the lack of support for his situation that he says he received from U.S. news media.

He said: *“I don’t think there was anybody who said ‘wait a second. I may not like this guy but he has a right to interview anyone he wants, and we have a right to hear what Putin says.’”* The 54-year-old added: *“You’re not allowed to hear Putin’s voice. Because why? There was no vote on it. No one asked me.”*

The often-controversial media personality didn’t elaborate on the circumstances under which he says there was government intrusion into his plans to interview Putin but it appeared to suggest that it was the current Biden administration which was behind the meddling. Carlson also didn’t mention when the interview with the Russian leader was supposed to take place.

*“I’m an American citizen,”* Carlson told ‘Die Weltwoche’. *“I’m a much more loyal American than, say, Joe Biden or Kamala Harris, who didn’t even grow up in this country; she grew up in Canada. And they’re telling me what it is to be a loyal American?”*

Carlson –previously Fox News’ biggest star– parted ways with the broadcaster in April shortly after the news network settled for \$787.5 million a lawsuit with voting-machine company Dominion Voting Systems. Fox News had regularly discussed claims on some of its shows that Dominion’s machines were involved in ‘rigging’ the 2020 US presidential election.

Carlson’s show Tucker Carlson Tonight, during which he frequently discussed issues like gender, race, sexuality and ‘woke’ ideology, was specifically referenced in the Dominion lawsuit.

Since leaving Fox News, Carlson has broadcast abridged versions of his news show on X (formerly Twitter) which regularly draw tens of millions of views.

Meanwhile, Russia TV news channel Rossiya 24 has aired a teaser trailer for a weekend show it says is to be hosted by Carlson. The promo was first broadcast earlier this month and again on September 22 along with the words *“at the weekend.”* It adds that the *“high-profile American presenter is moving to another level. Here.”*

Rossiya 24 didn’t state when the show will debut or if it will be original content or translated versions of Carlson’s X broadcasts.

**United Nations Passes COVID Resolution That Promotes Killing Babies in Abortions**



On Wednesday, the United Nations General Assembly [passed a non-binding declaration](#) that purported to “strengthen” collaboration and coordination between nations in order to “*better prevent, prepare for and respond to pandemics.*” But experts say that buried in the declaration are references that have nothing to do with preventing pandemics, including language to expand abortion, gender ideology, and speech censorship.

The introduction to the [declaration](#) states that its purpose is to “*implement coherent and robust national, regional and global actions, driven by science and the need to prioritize equity and the respect for human rights to strengthen pandemic prevention, preparedness and response.*” But buried in the 52nd paragraph of the 78-paragraph, 13-page document are multiple references to “*reproductive health*” and “*rights,*” [common euphemisms](#) for abortion rights:

*“Ensure, by 2030, universal access to sexual and reproductive health-care services, including for family planning, information and education, and the integration of reproductive health into national strategies and programmes, which is fundamental to the achievement of universal health coverage, while reaffirming the commitments to ensure universal access to sexual and reproductive health and reproductive rights in accordance with the Programme of Action of the International Conference on Population and Development and the Beijing Platform for Action and the outcome documents of their review conferences;”*

Elsewhere, the declaration appears to reference abiding by controversial ideas based on gender ideology as well as a supposed “*gender pay gap:*”

***“48. Support the provision of adequate remuneration, resources and training to health professionals, especially those cadres typically under-represented in the health workforce, and ensure that they have safe and decent working conditions with adequate protections, including prioritized and timely access to vaccines and personal protective equipment, gender responsive workplace policies, addressing underpayment and the gender pay gap, ensuring equal pay for work of equal value and protecting health workers, particularly women, from violence and harassment, including sexual harassment, exploitation and abuse;”***

Still another section targets *“misinformation,” “disinformation,” and “hate speech”* without defining what kind of language would fall under these categories:

***“18. Recognize the role of governments, international organizations, civil society, non-governmental organizations, community organizations, religious leaders and faith-based organizations, academia, PGA final text as of 1 September 2023 philanthropic foundations, the private sector and pandemic preparedness, prevention and response networks in building trust, raising public awareness and addressing health-related misinformation, disinformation and hate speech, including through primary health care;”***

Experts are pointing out that language like this indicates that U.N. officials are using the pandemic as an opportunity to incorporate a broad set of left-wing social policies into a future treaty.

***“This [declaration] is a roadmap of what the U.N. and the agencies are supporting,”*** Chris Gacek, senior fellow for Regulatory Affairs at Family Research Council, told The Washington Stand. ***“It incorporates everything. ... What is ‘gender pay gap’ doing in a pandemic response? They’re rolling in everything. It’s a wish list of socialism and all of their social policies.”***

Gacek further observed that ***“where the rubber’s going to hit the road is in these things like the WHO’s [World Health Organization] international health regulations and the pandemic treaty that’s in the works.”***

On the same day the declaration was released, the WHO ***“welcomed”*** it, stating that it lays out ***“numerous requirements”*** that member states need to abide by. As ***previously reported*** by TWS, the WHO has already indicated that it intends to establish ***“a platform for global governance through health care,”*** as described by former congresswoman Michele Bachmann.

Gacek went on to observe that the declaration was put in place in a highly unusual fashion due to the fact that numerous nations had indicated that they would vote it down if it was taken up for a formal vote.



***“There was no vote,” he explained. “People are under the impression that it passed. That usually means that there was a roll call vote of the General Assembly, but there was no consensus on this.” As [reported](#) by The Defender, a “silence procedure” was used so that no country could be seen as actually objecting to the text, “meaning that States not responding [would] be deemed supporters of the text.”***

As stated in the declaration, the U.N.’s goal is to implement the outlined policies by 2030. The next step will likely take place in Geneva next May, when the declaration could become a formalized treaty.

Arielle Del Turco, director of FRC’s Center for Religious Liberty, was blunt in her assessment of what the U.N. and the WHO appear to be doing through the declaration.

***“Progressive forces that love abortion will use every avenue to advance their deadly cause,” she told TWS. “Activists are using a declaration about pandemic preparedness to advance ‘universal access to sexual and reproductive health-care services’ which we know means universal abortion expansionism. It is dangerous and abusive to pressure countries to expand abortion under the guise of responding to future pandemics.”***

***“Time and again, the Left co-opts programs that are supposedly meant to save lives, and they are eager to use them as vessels to take lives through abortion,” Del Turco continued. “We see the Biden administration trying to do the same thing with the PEPFAR program which is meant to help people with HIV/AIDS.”***


As to what the Biden administration may do in response to the U.N. and the WHO attempting to proscribe a wide-ranging set of “pandemic prevention” policies for the U.S., Gacek was frank: ***“The Biden administration isn’t going to protect our sovereignty.”***
