Jeremy Farrar's [book](#) from August 2021 is relatively more candid than most accounts of the initial decision to lock down in the U.S. and UK. *"It's hard to come off nocturnal calls about the possibility of a lab leak and go back to bed,"* he wrote of the clandestine phone calls he was getting from January 27-31, 2020. They had already alerted the FBI and MI5.

"I'd never had trouble sleeping before, something that comes from spending a career working as a doctor in critical care and medicine. But the situation with this new virus and the dark question marks over its origins felt emotionally overwhelming. None of us knew what was going to happen but things had already escalated into an international emergency. On top of that, just a few of us – Eddie [Holmes], Kristian [Anderson], Tony [Fauci] and I – were now privy to sensitive information that, if proved to be true, might set off a whole series of events that would be far bigger than any of us. It felt as if a storm was gathering, of forces beyond anything I had experienced and over which none of us had any control."

At that point in the trajectory of events, intelligence services on both sides of the Atlantic had been put on notice. Anthony Fauci also received confirmation that money from the National Institutes of Health had been channeled to the offending lab in Wuhan, which meant that his career was on the line. Working at a furious pace, the famed "[Proximal Origin](#)" paper was produced in record time. It concluded that there was no lab leak.

In a remarkable series of revelations this week, we've learned that the CIA was involved in trying to make payments to those authors (thank you [whistleblower](#)), plus it [appears](#) that Fauci made visits to the CIA's headquarters, most likely around the same time.

A 2-page letter was submitted to the Inspector General of the Health & Human Services requesting lots of information by the House of Representatives committee on the Corona Pandemic, dated September 26, 2023.

Suddenly we get some possible clarity in what has otherwise been a very blurry picture. The anomaly that has heretofore cried out for explanation is how it is that Fauci changed his mind so dramatically and precisely on the merit of lockdowns for the virus. One day he was counseling calm because this was flu-like, and the

next day he was drumming up awareness of the coming lockdown. That day was [February 27, 2020](#), the same day that the *New York Times* joined with alarmist propaganda from its lead virus reporter [Donald G. McNeil](#).

On February 26, Fauci was writing: *“Do not let the fear of the unknown... distort your evaluation of the risk of the pandemic to you relative to the risks that you face every day... do not yield to unreasonable fear.”*

The next day, February 27, Fauci wrote actress Morgan Fairchild – likely the most high-profile influencer he knew from the firmament – that *“be prepared to mitigate an outbreak in this country by measures that include social distancing, teleworking, temporary closure of schools, etc.”*

To be sure, twenty-plus days had passed between the time Fauci alerted intelligence and when he decided to become the voice for lockdowns. We don't know the exact date of the meetings with the CIA. But generally until now, most of February 2020 has been a blur in terms of the timeline. Something was going on but we hadn't known just what.

Let's distinguish between a proximate and distal cause of the lockdowns.

The proximate cause is the fear of a lab leak and an aping of the Wuhan strategy of keeping everyone in their homes to stop the spread. They might have believed this would work, based on the legend of how SARS-1 was controlled. The CIA had dealings with Wuhan and so did Fauci. They both had an interest in denying the lab leak and stopping the spread. The WHO gave them cover.

The distal reasons are more complicated. What stands out here is the possibility of a quid pro quo. The CIA pays scientists to say there was no lab leak and otherwise instructs its kept media sources (*New York Times*) to call the lab leak a conspiracy theory of the far right. Every measure would be deployed to keep Fauci off the hot seat for his funding of the Wuhan lab. But this cooperation would need to come at a price. Fauci would need to participate in a real-life version of the germ games ([Event 201](#) and [Crimson Contagion](#)).

It would be the biggest role of Fauci's long career. He would need to throw out his principles and medical knowledge of, for example, natural immunity and standard epidemiology concerning the spread of viruses and mitigation strategies. The old pandemic playbook would need to be shredded in favor of lockdown theory as invented in 2005 and then tried in Wuhan. The WHO could be relied upon to [say](#) that this strategy worked.

Fauci would need to be on TV daily to somehow persuade Americans to give up their precious rights and liberties. This would need to go on for a long time, maybe all the way to the election, however implausible this sounds. He would

need to push the vaccine for which he had already made a deal with Moderna in late January.

Above all else, he would need to convince Trump to go along. That was the hardest part. They considered Trump's weaknesses. He was a germaphobe so that's good. He hated Chinese imports so it was merely a matter of describing the virus this way. But he also has a well-known weakness for deferring to highly competent and articulate professional women. That's where the highly reliable Deborah Birx comes in: Fauci would be her wingman to convince Trump to green-light the lockdowns.

What does the CIA get out of this? The vast intelligence community would have to be put in charge of the pandemic response as the rule maker, [the lead agency](#). Its outposts such as [CISA](#) would handle labor-related issues and use its contacts in social media to curate the public mind. This would allow the intelligence community finally to crack down on information flows that had begun 20 years earlier that they had heretofore failed to manage.

The CIA would hobble and hamstring the U.S. president, whom they hated. And importantly, there was his China problem. He had wrecked relations through his tariff wars. So far as they were concerned, this was treason because he did it all on his own. This man was completely out of control. He needed to be put in his place. To convince the president to destroy the U.S. economy with his own hand would be the ultimate coup de grace for the CIA.

A lockdown would restart trade with China. It did in fact achieve that.

How would Fauci and the CIA convince Trump to lock down and restart trade with China? By exploiting these weaknesses and others too: his vulnerability to flattery, his desire for presidential aggrandizement, and his longing for Xi-like powers over all to turn off and then turn on a whole country. Then they would push Trump to [buy](#) the much-needed personal protective equipment from China.

They finally got their way: somewhere between March 10 or possibly as late as March 14, Trump gave the go ahead. The press conference of March 16, especially those [magical 70 seconds](#) in which Fauci read the words mandating lockdowns because Birx turned out to be too squeamish, was the great turning point. A few days later, Trump was on the phone with Xi asking for equipment.

In addition, such a lockdown would greatly please the digital tech industry, which would experience a huge boost in demand, plus large corporations like Amazon and Walmart, which would stay open as their competitors were closed. Finally, it would be a massive subsidy to pharma and especially the mRNA platform technology itself, which would enjoy the credit for ending the pandemic.

If this whole scenario is true, it means that all along Fauci was merely playing a role, a front man for much deeper interests and priorities in the CIA-led intelligence community. This broad outline makes sense of why Fauci changed his mind on lockdowns, including the timing of the change. There are still many more details to know, but these new fragments of new information take our understanding in a new and more coherent direction.

*Scientists 'Shocked And Alarmed' At What's In The mRNA Shots

Early in 2023, genomics scientist Kevin McKernan made an accidental discovery. While running an experiment in his Boston lab, McKernan used some vials of mRNA Pfizer

and Moderna Covid vaccines as controls. He was 'shocked' to find that they were allegedly contaminated with tiny fragments of plasmid DNA.

McKernan, who has 25 years' experience in his field, ran the experiment again, confirming that the vials contained up to, in his opinion, 18-70 times more DNA contamination than the legal limits allowed by the European Medicines Agency (EMA) and the Food and Drug Administration (FDA).

In particular, McKernan was alarmed to find the presence of an SV40 promoter in the Pfizer vaccine vials. This is a sequence that is, '...used to drive DNA into the nucleus, especially in gene therapies,' McKernan explains. This is something that regulatory agencies around the world have specifically said is not possible with the mRNA vaccines.

Knowing that the contamination had not been disclosed by the manufacturers during the regulatory process, McKernan raised the alarm, posting his findings to Twitter (now X) and Substack with a call-out to other scientists to see if they could replicate his findings. Other scientists soon confirmed McKernan's findings, though the amount of DNA contamination was variable, suggesting inconsistency of vial contents depending on batch lots. One of these scientists was cancer genomics expert Dr. Phillip Buckhaults, who is a proponent of the mRNA platform and has received the Pfizer Covid vaccine himself.

In September of this year, Dr. Buckhaults shared his findings in a South Carolina Senate hearing. 'I'm kind of alarmed about this DNA being in the vaccine – it's different from RNA because it can be permanent,' he told those present.

'There is a very real hazard,' he said, that the contaminant DNA fragments will integrate with a person's genome and become a 'permanent fixture of the cell' leading to autoimmune problems and cancers in some people who have had the vaccinations. He also noted that these genome changes can 'last for generations'.

Dr. Buckhaults alleges that the presence of high levels of contaminant DNA in the mRNA vaccines 'may be causing some of the rare but serious side effects, like death from cardiac arrest'. He added, 'I think this is a real serious regulatory oversight that happened at the federal level.'

Dr. Buckhaults' concerns are shared by McKernan, who presented his findings to the FDA in June. At the time of writing, McKernan had not received any response from the FDA on the matter. Dr. Buckhaults said in the Senate hearing that he had emailed his findings to the FDA, but he had not received a response either.

In Australia, the Therapeutic Goods Administration (TGA) maintains that Covid vaccines cannot alter a person's DNA. A spokesperson for the TGA stated, 'The mRNA in the vaccines does not enter the nucleus of cells and is not integrated into the human

genome. Thus, the mRNA does not cause genetic damage or affect the offspring of vaccinated individuals.'

They also said, 'All batches of Covid vaccines distributed to Australians have been tested for the presence of contaminants including residual DNA template levels.'

However, a legal case filed in the Australian Federal Court in July of this year alleges that the TGA is not the appropriate regulator of COVID mRNA vaccines because, under the Gene Technology Act (2000) definition, DNA contamination is a genetically modified organism (GMO).

The plaintiff, Victorian doctor, and pharmacist Dr. Julian Fidge, is seeking an injunction to stop Pfizer and Moderna from distributing their mRNA Covid vaccines because they never obtained a license from the Office of the Gene Technology Regulator (OGTR), which is the agency that oversees all GMO related products.

The TGA did not require tests for genotoxicity or carcinogenicity before providing provisional approval and, eventually, full registration of both the Moderna and Pfizer Covid vaccines. OGTR guidance strongly suggests such tests should be undertaken where there exists a risk of harm to human health.

McKernan, who provided expert advice on the case, agrees that the DNA contamination in the mRNA vaccines fits the Australian legal definition of a GMO. But there is also a second component of the mRNA vaccines that fits the definition.

That's the mRNA itself, which is actually modified RNA wrapped in lipid nanoparticles (LNPs). The case argues that this 'LNP-mod-RNA complex' falls under the legal definition of a GMO and that, like DNA contamination, it has the capacity to enter the cell nucleus and integrate into the human genome.

There is already at least one peer-reviewed scientific paper demonstrating that the Pfizer Covid vaccine mRNA can enter the human liver cell line and reverse transcribed into DNA in vitro (meaning in a lab dish).

Other studies cited in the case materials show the presence of spike protein mRNA in the nucleus of human cells, and evidence that acquired immune traits pass down to the offspring of mice pre-exposed to the Covid vaccine mRNA-LNP platform. This is suggestive that, once in the nucleus, the vaccine mRNA can be transferred and integrated with chromosomal DNA.

Taking both the LNP-mod-RNA complexes and the recently discovered DNA contamination present in the mRNA Covid vaccines, acting solicitor Katie Ashby Koppens says, 'Every single person who has been injected with these products has received a GMO that has not been through the expert regulatory process in this country.' She adds, 'The human genome could be changed permanently, and no one was informed.'

Now, McKernan, Dr. Buckhaults, and other scientists are calling for urgent research to test whether the DNA contamination is lingering in the cells of mRNA-vaccinated people and whether the human genome has in fact been altered by mRNA Covid vaccines.

Unvaccinated with Omicron Infection have Lowest Risk of Post-COVID Syndrome

Post-COVID or "long-COVID" syndrome is a very real and miserable condition I see in clinical practice every day. The billion dollar US HHS National Action Plan on Long COVID-19 for this condition does not take into consideration that mass genetic vaccination has loaded Spike protein into the bodies of Americans making them even more sick with symptoms of fatigue, hair loss, weakness, effort-intolerance, headaches, tinnitus, palpitations, labile blood pressure, and numbness/tingling.

Meat from Animals Vaccinated With mRNA Vaccines May Soon Make Its Way Into The US Food Supply

Shrimp have become the latest addition to a growing list of food sources targeted by mRNA gene therapy technology. An Israeli company seeking to bring mRNA vaccines to shrimp farming has [raised \\$8.25 million](#) from a group of venture capitalists to promote and improve animal health in marine species through its orally administered RNA-particle platform.

ViAqua, a biotechnology company, created an RNA-based vaccine product that uses [ribonucleic acid interference](#) (RNAi) to manipulate gene expression in shrimp. **RNAi is a biological process where RNA molecules are used to inhibit gene expression or translation by neutralizing targeted mRNA molecules.**

The vaccine comes in the form of a coated feed supplement designed to enhance resistance to white spot syndrome virus (WSSV)—a viral infection that causes an annual loss of about [\\$3 billion and a 15 percent reduction](#) in global shrimp production. ViAqua suggests RNA molecules can inhibit the expression of genes that cause disease with every meal containing its coated product.

According to a 2022 [proof-of-concept study](#), the nanovaccine was roughly 80 percent effective in a lethal WSSV challenge model and exhibited excellent in vivo safety profiles. Yet the risks of altering gene expression in shrimp and the effects of consuming vaccinated shrimp are unknown.

"Oral delivery is the holy grail of aquaculture health development due to both the impossibility of vaccinating individual shrimp and its ability to substantially bring down the operational costs of disease management while improving outcomes," said Shai Ufaz, CEO of ViAqua in a press release. "We are excited to bring this technology to market to address the need for affordable disease solutions in aquaculture."

ViAqua plans to begin production in India in 2024 and believes its technology has numerous applications in aquaculture and beyond, according to their press release.

mRNA Vaccines Are Already Used in Pigs

The aquaculture industry is not the only market being targeted with mRNA vaccines. Genvax Technologies, a startup creating mRNA vaccines for animals, in 2022 secured \$6.5 million in funding to develop a self-amplifying mRNA (saRNA) platform that allows for rapid development of a herd or flock-specific vaccine matched 100 percent to the circulating variant at the root of a disease outbreak.

Genvax's technology involves inserting a specific transgene or "gene of interest" matched to the variant strain into the platform. The saRNA then generates an antibody response without requiring the whole pathogen to be matched to the circulating strain.

In April 2022, Genvax [was awarded a \\$145,000 grant](#) by the Foundation for Food and Agriculture Research to develop an saRNA vaccine for African swine flu (ASF) in collaboration with the U.S. Department of Agriculture. ASF is a highly contagious virus with a 100 percent swine mortality rate but has never occurred in the United States.

According to a [2022 paper](#) published in eClinicalMedicine, saRNA technology uses lipid nanoparticles (LNPs) to encapsulate saRNA. When injected as a vaccine, the LNP encapsulation facilitates "endosomal uptake and release into the cytoplasm of target

cells in vivo.” This novel technology has “significant and previously untested potential” to be used in drugs and vaccines.

Genvax isn't the first company to harness mRNA technology in pigs. Merck, in 2018, [introduced SEQUIVITY](#), a “revolutionary swine vaccine platform” that uses RNA particle technology to create “customized prescription vaccines against strains of influenza A virus in swine, porcine circovirus (PCV), rotavirus and beyond.”

SEQUIVITY uses electronic gene sequencing to generate RNA particles that, when injected into an animal, provide instructions to immune cells to translate the sequence into proteins that act as antigens, similar to how the COVID-19 vaccine causes the body to generate spike proteins. **The idea is that the animal's immune system, when challenged with the actual live pathogen, will recognize the antigen and elicit an immune response.**

According to Merck, their RNA particle technology allows for the development of a “safe and flexible” custom swine flu vaccine in only eight to 12 weeks compared to traditional vaccines that take years to develop.

Although it is claimed vaccines [utilizing RNA technology](#) are safe and effective, studies appear to be scarce with little to no research to determine what effects consuming pork from vaccinated pigs may have on the human body.

mRNA Vaccines in Cattle Raise Concerns Among Producers

According to the National Cattlemen's Beef Association, mRNA vaccines are currently not [licensed for use](#) in U.S. beef cattle. The vaccines [are being developed](#) to treat and prevent diseases in cattle, whose meat could make its way to the dinner table.

Ranchers-Cattlemen Action Legal Fund United Stockgrowers of America (R-CALF USA), a national, non-profit organization with more than 5,000 members dedicated to ensuring the continued profitability and viability of the U.S. cattle industry, has [raised concerns](#) over using mRNA vaccines in cattle.

In April 2023, R-CALF USA met with medical doctors and a molecular biologist regarding the status of mRNA injections in the global protein supply chain. Veterinarian Max Thornsberry reported that some researchers have found that mRNA and its coded virus could pass to humans who have consumed dairy or meat products from an mRNA-injected animal.

Mr. Thornsberry raised concerns about the full impact and unknown long-term effects of consuming meat from animals injected with mRNA vaccines and called for more extensive research. Although the United States has not yet approved an mRNA vaccine for use in cattle, the country is increasing imports of beef from other countries that either vaccinate cattle with mRNA vaccines or plan to.

“This points to the urgent need for MCOOL (mandatory country of origin labeling),” Mr. Thonsberry said. “Consumers deserve the right to choose whether to consume beef from a country where mRNA injections are being given to cattle, and the only way they can have that choice is if Congress passes MCOOL for beef.”

R-CALF USA plans to develop a policy direction for the organization at an upcoming meeting, but “strongly reinforces the need for mandatory country of origin labeling” of beef immediately so that American consumers will know if the beef they are buying comes from a country that is using the controversial mRNA technology in their cattle.

In an op-ed posted on its website, R-CALF USA CEO Bill Bullard said the organization has been [attacked for its position](#) and accused by pharmaceutical-backed publications of “fearmongering and misinformation.”

“Iowa State University researchers submitted a multi-year [research project](#) to the U.S. Department of Agriculture to test a cattle mRNA vaccine system for bovine respiratory syncytial virus (RSV) infection,” Mr. Bullard said.

“According to the submission, researchers planned to test the mRNA on cattle during the second year of the project with a completion date of 2026. It would be naïve not to assume that such a research project signals an effort to obtain approval for mRNA injections in U.S. cattle,” he added.

Mr. Bullard encouraged others not to “simply trust the pharmaceutical companies and the government” and says his organization “intends to learn the truth by continuing to disclose differing scientific findings, seeking more research into the long-term effects of mRNA injections for cattle, and demanding more transparency from pharmaceutical companies and the government.”

Meanwhile, the organization has stated it believes people have a right to know whether the meat they consume has come from animals injected with mRNA technology. Several states have already drafted or proposed legislation seeking to require the labeling of products derived from animals administered mRNA vaccines, including [Tennessee](#), [Idaho](#), [Arizona](#), [Texas](#), and Missouri.

They Aren't Even Trying To Hide It Anymore: ‘Pandemic Emotions’ Create ‘Opportunity’ to Push Climate Fear – WEF

“But I believe we were talking a little before we started the panel that people have forgotten....”

Mahmood: *“People have forgotten.”*

Kerry: *“...that people have forgotten and don’t care.”*

“How do we keep that front and center?”

Mahmood: *“Absolutely right and we were just talking about it earlier: ‘Have people forgotten about Covid?’”*

“So I think it’s about the storytelling element.”

“I think that a lot of the things we see on health are very doom and gloom very very much, even on the climate issue, right, the extent that people feel ‘I can’t deal with this anymore ...I can’t do this.’”

“But telling, you know, really inspiring stories about what is possible if we work together.”

(Cohen). My suspicion is that Tim Huckabee used the pen name of Tim Cohen to appeal to a Jewish audience for his book *'The Antichrist and a Cup of Tea'*. The name Tim Huckabee is English or Anglo-Saxon.

Nowadays, as Chabad says, Kohan (more specifically, it's variant spelling Cohen) is the most common name in all of Israel — almost 160,000 people, as Forebears shows. That's quite the large number of descendants for people claiming to be descended from a single man, Aaron, the brother of Moses. It's even more impressive when you consider that there are an additional 145,000 people with the last name Cohen in the United States. 4. Tim never even mentions the Apostle Paul's name once in his presentations. Keep in mind, it was the Apostle Paul who mentions "Dispensations" ~ 1st Corinthians 9:17; Ephesians 1:10, 3:2; and Colossians 1:25.
5. In Tim's baptism, the messianic pastor who baptized him said Tim was a priest, or could have been a priest in the order of his heritage, i.e., the name of (Cohen). **Tim chose for himself the surname of Cohen!** The date of his baptism was June 10, 2010 with a small messianic congregation in Colorado. His baptism is recorded in a You Tube video. It is a 2-part video, the first around 7 minutes and the immersion portion by the messianic pastor is 1 minute in length. The link below is his second interview with Janie Duvall and deals with recent activities of Prince Charles since his coronation. He revealed that Klaus Schwab and Bill Gates are Knights of Prince Charles. I suspected that was so even though I had no confirmation of that fact. **Tim Huckabee (Cohen) leaves the impression to the world that he is Jewish, and begs an answer why so and for what reason. Gentiles simply do not adopt an obvious Jewish surname.**
6. **A critical point about the Apostle Paul's legitimacy in the Bible is relevant here. Recently I posted an explanation of why John included the reference to the**

153 fish being caught in John 21:11. If you link to that article, it explains and validates that Peter's ministry was to the Jews and that Paul's ministry was to the Gentiles. Link: [The Mystery of John's 153 Fish](#) God in His infinite wisdom for future readers to discover a numerical concept to convey His confirmation and validation of the Apostle Paul's ministry. This is much like when Jesus validated Daniel the Prophet in the Old Testament. I discussed this very point in Blessed Hope #199. Although it may seem insignificant at first reading, it is important in the larger context of confirming the Bible's accuracy, and particularly Paul's Epistles; and as such these what might be seen as minor details become important to the Bible as being God's Inspired Word. There are no mistakes in the meaning of the KJV Bible, only human misunderstandings and human tampering. It is fully inspired, inerrant, and infallible. Through computer analysis, it has been confirmed to be 98.2% accurate and the 1.8% does not change the meaning of the overall text. God created a 'Heptadic Design Feature' as a numerical code based upon the signature number 7.

In computer programming this is known as a parity code. Parity code is a bit that is included with the binary data to be transmitted to detect errors. The parity bit is assigned either 0 or 1 that makes the number of 1s in the message block either even or odd depending upon the type of parity. Parity bits are a simple form of error detecting code. The even or odd quality of the number of 1's or 0's in a binary code is often used to determine the integrity of data especially after transmission. All computer software incorporates a parity bit check which confirms data integrity or an error has occurred.

The Russian mathematician Ivan Panin manually discovered this signature code of 7; however it was not until we [computer programming team at the University of Pittsburgh] computerized the KJV Bible in 1963 when this HDF became fully evident and confirmed. Think of it as God's thumb print of Divine Authorship. It is not evident in other modern translations of the Bible. It would be similar to a "water mark" used by CRANES CREST to identify genuine paper for printing currency and financial documents.

The fact that Tim Huckabee (Cohen) does not believe in or recognize the Biblical teaching on a Pre-Tribulation, Pre-Millennial Rapture does not discredit the work of the first edition of *'The Antichrist and A Cup of Tea'*. Other scientists soon confirmed McKernan’s findings, though the amount of DNA contamination was variable, suggesting inconsistency of vial contents depending on batch lots. One of these scientists was cancer genomics expert Dr. Phillip Buckhaults, who is a proponent of the mRNA platform and has received the Pfizer Covid vaccine himself.
