The Future is There Will be No Future with the WEF!

With an ominous call for increased global collaboration and centralization, European Commission President, Ursula von der Leyen at a G20 Summit session, dubbed “One Future,” today appealed for an international regulatory body for Artificial Intelligence and digital ID systems similar to coronavirus vaccine passports.

Von der Leyen audaciously proclaimed our collective future to be digital, hence the implied necessity for global entities to draw boundaries and enforce regulations. She is a child of Nazi parents as is Klaus Schwab, head of the WEF.

Von der Leyen, in her position as the EU Commission President, touched on AI and the digital landscape in her address. She acknowledged the potential dangers and gargantuan opportunities linked with advancing AI technology and emphasized the importance of channeling such explosive technology.

“Today I want to focus on AI and digital infrastructure. As it has been described, AI has risks but also offers tremendous opportunities. The crucial question is how to harness a rapidly changing technology.”

“In the EU, in 2020, we presented the first-ever law on artificial intelligence. We want to facilitate innovation while building trust. But we need more. What the world does now will shape our future. I believe that Europe — and its partners — should develop a new global framework for AI risks,” von der Leyen said.

Von der Leyen praised the European Union’s move in 2020 to introduce the first legal framework on AI, a step taken with the intent of fostering innovation alongside trust. However, she insisted that this wasn’t sufficient. She suggested a multinational adoption of a coping mechanism for managing AI risks.

The EU Chief also stressed that globally accepted standards must be created under the purview of the United Nations, akin to their Intergovernmental Panel on

Climate Change. Humanity stood to benefit, she argued, if an international authority could clarify the risks and rewards related to AI, akin to the IPCC for climate concerns.

Concurrently, von der Leyen championed the concept of digital public infrastructure similar to the coronavirus passport system – a system developed by the EU as a response to the Covid saga. The World Health Organization embraced it with open arms as a global standard for combating health threats.

“Many of you are familiar with the COVID-19 digital certificate. The EU developed it for itself. The model was so functional and so trusted that 51 countries on 4 continents adopted it for free. Today, the WHO uses it as a global standard to facilitate mobility in times of health threats,” von der Leyen continued.

Alarmingly, von der Leyen praised the EU’s strides towards a bloc-wide digital identity app capable of storing a citizen’s personal information, including credit cards, driver’s license, and passport data.

These developments ring alarm bells for individuals and nations valuing free speech and privacy.

Think about how that will change your life. But first a little background if you are not familiar with personal ID technology.

If you look in your refrigerator or pantry closet, you'll find that just about every package you see has a unique UPC code or Universal Product Code. In fact, all items sold by major retailers, including grocery stores, department stores and online retailers have Universal Product Codes.

But where do these UPC codes come from and what do they mean?

What Is a UPC Code and a Bar Code?

It's first helpful to start out defining bar code. A bar code is made up of bars and spaces of varying width found on packages of products sold everywhere. Bar codes are read by optical bar code scanners at stores. The most common bar code is the UPC code (aka UPC-A).

UPC codes were originally created in the early 1970s to identify products and help grocery stores speed up the checkout process and keep better track of inventory, but the UPC code system caught on quickly in other retail areas because it was so successful. The first UPC code appeared on a pack of Wrigley's gum sold in in Troy, Ohio, in June 1974. I am going to explain this as if you want to sell a product you have made.

A UPC code is a bar code symbol with a 12-digit number called a GTIN-12. GTIN stands for Global Trade Item Number and it is the UPC data derived from the

Uniform Code Council (UCC), a nonprofit organization that represents the market for supply chain codes.

The GTIN-12 number is the UPC data that comes from a UPC Company Prefix and Item Reference Numbers (more on that below). The most common type for retail stores is the UPC-A, which is for products sold at a retail point of sale. Today all retail products have their own unique UPC code.

UPC codes are most commonly used for retailers in the United States, while the European Article Number code or EAN code is used internationally. Today, though, most places will accept both UPC codes and EAN codes.

How Bar Codes Work

Bar codes use patterns of lines, squares, hexagons, dots and other shapes to encode data. Bar codes are technical, but they're not that hard to understand when you break the process down in a few steps.

A bar code has tons of information about an individual product, including its weight, price, manufacture date, product ID and more. This data is generated by a bar code website (more on that below).

Bar code zymology is the process of encoding that data into a bar code. The parallel lines of a bar code symbolize a language of letters and numbers.

Data stored on the bar codes can be scanned in a few ways, including using a bar code scanner at a grocery store, or a cell-phone camera. The scanner picks up the code and all the data included and translates the code into text.

What Is a UPC Company Prefix?

One of the most important parts of the UPC code data is the UPC company prefix. Its sole purpose is to assign the company a unique code for identification.

A UPC company prefix is a unique six to nine digit number assigned by GS1US to a company. Companies with a large numbers of items and UPC needs get a UPC company prefix with fewer digits to allow for more product identification assignments.

UPC codes include the UPC company prefix, the item reference number and the check digit number. Companies purchase UPC codes for products they sell in retail stores and online. [GS1US]

UPC codes are not free. As mentioned, GS1US assigns them so it's best to register directly with the nonprofit. There are third-party resellers where companies can buy UPC codes in bulk, but it breaks the chain of authority, so it's best to register in the GS1US database. Here's how to do that.

Buying UPC Codes UPC code



In the illustration above note three sets of bars extend lower than the rest. These are known as “guard bars”. This is where the infamous “666” came about. They are slightly a smidge different than the two lines above the number 6 in the picture here. When the cashier scans the particular item, those three “guard bars” determine the computer to “start and stop” the scan phase. The number 6 was chosen by IBM engineer George Lauer simply because it can be read upside down as well as right side up. The computer does the rest! Determine how many UPC codes you need. You need to purchase UPC codes for each individual product. For example, if you're selling a T-shirt that comes in three sizes (small, medium and large) and three colors (red, white and blue), you'll need nine UPC codes. This is a mathematical factor of 3-squared.

Buy UPC codes. As suggested, register with GS1US for your UPC codes to ensure they work properly and to keep the chain of authority intact.

The pricing plan you pay depends on the provider and the number of bar codes you need. For example, a small business might need just one UPC, while a large seller on Amazon Marketplace will require multiple Amazon UPC codes. Some UPC providers might charge an initial fee and then an annual renewal fee later.

When Timothy Cohen published *'The Antichrist and A Cup of Tea'* in 1998, it was without a UPC Code. He would not permit it to have a UPC Code placed on the cover of his book in the publishing process. Retailers who resell it like Amazon had to use their own UPC Code for it to be sold through retail book stores.

Get your UPC codes. Be sure to view your product's UPC before you download it. Once you know it has the correct information from the provider site, you can download it.

UPC Codes for Amazon

Amazon uses bar codes to identify and track inventory through the fulfillment process. That means sellers on the Amazon marketplace must have a product code on all items they are selling online.

But Amazon uses three kinds of bar codes for this purpose:

- **Manufacturer bar codes, including Universal Product Codes**
- **Amazon bar codes**
- **Transparency authenticity codes (brand owner only)**

Amazon uses the UPC to track inventory. When more than one seller has inventory with the same UPC code, Amazon fills orders that are closest to the customer for faster delivery.

When products don't have UPC codes, they must have Amazon UPC codes. Sellers can print Amazon bar codes from their seller accounts and affix the bar codes to their packages. The UPC codes were one-dimensional and this led later to the QR codes in use more and more.

You can find UPC codes on practically every product on the shelves. Like all bar codes, UPC codes provide anyone with a bar code scanner instantaneous access to the data that a bar code contains.

Like all of the first bar code formats, UPC codes were 1D, meaning they only carried information in one direction. Those worked fine for carrying small amounts of data like numeric product codes, but the need for a bar code capable of carrying more data became apparent.

That's where 2D bar codes, or QR codes, come in the picture today. But how do QR codes work?

The Transition to Stacked and 2D Bar Codes

One solution still used today is the stacked bar code, which, as the name implies, contain a number of 1D codes piled one on top of another. Although stacked bar codes can accommodate more information than their traditional 1D counter-parts, they can quickly grow very large in order to store more data and can be difficult to read.

In order to have a bar code that was small in size, easy to read and capable of holding both a large amount of data and a large variety of character types, the market called for a new approach.

Enter: 2D bar codes.

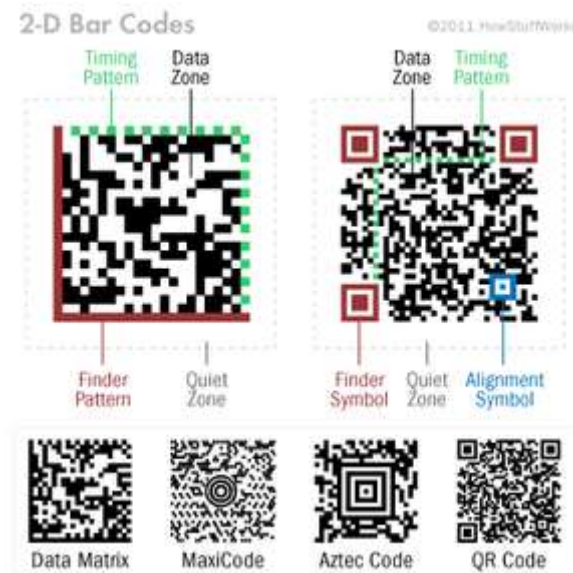
As you might have guessed, 2D bar codes (sometimes called matrix codes) carry information in two directions: vertically and horizontally.

2D bar codes are capable of holding tens and even hundreds of times as much information as the 1D bar codes. For instance, one of the most popular 2D bar code formats, Denso Wave's QR Code, can hold more than 7,000 digits or 4,000 characters of text, whereas even the most complex 1D codes top out around 20 characters.

Still, 2D codes aren't perfect for every application. Because they're more complex than 1D codes, they require more powerful scanners to decode.

What's more, some people are simply unfamiliar with the technology, which slowed widespread adoption. But thanks to the smartphone in your pocket, that is quickly changing.

The Adoption Challenge: UPC Codes vs. 2D Bar Codes

When the now-ubiquitous UPC code first started making waves in the 1970s, retailers everywhere immediately recognized its potential. Unfortunately, the technology faced something of a catch-22.

Retailers refused to buy the expensive scanners needed to read the codes until manufacturers began putting UPC codes on all of their products. Manufacturers meanwhile stonewalled on adopting them until they knew retailers could read the

codes. Eventually, large retailers like Kmart jumped in to kick-start the technology. Walmart and the Department of Defense then moved the market place for everyone else.

Fortunately for proponents of 2D bar codes, we buy millions of scanners every year in the form of our smartphones. The iPhone and Android each comes with a built in QR Code scanner, helping to clear perhaps the largest hurdle to widespread adoption.

Decoding QR Code Technology

But how does a smartphone — or any bar code scanner, for that matter — actually make sense of the seemingly unintelligible patterns of lines and squares that 2D bar codes contain? Part of the answer lies in the bar code itself, which is designed to make the scanning process as accurate and speedy as possible.

Alignment and Data

Every QR Code contains a finder pattern: an arrangement of squares that helps the QR scanner detect the size of the QR Code, the direction it's facing and even the angle at which the code is being scanned.

Next, every QR Code contains an alignment pattern, which is another pattern of squares designed to help a QR reader determine if the 2D bar code is distorted (perhaps it's placed on a round surface, for instance).

Once the smartphone's camera processes the code's image, the software goes to work analyzing the image. By calculating the ratio between the black and white areas of the QR Code image, it can quickly identify which squares are part of the alignment patterns and which squares contain actual data.

Allowing for Imperfection

Of course, QR Code scanning has a margin for error. Even if part of the pattern is smudged or obscured, you can still scan QR Codes with a QR Code reader.

Using built-in patterns and error correction of the QR Code system, the software can also compensate for any distortion or obscured areas of the bar code. After the software has digitally "reconstructed" the QR Code, it examines the jumble of black and white squares in the QR Code's data section and outputs the data contained within.

How to Create QR Codes

You can make your own 2D bar code using QR Code generators online. They let you generate QR codes and adjust everything from the format you want to use to the size of the code.

I have read of some really neat ways to use for your own needs the QR code system.

So the next time you're putting up a flyer for your local garage sale, consider using a QR Code generator to add a code with the sale details. Who knows how many smartphone-carrying bargain hunters you might attract? Some of you may be familiar with the Kentucky-127 largest yard sale event. Every August there is a 4 day yard sale on U.S. route 127, it covers six states and 690 miles. It is known as the largest yard sale in the country. It's a big deal and I know of many vendors who use the QR system to attract potential buyers.

Scan Smart

On the flip side, you don't want to accidentally scan a malicious QR Code created to steal data stored on your device. Certain apps and scanners will check to make sure you're only able to open legitimate QR Codes, providing a comforting level of added security.

Variety in 2D Bar Codes

The QR Code is only one example of a 2D bar code. The shipping company UPS uses a format called MaxiCode, which workers scan quickly as packages fly down the conveyor belt, whereas the U.S. Department of Defense has adopted DataMatrix — a 2D bar code capable of holding a lot of information in a very small area.

Regardless of the format, 2D bar codes contain both data and built-in patterns to help the scanner decode the information each bar code contains. In many cases, one device can read a variety of different formats, even traditional 1D bar codes.

2D Bar Code Advertising

If you can think of a way to sell a product, it's probably been done.

Blimps with giant company logos, televisions inside taxis that stream ads to passengers and even advertisements printed in edible ink on food — nothing is off-limits from advertisers. But even they have long faced a difficult challenge as they try to determine the effectiveness of their physical ads.

That all changed with 2D bar codes. For the first time, companies could simply add a 2D bar code to their advertisement and directly track how many times consumers scanned the code. If someone scans it, the advertisers can track whether that person then visits the company's website or purchases a particular product.

Real-World Applications

The fashion company Tommy Bahama added a 2D bar code into *'Esquire Magazine'* that, when scanned, took readers directly to a web page featuring the pair of sunglasses shown in the magazine ad. With one click of their mouse (or tap on their smartphone screens), readers could then buy the sunglasses for a cool \$138.

Target has also explored the capabilities of 2D bar codes by adding dynamic QR codes to its magazine advertisements. When curious readers scan a QR code, Target serves them a video from a famous interior designer explaining how to use the product. You can see the benefits of reaching potential customers.

Future of 2D Bar Codes in Advertising

Advertisers say this level of interactivity is perfect for a new generation of tech-savvy consumers who want instantaneous access to product information, reviews and more. The codes have become such a popular way to advertise in Japan, they're even found on billboards where they can be scanned at highway speeds from a passing car.

Currently, the codes aren't quite as popular in the United States as they are in Japan, so data on just how many advertisers are using them and what sort of results they get is hard to come by. Still, as more people purchase smartphones and learn about the capabilities of scanning QR Codes, 2D bar codes may take off much like their 1D predecessors. China leads the way in this technology.

Crop Circles to Crop Bar Codes?

For years, people wondered if the mysterious crop circles popping up all over the world were the work of mischievous extraterrestrials. In truth, the 160-square-meter (1,700-square-foot) pattern that appeared in a wheat field in 2007 was the work of an earthling named Ben Hopfeng-Aertner. Hopfeng-Aertner, a German programmer interested in 2D bar code symbology, spent several months stamping out a 2D bar code into the wheat field. When finished, the code was large enough to read from space. So, what did the code say? *"Hello, World!"* of course.

In recent years with the advancement in Directed Energy Weapons, it has been my thoughts the crop circles were not supernatural, but a psychological operation (PsyOp) hoax perpetrated by UK scientists. These crop circles were most commonly found in the fields of southern England. The use of EMFs (electromagnetic frequencies) is one of our elite controller's most effective stealth technologies.

Can We Stop Cell Phone Tower Construction?

Although thought to be legislation about deregulation issues, the Telecommunications Act of 1996 (TCA) was really an open invitation for the cell phone industry to place their towers anywhere they wanted.

Section 704 of the TCA basically states that local authorities can't ban the placement of towers in their jurisdictions.

The law says:

"No State or local government or instrumentality thereof may regulate the placement, construction, and modification of personal wireless service facilities on the basis of the environmental effects of radio frequency emissions to the extent that such facilities comply with the Commission's regulations concerning such emissions."

So legally the local government can't refuse the construction of a cell phone tower in your neighborhood!

Simply type in your address and you'll get a listing and a map of all the towers and antennas within a short radius of your address. Like most people you'll probably gasp when you see the numbers. These towers are literally everywhere.

Hundreds and hundreds of them are probably located within a few miles of your home or office.

What Can We Do?

Throughout history, people have recorded the passage of time in many ways, such as using sunrise and sunset and the phases of the moon. Clocks evolved from sundials and water wheels to more accurate pendulums and quartz crystals. Nowadays when we need to know the current time, we look at our wristwatch or the digital clock on our computer or phone.

The digital clocks on our computers and phones get their time from atomic clocks, including the ones developed and operated by the National Institute of Standards and Technology (NIST).

A cloud of strontium atoms inside an optical lattice atomic clock at JILA, which is jointly operated by NIST and the University of Colorado Boulder. So stable and accurate that it would not gain or lose a second in 15 billion years, longer than the current life age of the universe, the strontium-powered clock is among the leading contenders for replacing today's cesium-powered atomic clock standards and redefining the second.

The official sources of time currently rely on cesium atoms. The best of these clocks is accurate to within one three hundred millionths of a second per year. For perspective, your quartz wristwatch may be accurate to within about 15 seconds per month.

Inside these clocks, electromagnetic waves are aimed at a collection of cesium atoms that absorb this radiation and make a “quantum jump” to a different energy state. But this jump only happens when the atoms absorb waves of a precise frequency — the number of wave cycles per second. Operators of atomic clocks know they’ve tuned their clock to the exact right, or “resonance,” frequency when they detect a maximum number of atoms jumping to the different energy state.

I could share a lot more but from what I have stated you can see the importance of Cesium-137 in **5G** technology. Think of it as the “heart” of electronic communications. We are dependent upon all this modern technology but ignorant of its harm. Cesium-137 is a radioactive isotope and can cause cancer. 'CHINA'S WORLD BANK' PLANS TO TRIPLE CLIMATE CHANGE LENDING BY 2030

The Asian Infrastructure Investment Bank (AIIB) has launched its inaugural Climate Action Plan. AIIB has set ambitious targets, committing to allocate at least 50 percent of its annual financing approvals as climate finance by 2025. The Bank stated that the battle against climate change will be decided in Asia, *"an engine of global economic growth facing heightened vulnerability to climate hazards"*.

POPE FRANCIS OPENS POSSIBILITY FOR BLESSING SAME-SEX UNIONS

Pope Francis suggested it may be possible to bless same-sex unions in a newly public response to the cardinals who questioned the pope's affirmation of the [LGBTQ](#) community in [the Catholic Church](#).

In the July letter, which is written in Spanish, he reaffirmed that *"the Church has a very clear understanding of marriage: an exclusive, stable, and indissoluble union between a man and a woman, naturally open to procreation,"* according to [the Vatican News](#).

However, he advocated for "pastoral charity."

"The defense of objective truth is not the only expression of this charity; it also includes kindness, patience, understanding, tenderness and encouragement. Therefore, we cannot be judges who only deny, reject and exclude," he said, according to Vatican News. He added that *"pastoral prudence must adequately discern whether there are forms of blessing, requested by one or more persons, that do not convey a mistaken concept of marriage."*

POPE SAYS A REVISED ENVIRONMENTAL ENCYCLICAL WILL BE RELEASED OCT. 4, FEAST OF ST. FRANCIS OF ASSISI

After nearly two years since the beginning of the 7 sector, 7 year covenant which began in January 2022, Pope Francis is planning to release an update to his landmark 2015 environmental encyclical on Oct. 4, 2023. as he called for an end to the *"senseless war against our common home."*

Francis recently revealed he was writing a *"second part"* to the document *"to address current problems."* The Vatican spokesman said the update would take into account in particular recent climate crises.

Citing the deforestation of the Amazon, the melting of Arctic glaciers and the deaths of coral reefs, Francis rebuked “*obstructionist*” climate doubters and accused politicians of listening more to oil industry interests than Scripture, common sense or the cries of the poor.

The encyclical has inspired ecological movements around the world, been cited by presidents and patriarchs, and in many ways has formed the bedrock of Francis' 10-year papacy, which has prioritized the poor and marginalized.

It was initially released ahead of the Paris climate talks in 2015, and the update is being released ahead of the next U.N. COP28 later this year in Dubai before the agreement is strengthened at the global Stocktake.

“Let us unite with our Christian brothers and sisters in the commitment to care for creation as a sacred gift of the creator,” Francis said Wednesday. *“We must side with the victims of environmental and climate injustice, working to put an end to the senseless war against our common home.”*

He calls for “*prophetic actions*” and “*drastic measures*” to achieve zero net greenhouse gas emissions and limit global warming.

COP28 updates their principles to 2030, promoting sustainable behaviors. In other words, they want to transform the behaviors of all 8 billion people on planet Earth. October 4th is going to be an interesting day with the Pope's declaration on Climate Change, so pay close attention to what he says. Well, neither the CDC nor the manufacturer know. An August 30th BioNTech press release on the EU's authorization of Pfizer and BioNTech's "XBB.1.5-adapted" COVID-19 vaccine includes the following paragraph in the 'Important Safety Information' section.

EBS AFTER THOUGHTS

The federal government conducted a nationwide test of its Wireless Emergency Alerts (WEA) system on Wednesday afternoon, sending messages to all cellphones, televisions and radios.

The Federal Emergency Management Agency said the test went well, reaching all cell carriers that participate in WEA and the signal was processed and sent to broadcasters.

FEMA and the Federal Communications Commission are running the test to prepare for actual emergencies. The aim is to ensure the emergency messaging system is running smoothly in the event Americans are threatened by natural disasters, terrorism or other dangers to public safety.

You may be familiar with the jolting sounds accompanying National Weather Service alerts and AMBER (America's Missing: Broadcast Emergency Response) alerts. Wednesday's cellphone alerts were sent via the same wireless system.

When was the test?

The test was scheduled to begin at about 2:20 p.m. ET on Wednesday, although many people received it two minutes early.

The testing window ran for 30 minutes, and you should have received only one message. If an actual emergency had happened on Wednesday, the test would have been postponed with a backup scheduled for next week.

FEMA is required by law to conduct national tests of the Integrated Public Alert & Warning System (IPAWS) at least once every three years. The last national test was in 2021.

What did the test message look like?

On cellphones, the alert read:

"THIS IS A TEST of the National Wireless Emergency Alert System. No action is needed." Phones set to Spanish displayed: "ESTA ES UNA PRUEBA del Sistema Nacional de Alerta de Emergencia. No se necesita acción."

TV and radio announced:

"This is a nationwide test of the Emergency Alert System, issued by the Federal Emergency Management Agency, covering the United States from 14:20 to 14:50 hours ET. This is only a test. No action is required by the public."

How did it go over?

Most people posting to social media seemed underwhelmed by the short, blaring alert after lots of online hype. Some were jarred by it coming two minutes before the scheduled time of 2:20 p.m. But for many, the prevailing sentiment was *"nothing really happened."*

What happens next?

FEMA will now conduct a survey on the WEA portion of the test to gauge its geographic reach. The results will help FEMA, the Federal Communications Commission and public safety officials enhance and expand the system.

Final determination of how far the test reached will be done by FEMA and the FCC and results could take about four months.

All of the above is the official content provided the public through NPR or National Public Radio.
