Biden extends 9/11 state of emergency by a year

The United States will continue in a decade’s long, post-9/11 state of emergency for at least another year. In a Thursday night [declaration](#), President Joe Biden ensured the emergency will extend at least 23 years after coordinated attacks killed nearly 3,000 people in New York, Virginia and Pennsylvania. Biden penned his signature to a one-year extension of President George W. Bush’s [Proclamation 7463](#), retaining broad powers over the organization of the military. The proclamation is officially titled “*The National Emergency with Respect to Certain Terrorist Attacks*.” Most emergencies are used to impose economic sanctions. **But Proclamation 7463, along with the broad 2001 Authorization for Use of Military Force, gives the president the power to call up the National Guard, alter the size and shape of the military's top officers and hire or fire commissioned officers — even ordering them out of retirement if necessary.** Biden has most recently [cited the 2001 authorization](#) to justify drone strikes against [al-Shabab militants](#) in Somalia in 2021. The National Emergencies Act, adopted in 1976, requires presidents to renew emergencies each year. Presidents Barack Obama and Donald Trump also extended the 9/11 state of emergency each year of their respective tenures. Trump used it in 2017 to fill a chronic shortage in Air Force pilots. So far, Biden has declared eight new emergencies, continued 34 from his predecessors and ended three.

The FDA is now fast-tracking new drug approvals — why that's so worrying

ALARMING!

The Food and Drug Administration is now regularly approving new drugs after just one or two clinical trials — a significant departure from the more rigorous vetting process the agency was previously known for, newly published research reveals. Furthermore, the authors say, there's now less information available to the public about the results of all trials. Of the 37 drugs [approved by the FDA](#) last year, 24 (about 65%) were approved based on just one study, according to a paper [published in JAMA Network Open](#). Only four of those 37 drugs, or about 11%, reported three or more studies before approval. Another piece of new research, published in [Health Affairs Scholar](#), found that of the 46 new drugs approved in 2017, 19 of them (41%) were approved based on a single study — though the drug makers conducted an average of 2.2 studies per drug, including 165 studies for the popular weight-loss drug Ozempic. The ease with which novel drugs are approved is in part the result of the [21st Century Cures Act](#), passed in 2016 to speed the approval of new medicines so patients could gain access to life-saving treatments. As part of that law, the FDA relaxed some standards to allow treatments for priority health conditions such as cancer to be approved with fewer supporting studies, and with less emphasis on randomized clinical trials. But in the years following the passage of the 21st Century Cures Act, the FDA has faced a firestorm of criticism over the approval process for some new drugs.

The word “Israel” was first presented in the Bible as a name given to Jacob after he fought an angel. Its meaning was a man who has struggled with God. And is commonly translated as “*God Prevails*” or “*Man seeing God*”. Many have argued that the word Israel in the Bible does not refer to a place, but rather a believer or a group of believers in God.

Others believe the land known as Palestine was where the Biblical state of Israel once stood. And in the 17th century, Sabbatai Zevi was the first Jew to try and re-settle there.

Sabbatai Zevi claimed to be the Messiah and amassed a large Jewish following that engaged in ritual sex orgies and the defilement of God's law. In the spring of 1666, they were planning to be the first Jewish settlement in Palestine. But things changed when Sabbatai was arrested and thrown in jail. His radical movement continued with the Frankism movement, and Zionism became more political.

Although they claimed to be secular, the Zionists flooded the temples with prayers for a return to Zion and a restoration of the Jewish state. But the rabbis rejected them. In

1885 the rabbis wrote that *"we consider ourselves no longer a nation, but a religious community; and we therefore expect neither a return to Palestine, nor a sacrificial worship under the sons of Aaron, nor the restoration of any of the laws"*

While the rabbis offered no support, the Zionists garnered the support of the British Crown as early as 1841. And they were funded by the Rothschild banking dynasty, otherwise known as the Bank of England, so the Crown was likely involved from the start.

In 1897, the political intent to re-create the state of Israel was made official to the public. And in 1917, under the British government's Balfour Declaration, British troops seized control of Palestine on behalf of the Zionists. [Gifted to the Rothschild's – Pastor Bob's comments added at the end of the post.]

In 1922, the League of Nations adopted the declaration. And in 1947, the United Nations granted parts of Palestine to the Zionists.

Between 1947 and 1949, Palestinians were made refugees and kicked out of the homes of their ancestors. Hundreds of villages were destroyed, and thousands of Palestinians were murdered in a series of massacres known as the Nakba. The Zionists killed Palestinian Muslims, Christians, and Jews.

The Zionists claimed to be non-religious but they were mostly Ashkenazi Jews. The Ashkenazi can be traced back to the Khazars; the progenitors of Rabbinic Judaism.

The Khazar Khaganate was a major empire in what is now Ukraine, Georgia, Armenia, Azerbaijan, and parts of Russia, Turkey, and Iran. It was ruled by the Khazars but made up of several diverse nomadic tribes.

In the year 740 the Khazars mass converted to Judaism. Synagogues and schools were built and Rabbinic Judaism was born. The original Jerusalem Talmud was replaced by the recently codified Babylonian Talmud. Which was based on Babylonian philosophy and became the mainstream thanks to the Khazars and the Zionists.

The Gregg Reese Report is fairly succinct for the reader, aside from a few minor points. More than a century ago, in 1915, a senior lecturer in biochemistry at the University of Manchester named Dr. Chaim Weizmann invented a fermentation process that converted starch — a poly-sugar readily available from corn and potatoes — into acetone and butyl alcohol, facilitated by a bacteria, *Clostridium acetobutylicum*, that Dr. Weizmann had previously isolated.

This novel method of acetone production became known as "the Weizmann process." As serendipity would have it, acetone was a key component in the production of the smokeless gunpowder (cordite) used by the Allies in World War I. Acetone had previously been made from calcium acetate imported from Germany, but since the Allies were at war with Germany, this was no longer possible, and the U.S. had a sparse supply. So, Winston Churchill, then First Lord of the Admiralty, requested that the "Weizmann process" be used to mass produce acetone in England, Canada, and the U.S.

The rapid wartime expansion of this process, from laboratory to industrial scale, was not only unusual among microbiological processes used in industry, but it also set a precedent for the rapid expansion of penicillin production during World War II and for the wide scope of applied biotechnological processes that came afterward.

The UNDP’s guidance builds upon 9 core factors: legal and regulatory frameworks, non-discrimination, access to information, legal accountability, capable institutions, user value, procurement and anti-corruption, and data protections.

Their framework from their website is as follows:

A robust digital public infrastructure (DPI) has become increasingly crucial for governments, especially when it comes to delivering large-scale, effective public services. For the public sector, the debate isn’t about whether to adopt digital technologies but which ones to embrace and how to ensure their seamless and effective integration. This is particularly true when it comes to digital legal ID, a foundational digital public infrastructure that has the potential to catalyze digital transformation and development opportunities across countries.

Technology and governance must progress in tandem

DPI is made up of digital building blocks, laying the foundation for subsequent innovations. For example, these building blocks may include digital legal ID or digital payment systems that unlock new solutions such as mobile financial services. But like roads and bridges, overhauling an established infrastructure can be daunting. Therefore, it’s imperative to be intentional and meticulous from the outset.

The digital standards, regulations and privacy protocols instituted initially will have implications, for instance for government-related e-services and even business ventures. While the technological facets of digital legal ID are often in the spotlight, effective implementation demands robust governance. This ensures inclusion, safety and the preservation of rights.

Ensuring rights-based and inclusive governance of digital legal ID systems is crucial for their alignment with the public good. In essence, the regulations and standards set the ‘rules of the road.’ They guide decision-makers on the most suitable technologies for public service delivery, instill confidence in the private sector to invest and innovate and foster trust among the end users in the systems and technologies.

Modelling a governance framework

The United Nations Development Programme (UNDP) frequently receives requests for legal, regulatory and institutional support, particularly within the scope of the organization's legal ID programming. A recent surge in requests mirrors a growing awareness among Member States of the importance of adopting participatory, rights-based approaches to legislative and policy aspects of digital legal ID design and implementation.

Acknowledging the burgeoning potential and significance of digital legal ID, UNDP has taken the initiative to draft a model governance framework. This blueprint is designed to aid the swift establishment of digital legal ID systems globally.

At its core, this framework is intended to outline a normative model of the laws, policies and institutional arrangements that can help ensure the governance of digital legal ID systems is both inclusive and respectful of individual rights. It is informed by UNDP's [governance](#) and [digital strategies](#), which emphasize a rights-based and whole-of-society approach. The framework, for instance, recognizes the importance of civil society's role in accountability, recourse and oversight. It also builds on long-standing experience and lessons from within [the UN System on legal identity](#) and the whole legal identity management ecosystem, which is based on civil registration.

Framework elements

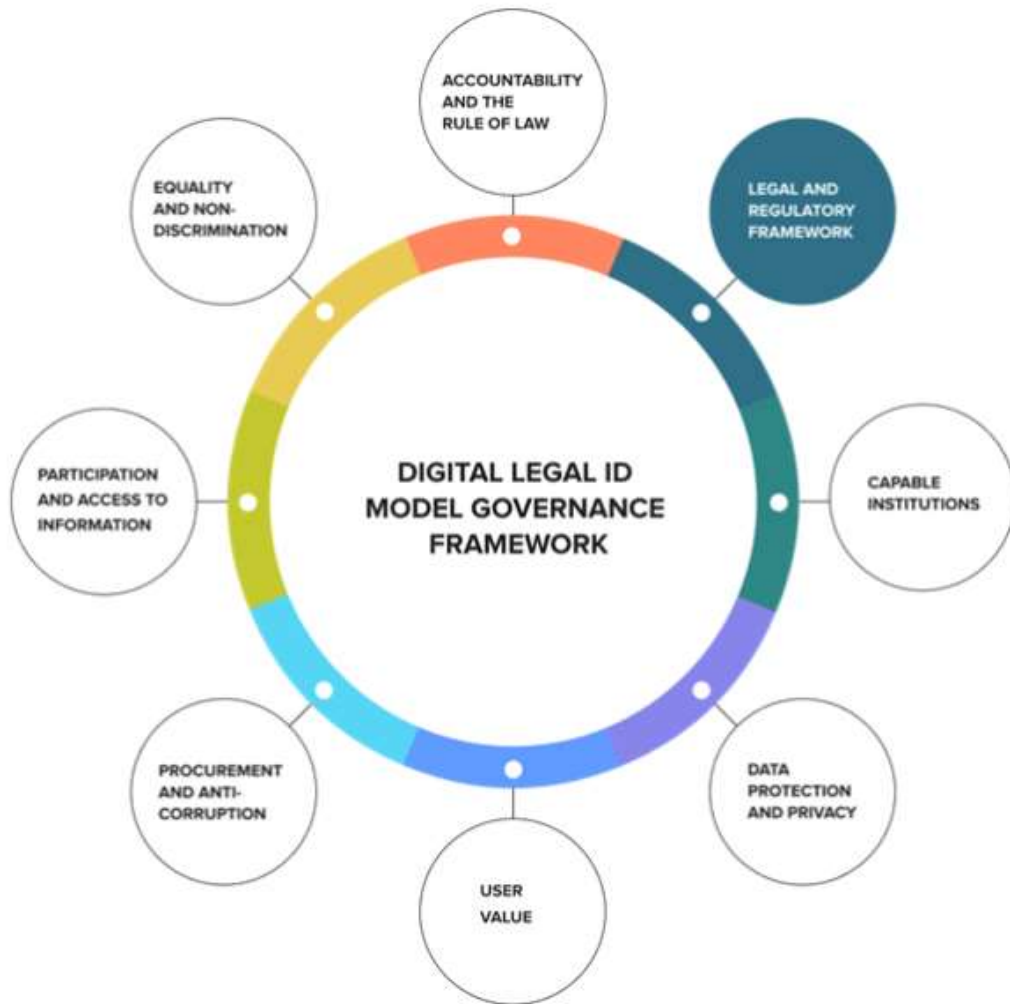
The importance of legal identity is an integral part of Agenda 2030 and the Sustainable Development Goals (SDGs). SDG Target 16.9, which aims to "provide legal identity for all, including birth registration," underscores the widespread significance of civil registration in societies globally.

However, without effective governance, digital legal ID systems risk perpetuating, and potentially exacerbating, the challenges seen in previous identity systems. The governance framework can serve as a reference point, from which government partners can develop their own iterations, adapting it to meet their needs based on their own contexts and circumstances.

Getting it right

For countries already implementing DPI, digital ID has been a powerful force for improving public service delivery and driving economic opportunities. Given its overarching role, proper governance of digital legal ID is paramount. Such governance ensures that stakeholders, who depend on and use these systems, are both cognizant of the rules and committed to adhering to them. 'Good' governance mechanisms not only ensure accountability for shared infrastructure but also streamline decision-making on resource allocation for developing and upholding crucial government systems.

Finally, setting unequivocal standards for digital identity systems becomes indispensable if these systems are to align with developmental ambitions and uphold principles of human rights, inclusion and protection.



This framework builds off a [report that was published by the UN in June](#), called “Our Common Agenda that discussed “the vision for the future,” which involves linking digital IDs to banking. The UN says the implementation of digital IDs will also help to fulfil the broader goal of SDG1, No Poverty.

A spokesperson for the Department of Health and Human Services (HHS) said in an email:

COVID-19 vaccine distribution, which has shifted to the private market, is a lot different than it was last year when the government was distributing them. The Biden-Harris Administration, through HHS, has been working directly with manufacturers and distributors to ensure that the vaccines are getting to pharmacies, hospitals, clinics, pediatricians, and other vaccination sites, including long-term care facilities.

As a result, more than 7 million Americans have received their updated COVID vaccine in September, and 91% of Americans 12 years and older can access the vaccine within 5 miles of where they live. Just as we did last vaccine season, we will be working to reach Americans where they are and inform them of the updated vaccines and where they can get them.

Almost 14 million vaccines have shipped to pharmacies and other locations, with 91% of Americans 12 years and older living within 5-miles of a vaccination site.

As we head into the fall and winter season, we will be encouraging Americans, particularly older adults, to get their COVID-19 vaccine in addition to their annual flu shot, the RSV vaccine for people over 60 and pregnant people during 32 and 36 weeks of pregnancy, as well as an RSV immunization for infants younger than 8 months.

According to an Epoch Times report, government data says nearly 56.5 million people, or 17% of the population, received one of the bivalent vaccines.

According to USA Facts, as of October of 2022, 34% of Americans got the third dose, or the first round of booster shots. The data stopped being published after that. 70% reportedly took at least two does, and 81% got at least one.

In a recent financial statement, Pfizer, the pharmaceutical giant and producers of one of the mRNA Covid-19 vaccines, lowered their financial outlook for the remainder of the fiscal year, citing lower vaccination uptick and less reliance on other Covid treatments.

Pfizer also announced that it now anticipates full-year 2023 revenues to be in the range of \$58.0 to \$61.0 billion, versus its previous guidance range of \$67.0 to \$70.0 billion solely due to its COVID products.

Full-year 2023 revenues for Paxlovid and Comirnaty are expected to be approximately \$12.5 billion, a decline of \$9.0 billion versus original expectations.

The company is reducing its full-year 2023 revenue expectations for Paxlovid by approximately \$7.0 billion which includes a non-cash \$4.2 billion revenue reversal for the return of the 7.9 million treatment courses of EUA-labeled U.S. government inventory, as well as the delayed commercialization to January 2024 versus our previous expectation of commercialization in the second half of 2023.

The company is also reducing its full-year 2023 revenue expectations for Comirnaty by approximately \$2.0 billion due to lower-than-expected vaccination rates.

94% of UK Covid Deaths Are Fully Vaxxed, Study Shows

A new study based on official government data has revealed that 94% of Covid deaths were among patients who were fully vaccinated for the virus.

The study was based on data from the British government's Office for National Statistics (ONS).

The ONS recently published an update on deaths by vaccination status in England.

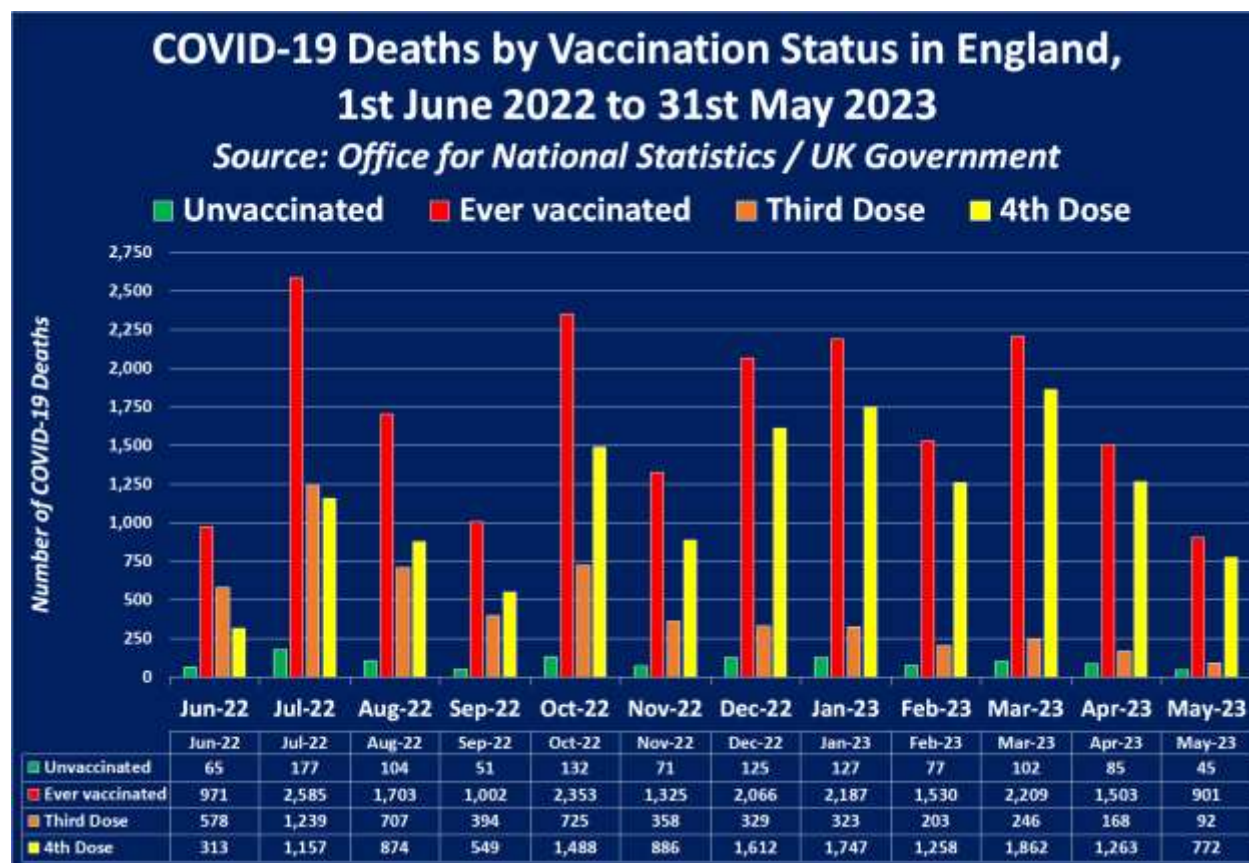
The data has shockingly revealed that the vaccinated population accounted for 95% of COVID-19 deaths in the 12 months between June 1, 2022, and May 31, 2023.

94% of those deaths were among the fully vaccinated – either the triple or quadruple-vaccinated – population.

The dataset was published recently by the UK Government and it can be found on the ONS website [here](#), or downloaded [here](#).

The dataset includes deaths by vaccination status between 1st April 2021 and 31st May 2023.

But because we have extensively looked at deaths up to the end of 2022 in previously published datasets we decided to take a look at Covid-19 deaths by vaccination status over a full year up to 31st May 2023, and the following chart shows what we discovered.

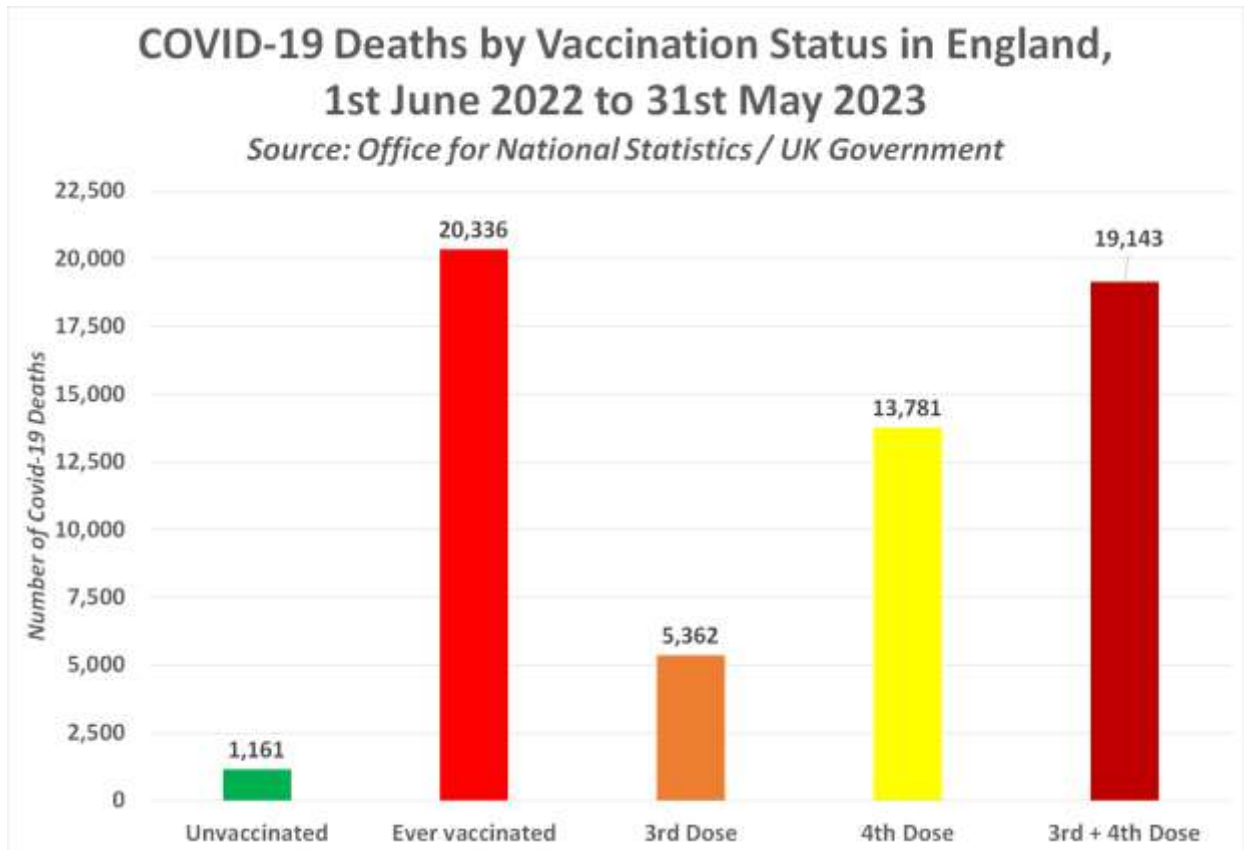


The unvaccinated accounted for the least amount of COVID-19 deaths in every single month up to May 2023, barely even getting into triple figures in most months. Whereas the vaccinated population accounted for the majority of Covid-19 deaths every single month, hitting four figures in all but 2 months throughout that year.

But what's curious about the figures is that it's not the one-dose, or double-vaccinated population who account for the majority of COVID-19 deaths throughout the 12 months, it's instead the triple and quadruple-vaccinated population that accounted for the majority of COVID-19 deaths.

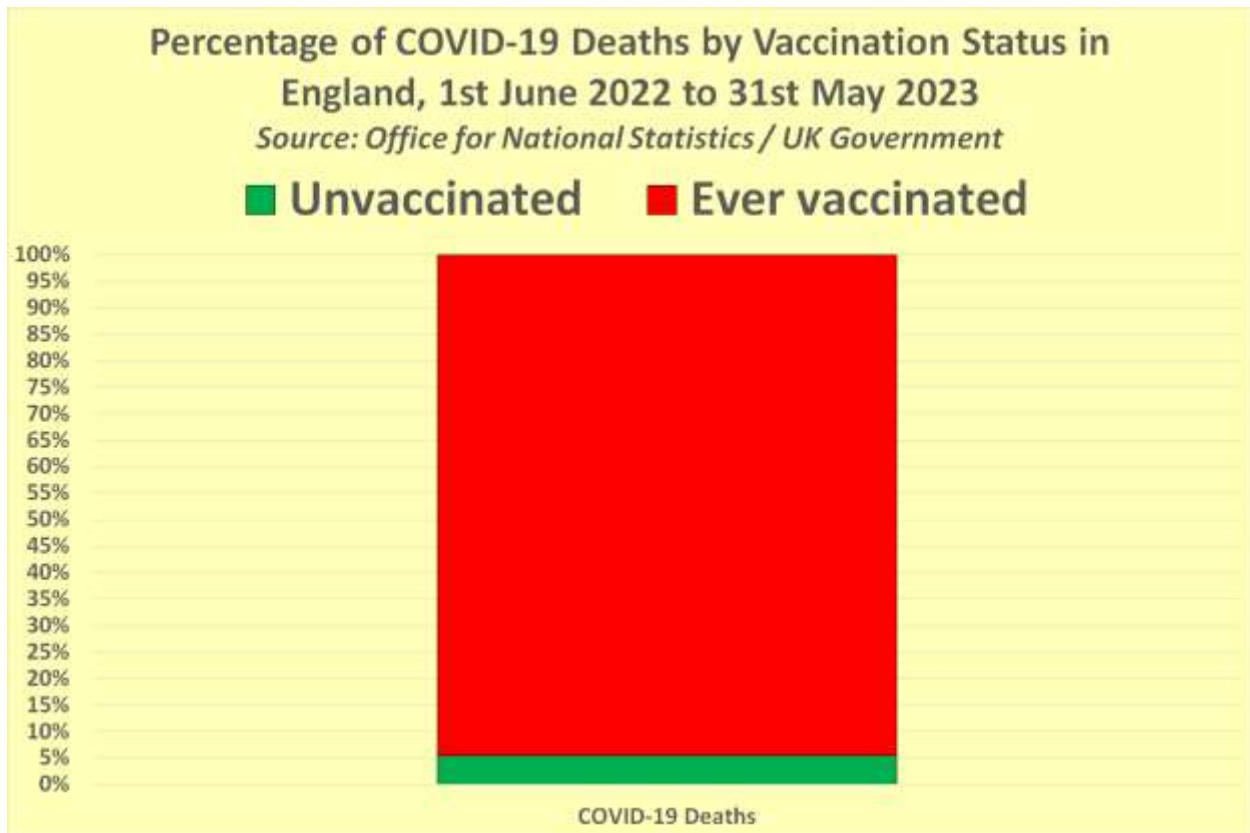
With the most deaths occurring among the quadruple-vaccinated from August 2022 onwards.

The following chart shows the total number of COVID-19 deaths by vaccinated status throughout the entire year and reveals the true extent of the shocking statistics –

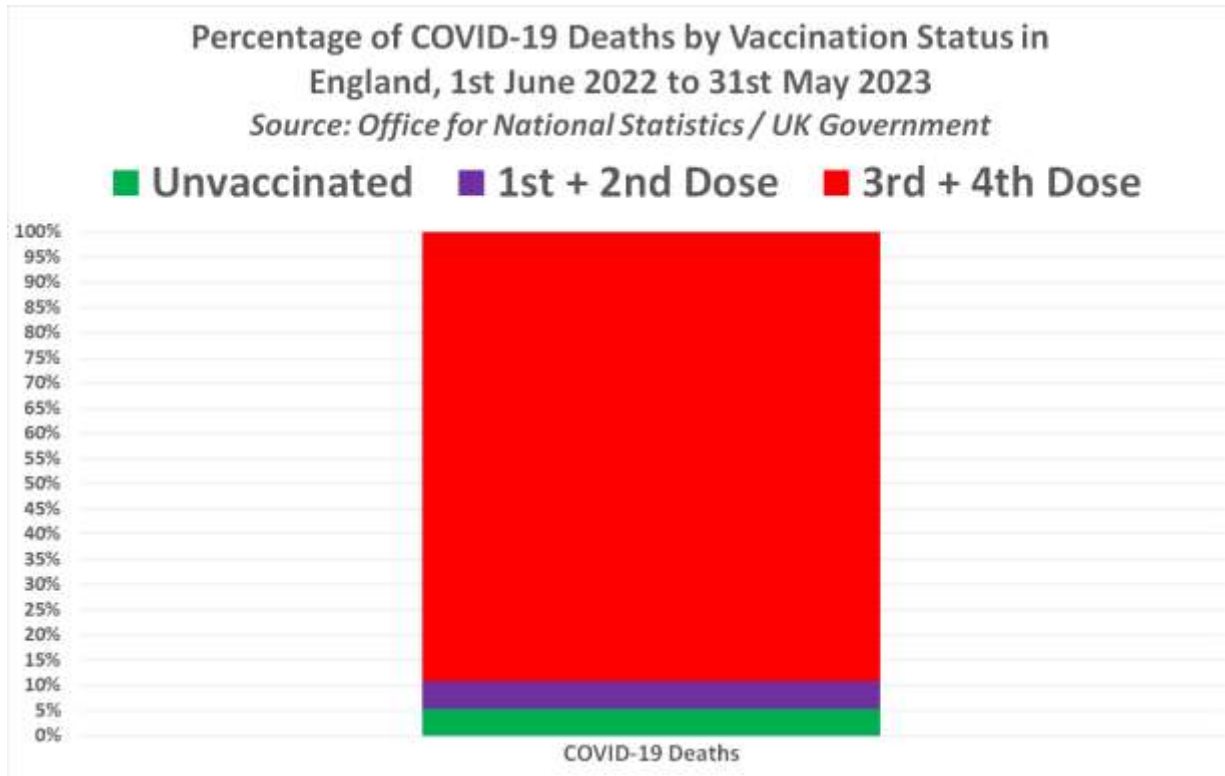


The unvaccinated population barely broke into 4 figures throughout the entire year, hitting a total of 1,161 Covid-19 deaths, whereas the vaccinated population hit five figures with 20,336 Covid-19 deaths; 19,143 of which were among the triple and quadruple vaccinated.

This means, as is shown in the following chart that the vaccinated population in England accounted for 95% of COVID-19 deaths between June 1, 2022, and May 31, 2023. Whereas the unvaccinated population accounted for just 5%.



The triple and quadruple vaccinated shockingly accounted for 94% of all deaths among the vaccinated population, and as is shown in the following chart, 89% of all Covid-19 deaths, with the one-dose and two-dose vaccinated accounting for just 6% of Covid-19 deaths.



This is, however, still higher than the 5% of Covid-19 deaths among the unvaccinated population.

These aren't the kind of figures you would expect to see if the COVID-19 injections really are up to 95% effective at preventing death, are they?

With 95% of Covid-19 deaths in the full 12 months up to May 2023 being among the vaccinated it would appear they are in fact only 5% effective, and even that number is generous.

The thing about a DNA bank, combined with bio/medical-data is that it is powerful stuff. The ability to do retrospective studies is important. A retrospective study uses information on events that have taken place in the past. That is the most benign usage.

Traditionally datasets can be anonymized, with people's identities stripped out of the data. So, our government doesn't even require permission from the individual to use such data (this was all codified in HIPAA). But herein lies the problem, one's genetic data is a fingerprint. It can never be "stripped" out to anonymize a person's medical or bio-data. Genetic data will be sold, stolen and even taken by governments (such as Israel) or in the process of getting arrested for a crime, such as in the USA.

In the USA, the CODIS and NDIS database combines Federal, state and local DNA banks on people arrested and convicted of crimes. CODIS is automatically and constantly comparing its database with new DNA evidence found in crime scenes.

A key part of CODIS is the database itself, NDIS. This massive database contains 12.2 million offender profiles, 2.6 million arrestee profiles, and 684,000 forensic profiles giving us a grand total of 15.48 million profiles or about 4.85% of the total U.S. population (2016).

We can only assume that in the past eight years, the NDIS database has grown ever larger. However, since 2016, the FBI has not released any more data on the size of the database. NDIS is purported to be the largest DNA database in the world.

By combining one's medical records with the most permanent identifier known to man, one's DNA, this information could be sold to auto, life and medical insurance companies, potential employers, landlords, financial institutions and the like. Has someone taken a drug to treat bi-polar disorder, or sought treatment for cardiovascular disease or had domestic abuse issues that they sought help for? What about markers for a specific disease that a person might be susceptible to? When medical data is linked to a DNA identifier, it will always have the potential to be traceable. A DNA identifier ensures that this information is never expunged from your history.

Since 2018, the Israeli government has put the nation's [medical database online](#). So, it is safe to assume that once the DNA database is set-up, it also will go into the cloud.

Beyond that, what Benjamin Netanyahu is now proposing, is much more radical. That is the idea that the two databases will be linked and uploaded online. He is combining people's medical records, with their genetic identity (DNA). That DNA record is easily traced to a name.

“Informed Consent. -- Respect for persons requires that subjects, to the degree that they are capable, be given the opportunity to choose what shall or shall not happen to them. This opportunity is provided when adequate standards for informed consent are satisfied.

While the importance of informed consent is unquestioned, controversy prevails over the nature and possibility of an informed consent. Nonetheless, there is widespread agreement that the consent process can be analyzed as containing three elements: information, comprehension and voluntariness.” (The Belmont Report)

Informed consent is the backbone of clinical trial research.

Benjamin Netanyahu is offering that biotech and pharma can use the Israeli population as a test bed for biotech and big pharma for prospective, interventional trials combining DNA and medical records. Interventional prospective clinical trials are experimental studies that compare the effectiveness of drugs, medical treatments as well as prevention strategies. So the issue here is that without knowing, people could easily become subjects of an interventional clinical trial, which would include their genetic identity permanently bound to the results of that trial. Furthermore, without informed consent, their data could be used in all sorts of ways that they had never considered.

Because the uses of genetic data go beyond traditional pharma, we have to consider other uses and misuses for that data.

Such a combined database is a set-up for bioweapons development. The evidence is clear and compelling those countries are developing such bioweapons. Wiki provides a succinct and chilling history lesson:

Genetic Weapons

In 1997, [U.S. Secretary of Defense William Cohen](#) referred to the concept of an ethnic bioweapon as a possible risk.^[1] In 1998 some biological weapon experts considered such a "genetic weapon" plausible, and believed the former [Soviet Union](#) had undertaken some research on the influence of various substances on human genes.^[2]

In its 2000 policy paper [Rebuilding America's Defenses](#), think-tank [Project for the New American Century](#) (PNAC) described ethnic bioweapons as a "politically useful tool" that US could have incentive to develop and use.^[3]

In 2004, [The Guardian](#) reported that the [British Medical Association](#) (BMA) considered bioweapons designed to target certain ethnic groups as a possibility, and highlighted problems that advances in science for such things as "treatment to [Alzheimer's](#) and other debilitating diseases could also be used for malign purposes".^[4]

In 2005, the official view of the [International Committee of the Red Cross](#) was "The potential to target a particular ethnic group with a biological agent is probably not far off. These scenarios are not the product of the ICRC's imagination but have either occurred or been identified by countless independent and governmental experts."^[5]

In May 2007, it was reported that the Russian government banned all exports of human biosamples.^[6] The reason for the ban was allegedly a report by the head of [FSB Nikolay Patrushev](#) presented to [Vladimir Putin](#). The report claimed about on-going development of "genetic bioweapons" targeting Russian population by Western institutions.^[citation needed]

In 2008, the U.S. government held a congressional committee, 'Genetics and other human modification technologies: sensible international regulation or a new kind of arms race?', during which it was discussed how "we can anticipate a world where rogue (and even not-so-rogue) states and non-state actors attempt to manipulate human genetics in ways that will horrify us".^[7]

In 2012, [The Atlantic](#) wrote that a specific virus that targets individuals with a specific DNA sequence is within possibility in the near future. The magazine put forward a hypothetical scenario of a virus which caused mild flu to the general population but deadly symptoms to the [President of the United States](#). They cite advances in personalized gene therapy as evidence.^[8]

In 2016, [Foreign Policy](#) magazine suggested the possibility of a virus used as an ethnic bioweapon that could [sterilize](#) a "genetically-related ethnic population."^[9]

Information on U.S. bioweapons research seems to *dead-end* at year 2016. Which is also when much of the up-to-date information on the USA DNA databases abruptly ends also. These types of firewalls in controversial subjects that the U.S. Government doesn't want us talking about are more and more common on the Googlenet.

But we do know that the engineered SARS-CoV-2 virus appears to be more severe with specific populations that have more ACE2 receptors on their cell surfaces. Was this a bioweapon? Judging by the reaction of the fact checkers and MSM, it sure seems like that U.S. government doesn't want people to ask too many questions about that line of thinking!

The risks to putting such a database online are enormous. In 2016, I had my classified information stolen by the Chinese, as did thousands of other U.S. government security cleared people.

What will Israeli offer its citizens when the data is hacked by the Chinese and lands in the hands of Syria, which has a very large biotech sector. In fact, [Israel has produced data](#) that Syria has a large bioweapons program. What happens if Syria manages to get their hands on that Israeli database?

Bioweapons programs only required dual-use materials (purposed for other biotech purposes) and limited equipment. Bioweapons are cheap to make and a bioweapon facility can be housed anywhere, including a garage or kitchen. Just because the Israeli government can link all the medical records of Israeli's with their DNA records, should they?

Another use for such a combined database is for developing transhumanism applications. Will certain genotypes be able to have brain microchips or sensors under the skin without rejecting the implant? Will some genotypes be better candidates for brain wave computer interfaces? Will be military be choosing candidates based on a person's DNA? About 2020 - official information on the DoD and DARPA's various "cyborg programs" ends.

Then there are the questions about developing and using a population-based DNA bank/medical records database for military applications and transhumanism. Will certain genes allow for some people to become "super-humans", able to withstand genetic treatments that will allow them to become more intelligent, able to communicate via brainwaves, stronger, more or less empathetic, and more able to withstand or respond to specific genetic treatments? What about infants with a specific genotype? How will a government use that data? What about corporations? What happens when that data becomes as public as a social security number?

What Israel is doing is dangerous. Bibi is rushing into an unknown and uncharted ethic morass before there is a regulatory framework for addressing the obvious and uncharted dangers from such a project.

The importance of Dr. Robert Malone's post will not be recognized but it touches on the Satanic Agenda found throughout the entire Bible where Satan on more than two dozen times attempts to wipe out the bloodlines of Abraham, Isaac, and Jacob. I've written about this many times before and I will remind the reader that Benjamin Netanyahu is an Ashkenzai Jew from Poland. The Ashkenazi Jews are Khazarians with roots back to

Sabbatai Zevi. Satan has used the Khazarians and Ashkenazi sect to hi-jack the Biblical people of God. The Satanic plan has been to exterminate the Biblical descendants of Abraham, Isaac, and Jacob. I will explain the significance of what seems to be diabolical genocidal plan. It is for this reason that Dr. Robert Malone's post is so important. The terms "motive, means, and opportunity" is to that of a crime suspect might be a stretch here but it is potential that Benjamin Netanyahu may have another less obvious reason to require all Israeli citizens to be vaxxed.

From the first human beings God created and placed in the Garden of Eden, to the very last person born on this earth, our gracious God has offered salvation to sinners on the basis of faith in the promised "**seed**," Jesus Christ. Before Messiah's birth, Old Testament saints admitted their sin and trusted in the "**seed**" that was to come, and they were saved. Adam and Eve were given the promise of deliverance through their "**seed**" -(Genesis 3:15), and they believed -(see Genesis 4:25-26). So it was with Abraham as well:

After these things the word of the Lord came to Abram in a vision, saying, "***Do not fear, Abram, I am a shield to you; your reward shall be very great.***" And Abram said, "***O Lord God, what wilt Thou give me, since I am childless, and the heir of my house is Eliezer of Damascus?***" And Abram said, "***Since Thou hast given no offspring to me, one born in my house is my heir.***" Then behold, the word of the Lord came to him, saying, "***This man will not be your heir; but one who shall come forth from your own body, he shall be your heir.***" And He took him outside and said, "***Now look toward the heavens, and count the stars, if you are able to count them.***" And He said to him, "***So shall your descendants be.***" Then he believed in the Lord; and He reckoned it to him as righteousness -(Genesis 15:1-6).

Jesus answered, "***If I glorify Myself, My glory is nothing; it is My Father who glorifies Me, of whom you say, 'He is our God'; and you have not come to know Him, but I know Him; and if I say that I do not know Him, I shall be a liar like you, but I do know Him, and keep His word. Your father Abraham rejoiced to see My day, and he saw it and was glad.***" The Jews therefore said to Him, "***You are not yet fifty years old, and have You seen Abraham?***" Jesus said to them, "***Truly, truly, I say to you, before Abraham was born, I am***" -(John 8:54-58).

For this reason it is by faith, that it might be in accordance with grace, in order that the promise may be certain to all the descendants, not only to those who are of the Law, but also to those who are of the faith of Abraham, who is the father of us all, (as it is written, "***A father of many nations have I made you***") in the sight of Him whom he believed, even God, who gives life to the dead and calls into being that which does not exist. In hope against hope he believed, in order that he might become a father of many nations, according to that which had been spoken, "***So shall your descendants be.***" And without becoming weak in faith he contemplated his own body, now as good as dead since he was about a hundred years old, and the deadness of Sarah's womb; yet, with respect to the promise of God, he did not waver in unbelief, but grew strong in faith, giving glory to God, and being fully assured that what He had promised, He was able

also to perform. Therefore also it was reckoned to him as righteousness. Now not for his sake only was it written, that it was reckoned to him, but for our sake also, to whom it will be reckoned, as those who believe in Him who raised Jesus our Lord from the dead -(Romans 4:16-24).

For the Old Testament sinner, the good news of the gospel was this: "Salvation is available to sinners who trust in the **"seed"** whom God will provide:

"And Abraham took the wood of the burnt offering and laid it on Isaac his son, and he took in his hand the fire and the knife. So the two of them walked on together. And Isaac spoke to Abraham his father and said, "My father!" And he said, "Here I am, my son." And he said, "Behold, the fire and the wood, but where is the lamb for the burnt offering?" And Abraham said, "God will provide {for} Himself the lamb for the burnt offering, my son." So the two of them walked on together. Then they came to the place of which God had told him; and Abraham built the altar there, and arranged the wood, and bound his son Isaac, and laid him on the altar on top of the wood. And Abraham stretched out his hand, and took the knife to slay his son. But the angel of the LORD called to him from heaven, and said, " Abraham, Abraham! "And he said," Here I am. " And he said, "Do not stretch out your hand against the lad, and do nothing to him; for now I know that you fear God, since you have not withheld your son, your only son, from Me." Then Abraham raised his eyes and looked, and behold, behind him a ram caught in the thicket by his horns; and Abraham went and took the ram, and offered him up for a burnt offering in the place of his son. And Abraham called the name of that place The Lord Will Provide, as it is said to this day, "In the mount of the LORD it will be provided" -(Genesis 22:6-14). [This passage is from a modern translation and illustrates how the addition of one word {for} changed the meaning of the text.

[The word **"for"** above in brackets does not appear in the KJV Bible Hebrew text]. [The preposition **"for"** has been added in modern translations for ease of reading but it changes the meaning of verse 8 entirely.]

The good news of the gospel is this: God has provided the promised **"seed,"** Jesus Christ. By faith in Him, sinners are saved and become the children (the **"seed"**) of God. They thus enter into the blessings of the Abrahamic covenant:

"There was the true light which, coming into the world, enlightens every man. He was in the world, and the world was made through Him, and the world did not know Him. He came to His own, and those who were His own did not receive Him. But as many as received Him, to them He gave the right to become children of God, even to those who believe in His name, who were born not of blood, nor of the will of the flesh, nor of the will of man, but of God" -(John 1:9-13).

"For you are all sons of God through faith in Christ Jesus. For all of you who were baptized into Christ have clothed yourselves with Christ. There is neither

Jew nor Greek, there is neither slave nor free man, there is neither male nor female; for you are all one in Christ Jesus. And if you belong to Christ, then you are Abraham's offspring, heirs according to promise" -(Galatians 3:26-29).

Jesus Christ is the "seed" of Abraham. Your response to Him is the most important decision you will ever make. To trust in Him for salvation is to enter into God's blessings. To reject Him is to bring upon you the curse of God. May you trust in Him for salvation and blessing.

Our study has shown that men are sinful and that God is faithful, in spite of man's sin. The Abrahamic covenant has been fulfilled in Jesus Christ, not because of man's faithfulness, but in spite of his sin and rebellion. The blessings of that covenant flow to men because of God's grace and His provision for sinners in Jesus Christ. In spite of our sins, the purposes and promises of God will be fulfilled. We find no basis for pride or presumption on our part, but only gratitude and praise to Him, through whom we are richly blessed. Let us boast in our salvation--not in ourselves--but in the God who has blessed us. Let us boast in the Lord.

But by His doing you are in Christ Jesus, who became to us wisdom from God, and righteousness and sanctification, and redemption, that, just as it is written, "**LET HIM WHO BOASTS, BOAST IN THE LORD**" -(1st Corinthians 1:30,31).

Satan does not know when the rapture will happen, but once it does happen, he knows his time is short. Have you ever thought about the fact the reason no man was to know the date of the Rapture was because God did not want Satan and the Antichrist to know the date? Satan knows the Bible. He has heard all that has been taught on the subject.

It was back in May, 2023 when I first heard Prince Charles say that we only had seven years left it suddenly occurred to me that something else was going on in the mind of Prince Charles. He has repeated many times his statement that we only have seven years to save the planet. In what he was blabbering about made no sense unless he knew or was aware of some cosmic event of some object hitting the planet. In my little spare time I began to inquire about known planetary data on meteors or objects being tracked posing a threat of collision with the earth. I have often thought of the many reasons why we were not meant to know the date of our "Departure", but we were told to be watching the signs nonetheless. I don't need to go into that other than to say that none of us would be able to live life as God intended us do. Matthew 24:36 and Mark 13:32 will stand as God's Word. Matthew 25:13 remains the operative passage for you and me: "**Therefore keep watch, because you do not know the day or the hour.**" Over the years I have been studying Bible prophecy, I always come back to my experience as a soldier walking guard-duty in West Germany during the Cold War. Since I was in a nuclear artillery unit that operated with the highest level of security possible in those days, it was routine to walk guard-duty

every three or four days. The duty officer of the day conducting guard inspection would recite the words of Matthew 25:13, although I only knew it as a warning, and not something with a religious message. I knew I did not want to go to Crailsheim Stockade where the U.S. Army incarcerated military personnel convicted by court-martial of violations. I still remember the winter nights standing in an open wood guard tower exposed to twenty-degree weather in blowing snow. But the point here is we are to be watching all the time for related signs of how close we may be.

The most important bit of information is the Antichrist, Prince Charles will be signing a "Covenant with the Many" at COP28 between 11/30 and 12/12, 2023. By knowing those dates, we know our "Departure" could be any day from today until just before the Confirmation of the Covenant observance takes place. It will happen and God does not share that date and all of those who try to set a date will be wrong!

Why does Satan help fulfill prophecy? Why doesn't he do things differently than what is written? Or is he so hardened that he honestly thinks he can change what has been foretold by God Himself? Satan seems to be riddled with a lack of humility which has hardened him to think that he can change the outcome.

"His pride is what gets him every single time. He literally thinks he can be God. He still thinks he can be God," added Todd Hampson, an author, illustrator and animation producer who co-wrote a book with Jeff Kinley, titled *"The Illustrated Guide to Tough Questions About the End Times"*.

"When he (Satan) had Christ on the cross, he thought he won. He thought it was game-set-match. He didn't see the resurrection coming. So he does know prophecy, but he doesn't know everything."

"He's not omniscient. And he doesn't realize that everything he's doing to usurp God actually plays into the hands of God's overall sovereign plan, which we can't fully understand ourselves."

Todd Hampson said it is important to recognize that Satan does, in fact, *"try to keep prophecy from being fulfilled, specifically in the tribulation period."*

"He tried to keep it from being fulfilled when he had Herod kill all the young babies," Hampson said. *"He was trying to keep the Genesis 3:15 **seed** of the woman from coming on the scene. But once that happened (Jesus' birth), he tried to kill Him on the cross. [Satan] thought he had [Jesus] cornered."* Could the Covid scamdemic have been a cover distraction in order to destroy the bloodline descendants of Abraham, Isaac, and Jacob? It was my first thought in February of 2020 when I was following the reports on the cruise ship *'Diamond Princess'* propaganda of the rogue novel virus on the loose!

It seems to me that we have many more examples in the Bible that begin to make sense with sharper focus when we see them as History being revealed in advance!

The devil is *“self-deluded and his pride gets the best of him at every turn and he falls right into his own trap by fulfilling prophecy by trying to un-fulfill prophecy,”* Hampson added.

“We find at the end of the tribulation period [Satan] knows from prophecy that what ushers in Christ’s physical return at the end of the tribulation is the Jewish people calling on the name of the Lord, realizing He’s the Messiah,” Hampson said.

Since we can be certain that Prince Charles is the Antichrist, we can see why that he is so adamant, conspicuously so and continually pushing the idea that *“We only have seven years!”* Although he is saying this as a reference to his saving the planet from an environmental disaster, he probably knows that his plan has always been to destroy the bloodline’ promises as the larger issue.

At this point Dr. Robert Malone’s medical background in research explains what Benjamin Netanyahu is doing by permitting the Jewish population to be used as a lab experiment which will likely kill all of the Biblical Jews or descendants of Abraham, Isaac, and Jacob. I don’t think Dr. Robert Malone sees this in the context of what I am saying, but he is proving my contention. It was reported elsewhere more than two years ago that the Ashkenazi Jews were genetically immune from becoming ill and dying from the Pfizer and Moderna vaxxines.

The UK Journal *‘Lancet’* reported: *“Ethnic and religious minorities have been disproportionately affected by SARS-CoV-2 worldwide. The UK strictly-Orthodox Jewish community has been severely affected by the pandemic. This group shares characteristics with other ethnic minorities including larger family sizes, higher rates of household crowding and relative socioeconomic deprivation. We studied a UK strictly-Orthodox Jewish population to understand transmission of COVID-19 within this community.”*

By January 2021, a large number of authors had reported that ethnic minority groups experienced higher numbers of cases and increased hospitalizations due to COVID-19. A small number of articles provided evidence that strictly-Orthodox Jewish populations had experienced a high rate of SARS-CoV-2 infection but extremely limited data was available on overall population level rates of infection amongst specific ethnic minority population groups. There was also limited data on rates of infection amongst young children from ethnic minority groups.

In Spring of 2020, a tightly-knit strictly-Orthodox (Sephardic Jews) Jewish in the UK community became aware that they appeared to be experiencing a high burden of SARS-CoV-2. In view of this, and national data suggesting a high burden of infection in the Jewish community and a possible disproportionately high burden in the strictly-Orthodox community, we co-developed a cross-sectional serological survey to measure the burden of infection and identify factors associated with transmission and to inform local control efforts.

The precise reasons why the burden of SARS-CoV-2 has been so high in this population are unclear. In Israel, strictly-Orthodox Jewish communities had markedly higher SARS-CoV-2 PCR swab positive incidence rates compared to other socio-economically similar communities during the first wave of the Israeli epidemic, whilst seroprevalence following the first wave of COVID-19 was above 30% in many strictly-Orthodox communities the United States. Data from other sources suggest that lower socio-economic status, ongoing need to travel to work and a greater burden of pre-existing comorbidities, may all contribute to increased risk of acquiring SARS-CoV-2.

To clarify this, the Ashkenazi Jews were immune from getting SARS-CoV-2, whereas the Sephardic Jews had higher rates of positive incidence for SARS-CoV-2. Sephardic Jews' are blood descendants "seed" of Abraham, Isaac, and Jacob.

A number of high-profile Jewish groups are denouncing Democratic presidential contender Robert F. Kennedy Jr.'s remarks that "*Ashkenazi Jews and Chinese*" people are "*most immune*" to Covid-19. Robert Kennedy was quoting from facts that had been reported elsewhere by virus researchers. Dr. Lee Merritt, a retired U.S. Navy surgeon reported this on her site at least two years ago.

Speaking at a dinner in New York City earlier this week, Kennedy said "*there's an argument that it is ethnically targeted,*" according to video shared by the 'New York Post' on Saturday. Kennedy was immediately attacked as being anti-Semitic. The medical data is well-established at least two years ago.

"Covid-19 is targeted to attack Caucasians and Black people. The people who are most immune are Ashkenazi Jews and Chinese," Kennedy said, adding that "*we don't know whether it's deliberately targeted that or not.*"

Ashkenazi Jews trace their roots to Central and Eastern Europe and represent a majority of the U.S. Jewish population. 90% of those claiming to be ethnic Jews are Ashkenazi. Prophecy teachers do not seem a bit concerned about this matter but Jesus Christ thought it important enough to mention it twice and tell us in Revelation 2:9 and 3:9 that these people are of the Synagogue of Satan, and not Jews.

The American Jewish Committee told CNN in a statement Saturday that Kennedy's "*assertion that Covid was genetically engineered to spare Jewish and Chinese people is deeply offensive and incredibly dangerous.*"

In a tweet Saturday, Kennedy said that the dinner conversation was supposed to be off the record and that he "never, ever suggested that the Covid-19 virus was targeted to spare Jews." Rather, he said, he was referring to a study that "*serves as a kind of proof of concept for ethnically targeted bioweapons.*"

According to the New York Post, the event's organizer, Doug Dechert, said the event had been on the record.

While there are disproportionate rates of Covid-19 illness and death across different demographics, this has been attributed to racial disparities, not genetics.

Since the start of the pandemic, the risk of dying from Covid-19 has been nearly twice as high for Black and Hispanic people in the United States than for White people, data from the Centers for Disease Control and Prevention shows. Black and Hispanic people also faced a higher risk of coronavirus infection and were more than twice as likely to be hospitalized.

“Given generations of systemic disinvestment in the health of Black communities in the United States, the starkly disproportionate rates of Covid-19 illness and death are not surprising,” Dr. Marcella Nunez-Smith, a chair of the Presidential Covid-19 Health Equity Task Force, wrote in a report last year.

Kennedy, who is polling between 15% and 20% nationally in the Democratic primary, is a longtime vaccine skeptic who has promoted several health-related conspiracy theories. He was a strident critic of the government’s handling of the coronavirus pandemic and its top infectious disease expert, Anthony Fauci. He also railed against the coronavirus vaccine and vaccine mandates.

Nonetheless, the Bible’s narrative of Satan’s plan to destroy the **“Seed”**, Dr. Malone’s report, along with a series of facts, such as Prince Charles asserting there is only seven years repetively, Netanyahu (a non-Sephardic) mandating the population of Israel to be the first vaxxed raise many circumstantial points of something so diabolical and part of Satan’s power to bring about the elimination of the need for the Messiah to return. Jesus Christ would be a liar if he were not to return because of His many promises to return. Since the focus of the Tribulation is on causing ethnic Israel to turn back to God, Satan will be focusing on preventing those who are ethnically of Israel from coming to know God.

While Satan will still be trying to prevent all people from accepting Jesus, he will be specifically targeting Israel. Satan does this because he wants God’s people not to choose him and to instead continue to live in rebellion.

Does Israeli PM Netanyahu Trust The Prophetic Hebrew Scriptures?

Any serious student of the Hebrew Bible knows that God determines who shall rule:

“...He (God) removeth kings, and setteth up kings: He giveth wisdom unto the wise, and knowledge to them that know understanding.” -(Daniel 2:21)

Benjamin Netanyahu - if he believes the Hebrew Scriptures - believes that God has set him as Prime Minister and is making him invincible. Could it be that Prime Minister Netanyahu see himself as similar as King David? Consider:

“And there was war again: and David went out, and fought with the Philistines, and slew them with a great slaughter; and they fled from him.” -(1st Samuel 19:9)

If he is emboldened by Old Testament prophecies, the world is about to see remarkable events!

Consider the prophecies of Obadiah:

God breathed an End of the Age prophecy against the *"House of Esau"* in Obadiah 15-18, one of the most startling prophecies in the Bible -- and one working its way forward toward fulfillment.

"But on Mount Zion [in Jerusalem] there shall be deliverance [for those who escape], and it shall be holy; and the house of Jacob shall possess its [own former] possessions. The house of Jacob shall be a fire, and the house of Joseph a flame, but the house of Esau shall be stubble; they shall kindle and burn them and consume them, and there shall be no survivor of the house of Esau, for the Lord has spoken it." -(Verses 17-18)

Take special note of the part of the verse ***"But on Mount Zion [in Jerusalem] there shall be deliverance [for those who escape],"***

This prophecy is close to being fulfilled in Israel today, as the modern Palestinians are the ***"House of Esau"***. The current Prime Minister should read the Hebrew Scriptures, that God has everything under control, and that His prophetic word of 2,600 years ago will be precisely fulfilled.

Prime Minister Netanyahu may have determined that he cannot fail because God is with him. If 'Bibi' feels this way, he is not the first modern leader to do so.

In June, 1990, an editorial in the Jewish Press which indicated that Israel's patience was at an end, and that the next major war was going to result in the annihilation of Israel's implacable enemies. This editorial stated that a decision had been made at the highest military and civilian leadership levels of the Israeli government that a future Arab-Israeli war would be the war in which the Israeli Defense Force would annihilate the entire populations of the Arabs who hated them so putridly. These Jewish leaders were sick and tired of constantly being attacked, winning the war, but then not winning the peace.

Further, the top Israeli leadership was concerned that, in due time, the Arabs would possess Weapons of Mass Destruction which could be delivered by suicide bombers, at which point Israel was surely doomed. **Therefore, top Israeli leadership in 1990 had decided to annihilate entire populations during the next Arab - Israeli war.**

"In a newly released military statement, the Al-Aqsa Martyrs Brigade — the military wing of Palestinian Authority President Mahmoud Abbas' supposedly "moderate" Fatah movement governing in Judea and Samaria (the West Bank) — declared its alliance with Hamas and its commitment to the ongoing military campaign against Israel."

"Fatah articulated its unwavering dedication to liberating Palestine and Jerusalem, while asserting its pivotal role in what Hamas has termed Operation Al-Aqsa Flood", as reported by Israel National News.

"We were there from the start of the 'Al-Aqsa Flood' operation out of our dedication to the ideal of fighting to liberate Palestine and holy Jerusalem', the Al-Aqsa Martyrs Brigade stated ... "[The] armed struggle is the only and fastest way to liberate Palestine," they stated, adding that "the unity of the rifle, the (struggle) in the field, and the firm stand of our people is the only way to guarantee victory."

What does God say?

- *"God stated His covenant is with Abraham and his "seed". This word, "seed" most definitely refers to those physical descendants which will follow Abraham, to the nation Israel, which grew out of Abraham's descendants. Further, God stated that this covenant will be an "everlasting" covenant. The word, "everlasting" literally means, "forever" or "eternal." -(Genesis 17:7-8)*
- *Ezekiel 36:6-38 Restoration -- This passage is one of the most revealing concerning God's plan to restore Israel. In verse 6, God reiterated that Israel will suffer His judgment, but then in verse 7, He stated that, after He had finished His judgment, He shall call the Gentile nations which He had used to punish Israel into judgment. Then, in verses 8-10, God stated, **"O mountains of Israel...shoot forth your branches and yield your fruit to My people, for they are soon to come home..."** And then, just to ensure that no one misunderstands the nature of this return, God states, in verse 10, that He will give all the land of Israel back to the Jews.*
- *Ezekiel 37 - This chapter foretells precisely how God will return Israel back to her land. God likens this gradual process to a valley of dry bones being systematically raised up to a living body again. And, just to ensure that no one misses this point, God first gives the cryptic prophecy in verses 1-10, and then the plain explanation beginning in verse 11. God states plainly, **"...these bones are the whole house of Israel...I will open your graves and cause you to come up out of your graves and bring you into the land of Israel"**.*

Interestingly, God stated, in verse 8, that He will bring Israel back into the land without His spirit; since we know that the Holy Spirit always testifies of Jesus Christ, we know that God will restore Israel initially in a state of unbelief in Jesus Christ as Messiah. But, then, in verse 14, God says, **"And I shall put My Spirit in you and you shall live..."** Of course, we know from recent history that Israel was, indeed, established in unbelief in Jesus Christ; her belief in Jesus as Messiah is still future.

- "In Joel 2:18, God clearly states His theme of restoration, when He says, ***"Then will the Lord be jealous for His land and pity His people"***. God then details how He will bless Israel when she returns to her land in these last days, and how He plans to protect her militarily. Then, in chapter 3, verse 1, God says, ***"...in those days when I shall bring again (or bring back) the captivity of Judah and Jerusalem.."*** Again, God foretells the return of Israel to her Promised Land.

In Amos chapters 1 through 9:7, God thoroughly mourns Israel's sin and her coming punishment. But, in verse 8 of chapter 9 God returns to His theme of restoration. God says, ***"...the eyes of the Lord God are upon the sinful kingdom, and I will destroy it from off the face of the earth, [except] that I will not utterly destroy the house of Jacob...I will command and I will sift the house of Israel among all the nations... yet shall not the least grain (Jew) fall upon the earth. All the sinners of My people shall die by the sword..."***

But then God turns to the theme of restoration, beginning with verse 11. He promises to accomplish the following:

He will re-establish the Tabernacle of David and will rebuild it as in the days of old. In other words, He will bring the old Sacrificial system back into place. He shall cause the land to become extremely productive once again. Since 1948, God has caused rainfall to return to normal, and Israel has flourished agriculturally. God promises to bring back the Jewish exiles so that they may rebuild the waste cities, plant vineyards, and make gardens. And this time, they shall be able to enjoy the fruits of their labor, rather than seeing their enemies enjoy the fruits of that for which they had labored.

God promised that, when He brings them back to their land, they shall never more fear being driven back out of it. They will never face military defeat or annihilation. Even when the invasion by the armies led by Russia in the last days, as foretold in Ezekiel 38-39 occurs, Israel will be saved.

- ***"And at that time shall Michael stand up, the great prince which standeth for the children of thy people: and there shall be a time of trouble, such as never was since there was a nation even to that same time: and at that time thy people shall be delivered, every one that shall be found written in the book."***-(Daniel 12:1)

Therefore, when Prime Minister Netanyahu leads Israel against her Palestinian foe, he will go forth with a mighty and a confident hand!

Now, Israel is fighting a 3-front war!

"America can certainly afford to stand with Israel and to support Israel's military needs and we also can and must support Ukraine in its struggle against Russia," [Yellen said](#).

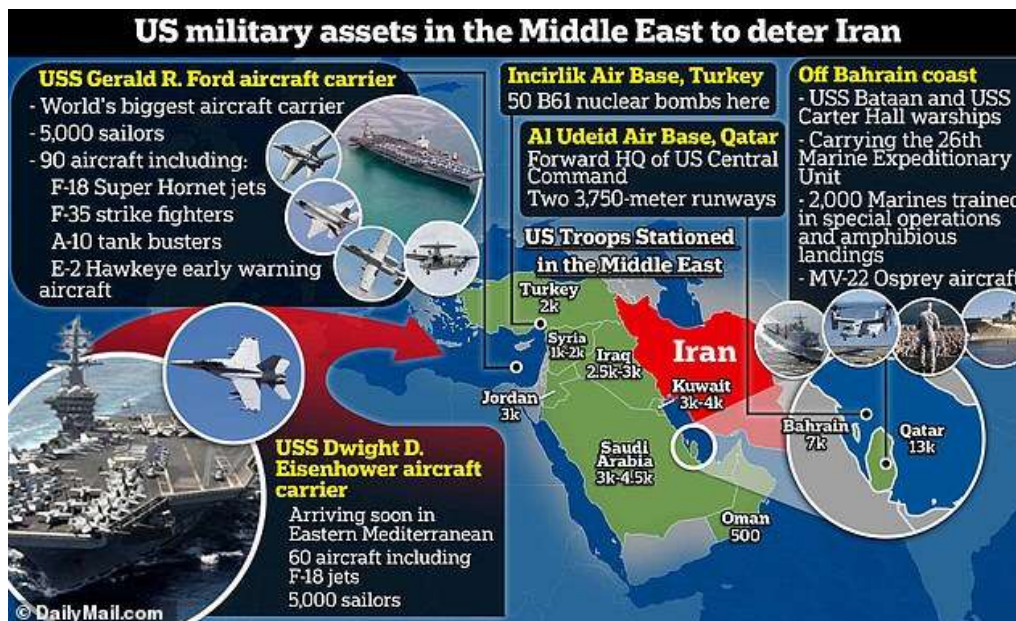
"We do need to come up with funds, both for Israel and for Ukraine. This is a priority," she added.
