All of what Dr. Ana Maria Mihalcea is revealing in exposing the technology aspect of Nanotechnology in the forthcoming “Sustainable Development” Agenda of Prince Charles is leading to the potential of “Immortality” of the person. Through CRISPR-Cas-9 technology, the Antichrist will be theoretically possible to offer Immortality; as an incentive to those who will worship him in the coming months.

The Fallen One's claims of Isaiah 14:12-15 speak or allude to the fact that Lucifer would be able to achieve that which has been until of recently an exclusive right to the Creator. Between 2013 and 2020 the buzz in the field of science relative to its future implications for humanity centered upon the so-called cracking the code or genome that would lead to designer genes.

The Institute of Zoology of the China Academy of Science has successfully prolonged the lives of mice by using CRISPR/Cas9. CRISPR has become a relatively simple and popular way to edit strands of DNA. The CRISPR/Cas9 study found a gene tied to cellular senescence (which tells cells to stop growing) and also, that CRISPR/Cas9 treatment can make partially dormant the aging process. CRISPR/Cas9 treatment allowed mice to live 25% longer and be physically stronger. Biologists see these results being relatively easy to reproduce on humans in a clinical setting.

Existing in a world where individuals are able to receive treatment to live longer border dystopian science fiction. The treatment can reduce the need for medical attention by potentially reducing injuries, heart attacks, and organ failures.

In part, due to breakthroughs in the tech and science industries, life expectancy in the 21st century is projected to steadily increase. In a study published in the *'Lancet'*, average life expectancy is predicted to rise in 35 industrialized countries by 4.4 years in men and women by 2030.

Emmanuelle Charpentier and Jennifer Doudna won the Nobel Prize in Chemistry, in the year 2020, for their work on CRISPR technology, discovering one of gene technology's sharpest tools: the CRISPR/Cas9 genetic scissors.

Aging is a leading risk factor for a number of debilitating conditions, including heart disease, cancer and Alzheimer's disease, to name a few. This makes the need for anti-aging therapies all the more urgent. Now, Salk Institute researchers have developed a new gene therapy to help decelerate the aging process. I first learned of CRISPR in 2020 in an email investment offer in early 2020 from a site that I watch and learn about the next big future discovery. Since we were in the Covid scamdemic, I was curious. I purchased a small book *'CRISPR: A Powerful Way to Change DNA'*.

I have had an interest in genetics since my first wife died of Huntingdon's Disease and I had been wondering if the Covid scamdemic was related in any way. I look for three or four points of connection in determining whether there is a reason to study deeper. In the fall of 2020, Dr. Sherri Tenpenny reported that the Moderna and Pfizer vaccines had the spike or s-Protein (PEG) in the vaxx. If you follow the alternative news you know that it is the s-Protein that is causing serious heart problems and people are beginning to die of myocarditis and related side effects in huge numbers. Children as young as 8 and 11 have died recently of heart attacks within hours of being vaxxed. Also back in 2019 a number of scientists from Pfizer and other big pharma firms had been talking about "cracking the code" meaning the genome.

I am of the opinion that we are not likely to know the whole truth about Covid. The people behind it certainly made it difficult to determine what all were in the vaxxes, who got what, and what dosage levels, etc. Even now recent findings raise serious

questions about the vaxxes being tainted with various pathogens, being blamed on quality control and manufacturing processes. That may or may not be true, but the industry has been careless and negligent to the point law suits are being filed in such numbers that we can look for some like Pfizer to file bankruptcy as the vaxx uptake by the public is now less than 2%. SEC reports have shown that the executives of Pfizer had been dumping their stock as quietly and quickly as they could.

I may be wrong, but since I do read the reports and literature, it has occurred to me that the vaxxines are “gene” therapy, and not true vaccines, perhaps there was other experiments included into this soup mix. What I am saying is that the entire human population was being used as a giant lab experiment and everyone who submitted to getting the shots were in fact lab rats in a global experiment that has something to do with the technology enabling the s-Protein to be the core of the Nanoparticle technology. I have read enough of their literature, particularly Dr. Robert Malone who is one of those that invented the mRNA process. Two of his colleagues were given the Nobel Peace Prize recently for inventing the mRNA.

This year’s Nobel Prize in Physiology or Medicine goes to a transformative medical technology that significantly altered the path of the pandemic and saved millions: the mRNA vaccines against COVID. Katalin Karikó and Drew Weissman were jointly awarded the prize for advancements that have changed the field of vaccine development and researchers’ understanding of how messenger RNA (mRNA) interacts with the body’s immune system. This award is like rewarding a bank robber with the combination to the vault safe so that the next time he does not need to frighten the tellers. I know that I have devoted more than eight thousand hours of research, reading, on what I know still has never been proven to exist. The Covid scam was a Hegelian Dialectic tactic to frighten people to get an alleged vaccine which is patently “gene” therapy to modify and change the human DNA. Since the World Health Organization stated 20-million people worldwide have died from a virus that does not exist, but it was likely a “bioweapon”. In all of this there is a connection with the Bill Gates ID system that requires a microchip interface with the Cloud using 5G wireless energy.

Bill Gates' Microsoft filed the patent on March 20, 2020 to develop a cryptocurrency (called "666") that is distributed to people based on their bodily activity.

The idea behind it is to create a cryptocurrency that is connected to people's physical bodies. This system will be very different from the proof of work used for example by Bitcoin.

"A brain wave or body heat emitted by a user when he performs the task assigned by a server provider, such as watching advertisements or using some Internet services, can be used in the cryptocurrency mining process. Rather than the massive computational work required by some conventional cryptocurrency systems, the data generated based on body activity can become proof of the work

done, and therefore, a user can unconsciously solve the difficult computational calculation problem"

So when people carry out any daily activity (work, shopping, sports, etc.) they would automatically receive this cryptocurrency.

The centralized system that creates this crypto detects people's bodily activities and distributes money based on the person's tasks.

In the technical explanation of how the operating system would work, there is even attached a sort of explanatory scheme.

People are connected to the central unit called the "cryptocurrency system" which produces digital currency and distributes it through a communication network.

But how does the system in practice give this coin to connected users?

"A sensor communicatively linked or inserted into the user's device can detect the person's body activity. A cryptocurrency system connected to a person's device (mobile phones, computers or laptops) can check if the body activity meets the conditions required by the system and assign the cryptocurrency to the person whose body activity has been verified"

In other words, the system that creates the cryptocurrency decides whether to pay a person a certain amount of digital currency based on his / her body activity.

If the system, for any reason, believes that someone is not performing the assigned task correctly, that person will not receive anything.

For example, if someone does not watch enough TV advertising, they will run out of money.

The subcutaneous microchip could be the ideal tool to connect a person to this system that produces global currency. But not only that: also smartwatch type devices.

A curious aspect concerning the project lies in its patent number: WO2020060606.

The world of science and medicine have long believed in and have been engaged so they could one day achieve the discovery to what some have called it the Holy Grail of Immortality. Few people would be able to resist the Antichrist's gift of immortality rivaling the Creator Himself! What is unknown to the gullible public is evidence to the fact they can follow through with their lofty claims! The Isaiah 14:15 passage and the verses that follow suggest the Antichrist will fail and fail hugely.

The Antichrist Appears at the Beginning of the Tribulation

“And I saw when the Lamb opened one of the seven seals, and I heard one of the four living creatures saying as with a voice of thunder, Come.” –(Revelation 6:1)

“And I saw, and behold, a white horse, and he that sat thereon had a bow; and there was given unto him a crown: and he came forth conquering, and to conquer.” –(Revelation 6:2)

Since he is a counterfeit Christ he will have a natural birth and a supernatural birth.

The natural origin of Christ is that He was a product of a Jewish woman. The supernatural origin was the miraculous virgin birth by means of the power of the Holy Spirit. The result was the God-Man that we worship as Jesus of Nazareth that we know as the Messiah or Christ.

The Antichrist Will Be a Gentile:

He Will Be of Roman Origin:

“The person that makes the seven-year covenant with Israel whose people destroyed the Temple is the Antichrist.” –(Daniel 9:26-27)

His Supernatural Origin:

The supernatural origin of Antichrist is by means of a counterfeit virgin conception. The supernatural origin is found in Genesis 3:15.

“And I will put enmity between thee and the woman, and between thy seed and her seed; it shall bruise thy head, and thou shalt bruise his heel.” -(Genesis 3:15)

This verse gives the first prophecy of the coming of the Messiah. It also speaks to the coming of Antichrist. There are two pairs listed here.

Enmity between Satan and the woman

The second pair is the seeds of the Woman and the seed of Satan. The first satanic enmity with woman is shown in Genesis 6 where demons intermarry with human women attempting to stop the Messiah from coming. A worldwide flood stopped this attempt. It is important to note though that the second pair is the enmity between Satan's seed and the woman's seed. Women do not have the seed for procreation, men do. However, since Jesus was born of a virgin -(Isaiah 7:14) the expression her seed represents a miraculous conception.

The reference in this verse to Satan's seed implies a supernatural, miraculous conception too. From this passage then it can be deduced that Satan will someday impregnate a Roman woman who will give birth to Satan's seed who is going to be the Antichrist. The woman might not be a virgin because Scripture does not affirm this but he will be conceived through supernatural means. Consider 2nd Thessalonians 2:8-9.

“And then shall be revealed the lawless one, whom the Lord Jesus shall slay with the breath of his mouth, and bring to naught by the manifestation of his coming;” -(2nd Thessalonians 2:8)

“[even he], whose coming is according to the working of Satan with all power and signs and lying wonders” -(2nd Thessalonians 2:9)

The Greek word translated working is **energeo**, which means to energize. So then the coming of Antichrist will be brought about by the energizing of Satan. The counterfeit Son of the unholy Trinity will be brought about by a counterfeit virgin conception.

A time is coming when the events of Genesis 6 will be repeated. The fallen anointed Cherub Satan (Lucifer) will impregnate a Roman woman to give birth to Satan's son. The product of this conception will be a counterfeit god-man.

The Character and the Rise of the Antichrist:

Because of his close relative (father) Satan the Antichrist will have access to the satanic and demonic realm. He will accept the offer of Satan that Jesus refused when He was tempted in the wilderness. When he accepts Satan's offer of all the kingdoms of the

world it will start his rise to political power and world domination. The Church may be here to see his rise. We do not know when the rapture will occur. As I noted in the previous Blessed Hope, God has reason not to announce a date and events surrounding the COP28 dates infers it will be soon. It can happen any time before the Tribulation starts and that is sometime before the signing of the seven-year covenant with Israel recorded in Daniel 9:27.

Daniel describes him as a willful king, characterized by self-exultation above all men and self-deification by magnifying himself above even God. By deifying himself he will put himself above all humanity. He won't desire the love of women and therefore be inhuman toward women. Some have concluded that he will be a homosexual from (Daniel 11:37). Prince Charles has gone to great length and expense to expunge from the UK media concerning his predilection for young boys. The enmity of Satan against women will continue through Satan's seed. He will be under the total control of Satan. He will honor Satan. His policy will be "*might makes right.*" Then with the help of this foreign god, Satan he will take over the strongest defenses in the world appearing invulnerable. Those who give over themselves to his authority will be given status and authority in his kingdom. -(Revelation 13:17-18; **666**) He will divide territory he has conquered among those who will be loyal to him and confess him to be god.

One of his capabilities will be superb oratory skill while misleading the masses. Listening to Prince Charles delivering his public statements confirm his gift of speech. I try to listen to each of his addresses two or three times watching for his inflections in speech and inference.

This will be his chief satanic enablement. He will be able to sway the masses with "*great swelling words.*" Ian Kershaw in his biography of Adolph Hitler provided the following quote of his appraisal of Hitler's oratory skills. "*Hitler's frequently demonstrated diffidence and unease in dealings with individuals contrasted diametrically with his self-confident mastery in exploiting the emotions of his listeners in the theatrical setting of a major speech. He needed the orgasmic excitement which only the ecstatic masses could give him.*" Hitler himself quipped that "*I must have a crowd to speak.*"

So the Antichrist will be Satan -controlled and Satan energized who will set out to conquer the world. The first seal demonstrates the beginning of his conquest. He does not gain full control until the middle of the Great Tribulation. This then is the first of the four horsemen of the apocalypse -(Revelation 6:2) the rider on the white horse wearing a "**stephanos**" crown going out conquering and to conquer.

He Will Lead The Entire World

Antichrist in Daniel

One of the finest Bible scholars was the late Arthur W. Pink. When I was a resident pastor, I acquired all of his books. After reading his book on Genesis, I began regularly to add his works to my pastoral library. A.W. Pink had this to say about The Antichrist:

It is here that we find the fullest description of the Man of Sin. First, he is looked at under the figure of **"the little horn."** As there has been some dispute whether this expression really applies to him, we propose to examine the more carefully what is here said of **"the little horn."** Personally, we have long been convinced that this expression refers to none other than the Antichrist. There are a number of plain marks which make it comparatively easy to recognize his person, whenever Scripture brings him before us. For example: his insolent and blasphemous pride; his exalting himself against and above God; his impious and cruel warfare against the people of God; his sudden, terrible, and supernatural end. Let us compare these features with what is said of **"the little horn"** in Daniel 7 and 8.

We turn first to Daniel. 7. In vv.7 and 8 we read, **"After this I saw in the night visions, and behold a fourth beast, dreadful and terrible, and strong exceedingly; and it had great iron teeth: it devoured and brake in pieces, and stamped the residue with the feet of it: and it was diverse from all the beasts which were before it; and it had ten horns. I considered the horns, and, behold, there came up among them another little horn, before whom there were three of the first horns plucked up by the roots: and, behold, in this horn were eyes like the eyes of man, and a mouth speaking great things."** This refers to the rise of **"the little horn"** within the bounds of the Roman Empire, for that is what is represented by the **"fourth beast."** The first thing said of the little horn is that he has eyes like the eyes of man, which speak of intelligence, and a mouth speaking great things -- the Hebrew word signifies **"very great,"** and the reference is, no doubt, to his lofty pretensions and his daring blasphemies.

In 7:21 it is further said of him that he **"made war with the saints, and prevailed against them."** This contemplates his persecution of the godly Jews, and agrees perfectly with Revelation 13:7; **"And it was given unto him to make war with the saints, and to overcome them."** In v.25 we are told, **"He shall speak great words against the Most High."** Surely this serves to identify this **"little horn"** as the first beast of Revelation 13: **"And there was given unto him a mouth speaking great things and blasphemies"** (v.5). If further proof be needed, it is supplied by the remainder of verse 25: **"And shall wear out the saints of the Most High and they shall be given into his hand until a time and times and the dividing of time."** A **"time"** equals a year (see Daniel 4:23 and Revelation 12:14, and cf.12:6), so that a **"time and times and the dividing of time"** would be three and one-half years during which the saints are given into his hand. This corresponds exactly with Revelation 13:5, where of the first Beast, the Antichrist, it is said, **"And power was given unto him to continue forty and two months"** -- in a later chapter we shall give a number of proofs to show that the first Beast of Revelation 13 is the Antichrist.

In Daniel 8 the Little Horn is before us again, and that it is the same dread personage as in chapter 7 appears from what is predicted of him. First, he is referred to as **"a king of fierce countenance"** (8:23), which agrees with **"whose look was more stout than his fellows"** (7:20). Second, it is said of him that he **"waxed exceeding great (first) towards the south, and (second) towards the east, and (third) toward the pleasant**

land" (8:9), which agrees with **"there came up among them another little horn, before whom there were three of the first horns plucked up"** (7:8). Third, it is said that he **"shall destroy the mighty and the holy people"** (8:24), which agrees with **"and the same horn made war with the saints and prevailed against them"** (7:21). There should, then, be no doubt whatever that the **"little horn"** of Dan.7 and the **"little horn"** of Daniel 8 refer to one and the same person. Their moral features coincide: both, from an insignificant beginning, become great in the end: both persecute the people of God: both are stricken down by direct interposition of God. We may add that Messrs. B. W. Newton, James Inglis, G. H. Pember, Sir Robert Anderson, Drs. Tregilles, J. H. Brookes, Haldeman, and a host of other devout scholars and students, take the same view, namely, that the **"little horn"** of Daniel 7 and 8 and the Man of Sin is one and the same person.

Let us now consider briefly what is revealed concerning the Antichrist under this title of his, the **"little horn."** We confine our self to Daniel 8:23-25.

First, he is **"a king of fierce countenance."** This we believe is a literal description of his facial expression, though we are satisfied that it also has a moral significance. In Deuteronomy 28:50 we read of **"a nation of fierce countenance, which shall not regard the person of the old nor show favor to the young."** In the light of this scripture it seems clear that when the Antichrist is denominated the **"King of fierce countenance"** the reference is not only to his actual features, but that it also intimates he will be empowered to face the most perplexing and frightful dangers and the most appalling scenes of horror without flinching or blanching. It is significant that the reference in Deuteronomy 28:50 is to the Romans, while what is said of the Antichrist in Daniel 8:23 relates, specially, to his connections with Greece. The two dominant characteristics of these Powers will be combined in the Man of Sin. There will be concentrated in him the irresistible will of the Romans and the brilliant intellect of the Greeks. [Prince Charles father Philip was born in Corfu, Greece as a Prince of Greece and Demark.]

Second, we are told that he shall be able to **"understand dark sentences."** The Hebrew noun for "dark sentences" is used of Samson's riddle (Judges 14:12, of the Queen of Sheba's hard questions (1 Kings 10:1), and of the dark sayings of the wise (Proverbs 1:6), which are too profound to be understood by the simple. This characteristic of the King of fierce countance, that he shall be able to **"understand dark sentences,"** suggests an attempted rivalry of Christ as the Revealer of secret things. This is one of the fascinations by which the Antichrist will dazzle humanity. He will present himself as one in whom are hidden treasures of wisdom and knowledge. He will bewitch the world by his solutions of the enigmas of life, and most probably by his revelation of occult powers implanted in men hitherto unsuspected by most, and of forces and secrets of nature previously undiscovered.

Third, it is said **"And his power shall be mighty, but not by his own power"** (8:24). This is explained in Revelation 13:2, where we are told, **"And the Dragon gave him his power, and his throne, and great authority."** Just as we read of the Lord Jesus,

"The Father that dwelleth in Me, He doeth the works" (John 14:10), so shall the Son of Perdition perform his prodigies by power from his father, the Devil. This is exactly what 2 Thessalonians 2:9 declares, **"Whose coming is after the working of Satan with all power and signs and lying wonders."** Thus will men be deceived by the miracles he performs. [It is interesting that when Prince Charles was crowned Prince, his mother the Queen *"stated that it was the dragon who gave him his power."*]

Fourth, he will **"destroy wonderfully, and shall prosper, and practice, and shall destroy the mighty and the holy people"** (8:24). This has received enlargement in the previous chapter, where we have given several illustrations from the Psalms of the Antichrist persecuting Israel.

Fifth, **"And through his policy also he shall cause craft to prosper in his hand"** (8:25). The Hebrew word for "policy" denotes wisdom and understanding. It was the word used by David to Solomon, when he said, **"Only the Lord give thee wisdom"** (1 Chronicles 22:12), as it is also employed by Hiram when writing to Solomon: **"Blessed be the Lord God of Israel, that made heaven and earth, who hath given to David the king a wise son, endued with prudence"** (2 Chronicles 2:12). The Hebrew word for "craft" -- **"He shall cause craft to prosper"** -- is the one employed by Isaac when speaking to Esau concerning Jacob: **"Thy brother came with subtilty"** (Gen.27:35). It has in view the chicanery and treacherous methods the Antichrist will employ. **"By peace shall destroy many"** (v.25) refers to the fact that he will pose as the Prince of peace, and after gaining men's confidence -- particularly that of the Jews -- will take advantage of this to spring his bloody schemes upon them. [The term "craft" is a term that refers to Freemasonry of which Prince Charles is the senior Mason to which all other Masons are subject to.]

Sixth, it is said **"He shall also stand up against the Prince of princes"** (8:25). This unmistakably identifies him with the Beast of Revelation 19:19, where we are told, **"And I saw the Beast, and the kings of the earth, and their armies, gathered together to make war against Him that sat on the horse, and against His army."**

Seventh, **"But he shall be broken without hand"** (8:25). This expression means that he shall come to his doom without human intervention or instrumentality -- see Daniel 2:45; 2 Corinthians 5:1, etc. That the King of fierce countenance shall be broken without hand refers to his destruction by the Lord Himself -- **"And He shall smite the earth with the rod of His mouth, and with the breath of His lips shall He slay the Wicked"** (Isaiah 11:4).

We turn now to Daniel 9:26, 27. This forms a part of the celebrated prophecy of the seventy "weeks" or **hebdomads**. We cannot now attempt an exposition of the whole prophecy: sufficient to point out its principal divisions and examine that part of it which bears on our present theme.

The prophecy begins with v.24 and concerns the seventy hebdomads, a word signifying "sevens." Each **"hebdomad"** equals seven years, so that a period of 490 years in all is

here comprehended. These seventy "sevens" are divided into three portions: First, seven "sevens" which concerned the re-building of Jerusalem, following the Babylonian captivity. Second, sixty-two "sevens" unto **"Messiah the Prince,"** that is, unto the time when He formally presented Himself to Israel as their King: this receiving its fulfillment in the so-called **"Triumphal Entrance into Jerusalem."** Third, the last "seven" which is severed from the others. It should be carefully noted that we are expressly told that **"after threescore and two weeks** (which added to the preceding seven would make sixty-nine in all up to this point) **shall Messiah be cut off."** The reference is to the Cross when Christ was cut off from Israel and from the land of the living. This occurred after the sixty-ninth week before the seventieth began.

The sixty-ninth terminated with the formal presentation of Christ to Israel as their **"Prince."** This is described by Matthew (the distinctively Jewish Gospel) in chapter 21. The rejection of their Prince caused the break between Christ and Israel. It is very striking to note that (following the rejection) Matthew records three distinct proofs or evidences of this break. The first is found in Matt.21:19 in the cursing of the **"fig tree,"** which signified the rejection of the Nation. The second was His sorrowful announcement from the brow of Olivet that the time of Israel's visitation was past and her overthrow now certain (Matthew 23:37 and cf. Luke 19:41-44). This was the abandonment of the City. The third was His solemn pronouncement concerning the Temple: **"Behold your House is left unto you desolate. For I say unto you, Ye shall not see Me henceforth, till ye shall say, Blessed is He that cometh in the name of the Lord"** (Matthew 23:38, 39). This was the giving up of the Sanctuary.

The entire Christian dispensation (which began with the crucifixion of Christ) is passed by unnoticed in this prophecy of the **"seventy weeks."** It comes in, parenthetically, between the sixty-ninth and the seventieth. What follows in Daniel 9:26, 27 concerns what will happen after the Christian dispensation is ended when God again takes up Israel and accomplishes His purpose concerning them. This purpose will be accomplished by means of sore judgment which will be God's answer to Israel's rejection of His Son. But let us examine more closely the form this judgment will take.

The judgment of God upon the people who were primarily responsible for the cutting off of their Messiah was to issue in the destruction of their city and sanctuary (9:26). This destruction was to be brought about by the people of a Prince who should subsequently appear, and be himself destroyed. The Prince here is the Antichrist, but the Antichrist connected with and at the head of the Roman Empire in its final form. [4] Now we know that it in A.D. 70, but that **"the Prince"** here does not refer to the one who then headed the Roman armies is clear from the fact that Daniel 9:27 informs us this Prince is to play his part in the yet future seventieth week -- further proof is furnished in that v. 26 carries us to the end (i.e. of Israel's desolations) which is to be marked by a **"flood,"** and Isaiah 28:14, 15 intimates that this is to be after Israel's covenant with Antichrist: **"Wherefore hear the word of the Lord, ye scornful men, that rule this people which was in Jerusalem. Because ye have said, We have made a covenant with Death, and with Hell are we at agreement; when the overflowing scourge shall pass through it, it shall not come unto us: for we have made lies our refuge, and under falsehood**

have we hid ourselves." To this God replies, **"Your covenant with Death shall be disannulled, and your agreement with Hell shall not stand; when the overflowing scourge shall pass through, then ye shall be trodden down by it"** (v.18). The **"overflowing scourge"** is, literally, **"the scourge coming in like a flood."**

A few words remain to be said on 9:27: **"And he shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate."** The subject of this verse is the Antichrist, **"the Prince that shall come"** of the previous verse. By the time he appears on the scene large numbers of Jews will have been carried back to their land (cf. Isaiah 18). With them the Prince makes a covenant, as of old Jehovah made one with Abraham, and as Christ will yet do with Israel, see Jeremiah 31. This will be regarded by God with indignation, as a covenant with Death, and an agreement with Sheol. But while this covenant is accepted by the majority of the Jews, God will again reserve to Himself a remnant who will refuse to bow the knee to Baal: hence the qualification, **"He shall confirm the covenant with many,"** not all.

"In the midst of the week he shall cause the sacrifice and the oblation to cease."

The returned Jews will rebuild their temple and there offer sacrifices. But these, so far from being acceptable to God, will be an offense. There seems a clear reference to this in the opening verses of Isaiah 66, which describe conditions just before the Lord's appearing (see v.15). And here the Lord says, **"He that killeth an ox is as if he slew a man; he that sacrificeth a lamb, as if he cut off a dog's neck,"** etc. (v.3). But three and a half years before the end, the Prince will issue a decree demanding that the sacrifices must cease, and the worship of Jehovah be transferred to himself, for it is at this point he shall **"exalt himself above all that is called God, or that is worshipped"** (2 Thessalonians 2:4). The fact that we are here told that he causes the sacrifices and the oblation to cease, at once identifies this Prince of the Romans as the Antichrist -- cf.8:11. The remaining portion of 9:27 will be considered when we come to Matt.24:15.

We turn now to Daniel 11, which is undoubtedly the most difficult chapter in the book. It contains a prophecy which is remarkable for its fullness of details. Much of it has already received a most striking fulfillment, but like other prophecies, we are fully satisfied that this one yet awaits its final accomplishment. That Daniel 11 treats of the Antichrist all pre-millennial students are agreed, but as to how much of it refers to him there is considerable difference of opinion. A small minority, from whom we must dissent, confine the first thirty-five verses to the past. Others make the division in the middle of the chapter and regard all from v. 21 onwards as a description of the Man of Sin, and with them the writer is in hearty accord. A few consider the entire chapter, after v. 2, as containing a prediction of the Antichrist under the title of **"The King of the North,"** and while we are not prepared to unreservedly endorse this, yet it is fully allowed that there is not a little to be said in its favor.

We shall here confine our self to the second half of Daniel 11. Our present limits of space, however, will permit of nothing more than brief notes upon it. Commencing at v.31 we read, **"And in his estate shall stand up a vile person, to whom they shall not give the honor of the kingdom: but he shall come in peaceably, and obtain the kingdom by flatteries."** The history of this **"vile person"** is here divided into three parts: first, the means by which he obtains the kingdom: vv.21, 22; second, the interval which elapses between the time when he makes a covenant with Israel, the taking away of the daily sacrifice and the setting up of the abomination of desolation: vv.23-31; third, the brief season when he comes out in his true colors and enters upon his career of open defiance of God, reaching on to his destruction: vv.32-45. Thus from v.21 to the end of the chapter we have a continuous history of the Antichrist.

"In his estate shall stand up a vile person he shall come in peaceably, and obtain the kingdom by flatteries." This epithet **"the vile person"** is a manifest antithesis from **"the Holy One of God."** This twenty-first verse takes notice of the Man of Sin posing as the Prince of peace. He shall achieve what his antitype, Absalom, tried but failed to do -- **"Obtain the kingdom by flatteries."**

"And with the arms of a flood shall they be overflown from before him, and shall be broken; yea, also the Prince of the Covenant" (v.22). This Vile Person is denominated **"the Prince of the Covenant,"** which, at once, identifies him with the Prince of 9:26, 27. Then we are told in v.23 **"And after the league made with him he shall work deceitfully: for he shall come up, and shall become strong with a small people."** This "league" or "covenant" is doubtless the seven-years-treaty confirmed with Israel, which is made at an early point in the Antichrist's career, and which corresponds with the fact that at the first he appears as a **"little horn,"** the **"small people"** being the Syrians -- cf. our remarks on Daniel 8:8, 9 in chapter six.

Vv.25 and 26 describe his victory over the king of Egypt. Then, in v.28 we read, **"Then shall he return into his land with great riches."** His land is Assyria. The mention of great riches corresponds with what we are told of the Antichrist in Psalm 52:7; Ezekiel 28:4, etc.

"And arms shall stand on his part, and they shall pollute the sanctuary of strength and shall take away the daily sacrifice, and they shall place the abomination that maketh desolate." This is clear evidence that these verses are treating of that which takes place during the seventieth week. The mention of polluting the Sanctuary is an unmistakable reference to **"the abomination of desolation,"** i.e. the setting up of an idol to the Antichrist in the Temple. Note the repeated use of the plural pronoun in this verse; the **"they"** refer to the Antichrist and the False Prophet, cf. Rev.13. It is significant that in the next verse (v.32) there is an allusion made to the faithful remnant -- **"The people that do know their God."**

"And the king shall do according to his will; and he shall exalt himself, and magnify himself above every god, and shall speak marvelous things against the God of gods, and shall prosper till the indignation be accomplished: for that that

is determined shall be done" (v.36). That **"the King"** here is the **"Vile Person"** is not only indicated by the absence of any break in the prophecy, as also by the connecting **"and"** with which the verse opens, but is definitely established by the fact that in v.27 (note context) the Vile Person is expressly termed a **"king!"** The contents of this thirty-sixth verse clearly connects **"the king"** with the Man of Sin of 2 Thessalonians 2:3, 4, and also as definitely identifies him with the **"little horn"** -- cf.7:23 and 8:25. The remaining verses of Daniel 11 have been before us in previous chapters and need not detain us now. [The work for "king" in Daniel 11:37 is **"hammelek"** which could be the transition word for **"The Prince of the Covenant"**].

Dr. Sherri Tenpenny: More MASS DEATHS From COVID Kill Shots Still To Come

Well-known physician Dr. Sherri Tenpenny has warned of an impending increase of deaths caused by the Wuhan coronavirus (COVID-19) "vaccines" and boosters.

She discussed this matter during an appearance on the "Zeee Media" podcast with Australian independent journalist Maria Zeee. The podcast host remarked that the world is tragically seeing the deaths of young people, alongside an increase in deaths and disabilities among the working population. Zeee also noted that every country highly injected with the COVID-19 vaccines are seeing excess death rates soar.

Tenpenny, [an osteopathic medical doctor](#), then recounted a 2021 webinar about the dangers of the COVID-19 injections. After that webinar, she has since discovered 20 more mechanisms of injury caused by the vaccines. She then divided these into four categories. (Related: [Dr. Sherri Tenpenny warns of DEATH TSUNAMI caused by COVID-19 vaccines.](#))

The first category is the **acute sudden death of people**, which happens immediately or within two days after injection. Those who fell under this category died of cardiac arrest, pulmonary embolism, blood clots to the lungs and anaphylactic shock. According to Tenpenny, vaccination centers in the U.K. had to have crash carts as people were having anaphylactic shock post-injection.

The second category is the **spike protein disease**, which happens *"anywhere from six months to two to three years after the last shot that people got – whether they got one, two, three or more."* The host of *"The Tenpenny Files, On Your Health"* on [Brighteon.TV](#) elaborated: "It would be three to five years because it takes a while for that spike protein to be generated in your body and to go into your organs and cause all this harm that we are now seeing."

Rise in AUTOIMMUNE DISEASES projected in the next 7-10 years

The third category is **autoimmune disease**, which Tenpenny said will rise in all age groups within the next seven to 10 years. She spoke to two very prominent immunologists – one American and one British – and both warned of "big trouble" caused by the surge in autoimmune diseases.

According to Zee's guest, autoimmune diseases take time to show up. When they do, people are treated with steroids and different anti-inflammatory-type medications to shut it down.

Zee commented that these autoimmune diseases are caused by the SARS-CoV-2 spike protein that triggers serious inflammation in the body. Tenpenny agreed, adding that the antibodies created due to the spike protein, hydrogen, lipid nanoparticles and other components are also to blame. Autoimmune diseases involve the body's own immune system attacking its own organs such as the brain, heart and kidneys.

The fourth category is termed **catch-all diseases** and pertain to health issues such as infertility, turbo cancers, Alzheimer's disease, dementia and all the neurological complications that people are seeing. Various experts, including Texas-based cardiologist Dr. Peter McCullough and others, have warned of these vaccine-caused harms.

"That's what makes me dangerous – because I told the truth," Tenpenny told Zee. "I dug the stuff out of the medical literature. I did my very best to warn people, just like what you did – spent all your time trying to warn people."

Zee tragically lamented, however, that many did not listen to their warning about the COVID-19 vaccine. Nevertheless, Tenpenny ultimately called on people to never bow down and be coerced into getting injected with the COVID-19 shot.

John Kerry: 'We Must Sacrifice Billions of Humans To Save Planet Earth'

Hutton was a Scottish geologist, agriculturalist, chemical manufacturer, naturalist, physician, and philosopher who played a key role in establishing geology as a modern science. He was [an important contributor](#) to the Scottish Enlightenment. Hutton enjoyed the company of notable figures such as Sir James Hall of Dunglass, James Watt, Adam Smith, and Joseph Black.

“The Enlightenment transformed thinking to win acceptance of the principle that science-based evidence, not vested power promulgating its own tradition, is the foundation of the laws of the universe,” Kerry said.

According to the U.S. State Department [transcript](#) of his remarks, Kerry said:

“Despite a vast array of empirical facts beyond any shadow of reasonable doubt, despite thousands of scientists’ lifetime work accumulating hard data, and without a single piece of peer-reviewed, documentation to the contrary, we are again witnessing another moment in which the persuasive force of evidence and with it, Earth’s future hangs in the balance.”

“All because some extremist political voices, holdout nations, and vastly vested interests have declared war on facts and science.”

“All because they distort for political or personal gain what science and common sense dictate we humans must do to put our house in order.”

“They incite a movement against what they falsely label ‘climate change fanaticism,’ as they conveniently forget that the dictionary definition of a cult is the dismissal of facts in devotion to a lie.”

“While they refuse to accept the facts behind the increasingly obvious damages of the climate crisis, they lash out at the truth-tellers and label indisputable evidence as hysteria.”

“They compound the already difficult challenge of the climate crisis by promising to do more of exactly what created the crisis in the first place.”

Kerry then underscored his globalist anti-human agenda by declaring: “So now, humanity is inexorably threatened by humanity itself.”

Kerry’s comments invoked The Club of Rome’s 1991 publication which dishonestly claimed “*the common enemy of humanity is man.*”

The book published by the globalist think-tank Club of Rome in 1991 was titled “The First Global Revolution.” It followed up the earlier 1972 depopulation report from the Club of Rome titled “[The Limits to Growth.](#)” “*The Limits to Growth*” was co-authored by World Economic Forum (WEF) agenda architect Dennis Meadows.

“*The First Global Revolution*” was released shortly after the collapse of communism.

THE PROBLEMATIQUE: THE VACUUM

The scapegoat practice is as old as mankind itself. When things become too difficult at home, divert attention by adventure abroad. Bring the divided nation together to face an outside enemy, either a real one or else one invented for the purpose. [pg. 108]

Every state has been so used to classifying its neighbors as friend or foe that the sudden absence of traditional adversaries has left governments and public opinion with a great void. New enemies, therefore, have to be identified, new strategies imagined, new weapons devised. The new enemies may have changed in nature and location, but they are no less real. They threaten the whole human race and their names are pollution, water shortage, famine, malnutrition, illiteracy, unemployment.

However, it appears that awareness of the new enemies is, as yet, insufficient to elicit world cohesion and solidarity for the fight. [pg.108]

The Common Enemy of Humanity Is Man

In searching for a new enemy to unite us, we came up with the idea that pollution, the threat of global warming, water shortages, famine and the like would fit the bill. All these dangers are caused by human intervention and it is only through changed attitudes and behavior that they can be overcome. The real enemy, then, is humanity itself.

The comments from the “Climate Czar” come as Kerry has been leading the charge in the war against America’s food supply.

In the meantime, the World Economic Forum was taken over by the same group that is pushing Agenda 2030 at the UN, which Pascal calls *"The end of humanity."*

Last February, Pascal said of the International Health Regulations, *"Trump was good. He exited the WHO. If you can do that, that's the smartest thing to do. Just exit...It is a Fascist declaration."*

Israel allegedly strikes Syrian airports as additional northern Israeli towns are evacuated

After the city of Kiryat Shmona was evacuated, 14 more villages received evacuation orders.

As tensions on Israel's border with Lebanon continue to rise, foreign reports claim that Israel again attacked two major airports in Syria.

Airstrikes attributed to the Israeli Air Force put the airports of Damascus and Aleppo out of order on Sunday morning, according to reports by Syrian state media.

During the airstrikes, a civilian was killed and another wounded. Both the runways of the airports were damaged.

All flights in and out of the Damascus and Aleppo airports were either canceled or diverted to an airport near the town of Latakia, on the Mediterranean coast.

According to Syrian reports, both airports were struck by Israel on Oct. 12 and the Aleppo Airport was allegedly targeted again on October 14.

Israel does not comment on foreign reports about airstrikes across the Middle East, as per its policy.

Nevertheless, the IDF is thought to have struck thousands of targets in Lebanon and Syria to prevent weapons deliveries from Iran to Hezbollah, since the outbreak of the Syrian Civil War in 2011.

After Israel evacuated the city of Kiryat Shmona on Friday, in anticipation of the continued low-intensity warfare with Hezbollah along the northern border, the Ministry of Defense ordered the evacuation of 14 more border communities on Sunday.

So far, Israel has evacuated 28 communities located close to the border, while many residents of the area chose to evacuate on their own.

The 14 additional towns include both Jewish and Arab residents, including the Arab town of Arab al-Aramshe, which has come under attack several times since the outbreak of the war.

In the latest border skirmishes, one IDF soldier was seriously wounded and two others lightly injured by a Hezbollah missile attack near Bar'am. In addition, two Thai foreign workers were lightly wounded in an attack near Margalioth.

Israel responded with multiple airstrikes by drones and fighter jets.

I will repeat a statement that I have included in almost every Blessed Hope since the Hamas invasion of Israel proper began two weeks ago, and that is "When you read or hear that Damascus has been nuked and leveled, get ready to go home, as it will not be too long after that Russia and Iran invade and attack Israel." Isaiah 17:1 is the proof-text for my statement. Because the Bible tells us 'History told in Advance', (we have been told to call it prophecy) but it determines a number of important aspects of the Bible. Its only taken me thirty years to grasp this important truth about the Word of God

and after eleven years of college and seminary education. Most folks will not understand what is happening in the world, and even most church attending people are not taught a word about Bible prophecy in denominations that do not mention the phrase. I urge caution about what you hear, read, or see about what is happening right now in the Middle East. Do not fear what is coming. If you are a believer in the Lord Jesus Christ as your Lord and Saviour, you have nothing to be fearful of. You may not understand all the details, personalities, timing, circumstances, etc. God has your back and keep His Promise on your refrigerator, namely Revelation 3:10: ***“Because thou hast kept the word of my patience, I also will keep thee from the hour of temptation, which shall come upon all the world, to try them that dwell upon the earth.”***

As a confirmation of this you might put Isaiah 46:9-10 on the refrigerator door as well: ***“Remember the former things of old: for I am God, and there is none else; I am God, and there is none like me, ¹⁰Declaring the end from the beginning, and from ancient times the things that are not yet done, saying, My counsel shall stand, and I will do all my pleasure:”***

From the archives of Pastor Bob’s Studies on Deliverance before Judgment / Pre-Tribulation Rapture

In part one, a blueprint of the Grand Theme of the Bible was presented. That is God delivers before judgment. However, there is a caveat! To partake of this Grand Theme, it should not be concluded that no personal action is necessary. The present circumstance one finds themselves in today is similar to the case of a man at sea who has fallen overboard. When the lifesaving provision is presented, an urgent decision is needed. To save himself, he must make a choice. He has one choice only. He can choose either to take advantage of the lifesaving provision by accepting it or he can choose to reject it and permanently lose the offered provision. There is only one provision. My friends, herein lies the underlying message behind the ***“Unpardonable Sin”***. To reject this lifesaving opportunity is to condemn oneself to the ultimate loss and suffer the consequence of becoming a meal for sharks. In this case, the illustration refers to a permanent loss from which recovery is impossible. He may lose his life at sea, but resurrection under this circumstance will not be a part of the plan for choosing to reject this provision.

Deliverance is defined as *“a rescue from bondage, enslavement, or danger”*. As outlined in the Bible, redemption is an act of God whereby He delivers His people from certain peril. His people (Jew and Gentile alike) are marked for salvation by the choice they make and the subsequent action they take. In the Old Testament, deliverance primarily focused on God’s removal of those who found themselves in the midst of trouble and

danger. He stepped in to liberate His people (Israelites) from their enemies. The most striking example of deliverance is that of the Exodus -(Exodus 3:8; 7:6; 6:10-13). Here, God is defined as the “Deliverer” of Israel who rescues His people. This is not because they deserved to be scooped up and saved, but because the act of redeeming is an expression of His grace, mercy and love. Furthermore, this experience provides an unfolding glimpse into God’s future plan for redemption. -(Psalm 61:1-3; 71:1-5; 86:13).

In the New Testament, God is always the subject – and His people are always the object of deliverance. The description of physical, earthly deliverance in the Old Testament as a symbolic representation of the spiritual deliverance from sin which is available only through Jesus Christ is basic training and is amplified in the New Testament. Today, He offers deliverance from mankind’s greatest peril – sin, evil, death, and judgment.

Through God’s power, believers (Jew and Gentile) are delivered from this present evil age -(Galatians 1:4) and from the power of Satan’s reign -(Colossians 1:13). All aspects of deliverance (spiritual, mental, emotional and physical) are available only through the person and work of Jesus Christ, who was Himself delivered up for us -(Romans 4:25) so that all could partake of the opportunity of deliverance from the eternal punishment resulting from sin. Only Jesus Christ can rescue us from the **“wrath to come”** - (1st Thessalonians 1:10). This is where choice plays a role in the future outcome for unbelievers.

Another aspect of deliverance concerns the earthly walk. While believers are delivered once for all time from eternal punishment, we are also delivered from the trials and temptations of this life -(2nd Peter 2:9). Sometimes that deliverance means that God simply walks by our side through the trials, comforting and encouraging us through them while He uses them to mature us in faith. Paul reassures the Corinthian believers, explaining how God accomplishes this: **“no temptation has seized you except what is common to man. And God is faithful, but He will not let you be tempted beyond what you can bear. But when you are tempted, He will also provide a way out so that you can stand up under it”**. -(1st Corinthians 10:13). Rescue is not always immediate, but comes in due time after patience has had its ‘perfect work’ -(James 1:2-4, 12). It is not our nature to endure. When it comes to trials, we would rather escape, explain, or exit the difficulty. In fact, we will tend to do almost anything to avoid enduring a trial.

Faithful endurance, however, generates whole people, recognized as strong in character, or mature. We will be seasoned, experienced, well-developed, fit for the tasks God sent us into the world to do. This strength is a quality developed by how much we have learned from the trials we have experienced. Weaknesses and imperfections are being removed from our character; we are gaining victory over old sins; we are demonstrating a sense of competence about life. This completeness relates to the breadth of our experience. God makes the way of escape available simultaneously at the same time as the temptation which, is in His perfect will and timing. In this way, He permissively arranges or allows for His people.

Deliverance is often sought from evil spirits and their influence over fleshly weaknesses. As believers, it is important to remember that we already have eternal victory over Satan and his demons. By using the weapons God has supplied to us as spiritual armor, we can be delivered from these influences in our lives. Our battle is against the powers of darkness and against the spiritual forces of evil in the heavenly realms: ***“For we do not wrestle against flesh and blood, but against principalities, against powers, against the world's rulers, of the darkness of this age, against spiritual wickedness in high places. Therefore take to yourselves the whole armor of God that you may be able to withstand in the evil day, and having done all, to stand. Therefore stand, having your loins girded about with truth, and having on the breastplate of righteousness and your feet shod with the preparation of the gospel of peace. Above all, take the shield of faith, with which you shall be able to quench all the fiery darts of the wicked. And take the helmet of salvation, and the sword of the Spirit, which is the Word of God, praying always with all prayer and supplication in the Spirit, and watching to this very thing with all perseverance and supplication for all saints.”*** -(Ephesians 6:12-18)

A believer defends himself using the shield of faith to protect his heart while applying the offensive weapon of the sword of the Spirit or the Word of God. Against these two, no evil spirit can prevail. By holding up the shield of faith, we extinguish the flaming spiritual arrows Satan and his demons hurl against us - arrows of lust, doubt, guilt, jealousy, evil speech, and all manner of temptation. With the sword of the Spirit or the Word of God, we can overcome the devil by proving his temptations to be lies. No matter how elaborate his schemes, he is still the father of lies -(John 8:44). John's second letter commends young Christians whose spiritual strength came from the Word of God living within them. By utilizing the offensive weapon of the Truth, we overcome the evil one's attempts to weaken resolve. -(1st John 2:14b).

Deliverance from sin, rescue from trials, and escape from the influence of a world under Satan's control can only be accomplished by remaining in close alliance with Christ Jesus, the Son of God. He is the one who by means of the Holy Spirit residing within us has given us understanding, so that we may truly know Him. ***“We know that we are of God, and all the world lies in evil. And we know that the Son of God has come, and He has given us an understanding so that we may know Him who is true. And we are in Him that is true, in His Son Jesus Christ. This is the true God, and the everlasting life.”*** -(1st John 5:19-20).

Keep in mind that Roman Catholicism is responsible for snuffing out the early church's interpretive structure of Dispensationalism, and the teaching of a Pre-Tribulation Rapture which includes “Deliverance before Judgment”. Dispensationalism is a theological system that recognizes these ages ordained by God to order the affairs of the world. It has two primary distinctions:

- A consistently literal interpretation of Scripture, especially Bible prophecy, and
- A view of the uniqueness of Israel as separate from the church in God's program

It was Roman Catholicism that adopted the erroneous belief that the church replaced Israel in God's Plans. This new position made whatever views related to the Pre-Tribulation Rapture virtually impossible to teach as an accurate Biblical interpretation. Further, once Augustine adopted the "Amillennial" position meaning the rejection of the belief that Jesus will have a literal, thousand-year-long, physical reign on the earth, there could be no further development of prophetic viewpoints. Open discussions related to the Pre-Tribulation Rapture in the church were curtailed. The Roman Catholic Institution would not tolerate doctrine alternatives or a sincere, truthful exploration into the accuracy of Biblical teachings. Anyone possessing views other than that advocated by Rome or which differed from Catholic doctrine at any point thereafter was burned at the stake for heresy, along with their writings.

Now we find Pope Francis slamming fundamentalism across religions attacking the fundamental doctrines of the Bible and claiming they are heresy. He further added that fundamentalism is more idolatry than actual religion, warning that 'ideas and false certainties' can take the place of faith, love, and God. Concerning the ministry of Jesus, he has been quoted as saying: *"And if at times our efforts and works seem to fail and produce no fruit, we need to remember that we are followers of Jesus... and his life, humanly speaking, ended in failure, the failure of the cross."* Does that mean that we can be comforted by knowing we all fail, including Jesus? Or does it mean, from a human (godless one's) perspective, that Jesus was viewed as a failure? What is he saying? The conciliatory words spoken by Pope Francis that Catholics and atheists can be "precious allies... to defend the dignity of man, in the building of a peaceful coexistence between peoples and in the careful protection of creation" have been taken by many to mean he is teaching everyone—even atheists—will go to heaven. Is this what Pope Francis meant? As of early 2016, Pope Francis has rejected, revised, or disassociated the Roman Catholic Institution from sound Bible doctrine which has existed for centuries.

The pope is never flippant in his remarks. He smothers his words in generalities but maintains his point in such a way as not to be lost on his audience. As a Jesuit, he is methodical, deliberate, and conveys his points in obscurities and general comments. Pope Francis is cunning in ways that are lost on the ears of his flock but remain pointed when it comes to his adversaries. He is a "false prophet," if not the "False Prophet".

The point of this series is to present the Biblical case for the "Pre-Tribulation" Rapture and God's Master Plan of "Deliverance before Judgment".

The "Great Tribulation" period of "Seven" years is deeply misunderstood by most Bible students. The distinction between 'tribulation' in general, and the Biblical definition of the Great Tribulation, is extremely important. Much of the confusion about the Rapture of Jesus Christ's Bride (the Church), and when it occurs could easily be resolved if we clarify what actually develops during this "Seven" year period known as the "Great Tribulation" which Jesus spoke of in Matthew 24:21. In this same chapter He references Daniel 12:1. It is not just 'tribulation' as the church has experienced during the past 2,000 years, or even in the last 20 years. History tells us that the saints have been

martyred by the thousands. They have been sawn asunder, fed to the lions, watched their own children slaughtered before their eyes, and suffered untold deprivations simply for believing in Jesus. The gates of hell have beaten the church with indescribable vengeance, but neither Satan nor his demons have been able to eliminate her testimony or destroy the Biblical evidence revealing the truth of God's Plan for mankind. The true church of Jesus Christ lives on as a remnant of blood-washed saints, who still love holiness and who respectfully recognize the sovereignty of the Lord. Instead, they count it all as great joy spoken of by James: ***“My brethren, count it all joy when you fall into various trials, knowing that the testing of your faith produces patience. But let patience have its perfect work, that you may be perfect and complete, lacking nothing.”*** -(James 1:2-4).

To think of the “Great Tribulation” as nothing more than what the saints have already suffered is to totally miss the truth of the Bible. The devil has made every effort to silence the voice of God's saints using indescribable hatred, and that hatred will grow as the end approaches. In fact, Satan will continue to direct his hatred towards anyone who confesses Jesus Christ, and especially so after the final “Seven” years begin. The Jewish people will reap their last great sorrow during this period as Satan together with his cohorts, the Antichrist, and the False Prophet unleash the fury of their vengeance against God's chosen nation through which Jesus Christ came some 2,000 years ago. Satan's primary hatred has always been focused on the Jews first and then the followers or the church of Jesus Christ.

After the Rapture, the ‘Great Tribulation’ will be a specific, final onetime event covering a seven-year period of time that is far graver. It will release a tremendous outpouring of Satan's rage against the Jews and those who confess Jesus Christ and it will be like nothing that has occurred prior to this time. This period is the time of God's wrath upon a world of ungodly people. To date, the only other precedents noted in mankind's history are the worldwide flood of Noah's generation and the destruction of the cities of Sodom and Gomorrah.

This final event of God's wrath will be the ultimate judgment upon a wicked world. It will most certainly surpass the two prior events not only in intensity, but also in finality. Jesus made it perfectly clear in Matthew 24 that this is the final act of judgment against the vileness of human sin. ***“For then shall be great tribulation, such as was not since the beginning of the world to this time, no, nor ever shall be. And except those days be shortened, there should no flesh be saved: but for the elect's sake those days shall be shortened”.*** -(Matthew 24:21-22).

specific teaching of the Bible is so simple and basic that even a child can understand its message.

- **Typology:** a doctrine of theological types; especially one holding that things in Christian belief are prefigured or symbolized by things in the Old Testament.
- **Parable:** a succinct, educational story, in prose or verse, which illustrates one or more instructive lessons or principles.
- **Similitude:** an imaginative comparison; simile.
- **Object Lesson:** a teaching method that consists of using a physical object or visual aid as a discussion piece for a lesson.
