Israel soldiers angry at Netanyahu's US-based son – Times

The prime minister's son has "abandoned" his country for Florida, several reservists have said

Prime Minister Benjamin Netanyahu's son Yair is not among the 300,000 reservists mobilized for the war with Hamas, but remains in Florida doing nonprofit charity work. Several Israeli soldiers feel this is a betrayal, according to the Times of London.

"Yair is enjoying his life at Miami Beach while I'm on the front lines," one soldier, a volunteer facing Hezbollah on the border with Lebanon, told the British newspaper. Requesting anonymity for security reasons, the soldier complained that "the people responsible for this situation" aren't shouldering their share of the burden, fueling "distrust and anger" in the ranks.

"Our brothers, our fathers, sons, are all going to the front line, but Yair is still not here. It does not help build trust in the leadership of the country," the soldier told the 'Times'.

Another soldier, who volunteered and is preparing to deploy to the southern front against Hamas, said he flew back from the U.S. and left his job, life, and family.

"There is no way I can stay there and abandon my country, my people, at this critical time. Where is the prime minister's son? Why isn't he in Israel?" the soldier said. "It is the most uniting moment for us as Israelis in our recent history and every single one of us should be here right now, including the prime minister's son."

All Israelis are subject to compulsory military service and reserve call-up until the age of 40. Yair Netanyahu is 32. However, his service in the Israel Defense Force (IDF) was as a spokesman, not a combat soldier.

The prime minister's son moved to the U.S. earlier this year, after making social media posts criticizing Israelis who protested against his father's judicial reforms as "terrorists" and accusing the U.S. of funding the turmoil.

His Instagram page now raises funds for NGOs helping some 120,000 Israelis evacuated from the north and the south of the country since the Hamas attack. A photo used by the Times showed Yair Netanyahu handling aid packages at the warehouse of Yedidim USA, a Jewish charity in Fort Lauderdale.

Close to 360,000 Israelis have been called up, or volunteered, for military or support service in the "war" Netanyahu declared on Hamas in the aftermath of the October 7 Hamas incursion, which resulted in an estimated 1,400 Israeli deaths. The government in West Jerusalem has vowed to "wipe out" the Palestinian group based in Gaza.

Japan Releases Evidence That ALL COVID Variants Were Engineered in Biolabs

An official new study out of Japan has concluded that all Covid variants were engineered in bio-labs and intentionally released into the public. The mainstream media has recently ramped up reports that Covid cases are on the rise in the run-up to the 2024 election.

Mainstream journalists and health officials have been promoting the return of masks and vaccines to tackle the spread of new variants EG.5.1 and BA.X. However, a recent Japanese study suggests that the plot to lockdown the public again may be part of a sinister plan to take away more of our personal freedoms.

NN reports: The study found that all previous variants of SARS-CoV-2, the virus that causes COVID-19, were not naturally occurring but were, in fact, made in a laboratory.

Presumably, the latest EG.5.1 and BA.X variants were also engineered in a lab, according to the study. The study was led by renowned Japanese Professors Atsuki Tanaka and Takayuki Miyazawa of Osaka Medical University and Kyoto University. Tanaka and Miyazawa wanted to trace the historical evolution of the omicron variant of SARS-CoV2.

To trace the variant's origins, they studied viral sequences found "in the wild" and deposited in public databases. In doing this they found around 100 separate omicron subvariants that could not conceivably have arisen through natural processes. The existence of these variants seems to provide definitive proof of large-scale lab creation and release of COVID-19 viruses.

Moreover, the variants appear to form comprehensive panels of mutations typical of those used in "reverse genetics" experiments to systematically test the properties of different parts of viruses, Substacker **PSMI wrote**.

Professors Tanaka and Miyazawa's new paper is called: "<u>Unnaturalness in the Evolution Process of the SARS-CoV-2 variants and the possibility of deliberate natural selection</u>."

"In this study, we aimed to clarify the evolutionary processes leading to the formation of SARS-CoV-2 Omicron variants, focusing on Omicron variants with many amino acid mutations in the spike protein among SARS-CoV-2 isolates," Tanaka and Miyazawa explain in their paper.

"To determine the order in which the mutations leading to the formation of the SARS-CoV-2 Omicron variants, we compared the sequences of 129 Omicron BA.1-related isolates, 141 BA.1.1-related isolates, and 122 BA.2-related isolates, and tried to dissolve the evolutionary processes of the SARS-CoV-2 Omicron variants, including the order of mutations leading to the formation of the SARS-CoV-2 Omicron variants and the occurrence of homologous recombination."

"As a result, we concluded that the formations of a part of Omicron isolates BA.1, BA.1.1, and BA.2 were not the products of genome evolution as is commonly observed in nature."

These findings confirm that the variants could not have occurred naturally.

"The analysis we have shown here is that the Omicron variants are formed by an entirely new mechanism that cannot be explained by previous biology," they assert. They continue by further explaining the findings.

"In the genetic variation in the S protein in these variants, most of the mutations were non-synonymous," the paper continues.

"There were no synonymous mutations in the Alpha, Beta, Gamma, Delta, or Mu variants, but only one each in the Lambda and Omicron variants."

"Among these variants, the Omicron variant (BA.1 lineage), which shows the greatest accumulation of mutations in the S protein, is primarily non-synonymous in the S protein and has only one synonymous mutation at c25000u."

"The synonymous/non-synonymous ratio is abnormal, given how human coronaviruses have mutated."

In this context, "synonymous" normally refers to something that mutates naturally. A "synonymous" mutation does so mostly in ways that don't change the nature of the original.

Therefore, when you have a "synonymous/non-synonymous ratio" that is as "abnormal" as that of the Covid variants, that means they are not occurring naturally.

"The fact that most of these mutations occurred without synonymous mutations suggests that none of these mutations arose as a result of trial-and-error random mutations in nature," Tanaka and Miyazawa explain.

According to the professors' findings, COVID-19 and all of its variants came from a lab.

"Suppose the SARS-CoV-2 Omicron variant and its one amino acid reversion mutants were artificially and systematically generated," they further clarify.

"In that case, we should suspect that the other variants (Alpha to Delta) may also be artificially generated viruses."

They continue by raising questions about who may have engineered the virus and why.

"One idea, the hypothesis that these viruses were artificially generated, is more reasonable than proposing a novel mutation acquisition mechanism," the paper reads.

"However, is there any reason to artificially create these mutants, which are unlikely to have occurred naturally, given the current SARS-CoV-2 epidemic?"

The scientists draw the line at making allegations about the Covid pandemic being intentionally triggered, however. They argue that making such judgments falls outside of their area of expertise.

"It is inimical to virus research to consider that artificially synthesized viruses were deliberately spread throughout the world," they note.

"Furthermore, we do not conclude that these viruses were artificially synthesized and distributed based on malicious intent."

Nevertheless, they assert that the variants could not have formed naturally, meaning they could have only been engineered in a lab.

"The analysis we have shown here concludes that the Omicron variants are formed by a completely new mechanism that cannot be explained by previous biology," they conclude.

In summary, the new Japanese paper states:

From the archives of Pastor Bob's Studies on Deliverance before Judgment / Pre-Tribulation Rapture Why The Rapture Occurs Before the Revealing of the Antichrist!

Part 4 offers the believer in Jesus Christ great hope that our belief is not in vain, particularly concerning the Pre-Tribulation Rapture. Hopefully what was shared in Part 4 will aid in the understanding about why so many struggle with the teaching simply because the word "Rapture" is not mentioned in Scripture. Still, we can be confident that "Deliverance comes before Judgment". Followers of Jesus Christ have no need whatsoever to fear the Great Tribulation. As noted, critics argue that we will go through part or all of the Great Tribulation.

The "Blessed Hope" for the church is under attack from many sides, and this is easy to explain. We are living at a time when the spirit of this age wants to destroy our Christian faith. Lucifer hates the Pre-Tribulation doctrine. Why? Because it heightens a sense of urgency for this time period in which we see undeniable evidence of all the signs spoken of in Scripture pertaining to the last days. It is crystal clear that these signs are progressing and increasing worldwide as fulfillment occurs around the world. All of these magnify our need to remain standing and vigilant. They remind us to prepare, to don the full suit of armor spoken of by the Apostle Paul, to diligently persist, to be about working out our salvation. They increase our awareness of the nearness of Jesus' Second Coming.

An analogy for the Pre-Tribulation Rapture reminds me about what occurs when two countries go to war. Few folks today recall the events that took place on December 7, 1941. President Roosevelt called Congress into session to make a formal declaration of war against Japan and the Axis powers of Germany and Italy. Before the President unleashed the full wrath of the American war machine on those nations, he first took measures to recall the U.S. ambassador's home from Japan, Germany, and Italy. This action was a strategic move revealing the President's concern for the well-being and safety of those Americans serving in the diplomatic corps.

Before unleashing the wrath of America's military might in a declared state of war, it is customary protocol to withdraw American civilians from harm's way first. The wrath of America was reserved for her enemies. It was not directed toward her own people. In the same identical way, before God declares war on this godless world at the Tribulation and unleashes His unmitigated wrath, God will also call His Ambassadors home. It is similar to what Paul states, "Now then we are <u>ambassadors</u> for Christ, as though God did beseech you by us, we pray you in Christ's stead, be ye reconciled to God" -(2nd Corinthians 5:20).

God's wrath is not for the citizens of His heavenly kingdom (the Bride or Church – made up of both Jew and Gentile). During the Berlin crisis in the 1950's, I was serving a three-year+ enlistment (deployment) in West Germany with a nuclear artillery battalion. Our mission as part of the 7th Army command was to hold the West German border. We were tasked with the mission of holding the Fulda Gap (a geographical area through which the Russian's armored forces invaded Germany in World War II) for 72-hours in order to insure that all civilian personnel, military dependents, and their children were evacuated to the safety of the UK or stateside. This experience was unnerving, to say the least. The troops all kept what were known as "short-timer's" calendars. We anxiously counted off the days until we received a port-call for our departure date. Relief was not fully realized until we touched down at McGuire Air Force Base at nearby Fort Dix, NJ. Until then, we remained on high alert and at the ready!

While tribulation abounds worldwide, this analogy serves as a poignant reminder for us as we anxiously await the Rapture. Hilton Sutton once said, "When the bombs are descending, the saints will be ascending." I have no doubt that the tension over world events will increase in frequency and become progressively worse throughout the remainder of this year. But our "short-timer" calendar is marked for departure. We are going home in Pre-Tribulation Rapture style! My friend, that is our "Blessed Hope" – Don't doubt for one moment that the Bride (Church) is going to go through any portion or all of the Great Tribulation.

Keep in mind that Lucifer wants to sow seeds of doubt in the minds of those who have found faith in Christ. As a result, believers find themselves under constant spiritual warfare because the adversary is a sore loser. He wants to retrieve his former followers. How does he do this exactly? What is his strategy? Old temptations or vices are flashed in the minds or the hearts, or the environment of those who have dealt with addiction of one kind or another. Those once addicted are always at risk of falling off the wagon so

to speak. Satan seeks to find the weakest point in an attempt to break our shield of faith -(Ephesians 6:16). Then he can lay a guilt trip on a believer making them think they are unworthy of God's grace, etc. This makes them prime game and they end up falling prey to Lucifer's schemes.

This is a war of supernatural proportions. The message of salvation and redemption is extended to all who are willing to place their trust in Jesus Christ. The Pre-Tribulation Rapture is part of that message. But, that does not keep Lucifer from using those around us to sow seeds of doubt in the minds of believers. If Lucifer can weaken your faith by sowing seeds of doubt, he has already begun to eat your lunch and kill your joy. Remember the crafty implication of his words when he spoke in the Garden to Eve, "Yea, hath God said?"

The KJV text implies a subtle, sinister question about God's motive. The serpent's temptation began with a question. Satan still begins that way. "Yea" he says, (as if to say indeed, really?); he slyly intimates surprise and astonishment. His question attempts to imply that the love of God is flawed in some way. He cunningly suggests, "How could God keep any good thing from you if He loves you?" He wants to draw attention away from all the good things they could have and instead focus attention on the one thing they could not have. Satan still does this today. He has not changed his basic methods, and we need to learn from this. If you read the text, God even went so far as to tell them not to touch the tree.

The serpent did not have to force the woman to take the forbidden fruit. Once she gave her attention to it and spent some time contemplating it, the fruit began to look so good to her that she found herself drawn to it like a magnet. This is where the New Testament identifies the lust of the flesh. It is an out of balance craving sinful persons have for physical benefit and pleasure. This appearance of being pleasant to the eyes, leads to the lust of the eyes that focuses on visual attraction despite its destructive results, and the desire to make one wise, the third aspect being the pride of life. -(1 John 2:16).

But this event did not make them like God at all. Their eyes were opened. Instead it filled them with guilt and shame and they became painfully conscious of the fact that they were naked! This then led to the "blame game"!

We haven't seen such an attack on the doctrine of the Pre-Tribulation Rapture, since Hal Lindsey's book, 'The Late Great Planet Earth'. Some years back, I was a member of the original team that put the King James Bible onto computer tape in 1963-1964. It was because of that experience that I became a student of the Bible and have been for 54 years. With the invention of high-speed IBM computers, we were able to achieve something that previously took weeks and months of time to accomplish. Back then, the University of Pittsburgh's computing center housed an IBM-showcase of 7070/7090/360/1410/1401 computer systems. We could perform search functions in minutes on computer when something like a comprehensive search once required weeks of manual labor pouring over volumes of books before answers were attainable. I came to faith and salvation through the Lord Jesus Christ as a result of that providential

event and because I was part of such a fortuitous event, it led to a career change. In just a matter of a few months, I shifted my focus to ministry and enrolled full time at Waynesburg College. Shortly thereafter, I became a student pastor of three small rural Methodist churches. It was a remarkable landmark date in my journey of faith.

Shortly thereafter I was to witness firsthand another significant event. Following the Six-Day War of 1967, the Grand Orient Lodge of Freemasonry had placed an order for 60,000 tons of Bedford, Indiana limestone blocks for the future Third Temple in Israel. It was the subject of an article in the August, 1967 issue of 'Christianity Today', the flagship publication of Rev. Billy Graham. By late summer of 1969, my three-year-old son and I often found ourselves parked near the west end of the Pennsylvania Railroad's Pitcairn Yard to watch the trains coming and going. On Friday and Saturday mornings, we witnessed gondola cars displaying signs on the sides of each car bearing the words: "Destination: Kearney, NJ, for Export to Israel". The open-top gondolas carried from two to six limestone blocks, each spray painted with neon orange letter/number combinations. The significance of this fact affirms that they were cut to predesigned architect's plans. Those stones are now, without a doubt, not far from the Temple Mount today. However, no one contemplated that Israel would try to secure peace and transfer custodial care to the Jordanian government.

I've been a student of Bible prophecy since June 8, 1967, following the Israeli 6-Day War. That date was another benchmark for me in my walk of faith and study of the Word of God. June 7, 1967 is the definitive date of Israel's control over the national capital of Israel and Jerusalem. Historically, it marked interest in the Biblical theme of Jubilee cycles. It offers the greatest living proof revealing that God has not abandoned Israel or the Jewish people.

None of the academic institutions where I received my academic degrees taught Bible prophecy to their students. In fact, students were admonished not to even talk about Bible prophecy. The absence from their curriculum of such an important topic forced me to go outside my denomination, the United Methodist Church, to discover this evidence found in God's Word. The failure of mainstream denominations to teach or offer courses on Bible prophecy is both tragic and sad. We live at the end of the end days. Few pastors are competent enough today to teach on Bible prophecy, or answer the questions their congregation has with regards to them.

As noted in an earlier segment, the term for "Rapture" is found in the Old Testament and is shown by the use of the Hebrew word "Natzal" along with its many derivatives numbering around 620X times. The Greek word "Harpazo", which means to "take by force" is found in the New Testament. The Hebrew word for "Natsal" shown here has almost the same meaning: to "deliver by force".

In a coming segment, I will cover in more detail the use of the Greek word "Harpazo" and how it is used in the New Testament to describe the expression to "deliver or take by force". Before moving to that portion of this study, we need to look at a number of Biblical passages which speak to God's pattern of "Deliverance before Judgment". I tried carefully not to make a mistake in my typing here. In some instances, the theme is masked as such but the Biblical text validates the subtle facts.

Peer-Reviewed Study Finds 'Hundreds of Billions of DNA Molecules Per Dose' in mRNA Covid Jabs

A new peer-reviewed scientific study has found the "presence of billions to hundreds of billions of DNA molecules per dose" in both Pfizer and Moderna mRNA vaccines, directly contradicting the information given to the public by governments and regulators about the contents of the jabs.

A pre-print of the highly-anticipated new study by researchers at the University of Guelph in Canada <u>published</u> on October 18 outlined the investigation into the "exploratory dose response relationship with serious adverse events."

The study concludes "the data demonstrates the presence of billions to hundreds of billions of 61 DNA molecules per dose in these vaccines. Using fluorometry, all vaccines exceed the 62 guidelines for residual DNA set by FDA and WHO of 10 ng/dose by 188–509-fold."

These findings are cause for concern because governments and regulators around the world have consistently reassured the public that both Moderna and Pfizer's experimental COVID vaccines do not modify an individual's DNA.

This is because, according to the regulator's explanation, the vaccines contain only mRNA instead of DNA.

However, in early 2023, researchers began to find evidence that disputes the official narrative regarding the mRNA vaccines that were pushed on the public en masse during the pandemic.

As PharmaFiles <u>reports</u>, the scientific community has been slowly but surely inching towards disclosure regarding the fact that mRNA vaccines may not be what governments and regulators told us they are.

Kevin's findings were **eventually reproduced across several independent labs**, one of which is run by Dr. Phillip Buckhaults, a molecular biologist and cancer genomics expert from the University of South Carolina. **Dr. Buckhaults was alarmed at the findings of DNA contaminants**, and what's admirable about him is his courage to address what he found, despite being seen as "pro-mRNA" (as evident in the clip above, Dr. Buckhaults is a fan of mRNA technology).

The problem with the "vaxxers and antivaxxers" war is that it has become so toxic that nobody wants to investigate anything for fear of being attacked or having their careers and livelihoods derailed for speaking out against the "official narrative."

On September 14, 2023, Dr. Phillip Buckhaults testified before the South Carolina Senate Medical Affairs Ad-Hoc Committee, shedding light on the issue. **Expressing surprise at the presence of DNA Contaminants in the vaccines**, Dr. Buckhaults highlighted the urgent need for thorough investigations. Furthermore, he acknowledged the challenges in determining the cause of suspicious deaths following vaccination, making it difficult to attribute them to COVID or the vaccines themselves.

Dr. Buckhaults proposed that further investigation and genetic analysis of vaccinated individuals, specifically examining stem cells, should occur to identify any potential genetic modifications. **Integrating plasmid DNA into the genomes of stem cells can leave lasting effects** such as cancer and autoimmune diseases, raising concerns about the **long-term impact** of the vaccine.

With regard to booster shots, Dr. Buckhaults expressed **his hesitation to receive them** until he can ensure they do not contain DNA plasmids. This cautious approach underscores the need for careful evaluation and verification of the CDC-recommended booster shots.

Dr. Buckhaults' testimony garnered the interest of renowned doctors like Dr. Wafik S. El-Deiry, who raised his personal concerns regarding the experimental vaccines.

Experts say 50 million miles of new power lines needed for green energy, and that may be impossible [A huge problem for Prince Charles "Sustainable Development" SDGs!]

Some estimates say the U.S. needs to build over 700,000 miles of transmission lines to reach its own renewable energy goals: enough to circle the globe 2,000 times. A 700-mile transmission line starting in Wyoming cost \$3 billion and took 15 years to clear regulatory permits.

It's one thing to try and replace fossil fuels with wind and solar power, but experts are saying the generation of power is only half the battle, and that the problems in getting that power to Americans may be insurmountable.

A <u>new report from the International Energy Agency</u> (IEA) concludes that the size of the global electricity grid will need to double by 2040, in order to reach global emission reductions targets in line with the <u>Paris Agreement</u>. (Prince Charles will not be happy to hear this report!)

That means, the IEA says, the world will need to refurbish or add 50 million miles of new transmission lines within 17 years — the equivalent of circling the equator more than 2,000 times.

The IEA estimates that global investments in transmission capacity will need to double to \$600 billion per year by 2030 in order to reach that goal.

Energy expert, podcaster, and author <u>Robert Bryce</u> told Just The News the agency's estimates suggest enormous challenges ahead to reach the goals they are proposing. "It's easy to talk about building transmission, but it's incredibly hard to do," Bryce said.

As mining expert and Utah-based lawyer B.F. Randall explains, electricity has a property that makes it more of a service than a commodity. It has to be produced almost the moment it's consumed.

Wind and solar provide energy intermittently, according to when the wind is blowing or the sun is shining, which may or may not align with demand.

Solar production, for example, diminishes in the evening when demand starts to climb, which is why the operators of the Texas grid this summer <u>requested people conserve</u> <u>during those hours</u>. <u>Wind energy typically fails</u> at the same time.

While some storage systems, such as batteries and <u>pumped storage</u>, can store energy for later use, they are very expensive, <u>especially when bridging long durations</u> when wind or solar energy may not be available.

The idea of renewable energy may be good, but the execution is problematic. In order to run the grid reliably with many wind and solar farms, it has to be able to transfer electricity from wherever it's produced at any given moment to wherever it's needed. That means a lot of transmission lines.

The Biden administration announced last week \$3.5 billion for 58 projects across the country, which includes billions for transmission projects. "Today's announcement represents the largest-ever direct investment in critical grid infrastructure, supporting projects that will harden systems, improve energy reliability and affordability—all while generating union jobs for highly skilled workers," U.S. Department of Energy Secretary Jennifer Granholm said in a statement.

There are various studies estimating what it would take for the U.S. to meet its own renewable energy goals while satisfying the <u>world's highest demand for energy</u>.

A 2020 Princeton University study on reaching "net zero" in America estimates that transmission systems in the U.S. will need to expand by 60% by 2030 and may need to triple by 2050. Net zero means "cutting greenhouse gas emissions to as close to zero as possible, with any remaining emissions re-absorbed from the atmosphere, by oceans and forests for instance," explains the United Nations' "Climate Change" webpage.

The U.S. <u>currently has about 240,000 miles</u> of high-voltage transmission lines. That doesn't include 5.5 million miles of local distribution lines. If the U.S. were to triple the miles of high-voltage transmission lines, that would equal about 720,000 miles of transmission that need to be built.

According to Xcel Energy Transmission, a company specializing in constructing and maintaining power lines, an overhead high-voltage power line costs approximately \$2 million to \$2.5 million. Based on the lower estimate, 720,000 miles of power lines will require \$1.44 trillion in investment.

Bryce explains his Substack article that studies looking at meeting transmission capacity expansion needs in the U.S. <u>don't often consider the feasibility</u> of the transmission build out goals.

As an example, Bryce points to a Lawrence Berkeley National Lab paper, which found, based on 2022 data, that American consumers could save hundreds of millions of dollars with expanded transmission capacity.

But the authors don't calculate the cost of the planning and construction of the theoretical transmission lines. Instead, the information is explained as a "simple concept"

that transmission enables a lower cost set of generators to meet load than would otherwise be available," says Bryce.

In an interview with Just The News, Bryce said that there are land-use conflicts, labor shortages, and transformer shortages that make it difficult to get a high-voltage transmission line built. "All of these add complexity and cost to building these projects," he said.

A transmission line running hundreds of miles will possibly cross a combination of state lines, federal and state lands, local jurisdictions, tribal lands, and private lands. All of those require different regulations and approval processes, and ironically, often run into opposition from environmentalists. Getting all the permits and going through lawsuits can take years.

The \$3 billion, 700-mile <u>Transwest Express transmission line</u>, which will connect a large wind farm in Wyoming to consumers in other states, took 15 years to get the approval for construction to begin. The construction is estimated to take another five years.

Lee Cordner, an electrical engineer who has 50 years of experience in the power sector, <u>said on Bryce's "Power Hungry" Podcast</u> that the tribal governments can be "pretty obstructionist" when it comes to getting rights of way. "They don't like it when you show up and say, 'I think we're going to have to take some of your land.'...They've been through that, and they don't like it," Cordner said.

With 326 land areas in the U.S. that are administered as federal Indian reservations, the proposed transmission buildout will have to cross a lot of these lands.

Another problem is getting the skilled labor needed to build the projects. Cordner said a lineman's work involves power lines carrying electricity of up to 500,000 volts, making it dangerous work, and it can take several years to train someone.

"These lineman are tough hombres," Bryce said, adding that all across the country, utilities struggle to fill open lineman positions. "It takes a very dedicated person who likes physical work, likes being outdoors, and then likes the challenge of a job that is physically and technically demanding," Bryce said.

Then, there is the always-present challenge of supply chains. All the copper, iron and other minerals have to be mined and processed. Besides the power lines themselves, there is the associated equipment, like transformers, which step up and step down voltage.

Bryce said the transformers needed for bulk power delivery on high-voltage transmission lines are usually custom built, and the <u>wait times can be two or three years</u>. "It is another aspect of the infrastructure challenge that is complex and costly," Bryce said.

Meredith Angwin, a chemist and author of "Shorting The Grid," told Just The News that the challenges are likely insurmountable. Blackouts are going to become more common as the U.S. tries to power an energy-hungry grid on more and more intermittent resources. At the same time, electricity rates are going to go up as the cost of all the infrastructure build out gets passed down to consumers.

"It's very close to impossible to run a modern civilization on wind and solar. And so it isn't going to happen," Angwin said. She added that besides the technical challenges to this massive build out of transmission lines, there are the environmental impacts that aren't being considered. All those steel towers will affect wildlife and the natural landscape.

"The question is going to be, how much damage to the environment before people say, 'Oh, I guess we better not do this," she said.

Angwin said her optimistic side thinks that, when all the technical and environmental problems come to the forefront of the conversation, public opinion will likely turn against the whole idea of going completely green.

22 horrifying things that may happen next

Because of the humanitarian crisis Israel is creating in Gaza by shutting off food, water, electricity and fuel, and because of the rising number of civilian deaths and injuries being widely reported, a full-scale attack on Gaza risks rapid escalation into a regional conflict that will likely involve Hezbollah, Iran, Syria and even Turkey.

The following list reveals 22 things that may follow as "chain reaction" events, if Israel decides to wage a full-force assault on Gaza.

Over a decade ago, I wrote a comprehensive 3-part article: "Out of Egypt and Pharaoh's Revenge". Also on January 29, 2019 Gary Stearman posted an article on his Prophecy Watchers site, titled "The Tower of Syene: A Prophetic Wonder."

I like Gary Stearman's writing, which is also much shorter and so I will share his words on the Tower of Syene, which did not exist until 1972, yet it was written about in Ezekiel, roughly, 2,500 years ago. Below is the article by Gary Stearman:

[[It's not often that one can point to a physical object at a specific geographical location in the contemporary world, and identify it as being the focus of a biblical prophecy that was written long before Christ. Yet, that is exactly what we can do in the case of a remarkable manmade edifice in Egypt that didn't exist until 1970. It is a 230-foot tower, called the "Lotus Tower," because it is topped by the five petals of the lotus blossom. The tower was designed as a token of Arab-Russian friendship, its five petals perhaps signifying the five pillars of the Islamic faith. It is only 49 years old, yet Ezekiel referred to it by name ... twice.

In the 29th and 30th chapters of his prophecy, "the tower of Syene" is mentioned as a landmark that is specifically related to the fulfillment of latter-day prophecy. In fact, this prophecy is profoundly powerful, sounding the death knell of Egypt.

We have written about the current crisis in Egypt, which began with street riots in 2010, followed by Hosni Mubarak's resignation early in 2011. This was followed by another coup, the assumption of power by the Muslim Brotherhood and more Islamic riots, finally resulting in the rise to power of Abdel Fattah el-Sisi in June of 2014. Egypt, like other countries in the Mideast, continues to experience uprisings and internal dissent. As this is written, war clouds surround Egypt in every direction.

In this context, we have long studied a graphic prophecy in Ezekiel 29 and 30 that summons up the dark vision of Egypt's future destruction by a great flood, which itself, is linked to a number of end-time prophecies.

A STAFF OF REED

That Egyptian prophecy directly addresses these developments. In it, Ezekiel states that because of its failure to support Israel, Egypt will at some future point, be grievously judged. That judgment will turn it into a wasteland. This is clearly stated in the opening words of the following prophecy:

"⁶And all the inhabitants of Egypt shall know that I am the LORD, because they have been a staff of reed to the house of Israel. ⁷When they took hold of thee by thy hand, thou didst break, and rend all their shoulder: and when they leaned upon thee, thou brakest, and madest all their loins to be at a stand. ⁸Therefore thus saith the Lord GOD; Behold, I will bring a sword upon thee, and

cut off man and beast out of thee. ⁹And the land of Egypt shall be desolate and waste; and they shall know that I am the LORD: because he hath said, The river is mine, and I have made it. ¹⁰Behold, therefore I am against thee, and against thy rivers, and I will make the land of Egypt utterly waste and desolate, from the tower of Syene even unto the border of Ethiopia. ¹¹No foot of man shall pass through it, nor foot of beast shall pass through it, neither shall it be inhabited forty years. ¹²And I will make the land of Egypt desolate in the midst of the countries that are desolate, and her cities among the cities that are laid waste shall be desolate forty years: and I will scatter the Egyptians among the nations, and will disperse them through the countries" (Ezek. 29:6-12).

THE DRAGON'S RIVER

For a time, Egypt joined the legions of Islamic terrorists bent upon the annihilation of Israel. Currently, Sisi's administration has stabilized the situation. But in the days ahead, such militancy is bound to spread like wildfire, finally arriving at a critical mass, at which time the Brotherhood will believe that it has arrived at a historic moment. Then, it will launch its invasion against Israel.

Many object to interpreting the above passage in Ezekiel 29 as being an end-time prophecy. They say that the context of this chapter took place in the past, during the days of the Babylonian captivity. In fact, it may be partially interpreted in that way. But the very nature of Ezekiel's words, places the final outcome of the Syene prophecy in the last days. Egypt has never been desolate and uninhabited for any 40-year period, as described above. Presenting its self-evident truth, this prophecy must be contemporary in nature, because when Ezekiel first wrote it, there was no "tower of Syene." In fact, it didn't even come into existence until 1970, at the dedication of the Aswan High Dam, spanning the Nile at the location of the first cataract, Egypt's southern border. The proper noun "Syene," from the Hebrew S'veneh [vbux], means "opening," or "key." This name is said to be the ancient designation for the opening to Egypt, as one approaches from the south, or from the direction of Ethiopia.

From several sources, it is quite easy to confirm that the biblical Syene is really Aswan. One of these is the *Keil & Delitzsch Commentary on the Old Testament*, first published in 1866. It affirms the connection, from the Greek Septuagint: "[Suhnh], Syene, in the inscriptions according to Brugsch [was] the most southerly border town of Egypt in the direction of Cush, *i.e.* Ethiopia, on the eastern bank of the Nile, some ruins of which are still to be seen in the modern *Assuan* (Aswan) ..." (Vol. 9, Ezekiel 29-48, p. 8).

When Keil and Delitzsch wrote their commentary in 1866, there was not a trace of the prophesied tower at Aswan. And when Ezekiel wrote his prophecy around 570 B.C., there was no tower. In fact, until the huge hydroelectric project was completed there, by the Russians and Egyptians in 1970, there was no tower at Aswan. Today, this dam is the most imposing feature of the area, doomed by

biblical prophecy to be wiped out at some point between now and the Tribulation.

Using Russian technology, the Egyptians completed the dam, effectively placing themselves in the position of being able to say, "The river is mine, and I have made it for my own use."

"Son of man, set thy face against Pharaoh king of Egypt, and prophesy against him, and against all Egypt: "Speak, and say, Thus saith the Lord GOD; Behold, I am against thee, Pharaoh king of Egypt, the great dragon that lieth in the midst of his rivers, which hath said, My river is mine own, and I have made it for myself. But I will put hooks in thy jaws, and I will cause the fish of thy rivers to stick unto thy scales, and I will bring thee up out of the midst of thy rivers, and all the fish of thy rivers shall stick unto thy scales. And I will leave thee thrown into the wilderness, thee and all the fish of thy rivers: thou shalt fall upon the open fields; thou shalt not be brought together, nor gathered: I have given thee for meat to the beasts of the field and to the fowls of the heaven" (Ezek. 29:2-5).

At first glance, this prophecy seems generically directed toward "Pharaoh, king of Egypt." But upon further examination, its real target is, "... the great dragon that lieth in the midst of his rivers." This scaly creature seems to represent the remnant of Egypt's power, lurking behind the scenes since the days of Moses. In Ezekiel 28, the chapter that immediately precedes this one, Satan, as the "anointed cherub," is shown as defeated. This prophecy in Chapter 29, then, may possibly be taken as an extension of that preceding prophecy.

Here, the fish of the Nile River figuratively stick to the dragon's scales, as all are hurled from the river onto its banks to rot and dry in the sun. His power is destroyed. The Nile, which annually flooded with clocklike predictability, has ceased its flooding since the construction of the High Dam at Aswan. Total destruction of this dam is the only way it could flood as catastrophically as described in Scripture.

THE RUSSIAN PROJECT

Interestingly, the huge dam is so massive that experts have pronounced it indestructible ... except through the use of nuclear force. This fact alone makes it more than clear that this is a latter-day prophecy. With the foregoing in mind, it is interesting to examine two distinct biblical prophecies. As we shall see, they are related. But they evoke a mystery. They suggest that Egypt will soon experience a massive devastation that is unique to its geography. And apparently, for reasons that shall become clear, this event will predate Gog's lightning assault upon Israel.

We have written at some length about the first of the two prophecies, found in Ezekiel 29. As it begins, it seems to be directed to a specific Pharaoh, perhaps the one on the throne at the time Ezekiel wrote his prophecy. But as one reads

carefully, it becomes clear that "Pharaoh" is really a literary title given to the evil spirit of Egypt in general. It is quite easy to see this, since this particular "Pharaoh" is a dragon who lives in the Nile River. Taking an expanded look in the verses that follow, the dragon professes ownership of the Nile, even boasting that he has created it. His arrogance is about to be challenged:


"6And all the inhabitants of Egypt shall know that I am the LORD, because they have been a staff of reed to the house of Israel. TWhen they took hold of thee by thy hand, thou didst break, and rend all their shoulder: and when they leaned upon thee, thou brakest, and madest all their loins to be at a stand. Therefore thus saith the Lord GOD; Behold, I will bring a sword upon thee, and cut off man and beast out of thee. And the land of Egypt shall be desolate and waste; and they shall know that I am the LORD: because he hath said, The river is mine, and I have made it. Behold, therefore I am against thee, and against thy rivers, and I will make the land of Egypt utterly waste and desolate, from the tower of Syene even unto the border of Ethiopia. No foot of man shall pass through it, nor foot of beast shall pass through it, neither shall it be inhabited forty years. And I will make the land of Egypt desolate in the midst of the countries that are desolate, and her cities among the cities that are laid waste shall be desolate forty years: and I will scatter the Egyptians among the nations, and will disperse them through the countries" (Ezek. 29:6-12).

In the last few decades, this arrangement has radically changed. The Russian hydroelectric project was amazing in its scope. It is huge, measuring 360 feet in height, 10,200 feet (almost two miles!) long and 3,200 feet wide at the base. Backed up behind it is the vast Lake Nasser, and the waters of the Nile that pool all the way into Ethiopia. The dam's dimensions are so massive that it is considered indestructible. Saboteurs using ordinary explosives wouldn't make a dent. However, experts have said that one or two well-placed nuclear bombs could blow it wide open.

In Ezekiel's day, Aswan (biblical Syene) was a small village, some 550 miles south of the Great Pyramid, on the bank of the first cataract of the Nile. It was considered the southernmost extent of Egypt. When Ezekiel wrote this prophecy, the entire area was geographically different. Of course, there was no "tower" there! Today, of course, there is the towering High Dam, which this prophecy indirectly names as the source of the great flood that will ravage Egypt.

Ezekiel wrote his prophecy about 2,500 years, before its targeted object even existed, saying that it will break, allowing flood waters to surge almost six hundred miles to the north, where they would empty into the Mediterranean Sea.

If nuclear weapons are used to accomplish this catastrophe, the floodwaters would cover all Egypt with nuclear waste. As we have mentioned in the past, this would account for the virtual abandonment of the country for the forty-year period mentioned by Ezekiel. This has never before happened.



ISRAEL'S EXPERT ASSESSMENT

In 2002, Israeli Knesset member (MK) Avigdor Lieberman, admittedly a man given to controversial statements, announced that Israel could defeat an invading Egypt by bombing the Aswan High Dam. He knew that this would require the use of nuclear force, since many experts have testified that the dam is too massive to fall to ordinary explosives. Lieberman, who served as Israel's Deputy Prime Minister, and as Minister both of Foreign Affairs and Strategic Affairs, had obviously been briefed upon military alternatives. It appears that he wanted to give Egypt something to think about.

Nor was he alone in his opinion. MK Yigal Allon had publicly made the same statement during the early 1980s. A Labor Party representative, he too, had served as a government minister for seven years. These men were saying what others knew, but refused to speak about openly.

They were simply stating the obvious. If Israel's existence were threatened by an Egyptian invasion, drastic measures would be brought into play, The Aswan Dam

holds back the waters of the enormous Lake Nasser, 340 miles long and 22 miles wide at its widest. If the dam were breached by a nuclear blast, radioactive waters would cover Egypt from Ethiopia's Blue Nile, through Sudan to the Mediterranean Sea.

Satellite photos reveal a staggering truth about Egypt. Virtually its entire population lives in close proximity to the Nile River, from Aswan all the way down to Cairo and the Mediterranean Sea. Night photos show the Nile as a narrow river of light that fans out at the Nile Delta. Egypt may be the only country on earth so vulnerable to total destruction.



FIRE FALLS UPON SYENE

Naturally, when we read about the horrific event mentioned above, our first question is: When does this prophecy take place? In the following chapter of his prophecy, Ezekiel answers this question, too.

The following verses link the Tribulation Period (Day of the Lord) and the coming of this dire event. Also, notice again that the "tower of Syene" is mentioned:



"The word of the LORD came again unto me, saying, Son of man, prophesy and say, Thus saith the Lord GOD; Howl ye, Woe worth the day, For the day is near, even the day of the LORD is near, a cloudy day; it shall be the time of the heathen. And the sword shall come upon Egypt, and great pain shall be in Ethiopia, when the slain shall fall in Egypt, and they shall take away her multitude, and her foundations shall be broken down. Ethiopia, and Libya, and Lydia, and all the mingled people, and Chub, and the men of the land that is in league, shall fall with them by the sword. Thus saith the LORD; They also that uphold Egypt shall fall; and the pride of her power shall come down: from the tower of Syene shall they fall in it by the sword, saith the Lord GOD. And they shall be desolate in the midst of the countries that are desolate, and her cities shall be in the midst of the cities that are wasted. And they shall know that I am the LORD, when I have set a fire in Egypt, and when all her helpers shall be destroyed" (Ezek. 30:1-8).

The language of this prophecy is unmistakable. A storm is gathering; the Day of the Lord is approaching. Note that not just Egypt, but all of northeast Africa is involved. Today, northeast Africa – Ethiopia, Somalia, Sudan, Chad and Libya –

constitute a seething cauldron of Islamic terrorism. These countries surround Egypt, which is, itself, a seat of Islamic power. In spite of an intervening peace treaty, it has never deviated from its desire to eradicate Israel.

In the prophecy above, Ezekiel states that all these countries will suffer judgment ... including "Lydia," representing modern Turkey. But the most devastating judgment of all is reserved for Egypt. Once again, the prophecy evokes the imagery of the "tower of Syene," which we have pointed out as the Aswan High Dam. It seems to be central to all the judgments mentioned here. Egypt's Islamic allies will also suffer greatly when the Lord sets His fire in the land of Egypt. It is clear that this fire is the instrument that will unleash the trillions of gallons of radioactive water that washes across Egypt.

Many students of Bible prophecy have asked why Egypt is not listed among the allies that come against Israel in the great invasion described in Ezekiel 38. Certainly, Russia is represented, along with Persia and some of the countries of north Africa. Nations from parts of Europe and Asia are also represented, but Egypt is not among them. Under today's geopolitical circumstances, Egypt would be at the head of the line in support of such an invasion, as it has been in the past. We would conclude that by the time Gog launches his lightning invasion, Egypt has already been destroyed.

This would explain why Egypt is prophesied to be uninhabitable for a future period of forty years. This also explains why Egypt is missing in the prophesied attack on Israel by the allied forces of Gog, in Ezekiel 38.

Clean-up of the radioactive debris would be a staggering task. This massive project seems to extend into the early years of the Millennium. But somehow, it will be accomplished in the years following the Tribulation, probably supervised by the Lord and His followers.]]

If you understand what Gary Stearman is saying, this will take place before the Ezekiel 38/39 War. 
