Senator Johnson: ‘Globalists’ Are Using Covid and Climate ‘Fear’ to ‘Control Our Lives’

Republican Senator Ron Johnson (R-WI) has dropped the hammer on “*globalists*” trying to “*control our lives*” by creating a “*state of fear*” over Covid and the so-called “*climate crisis*.”

Johnson blasted the globalist agenda during a recent interview on Fox News. The senator began by slamming the Democrats for creating division in America while “*strengthening China*.”

He also warned that Democrat President Joe Biden doesn’t want to contain the Chinese Communist Party. Sen. Johnson continued by raising the alarm over the global climate agenda. “*This whole climate change agenda is driven toward **control over our lives**,*” Johnson warned.

“*Climate change alarmism, our miserably failed response to the pandemic...*” he continued. “*These are all **designed to create a state of fear** so that the **globalists can control our lives**. We have to say stop,*” Johnson declared.

Johnson has long been warning the public and his fellow Republicans about the green agenda.

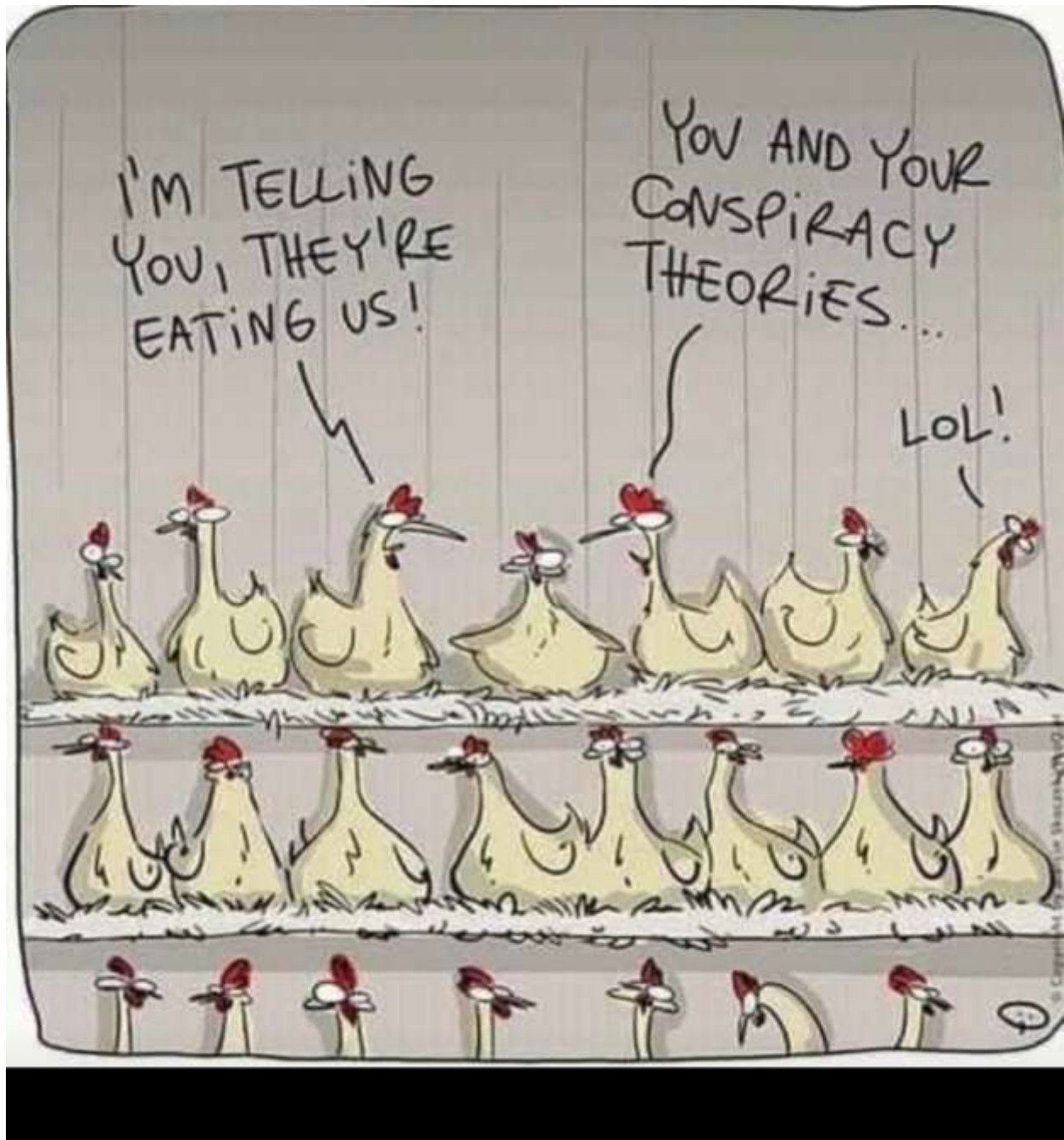
The agenda is being pushed by unelected bureaucrats and corporate elites such as the World Economic Forum (WEF), The United Nations, and the World Health Organization (WHO).

In 2021, Johnson slammed the “climate crisis” narrative during a Republican luncheon, according to ‘[The Hill](#)’. “*I don’t know about you guys, but I think climate change is — as Lord Monckton said — **bullsh*t**,*” Johnson said, according to CNN’s KFILE. According to the report, Johnson did not utter the expletive but mouthed it instead.

“*By the way, it is,*” Johnson then added, according to a report.

Lord Christopher Monckton is a British conservative climate change critic and political pundit.

Johnson has previously tried to warn the public about the Covid pandemic. As 'Slay News' reported, Johnson issued an explosive statement on national television in August, warning the American people that Covid was "preplanned by an elite group of people."



During an interview with Fox host Maria Bartiromo, Johnson declared that *“a very powerful group of people”* intentionally engineered the pandemic to *“take total control of our lives.”*

According to Johnson, the plot is part of a globalist agenda linked to Event 201. On October 18, 2019, the Johns Hopkins Center for Health Security hosted Event 201 in New York City in partnership with the World Economic Forum (WEF) and the Bill and Melinda Gates Foundation.

Event 201 was a high-level pandemic exercise that was held just weeks before the first cases of COVID-19 were detected in China. The exercise laid out plans for collaborations between governments, private companies, and unelected globalist organizations in order to respond to a severe pandemic. The claimed goal of the exercise was to diminish large-scale economic and societal consequences during and after a pandemic.

According to Johnson, the powerful elites that took part in Event 201 went on to orchestrate the Covid pandemic shortly after. During the interview, Bartiromo asked Johnson why the government colluded with Big Tech to stop the American people from learning about the side effects of the Covid vaccines.

“This was all pre-planned by an elite group of people,” the senator responded. *“Event 201 – it occurred in late 2019, prior to the rest of us knowing about this pandemic,”* Johnson continues. *“This is very concerning in terms of what has happened, what is happening, what continues to be planned for our loss of freedom. It needs to be exposed but unfortunately, there are very few people, even in Congress, that are willing to take a look at this. They all pushed the vaccine,”* he noted.

“They don’t want to be made aware of the fact the vaccines may have caused injuries, may have caused death. So many people simply don’t want to admit they were wrong and they’re going to do everything they can to make sure they’re not proven wrong. We’re up against a very powerful group of people here, Maria.”

Meanwhile, lone maverick lawmakers like Senator Johnson are beginning to emerge in other nations. A top EU German Leader and MEP, has warned that the Covid pandemic was a “beta test.”

German MEP Christine Anderson has stated that the *“pandemic”* was a beta test conducted by unelected globalists. She says the *“test”* sought to determine how easy it would be to seize totalitarian control, under the pretext of a global *“emergency.”*

Interestingly, Anderson’s comments come after a video recently emerged of WEF founder Klaus Schwab’s daughter stating that the pandemic served as a precursor to coming *“climate lockdowns.”*

As 'Slay News' reported, Nicole Schwab gloated that Covid was a "tremendous opportunity" to test how the public would comply with authoritarian measures that could be used to usher in the WEF's "[Great Reset](#)" agenda.

The [WEF's promotion](#) of the "climate crisis" narrative seeks to "create a change that is not incremental...to position nature at the core of the economy," according to the younger Schwab.

Thankfully, leaders like Senator Johnson are finally beginning to speak out. Even so, Senator Johnson is more than a day late and a dollar short in his calling this globalist agenda with the COP28 "Sustainable Development" SDGs quickly becoming global mandates. In Senator Johnson's remarks to Fox host Maria Bartiromo, he spoke in generalities and never went beyond referring to the leaders like John Kerry as being "very powerful group of people." Senator Johnson came up short like Kentucky's Senator Rand Paul has with criminal Dr. Anthony Fauci in the past. So much for the political theater to score points with their constituents back home! New Document Leak on Plan to Expel Gaza Population

A leaked document from the Israeli Ministry of Intelligence to an Israeli news site on Monday lays out a plan to transfer more than 2 million Palestinians from Gaza to Egypt's Sinai desert, reports Joe Lauria.

The document from the Ministry of Intelligence is being downplayed by Israeli officials, who are saying it is not being actively considered while the ground operation is underway. The document was first published in Hebrew by the news website *Sicha Mekomit*. The article's blurb says:

"A document on behalf of the Ministry of Intelligence, the full content of which is published here for the first time, recommends the forced transfer of the population of the Gaza Strip to Sinai permanently, and calls for the international community to be harnessed for the move. The document also suggests

promoting a ‘dedicated campaign’ for the residents of Gaza that will ‘motivate them to agree to the plan.’”

The news site’s source said the Ministry’s “*personnel stand behind these recommendations*” but that they are “*not based on military intelligence*” and are only used as “*a basis for discussions in the government.*”

‘The Times of Israel’ reported:

“The document is being downplayed by government officials, with the Prime Minister’s Office telling ‘Haaretz’ that it represents ‘initial thoughts’ on the issue, which is currently not being considered by authorities focused on the war effort and not the day after.”

“The document, which is dated October 13, calls for the civilian population to be moved to tent cities in northern Sinai, and eventually the building of permanent cities and the opening of a humanitarian corridor. The plan includes a several-kilometer-wide ‘sterile’ buffer zone inside Egypt, to ensure the population cannot settle on Israel’s borders.”

According to *Sicha Mekomit*, the document says, ***“The messages [to the Gazans] should revolve around the loss of the land, that is, to make it clear that there is no longer any hope of returning to the territories that Israel will occupy in the near future ... The image should be ‘Allah made sure that you lost this land because of the leadership of Hamas – there is no choice but to move to another place with the help of Your Muslim brothers.’”***

It is a cynical message in the extreme to sell a crime against humanity to a totally desperate population. ***“The term ‘forcible transfer’ describes the forced relocation of civilian populations as part of an organized offensive against that population. It is a crime against humanity punishable by the International Criminal Court (ICC),”*** according to the Legal Information Institute at Cornell Law School. The ICC is currently investigating possible war crimes and crimes against humanity in Israel and Palestine.

According to *Sicha Mekomit*, the Israeli government is well aware of the international damage to Israel’s reputation that would result from implementing such a plan by force:

“It is claimed [in the document] that if the population of Gaza remains in the Strip there will be ‘many Arab deaths’ during the expected occupation of Gaza, and this will damage Israel’s international image even more than the deportation of the population. For all these reasons, the recommendation of the Ministry of Intelligence is to promote the transfer of all citizens from Gaza to Sinai permanently.”

According to *The 'Washington Post'*, Egypt and the United States have discussed ways to keep the Palestinian population from being forced out of Gaza. According to a White House readout of a call, the U.S. and Egyptian leaders *"discussed the importance of protecting civilian lives, respect for international humanitarian law, and ensuring that Palestinians in Gaza are not displaced to Egypt or any other nation."*

Most Gazans are already refugees or descendants of refugees who were expelled from their homes by Israel in 1948 in the violent creation of the state of Israel.

Vladimir Putin turns on Netanyahu as he sees Israel 'as Russia's enemy'

EXCLUSIVE: The Russian president "no longer cares for Netanyahu" as Russia's stance shifts in the Middle East, a former speechwriter has claimed.

Vladimir Putin will now see Israel as an "enemy" as he moves closer to Iran and sides with Hamas in the Middle East, a former speechwriter for the Russian President tells Daily Express US.

Hamas has called Russia its *"closest friend"* as the terror group vows to release eight Russian hostages kidnapped during its October 7 attack in Israel.

Putin appears to be breaking from his previous line of neutrality over Israel and Palestine. This week he called on Israel to cancel its ground invasion into Gaza.

Abbas Gallyamov, a former speechwriter for Putin from 2008-2012 who lives in Tel Aviv, tells Daily Express US that Putin has become more reliant on Iran for weapons, and this is why he has shifted to a more pro-Palestine stance.

Netanyahu and Putin had fostered good relations previously. He said: *"For many years Putin was really skillfully keeping a middle ground between Israel and Iran, but recently Russia became dependent on Tehran because of arms deliveries."*

"He lost his chance to be an independent player. It was probably that Iran said 'we support you in Ukraine, you support us in the Middle East'."

"Putin had to follow Tehran. In the Middle East, Russia is quickly turning into another Iran proxy just like Hamas and Hezbollah."

Mr. Gallyamov was placed on a wanted list of criminal suspects in Russia earlier this year because of his criticism of the invasion of Ukraine. Asked if Russia could provide money and weapons for Hamas, Mr. Gallyamov: "Yes. I don't rule this out. When you become a proxy you lose the chance to conduct an independent line." He continued: *"I think Putin no longer cares for Netanyahu."*

Now he has taken this pro-Palestine stance on the conflict any Israeli government is an enemy for Putin."

Mousa Abu Marzouk was hosted at the Kremlin.

Gaza has been heavily bombed by Israel after Hamas' attack. Iran has supplied Russia with drones to use for its war in Ukraine after heavy sanctions left Russia isolated.

As for Putin's relationship with Israeli Prime Minister Benjamin Netanyahu, the two leaders had tried to forge a stronger relationship in recent years. Putin and Netanyahu promoted cultural ties and visa-free travel between the two countries.

In his memoir published during Russia's war on Ukraine, Netanyahu praised the Russian leader for his intellect and his *"particularly friendly attitude"* toward the Jewish people.

But the two leaders didn't speak until a week after Hamas October 7 attack. Relations between Israel and Russia will not have been helped by Moscow hosting Hamas at the Kremlin last week. Mousa Abu Marzouk, a Hamas political leader, praised Putin's *"highly valued"* stance on the Israel-Gaza war.

The Israeli-Hamas Conflict Is A Continuation of the 9/11 Plot

This is not a conspiracy theory. It is the most likely explanation we have of the information at this time.

The Hamas October 7th attack on Israel was the opening gun of a plot devised by U.S. neoconservatives and Netanyahu to renew the U.S. attack on Hezbollah's suppliers in behalf of Greater Israel. Greater Israel is a Zionist belief that Israel comprises the territory from the Nile in Egypt to the Euphrates in Iraq. The purpose of 9/11 was to launch under the guise of a "*war on terror*" the wars that the American neoconservatives had called for in their publications and that General Wesley Clark told us about against Israel's enemies in the Middle East. The purpose of Washington's "*war on terror*" was to destroy Hezbollah's suppliers—Iraq, Syria and Iran. Israel and the neoconservatives want these three countries destroyed because they supply Hezbollah with money and weapons that permits Hezbollah to successfully repeal Israel's attempts to occupy southern Lebanon. Israel needs the water resources in southern Lebanon. With the Iraq, Syrian, and Iranian regimes destroyed, avenues are opened to Greater Israel.

In other words, there was never a "*war on terror.*" There was a war devised by U.S. neocons against Israel's opponents. And that is precisely what the war on Hamas is about.

It is impossible to breach the Israeli security barrier without setting off alarms. The plot called for the barrier to be stood down. What most likely happened is this: Israeli agents who have infiltrated Hamas were instructed to sell Hamas on the attack by promising the ability to disable the barrier and surprise the Israelis. Netanyahu and the neocons sacrificed Israeli lives for the outrage about Israeli deaths, rapes, and Israeli babies with cut off heads. This would gain Israel support for destroying the remnants of Palestine and incorporating all of Palestine into Israel, thus ending any prospect of a two-state solution and simultaneously settling Netanyahu's legal and political problems by making him a hero who consolidated Palestine under Israel.

But the plot has wider aims, which were revealed by the almost instant appearance on the scene of U.S. aircraft carrier task forces, the 101st Airborne Division followed by U.S. Marines and Special Forces. Israel, of course, does not need these American forces in order to destroy Gaza. Pundits, reflecting either a

lack of imagination or serving a disinformation function, have rationalized the presence of the U.S. forces as a warning and protective buffer between Israel and Hezbollah/Iran.

Think about this rationale. If Netanyahu understood that the plot might bring Iran/Hezbollah and even Syria and Iraqi volunteers down on Israel's head, would he have sponsored a plot that initiated war with Hamas? The answer is not unless he and the U.S. neoconservatives want to bring Iran/Hezbollah down on Israel's head. And they do, which is why the U.S. forces are in the area. A Hezbollah attack on Israel gives the neocons, which control the U.S. State and Defense Departments and National Security Council the excuse they need to finish the real purpose of the "war on terror"—to destroy Syria and Iran. Iraq was taken out, but Syria and Iran remain in Israel's way.

Will this plot succeed?

The plot is premised on drawing Hezbollah and Iran into the war. If they are not drawn in—and Putin is doing his best to prevent them from being drawn in—the U.S. neoconservatives don't have an excuse to widen the war. The neoconservatives would be tempted to go for a false flag attack that would provide an excuse, but it would be risky and not compare to Hezbollah troops pouring into Israel and missiles raining down on Israel from Iran. If the neocons use a false flag attack, the result of Putin's efforts will be to take the initiative, the element of surprise, from Iran/Hezbollah and to give the initiative to the neoconservatives. Thus Putin's efforts to contain the conflict would turn out to be counterproductive.

The Israeli-Hamas conflict is running into trouble with the U.S. Democrats. Their "diversity-multicultural-open border" policy has brought Muslims into the U.S. and into the Democrat Party and members of Congress. Someone is getting through the neocon barrier around Biden as we can see from Biden's efforts to dampen down the conflict, delay Israel's invasion of Gaza, and warn Israel away from repeating Hamas' atrocities. If Biden succeeds in restraining Netanyahu and Putin succeeds in restraining Iran/Hezbollah, the plot will have to settle for second best.

What would second best be? It would be bombing the Gazans out of Gaza into the Sinai Dessert into tent cities. Israelis are already talking about this. In other words, the Gazans who survive would become refugees outside of Gaza. That would only leave a few isolated Palestinian villages in the West Bank, from which the remaining Palestinians would be driven out by the Israeli settlers.

So it is possible for Israel to destroy Gaza without invading, which, as matters stand, is the trigger for Iran/Hezbollah's entry into the conflict. What we don't know is whether Putin can keep Iran/Hezbollah restrained if the consequence is the demise of Gaza and all hope for Palestinians.

We also don't know if Biden and the Democrats can prevent the Republicans, who are now aligned with the neoconservatives in behalf of Israel, from egging on the war.

Many Republicans, such as House Speaker Mike Johnson, are evangelicals who worship Israel more than God. Netanyahu and American Evangelicals are invoking Biblical prophecies to stir Israelis and Americans into eschatological insanity. Biden is discredited, and polls show that his public support is too low to permit his reelection. Trump was recently described by the Israeli newspaper Haaretz as *"the most pro-Israel President in history."* This leaves us with the question: Will Putin/Biden's attempts to contain the conflict prevail or will the Republican/evangelical/neoconservative/Netanyahu efforts to widen the conflict prevail? Time will tell.

Deliverance before Judgment / Pre-Tribulation Rapture
Why The Rapture Occurs Before the Revealing of the Antichrist!**

In this segment we continue to explore and discuss Dr. John Walvoord's 50 facts furnishing ample evidence for a Pre-Tribulation Rapture. Dr. Walvoord was a distinguished theologian of renowned scholarship at Dallas Theological Seminary. He was greatly respected among members in the theological community for his insights into Scriptural understanding. We pick up next with his list of important evidence:

The Work of the Holy Spirit

The Holy Spirit is the Restrainer of evil in the world. He cannot be taken out as prophesied unless the Church, which is indwelt by the Holy Spirit, is taken out. – (2nd Thessalonians 2:1-12, supported by Genesis 6:3).

This identification of the restrainer with deep roots in church history is most appealing. The special presence of the Spirit as the indweller of saints will terminate abruptly at the "Parousia" (a noun that means "a coming" or "a presence.") as it began abruptly at Pentecost. If a search of the Greek New Testament were conducted, one would find that primarily this word (Parousia) refers to the Coming of the Lord Jesus. It can refer to either His second coming at the END of the 7-year Tribulation period -(Matthew 24:27, 37, 39; Revelation

19:11), or to His coming to Rapture His Church PRIOR to the 7-year period known as the Tribulation -(1st Corinthians 15:23; 1st Thessalonians 2:19; 5:23; James 5:8; 1st John 2:28). Once the body of Christ has been caught away to heaven, the Spirit's ministry will revert back to what he did for believers during the OT period. His function of restraining evil through the body of Christ -(John 16:7-11; 1 John 4:4) will cease similarly to the way He terminated His striving in the days of Noah -(Genesis 6:3). At that point the reins will be removed from lawlessness and the Satanically inspired rebellion will begin. It appears that to "*katechon*" ("what is holding back") was well known at Thessalonica as a title for the Holy Spirit on whom the readers had come to depend in their personal attempts to combat lawlessness -(1st Thessalonians. 1:6; 4:8; 5:19; 2nd Thessalonians. 2:13).

Dr. Gerald Stanton cites six reasons why this passage should be understood to refer to the Holy Spirit's restraining ministry through the church:

(1) By mere elimination, the Holy Spirit must be the restrainer. All other possibilities fall short of meeting the requirements of one who is to hold in check the forces of evil until the manifestation of Antichrist.

(2) The Wicked One is a personality and his operations include the realm of the spiritual. The restrainer must likewise be a personality and of a spiritual order, to resist the wiles of the Devil and to hold Antichrist in check until the time of his revealing.

(3) To achieve all that is to be accomplished, the restrainer must be a member of the Godhead. He must be stronger than the Man of Sin, and stronger than Satan.

(4) This present age is in a particular sense the "dispensation of the Spirit," for He works in a way uncommon to other ages as an abiding Presence within the children of God.

(5) The work of the Spirit since His advent has included the restraint of evil. The Spirit is God's righteous Agent for the age, and there are many reasons to be grateful for His restraining hand upon this world's iniquity. None but the Lawful One could restrain this world's iniquity.

(6) It is not difficult to establish that although the Spirit was not resident on earth during Old Testament days, whatever restraint was exerted was by the Spirit. - (Isaiah. 59:19). The wickedness of Noah's day and the fact that life went on as usual in blindness to impending destruction is used of the Spirit in vivid portrayal of careless and wicked men upon whom Tribulation judgment shall fall.

The Holy Spirit will be removed before the "lawless one" is revealed. -(2nd Thessalonians 2:6-8). That lawless one will certainly be revealed in the Tribulation. In fact, the Tribulation begins with the signing of the covenant

between the lawless one and Israel. That act will reveal the Antichrist's identity – (Daniel 9:27a).

The man of lawlessness in 2nd Thessalonians 2:1–12 is the Antichrist who will come on the world scene at the beginning of the Day of the Lord. This Day, sometimes called the “end times,” starts after the Rapture of the Church in 1st Thessalonians 4:13–18 -(cf. 1st Thessalonians 5:1–11). The Antichrist is given the title “man of lawlessness” (one of 33 names in the Old Testament and 13 in the New Testament) because he will oppose in every way the Biblical God and His law. He will be completely lawless. Daniel 7 speaks of this man as a “boastful” king who will “try to change the set times and the laws” -(verses 11 and 25). He will come offering a false peace to the world and will with his charismatic personality, incredible promises, and breathtaking miracles unite all nations politically, economically, and religiously under his leadership. At the same time, he will make a covenant with Israel for three and one-half years (cf. Daniel 9:27, where “seven” indicates seven years). In the middle of the seven years, the man of lawlessness will break his covenant with Israel, stop their sacrifices -(Daniel 9:27), and enter the temple to set himself up as “god” and demand worship -(2nd Thessalonians 2:4). This is the “abomination that causes desolation” that Jesus spoke of in Mark 13:14.

The “falling away” in 2nd Thessalonians 2:3 is better understood in its context as “the departure”. To augment Dr. Walvoord's point, the expression “the departure” was used by the first six English Bibles prior to the King James Bible. The KJV Bible translators opted for the term “*falling away*” during a period of time when there was an effort to seek reconciliation with the Roman Catholic elements who were advancing and attempting to undermine the translation of the KJV Bible. Instead they were promoting their own Jesuit Bible.

The work of the Holy Spirit making the Church like Christ in that they submit to death and persecution, whereas the Tribulation saints cry out for vengeance – (Revelation 6:10).

The Hermeneutical Argument

Only the Pre-Tribulation view allows for a truly literal interpretation in all of the Old Testament and New Testament passages regarding the Great Tribulation.

Only the Pre-Tribulation position clearly distinguishes the Church from Israel and identifies God's dealing with each as well as defining the necessity of an interval of time between the Rapture and the Second Coming.

The Church began on the Day of Pentecost with a visitation of the Holy Spirit as recorded in Acts 2. The Church ends at the Rapture with the translation of living saints and the resurrection of those who have died in Christ -(1st Thessalonians 4:13-18). Until the Rapture, God is gathering out from the Gentiles a people for

His name -(Acts 15:14) and combining them with the elect remnant of Israel - (Romans 11:5) into one new body called the Church -(Ephesians 2:11-3:13). This great task is accomplished by a unique ministry of the Holy Spirit only during the Church Age called the baptism of the Holy Spirit. Paul taught in 1st Corinthians 12:13, *"For by one Spirit were we all [Jewish and Gentile Believers] baptized into one body, whether Jews or Greeks, whether slaves or free, and we were all made to drink of one Spirit."* This work of the Holy Spirit is only for the Church. Therefore, it is not surprising that since the Tribulation cannot start until after the Church is completed and taken to heaven in the Rapture that the man of lawlessness is restrained through the presence of the Holy Spirit on earth indwelling Church Age Believers. This current work of the Holy Spirit is unique to the Church, Dr. John Walvoord explains. We search the prophetic Scriptures in vain for any reference to baptism of the Spirit except in regard to the Church, the body of Christ -(1st Corinthians. 12:13).

The Church is not found in the Bible until Jesus said he was going to build His church and that is found in Matthew 16:18 and 18:17. These are the only two places in the Gospels where the name or word "church" is found. However, from Acts to Revelation, the word "church" is mentioned 75X times, and always separate from Israel. Doctrine is based on building blocks, drawn upon through a comprehensive study of the major doctrines found in the Bible. It is not until Acts 2 and following that the clear picture of a separate body we know as the "Church" begins to be defined, fleshed out, and where its mission and particular blessings are defined, its message, purpose, and promises are made to the followers of Jesus Christ.

The specifics of a seven-year gap is based totally on the fact that God's plan for 70 weeks to bring about the end of sin is found in Daniel 9:24-27. History has shown that 69 of those seventy weeks specifically related to the Jews are completed. Since Christ's resurrection, we have been in a "Gap" where the clock for Israel has stopped and the clock for the Church Age is active. At the Rapture, the Church Age clock ends, and the clock for Israel begins to start ticking off the last seven years. This is what is known in prophecy as Daniel's 70th week.

All believers must appear before the Judgment Seat of Christ -(2nd Corinthians 5:10). This event is never mentioned in the account of events surrounding the Second Coming.

This is a confirmation that we are held accountable for our time here on earth, what we did with what God gave us, how we spent our time, how we treated others, used our talents, and treasure. IT HAS NOTHING TO DO WITH SALVATION. Paul's words merely point out the fact that God is equitable, and just, but our rewards in Heaven are determined by how we lived here and now. This is not about works-righteousness but about accountability.

The *“four and twenty elders”* in Revelation 4:1-5, 4:10, 5:8, 5:14, 11:16, and 19:4 are representative of the Church. Thus it is necessary that the Church be undivided and brought to glory before events of the Tribulation begin.

The Greek word translated here as “elders” is never used to refer to angels, only to men, particularly to men of a certain age who are mature and able to rule the Church. The word elder would be inappropriate to refer to as angels, who do not age. Their mode of dress would also indicate these are men. While angels do appear in white, white garments are more commonly found on believers, symbolizing Christ’s righteousness imputed to us at salvation -(Revelation 3:5,18; 19:8).

The golden crowns worn by the elders also indicate these are men, not angels. Crowns are never promised to angels, nor are angels ever seen wearing them. The word translated “crown” here refers to the victor’s crown, worn by those who have successfully competed and won the victory, as Christ promised -(Revelation 2:10; 2nd Timothy 4:8; and James 1:12).

There is clearly a coming of Christ for His Bride before the Second Coming to Earth. -(Revelation 19:7-10).

Tribulation saints are not translated (Raptured) at the Second Coming of Christ but carry on ordinary activities. These specifically include farming, construction, and giving birth. -(Isaiah 65:20-25).

The tribulation saints are, quite simply, saints living during the tribulation. The Bible indicates that a great number of people during the tribulation will place their faith in Jesus Christ. In his vision of heaven, John sees a vast number of these tribulation saints who have been martyred by the Antichrist: *“There before me was a great multitude that no one could count, from every nation, tribe, people and language, standing before the throne and in front of the Lamb. They were wearing white robes and were holding palm branches in their hands”* -(Revelation 7:9). When John asks who they are, he is told, *“These are they who have come out of the great tribulation; they have washed their robes and made them white in the blood of the Lamb”* -(Revelation 7:14).

The Judgment of the Gentile nations following the Second Coming -(Matthew 25:31-46) indicates that both the saved and the lost are in a natural body, which would be impossible if the Tribulation had taken place at the Second Coming.

The Judgment of the Nations, or Gentiles (the Greek word can mean either), takes place on earth after Christ comes to reign, as verse 31 clearly states: *“When the Son of Man comes in His glory, and all the holy angels with Him.”* If we are right in identifying it with Joel 3, the location is the Valley of Jehoshaphat, outside Jerusalem -(Joel: 3:2). The nations will be judged according to their treatment of

Christ's Jewish brethren during the Tribulation -(Joel 3:1-2, Joel 3:12-14; Matthew 25:31-46).

It is important to notice that three classes are mentioned—sheep, goats, and Christ's brethren. The first two classes, over whom Christ sits in judgment, are Gentiles living during the Tribulation. The third class is Christ's faithful Jewish brethren who refuse to deny His Name during the Tribulation in spite of towering persecution.

The separation of the saved and the lost would be unnecessary if the Translation (Rapture) took place at the same time as the Second Coming and requires a regathered Israel, or if all the saved had previously been separated by a translation (Rapture) at the Second Coming,

Differences between the Rapture and the Second Coming

At the Rapture, the Church meets Jesus Christ in the air. -(1st Thessalonians 4:16-17). At the Second Coming, Christ returns to the Mount of Olives with the Church. -(Revelation 19:6-14).

Revelation 9:14: Accompanying Christ are the “armies of heaven” referring to all believers who have been taken to heaven (in the Rapture, which will have occurred at some point prior to this). Here the believers will be returning to earth with Christ as part of his vast army. They will be dressed in pure white linen, as noted also in Revelation 19:8. Some suggest that this army will be angels because Christ had spoken of returning with his angels -(Matthew 24:30-31). Most likely, however, this army will be believers because Revelation 17:14 says that the victory will come through the Lamb “*and his people.*” The believers will come with Christ on white horses. They will not come to fight, however, for there will not need to be a battle. Christ will conquer with his potent word (Revelation 19:15).

At the time of the Rapture, the Mount of Olives is unchanged. At the Second Coming, it is divided (split in two) forming a valley east of Jerusalem. -(Zechariah 14:4).

At the time of the Rapture, saints are translated (Raptured). -(1st Thessalonians 4:16-17). No saints are translated at the time of the Second Coming. -(Revelation 19:6-14).

At the time of the Rapture, the world is not judged for sin, but descends deeper into sin. At the Second Coming of Jesus Christ, the world is judged by the King of kings. -(2nd Thessalonians 1:7-9)

The following people will be judged when Christ returns.

Those Living From The Nation Israel

When Christ returns, He will judge those from the nation Israel, who have survived the Great Tribulation. This judgment is described in Ezekiel 20:34-38. Jesus also illustrates this judgment in Matthew 25:1-30 in the parables of the ten maidens and the ten talents. These survivors of the Great Tribulation will be regathered from all over the world to the land of Israel. This will follow the victory of Christ over His enemies at Armageddon. The unrighteous will be purged from the righteous and sent away. Jesus illustrated this truth in the parable of the talents. *“As for this worthless slave, throw him into the outer darkness, where there will be weeping and gnashing of teeth.”* -(Matthew 25:30).

The Gentile Nations

Jesus spoke of judging the living Gentile (non-Jewish) nations at His Second Coming. These Gentiles are people who are still upon the earth during the Great Tribulation. They are the living, not the dead. The dead will be raised to judgment in the future. The prophet Isaiah wrote of these. *“Even the nations are like a drop from a bucket, and are accounted as dust on the scales; see, He takes up the isles like fine dust. All the nations are as nothing before Him; they are accounted by him as less than nothing and emptiness.”* -(Isaiah 40:15, 17). They will be brought to the city of Jerusalem and judged in the valley of Jehoshaphat. The righteous will enter into God's Millennial kingdom while the unrighteous will be taken to judgment. Like the unbelievers from the nation Israel, they will probably be killed at this time. Their final judgment is still future.

The Old Testament Saints

There will also be a judgment of the Old Testament saints. They will be raised from the dead and judged. Daniel wrote. *“Multitudes who sleep in the dust of the earth will awake: some to everlasting life, others to shame and everlasting contempt.”* (Daniel 12:2). *“For the Son of Man is to come with His angels in the glory of His Father, and then He will repay everyone for what has been done.”* - (Matthew 16:27).

The Tribulation Saints

When Christ returns, those who were killed during the Great Tribulation will also be judged. They will be raised from the dead in a glorified body, receive rewards, and will enter into the kingdom of God. In the Book of Revelation we read. *“I saw thrones on which were seated those who had been given authority to judge. And I saw the souls of those who had been beheaded because of their testimony for Jesus and because of the Word of God. They had not worshiped the beast or his image and had not received his mark on their foreheads or their hands. They came to life and reigned with Christ a thousand years. (The rest of the dead did not come to life until the thousand years were ended.) This is the first*

resurrection. Blessed and holy are those who have part in the first resurrection. The second death has no power over them, but they will be priests of God and of Christ and will reign with Him for a thousand years.” -(Revelation 20:4-6).

The church, the body of Christ, will have already been judged and rewarded before Christ returns.

The Translation (Rapture) of the Church is pictured as a “*deliverance*” from the Day of Wrath, whereas the coming of Jesus Christ is a “*deliverance*” for those who have suffered under severe Tribulation. The theme of “*deliverance before judgment*” is an integral aspect of God’s plan for the righteous followers of the Lord Jesus Christ. There are no fewer than 637 specific passages dealing with the “*theme*” of “*deliverance before judgment*”. Of all the different competing views on the Rapture, only the Pre-Tribulation Pre-Millennial view meets the requirements of God’s “*theme*” of “*Deliverance before Judgment*”.

The Rapture is only for the saved –(Titus 2:13-14), while the Tribulation and Second Coming deal with the entire world. The judgment pattern is an inherent feature of God’s rule as explained in the Mosaic covenant –(Leviticus 26, Deuteronomy 28). It is the Biblical answer to the problem of evil.

No unfulfilled prophecy stands between the Church and the Rapture. Many signs must be fulfilled before the Second Coming of Jesus Christ.

No passage in either the Old Testament or New Testament deals with the resurrection of the saints at the Second Coming nor mentions the Translation of living saints at that same time.

The word "saint" is derived from a Greek verb “*hagiazō*” whose basic meaning is “*to set apart,*” “*sanctify,*” or “*make holy.*” In the history of the Old Testament religion, the idea of holiness or separateness was inherent in the concept of God.

This idea of the separateness of God and His people is carried forward in the New Testament, which was written by Jews (except possibly Luke-Acts) who interpreted God's covenant with Israel through the teachings of Christ. Those who were dedicated to the teachings of Christ were frequently called saints by these writers (e.g., Matthew 27:52; Acts 9:13; 26:10; Revelation 14:12). Six of Paul's letters to churches are addressed to saints -(Romans, 1st and 2nd Corinthians, Ephesians, Philippians, and Colossians).

Saints, in the New Testament, are never deceased individuals who have been canonized by the church and given sainthood. They are living individuals who have dedicated themselves to the worship and service of the one true God as revealed through His Son, Jesus Christ. Even the children of such parents are called “*sanctified*” -(1st Corinthians 7:14-15). That is, they are considered

undefiled by paganism if at least one of their parents is a Christian. All saved are sanctified, but not all sanctified are saved.

The Nature of the Tribulation

Only the Pre-Tribulation view maintains the distinction between the *“Great Tribulation”* and the Tribulation in general, which will befall all humanity as the result of sin and evil in this life.

The Great Tribulation is properly understood in the Pre-Tribulation view as a preparation for the restoration of Israel. -(Deuteronomy 4:29-30; Jeremiah 30:4-11; Daniel 9:24-27; Daniel 12:1-2).

Not one single passage in the Old Testament which discusses the Tribulation mentions the Church. That is an important point in the Dispensational construct differentiating a unique difference between the Church and Israel.

In contrast to Mid-Tribulation, or Pre-Wrath views, the Pre-Tribulation view offers an adequate explanation for the beginning of the Great Tribulation in Revelation 6. These others are clearly refuted by the plain teaching of Scripture that the Great Tribulation begins long before the 6th trumpet of Revelation 11.

There is no proper groundwork provided that the 7th trumpet of Revelation is the last trumpet of 1st Corinthians 15. It is accepted only on the basis of assumption. The Pre-Tribulation view maintains the proper distinction between the prophetic trumpets of the Church and the trumpets of the Tribulation.

The Unity of Daniel’s 70th Week is maintained by the Pre-Tribulation view. By contrast, the Mid-Tribulation view destroys the unity and confuses the program for Israel and the Church. The Post-Tribulation view usually denies the clear teaching of the 70th Week by subverting it into some form of allegory.

The gathering of saints after the Tribulation is done by angels, whereas the gathering of the Church is done by *“The Lord Himself”* -(John 14:3; 1st Thessalonians 4:17).

Revelation 22:17-20 states, *“And the Spirit and the Bride say come, And he that heareth, let him say come ... He who testifieth of these things saith, “Yea, I come quickly, AMEN COME LORD JESUS”*.

At the Rapture Satan is not bound, while at the Second Coming Satan is bound and thrown into the abyss.

No passage dealing with the Resurrection of saints at the Second Coming, in either Testament ever mentions a Rapture of living saints at the same time.

Dr. Walvoord was a scholar of renown. We lost him a few years ago when he went home at the age of 95 to be with the Lord. His methodical analysis of Scripture will be greatly missed. His skill and scholarship was amply evident in his ability to reconcile confusing or what might be seen as confusing passages.

A Cup of Trembling

“Behold, I will make Jerusalem a cup of trembling unto all the people round about, when they shall be in the siege both against Judah and against Jerusalem. And in that day will I make Jerusalem a burdensome stone for all people: all that burden themselves with it shall be cut in pieces, though all the people of the earth be gathered together against it.” –(Zechariah 12:2-3)

World War II began in 1939 when Germany invaded Poland, with the U.S. entering in 1941 and ending in 1945. It was divided into belligerents, Germany, Italy and Japan, and Allies, France, Britain, the U.S., Russia and to a lesser extent, China.

A world war is described as *"a war that involves most of the principal nations of the world,"* according to most dictionaries. While the official definition for a world war, shown above, calls for all or most of the principal nations to be involved, at the beginning it was just the U.K. and France that declared war on Germany, after they invaded Poland. Nations then took sides, and global war commenced.

The point of this recap of history is to show that multiple nations are already taking sides in not only the Israel/Hamas war, but also the Russia Ukraine war, with more involved right now than in 1939, which is the consensus date of when WWII officially began.

Many are now saying that World War III is (since October 7th, 2023) already underway, the only question now is whether it will go nuclear, and between Israel, the U.S., Russia, China, all nuclear powers and on opposite sides of the Israel/Hamas war, each day we get closer to the first nuke being dropped. The Hamas invasion began exactly on the 50th anniversary of the start of the 1973 Yom Kippur War.

While Iran, who controls Syria, and the terrorists groups Hamas and Hezbollah, has both groups attacking Israel from two different sides, it is important if not absolutely critical to remember Israel's 'Samson option', *"Israel's deterrence strategy of massive retaliation with nuclear weapons as a "last resort" against a country whose military has invaded and/or destroyed much of Israel."* Seymore Hersh wrote the book, *'The Samson Option'* back in 1991. It was based upon the Biblical account of Samson who is said to have pushed apart the pillars of a Philistine temple, bringing down the roof and killing himself and thousands of Philistines who had gathered to see him humiliated. The More Things Change,

the More They Stay the Same! You need to understand that the Palestinians are the descendants of the Philistines.

We know this is being spoken about by some in Israel as we have seen an official already call for Israel to use their "Doomsday" nuclear option on their enemies. This is not a deterrent to Muslim nations surrounding Israel because according to their beliefs, the closer the world comes to being destroyed, the faster their "Mahdi" appears.

Mahdī, (Arabic: "guided one") in Islamic eschatology, a messianic deliverer who will fill earth with justice and equity, restore true religion, and usher in a short golden age lasting seven, eight, or nine years before the end of the world.

Some believe that it is not "if" a nuclear war will happen in the coming weeks or months, but "when," and much of the world is wondering who will drop the first nuke.

With only five weeks to the COP28 meetings, we are on the threshold of Biblical history and prophecy converging, culminating in a way that most of the world will not be able to come to grips with when millions are removed from the physical realm we know as home. Those left behind will be told that we were taken by ET's for re-education in order to calm folks of what happened at the Rapture. The Antichrist will sell them on the idea they can have immortality by following him, worshipping him, and taking his Mark.

The prophecy of the Tower of Syene is likely to take place before the Ezekiel 38/39 War. The reason for this is that Egypt is not in the list of nations or coalition found in Ezekiel 38/39. Five weeks may seem like a short time but in war decisions and actions can occur in split second timing!

When you read and hear that **Damascus** has been "Nuked" you will know that we only have days before the End! When Isaiah 17:1 is fulfilled, Russia will enter the picture that leads to World War III. We were told in advance it would happen! The Bible however does not name a nation or state responsible or behind it; it even could be the U.S. as much as Israel, or precipitated by an unknown client "third party". Russia has multiple business and defense treaty agreements with Syria that will bring in Russia quickly. The COP28 meetings are still on schedule and the calendar dates below are baked into the cake.

World War III (Ezekiel 38/39 included) will break out once the Antichrist, aka Prince Charles signs/confirms the 'Covenant with the Many' of Daniel 9:27. Even Prince Charles' chief lieutenants like Klaus Schwab have stated that Tribulation would occur. In fact they are pushing this war to occur!


Believers worldwide will be Raptured out of here just before or at least prior to when Prince Charles makes his rare appearance at the COP28 being held in Dubai

that will usher in the Great Tribulation of Daniel 9:27. Hanukkah, 2023 offers still another possible Rapture date within this time frame!
