

An Ecumenical Organization Asks Oil Executives to Adhere to the Pope's Teachings in Laudate Deum Concerning the Common Good

On October 17, 2023, the following was published in 'The Tablet', an international Catholic news journal based in London, England:

- "Christian Climate Action (CCA) held a vigil on Monday evening outside a three-day meeting in London attended by oil company executives. Around 25 people attended the ecumenical vigil, holding candles in a 'circle of lament' and praying. One of the organizers, Melanie Nazareth, told 'The Tablet' they prayed that those taking part in this conference would do as the pope asks and 'be strategists capable of considering the common good, and the future of the children, more than the short-term interests of certain countries or businesses'."
- "Sections were read out from Laudate Deum, the public exhortation Pope Francis published two weeks ago on the climate crisis. Activists quoted his comments on the crisis not being just ecological but 'a human and social problem' and his plea that 'we must move beyond the mentality of appearing to be concerned but not having the courage needed to produce substantial changes'."

Agents of the church are currently pressuring business leaders to embrace the Pope's message on climate change. All the major denominational churches seem to be in favor of this kind of lobbying effort. The scientific world supports this. Leaders in business, finance, and politics are getting involved in the climate movement. They're all on the same page. Additionally, the Vatican is coordinating strategies and responses to address the climate change crisis with the backing of nations worldwide.


The prophetic developments regarding the religious and political situation that the Bible predicted would take place in the end times are truly amazing to every student of Bible prophecy. Revelation 13 describes the revival of the Papacy and the development of the image of the Beast. Rome is leading the churches in trying to bring about the final crisis with its increasing agitation for Laudate Deum in the U.S. and around the world:

"When the leading churches of the United States, uniting upon such points of doctrine as are held by them in common, shall influence the State to enforce their decrees and to sustain their institutions, then Protestant America will have formed an image of the Roman hierarchy, and the infliction of civil penalties upon dissenters will inevitably result."

Inspiration tells us that the "professed Protestant world" will form "a confederacy with the man of sin". But who will force this union? There is no need to guess. We have been told exactly who will do this. The ecumenical movement is now a half-century and most of the Protestant clergy/laity have been asleep to what their leaders have been doing to bring them under the pope's authority.

One of the first steps or outcomes of the ecumenical movement was with the creation of the NIV Bible, the "New International Version Bible" is exactly what Rome wanted and stated that it was a Bible to unite the RCC and Evangelical Christianity back in the 1970s. The NIV translation and most modern translations are largely based upon the

flawed Alexandrian school in Egypt followed by Rome. The Antioch school is the source of the Majority Texts used to translate the KJV, NKJV, and the NASB. The Majority Texts are considered the most in (quantity and quality) existence in and around the land of the Bible during the first four centuries A.D.



The NIV is a translation of the Nestle-Aland critical text of the Greek New Testament. It also critically evaluates the BHS for the OT, and often takes the Greek Septuagint as being a more reliable record than the Masoretic Hebrew.

Now most translations today are also based on these critical texts, and most people and scholars approve of their use of being easier to read. But there is a small minority of people who think the Textus Receptus or the Majority text is more reliable. Some of these fit into the KJV only movement, while others are not as concerned with the translation, just which source texts are used. If you see anyone talking about "missing" verses, this is what they mean: compared to the TR or MT, the NIV has fewer verses and something like 64,000 fewer words. To me that is a no-no based on the words of Revelation 22:18-19: "For I testify unto every man that heareth the words of the prophecy of this book, If any man shall add unto these things, God shall add unto him the plagues that are written in this book: ¹⁹And if any man shall take away from the words of the book of this prophecy, God shall take away his part out of the book of life, and out of the holy city, and from the things which are written in this book."

The main issue regarding the text is the choice of the corrupt Westcott and Hort/Nestle-Aland text rather than the Textus Receptus. There are of course two much divided schools of thought on that matter. Westcott and Hort were avowed Satanists and apostates and deceived the church of what became the basis of the Revised Standard Bible of 1900. An even larger problem is that the Westcott and Hort text undermines the Heptadic Design Feature which validates the DNA structure of the original 1611 KJV Bible. The 'HDF' is the equivalent of the Divine Signature of God, His Fingerprints if you understand what I am saying. Most theologians sold out many years ago to the Copyright System of compensation which encourages scholars to write newer translations at the expense of Truth of God's Own Words!

I will name a few here that makes my point of great importance:

The translation of the NIV makes Christ appear to be without authority, and contradicts other Scripture that affirms His nature and deity as the Son of God -(John 10:30; John 20:28; 1st John 5:7). It also implies that as He took on the likeness of a man, that therefore man is also nothing. This is not just a bad translation, but a completely false translation, and if not outright blasphemy it certainly borders on it.

The NIV obliterates the subjunctive mood. In John 3:16 it makes the text say exactly opposite what the original text says. It changes the word "should" to "shall" (Once saved Always saved). "Should be saved" gives hope but does not give a guarantee. "Should" reflects the subjunctive mood of the original text but "shall" puts the translation into the indicative mood which indicates a statement of fact. If this condition were true only in a case or two, it might not make so much difference, but the NIV has eliminated the subjunctive mood throughout the New Testament. Satan uses subtleties to deceive!

The NIV Teaches the church was built on Peter.

Matthew 16:18 (NIV), "And I tell you that you are Peter, and on this rock I will build my church." Then the footnote says, "Peter means rock." But Jesus says Peter is a pebble, and the great confession Peter made concerning the Deity of Christ (vs. 16) is the "ROCK" foundation upon which the church is built -(1st Corinthians 3:11). The NIV translators did what the Catholics have wanted to do for years but did not have the nerve to do.

To the reader these may seem insignificant; however, God made a point in what the Apostle John was told to write in 95/96 AD, referring you back to Revelation 22:18-19 noted previously.

Pope Francis has over the decade of his reign as pope proved he is not a Christian and so the world can look forward to his efforts to cajole the world into believing Francis is more important than the Lord Jesus Christ.

"Yet under one head—the papal power—the people will unite to oppose God in the person of His witnesses. This union is cemented by the great apostate"

Rome cements the union. How does she do it? Again, we don't have to guess. 

The publishing industry has gone to a great deal of work to make the choice of purchasing a Bible can be made by knowing what you are looking for. An example can be seen on the next page, which even provides a prospective purchaser of a Bible, its reading level. The example I have included below shows how Bibles compare with others. It is my personal opinion that it does not hurt to have at least one of each of the three groups above. Even this chart does not include all the Bibles. Over the past century, it seems that each new Bible to hit the market has a lower reading level scale. The most obvious one at first glance is Eugene Peterson's 'The Message' Bible. I had a District Superintendent in Kentucky who thought it was the best thing since sliced bread. 'The Message' Bible is rated at a fourth grade reading level. It is an excellent example that reflects the dumbing down of Americans. I am not being critical here, just stating facts; I worked in the publishing industry at the college level and the first question by a

college professor would ask was, "What is the reading level of the book I was promoting." That kind of question tells you a whole lot about out education system!

World Bank warns of huge oil price surge

The organization warned millions could go hungry if hostilities between Israel and Hamas continue to intensify.

Continued escalation of Israel's war with Hamas could push oil prices into "uncharted waters," the World Bank warned in its Commodity Markets Outlook on Monday.

The World Bank cautioned that while the war's effect on oil prices had been limited thus far, the future "would darken quickly if the conflict were to escalate." The organization's report outlined three potential futures based on the level of disruption escalating hostilities might cause in global oil supply.

A "small disruption," removing 500,000 to 2 million barrels of oil from circulation per day, would be mostly absorbed by the market, the bank predicted. Prices would inch up from the current \$90 per barrel to between \$93 and \$102, canceling out the \$9 drop it had previously predicted by next year in the face of slowed economic growth.

A "medium disruption," the equivalent of the U.S.' 2003 war in Iraq, could see prices increase between 21% and 35%, with 3 to 5 million barrels per day taken out of supply – leaving oil priced between \$109 and \$121 per barrel, the report stated.

A "large disruption," which the bank likened to the Arab oil embargo of 1973, with 6 to 8 million barrels eliminated from supply per day, could see prices surge between 56% and 75%. This would drive the cost per barrel up to between \$140 and \$157.

Higher oil prices would translate to spiking food prices, exacerbating current food insecurity and causing millions to go hungry, World Bank deputy chief economist Ayhan Kose explained. "If a severe oil price shock materializes, it would push up food price inflation that has already been elevated in many developing countries" as a result of the Ukraine conflict, he said.

Nearly a tenth of Earth's population – over 700 million people – were undernourished by the end of 2022 due to disruptions in commodity markets caused by the conflict, he added.

World Bank chief economist Indermit Gill urged policy-makers to "be vigilant," warning that "the global economy would face a dual energy shock for the first time in decades – not just from the war in Ukraine," which he called "the biggest shock to commodity markets since the 1970s," but from the Middle East as well if the war in Gaza continues to escalate.

While oil prices have increased 6% since Hamas' attack on Israel earlier this month, agricultural commodities and precious metals have "barely budged," the World Bank reported.

Israel expanded its ground assault on Gaza on Monday, with tanks reportedly advancing on Gaza City from multiple directions. Over 8,000 Palestinians have been killed and hundreds of thousands displaced under the most intense bombing of Gaza in Israel's history.

From the archives of Pastor Bob's Studies on Deliverance before Judgment / Pre-Tribulation Rapture Why The Rapture Occurs Before the Revealing of the Antichrist!

Dr. John Walvoord's "50 Reasons for a Pre-Tribulation Rapture" was concluded in Part 8. Born in 1910, Dr. Walvoord was around a long time before he went to be with the Lord in 2002. At the height of his scholarly life, he was one of a half dozen major theologians who taught Dispensationalism and the Pre-Tribulation Rapture. He was president of Dallas Theological Seminary from 1952 until 1986 and wrote numerous books. One of the most important books he wrote is titled:

'The Prophecy Knowledge Handbook', which covers all the Bible prophecies. It is a huge reference work, but modestly priced as a hard-bound book published in 1990. This is just one of his many books I have in my personal library today.

The typical Christian believer seeking to understand Bible prophecy would be greatly blessed by reading Dr. Walvoord's books. One could study Dr. Walvoord's "50 Reasons for the Pre-Tribulation Rapture" and rest on what he has presented as credible evidence and be sufficiently informed on what I define as "Deliverance before Judgment". I have been a student of Bible prophecy since June 8, 1967, the date following the Arab-Muslim nation's attack on Israel. Known today as the Six-Day War, that date actually marked the beginning of a cycle of 2,520 weeks between June 6, 1967 and September 23, 2015. This astonishing time frame led many prophecy students to an anticipation of the Rapture initially thought to occur last fall. The number 2,520 is most significant in ways few people realize. A series titled "God's Clock and June 7, 1967" was begun in the summer of 2015. Currently, the series is incomplete and on hold because there are some unanswered details yet to establish. We are presently experiencing what can be termed "a silence" or "holding pattern" and there are questions to discuss related to why this is occurring. In a coming segment, additional information recently discovered will be revealed concerning the significance of the Biblical number 2,520. I, personally hold the view that we are in a "prophetic holding period". It should be perceived as a warning! I believe we are on borrowed time before God's clock starts up again!

There was so much in the way of pertinent news that occurred during the last three months of 2015 that were relevant to the Lord's return. For starters, Pope Francis visited the White House in Washington, DC on the same date as Yom Kippur on September 23rd and held a session with President Obama, and a joint session with the U.S. Congress on September 24th. Then his visit included an address to the United Nations in New York the day after that. This event was not a spare of the moment notice or brought about by accident. Nor was it some randomly selected date. It was planned nearly two years earlier for these specific dates. All this begs the question: Why?

September 13th on the Hebrew calendar initiated and marked three important calendar cycles in reference to the nation of Israel:

A millennial beginning of the year 6001

A Jubilee Cycle, which occurs every fifty years

A new Sabbatical Cycle of seven years

Further, in this particular Sabbatical year of 2014-2015, we experienced a double set of Blood Red moons. This is referred to as a 'tetrad' (a series of four consecutive lunar eclipses—all coinciding on Jewish holidays—with six full

moons in between, and no intervening partial lunar eclipses). The tetrad of Blood moons began with the April 2014 lunar eclipse and was thought to be a sign of the end times as described in the Bible in the book of Joel, Acts 2:20 and Revelation 6:12. The tetrad ended with the lunar eclipse on September 27-28, 2015, which was also a Super Blood Red moon on the Hebrew Feast of Sukkot. The September 28, 2015 total lunar eclipse was the fourth and final eclipse in the series of four total lunar eclipses. The first three eclipses took place on April 15, 2014 (Passover), October 8, 2014 (Sukkot) and on April 4, 2015 (Passover). In the very middle of the Sabbatical Year there was a solar eclipse on March 30, 2015 and a partial solar eclipse at the end of the Sabbatical year on September 13, 2015 (Rosh HaShanah). According to the Jewish calendar, the year 5775 (Sept. 24, 2014—Sept. 13, 2015) was a Sabbatical or Shemitah year. In biblical times, a Sabbatical year or Shemitah was observed every seventh year under the Mosaic Law as a "Sabbath" during which the land was allowed to rest.

The Festival of Sukkot began on Tishri 15 (September 28, 2015), the fifth day after Yom Kippur (September 23, 2015). It is quite a drastic transition, from one of the most solemn holidays in the Jewish year to one of the most joyous. Sukkot is so unreservedly joyful that it is commonly referred to in Jewish prayer and literature as the "Season of our Rejoicing".

The bottom line of this information is that many of us anticipated the Rapture to begin on Rosh HaShanah – occurring from sundown on September 13th to sundown on September 15th. The reason for such great anticipation will be shared in future segments. There are many threads to this larger picture of the Pre-Tribulation Rapture doctrine yet to be explored. I merely ask for patience so that you can benefit from all the evidence that will be presented in this series. As stated earlier, Dr. John Walvoord's list of 50 reasons for a Pre-Tribulation Rapture is extremely important. There is so much more to the larger theme of "Deliverance before Judgment". As we progress, we will explore how this idea of deliverance weaves its way through the "Theme of the Bride" and the meaning of the "Feast Days of the Lord" as well as other threads yet to be mentioned - all designed for God's Grand Plan to benefit mankind.

If you are an observant individual with regards to unfolding world events and the ever increasing madness occurring worldwide, then you will likely be pondering questions that are relevant to your life, family, employment and retirement, etc. If you recognize the unstable world in which we live, you probably are wondering what all of this means in light of Bible prophecy, end times and the Word of God.

The Rapture is going to make an incredible impact throughout the world. Those who are Raptured could be anyone, including friends, family, neighbors, or homeless street people. Facts are needed and you will want to grasp the truth found hidden within events leading up to the Rapture and how Biblical prophecy comes into focus as it is fulfilled. Entire families could disappear in the Rapture and disbelieving spouses could find their mates have vanished, along with

children. It is true. Born-again Christians will be 'Translated' or 'Raptured' from the face of this earth to meet the Lord in the air. In an instant they will be gone! To say this will be shocking for everyone is an understatement!

It is possible that when the Rapture occurs, the internet and perhaps some media outlets might even censor or try to thwart the truth of this event from surfacing and impacting public awareness. Those left behind will have a problem explaining away or making light of this event. They may even try to convince people that the Rapture didn't occur at all. World leaders will have to admit that it did happen. Then, logically many will begin to realize that everything that was taught and preached by Christians about Jesus Christ, the Bible and eternity must be true. The effects of the Rapture will shock everyone from every walk of life and people will want to talk about it. Unfortunately, world leaders will go to great lengths to embark on a campaign of misinformation and great deception while they attempt to convince the world's populations of their version about what happened to the missing Christians.

It is important that this message not be interpreted as a message of doom and gloom or something to be feared. Quite the contrary, it offers a timely warning in sufficient time for those who listen and digest its content for the purpose of preparing oneself spiritually for what lies just over the horizon. Turn on the world news, and take in how the world is imploding right before our eyes. There are no places to hide or escape to when the global financial and economic system is on the verge of collapse or collapses outright. The big slump for China came as the Shanghai Composite lost more than 8% on Monday, August 24, 2015 causing other stock markets to nose-dive as well. After the Dow dropped more than 1,000 points lower in the first minutes of Black Monday, it ended the day with a decline of 588.40, or 3.6%. Investors all over the world panicked. Before trading started on January 4th, the first trading day of 2016, Chinese financial media were full of cheery predictions that the nation's markets would "open the door to red"—that is, get off to a flying start. But when the door opened, it was a flood of green. The CSI 300, an index of the country's biggest stocks, fell by 7%, the worst-ever start to a year for Chinese markets.

Presently, you might be hearing how well the U.S. economy is doing but the fact is that there are almost 95,000,000 adults out of the employment market today. 48-million are receiving EBT or SNAP benefits just to survive. But the crash of 2016 really is coming. Dead ahead! As I write this, Germany's largest bank, Deutsche Bank, is expected to collapse at any time. The ripples of this possibility are profound and expected to surpass the Lehman Bank collapse of in 2008. Maybe not till we get a bit closer to the presidential election cycle of 2016. But a crash is a sure bet, it's guaranteed certain: Complete with echoes of the 2008 crash.

Many will come to faith during the Great Tribulation, but the cost for the delay or neglect in taking the Gospel message seriously carries a very high price. Many will be saved now and repent, thus avoiding the Great Tribulation. The question you have to ask yourself and answer is: will the cost be too high to pay? Sometimes there is tremendous resistance to the Pre-Tribulation Rapture because people have been misled by the apostasy of this age.

Often Religious leaders today are naïve and ignorant of the Biblical message. Many today are in their corporate leadership position because of the attractive lure that perks and benefits provide with a religious vocation. They simply do not take the Word of God seriously. I lost close to \$1.5 million in salary, perks, and pension benefits when I left the institutional UMC church because I refused to yield to the acceptance of changing teachings within the liberal church today. To simply assume that any or every church is Biblically sound is a dangerous supposition to make because of how heresy and rampant apostasy has infiltrated so many churches since the 1970's.

Devastating leaks from the New Zealand government have revealed that the fully-vaxxed nation has suffered a staggering 3,000 percent spike in excess deaths over the past two years.

Official data shows that 95.8% of the eligible New Zealand population aged 12 and over have received one dose of the Covid mRNA shots.

The head of a New Zealand political party has cited leaked documents while raising the alarm about the Australasian country's soaring excess mortality rates. Liz Gunn, head of NZ Loyal, is warning that tens of thousands of the nation's population have died from the Covid injections.

Gunn is one of few politicians in New Zealand who has spoken out about the number of excess deaths in the country of 5 million since the rollout of the Covid shots.

A recent report revealed that, during a 49-week period in 2022, there were 5,285 excess deaths in New Zealand.

The number is a 3,203 percent increase over the figures for 2020, the last year before the Covid shots were rolled out.

Gunn said she was contacted by a whistleblower who gave her leaked government documentation.

"The number of deaths is usually less than the number of those suffering from ill effects of the injections, then the extrapolation of the numbers that have been injured and killed starts to become, frankly, eye-watering," Gunn said.

"People who attended the same jab site, and were jabbed one after the other, at consecutive times on the same day.

"We saw their jab date and we saw their date of death," Gunn noted.

As one of many examples to illustrate the point, Gunn cited a recent study that was conducted in New Zealand.

An investigation for the study, which was led by Gunn, found that every single person who received a Covid mRNA shot from one clinic died suddenly shortly after vaccination, within the same timeframe.

Gunn, a former TV host-turned-investigative reporter, tracked down patients who had received Covid vaccinations from the same clinic in New Zealand.

Alarmingly, she traced all 30 patients who were vaccinated by the clinic on the same day and discovered that every single one of them had died around the same time.

Gunn published a video update about the findings and described New Zealand as "a crime scene."

"On one day, 30 people were jabbed on the same day, at the same location," Gunn said of the study.

"All are now deceased," she continued.

"And their deaths are in close temporal, time, proximity to each other. We are calling for an inquiry. Not just any inquiry. A full-blown criminal investigation leaving no stone unturned."

New Zealand reporter Meryl Dorey noted that locals in small towns have been raising the alarm about excess deaths for some time.

"I clearly remember when the Vaxxed Bus was in Lightning Ridge last year — a town of about 3,000 people," Dorey wrote for Informed Choice.

"We spoke with 25 locals and every single person we spoke with could name at least 3 people they personally know who died after a Covid jab and 6 to 10 who were injured."

"Until they are proven to be safe, effective, and necessary, we should not be forcing, mandating or even using any medical products which are essentially untested."

"I applaud Liz Gunn and pray she will be successful in her appeals."

Yet despite the pressure for the general public to get vaccinated, the left-wing New Zealand government issued over 11,000 exceptions to key staff.

The government raided people's private homes and arrested citizens who refused to obey the lockdowns and forced injections.

However, evidence has now emerged that the government secretly <u>granted</u> <u>exceptions</u> to elites who didn't want to get vaccinated or be locked in their mansions.

The hypocritical vaccine exemptions for the elite were granted by former Prime Minister Jacinda Ardern's government before she stood down and accepted a new role as the World Economic Forum's global "disinformation czar."



On Sunday, SpaceX launched 23 satellites from Cape Canaveral in the morning, and 22 more from Vandenberg Air Force Base in the evening. On October 17, 2023, the journal 'Science', reviewing filings with the International Telecommunication Union, informed the world that the number of filings and the number of planned satellites have again more than doubled. There are more than

90 filings for constellations of over 1,000 satellites each. Twenty-three have over 5,000 satellites, and eight have over 10,000 satellites. As of December 31, 2022, the number of satellites being planned by 300 companies and governments exceeded one million. And in June, 2023, E-Space, a company based in France and founded by Greg Wyler in 2022, filed a plan for a single mega-constellation containing 116,640 satellites. E-Space had previously filed a plan, via the government of Rwanda, for an even larger constellation containing 327,320 satellites. Two days after his new filing with the ITU, Wyler clarified that "Our filing in France is in addition to our filings in Rwanda."

Dr. Firstenberg's 'Our new network, People Without Cell Phones', is more important than ever. The only way to diminish the demand for bandwidth that is turning the Earth into a giant computer, with all living beings electrocuted inside of it, is to stop using cell phones. 
understand the larger plan to 'divide and conquer'. Satan's demonic plans are to steal, kill, and destroy. –(John 10:10)
