Happy Belated All Saints Day! Let's Talk About the Martyrs Who Died at the Hands of the Catholic Church

Today, November 1st is All Saints' Day, a day when Roman Catholics around the world pay homage to their canonized saints. The ecumenical movement does little to keep its believers informed. But let's shatter the usual narrative and cast the spotlight where it's often deliberately avoided—on the indomitable Protestant martyrs who were gruesomely executed by the Roman Catholic Church. These were not mere dissenters or reformers—these were defenders of the gospel who chose excruciating death over compromising their convictions. And while the Roman Catholic Church would love for their stories to be discounted, wiped out, made into mere footnotes in religious history, the reality is that they are monumental testimonies to the enduring power of the Holy Spirit through faith in the face of relentless persecution.

Over the centuries, countless men and women have faced unspeakable horrors and brutal executions, most often at the hands of Roman Catholics, all because they dared to challenge a religious system they believed was corrupt and contrary to the teachings of Scripture. These certainly were not rabble-rousers or anarchists, these were men and women rooted in the Word of God, who held to their convictions with an unyielding resolve that should stir every believing heart.

The bloody era of the Reformation encapsulates the severity of what was at stake. Men like William Tyndale, who was strangled and burned at the stake, gave their lives so that the Bible could be read in the vernacular. Tyndale's crime? Translating the Scriptures into English so that even the common farmer could have access to God's Word. He wasn't doing this to try to undermine civil order. Rather, his mission was to ensure that the true gospel could be understood by the people, free from the convoluted doctrines and practices of the Roman Catholic Church.

Then there was Hugh Latimer and Nicholas Ridley, burned alive in Oxford for their belief in the authority of Scripture over church traditions, the doctrine of justification by faith alone, and the rejection of papal authority. These were educated men who had much to lose in terms of earthly goods and reputation. Yet, when they were given the choice to

recant these specific beliefs or die, they chose the latter. Why? Because they understood that allegiance to these core tenets of the gospel was far more important than sparing their earthly lives. Their deaths were not in vain but served as a roaring declaration that such foundational truths could not be suppressed.

John Huss, a predecessor to Martin Luther, met a similar fate. He was burned at the stake for heresy, a charge leveraged against him for his criticisms of the moral failings and theological errors within the Roman Catholic Church.

Jerome of Prague was not merely a close associate of John Huss but a compelling theologian and philosopher in his own right. He was a master of multiple languages and well-versed in both the Scriptures and the early church fathers. Having studied at the universities of Prague, Oxford, Paris, and Heidelberg, Jerome was an intellectual force to be reckoned with. He was deeply influenced by the teachings of John Wycliffe and his fellow countryman John Huss. Together with Huss, Jerome sought to reform the Roman Catholic Church, challenging its excesses, doctrinal errors, and unbiblical practices.

But Jerome's brilliance and commitment to the gospel would put him on a collision course with the Roman Catholic hierarchy. He was arrested and charged with heresy, much like his friend Huss. Jerome initially recanted his views under the threat of execution but later revoked his recantation, unable to betray his conscience and the truths he found in the Scriptures. In 1416, about a year after the execution of John Huss, Jerome too was burned at the stake. But even as the flames rose around him, he did not waver. Jerome displayed remarkable courage and composure, reportedly singing a hymn—specifically, the liturgical Latin hymn known as the "Te Deum," a hymn of praise to God—as he met his gruesome end.

Russia warns Israel about attacks on Syria

Spreading conflict to other countries in the Middle East is “unacceptable,” Russian Foreign Minister Sergey Lavrov said on Tuesday, while discussing a spate of recent Israeli airstrikes with his Syrian counterpart.

Lavrov brought up the issue of Israeli airstrikes, “which have become more frequent against the backdrop of events around the Gaza Strip,” during a phone call with Syrian Foreign Minister Faisal Mekdad, the Russian Foreign Ministry said in a readout of the call.

Both ministers “emphasized the danger of attempts by external forces to turn the Middle East, in its current explosive situation, into an arena for settling geopolitical scores,” the readout added.

Mekdad phoned Lavrov to discuss the situation in Gaza, as well as a number of bilateral issues and the progress in ending the war in Syria. While the 2011 attempt at armed “regime change” backed by the West and some regional powers ended in failure,

the north and northeast of Syria remain outside the control of the government in Damascus.

Since the Hamas incursion from Gaza on October 7, Israel has bombed Syria at least three times, **repeatedly** shutting down the airports in Aleppo and Damascus. One of these attacks was acknowledged by the Israeli ambassador to Germany, who said it was intended to disrupt *“weapons deliveries from Iran.”*

Israeli Prime Minister Benjamin Netanyahu once said there had been “hundreds” of strikes on Syria over the past decade. On the rare occasions when the Israel Defense Forces (IDF) comments on the attacks, it claims to have acted in pre-emptive self-defense against Iran, accusing Tehran of supplying Hezbollah militants. Damascus has repeatedly insisted that the raids constitute a violation of Syrian sovereignty, but to no avail.

Lavrov and Mekdad agreed on the need for an *“immediate end to the bloodshed”* in Gaza and a solution to all the humanitarian problems created by the fighting.

Russia has condemned the Hamas attack but called Israel’s response against Gaza an unacceptable form of *“collective punishment”* against innocent civilians. Moscow has called for a peace settlement between Israel and the Palestinians through the creation and recognition of an independent Palestinian state.

The Abraham Accords are not at risk amid the war between Israel and Hamas, said Dr. Ali Rashid Al Nuaimi, chairman of the Defense, Interior, and Foreign Affairs Committee of the United Arab Emirates Federal National Council on Tuesday, according to the European Jewish Press.

You can call the Abraham Accords anything you like, call it normalization, an agreement, a memorandum of understanding. What it really is it is a covenant between Israel and her enemies, it was just confirmed this week by the UAE, and will be confirmed by Antichrist in the days after the Rapture of the Church takes place. “The Accords are our future. It is not an agreement between two governments, but a platform that we believe should transform the region where everyone will enjoy security, stability and prosperity. This is a people-to-people engagement. This is what we need,” Nuaimi said.

“We want everyone to acknowledge and accept that Israel is there to exist and that the roots of Jews and Christian are not in New York or Paris but here in our region. They are part of our history and they should be part of our future.” The Emirati official explained that the UAE wants to change the educational system and religious narrative.

Emirati officials warns of ‘enemies’ opposed to Abraham Accords

“It is very important to understand that there are enemies for what we are doing,” he said. “Those terrorist organizations don’t respect human life. Don’t let them achieve their goals. No person with a human feeling and common sense will agree with the barbarian terrorist attack that Hamas committed on October 7: No one.”

Nuaimi stressed that “enemies” took advantage of the war and that there is a difference between Hamas and the Palestinian people.

“We need those who believe in peace in Europe, the US and everywhere to counter the hate narrative that we see in demonstrations in Paris and London.”

Amid the war between Israel and Hamas, the UAE has issued statements condemning both Hamas’s assault on Israel and Israel’s ground operation in the Gaza Strip.

BREAKING: FDA Is REFUSING To Recall Pfizer's COVID-19 Vaccine Over DNA Fragments

The FDA is not required to take Pfizer's COVID-19 vaccine, or other COVID-19 shots, off the market, an agency spokeswoman told The Epoch Times via email.

The U.S. Food and Drug Administration (FDA) is refusing to recall Pfizer's COVID-19 vaccine, promoting the view that the inclusion of a previously-undisclosed DNA sequence that leaves behind fragments is not of concern.

The FDA is not required to take Pfizer's COVID-19 vaccine, or other COVID-19 shots, off the market, an agency spokeswoman told The Epoch Times via email.

"With over a billion doses of the mRNA vaccines administered, no safety concerns related to the sequence of, or amount of, residual DNA have been identified. With regard to the FDA-approved mRNA vaccines, available scientific evidence supports the conclusion that they are safe and effective," the spokeswoman added.

The FDA did not provide any evidence to back up its position.

The email came in response to 10 questions about the inclusion of the Simian Virus 40 (SV40) DNA sequence in the Pfizer-BioNTech shot.

The Epoch Times has submitted a Freedom of Information Act query to try to unlock when the FDA learned about the sequence, and from whom. The FDA denied expedited processing for the request, claiming there is not a *"compelling need"* to quickly provide the information.

Several foreign agencies, including [Health Canada](#), have confirmed outside scientists' assessment that the vaccine contains the DNA sequence. They've also said Pfizer did not highlight the inclusion in regulatory filings.

The FDA would not answer a number of questions about the sequence, including when the agency learned about its inclusion and whether it learned about it from Pfizer.

Pfizer and its partner, BioNTech, have not responded to inquiries.

The inclusion was first identified by Kevin McKernan, a former researcher and team leader for the Massachusetts Institute of Technology Human Genome Project.

"Nothing will be identified if they continue to choose not to look," Mr. McKernan told The Epoch Times via email.

A number of scientists have said the inclusion raises major concerns, such as having potential for oncogenesis—or a process that leads to cancer—including Dr. Robert Malone, a vaccine expert whose work [has been cited](#) by Pfizer.

The inclusion means the Pfizer shot is *"adulterated"* and should be recalled, Dr. Malone [told The Epoch Times](#).

Federal law states that the FDA can test drugs suspected of being adulterated. If the drugs fail to meet certain standards, and a health hazard is found, the FDA is directed to advise the manufacturer to issue a recall.

If the manufacturer then fails to issue a recall, *"seizure should be considered,"* the law states.

"The general policy is that if there's adulteration and reasonable risk of toxicity, there must be immediate action," Dr. Malone told The Epoch Times. *"This is a core mandate to the FDA from Congress to prevent adulteration of drugs, medical devices, and food. And then the next question is, is that adulteration? Is it associated with a reasonable risk of toxicity in humans? And my opinion is, absolutely."*

Dr. Malone, after reviewing the FDA's response, said that regulators have not done their job.

"The normal process worldwide has been that that risk must be rigorously assessed proactively. But they haven't done it, and their rationale for not doing it is the reason why they were so adamant that this is not a gene therapy technology," Dr. Malone said.

Moderna has said that its vaccine meets the FDA's gene therapy definition, but regulators have defined the Pfizer and Moderna products as vaccines, avoiding questions about oncogenesis.

Why Was SV40 Included?

SV40 sequences have been used by biotechnology companies in drug products.

"Specific sequences for the non-infectious parts of SV40 are commonly present in plasmids used for manufacturing of biological active substances," the European Medicines Agency (EMA) told The Epoch Times via email.

The purpose is primarily to *"drive very aggressive expression of a gene,"* Mr. McKernan [told The Epoch Times](#).

EMA alleged that Pfizer considered the sequence *"a non-functional part of the plasmid."*

"If commonly used, then why are they included if they serve no function?" Dr. Malone wondered in a Substack [post](#).

But the result is residual DNA left behind, according to testing. That could have negative effects, some scientists say.

David Wiseman, a former Johnson & Johnson scientist who conducted [some of the testing](#), said that he's concerned the residual DNA pieces *"could actually get into your genome."*

If it does that, *"it can disrupt gene regulation and potentially lead to the oncogenesis,"* Mr. McKernan said.

Phillip Buckhaults, professor of cancer genomics and director of the Cancer Genetics Lab at the University of South Carolina, said earlier this year that he tested vials of Pfizer's vaccine and detected DNA.

"I'm kind of alarmed about the possible consequences of this both in terms of human health and biology, but you should be alarmed about the regulatory process that allowed it to get there," he told the South Carolina Senate.

Mr. Buckhaults said the DNA *"could be causing some of the rare but serious side effects like death from cardiac arrest."*

He has encouraged regulators to test the Pfizer vaccine.

"This is probably not a problem, but it is surprising and therefore causing concern," Mr. Buckhaults wrote on X, formerly known as Twitter, tagging the FDA. *"You should address with rigorous safety review ASAP."*

World War III – It's Inevitable

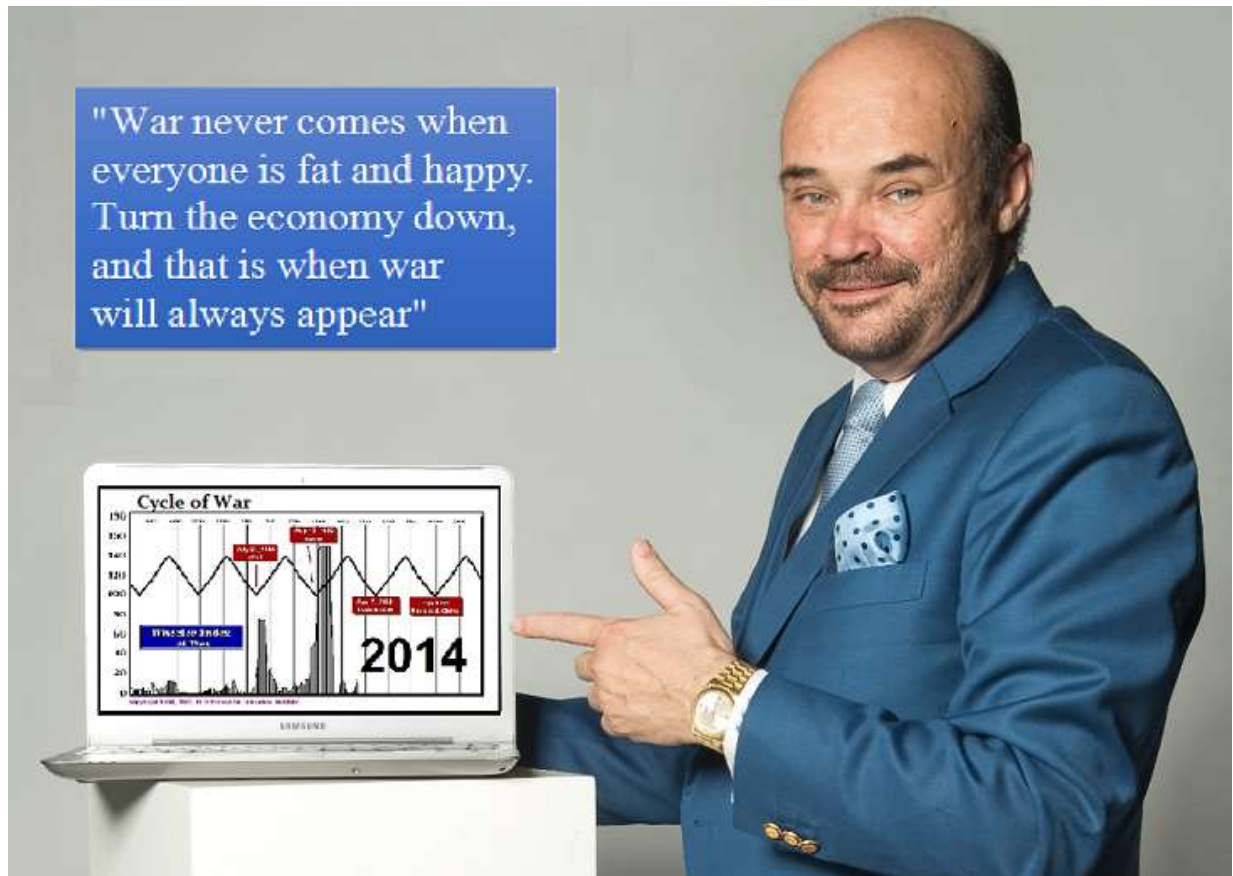

In response to legal pressure, the National Archives has uncovered 82,000 pages of emails sent or received by Vice President Joe Biden on three private pseudonym accounts during his tenure as vice president, according to a federal court filing [reported](#) by Just the News on Monday.

This amount potentially dwarfs the amount that landed Hillary Clinton in 'hot water' a decade ago, investigative reporter John Solomon noted. The total number of Biden's private email exchanges was disclosed in a little-noticed status report filed in a Freedom of Information Act lawsuit filed by the Southeastern Legal Foundation against the National Archives and Records Administration, the report adds.

As the nation celebrates Halloween, the House and Senate are engaged in some spooky late-stage Republic chaos over aid to Israel and Ukraine amid a backdrop of yet another government shutdown looming in two weeks.



In short,

- The government will run out of money (again) in roughly two weeks, requiring Congress to act (again).
- According to Democrats and GOP Neocons such as Mitch McConnell and Lindsey Graham, **America needs to send billions of taxpayer funds to both Israel and Ukraine**, and won't consider any legislation that doesn't combine the two.
- House Republicans under newly minted Speaker Mike Johnson (R-LA), as well as a group of Senate Republicans, **want Israel aid separated from Ukraine aid**, while the Biden White House wants to jam a \$105 billion foreign aid package (\$14B to Israel, \$60B to Ukraine) through Congress.
- The House's plan (if they can even pass it) to separate Israel aid from Ukraine aid is DOA in the Senate, while both the Senate's combined package *and* the Biden admin's package is DOA in the House.
- The House and the Senate also need to pass 12 appropriations measures for 2024, or face a 1% across-the-board cut on defense and nondefense spending, per the debt ceiling bill passed earlier this year.

While Johnson is hoping to push this through in a Thursday vote in the House (with no guarantee it'll pass), **Senate Republicans and Senate Majority Leader Chuck Schumer (D-NY) - who love war and defending foreign borders, are a no-go**, with Schumer calling it "insulting."

As previously noted, while McConnell and other Senate neocons are in lockstep with Schumer and the Democrats over a massive funding package, a group of GOP

Senators led by Roger Marshall (R-KS) have introduced legislation to provide a similar \$14.3 billion in aid to Israel **without Ukraine funding**.

"If Democrats want [Ukraine aid] so badly, then shouldn't Republicans get one of our priorities in a trade?" said Sen. J.D. Vance (R-OH) in a statement to [Punchbowl News](#). **"We shouldn't just roll over and give Democrats everything they want, especially when it divides our conference so starkly."**

More via *Punchbowl*:

Vance said McConnell should force Democrats to accept policy changes at the southern border, before giving them enough GOP votes to pass a massive aid package for Israel, Ukraine and the Indo-Pacific. Many other Republicans agree with Vance. The White House's request asks for more border security funding, but Republicans see this as a ruse. And Democrats say policy changes are a non-starter.

Sen. Rand Paul (R-Ky.), who has long called to offset new federal spending, praised the House's approach to Israel aid and said anything else is "dead on arrival" in the Senate. Paul also called out McConnell by name, saying his fellow Kentucky Republican should simply accede to the House's proposal.

"If Sen. McConnell thinks he's going to pass a \$100 billion conglomeration — what Biden wants — there's no way it passes the House. Sen. McConnell's not unaware of the way the House works," Paul told us. "It's a very precarious position the speaker is in. I think that's all he can get through."

There are some practical challenges tied to what Vance and Paul are pushing for. For one, a standalone Israel bill with offsets is a no-go for the Democratic-led Senate.
Meanwhile...

House Republicans are scrambling to pass 12 appropriations measures under Johnson, as they seek to stave off the impending shutdown and carve out deeper cuts on government spending. According to *The Hill*, GOP negotiators under former Speaker Kevin McCarthy (R-CA) had negotiated cuts the top-line level for the party's government funding to \$1.471 trillion earlier this year as part of the Fiscal Responsibility Act (FRA), however an intraparty compromise was later reached for \$1.526 trillion as tensions simmered.

Passage of the bills would set up negotiations with the Senate, which faces its own challenges in regards to the 12 appropriations measures.

The House swiftly approved its first funding bill in week's just days ago after the chamber reopened under Johnson, who won the gavel less than a week ago. The sprawling partisan energy plan is just one of eight bills that Republicans hope to pass out of the House by Nov. 17, when government funding is set to expire.

...

The party previously hoped to pass their 12 annual government funding bills during the summer, but those efforts fell short as then-Speaker [Kevin McCarthy](#) (R-Calif.) struggled to unify the party behind those bills amid calls for deeper cuts from conservatives. -[The Hill](#)

Shutdown imminent?

Congress has until Nov. 17 to pass yet more legislation to keep the lights on or risk a shutdown. The most likely course of action is that members on both sides of the aisle will pass another short-term funding bill at 2022 levels, which will buy time for more spending talks.

1% penalty

As *The Hill* further notes, part of the debt ceiling bill passed earlier this year includes a provision that if Congress crosses into 2024 without having passed its 12 funding bills, **there will be a 1% cut across-the-board on defense and nondefense spending**, which will take effect in April.

All eyes on Lebanon as Hezbollah leader Nasrallah set to give fateful speech on Friday

Hezbollah might decide to step up actions against Israel

After a suspicious absence from the limelight since the start of the war between Israel and the Hamas terrorists in Gaza on Oct. 7, Hezbollah's Secretary-General Hassan Nasrallah announced he would give a major address to his supporters in Beirut on Friday, at 3p.m. [Hassan Nasrallah intentionally chose the time to impact global financial markets before closing time. This is why I said watch for gas to spike on Friday. The markets for the past 27 days have ignored the events in Gaza. Those pushing the war have orchestrated what happens tomorrow to impact the global markets and create a perfect storm to leverage the supply and cost of energy! -Pastor Bob]

The speech is widely expected to reveal the direction the Iran-backed terror organization intends to take in the conflict with Israel. Israel and the U.S. have so far made major efforts to keep Hezbollah on the sidelines of the war.

U.S. President Joe Biden sent a strong message to that effect with his repeated [warnings of "don't,"](#) and the transfer of two U.S. carrier strike groups to the area underscored that statement.

Hezbollah so far has slowly, but continuously escalated attacks on Israel's northern border, leading to a broad mobilization of IDF forces along the border and the evacuation of most civilian communities there.

The Shi'ite terror organization and its allies in Lebanon have fired rockets, grenades, guided missiles, and SAM missiles at Israeli targets on a daily basis.

At least 50 terrorists, and probably more, were killed in the Israeli retaliatory strikes, a fact Hezbollah has publicized to gin up support in war-weary Lebanon.

"There are signs Nasrallah is preparing to announce an all-out war against Israel, opening a second major front where the Israeli military will face an adversary that is better armed and more entrenched than Hamas in Gaza," Jonathan Schanzer from the Foundation for Freedom of Democracies (FDD) [wrote on Wednesday.](#)

The day before the speech, Hezbollah carried out a broad attack firing at least 25 rockets and mortar bombs at targets along the border at the same time, which may in retrospect prove to be the opening act to a larger offensive.

On the other hand, *"there is a chance that Nasrallah's speech will be an exercise in chest-thumping and excuse-making rather than a declaration of war,"* Schanzer wrote.

"He may declare that Hezbollah will continue to 'resist' Israel's invasion of Gaza by carrying out limited strikes that would fall short of eliciting a major response to Israel. The Hezbollah chief might even lament that his hands are tied because the United States has warned his group not to widen this war."

Meanwhile Israeli representatives have made clear that they are ready for any escalation.

"We maintain high readiness in all arenas," IDF Chief of Staff Herzi Halevi stressed in a statement on Thursday.

"We are operating on the northern border... and are constantly committed to being ready for the expansion of scenarios to other arenas as well. The Air Force operates in the Gaza Strip with great power and with great distinction."

In an obvious threat to Hezbollah, Halevi added: "But make no mistake - we are operating less than half of the strength of the Air Force in the Gaza Strip! Most of the force is prepared and ready, with bombs on the wings and people who are ready to leap at any moment to the planes, to go out and attack in other arenas as soon as necessary."

**From the archives of Pastor Bob's Studies on
Deliverance before Judgment / Pre-Tribulation Rapture
Why the Rapture Occurs Before the Revealing of the Antichrist!**

After reviewing the “Compare and Contrast” differences between the attributes of the Rapture and the components of the Second Coming of Christ, it becomes immediately apparent that these experiences point to two separate events surrounding the Second Coming of Jesus Christ.

The Rapture of the Bride (Church).

Followed by a “Seven” year period of Great Tribulation closing out history with the Battle of Armageddon and the glorious “Second” Coming of Christ Jesus.

The question one has to ask is: Why is it that so much of the Church at large misunderstands this obvious order of events related to the Rapture and the Second Coming?

The simple answer is that not all, but most Protestant theological doctrines, were carried over from the Pre-Reformation period, which covers Church history between 1215 A.D. – 1515 A.D.⁽¹⁾ During its entire existence, the Roman Catholic Institution, has taught Amillennialism⁽²⁾, meaning that there would be no 1,000 year Millennial reign. This is contrary to Revelation 20, where it states that a 1,000 year reign of peace and righteousness would prevail. Roman and Orthodox communions taught that God was finished with the Jews and the Church inherited all the blessings originally promised to the Jews. The bulk of Reformation denominations perpetuated this lie. It is a lie, and you can prove me correct by simply reading the Apostle Paul's epistle to the Romans, particularly chapters 9, 10, and 11. These three chapters make it very clear that God is not through with Israel, not by a long shot. This errant teaching is known as “Replacement theology” or the technical theological term is “Supersessionism”.⁽³⁾

Believers, including the Apostle Paul, expected the Lord's return during the early church years from Jesus' day up to about 310-325 A.D. As Rome became the dominant power, the Church began to persecute the Jewish people distancing itself from the Jews and claiming God had washed His proverbial hands of the Jews because they were Christ killers, etc. Roman Catholicism suppressed all theological dialogue or dissent from 325 A.D. until the Protestant Reformation in 1517 A.D. In the years following the Reformation, men broke free of the oppressive and restrictive theological authority of Rome.

The many errant statements Pope Francis has made in almost four years since he was elected pope is confirmation of the Vatican's deficiency and inability to hold to true Biblical teachings. He is a false prophet, and may very well be “The False Prophet” spoken of in the book of Revelation. One theological statement Pope Francis expressed that was way off base was an insolent remark suggesting that

Jesus' death on the cross was a failure. Either he does not know his Bible or he is deliberately spreading false teachings. There are at least six to eight proclamations the pope has made in the past two years alone that most assuredly disqualifies him to be an equipped Bible expositor or someone who is competent to explain complicated theological teachings, let alone hold the position of the Vicar of Christ.

When you study the passages of the New Testament, the evidence for *"Deliverance before Judgment"* is inescapable. Even while the focus of the Old Testament is centered on the Jews and the Mosaic Law, God has left us abundant examples of Biblical Typology⁽⁴⁾ that reflect evidence for a conclusion that God does indeed provide *"Deliverance before Judgment"*. The New Testament transitions to a clear message of God's Grace with even stronger focus on God's plan for *"Deliverance before Judgment"*. In some fifty years of studying the Bible, I have not seen sufficient reason to believe anything other than God's foundational teaching of *"Deliverance before Judgment"*. That is a central understanding which points to a Pre-Tribulation Rapture scenario. Let's examine an assortment of New Testament passages supporting this conclusion:

"But we had the sentence of death in ourselves that we should not trust in ourselves, but in God which raiseth the dead: Who delivered us from so great a death, and doth deliver: in Whom we trust that He will yet deliver us." –(2nd Corinthians 1:9-10).

1:9 The apostle's outlook was so grim that he had the feelings of a man sentenced to death. If someone had asked him, *"Is it going to be life or death?"* he would have had to answer, *"Death."* God allowed His servant to be brought to this place of extremity in order that he would not trust in himself but in the God who raises the dead. The God who raises the dead is here used doubtlessly as a synonym for the omnipotent God. One who can raise the dead is the only hope of a man who is doomed to die, as the apostle considered himself to be.

1:10 In the King James tradition (and the majority of manuscripts) Paul is speaking of deliverance in its three tenses: past (delivered), present (does deliver), and future (will ... deliver). If the riot in Ephesus is in view, then Paul refers to the way in which it stopped suddenly and he escaped –(Acts 20:1). The apostle knows that the same God who delivered him in the past is able to deliver him day by day, and will continue to deliver him until that final, grand moment when he will be completely released from the tribulations and persecutions of this world.

"The Spirit of the LORD is upon Me, because He hath anointed Me to preach the Gospel to the poor; He hath sent Me to heal the brokenhearted, to preach deliverance to the captives, and recovering of sight to the blind, and to set at liberty them that are bruised, To preach the acceptable year of the LORD." –(Luke 4:18-19).

Jesus regularly went to the synagogue on the Sabbath day, that is, Saturday. On one visit to the synagogue, He rose to read from the Old Testament Scriptures. The Lord unrolled the scroll to what we now know as Isaiah 61, and read verse 1 and the first half of verse 2. This passage has always been acknowledged as a description of the ministry of the Messiah. When Jesus said, *“Today this Scripture is fulfilled in your hearing,”* He was saying in the clearest possible manner that He was the Messiah of Israel.

Notice the revolutionary implications of the Messiah's mission. He came to deal with the enormous problems that have afflicted mankind throughout history:

Poverty - To preach the gospel to the poor.

Sorrow - To heal the brokenhearted.

Bondage - To proclaim liberty to the captives.

Suffering - And recovery of sight to the blind.

Oppression - To set at liberty those who are oppressed.

In short, He came to proclaim the acceptable year of the Lord—the dawning of a new era for this world's sighing, sobbing multitudes. He presented Himself as the answer to all the ills that torment us. And it is true, whether you think of these ills in a physical sense or in a spiritual sense. Christ is the answer.

As Jesus read this passage from Isaiah to the people in the synagogue, He stopped in the middle of Luke 61:2 after the words, the time of the Lord's favor has come. (The next phrase in Isaiah 61:2, however, is *“and with it, the day of God's anger against their enemies.”* This will not be fulfilled until Jesus returns to earth again. We are now under God's favor; his wrath is yet to come.) This is a dual prophecy, and confirms more than twenty examples of how God's Word uses a dual prophecy or dual fulfillment.

“And lead us not into temptation, but deliver us from evil: For Thine is the Kingdom, and the power, and the glory, forever. Amen.” -(Matthew 6:13).

6:13 The Greek word translated temptation does not mean *“enticement to do evil”* but *“testing.”* Sometimes God allows His people to be *“tested”* by temptation. But this testing is never without a purpose: God is always working to refine His people, teach them to depend on Him, and strengthen their character to be more like Him. How He does this differs in every person's life. The prayer, then, is that we not yield to temptation.

Jesus wanted his followers to place their trust in God during trying times and to pray for deliverance from the evil one and his deceit. All Christians struggle with temptation. Believers who pray these words realize their sinful nature and their need to depend on God in the face of temptation.

“I have seen the affliction of My people which is in Egypt, and I have heard their groaning, and am come down to deliver them.” -(Acts 7:34).

God reminded Moses that though eighty years had passed in his life and though four hundred years had passed in Israel’s life in Egypt, God would intervene at this point in history and rescue them. But God would not be doing the rescue alone. He planned to send Moses back to Egypt.

“O wretched man that I am! Who shall deliver me from the body of this death? I thank God through Jesus Christ our LORD... There is therefore now no condemnation to them which are in Christ Jesus, who walk not after the flesh, but after the Spirit.” -(Romans 7:24-25; 8:1).

8:1 We feel condemned because Satan uses past guilt and present failures to make us question what Christ has done for us. Our assurance must be focused on Christ, not our performance. No matter how we may feel, there is no condemnation for those who belong to Christ Jesus. Because we have been rescued by Christ -(Romans 7:24-25), we are not condemned. To belong to Christ Jesus means to have put our faith in Him, becoming a member of his body of believers. Jesus said, *“I assure you, those who listen to my message and believe in God who sent me have eternal life. They will never be condemned for their sins, but they have already passed from death into life”* -(John 5:24).

“Who gave Himself for our sins, that He might deliver us from this present evil world, according to the will of God and our Father.” -(Galatians 1:4).

Christ died for our sins, in our place, so we would not have to suffer the punishment we deserve -(see 1st Peter 2:24). This was not an accident; it occurred just as God our Father planned. God made a way for salvation—the ultimate sacrifice of sending His only Son to die on the cross, taking the penalty for humanity’s sins. People can only be saved through Christ.

The result of Jesus’ gift of Himself was to rescue us from this evil world. This rescue or deliverance does not remove believers from the world (at least not yet); instead, it gives us the blessings of our future eternity with Christ and offers us His guidance and presence as we serve him in this evil world. Indeed, if all the early believers had been rescued out of the evil age in which they lived, there would have been no hope for us. To use Jesus’ expression, though we are still *“in”* the world, we are no longer *“of”* the world -(see John 17:15-18).

“And the LORD shall deliver me from every evil work, and will preserve me unto His Heavenly Kingdom: to Whom be glory for ever and ever. Amen.” -(2nd Timothy 4:18).

4:18 When the apostle said the Lord would deliver him from every evil work, he did not imply that he would be indefinitely delivered from execution. He knew that the time of his death was drawing near -(v. 6). What then did he mean? Doubtless He meant that the Lord would save Him from doing anything that would be a blot on the closing days of His testimony. The Lord would deliver Him from recanting, from denying His name, from cowardice, or from any form of moral breakdown.

Not only so, but Paul was sure that the Lord would preserve him for His heavenly kingdom. The heavenly kingdom refers not to Christ's Millennial Reign on earth, but to heaven itself, where the rule of the Lord is acknowledged perfectly.

Here the apostle bursts into an ascription of glory to God forever and ever. Forever and ever is literally “to the ages of the ages” and the words represent the strongest expression of eternity possible in the Greek language. Technically, there are no “ages” in eternity, but since the human mind has no conception of timelessness, it is compelled to use expressions of time.

“The LORD knoweth how to deliver the Godly out of temptation, and to reserve the unjust unto the day of judgment to be punished.” -(2nd Peter 2:9).

Strachan says: "The idea here is primarily of those surroundings that try a man's fidelity and integrity, and not of the inward; inducement to sin, arising from the desires. Both Noah and Lot were in the midst of mockers, and unbelievers. This “Peirasmos” (testing, temptation) is the atmosphere in which faith is brought to full development. It was a condition even in the life of Jesus -(Luke 22:28). It is the word used by Luke of the Temptation -(Luke 4:13). On the one hand “Peirasmos” is not to be lightly sought -(Luke 11:4) nor entered into carelessly -(Mark 14:38); the situation of “Peirasmos” may itself be the result of sin -(1st Timothy 6:9). On the other hand, it is a joyous opportunity for the development of spiritual and moral strength -(James 1:2; James 1:12). “Peirasmos” becomes sin only when it ceases to be in opposition to the will. The word originally meant "a test," and by use, came also to mean "a temptation," in the sense of a solicitation to do evil. "To be punished" is a present participle in the Greek text. It presents continuous action.

“He also Himself likewise took part of the same; that through death He might destroy him that had the power of death, that is, the devil; and deliver them who through fear of death were all their lifetime subject to bondage.” -(Hebrews 2:14-15).

2:14 After building his case that Christ had become a human being, the writer explained why such association and identity were important. Death is the

common fear and final experience of all people, and only as a human being, made of flesh and blood, could Christ die because only by dying could He break the power of the Devil, who had the power of death. His death and His return to life showed that death had been defeated -(Romans 6:9).

Sin and death are interconnected: Sin results in death. Only by first breaking the power of sin could Christ then break the power of death. He accomplished both through His death and resurrection. In those acts, Christ dealt the final blow to both Satan and death. Although Satan still holds great power over this world, he is mortally wounded. God allows Satan to work, but limits him -(see Job 1:12; Job 2:6; Ephesians 4:27; Ephesians 6:11-12; 1st Timothy 3:7; James 4:7; 1st Peter 5:8-9). Just as salvation is partly realized now and will be fully realized later, in God's Kingdom, so Satan is still at work but will one day be destroyed -(Revelation 20:10).

2:15 People have always been slaves to the fear of dying. Eventually, however, death strikes everyone. Through Christ, however, we no longer need to fear dying and death. Christ died and rose again and only in this way could He deliver humanity. Because Jesus died and arose, we no longer need to be enslaved to the fear of dying. We know that because Jesus rose from the dead, we will also. We will die physically, but we are promised new bodies and a new life in eternity with God. Thus, death becomes the gateway to a new life -(1st Corinthians 15:55; 1st Corinthians 15:57; 2nd Corinthians 5:8).

“The LORD shall preserve thee from all evil: He shall preserve thy soul.” -(Psalm 121:7).

121:7 There is the guarantee of deliverance from all evil. It is a solid fact that nothing can come into the life of a believer apart from God's permissive will. There are no random circumstances, no purposeless accidents, and no fatalistic tragedies. Though He is not the author of sickness, suffering, or death, He overrules and harnesses them for the accomplishment of His purposes. In the meantime, His trusting child can know that God is working all things together for good to those who love Him, who are called according to His purpose -(Romans 8:28).

“Thou art my Hiding Place and my Shield: I hope in Thy Word.” -(Psalm 119:114).

119:114 The Lord is our hiding place when we are pursued and our shield when we are being directly attacked. Those who hope in His promise will never be disappointed because He cannot deceive or be deceived.

Thou art my hiding place, from temporal calamities. The perfections of God are chambers of retreat and safety to his people, where they may hide themselves and be safe, till such calamities are over, -(Isaiah 26:20). And from spiritual evils; from avenging justice, from divine wrath, from the rage of Satan, and the fury of

men, -(Isaiah 32:2); and from eternal death, and being hurt by it; the spiritual and eternal life of saints being hid with Christ in God, -(Colossians 3:3; see Psalm 32:7).

and my shield, to protect from all dangers, and preserve from every enemy: such are the love and grace, the power and strength, the truth and faithfulness of God; which are the saints' shield and buckler, Psalm 5:12; such also the person, blood, righteousness, and salvation of Christ, who is a sun and shield; the shield of faith, or which faith holds up and defends the soul against the attacks of a powerful enemy, -(Psalm 84:11);

I hope in Thy Word, in Christ the Word, for acceptance and justification, for peace, pardon, and eternal salvation; all which are in Him: in the word of promise, for all supplies of grace, strength, light, life, and comfort here, and for glory hereafter, contained therein; see Psalm 119:74.

“The LORD will preserve him, and keep him alive; and he shall be blessed upon the earth: and Thou wilt not deliver him unto the will of his enemies.” -(Psalm 41:2).

41:1-3 But the patient is not without comfort. First he remembers that the Lord blesses the person who considers the poor. Here *“the poor”* probably means not so much poor financially as poor in health, weakened by sickness. David consoles himself with the thought that he had done just what the Lord did for people in distress—he had assisted, comforted, and cheered all who were in the grip of disease. Now he claims the promise that the LORD will deliver him too in time of trouble. Yes, the Lord will keep a protective vigil over him, preserving his life. Because David has earned a good reputation for his consideration of the sick and the suffering, he is confident that God will not desert him to the malicious will of his foes. He will instead give David all needed grace for his time in the sickroom, then raise him up to health and strength once more. The Lord is pictured as a nurse, adjusting the patient's bed so as to make him comfortable.

Do these passages sound like the words of a God who wants to or takes pleasure in permitting His children to endure the Great Tribulation? I don't think so! When you read each passage closely, you can easily see that the God of the Bible wants only the best for His children. He has given us free will choice allowing us time to determine for ourselves that His ways are far superior to our own. Further, He has provided a way for us to know Him, by insuring we were all left with a perfect teaching tool full of hundreds of passages that communicate His love and well-being for us. Plus, we each enjoy the indwelling of the Holy Spirit which unlocks the many hidden mysteries found within the pages of the Bible. All we have to do is make the effort to build an intimate relationship with Him. It's all there for the asking!

The Bible contains 66 books with 1,189 chapters. A thorough reading of the Word of God reveals that God wants the best for His children. In the world of education, teaching professionals have what is known as the *“carrot and the stick”* approach to bringing about motivational change in behavior. Even the legal system applies similar methods to bring about reform in those who break the laws of society. God offers each and every individual of sound mind a chance to accept the love of the Father. If they refuse, they will face the consequences for disobedience. All actions carry consequences in all areas of life. It’s the choice that determines whether the consequence is good or whether it is not so good. Sometimes, those choices can cause quite a problem for a very long time in one’s life. Sometimes that problem remains an entire lifetime. A wrong choice at this point can even lead to an eternal consequence.

The *“Moral Law”* or the Ten Commandments or the *“Don’ts”* seem harsh, but that is a misreading of the text. The *“Torah”*, or the first five books of the Old Testament, sounds severe in the minds of many, but they were never taught that the Old Testament word: *“Law”* has a number of meanings. The correct rendering of the *“Moral Law”* is *“Teachings”*. The essence of the Law is that certain behaviors have consequences, some more severe than others. Have you ever had to sternly command a child not to touch a hot pot on the stove because you were concerned about the danger to the child? One would not idly stand by and watch the child pull a pot of boiling water down onto themselves. Instead, one would act instinctively to protect the safety of the child, even to bellow out the loud command, *“Don’t touch that pot!”* Off hand, we can probably think of dozens of examples where the concern is for the safety and well-being of the child or teenager and perhaps a grown adult.

This hypothetical example is shared as a means to illustrate my point that folks, particularly theologians and religious leaders, have created some prejudice with regards to the meaning of the term *“Law”* or the *“Ten Commandments”* so that they communicate a different meaning about the text. There is no question that one could cast the image of God as an evil entity. I can *“cherry-pick”* passages to present the image of the God of the Bible as an evil being. The fact is that the religious community has either misrepresented the Hebrew text or misunderstood the intent of the Creator. Many errantly misconstrue the Biblical difference between Law and Grace.

The COP28 meetings are still on schedule and the calendar dates below are baked into the cake.

World War III (Ezekiel 38/39 included) will break out once the Antichrist, aka Prince Charles signs/confirms the 'Covenant with the Many' of Daniel 9:27. Even Prince Charles' chief lieutenants like Klaus Schwab have stated that Tribulation would occur. In fact they are pushing this war to occur! Very few people understand the larger plan to 'divide and conquer'. Satan's demonic plans are to steal, kill, and destroy. -(John 10:10)

Believers worldwide will be Raptured out of here just before or at least prior to when Prince Charles makes his rare appearance at the COP28 being held in Dubai that will usher in the Great Tribulation of Daniel 9:27.
