When U.S. Catholic Bishops met with White House Officials to discuss *Laudato Si'*, *Laudate Deum*, and COP28, the Biden Administration was receptive to the Pope's Message.

A Catholic delegation, consisting of three U.S. Catholic bishops and other church representatives, met with senior White House officials on November 17, 2023, to discuss the Pope's message as outlined in *Laudato Si'* and *Laudate Deum* prior to the start of COP28, according to *The Tablet*, a Roman Catholic news agency. According to the report, White House officials were “receptive” and took these faith leaders very “seriously.”

The Tablet reported the following:

- “Three U.S. Catholic bishops and the head of a conference of women religious met with Biden administration officials Nov. 17 to discuss the Catholic Church's priorities for what Pope Francis has called ‘our suffering planet’.”
- “Leading members of the delegation included Archbishop John C. Wester of Santa Fe, New Mexico; Bishop Edward J. Weisenburger of Tucson, Arizona; and Bishop Joseph J. Tyson of Yakima, Washington; along with Sister Carol Zinn, a Sister of St. Joseph of Philadelphia and the executive director of the Leadership Conference of Women Religious, which represents 302 U.S. religious congregations, who went to the White House to share their concerns in advance of COP28, the United Nations climate change conference held in Dubai, United Arab Emirates.”
- “The delegation spoke with the White House's John Podesta, senior adviser to the president for clean energy innovation and implementation; Ali Zaidi, national climate adviser; and John McCarthy, senior adviser for political engagement.”
- “We're men and women of the church,” Bishop Weisenburger told OSV News. ‘And we echo what we find in Scripture, consistent church teaching — and brought into beautiful focus by Pope Francis in *Laudato Si'* and *Laudate Deum* — that this is not just a scientific matter or issue. This is a theological and spiritual matter.’”

- *“He [Catholic Bishop Weisenburger] found the Biden administration’s representatives receptive to that message.”*
- *“Ellis [a member of the Catholic delegation] was impressed by ‘how seriously the White House took these faith leaders’.”*

Warning of Something Huge Coming In The Global Financial System

UBS Group AG is a multinational investment bank and financial services company founded and based in Switzerland. Co-headquartered in the cities of Zürich and Basel, it maintains a presence in all major financial centers as the largest Swiss banking institution and the largest private bank in the world. Yesterday, UBS appears to have FAILED-TO-DELIVER on Bonds that were due.

According to rapidly-spreading reports, not only has UBS Failed-to-Deliver on Bonds, but The Depository Trust and Clearing Corporation (DTCC) reportedly took action to COVER-UP the UBS Failure-to-Deliver; DTCC allegedly ***** D E L E T E D ***** the CUSIP Numbers for those bonds, so as a matter of record, **those bonds "no longer exist."** Apparently, they're simply "gone."

Let's begin with some basics.

What is the DTCC?

The Depository Trust & Clearing Corporation (DTCC) is an American post-trade financial services company providing clearing and settlement services to the financial markets.

It performs the exchange of securities on behalf of buyers and sellers and functions as a central securities depository by providing central custody of securities.

DTCC was established in 1999 as a holding company to combine The Depository Trust Company (DTC) and National Securities Clearing Corporation (NSCC). User-owned and directed, it automates, centralizes, standardizes, and streamlines processes in the capital markets. Through its subsidiaries, DTCC provides clearance, settlement, and information services for equities, corporate and municipal bonds, unit investment trusts, government and mortgage-backed securities, money market instruments, and over-the-counter derivatives.

It also manages transactions between mutual funds and insurance carriers and their respective investors.

In 2011, DTCC settled the vast majority of securities transactions in the United States and close to **\$1.7 quadrillion in values worldwide**, making it by far the highest financial value processor in the world. DTCC operates facilities in the New York metropolitan area and at multiple locations in and outside the United States.

What is a CUSIP Number?

CUSIP stands for Committee on Uniform Securities Identification Procedures. A CUSIP number identifies most financial instruments, including: stocks of all registered U.S. and Canadian companies, commercial paper, and U.S. government and municipal bonds. The CUSIP system (formally known as CUSIP Global Services)—owned by the American Bankers Association and managed by Standard & Poor's Global Market Intelligence—helps facilitate the clearance and settlement process of securities.

CUSIP numbers consist of nine characters (including letters and numbers) that uniquely identify a company or issuer and the type of financial instrument. A similar system is used to identify foreign securities (CUSIP International Numbering System or CINS). CINS employs the same nine character identifier as CUSIP, but also contains a letter in the first position to signify the issuer's country or geographic region.

Bond CUSIP Numbers DELETED . . .

According to reports coming out from the general public, the DTCC ***** D E L E T E D ***** the CUSIP Numbers for those UBS Bonds. Without CUSIP Numbers, there is no bond to buy, sell, or trade. **It seems, the records of the money . . . are just . . . gone!**

No CUSIP Number equals no Bond. No Bond equals no money for the Bondholder!

When a "Failure-To-Deliver" happens, BOTH sides in the transaction are __supposed__ to report it to authorities. There are FINES associated with Failure-to-Deliver. For instance, in a transaction with a \$50 Million position, the fines are about \$4166. PER DAY!

The government implemented these fines back in the year 2009. They implemented them because in the financial crisis of 2008, in October 2008 alone, some \$16 TRILLION in Bonds alone, Failed-to-Deliver!

So why would DTCC not report these Failed-To-Deliver Bonds by UBS, and instead, just wipe them off the planet by DELETING the CUSIP Numbers? It's like the Bonds never existed!

Does this mean that UBS just doesn't have the money? Where did it go?

Does this mean that the financial markets are so corrupted they can actually control DTCC to get DTCC to cover up a massive failure to deliver? Is it so simple that when Bad Actors can't deliver on their bonds, they can just pick up the phone, call their buddies at DTCC, and have their buddies just ERASE them? Because that's what appears to have taken place; DTCC appears to have simply ERASED these Bonds as if they never existed.

Oh, and By the way If they didn't have the money to pay the bonds, it's a safe bet they also don't have the money to pay the fines, so it seems as though they just had the bonds ERASED by DTCC by deleting the CUSIP Numbers!

What Is Failure To Deliver (FTD)?

Failure to deliver (FTD) refers to a situation where one party in a trading contract (whether it's shares, futures, options, or forward contracts) doesn't deliver on their obligation. Such failures occur when a buyer (the party with a long position) **doesn't have enough money** to take delivery and pay for the transaction at settlement.

A failure can also occur when the seller (the party with a short position) does not own all or any of the underlying assets required at settlement, and so cannot make the delivery.

Understanding Failure To Deliver

Whenever a trade is made, both parties in the transaction are contractually obligated to transfer either cash or assets before the settlement date. Subsequently, **if the transaction is not settled, one side of the transaction has failed to deliver.** Failure to deliver can also occur if there is a technical problem in the settlement process carried out by the respective clearinghouse.

Failure to deliver is critical when discussing naked short selling. When naked short selling occurs, an individual agrees to sell a stock that neither they nor their associated broker possess, and the individual has no way to substantiate their access to such shares. The average individual is incapable of doing this kind of trade. However, an individual working as a proprietary trader for a trading firm and risking their own capital may be able. Though it would be considered illegal to do so, some such individuals or institutions may believe the company they short will go out of business, and thus in a naked short sale they may be able to make a profit with no accountability.

Subsequently, the pending failure to deliver creates what are called "phantom shares" in the marketplace, which may dilute the price of the underlying stock. In other words, the buyer on the other side of such trades may own shares, on paper, which do not actually exist.

Chain Reactions of Failure to Deliver Events

Several potential problems occur when trades don't settle appropriately due to failure to deliver. Both equity and derivative markets can have a failure to deliver occurrence.

With forward contracts, a party with a short position's failure to deliver can cause significant problems for the party with the long position. This difficulty happens because these contracts often involve substantial volumes of assets that are pertinent to the long position's business operations.

In business, a seller may pre-sell an item that they do not yet have in their possession. Often this will be due to a delayed shipment from the supplier. When it comes time for the seller to deliver to the buyer, they can't fulfill the order because the supplier was late. The buyer may cancel the order leaving the seller with a lost sale, useless inventory, and the need to deal with the tardy supplier. Meanwhile, the buyer will not have what they need. Remedies include the seller going into the market to buy the desired goods at what may be higher prices.

The same scenario applies to financial and commodity instruments. **Failure to deliver in one part of the chain can impact participants much further down that chain.**

During the financial crisis of 2008, failures to deliver increased. Much the same as check kiting, where someone writes a check but has not yet secured the funds to cover it, sellers did not surrender securities sold on time. They delayed the process to buy securities at a lower price for delivery.

SEC "FTD" List - Concealed Since September

The U.S. Securities and Exchange Commission (SEC) is an independent agency of the United States federal government, created in the aftermath of the Wall Street Crash of 1929. The primary purpose of the SEC is to enforce the law against market manipulation.

Among its vast reporting to the Public, the SEC provides reports, TWICE A MONTH, of all "**Failed-To-Deliver (FTD)**" occurrences. They have provided this report, twice a month, for YEARS.

On the First of each month, they report the last two weeks of the prior month. On the 15th of each month, they report the second two weeks of each prior month.

In August, 2023, the SEC *didn't* publish the second report, which would have covered the last two weeks of July, 2023,

Then the SEC *didn't* report FTD's at all for September, October, or even the first two weeks of this month, November!

The only reason the SEC is concealing the FTD is because they don't want the general public knowing who it is that's failing to deliver. It seems to me, and this is just my personal guess, I have no actual facts to back this up, the ONLY reason the SEC would

The **Palestinian keffiyeh** (Arabic: كوفية, romanized: *kūfiyya*) is a chequered black and white scarf that is usually worn around the neck or head. This *keffiyeh* has become a symbol of Palestinian nationalism, dating back to the 1936–1939 Arab revolt in Palestine. Outside of the Middle East and North Africa, the *keffiyeh* first gained popularity among activists supporting the Palestinians in the conflict with Israel and is an icon of Palestinian solidarity.

In observing Prince Charles, in any event where the audience or participants are Primarily Arabs or Muslims, Prince Charles interestingly sports the Yasser Arafat symbol of the Palestinian *keffiyeh* displayed in his left breast suit pocket. Traditionally worn by Palestinian farmers, during the Ottoman period, the *keffiyeh* signaled that the wearer was rural, in contrast to the tarboosh worn by the urban classes.

The black and white *keffiyeh* worn by Palestinian men of any rank, became a symbol of Palestinian nationalism during the Arab Revolt of the 1930s. This reached a peak in 1938, when the leadership of the revolt ordered that the urban classes replace their

traditional tarbush hats with the *keffiyeh*. The move was intended to create unity, as well as allow the rebels to blend in when they entered the cities.

Its prominence increased during the 1960s with the beginning of the Palestinian resistance movement and its adoption by Palestinian politician Yasser Arafat.

The black-and-white fishnet pattern *keffiyeh* would later become Arafat's symbol and he would rarely be seen without it; only occasionally would he wear a military cap, or, in colder climates, a Russian-style *ushanka* hat. Arafat would wear his *keffiyeh* in a semi-traditional way, wrapped around his head via an *agal*. He also wore a similarly patterned piece of cloth in the neckline of his military fatigues. Early on, he had made it his personal trademark to drape the scarf over his right shoulder only, arranging it in the rough shape of a triangle, to resemble the outlines of the territory claimed by Palestine. This way of wearing the *keffiyeh* became a symbol of Arafat as a person and political leader, and it has not been imitated by other Palestinian leaders.

Another Palestinian figure associated with the *keffiyeh* is Leila Khaled, a member of the armed wing of the Popular Front for the Liberation of Palestine. Several photographs of Khaled circulated in the Western newspapers after the hijacking of TWA Flight 840 and the Dawson's Field hijackings. These photos often included Khaled wearing a *keffiyeh* in the style of a Muslim woman's *hijab*, wrapped around the head and shoulders. This was unusual, as the *keffiyeh* is associated with Arab masculinity, and many believe this to be something of a fashion statement by Khaled, denoting her equality with men in the Palestinian armed struggle.

The colors of the stitching in a *keffiyeh* are also vaguely associated with Palestinians' political sympathies. Traditional black and white *keffiyehs* became associated with Fatah. Later, red and white *keffiyehs* were adopted by Palestinian Marxists, such as the PFLP.



Check out the lapel scarf in the Prince's pin-stripe suit, note it is the familiar PLO *keffiyeh*, worn by the former PLO leader Yasser Arafat. A better view is in the picture on the next page.

In a 1997 *Middle East Quarterly* article titled "[Prince Charles of Arabia](#)," Ronni L. Gordon and David M. Stillman looked at evidence that Britain's crown prince might be a

They sifted through his public statements (defending Islamic law, praising the status of Muslim women, seeing in Islam a solution for Britain's ailments) and actions (setting up a panel of twelve "wise men" to advise him on Islamic religion and culture), then concluded that, *"should Charles persist in his admiration of Islam and defamation of his own culture,"* his accession to the throne will indeed usher in a *"different kind of monarchy."*

Charles continues this pattern of admiration and defamation, keeping alive the question of his stealth conversion to Islam. This weblog entry continues to document the topic.

Prince Charles today visited the Islamic Foundation, an Islamist institution, at its offices in Markfield, England (pictures [here](#)). He praised it as *"a pioneering institution in many ways and is well known for its scholarly work, its publications and its research."*

The Islamic Foundation is the leading UK publisher of books and writings by Islamist ideologues such as Abul A'la al-Maududi, the founder of the violent South Asian Islamist movement Jamaat-e-Islami. Indeed, long staffed by officials from the movement's

Pakistani and Bangladeshi branches, it serves as a leading think tank for Jamaat-e-Islami in the West. It has. One key trustee of the Islamic Foundation, Khurshid Ahmad, also served as vice-president of the Pakistani Jamaat-e-Islami. He has [described](#) the Taliban as "*refulgent and splendid*," and has warned of the "*implication of Europe's being in the clasp of Jews*."

While visiting the Islamic Foundation in 2003, the Prince met with leading Islamists such as Manazir Ahsan and Hashir Faruqi, globally-known Jamaat-e-Islami leaders [who coordinated](#) the riots against Salman Rushdie and backed the Iranian regime's call for the author's murder.

The Prince was also photographed talking with Chowdhury Mueen-Uddin. In November 2013, a Bangladeshi War Crimes Tribunal sentenced Mueen-Uddin to death in absentia for his role in the abduction and murder of 18 journalists and intellectuals during the 1971 Liberation War. Mueen-Uddin was reportedly in charge of Jamaat-e-Islami's Al-Badr killing squad. (January 24, 2003)

Nov. 9, 2003 update: A report, "[Charles Breaks Fast with the Faithful in Muscat](#)," in the Dubai-based *Gulf News*, details some of Charles' activities during his current five-day visit to Oman:

- He toured the Sultan Qaboos Grand Mosque for almost two hours and "took keen interest in studying various sections at the mosque, including the main prayer hall." As his spokesman put it, "The Prince was particularly keen to come to the mosque today to see the fantastic building and remarkable architecture which Prince was fascinated with. The Prince has a great love for Islamic architecture and I can't think of finer example than this mosque."
- He "spent a considerable time at an exhibition of Islamic calligraphy and held meetings with Sheikha Aisha Al Siaby, Head of Public Authority for Craft Industries and Taha Al Kisri, the Head of Omani Society for Fine Arts to discuss various aspects of Islamic art."
- He "broke fast with a large congregation of people from different nationalities as he sat with folded legs on the floor in the open. He ate date and drank juice at the call of Iftar."

None of this, of course, is evidence that the Heir to the British Throne has changed religions, but his actions most certainly would be consistent with such a move, and especially the implication that he had kept the Ramadan fast.

June 21, 2004 update: Sultan Hassanal Bolkiah of Brunei will award Prince Charles a \$50,000 prize chosen by an international jury set up by the Oxford Centre for Islamic Studies for his contribution to understanding Islam in the West during a London ceremony on June 24. He is the first non-Muslim to receive the prize established in 1992. Other winners have included Youssef Al-Qaradawi, Abdul Fattah Abu Ghudda, and Adnan Mohd Zarzar.

Dec. 18, 2004 update: Prince Charles put himself in the middle of an Islamic theological issue that again could suggest his conversion to Islam – for if that is not the case, then on what basis does he opine on the Islamic law requiring that apostates from Islam be executed? Jonathan Petre of London's *Daily Telegraph* [reports](#) on a private summit of Christian and Muslim leaders at Clarence House on this topic sponsored earlier in December by the prince. Apparently, however, he did not get the results he hoped for, with one Christian participant indicating that Charles was "very, very unhappy" about its outcome. That may have been because the Muslims at the meeting resented his public involvement in this topic.

July 14, 2005 update: And what does the good prince have to say about the murder by Islamists of 55 in London a week ago? He put fingers to keyboard and produced "[True Muslims Must Root Out The Extremists](#)" for the *Mirror*:

Some deeply evil influence has been brought to bear on these impressionable young minds. ... Some may think this cause is Islam. It is anything but. It is a perversion of traditional Islam. As I understand it, Islam preaches humanity, tolerance and a sense of community. ... these acts have nothing to do with any true faith. ... it is vital that

everyone resists the temptation to condemn the Muslim community for the actions of such a tiny and evil minority. If we succumb to that temptation, the bombers will have achieved their aim. Likewise, in my view, it is the duty of every true Muslim to condemn these atrocities and root out those among them who preach and practice such hatred and bitterness.

Comment: This sounds to me like the same apologetics churned out by the Muslim Council of Britain and other Islamist bodies.

Aug. 2, 2005 update: At the funeral of King Fahd in Riyadh, the Associated Press reports, "*Non-Muslims were not allowed at the ceremonies.*" So far as I can tell, Charles did not attend the ceremonies. (There surely would have been a press uproar if he had.) We can conclude that whatever his inner faith, he is not presenting himself as a Muslim in public. In brief, he is not a Muslim at this time.



Sep. 4, 2005 update: Prince Charles revealed in a letter leaked to the *'Daily Telegraph'* that he had strained relations with George Carey, then archbishop of Canterbury, over his attitude toward Islam. Particularly contentious was his expressed intent, on becoming king and supreme governor of the Church of England, to ditch the centuries' old *defender of the faith* title and replace it with *defender of faith* and *defender of the Divine*. The letter reveals the archbishop's reaction.

I wish you'd been there for the archbishop! Didn't really appreciate what I was getting at by talking about "*the Divine*" and felt that I had said far more about Islam than I did about Christianity - and was therefore worried about my development as a Christian.

According to royal aides, Charles did not much respect Lord Carey's views and the feelings were reciprocated.

Oct. 29, 2005 update: "Prince Charles to plead Islam's cause to Bush" reads the *Sunday Telegraph* headline. The text by Andrew Alderson tells how the prince of Wales will try to persuade George W Bush and Americans of the merits of Islam this week because he thinks the United States has been too intolerant of the religion since September 11. The Prince, who leaves on Tuesday for an eight-day tour of the US, has voiced private concerns over America's "confrontational" approach to Muslim countries and its failure to appreciate Islam's strengths.

Apparently, he *"wants Americans - including Mr. Bush - to share his fondness for Islam."*

Nov. 2, 2005 update: That *Daily Telegraph* article cited in the previous update made the rounds, perhaps even to the White House. In any case, George W. Bush had a little zinger ready for the good prince in his welcome for him and Camilla at the state dinner: In the first part of the 20th century, our nations stood together to ensure that fascism did not prevail in Europe. In the second half of the 20th century, we worked tirelessly to defeat the totalitarian ideology of communism. And today we're fighting side by side against an ideology of hatred and intolerance to ensure that the 21st century will be one of liberty and hope.

Charles did not reply to this comment, limiting his response to projects for the underprivileged and fond memories of Winston Churchill.

Nov. 3, 2005 update: Ali Sina proposes a reason for Charles' attraction to Islam, suggesting that he may be tired of democracy: *"Does he secretly envy the Islamic system of government where the rulers have absolute power and can even impose morality on their subjects?"*

Nov. 5, 2005 update: Sharp-tongued Julie Burchill asks in *"What's not to like about Islam if you're the Prince of Wales,"* I wonder why Prince Charles seeks to big up powerful, theocratic Islam — which already controls so much land and wealth and yet will kill and kill to gain more — and not vulnerable, pluralistic Israel? Why doesn't he invest as much energy in defense of the persecuted and murdered Christians who suffer for their beliefs under Islamic regimes?

She then answers her own questions, much as Ali Sina does:

Well, I think I know why; because cleaving to Islam is the one way that men who wish to appear liberal and enlightened can promote reactionary ideas. Monarch-worshipping, woman-oppressing, non-democratic — what's there not for Charles to like!

Nov. 13, 2005 update: Charles' efforts to promote Islam does his mother no good in Al-Qaeda's eyes. In a just-reviewed videotape, the organization's number two, [Ayman al-Zawahiri](#), calls Queen Elizabeth II *"one of the severest enemies of Islam"* and blames her for what he calls Britain's *"crusader laws."* In addition, he criticizes British Muslims who *"work for the pleasure of Elizabeth, the head of the Church of England"* and

ridicules them for saying (his words, not theirs): *"We are British citizens, subject to Britain's crusader laws, and we are proud of our submission . . . to Elizabeth, head of the Church of England."*

I have followed Daniel Pipes Middle East Forum for over two decades and I could show literally hundreds of reports that infer that Prince Charles of Wales has been a secret convert to Islam. In a previous Blessed Hope, I even included Charles Muslim own background information that he is a descendant of Muhammed.

The Queen of England, Elizabeth II, is a direct descendant of the Prophet Muhammad, according to a Moroccan newspaper that claimed to trace the monarch's genealogy back to the founder of Islam.

The theory first surfaced in the late 1980s when [a genealogy guide](#) for the monarchy alleged that the Queen was related to the Muslim Kings who ruled Spain from around 711 until 1492. The UK dismissed the claim out of hand that the Queen was a descendent of Muhammad, for obviously good reasons.

"It is little known by the British people that the blood of Mohammed flows in the veins of the queen," Harold Brooks-Baker, an authority on the British monarchy and the publisher of the royal genealogical guide, [wrote to Britain's then-Prime Minister Margaret Thatcher in 1986](#). *"However, all Moslem religious leaders are proud of this fact,"* Brooks-Baker added. It was as if they wanted to hide the facts and evidence. The fact that Prince Harry married a wife that is mixed race has been an almost hidden secret as well. Prince Harry is largely persona-non-grata at the Buckingham family estate since the death of the Queen.

Queen Elizabeth II and Prince Philip, Duke of Edinburgh arrive at the Sheikh Zayed Mosque on November 24, 2010 in Abu Dhabi, United Arab Emirates. A theory from the 1980s claims the Queen is a descendant of the Prophet Muhammad. The claim gained little attention in the West over the subsequent decades. But *Assahifa Al-Ousbouia*, a weekly Arabic-language newspaper in Morocco, called attention to the theory by publishing a family tree that claimed to trace the Queen's lineage from Abu al-Qasim Muhammad ibn Abbad, the first independent ruler of Seville in what was then the territory of Al-Andalus in Spain.

According to the chart published in Morocco and [translated by the British press](#), Muhammad ibn Abbad is a great-grandchild of the Prophet Muhammad, who died in 632 AD in what is now Saudi Arabia. The line between the Prophet Mohammad, ibn Abbad and Elizabeth II thus links the current monarch with the founder of one of the three monotheistic religions, according to the newspaper.

Historians have suggested that [the connection is possible](#) but not entirely irrefutable. Marriages between Spanish and British royals have been common throughout the centuries, and both the British and Spanish royal families [descend from Queen Victoria](#). Brooks-Baker appears to have connected the Queen to the prophet through a princess

named Zaida, a grandchild of ibn Abbad who converted to Christianity and became the concubine of King Alfonso VI of Castile.

Why this is of such serious interest is HRH Prince Charles should be huge since being the Antichrist of Revelation 13, and signing/confirming the Daniel 9:27 “*covenant with the many*”, assures his role in whatever that takes place on the Temple Mount during the coming “seven” years. Dutch Farmers Dilemma: Sort Out Emissions or Sell The Farm



Dutch farmers protested as lawmakers voted on proposals to reduce nitrogen emissions, a plan that will likely force them to cut their livestock herds or exit the farming business.

The Netherlands is Europe's biggest meat exporter from its intensive livestock farming industry. But the [Dutch government decided to cut nitrogen and ammonia by 50% by 2030](#), with a **€25 billion** budget for it.

Ministers call the proposal an “unavoidable transition” that aims to improve air, land and water quality. They warn that farmers need to adapt or face the prospect of closing their businesses.

The honest message, however, is that not all farmers can continue their business if profits are also cut. And so, Dutch farmers are revolting.

They're angered by the government's environmental policy to reduce **30%** in livestock production. They're blocking food distribution centers, roads, and ministers' driveways.

Livestock Farming and Nitrogen Emissions in the Netherlands

The country has the EU's highest density of livestock. It has ~20 million livestock, including cattle, pigs, and chickens but it only has a 17 million population. The intensive livestock production pollutes the environment. Manure and urine combine to release ammonia. They then run-off from fields as fertilizer to streams and lakes, harming life in these bodies of water.

In other words, manure poses a harmful waste product in the Netherlands instead of being a vital fertilizer. Also, the success in agriculture has been emitting harmful nitrogen compounds that include nitrogen oxide (N₂O).

In response, the government introduced a trading or offsetting scheme in 2015. It permitted projects releasing nitrogen in exchange for future nitrogen reductions.

But in 2019, the Council of State court ruled that the scheme was not valid and that nitrogen reductions have to come first. The Dutch government believes that something has to be done with ammonia, nitrogen, and its warming emissions.

- ***In effect, there's a plan to reduce nitrogen emissions by 50% by 2030. And this has a backing of €25 (US\$25.4) billion budget.***

Part of the plan is cutting livestock production by 30%. Plus, over **€500 million** is brought forward for the regional government to buy out farmers this year and next. Since the Netherlands is the region's largest nitrogen emitter, the plans to cut N₂O emissions must go through. So, the Dutch government created two official documents.

One is a map showing the areas where [N₂O reductions](#) should happen by about **12% to 95%**. The other one is a statement intended to help farmers.

But farmers consider both measures damaging to their business, particularly pointing out to the reduction numbers. They think the plans are a huge blow to their farming business and the entire sector. In fact, many of them invested a lot in new equipment to cut down their herds' environmental impact.

Farmers' Grassroots Proposals Ignored

The protest that Dutch farmers initiated shakes the entire nation. There's a big rally in Stroe's central village and police cars get attacked. Food retailers lost tens of millions in sales.

- ***And farmers declared a free state of boerenlanden (farmer land) in some villages.***

One major reason for the farmers uprising is the fact that their proposals were not heard by the national government. According to Wytse Sonnema, a spokesman for the farmers' association the LTO, they proposed a **40% reduction by 2030**.

But their proposal was fully ignored and lost over the government's **70% [reduction targets](#)**. And farms in EU-designated Natura 2000 protected zones face the hardest restrictions.

Sonnema said that:

"Farmers in the Netherlands are deeply concerned and angry about the nitrogen policy that was presented by the national government on June 10th... According to the government these should all add up to a country-level reduction of 50% in 2030... which is simply unfeasible, and will have disastrous effects on not just agriculture, but on the economic, social and cultural viability of rural Netherlands."

One group of organic farmers proposed its own 10-point plan called [Green Farmers Plan](#). It's intended to get farmers out of the stand-off of the nitrogen dossier yet the government ignored it.

The food team at WWF Netherlands commented on this concern. Natasja Oerlemans remarked that:

"I speak to many farmers who want to change [livestock production]: the question is how. The how is not very clear in current government communication but I think there are many opportunities for farmers to change."

Across the country, people hang Dutch flags upside down along roads and bridges as support for the farmers. And the world is also starting to take notice.

Not Just a Dutch Issue

Nitrogen emissions are not just a Dutch issue. It's a problem all over Europe, such as the Po Valley in Italy, Brittany in France, and parts of Denmark, Ireland and the UK.

The current Dutch farmers' rally hinges on EU standards setting maximum safe nitrogen emissions levels. This applies all throughout the bloc.

For instance, Belgium, which has the 3rd-highest EU livestock concentration, is paying big attention to the Netherlands.

The government of the Dutch-speaking region, Flanders, also aims to reduce numbers of pigs 30% by 2030. It's offering farmers €150 euros per pig and €855 euros per sow to buy them out.

Germany also has its new regulations on nitrogen pollution. France could also follow.

With the Dutch government already having some outlines, it's now up to provincial administrators to develop and implement their nitrogen [emission reductions](#) plan.

How Big Banks Are Planning to Force Americans Into the 'Great Reset' Trap

Among the many world leaders and powerful institutions that pledged their support for the Great Reset at the June meeting were the International Monetary Fund, Prince Charles, the head of the United Nations, CEOs from major international corporations, and the World Economic Forum—one of the key ringleaders of the Great Reset.

“Every country, from the United States to China, must participate [in the Great Reset], and every industry, from oil and gas to tech, must be transformed,” wrote [Klaus Schwab](#), the founder and executive chairman of the World Economic Forum, in an article published on WEF’s website. “In short, we need a ‘Great Reset’ of capitalism.”

The initial justification for the Great Reset was the COVID-19 pandemic, but from the start, supporters of the global economic overhaul repeatedly said that climate change was the long-term justification, the one that would allow a sustained, massive transformation of society. Doing nothing, they argued, would pose an “existential threat” to the human race—a completely ludicrous argument many on the left continuously make without a shred of solid scientific evidence to support the claim.

Among the most important figures in the Great Reset movement are gigantic financial institutions and/or their CEOs, including Bank of America and MasterCard.

Although many Great Reset supporters have called for dramatic expansions of government welfare programs, including job guarantees, government-provided health care, etc., the heart of the Great Reset is something called environmental, social, and governance (ESG) metrics.

ESG metrics offer public policy leaders, economists, investors, and banks an entirely new way of evaluating businesses. Instead of looking at how profitable a company is, how many employees it has, its business model, and other traditional metrics, ESG

adds to those concerns a whole host of left-wing causes, including how “green” a company is, having the “right” ratio of minorities, whether a business is involved in politically disfavored industries (such gun manufacturing and sales), as well as other, similar considerations. Companies are then given a score or rating to determine how well they align with ESG goals.

Hundreds of the world’s largest corporations, including financial institutions, have already created ESG systems and reporting metrics within their companies, and investor groups worth trillions of dollars have pledged to prioritize these companies over those that refuse to participate.

ESG systems, sustainable investment, and forcing the world to adopt “green” energy sources are all essential elements of the Great Reset plan to transform the world. (I put “green” in quotes because there is ample evidence to show wind and solar energy are not even remotely environmentally friendly, as even left-wing documentarian Michael Moore now admits).

Parts of the Great Reset are theoretical and have yet to be put into place, but some components of the plan have already been rolled out or are now being put into place. One of the most important is financial institutions’ commitment to mandate that virtually all businesses in America adopt renewable energy.

In February 2021, Bank of America, citing its “longstanding support for the Paris Climate Agreement,” announced, *“the company today outlined initial steps to achieve its goal of net-zero greenhouse gas (GHG) emissions in its financing activities, operations and supply chain before 2050.”*

Note that the *“net-zero greenhouse gas emissions”* rule will be applied not only to Bank of America’s own operations and supply chain—meaning every company that does business with Bank of America—but also its *“financing activities.”*

Put more simply, if you want a loan from Bank of America in the future, you better toe the globalist line on climate change.

Of course, Bank of America isn’t the only bank with these policies. Wells Fargo CEO Charlie Scharf made a comparable announcement on March 8.

“Climate change is one of the most urgent environmental and social issues of our time,” Scharf said, *“and Wells Fargo is committed to aligning our activities to support the goals of the Paris Agreement and to helping transition to a net-zero carbon economy.”*

Citi, Goldman Sachs, Morgan Stanley, and JPMorgan Chase—which, together with Wells Fargo and Bank of America, make up the six largest banks in the United States—also have made similar commitments.

And do not think for a moment that these requirements will only apply to businesses, either. Some financial institutions have already started to give ESG scores to individual investment accounts, [as Glenn Beck has repeatedly noted](#), sending a clear signal that *everyone* will be required to adopt the Great Reset in the coming years.

If banks are allowed to collectively decide to stop financing any group of people they want, based not on financial concerns but ideological considerations, then banks and their Great Reset allies will have, in effect, near-total control over society—especially if they begin to tie lending decisions to a vast ESG system.

Interestingly, in January 2021, the Trump-era Office of the Comptroller of the Currency issued a finalized Fair Access to Financial Services regulation that would have made it illegal for large banks to engage in the sort of discrimination I warned about above. But just one week after entering the White House, President Joe Biden “*paused*” the rule’s implementation, signaling his clear intention to eliminate the rule before it ever has a chance to be published in the Federal Register.

This shouldn’t come as a surprise to those of you who have been following the Great Reset closely. The Biden administration’s “*climate czar*,” John Kerry, as well as Biden himself, are supporters of the Great Reset.

The time has come for a massive populist revolt against the Great Reset, one that will hopefully have the same success as the grassroots movement against Common Core did under the Obama administration.

Power Grid Operator Warns of Total Blackout Due to Imminent Shut Down of Coal Plant

The power grid operator in the mid-Atlantic has warned that the planned shutdown of a coal-fired power plant could affect the electrical supply to millions of Americans, causing a total blackout.

PJM Interconnection, the company that manages wholesale electricity for 65 million Americans in 13 states, said they expect the shutdown of the Brandon Shores coal power plant to disrupt the power.

The plant’s owner, Talen Energy, recently struck a deal with the environmentalist group Sierra Club to deactivate it by 2025 to reduce carbon dioxide outputs and help fight ‘climate change.’

However, that deal could be better for residents.

Jeff Shields, a spokesperson for PJM Interconnection, told Fox News:

“The PJM region and the state of Maryland are facing future reliability challenges as a result of the announced retirement of the Brandon Shores units.”

“Specifically, PJM analyses showed that the deactivation of the Brandon Shores units would cause severe voltage drop and thermal violations across seven PJM zones, which could lead to a widespread reliability risk in Baltimore and the immediate surrounding areas.”

The ‘Washington Examiner’ reported:

PJM predicts prematurely shutting down Brandon Shores could create an imbalance in the local power grid, and cause a blackout for millions.

The plant generates about 1,295 megawatts, which is enough to power more than a million homes.

Grids can sometimes transfer power from other areas, but the upgrades required to do so will not be finished until 2028 — three years after Brandon Shores is scheduled to shut down.

The company has demanded that Brandon Shores remain in operation until those upgrades are finished but notes that the Talen agreement with Sierra Club bars this from being the case.

Local regulators are working on accounting for these problems. Maryland Public Service Commission spokeswoman Tori Leonard said:

“We are always mindful of regional electric system reliability and how it relates to electricity consumers in Maryland.”

A Fox News noted that because of the tight timeframe, PJM has requested that Brandon Shores remain in operation through 2028 under a so-called Reliability Must-Run Agreement until transmission upgrades are completed.

However, Shields noted Talen Energy’s agreement with Sierra Club prevents such an agreement from progressing.

Additionally, while Talen Energy previously said it would convert Brandon Shores to rely on another, less emitting fuel source, it ultimately abandoned that plan.

It opted to close the facility, potentially increasing future reliability concerns completely.

“Talen is currently in discussions with PJM and others regarding the reliability issue claimed by PJM,” Taryne Williams, a spokesperson for Talen Energy, told Fox News Digital in an email.

“We are always mindful of regional electric system reliability and how it relates to electricity consumers in Maryland,” added Maryland Public Service Commission spokesperson Tori Leonard in a statement, noting that PJM is responsible for reliably operating the regional transmission grid.

Democratic Gov. Wes Moore called for the state’s power grid to be entirely powered by green energy by 2035.

“Governor Moore remains committed to a vision for Maryland’s future that includes 100 percent clean energy — a commitment that will bring countless jobs and hundreds of millions in economic investment across the state,” Carter Elliott, a spokesperson for Moore said.

“Earlier this year, the governor was proud to sign the POWER Act and partner with Ørsted to announce Maryland’s First Offshore Wind Turbine Component Center at Tradepoint Atlantic.”

“Ørsted’s projects will support the creation of thousands of jobs in Maryland, power nearly 300,000 homes with renewable energy, and help the state achieve its goals of 8.5 gigawatts of offshore wind energy by 2031.”

“At every opportunity, the governor has worked aggressively to help Maryland meet its energy goals, and he will continue to lead the state with that goal at the top of mind while maintaining grid reliability and protecting ratepayers.”

As desirable as clean energy might be, the Power Energy industry have concluded that it will be impossible to replace fossil fuels with renewable green energy replacement. Wind and solar are known to be unreliable sources of power and as Prince Charles mandates to restrict emissions are implemented the world is ultimately facing black outs and brown outs disrupting people’s living standards and survivability.

From the archives of Pastor Bob’s Studies on Deliverance before Judgment / Pre-Tribulation Rapture Why the Rapture Occurs Before the Revealing of the Antichrist!

The focus on the Exodus in understanding *“Deliverance before Judgment”* is confusing for many, especially so for the Jewish people. It is written in the Torah, ***“And the sons of Israel journeyed from Rameses to Succoth, the men being about six hundred thousand men on foot, apart from little ones.”*** -(Exodus 12:37). Since the verse only includes the number of men who were 20 years of age and over, we can extrapolate the total population by including the women and children as well.

According to Rabbi Yonasan ben Uziel (circa 1st century C.E., author of an Aramaic translation of the Five Books of Moses), there were three million Jews who witnessed the giving of the Torah at Mount Sinai. It is probable that a comparable number of Jews left Egypt. The Talmud says that 80 percent of the Jews never even left Egypt. That

said, it should be noted that the Talmud is disputed as being a reliable source of truth among many theologians and scholars. They were **so steeped in Egyptian culture that they were unwilling to join the Exodus**. As such, they were lost to the Jewish nation forever.⁽¹⁾

After the greatest national revelation experience in human history when the whole nation heard God, Moses went up the mountain and came down 40 days later to find people dancing around an idol. Were all three million Jews dancing around a golden calf? Not likely. The Torah in Exodus 32:28 says it was about three thousand people, mostly the mixed multitude of individuals who left with the Jews.

That means that only about .001% of the Jews (one in a thousand) participated in worshiping the golden calf and 99.9% of the Jews did nothing wrong, (although the majority failed to stop the minority from worshipping the golden calf and this was considered a serious mistake). Yet God's reaction made it clear that he held the whole nation accountable. This is an important Biblical truth that should not be forgotten by the Gentile and Christian community as well.

God held the Jews to a very high standard because they had a unique responsibility in human history. The world wouldn't get perfected without the Jews and if the Jews blew it, all of humanity, not just the Jewish people, would be doomed. Therefore, the Bible uses critical language to bring home two important principles:

According to your level of knowledge is your level of responsibility. Even the small mistakes of people in positions of power have huge consequences.

According to your level of responsibility is your level of accountability. The greater you are, the bigger the impact of your decisions, therefore you must be held to an extremely high standard of accountability.

The Jewish people had been given the ultimate responsibility for the world at Mount Sinai, and these principles explain the criticism that God levels against Jews and why it was so over-stated.

We learn here another fundamental idea of the Torah -- that every Jew was a guarantor for every other Jew. The nation of Israel is a "body" and the individual Jews are like cells in this body. **If part of the body does something wrong, the whole body is held accountable**.⁽²⁾

There were two distinct expectations prevailing among the Jews when John the Baptizer began to proclaim: **"Repent, for the kingdom of heaven is at hand"**. – (Matthew 3:2). John's preaching was not only the warning of impending judgment, it was a call to action. John called upon men to repent and to be baptized. What does John mean by the term "repent"? It means to **have a change of mind, to turn around**. By repentance John means much more than just a change of one's thinking.

There is an element of sorrow or remorse. Repentance is a change of heart and mind that results in a change of course, a change in lifestyle.⁽³⁾

There were those who shared similar sentiments like the prophet Daniel did: ***“We have sinned, and have committed iniquity, and have done wickedly, and have rebelled, even by departing from Thy precepts and from Thy judgments: Neither have we hearkened unto Thy servants the prophets, which spake in Thy name to our kings, our princes, and our fathers, and at the people of this land”*** -(Daniel 9:5-6).

To those who could see the same pattern of religious hypocrisy, compromise, and corruption that prevailed before the destruction of the first Temple, the Day of the LORD was looming – a day of darkness and not light in which God would lay the land desolate and destroy the sinner as had happened before. Whatever the messianic expectation of these people might have been at the time, it would have been **couched in the fear of judgment.**

Instead to these came glad tidings of great joy, that there was born to them in David’s city from the line of David, One who would be the Savior and Redeemer of His people. ***“And she shall bring forth a son, and you must call His name Jesus (Yeshua) for He shall save His people from their sins”***. -(Matthew 1:21). The name Jesus (Aramaic *Yeshūa*, Greek *lēsous*) means “God is salvation” in Hebrew. Parents often intended the names they gave children to have some meaning, but if God gave the name, it had special significance. The Old Testament taught that God’s people would be saved in the time of the Messiah -(Jeremiah 23:5-6), and Jewish readers in the first century would have understood this salvation to mean much more than just personal forgiveness. They prayed for the day when God would deliver His people from the consequences of their sins—from subjugation beneath their enemies; many believed that this deliverance would occur when their people as a whole reformed and turned wholeheartedly to God. Jesus came to deliver His people from personal sin and thus to deliver them from its judgment as well.

John the Baptizer met Jesus with these words: ***“Behold the lamb of God, who takes away the sin of the world”*** -(John 1:29). The title **“Lamb of God”** would be associated in the minds of the Jews with the Passover lamb -(Exodus 12) and the lambs used in the daily sacrifices for the sin offerings -(see Leviticus 14:12; Lev. 14:21; Lev. 14:24; Numbers 6:12). Every morning and evening, a lamb was sacrificed in the Temple for the sins of the people -(Exodus 29:38-42). Isaiah 53:7 prophesied that the Messiah, God’s servant, would be led to the slaughter like a lamb. **To pay the penalty for sin, a life had to be given** - God chose to provide the sacrifice Himself. When Jesus died as the perfect sacrifice, **He removed the sin of the world and destroyed the power of sin itself.** Thus God forgives our sin -(1st Corinthians 5:7). In calling Jesus the Lamb of God, **John pointed to Jesus as the substitutionary sacrifice provided by God.** For He would become the Passover sacrifice and by His shed blood, the faithful remnant would escape the judgment which was about to befall the nation of Israel.

Thus, ***“In that day shall the branch of the LORD be beautiful and glorious, and the fruit of the earth shall be excellent and comely for them that are escaped of Israel”***. –(Isaiah 4:2). ***“The Redeemer will come to Zion, to those in Jacob who repent of their sins, declares the LORD”***. –(Isaiah 59:20).

John baptized across the Jordan River –(John 10:40) – probably at the site where the Israelites crossed into the Promised Land with Joshua and Caleb.

According to the terms of the Law of Moses, the Lord was promised as an inheritance for as long as the Israelites would remain obedient to the covenant –(Leviticus 20:22-24). By withdrawing across the Jordan, **the penitent ones of Israel were acknowledging that they had forfeited their promised inheritance through disobedience, placing themselves at God’s mercy in anticipation of the coming Redeemer.** ***“All the people, even the tax collectors, when they heard Jesus’ words, acknowledged that God’s way was right, because they had been baptized by John. But the Pharisees and experts in the law rejected God’s purpose for themselves, because they had not been baptized by John”***. –(Luke 7:29-30). The obvious contrast here cannot be missed. The words are simple but their significance is profound. All the people, referring to the crowds, and even the tax collectors had come to understand an important truth. When these common, ordinary people, and these evil, self-serving tax collectors heard Jesus’ words, they agreed that God’s plan was right. Certainly John had done his job—these people were ready to accept Jesus because they had been prepared. They had listened to John’s preaching –(Luke 3:7-18) and had been baptized by him.

But the group who should have been most ready and most accepting had refused John’s baptism. They had refused the repentance and confession that John had required (probably because they felt themselves already righteous and did not need to do so). The Pharisees and experts in religious law had rejected the forerunner of Jesus; the obvious result was that they also had rejected their own Messiah. Luke explained that ***in so doing, they had rejected God’s plan for them. While they may have understood God’s law, they had missed His purpose.***

On the other hand, there was an expectation of a Messiah who would vindicate Israel before its enemies and elevate the Jews to the foremost position amongst the nations of the world. In fact, this view is still held by many within Israel today.

The Pharisees and others who shared their sentiment could not foresee that ***they themselves had fallen under God’s wrath and judgment.*** Meticulous in their religious observances – and thoroughly convinced of their own righteousness – they were awaiting their just reward for their disciplined life. Salvation from sin was not part of their messianic expectation.

The Pharisees would not recognize that they had made an idol out of the Torah and had adopted the pursuit of moral perfection in exchange for a relationship with the living God. Nor did they understand their need of an internal transformation.

Observance to an external code could not possibly be achieved in this manner. ***“You have heard that it was said to the ancients, “You shall not commit adultery.” But I say to you that whoever looks on a woman to lust after her has already committed adultery with her in his heart”*** -(Matthew 5:27-28). ***“For My people have committed two evils; they have forsaken Me the fountain of living waters, and hewed them out cisterns, broken cisterns, that can hold no water”*** -(Jeremiah 2:13). To forsake this Fountain is the first evil; this is done when the people of God neglect His word and ordinances. They hewed them out broken cisterns that could hold no water. Such are the world, and the things in it; such are the inventions of men when followed and depended on.

This Pharisaic mindset is pervasive throughout the Talmud. Other rabbinical writings are problematic among Jews today around the world. Variations of this endure in the messianic hopes of Jews today, and just as building an ark would be of little interest to those not expecting a Messiah, so the gospel of Jesus our Messiah finds no rapport amongst those awaiting their glorious restoration. This disastrous flaw will be a contributing factor to the reason why the Jews will become receptive to the Antichrist, rather than to their true Messiah, Christ Jesus.

Many within the Christian community hold the view that the Church will have to go through part or all of the Tribulation. This is primarily because they cannot understand or accept their own redemption. It is as if they believe they have to do something to merit that redemption. They overlook the fact that the Lord’s redeeming action at the Cross has already taken on all the costs involved. For some, saying thank you seems too insufficient in exchange for such a tremendous gift.

Likewise, the trap and snare of religious and ethnic pride for those who share the same sentiment as the Pharisees, continues even today to be a problem as spoken of by Isaiah. ***“The LORD has pronounced His verdict over those that say, “Stand by thyself, come not near to me; for I am holier than thou.” For these are a smoke in my nose, a fire that burns all the day,” says the LORD”*** -(Isaiah 65:5). In 2015, almost 10,000 Jews returned to Israel (9,880 to be precise). They come largely in unbelief, ingrained with the belief that they need only rely solely on themselves. This *“sin of unbelief”* will weigh heavily in the coming weeks, months and years just ahead. I will deal with this near the end of this series, but make no mistake about it the *“sin of unbelief”* is far more problematic among Gentiles as it is among the Jews.

Much of the New Testament and the prophetic outworking of Jesus’ teaching will be completely misunderstood unless we see that those who, to hold off the promise of salvation, were expecting imminent destruction. Not only did Jesus fail to live up to the expectation of the Pharisees, namely that they were to be showcased before all mankind as the paragon of religious virtue, but He also failed at the outset to come in judgment in accordance with the prophetic warnings. Thus, the question that John the Baptizer sent to Jesus from King Herod’s prison, ***“Are you the One who was to come, or should we look for another?”*** -(Luke 7:19). But it was in accordance with God’s great mercy that the Gospel of salvation would first reach its entire population, before

Israel would be condemned, consequential to Daniel's prophecy of the Seventy Weeks –(Daniel 9:24-27). As the rabbis like to teach: God always sends the cure before the disease. **The Pharisees of Jesus' day are comparable to the folks today who attack the Pre-Tribulation Rapture.**

When Jesus prophesied in accordance with all that the prophets had spoken in centuries past that ***“men will faint with fear and apprehension because of the things that are to come ... they will see the Son of Man coming in a cloud ... (and) this generation will not pass away until it is fulfilled”*** -(Luke 21:26-32). He was not referring to His Second Coming that He would soon come in judgment against Israel and Jerusalem. There are three main views of the meaning of this generation will not pass:

- It refers only to those alive at the time Jesus spoke and who still would be alive at the destruction of Jerusalem.
- It refers only to those who would experience the end times.
- It refers both to the destruction of Jerusalem and the end times—the destruction of Jerusalem contains within itself the elements of the final end times and thus serves as a precursor. The Greek word for “generation” is ***genea***; it refers both to those living at a given time as well as to race or lineage (therefore, **Jesus would have been speaking of the Jewish race**). This makes the third view most likely being referred to.

The proud and the arrogant will always be blind to their impending doom. **Only the fear of God can keep us from the snare, and the dread of His righteous judgment.** We have this as our assurance that ***“mercy triumphs over judgment”***. -(James 2:13). Mercy triumphs over judgment may mean that God would rather show mercy to us than discipline us -(Micah 7:18). It may mean we can rejoice in the face of judgment if we have shown mercy to others, but if we have not shown mercy to those whom we might justly condemn, we will not be shown mercy. Or it may mean that mercy triumphs over judgment in the sense that it is always greater than judgment. The general idea seems to be that if we show mercy to others, the judgment which might otherwise fall on us will be replaced by mercy.

Let us test ourselves then on this important subject of partiality. Do we show more kindness to those of our own race than those of other races? Are we more kindly disposed to the young than to the old? Are we more outgoing to good-looking people than to those who are plain or homely? Are we more anxious to befriend prominent people than those who are comparatively unknown? Do we avoid people with physical infirmities and seek the companionship of the strong and healthy? Do we favor the rich over the poor? Do we give the “cold shoulder” to “foreigners,” those who speak our language with a foreign accent?

As we answer these questions, let us remember that the way we treat the least lovable believer is the way we treat the Savior (Mat 25:40).

Paul's words in Romans 1:18-21 are going to be Key: ***“For God’s wrath is being revealed from heaven against all the ungodliness and wickedness of those who suppress the truth in their wickedness. For what can be known about God is plain to them, because God Himself has made it plain to them. For since the creation of the world His invisible attributes – His eternal power and divine nature – have been understood and observed by what He made, so that people are without excuse. For although they knew God, they neither glorified Him as God nor gave thanks to Him. Instead, their thoughts turned to worthless things, and their ignorant hearts were darkened.”***

The truth about God has been clearly revealed by God. The clues to God's existence and character have traditionally been called “general revelation”. God could have kept humans in ignorance about Himself. But He chose to reveal Himself, generally in nature and specifically through the Scriptures and Jesus Christ. Because God has made certain facts about Himself known instinctively, people will someday have to give an account before God concerning why they chose to ignore His existence and His character.

But how could a loving God send anyone to hell, especially someone who has never heard the Good News of Jesus? In fact, says Paul, people have seen the earth and sky and all that God made—therefore, they can clearly see his invisible qualities. Also, **everyone has an inner sense of what God requires, but they choose not to live up to it.** Put another way, people's moral standards are always better than their behavior. **If people suppress God's truth in order to live their own way, they have no excuse.** They know the truth, and they will have to endure the consequences of ignoring it.

The paradox can't be missed—all people can “clearly see” God's “invisible qualities.” How? God created the world with natural processes, with cause and effect. In the same way that observing a painting leads a person to conclude that there is an artist, so to observe the tremendous creation is to conclude that there is a supreme Creator, one with eternal power and divinity. This is part of the truth that unsaved people are suppressing from the public at large.

The Exodus event pictures God's original and unchanging plan for “Deliverance before Judgment”. **The consequences for their belief or unbelief in Jesus Christ and likewise of our own will determine individual destiny** as we approach the coming Seven-year Great Tribulation.
