A new study led by Dr. Nicholas Cowan, an atmospheric physicist at the UK Centre for Ecology and Hydrology in Edinburgh, claims gases exhaled by humans when breathing contribute to global warming.

Sadly, this isn't a parody.

"It has been reported that exhaled human breath can contain the greenhouse gases methane (CH_4) and nitrous oxide (N_2O), both of which have a much higher global warming potential than carbon dioxide (CO_2)," the study reads.

"Where hydrocarbon chains (food types) are consumed by humans and turned into CH4 (and N2O from nitrogen intake), the global warming potential is no longer neutral, and human respiration has a net warming effect on the atmosphere," it adds.

"We would urge caution in the assumption that emissions from humans are negligible," the researchers stated.

Daily Mail reports:

For the study, the researchers investigated emissions of methane and nitrous oxide in human breath from 104 adult volunteers from the UK population.

Participants were required to take in a deep breath and hold it for five seconds, then exhale into a sealable plastic bag.

A total of 328 breath samples were collected and every participant had details recorded such as age, sex and dietary preference.

After analyzing the samples, researchers found nitrous oxide was emitted by every participant, but methane was found in the breath of only 31 per cent of participants.

Researchers say those who do not exhale methane in their breath are still likely to 'release the gas in flatus' – in other words, by farting.

Interestingly, people with methane in their exhaled breath were more likely to be female and above the age of 30, but researchers aren't sure why.

Concentrations of the two gases in the overall samples let the researchers estimate the proportion of the UK's emissions are from our breath -0.05 per cent for methane and 0.1 per cent for nitrous oxide.

Dr. Cowan stresses that each of these percentages relate specifically to these respective gases, not all of the UK's greenhouse gas emissions as a whole.

Researchers didn't manage to find any link between gases in the breath and diets – although meat eaters are known to fuel the climate crisis in other ways.

The experts stress that their study only looked at greenhouse gases in breath, and so it does not provide an overall estimate of a person's emissions footprint.



The 'scientists' wrote in their conclusion:

The measurements carried out in this study allow us to estimate UK-scale emissions of approximately 1.04 (0.86–1.40) Gg of CH4 and 0.069 (0.066–0.072) Gg of N2O emitted

in the form of human breath. Based on a sample population of 104 volunteers, we estimate that the methane producing (MP) population in the UK is 25% for those aged less than 30 years, and 40% for those aged over 30 years of age. We have found no correlation between diet and emission of CH4 and N2O in breath and recommend if future studies wish to assess this in more detail, that rigid dietary regimes are implemented to reduce the effect of heterogeneity of emissions in a given population. While emissions of CH4 and N2O account for only 0.05% and 0.1% of the total emissions in the UK national greenhouse gas inventories, respectively, we would urge caution in the assumption that emissions from humans are negligible. We report only emissions in breath in this study, and flatus emissions are likely to increase these values significantly, though no literature characterizes these emissions for people in the UK. Assuming that livestock and other wild animals also exhale emissions of N2O, there may still be a small but significant unaccounted for source of N2O emissions in the UK, which could account for more than 1% of national-scale emissions.

Censoring Free Speech: a Page from the Papal Playbook By Wings of Liberty

Bible prophecy speaks of the lamb-like beast of Revelation 13 making an image to the first beast of Revelation. A beast in Bible prophecy represents a kingdom – see Daniel 7 – raising the question of which kingdoms are represented by these two beasts. The first, or leopard-like beast of Revelation 13, represents the Roman papacy, especially during the 1,260 year period from 538 AD to 1798. [1]

The lamb-like beast of Revelation 13 represents primarily the United States; it is the only globally dominant kingdom with world-wide significance arising after the 1798 year period and the deadly wound to the papacy (the overthrow of the papal state by Napoleon Bonaparte 1 and the capture and exile of Pope Pius VI). The lamb-like beast is said to arise from the earth. The United States arose from the land of the New World. The lamb-like characteristics of civil and religious liberty and the recognition of the individual rights bestowed by the Creator on every human being are the secrets of America's great strength. It is this that has secured the blessings of Providence.

But Revelation 13 describes a sad deterioration in the lamb-like beast and states that it will make an image to the persecuting papal beast and then force all the earth to worship it.



What then would an image of the papal beast look like? To answer this question, we must analyze the papal beast. What is it? What does it do? How does it function?

The papacy is a church-state power. The Pope, the head of the church, is also the head of state. The church, therefore, influences and controls the state. Bible prophecy predicts that at its end, America will be controlled by a religious power. But there is more.

The papacy abhors individual rights. For centuries, Popes have railed against the concept of individual rights, specifically the liberty of individual conscience. From the archives of Pastor Bob's Studies on Deliverance before Judgment / Pre-Tribulation Rapture Why the Rapture Occurs Before the Revealing of the Antichrist!

I first began my study of Bible prophecy back on June 8, 1967. It was at the same time as the Israeli Six-Day War, in which Israel took total control of East Jerusalem and was itself a prophetic date.

Most people are helpless when it comes to understanding the Bible and its central message. In this particular segment of "Deliverance before Judgment," I will be sharing examples of how God saved His remnant in a temporary safe place when trouble came. Today, the only criteria to be delivered from the coming Tribulation is to be a saved 'born-again' believer who has accepted and believes that Christ Jesus is our Savior. It does not matter how long you have been saved. You could be a new believer today or you could be someone who has been a believer for fifty years like me.

- When God decided to cleanse the earth of people, He did so with the exception of a remnant. The way God did that was to temporarily keep His remnant safe in the Ark. Genesis 7:1 states, "Then the LORD said to Noah, "Enter the ark, you and all your household, for you alone I have seen to be righteous before Me in this time." Genesis 7:16-17 relates the story of Noah and his family: "Those that entered, male and female of all flesh, entered as God had commanded him; and the LORD closed it behind him. Then the flood came upon the earth for forty days, and the water increased and lifted up the ark, so that it rose above the earth. This physical event was a type of the Pre-Tribulation Rapture theme found in the Bible.
- Sodom was condemned but God sent angels to rescue Lot before calamity and he was kept in a nearby city until it was safe. Genesis 19:19-20 states, "Now behold, your servant has found favor in your sight, and you have magnified your loving kindness, which you have shown me by saving my life; but I cannot escape to the mountains, for the disaster will overtake me and I will die; Now behold, this town is near enough to flee to, and it is small. Please, let me escape there (Is it not small?) that my life may be saved." Genesis 19:22 adds, "Hurry, escape there, for I cannot do anything until you arrive there." Therefore the name of the town was called Zoar."
- Joseph was abhorred by his brothers, thrown into a pit and saved by God for a time in Egypt. God sent angels to rescue him from calamity and kept him in a nearby city until it was safe. Genesis 37:28-29 reads, "Then some Midianite traders passed by, so they pulled him up and lifted Joseph out of the pit, and sold him to the Ishmaelite's for twenty (shekels) of silver. Thus they brought Joseph into Egypt. Now Reuben returned to the pit, and behold, Joseph was not in the pit; so he tore his garments."

These three stories from the book of Genesis were actual physical events; however, they communicate a three-dimensional understanding of the text. Hebrew is a 3-D language which will be covered later. Unfortunately, those who read the Bible are largely ignorant [lacking knowledge]. Hebrew scholars who teach the Old Testament know that with each passage there could be as much as three or even four meanings. Hebrew scholars know this as **"PRDS"**, an acronym for the Hebrew word "paradise". "Pardes" refers to (types of) approaches to biblical exegesis in rabbinic Judaism or to interpretation of text in Torah study. The term, sometimes also spelled **PaRDeS**, is an acronym formed from the same initials of the following four approaches:

- <u>Peshat (פְּשָׁט) "surface" ("straight") or the literal (direct) meaning.</u>
- Remez (מֶמֶז) "hints" or the deep (allegoric: hidden or symbolic) meaning beyond just the literal sense.
- <u>Derash (דְרַשׁ)</u> from Hebrew darash: "inquire" ("seek") <u>the comparative</u> (midrashic) meaning, as given through similar occurrences.
- **Sod** (τίο) (pronounced with a long O as in 'sore') "secret" ("mystery") or the esoteric/mystical meaning, as given through inspiration or revelation. (1)

Sadly, the Christian community is for the most part completely unaware of this method of Scriptural interpretation. There are many things most Christian pastors do not know. Possessing a working knowledge of Hebrew and Greek is helpful. But for now, just remember that the Hebrew Old Testament is a book written with three dimensional language features. Unfortunately, few pastors have had Biblical language training in Greek, and even fewer have had Hebrew training.

In the book of Exodus, death was decreed for Moses and all male sons born to the Hebrew slaves. But God saved Moses by hiding him in a basket among the reeds of the Nile River. Exodus 1:22 states, "Then Pharaoh commanded all his people, saying, "Every son who is born you are to cast into the Nile, and every daughter you are to keep alive." Exodus 2:2-3 reads, "The woman conceived and bore a son; and when she saw that he was beautiful, she hid him for three months. But when she could hide him no longer, she got him a wicker basket and covered it over with tar and pitch. Then she put the child into it and set it among the reeds by the bank of the Nile." The man of the house of Levi in verse 1 was Amram, and the daughter of Levi was Jochebed (Exo 6:20). Thus both of Moses' parents were of the priestly tribe of Levi. By faith Moses' parents hid him for three months -(Hebrews 11:23). This must mean that they received some revelation that he was a child of destiny, because faith must be based on some revealed word of God.

Jochebed's ark, like Noah's, is <u>a picture of Christ</u>. Moses' sister was Miriam - (Numbers 26:59). This chapter is full of seeming coincidences. For example, why did Pharaoh's daughter happen to bathe right where the ark was floating? Why did the baby happen to cry and thus draw out her compassion? Why was Moses' mother accepted by Pharaoh's daughter as his nurse?^(a)

Israel was saved in a nearby town of Goshen from the hail that fell during the fourth plague of judgment on Egypt. Exodus 9:26 reads, "Only in the land of Goshen from the hail of the judgements..." The Lord used Pharaoh as an example of what happens to a person who is determined to resist the power of God. The plague consisted of hail and lightning or fire, accompanied by thunder. It destroyed men, beasts, and the flax and . . . barley, that were ready for harvest -(cf. vv. 31, 32); but the wheat and the spelt were not struck, for they are late crops. The Israelites, dwelling in Goshen, were untouched. In response to Pharaoh's plea, Moses prayed and the plague

stopped. But, as Moses expected, Pharaoh became even more adamant against letting the Hebrews leave. (a)

At this point, the larger picture of "Deliverance before Judgment" for God's people should be beginning to come into focus. This same portrayal characterizes what applies to the "born-again" Christian as well. We are studying the Word of God through the use of "types" and "themes". This method of understanding Scripture was lost in the church at the end of the 19th Century, when liberalism invaded and flooded the Church, nearly overtaking it like a Tsunami. Consequently, from the late 1890's and forward the Church began to adopt a "Social Gospel" instead of proclaiming the real "Gospel". (2)

If we resume and teach this pattern of "types" used by the Creator to communicate the doctrine of "Deliverance before Judgment" through His Word, we are able to understand and grasp His Master Plan for Redemption. In the book of Exodus, the LORD rescued those who were safe in a house marked by the Blood of the Lamb. This represented a symbolic "type" or "shadow" of the future Messiah, Jesus Christ. Exodus 11:4 states, "Thus says the LORD, 'About midnight I am going out into the midst of Egypt." In Exodus 12:12-13, we read: "For I will go through the land of Egypt on that night, and will strike down all the firstborn in the land of Egypt, both man and beast, and against all the gods of Egypt I will execute judgment – I am the LORD. The blood shall be a sign for you on the houses where you live; and when I see the blood I will pass over you, and no plague will befall you to destroy you when I strike the land of Egypt." Then in Exodus 12:23, we read, "For the LORD will pass through to smite the Egyptians, and when He sees the blood on the lintel and on the two doorposts, the LORD will pass over the door and will not allow the destroyer to come in to your house to smite you." This is a perfect example illustrating the three dimensional message of the Hebrew text:

- Peshat (פְּשָׁט) A <u>physical and historical event</u> preceded by a warning describing how the people were to avoid death by the angel of death.
- Remez (רֶמֶז) A spiritual message that God will deliver them to freedom and rest.
- **Sod** (Tio) A prophetic picture illustrating God's purpose and plan to send a Redeemer who would provide an avenue to obtain salvation for God's people.

God used some 200 different forms of literary and linguistic devices to teach His Master Plan to Israel and to those who have sought Him out and became believers. "Typology" is but one of the ways God teaches using object lessons designed to drive His message home. His love for His creation is only surpassed by His holiness. Even though His perfect justice requires that sin cannot be left unpunished, He gave the best possible solution by providing His own Lamb, the Messiah Christ Jesus to offer payment for the price of our sins. This is the most perfect example of "Deliverance before Judgment".

As Pharaoh came to destroy them, the nation of Israel was saved by another flood when the LORD kept the waters from destroying them as they crossed through the Red

Sea on dry land. Exodus 14:29 states, "But the sons of Israel walked on dry land through the midst of the sea, and the waters were like a wall to them on their right hand and on their left." God had a plan for their deliverance and death from the pursuing Egyptian army was not part of God's plan. He brought them to a location at the Red Sea where a natural land bridge existed that spanned across 11 miles to the opposite side where the land of Midian and their freedom from Egyptian slavery awaited. The land bridge is a half mile wide and was only about 260-meters beneath the surface of the Red Sea. Skeptics scoff but underwater camera and grappling devices have uncovered the bones and remains of the destroyed Egyptians along with parts and wheels from their chariots. The Gospel of Mark, 10:27 states, "Looking at them, Jesus said, "With people it is impossible but not with God; for all things are possible with God." Arrogance has for more than a century caused man to lie, distort and misrepresent the text and the truth of the story of the Red Sea crossing by the Israelites. We now know it as a **proven fact of history!** (See Notes 1-5 containing 4 interview videos from PITN with Dr. Lennert Moller on Part 17 of Deliverance before Judgment for further discussion related to the land bridge.)(3)

Ask yourself these questions for a moment:

- If God was going to destroy His people, why did God tell them how to escape the judgment?
- If He was planning on bringing judgment to disobedient and sinful mankind, why didn't God simply destroy them all?
- If God is such a divine despot, why has God embedded over 300 examples throughout the Bible of where this divine theme of "Deliverance before Judgment is revealed?

On the 3rd month after Israel escaped and were delivered by God from Egypt, they were to be ready for the Lord to "come down". Exodus 19:1 states, "In the third month, when the children of Israel were gone out of the land of Egypt, the same day came they into the wilderness of Sinai." Exodus 19:11 says, "And be ready against the third day: for the third day the LORD will come down in the sight of all the people on Mount Sinai." The people were told to prepare for a revelation from God by washing their clothes and refraining from sexual intercourse. This was designed to teach them the necessity for purity in the presence of God. (a) To make a long story short, the Israelites could have made their journey to the Promised Land possible in two weeks, but because of their disobedience, it took them forty year to arrive at their final destination. Furthermore, only those 20 years and younger plus Joshua and Caleb were permitted into the Promised Land. All those who left Egypt forfeited their opportunity and died in the wilderness. (4) There is a lesson to be learned for us today in the telling of this story.

Hopefully readers are beginning to see how the three dimensional method of *PaRDeS* amplifies understanding of the Bible as it unfolds through "types" and brings the Word of God alive in your hearts and minds. Everything that happened to God's chosen people, historically and physically, were "types" and "shadows" of good things to

come in God's Master Plan of Redemption. –(Colossians 2:17; Hebrews 10:1) In the next segment I will illustrate more examples of "Deliverance before Judgment!"

COP28 Synopsis for Prince Charles It Was A Bummer!



COP28 left behind an air of mixed emotions as it wrapped up on Wednesday, reflecting the complexity of the discussions and outcomes.

A visibly jubilant Sultan Al Jaber strolled into the plenary, sharing a warm hug with UN climate chief Simon Stiell, basking in the applause as they marked a "historic" milestone: the first time in 30 years that a climate summit decision text explicitly mentions fossil fuels.

The conference president told parties the global stocktake deal "confronted realities and set the world in the right direction" and "delivered a paradigm shift that has the potential to redefine economies".

- Historic deal struck at Cop28 to 'transition away' from fossil fuels
- Cop28: Everything you need to know
- Semantic suggestions to break the Cop28 impasse

The mood was marked by wary optimism but also deep skepticism about vague language and "loopholes" in the text, including concerns about carbon capture, finance and the continued use of gas as a transition fuel.

The hard-fought agreement urged a transition away from coal, oil and gas this decade and was adopted in the fifth iteration of the global stocktake deal, after heated negotiations ran over the Tuesday deadline.

This language replaced the clear call for a "phase out" of fossil fuels, a central point of contention throughout the talks.

The text specifically calls for "transitioning away from fossil fuels in energy systems, in a just, orderly and equitable manner ... so as to achieve net zero by 2050 in keeping with the science".

This substitutes the previous reference to "reducing both consumption and production" of fossil fuels that was met with strong resistance from oil producers including Saudi Arabia, Iraq, Iran, Oman and China.

NY Post: "John Kerry might need to cut back on his own emissions. The Biden administration's climate envoy was discussing US policy on coal power plants at the Climate Change Conference in Dubai on Sunday when Kerry may have unleashed a burst of wind energy. The former secretary of state was speaking next to Becky Anderson, managing editor of CNN Abu Dhabi, and Fatih Birol, executive director of the International Energy Agency, when a Bronx cheer suddenly erupted midsentence. "There shouldn't be any more coal-fired power plants permitted anywhere in the world," Kerry began before launching into an anti-coal diatribe. "I find myself getting more and more militant because I do not understand how adults who are in a position of responsibility can be avoiding responsibility for taking away those things that are killing people on a daily basis..." Before Kerry can complete his thought, the crude sound of

passing gas can be heard over the microphone. The crowd breaks into applause, apparently oblivious to the crude theatrics."



Sultan Al Jaber and Simon Stiell celebrated their milestone deal in Dubai **Not a win for oil producers**

Catherine Abreu, founder and executive director at Destination Zero, said the deal did not count as a win for oil producers as it sends a "strong signal to investment markets" to stop pouring money into fossil fuels and to scale up money being invested in renewables.

Reuters reported the closing statement of a meeting of Arab energy ministers in Doha on Tuesday that said oil and gas will be "pillars of global energy for many decades to come".

A Saudi representative at COP28 told the plenary the kingdom welcomes the deal and praised the outcome.

Romain Ioualalen, global policy manager Oil Change International, said the oil industry, especially <u>OPEC</u>, is in denial about *"the scale of change happening right now"* and needed to think long and hard about the long-term impact of the 200 or so countries agreeing to transition away from hydrocarbons.

loualalen added that it was "too easy to blame Saudi Arabia", alluding to proxy wars in the negotiations.

He called out the US – which is still the largest producer and consumer of oil in the world and still the largest expander of fossil fuel production in the world, way ahead of Saudi Arabia.

"This agreement is a very loud signal that the diversification of its economy needs to start now and needs to be accelerated," he said.

'Massive clean energy revolution'

The final text includes a new specific target to treble renewables and double energy efficiency by 2030.

Bruce Douglas, CEO of Global Renewables Alliance, said this was "unprecedented and signals the start of a massive clean energy revolution".

He said: "It is the first time all nations have recognized renewable energy as the main solution to the climate crisis, representing a paradigm shift in the energy transition."

Despite this, Justin Alexander, a director at the consultancy Khalij Economics based in the US, said the demand for fossil fuels was not suddenly going to disappear as a result of the COP28 deal.

"Even if the world does get its act together for an aggressive phase-out of fossil fuels there will still be demand for tens of millions of barrels a day for several decades to come," he said.

Moving forward towards Cop29 in Baku, Linda Kalcher, executive director of Brussels-based consultancy Strategic Perspectives, said what was missing was clarity on how the transition away from hydrocarbons will be managed and policed.

"This deal is still heavy with loopholes, lacking timelines, and fails to provide the support that the majority of the world's people are going to need to finance the rapid transition that is now required."

Car-Free Sunday Comes to New York City's Iconic Fifth Avenue and the Police will Enforce this Event



Fifth Avenue in New York City is considered iconic and is renowned as one of the most prestigious and upscale streets in the world. Fifth Avenue runs through the heart of Manhattan and is home to some of the city's most famous landmarks and high-end retail stores, including St. Patrick's Cathedral, Rockefeller Center, Central Park, Trump Tower, the Empire State Building, Tiffany & Co., and many others. Fifth Avenue has become a symbol of luxury, wealth, architecture, and commercial significance.

But on three Sundays in December 2023, for the first time in 50 years, cars will be prohibited by law, according to a partnership between the New York City Department of Transportation, City Hall, the New York City Police Department, and the Fifth Avenue Association. NBC News reported the following on December 1, 2023:

- "On Dec. 3, 10, and 17, from noon until 6 p.m., a stretch of Fifth Avenue will only be open to pedestrians." [1]
- "Through a partnership between the New York City Department of Transportation (DOT), NYPD, and the Fifth Avenue Association, the city will <u>for the first time in</u> half a century transform Fifth Avenue, from 48th Street to 57th Street, into an

Open Street three Sundays in December." [1]

- "The city announced that 12 city blocks will be open for pedestrians only, making it the largest-ever holiday season-specific Open Streets program. This year, the area will expand by 25%, opening Fifth Avenue up to pedestrians from 48th Street up to 59th Street reaching up to Central Park." [1]
- "On Dec. 3, 10, and 17, from noon until 6 p.m., Fifth Avenue in that section of midtown will only be open to pedestrians, the city said. On these designated <u>Sundays</u>, these areas will also feature performances as well as food and drink vendors." [1]
- "The NYPD will help ensure that vehicle traffic does not enter those streets and barriers will be in place to prevent traffic flow." [1]

Manhattan, with its business and tourist districts, is known for having some of the most congested and challenging traffic conditions in the world. In addition, it is one of the most densely populated cities and has an extensive public transportation system. And for city officials to shut down all traffic on Sunday and designate this day as something special in one of the most influential cities, it takes a great deal of work, preparation, and cooperation.

As the famous motto says, "If I can make it there (New York City), I can make it anywhere," this brings new life to the idea of car-free Sundays enforced by law. If they can make New York City car-free on Sundays, which is one of the hardest places to implement such a policy due to the disruption of so many people's livelihoods, they can achieve car-free Sundays anywhere. People can and will be forced to rest on Sundays.

With so much emphasis on reducing CO2 emissions to save the planet, it's no wonder Car-Free Sunday is becoming increasingly popular. Governments from around the world agreed to a global transition away from "fossil fuels," greater limits on energy use, and a new fund to compensate governments of poorer nations for alleged damages caused by CO2 emissions from wealthier countries.

The outcome follows two weeks of negotiations at the United Nations climate summit held in the oil-rich United Arab Emirates.

The deal, adopted by consensus of the nearly 200 governments in attendance, is being framed by U.N. officials as a turning point for the world.

Critics, however, are sounding the alarm, saying the agreement and the broader process threaten both prosperity and liberty while doing little to nothing for the environment.

Climate Depot editor Marc Morano, a former U.S. Senate aide who has long worked on climate policy, said Republican leaders in Congress must push back against the agenda.

"This is Soviet-style central planning that simply must be stopped," he told The Epoch Times.

He said all Republicans, from the leaders on down, "need to get to work stopping this anti-human agenda."

Mr. Morano, who attended the COP28 and has been a staple at the events for almost two decades, ridiculed as "absurd" and "psychotic" the notion that humanity can stop using hydrocarbon energy. He predicts the U.N. agreement will do nothing to help the climate.

Separately, numerous experts have pointed out that Russian, Chinese, and Arab governments don't appear likely to rein in traditional energy sources.

U.N. officials said the agreement is a significant step toward protecting the climate, which the U.N. Intergovernmental Panel on Climate Change (IPCC) says is threatened by human emissions of carbon dioxide and methane.

"Whilst we didn't turn the page on the fossil fuel era in Dubai, this outcome is the beginning of the end," said U.N. Climate Change Executive Secretary Simon Stiell at the close of the event.

"Now all governments and businesses need to turn these pledges into real-economy outcomes, without delay."

One of the major takeaways from the event was what the U.N. calls the "global stocktake," described by the international organization as the "central outcome of this year's climate summit."

According to the stocktake, the "science" requires a 43 percent reduction in emissions by 2030 if planetary temperature increases are to be kept below 1.5 degrees Celsius.

Those projections, based on computer models that have long been heavily criticized by scientists and experts for being unreliable, serve as the basis for the entire climate process.

Other policies that the U.N. said are required by 2030, based on the stocktake, include a tripling of "renewable energy" such as solar and wind power, along with a doubling of energy efficiency.

As part of that, the U.N. called for a phase-down of coal power and a "just, orderly, and equitable" transition away from fossil fuels.

Under the plan, governments of wealthier nations such as the United States are expected to lead the way in winding down traditional energy while providing funding for governments of poorer nations to follow suit later.

On the sidelines of the event, data provided by the "Climate Action Commitment Counter" showed billions of dollars pledged throughout the conference by governments and other interests.

The funds are intended to go toward "green" energy, adapting to climate change, "inclusion," reparations, development, and other projects.

To help achieve the goals agreed to by governments at the COP28 and earlier summits, the Biden administration pledged billions of additional dollars to various U.N. programs including the "Green Climate Fund."

The fund is meant to help governments of poorer nations prepare for potential future climate change impacts.

Administration officials also joined other Western governments in pledging hundreds of millions for a new "loss and damage" fund, painted as a mechanism to provide "climate reparations" for poorer nations supposedly harmed by previous CO2 emissions. The fund is to be held by the World Bank.

Perhaps even more significant, the Biden administration pledged to further tighten regulations on power plants that experts warned could produce devastating consequences for the United States.

Stephen Moore, chief economist at FreedomWorks, said the administration's pledges would shut down 60 percent of U.S. electrical power generation.

"Biden is playing a dangerous game of unilateral energy disarmament," said Mr. Moore. "Whether intentional or not, this radical green agenda will cripple our global economic leadership, cost our economy millions of jobs, and make Americans colder in their homes in the winter and hotter in the summer."

Other critics ridiculed the Biden administration's efforts, especially in light of what other governments are doing.

"At the conclusion of COP28, there was a sense of euphoria among the climate faithful that they achieved something monumental, specifically securing a document called the 'UAE Consensus' to 'transition' away from fossil fuels," said Craig Rucker, who attended the summit as head of the conservative-leaning environmental group Committee for a Constructive Tomorrow (CFACT).

"But let's face it, China has been constructing new coal plants at a rate of two per week and India is expected to increase its coal fleet 25 percent by 2030," Mr. Rucker told The Epoch Times.

"Only Western nations steeped in global warming alarmism will undertake the foolish measures the Greens demand to gut their energy infrastructure."

He said COP28 meant nations were recommitting to past commitments that "they've failed to deliver on time and time again."

"The whole thing is a joke," Mr. Rucker said.

Asked at the summit about the Chinese Communist Party's (CCP) rapid expansion of coal-fired electrical power generation, even as the U.S. government further restricts traditional energy sources, U.S. Sen. Lisa Murkowski (R-Alaska), the only Republican to attend as part of the Senate delegation, acknowledged the issue and called for Beijing to cooperate.

Ultimately, however, Ms. Murkowski—one of a handful of Republican lawmakers openly onboard with U.N. climate goals—said the U.S. government must continue its efforts to reduce CO2 emissions and "lead" on the process internationally.

"Everybody needs to be a participant in the broader solution," she said.

"The Chinese need to be part of this discussion, and I think the Chinese need to be challenged on what they are doing and how they are doing it, and brought into the overall solutions."

Asked whether the United States will continue pursuing anti-emissions policies if the CCP refuses to rein in its CO2 output, the senator said the United States will continue to use its own resources while also cracking down on emissions.

The prospect of former President Donald Trump returning to the White House loomed large over the conference, especially with multiple polls showing him leading the field. However, U.N. and U.S. officials said that nothing can stop the "transformation" that is now underway.

"The transformation is unstoppable," declared giant monitors and posters scattered throughout the sprawling Expo Center that hosted the COP28. It seems to me that today (Friday) the momentum is now on the side of HRH Prince Charles; sufficiently enough for his words of "flattery" and putting lipstick on this pig!



The sheer blatant hypocrisy of the UN COP28 Summit was visible in their message to attendees, the ongoing United Nations COP28 climate summit in Dubai is offering a wide variety of gourmet food options from vendors who serve beef, even as it prepares a report that is expected to call for the West to reduce consumption of beef.

According to the summit's online portal, its food offerings include "juicy beef," "slabs of succulent meat," smoked wagyu burgers, Philly cheesesteaks and "melt-in-your-mouth BBQ" in addition to African street BBQ, fast casual Mexican fare and an Asian option that has a "touch of French flair." The revelation comes as the U.N. faces criticism for preparing a first-of-its-kind report that is expected to be published at the summit and call for lower meat consumption.

A coalition of more than 1,600 scientists, including Nobel winners, recently debunked the idea that climate change – or global warming as it was known before the warming stopped – is a worldwide emergency. The declaration from scientists from all around the globe said simply, "There is no climate emergency." The statement is from CLINTEL, the Global Climate Intelligence Group.

The statement that left no room for qualifiers, it said there's "no evidence of a climate emergency in the record to date. No evidence."

So in a move that obviously defies the science, a coalition of national representatives attending a new climate conference adopted a plan to transition away from fossil fuels, entirely.

Reuters, which adopted the failed ideology that using fossil fuels will bring on a "climate catastrophe," said the officials from nearly 200 nations agreed "to begin reducing global consumption of fossil fuels."

The report cited "scientists" saying that's the best hope to avoid a worldwide cataclysm. Sultan al-Jaber, the chief of the COP28 conference, said, "We must take the steps necessary to turn this agreement into tangible actions."

Espen Barth Eide, of Norway, suggested it was the "first time that the world unites around such a clear text on the need to transition away from fossil fuels."

The move was opposed by members of the Organization of the Petroleum Exporting Countries, nations that control nearly 80% of the world's proven oil reserves along with about a third of global oil output.

John Kerry, Joe Biden's hand-selected climate envoy, said, "This is a moment where multilateralism has actually come together and people have taken individual interests and attempted to define the common good."

He's long advocated for faith in the green ideology, but justified his own global travel in emissions-spewing jets as necessary.

The plan demands "transitioning away from fossil fuels in energy systems, in a just, orderly and equitable manner ... so as to achieve net zero by 2050 in keeping with the science," although that statement actually conflicts with much of the science about global warming available now.

Former U.S. vice president Al Gore, for example, repeatedly has made claims about the dire situation caused by global warming, and repeatedly his predictions, such as that the polar cap would be ice-free, have failed to materialize.

Gore praised the agenda, but said more needs to be done, as "The influence of petrostates is still evident in the half measures and loopholes included in the final agreement."


