Canada to Mandate WEF's Digital ID System for Public

Canada has just signed an agreement to mandate the World Economic Forum's (WEF) digital ID system for all members of the public.

The system will be necessary for those who wish to participate in society.

Canada's WEF-tied Prime Minister Justin Trudeau, a proponent of centralized control, has finalized a controversial collaborative digital partnership with the European Union.

The digital ID will also be integrated with a coming single digital currency.

The Central Bank Digital Currency (CBDC) will allow the government to track and monitor individuals' spending while the ID logs their movements.

This agreement exhibits a full commitment to the introduction of a digital identity system in Canada.

The liberal government is pursuing it, in part, under the guise of fighting online “disinformation.”

The Trudeau government’s announcement delineates the terms of the Canada-EU Digital Partnership, which aims not only to institute digital credentials for Canadians but also to bolster cooperation in the field of artificial intelligence (AI).

The contentious partnership insists on a joint effort from Canada and the EU to bolster their respective bilateral and multilateral cooperation in forums like the G7 and the G20. The announcement states:

“The Digital Partnership will allow Canada and the EU to have a stronger common voice in multilateral fora, where appropriate, and bring jointly developed solutions to international partners and advance our joint strategic priorities.”

The G20, an influential conglomerate of the globe’s 19 major countries and the EU, has previously encouraged exploring the creation of “digital public infrastructure.”

This includes digital identification systems and integration with a centralized digital currency.

This “digital public infrastructure” phrase is the same buzzword being used by the likes of The WEF, Gates Foundation, and the UN.

It is often used when it comes to pushing digital ID and payment systems.

Biden's Executive Order Calls for 'Highest Urgency' on CBDC Research and Development

The president has called on the Treasury Department to spearhead a series of reports looking into CBDC technologies and how to implement them – *"if doing so is deemed to be in the national interest."*

U.S. President Joe Biden called for an urgent, government-wide focus to be placed on the research and development of a potential central bank digital currency ([CBDC](#)) in his executive order [signed](#) Wednesday.

The [order](#) calls for a full-scale assessment of the potential benefits and risks of a CBDC, both for consumers and investors as well as the broader U.S. financial system. Biden has ordered the Treasury Department to spearhead the research and report, with input from other federal agencies, including the Secretary of Commerce and the Secretary of Homeland Security.

The assessment is also supposed to determine whether the implementation of a CBDC would be in "the national interest."

There are several organizations already researching and piloting CBDCs in the United States, including the Boston Fed, which has partnered with Massachusetts Institute of Technology (MIT) on CBDC technology, and the Digital Dollar Project, a public-private partnership founded by consulting firm Accenture and Chris Giancarlo, the former chairman of the Commodity Futures Trading Commission (CFTC).

However, U.S. efforts have moved noticeably slower than those in other countries, including China, whose digital yuan is already being piloted in cities across the country. The order suggests that Biden – who noted that "over 100 countries are exploring or piloting" CBDCs – does not want the U.S. to get left behind.

David Treat, global blockchain lead at Accenture, told CoinDesk that the government will need to work with industry leaders if it wants to get things done right – and quickly.

“The executive order catalyzes the important work to pilot, test and advance the development of a CBDC,” Treat said. “We are excited about the pilot programs that the Digital Dollar Project will launch with our multi-stakeholder community.”

The Digital Dollar Project has promised five [pilot projects](#), which are planned to kick off in the coming months, to evaluate whether and how a U.S. CBDC would benefit people who are unbanked (or underbanked) – a key point stressed in Biden’s executive order.

Jim Rickards, a highly respected financial writer/author weighed in on the CBDC and provides the most honest and comprehensive evaluation of the CBDC. Consider that Canada made it mandatory for all Canadian citizens to accept the CBDC in order to participate in society. The Liberty Counsel said the following:

The Biden administration is working with the Federal Reserve (the Fed) to develop a replacement for paper and coin currency. The Fed plans to issue what is known as a “Central Bank Digital Currency” or CBDC, which some call “FedCoin.”

CBDC will effectively turn the government into a commercial bank — the bank to replace all banks, if you will. Once the government becomes your bank, it will control every purchase you make.

A CBDC gives governments the ability to erase bank accounts of political enemies, and control where people are allowed to shop and what they are allowed to buy.

A CBDC can even put an “*expiration date*” on funds, forcing people to spend money or the government simply takes it away. The Chinese Communist Party (CCP) has already

issued its CBDC, called the digital yuan, and uses it as part of its social credit score that regulates people at home and around the world.

Further, when the government is your direct bank, it can withhold home loans, auto financing, and other fiscal instruments, not because of your credit, but because of your political inclinations or your poor social score for not supporting green initiatives and progressive ideals. If you want to buy a gas vehicle rather than an EV, you could be blocked. If you want to buy a handgun, your transaction could be halted.

CBDC allows the government to individually monitor and control your purchases — and even your contributions.

Some members of Congress are alarmed by this shocking attempt to rob Americans of their most basic privacy. Rep. Tom Emmer (R-MN) and Sen. Ted Cruz (R-TX) have filed HR 1122 and S 887 respectively, to stop this federal power grab.

HR 1122 co-sponsor Byron Donalds (R-FL) says, *“As the Federal Reserve continues its study of central bank digital currencies, one thing has become clear — CBDCs pose a clear threat to Americans’ financial independence. Rather than following the lead of oppressive regimes like China and Russia, we should dramatically decrease the federal government’s involvement in personal finances and look to the free market to guide the way regarding innovation. That’s why I’m proud to support Congressman Emmer’s CBDC Anti-Surveillance State Act which prevents the issuance of a retail CBDC and ensures the Fed stays within its statutory bounds.”*

Rep. Warren said, *“A retail CBDC would essentially allow the government to mediate all transactions, which would mirror what we see in China. It’s vital to ensure this does not happen here.”*

Sen. Cruz said, *“The federal government has no authority to unilaterally establish a central bank currency. This bill goes a long way in making sure big government doesn’t attempt to centralize or control cryptocurrency.”*

During the COVID shutdowns, we bore witness, and in some states been held hostage by government agencies that sought to dictate where and how we could eat, shop, and worship.

Remember when the City of Los Angeles threatened to cut the power and water if a certain church would not forfeit its First Amendment right to worship? Under a CBDC, the government could simply freeze or erase the church’s bank accounts.

My Redeemer awaits.

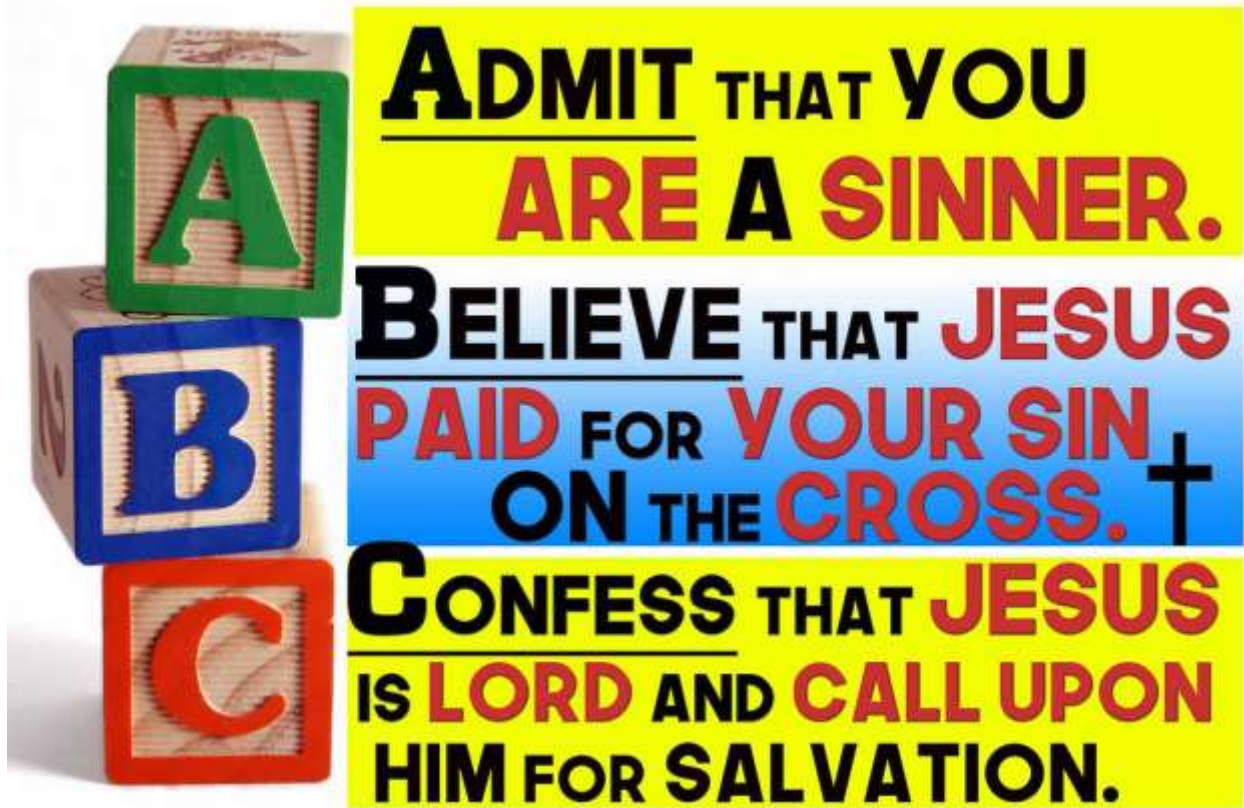
And I feel His Spirit rise up within me each day
