

But its unlikely Francis would be interested. He is more interested in overruling God's word and eradicating Christianity in favor of what he calls "Chrislam."



'Unlabeled and Unregulated': Synthetic Milk Protein with 92 Unknown Compounds Used by More Than a Dozen Food Brands

Testing by the Health Research Institute found 92 unknown compounds in Bored Cow's synthetic milk — produced from a "form of genetic engineering" — in addition to significant nutrient deficiencies. Over a dozen companies use similar formulations in products like cream cheese, smoothies and ice cream.

Recent testing revealed 92 unknown molecules — and a fungicide — in "synthetic" milk now sold in common grocery chains, according to the Health Research Institute (HRI).

The product, sold by <u>Bored Cow</u>, uses a fake whey protein called "ProFerm" made by <u>biotech company and partner</u> Perfect Day. <u>Perfect Day</u> uses genetically modified "<u>microflora</u>" to produce the synthetic milk protein.

According to Bored Cow, their product is a new kind of *"animal-free"* milk alternative *"made with real milk protein from fermentation."*



<u>HRI</u>, a nonprofit independent lab based in Fairfield, Iowa, examined multiple samples of Bored Cow's *"original"* flavor milk using <u>mass spectrometry</u> to test the claim that the synthetic protein it contained was the same as real milk protein.

Synthetic milk has never before been consumed by humans and has not undergone safety testing by the U.S. Food and Drug Administration (FDA), according to HRI's Chief Scientist and CEO John Fagan, Ph.D.

The testing results have yet to be published, but Fagan shared a few highlights with <u>'The Defender'</u>, including that the synthetic milk lacked many important micronutrients found in natural milk such as an omega-3 fatty acid, vitamin E and some B vitamins. It also contained a host of compounds that could be harmful to human health, Fagan said.

This news comes as <u>Italy last month banned</u> the sale of synthetically-produced meat, making it the <u>first country to ban synthetic food</u>, according to the <u>Organic Consumers</u> <u>Association</u>.

Fagan — a molecular biologist and former cancer researcher at the National Institutes of Health — has been a worldwide pioneer in testing genetically modified organisms (GMOs).

Commenting on his lab's findings, he told The Defender, *"The 92 unknown molecules we found have never been studied by scientists. So we don't know whether they're safe or dangerous, whether they are nutrients or toxics."*

Only eight compounds were identifiable. The rest were *"uncharacterized"* by scientific literature. Fagain explained:

"In any natural material, you're going to probably find a majority of compounds that science has not studied."

"Human beings have this arrogant idea that they know everything, but in fact, we know just a little fragment of what there is to know about the living world ..."

"[For example, a sample of] wheat will have many compounds that are unknown to science. But the difference is that you and I — our ancestors going back 4,000 years — have been eating wheat. And so we know from traditional use that whatever's in wheat, it's safe for us to eat."

"We can't say that about the synbio milk. It's what is called, in Europe and in Canada, a '<u>novel food</u>.'"

Such countries require that novel foods be tested for safety before they're put on the market, he added, but not the U.S.

Fagan said he found it concerning that the Bored Cow samples contained a pesticide — a fungicide called <u>Benthiavalicarb-isopropyl</u>.

"I think the reason this fungicide is present is because they added it to the fermentation process to inhibit the growth of fungi that could contaminate the production system," he said, *"So the things that we see here are not really good for us, let me put it that way."* HRI compared these results to samples of natural milk from grass-fed cows.

69 important nutrients in natural milk absent in synthetic milk

"There were 69 important nutrients present in natural milk, most of which were completely absent in synbio milk. A few were present in small or trace amounts," Fagan said.

For example, Bored Cow's milk only had a trace of <u>riboflavin</u>, known as vitamin B2, while natural milk has very high levels, he said. <u>Pantothenic acid</u>, known as vitamin B5, was *"absolutely absent in the synbio milk."*

Similarly, vitamin E was *"essentially absent yet present in substantial levels in natural milk,"* he said.

Additionally, forms of <u>carnitine</u> that are "really important for energy metabolism" were either missing or only present in trace amounts in the synbio product, he said.

The synthetic milk had *"only a tiny trace of the important omega-3 fatty acid <u>alpha-</u> <u>linolenic</u>."*

Alpha-linolenic acid is *"the most abundant omega-3 fatty acid in plants."* Natural milk from grass-fed cows typically has *"significant levels"* of it, Fagan explained.

Fagan added that "a number of other lipids or fats — diglycerides and mono and triglycerides — were undetectable in the synbio milk."

These results contradict Perfect Day's claim that its product — used by Bored Cow — is "identical to what cows make."

Industry calls it 'precision fermentation' rather than 'genetic engineering' Bored Cow is one of at least ten <u>companies selling "synthetic"</u> or "synbio" dairy products.

"Synbio" — short for "synthetic biology" — is a method that uses genetic engineering to modify microorganisms like yeast, algae or bacteria to produce novel products, according to the Non-GMO Project.

The <u>Non-GMO Project</u> said, "The biotechnology industry is marketing this method as '<u>precision fermentation</u>' because it exploits a natural process ... but it's actually a form of genetic engineering."

Indeed, Perfect Day avoids describing its production process as involving "GMOs" and, instead, explains on its website "how we teach microflora to create sustainable protein."

Meanwhile, critics — including groups like the nonprofit <u>GMO/Toxin Free USA</u> that consider the product to be GMO — say synbio milk needs to undergo safety testing before the FDA allows it to be sold.

GMO/Toxin Free USA released a <u>list of 12 brands</u> they found to include synbio milk in their products, such as alternative dairy ice cream, milk, whey protein and cream cheese.

In addition to Bored Cow, the brands were Brave Robot, Nick's, Coolhaus, Strive Nutrition, Nestle Cowabunga, Whey FWRD, JuiceLand, Apollo, Modern Kitchen, Nurishh and Mars CO2COA.

The Non-GMO Project <u>named more companies</u>, including The Urgent Company, California Performance Co. and Betterland Foods. Even <u>General Mills now sells</u> <u>products</u> made with synbio milk, according to Bored Cow.

Perfect Day also lists <u>partnerships with Nestlé</u>, Mars, Myprotein, Renewal Mill and Bel Group.

GMO/Toxin Free USA said, *"This is yet another <u>corporate attempt to use Americans as</u> <u>their lab rats</u>. NO THANK YOU."*

Experts Warn - WEF's Net Zero Goals Will Kill 4+ Billion People.

The World Economic Forum (WEF) and its fellow unelected globalist leaders are pushing for governments around the world to phase out fossil fuels. Leading experts have spoken out against their plans and are warning the public that the WEF's "Net Zero" goal to eliminate fossil fuels will result in the deaths of over four billion people or more.

The "Net Zero" target to end fossil fuel use is part of the WEF and UN's "Agenda 2030" and "Agenda 2050" plans for humanity and involves dramatically reducing fossil reliance by 2030 and completely eliminating their use by 2050.

The WEF continues to push its agenda and has been calling for taxpayers worldwide to pay \$3.5 trillion per year, which they insist is necessary to fund the noble global power in order to meet the globalist organization's *"Net Zero"* goal of "decarbonizing" the planet.

However, critics argue that "decarbonization" is just a euphemism for the WEF's <u>anti-human agenda</u> and experts are raising the alarm about what this will actually mean for civilization, which includes the death of over four billion people.

Starvation

Danish statistician Bjørn Lomborg is just one who has warned that ending fossil fuel use will lead to the deaths of around half of the world's population through starvation alone.

"4 billion people are dependent on fossil fertilizer for food," Lomborg notes. "Without, 4 billion will starve to death. "It is time to call out the astoundingly destructive & misanthropic campaigners," he declared.

The article Lomborg was responding to was by British economist Neil Record in the *'Telegraph'*, who argued that the number of people that might die was closer to six billion.

Six Billion Would Die in a Year.

Neil Record <u>reported:</u> "If we literally just stopped using fossil fuels and "did without the natural resources on which the world, its economies and populations depend, most likely six billion people would die within a year."

Breaking down what would happen in a world without fossil fuels, Record notes that most people would suffer blackouts due to the grid being so seriously compromised, possibly fatally, and they may be widespread and permanent.

From day one, gas users would be the first to feel the change of no more mining of coal; the world's <u>oil wells shut down</u>; the world's gas fields likewise, and in 10 or 15 days, the UK would have to turn off its gas distribution system as it would be unable to maintain pressure.

In turn, the domestic supply would be shut down too – gas would stop flowing, and some 21 million households (74% of the population) would no longer have heating, hot water, and cooking facilities.


"In their panic, people might turn to electricity for their cooking and heating, but wait..." says Record, who adds, "The <u>UK electricity grid relies on natural gas as its</u> "buffer" energy source. Every day, demand varies according to consumer demand, and the other main energy supplier, renewables, are highly variable and can only power the grid when gas is picking up the lion's share of the gap between their output and consumer demand."

So the moment that the main gas distribution system is de-pressurized, the gridbalancing system fails and power cuts ensue.

Electricity demand would have rocketed through the switch to electric space heating, cooking and water-heating, and so it seems very likely that the sudden excess demand would be undeliverable, and therefore that the grid would spiral into uncontrollability resulting in no electricity. This also means there would be no communication systems no mobile phones and no television.

Without power, there will be no running water and no heating and the most vulnerable people will start to die, according to Record. Initially, this will be the elderly in their own homes, then in hospitals when the diesel backup generators run out of fuel. Within the

first 25 days new "existential problems emerge for ordinary people in the form of food availability and distribution."

Starvation Begins From **Day 25**

Day 25 – By the twenty-fifth day, diesel and petrol are likely to have run dry, although, Record says that he is probably being generous with the timing here, but what this will mean is that food distribution would fail, and so as most of the population are entirely dependent on bought food they will begin to starve.


Interestingly, it will be only the isolated rural communities, and those who are agriculturally self-sufficient would be relatively unaffected.

Day 50 – Many people in urban areas would now be near death from starvation, Record claims, and *"law and order would have broken down"* and due to the *"increasingly desperate search for the means of survival"* he suspects there will have been *"mass conflict and slaughter taking place."*

Without the sanitary conditions that we have due to power, water supply, and sewage flow, we will see a return of Victorian diseases such as cholera and dysentery.

Day 100 – money and status will be irrelevant as time passes and just three months after the world stops oil, Neil Record, guesses that around half of the world's population of approximately four billion, people would be dead *"The first to die would be the urban poor; then the middle and upper classes"*

Again, the survivors would be those in rural areas and able to live off local agricultural produce or live off dwindling food stocks.

For fifty-five percent of people in urban areas, it will be almost impossible to access food and safe water as there will be none of the normal distribution routes for food or storage facilities (chillers/freezers) without electricity, and without pumped water, clean water would be unavailable, or close to impossible to access. <u>Source</u>

A Year Without Oil – Murder and Mayhem.



Forty-six-percent of the mothers (124) exposed to the Pfizer Covid-19 injection suffered an adverse reaction.

Of those 124 mothers suffering an adverse reaction, 49 were considered non-serious adverse reactions, whereas 75 were considered serious. This means 58% of the mothers who reported suffering adverse reactions suffered a serious adverse event ranging from uterine contraction to foetal death.

- 146 non-serious mother cases reported exposure to vaccine in utero without the occurrence of any clinical adverse event. The exposure PTs coded to the PTs Maternal exposure during pregnancy (111), Exposure during pregnancy (29) and Maternal exposure timing unspecified (6). Trimester of exposure was reported in 21 of these cases: 1st trimester (15 cases), 2nd trimester (7), and 3rd trimester (2).
- 124 mother cases, 49 non-serious and 75 serious, reported clinical events, which occurred in
 the vaccinated mothers. Pregnancy related events reported in these cases coded to the PTs
 Abortion spontaneous (25), Uterine contraction during pregnancy, Premature rupture of
 membranes, Abortion, Abortion missed, and Foetal death (1 each). Other clinical events which
 occurred in more than 5 cases coded to the PTs Headache (33), Vaccination site pain (24),
 Pain in extremity and Fatigue (22 each), Myalgia and Pyrexia (16 each), Chills (13) Nausea
 (12), Pain (11), Arthralgia (9), Lymphadenopathy and Drug ineffective (7 each), Chest pain,
 Dizziness and Asthenia (6 each), Malaise and COVID-19 (5 each). Trimester of exposure was
 reported in 22 of these cases: 1st trimester (19 cases), 2nd trimester (1 case), 3rd trimester (2
 cases).

A total of 4 serious foetus/baby cases were reported due to exposure to the Pfizer injection.

4 serious foetus/baby cases reported the PTs Exposure during pregnancy, Foetal growth
restriction, Maternal exposure during pregnancy, Premature baby (2 each), and Death neonatal
(1). Trimester of exposure was reported for 2 cases (twins) as occurring during the 1st
trimester.

But here's where things get rather concerning. Pfizer state that of the 270 pregnancies they have absolutely no idea what happened in 238 of them.

But here are the known outcomes of the remaining pregnancies -

There were 34 outcomes altogether at the time of the report, but 5 of them were still pending. Pfizer note that only 1 of the 29 known outcomes were normal, whilst 28 of the 29 outcomes resulted in the loss/death of the baby. This equates to 97% of all known outcomes of Covid-19 vaccination during pregnancy resulting in the loss of the child.

When we include the 5 cases where the outcome was still pending it equates to 82% of all outcomes of Covid-19 vaccination during pregnancy resulting in the loss of the child. This equates to an average of around 90% between the 82% and 97% figure.

So here we have our first piece of evidence that something is amiss when it comes to administering the Pfizer Covid-19 injection during pregnancy.

Here's the guidance taken from the UK Government's '**REG 174 INFORMATION FOR UK HEALTHCARE PROFESSIONALS**' document –

'Pregnancy

There are no or limited amount of data from the use of COVID-19 mRNA Vaccine BNT162b2. Animal reproductive toxicity studies **have not been completed**. COVID-19 mRNA **Vaccine**

BNT162b2 is not recommended during pregnancy.

For women of childbearing age, pregnancy should be excluded before vaccination. In addition, women of childbearing age should be advised to **avoid pregnancy for at least 2 months after** their second dose.

Breast-feeding

It is unknown whether COVID-19 mRNA Vaccine BNT162b2 is excreted in human milk. A risk to the newborns/infants cannot be excluded. COVID-19 mRNA Vaccine BNT162b2 should not be used during breast-feeding.

Fertility

It is unknown whether COVID-19 mRNA Vaccine BNT162b2 has an impact on fertility.'

That's how the guidance read in December 2020 anyway. Unfortunately, just a month or so later, the UK Government and other Governments around the world revised that guidance to read as follows –

4.6 Fertility, pregnancy and lactation

Pregnancy

There is limited experience with use of the COVID-19 mRNA Vaccine BNT162b2 in pregnant women. Animal studies do not indicate direct or indirect harmful effects with respect to pregnancy, embryo/foetal development, parturition or post-natal development (see section 5.3). Administration of the COVID-19 mRNA Vaccine BNT162b2 in pregnancy should only be considered when the potential benefits outweigh any potential risks for the mother and foetus.

Breast-feeding

It is unknown whether the COVID-19 mRNA Vaccine BNT162b2 is excreted in human milk.

Fertility

Animal studies do not indicate direct or indirect harmful effects with respect to reproductive toxicity (see section 5.3)

This is still the official guidance as of June 2022, and leads to several questions requiring urgent answers when we consider since early 2021 pregnant women have been told Covid-19 vaccination is perfectly safe.

You only have to look at the things women were told to avoid during pregnancy prior to being told it's perfectly safe to take an experimental injection to realise something just isn't right here –

- Smoked fish,
- Soft cheese,
- Wet paint,
- Coffee,
- Herbal tea,
- Vitamin supplements,
- Processed Junk foods.

These are just to name a few, and the list is endless.

So let's start with the 'Pregnancy' section of the official guidance. In December 2020 the guidance stated '*Covid-19 vaccination is not recommended during pregnancy*'. Just a month or so later this guidance stated '*Animal studies do not indicate harmful effects with respect to pregnancy etc.*'

So let's take a look at the animal studies in question.

But before we do it's worth pointing out that the official guidance states, as of June 2022, that 'administration of the COVID-19 mRNA Vaccine BNT162b2 in pregnancy should only be considered when the potential benefits outweigh any potential risks for

the mother and foetus'. So why on earth has every single pregnant woman up and down the land been actively coerced into getting this injection?

Pfizer and Medicine Regulators hid dangers of Covid-19 Vaccination during Pregnancy due to Animal Study finding an increased risk of Birth Defects & Infertility

The limited animal study talked about in the official guidance actually uncovered the risk of significant harm to the developing foetus, but medicine regulators in the USA, UK and Australia actively chose to remove this information from public documents.

The actual study can be viewed in full <u>here</u> and is titled '<u>Lack of effects on female</u> fertility and prenatal and postnatal offspring development in rats with BNT162b2, a <u>mRNA-based COVID-19 vaccine</u>'.

The study was performed on 42 female Wistar Han rats. Twenty-one were given the Pfizer Covid-19 injection, and 21 were not. Here are the results of the study – <u>Source</u>

The results of the number of foetuses observed to have supernumerary lumbar ribs in the control group were 3/3 (2.1). But the results of the number of foetuses to have supernumerary lumbar ribs in the vaccinated group were 6/12 (8.3). Therefore on average, the rate of occurrence was 295% higher in the vaccinated group.

Supernumerary ribs also called accessory ribs are an uncommon variant of extra ribs arising most commonly from the cervical or lumbar vertebrae.

So what this study found is evidence of abnormal foetal formation and birth defects caused by the Pfizer Covid-19 injection.

But the abnormal findings of the study don't end there. The 'pre-implantation loss' rate in the vaccinated group of rats was double that of the control group.

<u>Source</u>

Pre-implantation loss refers to fertilised ova that fail to implant. Therefore, this study suggests that the Pfizer Covid-19 injection reduces the chances of a woman being able to get pregnant. So, therefore, increases the risk of infertility.

So with this being the case, how on earth have medicine regulators around the world managed to state in their official guidance that "Animal studies do not indicate direct or indirect harmful effects with respect to pregnancy"? And how have they managed to state "It is unknown whether the Pfizer vaccine has an impact on fertility"?

The truth of the matter is that they actively chose to cover it up.

We know this thanks to a 'Freedom of Information (FOI) request made to the Australian Government Department of Health Therapeutic Goods Administration (TGA).

A <u>document</u> titled '<u>Delegate's Overview and Request for ACV's Advice</u>' that was created on 11th January 2021 was published under the FOI request. Page 30 onwards of the <u>document</u> shows a 'review of the product information', and highlights changes that should be made to the 'Non-clinical evaluation report' prior to official publication.

The changes were requested to be made by Pfizer prior to the next product information update.

Some of those requested changes were as follows -

The Module 4 evaluator requested Pfizer remove their claim that "Animal studies do not indicate direct or indirect harmful effects with respect to reproductive toxicity".

Why?

The Module 4 evaluator told Pfizer that 'Pregnancy Category B2' was considered appropriate and requested that they added the following line –

"A combined fertility and developmental toxicity study in rats showed increased occurrence of supernumerary lumbar ribs in fetuses from COMIRNATY- treated female rats".

But here's a reminder of how the <u>official document</u> issued to the general public reads – <u>Source – Page 7</u>

The pregnancy category was changed to 'B1', no line was included on the increased occurrence of supernumerary lumbar ribs in fetuses, and they instead included the line that was requested to be removed claiming "*Animal studies do not indicate direct or indirect harmful effects with respect to pregnancy…*".

Here's the official description of the pregnancy categories – <u>Source</u>

That's quite a big difference between the two categories. But the fact that the Module 4 evaluator even thought Pregnancy Category B2 was appropriate is highly questionable when you consider the results, as we revealed above, of the "inadequate" and extremely small animal study that was performed to evaluate the safety of administering the Pfizer Covid-19 injection during pregnancy.

So not only do we have evidence that the Pfizer vaccine may cause between 82% and 97% of recipients to lose their babies, we also now have evidence that the Pfizer vaccine leads to an increased risk of suffering infertility or birth defects.

Both of these examples alone support the suggestion that Covid-19 vaccination is going to lead to depopulation. But unfortunately, the evidence doesn't end there.

Confidential Pfizer Documents reveal the Covid-19 Vaccine accumulates in the Ovaries

<u>Another study</u>, which can be found in the long list of confidential Pfizer documents that the FDA have been forced to publish via a court order <u>here</u>, was carried out on Wistar Han rats, 21 of which were female and 21 of which were male.

Each rat received a single intramuscular dose of the Pfizer Covid-19 injection and then the content and concentration of total radioactivity in blood, plasma and tissues were determined at pre-defined points following administration.

In other words, the scientists conducting the study measured how much of the Covid-19 injection has spread to other parts of the body such as the skin, liver, spleen, heart etc.

But one of the most concerning findings from the study is the fact that the Pfizer injection accumulates in the ovaries over time.

An 'ovary' is one of a pair of female glands in which the eggs form and the female hormones oestrogen and progesterone are made.

In the first 15 minutes following injection of the Pfizer jab, researchers found that the total lipid concentration in the ovaries measured 0.104ml. This then increased to 1.34ml after 1 hour, 2.34ml after 4 hours, and then 12.3ml after 48 hours.

The scientists, however, did not conduct any further research on the accumulation after a period of 48 hours, so we simply don't know whether that concerning accumulation continued.

But official UK data published by Public Health Scotland, which can be found <u>here</u>, offers some concerning clues as to the consequences of that accumulation on the ovaries.

Figures for the number of individuals suffering from ovarian cancer show that the known trend in 2021 was significantly higher than 2020 and the 2017-2019 average. Ovarian Cancer – <u>Source</u>

The above chart shows up to June 2021, but the charts found on Public Health Scotland's dashboard now show figures all the way up to December 2021 and unfortunately reveal that the gap has widened even further with the number of women suffering Ovarian cancer increasing significantly.

That concludes our third piece of evidence. So now we know –

• Confidential Pfizer documents show a miscarriage rate between 82 and 97%,

- The only animal study performed to prove the safety of administering the Pfizer vaccine during pregnancy indicated an increased risk of infertility and birth defects,
- and further confidential Pfizer documents reveal the vaccine accumulates in the ovaries.

Unfortunately, we also have evidence that Covid-19 vaccination increases the risk of newborn babies sadly losing their lives, and it also comes from the Public Health Scotland 'Covid-19 Wider Impacts' dashboard.

Newborn Baby Deaths hit critical levels for 2nd time in 7 Months in March 2022

<u>Official figures</u> reveal that the rate of neonatal deaths increased to 4.6 per 1000 live births in March 2022, a 119% increase on the expected rate of deaths. This means the neonatal mortality rate breached an upper warning threshold known as the 'control limit' for the second time in at least four years.

The last time it breached was in September 2021, when neonatal deaths per 1000 live births climbed to 5.1. Although the rate fluctuates month to month, the figure for both September 2021 and March 2022 is on a par with levels that were last typically seen in the late 1980s.

<u>Source</u>

Public Health Scotland (PHS) did not formally announce they had launched an investigation, but this is what they are supposed to do when the upper warning threshold is reached, and they did so back in 2021.

At the time, PHS said the fact that the upper control limit has been exceeded "*indicates* there is a higher likelihood that there are factors beyond random variation that may have contributed to the number of deaths that occurred".

Our final piece of evidence to support the claim that Covid-19 vaccination is going to lead to depopulation comes in the form of more real-world data, but this time from the USA.

Covid-19 Vaccination increases risk of suffering Miscarriage by at least 1,517%

According to the Centers for Disease Control's (CDC)) <u>Vaccine Adverse Event</u> <u>Database (VAERS)</u>, as of April 2022, a total of 4,113 foetal deaths had been reported as adverse reactions to the Covid-19 injections, 3,209 of which were reported against the Pfizer injection.

The CDC has admitted that just 1 to 10% of adverse reactions are actually reported to VAERS therefore the true figure could be many times worse. But to put these numbers into perspective, there were only 2,239 reported foetal deaths to VAERS in the 30 years prior to the emergency use authorisation of the Covid-19 injections in December of 2020. (Source)

And a further study which can be viewed <u>here</u>, found that the risk of suffering a miscarriage following Covid-19 vaccination is 1,517% higher than the risk of suffering a miscarriage following flu vaccination.

The true risk could however actually be much higher because pregnant women are a target group for Flu vaccination, whereas they are only a small demographic in terms of Covid-19 vaccination so far.

63,060% increase in Child Excess Deaths across Europe

Cambridge Scientists: 25% of Vaxxed Now Have VAIDS

"These findings were shared with medicines regulator MHRA around a year ago, the scientists say, and updated vaccines that use the improved form of mRNA are in the works for cancer jabs, and other therapeutics," the report adds.

Mainstream media outlets are working tirelessly to cover up the impact of the study.

A report from Science magazine has distorted the scientists' findings, asserting that the unintended proteins generated by the injections may not be inflicting any harm.

The estate is around 52,000 hectares (128,000 acres), spans across 20 counties in England and Wales (bizarrely most of it isn't actually in Cornwall) and consists of farmland, parts of Dartmoor national park, cricket grounds, and even a prison.



Prince William and Kate Middleton are now the Prince and Princess of Wales.

Charles was previously the Duchy of Cornwall for over five decades, making him the longest-serving Duke of Cornwall in history.

The ownership of the estate paid him £21 million (\$24m) in the last fiscal year.

The King voluntarily paid the top rate of income tax (45 percent) on the property. However, as the duchy is not considered a company according to tax laws, Charles didn't have to pay corporate or capital gains tax.

This has drawn criticism from the public and MPs alike and is particularly controversial as the estate owns land that used to be used for mining, and the duchy owns the mine's mineral rights.

Charles also set up a food company three decades ago, named Duchy Organics, which many argue connects the estate and title with the company. The brand was acquired by Waitrose and is now separate to the Duchy, but the controversy persists.

After acquiring the estate, William will now make all decisions on shaping its future. The new Prince of Wales released a moving tribute to his grandmother the Queen which read in part: "She was by my side at my happiest moments. And she was by my side during the saddest days of my life. I knew this day would come, but it will be some time before the reality of life without Grannie will truly feel real."

"I thank her for the kindness she showed my family and me. And I thank her on behalf of my generation for providing an example of service and dignity in public life that was from a different age, but always relevant to us all."
