Censored Study Exposes 17 Millions Deaths Among Vaxxed Hunter Fielding December 26, 2023

A groundbreaking study has revealed that 17 million people died worldwide after the Covid mRNA shots were rolled out to the public.

The shocking study *should* be garnering worldwide attention and calls for an immediate cessation of all Covid vaccines.

Instead, it has been censored.

The bombshell study, <u>COVID-19</u> vaccine-associated mortality in the Southern <u>Hemisphere</u>, by <u>Drs. Denis Rancourt</u>, <u>Marine Baudin</u>, Joseph Hickey and <u>Jérémie</u> <u>Mercier</u> was published September 17, 2023, yet, also shockingly the study has not had the attention it deserves, but, <u>has met only</u> censorship and narrative-confirming "fact-checks" on the safety and effectiveness of the as-yet untested Covid-19 "vaccines."

#### The Study

The team of doctors <u>studied</u> 17 countries across 4 continents, in Latin America and in the equatorial region which provided them with a representative sample of the world.

"We calculate the toxicity of the vaccine for all ages," explained Dr. Rancourt, "given the number of doses given worldwide to conclude that 17 million people would have been killed by this vaccine."

#### **17 Countries, 4 Continents**

The seventeen equatorial and Southern-Hemisphere countries studied: Argentina, Australia, Bolivia, Brazil, Chile, Colombia, Ecuador, Malaysia, New Zealand, Paraguay, Peru, Philippines, Singapore, South Africa, Suriname, Thailand, and Uruguay.




Figure 1: World map showing the 17 countries considered in the present study, in relation to the equator and the tropics — Argentina, Australia, Bolivia, Brazil, Chile, Colombia, Ecuador, Malaysia, New Zealand, Paraguay, Peru, Philippines, Singapore, South Africa, Suriname, Thailand, and Uruguay.

These countries, spanning across four continents comprise of 9.10% of the worldwide population, 10.3% of worldwide COVID-19 injections (vaccination rate of 1.91 injections per person, all ages), virtually every COVID-19 vaccine type and manufacturer.

#### **Covid Vaccines Had No Beneficial Effect.**

In the 17 countries, there is no evidence in all-cause mortality (ACM) by time data that there have been any beneficial effects from the COVID-19 vaccines and there is no association in time between COVID-19 vaccination and any proportionate reduction in all-cause mortality (ACM)

In fact, the opposite occurs. In all 17 countries, higher numbers are seen in all-cause mortality (ACM) when the COVID-19 vaccines are deployed and administered.

Nine of the 17 countries have no detectable excess ACM in the period of approximately one year after a pandemic was declared on the 11th of March 2020 by the World Health Organization (WHO), until the vaccines are rolled out (Australia, Malaysia, New Zealand, Paraguay, Philippines, Singapore, Suriname, Thailand, Uruguay). <u>Source</u>

#### **Boosters Boost All-Cause Mortality**

According to the research, there were "unprecedented peaks in ACM that occur in the summer (January-February) of 2022 in the Southern Hemisphere, and in equatorial-latitude countries. These peaks are synchronous with, or immediately preceded by rapid COVID-19-vaccine-booster-dose rollouts (3rd or 4th doses). The researchers say that this phenomenon is present in every case with sufficient mortality data, (Argentina and Suriname had insufficient mortality data in January – February 2022).

According to the doctors who conducted <u>the research</u> "it is unlikely that the transitions to regimes of high ACM, coincident with the rollout and sustained administration of COVID-19 vaccines, in all 17 Southern- Hemisphere and equatorial-latitude countries, could be due to any cause other than the vaccines."

#### Fatality Rate Increased with Age

The doctors state "synchronicity between the many peaks in ACM (in 17 countries, on 4 continents, in all elderly age groups, at different times) and associated rapid booster rollouts allows this <u>firm conclusion</u> regarding causality and accurate quantification of COVID-19-vaccine toxicity."

The all-ages vaccine-dose fatality rate (VDFR), which is the ratio of inferred vaccineinduced deaths to vaccine doses delivered in a population, is quantified for the January – February 2022 ACM peak to fall in the range of 0.02 % (New Zealand) to 0.20% (Uruguay).

In Chile and Peru, the vaccine Dose Fatality Rate increased exponentially with age (doubling approximately every 4 years of age), and is largest for the latest booster doses, reaching approximately 5% in the 90+ years age groups (1 death per 20 injections of dose 4). (Also comparable to results found in research of the Northern Hemisphere (India, Israel, and USA) according to the researchers.)

The team quantified the overall all-ages vaccine Dose Fatality Rate (VDFR) for the 17 countries to be  $(0.126 \pm 0.004)$  %, which would imply 17.0 ± 0.5 million COVID-19 vaccine deaths worldwide, from 13.50 billion injections up to 2 September 2023. Source

Rancourt *et al*, say that the deaths caused by the Covid vaccines "would correspond to a mass iatrogenic event that killed ( $0.213 \pm 0.006$ ) % of the world population.

**"1 death per 470 living persons, in less than 3 years** did not measurably prevent any deaths."

The <u>overall risk</u> of death induced by injection with the COVID-19 vaccines in actual populations, inferred from excess all-cause mortality and its synchronicity with rollouts, is globally pervasive and much larger than reported in clinical trials, adverse effect monitoring, and cause-of-death statistics from death certificates, by 3 orders of magnitude (1,000-fold greater).




Figure 3: (three panels) Covid-period excess ACM versus vaccination-period excess ACM (top), first expanded view (middle), second expanded view (bottom), with 1:1 line as a reference.

The results of Table 1 are illustrated in Figure 3. Here, the same colour coding of the symbols as for Table 1 is used: orange points for countries that have no apparent excess ACM prior to the start of vaccination, pursuant to Figure 2, and blue points for countries that exhibit excess ACM prior to the start of vaccination (and after a pandemic is declared on 11 March 2020).

#### To summarize:

In seventeen countries across four continents "Covid" had no excess all-cause mortality in the majority of them during the "pandemic," and therefore as would be expected in that case alone, the Covid vaccines had no beneficial effects, but have actually shown to cause a higher number of deaths following the vaccine rollout and administration.

The study has revealed that peaks were observed in all-cause mortality that also coincided with the rollout of booster vaccine doses three and four and there is no other likely reason for the higher number of deaths, than these booster vaccines.

In all of the 17 countries, across four continents, a peak occurred in the deaths of all elderly of all ages following the vaccine and elderly deaths caused by the vaccine increased exponentially doubling approximately every four years of age. This is not a coincidence.

They are now doing their very best to prevent the true evil of their actions from being known by everyone else.


#### END OF CYCLE FORMULA FOR THE 'VACCINATED'

In full transparency, Dr. Canderian is what I would call a "Genocidal Globalist," who follows Precept Ten of the Georgia Guidestones, which is very seldom discussed, stating,

"Be not a Cancer upon the Earth; Leave Room for Nature."

Dr. Canderian is a Medical Contributor to the World Health Organization (WHO) and is also very supportive of Klaus Schwab and the "Great Reset," ushering in one world digital currency which is a secondary goal of the WHO for 2022.

Dr. Canderian is of the opinion that 95% of the world's population are "Useless Eaters" who need to be euthanized as quickly as possible.

As I said, I have met him in Davos, Switzerland.



"There are big questions here about whether individuals will be able to refuse this technology if it is used in, for example, tracking devices."

<u>Klaus Schwab</u>'s right hand man, <u>Yuval Noah Harari</u>, says there is no question that individuals will have no say whatsoever about refusing this technology.

#### According to Harari,

"The designer of life will no longer be god... the WEF are going to be the designers of the future of life."

Harari also explains why Gates' patent on the human body is so important.

Gates was at the forefront of the computer science revolution, according to Harari, and he is also at the forefront of, *"the revolution in the biological sciences."*

agriculture) and his deep understanding of computers to make him the savior to all of humanity. We are his guinea pigs."

But if you think Bill Gates' plans for humanity are disturbing, wait until you meet the people he is collaborating with.

A controversial proposal by a New York University professor to combat Climate Change through biohacking has attracted the attention of World Economic Forum and the Gates Foundation.

**Matthew Liao**, a bioethicist at NYU, first presented the proposal in a <u>paper</u> he wrote in 2012.

Titled '<u>Human Engineering and Climate Change</u>', the crux of the paper argues for the use of radical biomedical interventions on humans so as to create people who are literally physiologically environmentally-friendly.

These biomedical interventions involve three approaches:

- a eugenics program against tall people
- inducing intolerance towards meat including beef, pork and chicken
- radically lowering birth rates by altering women's cognitive abilities...

Liao states that it's necessary to have a eugenics program that breeds tall people out of the population because the increase in human height over the past few centuries has had a negative environmental impact, because tall people consume more calories.

To carry out the eugenics program, Liao has two suggestions. The first one being the genetic screening of embryos before IVF implantation so that parents can have the option to choose children who are likely to be short and small.

Liao's second suggestion is even more radical, and involves injecting children with hormones to severely stunt their growth so they consume less calories when they are adults.

As for inducing *meat intolerance*, Liao uses the globalist elite's favorite excuse, <u>climate</u> <u>change</u>, to argue that we must make people allergic to meat, by stimulating the immune system against common bovine proteins.

This is taking authoritarianism to a whole new level, far surpassing anything attempted in **Mao**'s China or **Stalin**'s Russia.

He arrives at this conclusion by arguing that the more educated women become, the less children they have. "Women with low cognitive ability are more likely to have children before age eighteen," says Liao.

"Hence, another possible human engineering solution is to use cognition enhancements such as Ritalin and Modafinil to achieve lower birthrates."

When Liao published <u>his paper</u> almost a decade ago, it caused <u>controversy</u>, and was for the most part dismissed as eco-extremism, even by climate change activists.

But fast forward to the present day, and the extreme bioengineering proposals of the paper are being seriously discussed at the <u>World Economic Forum</u>.

Last year in December, in preparation for this year's <u>Davos Summit</u>, the World Economic Forum unveiled its bioengineering framework in a presentation called '<u>3</u> <u>Scenarios for How Bioengineering could Change our World in 10 Years</u>.'

Edible vaccines grown in plants and <u>CRISPR gene-editing</u> were some of the highlights of the framework. The presentation was based off a World Economic Forum sponsored academic paper called <u>Bioengineering Horizon Scan 2020</u>.

For this year's Davos Summit, Liao's human bioengineering paper was added to the 'Bioengineering Horizon Scan 2020' paper for both the,

- World Economic Forum's bioengineering framework
- Climate Change framework...

As radical as Matthew Liao's human bioengineering suggestions might seem, their consideration and deliberation by the World Economic Forum should come as no surprise.

# Official CDC Data: 143,233% Surge in Fatal Cancers Among Vaxxed Americans

Official data from the U.S. Centers for Disease Control and Prevention (CDC) has revealed an alarming spike in fatal cancers among Americans who have received Covid mRNA injections.

The data shows that cancer, the leading cause of death in the United States, has been soaring over the past two years.

However, the data shows a correlation between the rise in cancer and the public rollout of Covid mRNA shots.

The U.S. federal government's own official data confirms that the risk of developing cancer following Covid vaccination increases by a staggering 143,233%.

The CDC hosts a <u>Vaccine Adverse Event Reporting System (VAERS)</u>. The <u>VAERS</u> database contains historical data on adverse reactions reported against every vaccine that has been administered in the United States.

According to VAERS data analyzed by <u>The Exposé</u>, the number of cancer cases spikes dramatically among those vaccinated with the shots.

In the report, the outlet performed a <u>quick search</u> of the <u>CDC VAERS database</u> on the number of cancer cases reported as adverse reactions to the Covid injections since they were first rolled out in the United States.

This reveals that from December 2020 up to 5th August 2022, a total of 2,579 adverse events related to cancer were made in just 1 year and 8 months.

However, performing a <u>similar search</u> of the <u>VAERS database</u> on the number of cancer cases reported as adverse events to all other available vaccines between 2008 and 2020, a period of 13 years, reveals there were just 791 adverse events related to cancer.

Many would simply argue, without evidence, that this is just because of the volume of Covid injections administered compared to all other vaccines.

Unfortunately, anyone who argues this point is wrong.

We can see this by looking at the number of doses administered.

The following chart shows the total number of flu vaccine doses administered in 13 full flu seasons all the way from the 2008/2009 flu season to the 2019-2020 flu season.

The data has been extracted from the CDC info found here.

In all between the 08/09 flu season and the 19/20 flu season, there were a total of 1,720,400,000 (1.7204 billion) doses of the flu jab administered in the USA.

The CDC also confirms that between 2008 and 2020, a period of 13 years, there were just 64 events related to cancer reported as adverse reactions to the influenza vaccines.

Based on the number of adverse events related to cancer alone, we can see that there have been 40.3x as many cancer cases related to Covid-19 vaccination as there have been related to flu vaccination.

However, this statistic doesn't properly represent the severity of the situation.

To do that we need to know the number of cancer cases per 100,000 doses administered.

Based on the above numbers provided by the CDC, the number of adverse events related to cancer reported per 100,000 doses of flu vaccine administered equates to just 0.0003 per 100,000 doses.

According to <u>"Our World in Data</u>," as of 9th August 2022, 606 million doses of the Covid-19 vaccines have been administered in the USA.

This means there have been nearly 3 times as many flu vaccines administered between 2008 and 2020 than Covid-19 injections since the end of 2020, let alone all of the other vaccines that have been administered.

Therefore, the number of adverse events related to cancer reported per 100,000 doses of Covid-19 vaccine administered equates to 0.43 per 100,000 doses.

This means Covid vaccination is 1433.33x / 143,233.33% more likely to cause cancer than flu vaccination.

It can be argued that because the numbers are so extraordinarily low for the flu vaccine, that it does not cause cancer.

Therefore, it can be argued that the risk of developing cancer following Covid vaccination is 1433x greater than the background risk.

This should however not come as much of a surprise considering we already have scientific proof that the Covid mRNA injections can cause cancer of the ovaries, pancreas, and breast.

The homologous recombination DNA repair pathway is one of the mechanisms that the body uses to stop your cells from turning cancerous in response to environmental stress.

In October 2021, two revered scientists, Jiang and Mei, published a peer-reviewed study paper in <u>MDPI</u>.

The study shows that the SARS-Cov-2 spike protein obliterated the DNA repair mechanism in lymphocytes.

The viral spike protein was so toxic to this pathway that it knocked 90% of it out.

If the whole spike protein got into the nucleus (in the ovaries), and enough of it was produced and hung around long enough before the body was able to get rid of it all, it would cause cancer.

Fortunately, in the case of natural infection, this is unlikely to occur.

However, the mRNA shots induce spike protein to be produced in and around the cell nucleus and this occurs for at least 60 days and almost certainly longer.

This is probably why cases of ovarian cancer are now at an all-time high.

Official UK data published by Public Health Scotland, which can be found <u>here</u>, reveal the number of women suffering from ovarian cancer from the introduction of the Covid-19 injection to the general population.

Unfortunately, the <u>known trend</u> in 2021 was significantly higher than 2020 and the 2017-2019 average.

The above chart shows up to June 2021, but the charts found on Public Health Scotland's dashboard now show figures all the way up to December 2021.

Unfortunately, the data reveals that the gap has widened even further with the number of women suffering from Ovarian cancer increasing significantly.

The news comes as experts have been <u>raising the alarm</u> of a disturbing upward trend in cancers <u>across America</u> and beyond.

During a recent testimony, Dr. Robert Malone, one of the inventors of mRNA vaccine technology, produced patent documentation showing that pharmaceutical companies are aware their Covid shots cause cancer.

As Slay News <u>reported</u>, Malone testified during a hearing on Capitol Hill led by Republican Rep. Marjorie Taylor Greene (R-GA).

During his testimony, Malone presented the patent for Moderna's Covid vaccine.

Moderna's patent shows that its COVID-19 vaccine vials contain billions of DNA fragments.

Those fragments, along with other contaminants, are linked to birth defects and cancer. In the patent, Moderna admits that contaminants in the shots cause cancer.

However, as Malone highlights in his testimony, the U.S. Food and Drug Administration (FDA) apparently ignored this admission when approving the shots for public use.

The failure raises major concerns, especially as several top FDA officials secured highpaying jobs with Moderna after they approved the injections, as Slay News <u>reported</u>.

During the hearing, Dr. Malone highlighted that Moderna acknowledges in its patent that RNA is preferable to DNA in vaccines.

"Moderna has a patent on the use of RNA for vaccines," Malone told the hearing.

"And in that, Moderna explicitly acknowledges that RNA is superior to DNA for vaccine purposes because of problems, including the possibility of insertional mutagenesis that could lead to the activation of oncogenes or the inactivation of tumor suppressor genes."

"FDA says they're not aware of any concerns, but Moderna in its own patent lays out exactly the same concerns that exist about DNA in insertional mutagenesis and genotoxicity."

"So, Moderna knows it – DNA is a contaminant.

"[DNA] is left in because of the way they make it."

Dr. Malone goes on to explain how the DNA contamination in the shots causes cancer.


Malone warned that those who have received the mRNA injections would likely <u>be at</u> risk from *"anything that is associated with DNA damage."*
