## **“We Have Reached A Breaking Point”**

If you don't have a border, you don't have a country. It certainly wouldn't be a surprise to hear me say that our immigration crisis has brought us to “a breaking point”, but those aren't my words. As you will see below, the mayor of New York City is actually saying this. During the Biden administration, the floodgates have opened and vast hordes of illegal immigrants are pouring into this country every single day. New York City, Chicago and other major urban areas simply do not have enough resources to take care of the illegal immigrants that have already arrived, but more just keep on coming.

The tsunami of humanity that is coming over our borders has become so extreme that even CNN is reporting on it now...

Brian Silvas' three dogs were usually the first to alert him that large groups of people were walking onto his San Diego County property. He'd wake up at all hours to Whisky, Soldier and Freedom barking incessantly. Today, the trio keep quiet most of the night. While the crowds of migrants have not stopped passing through, it's become so common that the dogs now sleep through it.

*“This country was built on immigration. I'm fine with that,” Silvas said. “But not like this. This is ridiculous.”*

Silvas is beyond frustrated, and he told CNN that if he had enough money he would *“build my own wall right here”*.

CNN interviewed the owners of another property about five miles away who say that all of their trees are gone because illegal immigrants have chopped them all down to use in their campfires...

About five miles east of Silvas' property, along the same southern border, Jerry and Maria Shuster are experiencing a similar crisis. Except the migrants who cross there are not just passing through their land – they're also camping out. Tents, discarded clothes and trash are scattered across parts of their 17-acre property. There are several campfires burning at night as the migrants try to keep warm in the near freezing temperatures, as they make their way to various gathering spots along the U.S. side and await officials with the U.S. Customs and Border Protection.

*"(My trees) are all gone. They chop them up and put them in the fire,"* said Jerry Shuster, who alleges one group of migrants broke a wood fence on his property to fuel their fire.

Did you ever imagine that CNN would publish such an article?

And CNN is actually admitting that most illegal immigrants actually *"run to authorities"* once they reach U.S. soil...

For years, migrants who crossed illegally into the United States would often run away from law enforcement, but now once reaching the U.S. most run to authorities, according to observers. They're eager to be processed, knowing that they will likely be released in a few days to await court dates that could be years away.

Our once proud Border Patrol officers have been transformed into customer service agents for those seeking asylum.

Instead of enforcing our laws, they have been relegated to facilitating a systematic invasion of our country.

### **From the archives of Pastor Bob’s Studies on Deliverance before Judgment / Pre-Tribulation Rapture Why the Rapture Occurs Before the Revealing of the Antichrist!**

Critics of the Pre-Tribulation Rapture frequently challenge believers, stating that Jesus never mentioned anything about the Rapture. Instead they proceed to build a case declaring there will be no Rapture. But, this stance uses false logic. Anyone who has studied “logic” in college can refute this erroneous argument because it is based on deductive reasoning. In other words, it is a kind of logical argument that applies deductive reasoning to arrive at a conclusion based on two or more propositions that are asserted or assumed to be true.

For example, a case can be made that the “mystery” of the Rapture was left for the Apostle Paul to address during his ministry and that was shared in his letters or epistles. The early Disciples had no need to know the details of the “Blessed Hope” because the Church had not been birthed while Jesus was still present on the earth. But there is an evidential basis for a more subtle argument that **Jesus did in fact discuss the Pre-Tribulation Rapture.** Please note closely.

Jesus addressed the topic by means of a form of word-picture. ***“For the coming of the Son of Man will be just like the days of Noah”*** –(Matthew 24:37). In the days of Noah, while the ark was being constructed, non-believers scoffed, just as they do today until ***“God shut the door”*** –(Genesis 7:16). The rains began and as the waters rose and flooded the land, the ark floated up over the disaster taking place below. Then when the waters receded, the ark rested back on the earth to begin a new dispensation, or epoch of time. This type of experience is exactly what will happen in the future. God will shut the door of the Church Age when the Rapture of ‘born again’ believers are taken up into the clouds. The Greek term for this is called ***“harpazo”*** or “caught up”. They will be above the Tribulation which will be occurring below the clouds and on earth.

This could not be a better example to describe the event we call the Pre-Tribulation Rapture. There are roughly 100+ examples of “typology” language in the Bible which communicates the concept of the topic for this series: ***“Deliverance before Judgment”***. It absolutely affirms the words of Proverbs 25:1 describing how God has hidden

“diamonds and nuggets” within His Word for us to discover on our own. The Apostle Paul told the Thessalonian Church: ***“Then we who are alive and remain will be caught up together with them in the clouds to meet the Lord in the air, and so we shall always be with the Lord”*** –(1<sup>st</sup> Thessalonians 4:17).

Then, after the Great Tribulation, which will last seven years, those who were ‘caught up’ in the clouds will return to the earth to begin a new dispensation, at the Millennium. Think of it this way: Noah’s deliverance was pre-flood, and not mid-flood or post-flood. Logic alone tells us that if it were anything other than pre-flood, Noah and his family would have perished in the flood. Furthermore, if Noah was considered a righteous man in God’s eyes, -(Genesis 7:1) why would God subject Noah to suffer even a partial portion of the same judgment that would befall the rest of mankind at that time? Contrary to what is being taught in many churches, the doctrine of the Pre-Tribulation Rapture WAS taught prior to 1830. This is when the claim was made that the rapture theory originally began. However, this is an erroneous claim. It was taught in Scripture by the Apostle Paul, under the inspiration of the Holy Spirit, and it was also taught by early Christian teachers.

Former host of the PTL Club, televangelist and former Assemblies of God minister, Jim Bakker,<sup>(2)</sup> teaches his audience that the Pre-Tribulation Rapture is a “new” teaching introduced by a young Scottish teenage girl, Margaret MacDonald. The belief was then picked up and taught by John Nelson Darby.<sup>(1)</sup> This is a common lie taught by those who may have an agenda meant to attack the Pre-Tribulation doctrine. Whether intentional or otherwise, such false teachings deny one’s salvation by inferring that believers will be subjected to the judgments of the Great Tribulation. Somehow they believe and teach that believers have to suffer by going through the 70<sup>th</sup> Week of Daniel 9:24-27, known as the Great Tribulation. But this is a misconception that undermines what the Bible really teaches.

Baptist preacher, Morgan Edwards, taught the Pre-Tribulation Rapture in the mid-1700s, a century before John Nelson Darby came on the scene. Even with the Roman Catholic suppression of dissent, we can still find dozens of church leaders who taught and wrote about Pre-Millennialism and the Dispensationalist beliefs on the concept of the Pre-Tribulation Rapture.

Regrettably, Pastor Bakker has unwittingly placed himself in a difficult spot. Because he literally needs the belief he has in a Post-Tribulation doctrine in order to justify selling survival supplies. The issue of accurate Biblical understanding then becomes very difficult to approach or to even make an honest and thorough examination of the Pre-Tribulation Rapture teaching apart from personal belief. When there is a strong attachment to one’s beliefs, then those beliefs often trump the desire for truth in the mind of those being deceived because they end up viewing truth through the lens of their own beliefs.

To stop this cycle of deception, one has to be willing to detach from them (their beliefs) to explore the truth without these mental encumbrances. This factor is true for anyone

seeking truth. Attachments of this nature hinder the desire to acquire accurate truth. Sometimes we find scientists falling into this same trap. This situation poses a learning lesson for everyone. Constant vigilance, and an internal commitment to honesty while seeking truth is required despite the impact to one's needs for personal or deep-seated gratification, whatever that might be for the individual.

If he were to realize that the Pre-Tribulation Rapture doctrine is truly taught in the Bible, Pastor Bakker would lose his source of income because his income is dependent upon his belief in something other than a Pre-Tribulation Rapture. Understanding the truth would mean that he could no longer in all honesty market survival products with the belief that he is helping people prepare to survive the Great Tribulation. This poses a real challenge which may be difficult to come to terms with for it reveals a requirement to make a significant course correction.

At some point, the entire situation becomes a crisis of conscience. Avoiding the truth of a Pre-Tribulation Rapture poses a conflict of interest IF the desire is to adhere to accurate Biblical teaching. One's source of income should never be the foundation on which one bases their beliefs or their understanding of Biblical truths. It goes without saying that faith truly demands a genuine desire for truth regardless of personal cost. Keeping a clear conscience before the Lord must always be the priority in our daily Christian walk. –(Job 32:8; 30:21; John 1:9). With that said, it is also true that God is the One who judges all men, including our Christian brothers. Therefore, it is not our place to pass judgment but God's. If we are guilty of such judging ourselves, we cannot feel justified with our stance because we recognize something incongruous in our brother's walk with the Lord. Rather let us keep our own porches clear of debris in our endeavor to serve. –(Romans 14:10; James 4:11-12; Matthew 7:1-5)

The early church believed in the imminent return of the Lord. Up to the early 300's, they believed and taught the concept of the Pre-Tribulation Rapture. The doctrine of imminence is not in conflict with the Pre-Tribulation Rapture. It can only be associated with the Pre-Tribulational doctrine since it is incongruent with all other views of the Rapture event. With the expanding Christian church, a power struggle developed between bishops. By the end of the fourth century, the Christian church had been conquered by the Roman Caesars. During the period known as the dark ages from 500 A.D. to the early 1500s A.D., the Roman Catholic Institution controlled religion, philosophy, morals, politics, art and education and forbade the people from even owning or reading the Bible. They seized power over the church and snuffed out all dissent. In order to justify their control of the church, the Roman Catholic Institution had to invent ways to manipulate its congregants into submission, and so suppressed all Biblical teachings, except the post-tribulation return of Christ Jesus and replaced them with church doctrine. They eventually became overrun by heretical teachings.<sup>(3)</sup>

In 1994, the late Grant Jeffrey, discovered a number of manuscripts authored by a Christian writer and poet, Ephraem the Syrian, who lived from 306 A.D. to 373 A.D.<sup>(4)</sup>

**The manuscripts show that he believed in:**

1. A literal interpretation of Scripture
2. The Pre-Millennial return of Christ Jesus
3. A man who would become the antichrist and rule the Roman Empire during the last days
4. The Pre-Tribulation Rapture
5. The fulfillment of Daniel's 70<sup>th</sup> week of Daniel 9:24-27 at the end of this age
6. Concluding with the Battle of Armageddon and Christ Jesus' return

Michael Snyder, a former lawyer, (the same Michael Snyder of the opening article on page 1 of this Blessed Hope) and an author is a frequent guest on the Jim Bakker Show; he believes in modern theology but he isn't a theologian. Besides being inexperienced and lacking any formal Biblical Studies training or a solid theologian's scholarship, his writings have created a conflict related to accurate biblical teachings. Michael has authored a book that denies the Pre-Tribulation Rapture teaching but was prepared without the experience afforded by a thorough examination and a solid background in theological training. In addition, his book is fraught with error and above all he does not make the distinction between Israel and the Church. This incorrect teaching further serves to buttress a program supported by marketing survival supplies which has become a lucrative business at his news sites. In addition, the whole theme of survival can lead to fear-mongering which often becomes interwoven into topics aired on the Jim Bakker Show. It is certainly not a good idea to be naïve about the state of affairs in the world today. That's a given. At the same time, readers are reminded that God does have a plan to deliver believers from the Great Tribulation, and it will not require stockpiling years of survival supplies. The purpose of the Tribulation is to punish the disobedient world and to bring the Jews, who are the 'Apple of God's Eye' to repentance. It is meant to bring judgment on a God-hating world and not on believers.

The most crucial take away of this lesson is to remember that we must always **under all circumstances** and to the best of our capabilities handle the Word of God correctly. **A good worker who correctly explains the word of truth would be the most effective silencer of false teachers. Christians need unity, strength, the truth of the gospel and to impart the truth to future generations.** This incredible responsibility **means individual teachers, ministers, and leaders must seek not the approval of people, or their own glory but the approval of God.** This includes people who teach through books, blogs, on the internet, radio, television and thru published articles. An unashamed worker can present his or her life and ministry to God, knowing that God will approve the quality of work. **Approval of one's ministry before God will depend on how well one has proclaimed, explained, and applied the word of truth.** We must help the gospel **cut a straight path and do nothing to hinder it.**-(2<sup>nd</sup> Timothy 2:15)<sup>(a)</sup>

2<sup>nd</sup> Peter 2:1-3 states, ***"But there were false prophets also among the people, even as there shall be false teachers among you, who privily shall bring in damnable heresies, even denying the Lord that bought them, and bring upon themselves swift destruction. And many shall follow their pernicious ways, by reason of whom the way of truth shall be evil spoken of. And through covetousness shall***



***the feigned words make merchandise of you: whose judgment now of a long time lingereth not, and their damnation slumbereth not.***” Such rejection is like denying Christ Jesus and it is fatal to our salvation. It is tantamount to facing denial by God at the Day of Judgment. Jesus Himself confirmed this when he said: ***“But whosoever shall deny Me before men, him will I also deny before My Father which is in heaven”***—(Matthew 10:33; Luke 9:26; 2<sup>nd</sup> Timothy 2:12).

Although not the unpardonable sin, the Bible does teach that one can be forgiven and restored. In the previous segment, I identified and noted illustrations in the book of Genesis revealing how God provided *“deliverance before judgment”*. **Be aware and exercise discernment with full reliance on the Holy Spirit.** Watch for possible reasons why some programs marketing products of any nature might not want to endorse the truth of the Pre-Tribulation Rapture.

The Apostle Paul used the expression ***“Edify One Another”***, not once, but twice: 1<sup>st</sup> Thessalonians 5:11 and Romans 14:19. Chances are he proclaimed these words more often than what are recorded in Thessalonians and Romans. Deceivers were hard at work in Paul’s day just as they are today. We can protect ourselves against deceptions by praying for discernment and by taking up the whole suit of armor. — (Ephesians 6:13-18)

That the Apostle Paul coped with opposition is obvious when you read his response concerning the fact that someone had attempted a pretense at being Paul or speaking on Paul’s behalf. This experience had frightened the church at Thessalonica. The Thessalonians had received a forged letter that was intended to scare them or unsettle them. Some of the Thessalonian believers seemed to have accepted some of these wrong teachings regarding Christ’s Second Coming -(2<sup>nd</sup> Thessalonians 2:2-3) and what would happen in the world before he returned. Paul had already taught them much when he was with them and had explained more in his first letter -(1 Thessalonians 4–5).<sup>(a)</sup> To put it mildly, they were really upset. Interestingly, by reading 2<sup>nd</sup> Thessalonians 2:1-3, we can conclude they had disputed Paul’s teaching on the events leading up to the Day of the Lord.

Right from the very beginning, Paul’s teachings separated the coming of the Lord from that of believers being gathered together in Him. This differentiation is extremely important in our understanding of Paul’s position. That is because they are two different events. We cannot tell their relative timing from this Scripture, but **we can tell they are two distinctively different events**. In an article at this same website under the heading of “Pre-Tribulation Truth” you will find a comprehensive list comparing and contrasting the distinctions between the Rapture and the Second Coming; within them I note 28 specific and distinct differences. All preclude any possibility that these two events are simultaneous or a single event.

The Rapture is going to happen so fast that we will not have time to think about it when it happens. It will be in the ***“twinkling of an eye”***, as Paul says in 1<sup>st</sup> Corinthians 15:52.

**Leprosy, Polio, TB, and Malaria: What Do They Have in Common?  
Illegal Aliens.**



What do leprosy, polio, malaria, tuberculosis, and measles all have in common? Two things: They were mostly eradicated in the United States until recently, and they have recently been reintroduced and are flaring up in various locations in the US now -- [brought in \(at least in part\) by unscreened, unvaccinated, unidentified illegal immigrants.](#)

Successful public health campaigns and medical advances have enabled the United States to conquer a range of disfiguring and damaging diseases. Polio, which paralyzed thousands of Americans annually, was wiped out by widespread vaccinations. In 1999 the nation's last hospital for lepers closed its doors in Louisiana. A global campaign eradicated smallpox, while lethal tuberculosis, the "consumption" that stalked characters in decades of literature, seemed beaten by antibiotics. Measles outbreaks still occur from time to time, but they are small, local, and easily contained.

Recently, however, some of these forgotten but still formidable infectious diseases have begun to reappear in the U.S. For two years running, polio has been detected in some New York water samples, and this fall, leprosy re-emerged in Florida, where cases of malaria have also been recorded.

While leprosy can be spread by, of all things, armadillos, and malaria still lingers in swampy areas around the country, those disease reservoirs were largely under control - until now. The sudden outbreaks of these diseases correlate very distinctly with the sudden influx of unscreened illegals across the southern border. Yes, correlation is not causation, but that doesn't mean that correlation may not indicate causation. In any case, one would think that the sudden outbreaks of these diseases would prompt some action on the part of the Biden Administration, the Centers for Disease Control and Prevention, or the Department of Homeland Security, all of whom are responsible for various aspects of immigration and public health.

Here's the onion, and as you'd expect, the more layers you peel off, the worse it smells. "The recent polio and leprosy cases are almost certainly imports to the U.S.," said Dr. Jay Bhattacharya, a physician and scientist at Stanford University, one of the most outspoken critics of official COVID-19 narratives in the last pandemic that later proved flawed.

And the Biden administration, an aggressive promoter of often mandatory vaccination last time, now is offering little public comment on the connection between disease and the porous borders with which its immigration policy has become widely identified.

That's the first layer; as you'd expect, the Biden Administration seems to have little to say about the sudden re-emergence of these diseases. That's likely because there's an obvious place to start looking for a cause of the problem, that being our wide-open running sore (in this case, literally) of a southern border. 4. Meat consumption will be minimized.
5. Massive displacement of people will take place with billions of refugees.
6. To limit the emission of carbon dioxide, a global price will be set at an exorbitant level.
7. People can prepare to go to Mars and start a journey to find alien life.
8. Western values will be tested to the breaking point.

### **Beyond Privacy and Property**

In a publication for the World Economic Forum, the Danish ecoactivist [Ida Auken](#), who served as her country’s minister of the environment from 2011 to 2014 and still is a member of the Danish Parliament (the Folketing), has elaborated a scenario of a world without privacy or property.

In “Welcome to 2030,” she envisions a world where *“I own nothing, have no privacy, and life has never been better.”* By 2030, so says her scenario, shopping and owning have become obsolete, because everything that once was a product is now a service. In this idyllic new world of hers, people have free access to transportation, accommodation, food, “and all the things we need in our daily lives.”

As these things will become free of charge, *“it ended up not making sense for us to own much.”* There would be no private ownership in houses nor would anyone pay rent, *“because someone else is using our free space whenever we do not need it.”*

A person’s living room, for example, will be used for business meetings when one is absent. Concerns like *“lifestyle diseases, climate change, the refugee crisis, environmental degradation, completely congested cities, water pollution, air pollution, social unrest and unemployment”* are things of the past.

*The author predicts that people will be happy to enjoy such a good life that is so much better “than the path we were on, where it became so clear that we could not continue with the same model of growth.”*

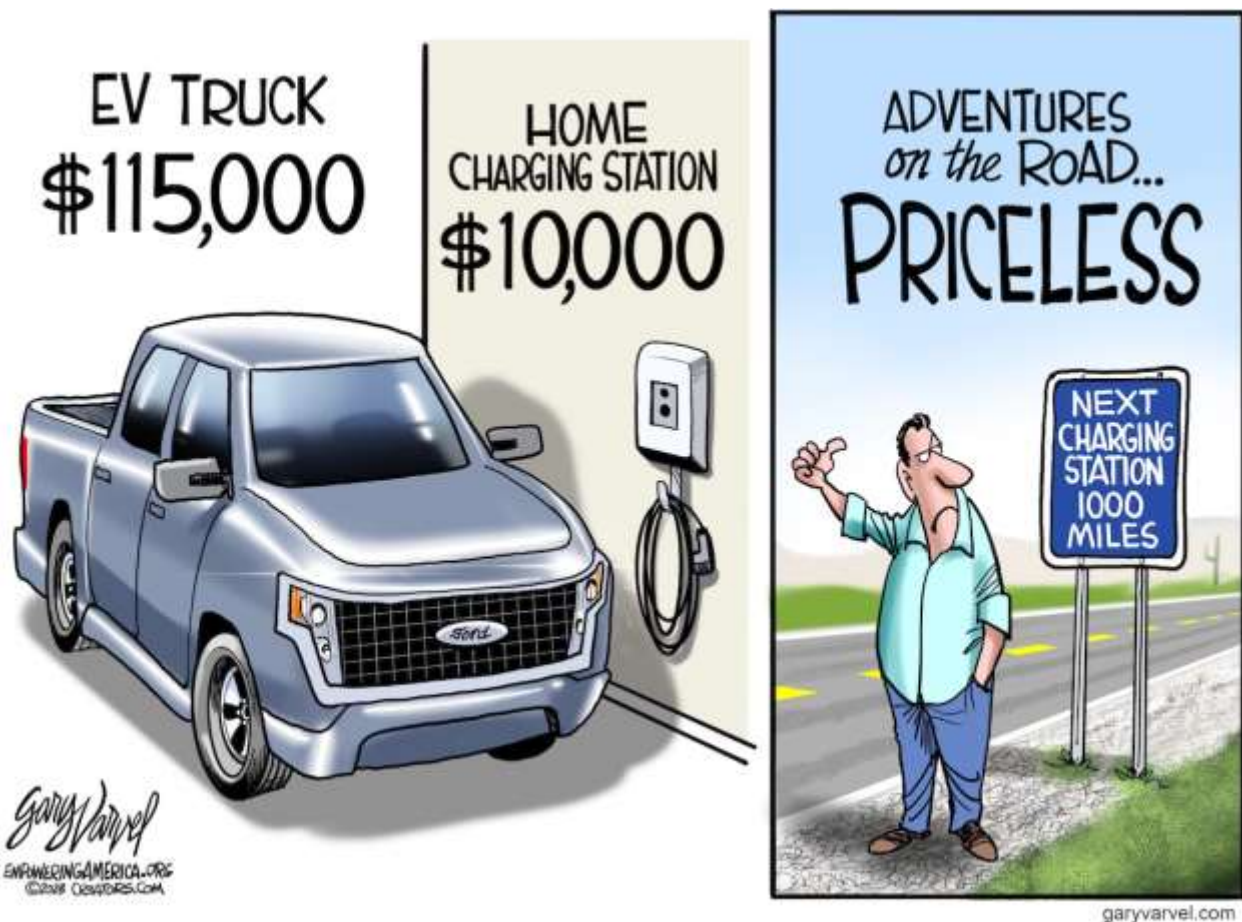


### Ecological Paradise

In her 2019 contribution to the Annual Meeting of the Global Future Councils of the World Economic Forum, Ida Auken foretells how the world may look in the future *“if we win the war on climate change.”*

By 2030, when CO2 emissions will be greatly reduced, people will live in a world where meat on the dinner plate *“will be a rare sight”* while water and the air will be much cleaner than today.

Because of the shift from buying goods to using services, the need to have money will vanish, because people will spend less and less on goods. Work time will shrink and leisure time will grow.



For the future, Auken envisions a city where electric cars have substituted conventional combustion vehicles. Most of the roads and parking spaces will have become green parks and walking zones for pedestrians.

By 2030, agriculture will offer mainly plant-based alternatives to the food supply instead of meat and dairy products. The use of land to produce animal feed will greatly diminish and nature will be spreading across the globe again.

## **Fabricating Social Consent**

How can people be brought to accept such a system?

The bait to entice the masses is the assurance of comprehensive healthcare and a guaranteed basic income.

The promoters of the Great Reset promise a world without diseases.

Due to biotechnologically produced organs and individualized genetics-based medical treatments, a drastically increased life expectancy and even immortality are said to be possible.

Artificial intelligence (AI) will eradicate death and eliminate disease and mortality, all while “dominating” the human race.

The race is on among biotechnological companies to find the key to eternal life.

## **Japanese Scientists Find Indisputable Evidence That ALL COVID Variants Are MAN-MADE!!**

**A stunning Japanese study that has evolved from preprint to peer-reviewed publication suggests that all COVID-19 variants were engineered in bio-labs and intentionally released upon humanity.** First released in August 2023, the study, conducted by renowned Japanese virologists Professors Atsushi Tanaka and Takayuki Miyazawa of Osaka Medical University and Kyoto University, **affirms that the push to keep COVID around is part of a nefarious deep state scheme to remove our individual freedoms and control us.**

It is well known that the U.S. Department of Energy, the CIA, and the FBI now recognize that there is a possibility that SARS-CoV-2 was [created in a lab](#). And now, as conveyed in a super interesting September 15 discussion between [Jefferey Jaxen](#) and Del Bigtree, the mind-boggling published scientific conclusion by Tanaka and Miyazawa that all COVID-19 variants are intentionally manufactured adds a massive component to the

quite technical scientific debate, which has been slow to get a proper investigation in a public forum because it is such a specialized and colossal conversation. And let's not forget the topic is heavily censored.

Though complicated, in a [nutshell](#), to determine the order of mutations of the Omicron variant of SARS-CoV-2, in a [25-page paper](#) titled "*Unnaturalness in the Evolution Process of the SARS-CoV-2 variants and the possibility of deliberate natural selection,*" Tanaka and Miyazawa traced the variant's origins by studying viral sequences found "in the wild" around the world that had been deposited into public databases. The researchers explained that their study aimed "to clarify the evolutionary processes leading to the formation of SARS-CoV-2 Omicron variants, focusing on Omicron variants with many amino acid mutations in the spike protein among SARS-CoV-2 isolates."

As their work progressed, they [discovered](#) roughly 100 separate Omicron subvariants that could not possibly have arisen naturally. The existence of these variants and the systematic order in which they appeared provide conclusive evidence of large-scale lab creation and release of COVID-19 viruses. Specifically, to determine the order of mutations leading to the formation of the SARS-CoV-2 Omicron variants, Tanaka and Miyazawa compared the sequences of 129 Omicron BA.1-related isolates, 141 BA.1.1-related isolates, and 122 BA.2-related isolates, and attempted to clarify the evolutionary processes of SARS-CoV-2 Omicron variants, including the order of mutations leading to their formation and the occurrence of homologous recombination. Surprised by their findings, the scientists remarked:

*"As a result, we concluded that the formation of part of Omicron isolated BA.1, BA.1.1, and BA.2 was not the product of genome evolution, as is commonly observed in nature, such as the accumulation of mutations and homologous recombinations. Furthermore, the study of 35 recombinant isolates of Omicron variants BA.1 and BA.2 confirmed that Omicron variants were already present in 2020. The analysis showed that Omicron variants were formed by an entirely new mechanism that cannot be explained by previous biology, and knowing how the SARS-CoV-2 variants were formed prompts a reconsideration of the SARS-CoV-2 pandemic.*

*These results suggest that the establishment of BA.1-0.1 and BA.1.1-0.1 isolates occurred independently. On the other hand, if reversion mutations caused each of these isolates with one amino acid different to the Wuhan-type, these isolates could be detected by examining an astronomical number of isolates. However, these virus strains were detected in the number of sequenced whole genomes (a limited number), rather than in astronomical numbers examined. The fact that most of these mutations occurred without synonymous mutations suggests that none of them arose as a result of trial-and-error random mutations in nature."*

The ramifications of this study are profound and demand immediate attention. As so aptly expressed by [Substack author Phillip Altman](#), there has never been a business model so perfectly planned and executed as SARS-CoV-2. Once released, there was a

gigantic cover-up. Indeed, “drug regulatory agencies around the world allowed the release of poorly researched, dangerous gene-based mRNA lipid nanoparticle injections which they incorrectly called ‘vaccines’...a key part of the misinformation campaign.”

Then, with babies and pregnant moms coerced into getting the jab, Altman shared that what ensued was a scandalous, coordinated grab “for rivers of gold and power the world had never seen.” Without a doubt, the level of reported “vaccine” injuries and deaths in various adverse drug event reporting systems around the world was (and still is) unprecedented. And the icing on the cake for the masters of the plan—a continual stream of variants would line the pockets of the deep state well into the foreseeable future.

Immunologist Atsushi Tanaka is a professor in the Immunology Frontier Research Center at Osaka University. He has published over 30 scholarly papers with nearly 6,000 citations. Likewise, Virologist Takayuki Miyazawa, a professor at Kyoto University, has published almost 300 academic articles, and his work has been cited over 7,000 times. Both men arise top-notch in their fields, and their work must not be dismissed out of hand. While stressing the importance of holding this eye-opening discovery front and center, the authors’ study conclusion deserves to close out this article. With the prediction of more “corona hoopla” on the horizon, they declare:

*“Nonetheless, the analysis we have shown here concludes that the Omicron variants were formed by a completely new mechanism that cannot be explained by previous biology. The process of how SARS-CoV-2 mutations occurred should prompt a reconsideration of the SARS-CoV-2 pandemic. If the SARS-CoV-2 epidemic strain is an artificially mutated virus and if the corona disaster (corona hoopla) was a well-designed global experiment in human inoculation and a social experiment, then the design of this experiment and the nature of the virus used make it likely that this experiment (corona hoopla) is a preliminary experiment.”*

## **IAEA says Iran has tripled production to 60% enriched uranium, has enough for 3 bombs - Iran denies any recent change in enrichment levels**

The International Atomic Energy Agency (IAEA) issued a report on Tuesday revealing that Iran had increased its uranium enrichment following a brief reported slowdown earlier this year.

The slowdown was believed to be related to secret negotiations between Iran and the United States earlier this year, which led to the release of several U.S. citizens held in Iran, according to the statement.

The IAEA also said that Iran has enough uranium enriched to 60% that it could make three nuclear bombs, after further enrichment.

Uranium only has to be enriched to near 4% purity for use in nuclear energy, while nuclear weapons-grade uranium requires enrichment to around 90%. Critical mass can be achieved with lower purities but would require a larger bomb.

Nuclear experts estimate that Iran would require only seven days to further purify the uranium to weapons-grade enrichment (90%).

Iran had been producing enriched uranium at a rate of around 3 kilograms per month, during the slowdown, but according to the IAEA has resumed production of larger amounts, around 9 kilograms per month.

*“This represents an increase compared to the approximately three kilograms produced per month since June, and a return to the monthly pace of nine kilos during the first half of 2023,”* reported the IAEA, which is run by the United Nations.

The Iranian regime is also producing stockpiles of uranium enriched to other purity levels – less than 60% – which could be further enriched if desired. The production of stockpiles at greater than 5% enrichment is unnecessary for a civilian energy program.

While the presence of such highly-enriched uranium (HEU) indicates a weapons program, the IAEA believes Iran would still need additional time to produce a working nuclear device after achieving the necessary purity.

The U.S. Biden administration expressed concern following the IAEA report.

*“Iran’s nuclear escalation is all the more concerning at a time when Iran-backed proxies continue their dangerous and destabilizing activities in the region, including the recent deadly drone attack and other attempted attacks in Iraq and Syria and the Houthi attacks against commercial shipping vessels in the Red Sea,”* U.S. National Security Council Spokesman John Kirby said on Tuesday evening.

Senior Director of Nonproliferation and Biodefense Program Anthony Ruggiero, who works for the Foundation for Defense of Democracies, blamed the failed policy of the U.S. administration for allowing Iran to get so close to achieving a nuclear weapon.

*“President Biden’s failed Iran policy has emboldened Tehran to expand its nuclear program and attack U.S. personnel in Iraq and Syria. Biden must restore deterrence with overwhelming military strikes and financial sanctions on the Islamic Republic and its proxies,”* Ruggiero said.

Mohammad Eslami, head of the Atomic Energy Organization of Iran (AEOI), confirmed the 60% enrichment rate but claimed there was no change to the pace.

*"We are enriching to the same 60% purity; we have neither changed our work nor expanded our capacity,"* he said in a statement.

Eslami accused the IAEA of trying *"to distract public attention"* from the war in Gaza.

The whole thing sounds quite dirty and promiscuous, but **constantly reminding ourselves what is actually true in a blizzard of lies is an admirable pursuit**. Crafty French diplomat Talleyrand, who managed to keep his head through both the French Revolution and the reign of Napoleon, observed, *"Speech was given to man to conceal his thoughts."* The **Marxist globalists who use censorship and propaganda as shield and sword** are Talleyrand's ardent disciples.

The size of the information war being conducted against us is astounding, and because the formerly **free press has been conquered** and conditioned to support the State, news outlets willing to report the truth are few. When **the corporate news cartel controls 95% of the information flow** and **the Department of Homeland Security is**



**effectively censoring the remaining 5%**, it becomes essential for those of us who see this war as it really is to sound a little like broken records.

Using labels such as “Deep State,” “Uniparty,” “Marxist globalists,” “ruling class,” and “elites” is a form of subversive branding meant to align us against a common enemy. “Make American Great Again” is more than a jingle or campaign slogan; it is an attempt to cut through artificial political divisions so that abused citizens can find common purpose. Rejecting “woke” dogma, “political correctness,” and other Marxist distortions of truth is a form of mental armor that defends against the government’s unabating propaganda. **Repetition of simple truths must meet the repetition of outrageous lies head-on.**

Why do I bring this up? Because **the information warfare leveled against us is going to become much worse.** A Canadian court [recently ruled](#) that describing drag queens who perform in front of children as “groomers” is not “protected speech.” **Western governments’ war against moral virtue has become so obscene that those who abuse children have become a legally protected class.** “Hate speech” laws — that novel **approach by Marxist globalists to criminalize all dissent — are silencing people throughout the West.**

Before you assume that the First Amendment will prevent **Canada’s love for depravity** over free speech from fully metastasizing down here, remember this: the U.S. government’s terrorist watch list is now over [two million people worldwide](#), including thousands of Americans here at home. Although the O’Biden administration has made it clear that **Iran (the world’s leading State sponsor of terrorism)** and **Hamas (a bunch of vile murderers and rapists)** are its friends, it has **gone out of its way to use the FBI to hunt Christians, concerned parents, pro-life Americans, and Trump-supporters as “domestic terrorists.”**

Since when has the federal government ever worried about a suspected (non-leftist) terrorist’s free speech? **What happens when a hundred and fifty million Americans discover that they are now seen as “terrorists”?** With enough intimidation, the national security surveillance State expects that dissent will disappear like a puff of smoke. As Brandon Smith [wrote recently](#) in an essay dissecting information warfare, “The globalists view public manipulation and social engineering as their birthright. They think it’s their manifest destiny, and they suggest often that humanity would somehow decay and self-destruct without their influence.” **Those who keep it simple and stand their ground,** though, **may force the Marxist globalists to one day face their Waterloo.**

I have met few people with a perfect track record of seeing through the government’s propaganda over the last twenty years. Not everyone saw the PATRIOT Act as a dangerous step toward an all-powerful surveillance State. Not everyone saw through the Russia collusion hoax. Not everyone recognized the early steps of the federal government’s manipulation of social media as **a mass censorship campaign against the American people.**

Not everyone recognized **the mass hysteria over COVID as a complex, multi-pronged battle plan meant to manipulate the 2020 election** and **convince terrified people to surrender their own liberties**. Not everyone recognized **the war in Ukraine as a money-laundering operation for politicians, bankers, and industrialists**. Be patient with those who do not clearly see things as quickly as you do, because we have all had the wool pulled over our eyes at some point in life.

The government is exceedingly effective in its information warfare because it, too, keeps it simple. Diplomats of the “woke” faith repeat dopey lies — such as “*men can menstruate*” — with such gusto that even religious leaders who should know better begin spreading those same lies as “*truths*.” Politicians use our morality against us when they say things such as, “*We’re all in this together*,” and good people can get caught in those empathy traps.

Military [spokespeople use](#) our patriotism against us when they insist, “*If we don’t fight them over there, we’ll fight them over here*,” and it is easy for warriors to end up volunteering for the wrong wars. My point is this: however much you think you know, **chances are that the U.S. government has conditioned you to believe at least some damaging lie in the course of your life**. Have compassion for those who are just now waking up to the reality of our situation, and state the truth calmly and simply, again and again.

NYU professor Mark Crispin Miller, a scholar who has written much about propaganda, [says bluntly](#):

***The media has been crucial to this entire operation, and ... I would say since the beginning of 2020, we have been subjected to a “Rolling Thunder of Propaganda.” First, there was the virus panic. Then, there was the George Floyd moment. ... There was the 2020 Election. There was the so-called “insurrection.” That was a wave of crackpot hysteria. ... Then, there was Ukraine, and the entire backstory of Russia’s invasion was completely missing from all the coverage. ... To say the press has failed abysmally is actually giving them too much credit.***

While you see through the media’s obvious lies, too many Americans still see them as obvious truths. **It is far easier to accept outrageous deceptions than to accept that our most trusted institutions habitually distort reality**. The only way out of this psychological war is to confront falsehoods, mock propaganda, and **speak honestly — again and again, until you break the government’s spell over the enchanted**.

As the great James Howard Kunstler [wisely advises](#): “Remember, you are a sovereign individual and the blob in our nation’s capital city is an undifferentiated mass of feckless protoplasm. You contain a cosmos of ideas and aspirations. The blob is an agglomeration of sham and failure. The blob stands for itself, not for our country. You and I can stand for our country.”

My advice for emancipating others from their mental straitjackets is straightforward: **acknowledge that there is good and evil in this world, and commit yourself to fighting evil.** Because we are in an information war, recognize that every lie must be confronted before it is allowed to subvert important truths. **Repeat what is true often. And always keep it simple.**
