Big Pharma Executive Blows Whistle: ‘COVID Vaccines Are Designed To Kill Billions’

COVID-19 mRNA vaccines were deliberately designed to be ineffective and lethal, according to bombshell testimony by pharmaceutical executive Alexandra “Sasha” Latypova.

According to Latypova, the Department of Defense (DoD) had *“very clear intent to harm”* by executing a *“mass genocide of Americans.”*

Under the DoD’s control and direction, drug manufacturers like Pfizer, Moderna, and Janssen started mass-producing the shots for Operation Warp Speed – long before the first cases of Covid even appeared, it turns out. These “figurehead” organizations, Latypova insists, were just obeying the DoD’s orders.

Naturalnews reports: What this means is the United States military oversaw the creation and rollout of these *“covid countermeasures,”* as they were classified before being erroneously dubbed as *“vaccines.”* This is why they called it Operation Warp Speed: because it was a military warfare operation, not a *“public health”* operation.

The Centers for Disease Control and Prevention (CDC) and the Food and Drug Administration (FDA) also played their role by fast-tracking emergency use authorization (EUA) for the deadly drugs, followed by official approval for some of them – and the rest is history.

Back in December, Latypova laid this all out in a video lecture.

The crux of Latypova’s presentation claims that the DoD, Big Pharma, and Big Regulation (the FDA and CDC) conspired with one another *“to commit mass murder through bioterrorism and informational warfare operations worldwide.”*

“The evidence is overwhelming that there is an intent to harm people by the covid-19 injections, so-called ‘vaccines,’ and other nonsensical covid response measures implemented in lockstep by governments all over the world,” she said.

Again, it is not that the shots were designed to help people but just so happened to be dangerous. Latypova says they were designed that way on purpose as a chemical and / or biological weapon against the people, which she says is substantiated by an extensive body of literature, studies, scientific discussions, (and) evidence published on this matter.

“There are numerous mechanisms of injury built into the covid-19 injections,” she further explained. “The most important one being that these shots are designed to make your cells attack themselves, make your cells express antigens that are toxic spike proteins, and then create antibodies to attack the cells. So, it trains your body to destroy itself.”

There is nothing safe, let alone effective, about these injections, in other words – unless the effective goal was to massively depopulate the world. In that case, the injections are working exactly as designed – and the worst is yet to come.

From the very beginning, the safety signals were “obvious,” Latypova says. And yet nobody in any position of power seemed to notice, or perhaps they deliberately ignored these safety signals because killing people was the goal.

“There is no efficacy in these shots,” Latypova reveals. “In fact, we know there is negative efficacy, meaning that these shots make you more likely to get sick and die.”

During the shots’ production, good manufacturing practices (GMP) were completely ignored, also apparently by design, to further ensure a deadly product outcome. Had proper safety standards been upheld, the shots might have ended up less deadly, which would have gone against the agenda.

“We found that these products are dirty, contaminated, do not conform at all to what the label says,” Latypova says. “And they’re hugely toxic by design.”

“They should all be stopped immediately, and this should be investigated properly. And we should bring those responsible to justice, to accountability. Until that happens, we cannot move on from this.”

Agenda 2030: WHO Head Declares War On Meat And Demands Nations Transition To Plant-Based Diets At COP28

Tedros’ message mostly went unheard at the time but gained some traction online weeks after COP28 concluded.

“By 2025 we intend to strengthen our respective and shared efforts [...] We affirm that agriculture and food systems must urgently adapt and transform in order to respond to the imperatives of climate change,” the declaration at COP28 reads,

World Health Organization Director-General Tedros Adhanom Ghebreyesus issued a short statement during the COP 28 climate summit in Dubai last month, blaming meat and livestock practices for contributing a major amount of emissions.

Tedros’ message mostly went unheard at the time but gained some traction online weeks after COP28 concluded.

In the video the WHO head stated:

Our food systems are harming the health of people and planet. Food systems contribute to over 30 percent of greenhouse gas emissions, and account for almost one-third of the global burden of disease. Transforming food systems is therefore essential by shifting for this healthier, diversified and more plant-based diets.

If food systems deliver healthy diets for all we could save 8 million lives per year. [...] WHO is committed to supporting countries to develop and implement policies to improve diets and fight climate change.

[...] I’m therefore very pleased that over 130 countries have signed the code 28 UAE Declaration on climate and health. Together, we can protect and promote the health of both people and planet. Thank you.

As referenced in his video briefing, during COP28, actually 159 countries signed a pact to work to transform their national food systems and agricultural practices, called the *“COP28 UAE Declaration on Sustainable Agriculture, Resilient Food Systems, and Climate Action.”*

According to a press release the day the pact was announced, COP 28 organizers wrote: ‘Also announced was the mobilization of more than USD\$2.5 billion in funding to support food security while combatting climate change and a new partnership between the UAE and the Bill and Melinda Gates Foundation for food systems innovation in the fact of climate change.’

Additionally, Prime Minister of Italy, Fiamē Naomi Mata’afa, helped to lead the talks, among others; which is worth noting considering Italy just made moves to ban lab-grown and cell-cultured meat in the country in November.

The full declaration is as follows:

WE, HEADS OF STATE AND GOVERNMENT:

Recognizing that unprecedented adverse climate impacts are increasingly threatening the resilience of agriculture and food systems as well as the ability of many, especially the most vulnerable, to produce and access food in the face of mounting hunger, malnutrition, and economic stresses;

Recognizing the profound potential of agriculture and food systems to drive powerful and innovative responses to climate change and to unlock shared prosperity for all;

Underscoring the need to progressively realize the right to adequate food in the context of national food security as well as the need to ensure access to safe, sufficient, affordable, and nutritious food for all;

Noting that agriculture and food systems are fundamental to the lives and livelihoods of billions of people, including smallholders, family farmers, fisher folk and other producers and food workers;

Noting the essential role of international and multi-stakeholder cooperation, including South-South and Triangular cooperation, financial and funding institutions, trade, and non-state actors in responding to climate change;

Reaffirming our respective commitments, collective and individual, to the 2030 Agenda for Sustainable Development, the UN Framework Convention on Climate Change and the Paris Agreement, the UN Convention on Biological Diversity and the Kunming-Montreal Global Biodiversity Framework, the UN Convention to Combat Desertification, and the Sharm El Sheikh Joint Work on implementation of climate action in agriculture and food security; as well as noting the UN Food Systems Summit;

Recalling also the United Nations Framework Convention on Climate Change and the Paris Agreement, acknowledging that they are the primary international, intergovernmental forums for negotiating the global response to climate change;

Recalling the findings of recent Intergovernmental Panel on Climate Change (IPCC) assessments as well as noting the Synthesis report by the co-facilitators on the technical dialogue of the first global stocktake;

We stress that any path to fully achieving the long-term goals of the Paris Agreement must include agriculture and food systems.

We affirm that agriculture and food systems must urgently adapt and transform in order to respond to the imperatives of climate change.

WE DECLARE OUR INTENT TO WORK COLLABORATIVELY AND EXPEDITIOUSLY TO PURSUE THE FOLLOWING OBJECTIVES:

1. Scaling-up adaptation and resilience activities and responses in order to reduce the vulnerability of all farmers, fisher-folk, and other food producers to the impacts of

climate change, including through financial and technical support for solutions, capacity building, infrastructure, and innovations, including early warning systems, that promote sustainable food security, production and nutrition, while conserving, protecting and restoring nature.

2. Promoting food security and nutrition by increasing efforts to support vulnerable people through approaches such as social protection systems and safety nets, school feeding and public procurement programs, targeted research and innovation, and focusing on the specific needs of women, children and youth, Indigenous Peoples, smallholders, family farmers, local communities and persons with disabilities, among others;

3. Supporting workers in agriculture and food systems, including women and youth, whose livelihoods are threatened by climate change, to maintain inclusive, decent work, through context-appropriate approaches which could include increasing, adapting and diversifying incomes;

4. Strengthening the integrated management of water in agriculture and food systems at all levels to ensure sustainability and reduce adverse impacts on communities that depend on these inter-related areas;

5. Maximize the climate and environmental benefits – while containing and reducing harmful impacts – associated with agriculture and food systems by conserving, protecting and restoring land and natural ecosystems, enhancing soil health, and biodiversity, and shifting from higher greenhouse gas-emitting practices to more sustainable production and consumption approaches, including by reducing food loss and waste and promoting sustainable aquatic blue foods;

To achieve these aims – according to our own national circumstances – we commit to expedite the integration of agriculture and food systems into our climate action and, simultaneously, to mainstream climate action across our policy agendas and actions related to agriculture and food systems.

IN FULFILLING THIS COMMITMENT, BY 2025 WE INTEND TO STRENGTHEN OUR RESPECTIVE AND SHARED EFFORTS TO:

1. Pursue broad, transparent, and inclusive engagement, as appropriate within our national contexts, to integrate agriculture and food systems into National Adaptation Plans, Nationally Determined Contributions, Long-term Strategies, National Biodiversity Strategies and Action Plans, and other related strategies before the convening of COP30.

2. Revisit or orient policies and public support related to agriculture and food systems to promote activities which increase incomes, reduce greenhouse gas emissions, and bolster resilience, productivity, livelihoods, nutrition, water efficiency and human, animal

and ecosystem health while reducing food loss and waste, and ecosystem loss and degradation.

3. Continue to scale-up and enhance access to all forms of finance from the public, philanthropic and private sectors – including through blended instruments, public-private partnerships and other aligned efforts – to adapt and transform agriculture and food systems to respond to climate change.

4. Accelerate and scale science and evidence-based innovations – including local and indigenous knowledge – which increase sustainable productivity and production of agriculture and related emerging domains, promote ecosystem resilience and improve livelihoods, including for rural communities, smallholders, family farmers and other producers.

5. Strengthen the rules-based, non-discriminatory, open, fair, inclusive, equitable and transparent multilateral trading system with the World Trade Organization at its core.

With seven years remaining to achieve our shared goals, (Depopulation) we intend to strengthen collaboration among our respective ministries – including agriculture, climate, energy, environment, finance, and health – and with diverse stakeholders to achieve the objectives and efforts articulated in this Declaration, and as appropriate within our national contexts.

To maintain momentum, we intend to benefit from relevant regional and global convening's in order to share experiences and to accelerate national and collaborative action. We will review our collective progress next year at COP29 with a view to considering next steps in 2025 and beyond.

Facebook Rolls Out "Link History" Showing How it Tracks All The Websites Users Visit

Facebook, just like the rest of Big Tech, has historically made a great effort to track users across the internet, even when they are not logged into the platform, for data collecting and ultimately monetary reasons.

Now, reports say that a new way to achieve this has been recently launched by the giant, and notably, for the first time this type of tracking is made visible.

Called Link History, the new feature is found in the Facebook app as essentially one of the permissions, and "documents" every link a user clicks while using the app.

Once again, fully in vein of what Google, Microsoft, etc., are doing, Facebook says the change - putting all links in one place - is there for better user experience, and again habitually, while the feature is not mandatory, it is there by default and "hiding" behind a pretty solid wall of an "opt-out."

Whatever the case may be, most users don't bother jumping over that wall, allowing corporations to at once offer a choice - and in most cases have it their way.

In order to deactivate this on their app, users first need to be aware Link History exists, and then navigate to the appropriate setting in order to "opt out."

But there is no shortage of criticism of this latest move, from the privacy point of view (although mainstream tech press curiously chooses to single out Facebook while praising Google and Apple as some sort of "*privacy warriors*" now).

This should be viewed as part of the big (political) picture where keeping pressure on Facebook as still the most influential social media is especially important in an election year - while at the same time rightfully questioning Facebook's (persistent) motivation for pursuing cross-site user tracking.

A classic example of two things getting to be true at the same time.

Facebook (Meta) doesn't exactly pretend it is working solely to make sure users "never lose a link again" and enjoy other things that benefit them. A part of Link History's announcement spells this out: *"When you allow link history, we may use your information to improve your ads across Meta technologies."*

What the statement doesn't clarify is if any of the well-known, ultra-invasive methods it uses to track users will actually change in any way with the introduction of Link History.

NEW RESTRICTIONS

California Introduces New Law, Limiting and Regulating Cops' Posting of Mugshots Online, Forcing Chosen Names and Pronouns

California's AB 994 is a newly instituted piece of legislation that significantly regulates the protocol for police departments and sheriff's offices in relation to the publication of mugshots on their social media platforms. This law, effective from January 1, 2024, introduces strict controls regarding the display of mugshots, particularly emphasizing the inclusion of the arrested individual's self-identified name and gendered pronouns.

We obtained a copy of the bill for you here.

Under AB 994, the conditions allowing for the sharing of mugshots on social media by law enforcement are notably restricted. The law mandates that the person's chosen name and chosen pronouns be used when their mugshot is uploaded on these platforms. This requirement is applicable regardless of the nature of the alleged crime.

"With respect to an individual who has been arrested for any crime, this bill would require a police department or sheriff's office, upon posting a booking photo on social media, to use the name and pronouns given by the individual arrested," the law specifically states.

Law enforcement agencies, however, retain the discretion to use other legal names or aliases in situations where it may aid in apprehending the individual, reduce imminent threats to public safety, or in other urgent scenarios.

Traditionally, the booking process after an arrest involves using the person's legal name from official documents like birth certificates or driver's licenses. The new legislation, however, stipulates these new rules specifically for the phase when the individual's mugshot is posted online.

AB 994 also sets boundaries on the posting of mugshots for those accused of nonviolent crimes. The exceptions to this limitation include instances where the release of the image could contribute to the person's capture, mitigate threats to others, or is ordered by a judge.

Furthermore, the law requires the removal of all mugshots from law enforcement social media accounts within two weeks, unless it falls under the same three exceptional categories.

PLOTTING SPEECH LAWS

Ireland's Media Commission Chief Admits Considering Censorship Related to Recent Stabbing in Dublin That Sparked Riots

Ireland's media watchdog, Coimisiún na Meán (Media Commission), headed by executive chairman Jeremy Godfrey, has voiced concerns about online "misinformation" and the possibility of foreign interference in the upcoming local and European elections. However, this stance has raised questions about the potential for overreach in online censorship in the country, especially as it has come to light that Ireland considered censorship plans over the recent backlash to the stabbing of a child caused heated arguments and riots over the nation's immigration policy.

While discussing these concerns with the Irish Examiner, Godfrey emphasized the importance of preserving the integrity of elections and civil discourse. Yet, this focus brings to the fore the delicate issue of how far regulatory bodies should go in controlling online content without infringing on free speech and the right to information.

"I suppose from around Thursday lunchtime, we first found out about the stabbing incident," Godfrey said. "And we decided that this was something that we needed to do something about."

"Our concerns were firstly there might be imagery of the incident itself that could circulate online. It could be damaging if children saw it, and damaging to the relatives of people who'd been hurt, and could actually result in the identification of a suspect. All those things are to be avoided."

"But then we were also worried that it could become a lightning rod for the incitement of hatred against ethnic minorities or incitement to violence. That is absolutely illegal content that will definitely fall within our regulatory remit."

Godfrey's additional concerns about "hate speech," particularly against women in public roles, point to the complexity of regulating online discourse.

While the intention to protect individuals from harmful content is clear, elsewhere such regulations are being used to suppress dissenting voices or controversial viewpoints.

"We will be monitoring all the wide range of obligations in the online safety framework, but how platforms deal with hate speech is going to be a high priority," Godfrey said.

Coimisiún na Meán's collaboration with the Electoral Commission to mitigate these risks may be seen as a move towards more stringent online content regulation. This perspective is further reinforced by Godfrey's recount of his organization's intervention

during the Dublin riots last November, where they monitored online speech related to a violent incident. This intervention, while intended to prevent the spread of harmful content, can also be seen as a step towards greater control over online expression and controlling the public's access to truthful information.

With Coimisiún na Meán's plans to significantly expand its workforce and assume greater regulatory powers in 2024, there is growing concern about the potential for increased online censorship under the guise of public safety.

SPEECH SURVEILLANCE

DHS Has Been Funding Programs at Universities To Label the "Manosphere" Movement a Terror Threat

The U.S. Department of Homeland Security (DHS) continues to team up (by means of funding) with universities around the country, this time in a bid to stomp out the "Manosphere."

In keeping with the formal purpose and tasks of the DHS, the idea is to treat the "*Manosphere*," positioned as an anti-feminist effort, as a terrorist threat.

Regardless of somebody's stance pro or against modern variations on feminism, some observers are wondering if opposing this social and ideological phenomenon can in fact fit within any definition of - terrorism.

All swans were presumed to be white because all historical records of swans showed them with white feathers. The term black swan was thus used to describe any impossible event or circumstance. But in 1697 the Dutch explorer Willem de Vlamingh encountered swans with dark plumage in Australia, a land largely unexplored by Europeans at that time. The black swan thus came to be a metaphor for the reality that just because something has not happened does not mean that it cannot occur in the future. The metaphor is analogous to the fragility of any system of thought and a testament to the fallacy of assumption. A set of conclusions can be undone once any of its fundamentals is proved false. In this case, the observation of a single black swan negated the long-held presumption about the species. Any logic that followed the assumption that swans must be white was also invalidated by the discovery.

The panel was discussing plans for achieving “Net Zero” to comply with the targets for “Agenda 2030” as dictated by the WEF and its fellow unelected globalist organization – the United Nations.

The WEF and WHO – Are They Running a Death Cult? A WHO / Pharma controlled Worldwide Tyrannical “health system”

A falling tree makes more noise than a growing forest. – A Tibetan proverb

Let's hope the silently growing forest represents a mass-awakening.

From the looks and evidence – ever more visible to even the ignorant – we are living in a Death Cult – a cabal-driven death cult, with a key objective to do away with: eliminate a large segment, if not the majority of the world population.

Who is executing this Death Cult? And on behalf of whom?

Three entities come to mind.

1. The World Economic Forum (WEF)

– a Coligny (lush suburb of Geneva, Switzerland)-registered NGO; a never-voted-for “influencer” organization that has amassed power and money in the hundreds of millions of dollars, like no other NGO around the world. Its founder and eternal chairman, Klaus Schwab (84), is an engineer cum economist, with origins linked to the former Third Reich Nazi-leadership.

By the way, the WEF is holding their annual Davos conference from 16-20 January 2023. The pathology of this outfit and of those elitist billionaires and corporate honchos attending is reflected in this year's even more dystopian agenda. Have a look at the official program.

This is only the visible agenda. None of us, the commons, knows what's going on behind closed doors in special secretive sessions. We feed on leakages, and as Globalism is fading, they become ever more abundant.

2. The World Health Organization (WHO)

– goes as a specialized UN Agency – which in reality it isn't. It was founded in 1948 by Rockefeller, a eugenicist and obsessed globalist, who was (and still is) aiming at controlling the world population through health (and death), and who is hellbent to make the Mother Earth a better place through a One World Order. WHO was then “bought” into the UN system.

At that time, Rockefeller with Standard Oil, had also a monopoly on petrol. He decided that pharmaceuticals, up to the 1950's, mostly based on plants and plant chemistry could be made from petro-chemicals. WHO, according to its bylaws, a disease-preventive health organization, became, thus, largely a curative pharma-based and pharma-pushing organization.

While the bulk of the budget from other UN agencies stems from member countries' contribution, WHO is funded at least to two-thirds or more by the private sector, mostly the pharma industry, as well as the Bill Gates Foundation.

A conflict of interest is more than evident. WHO should not be a UN agency. WHO – against its scientific staff's better knowledge — has declared Covid as a deadly pandemic, spreading fear, imposing lockdowns, face masks, social distancing and more human-denigrating measures.

Eventually, WHO, strongly nudged by the WEF (and the powers behind the WEF) was coercing governments to “vaccinate” their populations with never-before tested genetically-modifying mRNA injections, of which nobody but the producing pharmaceutical industry knows the composition – contents that has turned out deadly for tens of millions of people and mounting.

By the end of 2022, excess mortality in western countries amounts to between 15% and 25% — in some countries even higher.

All of the western used so-called vaccines are, in fact, bioweapons.

This horrendous vaxx fraud is also a multi-billion, if not trillion, bonanza for the pharmaceuticals.

The Covid jabs also contain sterilization agents for both men and women, resulting already by now in drastically falling birth rates in western countries. The term “western countries” means all of Europe and the worldwide Anglosaxonia.

So far, all fits well within the Rockefeller, Gates, Soros, et al's eugenist agenda.

WHO is truth censoring through social platforms – NewsGuard, an organization of “True Journalism”, tracking credibility of news and information websites and online misinformation, provides WHO regularly with lists of the most important “influencers” of “misinformation” in matters of health, alias conspiracy theorists; people who do not conform with the official narrative.

WHO forwards this list to the different social media platforms, requesting them to block the accounts of the “perpetrators”, or to clandestinely hide or limit their social media inputs. This is called “shadow banning”.

WHO works closely with the International Fact Checking Network (IFCN) at the Poynter Institute for Media Studies, a non-profit journalism school and research organization in St. Petersburg, Florida. The IFCN has a databank with more than 10,000 “fact-checked false information”, most of them related to WHO dictates.

IFCN is mainly funded by the U.S. State Department, the National Endowment for Democracy (NED), the Bill and Melinda Gates Foundation, Soros Open Society Foundation, Google and Facebook. Coincidentally, the Gates Foundation and the U.S. government are also the biggest donors of WHO.

This WHO censoring information can be read in full in German, under Point 5 here.

To top it all off, WHO is currently preparing a so-called Pandemic Treaty. Under this Treaty, if approved, WHO's DG would have the power to declare worldwide pandemics as he, alias the ruling class, sees fit to control the masses. Compulsory vaccinations could be military enforced. This would be an authority above each of the member countries' National Constitution. So far trial votations have not succeeded, as several country blocks, for example, in Africa, do not agree.

But the beat goes on with coercing and potentially bribing of country delegates. A final vote should take place in the course of 2023. If approved, the lawless Pandemic Treaty rule should enter into effect at the beginning of 2024.

If so, this is a call on each WHO member to leave WHO.

3. The North Atlantic Treaty Organization (NATO)

– has long ceased being a defense alliance of North Atlantic countries. It has become a worldwide war machine with access and use of some 850 US military bases around the world.

NATO is not only a multi-billion-dollar income generator largely for the US military industrial complex (MIC), but it is also an important US GDP engine, contributing an estimated 30% of the U.S. GDP, counting all NATO-related and dependent industries and services.

NATO is the provoker, funder and main executer of the Ukraine-Russia war – the US-Russia proxy war. Its expansionism has become a monster octopus, stretching its tentacles completely and all-controlling around Mother Earth.

Other than non-stop provoking Russia, NATO also fulfills a role in the Great Reset / UN Agenda 2030 eugenist agenda, as killing is one of its chief purposes.

NATO enters any territory where the “conventional” media lie-machine, and social engineering are failing or not completing their people-ordaining goals fast enough. Be aware, NATO is ready for weaponized interference wherever a “human conflict” cannot be resolved by the WEF / WHO oppressive tyrannical means.

We, the People, of the world have largely only little or no saying in how our world, our countries, even our communities are run. And this already for several decades.

In the last three years, the common people's exclusion from what is still sold as a democratic process has reached a pinnacle. With the onset of a fake pandemic at the beginning of 2020 – the beginning of an agenda long ago planned, the UN Agenda 2030 — the beginning of the larger Agenda 21 (all of the 21st century), officially decided at the UN Environment Conference in Rio in June 1992 – the so-called United Nations Conference on Environment and Development (UNCED), also known as the ‘Earth Summit’.

Manipulated energy shortages, a proven combined manipulation of “sanctions” on Russia, and the worst western government-sponsored terror sabotage act in recent history, the torpedoed Nord Stream 1 and 2 gas pipelines under the Baltic Sea from

Russia to Germany. Russian hydrocarbons, mostly gas, provided at least 40% of all of Europe's energy uses.

Engineered food shortages, leading to famine – and a new artificial toxic way of food production; geoengineered crop-destroying weather catastrophes; food staple speculations; forced supply-chain disruptions and more are responsible for “food shortages”. The world can produce enough food for at least ten billion people, see this; it's a mere question of banning speculation and introducing a just food distribution system;

Compromised banker's engineered hyper-inflation, leading more rapidly to poverty; crisis after crisis caused demolition of the western economy, bankruptcies, unemployment, poverty, unaffordable food and / or housing, disease and death – genocidal death.

Worldwide network of **5G** microwaves – and would you believe, and soon to come all-controlling, potentially deadly Sixth Generation (**6G**), whose target date is coverage of the entire planet by 2030.

Absolute control – via the all-invasive QR code. See this.

Digitization of everything, the objective of Klaus Schwab's designed 4th Industrial Revolution (see this), including

Digitization of money – may result in turn-on, turn-off money, expiring money, blocked or canceled money for misbehavior, potentially resulting in lack of sustenance for non-behaviors, no food, no energy, no housing – disease – death

Digitization of your brain – transhumanization, robotization, social engineering of the masses, as well as the individual (see Daniel Estulin's *“Tavistock Institute – Social Engineering of the Masses”*)

God said, I need somebody willing to get up before dawn. Fix this country. Work all day. Fight the Marxists. Eat supper. Then go to the Oval Office and stay past midnight. And a meeting of the heads of state. So God made Trump.

I need somebody with arms strong enough to wrestle the deep state, and yet gentle enough to deliver his own grandchild. Somebody to ruffle the feathers. Tame the cantankerous World Economic Forum. Come home hungry. Have to wait until the First Lady is done with lunch with friends. Then tell the ladies to be sure and come back real soon and mean it. So God gave us Trump.

I need somebody who can shape an ax but wield a sword. Who had the courage to step foot in North Korea? Who can make money from the tar of the sand turned liquid to gold? Who understands the difference between tariffs and inflation? We'll finish this 40 hour week by Tuesday noon, but then put in another 72 hours. So God made Trump.

God had to have somebody willing to go into the den of vipers. Call out the fake news for their tongues as sharp as serpents. The poison of vipers is on their lips. And yet. Stop. So God made Trump.

Moreover, the video Trump shared erroneously states that God made him to *"Tame the cantankerous World Economic Forum;"* but in 2020 when Trump visited Davos, Switzerland, he told the press, with founder Klaus Schwab standing next to him, *"We look forward to being here. King Charles 'calls emergency meeting' with William, Kate amid abdication rumors

King Charles reportedly decides to leave the throne for Prince William

King Charles could abdicate to Prince William!

King Charles has reportedly decided to abdicate to his eldest son Prince William following in Queen Margrethe of Denmark's footsteps who's set to step down as monarch on January 14.

"The 75-year-old monarch has summoned a meeting with the Prince and Princess of Wales to discuss the future of the monarchy," an insider has claimed.

"The King, who's a caretaker of the throne for his eldest son, will ask William and Kate to prepare for their future roles," they added.

Some are giving examples of the abdication of Beatrix of the Netherlands to Willem-Alexander in 2013. They are claiming it was an ideal precedent. It prompted an outpouring of gratitude for her reign, a welcome for her son and a stronger monarchy as a result.

Beatrix, 85, is a member of the Dutch royal house who reigned as Queen of the Netherlands from 1980 until her abdication in 2013. Beatrix is the eldest daughter of Queen Juliana and her husband, Prince Bernhard of Lippe-Biesterfeld. Upon her mother's accession in 1948, she became heir presumptive.
