UN Chief António Guterres Advocates for "Sustainable Development Goals" (Including Digital ID) and Enhanced Data Sharing at WEF 2024

UN Secretary-General Antonio Guterres is in Davos these days for the annual World Economic Summit (WEF), and his address at one of the panels has been in keeping with the meeting's agenda(s) - but also, clearly, those recently forcefully pushed by the world organization.

Among the schemes Guterres spoke about are the UN's Global Digital Compact and the Sustainable Development Goals.

The first consists of several proposals, including digital ID that is linked to people's bank accounts, while the second, overarching one, that enjoys the support of some of the world's most powerful countries, also involves digital ID, and UN's "vision" of disinformation moderation (also known as censorship).

Guterres said that Global Digital Compact would be a major contributor to what he called *"the digital connectivity gap."* Referring to the overall project as multi-stakeholder, the UN chief noted that *"AI"* would play a role in building the public and private sector's capability of a *"networked governance model."*

More data sharing seems to be at the heart of all this, while in order to keep control over the way *"AI"* is used in the future, Guterres and his team want to see governments and (private) tech companies work together.

All these initiatives will feature at the *"Summit for the Future"* this coming September. One idea voiced by Guterres is to make globalist organizations - such as G20, international financial institutions, and the UN itself, even closer.

A recent UN Policy Brief discusses the complex *"pyramid"* of initiatives, where until now something called *"Our Common Agenda"* (of which Global Digital Compact is one mechanism) was designed to accelerate Sustainable Development Goals.

Now, there is also the move to bring G20 and others into this play - likened in some reports as an economy-oriented counterpart to UN's Security Council.

And the fear here becomes the effect it may have on the international banking system - and in the process, of people's financial liberties. As for the Global Digital Compact, it looks like yet another dystopian iteration of an idea that is cropping up all over the world in different forms.

With digital ID as an unavoidable component, it would create a centralized - therefore easily controlled - network of citizens.

Breaking down the coming \$20 trillion Debt Tsunami

Tony Fauci should be in a prison cell in Wuhan right now given how much responsibility he bears for destroying U.S. government finances.

This guy was one of the chief architects of the hysteria that took over the U.S. (and much of the world) back in 2020.

Yet he now admits, according to recent Congressional testimony, that his infamous six-foot social distancing edict “**sort of just appeared**” and was “**not based on any data**”. But it was precisely those sorts of claims that prompted politicians to close schools and business across the country, and to pay people to stay home and NOT work.

The financial results of this insanity are clear; the U.S. national debt increased by an unbelievable \$6.5 trillion during 2020 and 2021. And while there is a lot of blame to go around– politicians had ample time to find their intellectual courage– Fauci is extremely culpable.

Now, the U.S. fiscal situation was already in bad shape prior to 2020. I remember back in 2019, when the economy was booming and federal tax revenue was at a record high, the U.S. national debt STILL increased by more than \$1 trillion that year.

And I wrote to our readers wondering– if the United States government still manages to add \$1 trillion to the national debt when everything is awesome, what’s going to happen when there’s a real emergency?

Well, Tony Fauci gave us the answer the following year.

But even now that Covid is over, government overspending is still extreme. And it’s not getting any better.

I’ve been writing about this a lot lately, but today I need to explain where this is headed, and why it’s so inflationary.

Consider that, according to the Congressional Budget Office’s own forecasts, **the United States will add another TWENTY TRILLION DOLLARS to the national debt through 2033.**

Now, 2033 is a REALLY important date, because it also happens to be the year that Social Security’s primary trust fund completely runs out of money. Should you be on Social Security it should be of great concern to you, especially if you are not a Christian.

Social Security is funded in large part by workers who contribute a portion of their paychecks into the program through the FICA/payroll tax.

Social Security uses that tax revenue to pay monthly benefits to retirees across the country. And any surplus left over is rolled into a special trust fund.

Over time, the accumulated surplus in the trust fund amounted to roughly \$3 trillion dollars; and all that money was invested in interest-bearing government bonds.

Between the payroll tax contributions and the trust fund's interest income, Social Security always ran a healthy surplus. Until recently that was true.

Starting back in 2020, there were so many retirees receiving Social Security benefits that the program barely broke even for the year.

The following year, 2021, was even worse. Social Security ran a deficit for the first time ever and had to dip into its trust fund to make ends meet.

This trend kept up in 2022 and 2023 as well. In fact, the program loses so much money now that its trust fund is shrinking rapidly, and Social Security projects it will fully be depleted by 2033.

One of the many, many reasons this is so important is because **Social Security will no longer be a BUYER of U.S. government bonds**. It will be a SELLER. And that's a big deal.

For the past 90+ years, Social Security always invested its annual surplus into government bonds... which essentially gave politicians an extra pile of cash each year to spend.

But now this cash flow will reverse. Instead of Social Security sending its surplus to the Treasury, the Treasury Department now must repay the debt that it owes to Social Security.

This nearly \$3 trillion repayment will happen gradually over the next ten years. And then, of course, in 2033, Social Security will be out of money and require a multi-trillion-dollar bailout.

Unfortunately, the Treasury Department doesn't have the money to repay this \$3 trillion debt, let alone another \$5 to \$10 trillion to bail out Social Security.

This means that, **in addition to the \$20 TRILLION in new debt** that the CBO is projecting over the next ten years, the Treasury Department will have to borrow an **ADDITIONAL \$3 trillion** to repay Social Security. And then even more to bail out the program. Don't count on that happening in our lifetime!

(So, this means that the government will need to find someone to buy \$23++ trillion of government bonds over the next ten years... which is just an absurd amount of money.)

And it will have to do this at a time when it has lost some of its biggest investors; again, Social Security can no longer afford to buy bonds. And many of America's biggest foreign bondholders, including China and Japan, are also not buying any more bonds.

So, who is going to buy all this new debt?

The only realistic option is the Federal Reserve. And this is nothing new for the Fed.

During the pandemic, for example, the Fed magically created about \$4 trillion in new money; and then used that money to buy U.S. government bonds. Of course, their \$4 trillion in new money also helped create the highest inflation in four decades.

So, if buying \$4 trillion of government bonds led to 9% inflation, what's going to happen when the Fed has to create \$20+ trillion to buy government bonds?

And by the way, the CBO's \$20 trillion estimate on new government debt is probably a bit too optimistic. It assumes there will be no new war, no pandemic, no national emergency, and no idiotic legislation that causes even crazier spending.

If any of those were to happen over the next decade, the increase to the national debt would be even higher... meaning the Fed would have to create even MORE money.

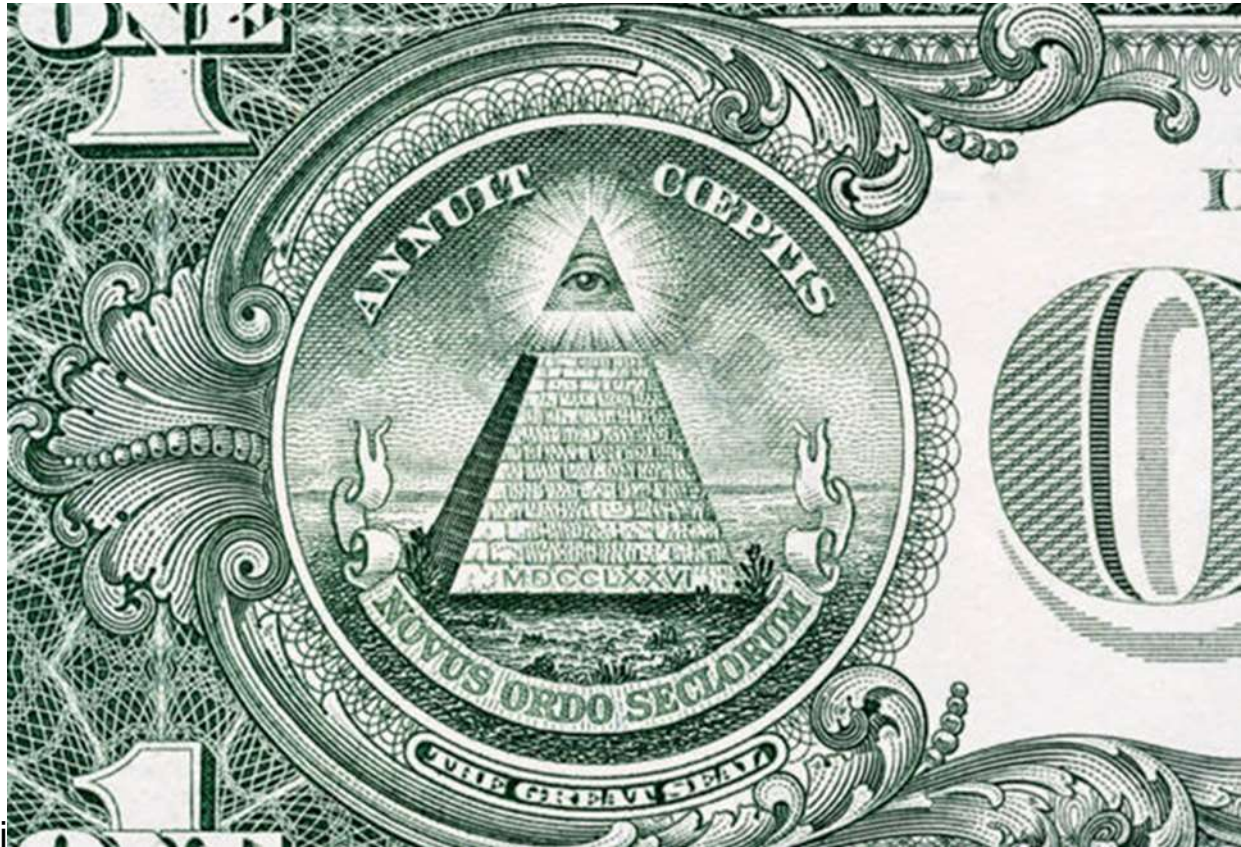
\$20+ trillion is a ton of debt. And with no other realistic option other than the Federal Reserve to buy that debt, it's easy to make a very strong argument for substantial inflation a few years down the road.

This National Debt report is directly connected to the unfolding story of the Pyramid on the back of the U.S. Federal Reserve Note which is about to crash; intentionally as soon as this year of 2024!

In Blessed Hope #284, I closed by drawing your attention to the picture below. You can learn a lot about **Freemasonry = Satan's Earthly Power Base** through their "hidden in plain sight" use of symbols, signs, numbers, and related devices to communicate their agenda.

In the illustration of the "unfinished" pyramid on the back of the U.S. One Dollar Federal Reserve note, each block represents a 7-year cycle. The bottom foundation block was laid in 1776 with the creation of the U.S.A. There are 13 rows in the "unfinished" pyramid ($13 \times 7 = 231$ Years). The next period is the 14th row or the placement of the **All-Seeing Eye pyramid of Horus**. Even the All-Seeing Eye is referred to by many terms; i.e. Eye of God; the Eye of Providence; the Eye of Providence has also been associated with the Freemasons, and thanks to films, such as the 2004 "National Treasure", starring Nicolas Cage, conspiracy theories linking the Freemasons with the

founding of the United States have been popularized. According to ancient Egyptian mythology, Horus lost his left eye during a battle with his uncle Seth. This eye was magically restored by the goddess Hathor, who is believed to have been either Horus' mother or wife. Thus, the Eye of Horus became a symbol of healing.



There has been known for a number of years that this view of the “uncapped” Pyramid on the back of the One Dollar Federal Reserve Note is part and parcel of what some call “The Expiration Date Theory” but based upon the Encrypted “13 Step Period of Time” as depicted in the Masonic Reverse Seal of the U.S. One Dollar bill. As this study suggests, such entities and agencies are one in the same that have usurped the U.S. monetary system since 1792. It was at that time that the U.S. gave away its Monetary Rights to the Private Banks that printed and issued the People’s Money, with Interest charged for a nation and to always be in perpetual Debt. This Act is known as the Coinage Act of 1792.

The Coinage Act of 1792 (also known as the Mint Act; officially: An act establishing a mint, and regulating the Coins of the United States), passed by the United States Congress on April 2, 1792, created the United States dollar as the country's standard unit of money, established the United States Mint, and regulated the coinage of the United States. This act established the silver dollar as the unit of money in the United States, declared it to be lawful tender, and created a decimal system for U.S. currency.

What followed was a series of three charters for a National Bank. **The current Federal Reserve System is the third central banking system in United States history.** The First Bank of the United States (1791–1811) and the Second Bank of the United States (1817–1836) each had a 20-year charter. Both banks issued currency, made commercial loans, accepted deposits, purchased securities, maintained multiple branches and acted as fiscal agents for the U.S.

The U.S. Federal Government was required to purchase 20% of the bank capital stock shares and to appoint 20% of the board members (directors) of each of those first two banks "of the United States." **Therefore, each bank's majority control was placed squarely in the hands of wealthy investors who purchased the remaining 80% of the stock. These wealthy investors were European Rothschild-owned or controlled banks. These banks were opposed by state-chartered banks that saw them as very large competitors, and by many who insisted that they were in reality banking cartels compelling the common man to maintain and support them.**

President Andrew Jackson vetoed legislation to renew the Second Bank of the United States, starting a period of free banking. Jackson staked the legislative success of his second presidential term on the issue of central banking. *"Every monopoly and all exclusive privileges are granted at the expense of the public, which ought to receive a fair equivalent. The many millions which this act proposes to bestow on the stockholders of the existing bank must come directly or indirectly out of the earnings of the American people,"* Jackson said in 1832. Jackson's second term in office ended in March, 1837 without the Second Bank of the United States charter being renewed.

In 1863, as a means to help finance the Civil War, a system of national banks was instituted by the National Currency Act. The banks each had the power to issue standardized national bank notes based on United States bonds held by the bank. The Act was totally revised in 1864 and later named as the National-Bank Act, or National Banking Act, as it is popularly known. The administration of the new national banking system was vested in the newly created Office of the Comptroller of the Currency and its chief administrator, the Comptroller of the Currency. The Office, which still exists today, examines and supervises all banks chartered nationally and is a part of the U.S. Treasury Department.

In essence, with the passage of the Coinage Act of 1792, the nation became subservient to investors outside of the nation in Europe. The words appearing on this portion of the One Dollar Federal Reserve Dollar are ambiguous in their meaning at best; but at the end of the day confirm that the U.S. was a Freemasonic creation.

Above the All-Seeing Eye is the Latin phrase ANNUIT COEPTIS.

Translating ANNUIT COEPTIS

ANNUIT means to nod assent, to favor, to smile upon.
COEPTIS means undertakings, endeavors, beginnings.

Annuit Coeptis means "favors (literally, gives the nod to) undertakings." The subject must be supplied. Who favors? The Eye (Providence) does.

The verb Annuit can be either present tense or perfect tense, therefore an accurate translation of the motto is: "Providence favors our undertakings" or "Providence has favored our undertakings." (The word "our" is supplied.)

It has also been translated as: "He favors our undertakings" or "He has prospered our endeavors." The meaning of this motto is better understood when seen in its original classical context. The Freemasons will tell you that "He" refers to God; but it does not identify it as the God of the Bible. The reader is left to his own conclusion about who this deity is.

Accompanying the phrase "Annuit Coeptis" is another Latin phrase: "Novus Ordo Seclorum," which is a contraction of "Novus Ordo Saeculorum." According to 'Liberty Magazine', this phrase translates in Classical Latin as "new order of/for the ages." This idea of the saeculum goes back centuries BC; it came to the Romans, and into Latin, from the Etruscans. The Roman had Saecular celebrations originating from a notable year. The term "Novus Ordo Saeculorum" actually means "A New Secular Order" without a religious foundation.

Above the Latin phrase on the base of the pyramid, is a Roman numeral that demystifies the phrase. The numeral is **MDCCLXVII**, which in Roman numerals, is **1776**. Most will recognize this as the year the United States declared independence from the British Empire. Coincidentally it is also the year Adam Weishaupt birthed the Illuminati on May 1, 1776. Most people do not know that we have never been free of the British Empire and the secret is in the details of the War of 1812. **The War had no formal surrender or a declared victor.**

We are told that the 13 layers or blocks of the pyramid represent the 13 original colonies. Again, the meaning is obfuscated by intention to mislead the public. The number 13 is really about the Encrypted "13 Step Period of Time".

- 1792 + 7 Years (Sabbatical Cycle) x 33 = 231 years = 2023

- 1793 + 7 Years (Sabbatical Cycle) x 33 = 231 years = 2024

- Excluding End Year. Thus, 33rd Sabbatical Cycle was from 2015-2022

- From 1792 Coinage Act to 2015 Year of Light (2015-16) = 223 years (Skull & Bones 322) (Genesis 3:22)

- 33rd Sabbatical Cycle started in 5776 (2015-16) then 1776 to 2015 = 239 Years

- 239 / 13 'Steps' of the 'Pyramid' = 18 Periods (6-6-6)

To reiterate, the premise of this concept is that the Luciferians, Freemasons, and Jews have incorporated such a Spiritual Principle of 33 Sabbath Cycles of 7 Years since the Coin Act of 1792. From the Year after, it has been a Countdown to the Expiration Date of how long the U.S. Dollar's Shelf Life would be lasting. It is a conjectured economic timeline for the U.S. of when perhaps it is to Imploded or to Fall Economically. It is for the purpose to allow the subsequent New World Order 'Phoenix' to rise from the ashes. The Point here is that there has been a Cabal that has usurped the U.S. Political, Social, Economic, and Educational system that has synchronized a similar timeline to the world markets and specifically for the U.S. to run its course. What is that end year? That End Year is 2023! The parallels are striking at first glance.

If this is correct as I believe it is could then mean that 2024-25 will be the Year; and at some Point in Time when the Federal Reserve will 'Pull' the backing of the U.S. Dollar in favor for their New Monetary Reset. Klaus Schwab and HRH Prince Charles liken this Great Reset as the New Dollar to be a CBDC or a computer digital currency instead and highly devalued. It will essentially make the once Mighty U.S. a 3rd World nation with food lines, rampant crime, lawlessness, an underground economy or Black Market. Traitors within the administration have allow thousands to enter this country weekly through the Southern Border to overwhelm the social fabric of the country as a method of bankrupting government as part of this plan to destroy the national currency.

Food will be rationed and scarce. It will be of the likes of Cuba, Venezuela and most War-Torn Nations with Despot Wealthy Rulers. And who will be armed? Not the Average Citizen as guns will be confiscated. Then those not capitulating to the Great Reset and the Mandatory Injections will be 'Quarantined' for 'Their Own Safety'. Most likely, such will be in FEMA Detention Centers that now include any Local, State and National Assembly Halls. Governors have mandated such Facilities to include places such as Recreation Centers at State Universities, Gyms, Town Halls, Lodges and Civic Centers, etc.; even former Walmart's that have closed. Why? The coming New World Order Great Reset is for only those that will and can accept/submit to their Great Reset. Keep in mind that the U.S. Dollar is the world's reserve currency at least so far. When the U.S. Dollar is imploded and intentionally crashed, the world will be crushed as well. Trillions of U.S. dollars are held by nations, businesses, and individuals around 194 countries on the planet.

Thus, the 33 Sabbatical Cycle Pattern since 1792 appears to be clocking America's Lifespan; its Beginning, Climax and 'Expiration Date'. It has been precisely designed by the Luciferian Kabbalists. It is such that they use the very same Divine Timepiece of God to mimic His Holy Feasts and 'Resets'. Their Conspiracy is to Initiate their next World Order out of the Ashes of American imploded 'Phoenix'. When? The Coinage Act of 1792 is the clue. This Act was instituted after the U.S. became a Constitutional Republic and started to Coin its own Currency in Silver. Up until the Revolutionary Era, the Main Currency of the American Colonies was the Spanish Reales that were Minted in New Spain or Mexico. At that time, the U.S. had no Central Bank or a Private 'Federal Reserve' that Thomas Jefferson had warned about.

Alexander Hamilton was Pro-Bank of England and sold-out the Nation. It is the sole responsibility of the Department of the Treasury to issue Currency, Interest Free to its own Government; backed by Gold and/or Silver. As one can sense, the Numerology of the Luciferians, Kabbalists, and Freemasons are all over this 'Expiration Date' for America, if True. As it is, they have diminished the Value of the Fiat U.S. Dollar since being taken off the Gold Standard in 1971 by President Richard Nixon.

Currently, the U.S. Dollar is backed by nothing and all owned by the Federal Reserve. It is a Luciferian Rothschild's International Conglomerate of Central Banks that is not American and boasts to be the Highest Law of the Land. It is also without any Oversight and Auditing by the U.S. Congress. It is these Bankster's that have pegged their Economic Manipulation of the Markets to their Shemitah Cycles as they did in Ancient Israel, because they are one in the same. For the most part, they are the Money Changers Types as Jesus called them. Such are the Types that conspired to murder Jesus for 'Interrupting' their Tower of Power, their 'Great Work'. What Work was that? In part, it was and is to complete Nimrod's Temple. The other 'Work' was to make God's House a Den of Thieves; to Steal from and abuse God's People with. But Jesus exposed them as being the 'Synagogue of Satan' in Revelation 2:9 and 3:9; and who's God is 'Mercury', the Patron of all thieves, etc. Abraham Lincoln and John F. Kennedy paid with their life in their attempts to take back control of the issuance of debt-free money from the House of Rothschild.

Jonathan Cahn and Mark Biltz have demonstrated the Shemitah Cycles were designed by God to track time; that at the End of the 7th Shemitah Cycle of 7 Year or 49 Years, that all Debts, Slaves and Properties were to be cancelled on the 50th year of Jubilee. God's 'Economic Reset' was to occur then to ensure no Economic Collapses occurred and that Debt or Slavery was not to continue in perpetuity.

Such reckoning of time established by God was to avert what is about to occur in the USA in 2024-25 with the Great Reset. In the case of Ancient Israel, the Elders did not comply. The Elders who sat in Moses' Seat never had the intention of keeping this Portion of the Law. They instead became greedy and did not want to lose their Power, Profitability and Revenue. This would not have been the case as God promised a Double Portion in the 6th Year of the Shemitah cycle to cover the needs for the Sabbath Cycle of rest for the land.

For that reason of the Elder's Disobedience, the whole Nation of Israel had to 'Expire', temporarily. The Nation was exiled, taken captive into Babylon until every Sabbatical Cycle was accounted and paid for. There is yet a 7-Year that is still Outstanding. That is called the Tribulation Period or Daniel's 70th week of Daniel 9:27; that will commence soon after the End of the Church Age concludes with the Rapture Event, etc. The Promised Land rested for 70 Years. And it was the amount owed by the Money Changers who refused to abide by God's Economic Policies. They instead indebted the whole Nation and it resulted in the Enslavement of the entire People. This is exactly what have been their Protocols for every Nation they have subverted. And this

enslavement will also occur again for the U.S. It has since because the U.S. sourced-out the Printing of the Money Supply to a Central Bank.

The U.S. National Debt incurred through the Bankster's Economic Schemes is owned by foreign Nations and they will one day soon come calling to collect their due -all by design. It will mean the acquisition of any and all Property, Assets, Collateral, Land and Commodities the U.S. has. Inflation will skyrocket, even more than it already is for the average American that has seen food prices triple and unemployment reach Depression Era Levels due to the forced Lock-Downs. California began the new year of 2024 with a minimum wage of \$20 an hour; my granddaughter in college recently took a position at Star Bucks located inside a Kroger superstore for \$15 an hour. My first job at the age of 14 was for a Pittsburgh 'Giant Eagle' grocery store was at a minimum wage of .38 cents an hour back in the early 1950s. So, when Klaus Schwab says, "You will own nothing, and enjoy it", you will know why this is their ultimate end game.

So, could 2024-25 then be the 'last years' just before the Great Reset is made? What does this then mean prophetically for those that study the End Times and Watch for the Rapture?

This is how I understand what is on our door steps. It means that the Rapture of the Bride of Christ occurs just before the collapse of the Dollar and the implementation of the CBDC or digital dollar that starts the 70th Week of Daniel. If not in 2024, it can't be too far out in 2025. This is it if the '33rd Degree Sabbatical Cycle' does indeed end the U.S. Dollar Dominance. Because of the Hebrew calendar difference, we are still three months until 5784(2024) begins. As of mid-January, 130 countries are ready to launch their own CBDC's. The European Union is the most advanced in their CBDC digital currency! Switzerland is now in life-changing reality between six major Swiss banks.

It could also mean that the Tribulation Period would then have to coincide with the Year after. How so? It is because the subsequent Sabbatical Cycle, that of 2025-2032 Timeframe of 7-Years could very well be Daniel's 70th Week of Years. But realize that one is conjecturing an overlap of the Sabbatical Cycle with the Shemitah Cycle of a 3.5 Year Difference. But one thing is for sure, after the 7-Year Tribulation Period, Jesus returns to Earth with His Bride the church. It will be at that time that Jesus will initiate His True Great Reset of the entire World and Humanity. It will be initiated with a True New World Order called the Millennial Kingdom.

Until then, it looks like 2024-25 will be the Turning Point and the intensification or the worst part yet to come as it leads to the Transformation and 'Reset' of the Luciferians after the Rapture Event. In that New World Order, it will not be a single Nation like the U.S. that will rule the World. It will be a 10-Nation Confederation in the long line of the 4th Beast of Daniel's Dream, being Rome 2.0. Realize that it will not be a 'Revived Roman Empire' as many have coined it. The Roman Empire never went away. It only reverted into its Ecclesiastical rendition, being the Vatican in Rome and the Orthodox in Constantinople or now called Istanbul. Thus, out of this configuration, the 'Nimrod' of the 'Resettlers' will arise from its territory, wherever that will be as each New World Order

will have its 'New Phoenix' political system along with a 'New Humanity' and Luciferian Hybrid Abrahamic Religion. The Luciferian Cabal will nevertheless continue in the quest to dehumanize humanity and deface it with the image of Lucifer inside, instead through DNA Alterations. It will be their 'Nimrod' Prince that will finish their interrupted or Truncated Pyramid or Tower of Babel. But once again, God will put a stop to that.

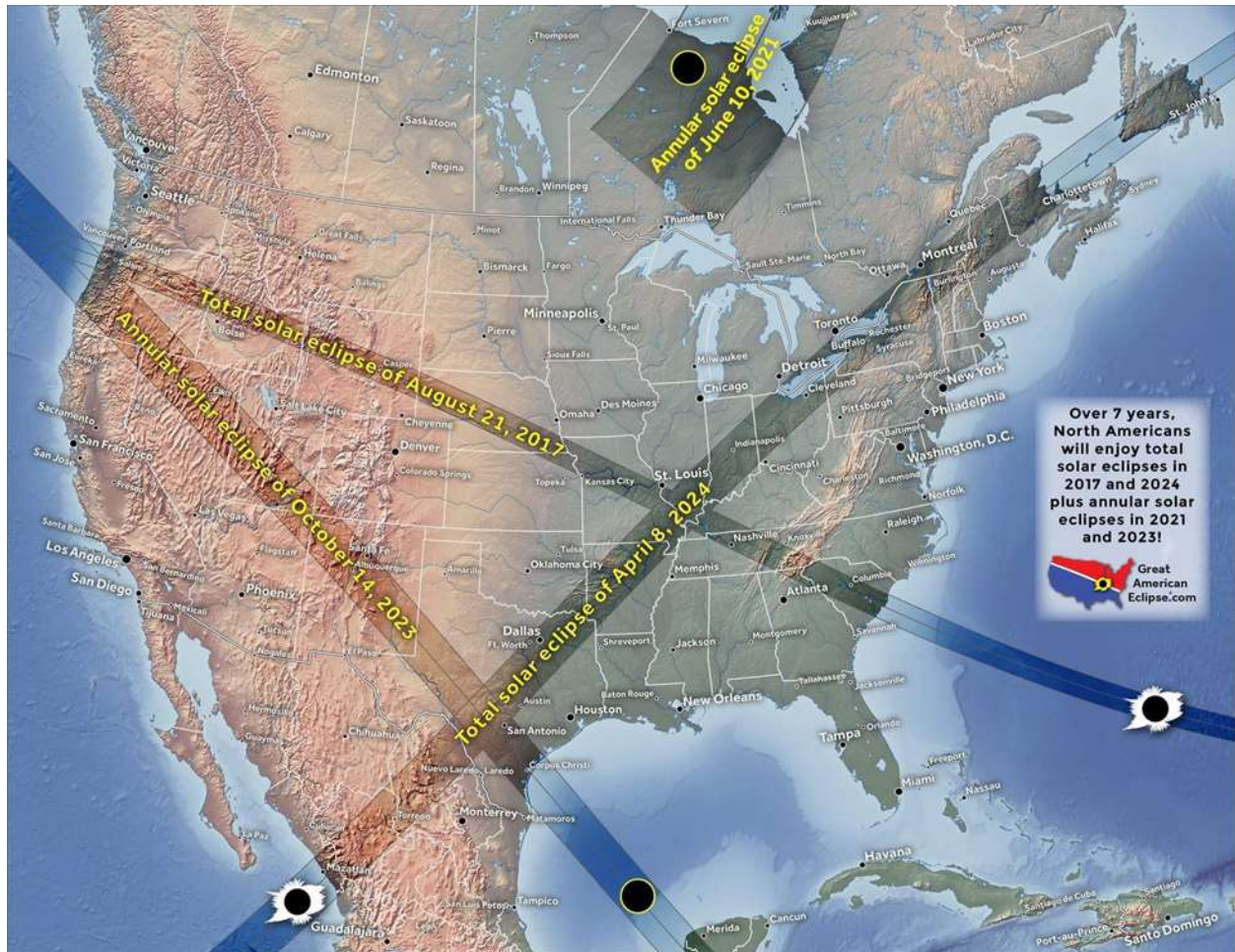
The 33rd Sabbath corresponds to the Year 2023. It was the 1st Year of the 2022-2029 7-Year cycle that is called the Shemitah. The issue is that the Jewish New Year starts in the Fall but God's Biblical begins in the Spring. Does this then play into the warning that Treasury Secretary Janet Yellen has made in September of 2021? If the USA did not authorize the raising of the Debt Ceiling, the USA will be unable to pay the Interest on its Debt. This became crucial to see if it will occur or if 2024 will be when they 'Pull of the Plug' on the U.S. Dollar. One could see their Great Reset start in 2024 or 2025. This would corroborate with one's 2025-32 Timeline.

To better understand the implications of this we need to be aware of an unusual event, we have been under a cloud of celestial judgment. I am speaking about two Solar eclipses that are just short of seven years apart. Two Solar eclipses leave an "X" crossing the mid-section of the U.S. for the 2017 and 2024 eclipses, "X" marks the spot over Cedar Lake in Jackson County, Illinois. Historically total solar eclipses have been signs of death and misery. A harbinger of doom, war and suffering.

The Solar eclipse slated to take place on April 8th, 2024. This comes after the August 21st, 2017 Solar eclipse that crossed the country from northwest to southeast. The Solar eclipse that will occur in April of this year follows in an opposite direction from the southwest to northeast. Ancient astronomy indicates foreboding events when Solar and Lunar eclipses occur. We are just 77 days from the next Great Solar Eclipse.

This series of celestial judgment that occurred in the 2017, 2023, and 2018 suggests that the collapse of the U.S. monetary and financial system will occur on or around April 8, 2024. This year April 9th, 2024 is the beginning of the Hebrew year of 5784 or 2024. Technically, the Biblical calendar is still the Hebrew Year 5783 of the secular year 2023 since Nisan 1 begins the Hebrew year 5784 on April 9, 2024. The calendar issue is confusing for most Christians and as Mark Biltz always say, we have to get on God's calendar to understand what God is telling us.

Rosh Chodesh Nisan 2024 / 5784 רֹשׁ חֹדֶשׁ נִסָּן is the start of month of Nisan on the Hebrew calendar. Rosh Chodesh Nisan for the Hebrew Year 5784 begins at sundown on **Monday, April 8 2024** and ends at nightfall on **Tuesday, April 9, 2024**. The start of month of Nisan on the Hebrew calendar. נִסָּן (transliterated Nisan or Nissan) is the 1st month of the Hebrew year, it has 30 days, and corresponds to March or April on the Gregorian calendar. רֹשׁ חֹדֶשׁ נִסָּן, transliterated Rosh Chodesh or Rosh Hodesh, is a minor holiday that occurs at the beginning of every month in the Hebrew calendar. It is marked by the birth of a new moon.



As the map shows two Solar eclipses and one Annual Solar eclipse that occurred on October 14, 2023.

The paths of three eclipses combine to form a giant “Aleph” over America, and hardly anyone knows about this. But is the fact that a giant “Aleph” will soon be completed over the United States significant?

In the 21st chapter of Luke, Jesus warned us that **“there shall be signs in the sun, and in the moon, and in the stars”** in the last days.

On **August 21st, 2017** the “Great American Eclipse” made headlines all over the world. It was the very first solar eclipse since 1918 that was able to be seen all the way from the west coast to the east coast. In the U.S., the path of the eclipse started in Oregon, it continued all the way across the continental United States, and it exited the country in South Carolina. My wife and I watched it from our kitchen porch and as it occurred all of nature around us was dead silence.

On **April 8th, 2024** another “Great American Eclipse” will make headlines all over the planet. The path of this eclipse will cross over the states of Texas, Oklahoma, Arkansas, Missouri, Illinois, Kentucky, Tennessee, Michigan, Indiana, Ohio, Pennsylvania, New

York, Vermont, New Hampshire and Maine. If you plot the paths of the 2017 eclipse and the 2024 eclipse on the same map, you will clearly see that they combine to form a massive “X” right over the heartland of the continental United States.

The precise intersection formed by the Great American Eclipse of 2017 and the Great American Eclipse of 2024 covers portions of the states of Kentucky, Illinois and Missouri.

But there was even more to the story. On October 14th, 2023 an annular solar eclipse crossed the United States from Oregon to Texas.

If you overlay the path of that annular solar eclipse on top of the paths of the Great American Eclipse of 2017 and the Great American Eclipse of 2024, you will see that those three eclipses actually combine to create a giant “**Aleph**” across America. The 2017, 2023 and 2024 solar eclipses on the United States make up this celestial sign. That’s God’s signature. **Aleph** is the first letter of the Hebrew alphabet. The **Aleph** in Hebrew has a numerical value of one. The **Aleph** is also representative of God and the oneness of God. The **Aleph** is also made of three lines; Also the number of God; The Father, the Son, and the Holy Spirit. The number three biblically represents divine wholeness, completeness and perfection. This particular **Aleph** is from the Paleo-Hebrew script, also Paleo-Hebrew, Proto-Hebrew or Old Hebrew; the writing system found in ancient inscriptions of biblical Israel and Judah.

So what does all of this mean? We should not overlook the following important facts:

- Ninety days after the last solar eclipse of 1811, the New Madrid fault was hit with a huge earthquake - the biggest quakes ever east of the Rockies hit that area from 1811 - 1812. Thousands of earthquakes continued to shake the area... *"and the tremors continued for decades"*. The War of 1812 followed these massive quakes.
- On December 16th, 1811 was the first huge quake to hit the New Madrid fault following the two great eclipses of 1811 and 1806 that crossed over the New Madrid fault - it was on a new moon - about the time the first sliver is visible.
- If you do a Google search for when the new moon in Jerusalem it will be in October 2023, you will discover that it will be on October 14th. And that is the day when the annular solar eclipse crossed our country from Oregon to Texas.
- If you do a Google search for when the new moon in Jerusalem will be in April 2024, you will discover that it will be on April 8th. That is the very day when the “Great American Eclipse” crosses America and completes the **Aleph**. By the way, April 8th also happens to be the first day of the first month on the Hebrew calendar 5784. In other words, a brand new Biblical year begins on that date.

- Hebrew does not have a word for 'coincidence' so perhaps God is trying to tell us something. Of course He has been trying to warn us in hundreds of different ways, but most people don't want to listen. The signs of the end times are literally being fulfilled all around us, but most of us refuse to see the truth. As a Bible prophecy watcher, I would say they are screaming at us with "staccato" tones so as to get our attention.
- Many in the secular media are talking 'Black Swan' events from war, to an EMP attack, to a financial collapse, and most certainly the Rapture looms as a potential "Black Swan" event that the entire world would be shaken to the core when it happens! It's only a question of when it will happen!

"The Middle East is blowing up. More militias and militaries are launching attacks against more countries, for more reasons, than the region has seen in decades - by some measures, in more than a century, since the breakup of the Ottoman Empire during and after the First World War."

Many of these recent strikes and incursions from the region's most largest, most violent, and contentious current war - the one between Israel and Hamas. But others are only peripherally related, if at all. And a few are downright puzzling."

In any case, the list amounts to what Charles Lister of the 'Middle East Institute' calls *"an insane scale of cross-border conflict."*

So what's going on - Wars and Rumors of Wars?

- Israel attacking Gaza and Lebanon.
- Hamas and Hezbollah attacking Israel.
- Jordan and Iran attacking Syria.
- Iran attacking Iraq.
- Yemen's Houthi's attacking ships in the Red Sea.
- U.S. and Britain attacking Houthi's in Yemen.
- Iran attacking Pakistan. (with ballistic missiles and drones)
- Pakistan attacking Iran. (with Air Force and artillery) (So they've cancelled their joint naval war games now.)
- Pakistan-Iran strike: The reason the Middle East is blowing up.

The Middle East is an arc of failed or failing states. Four countries are mired in civil war. Egypt is teetering on the brink of default (Egypt owes \$29 billion in external debt that needs to be repaid next year), while Lebanon is enduring one of the worst economic crises in modern history. The list of calamities goes on, and the Middle East only looks quiet if one ignores it. But that is exactly what the Biden administration has tried to do.

The Israeli-Palestinian conflict was ignored. Key diplomatic posts were unfilled: The administration didn't bother to appoint an ambassador to Egypt until this March. Last year an American diplomat was asked to describe his country's Syria policy. He

shrugged and laughed. His job, he said, was to keep the Middle East off Biden's desk, echoing words I have heard repeatedly from American officials since 2021.

This was America's flawed conception. It thought expanding the Abraham Accords and reaching a truce with Iran would allow it to disengage from the Middle East (so America could focus on Europe and Asia). But a conflict that America tried to ignore has now pushed the Middle East to the brink of a broader war, fueled by Iran and its proxies. The new Arab-Israel security alliance is nowhere to be found: Most Arab states are too weak to play a role in the crisis, leaving America to rush troops back to a region it wanted to leave. *"Their job was to keep the Middle East away from Biden's desk by supercharging all the 'good' tracks in the region, while pushing away the 'bad' stuff was how one acquaintance, who works on Middle East policy, put it shortly after the Hamas attack."*

Today, the Middle East is back on senile Joe's desk - *"with no plan for dealing with it."*

Things can move quickly over there. Going from bad to worse.

What's most amazing about this, is that NATO repeatedly claims *"We do not seek conflict"* yet step-by-step, they up the ante in supplying weapons to Ukraine. Those Western weapons are being used by Ukraine to attack and kill Russians.

- There are 13 blocks top to bottom on the pyramid.
- Fritz Springmeir in his book The 13 Bloodlines says these 13 blocks represent the 13 Satanic family's. But there is a lot more! A Lot More!
- As is often the case, symbols and numbers will have multiple meanings. With Freemasonry this is a guarantee. These 13 blocks have multiple meanings which hide the real meaning to be explained later. This will lead us to the date of the 'Great Reset' under the leadership of HRH Prince Charles, the WEF and the NWO. In the circles at the end of the hexagram points it even spells the word **Mason**. (image right)



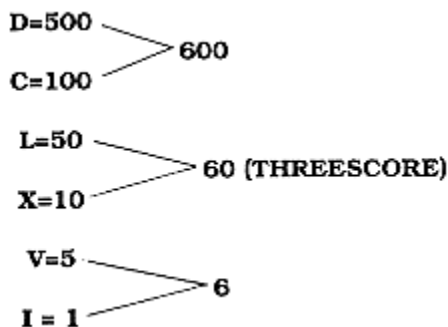
MASON = Freemason

The Roman Numerals at the bottom of the Pyramid:
MDCCLXXVI = 1776

We do not have to add them together to get the MARK OF THE BEAST OR THE NUMBER OF HIS NAME. John does not tell us to ADD THEM TOGETHER. It is not that we cannot add them together, but the point is John does not TELL US TO ADD THEM TOGETHER.

There are 13 stars in the Masons square on the treasury seal on the right.

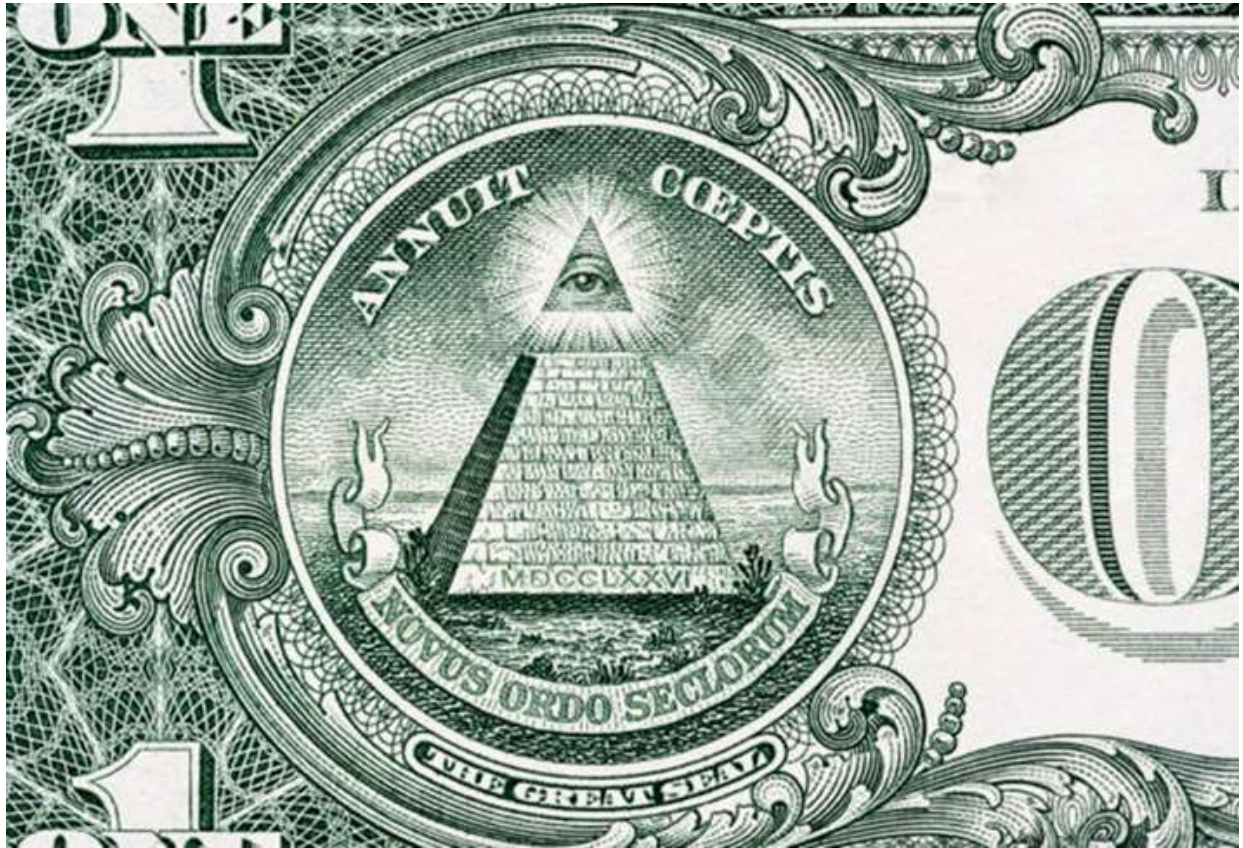
