Before we begin, let's look at what **5G** is. **5G** is the fifth generation of cellular communications. 1G was deployed in the 1980's and it was those old-school phones that only very wealthy people had. These phones were about 6" x 6" x 12", plus or minus a few inches. Many of the people who used these phones a lot had a region in their brain the size of a walnut that had been literally cooked. 2G came after that. 3G is the old-school flip phones from the early 2000's, then 4G and 4G LTE came along. **5G** is the next generation of cellular communications that is rolling out worldwide. 4G LTE offers 10s of Megabits per second (Mbps) where as **5G** offers 100s of Mbps and into the Gigabits per second (Gbps). What does this get you? You are now able to stream high-resolution video over your cellular network.

There are multiple variants of **5G** being deployed around the world. **5G** in China has the data encoded on a 28 GHz microwave carrier. **5G** in Europe is supposed to operate on a 28 GHz carrier. Verizon wants to be like the rest of the world and operate at 28 GHz. The FCC recently auctioned off 37 GHz, 39 GHz and 47 GHz for use in **5G** applications. AT&T wants to operate on 39 GHz. T-Mobile has launched their version of **5G** on a 400 MHz carrier.

You are probably confused by all of this and there is solid engineering rationale behind all of this. Let's start with a simple calculation, wavelength and what wavelength is for some common radiofrequency, microwave and millimeter-wave frequencies.

 $\lambda = v/f$

 λ = Wavelength

v =speed of light in vacuum = 3 x 108 meters/s

f = frequency

Example 1:

Determine the wavelength at 400 MHz.

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 400 \times 106 \text{ Hz} = 0.75 \text{ meters} = 29.5 \text{ inches}$

Example 2:

Determine the wavelength at 850 MHz (Cellular).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 850 \times 106 \text{ Hz} = 0.353 \text{ meters} = 13.9 \text{ inches}$

Example 3:

Determine the wavelength at 1.5 GHz (Global Positioning System or GPS).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 1.5 \times 109 \text{ Hz} = 0.2 \text{ meters} = 7.87 \text{ inches}$

Example 4:

Determine the wavelength at 2 GHz (Close proximity to many 4G LTE Bands).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 2.0 \times 109 \text{ Hz} = 0.15 \text{ meters} = 5.9 \text{ inches}$

Example 5:

Determine the wavelength at 2.45 GHz (WiFi, first resonant frequency of a water molecule/ operating frequency of a microwave oven).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 2.45 \times 109 \text{ Hz} = 0.122 \text{ meters} = 4.8 \text{ inches}$

Example 6:

Determine the wavelength at 5 GHz (WiFi upper band).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 5 \times 109 \text{ Hz} = 0.06 \text{ meters} = 2.36 \text{ inches}$

Example 7:

Determine the wavelength at 14 GHz (Approximate Satellite TV and Internet).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 14 \times 109 \text{ Hz} = 0.021 \text{ meters} = 0.843 \text{ inches}$

Example 8:

Determine the wavelength at 28 GHz (5G in China, Europe, Verizon).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 28 \times 109 \text{ Hz} = 10.7 \text{ millimeters} = 0.421 \text{ inches}$

Example 9:

Determine the wavelength at 39 GHz (AT&T 5G).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 39 \times 109 \text{ Hz} = 7.7 \text{ millimeters} = 0.303 \text{ inches}$

Example 10:


Determine the wavelength at 60 GHz (WiFi, Unlicensed Frequency Band).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 60 \times 109 \text{ Hz} = 5 \text{ millimeters} = 0.303 \text{ inches}$

Example 11:

Determine the wavelength at 90 GHz (Crowd Control machine that makes skin feel like it's on fire).

 $\lambda = v/f = 3 \times 108 \text{ m/s} / 90 \times 109 \text{ Hz} = 3.3 \text{ millimeters} = 0.13 \text{ inches}$



Wavelength is the length of the EM Wave

What is wavelength? It is the length of the electromagnetic wave. From examples 1 through 11, we can see that as we increase frequency the wavelength gets smaller. In general, the longer the wavelength the deeper it will penetrate into your body. The shorter the wavelength the less it will penetrate. 90 GHz penetrates to a depth that makes your skin feel like it's on fire. T-Mobile's 400 MHz **5G** has a long wavelength that will penetrate very deep into your body. Everything else is somewhere in between. Human blood is very good at converting radiofrequency, microwave and millimeter waves into heat. This is the basic premise on which many medical devices work.

These waves will undoubtedly induce currents into nerves, since they are ultimately conductors. We can only speculate what the outcome may be, but the possibilities are near infinite. Anxiety, insomnia, depression, ADHD are all neurological. Disrupting nerve signals and replacing them with radiofrequency waves may also cause things like *Irritable bowel syndrome* and all of these "new diseases" that have emerged in the last 10 or 20 years.

Let's summarize what we have learned so far.

- Lower frequencies have longer wavelengths that penetrate deep.
- Higher frequencies have shorter wavelengths that do not penetrate deep.

Before we get into specifics about **5G** and the coronavirus, let's first talk about how you can protect yourself from these radiofrequency, microwave and millimeter waves. Do not attempt to use metal except in limited applications and circumstances. You can inadvertently set up a cavity resonance by using metal and generate very strong fields and make things worse.

There is also a 7.83 Hz field that exists everywhere in the universe. If you isolate a person from this field by using a thick steel Faraday Cage you will die in about 3 to 4 weeks. Please don't try this at home and, if you do, you were forewarned. If you must completely isolate yourself, an earth-mound house or a house built into the side of a mountain is much safer. It is far better to convert the waves to heat.

Carbon impregnated foam is known to be one of the best and most cost-effective ways to convert radiofrequency, microwave and millimeter waves into heat. Once converted to heat, there is no wave. Use carbon-loaded foam if you can. More is better, but you eventually run into practical limitations. Make sure you do not build perfect square and rectangles to avoid cavity resonances. Alternatively, drywall, wood, fiberglass insulation, books, furniture, mattresses, common glass and all sorts of other common stuff will convert radiofrequency, microwave and millimeter waves into heat.

Remember, lower frequencies penetrate deeper and need more thickness than higher frequencies. **5G** operating at 28 GHz is stopped dead in its tracks by drywall, especially at a humidity level of 55% or 60%. T-Mobile 400 MHz **5G** penetrates deep and blasts right through your house and everything in it. This is why it "travels farther and delivers the strongest signal".

If 5G 28 GHz doesn't penetrate deep into the body, how can they get 5G to activate the coronavirus that is in your lungs?

5G PROPAGATES INTO YOUR MOUTH AND NOSTRILS, DOWN YOUR THROAT AND INTO YOUR LUNGS. IT WILL ALSO PROPAGATE DOWN YOUR EAR CANALS AND EXCITE YOUR INNER EAR, THE NERVES AND THAT ENTIRE REGION OF YOUR BRAIN THAT IS IN CLOSE PROXIMITY TO YOUR INNER EAR.

In example 8, we determined that the wavelength of a 28 GHz microwave data carrier is 10.7 millimeters or 0.421 inches. This small wavelength will propagate through your mouth and nose openings and into your lungs, where there will be small microwave fields and currents. There will also be a lot of heat generated in this process because blood readily converts microwave fields into heat. We are going to analyze this and demonstrate that, yes, this really happens using state of the art microwave field analysis software.

I am sure you are freaking out by now and saying, "OMG, how can I stop this from happening to me?" So, before we get started on the technical deep dive, let's discuss a simple solution about how to stop this.

This is the one instance where we advocate using metal. You can get one of those handy-dandy dust masks that everyone is wearing and cover it with some kind of metalized cloth. Copper Compression Socks can be used for this purpose. A single layer of Copper Compression Sock material covering your mouth, nose and ears will greatly reduce the 28 GHz field and offer a lot of protection. Do not wrap the cloth around the back of your head. Creating a metalized cylinder offers the opportunity to create cavity resonances, and your head will happen to be in the middle of the resonator. This is bad and we want to avoid this. Use enough to be effective and no more. Brick walls, foliage, shrubs, forest, drywall, carbon-impregnated foam are all known to stop 28 GHz microwave fields dead in their tracks. Use everything to your advantage. The main thing is if you know where the 28 GHz antennas are, you want to keep something between yourself and it to the maximum extent possible. 28 GHz fields do not penetrate automotive glass very well and you are safe to drive by one. Make sure the windows are rolled up and you will be fine.

Lets' start with the outside of the body and then we will move onto the mouth, nose, throat and lungs. Many of the **5G** deployments are using Phased Array technology. This means you can focus a lot of power into a very small area and steer it to follow a person. You can also "track" multiple people at the same time. There are 2 microwave energy sources in this situation, the cell tower transmitter and your smartphone. The Institute of Electrical and Electronics Engineering (IEEE) Standard C95.1-2005 states that a maximum Power Density of 10 milliWatts/ square centimeter is the maximum power density one should be exposed to. This is for 9 minutes for every 24 hours.

Now think about your cellphone. It contains a 500-milliwatt transmitter and we can assume it broadcasts out of an area that is approximately 1 cm x 3 cm area, meaning the power density is 166.67 mW/cm2. When your smartphone is against your head, the power density is 16 times higher than that recommended by the IEEE!!! Even if we assume the energy is divided equally among 5 sides of your smart phone, that is still 166.67 mW/cm2 / 5 = 33 mW / cm2 which is 3 times higher than that recommended by the IEEE. The IEEE Limit is the maximum exposure limit for a 9-minute total in a 24-hour period! If half of this is transmitted into your brain, which it is, it is still about 15 mW/ cm2 or 1.5 times the IEEE Limit! We haven't done any real math, only rough calculations and we can see that smartphone use is not looking that safe, since it is going against the recommendations of the world's most knowledgeable body of radiofrequency, microwave and millimeter wave communications.


The outside of your body is being illuminated with all kinds of radiofrequency and microwave signals from DC to daylight. We know this because we can look at the FCC's Frequency Allocation Plan and see that there aren't any unused frequencies below 20 GHz. No one has ever asked: what is the cumulative effect of being illuminated 24 hours a day, 7 days a week? Answer: Who knows! In America, it is SAFE until PROVEN UNSAFE. Not only are we literally being heated by radiofrequency and microwave energy sources, we are also being fed GMOs (genetically modified organisms) in our food. Is our government really looking out for us? Who on God's green earth are they representing? Answer: *THE MONEY*.

After a few detours we are now ready to start looking at how a 28 GHz microwave signal propagates down into your mouth and down your throat into your lungs. In our next article we are going to use a high-quality 3-Dimensional Electromagnetic Field Solver to analyze this and present results. We will start with a simple case and move into more complex problems. The first case will be a simple 1" long cylinder of sea water (saline solution) that is 0.3" inside diameter and 0.4" outer diameter to approximate the ear canal. We can then define the cylinder as blood and see how much signal gets to the bottom of the ear canal, as well as how much gets turned into heat along the way.

[If all of the above information is not enough to frighten you about the potential harm of 5G EMF/EMR Wi-Fi, what I will repeat 'should scare you' into abandoning your "smart" cell-phone. On the next page is an illustration of the integrated sensors in each "smart" phone, 4G LTE and 5G models. All of that capacity depends on an integrated chip that synchronizes "clock time". What am I saying? Every feature requires synchronization with the wireless energy platform. Built into the cell phone and all 5G devices that are connected to the wireless platform system is "clock time" functionality.

All "clock time" is established by Atomic clocks at the U.S. Naval Observatory. Standard time was not enacted into U.S. law until the 1918 Standard Time Act established standard time in time zones; the law also instituted daylight saving time (DST). The daylight saving time portion of the law was repealed in 1919 over a presidential veto, but was re-established nationally during World War II. In 2007 the

U.S. enacted a federal law formalizing the use of Coordinated Universal Time as the basis of standard time, and the role of the Secretary of Commerce (effectively, the National Institute of Standards and Technology) and the Secretary of the Navy (effectively, the U.S. Naval Observatory) in interpreting standard time.



Twice a year your PC or laptop computer, as well as your cell-phone, will reset their computer clock to "synchronize" to the changes for Daylight Savings Time. Each **5G** device has an integrated "chip" set which contains a Cesius-137 radioactive isotope, which cycles at 60-cycles per minute at a half-life of 30.7 years. That Cesium-137 radioactive isotope is emitting radiation similar to that of getting a chest X-ray, but many X-rays over time.

The tele-communications industry does not broadcast that information, for obvious reasons but after this "nuclear" secret became known disinformation and misleading information has been used to refute any fear in the general media. Just keep in mind that the exposure damage is cumulative in nature.

'Approaching, seeking, listening, looking at, coming to know and understand one another, and to find common ground: all these things are summed up in the one word dialogue' (Fratelli tutti, no. 198). Do not be afraid to step outside your disciplines, remain curious, cultivate flexibility, listen to the world; do not be afraid of this world, listen to your brother whom you have not chosen but whom God has put beside you to teach you to love." The 4th International Congress of PLURIEL (University Research Platform on Islam) is taking place in Abu Dhabi, United Arab Emirates, from February 4–7, 2024. The Vision Pro isn't an adequately priced smartphone. It isn't an iPad Mini. In its press release, Apple seemed determined to avoid the word "headset," instead referring to it constantly as a "spatial computer." Either way, this isn't a fun, disposable device, it's a wildly expensive MacBook that costs tens of thousands of dollars. Or a \$17,000 gold Apple Watch, like the one Kanye West used to wear.

Australia becomes latest country to Launch Digital ID system By Leo Hohmann

When digitized identities get matched with central bank digital currencies, it's game over for freedom of thought, movement, etc. All human behavior will be monitored, assessed and scored 24/7.

Australia has become the latest country to delve head first into the first goal of the Great Reset, which is to digitize its citizens.

The Australian government recently announced it has set July 1st as the tentative rollout date for its nationwide digital ID. The exact date will depend on the timing of its legislation which is due to be adopted by the federal parliament.

The U.K. has made similar plans, which were made public last year in a document titled Enabling the Use of Digital Identities in the U.K.

Ethiopia, Nigeria, China, Ukraine, the E.U. and a host of other countries are in the process of digitizing their citizenry.

I <u>reported last year</u> that in the U.S., Senators Kyrsten Sinema of Arizona and Cynthia Lummis of Wyoming have introduced Senate Bill 884, which would offer digital identities for all Americans, but thus far the bill has not been advanced through Congress. They are likely waiting for the opportune time, probably after some major cyber-disruptive event like that which was predicted in the Obama-produced movie *Leave the World Behind*.

I have also recently reported how Americans are being conditioned at U.S. airports to having their faces scanned, which is part and parcel to having a defacto digital ID.

According to a report by Biometric Update, Australia's stakeholder-comment period for a sweeping Digital ID Bill came to a close in late January after receiving submissions from business and financial groups as well as civil rights organizations. The government is now consultating with the states, ChannelNews Australia reports.

The Department of Finance told ChannelNews that the new system will allow users to choose their preferred digital ID provider for accessing services from both the government and private sectors.

Private organizations can apply to be accredited as digital ID services from the government's so-called Trusted Digital Identity Framework. Among companies that

have already received accreditation are Australia Post, MasterCard and OCR Labs. Banks, retailers and other institutions will eventually all be co-opted into this system.

A government spokesperson told ChannelNews:

"The legislation will enable the expansion of the Australian Government Digital ID System to include state, territory and private sector organizations that choose to participate."

The national digital ID will function like an expanded version of MyGovID, which Australians already use to access the Australian Taxation Office, Centrelink (which delivers Social Security payments to Australians) and Medicare.

In other words, whether you need to pay the government or receive payments from the government, you will at some point be locked out of the system if you don't have a digital ID.

All accredited digital ID systems will be expected to observe the same three levels of security standards with the highest one including registering user biometrics, such as a face, palm or eye scan.

According to ChannelNews:

"A user will be able to generate a multipoint image on a device that will be checked against their passport photo and, in the future, driver's license. Establishing your credentials only needed to be done once," officials say.

"Once the legislation passes through Parliament, the new national digital ID will roll out in several phases, according to an explainer published by consumer protection group Choice."

During the first phase, the government will work on setting up a regulator and expanding its use.

In phase two, local state and territory digital IDs will be used to access Commonwealth services while phase three will see myGovID used in the private sector.

In the final phase, Australians will be able to use privately created digital IDs that have received accreditation for accessing some government services.

This is part of the global digital reset that is coming to all nations. They will sell it by saying it's for your safety and security. China just Unveiled a plan for Brain Chips to be Implanted into Skulls to rival Elon Musk's Neuralink by 2025



China has entered the race to implant brain chips into human skulls in a bid to pit against Elon Musk's Neuralink.

The country unveiled a chilling timeline to develop what it calls a "brain-computer interface" – and aims to release products as early as 2025.

China's shock plan in the field of brain chips comes as Musk announced that the first Neuralink brain chip has been successfully implanted into a human skull.

The billionaire said that the preliminary results from the human test subject are promising.

And now the announcement by China – following the footsteps of the Tesla boss – could potentially spark the biggest global tech rivalry of this decade.

China dubbed the "brain-computer interface" as one of its "innovative iconic products", according to the Ministry of Industry and Information Technology's press release on Monday.

It said the country – in coming years – is aiming to develop a range of "brain-interface products" – just like Neuralink's Telepathy.

"[China] aims to make breakthroughs in key technologies and core devices such as brain-computer fusion, brain-like chips, and brain-computing neural models," the Chinese ministry added.

Last year, the Chinese government opened a 60-person laboratory focused entirely on brain-machine interfaces, Gizmodo reports.

The lab is reportedly focused on turning extensive research in the field of brain chips into practical applications – to rival Musk's Neuralink, according to South China Morning Post.

Researchers in China have apparently developed a computing device that connects to your brain via the inner ear.

While this device works without a chip implant – like Neuralink's Telepathy – it can still feed data directly into the human brain.

China says it hopes to use such advanced brain technology in driverless cars, virtual reality, and medical rehabilitation – a cumulative vision that was first pitched by Musk in 2017.

Experts, however, argue that China could leverage such tech implants and weaponize them to spy against their own people.

Meanwhile, some critics of the technology claim that such products will falsely be marketed as a remedy for all difficulties – and that interfering the human biology with such tech implants could turn people into zombies.

Dr. Mikhail Lebedev, a senior neuroscientist at Duke University in Durham, said: "It is even possible that "humanity" will evolve into a community of zombies."

European Farmer Protests Force EU to Scrap WEF's 'Net Zero' Targets

The European Union (EU) has been forced to scrap the "Net Zero" targets dictated to the bloc by the globalist World Economic Forum (WEF).

EU leaders dropped the controversial green agenda goals following widespread protests from farmers on the streets of Europe.

The European Union has backed down on the WEF's "Net Zero" targets for agriculture. The targets seek to force farmers out of business by enforcing drastic cuts in fertilizer and pesticide use.

Included in the "Net Zero" goals are recommendations that the general public eat less meat and switch to consuming lab-grown and insect-based "foods" instead. The push has led to widespread protests from farmers.

The EU has caved to angry protests from farmers and cut a target to slash agricultural emissions as part of the bloc's "Net Zero" drive, the Telegraph reports.

A demand to reduce nitrogen, methane and other emissions linked to farming by almost a third has been removed from a wider Brussels plan to cut so-called "greenhouse gas emissions" by 90% before 2040.

On Tuesday, unelected European Commission President Ursula von der Leyen, a former WEF board member, also proposed withdrawing the EU's plan to halve the use of pesticides.

She called it a "symbol of polarization."

"Our farmers deserve to be listened to," von der Leyen told the European Parliament.

"I know that they are worried about the future of agriculture and their future as farmers."

"But they also know that agriculture needs to move to a more sustainable model of production so that their farms remain profitable in the years to come."

A recommendation urging EU citizens to eat less meat was also removed from the plan. The concessions came amid mounting demonstrations by farmers in Belgium, France, Germany, and Italy ahead of this year's EU elections.

Blockades outside supermarket distribution centers have left shelves empty in Brussels. The Telegraph says farmers are "holding the EU hostage and winning."

However, the outlet warns globalists that the EU climb down on "Net Zero" rules "will not stuff the Eurosceptic genie back into the bottle," according to the outlet.

Polls predict anti-EU parties will win June's European Parliament elections in nine member states – Austria, Belgium, the Czech Republic, France, Hungary, Italy, the Netherlands, Poland, and Slovakia.

Now fully emerged from their defensive crouch after Britain's painful Brexit negotiations, they are set to come second or third in another nine EU countries.

The EU fears that those results could be boosted by the farmers' populist revolt.

Tractor protests against climate rules handed a Dutch farmer's party a landslide victory in regional elections last year after the vote became a referendum on establishment politics.

After the ruling coalition collapsed, voters turned to Geert Wilders, an anti-migrant, Nexit-backing, farmer-supporting firebrand in November's snap General Election.

Similar tractor protests have since been held in France, Italy, Germany, Belgium, Poland, and Romania, are expected soon in Slovakia and erupted in Spain on Tuesday. Eurosceptic parties have adopted the farmer's fight, robbing pro-EU forces of a constituency it has long regarded as its own thanks to the bloc's huge agricultural subsidies.

A key battleground in the looming campaign is the pushback against the EU's 2050 "Net Zero" target, a culture war given impetus by the cost of living crisis.

"One by one they crumble," says reporter Ross Clark.

"The Net Zero targets that were dreamed up without any regard to their cost and practicality."
