Vaccines Are Silent Killers

But not for the reasons most people might think.

Anti-aging expert Aubrey de Grey explains in his seminal book 'Ending Aging' that the total number of immune cells in the body is tightly controlled. There is an ironclad fixed limit on the number of immune cells. Thus there is an upper limit on our immune function.

de Grey states:

"There are various reasons for the weakening of the immune system that happens with aging, but one of the most profound—and unexpected—factors underlying our inability to mount a defense against infections that young people shrug off without ever suffering a sniffle is, believe it or not, a form of immunological overcrowding."

"The immune system ruthlessly maintains a cap on the total number of naïve and memory immune cells combined in the body at any given time."

The ramifications of this upper limit on immune cells are staggering. As we age, our immunity to new threats dwindles as we use up our immune resources that have been targeted against "old" threats.

According to De Grey:

"Between 30 percent and 75 percent of older people fail to respond to flu shots, compared with just 10 percent of young adults."

"Deaths from influenza and influenza-associated pneumonia are almost unheard-of in adults until the seventh decade, after which rates climb exponentially. In the United States, over 90 percent of all deaths from the two diseases are in people over sixty-five years of age."

A recent report revealed the elderly are dying in large numbers.

"Per US Census Data, during the height of COVID the elderly population grew to 6.7 million in 2020, but was devastated by the loss of more than 1 million lives in 2021, after the mRNA vaccine rollout."

Obviously, the elderly are being targeted, reducing the burden on Social Security and Medicare in the USA, but what kind of world are we creating for our children? Children today grow up with multitudes of vaccinations depleting their overall immune capacity much earlier in life.

More from de Grey:

"The decline of the immune system is one of the most deadly effects of aging. Infections that young people shake off as mere inconveniences are commonly fatal in the biologically old. Influenza, for instance, puts 114,000 Americans into the hospital each year, and flu and flu-related illnesses claim the lives of about 51,000."

"But the disease burden is dramatically skewed toward people who have previously suffered the ravages of aging."

"There are two main branches to the immune system. One is the so-called innate immune system, whose "innateness" comes from the fact that its job is so general that it doesn't have to "learn" to identify a specific enemy."

"The other main branch is the adaptive immune system. The adaptive immune system is more like a division of highly trained special forces units, each of them expert in waging targeted, tactically sophisticated warfare against specific enemies. This branch is responsible for the ability of the immune system to learn about invaders—and, thus, for the effectiveness of vaccines."

"The problem, once again, begins with the body's need to balance competing priorities in its metabolic processes—and to do so in the face of limited resources. On the one hand, it's critical that the immune system be able to identify and fight off infectious agents that it's never seen before, so it needs to have a reserve of CD8 cells that are ready to respond to new threats, "learn" about their key antigens, and then mount an attack; these are called naïve CD8 cells."

"This would be fine if we could keep on hand as many T cells as we might like, including plenty of naïve cells and large contingents of memory cells specific to each of the many pathogens that our body has racked up in its rogues' gallery over the course of the years. But producing and maintaining these armies is a resource-intensive investment, and as with everything else, the body's "budget" for the immune system is limited. To avoid going into deficit on its "military" spending, the body maintains a strict policy of balanced budgets—a limited amount of "immunological space" (as it's been called) for the entire T cell population in aggregate." de Grey, Aubrey; Rae, Michael. The message is that ordinary vaccinations, rather than improving immunity, create "false alarms" that deplete the number of immune cells available to fight future battles.

Once upon a time

In a Supreme Court decision in New York back in 1914, Justice Cardozo set one of the most important foundation stones for modern medical ethics, the principle of autonomy in healthcare decision-making.

This wasn't a new idea, it is one enshrined in many ancient texts, such as the Vedic texts of India and the Nei Ching of Chinese Medicine.

The importance of this <u>ethical principle in healthcare</u> was reinforced more recently by German philosopher Immanuel Kant (1724-1804) and the English philosopher John Stuart Mill (1806-1873) before being firmly set by <u>Tom Beauchamp and James</u> <u>Childress</u> in 1979.

Autonomy: ready for sacrifice?

In a modern context, building on <u>the views of Kant</u>, autonomy means that all persons have intrinsic and unconditional worth, and therefore, should have the power to make rational decisions and moral choices, and each should be allowed to exercise his or her capacity for self-determination.

But autonomy as a medical ethics principle is now under unprecedented threat, globally. The source of that threat is the most powerful health authority in our increasingly globalized world; the Swiss-based, unaccountable, international non-profit organization known as the WHO.

The scale and nature of the threat will become apparent in the coming months, during the lead-up to the voting by 196 countries at the <u>next meeting of the World Health</u> <u>Assembly</u> (WHA) in Geneva between May 27 and June 1.

The votes will determine how countries should respond in the event of <u>future</u> <u>pandemics</u> or global health emergencies, circumstances we are told over and over again we should come to expect more often than in the past.

The global plan is being driven by the WHO and its leading funders, the top six, in <u>descending order of contribution</u>, being Germany, the <u>Bill & Melinda Gates</u> <u>Foundation</u>, the U.S., the European Commission, the <u>GAVI Alliance</u>, and the United Kingdom (U.K.).

If the WHO declares another pandemic or "public health emergency of international concern" (PHEIC), something it can do unilaterally based on very limited criteria, the plan if enacted, will involve an international response, and consequent national responses, that run quite differently to our recent experience of the <u>COVID-19</u> pandemic between March 2020 and May 2023.

It should be noted that a single individual, namely the director-general of the WHO, currently <u>Dr. Tedros Adhanom Ghebreyesus</u>, has the <u>sole power to declare a PHEIC</u>, and this one individual is <u>unelected by the people</u>, unaccountable and has immunity from prosecution by virtue of "diplomatic immunity."

If you thought the COVID-19 pandemic response by governments, health authorities, corporations and the media last time around was too heavy-handed, too top-down or too authoritarian, don't imagine the next one will be more even-handed.

Conversely, if you thought the response wasn't sufficiently robust, that <u>lockdowns</u> weren't forceful or long enough, that there wasn't enough testing, tracking or <u>surveillance</u>, that mask-wearing wasn't mandated sufficiently, that people were given too much leeway to travel, that previously untrialled, novel <u>genetic</u> <u>vaccines</u> weren't rolled out quick enough or in sufficient number, or that those who exercised their right of refusal weren't penalized sufficiently, well ... you're going to be thrilled with what's in the pipeline.

The next time round, the pandemic response by nations and international authorities will almost certainly be more authoritarian and control will be much more centralized, masterminded from the WHO headquarters in Geneva. Countries will have a binding responsibility to comply with their masters at the WHO, and rich countries will have to gift lots of their hard-won money and healthcare products to poorer countries.

All in the name of health equity, very much the buzzword of the current negotiations. This is at least the vision of many of the most powerful world leaders — on both the political and <u>corporate stage</u>.

And here's the thing, to make this happen, it means ditching or, at least, severely limiting, individual decision-making of health, the fundamental tenets of "autonomy," one of four foundational pillars of modern medical ethics.

It also means kissing goodbye to the joint decision-making that has long existed between physicians and the public and passing that responsibility to faceless institutions and authorities who have zero understanding of your health status, your resilience or sensitivities, your health needs or your circumstances.

Moving the locus of control over health by taking health responsibility away from the individual, bypassing primary care physicians or other community-based health practitioners, and passing it to a faceless bureaucracy should be an anathema.

At least to the many thousands of us who have been working tirelessly towards increasing people's access to personalized and individualized systems of health that are tailored to the needs, circumstances and environment of each person.

The two key negotiating tables

The detail of how the global pandemic response is expected to be achieved, and exactly what mechanisms and processes will be brought to bear on us mere mortals in the event of the next global public health emergency, is currently unknown.

That's because it's all still on the negotiating table, and negotiations are at a fever pitch right now, with significant parts of it going on behind closed doors and most of it being unreported by the mainstream media.

There are two negotiating tables involved, but both are controlled by the very organization that is primed to become the supreme power broker in the event of the next health emergency, the WHO.

Let's take a quick look at these two negotiating tables, and offer you their respective hyperlinks so you can do your own digging should this appeal.

One is the <u>Working Group on Amendments to the International Health</u> <u>Regulations</u> (WGIHR) which is currently dealing with over 300 amendments to the existing International Health Regulations of 2005, many of which strengthen the power of the WHO and weaken national sovereignty in the event of a PHEIC. The other is the <u>Intergovernmental Negotiating Body</u> (INB) that is responsible for drafting and negotiating the so-called "<u>pandemic treaty</u>" (increasingly referred to as an "accord" so escapes the definition of "treaty" and can side-step parliamentary or congressional approval), that is an "international instrument under the Constitution of the World Health Organization [that intends] to strengthen pandemic prevention, preparedness and response."

The WHO likes to claim that the nearly 200 countries that are members of the WHO are running the show in each of these two negotiations. This view is meant to make us feel that the process is democratic and that it is the will of the people.

But that's a pipe dream. There are a few powerful players, like the U.S., Germany, the unelected European Commission and the U.K., and these have the ability to coerce other countries who will likely face penalties if they don't play by the emerging global rules.

There are many ways smaller and less developed countries can be forced to play by the rules. Two important devices include the building or breaking of trading relationships, or the conditions under which international loans, such as those from the <u>International</u> <u>Monetary Fund</u>, are paid off, deferred or forgotten.

Out of sight, out of mind

The problem with negotiations of the type that the WGIHR and INB are undertaking is that they're entirely undemocratic in the true sense of the word.

The people or electorates in the 196 countries involved, including 194 WHO "member states," don't get to have any kind of say.

That's because those engaged in the negotiations are unelected bureaucrats "doing a job" and there's no direct line of communication between elected representatives and these bureaucrats.

In many countries, a few, diligent elected representatives have tried raising their concerns in their own parliaments or assemblies. But we see a common pattern. Very few other representatives attend the hearings, and there is almost a whitewash on mainstream press coverage.

Take the British member of Parliament, Andrew Bridgen, for example. He has raised more than once, to an almost empty "house," the very concerns over the IHR amendments and "pandemic treaty" that we have been vocal about previously (such as <u>here</u> and <u>here</u>).

That includes the removal of the term "non-binding" from Article 1 and the insertion of the phrase in Article 13A that says "Member States [will] undertake to follow WHO recommendations."

But it's even worse than that. The vast majority of the public isn't even aware these negotiations are going on or what's at stake.

Why? Because concerns over the outcomes of the negotiations are just not being reported by the mainstream media.

Below you'll hear Congressman Andy Biggs (R-N.J.) raising awareness in Congress of his bill that pulls the U.S. out of the WHO.

Another congressman, Chris Smith (R-N.J.), <u>hosted a press conference</u> on Feb. 5 about the "pandemic accord," with invited experts that was barely reported.

Included in the discussion was the lack of transparency, the backroom negotiations, WHO overreach, infringement on U.S. sovereignty, unknown financial obligations for U.S. taxpayers, threats to intellectual property rights, free speech, funding for abortion and how it will benefit China at the expense of the U.S.

None of these presentations by elected representatives make the mainstream press. The coverage in The New York Times is much more typical of how the mainstream media has been covering the IHR and the "pandemic treaty."

For example, type in the phrase *"International Health Regulations"* into the search box of the Times and you'll find no coverage of the negotiations.

You simply find articles that endorse the principle of the WHO running the show, such as this one published the day after the WHO declared the pandemic on March 12, 2020, with the title "<u>The World Has a Plan to Fight Coronavirus</u>. Most Countries Are Not Using it."

Type *"pandemic treaty"* into the U.K.'s The Guardian website and you'll find stories, such as this one, *"Can a WHO pandemic treaty help poorer nations in future outbreaks?*" (Aug. 10, 2023), that talks to the desperate need by poorer countries to receive vaccines in the event of a pandemic.

This is odd, given many of the poorest countries didn't have much of a need or interest in getting their hands on COVID-19 vaccines last time around.

This kind of reporting underpins the public relations exercise the WHO and its big contributors, including vaccine interests like the Gates Foundation and the GAVI Alliance, are promulgating to give the WHO more muscle, to make it the top dog in the hierarchy of global control of health — and more.

The WHO muscle-building plan

Ostensibly, the goals of the WHO are worthy, "to promote, provide and protect health and wellbeing for all people, everywhere."

These are the first three Ps that Ghebreyesus spoke of in his <u>opening remarks</u> to the 154th session of the Executive Board of the WHO on Jan. 22. (In case you wondered, the other two Ps are Power and Perform, concepts that can seem scary in the hands of an unaccountable body).

The WHO muscle-building plan can't happen overnight as it inevitably needs to follow the deceptive and insidious, well-trodden approach of "boiling the frog slowly" (in the hope everyone will get used to the direction of travel and succumb to it).

The manifesto is already scripted in the WHO's upcoming <u>14th General Programme of</u> <u>Work</u> (GPW 14) (see Fig. 1) that's intimately connected to the United Nation's <u>Sustainable Development Goals</u>.

The WHO has found a way of putting health right at the center of what it calls the "converging crises" of climate, food, energy and geopolitics.

If that wasn't enough, the health of humans is now expected to be better managed by linking it directly to that of domestic and wild animals, plants and the wider environment through <u>One Health</u>.

This is described as a "unifying approach" that "aims to sustainably balance and optimize the health of people, animals and ecosystems."

With unbridled confidence, <u>the WHO declares</u> that "One Health can help to address the full spectrum of disease control — from prevention to detection, preparedness, response and management — and contribute to global health security."

It's a nice concept in that it recognizes the human interconnection with nature, but it's not so nice if it's all about installing top-down control over every facet of human, animal and planetary health, a concept that has been likened by those carrying the conspiracy theory tag on their foreheads as akin to global governance.

One significant problem with this globalized approach is that there's no evidence it works.

The authorities and most academics failed to see whether regionalization or individualization of approaches that included keeping schools open for children, avoiding the use of masks, or receiving any or multiple genetic vaccines during the height of the COVID-19 pandemic worked better than one-size-fits-all, globally controlled approaches.

As it happens, many of us in natural health circles did experience just how effectively individualized approaches, ones that ran diametrically against the WHO recommendations, worked.

I led a team that evaluated data collated by a U.K.-based non-profit called the <u>Control</u> <u>Group</u>, the works being subsequently published in the <u>International Journal of Vaccine</u> <u>Theory</u>, <u>Practice</u>, <u>and Research</u>, a journal specifically launched given most journals refusal to publish science that ran contrary to the narrative.

Regardless of push-back, a process continues to gather momentum that is in no way being supported by the majority of people on the planet, one that is attempting to centralize control over health, rather than individualizing it. This is being done without evidence of its value or ability to resolve our ever-growing health challenges.

The WHO has also scripted its plan in its updated document, "<u>WHO benchmarks for</u> <u>strengthening health emergency capacities</u>," as the title suggests, to show how different countries' health emergency capacities can be benchmarked so they can get behind the WHO's plan for health equity (read: authoritarian control).

Nowhere within the document is there any mention of how people's nutritional or immune status might be a useful benchmark of a country's capacity to withstand new infections. "Optimum vaccine coverage," by contrast, gets a big mention as a key benchmark.

Taken altogether, it is clear that the WHO is lock, stock and barrel sold on the idea that vaccines should be by far the most important medical intervention in the event of a new pandemic, and it's also clear that the WHO and its allies are desperately keen to make sure coverage is as complete as possible.

This rationale is astonishing in view of the facts that <u>COVID-19 genetic vaccines</u> failed to <u>stop transmission</u>, have driven (and continue to drive) the production of <u>immune</u> <u>escape variants</u>, caused more severe disease in those who <u>took more than two</u> <u>shots</u> and caused extensive harm (e.g., <u>OpenVAERS data</u>).

We all understand how higher coverage could be made to work, such as through mandates, coercion or withdrawing freedoms from those who choose to avoid.

We also recognize that elevated surveillance and so-called "<u>vaccine passports</u>" may well be forced through in the name of "global health security." Mention any of this to anyone who's sold on the plan, and you'll be told you're a conspiracy theorist. Just saying.

Dissenters are full of 'fake news, lies, and conspiracy theories,' says Ghebreyesus

And guess what Ghebreyesus is saying about it all?

Apparently us dissenters have it badly wrong, that the proposed "binding" agreements that countries will vote on in May will all be brought to bear under national laws so the WHO can't be accused of any power grab.

At his Jan. 22 <u>opening remarks at the informal briefing</u> on the INB and WGIHR, Ghebreyesus said:

"The INB and the IHR working group are operating amid a torrent of fake news, lies, and conspiracy theories.

"There are those who claim that the pandemic agreement and IHR will cede sovereignty to WHO and give the WHO Secretariat the power to impose lockdowns or vaccine mandates on countries. You know this is fake news, lies, and conspiracy theories."

The nub of the discrepancy in view boils down to who (pun 1) calls the shots and who (pun 2) maintains or delegates authority over which issues during a declared international health emergency. The WHO says the process is WHO member state-led therefore the WHO does not control it.

Opponents of the process, ourselves included, say by making the IHR binding (as proposed by <u>amendment to Article 1 on Definitions</u>), international law will have supremacy over national laws.

If that law places control during health emergencies into the hands of the WHO, nations will have elected to give up their powers on related matters, delegating them upwards to the WHO, justified presumably because these countries deem the WHO to be the most expert and powerful entity in the event of a global pandemic response.

In practice, this means, at least while an international public health emergency is active, nation-states will have effectively ceded their sovereignty to the WHO. While this seems like splitting hairs, what matters most is the effect, not the mechanism, of the process.

What next?

Feb. 9 marked the last day of the <u>7th (and penultimate) meeting of the WGIHR</u> and we eagerly await outcomes, the summary of which will be delivered by public webcast.

Before the vote and adoption of the IHR amendments at the 77th <u>meeting of the</u> <u>WHA</u> at the end of May, it will take a further 18 months for these amendments to come into effect.

This time may provide additional opportunities for more pushback if the outcomes of the current negotiations and the May vote are unfavorable for individual health and national sovereignty.

There is no doubt that public pressure and political resistance are slowing down and complicating the plan to create a *"safer and fairer world,"* one that massively disempowers the role of the physician and pretty much relegates the ever-more diluted, <u>four guiding principles</u> of contemporary medical ethics, namely autonomy, beneficence (doing good), maleficence (minimizing harm) and justice, to the trash can.

We will continue to stay on top of developments in these murky supranational negotiations and we'll keep providing our readers and subscribers with a view from the perspective of those who still value Justice Cardozo's 110-year-old perspective, that "Every human being of adult years and sound mind has a right to determine what shall be done with his own body."

While most will view the eclipse as simply an awesome natural spectacle, some consider it a sign from God. Here are 18 reasons why:

1. CREATED FOR SIGNS

Scripture says the sun and moon were created to serve as "signs" to mark sacred times (Gen. 1:14). The April eclipse, an astronomical phenomenon that involves both the sun and moon, occurs on the eve of the biblical New Year, Nisan 1, a sacred time on God's calendar.

2. SIGN OF JESUS' COMING

Of all the signs of the Day of the Lord, the most frequently mentioned in Scripture is a darkened sun, or total solar eclipse (Rev. 6:12; Joel 2:31; 3:14, 15; Isa. 13:9-10; Matt. 24:29; Mark 13:24; Luke 21:25-27; Acts 2:20, 21; Ezek. 32:8).

3. WARNING FOR GENTILES

According to the Talmud, solar eclipses are a sign for the Gentile world (Succah 29a). Since America is the leading Gentile nation, a sign for the U.S. may be considered a sign for the whole world.

4. JUBILEE NATION

The eclipse occurs above the nation uniquely founded on the biblical principle of "liberty," or Jubilee (Lev. 25:10). From the original U.S. charters, to the iconic symbols and currency, the theme of liberty, or Jubilee, is ever-present. Even the number of states—50—signifies Jubilee. Thus, a sign viewed from the U.S. may be considered a Jubilee sign.

5. JUBILEE YEAR

The eclipse above the "Jubilee nation" occurs during a calculated Jubilee year. The calculation derives from the only Bible prophecy that mentions a Jubilee period:

"From the time the word goes out to restore and rebuild Jerusalem until Messiah the prince comes, there will be seven sevens" [or one Jubilee period] (Dan. 9:25).

Following millennia of Gentile rule, Jerusalem was restored to its original owners, the Jews, in June 1967. Counting Daniel's "seven sevens" from the start of the first Sabbatical week after 1967, which is 1974, the 50th year, or Jubilee, spans 2023–24.

6. AMERICA'S FIFTH JUBILEE

Per our Jubilee calculation, the eclipse occurs during America's fifth Jubilee. (The nation's first Jubilee was 1778, the year following Sabbatical year 1777).

That the "Jubilee nation" has existed for exactly five Jubilees is significant because the number five denotes a period of grace or Divine favor. While God has certainly "shed His grace" on the U.S., the impending eclipse may be a sign that the grace period is over.

7. ISRAEL'S 70th JUBILEE

Per our Jubilee calculation, the eclipse occurs during the 70th Jubilee since the Israelites entered the Promised Land and began counting the 49-year cycle 1408–07 BC + 70 Jubilees = 2023–24.

This is significant because the number 70 is associated with a release from captivity and a return to one's land—the main themes of Jubilee (Jer. 29:10; Ex. 15:27; Lev. 25:8–54).

8. SEVEN JERUSALEMS AND THE JUBILEE 'X'

The 2024 eclipse occurs seven years after the "Great American Eclipse" of 2017. What is really remarkable, however, is that both eclipse-paths cross over seven U.S. cities named "Salem," an alternate name for Jerusalem:

The 2017 path crosses over Salems in Oregon, Idaho, Wyoming, Nebraska, Missouri, Kentucky, and South Carolina.

The 2024 path crosses over Salems in Arkansas, Illinois, Kentucky, Ohio, and three in Texas.

The "7 X 7" Salems recall the Jubilee prophecy in Daniel, where a restoration of Jerusalem initiates a count of "seven sevens" (Dan. 9:25).

Another Jubilee correlation is that the 2017 and 2024 eclipse paths intersect to form a giant X across the U.S., the center point of which is an area of Southern Illinois called "Little Egypt." In Scripture, Egypt is synonomous with a release from bondage, as in the Jubilee (Ex. 6:6; Lev. 25:10).

To appreciate the unlikelihood of the eclipse paths intersecting at Little Egypt, consider that on average a given location on earth sees a total solar eclipse about once every 400 years, yet America's Little Egypt will see two total eclipses in only seven years.

Finally, the widths of the respective eclipse paths evoke the Jubilee: The 2017 path was 70 miles wide, denoting a release from bondage (Jer. 29:10; Ex. 15:27). The 2024 eclipse path is 120 miles wide, corresponding to the 120 jubilees in God's 6,000-year plan of redemption (Gen. 6:3). There were also 120 believers gathered at the first Pentecost, the festival called the "little Jubilee" (Gen. 6:3; Acts 1, 2).

9. JUBILEE ASTEROIDS

The eclipse occurs days before two Jubilee-themed asteroids, "50 Virginia" and "652 Jubilatrix," enter the constellation Virgo.

Significantly, the pair of asteroids previously entered Virgo in August 2023, lingering there throughout the fall, before transitioning into Libra. In mid-April 2024, however—soon after the solar eclipse—the Jubilee asteroids re-enter Virgo, and remain there into August.

It is striking that the Jubilee-themed asteroids—one of which is named "50 Virginia" (Jubilee Virgin)—linger in the virgin–bride constellation (Virgo), during a calculated Jubilee year.

10. JUBILEE CONSTELLATION

The eclipse occurs in the constellation Pisces, the sign of the fishes that depicts God's people in bondage.

Significantly, the eclipse occurs precisely on the Band that binds the fish pointed toward Aquarius, the water bearer who symbolizes Jesus. A week later, the Sun crosses the Band that binds the fish pointed toward Andromeda, the chained woman. Image: <u>https://storage.googleapis.com/.../2024%20Solar%20Eclipse...</u>

An eclipse on the Band of the fish pointed toward Aquarius (Jesus) evokes the ultimate Jubilee, when the bonds of mortality are broken and believers are caught up into the heavens to meet the Lord (1 Cor. 15:51–54; 1 Thess. 4:13–17).

11. PLANETARY ATTENDANTS

The eclipse will be flanked on either side by the two planets that symbolize Jesus. To the immediate left, the "King Planet," Jupiter, will be visible in the constellation Aries, the Lamb. To the right, even nearer, the "bright morning star" that represents the coming Lord will be dazzling in Pisces, the Jubilee constellation.

Given how planets are continuously wandering relative to the Sun, it is striking that during the eclipse, the two largest and brightest, which happen to symbolize Jesus, will be visible on either side of the darkened solar disc.

12. WEDDING SIGN AND SIGNATURE

The eclipse occurs six months after an annular (ring-shaped) solar eclipse—also visible in the US—occurred in the left hand, or ring-finger, area of Virgo.

The wedding-ring eclipse of October 2023 is significant for two reasons:

First, it occurred in the year after a Sabbath (seventh) year. The day or year after the Sabbath is a biblical time of weddings: God wed Israel on the day after a Sabbath (Lev. 23:15, 16; Ex. 19). The Church was betrothed to the Lord on the day after a Sabbath (Lev. 23:15, 16; Acts 2). Jacob, a type of Christ, married Leah after seven years, and then wed Rachel after seven days (Gen. 29:14–30).

The second noteworthy thing about the wedding-ring eclipse of 2023 is that its path intersects the paths of the 2017 and 2024 American eclipses to form the first and last letters of the Hebrew alphabet, the Aleph and Tav.

Since Jesus is called the "first and the last" (Rev. 22), the first and last letters of the Hebrew alphabet represent a type of 'signature' of God. Moreover, the Hebrew letter Tav (X) by itself signifies a signature. The double reference to a signature is significant because when something is signed—as the U.S. will be after the impending eclipse—it is considered finished.

13. 70 DAYS TILL PENTECOST

The eclipse occurs 70 days before Pentecost. This is significant because:

- Pentecost is the harvest festival associated with the Church (Acts 2).
- Pentecost is called the "little Jubilee."

• The number 70 denotes a release from bondage, as in the Jubilee (Jer. 29:10; Ex. 15:27).

14. JUBILEE WAR

The eclipse occurs as Israel is engaged in its first major war in 50 years, the span of a Jubilee. Significantly, the war of 50 years ago, the Yom Kippur War, began on the Day of Atonement, the day on which the Jubilee is declared (Lev. 25:8–10).

15. DIVIDING THE LAND FOR PEACE

The eclipse coincides with a renewed push by the U.S. State Department to create a Palestinian State, thus dividing the Land of Israel, in order to achieve what it calls a lasting "peace and security" for the region.

This is significant for two reasons. First, God warns that He will judge the nations who divide the Land (Joel 3:2). Second, Paul informs the Church that the Day of the Lord will begin while people are saying "peace and security" (1 Thess. 5:3).

16. TRUMP'S "SEVENS" AND OTHER HARBINGERS

The eclipse occurs seven years after the 50th "Jubilee" anniversary of the restoration of Jerusalem in 1967.

While 2017 was not an actual Jubilee, it was a year of Jubilee-related signs:

• Donald Trump, whose last name means "trumpet," was inaugurated president of the "Jubilee nation" as he turned 70 years, 7 months, and 7 days old. Significantly, Trump was born on the biblical date Sivan 15, the Day of Pentecost, according to the Book of Jubilees.

• Trump became the first U.S. President since the 1967 restoration to recognize Jerusalem as the capital of Israel.

• On the same day that the Great American Eclipse traced a path across seven US cities named Salem, Trump's son-in-law, Jared Kushner, flew to the Middle East to begin work on a peace plan that would propose dividing Jerusalem.

• Thirty-three days after the Great American Eclipse, during the Feast of Trumpets, a one-of-a-kind astronomical alignment in Virgo inspired many Christians to start watching the signs in the heavens.

17. HORNED COMET

During the eclipse, a massive and unusually bright comet named "12/P Pons–Brooks" will be visible in the neighboring constellation Aries, the lamb.

Like the eclipse, Comet Pons–Brooks is brimming with biblical symbolism:

• The comet was discovered by astronomer Jean-Louis Pons in Sabbatical year 1812, and subsequently recovered in Sabbatical year 1883, by William Brooks. The name

Pons means the "way" or "path-maker." Jesus is the "way" or "path" to salvation (John 14:6; Matt. 7:13, 14). The name "Brooks" means "flowing stream or torrent" and has a dual connotation pertaining to the "waters of life" that flow from the Lamb, and the "flood" of judgment unleashed upon the wicked (Rev. 7:17; 22:1; Matt. 24:37–39; Isa. 59:19).

• Comet Pons–Brooks has an orbit of just over 70 years, evoking the Jews' liberation from captivity after 70 years (Jer. 29:10).

• According to astronomers, the most intriguing characteristic of Comet Pons–Brooks is its ability to produce unexpected outbursts in brightness, likely due to gas jetting from a fissure on the comet's nucleus. The sudden brightening recalls how, when Jesus comes, He will destroy the wicked with the brightness of His coming (2 Thess. 2:8).

• The outbursts of intense brightness by Comet Pons–Brooks cause the misshapen coma to resemble the horns of a bull. In the biblical Zodiac (Mazzaroth) Taurus the bull is a picture of Jesus coming to pierce through His enemies.

• Seeing how Comet Pons–Brooks resembles a bull, it is significant that the U.S., home to nearly half the world's Jews, is believed to be home to the scattered tribe of Israel that is represented by a bull, Ephraim (Deut. 33:17). But there is more. The aforementioned letter Aleph 'signature' formed by the eclipse is a pictograph of a bull. Thus, we have a comet that resembles a bull, appearing above the nation associated with a bull (Ephraim–U.S.), which is marked with the Hebrew letter that pictures a bull!

• With the bull symbolism in view, it is striking that Comet Pon–Brooks will each perihelion, or maximum brightness, as it enters the constellation Taurus the bull.

• After visiting Taurus, Pons–Brooks will enter the constellation Eridanus, a name that means "River of the Judge."

• On June 2, Comet Pons–Brooks will reach its closest point to Earth, at a distance of 144 million miles, evoking the "144,000 virgins" who are sealed for redemption before judgment begins (Rev. 7, 14).

Needless to say, Comet Pons–Brooks is a remarkable sign by itself. That it will be visible to the immediate left of the eclipse adds significance to both.

18. BOTANICAL SIGN

The eclipse coincides with an important botanical sign, the flowering of grapevines in Israel. According to grape growers, the second week of April is when the tender vines form flowers that give off an intoxicating fragrance. This is significant because in Song of Songs, the last seasonal clue mentioned before the shepherd comes to gather his Gentile bride is flowering grapevines:

"The vines in flower yield their sweet smell. Arise, my love, my beautiful one, and come away" (Song 2:13 DRB).

Assuming that the above is an allusion to the Rapture, the flowering of grape vines in Israel—beginning around the time of the eclipse—is a thrilling sign indeed, marking the start of a season of heightened anticipation.

SUMMARY

ON APRIL 8, a total solar eclipse will darken a 120-mile-wide path across the U.S. The eclipse . . .

- Will be the most watched celestial event in US history.
- Occurs on the eve of the biblical New Year, Nisan 1.
- Occurs above the "Jubilee nation," during a Jubilee year.
- · Occurs during America's fifth jubilee, denoting a period of grace.
- Occurs during Israel's 70th Jubilee, denoting a release from bondage.
- Completes a giant X and Aleph–Tav 'signature' across the US, denoting completion.
- Crosses over seven Salems, like the 2017 eclipse.
- Occurs days before two jubilee-themed asteroids enter the virgin constellation, Virgo.
- Occurs on the Band of Pisces, the constellation that depicts God's people in bondage.
- Is flanked on either side by the planets that symbolize Jesus, Jupiter and Venus.
- Occurs six months after a "wedding-ring" eclipse in Virgo.
- Occurs in the year after a Sabbatical year, a biblical time of weddings.
- Occurs 70 days ahead of Pentecost, the harvest festival associated with the Church.

• Occurs 50-plus years after Israel's last major war began on Yom Kippur, the day the Jubilee is declared.

- Occurs as the U.S. is pressuring Israel to divide the Land for peace.
- Occurs seven years after the Jubilee/Trump/Jerusalem harbingers of 2017.
- Traces the Hebrew letter that pictures a bull, across the nation associated with a bull, as a comet that resembles a bull appears nearby.
- Occurs as grape vines are beginning to flower in Israel.

According to Scripture, a darkened sun may be a sign of the impending Day of the Lord. The particulars of the 2024 total eclipse—the last one to cast a shadow across the "Jubilee nation" until 2045—suggest that it is such a sign.

If our reading is correct, Jesus is coming soon to liberate countless believers from the bondage of mortal existence. Precisely when, no one knows, but there is every reason to believe that it could be this year.

5. Supporting the 2023–24 Jubilee calculation, the Sabbatical year prior (5782 Hebrew) is divisible by 49, a characteristic unique to Sabbatical years preceding Jubilees.

6. A popular view is that Daniel 9:25 was fulfilled at Jesus' first coming. The seven weeks are added to the sixty-two weeks to make 69 weeks, and then counted from Artaxerxes' 457 BC decree to rebuild Jerusalem, to arrive at 27 AD, the year Jesus was anointed Messiah. While the above certainly represents a fulfillment, there is no reason to believe it is the ultimate fulfillment. In fact, since Daniel's prophecy encompasses God's whole plan of redemption, which entails two appearances of Messiah, it stands to reason that the year of both appearances would be given. This, I believe, is why the seven and sixty-two weeks are mentioned separately, to allow for the calculation of two

appearances of Messiah, based on the two historical returns to Jerusalem, the former one in 457 BC, and the latter in 1967.

7. There is debate as to the correct start month of the Jubilee year. Some say it begins at Nisan, the biblical "first month" (Ex. 12), while others say it begins at Tishrei, when the Jubilee is declared by a trumpet blast (Lev. 25:9, 10).

8. Concerning the reckoning of Sabbatical years, it is important to note that there are two accepted chronologies. The first chronology was published circa 1856 by Benedict Zuckermann, and is the Sabbatical calendar used in Israel today. The second chronology, which proposes Sabbatical dates one year later than Zuckermann's, was published by Ben Zion Wacholder in 1973. Because Wacholder had access to ancient documents not available to Zuckermann, scholars generally favor his chronology. It is also interesting to consider a number of coincidences around the man himself:

• Wacholder was born in a Sabbatical year (1924) preceding a Jubilee.

• Wacholder published his work on the Sabbatical cycle in a Sabbatical year (1973) preceding a Jubilee, at the age of 49.

• Wacholder was born one week before Tishrei 1, and died one week before Nisan 1 (September 21, 1924 and March 29, 2011, respectively). Thus, the scholar known for his chronology of Sabbatical weeks was born and died exactly one week before the dates from which Sabbatical weeks are counted.

There is far too much confusion surrounding the mRNA/lipid nanoparticle vaccines. Bodies are made up of 4 components, Proteins, Carbohydrates, lipids (fats) and nucleic acids (genetic material or RNA). 1

Synthetic RNA requires lipids in order to travel through the body and into cells. At the time of injection they combine two vials. The PEGylated Graphene Oxide (lipid nanoparticles) in one vial combined with the second vial containing mRNA (genetic material). When combined, they become known as Graphene Quantum Dots. Boston-based ExQor Technologies said it has demonstrated that the material can be formed into nano-sized biolasers suitable for transmitting information. It expects the technology will initially be used in medical applications. The precision of clathrin's selfassembly process, and ultra-small size also could be used to improve solar cells and batteries with nanoscale electronic and photonic properties not possible with silicon." People say no proteins in vial as if it is a bombshell, and there is not. mRNA is just genetic coding."

From that point on, Ishii dedicated his life to the deadliest kinds of science. His germ warfare and inhumane experiments aimed to place the Empire of Japan on a pedestal above the world. This is the story of General Shiro Ishii, Japan's answer to Josef Mengele and the evil "genius" behind Unit 731.

In order to protect Ishii and maintain a monopoly on his research, the United States kept its word. The crimes of Unit 731 and other similar organizations were suppressed, and at one point they were even labeled "Soviet Propaganda" by American authorities.

And yet, a "top secret" cable from Tokyo to Washington in 1947 revealed: "Experiments on humans were ... described by three Japanese and confirmed tacitly by Ishii. Shiro Ishii lived out the rest of his days in peace until he died of throat cancer at the age of 67. In any case, one thing is clear. Shiro Ishii never faced justice and died a free man in 1959 — all thanks to the United States deal with the Devil.
