Biden Pushing to Approve ‘Trash-Fed Crickets’ for Public Consumption

President Joe Biden’s administration is investing vast sums of taxpayer money into research to accelerate the approval of “trash-fed crickets” as “food” for the U.S. general public’s consumption.

Biden has reportedly ordered his Department of Agriculture (USDA) to rush through the approval to ensure that Americans are eating insects instead of meat and dairy products before the 2024 election.

To meet these demands, the USDA has allocated \$130,000 in federal taxpayer funds to advance the research into cultivating crickets as a protein source using municipal landfill waste.

[Mighty Cricket Inc.](#), a company specializing in cricket-based food products, is the beneficiary of the USDA's grant, the [Daily Caller](#) reported.

The research started on July 1, 2023, and is targeted to conclude by February 29, 2024. The agency's decision to fund research into trash-derived cricket feed is grounded in the belief that it could drastically cut the costs of cricket farming, allowing savings to trickle down to consumers.

The grant listing accuses traditional livestock farming of being overly resource-intensive and environmentally detrimental.

Biden insists that the American people need to replace meat in their diet with bugs in order to comply with the World Economic Forum's (WEF) "Net Zero" goals to "save the planet" from "global warming."

According to the [US Spending website](#):

"The research proposed in this application addresses the need for more cost-efficient production of crickets as a sustainable protein source. Compared to conventional proteins, cricket protein retails for over twice the cost. This is even after factoring out water weight (crickets are generally sold dry roasted or powdered).

The two biggest factors driving up the cost include lack of innovation and economies of scale. Unlike the beef, pork, poultry, and soy industries, there has been very little innovation invested into farming crickets. Most of the global production occurs in Thailand, where goods are generally produced via manual labor versus automation. In addition to labor costs, electricity and feed comprise the next two biggest costs in cricket farming.

Utilizing solar energy and insulation helps address electrical costs, meanwhile this research proposal seeks to address feed costs. As innovations reduce the cost of cricket production, it opens the door to more buyers, in turn improving economies of scale.

This research proposal also addresses the need to recapture food waste in the US, diverting a portion of food waste from landfills. The problem of food waste is significant. According to the USDA, in the United States, food waste is estimated at between 30-40 percent of the food supply. This estimate, based on estimates from USDA's Economic Research Service of 31 percent food loss at the retail and consumer levels, corresponded to approximately 133 billion pounds and \$161 billion worth of food in 2010.

Food is the largest component of municipal landfill waste, accounting for an average of 22%. All of this food waste creates a huge opportunity for Mighty Cricket to procure cricket feed at lower cost than what is available on the market. Mighty Cricket will then be able to pass along the cost savings to buyers of cricket protein. These include consumers purchasing Mighty Cricket products at retail outlets along with manufacturers of pet food, pharmaceuticals, and bioplastics.

In the last 10 years, global demand for alternative proteins has spiked. It is projected to increase at a compound annual growth rate (CAGR) of 18% through 2032, reaching \$497.6 billion USD.

The increase in demand is driven by public awareness of the need for more sustainable food sources. Conventional protein production poses a substantial strain on the ecosystem, requiring unsustainable quantities of water, land, and feed as inputs. Furthermore, animal based proteins are also a significant source of greenhouse gas emissions, estimated at 14.5% of all greenhouse gas emissions.

Today's food system can only feed 3.4 billion people sustainably. To sustain the world's growing population, food production practices need to dramatically shift towards resource conservation, and consumers are demanding change.

Cricket farming poses one solution to the challenge of food production, as it requires a fraction of consumable inputs compared to conventional proteins. This is why the UN Food and Agriculture Organization recognizes edible insects as a viable alternative to producing food and feed security.

Mighty Cricket will collect data on how the cricket feed produced from waste performs compared to standard feed on the market. The success of the project will be measured on the following objectives: cost savings of the feed, cricket growth, and mortality rates. Ultimately, the company hopes to lower production costs and the environmental footprint of the US food system."

Critics argue that this approach might be too avant-garde, overlooking potential health and ecological concerns associated with rearing insects on landfill waste.

Skeptics argue that without stringent regulations and thorough research into the safety and environmental implications, this initiative could inadvertently introduce toxins into the food chain or exacerbate waste management issues.

Last year the World Economic Forum promoted the EU's new plan to use mealworms in food in their bid to reduce meat consumption.

“Livestock around the world is responsible for around 14.5% of all greenhouse gas emissions relating to human activity,” the paper says.

People Vaccinated for Covid have Increased Risk of Neurological Diseases – Study

Data from almost 100 million people compares the expected and observed incidents of side effects

A big data study of 99 million people across eight countries showed greater than expected incidence of side effects from various Covid-19 vaccines, the Global Vaccine Data Network (GVDN) said on Monday.

The study, [originally published](#) in the medical journal ‘Vaccine’ on February 12, looked at 13 neurological, blood, and heart-related conditions, called “*adverse events of special interest*.” Researchers looked at 99,068,901 vaccinated individuals from ten sites in eight countries.

“The size of the population in this study increased the possibility of identifying rare potential vaccine safety signals,” said Kristyna Faksova, the lead author of the study from the Statens Serum Institut in Copenhagen, Denmark.

According to the GVDN, the study observed a greater incidence of myocarditis (inflammation of the heart muscle) and pericarditis (inflammation of the heart sac) than expected among those who took the Pfizer/BioNTech (BNT162b2) and Moderna (mRNA-1273) shots.

Moderna’s vaccine also had a higher rate of acute disseminated encephalomyelitis (ADEM, inflammation and swelling in the brain and spinal cord), with seven observed events compared to two expected within 42 days of the first shot.

Safety signals for myocarditis were “*consistently identified*” following the first three doses of either mRNA shot, with the highest ratio after the second dose. Signals for pericarditis also appeared following the first and fourth doses of mRNA-1273 and were also observed after a third dose of the Oxford/Astra Zeneca (ChAdOx1) viral vector vaccine.

Recipients of ChAdOx1 had 190 observed events of Guillain-Barré Syndrome (GBS) compared to the expected 76, and 69 observed instances of cerebral venous sinus thrombosis (CVST, a type of blood clot in the brain) compared to the expected 21, the study has shown.

The GVDN has made the results available to the public on its [interactive data dashboards](#), along with a warning not to read too much into correlations and that the vaccines are both safe and effective.

“By making the data dashboards publicly available, we are able to support greater transparency, and stronger communications to the health sector and public,” GVDN co-director Dr. Helen Petousis-Harris said.

The study was part of the GVDN’s Global COVID Vaccine Safety Project and was funded entirely by a \$10 million grant from the US Centers for Disease Control and Prevention (CDC).

Don't Be Fooled: Here's What 'FDA Approved' Really Means

If you've ever reached for a bottle of moisturizer labeled "patented" or "FDA approved," you might want to think twice.

In a [recent study](#) of hundreds of advertisements, I found that supplements and beauty products often misleadingly use these terms to suggest safety or efficacy.

As a [law professor](#), I suspect this is confusing for consumers, maybe even dangerous. Having a patent means only that you can stop others from making, using, selling or importing your invention. It doesn't mean the invention works or that it won't blow up in your face.

"FDA approved," meanwhile, means [a product's benefits have been found to outweigh its risks](#) for a specific purpose – not that it's of high quality or low risk in general.

Led astray by the label

I wanted to know whether companies exploit these sorts of misunderstandings, so I analyzed hundreds of ads from print, television and social media that mention patents or FDA approval. I found that advertisers throw these terms around in confusing ways.

For example, I found an ad for a probiotic supplement stating, *"The proof is in the patent"*; an ad for an earwax removal product stating its *"patented formula is safe, effective, and clinically proven"*; and an ad for a headache remedy that made the words *"FDA approved"* a bold visual focal point.

Here's the concerning part: I looked at all kinds of products and found that these terms appear most often in ads for things you eat or rub onto your skin, such as supplements, insecticides, toothpaste and lotions.

That's probably no coincidence. Products like this aren't tightly regulated, yet consumers want to know they're safe. It seems likely that advertisers are name-dropping the government to make people think just that.

Risks to consumers – and to innovation

One danger is clear: Ads with vague references to government authorities could dupe consumers into thinking products are safer or more effective than they actually are. In fact, there's some evidence this is already happening.

Another risk is that this creates perverse incentives for business. Companies could chose to forgo actual innovation, focusing instead on securing dubious patents or regulatory nods to keep up in the advertising race.

These practices could distort competition, burden government agencies with frivolous patent applications and deter new entrants from competing in markets where they can't employ similar advertising tactics.

Questions remain

Even though my study has shed light on how often these tricky advertising methods are used, it leaves some big questions unanswered. What exactly makes consumers [respond so favorably](#) to terms like "*patented*" or "*FDA approved*"? And who is most likely to be confused by these tactics?

As a next step, I plan to conduct comprehensive surveys of consumers, along with in-depth interviews, to explore how these labels resonate emotionally. I hope to coordinate with researchers from psychology and media studies.

Research along these lines could offer policymakers the robust evidence they need to make changes to the law.

What might those changes look like? For one thing, the law could make it easier for groups of consumers to sue in federal courts over misleading ads. The Federal Trade Commission could also place more of a burden on companies to prove their ads are honest.

These changes could make a big difference in ensuring companies persuade shoppers without confusing them.

At a time when ads are everywhere and Americans are losing trust in institutions – and each other – the stakes for truthful product claims are high.

U.S. Granted the UN \$1.3 billion in 2023 to Aid illegals Invading America

United States taxpayers are being milked of money that the United Nations (UN) and other agencies are spending [to aid illegals in crossing the U.S. borders](#). Based on available government spending data, more than \$1 billion in funding from the government has been granted to agencies assisting migrants.

"We are actually funding our own border crisis," Todd Bensman, a senior national security fellow at the Center for Immigration Studies, an anti-mass migration think tank. "And it's provided by, ultimately, the United States taxpayer."

Before President Joe Biden's term as president, America shelled out around \$500 million per year to the UN's main migration arm, the *International Organization for Migration* (IOM). But beginning in the Biden administration, the funding skyrocketed to nearly \$1.3 billion in 2023. This amount is [more than double what it had been](#) under former President Donald Trump's administration, as per [USASpending.gov](#).

As per government spending data, most of the money comes from the *Department of State* and the *U.S. Agency for International Development* (USAID). A total of \$547 million over two years ending in 2023 has also been voluntarily contributed to IOM from the Population, Refugees and Migration, which is under the State Department.

Moreover, the UN's "Regional Refugee and Migrant Response Plan" update for 2024 is requesting \$1.6 billion to be distributed to 17 Latin American and Caribbean countries. It is also receiving U.S. grants and has been allocated \$372 million in cash and vouchers

and "multipurpose cash assistance" during 2024 for 624,300 migrants in Central and South America who are headed for the U.S. border.

Migrants also directly receive cash, or what the UN emergency manual calls "[cash in envelopes](#)," and they know that the U.S. border is wide open. According to the U.S. House Committee on Homeland Security, there had been 6.2 million encounters at the southern border, in addition to 1.7 million known gotaways since Biden took office. "They say, 'Well, you know, we're coming now because Biden's letting us in,'" Bensman said.

Bensman, who has been at the forefront of investigating the causes of the migrant surge, found that IOM and other nongovernmental organizations (NGOs) helping migrants make the dangerous trek from South and Central America. Workers at an IOM migrant camp in Reynosa, Mexico, in 2021 told him that families of four were receiving about \$800 per month on a debit card. His viral post on X noted long lines of migrants waiting to receive the cards. One misperception is that the program allows the city to give out just \$50 million to migrants. No wonder the mayor has been reticent. This debit-card program — if you read the actual contract — has the potential to become an open-ended, multi-billion-dollar Bermuda Triangle of disappearing, untraceable cash, used for any purpose.

It will give migrants up to \$10,000 each in taxpayer money with no ID check, no restrictions and no fraud control.

This is total insanity.

Republicans propose bill to defund UN's illegal immigration operations

Even sanctuary city mayors have been crying for help and admitting that their local government funding and services are at breaking points due to the worsening migrant crisis at the United States border.

Because of this, the GOP lawmakers took the liberty to reintroduce legislation that would eliminate UN migrant funding. It's time to say enough and cut off funding to these corrupt globalist institutions until respect for our territorial integrity and appreciation for our generosity is restored."*

Zelensky Spends Millions in U.S. AID to Lobby DC

In the weekly news review on Russian television, the presenter made a comment about the West's handling of its nuclear weapons and the questions he raises cannot be dismissed. That's why I translated his [comment](#) .

Start of translation:

"The risk of nuclear war continues to increase

Strictly speaking, this is a violation of the Treaty on the Non-Proliferation of Nuclear Weapons. Because although the US formally retains control of its weapons in Germany, they are in German warehouses and on German territory, which means they are already under common control.

This week Germany decided to go even further. American nuclear weapons at their side now seem to be not enough for them. Finance Minister Christian Lindner spoke out in favor of stronger cooperation with Great Britain and France on the issue of nuclear deterrence. He referred to French President Macron's generous offer, which we will return to later. Let's stick with the Germans for now.

Katharina Barley, Vice President of the European Parliament from Chancellor Scholz's SPD, has spoken out in favor of establishing an EU nuclear force. However, the EU has no military functions. This is simply not intended. And now nuclear weapons! But Katarina Barley isn't uncomfortable with that. Here are her words: "This could become a topic of discussion on the way to the formation of the European army."

And how do you like this story? Under the pretext of the green agenda, Germany shut down its last nuclear power plants last spring. After all, the peaceful use of nuclear power is so scary! But no one talks about American nuclear weapons in the country. The country is also drawn into the nuclear games of Great Britain and France. Is there any logic to that? No. Just like with the increase in coal-fired power generation after the closure of the nuclear power plants.

And now to the French. They have no plans to give up nuclear power plants, even though their nuclear power fleet is outdated and France has not built a single nuclear power plant in the 21st century. But Macron has decided to prove himself differently. Recently, during a visit to Sweden, he literally said the following: "France has a responsibility to make its nuclear capabilities available to the EU."

Sorry, but how should one even imagine making this available? Who in the EU should have France's nuclear capabilities? Josep Borrell, who presents himself as the EU's defense minister, even though the office actually doesn't exist there?

And again the question of non-proliferation arises. In general, Macron's attitude to nuclear weapons is like that of Khlestakov in Gogol's "The Auditor": he has an extraordinary lightness of thought. One wonders if someone pulled that out of him? In any case, Khlestakov, who bragged about his literary talent to the city manager's astonished daughter, referred to the theater management.

So Macron amazed everyone one evening, and then things really started. The Germans have reacted. Trump explained that if Europe doesn't pay America, then America will no longer defend allies who owe money. And even Der Spiegel has the question on its front page today: "Does Germany need the bomb now?" After all, Trump refuses it...

In any case, the "unusual ease of thinking" about nuclear weapons cannot only be observed in Europe. In the USA, the nuclear button is in the hands of President Biden, who was officially declared to have limited ability to act last week. Special Counsel Robert Hur released a report on Biden's criminal cases and came to a negative conclusion because Biden is, quote, "an older man with memory problems who, in many cases, has difficulty recalling basic facts and details."

And such a person is in the position in the USA that he is the only one who can order the use of nuclear weapons.

The other person Biden must officially consult with before pressing the nuclear button is Defense Secretary Lloyd Austin. But General Lloyd Austin, in blatant disregard of his duty, disappears into the hospital for almost two weeks without telling anyone. How does that even work? Under these circumstances, the use of nuclear weapons in the West, both in Europe and America, is negligent, to say the least.

Would you like more examples? When he was president, Donald Trump angered potential nuclear powers like Iran and North Korea. On Iran, he pulled the U.S. out of

the nuclear deal that had imposed certain restrictions on Tehran, and on North Korea he was just arrogant and spiteful.

Then he suddenly claimed that he had received a “warm letter” from Kim, but a denial came from Pyongyang – Kim Jong-Un did not send a letter to Trump. Then Trump simply forgot about North Korea and his own commitments. That’s very American.

It is clear that North Korea has no choice but to further develop its nuclear missile capabilities and take care of its own security.

The risk of nuclear war continues to increase under these conditions, if only through human error. And in this behavior, as we see, one human error follows another.

Israel responds to Prince William's shock statement over Gaza conflict – as experts claim well-choreographed intervention shows he plans to be a hands-on King.

FROM 'THE DAILY MAIL' UK: The Prince of Wales, 41, ramped up his family's response to the Israel-Hamas war after he and wife Kate had earlier put out a joint statement of "distress". The heir to the throne expressed how his family was "deeply concerned" about its "human cost" in an impassioned statement just hours after Labor leader Sir Keir Starmer called for an "immediate humanitarian ceasefire".

It comes as royal experts say that his well-choreographed call for an end to the Gaza conflict showed he plans to be a hands-on King – while MPs have questioned whether King Charles knew about his son's statement before it was released. The comment comes just the day before MPs will debate and vote on an SNP measure calling for an unqualified 'immediate ceasefire' to end the bloodshed, even if Israeli hostages are not returned.

Labor has added an amendment as it also calls for an "immediate humanitarian ceasefire", adding a string of caveats to the demand.

A spokesperson for the Israeli Defense Forces said: "Israelis of course want to see an end to the fighting as soon as possible and that will be possible once the 134 hostages are released and once the Hamas terror army threatening to repeat the October 7 atrocities is dismantled."

“We appreciate the Prince of Wales” call for Hamas to free the hostages. “We also recall with gratitude his statement from October 11 condemning Hamas’ terror attacks and reaffirming Israel’s right of self-defense against them.”

Conservative MPs were wary of publicly criticizing Prince William but some questioned the royal’s ‘highly political’ message, calling his intervention ‘unwise’. But royal expert Richard Fitzwilliams said today’s intervention was evidence that William was following elements of his father Charles’ ‘outspoken’ approach to issues of the day.

He told ‘Mail Online’: *“The language William used in this statement was very stark. William has not been outspoken in the same way as Charles and tends to behave more like the Queen by being very circumspect. But he can be outspoken in very specific circumstances when he knows his words will carry weight.*

So while their style is very different, there something in his father in the way he made this statement. Over time we will judge how his style develops.”

Mr. Fitzwilliams added that William was *“following in his father’s footsteps’ by showing his interest interfaith relations. The Prince’s statement insisted ‘too many have been killed’ since Hamas’s terrorist attack on Israel on 7 October last year.”*

Now you might be asking the question about whether Prince William will be the Antichrist with Prince William’s stepping out onto the stage of world leadership; however it will in no way hinder or change the identity of the Antichrist of Revelation 13.

"Israeli Prime Minister Benjamin Netanyahu's office said on Friday that the country's military would expand its Gaza offensive into Rafah, despite the United Nations warning it would be catastrophic for the more than one million Palestinians who have sought shelter there."

"Netanyahu's office said ... that Israel could not achieve its goal of eliminating Hamas "by leaving four Hamas battalions in Rafah", and that the premier had told the military to draw up "a combined plan for evacuating the population and destroying the battalions".

Meanwhile, Egypt is quietly preparing a "safe zone" to absorb Palestinian civilians evacuating Rafah.

Might Jordan also be readying desert safe zones on its territory?

The Ark of the Covenant is said to be Located!

This location is recorded in our sources, and today, there are those who know exactly where this chamber is. the plan of Illuminized Freemason leaders is to seize control of the Temple Mount from the Arabs, produce the Ark of the Covenant -- an act which will spiritually thrill the people -- and then build the new Temple for the Masonic Christ.
