**Caught Red Handed: Fauci, Gates & Moderna are responsible for the COVID Pandemic – U.S. D.O.D issued a ‘COVID-19 Research’ contract 3 Months before COVID was known to exist & Fauci & Moderna had a Vaccine ready in Dec. 2019**

The discovery of a contract awarded by the U.S. Department of Defense to Labyrinth Global Health for “COVID-19 Research” in November 2019 has raised questions about the permanent U.S. Government’s knowledge of the novel coronavirus.

The contract was part of a larger project for a *“Biological threat reduction program in Ukraine,”* suggesting the permanent U.S. Government was at the very least aware of the alleged virus before it spread through Wuhan, China in December 2019.

But the findings also suggest the permanent U.S. Government may have had a hand in the creation of this alleged virus in Biolabs through Gain of Function Research overseen by Dr. Anthony Fauci.

This would explain why they knew the name of the novel coronavirus disease three months prior to the World Health Organization officially naming it Covid-19 in February 2020.

And it may also explain why Moderna and Fauci’s National Institute of Allergy and Infectious Diseases (NIAID) had a confidentiality agreement for an mRNA Coronavirus vaccine candidate in early December 2019, which was developed and jointly owned by Moderna and Fauci’s NIAID.

The U.S. Government’s *“USA Spending”* website reveals that it had spent a staggering \$4.04 trillion *“in response to COVID-19”*. A deeper look at the website’s *“Award Search”* feature uncovers a contract awarded by the Department of Defense to Black & Veatch

Special Projects Corp. for *“Professional, Scientific, and Technical Services”* on September 20, 2012.

A closer examination of the contract’s *“Sub-Awards”* tab reveals 115 transactions with recipients and brief descriptions, the majority of which are mundane items like *“laboratory equipment for Kyiv”* and *“office furniture for Kyiv.”*

There is, however, among the 115 transactions listed in the *“Sub-Awards”* tab of a contract awarded by the U.S. Department of Defense to Black & Veatch Special Projects Corp. one transaction that stands out:

An award to Labyrinth Global Health INC for *“SME Manuscript Documentation and COVID-19 Research.”*

While it is not surprising to see an award for COVID-19 research during a pandemic, the fact that the contract was awarded on November 12, 2019, at least one month before the alleged emergence of the novel coronavirus and three months before it was officially named Covid-19, raises questions about the government’s knowledge of the virus.

Furthermore, the contract was instructed to take place in Ukraine, as was the entire contract awarded to Black & Veatch Special Projects Corp. These findings suggest potential U.S. Government involvement in the creation and spread of the virus.

In September 2012, the Defense Threat Reduction Agency (DTRA) within the U.S. Department of Defense awarded a contract to a global engineering, procurement, and construction company specializing in infrastructure development.

The contract was for a Biological threat reduction program in Ukraine, and concluded in October 2020. While the details are unclear, it is known that \$21.7 million of the \$116.6 million contract was spent on this program.

It is puzzling why the DOD would contract a company specializing in infrastructure development for a biological threat reduction program.

Furthermore, it is intriguing that both the DOD and the contracting company subsequently paid Labyrinth Global Health INC to conduct COVID-19 research in Ukraine prior to the emergence of the novel coronavirus and before it was officially named Covid-19.

These events raise questions about the nature of the biological threat reduction program and its potential connection to the alleged COVID-19 pandemic. And the discovery of a contract awarded by the U.S. Department of Defense for Covid-19 research in November 2019 suggests that the U.S. Government either knew the virus existed naturally or was involved in constructing it in a lab.

This theory is supported by evidence that the National Institute of Allergy & Infectious Diseases (NIAID) and Moderna had a coronavirus candidate in December 2019.

A confidentiality agreement reveals that NIAID and Moderna agreed to transfer “*mRNA coronavirus vaccine candidates*” to the University of North Carolina at Chapel Hill on December 12, 2019.

The material transfer agreement was signed the December 12<sup>th</sup> 2019 by Ralph Baric, PhD, at the University of North Carolina at Chapel Hill, and then signed by Jacqueline Quay, Director of Licensing and Innovation Support at the University of North Carolina on December 16th 2019.

The agreement was also signed by two representatives of the NIAID, one of whom was Amy F. Petrik PhD, a technology transfer specialist who signed the agreement on December 12<sup>th</sup>, 2019 at 8:05 am. The other signatory was Barney Graham MD PhD, an investigator for the NIAID, however, this signature was not dated.

The final signatories on the agreement were Sunny Himansu, Moderna’s Investigator, and Shaun Ryan, Moderna’s Deputy General Counsel. Both signatures were made on December 17<sup>th</sup> 2019.

All of these signatures were made prior to the general public having any knowledge of the alleged emergence of the novel coronavirus.

A vaccine candidate that was funded by Bill Gates and his Foundation.

Moderna confirmed in 2016 that the Bill & Melinda Gates Foundation had granted them \$20 million to support their “*initial project related to the evaluation of antibody combinations in a preclinical setting as well as the conduct of a first-in-human Phase 1 clinical trial of a potential mRNA medicine*”.

But Moderna also revealed that the framework agreement they made with the Bill & Melinda Gates Foundation could bring the total funding up to \$100 million for “*follow-on projects*” that are proposed to and approved by the Bill & Melinda Gates Foundation up to 2022.

And the terms of this agreement stipulate that Moderna are obliged to grant the Bill & Melinda Gates Foundation certain non-exclusive licenses.

A Non-Exclusive License grants the licensee the right to use the intellectual property, but means that the licensor remains free to exploit the same intellectual property and to allow any number of other licensees to also exploit the same intellectual property.

Therefore under the terms of the agreement made with Moderna, the Bill & Melinda Gates Foundation have now been granted a non-exclusive license to the Moderna mRNA Covid-19 injection, and are therefore profiting from its use.

Are Fauci, Gates & Moderna responsible for the COVID Pandemic?

It wasn't until December 31<sup>st</sup> 2019 that the World Health Organization (WHO) became aware of an alleged cluster of viral pneumonia cases in Wuhan, China.

But even at this point, they had not determined that an alleged new coronavirus was to blame, instead stating the pneumonia was of "unknown cause".

It was not until January 9<sup>th</sup> 2020 that the WHO reported that Chinese authorities had determined the outbreak was due to a novel coronavirus which later became known as SARS-CoV-2 with the alleged resultant disease dubbed COVID-19.

So why were "*mRNA coronavirus vaccine candidates*" transferred to the University of North Carolina on December 12<sup>th</sup> 2019?

The same Moderna that have had an mRNA coronavirus vaccine authorized for emergency use only in both the United Kingdom and the United States to allegedly combat Covid-19.

What did Moderna, Fauci & Bill Gates know that we didn't?

In 2019 there was not any singular coronavirus posing a threat to humanity which would warrant a vaccine.

As the world tries to move on there are many questions that remain unanswered, the above being just some of them.

There are many sects, faiths, and religious systems that the secularists include within their favored term to encapsulate, to one degree or the other, religious belief in and spiritual embrace of the figure called Jesus Christ. These are each and every one false.

In my own view of what it means to be a Christian, there is but one system of faith. There is no other person, method, or anything else that can make a person a Christian. That Faith system, the Bible –God’s Word—tells us that Jesus Christ alone is the Savior of mankind. The person is a Christian who accepts without question what Jesus said: “I am the way, the truth, and the life. No man comes to the Father but by me” (John 14:6).

There is nothing that stands between God and the human being other than Jesus Christ, God’s only begotten (born in the flesh) Son.

It is with this Truth from God’s Word –the Bible—that I must somewhat qualify, or perhaps explain, the title of this article.

The Catholic system of belief –of which there are several versions—often is separated by those commenting on the Catholic faith as differing from mere Christianity. This is, presumably, because those devotees to that system consider their Catholic Church as the only True Church to the exclusion of others that left as part of the Reformation and since have divided into multiple factions of Protestantism.

Catholicism says there are layers of mediators between God and mankind, i.e., one must confess to a priest, who might take the confession to the Mother of God (Mary), who, again, presumably might take the confession to the Son (Jesus) Who then, presumably takes the confession and obtains the forgiveness necessary from God the Father. At least, this is my –a neophyte in comprehension of the Catholic system— cursory understanding of how the Catholic system of mediation works.

I cannot even begin to accept this for many reasons, but to name just one reason, I offer this Truth from God’s Holy Word.

***“For there is one God, and one mediator between God and men, the man Christ Jesus”*** -(1<sup>st</sup> Timothy 2:5).

Now, I write all of the above in order to try to explain how the Catholic pope –Pope Francis—has “defected” and why this “defection” is a key end time’s signal.

My belief in Christ alone for salvation precludes my counting the pope as within Christianity, but rather under the Christendom umbrella posited by the secularists, as I’ve tried to show above. So, when I say that Pope Francis has “defected,” I don’t mean that he has, in my view, defected from the True Christian Faith.

In my view, because of the Catholic Church’s declaration that there are a number of mediators between God and Man (as just one reason in this regard), this pope –or any other pope—can’t defect from a faith system under which they’ve never been.

This said, this pope, Pope Francis, has defected from that faith system –Catholicism—which has in common with True Christianity the belief that God finds homosexuality to be an egregious sin of an abominable sort. This agreement between the True Christian Faith and the Catholic faith does point starkly to the defection that this pope champions.

The following helps make understandable the end times apostasy at this late hour of the Church Age (Age of Grace).

Pope Francis is now accusing opponents of priestly gay-couple blessings of being hypocrites when, in fact, his blessing of homosexual relations and calling it good is hypocrisy. According to Francis, all the holy popes, bishops, and saints of Church history were hypocrites because they denied blessings to gay couples and barred them from the Church.

In a recent interview, Francis expressed his strongest words thus far concerning his decision to bless homosexual couples. He told NBC:

*“Nobody gets scandalized if I give my blessings to a businessman who perhaps \*exploits people, and this is a very grave sin. But they get scandalized if I give them to a homosexual, Pope Francis, via ‘Credere.’ This is Hypocrisy.”*

This is a highly inappropriate comparison and reflects an obstinate attempt to continue his blessing of homosexual unions. His argument holds no water. Comparing a businessman to a homosexual makes as much sense as comparing a carpenter to a rapist. A carpenter, by definition, is a responsible working man, whereas a homosexual, by definition, is a sex offender on the path to perdition. Businessmen generally are responsible people working to support their families, unlike homosexuals whose criminal lives “cry to heaven for vengeance.”

If a businessman comes to a priest for a blessing, it means he truly wants this blessing for his soul and for success in his work, so the priest should bless him. And while he might commit some sins or faults in his work, that’s not a reason to deny him a blessing. **“A just man shall fall seven times”** -(Proverbs 24:16) and then rises.

Whereas, if a homosexual couple comes to a priest for a blessing, it’s because they want their shameful relationship blessed. Were it otherwise, they wouldn’t dare to approach the priest ‘holding hands’ together. They want their gay union blessed, so Francis blesses it because he is a gay sympathizer. He is blessing their homosexual aspirations, not their souls, thereby working their eternal ruin, and then he calls it “good.” That is hypocrisy!

## **America’s First 15-Minute City Has Been Created In Tempe, Arizona – Do Residents Know What’s in Store for Them?**

## America's First 15-Minute City Has Been Created In Tempe, Arizona – Do Residents Know What's in Store for Them?



A 15-minute city is a SMART City in an urban environment with omnipresent surveillance and data harvesting technologies that will monitor and record even the most intimate, personal details of every individual inhabiting it.

The globalist goal is to collect the data of every individual and will know:

What they eat and drink,  
Where they go,  
What they buy,  
Who they meet,  
What they think and feel,  
Their opinions and habits,  
Their health and vaccination status. Etc, etc..

In other words, every little detail, and as the oft-quoted Noah Yuval Harari has said, those who own that data will know you better than you know yourself. Yet this all-encompassing surveillance has been justified as we are told that it will be essential for the future of the planet, and to save it from “*climate change*.”

They also guarantee it will make your life more connected, safer, and healthier and it looks like the “Culdesac” residents have bought the idea.

A 12 News report promoted the community as helping with sustainability which includes them giving up their own vehicles as “Culdesac” is the first community in the nation to



be designed around car-free living, but instead of being unhappy about this, the report showed a “Culdesac” employee who seemed to be thrilled about the alternate transportation provided in the neighborhood due to gas vehicles being prohibited from the area.

The employee told 12 News *“Residents can own one [a car] as long as it’s not parked on site”. “Can you imagine living on top of your grocery store?” the employee asked the news outlet.”*

*“What’s the appeal of living on top of a grocery store?” asked the People’s voice” who say that “of course, the development will be used to push similar Agenda 2030 nightmare neighborhoods across America.”*

A more recent report by NBC News promoted the car-free community to a national audience, talking with “Culdesac” co-founder Ryan Johnson, who claimed, *“Every generation and including 90% of Gen Z would like to pay more to live in a walkable neighborhood.”*

Do they know what their *“walkable neighbourhood”* is really all about though? While they may be thinking that it is like a scene from a 1950s movie, with white picket fences and all, or at its worst, it would be more akin to *“Nosedive”* an episode of Black Mirror. *“Once in a while I get annoyed about the fact that I have no real privacy. Nowhere I can go and not be registered. I know that somewhere, everything I do, think and dream of is recorded. I just hope that nobody will use it against me. All in all, it is a good life.”*

The central nervous system of Smart Cities will be **5G**. According to former Chilean president Sebastián Piñera, **5G** is not only able to read our thoughts but can also insert thoughts and emotions into everyone. He stated that it will become the central nervous system of society, and he guaranteed that they will make sure it reaches every home in the country. Interestingly, all streetlights in Smart Cities are also concealed **5G** antennas.

Smart Cities harvest everyone’s data surveillance data harvesting. Bill Gates Partner GAVI Vaccine Alliance Targets Online Memes

An international group promoting vaccines with ties to the Gates Foundation is going after memes. Whatever could make more sense?

But things here aren't as haphazard as they might seem. Bill Gates is known, and rich, for two things: as the founder of one of the most oppressive (in terms of design, security, and historically predatory toward free-as-in-freedom competing technology) companies ever - Microsoft.

And the other is Gates - now as a billionaire - reinventing himself through his *"uncanny valley"* philanthropic efforts, centered and emanating from his Bill & Melinda Gates Foundation, and focusing by and large on all sorts of vaccines, and - agriculture.

One of those involved, the GAVI Vaccine Alliance (that gets money from Gates) now wants to reframe memes - internet's succinct expression of humor and satire - as *"health disinformation super-spreaders."*

And we've heard this one before - this genre, that, in the digital age, might as well be considered as any other artistic format in previous times, is said to be capable of evading *"fact checkers and content moderators"* (i.e., censors).

In previous eras and authoritarian states, that would get the books with imagery and words characteristic of memes banned or burned.

So what could be the solution in the current era? And what does the big picture amount to?

Well, it's just Bill Gates going after a free and open internet again, only by other means - cynics might say.

But here's what a blog post on GAVI's site says: "Our research shows that memes form part of a highly sophisticated strategy to spread and monetize health disinformation."

(Not throwing the *"monetize slur"* in there - in the context of "the Gates!" /s)

### **Consequences of Prince Charles' Pipe Dream: Analysts Warn: Net Zero Movement to Cause SPIKES in Food Prices and Drive Farmers out of Business!**



Analysts have warned that the net zero movement will drive food prices even higher and small farmers out of business.

Farming requires large investments in heavy equipment and operating costs, especially during the time between planting crops or raising animals and selling them in the market. So, some farmer's claim that net zero policies could hurt smaller farms more than bigger ones. They argue that [smaller farms might struggle with the added costs](#), which may lead to fewer producers in the food industry.

A recent report by the pro-free market think tank the Buckeye Institute titled "Net-Zero Climate-Control Policies Will Fail the Farm" projects that farmers will experience a minimum 34 percent increase in costs due to net-zero emissions policies and corporate Environmental, Social and Governance (ESG) reporting requirements.



For instance, net zero mandates will increase the costs for a 700-acre corn farm in the U.S. from \$192,000 to \$257,000. Consequently, this increase is expected to raise the household grocery bill for an American family of four by over \$1,300 annually.

Rea Hederman, the executive director of the economic research center at the Buckeye Institute, stated that the public should understand the domino effect of raising costs for farmers.

*"It's important for people to understand that when you're raising costs to farmers, that is being passed on to consumers of food, and some types of food are going to be impacted more. So for example, beef is going to go up more than oranges because if you're raising the cost of corn, that's an input to beef, so beef suffers a double whammy,"* Hederman explained. (Related: [Food tyranny: NYC to monitor household food consumption as biotech companies take over food production.](#))

Data from the Federal Reserve supported Hederman in his claims. The data reveals that the average price of ground beef has already increased from \$3.97 per pound in January 2021 to \$5.03 per pound in January 2024.

### **ESG criteria could badly impact farming**

Agriculture officials from [12 U.S. states have sent letters to major financial institutions](#), including JPMorgan Chase, Citibank, Bank of America, Wells Fargo, Goldman Sachs and Morgan Stanley, urging them not to impose net zero criteria on farmers.

These banks are members of the United Nations' Net Zero Banking Alliance and have committed to the UN's net-zero goals through their loan portfolios. Farmers fear that stringent ESG criteria could disproportionately impact farming.

Fortunately, JPMorgan Chase has clarified that it does not have an agriculture emissions intensity reduction target and emphasized that it makes its banking, lending and underwriting decisions independently.

However, the administration of President Joe Biden has recommitted the U.S. to the UN Paris Climate Accord, which seeks to cut greenhouse gas emissions by up to 52 percent by 2030 and achieve economy-wide net-zero emissions by 2050. Former President Donald Trump withdrew from the agreement in 2017.

*"After recommitting the United States to the net-zero climate-control agenda, the president and Congress revived significant misguided features of the once-failed 'Green New Deal' through the Inflation Reduction Act. These federal initiatives and requirements will prove expensive and economically destructive here – just as they have been in Europe,"* stated the Buckeye Institute report.

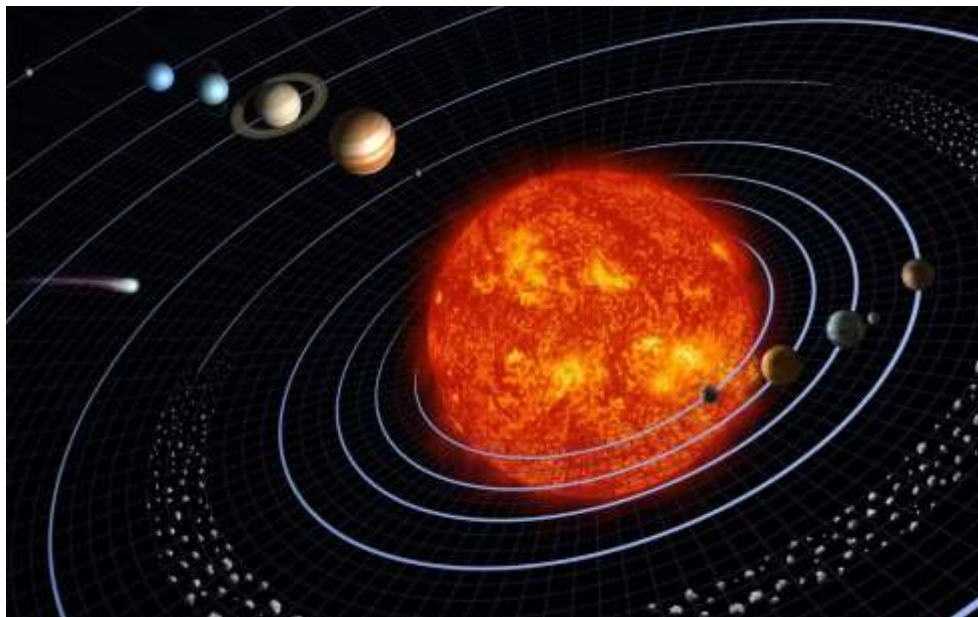

7 other planets in our solar system will form a line as the path of The Great American Eclipse of 2024 crosses America.

Since the Great American Eclipse of 2017, we have been waiting for the Great American Eclipse of 2024, and now it is less than 2 months away. On April 8<sup>th</sup>, the Great American Eclipse of 2024 will complete the giant "X" over America that the Great American Eclipse of 2017 started. Amazingly, on that exact day the seven other planets in our solar system will "line up" in the sky. This is an extremely rare event, and it will never be seen again.

### **What is going on in the heavens?**

In Luke 21:25, Jesus specifically told us that we should watch for “*signs in the sun, and in the moon, and in the stars*” just prior to His return.

During the month of April, so many things are going to be happening in the heavens. Let's begin with things that are commonly known. On April 4<sup>th</sup>, just 4 days before the Great American Eclipse of 2024, there will be a “planetary alignment” that will involve [4 planets](#)...

The next planetary alignment takes place on April 4<sup>th</sup>, 2024. It will feature four planets – Venus, Neptune, Saturn, and Mars. The planets will align in the morning sky. Venus, Saturn, and Mars will be visible to the naked eye, but you'll need a telescope or high-powered binoculars to see Neptune.

Half of the planets in our solar system will be aligned on that day, and that is pretty remarkable. In addition, there will be 4 “planetary conjunctions” during the month of April.

**On April 3<sup>rd</sup>, we will witness a conjunction of [Venus and Neptune](#)...**

On April 3<sup>rd</sup>, at 10:53 GMT (06:53 a.m. ET), Venus (mag -3.8) will pass 0°17' of Neptune (mag 8.0) in the constellation Pisces. Venus is visible with the naked eye, but Neptune requires a telescope or binoculars with good magnification. From the Northern Hemisphere, the conjunction will be difficult to see because the planets will be too close to the eastern horizon in the morning. From the Southern Hemisphere, the event will be slightly easier to see as the planets will be higher above the eastern horizon.

**On April 10<sup>th</sup>, we will witness a conjunction of [Mars and Saturn](#)...**

On April 10<sup>th</sup>, at 18:46 GMT (2:46 p.m. ET), Mars (mag 1.2) will pass 0°24' from Saturn (mag 1.1) in the constellation Aquarius. Both planets will be visible to the naked eye. Observers in the Southern Hemisphere will be able to see the planets high above the eastern horizon in the morning. In the Northern Hemisphere, the view will be poorer as the planets will be closer to the eastern horizon, rising just before sunrise.

**On April 20<sup>th</sup>, we will witness a conjunction of [Jupiter and Uranus](#)...**

On April 20<sup>th</sup>, at 07:30 GMT (03:30 a.m. ET), Jupiter (mag -2.0) and Uranus (mag 5.8) will meet in the constellation Aries. The distance between the planets will be only 0°31'. Observe the planets in the evening, low above the western horizon, just after sunset. This conjunction will be better seen from the Northern Hemisphere; in the Southern Hemisphere, Jupiter and Uranus will be very low. Don't forget to bring binoculars to see Uranus — this planet is too faint for the naked eye, especially from light-polluted cities.

**And on April 29<sup>th</sup> we will witness a conjunction of [Mars and Neptune](#)...**

On April 29, at 04:01 GMT (12:01 a.m. ET), Mars (mag 1.1) will pass extremely close to Neptune (mag 7.9) in the constellation Pisces. The apparent distance between the planets will be only 2'14" — even the distance between Jupiter and Saturn during the Great Conjunction in 2020 was greater (6.1 arcminutes). The conjunction of Mars and Neptune will be much less spectacular, however, because Neptune is too faint to be visible to the naked eye. Grab a pair of binoculars or a telescope and look for the duo in the east in the morning. Observers in the Southern Hemisphere will have a better view.

In addition to our planet, there are 7 other recognized planets in our solar system. In January, all 7 of those planets, along with the sun and the moon, began to “line up” in the sky.

This is different from a “*planetary alignment*”. During a “planetary alignment”, several planets appear to be stacked behind one another as one looks out from the Earth.

But in this case, the other planets in our solar system are actually forming a straight line in the sky. This is how Rachel Baxter explained it in the video.

Beginning in January, 2024 an alignment of the other 7 planets began to take shape and will continue through mid-May. Opposite the earth — when looking from Jerusalem to the East (which I believe is the way the Lord “keeps time” with His planets) all 7 recognized planets will line up in 3 constellations of Pisces, Aries and Taurus. They will look to be in a line (not what people commonly think of as a planetary alignment where the planets disappear into one bright light from our viewpoint.)

On April 8<sup>th</sup>, the sun, the moon and the other planets in our solar system will appear to form a straight line in the sky when looking out from Jerusalem toward the east.

A [narrative review published in Clinical and Experimental Medicine](#) concludes that COVID-19 "vaccination" actually increases one's likelihood of suffering through a SARS-CoV-2 infection. Furthermore, the evidence shows that the booster shots actually impair the most critical facets of the immune system – the function of CD4+ and CD8+ T cells.

### **COVID-19 "vaccines" put immune-compromised individuals in a perpetual state of immune failure**

The paper's lead author and scientist, Alberto Boretti, used the Google Scholar database to conduct the review. He did NOT find adequate evidence to suggest that repeated booster vaccination in immune-compromised individuals is safe or efficacious. The evidence he found showed that mRNA boosters actually impair the activation of CD4+ and CD8+ T cells.



These T cells are two of the most important facets of the immune system when it comes to surveilling, responding to and breaking down pathogens. These T cells also help the body respond to allergens and tumors. CD4+ T cells are responsible for activating other immune cells. They coordinate the immune response against other infections and help B cells create antibodies.

The CD8+ T cells help in the recognition and elimination of infected or abnormal cells. They also prevent excessive inflammation. When the vaccines suppress these T cells, they exacerbate basic infections and allow [tumor growth](#) to persist.

Despite an overwhelming body of evidence against COVID-19 vaccination, [the current CDC guidance](#) calls on children ages 6 months and older to receive one or two doses of an “updated” vaccine if they are immune-compromised and received an initial two doses before September 12, 2023.

Alberto Boretti advises against this: *"While booster doses have been recommended to enhance and extend immunity, especially in the face of emerging variants, this recommendation is not based on proven efficacy, and the side effects have been neglected."*

### **Compounding vaccination has created a population of immune-compromised individuals**

Immune-compromised individuals were one of the first groups of people prioritized for the experimental COVID-19 “vaccines.” According to the medical literature, the COVID-19 “vaccines” actually harm a compromised immune system even further. As more boosters are pumped into their blood, [their immune system is impaired further](#), destroying their ability to face all infections, and forcing these individuals into a perpetual state of immune failure.

On one hand, a high level of IgG4 antibodies after vaccination could equate to protection against the target infection. However, the protective effect of high IgG4 is only realized to a certain level. A [growing body of evidence](#) suggests that high levels of IgG4 antibodies from repeat vaccination actually causes multi-organ inflammation, autoimmune diseases, rapid onset cancers and autoimmune myocarditis. ## **A Stunning 10 Million Illegals Have Entered the U.S. Under Biden; Tucker Warns They Are "Destroying" The Country**

A record 7.3 million illegal aliens have crossed the southwest border under President Biden's watch, a number which according to Fox News is greater than the population of 36 individual states.

That figure is sourced from the U.S. Customs and Border Protection, which has already reported 961,537 Southwest land border encounters in the current fiscal year, which runs from October through September, and if the current pace of illegal immigration does not slow down, fiscal year 2024 will break last year's record of 2,475,669 southwest border encounters — a number that by itself exceeds the population of New Mexico.

The total number of southwest land border encounters since Biden assumed office in 2021 is 7,298,486, CBP data shows.

That number is larger than the population of 36 U.S. states including: Alabama, Alaska, Arkansas, Colorado, Connecticut, Delaware, Hawaii, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Dakota, Oklahoma, Oregon, Rhode Island, South Carolina, South Dakota, Tennessee, Utah, Vermont, West Virginia, Wisconsin and Wyoming.

In fact, the only states that are not in danger of being "replaced" are the blue ones.

Compared to the largest U.S. states, the 7.3 million numbers is about 18.7% of California's population of 39 million, 23.9% of the state of Texas and its 31 million residents, 32.3% of the population of Florida and 37.3% of New York. It's more than half the size of Pennsylvania, Illinois and Ohio.

As Fox News graphically describes, were the number of illegal immigrants who entered the United States under President Biden gathered together to found a city, it would be the second-largest city in America after New York.

Shockingly, that total does not include an estimated additional 1.6 million illegals who entered the U.S. at other locations, or 1.8 million known "gotaways" who evaded law enforcement, which would make the total bigger than the population of New York.

Taken together, over 10 million migrants have crossed into the U.S. illegally during the Biden administration a record Biden's critics assert could only be achieved by intentionally refusing to enforce the law.

*"This unprecedented surge in illegal immigration isn't an accident. It is the result of deliberate policy choices by the Biden administration,"* said Eric Ruark, Director of Research for Numbers USA, a nonprofit that advocates for immigration restrictions.

While some republicans and anti-illegal immigration activists have for blamed Biden for allowing the current overwhelming surge of migrants by reversing former President Donald Trump's border policies - a fact clearly visible in the chart above when comparing alien entrants under Trump and under Biden, the White House has denied responsibility for the crisis and pointed to external "push" factors like violence and economic instability in South and Central America as the culprit responsible for vast waves of migration to the U.S.

Meanwhile, the president's critics say migrants face more of a "pull" factor in the form of job opportunities and government benefits because they know they will not face deportation under Biden's lenient policies.

*"The administration has refused to enforce existing immigration law and taken every opportunity to aid and abet illegal border crossings — through policies such as catch-and-release, mass parole, and offering temporary work permits to tens of thousands of foreigners who make dubious claims for asylum,"* Ruark told Fox News Digital. *"In actual effect, the United States government is completing the human smuggling and trafficking process for the Mexican cartels."*

Ira Mehlman, a spokesman for the Federation for American Immigration Reform (FAIR), said migrants have learned in the last three years that they won't face deportation for entering the country illegally.

*"They have sent the signal that if you come to the U.S. illegally, if you abuse the asylum system, you'll be released into the country and allowed to remain here, in most cases given work authorization,"* Mehlman said. *"Even if you neglect to show up for your hearings, the odds of you being removed are negligible. The president claims he doesn't have the authority to enforce our laws. He absolutely does. He is deliberately not enforcing those laws."*

There is another reason why the Biden admin has refused to crack down on illegal immigration: as we first revealed, all of the jobs since 2018 have gone to non-native born workers, which primarily means illegal immigrants.

Since then establishment economists and lunatic idiots such as Paul Krugman and Jerome Powell have claimed that these illegal immigrants are actually beneficial for the economy as they take jobs that Americans are "too lazy" to take and have helped push down wage inflation; meanwhile the CBO has taken this grotesque stupidity one step further, and projected that the surge in illegal immigration will boost the US labor force significantly more than previously forecast...

... with CBO Director Phill Swagel, going so far as predicting that *"as a result of those changes in the labor force, we estimate that from 2023 to 2034, GDP will be greater by about \$7 trillion and revenue will be greater by about \$1 trillion than they would have been otherwise."*

"Got that?", the Washington Post in-house propaganda apparatchik asked rhetorically: Illegal immigration is not only not bad, it's great for the country, as it enables Americans to remain lazy, it reduces wage inflation and ends up boosting GDP by trillions. In fact, the only thing preventing the U.S. from entering a new golden age of growth is that instead of a mere 10 million illegals, the U.S. should gladly accept 100 million or more, and be thankful to the Biden regime, which alone could come up with this absolutely brilliant theory of common sense, sanity - and of course population - replacement.

Of course, for a far saner take on what is really going on, listen to the latest Tucker, who in his latest video note says that *"mass immigration is completely destroying our country."*

Listen to it before Tucker is also taken out by a CIA magic bullet.

[The Bible does not explicitly note the U.S.A. and/or its demise; however, there are many allusions to such a notion. The United States of America is not mentioned in the Bible. Some people believe that Revelation 17 or Revelation 18 is a reference to the U.S., but this is a matter of interpretation. However, the United States is mentioned in Daniel 7:14, where it is not attacked but its armed forces are destroyed.

Various groups try to find the United States in prophecy, and some of their interpretations show great creativity. Some see the United States as the second beast that rises from the earth in Revelation 13. Others see the **"people tall and smooth-skinned, . . . feared far and wide"** in Isaiah 18:2 as a reference to Americans, although the context is an oracle against Cush (verse 1). Still others point to Ezekiel 38:13, which, in describing the Battle of Gog and Magog, refers to **"the merchants of Tarshish and all her villages"**: according to this theory, "Tarshish" is Britain, and the "villages" are the English-speaking colonies such as the United States of America. And then there's the reference to the **"great eagle"** that protects the woman/Israel in Revelation 12:14—another reference to the United States' role in the end times, according to some.

The late Richard Coombes published his book, *'America, The Babylon: America's Destiny Foretold in Biblical Prophecy'* in 1998, the closest evidence to suggest the U.S. is in the Bible.

Dr. Dave Reagan of Lamb & Lion Ministry believes that the reason the U.S. is not mentioned in end time prophecy is because we will suddenly cease to be a world power and will therefore play no significant role in end time events. Dr. Reagan a former college professor once taught International Relations and understands geo-politics well enough to hold such a view that he does. It would take several pages just to show the corruption of the so-called Biden administration which have heavily damaged the world-view of the U.S. and its efforts to impose its will on nations around the world. The U.S. has been using intimidation and extortion on third world countries to accept the U.S. views on the LGBTQ culture. The problem is that the above interpretations require a good amount of speculation and seem to come from an Anglo-centric (or at least an America-centric) perspective. Why is the United States of America not clearly mentioned in Bible prophecy? There could be several reasons:

- 1) Perhaps in the end times the United States will be weakened to the extent that its influence in the world suffers, and America does not play an important role in end-times events.
- 2) Perhaps in the end times the United States has ceased to exist altogether.

3) Perhaps the United States is simply one of the other nations of the world that reject God in the end times -(Revelation 10:11; 11:18; 12:5; 14:8; 15:4; 16:19; 17:15; 18:3,23; 19:15).

The third option is the most likely answer. The United States of America has historically been one of Israel's most faithful allies, and God's promise to Abraham, "***I will bless those who bless you***" -(Genesis 12:3a), has resulted in America's success. But if America turns its back on Israel, it will lose God's favor: "***Whoever curses you I will curse***" (Genesis 12:3b).
