Preface: Among the most visible geopolitical controversies of our age is planetary climate. The idea goes that earth's temperature is rising, that this rise is becoming catastrophic, that its cause is manmade carbon emissions, and that only reductions in those emissions will save the planet and, by extension, humanity. But is any of this true? The American Geopolitical Institute will be exploring these questions through the eyes of our lead investigator, Dr. Lewis Coleman. In his initial article, Dr. Coleman takes a hard look at the much-maligned atmospheric gas, CO₂.

Carbon dioxide (CO₂) is the most misunderstood of all atmospheric gases, but also the most interesting. It is benign, beneficial, and essential for both plant and animal life, but it is vociferously vilified as toxic waste, like urine, that must be expelled from the body by breathing, and as a "greenhouse gas" that threatens human existence with excessive heat and melted polar ice.

Given overwhelming evidence to the contrary, these fractured fairy tales are flabbergasting. They can only be explained by prevailing ignorance plus the power, politics, privilege, and persuasion that perpetually prevails and perturbs human endeavor and prevents progress.¹

CO₂ is essential for life on the earth's surface. Multicellular plants convert carbon dioxide into carbohydrates for food and cellulose for structural support. In multicellular vertebrates, carbon dioxide is as essential as oxygen, because it enables the mechanism of oxygen transport and delivery that captures oxygen from the atmosphere (or water) and delivers it to cells deep within the body.²

CO₂ is also the major component of hydroxyapatite, which forms bone. The human body contains some 20 liters of gaseous carbon dioxide that is mostly dissolved in bodily fluids, as compared to 1 L of nitrogen and 1 L of oxygen. The CO₂ leaks from the skin and equilibrates with atmospheric CO₂, which slowly fluctuates over eons within a narrow range. Respiratory drive mechanisms adapt to this equilibrium and stimulate breathing to sustain it.

If CO₂ was a narcotic, we would all be drunk, and if it were toxic, we would all be dead. Instead, CO₂ has powerful therapeutic properties that were revealed by medical research at the turn of the 20th century. This is because breathing or bathing in CO₂ stimulates respiratory drive, reduces microvascular flow resistance, speeds the transport of oxygenated blood from the lungs to organs and tissues, and releases oxygen from blood into tissues.²

Carbon dioxide is one of the most beneficial substances on planet earth. Why then do the madmen who control society want to get rid of it?

It wasn't always this way.

A century ago, the nurse-anesthetists who dominated anesthesia service in operating rooms after WWI embraced physician research and supplemented ether anesthesia

with morphine analgesia to prevent harmful nervous activity induced by surgery.¹ They also supplemented ether with carbon dioxide to speed anesthetic induction and emergence; counteract morphine respiratory depression; optimize cardiorespiratory function, tissue oxygenation, and organ protection; and prevent heart attacks, strokes, atelectasis, pneumonia, nausea, vomiting, and unexpected postoperative respiratory arrest.

The success of these heroic nurses inspired physicians to use Carbogen, a therapeutic mixture of oxygen and carbon dioxide in pressurized tanks, to treat strokes, heart attacks, drowning, alcohol inebriation, drug overdose, asthma, pneumonia, smoke inhalation, cardiopulmonary arrest, and bacterial infections, and to assist newborn babies with breathing problems. Soon Carbogen became standard equipment on fire trucks in major cities, and it saved countless lives. All this came close to revolutionizing medicine in the 1930s.³

Carbogen has largely been forgotten, though with today's modern machines, monitors, and medications it could be more useful than ever. For example, it could cure or facilitate the treatment of interstitial cystitis, ulcerative colitis, regional enteritis, rheumatoid diseases, cancer, heart disease, and life-threatening critical illnesses such as eclampsia and multi-organ failure syndrome. CO₂ remains FDA-approved, but its therapeutic properties and even the mechanism of oxygen transport and delivery have been banished from medical literature and awareness, so it is almost never used anymore.

What happened was that, disastrously, organized medicine became envious of the success of the nurse-anesthetists and conspired to control this profitable medical specialty.⁴ In 1897 Dr. Charles Bardeen, the son of a New York publishing magnate, became the first graduate of Johns Hopkins Medical School. He was immediately appointed as a professor of anatomy at the University of Wisconsin Medical School, and then elevated to the position of Dean in 1907.

In 1927 he selected Dr. Ralph Waters to be the first chairman of a university department of anesthesia in the world. He later said, "*Ralph Waters was the first person the university hired to put people to sleep, but instead he awakened a worldwide interest in anesthesia.*"⁵ This anointed Dr. Waters with priceless prestige, and he knew how to use it. He was a shrewd salesman, who had acquired prominence in medical circles by dunking his anesthetized and intubated pet dog named "Airway" into a tank of water to demonstrate the effectiveness of Arthur Gudel's endotracheal tubes, which are inserted into the trachea to prevent airway obstruction and support breathing.^{6,7}

Dr. Waters immediately joined forces with Dr. Chauncey Leake, the chairman of the Department of Pharmacology at Wisconsin, whose specialty was war gas research, to devise specious animal experiments that deliberately confused CO₂ asphyxiation with anesthesia. Dr. Waters also confabulated clinical reports of anonymous anesthetists that dramatically described fictitious disasters caused by overenthusiastic CO₂ supplementation, which he characterized as "CO₂ toxicity" instead of

asphyxiation.^{1,8,9} This confusion has been subsequently sustained by rigged research and specious publications.¹⁰⁻¹³

As chairman, Dr. Waters introduced his practical new anesthetic technique that used intravenous barbiturate induction and paralysis to enable elective endotracheal intubation. This secured the airway against aspiration and obstruction, facilitated breathing, and enabled surgery in the prone position and in the oral cavity. These procedures were impossible with the mask management technique used by the nurses. Furthermore, the paralysis promoted surgical convenience by preventing untoward muscle tension and unexpected movements due to uncontrolled surgical stimulation.

Waters thus had devised a powerful political strategy to wreck the reputation of the nurses, replace them with his MD anesthesiology trainees, and promote the sales of his patented "*Waters Canister*" that absorbed carbon dioxide from gas mixtures. This created a powerful hoax that frightened physicians into avoiding both CO₂ and narcotics that has been abetted ever since by professional medicine, medical corporations, and "*climate change*" hucksters.⁴

He also indoctrinated his residents with the notion that carbon dioxide is "*toxic waste, like urine,*" that must be "*rid from the body*" to prevent mythical "*CO₂ toxicity*" by using mechanical hyperventilation during anesthesia.^{9,14} This was cleverly consistent with entrenched orthodox CO₂ beliefs, but it is scientific insanity, because hyperventilation is inherently dangerous, confers no benefits, and is incompatible with therapeutic narcotics. It also dangerously depletes CO₂ body reserves, which exaggerates narcotic respiratory depression and invites heart attacks, strokes, and unexpected postoperative respiratory arrest.

These effects, however, didn't become problematic until several years later when defective "closed circuit" anesthesia machines, which were designed to conserve expensive anesthetic gases, were replaced with "open circuit" anesthesia machines that were designed to eliminate any possibility of CO₂ accumulation within the machines.¹⁵ By that time, the therapeutic and life-sustaining characteristics of carbon dioxide were forgotten, so the consequent postoperative respiratory depression problems were blamed on narcotics.

Why? Because CO₂ is cheap, safe, effective, and easy to use, not all that far removed from a "home remedy." And because the combination of carbon dioxide and narcotics prevented lingering manifestations of the "*surgical stress syndrome*" including cancer, heart disease, and chronic illnesses, all of which promote professional and corporate profits at the price of public health.

Dr. Waters next took care to place his graduates in prominent positions in hospitals and university medical schools. Having successfully displaced the nurses, founded the anesthesiology profession on false science, and created a deadly hoax that has confused anesthesia practice ever since, he mysteriously retired at the age of 65 and refused further contact with the monstrous profession he had created.^{4,16-18} Meanwhile,

Dr. Chauncey Leake enjoyed prestigious appointments at UC San Francisco, the University of Texas, the Ohio State University, and as chairman of the Board of Science Journal.¹⁹

Seldom have so few caused so much harm to so many.¹ Their acts of wholesale mischief have reversed medical progress; derailed medical research; and killed and maimed countless patients ever since. Their endeavors are replete with the cloven hoof prints of organized medicine, powerful medical corporations, and the Wellcome Trust.

Back to CO2.

CO2 is a “trace gas” in the earth’s atmosphere that couldn’t possibly cause “global warming,” which is a cyclical phenomenon that occurs at intervals of hundreds of years. The most recent prior episode occurred during the early 1400s, when a fleet of massive Chinese junks sailed through the melted North Pole passage and mapped the world, soon followed by Western explorers.²⁰ But the ice froze again before Admiral Byrd and his contemporaries searched for the mysterious polar passage. Now it has melted again, and commercial shipping prefers it to the Panama Canal.

What, then, is the source of CO2? The fact is that it is continuously produced by the vast mass of microbial life that thrives in the hellishly hot environment deep beneath the earth’s surface, where the nuclear core provides abundant chemicals that serve as food. This explains the high CO2 concentrations found in caves and why volcanic eruptions belch forth vast quantities of carbon dioxide. Its high molecular weight causes atmospheric CO2 to hover near the earth’s surface, where photosynthetic bacteria and multicellular plants avidly consume it and constrain its concentration to only 0.03% of the atmospheric gas mix, so that plant and animal life on the earth’s surface thrive at the brink of CO2 starvation.

Multicellular life cannot survive at higher altitudes such as the “dead zone” near the top of Mt. Everest where CO2 is virtually absent, which explains why the top of Mt. Everest is littered with lemming-like Darwin Award winners and why their guides suffer hypoxic brain damage.

CO2 is also an ideal refrigerant with a revealing history. It was patented in Britain as a refrigerant in 1850, and in 1870 an American businessman installed CO2 refrigeration in a cargo ship to transport beef from Texas to New York City. It is devoid of toxicity, but its low cost undermines its commercial viability.²¹ CO2 was soon supplanted by ammonia, but consumers feared ammonia toxicity, and preferred ice deliveries to ammonia refrigerators.

For example, tour guides at California’s Hearst Castle were sickened by ammonia leaking from its damaged antique refrigerators after the 1989 Loma Prieta earthquake. The German division of the international General Electric cartel retained Albert Einstein and Moshe Szilard to invent safe refrigeration technologies during the interval between WWI and WWII. They patented several commercially impractical ideas,²² but their

efforts were rendered moot by Thomas Midgely, Jr., the infamous inventor of leaded gasoline, who dramatically inhaled Freon, a fluorinated hydrocarbon developed by DuPont, to demonstrate its safety before a crowded engineering convention.²³ The DuPont Corporation then promoted Freon, whereupon Freon refrigerators were enthusiastically embraced after WWII.

However, Freon was never safe. When exposed to open flame it degenerates to phosgene gas, which killed more soldiers than any other “war gas” during WWI. This was particularly problematic because refrigeration repairmen routinely used propane torches to detect Freon leaks.²⁴ This explains the fakery of the “Ozone Hole” hysteria, which enabled DuPont to replace dangerous Freon with hydrocarbon alternatives that likewise cannot compare to the safety of carbon dioxide.

Freon also explains the pulmonary illness suffered by firemen and policemen during the 9/11 demolition of the World Trade Center towers, which exposed massive quantities of Freon to thermite flame.²⁴ Thankfully, the European Union has introduced regulations to restrict toxic chemicals, so Mercedes Benz and other European corporations are now developing safe CO₂ air conditioning systems for cars and homes.

So, the next time a “climate change” fanatic starts ranting at you about the horrors of CO₂ you can tell them to hold on until they hear “the rest of the story.” Meanwhile, must we await the arrival of our great-great grandchildren before the therapeutic blessings of carbon dioxide, surgical narcotics, and stress theory can be realized? Why not us? Why not now?

Red Cross Caught Spiking Blood with Covid mRNA Vax

The American Red Cross has been caught pumping unvaccinated patients with blood that has been tainted with Covid mRNA vaccines.

The organization claims that it prevents patients who've recently received a Covid vaccine from donating blood. However, a worker tells an undercover journalist they don't separate donated blood by vaccination status.

They also often mix the two together to contaminate the unvaxxed blood with Covid mRNA vaccines. Blood batches that have been spiked with mRNA vaccines and are routinely transfused into unwitting patients, officials with the American Red Cross told an undercover journalist.

Following revelations that the American Red Cross is asking potential blood donors whether they've recently received a COVID-19 vaccine, undercover journalists with Stephen Crowder's 'Louder With Crowder' team found that the Red Cross does not separate donated blood by vaccination status, despite screening for vaccination.

"[In] situations where you may be in a car accident or something, you need blood right away, there is a possibility that you'll be getting vaccinated blood," a phone operator at the American Red Cross told an undercover journalist posing as a physician.

Asked if a patient could possibly learn whether they were receiving "vaccinated blood," the Red Cross worker replied, *"There isn't any way."*

"The blood isn't separated, you know, depending on if you're vaccinated or not."

The worker added, *"The only way that they can get it, blood that's not vaccinated, is if they donate for themselves, or if they have a family member that's willing to donate for them."*

Elsewhere in the call, the Red Cross worker described an anecdote of a situation in which a blood donation from a vaccinated person was denied because she began experiencing ringing in her ears, a common side effect associated with the COVID-19 vaccine.

"So, some people have had the vaccine two years ago and are still experiencing some type of symptoms, so that's why we specifically ask regarding that one," the worker said.

"Like for instance," the Red Cross worker continued, *"I've had one donor before call in and after she received the vaccine, her doctor was able to find that she had a direct correlation to ringing in the ears afterwards."*

"And so we see that as a symptom — so anything abnormal, and it proceeds to this day — so she essentially wasn't eligible to donate."

The Red Cross's tacit admission there could be something wrong with blood from a COVID-19 vaccinated patient comes as social media users this week discovered the group is now asking potential donors if they have "EVER had a Coronavirus (COVID-19) vaccine?"

If answered "Yes," the Red Cross tells potential donors to call a 1-800 number to check if they're still eligible to donate.

The problem of vaccine-tainted blood circulating in the blood supply has become a major issue over the past three years.

Some Americans have been refusing transfusions from COVID-19-vaccinated donors. The Red Cross's hesitancy to accept vaccinated blood appears to validate concerns by people who were skeptical of the COVID-19 vaccine rollout.

However, the Crowder team's latest revelations now highlight a new problem where vaccine-tainted blood is integrated into the blood supply.

This is not the first time the American Red Cross has been negligent on blood supply issues. Some 65 million Americans given the Polio vaccines from 1955 through 1962 were given an added gift of the SV-40 cancer causing strain of a vaccine that led to the premature death of millions. For decades the ARC kept this secret from the public until 1997. Both the Salk and Sabin polio vaccines were affected!

Insider Reveals Bill Gates Running WHO: 'Tedros Is Just a Puppet'

A United Nations (UN) insider has revealed a small handful of unelected globalists are secretly running the World Health Organization (WHO).

But patronage is not just a vehicle to gain positive press coverage. The benefits of patronage can be summed up in what I’ve termed in my research the “patronage bargain”, referring to the positive qualities that arise from the relationship.

These benefits, such as obligation, reciprocity, responsibility, dependency, kudos and indebtedness, give the patron a sense of duty and purpose. These features have been a hallmark of the patronage relationship from the 17th century through to today’s royal patronages.

According to Dr. David Martin, a leading vaccine expert with insider contacts at the UN and the WHO, *“Tedros is just a puppet.”*

Congressional Budget Office Director Phillip Swagel warned that the growing \$34 trillion national debt's interest payments will cost more than the entire defense budget this fiscal year. *"We have more debt and we have higher interest rates,"* he said on [Fox Business Network](#) on Tuesday. *"It makes us more vulnerable as well with more debt if interest rates go yet higher, it's like a turbocharger with our interest payments going up."*

According to a recent Committee for a Responsible Federal Budget analysis, interest will exceed defense spending and Medicare payments in fiscal year 2024.

"Spending on interest is projected to total \$870 billion, while spending on national defense will total \$822 billion. This has never been the case before, going back to at least 1940," read a [new analysis](#) from the CRFB. *"In addition to breaching defense spending, interest costs are expected to exceed Medicare spending this year, making interest on the national debt the second largest line item in the FY 2024 federal budget, behind only Social Security."*

Pressure is building on House Speaker Mike Johnson to hold a vote on the Senate-passed \$95 billion foreign aid bill that includes \$61 billion for Ukraine. The legislation does not include provisions that would cover the cost of the package.

"Vladimir Putin will not win if we stand united beside Ukraine in its fight for freedom," Rep. Jasmine Crockett, D-Texas, [wrote Tuesday on X](#). "Speaker Johnson, we have the votes to stop Putin in his tracks. Come back to work and put the bill on the floor."

House Foreign Affairs Committee Chairman Rep. Mike McCaul, R-Texas, has said that a [discharge petition](#) would be likely to force a floor vote on the foreign aid package if Johnson doesn't put it on the floor.

"I don't see any way of getting out of Israel, Indo Pacific and eventually Ukraine coming to the floor," [McCaul said](#) on Friday. "He's either going to have to do it — put it on the floor himself — or it's going to be by virtue of a discharge petition, which is a complete evisceration of his power, because it basically says we're going to do this without the speaker being in charge."

[The Senate border deal](#) language was removed from the foreign aid package in the Senate after Senate Republicans had blocked that version from advancing in the chamber. Johnson had said it was *"dead on arrival"* in the House amid opposition from Republicans over several provisions that they said would not adequately secure the border. House GOP leaders were not directly involved in negotiating the agreement.

Last week, White House press secretary Karine Jean-Pierre was asked about Johnson requesting a meeting with Biden over the border. She noted Biden previously met with congressional leaders in January. *"What is there to negotiate, truly?"* she said at a press briefing. *"It's almost as if the speaker is negotiating with himself."*

On Monday, Biden said he would be willing to meet with Johnson regarding Ukraine funding.

"Sure, I'd be happy to meet with him if he has anything to say," he said after blasting House Republicans for not voting on the foreign aid package yet.

The House is scheduled to come back into session on Feb. 28.

Those days are gone, and we can no longer depend on the Courts and the legal systems for Truth, Fairness, and Justice for all, which we were told was the American Way! How many millions went off to war and died to defend that principle they have torn to shreds in New York City? The American Way of Life is dead. The Democrats have allowed our nation to be flooded with people who do not share our culture, our philosophies, or our history solely to ensure they win at all costs.

This is no longer any difference we have with Russia and China and how they treat the people. The United States now has more people in prison than China, which has 1.5 billion people compared to our 300 million. The system is so bad that Judge Rakoof was thoroughly disgusted and wrote a book on his experience on the bench in New York. The title is ***“Why the innocent plead guilty and the guilty of free.”*** I cannot express strongly enough that you have virtually no chance of a fair trial **EVER** in the United States. And if they cannot put you on trial, they will kill you and swear it was suicide. Nothing but nothing someone is charged with should **EVER** be taken as truth. Even Madoff quickly pled guilty to save his family, yet his son still committed suicide. There, too, the banks claimed they had no idea. That was a lie and **ABSOLUTELY** impossible.

I was interviewed by a journalist when they saw the bank was illegally trading in my accounts, like MF Global. Engoron found Trump was found liable for overstating the values of his assets on bank loan applications. That is a common negotiating practice, like haggling in a bazaar in Iran. It’s expected and an insult if you do not. Considering that New York City is the world’s financial capital, the city’s bankers walk on water and are among the most sophisticated on the planet. Developers always inflate property valuations, and banks

have their own appraisers who simply adjust them down. According to Turley, during the trial, ***“witnesses [loan officers] testified that they wanted to do more business with Trump, who was described as a ‘whale’ client with high yield business opportunities.”***

It is the same when trading. The banks try to guess if you will buy or sell and will move the quotes in the direction they anticipate you will trade. It is always a negotiation. That is how high-stakes finance deals are done.

Covid Shots Were ‘Designed to Kill,’ Top Scientist Warns

A globally celebrated scientist has uncovered explosive evidence to suggest that Covid mRNA shots were developed as a mass depopulation tool, warning they were “designed to kill.”

Professor Denis Rancourt says that not a single life was saved by the Covid vaccines.

“Divide that number by 800 and you end up with approximately 17 million COVID-19 vaccine-related deaths,” noted *The Vigilant Fox* on X, also sharing the following video from Dan Skorbach.

Electrical engineer John Beaudoin has been probing the data in his home state of Massachusetts as well, coming to similar conclusions about the ugly nature of COVID jabs.

Upon looking through the death database compiled by the Massachusetts Department of Health, Beaudoin found that 2020 *“was a year of excess respiratory [deaths],”* followed by a change in 2021 after Covid injections were unleashed on the world.

Beaudoin found that excess respiratory deaths actually went *down* in 2021 after the jab’s release *“while at the same time, the blood and circulatory causes of death went up instead of down.”*

In other words, the coughs and colds that people suffering during the Covid “pandemic” largely disappeared after the shots were rolled out for public use, only to be replaced by many now-known adverse events stemming from COVID shots.

“So what people are dying from, they’re dying from ... cardiac stroke, pulmonary embolism, gastrointestinal hemorrhages, aortic arch dissections, more than the respiratory, which went down at the same time,” Beaudoin said.

Five Marks of a False Teacher

In the pursuit of spiritual growth and understanding, the true Bride of Christ is a community that is rich in faith, hope, and love, all bound together by the Word of God. Yet, within this visible body, there lurks a danger that threatens the very fabric of our faith—false teachers. These people, driven by their own desires and agendas, stealthily introduce destructive heresies, leading many astray, and marching many straight to the pits of Hell. The Bible, our unerring and authoritative guide, illuminates the path to discernment and offers clear markers to identify those who distort the truth. Here, we explore five biblical traits of a false teacher, arming believers with the knowledge to protect their faith and community.

Trait #1: Twisting Scripture

False teachers are notorious for their cunning manipulation of Scripture, bending it to fit their own narratives and deceive the unwary. They cherry-pick verses, taking them out of context, to endorse sinful lifestyles or justify ungodly beliefs. Like the serpent in Eden, they ask, **“Did God really say...?”** leading people away from the truth of God’s Word. The Apostle Peter warns us of such individuals, stating, **“They twist the Scriptures to their own destruction”** -(2nd Peter 3:16). A true teacher of God’s Word handles it rightly, offering the full counsel of God, not just the parts that tickle itching ears.

This disgraceful practice almost always catapults them into the realm of rank heresy, challenging and distorting basic Christian doctrines that form the foundation of the faith. They will very often pervert the doctrine of the Trinity, a mystery central to our faith, by promoting heresies such as modalism or denying the distinct persons of the Godhead, which undermines the unity and diversity within the Trinity itself. Such false teachings

not only confuse believers but also strip the Christian faith of its power and lead many into a superficial and insufficient understanding of God's nature.

The denial of Christ's deity is a grievous error propagated by some under the guise of enlightened teaching—a heresy, as ancient as the church itself that undermines the very foundation of our salvation—the incarnation, death, and resurrection of God the Son. And the prosperity gospel is another malignant distortion, promising health, wealth, and success as the inevitable outcomes of true faith.

False teachers will also often misuse Scripture to endorse new revelations or secret knowledge, placing their own authority above that of the Bible. They claim direct revelation from God, bypassing the need for Scriptural support and leading their followers away from the sufficiency of Scripture and into the dangerous waters of subjective experience. This not only breeds confusion but also elevates human authority above divine revelation, a move that is antithetical to the core principles of the Reformation—*sola Scriptura*, by Scripture alone.

Trait #2: Greed for Gain

One of the most telling signs of a false teacher is their insatiable greed. They exploit their followers, weaving tales and fabricating “*revelations*” to line their pockets. Their messages often revolve around prosperity and financial blessing, contingent upon the giving of money to their ministries. Paul speaks to this in 1st Timothy 6:5, describing them as “***men of corrupt mind, who have been robbed of the truth and who think that godliness is a means to financial gain.***” True shepherds of Christ's flock feed the sheep without thought of personal gain, seeking rather to store up treasures in heaven.

This greed manifests most conspicuously in the teachings of false teachers like Kenneth Copeland, Todd Bentley, Jesse Duplantis, and their ilk—teachers of the prosperity gospel—who have turned their ministries into platforms for personal enrichment. These false teachers are known for their relentless focus on tithing and giving, often with the promise that such financial sacrifices will unlock God's blessings of personal wealth and health. They peddle a gospel that is more about investment in earthly riches than in heavenly treasures, again, twisting Christ's teaching that “***where your treasure is, there your heart will be also***” -(Matthew 6:21).

Kenneth Copeland, Todd Bentley, and Jesse Duplantis are all false teachers who twist the Scriptures, abandoning the actual gospel for their prosperity teachings. They encourage their followers to give financially, even to the point that it causes them to go into extreme debt, all with promises of divine rewards. Copeland's seed-faith concept, Bentley's calls for donations tied to healing and breakthroughs, and Duplantis's claim for a \$54 million jet for gospel spread, all exemplify the distortion of biblical giving. These teachings not only distort Scripture but also pressure believers into supporting the extravagant lifestyles of these preachers as they exploit the faith—albeit a false faith—for personal gain.

These are just a few examples of this trait that demonstrate a fundamental departure from the teachings of Jesus and the apostles, who warned against the love of money and urged followers of Christ to seek first the kingdom of God. The apostle Paul's admonition to Timothy about the dangers of desiring riches is a stark reminder of the true calling of the shepherds who lead God's people—to shepherd with humility, integrity, and a focus on eternal, not temporal, rewards.

Trait #3: Denial of Christ's Headship

An often overlooked trait of false teachers is a subtle, but profound and often concealed denial of the sovereignty and lordship of Jesus Christ. This denial may not always manifest through an open and direct rejection of His deity or the essential truth of His atoning sacrifice. Instead, it frequently surfaces in the attitudes and teachings of false teachers who, while paying lip service to Christ's lordship, position themselves as the pinnacle of authority and spiritual insight within their "churches." Steven Furtick very well may be the quintessential example of this tendency as he parades himself as the ultimate arbiter of truth in his church, focusing sermons on his personal achievements, insights, and so-called spiritual acumen, rather than on the teachings of Christ.

These leaders, self-styled as "*vision casters*" and the ultimate standard for their followers, subtly redirect the allegiance due to Christ to themselves. Their sermons overflow with references to their own accomplishments and spiritual journeys, overshadowing the gospel with narratives of self-glorification. This narcissistic approach not only diverts attention from Jesus but also fosters a culture where the leader's voice holds more weight than Scripture, thereby eroding the foundation of Christianity—Christ as the head of the church.

The actions of these false teachers often betray a heart that is far removed from the humility and servitude modeled by Jesus. Such leaders demand obedience and subservience, not to Christ, but to their own directives and visions for the church. In this distorted framework, a believer's relationship with God is mediated through, and contingent upon, their loyalty to the leader. This dangerous dynamic effectively sidelines the true essence of Christian discipleship, which is direct and personal communion with Christ, guided by His Word and Spirit.

This subtle yet pervasive denial of Christ's authority undermines the very essence of the Christian gospel, which proclaims Jesus as the sole pathway to salvation and the supreme authority over all creation. Jude's admonition against those who "***deny our only Master and Lord, Jesus Christ***" -(Jude 1:4) remains distinctly relevant in our modern religious landscape, cautioning us against the allure of charismatic leaders who, through their actions and teachings, detract from the supremacy of Christ. For true spiritual nourishment and growth, we must anchor ourselves in the teachings of Scripture, uphold the centrality of Jesus in all aspects of our faith, and resist the seductive charisma of those who would place themselves above the Lord they claim to serve.

Trait #4: Moral Compromise

False teachers will frequently usher their followers into a state of moral compromise, selectively disregarding the Bible's clear directives on sin to promote a *"tolerant"* or misleadingly *"progressive"* moral compromise. This dilution of biblical morality and the gospel's call for personal holiness often serves to rationalize sinful conduct, masquerading as a distorted understanding of grace. Paul's warning to the Roman church about those who prioritize their own desires over service to Christ, using ***"smooth talk and flattery"*** to mislead the unsuspecting, rings ever true today - (Romans 16:18). True spiritual shepherds will guide their flock toward a lifestyle of repentance and sanctification while opposing the sham "liberty" that is ultimately just continued bondage in sin.

This moral compromise among false teachers is not limited to their teachings but is very often reflected in their personal lives, rife with accusations and instances of affairs, sexual immorality, adultery, bullying, and more. Their actions, grossly at odds with biblical morality, spotlight a deep-seated, even pharisaical hypocrisy, as we see in Romans 2. These false teachers tend to view themselves as beyond the reach of accountability, enshrined within a self-constructed pedestal of infallibility. This dangerous mindset not only undermines the integrity of their ministry but also sets a perilous example for their followers, suggesting that power can exempt one from the moral strictures demanded of Christ's followers.

The personal failings of such leaders—ranging from the exploitation of their positions for sexual gain to the manipulation and bullying of those who dare to question them—reveal a flagrant disregard for the ethical and spiritual accountability that is foundational to Christian leadership. The New Testament is replete with admonitions against such behaviors, emphasizing the need for leaders to be above reproach, faithful to their spouses, gentle, self-controlled, and holy -(1st Timothy 3:2-3; Titus 1:6-9).

And finally, the tendency of these false teachers to cloak their immorality in theological justification—claiming grace as a cover for sin—perverts the gospel's true message of redemption and transformation. Such perversions of grace not only lead people astray but also tarnish the witness of the Church in the eyes of a watching world. The biblical call to holiness is not an archaic or optional aspect of Christian faith but the very evidence of a life transformed by the power of the Holy Spirit.

Trait #5: Creating Division

False teachers, in their quest for influence and control, often become the architects of division within the church, strategically undermining the unity that is found in Christ. They do this by promoting and prioritizing controversial or non-essential doctrines, creating factions and splinter groups that pledge allegiance to their distorted teachings rather than to the gospel of Christ. Paul explicitly condemns such behavior, instructing Titus to admonish those who cause divisions, and even calls for severing ties with those who persist in this disruptive conduct -(Titus 3:10). Notably, not all divisions are detrimental. In fact, Scripture delineates a clear distinction between destructive division and the division that arises naturally from clinging to orthodoxy and exposing heresy.

Romans 16:17-18 stresses that the true agents of division are not those who call out false teachings in defense of biblical truth but the false teachers themselves—those who introduce heretical doctrines into the body of Christ. These false teachers tend to label their critics as “*heresy hunters*” or deploy other pejorative aimed at discrediting their legitimate concerns. This behavior isn’t limited to those who are teaching rank heresies but is prevalent within mainstream Evangelical circles. If you need an example of this, just look at the establishment leadership of the Southern Baptist Convention and see how they treat anyone who questions their positions on anything from women pastors to Critical Race Theory.

Nonetheless, the false teachers, through their rejection of sound doctrine, be it subtly or blatantly, bear the responsibility for fracturing the church’s unity. This differentiation is crucial—division over doctrinal integrity and the clear teachings of Scripture is not only justified but necessary to maintain the purity and integrity of the church’s witness.

The New Testament affirms the importance of discernment and the responsibility of believers to defend the faith against false teachings that threaten the core of Christian orthodoxy. Jude 1:3 exhorts believers to “***contend for the faith that was once for all delivered to the saints,***” signaling that division in the face of false teaching is an act of fidelity to the gospel. This form of division is not a mark of disunity but a testament to the church’s commitment to truth and purity, safeguarding the community from teachings that lead away from salvation and the true knowledge of God.

False teachers exploit the biblical call for unity to silence criticism and continue their propagation of errors unchallenged. In reality, true biblical unity is rooted in shared truth and doctrine, not a superficial harmony that ignores or tolerates theological error for the sake of peace. Effective church leadership involves discerning these threats and acting decisively to protect the flock from teachings that deviate from the gospel of Christ.

I hope you found this list helpful. The Christian walk is one of vigilance and discernment, as false teachers abound, seeking to lead the faithful astray. We can identify and resist these wolves in sheep’s clothing by grounding ourselves in the Word of God and heeding the Holy Spirit’s guidance. We must always cling to the truth of Scripture, uphold the authority of Christ, and walk in unity and holiness, so that we may stand firm against the schemes of those who would pervert the gospel of grace. Our lives must reflect the light of Christ as we earnestly contend for the faith once and for all delivered to the saints.

Does Pope Francis Have All The Markers Of An Apocalyptic Figure?

Pope Francis is revealing himself to be a blatant Marxist. He has also pulled back from issues Catholics have considered sacred. He apparently has replaced abortion with social justice and environmentalism. Most troubling, however, is his call for a “new world order” and that there be a global constitution, a global court and a one-world government. Scripture is clear that the Antichrist will be the head of a one-world government (Revelation 13).

Even conservative Catholics are sounding a warning that Pope Francis—the first Jesuit Pope—may be the most troubling Pope ever. He is raising apocalyptic concerns and some in the eschatological community feel that he, indeed, has gotten the nod to be the False Prophet.

Roger Oakland, a former Catholic, writes, “According to Bible prophecy, a one-world religion that will offer the promise of peace throughout the world is going to commence prior to Christ’s return. To most, this global body will seem like a wonderful thing and very possibly will be a pseudo-Christianity (coming in the Name of Christ); however, contrary to how the masses will view it, it will actually help establish and set up the Antichrist and his one-world government.”

He continues, “In order for this to happen, all religions must come together in an ecumenical plan. Today, as part of this Satanic scheme, the evangelical/Protestant church is being drawn seductively into the Roman Catholic Church, largely through what we call ‘the Jesuit agenda.’ Incredibly, while the evidence is obvious to some, the majority of proclaiming Christians are not at all aware it is happening.”

Francis, in 2014, sent a video message to Kenneth Copeland urging reconciliation between Catholics and Charismatics, a move cheered by Copeland’s audience. The video’s introduction was delivered by a friend of Francis, Anglican Episcopal Bishop Tony Palmer, who told Copeland’s audience that “Catholic and Charismatic renewal is the hope of the Church.”

Pope Francis is making a plea for the union of many faiths. He reportedly has said, “Jesus Christ, Mohammed, Jehovah, Allah. These are all names employed to describe an entity that is distinctly the same across the world.” He opened the door to Muslim prayers at the Vatican.

Can you say one-world religion?

Pope Francis has spoken at the White House, Congress, and the U.N. pushing climate change and “sustainable development” which is again all about global government! One has to wonder where he fits the gospel into his agenda. It doesn’t appear as though it does. One writer calls him a “wolf in Pope’s clothing.”

Put it all together: Marxism, environmentalism, new world order, global government, sustainable development, the Jesuit agenda, unity of faiths, a global constitution, a global court, a departure from Catholic traditions.
