## **Banks will 'tokenize' customer deposits to pave way for CBDCs Digital tokenization explained in simple, plain English**

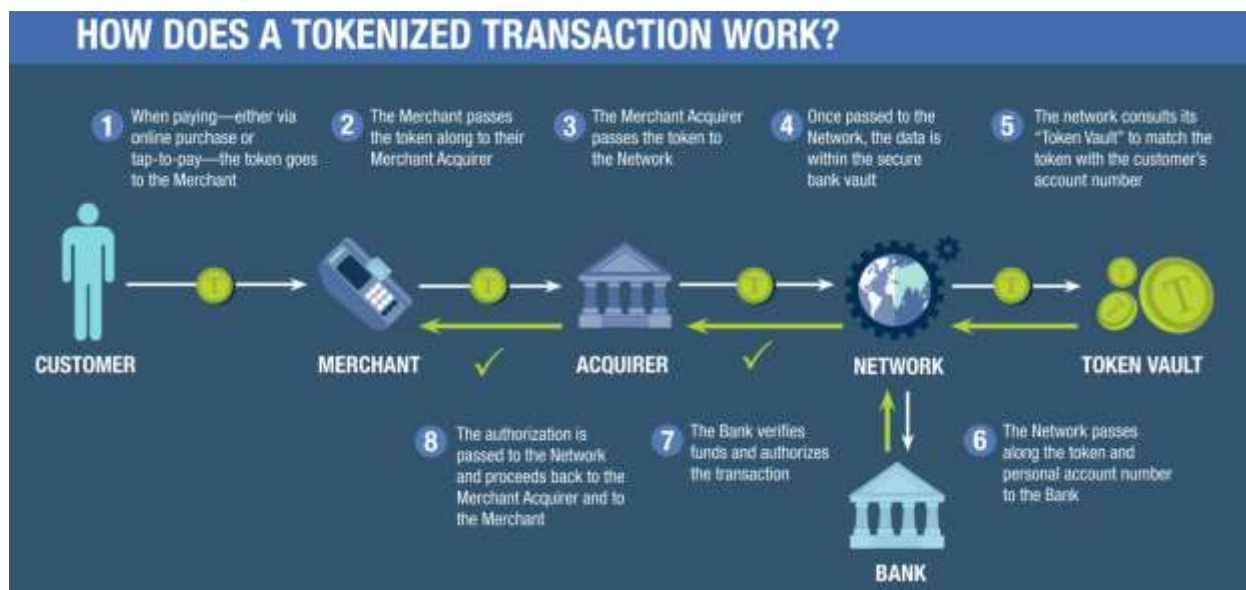

Petrova laid out the key to the coming digital system. They will tokenize your assets. The other part of the deal is that they will also tokenize your existence through the issuance of a digital ID. Any asset, living or nonliving, can be tokenized.

What is a digital token?

Wireless token technology has been around since 2008. A wireless token is like a serial number printed on a dollar bill, including a series of letters and numbers, only with tokenization those letters and numbers can change every ten seconds. These changes provide authentication.

Over the past four years while people were being distracted to bring on the "Great Reset" of the WEF, the world has been conditioned to a shift of paradigm; they simply do not understand how it is they will lose it all.

The introduction of the credit card lead by American Express back in 1972 has laid a trail of psychological "mind entraining" to where people today use their cell phone to do banking. It all seems so innocent and so right but it is more like a sugar-coated poison pill.

While 86% of the world's central banks weigh the potential risks and rewards of issuing a central bank digital currency (CBDC), much of the analysis remains abstract to experimental. This is a good thing, since there are numerous potentially destabilizing risks and other considerations central bankers must weigh as they contemplate entering the digital currency space race. Indeed, a space race is afoot for the future of money and payments, but the real choice is not whether central banks should become retail-level technology companies, an implied change of launching a CBDC. Rather, the real debate is how to let a growing and increasingly competitive private sector thrive in adding much needed competition and optionality when it comes to the future of payments and money.

Here are 10 key risks and considerations that are often missed in the CBDC debate, and should be carefully weighed as central banks look at the tradeoffs of digitizing their national currencies.

**1. Technology risks and obsolescence** - Launching a CBDC would transfer substantial technology risks to the public sector and ultimately taxpayers, who would bear the brunt of fast moving and often experimental technologies. Blockchains are now in their third generation and the technologies of public, open-source financial infrastructure are evolving rapidly. Consumers, markets and public authorities will all benefit in equal measure if this evolution in the movement of value on the Internet, like all others before it, remains a free market activity with public sector oversight.

**2. Cyber threats and single points of failure** - Invariably, a CBDC would necessitate centralization, which would amplify already rife cyber vulnerabilities and increase the surface area and vectors of attack to now include central banks, in addition to the economy overall (recall Equifax, Solar Winds and the Colonial gas pipeline as 3 examples). To truly leverage the inherent cyber resilience of distributed systems, public blockchains alongside a competitive free market for the movement of value on the internet is a better long range posture. Just as the failure of any one bank erodes confidence in banking, a CBDC could potentially transition this risk to central banks negating the benefits of strategic risk-sharing structures and operational "air gaps" between participants in the financial system.

**3. Privacy and consumer protection** - A CBDC, particularly if issued at the retail level or by a less than benign government (noting the thin line between democracy and anarchy), would represent a potentially troubling encroachment on consumer privacy and protections. What would stop the weaponization of a CBDC against citizens or the potential blockage of lawful transactions by groups that fall into disfavor? To the right of lawful, the use of money (a public good to which equal access is a human right) and how it is saved, sent, spent and secured, should be as free as possible while maximizing the penalty on bad actors.

**4. Systemic risk and destabilization** - A CBDC creates a potential domestic “flight to quality” problem, which would destabilize the very two-tiered banking system central banks are designed to protect. The potential systemic effects of a CBDC, the prospect of spillover effects by virtue of increased velocity of money, among other perils, could pose serious detrimental effects to the banking system and economy writ large. The model represented by privately-issued digital currencies with a veritable “air gap” between reference assets (such as cash, cash equivalents and high quality assets inside the banking system) and tokenized assets on public blockchains results in no new money creation and protects and preserves the two-tiered banking system. Critically, the transmission of monetary policy is also preserved.

**5. Vendor risk and technology capture** - For a CBDC to exist, someone is selling some newfangled technology to central banks. This introduces the often overlooked operating vulnerability of supply chain and vendor risk, let alone the potentially insidious prospect of buyer’s remorse or technological obsolescence. Protecting the public provenance of money and monetary oversight does not require central banks to become retail banks or, worse yet, technology service providers with massive stores of data recreating the very “honeypot” databases that attract swarms of cyber ne’er-do-wells.

**6. The limitations of digital twins** - Conceptually, CBDCs come in many shapes and sizes, with the most likely outcome being a wholesale variant, which could potentially make interbank relationships more efficient, but would leave retail and market-level improvements up to trickle down effects. The real financial inclusion and innovation gains, as with the current state of play of digital currencies, e-money and mobile money innovations, hinges on robust free market competition and innovation with exponential technologies. Many of these can be considered digital public goods, which benefit from open source standards that promote competition and rapid prototyping and gain from thousands of developers and cybersecurity experts (leveraging bug bounties) who collectively improve resiliency.

**7. Decentralization is the point** - If a CBDC is to work at all, at least as currently conceived, it must ride on blockchain rails. Herein lays the conundrum from a technological, operational and governance point of view, which is that with blockchains decentralization and distribution are the key. Therefore, a CBDC issued and managed by a central authority would likely involve closed loop systems or pseudo blockchains,

which in turn would replicate the very cyber and other potential manipulation vulnerabilities distributed systems were designed to combat.

**8. Regulate the activity not the technology** - Most competitive regulators and banks for that matter; acknowledge the need to regulate the financial activity and not the technology. Notwithstanding the void of an industrial policy in the U.S. and other countries on how to harness exponential technologies such as blockchain, artificial intelligence and quantum computing, among others, there is a tendency among

Regulators to want to bar crypto-assets and blockchain-based payment systems. Ironically, these very technologies may represent the most material upgrade to financial inclusion, innovation and integrity in 50 years - the sum of this translates into potential exponential gains in financial crime compliance and security as well, through the collective witness of public financial ledgers on the internet.

**9. Disruption of free markets** - A vibrant and competitive economy produces growth through the creative destructive process. Over the maiden decade of cryptocurrencies, digital assets and public blockchains (now in their third generation), entrepreneurs have built a \$2 trillion dollar sector. This journey has been rife with risks, failures, lessons learned, and, critically, growing regulatory understanding and clarity on how to responsibly harness these foundational innovations. The free market is where these risks (and those outlined in this article) should remain. Indeed, the key is to espouse and practice activity-based, technology neutral regulations and, vitally, to regulate the economic behavior of digital assets and not take a catch all approach - in short not all crypto is created equal. If it behaves like a security, it probably is. If it behaves like a currency or payment system, it should be afforded the benefits of “digital legal tender” or conformity with well-laid money transmission, e-money, financial markets infrastructure and prudential rules.

**10. Complex systems fail in complex ways** - While there is no question the public sector must continue to innovate and evolve their digital transformation agenda. Keeping up with the central bank Jones’ and jumping onto the CBDC bandwagon transitions more risks to the public sector, which already labors under challenges with core infrastructure upgrades, than the potential rewards a CBDC warrants. As the risk management adage goes, complex systems fail in complex ways. Transitioning a rapidly evolving blockchain-based business model to the public sector for something as fundamentally critical as money and monetary oversight negates the fact that most value-added money in circulation today (M2) benefits from a robust banking, payments and technology landscape - all operating under the purview and global coordination of central banks, who are the guardians of the macro-prudential framework.

Against this backdrop, there is a sobering choice ahead on whether it is prudent for central banks to digitize their fiat currencies. As with every other evolution in the movement of money since humanity shifted from trucking and bartering their goods, to more formalized units of account and mediums of exchange, how money moves invariably has evolved into a public-private phenomenon.

**AS a student of eschatology, I am continually amazed at how Bible prophecy is being fulfilled in our time.**

But never more than now. T.W. Tramm shares his insights.

A few weeks ago, we witnessed a remarkable sign in the heavens, an astronomical alignment mirroring the "Sign of the Woman" in travail in Revelation 12.

And now, the nation symbolized by the woman—Israel—is at war for the first time in 50 years.

The surprise attack by Hamas is being called:

- *"The worst massacre of Jews since the Holocaust."*
- *"The greatest intelligence failure in Israeli history."*
- *"Israel's 9/11."*

To date, more than 1,300 Israelis have been killed, 3,000 wounded, and scores taken hostage. Many civilians, including the elderly, women, children and infants, have been brutally beaten, raped, burned, and beheaded by the barbaric attackers.

As Israel prepares to invade Gaza, missiles and mortars fired from Lebanon and Syria, and threats from other Islamic factions are raising concerns about a multi-front war. Needless to say, the war unfolding in Israel marks a dramatic escalation of the "birth pains" signaling Jesus' soon return (Matt. 24:6–8).

Understanding that *"God is in the details,"* here are some other indications that the war is prophetic:

### **LIKE A FLOOD**

The attack on Israel is being called *"Operation Al-Aqsa Flood."* Al Aqsa is the Arabic name given the Temple Mount in Jerusalem, ground zero for the culmination of Bible

prophecy (Zech. 12:2; Dan. 9:24–27). Moreover, a “flood” is a metaphor for judgment being poured out in the last days:

***“The end of it shall be with a flood, and till the end of the war desolations are determined”*** (Dan. 9:26).

***“The serpent spewed water out of his mouth like a flood after the woman, that he might cause her to be carried away by the flood”*** (Rev. 12:15).

The demonic ‘flood’ unleashed by Hamas caught Israel by surprise, echoing another end-times passage about a flood:

***“In the days before the flood, people were eating and drinking, marrying and giving in marriage, up to the day Noah entered the ark; and they knew nothing about what would happen until the flood came and took them all away. That is how it will be at the coming of the Son of Man”*** (Matt. 24:38, 39).

## **PEACE AND SECURITY**

A major reason Hamas (Iran) attacked Israel was to derail ongoing peace talks between the Jewish state and Saudi Arabia. Iran views the Saudis as “apostates,” enemies of “true Islam,” and their cozying up to Israel as an obstacle to Iranian hegemony in the region. Thus, while Israel was talking about “peace and security,” destruction came upon them suddenly, as labor pains on a pregnant woman (1 Thess. 5: 1–3).

## **RIPE FOR JUDGMENT**

The attack on Israel happened on the final day of the Feast of Tabernacles, the festival that celebrates the ingathering of the summer’s produce (Deut. 16:13). Prophetically, the fruit harvest is when Israel faces judgment (Amos 8:1, 2; Mic. 7:1, 2 CSB; Jer. 8:20 NET CEV).

## **THE WOMAN IN TRAVAIL**

As mentioned earlier, Israel was attacked on the heels of a major sign in the heavens. The September alignment in Virgo, which mirrored the “Sign of the Woman” in travail in Revelation 12, conveyed that the Rapture and Judgment Day are imminent. ## **JUBILEE**

The current war in Israel began 50 years, to-the-day, after the nation’s last major conflict, the Yom Kippur War of 1973. What’s more, the seven Sabbatical “weeks” between 1973 and 2023 comprise a Jubilee period, making 2023 a Jubilee. The Jubilee is the year of redemption for those who know Jesus, but marks the beginning of judgment for those who do not (Isa. 63:1–4).

## **AMERICAN ECLIPSES**

The attack on Israel occurred seven days ahead of another biblical sign. On Saturday, October 14, an annular “ring” solar eclipse will occur in the left-hand (ring-finger) area of

the constellation Virgo. Significantly, the eclipse is the second of three “American eclipses” viewable from the US between 2017 and 2024.

Here are some reasons the trio of American eclipses is prophetic:

- The three eclipses encompass a seven-year span. Biblically, the number seven signifies completion or a period of warning ahead of judgment (Gen. 7; 41; Josh. 6).
- The paths of the three eclipses intersect to form the first and last letters of the Hebrew alphabet, the Aleph and the Tav, thus inscribing a type of ‘signature’ of God, who is the “first and the last,” across the US (Rev. 22:13). Moreover, the Tav, or “X,” drawn by the eclipses signifies an end, or something being cancelled. (Click the link for an image: <https://tinyurl.com/33afnswt>).
- The first (2017) eclipse occurred on the first day of Elul, the month associated with repentance. The second (2023) eclipse occurs on the first day of Cheshvan, the month of judgment. The third and final (2024) eclipse occurs on the first day of Nisan, the month of new beginnings.

Another noteworthy aspect of the eclipse-signs relates to an asteroid, or minor planet, named 4220 Flood. During this weekend’s eclipse, asteroid 4220 Flood will be in the Constellation Aquarius, the sign that depicts the outpouring of the Holy Spirit in the last days (Joel 2:28–31). During the next and final American eclipse in 2024, asteroid 4220 Flood will be near the Sun and Moon in the Constellation Pisces, the sign that depicts God’s people in captivity, or hiding from the enemy.

Thus, in the above signs, we have a picture of two types of floods: an outpouring of the Holy Spirit, and the enemy pursuing God’s people like a flood (Rev. 12:15).

It gets more interesting. With the American eclipses and asteroid 4220 Flood in view, it is significant that in Strong’s Hebrew Concordance, #4220 is the word meach, meaning “wealthy, “fat,” or “rich.” America, where the eclipses are viewable, is home to the largest Jewish population outside Israel and, specifically, the descendants of the Tribe of Ephraim. In Scripture, Ephraim boasts that his wealth makes him immune to judgment:

***“I am very rich; I have become wealthy. With all my wealth they will not find in me any iniquity or sin”*** (Hos. 12:8).

But God says Ephraim will not escape judgment:

***“Ephraim has aroused his bitter anger; his Lord will leave on him the guilt of his bloodshed and will repay him for his contempt”*** (v. 14).

***“The guilt of Ephraim is stored up, his sins are kept on record. Pains as of a woman in childbirth come to him, but he is a child without wisdom; when the time arrives, he doesn’t have the sense to come out of the womb”*** (Hos. 13:12, 13).



While signs in the heavens do not enable one to predict the future, the general message of the eclipses and asteroid Flood seems to be that America (Ephraim) is ripe for judgment, and that something is about to occur that will unleash a flood of suffering and evil, but also a great outpouring of the Holy Spirit upon the Jews in the US and Israel.

As we watch and wait to see what God has in store, let us pray for the Jews already facing an onslaught of evil. May many come to know Jesus sooner rather than later, and escape all that is coming upon the world.

## **New Report Shows Violent Attacks Against Christian Churches Have More Than Doubled—Media Silent**

Don't expect to see any reports or op-eds about this issue on any left-leaning, legacy media outlets – it doesn't quite fit the narrative our once-vaunted Fourth Estate wishes to promote. A troubling new report from the Family Research Council (FRC) shows an alarming increase in documented incidents of aggression against churches. In fact, the number of these attacks more than doubled in 2023, and raises concerns about the state of religious freedom and respect for religious institutions.

The [report](#) notes that *“Over the past six years (2018-2023), FRC has identified 915 acts of hostility against churches in the United States” and that “Between January and November 2023, at least 436 acts of hostility against churches took place in the United States.”*

These acts included *“at least 315 occurrences of vandalism, 75 arson attacks or attempts, 10 gun-related incidents, 20 bomb threats, and 37 other incidents.”*

There are several different reasons why hostility against churches is on the rise. The report [suggests](#) these attacks *“may be symptomatic of a collapse in societal reverence and respect for houses of worship and religion.”*

Although the motivations for many of these incidents remain unknown, the rise in crimes against churches is taking place in a context in which American culture appears increasingly hostile to Christianity. Criminal acts of vandalism and destruction of church property may be symptomatic of a collapse in societal reverence and respect for houses of worship and religion—in this case, churches and Christianity. Americans appear increasingly comfortable lashing out against church buildings, pointing to a larger societal problem of marginalizing core Christian beliefs, including those that touch on hot button political issues related to human dignity and sexuality. Attacks on houses of worship may also signal a discomfort with religion in general.

For congregants and clergy, acts of hostility against their churches can be intimidating. For example, when a statue of Mary outside of a Catholic church is beheaded, it is natural for congregants to feel disturbed and upset, and that may be the vandal's aim. Acts of hostility against churches can send the message—regardless of whether it is the perpetrator's intent—that churches are not wanted in the community or respected in general. This may cause congregants or church leaders to feel unsafe. In some instances, the goal of the hostility is undoubtedly to interrupt the normal work of the church.

These findings come after the Supreme Court's ruling overturning *Roe v. Wade*, and the wave of fire-bombings and vandalism of pro-life organizations that followed. Many of these attacks were perpetrated against Christian groups.

The report's revelations are even more disturbing given that the nation has seen yet another church shooting at Lakewood Church in Houston, Texas, earlier in February.

It is worth mentioning that the report only details reported incidents of violence against churches. The authors note that *“many acts of hostility against churches are likely not reported to authorities and/or are not featured in the news or other online sources.”*

The spike in church-related violence is not happening in a vacuum, and coincides with a broader cultural and legal battle over religious freedom in America. Institutions across the country, including corporate America, higher education, the media, activist groups, and others have been a part of the battle over religious freedom.

There is also the issue of anti-gunner legislators doing their level best to prevent armed security in churches. New York's state government is one of several that [prohibits](#) civilians from carrying firearms in places of worship.

This news should be a clarion call for churchgoers and religious leaders. If there is a rise in anti-Christian sentiment manifesting in violent attacks, it is even more important for believers to be aware of their right to defend themselves and the lawmakers who seek to infringe on this right. While many churches have law enforcement officers present to protect the congregations, many don't, which makes it even more necessary for Christians to take their safety into their own hands.

## **How 'Trusted' Christian Pastors Coerced Congregations To Take Deadly COVID Vaccines Resulting In Untold Deaths**

([America Outloud News](#)) A new research paper has been published that shows how “trusted” Christian churches in the U.S. took government bribes — in the form of COVID relief grants — in exchange for pushing the [deadly, experimental COVID “vaccines”](#) on their unsuspecting congregations — which lead to the deaths and disabilities of untold thousands of “believers”.

*“What if I told you powerful U.S. government officials – such as former NIH Director Francis Collins and U.S. Surgeon General Vivek Murthy – **used religion in an attempt to convince faith leaders around the country to push the COVID-19 injections?**” A*

deep dive into the organization [Faiths4Vaccines](#) – a founding member of the HHS’ vaccine-propaganda machine COVID-19 Community Corps – has revealed just that.



That the HHS was tapping faith leaders in the spring of 2021 to push the uptake of COVID-19 vaccines was not a surprise. We uncovered this **in our previous article** that we broke on the COVID-19 Community Corps at the end of 2022.

But what did surprise us as we dug deeper for this article was the extent to which **faith leaders were pursued to push the COVID-19 vaccines and the inappropriate – if not unconstitutional – manner in which government officials persuaded these faith leaders to push the shots.**

With 86 founding members, the “*faith leaders*” category of the COVID-19 Community Corps was the most numerous. These founding members included both individual faith leaders and faith organizations from a variety of religions – including the American Baptist Church, Catholic Charities USA, the Episcopal Church, the National Association of Evangelicals, the Greek Orthodox Archdiocese of America, and the New York Jewish Agenda, just to name a few.

Not surprisingly, **many faith organizations received federal money during the pandemic.** For example, an entity called “American Baptist Churches in the USA” reportedly received \$1.5 million in COVID-19 relief bailout money – **in the form of two forgivable “loans”** that spanned 2020 and 2021...



...[At] a May 2021 national summit for faith leaders, **NIH Director Francis Collins** – referred to as **“Reverend-Doctor”** – would address hundreds of faith leaders across the nation, **claiming that the COVID-19 vaccines were God’s literal “answer to prayer”** and urging faith leaders to believe that **pushing the shots was a “love your neighbor moment.”**

In what was a sermon-like address tailored to appeal to these faith leaders, **Collins admonished them not to believe “conspiracy theories”** about **“possible side effects”** – which Collins falsely said were untrue.

In the spring of 2021, when COVID-19 vaccine uptake had leveled off, **faith leaders seemed to be the Biden administration’s answer to getting hesitant Americans vaccinated.** The reason? Faith leaders had vast untapped potential to convince vaccine-hesitant Americans to take the shots – particularly **if they could be persuaded that COVID-19 vaccination was a moral obligation owed to others.**

Like healthcare providers ([which we recently wrote about](#)), faith leaders were **“trusted”** – but arguably much more so than one’s doctor. Faith leaders were **associated with the divine.** They were often connected to deeply personal, intimate, and even sacred moments in Americans’ lives – spiritual moments that involved life and death, great joy, and deep sorrow – such as baptisms, christenings, bar and bat mitzvahs, weddings, and funerals.

As noted in one peer-reviewed article about the role faith leaders played in creating vaccine confidence, [faith organizations were able to penetrate people’s vaccine hesitation in “hyperlocal” ways](#)...

...Meet [Faiths4Vaccines](#) – a founding member of the **HHS COVID-19 Community Corps.** On its website, Faiths4Vaccines describes itself as a **“multi-faith group of local and national religious leaders”** seeking **“to increase opportunities for faith-based institutions, particularly houses of worship, to engage and support the United States government in its efforts to increase vaccination rates”** and combat **“vaccine hesitancy.”** Faiths4Vaccines’ top shared goal is shocking – it strives to **“Demonstrate religious communities’ trust in the vaccine.”**

According to a peer-reviewed study that assessed the impact of faith organizations on COVID-19 vaccination uptake, **Faiths4Vaccines includes over 1000 faith leaders across the U.S.** This study found that Faiths4Vaccines held 13 **“bi-weekly roundtables”** led by faith leaders who used their houses of worship as vaccination sites and had regular engagement with the White House, including the White House COVID-19 Task Force, as well as the CDC and HHS, as part of these bi-weekly calls. A spin-off initiative of Faiths4Vaccines – called **Youth4Vaccines** – pushed the COVID-19 vaccine among America’s youth and also held a roundtable **“showcasing how youths of faith are leading in their communities within the COVID-19 vaccination efforts.”**

...At the Faiths4Vaccines National Summit, NIH Director [Francis Collins](#), Surgeon General [Vivek Murthy](#), and ((([Jeffrey Zients](#)))) (then White House COVID-19 Response Coordinator, who is now Biden's Chief of Staff) – made virtual appearances, addressing the faith leaders directly. **Under the auspices of their official government positions, Collins, Murthy, and Zients relied on religion to persuade faith leaders to push the COVID-19 vaccines. Shockingly, Collins even claimed that the vaccines were provided by God.**

...However, **when religious doctrine and the sacredness of one's faith tradition are wielded with misleading information to push a risky, experimental biomedical government agenda** – this shocks the conscience. When available, cheap and potentially life-saving medications with an excellent safety profile are withheld in order to further this experimental biomedical agenda – **this defies ethical bounds.**

...In our opinion, this is precisely what happened. As demonstrated at the Faiths4Vaccines National Summit, **powerful government officials resorted to the use of religious doctrine to coerce faith leaders** across the country to use their own **spiritual influence, positions of trust, and sacred spaces to push the vaccines on their congregants.**

**Government officials claimed to know God's position on the issue of the COVID-19 vaccines**, failing to consider other perspectives or engage in open debate. In claiming that **their vaccine "theology" was the correct interpretation**, our government leaders implied that [any faith leaders with a different view opposed God or had an incorrect understanding of God.](#)

For those who dared question the government's vaccine "theology," Collins and Murthy use words that echoed pejorative tones – implying that **faith leaders who had hesitancy about recommending the vaccine were inferior and/or uneducated** – thus susceptible to believing in **"conspiracy theories"** (Collins) or **"misinformation and myths"** (Murthy).

...It is now incontrovertible that **mRNA injections have been associated with serious injuries and even deaths** of many in the U.S. and around the world. As just one example, a scientific database created by React1928 – an organization that assists COVID-19 vaccine-injured individuals who have been abandoned by the very government that assured them the shots were safe – documents 3,580 peer-reviewed case reports of serious adverse events following COVID-19 vaccination, as of the date of this writing.

Another website called [OpenVAERS](#), which tracks global data about COVID-19 vaccine adverse event reports, shows there have been 1,615,020 reports of adverse events and 36,726 deaths following COVID-19 vaccination through November 3, 2023. VAERS, the U.S. system for reporting vaccine adverse events, **is widely acknowledged to be vastly underreported.**

A researcher affiliated with Ottawa research group Correlation, Denis Rancourt, PhD, estimates that **17 million global citizens have been killed worldwide from the COVID-19 vaccines** as of September 2, 2023.

...Collins also told faith leaders that the vaccines were a literal answer to prayer – peppering his shameless appeal to push the vaccines with religious language that was sure to resonate with faith leaders:

...*“Yeah, I was praying about this. Back in August or September as the trials were getting underway. Oh, if I just pray, well, we’ll be end up with something that’s at least 60% or maybe 70% effective, and then it turns out to be 95%. So this does seem like, OK, I’ve been praying for rescue from COVID. Here’s the answer. It’s coming through science. But it still feels to me like it’s God’s answer too, because God works through people and God works through scientists, even some of them who don’t know it.”*

...The Faiths4Vaccines “Toolkit” suggests the use of theological interpretations and sacred Scriptures to push the COVID-19 vaccines and offers specific examples. Does this border on spiritual abuse? Consider that one of the hallmarks of spiritual abuse is taking Scriptures out of context in order to interpret passages to suit one’s own ends.

Another is using biblical-sounding words to give the appearance of virtuousness or righteousness – a tactic that we saw both Zients and Collins use.

Consider the propriety of this scriptural example, quoted from a “Trusted Source” in the Jewish community, according to the Faiths4Vaccines “Toolkit”:

*“The Lord took us out of the narrow place (Mitzrayim) with a strong hand and an outstretched arm.”* (Deuteronomy 26:8)

[Their interpretation]:

“‘The narrow place’ refers to Covid.

‘A strong hand’ refers to the hand holding the syringe.

‘An outstretched arm’ is the arm receiving the vaccine.

The Bible’s message is clear: **“Go forth and be vaccinated, that ye may live!”**

...The Faiths4Vaccines “Toolkit” also provides the following Scriptures to push COVID-19 vaccination, described as **“Scriptures on the Value of All Lives”**:

**“So whatever you wish that others would do to you, do also to them, for this is the Law and the Prophets.”** (Matthew 7:12)

**“You shall love your neighbor as yourself. There is no other commandment greater than these.”** (Mark 12:31)



***“For I know the plans I have for you, declares the Lord, plans for welfare and not for evil, to give you a future and a hope.”*** (Jeremiah 29:11)

***“Behold, I will bring to it health and healing, and I will heal them and reveal to them abundance of prosperity and security.”*** (Jeremiah 33:6)

***“And we know that for those who love God, all things work together for good, for those who are called according to his purpose.”*** (Romans 8:28)

In 2020, we reported in the very early stages of the fake pandemic how specifically the Catholic Church was pushing the COVID bio-weapon “vaccines” on their congregations as their “Christian responsibility” — and we reported on the first death of a priest who was killed by that “vaccine”.

We take no satisfaction in having exposed the satanic agenda of the COVID “pandemic” from its beginnings — nor do we feel righteous by thinking “*We told you so!*”

However, we were heartened to see that our numerous articles exposing the “pandemic” brought many new readers to our site — some of whom had the scales removed from their eyes and heard about the truth of the Christian-Israel message for the first time.

In reality, the purpose of the [“pandemic” Purim](#) was to largely target White Christian nations — which had the highest vaccination compliance rates — and the highest death rates due to the “vaccines” — upwards of at least 20 million deaths and counting.

We wrote how Jews — in [government and the pharmaceutical companies](#) — who “just so happened to be” [the inventors and purveyors of the “vaccine”](#) — likened the spread of “COVID” [to the spread of “antisemitism”](#) — by killing off White Christians, they eliminate their greatest “existential” [threat to world domination](#).

[They bragged that they were behind the “life saving” vaccines](#). Period.

But as this report points out, most [Jewish-worshipping Christians](#) trust their [Judaized pastors](#) more than they trust their doctors — but ironically, during this “pandemic” there was no difference between the two, as both pushed these agents of death with equal zeal and authority.

When [“judo-Christians”](#) go to church on Sunday, the vast majority of them turn off their critical thinking skills and sit passively in the pews — as if they are watching television — absorbing what comes out of the mouths of their pastors as if it is the unvarnished “truth”.

Even though the Gospels repeatedly warn Christians of false teachers:

***“Beware of the false prophets, who come to you in sheep’s clothing, but inwardly are ravenous wolves. You will know them by their fruits. Grapes are not gathered from thorn bushes nor figs from thistles, are they?”***

*—Matthew 7:15-16*

We have written about the treachery of these [anti-Christ so-called “Judeo-Christian” ministers](#) — who are most concerned about pleasing this world than pleasing God.

But this should not surprise us, considering Revelation warns us that in the End Times deception will be the rule, not the exception:

***“And the great dragon was thrown down, the serpent of old who is called the devil and Satan, who deceives the whole world; he was thrown down to the earth, and his angels were thrown down with him.”***

*—Revelation 12:9*

This verse doesn’t say that the whole world will be deceived *except for* Christians — and yet if you were to ask any [“Judeo-Christian”](#) if they count themselves [among the prophesized “deceived”](#), they will scoff at the notion — as if only “unbelievers” can be deceived.

And if these mainstream Christians wake up to the deception of the “*pandemic*” — and their own churches’ roles in promoting it — why aren’t they also questioning their pastors’ interpretation of the Scriptures — which they twisted to deceive them?

If Christians would only wake up and stop worshiping the anti-Christ Jews who plot their destruction — and put on the full armor of God — which is the Christian-Israel message — then and only then — can they hope to immunize themselves against Satan’s desire for their body and eternal soul.

[During June of 2021 the Vatican used its global megaphone to remind Catholics that the COVID-19 vaccines are morally acceptable, call on wealthy countries to equitably distribute the vaccine and has even turned a papal audience hall into a vaccination clinic for the poor of Rome.

For these efforts, the head of the U.S. National Institutes of Health, Dr. Francis Collins, was praising the Vatican’s leadership in the push for vaccine acceptance as “*extremely helpful*.” Former NIH Director Francis Collins was a “*cheerleader*” for the Vatican Jesuit Pope Francis. Dr. Francis Collins was a false teacher exploiting his directorship role as an ecumenical voice of Christianity.

***“Having a leader in the Catholic Church who has been so outspoken and so willing to lay out the facts and not be dissuaded by a lot of the myths and even conspiracies has been really helpful,” Collins told NCR in an interview. “I’m really delighted the Vatican has taken on this role.”***

Pope Francis has not minced words on the topic, suggesting that a refusal to take the vaccine is *"suicidal."*

Collins, who is a practicing Christian and was appointed by Pope Benedict XVI to the Vatican's Pontifical Academy of Sciences in 2009, says he agrees with Francis' assessment and *"not just because he and I have the same name."*

*"He is making a very good point. We have something here that is safe and effective. In the United States alone, almost 600,000 people have lost their lives and we're not done with this yet,"* Collins said.

In the U.S., some of those fueling the false rhetoric about vaccines have come from the pope's own house: Bishop Joseph Strickland of Tyler, Texas has openly defied the Vatican alleging that the vaccines are morally illicit, professors at the Catholic University of America have signed on to an open document alleging that the vaccine makes one complicit with abortion, and the U.S. bishops' conference's early messaging on the Johnson & Johnson vaccine fostered confusion among many Catholics.

*"Why would you not want to protect yourself from what could be a fatal disease?"* Collins asked. *"If you say 'no,' well, yeah maybe you are kind of making a suicidal decision, whether you think about it that way or not."*

June has been designated by President Joe Biden as a National Month of Action in an effort to mobilize 70% of U.S. adults to get at least one shot by July 4. The public health push also comes at a time when many religious leaders are making a concerted effort to get folks to return to in-person services.

As such, Collins said he believes religious leaders have a special obligation to encourage their congregants to get vaccinated.

*"As a person of faith myself, as well as a scientist, I've been spending a fair amount of my time talking with faith leaders, encouraging them to see themselves as really important voices,"* he said. *"People are looking for credible spokespeople who they think have their best interest at heart to give them some guidance about this."*

Collins said that he believes it is important and powerful *"to have your pastor or your priest basically say, 'You know, I've looked into this and for my flock, I do think this is something that is going to help you and it will help all of us, because we will be able to get back together again safely.'"*

After all, he believes people of faith should be in the "love your neighbor" space."

*"There are probably 5% of Americans, adults, for whom the vaccine will not give them immunity because their immune systems don't work," such as transplant or cancer patients who are on medicines that suppress the immune system, said Collins. "Those people's best hope to avoid COVID-19 is for this virus to be driven away from our communities by the rest of us getting immunized."*

*"If you say 'no' to the vaccine, in a certain way, you're putting those people at risk, and, generally, Christians are pretty good about thinking about others and particularly those most vulnerable," he added. "It's one more reason that the decision to roll up your sleeve is the best decision for somebody who really does love their neighbors."*

As one academic year comes to a close and colleges and universities are looking towards the start of the fall semester, there is an ongoing debate among many Catholic institutions as to whether students, faculty and staff should be required to get vaccinated.

Collins said he understood the tensions and labeled it a *"very challenging decision."*

*"Certainly though, if you really want to have an opportunity for students to be free to interact with one another without masks and without having to be very distantly apart, the only way to be really sure that's safe is to require that everyone be immunized," he said.*

Given the efficacy and the safety of the vaccines, he added, *"the opportunity to give that gift to everybody, and have them unwrap the gift and roll up their sleeve just makes so much sense, so I would hope schools wouldn't really have to impose that requirement and people would basically say, 'Well, of course I want that for my kids.' "*

During this National Month of Action, the White House has organized easy access to vaccines at some unexpected locations, including barbershops, beauty salons and church fellowship halls on Sunday afternoons, along with free child care to make the process as seamless as possible.

Collins says he hopes those who remain on the fence about getting vaccinated will realize how much more freedom they will experience by not having the fear of catching or spreading the virus.

And, for him, that includes being able to *"pray together, and plan together and just have the experience of being a Christian community again."*

Shortly after Dr. Collins "cheerleading" rants I wrote a couple articles on the 'Judas Goats' leading the faithful to slaughter, and named Pope Francis, Franklin Graham, Robert Jeffress, and the Southern Baptist Seminary president Albert Mohler as 'Judas Goats' coercing their faithful to take the Covid shots. As a lifelong student of Bible prophecy and a close observer of current events, I’m surprised that the Rapture has not yet happened. So many signs point to the nearness of the Tribulation and conditions described in Revelation 6:1-8 with the release of the riders of the apocalypse. However, we still wait for the time when we will meet Jesus in the air.

Even a secular organization, which goes by the name of the Bulletin of the Atomic Scientists, recognizes the nearness of the catastrophic events of the Day of the Lord. On January 23, 2024, they reset their “Doomsday Clock” at ninety seconds to midnight.

As a young child, I loved watching rockets take off, carrying their occupants to outer space. I remember the disappointment I felt when the countdown paused or even stopped to another day.

I believe that from our limited perspective, the countdown to the Day of the Lord has paused. In spite of the myriad of signs pointing to the start of the seven-year Tribulation, it seems as though time stands still for those of us excitedly awaiting Jesus’ appearing.

For the world, the seconds on the “Doomsday Clock” remain fixed at ninety seconds.

**As we wait, it’s important to keep in mind at least a couple of things:**

### **1 — The Restrainer**

With each passing month, the words of 2 Thessalonians 2:7-8 become increasingly relevant to our day: “For the mystery of lawlessness is already at work. Only he who now restrains it will do so until he is out of the way. And then the lawless one will be revealed, whom the Lord Jesus will kill with the breath of his mouth and bring to nothing by the appearance of his coming.”

The Restrainer is the Holy Spirit, and His presence within true believers is currently holding back the full expression of evil and lawlessness, which will happen when the antichrist appears on the world scene. This doesn’t mean that the Holy Spirit will cease to be active on the earth after the Rapture, only that His current work of restraining the “man of lawlessness” will end.

For the past several decades, world leaders have expressed their earnest desire to establish a two-state solution to the turmoil in the Middle East. Past U.S. presidents have promoted the faulty notion that giving the Palestinians a nation of their own will establish peace. Currently, rumors abound that the Biden administration might seek a UN resolution to force such a solution upon Israel.

Other world leaders have also offered similar proposals, but there's never been a time when both sides have agreed to any resolution, and does it seem likely to happen any time soon?

Why have all these attempts failed? 2 Thessalonians 2:1-12 gives us the answer. The ultimate peace accord cannot happen until after the Rapture and the antichrist brokers the deal. Daniel 9:27 tells us that he will succeed in establishing peace for Israel, albeit for a brief time.

I suspect that Israel's current war, which shows no sign of ending, may later play a role in Israel's willingness to accept the covenant offered by the man of lawlessness. Perhaps he will allow the rebuilding of the third temple to make his offer all the more alluring. The Bible tells us that Israel will have this temple by the midpoint of the Tribulation period.

Although at times I am tempted to think that things cannot get any worse, the Bible reveals that conditions on the earth will rapidly deteriorate after the Rapture.

## **2 — The Lord's Patient Warnings Regarding the Future**

A realistic examination of how the Old Testament prophets described the Day of the Lord, along with the judgments described by the Apostle John in the book of Revelation, tells us that the Tribulation period will be far more horrifying than anything the world has ever seen.

Because of the many terrors that lie ahead for planet Earth, God is giving people more time to heed the warnings of what's coming (see 2 Peter 3:8-10). Despite the tragic silence in most pulpits, the Lord is not silent today regarding the terrors that lie on the horizon for those who don't know Him as their Savior.

I believe God intends for the symbolism behind the April 8, 2024, solar eclipse completing an X upon the U.S. to alert America to the nearness of His judgment not only upon America but the entire world. The fact that it will pass over seven U.S. cities named Nineveh only adds to the drama unfolding this Spring.

The coming solar eclipse does not tell us when God's wrath will arrive, but it points to the dire consequences that surely lie ahead if America continues on its current path.



From the Father's perspective, the clock is still ticking toward the time when He sends Jesus to take His children out of the world. He knows the very moment when He will send His Son to bring us up to glory.

Tyson has contracted with Protix to build plants here but notably has also made a “*direct equity investment*” and “*minority stake*” in Protix to help the company grow.

Protix founder Kees Aarts [says](#) that they plan insect-based food for humans: “*They recently launched ENOUGH, a range of insect-based snacks and culinary ingredients. There is a wealth of flavors to be discovered, he says.*”

So is Tyson getting into growing bugs for human consumption or not?

Moreover, we can immediately use their existing byproducts as feedstock for our insects. This agreement is a major milestone for Protix and significantly accelerates our ambition to grow through international partnerships.”*



The to-be-built facility in the U.S. will house an enclosed system to support all aspects of insect protein production including the breeding, incubating, and hatching of insect larvae. In addition to ingredients for the aquaculture and pet food industries, processed larvae may also be used as ingredients within livestock and plant feed.

Protix is a fully integrated insect ingredients company, producing and processing 14,000 metric tons LLE annually in its Netherlands facility which has been in operation since 2019. It serves major global companies in the pet food, aquaculture feed, livestock feed and organic fertilizer industries as the demand for insect ingredients continues to grow.
