# Bill Gates Praises India's Sweeping Digital ID System as a Model for Other Nations

India's digital ID system may have its critics among those opposed to digitization of people's identities, but it has received praise from Bill Gates as one of the country's innovations that are "changing the world."

Gates, as well as EU and UN officials, refers to such systems as digital public infrastructure (DPI) - a buzzword for introduction of digital ID and payments by 2030.

Gates announced on his blog that he is visiting India, and made sure to note that the Gates Foundation is involved in what he calls "efforts that are saving millions of lives."

This is a reference to India's production of another of Gates' "passions" - vaccines. As for DPI, Gates expressed his "admiration" for the country's massive biometric identity DPI component, Aadhaar, and the fact that over 12 billion transactions are processed by it.

And, the Microsoft founder has another "passion" - agriculture. He made sure to note that he would be visiting a monitoring center where agriculture meets Aadhaar. More whopping numbers: the government uses the center in Odisha that has a registry of 7.5 million farmers to give them "real-time guidance," Gates said.

It sounds like a surveillance state dream, at least as far as the "right" infrastructure is concerned: "Officials can keep track of who is growing what," Gates continued, but he says this is done for the sake of providing those farmers with "advice."

It has almost become a rule that projects like DPI effectively get tested in developing countries, orchestrated by globalist financial institutions like the World Bank.

Gates mentions that the developments around the implementation of DPI in Odisha are monitored by the World Bank, as well as Ethiopia and Sri Lanka, ostensibly in order for the example to be replicated there.

Last fall, the United National Development Program (UNDP) unveiled a campaign called "50-in-5" that aims to "help" 50 countries "design, launch, and scale components of their digital public infrastructure."

This effort is one of those where the Gates Foundation shows up as a partner, while the program is supposed to promote "safe, inclusive and interoperable DPI" introduction in those countries.

When the campaign was announced, India was mentioned as a "success story" in the world of DPIs, while Africa was singled out as a particular target for "greater development of DPI." Bill Gates has since called for all nations to adopt the Indian digital ID system, no surprise there! I would expect nothing less from this demonic creep who has such a checkered past other than to be one of the world's richest individuals.

### Bill Gates' 'Self-Spreading mRNA Vaccines' Are 'Ready to Deploy'

A new form of "self-spreading mRNA vaccines" has been developed that will allow governments to vaccinate entire populations without the need for injections or individuals' consent.

The new technology, which was developed by Microsoft co-founder Bill Gates and his various organizations, is now reportedly "ready to deploy" to the public. Investigative reporter Jefferey Jaxen brought the alarming reality to light on <u>The Highwire</u>.

Jaxen explains that Gates's new technology means the ability to "vaccinate" the entire world without injecting large amounts of the population is upon us. What we're referring to is self-spreading vaccines, a technology that was **almost** ready to be deployed for the coronavirus pandemic.

However, it was ultimately passed at the time for mRNA injections instead. So, it would be naive to think, four years later, that global health authorities wouldn't push for its use in the event of another "global health crisis."

The only thing stopping the mass use of this technology is this pesky thing known as informed consent. But the reality is, as evidenced by the COVID era, informed consent is not what it used to be.

The whole idea behind self-spreading vaccines is largely grounded in circumventing informed consent. Scientists like to refer to members of the general public consenting to vaccines as "behavioral barriers."

A scientific paper from Timothy Notton et al. notes:

"Infectious disease control faces significant challenges including: how to therapeutically target the highest-risk populations, **circumvent behavioral barriers**, and overcome pathogen persistence and resistance mechanisms."

"In a study from November, the Department of Health stated that self-spreading techniques could eliminate 'vaccine delay."

The U.S. military and DARPA have also been researching self-spreading vaccines before Gates finally brought the technology to the market. DARPA, in particular, has been exploring antivirals to "evolve" in real-time against new viral strains.

However, if a self-spreading vaccine mutates in an unforeseen way, it could potentially pose grave risks for the entire population.

Attorney Aaron Siri issued a warning about self-spreading vaccines soon being deployed to the public.

"With this product, the whole idea is they release it to basically one person, and it spreads to every single person on the globe.

"So if they mess it up one time, just once, just once, they can mess up the entire world," he emphasized.

"What might even be the biggest victim ... if they ever release this thing, it's going to be civil, individual rights... "Here, they're going to release a product where you're going to have **no choice** effectively but to take it.

"That is the **ultimate crushing** of individual and civil rights."

#### Here's How Russia Could Hit Back If West Seizes Assets

Some \$300 billion in Russian assets were trapped abroad in 2022 after the escalation of the Ukrainian crisis into a full-on NATO-Russia proxy war. Western officials have threatened to seize these funds and transfer them to Ukraine for "reconstruction." A pair of leading Russian economists tell Sputnik why that's a very bad idea.

Treasury Secretary Janet Yellen has called on nations of the Western "coalition" against Moscow to "find a way to unlock the value of [Russia's] immobilized assets to support Ukraine's continued resistance and long-term reconstruction."

"I believe there is a strong international law, economic and moral case for moving forward. This would be a decisive response to Russia's unprecedented threat to global stability," Yellen said at a meeting of G20 finance ministers and central bank governors in Sao Paulo, Brazil on Tuesday.

Tackling the question of the potential threats to the dollar's status as the de facto world reserve currency that such an unprecedented move would entail, Yellen said that it it's "extremely unlikely" that the greenback would be negatively affected. "Realistically there are not alternatives to the dollar, euro and yen," she assured.

Yellen is the latest senior Western official to propose moving forward with the seizure of Russian assets as Western countries' own desire to continue fueling the Ukrainian proxy war against Russia falters. Earlier this month, the European Union adopted a law allowing Brussels to bank windfall profits from Russian assets trapped in European banks and use them in Ukraine, a move characterized by Moscow as blatant "theft" which will be met with legal action.

Russian officials and independent economic observers alike have warned of the possible consequences stemming from what Yellen is proposing, with Russian finance minister Anton Siluanov saying Moscow has the means to issue a "symmetrical" response to this form of Western financial aggression.

"We have no fewer frozen [assets than Western countries]," Siluanov said in an interview with Sputnik on Monday. "Any actions taken against our assets would receive a symmetrical response."

Mechanism for Tit-For-Tat Response Already Exists

"Russia has already taken conservatorship of assets of a number of foreign companies which refused to operate in Russia," Dr. Andrei Kolganov, a professor of economics at Moscow State University and chief researcher at the Russian Academy of Sciences' Institute of Economics, told Sputnik, commenting on the folly of the West's asset seizure plans.

This instrument was already used against foreign investors with an ownership stake in the Baltika Beer Company, as well as the assets of Finnish energy concern Fortum, the professor noted.

"So in principle, the mechanism for the confiscation of foreign assets has already been worked out. Moving from conservatorship to confiscation is, in principle, a fairly simple technical procedure. The amount of assets that are 'frozen' on the territory of the Russian Federation, or which may be frozen, is now estimated at approximately \$288 billion," Kolganov explained.

In other words, the professor said, Russia has control over a big chunk of Western assets which, if the U.S. and its allies proceed with confiscation, "will not escape to the West, but will work here in Russia, because we are talking about investment, first and foremost, in the manufacturing sector."

From there, these assets could become the property of the Russian state, or be transferred to Russian private owners and continue to work as before.

Confiscation of assets of Western companies in Russia would seriously impact their respective bottom lines, meaning they could try to put pressure on governments, both in their home countries and in Russia, to try to avoid having their capital seized.

"We have a lot of foreign companies working in Russia, including those from so-called unfriendly countries. We have more than 50 decently-sized American firms alone working here, and plenty of European companies," Dr. Georgy Ostapkovich, director of the Center for Market Research at the Institute of Statistical Research and Economics of Knowledge at Russia's Higher School of Economics, told Sputnik.

#### Sorry Yellen, Seizing Assets Won't Crash Russian Economy

Kolganov says that as unpleasant as a seizure of Russia's assets abroad might be it would not serve to tank the country's economy, with Moscow able to continue its international payments using its sizable and healthy foreign exchange earnings after reorienting its trade toward developing countries. The money frozen in Western banks

constitutes reserves, which "were not actively used for international trade and international payments" anyway, the professor explained.

"For private businesses, the confiscation of assets would create a pretty big hole in their earnings and budgets. Therefore, it would be a rather sensitive measure if Russia had to resort to it in response to the confiscation of its assets," the economist added.

Dr. Ostapkovich emphasizes that Moscow will have to be strategic and precise in the foreign assets it may choose to seize, to avoid the risk of friendly countries and companies doing business in Russia feeling threatened.

"Every operation" on Russia's part "must take place with the help of legal services, that is, through the courts," the veteran economist said. "We are a state based on the rule of law, and cannot just go ahead and close them, because they will naturally go to court. Moreover, they will file in the London court, which judges according to Anglo-Saxon law. This is case law. They will look for a precedent."

In other words, Ostapkovich stressed, Moscow should expect a tug of war on the international stage regarding the seizure of assets by the West and Russia's tit-for-tat response.

#### Pandora's Box of Damage to the Dollar

In his interview with Sputnik, Russia's finance minister mentioned the promising transition away from Western currencies in favor of new currencies among the world's rising economies, especially China.

"The Chinese are reducing their holdings of American securities. This is a consequence of what's happening [to Russia, ed.] The reliability of the dollar and the euro has been undermined," Siluanov said.

And while it may be too early to speak about the collapse of the dollar or euro as a result of a decision to seize the assets of a sizable economy like Russia, Kolganov confirmed that it has the potential to seriously undermine Western reserve currencies' reputation in a big way.

"The yuan's share in international transactions has doubled over the past two years, but doubled to only about 4.6 percent of the total. This is not a huge amount, but still, an upward trend exists. The share of rubles in international payments has also increased, mainly in the form of payments with our country... Nevertheless, a gradual move away from the dollar will of course take place. Because here we're talking not only about the confiscation of assets, which will undermine confidence in payments made in reserve currencies. Because any country and any central bank may feel threatened that if the geopolitical situation changes, they could be treated in a similar way."

The problem is exacerbated by the fact that the United States and Europe are facing a loss of economic confidence at home, with the former facing debt levels that are off the

charts, which in the future could cause serious shocks to the entire global dollar system, Kolganov noted.

#### **Recipe for Action**

Russia can already move forward with tit-for-tat measures against the Europeans over Brussels' law allowing the seizure and use of the interest earned on Russian assets frozen in Western banks, Ostapkovich says, noting if the EU moves forward with the seizures, Moscow could similarly start shaving dividends and interest on European companies operating in Russia.

## Government Ordered Doctors to Kill Patients to Boost Covid Fears Hunter Fielding February 27, 2024

Several doctors have come forward to blow the whistle with bombshell statements alleging they were ordered by the government to kill patients and list the cause of their deaths as "Covid" in order to boost fears about the virus among the general public.

The effort sought to create panic among populations in order to force compliance with lockdowns, vaccine mandates, and other tyrannical restrictions on public freedoms.

Graham Atkinson, also a pharmaceutical industry consultant, decided to quit the profession in October 2021 after witnessing what his country's government was doing by ordering doctors to basically kill patients with drugs like midazolam.

"I watched while this happened," Atkinson recalls about the horrors he saw with his own eyes during that time.

Based on the presumption that there would be outbreaks of the then-novel disease in care homes just prior to the first lockdown in early March 2020, midazolam and other "just-in-case" drugs were being administered to end the lives of possibly infected patients on purpose.

"Lots of things changed nationally in early March," Atkinson added.

"The death certification rules were changed.

"The cremation rules were changed, and the NICE guidelines."

#### Kill Every Patient Who Tests Positive for Covid

One of the key changes that Atkinson observed was the NICE NG163 guideline, which was changed to allow for those who tested "positive" for COVID to "die more comfortably" with "a good death."

"The National Institute for Clinical Excellence ('NICE') is an executive non-departmental public body, sponsored by the UK Department of Health and Social Care ('DHSC')," explains The Exposé about the group behind the changes.

It is an agency of the National Health Service ('NHS') and develops guidance and recommendations on the effectiveness of treatments and medical procedures.

On Oct. 13, 2020, later in the year, NG163 was replaced with NG161, though an archived copy of the former is available on the Wayback Machine.

The "just-in-case" drugs that UK doctors were told to administer to their "COVID-infected" patients are designed to reduce breathing and render the patient unconscious — "and then there are drugs to reduce your anxiety before that," Atkinson explained.

"There are five drugs that are used that are commonly called the 'just-in-case' drugs," Atkinson further said.

"For years, these have been used for cancer patients or maybe somebody with COPD, a respiratory disease that are ... struggling to breathe, so they get very distressed just before they die.

"So, there are drugs to help them feel less anxious about not being able to breathe, drugs to reduce their pain, drugs to relax them, and midazolam, as we know, takes away your consciousness."

When used in tandem, in other words, these five drugs basically euthanize the patient, killing them in a more peaceful way.

"It's going to progress you rapidly towards your final days because [your final days are] expected," Atkinson continued. All of this, mind you, was based on the lie that there were no viable treatments for the novel disease, which the world would later learn is not the case.

Ivermectin, hydroxychloroquine, and other remedies did, in fact, help many patients who thought they had COVID recovered without issue.

"We now know all this is false, but what was being told to clinicians at the time was this is a new novel disease," Atkinson said.

"Because this was the time when people were being put on ventilators and were expiring rapidly around the world." "You know we were all seeing it on our TV."

#### 24,000 US Army positions cut amid recruitment woes

The United States Army is reducing the size of its force by roughly 24,000 troops as the military service continues to struggle to meet recruitment goals.

According to a new document on the structural transformation of the U.S. Army, the decrease in the size of military service is intended to position the Army to be better equipped to fight future wars. While the document outlined multiple ways the Army is planning to invest in a restructuring of the force, it claimed that force reductions were necessary.

"While making these investments and adding formations, the Army must also reduce force structure to protect readiness in light of decreased end strength," the Army stated.

"The Army is currently significantly over-structured, meaning there are not enough soldiers to fill out existing units and organizations."

Fox News reported that a considerable portion of the jobs that will be eliminated by the Army were counter-insurgency positions that increased during the Iraq War and Afghanistan War. The Army noted that most of the positions are already empty and that the Army "is not asking current soldiers to leave."

The Army added, "As the Army builds back end strength over the next few years, most installations will likely see an increase in the number of soldiers actually stationed there."

The Army's plan includes the reduction of approximately 10,000 positions connected with counter-insurgency operations, 2,700 positions from units that are not regularly deployed, and 6,500 additional posts and training positions. Additionally, roughly 10,000 positions from cavalry squadrons, security force assistance brigades, and infantry brigade combat teams, and Stryker brigade combat teams will be cut.

On the other hand, the Army's plan also announced the addition of 7,500 troops for critical operations, such as counter-drone units, air-defense units, and five new task forces.

The Army's plan to reduce the size of its military force comes amid persistent recruitment challenges that have resulted in the Army missing its recruitment goals over the past two years.

The Department of Defense previously reported that the Army, Navy, and Air Force fell short of their recruitment goals for Fiscal Year 2023, which ended in September. While the Army gained over 50,000 recruits, it was well short of its goal of 65,000 new recruits. According to The Associated Press, the Army also missed its Fiscal Year 2022 recruitment goal by roughly 15,000 troops.

The Army announced that while the current structure of the military service is designed to have 494,000 soldiers, the total number of active-duty soldiers is currently 445,000. Based on the restructuring plan, the Army is striving to achieve a goal of 470,000 active-duty troops by Fiscal Year 2029.

The real reason for the cuts in Regular Army forces is really all about money and the absence of it. This is a story where the pig gets the lipstick. The current military budget is the largest in history at \$842 billion dollars. Recruiting is and has been a major problem since O'Biden stole the election in 2020. Fewer young people see the military as the avenue for serving their country because of the senile CEO at 1600 Pennsylvania Ave., where the military is the laughing stock of the world. Between CRT and gender equality issues the leaders of the politicized military has turned priorities upside down!

A number of U.S. military branches have struggled to entice new enlistees, the Army facing the worst of it. The Army has continuously lowered its standards to increase their ranks, such as no longer screaming at the recruits, and allowing greater flexibility on weight limits and tattoos. The Army has been so desperate to shovel in fresh soldiers they have resorted to using E-girls to entice young men to enlist.

Meanwhile, the Army is having trouble keeping itself funded. As noted in an exclusive report by CNN last week, the Army has been left to flip the bill in order to support Ukraine's defense against Russia, leaving officials concerned that they will be forced divert funds from other areas to continue to support Ukraine.

CNN wrote: 'Without a 2024 budget approved by Congress, and without additional funding specifically for Ukraine, the command has roughly \$3 billion to pay for \$5 billion of operations costs, a second senior Army official explained. That includes not only the operations related to Ukraine support — training and ferrying weapons and equipment to Poland and Ukraine — but other operations for the U.S. command throughout Europe and Africa.'

A senior Army official explained the veracity of the situation to CNN:

"If we don't get a base budget, if we don't get Ukraine supplemental [funding package], if the government shuts down, if we get nothing else and nothing changes from today ... we will run out of (operations and maintenance) funding in May.

We would cease to exist, (if these funds were not allocated from elsewhere within the Army's budget)."

The Army official said. Those operations include training exercises for Army forces in Europe and Africa and equipment moving into the theater. Contracts also wouldn't be paid on time and would garner penalty fees, he added.

Army Secretary Christine Wormuth told CNN she expects the Army would "have to sort of rob Peter to pay Paul."

Every incremental dollar I have, it's very important where I put that dollar. And I'm constantly choosing between, do we put it on barracks? Do I put it on enlistment incentives? Do I put it on exercises? Do I put it on modernization? I don't have spare cash to be just sort of donating some of that.

This was money that we anticipated to be replenished, obviously, by the supplemental. This is just embarrassing. We've examined a number of instances of how the U.S. military is deliberately being weakened, and this is another example. To think that the Army is running out of money and needs more of it, just so we can go fund a Neo-Nazi country run by a literal actor playing President, that's getting smoked right now, and have a lot of this money fall into corrupt official's hands, is just astounding.

#### Fluoride Action Network SUING to stop water fluoridation nationwide By Ethan Huff / Feb 27, 2024

A landmark legal case against artificial water fluoridation in the United States is moving forward with mostly flying colors as the illustrious Michael Connett of Waters Kraus and Paul is asking the court system: Does fluoridation present an unreasonable risk of neurodevelopmental effects?

If successful, the case, said to be airtight and "near impossible to argue against," to quote the advocacy group Fluoride Alert, will force the Environmental Protection Agency (EPA) to take action to address the risk, as required by law. It has the potential to end artificial water fluoridation all across America.

Simply put, fluoridation chemicals are drugs, which means Americans are entitled under the law to informed consent. This means that public water systems would no longer be allowed to automatically fluoridate everyone's water without each household's express permission. Every American household that currently receives fluoridated water would have to be informed of the risks involved with consuming the drug, which has been linked to decreased IQ in children, neurodevelopmental damage and other health problems.

"Fluoridating the water supply is a de facto medication, administered with the alleged goal of promoting dental health," Fluoride Alert says. "The government does not solicit informed consent from the patient (the public) prior to dumping fluoride into the water supply."

"The government is in violation of informed consent."

Fluoride damages the brain! We know from copious scientific research that the chemical fluoride drugs added to public water supplies across the United States accumulate in regions of the brain responsible for memory and learning. This is especially problematic in young, developing children, but is also toxic to adults.

The current maximum contaminant level goal (MCLG) for fluoride is 4 mg/L, a level that is not at all protective against the drug's adverse effects on the brain. Of the 18 published studies that provide water fluoride concentrations, 13 of them found deficits at levels below the MCLG, the average elevated level being just 2.3 mg/L, and the lowest being a mere 0.8 mg/L.

What this means is most Americans who live in fluoridated cities, towns and communities are drinking far more fluoride than what established science says is at the lower end of what causes brain damage in babies, infants, children and adults.

"Exposure to fluoride is associated with reduced intelligence in children," warns The 'Journal of Neurosciences in Rural Practice'. "We have found a significant inverse relationship between intelligence and the water fluoride level, and intelligence and the urinary fluoride level."

If Washington was really in the business of protecting the public interest, it would immediately and voluntarily remove all fluoride drugs from public water supplies. Instead, the establishment is fighting tooth and nail to keep fluoride flowing through people's taps.

"The question must be asked: what interest would the government have in lowering the IQ of the public it oversees?" asks independent journalist Ben Bartee. "How would a lobotomized public serve its interests, in this, Our Sacred Democracy™?"

"Is the benefit merely limited to generating more MSNBC viewers?" Bartee further jokes.

It is important to note further that water fluoridation is not currently supported with a Medical Product's License, despite continued establishment claims that the drug is perfectly safe and effective for Americans to consume from the tap, shower with, water their lawns with and bathe their babies in.

"When derived from air pollution scrubbers, the fluoride is also not purified to pharmaceutical standards," one of Bartee's Substack readers also noted. "So it still contains other neurotoxins as well as heavy metals such as arsenic, beryllium, cadmium, lead and mercury."

#### The Vietnam War

The US Congress adopted the Gulf of Tonkin Resolution, which authorized President Lyndon Johnson to dispatch ground forces to Vietnam on **March 8, 1965.** 

On 8 March 1965, 3,500 U.S. Marines were dispatched to South Vietnam marking the beginning of "America's ground war".

#### NATO's War on Yugoslavia

NATO's war on Yugoslavia was launched on March 24, 1999.

The NATO bombing of Yugoslavia code-named by the US Operation "Noble Anvil". started on March 24, 1999 and lasted until June 10, 1999.

#### The 1991 Gulf War on Iraq

The 1991 Gulf War on Iraq began on 17th January.

However, after the 28th February ceasefire was agreed and signed – following the Basra Road massacre of withdrawing soldiers and fleeing civilians on 26th/27th February –

The US 24th Infantry Division slaughtered thousands on the 2nd March."

#### The 2003 Iraq War

The War on Iraq was launched on **March 20, 2003.** (Baghdad time)

#### **Canada Moves to Criminalize Christianity**

Canada's far-left government is moving to criminalize Christianity, with Bible reading and prayer considered "hate speech" – a "crime" punishable with prison time.

Canadian Prime Minister Justin Trudeau's World Economic Forum-controlled government is planning to outlaw Christianity with the introduction of an amendment to the Criminal Code that could see believers face jail time for expressing historic Christian teachings.

The legislation, Bill C-367, will make it illegal to reiterate certain parts of the Bible, stripping away the "good faith" defense for what is deemed by the state as "hate speech" or "antisemitism."

Traditional Christian practices such as celebrating Christmas or attending church service will be considered crimes that carry severe penalties.

The proposed amendment aims to remove the provision that allows individuals to defend themselves by claiming they genuinely believe in and were merely expressing religious teaching already found in the Scriptures.

This means that citing religious beliefs as justification for words or actions that the state effectively regards as "heresy" will no longer be accepted as a valid defense under the law.

#### The bill states:

"The enactment amends the Criminal Code to eliminate as a defense against willful promotion of hatred or antisemitism the fact that a person, in good faith, expressed or attempted to establish by an argument an opinion or a religious subject or an opinion based on a belief in a religious text."

The bill has prompted outrage online with opponents expressing concerns about freedom of expression and the potential for targeted persecution of Christians in Canada.

Dr. Joseph Boot, President of the *Ezra Institute*, a Canada-based evangelical thinktank, said:

"If ratified, Canada's anti-Christian legal apparatus created over the last decade will overtly persecute Christians with the force of criminal law.

"Everything is already in place," he warned. "Buckle up."

Dr. Boot went on to explain that evangelism, preaching, counseling, statements in the workplace, on social media, and in books that condemn homosexuality or transgenderism on biblical grounds could be "subject to criminal prosecution and with heavy fines or jail time."

The legislation will also include statements deemed "anti-Semitic," which Gab CEO, Andrew Torba warned means:

"Christians who maintain traditional orthodox perspectives about Jews-views that have been part of our faith for 2,000 years, are the primary obstacle to the Ruling Regime." Torba said, "As a result, we are the most targeted and vilified group in the Western world."

This is just more evidence of that. Bill C-367 is still under consideration in Parliament. It has passed the first reading but faces further debate. It is expected to pass, however, and PM Trudeau has expressed his full support for the bill.


The former president 'put \$10 billion into a military program to depopulate Americans'
