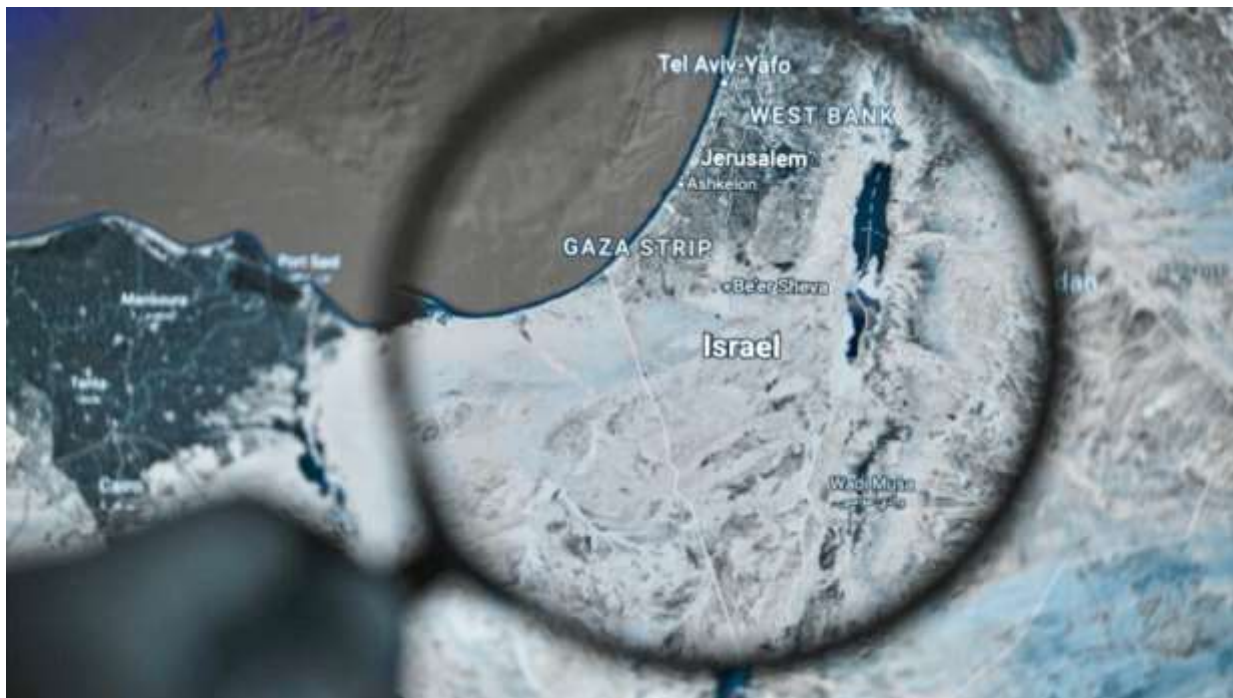

The Best Way to Understand Zionism Is Through A Biblical Lens

There are many different ways to look at Zionism. It can be cultural, political, historical, and even Christian. Yet, the safest way to define Zionism is biblically if, of course, it can be done. If Zionism could be defined biblically, it would supersede all other definitions as long as those looking at that definition would believe that the Bible is the inspired, inerrant word of God. So, can we truly define Zionism in the Tanach?

Let's first look at the words themselves. The terms "Zionism" and "Zionist" were coined in 1890 by Jewish activist Nathan Birnbaum (1864-1937), who also played an important part in the first Zionist Congress held in 1897 (renamed the World Zionist Organization in 1960) alongside its first president, Theodore Herzl. The word *Zion* comes from the Hebrew *tzion*, a reference to Jerusalem and often, by extension, to the Land of Israel itself (first mentioned in [II Samuel 5:7](#).) ***"Nevertheless, David captured the stronghold of Zion, that is the city of David."*** According to scholar Mitchell Bard, ***Zionism is: "The national movement for the return of the Jewish people to their homeland and the resumption of Jewish sovereignty in the Land of Israel."***

Many followers of Yeshua look at the Bible and clearly see that God is NOT done with Israel. They see a glorious future for the people and the Land. They understand that the promises of [Genesis 12:3](#) still stand, and they want to be in the center of God's will by blessing the people that He calls ***"the apple of [His] eye"*** ([Zechariah 2:8](#)). Believers in Yeshua who recognize Israel's biblical and historical right to the Land and the Jewish people's right to return to the Land are often called Christian Zionists. God Himself declared this plan in His Word; thus, Christian Zionism is a noble cause and is part of what every Bible-believing Christian should promote.

Unfortunately for those of us who are Bible-believing, modern-day disciples of Yeshua of Nazareth, the term Christian doesn't help our cause. It has been overused and abused by friends and foes, and its etymology is now quite different from the simple definition it once carried. Not all people called Christians have truly placed their trust in the finished work of Yeshua of Nazareth on their behalf. Additionally, among those who are Christian, not all of them espouse a positive, biblical view of Israel, its land and its people. So, let us forget the term Christian for a moment and move toward a definition of Biblical Zionism.

There is a lot of scriptural evidence validating the claims of Zionism, beginning with the fact that God Himself said that only HE owned the Land in [Leviticus 25:23](#): ***"The land, moreover, shall not be sold permanently, for the land is Mine; for you are but aliens and sojourners with Me."*** So, even though it would appear that God gave the title deed for Eretz Yisrael to the Jewish people, He still is the original owner. The following points are all taken from the Jewish Scriptures and they will help us to define biblical Zionism as we start to understand how God sees the whole thing. Since one of the main themes of God's word is Israel, it sheds some light for us, as we can see first from the Torah:

- The land belongs to God first and foremost: [Leviticus 25:23](#)
- God made a covenant with Abraham promising a land, a seed and a blessing: [Genesis 12:1-3](#)
- The land has specific boundaries yet to be fulfilled: [Genesis 15:18-21](#)

- God's covenant was reconfirmed through Isaac, Jacob and his 12 sons: [Genesis 26:2-4](#), [28:13](#), [50:24](#)
- God cares about the land and will bless/discipline Israel for obedience/disobedience: [Deuteronomy 11:8-17](#)
- The land is promised based on God's character and not Israel's performance: [Deuteronomy 7:7-9](#)
- God told Israel to conquer the land: [Deuteronomy 9:3](#)
- Israel's exact boundaries are controlled by God: [Deuteronomy 2:3-5](#), [16:19](#)
- The Babylonian captivity didn't annul the oath made by God: [Leviticus 26:41](#)
Additionally, the Prophets also tell us of the glorious future of Israel:
- Israel will never be destroyed because of God's promise of eternal protection: [Jeremiah 31:35-37](#)
- God promised Israel a New Covenant when He will remember their sins no more: [Jeremiah 31:31-34](#)
- Israel's glorious future includes a final restoration to the land: [Ezekiel 39:25-29](#)
- Israel's glorious future is secure because of God's character: [Ezekiel 36:22-28](#)

I think that the best way to understand Zionism is through a biblical lens. It will be helpful to remember that anytime we study the word of God, we must have a consistent method of interpretation. My preferred hermeneutical method is the literal grammatical/historical approach to the biblical record, making sure we always read a text within its original context. We should never read a biblical text through the eyes of our current culture, but rather, try to navigate through our current culture using a biblical lens.

From the biblical record, starting in Genesis, it can easily be argued that God Himself was the first Zionist. It hasn't changed and never will. Those who fight or reject Zionism are fighting and/or rejecting God. Incidentally, He doesn't want anybody to perish, and He certainly has the same love and compassion for both Jews and Arabs and so should we. Being a Zionist doesn't mean that one is a racist or a colonizer. Not historically, and certainly not biblically. Being a Zionist doesn't mean that one is anti-Palestinian, but sadly, the opposite is seldom true!

[Zechariah 12:2 helps one understand why it is that the world is caught up in this conflict existing among the nations of the world. As this war drags on 150 days since October 7, 2023, the media is flush with opinions, calls for UN intervention, op-ed pundits attempting to be “change” agents to influence global action; and few of them are knowledgeable of the Bible. We live in a world of religious confusion and that is reflected in over a thousand different religious denominations, sects, cults, and beliefs. As an example of how the Palestinian conflict divides American communities was reported at the University of Pittsburgh. Jewish students at the University of Pittsburgh are calling on the administration to take a stand in support of Israel, as protests continue on and near campus.

Pitt’s main campus has been a regular source of protests since Hamas attacked Israel on October 7 of last year. At one point, pro-Palestinian students had organized five protests in less than a month, as previously reported by The College Fix. On Monday, some students joined up with the Party for Socialism and Liberation’s Pittsburgh branch to protest attacks on the Houthis in Yemen by the U.S. and Britain.

Joshua Minsky, a Jewish student and College Republican leader at Pitt, called on Chancellor Joan Gabel to condemn the protests that have been taking place on campus.

Minsky told The Fix via social media messaging that Chancellor Gabel must stop *“trying to play both sides when it comes to this issue,”* but instead condemn the protests that *“openly support terrorist groups which advocate for the genocide of Jews.”*

“I think that by not condemning protests which support terrorist groups which call for the death of all Jews, the aim of neutrality which the university is trying to take is actually them just allowing antisemitism,” Minsky said recently.

Chancellor Gabel once released a statement condemning Hamas’ invasion of Israel back in October of 2023. However, no statement regarding the multiple pro-Palestinian gatherings on campus has been released.

Pitt and Chancellor Gabel did not respond to two requests for comment sent in the past week via email that asked for comment on university plans to support Jewish students.

Minsky also spoke out against the Monday *“Hands Off Yemen”* rally and the antisemitism that he said came along with it.

“To say that America should not attack Houthi rebels is to embrace antisemitism and anti-western ideals,” he said. “The mission statement, as defined on official Houthi documents, of this terrorist group is to kill all Jews, destroy Israel, and destroy the United States.”

Reuters referred to the attacks, meant to retaliate against the Yemen group for attacking ships in the Red Sea, as *“a dramatic regional widening of the Israel-Hamas war in Gaza.”*

At the protest, students convened with signs opposing Israel and calling to *“FREE PALESTINE.”*

“STOP the genocide; END the occupation; FREE PALESTINE,” one sign read.

Another sign linked *“White Supremacy”* to Israel, reading *“Death to White Supremacy; Capitalism = Extinction.”*]

Electric Power vs. Green Goals **(The King’s SDG’s Beginning to be Felt at Home)**

“The green movement calls for a shutdown of coal and gas power plants. At the same time, it demands a switch to electric vehicles, electric home appliances, and green hydrogen produced by power-intensive electrolyzers. This and the AI revolution portend a breakdown of the so-called energy transition.”

Twenty-three states have adopted goals to move to 100 percent clean energy by 2050. State governments propose to retire coal- and gas-fired power plants and adopt wind and solar systems. But these goals conflict with efforts to promote electric vehicles (EVs), electric appliances, and a new application (AI) that will increase the demand for electric power.

The green energy push seeks to eliminate greenhouse gas emissions to fight human-caused global warming. Leaders tell us that without a complete transformation of electric power, transportation, and home appliances to achieve Net Zero carbon dioxide (CO2) emissions, we are doomed to suffer from increasingly severe climate change impacts.

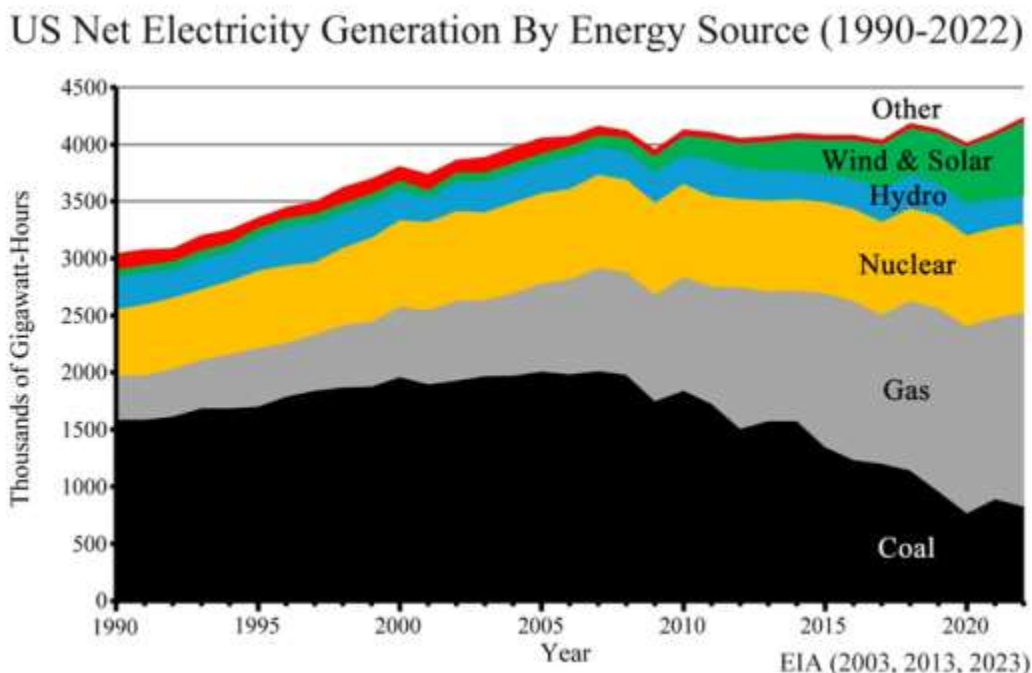
Michigan

For example, Michigan **passed** Senate Bill 271 on December 29 of last year, as part of its “Healthy Climate Plan.” The bill requires 100 percent carbon-free electricity by 2050. Michigan’s electrical power in 2022 was **generated** by gas (34%), coal (29%), nuclear (22%), with wind and solar at 12%. Michigan plans to close its gas and coal plants, which provide 63 percent of the electric power, while also retiring nuclear plants. At the same time, the state wants residents to switch to EVs and electric appliances.

The Healthy Climate Plan calls for two million EVs to be on the road by 2030 along with expanded electric-powered mass transit. It calls for replacement of gas appliances with electric heat pumps. But today, more than three quarters of Michigan homes are heated with natural gas. The state is also the largest user of propane fuel for home heating.

Efforts to adopt EVs and heat pumps will produce rising electricity demand and directly conflict with efforts to close power plants. Michigan's carbon-free electricity goals appear to be impossible to achieve.

In 2022, 60 percent of U.S. electric power was **generated** by coal and natural gas. About 85 percent came from the traditional generators: gas (40%), coal (20%), nuclear (18%), and hydroelectric (6%). After two decades of subsidies, wind and solar provided only about 15 percent of U.S. electricity.



U.S. demand for electricity has not grown since about 2005. But the push to electrify homes and transition to EVs will usher in a new era of rising power demand.

Almost all states striving for Net Zero by 2050 will run into the problem that Michigan faces. Shutting down coal and gas plants while promoting electric vehicles and heat pumps will produce electric power shortages. The only states that may be able to approach carbon-free electricity are Idaho, Oregon, and Washington, where hydroelectric generators produce most of the power.

ISO – NE Warning

The **New England Integrated System Operator** (ISO) issued a **report** in 2022 that looked at four scenarios to decarbonize the New England power grid by 2040. The report projected increases in power demand from EVs and electrification of home and business heating.

Only one scenario could meet state decarbonization goals and rising demand. That scenario called for 84 gigawatts of new wind, solar, and storage, to provide 56 percent of electricity by 2040.

But the ISO concluded that such a wind-, solar-, and battery-dominated system would not be reliable, requiring periodic operator-imposed blackouts. Even with 2,400 gigawatt-hours of battery-energy capacity and system reserve margins that were 300 percent over typical electricity demand, the system would fail for an estimated 15 days, and be at risk of failure an additional 36 days each year.

Wind and solar buildouts also conflict with alarming climate forecasts. Climate warnings call for increasingly severe weather, including stronger and more frequent storms, floods, and droughts. Yet climate-policy advocates demand a switch to intermittent wind and solar electricity sources. Wind and solar typically fail to operate during heatwave, cloudy, rainy, snowy, or stormy weather conditions.

After a transition to electrified energy systems, blackouts would be more severe. When the lights go out, residents won't be able to cook with an electric stove or drive an EV either.

Other nations also depend upon coal, gas, and oil generators for much of their electricity. Examples of hydrocarbon-produced power in 2022 were Australia (52%), China (64%), Europe (38%), India (77%), and Japan (65%). Switching to EVs and heat pumps while shuttering coal and natural gas generators will not be possible in most countries.

Two additional trends will drive electric power demand. First, the **revolution** in artificial intelligence (AI) requires data centers to upgrade servers with high-performance computer processors. Data center power consumption will jump by a factor of six to ten over the next decade, rising from about 1.5 percent of world power demand today to approach ten percent of world demand.

Second, governments are pushing to establish a new green hydrogen fuel business to power heavy industries such as steel. Production of green hydrogen from electrolysis of water is very electricity intensive.

The electricity required to drive electrolyzers to produce hydrogen to power a single steel plant with a four-million-ton annual capacity will require solar installations covering an area of approximately 70 square miles. About 5,000 terawatt-hours of electricity would be needed to drive electrolyzers to generate hydrogen for the world steel industry, equaling one and one-half times total non-hydroelectric global renewable electricity generated today.

Top Study: ‘Long Covid’ Only Effects Vaccinated People

A groundbreaking new peer-reviewed study has revealed that so-called “long Covid” is actually a disorder that only affects people who have been “vaccinated” with mRNA shots.

In the observational study, published in the prestigious Journal of Clinical Medicine, researchers conducted interviews with 390 individuals in Thailand who had contracted COVID-19 during the “*fifth wave of the COVID-19 pandemic*,” when the Omicron variant was prevalent.

These patients were tracked via phone for a year, starting three months after their diagnosis, to monitor their physical well-being, mental health, sleep disturbances, and quality of life.

According to a study, out of 390 individuals who contracted COVID-19, 97 percent, or 377 of them were “fully vaccinated,” 98 percent or 383 of them underwent antiviral treatment, and 78 percent or 330 of them developed long COVID syndrome.

Those who developed long Covid but were not “*fully vaccinated*” had received just one dose of mRNA shot.

The most frequently reported symptoms were cough and fatigue.

Other symptoms that were reported included anxiety, depression, and poor sleep quality.

The study found that individuals who were under 60 years old and had a cough as an initial symptom were more likely to develop the long COVID syndrome.

In a group of individuals who experienced long COVID, researchers discovered a significant correlation among females with headaches, dizziness, and brain fog.

“Despite the extensive distribution of vaccines and antiviral therapies, the prevalence of long COVID remains high,” the authors of the paper wrote.

The COVID vaccine side effects are slowly but surely beginning to be addressed by the mainstream media after all these years.

Meanwhile, the study has led to demands from some corporate media outlets for an investigation.

The UK Telegraph is now calling on governments to investigate the injections.

A group of MPs from all political parties has expressed concerns over the UK’s medical regulator, the Medicines and Healthcare Products Regulatory Agency (MHRA), for allegedly being aware of heart and clotting issues linked to Covid vaccines as early as February 2021 but failing to promptly inform the public about such problems for several months.

The [MHRA is responsible](#) for approving drugs and devices and monitoring the side effects of treatments.

The MPs are calling for an investigation into the MHRA’s handling of vaccine side effects.

But the all-party parliamentary group (APPG) on pandemic response and recovery, an influential group of MPs, has raised “*serious patient safety concerns.*”

**Farmers Warn of Looming ‘Death Sentence’ for
US Agriculture Under Biden
(Biden is just a Puppet for King Charles’ SDG’s)**

Iowa's farmers warned that the Biden administration in January that his "green agenda" policies would "cripple the farm economy" if allowed to continue.

U.S. farmers have slammed the Biden administration for wreaking havoc on U.S. agriculture with its *"Globalist green policies."*

Biden's green agenda, coupled with inflation and surging costs could create a *"domestic food crisis,"* farmers told US media.

While the federal government seems eager to prop up farmers in Ukraine, it is overlooking U.S. agriculture, farmers argued on *"The Ingraham Angle"* TV show.

Herds have been shrinking and some farms closing down altogether, farming industry figures warned. *"Farmers are going out of business every day,"* said Black Farmers of America founder John Boyd Jr.

"What's happening is America's beef cattle producers are depleting their herds. So they're not having more calves so they can multiply," added Boyd, who grows soybeans and grain and breeds cattle.

According to the U.S. Department of Agriculture (USDA,) nationwide beef cattle production plummeted to 28.2 million in 2024 — down two percent from a year ago. That level is the lowest since the 1970s. In turn, shrinking cattle numbers are contributing to the rising cost of beef. Economists say droughts over the last three years along with inflation have put further pressure on farmers.

The spike in diesel fuel costs is another challenge, said Boyd.

Texas rancher Shad Sullivan, told the program globalism was the main culprit.

"It's the global elites — claiming that climate change is ruining the world and that we must implement sustainability, which is just production and consumption control across the world," he said.

He derided claims that agriculture contributes *"one-third of all harmful emissions,"* along with *"sustainability regulations,"* as seeking to *"cripple"* Western agriculture.

Earlier this year, representatives of corn-growing sector raised the alarm after production costs for farmers surged by around \$15 billion in 2023. They also voiced concerns that the Biden administration's push for electric vehicles will slash demand for corn-based ethanol used to fuel some cars.

"I'm afraid if we keep heading down this path, we've got a lot of destruction ahead," one farmer told *Fox News*.

Zechariah 12:2

Ethnic Israelis are the most hated people on earth. An Israeli poll finds nearly 1 in 4 Americans hold anti-Israeli views, the highest in 60 years. It seems too many observers the feeling is mutual.

However, the same poll if conducted in most parts of the world where ethnic Israelis are not protected by mainstream media and compromised Jewish lobby politicians can be assumed that the term Israel raises a shudder of revulsion in a far higher percentage of respondents.

ADL chief decries 'shocking' results of the survey, which shows younger more sensitive respondents are most likely to agree with anti-Jewish tropes, have little problem with backing for the defenders of Palestinians. It is assumed that even more Europeans shudder at the thought of ethnic Israelis.



The poll of more than 4,000 US adults asked respondents the extent to which they agree with statements such as 'Jews have too much power in the business world,' 'Jews have too much control and influence on Wall Street' and 'Jews are more willing than others to use shady practices to get what they want.'

The results showed that 24 per cent of Americans agreed with at least six of the statements, up from 20% in 2022. The highest figure since the 11 statements were first polled in 1964.

FOR MATURE READERS WHO CAN TAKE THE TRUTH

The Israeli-financed Anti-Defamation League says, *“After decades of ‘antisemitism’.* Actually, most people don’t have a problem with Arabs who unlike Israelis are Semites. *“It is shocking to see the number of Americans who openly hold anti-Semitic beliefs increase so significantly in recent years,”* ADL director Jonathan Greenblatt whined in a statement.

The poll found that those under 45 were more likely to identify with anti-Jewish images. Among the ‘disturbing findings, 27% of respondents said it would be at least somewhat acceptable for a close family member to support the Hamas terror group while 23% have a close friend or family member who doesn’t like Jews.

In regards to Israel, 17% of Gen Z and 12% of millennials believe that the correct solution to the Israeli-Palestinian conflict is ‘the termination of the State of Israel and the establishment of a Palestinian State in all areas of historic Palestine, in which the Jews living there are not granted full citizenship rights.’

The poll found that many respondents viewed Israelis as callous or malicious toward Palestinians, with 43% agreeing strongly or somewhat that Israelis intend to cause Palestinians as much suffering as possible. A similar proportion said Israelis were indifferent to Palestinian suffering.

Nearly 36% agreed to some extent with the statement, *“If Israelis had their way, they would live in a world where all Palestinians were killed.”*

One fifth supported, strongly or somewhat, the removal of Israeli products from grocery stores. And more than a third agreed to some extent with the statement, *“I would not consider voting for a pro-Israel politician.”*

“Behold, I will make Jerusalem a cup of trembling unto all the people round about, when they shall be in the siege both against Judah and against Jerusalem.” -(Zechariah 12:2)

The main theme in chapter 12 is the overthrow of the nations that come against Jerusalem. The phrase ***“in that day”*** (noted five times) emphasizes the apocalyptic perspective of these events. The God Who speaks is identified as the Creator of heaven and earth as well as the One Who imparts life to all human beings. This God, Who is omnipotent and eternal, also has the power to move the created world toward its consummation.

God has his ***“eyes”*** on His people (cf. 3:9; 4:10; 9:8; 12:4), especially Jerusalem (mentioned eight times). The chaos which develops as ***“all the nations”*** focus on Jerusalem will yield to a restored order as God intervenes to destroy the nations.

Two metaphors, a cup or bowl of reeling and an immovable rock, are used as symbols of divine judgment. The former denotes the Lord's sovereign lot of men and nations, implying the fuddling of the minds of those who attack Jerusalem -(cf. Psalm 75:8; Isaiah 51:22f). The heavy stone, beyond their physical prowess, would render attacking nations helpless. (Ever since General Allenby occupied Palestine in 1917, Jerusalem has been central in the affairs of nations. England abandoned control in 1948, and since then, Jerusalem has been a heavy responsibility for the United Nations.) When ***"all the nations"*** line up against Jerusalem, the Lord will intervene, causing blindness and panic to defeat them. Judah and Jerusalem will be protected ***"like the Angel of the Lord going before them"***.

The survey found that 30% of respondents agreed in some measure that supporters of Israel control the media. And one third somewhat or strongly agreed that *"Israeli operatives are secretly manipulating U.S. national policy through the pro-Israel lobby AIPAC or other influence tools."*

In all, 33% of respondents at least somewhat endorsed the statement that *"Israeli operatives are manipulating U.S. national policy,"* while 30% at least somewhat believed that Israel controls the media.

The poll follows a study released last month by the ADL showing "anti-Semitic" incidents had skyrocketed since the Hamas terror group's October 7 attack and the ensuing war between Israel and Hamas.

"The sharp reversal, from older generations to younger generations being more likely to hold anti-Israel beliefs, is a terrifying concern for our future," Greenblatt said.

There were 3,283 anti-Semitic incidents in the U.S. between October 7 and January 7 including 60 physical assaults. It also counted 553 incidents of vandalism and 1,353 incidents of harassment.

The total number of incidents during the past three months is more than four times the number that occurred during the same period last year.

The figure is higher than the total the group has recorded over any full calendar year aside from 2022. By comparison, the ADL counted 2,717 anti-Israeli incidents during the entirety of 2021.

The rise in anti-Israeli sentiment has been traced to the October 7 attack and the ensuing offensive against Hamas in the Gaza Strip, which has sparked worldwide protests against Israel. Since the beginning of the war, over 30,000 Palestinians have been slain in the Gaza Strip, according to the Hamas-run Gaza health ministry.

Reporting that some wanted even stronger wording, such as “should receive an additional dose,” while *other members disagreed, pointing out that evidence does not support the need to add “should” in the vaccine recommendation,* that group also raised concerns that the wording could end up having a chilling or discouraging effect on individuals who haven't received a shot during the fall.

Proving us that even at the CDC, there are major differences of opinion among those pushing another round of vaxxes for the population, of course those totally spineless *members eventually voted in favor of the stronger recommendation, with the measure passing 11–1,* including the support of the stronger wording by CDC Director Mandy Cohen, who later endorsed their recommendation.

"Given the decreased severity of the virus, as acknowledged in various jurisdictions, there are legitimate concerns about the frequent administration of boosters in immunocompromised patients, raising questions about whether this practice may be causing more harm than benefit."

COVID-19 vaccines are also facing scrutiny for [shedding effects](#). The U.S. Food and Drug Administration defines shedding as the "release of [viral or bacterial gene therapy products] ... from the patient through one or all of the following ways: excreta (feces); secreta (urine, saliva, nasopharyngeal fluids, etc.); or through the skin (pustules, sores, wounds)."

Dr. Pierre Kory, founder of Front Line COVID-19 Critical Care Alliance (FLCCC), has said that both mRNA and adenovirus COVID-19 vaccines may cause vaccinated individuals to release spike proteins and other components. For instance, one study found the presence of mRNA in the breast milk of vaccinated females.

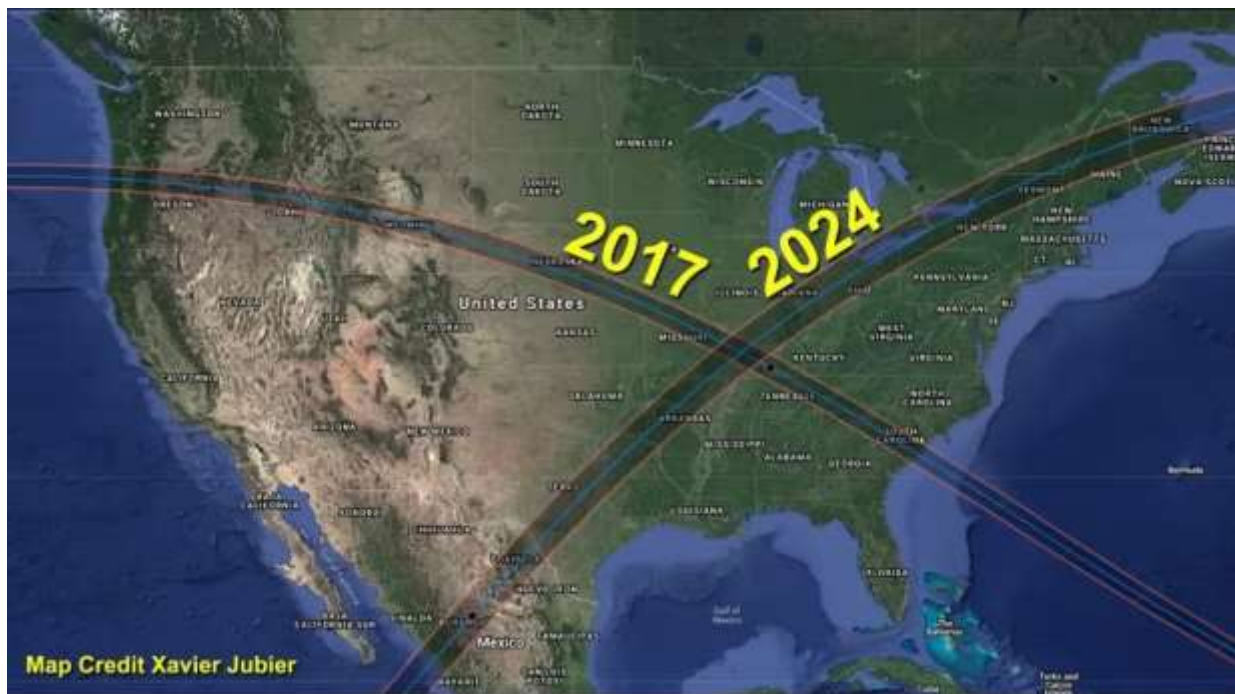

The Upcoming U.S. Eclipse Just Got Even Stranger!



I've previously reported on the upcoming Solar Eclipse to occur in the United States on April 8, 2024. But let me quickly bring you up to speed.... **33 Days away!**



Seven years ago in 2017 we had the first solar eclipse that crossed the USA, you probably remember it. It was a big craze. It resulted in this infamous Trump meme; Anyway, that was back in 2017 and we knew back then a new Eclipse would hit in 2024 criss-crossing the nation so it formed an "X" or a cross or whatever you want to label it.

So any time you get an event like that that literally marks an “X” on the USA, you tend to pay attention.

After all, the Bible tells us in Genesis 1:14 that God uses the Sun, Moon and Stars for signs and seasons:

“And God said, Let there be lights in the firmament of the heaven to divide the day from the night; and let them be for signs, and for seasons, and for days, and years”

So when there’s a giant sign in the sky creating an “X” across the USA, maybe it’s worth paying attention about what it means? But then when you look into it that’s when you start to notice some very strange wild stuff related to an eclipse.

As I reported on last week, this new eclipse crosses through 8 cities named Nineveh (7 in the U.S., 1 in Canada). I had no idea there were even 7 U.S. cities named Nineveh in the first place, but there are! I was only familiar with Nineveh, PA. A friend and fellow Methodist student-pastor was pastor of the Nineveh United Methodist Church some eight miles from where I was a student-pastor in Rogersville, PA way back in the mid-1960s. Nineveh, PA has fewer than 150 residents as I recall.

It turns out there are EXACTLY 7, so this eclipse just so happens to cross all of them. That’s kind of strange. Maybe it’s a coincidence, maybe not. But now here’s the new bit of information. I remember this now from 2017 but I had forgotten it. The 2017 eclipse similarly crosses through 7 U.S. cities named “Salem”. Wow!

It reminds me of that Bible story of the 7 Years of Plenty and the 7 Years of Famine. Same thing here, 7 and 7. 7 cities named Nineveh and 7 cities named Salem. The Bible is replete with 7’s from Genesis to Revelation.

From ChatGPT, here are the details:

The total solar eclipse of August 21, 2017, was a significant event that crossed the United States from the Pacific to the Atlantic.
