Top EU Leader Blows Whistle: WEF Using ‘Climate Change’ to Depopulate Earth

A top European Union leader has blown the whistle with an explosive warning for citizens around the world regarding the true agenda behind the “climate change” narrative.

Dutch Member of the European Parliament (MEP) Rob Roos has warned that the global elite, led by the World Economic Forum (WEF), is using “*climate change*” as a front for a mass depopulation operation.

The effort seeks to destroy the food supply in the name of “*saving the planet*” from “*global warming*,” making it impossible for a large percentage of the world’s population to survive.

Estimates have suggested that the plan will eliminate around 90 percent of the human race in order to meet the WEF’s goal of a maximum 1 billion global population cap.

To achieve this goal, the WEF, which controls politics, wants farmers to disappear by crushing them with one regulation after another and then concluding trade agreements with the entire world where they see fit, all under the guise of “climate change.”

“The ruling class wants to eliminate farming from Europe,” MEP Roos said.

“They want to completely change our lives.”

“It’s a kind of social engineering and the instrument they are using to do it is the Green Deal.”

In a post on X, Roos said: *“In every EU country, governments create different problems for farmers. Nitrogen (Netherlands), carbon tax (Denmark), higher fuel taxes (Germany). But the agenda is the same. The ruling class wants to eliminate farming from Europe. Their instrument: the Green Deal.”*

He attached a short clip from an interview with The Highwire’s Del Bigtree last month.

“The global elites ... want us to change our complete lives,” Roos told Bigtree.

“They want us to stop eating meat.”

“They want us to have electric cars.”

“They want us to have heat pumps.”

“Everything we have done so far is wrong and they are changing our lives.”

“It’s a kind of social engineering.”

“And it’s implemented by the Green Deal.”

Roos joined Bigtree at a time when the European farmer’s revolt was gaining powerful momentum. He gave Bigtree his take on why the European Union is placing these strict restrictions on farmers in the guise of climate activism. He discussed the reasons behind the pushback of European farmers and the elimination of rights looming for everyday citizens. On the surface, the protests are about higher taxes, nitrogen, and cheap imported goods, among other things.

But, as Roos articulated, the underlying reason is much deeper and is the same everywhere.

He remarked that the incredibly disconnected global elite ruling class has decided that human beings are *“living wrongly”* and, quite literally, that *“everything must change.”*

Indeed, the ruling class, which controls politics, wants the farmers to disappear by crushing them with one regulation after another and then concluding trade agreements with the entire world where they see fit, all under the guise of climate change.

Once farmers are out of the picture, this reliance on the global elite’s strategy for food is guaranteed to end freedom and basic life as we know it.

As an entrepreneur and expert in energy, Roos reminded in a speech in Warsaw, Poland, on 9 February that food security is a matter of national security, adding, *“no farmers, no food, no future.”*

As the deep state relentlessly aims to brainwash society to terminate meat consumption, it is not just cows they want to kill.

This is Oscar Mayer's Newest Hot Dog



Oscar Mayer is going vegan, even though the fad appears to be fading.

For the first-time ever, the Kraft Heinz-owned brand is going plant-based with two new versions of its hot dog and sausage it says offer a “smoky, savory taste and thick, juicy bite” that mirror its regular versions. The products, called Oscar Mayer “NotHotDogs” (\$5.99) and “NotSausage” (\$7.99), roll out nationwide later this year.

It's a continuation of its partnership with the plant-based foods company NotCo. to expand Kraft's plant-based portfolio in response to the growing hunger among American consumers for *"better-for-you"* products. In the past year, the company rolled out a vegan boxed Mac & Cheese, mayonnaise and vegan cheese slices.

The brand is doubling down on a segment, however, that isn't as popular as plant-based dairy: Plant-based meat sales fell 9% in 2023 to nearly \$886 million, according to figures provided to CNN from research firm NIQ.

Sinking sales have sparked troubles for pioneers, like Beyond Meat (BYND), which also has sausage products. The once-trendy plant-based meat company has faced falling demand and ballooning costs in recent years.

Beyond Meat last week said it was going to cut costs and transition to a "leaner operating structure" during its earnings report, however, it didn't specify whether that might include additional layoffs following a 19% workforce cut late last year.

Despite the setbacks, there are still a lot of *"consumer interest in healthier and more sustainable food options"* indicating opportunities for growth, Sherry Frey, vice president of Total Wellness at NIQ, told CNN.

Frey said that recent innovations in plant-based meat products, such as improving taste, texture and expanding options (i.e. including more protein per serving), *"could entice new and lapsed consumers back to the category."*

Taste, in particular, is a pain-point that Oscar Mayer acknowledged in its press release, writing that other plant-based hot dogs and sausage remain "underdeveloped and under-consumed" because of consumers' *"disappointment in existing offerings' taste and texture."*

It's an issue that even Beyond Meat is still figuring out and hopes that a new version of its products, [called "Beyond IV,"](#) will deliver *"superior health benefits and taste,"* the company previously stated.

Besides taste, plant-based meat *"faces challenges like price competitiveness, distribution issues and consumer skepticism,"* Frey said.

Changes at Kraft

The Kraft Heinz Company (KHC) has also found itself at a crossroads amid changing consumer tastes for processed foods. It has been examining and revamping its portfolio in an effort to increase net sales by \$2 billion through 2027.

In particular, the Kraft brand recently rolled out a makeover of its regular Kraft Singles cheese that emphasizes its lack of artificial flavors, colors or preservatives. The new packaging also includes a new graphic that says, *"made with real dairy."*

In 2022, Kraft tweaked the name of its boxed macaroni and cheese to “Kraft Mac & Cheese,” which is *“meant to reflect the way fans organically talk about the brand,”* and the packaging also got a makeover with a refreshed logo and a single-hue blue box color that *“amplifies the brand’s most recognizable asset — the noodle smile.”* A new advertising campaign is planned for this year, too.

Kraft remains bullish about its NotCo. products, although specific financials about the collaboration weren’t revealed in its most recent earnings report. In Wednesday’s press release, the company said it plans to add even more plant-based products and expand internationally.

NIQ’s Frey said that since eaters are becoming more health-conscious and environmentally aware, plant-based meat and dairy *“could likely become an increasingly popular choice for individuals seeking sustainable and ethical food options.”*

**From the archives of Pastor Bob's Studies on
Deliverance before Judgment / Pre-Tribulation Rapture
Why the Rapture Occurs Before the Revealing of the Antichrist!**

In the previous segment, a list of reasons one can trust the Pre-Tribulation Rapture view was begun. We will continue with those reasons now.

2. The Pre-Tribulation view is the most logical and consistent view of the Second Coming Scriptures when taken for their plain sense and literal meaning whenever possible. Regardless of the view some may take or believe, **many of the details of the Second Coming must be pieced together like a puzzle from various passages of Scripture.** The Pre-Tribulation position finds a logical place for every Second Coming passage, and like a completed puzzle, all the pieces fit nicely together. We find no leftover pieces that do not fit into the grand scheme of a Pre-Tribulation Rapture view.
3. The Pre-Tribulation position clearly and logically untangles the contrasting details of Christ Jesus' Second Coming. The Scriptures say that Jesus will come in the air to Rapture His Church, yet He will also come to the Earth publicly and physically. We have abundant Scriptural evidence supporting the Pre-Tribulation view to establish the coming of Christ Jesus in blessing for His Church and His return to the Earth in judgment are **two distinct events separated by Daniel's 70th week, found in Daniel 9:27.** The book of Revelation and 2nd Thessalonians 2 clarify what takes place between those two events.
4. The Pre-Tribulation Rapture position is the only view that makes a clear distinction between Israel and the Church. The lack of a proper understanding of the relationship between Israel and the Church in Bible prophecy is one of the major causes of confusion, as illustrated in the teachings of Amillennialism,⁽¹⁾ Post-Tribulation,⁽²⁾ and the Pre-Wrath⁽³⁾ views. The Pre-Tribulation Rapture is the **ONLY** position that clearly outlines the program of the Church. This is further confirmed by the fulfillment of **Isaiah 66:8**, the rebirth of Israel in a day. That was fulfilled June 14/15, 1948 and is proof positive of what the prophet Isaiah foretold, ***"Who hath heard such a thing? Who hath seen***

such things? Shall the earth be made to bring forth in one day? Or shall a nation be born at once? For as soon as Zion travailed, she brought forth her children.” My former fellow Methodists pull their hair out trying to get around Isaiah 66:8; and, so does anyone else that holds a view different than the Pre-Tribulation position. Those holding to “Replacement Theology” are determined that God is through with the Jews and replaced by the church. Paul’s Epistle to Romans, chapters 9, 10, and 11 refutes this position held by Amillennialism. Isaiah 66:8 does not elaborate or justify the event, nor does it give any background to its happening, but merely states its reality as a prophetic fact of history.

5. The Pre-Tribulation Rapture is the only view that makes ***“the blessed hope”*** of Titus 2:13 a truly blessed hope. Few Bible doctrines have brought more hope to grieving souls during the past two-thousand years than the doctrine of Titus’s ***“blessed hope”***. What could be more encouraging than to know that Christ Jesus will return for His Church, resurrect the dead, and transport living believers to be with Him while the world endures the Tribulation? The Mid-Tribulation position destroys that hope by forcing the believer to anticipate 3-1/2 years of incredible suffering and terror. The Pre-Wrath and Post-Tribulation further destroy such optimism in that it propels us through the entire Tribulation period or significant parts thereof. **No proper reading of Bible prophecy gives credence to the idea that the Church will be on earth during Daniel’s 70th week.** The judgments pictured in Revelation are clearly intended for Israel and the disbelieving Gentile world. **Keep in mind that the teaching on the Rapture was given to comfort those who mourned!** –(1st Thessalonians 4:18). The threat of experiencing the Tribulation is hardly a doctrine that gives comfort or encouragement to the redeemed.

6. Pre-Tribulationalism allows sufficient time for important end-time events to occur or take place, and there are many yet to be fulfilled. In fact, I have identified at least 58 individual events that take place following the Rapture. The Pre-Tribulational view allows adequate time for Christians to be taken to the Father’s house, experience the judgment seat of Christ (every one of us will have to give account of himself to God” –Romans 14:12), yet this view still provides time for the Wedding events in heaven before His Second Coming in time for the battle of Armageddon, when He comes ***“with power and great glory”*** to the earth as noted in Matthew 24:30 and Luke 21:27. Other viewpoints offer various periods of time for these events to take place, but all are too brief to allow adequate time for important events listed in Revelation. Dr. Arnold Fruchtenbaum, in his book *‘Footsteps of the Messiah’*,⁽⁴⁾ provides a long list of things that remain to occur, such as the rebuilding of the Third Temple, etc. Experts on the Third Temple estimate 2-1/2 years to rebuild the Third Temple based upon their architectural plans. The quarried limestone blocks are somewhere in Israel today, hidden away from public view. They were ordered in 1967, and paid for by the Freemasons of the UK. The story of the order was reported in Billy Graham’s flagship magazine, *‘Christianity Today’*. 60,000-tons of Bedford, Indiana,

limestone, precut, were ordered shortly after the Israeli military took East Jerusalem and the Temple Mount in the Six Day War of 1967.⁽⁵⁾ I personally saw the movement of the stones in Pennsylvania Railroad gondola cars on trains moving east through Pitcairn, PA in the summer of 1969 well into the summer of 1970. The cars were placard with routing signs reading, "Destination: Kearney Yard, N.J., for export to Israel". I personally saw their regular movement on Friday and Saturday mornings as they arrived in Pitcairn. The gondola cars with the cut stones were always on the head-end of the freight train that originated in East St. Louis, Illinois and added to the train in Indianapolis, Indiana. Each stone was spray painted neon orange with a combination of alpha/numeric characters to indicate that they were pre-cut for designated positioning during the construction phase, which is yet to occur.

7. Only the Pre-Tribulation Rapture view preserves the motivating power of the imminent return of Christ Jesus that was such a challenge to the early Church because of the persecution factor. In **John 14:1-3; Acts 1:11; 1st Corinthians 15:51-52; Philippians 3:20; and Colossians 3:4**, and many other passages, **the Apostles taught that Christ Jesus could come at any moment**. When the Church loses this anticipation, she tends to become carnal and die spiritually. Hundreds of examples all around America today confirm that this carnality already exists and is well engrained in a largely spiritually dead church. That errant belief has led many a church astray and into the "Emergent Church" movement⁽⁶⁾ one of the many apostate movements that prevail in the church today. Apostasy such as Yoga⁽⁷⁾ and Contemplative prayer⁽⁸⁾ have invaded what were once solid Bible-believing conservative denominations, like the Nazarenes, the C&MA (Christian & Missionary Alliance), and even many Baptist churches as well.
8. Pre-Tribulational Christians are looking for the coming of the Lord. Other Rapture views have Christians awaiting the Great Tribulation, Antichrist, and great suffering. There is no verse of Scripture that tells us we should be looking for the Antichrist, not one! In fact, only the Rapture could occur as soon as this very moment, but the Glorious Appearing [Second Coming] cannot occur for at least seven more years after the Tribulation begins.
9. Pre-Tribulationalism emphasizes the magnitude of the Rapture. Since at least four passages of Scripture describe the Rapture theme, it must be a significant event. The Post-Tribulational view trivializes the Rapture, treating it as an express-elevator trip – zip up and right back down! The Pre-Tribulational view treats it as a dignified, blessed event commensurate with a heavenly Bridegroom who comes to take His Bride to His Father's house for their wedding. I have prepared an entire series of articles on the detail outlining the "**Theme of the Bride**"⁽⁹⁾ that God has interwoven within the Biblical text. There are over **750** passages on the "**Theme of the Bride**" found from Genesis to Revelation. **You can truthfully say the Bible is a "love letter" from the Creator** based on this "**Theme of the Bride**". God has revealed the Pre-

Tribulation Rapture through a combination of implicit and explicit patterns and themes using Bible typology reinforcing His Grand Design for “Deliverance”!

It is true that God could have inspired one of the Biblical writers to spell it out in an unquestionable explicit message – “The Rapture will be at the beginning of the Seven-Year Tribulation”. But think about this for a moment, what would there be to look for in His Holy Word once you were given a **“Thus saith the Lord”** statement of declaration? As I have stated so many times before, Proverbs 25:2 is God’s challenge or invitation to man to search out the Word of God for all its goodies. The aspect of **“Mystery”** is intended to keep us motivated and not cause us to slack off or become lazy. This study on “Deliverance before Judgment” has been a project that has been in process since I first began studying Bible prophecy in 1967. I’ve often considered writing a book on the theme of “Deliverance before Judgement”.

Frankenmeat: The Disturbing Reality of Lab-Grown Meat Production

As the demand for sustainable meat alternatives soars, companies like Upside Foods are gambling with consumer health by using potentially cancerous immortalized cells in their lab-grown products.

As consumers become increasingly aware of the environmental and ethical concerns surrounding factory-farmed animal agriculture, the demand for sustainable, regeneratively farmed, and cruelty-free [meat](#) alternatives has skyrocketed. In response, some companies have turned to a controversial method for creating lab-grown meat: using immortalized cell lines. While this approach may seem like a groundbreaking solution as far as the synthetic production of a large quantity of cells goes, it raises serious questions about the long-term safety of consuming such products.

Immortalized cell lines, which are capable of continuously dividing and growing, bear a disturbing resemblance to [cancer](#) cells.¹ The article "Lab-Grown Meat Firms Don't Know If Their Food Is Safe Long-Term: REPORT" highlights this concern, stating that "Lab-grown meat is often made using immortalized cell lines, which, unlike regular cells, are capable of continuously dividing and growing in a manner similar to cancer cells."¹ Despite this alarming fact, many companies developing lab-grown meat have remained silent about the connection between their products and these potentially dangerous cells, possibly in an attempt to prevent consumers from becoming skittish about their offerings.¹

One such company is Upside Foods. In [November 2022](#), it became the first company in the world to receive the U.S. Food and Drug Administration (FDA)'s green light for cultivated meat. Upside Foods has attracted investments from several high-profile individuals and companies, including Bill Gates, Cargill, Tyson Foods, and Softbank Group.³ The involvement of these well-known investors has helped to raise the profile of Upside Foods and the cultivated meat industry more broadly. However, it also raises

questions about the potential conflicts of interest and the influence these investors may have on the company's decision-making processes, particularly when it comes to prioritizing safety and transparency.



One of the most concerning aspects of using immortalized cell lines in lab-grown meat production is the lack of long-term studies on the health effects of consuming these products. As noted in the article, "While there is no evidence to suggest that these cells -- which are either cultivated from cancer cells or created with [genetic modification](#) -- are dangerous for human consumption, there have also been no long-term studies on the health impact of these foods."¹ This absence of crucial data leaves consumers in the dark about the potential risks they may face when consuming synthetic meat derived from immortalized cells.

The article also cites an October 2021 study published in the *International Journal of Molecular Sciences*, in which MIT researchers emphasize the need for further investigation into the safety of consuming genetically engineered animal cells. The researcher's state, "Confirming that future products made from immortalized animal cells expressing oncogenes, either through spontaneous immortalization or genetic engineering, would be safe represents a gap in knowledge in this field."^{1,2}

Some companies, recognizing the potential backlash associated with using immortalized cell lines, have begun to explore alternative methods. Japan's IntegriCulture, for example, has shifted towards using cells taken directly from live animals in their production process, in an effort to distance themselves from the association with cancer.¹ IntegriCulture CEO Yuki Hanyu acknowledges the potential controversy, stating, *"There will be someone who will be poking at this issue. And it could basically flare up."*¹

As the demand for lab-grown meat continues to grow, it is crucial that comprehensive, long-term studies be conducted to assess the safety of consuming these products. MIT researcher Robert Weinberg, whose work demonstrated the genetic basis of cancer in the 1980s, suggests that the "best way" to permanently resolve the potential issue would be a 20 to 30-year-long study to determine if consumers of lab-grown meat were more likely to develop cancer than others.¹ However, he acknowledges that such a study is not practical, and companies are more likely to focus on gaining regulatory approval to soothe public relations concerns and allow consumers to try their products.¹ Until thorough, long-term research is available, consumers should be aware of the potential risks associated with synthetic meat derived from immortalized cells and make informed decisions about what they choose to consume. As the race to bring lab-grown meat to market continues, it is essential that companies like Upside Foods prioritize transparency and invest in research to ensure the safety of their products for human consumption, regardless of the potential influence from their high-profile investors.

There are no odds whatsoever that a disaster so huge and so economically devastating can occur by accident.

Drain the Reservoirs, Return California's Stolen Land

As was breathlessly reported in the *San Francisco Chronicle* and elsewhere, indigenous tribes are now able to recover their sacred land and revive their ancestral villages and way of life. It is time for California's progressive supermajority to do the right thing and return all stolen land to the first peoples. They can start by draining the rest of California's reservoirs.

Not only is demolishing California's dams, draining all of its reservoirs, and returning the restored riverfront property to their rightful claimants an appropriate reparatory gesture,

but it will also set the rivers themselves free. Unshackled, they will again be welcoming habitats for salmon and other aquatic life, able to send torrents of nurturing fresh water into California's Central Valley and ultimately into the Sacramento-San Joaquin Delta.

The first target in this noble effort should be to blow up the [O'Shaughnessy Dam](#) and drain the Hetch Hetchy Reservoir, which supplies water to the City of San Francisco. Surely the enlightened voters and elected officials in San Francisco will eagerly support this long overdue demolition. Once Hetch Hetchy Reservoir is empty, a beautiful valley, twin to Yosemite, will be exposed in all its granite grandeur once again, and the valley can be reoccupied by the Miwok, Yokuts, Washoe, Mono, and Paiute tribes, where they can recreate their ancient villages and recover their ancient ways. And why stop there?

Draining Lake Shasta will enable the Winnemem Wintu tribe to restore their villages that, for nearly a century, have been inundated, and they can again live peacefully in the upstream canyons of the Sacramento River headwaters. Similarly, blasting down the Oroville Dam will set the Feather River free again at last and empower the Maidu, Paiute, and Washoe tribes to repopulate the liberated riverbanks. Blowing up the Trinity Dam will allow the Yurok and Hoopa nations to return to their sacred river. Similarly, blasting the New Melones Dam to smithereens will set free the Stanislaus River, and the reclaimed land can be returned to the Yokuts people.

Just the removal of these five dams will free over 12 million acre feet of water to journey "unimpaired" from California's alpine heights to its ocean estuaries. But to be true to the principles they so self-righteously seek to impose on everyone, they must not stop there. *All* of these dams, these arrogant monuments to European hubris, must be demolished. California has over 1,500 reservoirs on its water grid. Together, they imprison over 41 million acre feet of water each year. Destroy them all! Return the land to its proper owners, California's first peoples, along with the fish and the waterfowl.

As California proceeds to correct the errors of previous generations of colonial usurpers, it might also reintroduce the magnificent species that were so cruelly diminished in earlier times. Wolves and grizzly bears must be reintroduced to their original habitats, starting with the Santa Cruz Mountains, overlooking one of California's many urban abominations, the Silicon Valley. The destruction of the Klamath River farming and ranching economy is part of a broader assault, coming from a technology-driven elite that masquerades as virtuous proponents of environmentalism and racial equity. They are confident they shall suppress the protests of those who recognize how these virtues have devolved into nihilism, and confident they shall sustain the masquerade until they dominate the world.



It has been more than two decades since the U.S. government legislated 50% of the United States is going to be set off limits to us nasty humans!!!! Below is the headline from almost a quarter-century past.

"House OKs \$45 billion to save land and wildlife: Easily approved, the bill, which faces a tougher go in the Senate, would more than double the government's budget for land acquisition", by Douglas Jehl, The 'New York Times', reported in The Providence Journal, May 12, 2000, p. A1, 6.

The legislation set aside \$45 billion over 15 years to buy parks and open spaces, pay for wildlife protection and restore damaged coastal areas. By far the biggest environmental initiative of this congressional session, the bill was supported by large numbers of Republicans as well as Democrats, reflecting the election-year appeal of a plan that would channel large sums of money back to home districts and give lawmakers *"a chance to cast what many portrayed as a vote on behalf of the environment."*

"By redirecting money the government collects from oil-drilling royalties, the bill would commit about \$3 billion annually over 15 years to buy private lands considered at risk from development, to repair coastal lands harmed by oil drilling, to rebuild eroded beaches and to help communities create soccer fields and bicycle paths."

This last statement certainly pinpoints the one of the real, hidden goals of this type of legislation-- the elimination of Private Property Rights. Our entire economic system hinges upon the preservation of Private Property Rights as our Founding Fathers certainly intended. THE most important difference between Capitalism and any other Socialist system is that Capitalism allows and encourages Private Property ownership, while Socialism and Communism forbid it, saying euphemistically that the "community" owns all property. It is important to repeat the opening statement here:

must be changed so the average person will accept the same Black Magick values as Antichrist possesses. The Bible tells us exactly what these values are:

"Who changed the truth of God into a lie, and worshipped and served the creature more than the Creator." –(Romans 1:25)

Thus, peoples of the world need to be led into the worship of created objects rather than Jesus Christ, Who created all things in the universe -(John 1:1-14). People need to start worshipping the human intellect, Astrology, Witchcraft, and the human body. The aim is to allow between a third and a half of all land to go wild. "

Indeed, the Christian Scientist who created the Re-wilding Map -- shown above, page 17 -- from reading hundreds of pages of United Nations planning, told insiders that, for the map of the United States to coming true, would require a population reduction of about 65%!

And, America is close enough to implementing this plan that California has started implementing it, right out in the open.

"Today, most farmers see their problems occurring as a result of stupidity, ignorance, or a failure to understand their needs. But what is happening to them is nothing to do with stupidity, ignorance or a failure to understand – it's all deliberate and quite cold-blooded. More and more European countries are now dependent on imports for most of their food and energy supplies. And most of our food will be made in factories owned by billionaires."

The bottom line, vital to remember, is that nothing is happening by accident or by coincidence. This conclusion is correct, but there is one more devastating fact that this plan has a name -- the New World Order.

And, this New World Order has a powerful leader who will be called "The Christ", but the Bible will call him "Antichrist"! HRH Charles operates from the shadows of world Freemasonry through control of credit and currency!

Can you see how very close to the appearance of Antichrist this article places mankind?

One of the first New World Order Plans ever published was a work entitled, *"The Protocols of the Learned Elders of Zion"*. Written with a very thin cover as the plans of worldwide Jewry to gain control of the world, this plan is, in reality, a most comprehensive plan as to how to achieve their New World Order. The exact date in which this was written is obscured, but some believe it was written in the late 1700's.

Listen, now, to their plans as the world is just about to enter the final phase of the transition into their 'kingdom', the New World Order. *"When we come into our kingdom, our orators will expound great problems which have turned humanity upside down in order to bring it, at the end, under our beneficent rule. Who will ever suspect, then, that all these peoples were stage-managed by us according to a political plan which no one has so much as guessed at in the course of many centuries?"* (*The Protocols of the Learned Elders of Zion*, end of Protocol No. 13.)

None of the people who were living at the time when the kingdom of the New World Order was being established, will ever understand that they have been 'stage-managed' by their leaders according to a plan that is several centuries old!! The New World Order literature quite boldly declares, time and time again, that their plan is a conspiracy; the Bible teaches conspiracy between God and Satan for control of the world, and a conspiracy at the very end that will allow Antichrist to arise. Yet, with both spiritual sides agreeing that there is a global conspiracy here, the most common belief held by the man on the street is that such a global conspiracy is impossible!! But, of course, that is exactly what the conspirators want you to believe, for then their activities can occur in the open, without fear of detection. The first part of the Plan, above, which states that, just before the actual implementation of the New World Order, their *"orators will expound such great problems which have turned humanity upside down in order to bring it, at the end, under our beneficent rule"*. Now, what *"great problems"*, which are turning our world upside down, have we been hearing about for the past 20 years? We have been hearing about how man-- the highest of all the animals in the Evolutionary ladder -has been irretrievably damaging the Earth's environment, in all the following ways:

- * Polluted waterways, lakes, ground water, and streams
- * Polluted air
- * Ozone layer holes
- * Smog in all the cities, with all the damage created worldwide
- * Polluted landfills
- * Carcinogens in the air
- * Global warming - or is it cooling now?- caused by man's activities
- * Mining operations that are damaging the environment, and the "ecological diversity" of the Earth
- * Cutting of forests, especially rain forests
- * Human overconsumption that constitutes tremendous waste of Mother Earth's limited resources.

Whenever responsible people, like scientists not involved with the Plan, object that most of the above warnings are just not true, or cannot be proven by scientific analysis, the answer we always hear is that, if such disasters were simply possible, we must act now. If we wait to act until science can "prove" such disasters are happening to Mother Earth, it would be too late to do anything about it. We have also seen how the extreme environmentalists have always resorted to creating fantastic false statistics about the amount of damage there is created. Statistics that, if analyzed, are found to be impossible, are continually being thrown out to a listening audience that swallows them down without ever thinking critically about them.

We have examined the original plan as espoused by the *"Protocols of the Learned Elders of Zion"* above, to deliberately create such huge disasters to panic the people into allowing the New World Order to be established. That was written about 200 years ago. Move forward in time to Mikhail Gorbachev, former leader of the old U.S.S.R. Gorbachev said that the *"threat of environmental crisis will be the 'international disaster key' that will unlock the New World Order."* [*"A Special Report: The Wildlands Project Unleashes Its War On Mankind"*, by Marilyn Brannan, Associate Editor, Monetary & Economic Review, pg. 5.]

One of the current leaders in this effort is Reed Noss, Director of The Wildlands Project. Noss stated the goal very succinctly, *"the collective needs of non-human species must take precedence over the needs and desires of humans."* (Ibid., pg. 4.)

Therefore, Extreme Environmentalism is designed to be the leading force in moving the world into the New World Order. Such environmentalism in this country is being primarily implemented by Executive Directive, not by Congress, simply because these people are aware that Congress, which is still elected by the people, could not enact such legislation without getting thrown out at the next election. Therefore, the Executive Branch, the President's Administration, has been quietly enacting a most bold plan to implement the Draconian goals of the New World Order through Directive, not through the Congressional process. After all, who pays much attention to what most of the obscure Federal Government agencies are doing? Most Conservatives have simply relaxed because we have prevented most of the very extreme environmental legislation from being passed through Congress, not realizing the enemy is entering the proverbial chicken house by a rear door.

I have been studying the broad scope of the New World Order Plan regarding human populations since the late 1980s when HRH Prince Charles began pushing the environment issue at Rio. The New World Order Plan calls for a rapid and forced reduction in the world's population from the present 8 billion to below 1 billion or so. This Plan also envisions severely restricted usage of the land, all over the world, and a return back to the kind of economy which existed worldwide about 300 years ago.

Before you scoff, let me remind you of the words of Jose Arguelles, writing in his *"25-Year Plan For The Earth"*, *"1997 -- The Year The New World Order Plan Changes Ominously"*. Arguelles called for a *"5-year phase-out of our industrial civilization"*, to be implemented by the United Nations! As if this information is not shocking enough, then Arguelles drops the real bomb, as he reveals the Plan for the period, 1997-2002. This 5-year plan would be *"Known as the Era of Reseeding, it will thin out major population centers. The human population will be resettled."* (*"Progress As If Survival Mattered"*, Friends of the Earth: 1981, pg. 68-70, quoting David Brower, Friends of the Earth Chairman, former head of Sierra Club, as quoted in *'A Planned Deception: The Staging of a New Age 'Messiah'*, by Constance E. Cumbey, Pointe Publishers, Inc., East Detroit, MI, 1985, pg. 164-5.)

Did you catch that last statement? The human population WILL BE resettled. Major population centers WILL BE thinned out. THIS is the true impact of this legislation. When time comes for the "thinning out" and the "resettlement", no individual will have any say about whether or not they will go to the new area; they will NOT be allowed to stay in their privately-owned property. The benevolent, kindly mask of the Government Beast will have come off, revealing the true Nazi Wolf that has been there all along, now ready to rend and kill the flock.

Consider again very, very carefully what Arguelles has just told us. Using euphemism and vagueness patterned closely on Hitler's propaganda before he gained power, Arguelles has told us that our present Industrial Civilization would be phased out over this 5-year period, from 1997 to 2002! I witnessed this with the steel industry in Pittsburgh and surrounding "rust belt" states.

Then, Arguelles states that the major population centers will be "thinned out". This is a euphemism that means, people die. At this point, if you turn to your Scriptures to the End of the Age passage of Matthew 24, where Jesus is giving the many signs of the End. In verses 6-7, Jesus said that the preparatory period would be characterized by wars and rumors of wars, of nations battling other nations constantly. But then, in verse 15, Jesus places the Antichrist in the Holy of Holies, profaning it as Daniel had foretold. Then, in verse 21, Jesus said that great distress and tribulation would break out upon the earth during this time period, unprecedented in history, and that this tribulation would result in such destruction of life that, if God did not intervene, no person would be left alive.

Unless otherwise noted, this material was taken from *"Special Report: The Wildland Project Unleashes Its WAR ON MANKIND"*, by Marilyn Brannan, Associate Editor, 'Monetary & Economic Review'.

What the President did not tell you back then was that these areas were to be set aside in New World Order planning will be swept of all human living and/or development, as part of the United Nations Biodiversity Protection program, created in 1972. This plan literally conceives of setting aside huge areas of the world where no humans can live -- will be allowed to live -- or work, or play. While this plan is global and is being instituted globally, we will limit our study of it to the United States. (The entire plan was published in a report entitled, *"Our Global Neighborhood: The Report of the Commission On Global Governance"*, Oxford University Press).

This plan in America is called the "Rewilding" of America. This term means to re-wild this continent. In other words, they plan to sweep aside all evidences of human endeavor, i.e., homes, businesses, structures, entire cities, allowing the land to go back to its natural state, before the wicked White Man took the land from the Native Americans (Indians). Using Presidential Directive, normally exercised through various Federal Government agencies, this "rewilding" project will be accomplished by declaring huge tracts of land completely off limits to humans. These tracts of land would be called 'reserves'. Reserves would [Op. Cit., Brannan, pg. 2.]

This is 50% of America!!! If we could show you the detail maps (based upon the map on pg. 17), where these off-limits zones are designated, your mind will be blown by the unbelievability of it all!! You will be able to see if your area is one of those who are swept clean of human activity, and you will be able to see where you might wind up being relocated. Many entire states are set aside, to prevent any human activity at all. These "re-wilding" blocs are as follows:

- * Oregon, Washington, Idaho, Utah, Montana, Wyoming, Colorado, New Mexico, Arizona
- * Wisconsin, Michigan
- * Maine, New Hampshire, Vermont, Massachusetts, Connecticut, New York
- * Portions of Virginia, West Virginia, the Carolinas, Tennessee, Georgia following major river systems
- * Portions of Florida

Remember, 50% of the United States is going to be set off limits to us nasty humans!!!! They used some terms in the above quote that need to be defined.

* 'Wilderness area' is defined as the habitat of plants and animals. All human activity is to be forbidden.

* 'Buffer Zones' are those areas surrounding the wilderness areas. Limited and strictly controlled, only access is to be permitted by humans. No organized activity, such as work, or homes, or cities, will be allowed. Knowing how dictatorial government works, any humans allowed to be in these Buffer Zones will probably have to be given special permits. And, of course, paramilitary forces will undoubtedly have to be patrolling these zones, enforcing the limited human access.

* 'Cooperation Zones' are the only zones where humans will be allowed to live, and presumably, work.

But, how can this plan, extreme as it is, be implemented without arousing a population which still has the opportunity to vote? If the American people truly understood the gravity of the situation facing them, they would immediately vote the current rascals out, and elect officials not associated with this New World Order Plan!

According to Dr. Michael Coffman of Environmental Perspectives, Inc., a strategy to implement these reserves and corridors would be to follow these steps carefully, in the northern Rockies, for this example:

Step 1. *"Start with a seemingly innocent-sounding program like 'The World Heritage Areas In Danger'. Bring all human activity under regulation in a 14-18 million acre buffer zone around Yellowstone Park."* [Good-bye, tourism. Of course, tourism is a bad thing, because it wastes resources like gas, pollutes the air, the streams and waters, and the land. Oh, especially the land. How much like pigs we humans are, with our sloppy

habits of throwing empty containers all over Mother Nature, much of them made of plastic which takes eons to decay!]

Step 2. Declare all Federal areas, except for Indian Reservations, as 'Buffer Zones' along with private land within Federal Administration boundaries. [Indians, you see, are good people. Their ancestors practiced a Nature religion, which enabled them to live as one with Mother Nature. Have you noticed now how popular Indian culture and artifacts, and books, are in book stores and fashion retailers, especially in the New Age culture?]

Step 3. Extend the U.S. Heritage corridor 'Buffer Zone' along the major river systems in the U.S. Critical Federal lands and ecosystems could then be converted to 'Reserves'.

Step 4. Convert all U.S. Forest Service, including grasslands, and wildlife refuges to reserves. [Ibid., pg. 2-3.]

When you add the reserves and corridors to this plan that have not been yet implemented in Steps 1-3, you will discover that 50% of the United States of America will have been swept absolutely clean of all human activity!! And, remember, that the global plan for implementing this plan was 1997-2001. Obviously, America was not quite ready for this Draconian plan just yet. We will be one of the last countries in the world to fully enact this plan.

This Satanic system is going to be 'governed' on a local level by 21 'bioregions'.

These 'bioregion councils' will supersede the authority of any local, state, and national governments who might disagree with their policies. Has anyone heard of the U.N. organization called the United Nations Environmental Program (UNEP)? It was created in December, 1972, by U.N. Resolution #2997. This agency has been planning to organize every society on earth under the pretense of saving the environment. The entire world has been mapped into 'bioregions' and *"is responsible for virtually all of the environmental policy changes that have occurred globally in the last two decades."* [Op. Cit., Brannan, pg. 7.]

As expected these Neo-pagans love the number 5, having developed a 5-step plan of action to implement their Orwellian goals.

1. *"Redraw land maps' based upon biological characteristics, not on political boundaries."*

2. *"Regroup human populations into self-sustaining settlements that minimize impact on biodiversity." [Remember Argulles' goal for the 1997-2001 5-Year Plan, i.e., "Thin out population centers and Resettle populations"?]*

3. Educate humans in the 'gaia ethic'. [This is the Satanic concept that Mother Earth is a living, breathing goddess, the creator and sustainer of all life. And, yes, she is very angry at the way mankind is treating her!!] This is why we have had so many bad storms the past several years you know. And too many of our current political leadership believes this paganism!
