Pope Francis Declares ‘God Hates Antivaxxers’

Pope Francis has warned that Christians who refuse to take the dangerous mRNA vaccine are ‘heretics’ who will be judged harshly by God.

In a newly released memoir, Francis was interviewed by journalist Fabio Marchese Ragona. In the interview, Francis complained that opposition to the COVID-19 vaccines “distressed” him. He claimed that *“being against the antidote is an almost suicidal act of denial.”*

“Deciding whether to get vaccinated is always an ethical choice, but I know that many people signed up to movements opposed to the administration of the medication. This distressed me because in my view, being against the antidote is an almost suicidal act of denial,” Francis said.

In the Catholic faith, suicide is considered a sin against God.

Naturalnews.com reports: According to Francis, the people living in fear are those that didn’t take the vaccine. He claims *“a generalized fear was created when superficial explanations of how the vaccines worked spoke of injections of the virus into the body.”*

Meanwhile, Francis continues to visibly live in a state of fear and subservience, having turned the Catholic Church into a shell of its former self, while deriding all of his dignity in the process. Remarkably, he is doubling down and spewing untruths about a failed vaccine program that he is bound to, in a cycle of constant boosters and mental abuse. Today, visitors to the Vatican Museums, the Vatican Gardens, the papal villas and the Apostolic Palace at Castel Gandolfo must show a Green Pass in order to enter. The Green Pass is a digital certificate verifying that the individual is fully-vaccinated with an additional booster shot. Individuals who do not furnish a Green Pass must submit to a fraudulent covid-19 PCR test to verify that they are negative for covid-19.

Anyone who fails to obtain a *"Super Green Pass"* is considered an *"unjustified absence"* and their pay is suspended. Moreover, Francis requires FFP2 and N95 masks in all enclosed spaces on Vatican territory, and he does not permit religious exemption to vaccination or masks. The recruitment of assassins for the terrorist attack in Moscow's Crocus City Hall Concert venue was organized through the Embassy of Ukraine in Tajikistan, according to a military expert, ex-special services officer, retired Colonel Bakhtiyer Rakhmonov.


A few weeks before the terrorist attack, information appeared on the website of the Ukrainian diplomatic mission about inviting foreigners to join the so-called "International Legion," he noted. The message was later removed.

"The ambassador of the Ukrainian embassy in Dushanbe is the ex-head of the foreign intelligence service, and the consulate itself was looking for perpetrators a few weeks before the terrorist attack, publishing an order to hire assassins openly on the page of the Embassy of Ukraine in Tajikistan," he said, adding that it provided all the contacts - a potential terrorist could only write or call.

Rakhmonov constantly monitors such messages on the website of the Ukrainian embassy. Since 2014, Ukrainian diplomats have posted similar announcements several times, only to have them removed.

"The work on recruiting foreigners was led by Ambassador Extraordinary of Ukraine Valery Evdokimov, former head of the foreign intelligence service under Zelensky," the expert said.

Evdokimov was the head of the Foreign Intelligence Service of Ukraine from September 2019 to June 2020.

Latest \$1.2 Trillion Omnibus Bill Removed Stipulation That Protects Against A CBDC And Phasing-Out Paper Money



Last week President Joe Biden signed a whopping \$1.2 trillion omnibus spending package on Saturday, March 23rd, that will fund the government for months into the future, after the Congress and Senate were able to quickly pass the bill before the government had to shut down.

The bill, however, was thrown together and unveiled at the last minute and contained a mammoth 1,012 pages, making it impossible for it to be carefully read in time for the vote.



The package, H.R. 2882, which can be read in full [here](#), was said to have contained a number of amendments introduced by some House Republicans, but were ultimately cut before the final bill was voted upon.

One of those, according to Representative Andrew Clyde (R-GA), included a stipulation that would have prevented funds allocated to the creation of a central bank digital currency (CBDC), and would have prevented the phasing-out of paper tender.

SEC. 131. None of the funds made available by this Act may be used by the Department of the Treasury to establish a United States Central Bank Digital Currency or discontinue circulation or use of paper currency as legal tender in the United States.

The provision that was cut from the passed bill follows:



Now that these conditions have been removed it provides a scapegoat for federal funds to be spent on further research & development in the creation of a CBDC, along with shrinking the physical money supply of paper cash.

Though the Federal Reserve and Head Chair Jerome Powell have been wishy-washy about implementing a CBDC, the [Feds recently indicated that a CBDC is one of their top priorities](#) including Fed Now, which was disclosed during a Senate Banking Committee meeting earlier this March.

A number of provisions in the original text of the omnibus bill were removed, as noted by [Reclaim The Net](#), which highlighted the surrendering of prohibiting funds to the Department of Homeland Security (DHS) to fund a Disinformation Governance Board or other entities that would increase domestic censorship.





Biometrics Are The Future Of Payment Whether You Like It Or Not

Facial recognition, fingerprints, eye scans, and handprints are some of the innovations expected in the payment market.

The use of biometrics as an identification tool is not new; it dates back to ancient times when fingerprints were used as signatures and seals. Application in payment technology is what makes it revolutionary. However, there is a gap between expectations and reality.

Since 2010, there has been an acceleration in this trend, primarily in the use of smartphones, while the fintech sector is still in the testing phases today. Although skepticism is strong in France, some players have already started to innovate in this field.

Biometrics At The Service Of Innovation

The use of fingerprints as a means of verification on smartphones has encouraged the development of biometrics in fintech. According to a survey conducted by Visa, 79% of French people trust biometrics as a secure means of authentication, and according to the 'Groupement des Cartes Bancaires' (CB), 52% of French people would prefer to use their fingerprint instead of their PIN code. Welcome to the New World Order!

With a biometric card, it is enough to place a finger on it to validate a transaction without a limit as long as it is pre-authorized. Because, today, the card's biometric data are stored securely on the chip, rather than sent to the banking servers, or communicated to the merchants.

The Future Of Payment

Facial recognition, fingerprints, eye scans, and handprints are some of the innovations expected in the payment market.

According to a study by Dentsu Data Lab, conducted in 14 countries in 2021, 81% of respondents would be willing to use fingerprints instead of PIN codes. This innovation could improve the customer experience, which is today a continuous challenge for merchants.

By using a totally personal and irreplaceable mechanism, biometric payment will significantly reduce fraud at points of sale and allow for greater efficiency in the automated payment process by reducing waiting times for customers.

If today, mobile wallets in their various forms are a trend, the arrival of biometric payment terminals constitutes a real disruptive innovation in the market. However, the development of this type of technology does not only concern payment terminal providers but also banks.

A Future Full Of Challenges

Biometrics face three challenges: cost, security, and data storage.

It is clear that the biometric card incurs an additional cost for the consumer, in terms of price, but there is also a cost for the merchant due to the transformation of payment terminals.

From a security standpoint, this form of verification is much harder to hack than a four-digit code. However, the risk that irreplaceable biometric information could be obtained by hackers raises doubts among consumers.

The storage of this encrypted information raises questions in the evolution of biometric payments. Who should be responsible for ensuring the security of biometric information, the bank or the payment terminal provider? This issue largely depends on the trust of the users.

The contactless biometric payment card is currently the only biometric payment method on the market, but its evolution towards other formats such as the pattern of veins on a hand or facial recognition is expected to be the next step. The biometric technology already used in smartphones and its level of acceptance show that the consumer market is ready to engage in this new innovative era in the financial sector. It is undeniable that biometric technology brings safer identification and an improvement in the customer experience to the payment sector.

Francis Scott Key Bridge in Baltimore Hit By Ship; Collapses

NATION HAL TURNER 26 MARCH 2024

At 1:28 AM local time today, March 26, 2024, The Key Bridge in Baltimore, MD collapsed after being hit by a ship. Video of the actual collision appears on Hal Turner.com site. All media are showing the actual collision and collapse.

This Bridge was part of Interstate 695 known as the Baltimore Beltway. I-695 is the route many trucks took to avoid the Fort McHenry Tunnel on I-95.

The bridge is named after Francis Scott Key who was an American lawyer, author, and amateur poet from Frederick, Maryland, best known as **the author of the text of the U.S. national anthem, "The Star-Spangled Banner."** Key observed the British bombardment of Fort McHenry in 1814 during the War of 1812.



This is an incredibly important roadway and bridge. This will adversely affect commerce from Washington, DC all the way up to New York City and even to Boston.

The bridge spanning the Baltimore Harbor and shipping channels was a vital connection for communities and transporting goods and people across waterways. It had four lanes and a speed limit of 55 mph, ensuring smooth traffic flow while adhering to safety standards. The bridge carried an estimated 11.5 million vehicles annually, with an average daily traffic of **31,500 vehicles**.

As a result of this catastrophe, the Port of Baltimore is now CLOSED. No ships in or out.

What this translates to is serious:

Baltimore is a big port. The Port's private and public terminals handled 847,158 autos and light trucks in 2023, the most of any U.S. port for the thirteenth straight year.

In 2023, the Port ranked first in the nation in handling automobiles, light trucks, farm and construction machinery, as well as imported sugar and gypsum. The Port ranked second in the country for exporting coal. In 2022, the Port ranked sixth for importing coffee, 119,000 tons worth \$609 million.

Overall, the Port of Baltimore is the 11th most important Port in America.

Baltimore Port lies close to the Chesapeake Bay in Maryland, the eastern part of the U.S, on the Patapsco River, making it one of the busiest ports and industrial centers in the region.

Along its 72 km long shoreline lies 5 public and 12 private terminals, handling general merchandise, dry and liquid bulk commodities, containerized cargo, etc. The port handles 37,850,000 tons of cargo, 632,000 TEU and 252,000 passengers annually.


The Port of Maryland has the deepest harbor in Chesapeake Bay. It is also closer to the Midwest than any other East Coast Port and also just an overnight drive of one-third of the country's population.

The Port of Baltimore, responsible for 25% of the country's coal exports.

According to Ship Finder, the container vessel which struck the bridge is named the "DALI" flagged out of Singapore.

Reports indicate upwards of twenty highway workers, who were on the bridge when it collapsed, are "missing." Baltimore Fire Dispatch has stated that 7 Construction Workers and 3-4 Civilian Vehicles are still Missing following the Collapse.

Investigative journalist Lara Logan is reporting that the destruction of the Francis Scott Key Bridge in Baltimore Harbor on Tuesday, March 26, by a Singapore-flagged commercial ship was a "Black Swan event."

Logan cites “multiple intel sources,” for her reporting and said the U.S. intelligence community is aware that the crashing of the bridge was an attack, not an accident.

The FBI almost immediately issued a statement that the attack was not in any way tied to terrorism, but this was nothing more than a deliberate attempt to deceive the American people, Logan reports.

Logan stated on her X account:

“The Baltimore bridge collapse was an ‘absolutely brilliant strategic attack’ on US critical infrastructure – most likely cyber – & our intel agencies know it. In information warfare terms, they just divided the US along the Mason Dixon line exactly like the Civil War. Second busiest strategic roadway in the nation for hazardous material now down for 4-5 years – which is how long they say it will take to recover.”

Logan explained that the bridge was built specifically for the purpose of moving hazardous material – fuel, diesel, propane gas, nitrogen, highly flammable materials, chemicals and oversized cargo that cannot fit through tunnels. And that critical supply-chain infrastructure has now been “crippled” by whoever engineered this attack.

“Make no mistake,” Logan wrote, “this was an extraordinary attack in terms of planning, timing & execution. The two critical components on that bridge are the two load-bearing pylons on each end, closest to the shore. They are bigger, thicker and deeper than anything else.”

“These are the anchor points and they knew that hitting either one of them would be a fatal wound to the integrity of the bridge. Half a mile of bridge went in the river – likely you will have to build a new one. Also caused so much damage to the structural integrity of the bottom concrete part that you cannot see & won’t know until they take the wreckage apart. Structural destruction likely absolute. Attack perfectly targeted.”

The timing of the attack is also noteworthy, following several U.S./NATO-led attacks on Russian critical infrastructure, including the Nordstream 2 gas pipeline in September 2022, and a missile attack on the Russian bridge to Crimea last year. Now, just last Friday, Russia was attacked by four Muslim terrorists that Russian authorities believe were working under the guise of Islam to kill 143 Russian civilians at a concert hall outside of Moscow. While the U.S. says the terror attack was strictly an act of Islamic terrorism conducted by ISIS-K out of Afghanistan, the public comments of Russian President Vladimir Putin and other Russian political leaders strongly suggest that they are convinced the attack was orchestrated by the Ukrainian national intelligence services, or GUR, which is a wholly owned subsidiary of the U.S. Central Intelligence Agency and British MI6.

So Tuesday’s bridge collapsing event may have been Russia’s first punch back for what they believe was a bloody below-the-belt terrorist attack by U.S.-controlled forces.

Logan wrote:

"They have figured out how to bring us down. As long as you stay away from the teeth of the US military, you can pick the US apart. We are arrogant and ignorant — lethal combination. Obama said they would fundamentally change America and they did. We are in a free-fall ride on a roller coaster right now — no brakes — just picking up speed."

And Logan is not the only one calling this bridge event a "Black Swan Event."

General Michael Flynn, retired three-star general and former national security advisor to President Trump, posted a statement to X that said:

"This is a BLACK SWAN event. Black swans normally come out of the world of finance (not military). The standard operating procedures for all U.S. ports, harbors, and bays that transit commerce and military activities are supposed to maintain an incredible level of discipline, rigor and awareness for these very type events to not occur (ever!), yet here we are. Douglas MacGregor, former NSA technical director William Binney, former UN Weapons Inspector Scott Ritter, and former CIA analysts Larry Johnson and Ray McGovern, among others, are part of an organization called Veteran Intelligence Professionals for Sanity (VIPS).

Google Is Ordered To Identify Who Watched Certain YouTube Videos

"U.S. federal law enforcement and courts have gone a step further in the extreme efforts they are making to surveil people's activities online, including on Google's vast platforms. The latest is that the tech giant gets orders to identify all people who happen to be watching certain videos or livestreams on YouTube."

After directly censoring creators and channels, giving geolocation data of its users to the authorities in response to the controversial geofencing warrants, this is a new example of how Google can be used and abused in dragnet-style "investigations."

Unmasking everyone who watched a particular video is similar to geo-fencing in that it makes everyone a suspect - and this, a number of experts and rights groups believe, is unconstitutional, i.e., in violation of the 4th Amendment, that protects from unreasonable searches.

[Forbes writes](#) that it has had access to several orders that name certain YouTube videos, citing one unsealed case originating in Kentucky and having to do with people viewing content posted by a user who law enforcement suspects of money laundering for selling bitcoin for cash.

Undercover agents had contacted the user, sending links to drone mapping and AR tutorials, to next turn to Google, asking to be told who watched the videos.

The videos had more than 30,000 views, and a court ordered that any user who did, between January 1 and 8, 2003, must be thoroughly unmasked. The order wanted names, addresses, phone numbers, and account activity of each Google user, and IP addresses of everyone who watched the videos without an account.

"It's fair to expect that law enforcement won't have access to that (sensitive personal) information without probable cause," commented Electronic Privacy Information Center's John Davisson. "This order turns that assumption on its head."

When the police asked for the order to be issued, they stated, *"There is reason to believe that these records would be relevant and material to an ongoing criminal investigation."*

Although Google complied with the demand to keep silent about all this until the records were unsealed last week, according to *'Forbes'*, they *"do not show whether or not Google provided data in the case."*

A separate case in New Hampshire concerned a bomb threat in a public place, and people watching a livestream of the police searching the area. The livestream was possible thanks to a camera on nearby business premises.

Next, the police wanted to know exactly who watched it, including on a YouTube channel belonging to Boston and Maine Live, which has 130,000 subscribers.

Again, no word if Google delivered.
