New Study Estimates US Has 13.7 Million Illegal Aliens, 37% Increase Since Biden Took Office, Larger than 33 State’s Individual Populations

Since President Biden took office in January 2021, the foreign-born population has grown by 6.4 million — larger than the individual populations of 33 states.

The following report is by the [Center for Immigration Studies](#) (CIS):

Analysis of the Census Bureau’s Current Population Survey (CPS) shows that the total foreign-born or immigrant population (legal and illegal) hit a new record high of 51.4 million in February 2024 — an increase of 6.4 million since President Biden took office.

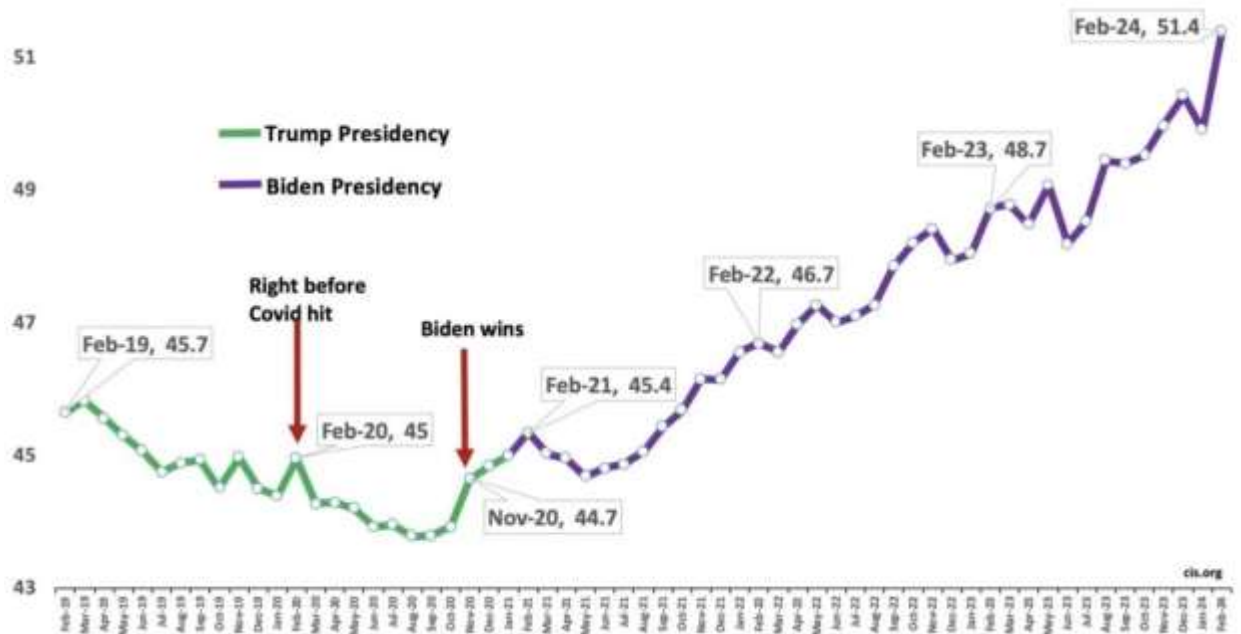
At 15.5 percent, the foreign-born share is also a new record in American history. Data such as border encounters and “got-aways” are clearly important, but they do not measure the number of immigrants actually living in the U.S., which is what ultimately determines the impact on the country. The enormous scale of immigration over the past three years has implications for nearly every aspect of American society, including

public coffers, the labor market, schools, hospitals, and the balance of political power, to say nothing of whether we can assimilate this many people.

Among the findings:

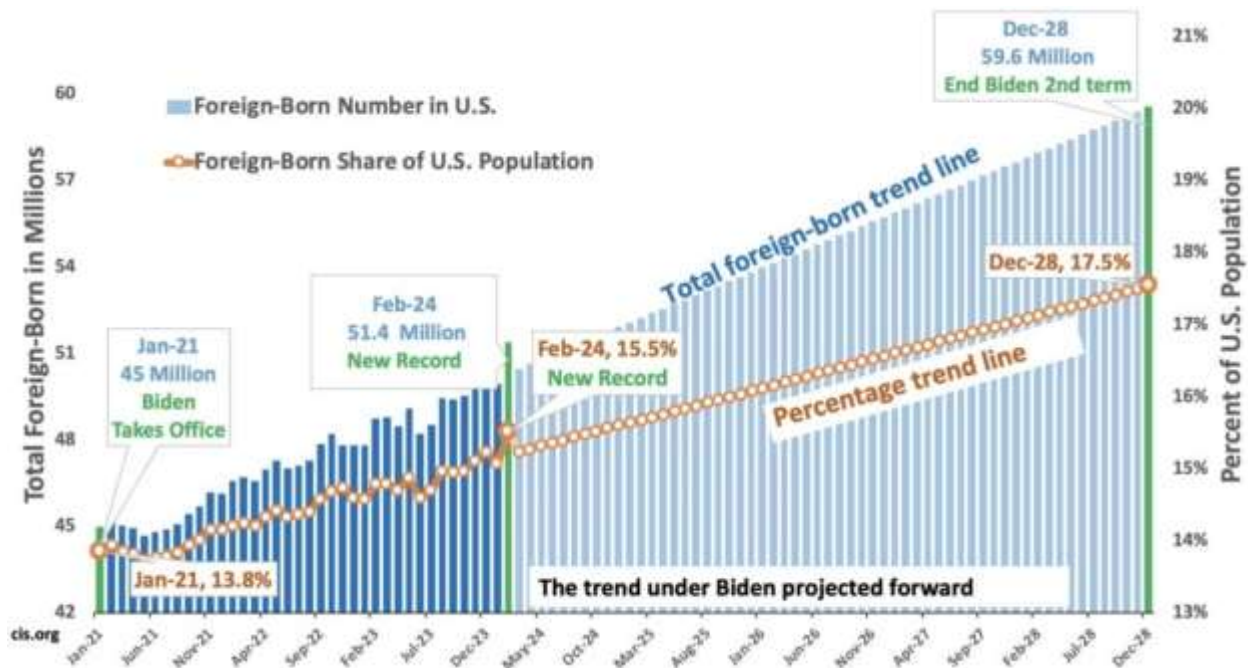
- In February 2024, the foreign-born population in the United States hit a new high of 51.4 million and 15.5 percent of the U.S. population — surpassing all prior records.
- The foreign-born share of the U.S. population has more than tripled since 1970, nearly doubled since 1990, and is up 40 percent just since 2000.
- Since President Biden took office in January 2021, the foreign-born population has grown by 6.4 million — larger than the individual populations of [33 states](#).
- Growth in the foreign-born population is being driven primarily by immigration from Latin America, which has grown 4.2 million since January 2021, with South and Central America up 1.7 million and 1.4 million, respectively. Also, immigration from the Indian subcontinent is up 819,000 and from the Middle East is up 654,000.
- At 172,000 a month, the average increase in the foreign-born under President Biden is four times the 42,000 average monthly increase under Trump before Covid-19 hit and double the 68,000 average under Obama.
- If current trends continue, the foreign-born population will reach nearly 60 million and 17.5 percent of the U.S. population by the end of a second Biden term — both figures would be without any precedent in American history.
- We preliminarily estimate that more than half (3.7 million) of the 6.4 million increase in the foreign-born population since January 2021 is likely due to illegal immigration. If adjusted for those missed by the survey, the increase is larger.
- The 6.4 million increase overall and the 3.7 million possible increase in illegal immigrants are both net figures. The number of new arrivals was higher, but was offset by outmigration and natural mortality among the foreign-born already here.
- While a large share of the recent growth in the foreign-born population is due to illegal immigration, legal immigrants still account for roughly three-fourths of the total foreign-born population.
- Due in part to the illegal influx, the education level of new arrivals has declined. Of working-age (18-64) adults who arrived in the two years prior to February of this year, 44 percent had no education beyond high school, compared to 29 percent in 2018.

- The scale of immigration is so high that it appears to have made the Census Bureau population projections, published in November of last year, obsolete. The bureau projected that the foreign-born share would not reach 15.5 percent until 2039.
- In February 2024, the 31 million immigrant workers accounted for 19.3 percent of workers — both new record highs. Compared to February 2020, right before Covid, the number of immigrant workers is up 3.3 million, while the number U.S.-born workers is down by one million.
- The immigrant workers have made the nation's aggregate GDP several hundred billion dollars larger. However, per-person GDP, not aggregate GDP, determines the standard of living. Immigration tends to lower per-person GDP because it causes the population to grow faster than the economy.

New York City Becomes First US City to Implement \$15 Congestion Toll When Entering Parts Of Manhattan

The following report is a [press release](#) by the New York Metropolitan Transportation Authority (MTA) Board:

Following a robust public comment period in which the MTA received 25,600 written comments and heard from 386 speakers at four public hearings, the Metropolitan Transportation Authority (MTA) Board, in its capacity as the board of the Triborough Bridge and Tunnel Authority, today approved Central Business District toll rates by a vote of 11 to 1.

The approved toll rates align with rates [recommended by the Traffic Mobility Review Board on Nov. 30, 2023](#), and [put forward for public review by the MTA Board on Dec. 6](#), with a handful of clarifications provided.

Passenger vehicles and small commercial vehicles – sedans, SUVs, pick-up trucks, and small vans – paying with a valid E-ZPass will be charged \$15 during the day and \$3.75 at night, when there is less congestion, to enter the congestion relief zone in Manhattan below 60th Street. They will be charged no more than once a day.

Today's vote is one of the most significant the Board has ever undertaken, and the MTA is ready. In advance of day one of tolling, we've increased service on 12 subway lines, advanced redesigns of the entire NYC bus network, and implemented the largest service increase in LIRR history.

And there's more to come with the funds raised from congestion pricing – more accessible stations, modernized subway signals, and new expansion projects like Phase 2 of the Second Avenue Subway and Metro-North Penn Station Access.

Said MTA Chair and CEO Janno Lieber:

Trucks and some buses will be charged a toll of \$24 or \$36 during the day to enter the congestion relief zone in Manhattan below 60th Street, depending on their size and function, and \$6 or \$9 at night. The toll for motorcycles will be \$7.50 during the day and \$1.75 at night. Yellow taxi, green cab and black car passengers will pay a \$1.25 toll for every trip to, from, within or through the zone; customers of app-based for-hire vehicles will pay \$2.50. As previously proposed, qualifying authorized emergency vehicles and qualifying vehicles carrying people with disabilities will be exempt. As will school buses contracted with the NYC Department of Education, buses providing scheduled commuter services open to the public, commuter vans licensed with the NYC Taxi and Limousine Commission, and specialized government vehicles.

As previously proposed, a 50% discount will be available for low-income vehicle owners and a tax credit is available for low-income residents of the Central Business District.

Scapegoating the Romans and Pontius Pilate for Killing Jesus

Almost every year near Good Friday, confusion is sown concerning the death of Jesus, usually put forth by a nationally syndicated liberal “Christian” columnist, or a sermon from an “evangelical” Protestant minister, or a priest of the modern Church of Rome.

They proceed to focus culpability for the crucifixion of Jesus almost exclusively on the Romans and Pontius Pilate. Some years ago we were present for a sermon by a Jesuit

priest at Gonzaga University in Spokane, Washington who devoted his homily to sparing the Pharisees a single admonitory word while alluding to Pilate in no uncertain terms as “a thug!”

According to the politically correct view now in vogue, the Pharisees of 33 A.D. were more sinned against than sinning.

Among falsifiers on the Right, are two luminaries in the ersatz “*Conservative*” firmament. Former Fox News talk show host Bill O’Reilly promotes the manifestly ridiculous Romans-are-to-blame-for-the-Crucifixion imposture in his book, *The Last Days of Jesus*. He’s not alone. Andrew P. Napolitano, better known as “*Judge Napolitano*,” a widely admired figure among “*Conservatives*,” wrote a column on Holy Thursday in which he had the temerity to state:

“On the first Good Friday, the Romans executed Jesus because they were persuaded that by claiming to be the Son of God, He might foment a revolution against them...they feared a revolution that would disrupt their worldly power, and so they condemned Him to death by crucifixion.” (LewRockwell.com, April 17, 2014). Pharisees are not mentioned anywhere in Mr. Napolitano’s column concerning who is culpable for the Crucifixion of Jesus.

To assert that the Romans bear the lion’s share of responsibility is an atrocious fabrication pleasing to the corporate media and the Cryptocracy.

The fact that Jesus praised a Roman officer above everyone in Israel (Matthew 8:5-13), and the Roman administrator Pilate urgently sought to save Christ’s life, calling him a just man, and being threatened by a mob as a result, is washed down the memory hole.

Historic Christianity, faithful to the Gospel narrative, had a very different view of Pontius Pilate. For example, Francis Turretin (1623-1687), was a distinguished professor of theology and the author of the magisterial, three volume *Institutio Theologiae Elencticae*, (“*Institutes of Elenctic Theology*” reprinted as recently as 1994), first published in 1679–85. In vol. II, p. 489-490, Dr. Turretin wrote:

“...the kingdom of Christ...is conducted in a spiritual manner, recognizes no other honors and resources than righteousness, holiness, peace of conscience, salvation and eternal life; no other arms than the Word and the Spirit; no other fortifications than the protection of God.” Pilate had this understanding of it. He clearly perceived that no prejudice could be created from it (the kingdom of Christ) against the empire of Caesar; otherwise he would not only have agreed with the accusation of the Jews charging Christ with rebellion against Caesar, but he would have been the first to think of taking Him out of the way.

“However, having dismissed this accusation of the Jews and (accepted) Christ’s own confession concerning His kingly office, Pilate pronounces Him just and innocent, and

desires Him to be cleared from condemnation (for he knew that for envy they had delivered Him, Matthew 27:18)..." (End quote from theologian Francis Turretin).

The disinformation that renders the Romans the principal malefactors is also undercut by *none other than the Babylonian Talmud itself*, in Sanhedrin 43a, where it is stated that the Roman "authorities" were favorable toward Jesus and did not want to execute him:

"Rather it must be that the case against Jesus was different, because he had close connections with the non-Jewish authorities, and those authorities were interested in his acquittal." — *The Steinsaltz Talmud*, volume 17, p. 159 (Random House, 1998).

What is there to debate? We have God's Word in 1 Thessalonians 2:14-15. This is an unambiguous statement. This Scripture was declared by St. Paul without qualifications of any kind. There is also the testimony of Acts 3-13-15.

Even in our time, one of most authoritative rabbis in the western world is the medieval *halakhist* Moses Maimonides, "*the Rambam.*" He is honored in Congress with a sculpture, and venerated in media and academia, though few of his enthusiasts have bothered to discover what he actually taught. We regret to report that Maimonides was an unabashed Jesus-despiser. In his magnum opus, the *Mishneh Torah*, he declared: "*The Christians are idol worshippers*" (*Avodah Zara* 9:4). "*Idol worshippers*" are subject to severe penalties according to the "*Noahide Laws*" promoted by every American President from Ronald Reagan forward, under the rubric of "*Education Day USA.*"

Furthermore, Maimonides taught that Jesus was killed "*by the court,*" a reference to the *Beth Din* (rabbinic court): "*Yeshu the Christian, who imagined himself the messiah and was killed by the court...*" (Rabbi Moses Maimonides, *Mishneh Torah: Laws of the King* 11:4).

Nowhere does the Talmud or Moses Maimonides, the supreme halachic authority for western Talmudists, blame the Romans, as do the modern popes, many Protestant "evangelists" and the corporate media. There are literally thousands of spineless academics and clerics on the Left as well as the Right who minimize the role of the Pharisees, the progenitors of the Talmud of Babylon, in the killing of the Son of God, putting the onus instead on the Romans and Pilate.

Talmudism is in higher repute in Christendom now than ever in history and it is to the Pharisaic theology founded upon it—and successive texts possessing *halachic* authority (such as the *Mishneh Torah*) —to which our apologetic and educational efforts are centered.

Nothing we teach is a negative reflection on Judaic people in general. *We unconditionally repudiate the disgusting "Christ-killers" imprecation unjustly leveled at all or most Jews.* Due to our own dreadful sins, every one of us is guilty of putting Jesus on that Cross of Calvary and being responsible for His death.

It was from the Tree of the Knowledge of Good and Evil that our first parents cursed all humanity, and it was from the “tree” of wood upon which Jesus was crucified, that through him the Gospel invites all of humanity to salvation.

It is incumbent on us as Christians to lovingly correct errors, as did Jesus, John the Baptist and the apostles Peter and Paul. We pray for those who promote the falsehoods of Talmudism. We are not reluctant to proclaim the truth about the Jesus-denying snares and pits into which people fall as a result of the continuing influence of the Pharisaic nullification of Scripture, which was virulent in the first century and which has culminated in the 21st century distortion of the Good Friday narrative.

Record 59% of American voters believe abortion should be legal in all or most cases: poll

A Fox poll shows that support for abortion among American voters has significantly increased since before the overturn of Roe v. Wade.



[\(LifeSiteNews\)](#) — A record 59% of American voters think abortion — which brutally kills unborn children — should be legal, according to a Fox News survey conducted this month.

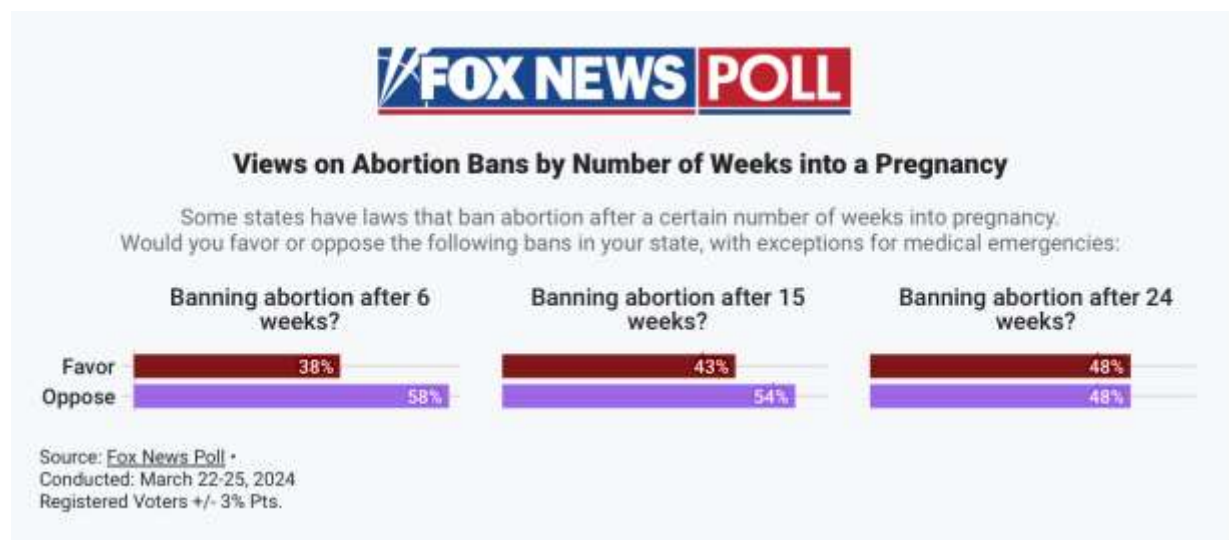
A remarkable 35% of registered voters said they think abortion should *always* be legal, and 24% of respondents said they think abortion should be legal most of the time when asked to choose an option that “*best describes*” their “*view on abortion*.”

About a third (32%) of those surveyed said they believe abortion should be illegal except in cases of rape, incest, or to save the life of the mother. Only 7% said they believe abortion should always be illegal.

The total of 59% of voters who believe abortion should be legal in all or most cases is a remarkable increase from the record low of 44% of voters who believed the same in April 2022, two months before *Roe v. Wade* was overturned.

Nearly two-thirds of respondents (65%) support a “*nationwide law guaranteeing access to legal abortion*,” according to the Fox News poll. The vast majority of Democrats (89%) and two-thirds of Independents (65%) favor nationally legalized abortion, while only just over half of Republicans (53%) are opposed.

The survey also shows that voters are split on whether abortion should be banned at 24 weeks or six months. About half (48%) are opposed to such a ban, and 48% are in favor of such a ban. At six months, a child is fully formed and can survive outside the womb with proper life support. Baby Center depicts an unborn child at 24 weeks:



Moreover, the survey showed that 68% of voters believe access to the abortion-inducing pill Mifepristone should be legal, while under a third (28%) believe the abortion pill should be banned.

Fox News explained that the poll was conducted from March 22 to March 25 “*under the joint direction of Beacon Research and Shaw & Company Research*” “*with a sample of 1,094 registered voters (RV) nationwide randomly selected from a national voter file.*”

The survey results reportedly have a “margin of sampling error of ± 3 percentage points,” and “weights are generally applied to age, race, education, and area variables to ensure the demographics of respondents are representative of the registered voter population.”

The apparently increased support for abortion among American voters is troubling given that the procedure brutally kills innocent human life, as former abortionist Dr. Anthony Levatino has demonstrated.

During the first three months of pregnancy, when an unborn child develops a heartbeat at about six weeks’ gestation, the abortionist typically uses a suction catheter that tears apart the baby through the force of suction, Dr. Levatino has [explained](#).

The most common form of the procedure during the second trimester — dismemberment or D&E abortion — involves tearing apart an unborn child piece by piece, starting with the child’s arms and legs, until the abortionist crushes the head, which is the size of a “large plum” at 20 weeks, [according to](#) Levatino.

Justice Anthony Kennedy noted in his [dissent](#) in the 2000 case *Stenberg v. Carhart* that “The fetus can be alive at the beginning of the dismemberment process and can survive for a time while its limbs are being torn off.” Moreover, it is believed that babies feel pain during this trimester, since pain receptors are linked to the brain of an unborn child by 12 to 15 weeks.

During the third trimester, the abortionist typically injects the pain-sensitive child with Digoxin, causing fatal cardiac arrest.

After an anticipated “red wave” failed to materialize in the 2022 midterm elections, with Republicans failing to wrest the Senate from Democrat control, many politicians blamed this failure on Republicans’ opposition to abortion.

The result has been silence on the issue of abortion or pointed compromises on the part of GOP strategists and politicians. For example, pundits like Sean Hannity [claimed](#) that being “moderate” on abortion is Republicans’ key to winning elections, and Donald Trump recently [stressed](#) that he wants to “make both sides happy” on the issue of abortion.

[[The larger question before us is what this indicates on the issue of the ‘Sanctity of Life’. The sanctity of life is a principle that all human life is sacred and inviolable. It is based on religious and ethical beliefs that human life has an inherent dignity, worth and sacredness that sets it apart from other beings. It implies that human life should be treated with reverence and respect, and that it should not be violated by actions such as abortion, euthanasia, capital punishment, or war.

The phrase “sanctity of life” reflects the belief that, because people are made in God’s image -(Genesis 1:26–27), human life has an inherently sacred attribute that should be

protected and respected at all times. While God gave humanity the authority to kill and eat other forms of life -(Genesis 9:3), the murdering of other human beings is expressly forbidden, with the penalty being death -(Genesis 9:6).

Humanity was created in God's image, but sin has corrupted that image. There is nothing inherently sacred in fallen man. The sanctity of human life is not due to the fact that we are such wonderful and good beings. The only reason the sanctity of life applies to humanity is the fact that God created us in His image and set us apart from all other forms of life. Although that image has indeed been marred by sin, His image is still present in humanity. We are like God, and that likeness means that human life is always to be treated with dignity and respect.

The sanctity of life means that humanity is more sacred than the rest of creation. Human life is not holy in the same sense that God is holy. Only God is holy in and of Himself. Human life is only holy in the sense of being "set apart" from all other life created by God. Many apply the sanctity of life to issues like abortion and euthanasia, and, while it definitely applies to those issues, it applies to much more. The sanctity of life should motivate us to combat all forms of evil and injustice that are perpetuated against human life. Violence, abuse, oppression, human trafficking, and many other evils are also violations of the sanctity of life.

Beyond the sanctity of life, there is a much better argument against these things: the greatest commandments. In Matthew 22:37–39 Jesus says, **"You shall love the Lord your God with all your heart, and with all your soul, and with all your mind.' This is the great and foremost commandment. The second is like it, 'You shall love your neighbor as yourself.'"** In these commandments, we see that our actions are to be motivated by love for God and love for others. If we love God, we will value our own lives as part of God's plan, to do His will until it comes about that His will is better served by our deaths. And we will love and care for His people -(Galatians 6:10; Colossians 3:12-15). We will see to the needs of the elderly and sick. We will protect others from harm—whether from abortion, euthanasia, human trafficking, or other abuses.

While the sanctity of life can be the foundation, love must be the motivation. Christians believe that human life reflects the image of our holy God, that God owns the right to give and take away life, that God values human life above other life forms, and that He is intimately involved in forming each life within the womb. These truths point to the fact that people matter to God. He commands mankind to value people the same way He does. Jesus quotes Leviticus 19:18 in Matthew 22:39 as the second greatest commandment: **"You shall love your neighbor as yourself."** He also tells His disciples, **"A new commandment I give to you, that you love one another: just as I have loved you, you also are to love one another. By this all people will know that you are my disciples, if you have love for one another"** -(John 13:34–35).

The Bible is filled with practical ways we're to value human life by loving others: tending to the sick, visiting the imprisoned, feeding the hungry, clothing the needy, seeking

justice for the oppressed, and caring for orphans, widows, and strangers (Matthew 25:35–36; James 1:27; 1 John 3:16–18; Ezekiel 45:9; Deuteronomy 10:18–19). We should be agents of love and compassion in the world, alleviating suffering wherever we can and remembering that each human life bears the image of our God. **Ultimately, we should be sharing the gospel "*not wishing that any should perish, but that all should reach repentance*" because that's how much God values human life and He desires that we do too -(2nd Peter 3:9).**

Sadly, our culture rejects the idea that all human life has value. The history of racism in the U.S. demonstrates that to many, black lives don't matter. The eugenics movement has advanced the notion that those born with genetic abnormalities don't matter.

The white nationalist movement promotes the idea that immigrant lives don't matter. The pro-abortion movement has legalized a practice which communicates that unborn lives don't matter.

Any movement that promotes the idea that any human being doesn't matter is anti-God, evil, Satanic.

As Christians, we have a responsibility, not only to honor all human life but to seek to protect all human life as we have opportunity. Roe vs. Wade was more than just the abortion issue and is a sad commentary of the cultural descent into devolution. **]]**

I have said it many times in the past but I think it bears repeating once again: If you want to understand why world events happen the way they do, you must understand the goals and influence of globalist institutions. You must accept the fact that these people create most of the national and international disasters you and I have to deal with on a regular basis and oftentimes they create these disasters deliberately.

Yes, I know, there are plenty of skeptics out there that think all geopolitics and crisis events are random or a product of bureaucratic stupidity; and those people are wrong. They have no idea what they're talking about because they're basing this conclusion on assumptions rather than facts and research. Make no mistake, there's a good reason why it feels like the whole world has gone crazy all at once.

The primary purpose of the globalists is to erase national borders and homogenize all countries and cultures under one economic and governmental system. They have openly admitted to this plan on numerous occasions. One of the most revealing quotes

on the agenda comes from Clinton Administration Deputy Secretary of State Strobe Talbot, who stated [in Time magazine](#) that:

“In the next century, nations as we know it will be obsolete; all states will recognize a single, global authority... National sovereignty wasn’t such a great idea after all.”

He adds in the same article a lesser known quote:

“...The free world formed multilateral financial institutions that depend on member states’ willingness to give up a degree of sovereignty. The International Monetary Fund can virtually dictate fiscal policies, even including how much tax a government should levy on its citizens. The General Agreement on Tariffs and Trade regulates how much duty a nation can charge on imports. These organizations can be seen as the protoministries of trade, finance and development for a united world.”

The people who push for this agenda are generally members of a number of globalist organizations, from the Council on Foreign Relations to the Tavistock Institute to the World Economic Forum to the IMF or World Bank, not to mention the Bank for International Settlements and the Council For Inclusive Capitalism. However, these think-tank groups are only part of the bigger picture. They are supported by some of the largest banking and investment corporations in the world, including Goldman Sachs, JP Morgan, HSBC, Vanguard, Blackrock, etc.

If you want to know why mass illegal immigration is a growing crisis at this time and why the current government has been actively trying to enforce an open border police in the U.S., simply look into the financial aspects of pro-illegal immigration lobbying groups and think tanks pushing open borders messaging into the mainstream. You will find many of these banks and investment funds connected to them in one way or another.

For example, [the list of companies](#) backing the Governor of New York’s plan to subsidize illegal aliens entering the state is very revealing. If they’re allowed to continue offering incentives to illegals then those people will continue trying to come to the U.S.; this isn’t complicated. The conspiracy is out in the open.

Admitting To The Agenda, Then Painting It As A Positive

For the first few years of Joe Biden’s presidency, he and his cohorts attempted to deny there was any mass illegal migration problem at all. However, when media coverage (mostly independent) began to expose the enormous caravans of illegals overwhelming border towns like El Paso, Texas, he was forced to acknowledge that the crisis was in fact a crisis.

But, if you thought that forcing Biden to admit to the migrant disaster was going to force him to do something about it, you were sorely mistaken. The reason mass immigration exists right now is exactly because the Biden Administration and globalist institutions are offering free handouts to “asylum seekers.” All they have to do to stop the rising tide of illegals is to stop offering them free stuff. Clearly, the political elites have no intention of doing this.

Instead, government officials, think-tanks and the media have decided that since they're now pressed to admit that mass immigration and open borders are real, they're going to spin the crisis as if it's actually a good thing for America.

In a narrative similar to the one used by EU officials to justify their support of the invasion of Islamic fundamentalists from 2014 onward, American elites claim that western nations are "desperate for a younger population" which can fill the "needs of the labor market." They claim that mass migrations into the west are "good for the economy."

This was also the primary message of a World Economic Forum conference on migration and labor held in March. The globalist organization discussed how open borders and mass immigration could be framed as a "positive" in terms of economic advantages. And the talking points derived from WEF events always find their way into the corporate media. The main takeaway? Protectionism (of national borders) is bad and countries that engage in it will be at an economic disadvantage.

Since last month there's been a hailstorm of establishment media articles and news reports suggesting that mass immigration will boost GDP and make America stronger. These assertions are all built on a single line from a single report from the Congressional Budget Office which states:

"In our projections, the deficit is also smaller than it was last year because economic output is greater, partly as a result of more people working. The labor force in 2033 (EDITOR'S NOTE: Do they mean 2023?) is larger by 5.2 million people, mostly because of higher net immigration. As a result of those changes in the labor force, we estimate that, from 2023 to 2034, GDP will be greater by about \$7 trillion and revenues will be greater by about \$1 trillion than they would have been otherwise. We are continuing to assess the implications of immigration for revenues and spending."

Bloomberg recently published an article boasting that this line from the CBO report shows that the rising fears among Americans over illegal immigration are unfounded. They question why the migrant crisis is a top issue going into the 2024 elections and cite a number of major banking institutions that have adjusted their US fiscal outlook into the positive because of the CBO's data point and higher immigration. Bloomberg quotes the HSBC:

"Immigration is not just a highly charged social and political issue, it is also a big macroeconomic one," Janet Henry, global chief economist at HSBC Holdings Plc, wrote in a note to clients Tuesday. No advanced economy is benefiting from immigration quite like the U.S., and *"the impact of migration has been an important part of the U.S. growth story over the past two years."*

Firstly, let's clarify something in terms of the CBO's theory – The U.S. deficit has fallen in direct correlation to the Federal Reserve raising interest rates. It's more expensive to borrow for everyone, including the government, which makes it more expensive to

spend. Because of far higher interest payments the US is now adding over \$1 Trillion every 100 days to the national debt. That's unprecedented.

Any spending cuts can be directly attributed to higher interest rates, NOT immigration. The CBO mentions this fact very quickly in the same report, without elaborating on why they think immigrants add value. But let's consider the GDP claim for a moment; why would the CBO expect higher immigration to add \$7 trillion to the GDP in the next ten years?

Illegal Immigrants Are A Net Negative – We Don't Need Them

They say it's about more people working, but what about more people taking welfare and other subsidies? Neither the CBO (nor the media) make any distinction between legal migrants and illegal migrants when it comes to economic effects.

Legal migrants usually have careers, business plans, skill sets and their own money coming into the U.S. Most illegals have nothing – Little education, no substantial skill sets, no money and no plan other than to get free handouts wherever possible. We have seen the proof of this in places like New York and Washington, DC, where a tiny percentage of migrants bused into the cities have absolutely crushed their welfare infrastructure.

It's estimated that the net lifetime cost of each illegal immigrant for the American taxpayer is over \$68,000. While some illegals do end up paying taxes, their overall cost is far higher than the amount they pay in.

The jobs market has been inflated by trillions in Federal Reserve stimulus and most of the jobs created are low wage retail and service positions that will disappear in a couple years anyway. The CBO notes in the same report that unemployment is set to increase in 2024, but the media overlooked that little tidbit of information.

Migrants are not needed to keep the labor market going. In fact, as jobs numbers inevitably plummet due to higher interest rates illegals will only add to jobless levels and poverty levels in the US, further dragging the economy down.

Not to mention, the American housing market has suffered an oppressive spike in prices, with home costs and rents in many places doubling. This is caused in part by the millions of migrants entering the country each year looking for housing and getting help from U.S. government programs to secure that housing. Get rid of the illegals and I guarantee rent costs will go down quickly.

Almost all of the projected GDP gain from illegal immigrants comes from their wages which go into their pockets (the same wages they send back to their families in their home countries). There is no direct GDP gain from illegals in terms of benefits to the overall economy. That said, the CBO may also be accounting for another factor which many Americans are unaware of – Government spending being added to GDP.

As I've noted in the past, a large portion of GDP calculated by state governments and the federal government comes from spending. The more the government spends the higher GDP climbs. It doesn't matter if that money was wasted, it is still counted as rising economic activity.

So, if the U.S. is adding 2-3 million illegals per year to the population and the government is spending thousands in tax dollars per year on each illegal through various subsidies, that will amount to billions per year in extra GDP. And the more they allow illegals to enter the country unchecked the more GDP can grow exponentially. Is that good for the economy? No. It's going to destroy the economy and we are already seeing the effects, but the government and the media can spin it to look like it's a positive.

The head of the CBO is a Republican but he's also a former member of the IMF, so it's not surprising he would paint mass immigration as a positive. The globalists want to end national sovereignty and the fastest way to do that is to create open border conditions, kill domestic economies, and erase western culture and then swoop in with a "global solution" after the dust settles. This is the plan; to destabilize the US economic system, not save it. And, illegal immigrants are a useful tool for that end game.

WEF's Net Zero Goals Could Kill 4+ Billion People

The World Economic Forum (WEF) and its fellow unelected globalist leaders are pushing for governments around the world to phase out fossil fuels. Leading experts have spoken out against their plans and are warning the public that the WEF's "Net Zero" goal to eliminate fossil fuels will result in the deaths of over four billion people or more.

The "Net Zero" target to end fossil fuel use is part of the WEF and UN's "Agenda 2030" and "Agenda 2050" plans for humanity and involves dramatically reducing fossil reliance by 2030 and completely eliminating their use by 2050.

The WEF continues to push its agenda and has been calling for taxpayers worldwide to pay \$3.5 trillion per year, which they insist is necessary to fund the noble global power in order to meet the globalist organization's "Net Zero" goal of "decarbonizing" the planet.

However, critics argue that "decarbonization" is just a euphemism for the WEF's [anti-human agenda](#) and experts are raising the alarm about what this will actually mean for civilization, which includes the death of over four billion people.

Starvation

Danish statistician Bjørn Lomborg is just one who has warned that ending fossil fuel use will lead to the deaths of around half of the world's population through starvation alone.

“4 billion people are dependent on fossil fertilizer for food,” Lomborg notes. “Without, 4 billion will starve to death. “It is time to call out the astoundingly destructive & misanthropic campaigners,” he declared.

The article Lomborg was responding to was by British economist Neil Record in the Telegraph, who argued that the number of people that might die was closer to six billion.

Six Billion Would Die in a Year.

Neil Record reported: *“If we literally just stopped using fossil fuels and “did without the natural resources on which the world, its economies and populations depend, most likely six billion people would die within a year.”*

Breaking down what would happen in a world without fossil fuels, Record notes that most people would suffer blackouts due to the grid being so seriously compromised, possibly fatally, and they may be widespread and permanent.

From day one, gas users would be the first to feel the change of no more mining of coal; the world’s [oil wells shut down](#); the world’s gas fields likewise, and in 10 or 15 days, the UK would have to turn off its gas distribution system as it would be unable to maintain pressure.

In turn, the domestic supply would be shut down too – gas would stop flowing, and some 21 million households (74% of the population) would no longer have heating, hot water, and cooking facilities.

“In their panic, people might turn to electricity for their cooking and heating, but wait...” says Record, who adds, *“The [UK electricity grid relies on natural gas as its “buffer”](#) energy source. Every day, demand varies according to consumer demand, and the other main energy supplier, renewables, are highly variable and can only power the grid when gas is picking up the lion’s share of the gap between their output and consumer demand.”*

So the moment that the main gas distribution system is de-pressurized, the grid-balancing system fails and power cuts ensue.

Electricity demand would have rocketed through the switch to electric space heating, cooking and water-heating, and so it seems very likely that the sudden excess demand would be undeliverable, and therefore that the grid would spiral into uncontrollability resulting in no electricity. This also means there would be no communication systems no mobile phones and no television.

Without power, there will be no running water and no heating and the most vulnerable people will start to die, according to Record. Initially, this will be the elderly in their own homes, then in hospitals when the diesel backup generators run out of fuel. Within the first 25 days new “existential problems emerge for ordinary people in the form of food availability and distribution.” [Source](#)

Starvation Begins From Day 25

Day 25 – By the twenty-fifth day, diesel and petrol are likely to have run dry, although, Record says that he is probably being generous with the timing here, but what this will mean is that food distribution would fail, and so as most of the population are entirely dependent on bought food they will begin to starve.

Interestingly, it will be only the isolated rural communities, and those who are agriculturally self-sufficient would be relatively unaffected.

Day 50 – Many people in urban areas would now be near death from starvation, Record claims, and “law and order would have broken down” and due to the “increasingly desperate search for the means of survival” he suspects there will have been “mass conflict and slaughter taking place.

Without the sanitary conditions that we have due to power, water supply, and sewage flow, we will see a return of Victorian diseases such as cholera and dysentery.

Day 100 – money and status will be irrelevant as time passes and just three months after the world stops oil, Neil Record, guesses that around half of the world’s population of approximately four billion, people would be dead “The first to die would be the urban poor; then the middle and upper classes”

Again, the survivors would be those in rural areas and able to live off local agricultural produce or live off dwindling food stocks.

For fifty-five percent of people in urban areas, it will be almost impossible to access food and safe water as there will be none of the normal distribution routes for food or storage facilities (chillers/freezers) without electricity, and without pumped water, clean water would be unavailable, or close to impossible to access. A Year Without Oil – Murder and Mayhem.

Day 365 – after a year without oil Record says *“perhaps a further two billion people would have starved or frozen to death, leaving, say, two billion left alive remaining food stocks would have been exhausted or spoiled, and the inevitable breakdown of law and order would have meant many would meet a violent end.”*

“Competition for scarce resources, so elegantly solved by the invention of markets and prices, would be replaced by murder and mayhem”

"To conserve his health in view of the vigil tomorrow and Mass on Easter Sunday, Pope Francis will follow the Via Crucis at the Colosseum this evening from the Casa Santa Marta," a statement from the Vatican press office said, according to [the AP](#).

He recently also skipped delivering the traditional homily on Palm Sunday to kick off the Catholic faith's Holy Week last Sunday. However, Francis presided over the service, speaking before and after the scheduled homily in a clear voice, [The New York Times](#) reported.

Francis was hospitalized in late February for the flu. For more than a year, he had been using a wheelchair and a walker because of [strained ligaments](#) in his knee.

The pontiff had surgery for intestinal blockage in June 2023. That came two years after Francis had 13 inches of his colon removed because of a narrowing of his large intestine.

He was hospitalized for five days at Rome's Gemelli Hospital in late March 2023 with a [lung infection](#). Francis had part of [one lung removed](#) when he was younger.

He was elected the 266th pope in history on March 13, 2013, after the surprising resignation of Pope Benedict XVI two weeks earlier.

Michigan Is Offering \$500 In Rent Aid A Month To House Illegal 'Newcomers'

The Michigan State Housing Development Authority rolled out a program last [year] that offers resettlement support to refugees and other immigrants.

[The Newcomer Rental Subsidy](#) provides refugees, asylees and immigrants from areas like Ukraine, Cuba, Haiti and African countries about \$300 to \$500 a month in rental subsidies. Assistance is available for up to 12 months.

The Newcomer Rental Subsidy program provides Refugees and other Newcomer population-eligible households with rental assistance up to \$500 per month for up to 12 months, with eligibility based on immigration status and household income.

Many refugees and other newcomers face critical housing challenges, and this program will increase access to better and more affordable housing opportunities while supporting a more rapid social integration to refugees and other newcomer populations to Michigan.

Amy Hovey, executive director of the Michigan State Housing Development Authority, said the program aligns with a goal to increase affordable housing across the state for everyone *“including those seeking to build a new life here.”*

This program is truly a win-win, as it addresses the most pressing barrier to refugee resettlement by meeting housing needs while setting up families for success with increased employment and opportunity.

Hovey said in a statement.

The two-year program is being funded by the Michigan Housing and Community Development Fund with \$4 million designated to the Office of Global Michigan.

Households need to apply for rental aid and eligibility and will be evaluated periodically, a news release said. Eligible recipients must be enrolled in an Office of Global Michigan-funded or similar employment program. They will also receive financial and budget education.

The United States resettled 24,645 refugees in the last fiscal year – falling below a 125,000 cap – [according to the Refugee Council USA](#). Michigan was ranked No. 4 for welcoming 713 refugees behind California, Texas and New York.

Most refugees arrived from the Democratic Republic of Congo, Syria, Sudan, Burma and Ukraine.

NTSB Releases Data on DALI's Black Box, Reveals No CCTV Footage Found, Sensors Cut Off and Turned Backed On, Voice Recorder Disrupted By Background Noise.

As [The Gateway Pundit](#) reported earlier the National Transportation Safety Board (NTSB) Chair Jennifer Homendy announced the voyage data recorder known as the 'black box' was recovered from the DALI cargo ship that crashed into the Francis Scott Key bridge early Tuesday morning.

On Tuesday evening, Homendy and NTSB investigator Marcel Muise held a press conference to reveal the data on the DALI's black box, also known as the Voyage Data Recorder (VDR).

NTSB investigator Marcel Muise revealed there were about six hours of VDR on data and included a timeline of midnight to 6 am.

Before revealing the data on the VDR, Muise warned that the quality of the voice recording and radio data was hard to comprehend due to background noise.

[Muise](#) then shared that the *“VDR sensor data ceased recording. The VDR audio continued to record using the redundant power source.”*

“VDR resumed recording sensor data, and during this time, steering commands and rutter orders were recorded on the audio,” added [Muise](#).

Muise continued, *“The ship’s pilot made a very high-frequency radio call for tugs in the vicinity to assist. About this time, the pilot dispatcher phoned the Maryland Transportation Authority duty officer regarding the blackout.”*

He concluded his statement by adding that *“The ship’s speed over ground was recorded at just under 7 knots. From this moment to approximately 1:29:33, the VDR audio recorded sounds consistent with the collision of the bridge.”*

Before the content on the black box was revealed, Homendy noted a group of operations and engineering groups boarded the DALI to do a walk-through of the ship’s bridge and engine room to find any electronic recorders, cameras, or CCTV footage but could not find any.

Per [The Washington Post](#):

The alarms first sounded on the Dali around 1:24 a.m. Tuesday, an NTSB official said in a Wednesday evening news conference, citing preliminary information from the container ship’s voice data recorder.

About a minute and a half later, the ship’s pilot used a high-frequency radio to request assistance, helping to alert the on-duty Maryland Transportation Authority officer. The pilot called for *“tugs in the vicinity,”* which help vessels leave the port and get into its main channel. Before the Dali hit the bridge, it had no tugs. Thirty seconds later, the pilot ordered the ship’s anchor to be dropped and gave *“additional steering commands,”* said Marcel Muise, the lead investigator.

At 1:27 a.m., the pilot reported that the Dali had lost all power and was approaching the bridge, Muise said. At the time, there were two Maryland Transportation Authority units at the scene because of the ongoing construction, and those units shut down all lanes of traffic on the bridge, according to Muise. He said the voice data recorder captured *“sounds consistent with the collision”* at 1:29 a.m. Around this time, the lights on the Key Bridge also went out.]]

Western mainstream media, which normally blame Russia for nearly everything, immediately shot down the too-obvious possibility of a Russian cyber-attack on the ship and bridge. Such an attack might seem to be a natural act of retaliation for the Crocus Hall massacre—and the many other U.S.-sponsored attacks inside Russia that [Scott Ritter](#) says have brought us to the edge of nuclear World War III.

While online influencers like Andrew Tate and Alex Jones raised the obvious questions, MSM pushed back with articles like “[Baltimore bridge collapse sparks baseless attack theories.](#)”

Even American Main Stream Media, whose primary job is to run interference for Israeli genocide, couldn't ignore the voices on social media fingering Israel as a likely suspect in the bridge collapse:

...some accounts are linking the tragedy to the United States' abstention in a UN Security Council vote calling for an immediate ceasefire in the Gaza war.

“Did Israel just hit the U.S. over not using the Veto power yesterday??” one account said in a post with thousands of interactions.

The MSM attack on “*conspiracy theories*” around the Baltimore bridge collapse echoes earlier attacks on Putin’s “*conspiracy theories*” blaming Ukraine and the U.S. for the Moscow attack. Just as the MSM tells us that the JFK coup was merely a random shooting by a deranged commie who got lucky, and the 9/11 coup was accomplished by incompetent coke-snorting stripper-loving jihadi hijackers who got even luckier, they are now telling us that the Crocus Hall massacre was done by random angry Muslim amateurs who were randomly offered \$10,000 on Telegram to shoot up a concert hall.

As neocon liar Stephens knows, there are far more than two “*plausible hypotheses*” about the Moscow and Baltimore attacks. The most plausible, and most obvious, hypothesis about the Crocus Hall massacre is that it, like almost everything attributed to “ISIS”, was a US-NATO-(neocon-Zionist) operation, as [Vladimir Putin](#) has opined and [Pepe Escobar](#) fleshed out in greater detail. If that is the case, then the destruction of the Baltimore Bridge—an important bit of American infrastructure whose loss will take a top-ten port out of operation indefinitely and gum up supply chains—looks, at first glance, suspiciously like retaliation.

But what about the other “retaliation” scenario: Israel, or rather Netanyahu’s faction, retaliating against the U.S. for refusing to veto Monday’s UN Security Council ceasefire resolution? By gumming up supply chains and harming the U.S. economy, Bibi would be punishing Biden politically and enhancing Trump’s chances in the November elections. He might also be sending a message heralding bigger and worse things to come if Biden continues to obstruct his plans to complete the genocide of Gaza and help people like Jared Kushner [make a literal killing in real estate](#).

Alongside the Israel-did-Baltimore theory, we might throw in the parallel Israel-did-Moscow theory. This one is a bit more complex: The Israelis would have designed the operation to be blamed on ISIS-Ukraine-NATO with an eye to ramping up US-Russia tensions to distract from Gaza and derail the recent U.S. move toward joining the world consensus by forcing Israel to withdraw. Under this scenario, Israel might have followed its attempt to make Russia believe it had been attacked by the US (Moscow) with an attempt to make the U.S. believe it had been attacked by Russia (Baltimore). By pushing the nuclear superpowers to the edge of a nuclear World War III, and possibly over the edge, Bibi’s faction might hope to create so much chaos that “*finishing the job in Gaza*” would look like small potatoes compared to events elsewhere. Bibi might figure that if the U.S. is desperately flailing to stop nuclear war, or involved in one and trying to keep it limited, “Biden” won’t be in any position to invest energy and political capital in saving the Gazans and removing Bibi from power.

This all may sound outlandish to the uninitiated. But there is ample historical precedent for Israel and its American agents whipping up U.S.-vs.-Russia tensions, and repeatedly bringing the two nuclear superpowers to the verge of World War III, in order to distract from, and enable, the Zionist genocide of Palestine. According to Guyénot, Israel [orchestrated the assassination of John F. Kennedy](#) in order to save its nuclear program and install its man, Lyndon Johnson, in the White House. The key plotter, CIA counterintelligence chief and de facto Mossad mole James Jesus Angleton, had an imposter posing as Lee Harvey Oswald appear to visit the KGB’s assassinations chief at the Russian Embassy in Mexico City shortly before the assassination. That allowed Lyndon Johnson, Allan Dulles, and other pro-assassination figures to persuade the non-complicit, including Chief Justice Earl Warren, that “*if the truth comes out, it will be World War III.*”

Guyénot argues that Israel opposed JFK’s moves to end the Cold War because it needed the distraction of U.S.-vs.-Russia and U.S.-vs.-Vietnam in order to get away with its 1967 war of aggression and subsequent land grab. Additionally, Russia had become a supporter of Arab causes including Palestine, so leading Jews suddenly abandoned Communism in favor of rabidly anti-Communist, ultra-Zionist neo-conservatism.

After brandishing the specter of nuclear war to shut down any real investigation of the JFK assassination in 1963, Israel brought the U.S. to within minutes of World War III in 1967 with [its false flag attack against the USS Liberty spy ship](#). That attack, orchestrated with the complicity of then-president Johnson, was designed to be blamed on Egypt in order to bring the U.S. into the war. According to Peter Hounem's *Operation Cyanide*, nuclear-armed U.S. bombers targeting Russian bases in Egypt were just a few minutes from no-recall range when the attack was called off due to the Liberty's stubborn refusal to sink.

Guyénot's suggestion that the whole Cold War was basically an Israeli-orchestrated distraction from the slow-motion genocide of Palestine may be an exaggeration. But he provides enough evidence to convince reasonable readers that the Israelis are not above stoking U.S.-Russia conflict, right up to the edge of nuclear World War III, in pursuit of their Greater Israel project. It would, therefore, not be surprising if Israel were deliberately orchestrating or exacerbating the U.S. war on Russia through Ukraine for its own advantage. Nor would it be surprising if Netanyahu's faction, facing imminent demise in the form of a U.S. order to stop or at least slow the genocide, might seek to ramp up U.S.-Russia tension by orchestrating the recent disasters in Moscow and/or Baltimore.

King Charles confirms attendance at Easter Sunday service after missing Maundy Thursday

King Charles of the United Kingdom will join the Easter service at Windsor Castle, marking a significant return to public engagements after announcing cancer treatment in February.

This year's Easter celebration for the royal family will be notably subdued, with several members, including the prince and princess of Wales, opting for private observances.

Buckingham Palace confirmed the king's participation in the Easter service, according to [The Times](#). This follows his absence from the Maundy Thursday event, reflecting a cautious approach to public appearances during his health recovery.

King Charles will attend the traditional Easter service at St. George's Chapel, Windsor Castle, alongside Queen Camilla and other royal family members. The decision follows his recent health challenges, including a [cancer diagnosis](#) and treatment for an enlarged prostate.

Buckingham Palace sources told *'The Times'* that weather conditions permitting, King Charles plans to arrive on foot. The royal family's Easter celebrations are set to be more restrained this year, with the Prince and Princess of Wales William and Catherine absent, choosing to focus on family time as she undergoes [chemotherapy treatment](#).

King Charles missed an appearance at a memorial service for King Constantine II at St. George's Chapel last month.

Despite these challenges, King Charles has maintained a visible presence through video messages and limited public appearances, such as his [recent engagement](#) with community and faith leaders at Buckingham Palace. He has made efforts to continue official duties, albeit in a modified capacity.

The contrast between this year's Easter observance and the previous year's vibrant celebrations is stark.

Last year, the royal family presented a united front, with a procession led by King Charles and Queen Camilla.

King Charles expressed regret over missing the Maundy Thursday service at Worcester Cathedral, a traditional royal engagement, the BBC [reported](#).

In his absence, Queen Camilla participated, distributing Maundy money to community-serving individuals, aligning with the king's message of service and community support.

The Maundy service symbolizes the monarch's role in serving and supporting the community, a sentiment echoed in King Charles's recorded message for the event.

The king reiterated his coronation pledge *"not to be served, but to serve"* with *"my whole heart."*

"It is for me a great sadness that I cannot be with you today," he said.

[[My thoughts on the reports by Hal Turner and the Christian Post is that our operative words are "discernment" and "deception". Tim Cohen's long delay of the 2nd edition of 'The AntiChrist and a Cup of Tea' will likely result in further delay in publication. from those hotspots; and a conquering antiChrist spirituality offering more lies and false hopes?" Tim answers these and other challenging and timely questions.

Is Jesus' return now just years away? Could the Church today discern the actual year, month and week of Jesus' return, but neither the day nor hour? Have God's saints been duped into thinking otherwise (i.e., wrong thinking), so that the Church itself has become "*dull of hearing*" and hardened to genuine scriptural truth — somehow taking Jesus' own simple words to mean something entirely opposite to what He intended to communicate? Would such error be due to the false prophets and mistaken teachers of whom Jesus likewise forewarned? Indeed, Jesus said no man would know the "*day or hour*" of His return (i.e., the Second Advent), but He did not say — nor does scripture anywhere — that no man would know the "year," "month," or "week;" in that omission, Jesus left open the possibility. Given that the foretold AntiChrist is now revealed to the saints, in this book and its first edition, should we be at all surprised to find that the world is, in fact, only years away from Jesus' return and Armageddon — or, for that matter, that a clearer timeline may now be possible?

Tim Cohen does not believe in the Rapture of the Church and so we are faced with the dilemma now that HRH Charles has both prostrate and pancreas cancer and has said he has two years to live. Victims of Pancreatic cancer rarely live more than six months and so the reporting raises questions pertaining to his diagnosis.

I sent the following reply to a brother in Christ friend of mine in Houston in regards to what I thought about the Hal Turner report:

These possibilities justify my saying that our operative words are “discernment” and “deception.” It was Arnold Fruchtenbaum who two decades ago in an article on Dr. David Reagan’s magazine ‘*Christ in Prophecy*’ in a survey on this question: “*There is a mysterious passage in Revelation 13 that implies the Antichrist might be killed and resurrected from the dead in the middle of the Tribulation. Is this what the passage means, or does it mean something else? Will the Antichrist be killed and resurrected from the dead?*”

Arnold Fruchtenbaum, a Messianic Jew and scholar, answered the question with this answer:

*“I would have to say, yes, because the very same term used of the Antichrist (Revelation 13:1-2) is also used of the true son (Revelation 5:6) as though he had been slain. In the case of Jesus, He didn’t appear to be dead. He really did die. Under normal experience He should have remained dead. And so, He was alive because of resurrection. And the phrase **“though he had been slain”** is the Greek idiom for resurrected individual, was used of the true son in chapter 5 and is used of the counterfeit son in chapter 13. You have to understand the same way. He will be killed in this war against the 10 kings. He will be raised back to life by Satan’s power. He will continue the war, kill 3 kings, then several will submit to his authority. And, therefore, he will undergo as part of the counterfeit program a counterfeit death and resurrection.”*

In reading Revelation 13:1, 3, it does not say how he will be killed, only that he will be killed. We should not attempt to read into the text our own inferences as to how he dies.

It seems God will permit Satan to give the appearance of duplicating the Resurrection. One of the heads of the beast seemed to be mortally wounded. But its mortal wound was healed. Then the whole world was full of wonder, indicating they venerated or even worshiped the beast.
