

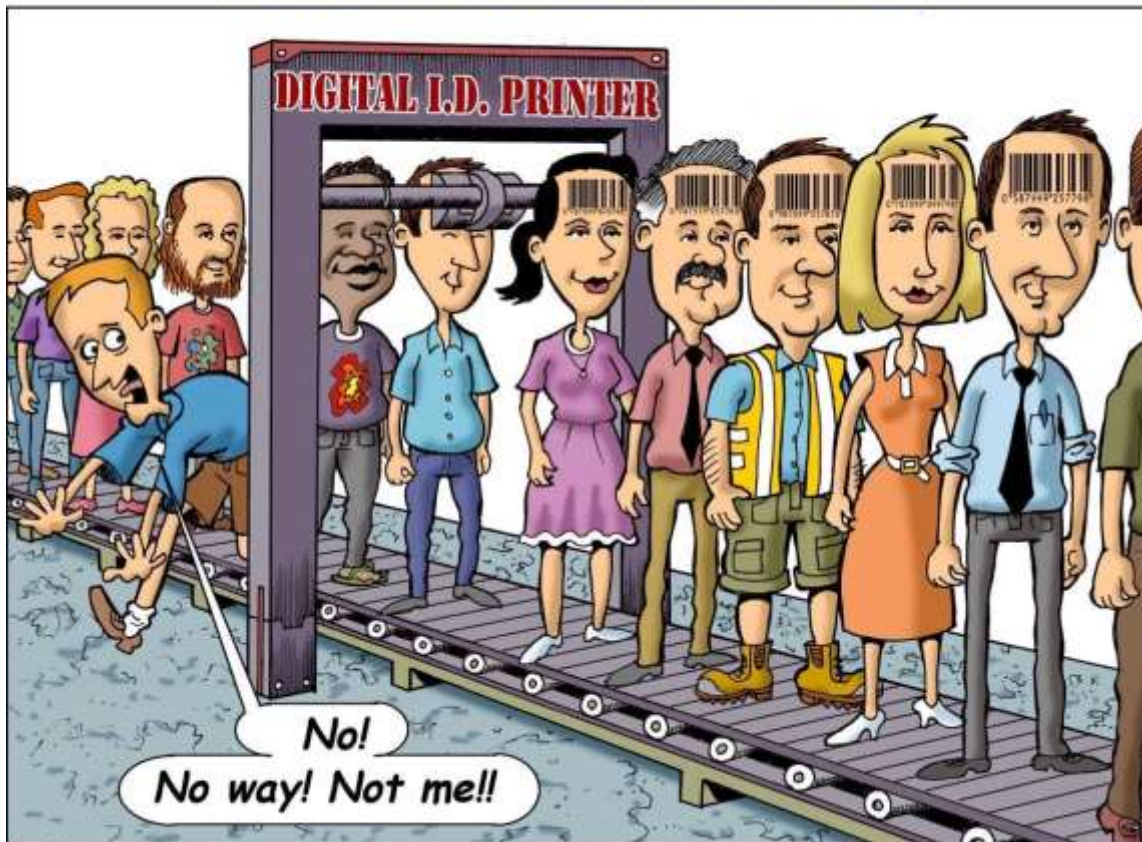

The above link is to a patent filed by the Microsoft Corporation on June 20, 2019.

The abstract reads as follows;

"(EN)

*Human body activity associated with a task provided to a user may be used in a mining process of a cryptocurrency system. A server may provide a task to a device of a user which is communicatively coupled to the server. A sensor communicatively coupled to or comprised in the device of the user may sense body activity of the user. Body activity data may be generated based on the sensed body activity of the user. The cryptocurrency system communicatively coupled to the device of the user may verify if the body activity data satisfies one or more conditions set by the cryptocurrency system, and award cryptocurrency to the user whose body activity data is verified."*

Sounds relatively benign and rather convenient right? Especially if you're a crypto lover, this concept may even excite you and present a unique opportunity to engage with the crypto space. But take a look again at what the abstract says; *"The cryptocurrency system communicatively coupled to the device of the user may VERIFY if the body activity data SATISFIES one or more CONDITIONS SET BY THE CRYPTOCURRENCY SYSTEM and award cryptocurrency to the user whose body activity data is VERIFIED"*. Read that carefully and ask yourself WHO WOULD BE SETTING THE CONDITIONS FOR THE SYSTEM?

To make sure that you've had all of your required doses of government mandated vaccines, scientists at MIT have created a new ink which can be embedded in the skin which can be read using a special infra-red smart phone camera app.

Futurism reports...

*“The invisible “tattoo” accompanying the vaccine is a pattern made up of minuscule quantum dots — tiny semiconducting crystals that reflect light — that glows under infrared light. The pattern — and vaccine — gets delivered into the skin using hi-tech dissolvable microneedles made of a mixture of polymers and sugar.”*

The research group’s findings were published this week in the journal ‘Science Translational Medicine’.

*“In other words, they’ve found a covert way to embed the record of a vaccination directly in a patient’s skin rather than documenting it electronically or on paper — and their low-risk tracking system could greatly simplify the process of maintaining accurate vaccine records, especially on a larger scale.”*

*“In areas where paper vaccination cards are often lost or do not exist at all, and electronic databases are unheard of, this technology could enable the rapid and anonymous detection of patient vaccination history to ensure that every child is vaccinated,”* said MIT researcher Kevin McHugh.

More interesting though is how useful this new technology will be from a corporate point of view, downstream tech such as this will make production and distribution more efficient upstream, and as vaccine manufactures can more efficiently identify who needs which product.

Essentially, this is new tech which can allow public administrators, law enforcement and corporate employers, to check within seconds to make sure that you are “safe” to be around,” and do not pose ‘a danger to the rest of the community.’

Interestingly, the funding for this new vaccine tattoo technology has come from the Bill and Melinda Gates Foundation funded the team’s research.

*“According to a ‘Scientific American’ story, the project came about following a direct request from Microsoft founder Bill Gates himself, who has been personally involved in efforts to eradicate polio and measles through vaccinations.”*

*“Accurate medical recordkeeping is a major challenge in many low-resource settings where well-maintained centralized databases do not exist, contributing to 1.5 million vaccine-preventable deaths annually. Here, we present an approach to encode medical history on a patient using the spatial distribution of biocompatible, near-infrared quantum dots (NIR QDs) in the dermis. QDs are invisible to the naked eye yet detectable when exposed to NIR light. QDs with a copper indium selenide core and aluminum-doped zinc sulfide shell were tuned to emit in the NIR spectrum by controlling stoichiometry and shelling time. The formulation showing the greatest resistance to*

*photobleaching after simulated sunlight exposure (5-year equivalence) through pigmented human skin was encapsulated in microparticles for use in vivo. In parallel, microneedle geometry was optimized in silico and validated ex vivo using porcine and synthetic human skin. QD-containing microparticles were then embedded in dissolvable microneedles and administered to rats with or without a vaccine. Longitudinal in vivo imaging using a smartphone adapted to detect NIR light demonstrated that microneedle-delivered QD patterns remained bright and could be accurately identified using a machine learning algorithm 9 months after application. In addition, codelivery with inactivated poliovirus vaccine produced neutralizing antibody titers above the threshold considered protective. These findings suggest that intradermal QDs can be used to reliably encode information and can be delivered with a vaccine, which may be particularly valuable in the developing world and open up new avenues for decentralized data storage and biosensing."*

What does a body-based cryptocurrency system and vaccine tattoos have to do with one another? Consider that Bill Gates has funded both concepts, and is also considered to a "vaccine expert" and has investments with almost every major vaccine manufacturer. *"Topline: A week after stepping down from the boards of Microsoft and Berkshire Hathaway, Bill Gates, cofounder of Microsoft and the second-richest person in the world with a net worth \$97.8 billion, took to reddit for an Ask Me Anything on the Covid-19 coronavirus pandemic, sharing his thoughts on how best to deal with the outbreak and its possible long-term effects on the world."*

*A TED Talk by Gates from 2015 recently emerged called "The Next Outbreak? We're Not Ready," given during the Ebola epidemic, but as the White House administration faces criticism for not reacting quick enough, Gates reiterated that, "We did know it would happen at some point, either with a flu or some other respiratory virus...There was almost no funding."*

Following the eventual end of the pandemic, Gates hopes that countries can work together to better prepare for similar situations, including the *"need to have the ability to scale up diagnostics, drugs and vaccines very rapidly...the technologies exist to do this well if the right investments are made"*; the \$100 million his and his wife Melinda's Gates Foundation donated to fight the coronavirus is focused on those three areas.

Dr. Anthony Fauci, the director of the National Institute of Allergy and Infectious Diseases, this week said that mass production of a vaccine would likely not occur for another 12-18 months, and Gates concurred, saying that lots of manufacturing will need to be built to provide *"billions of vaccines to protect the world"* and that the first vaccines, which would *"go to healthcare workers and critical workers...could happen before 18 months if everything goes well, but we and Fauci and others are being careful not to promise this when we are not sure."*

*A recent study released by Imperial College in the UK stated that even with mitigation, the U.S. could see around 1 million deaths from the coronavirus, but Gates cautioned that "the parameters used in that model were too negative," pointing to China as "the most critical data we have" and that its social distancing approach was "able to reduce the number of cases."*

Responding to a question on the Netherlands' *"controlled distribution"* strategy, Gates countered saying *"The only model that is known to work is a serious social distancing effort ('shut down'),"* estimating that *"If a country does a good job with testing and 'shut down' then within 6-10 weeks they should see very few cases and be able to open back up"*; however, he also admitted that *"The U.S is still not organized on testing."*

Gates called for a *"national tracking system"* similar to South Korea, saying that *"in Seattle, the [University of Washington] is providing thousands of tests per day but no one is connected to a national tracking system"* and that *"Whenever there is a positive test it should be seen to understand where the disease is and whether we need to strengthen the social distancing."*

*All of this points towards this "man" creating an infrastructure for a global vaccine tracking system. And when you don't take the vaccines he produces and profits from? You will be labeled a "public health threat". You will be stripped of your right to earn the government approved currency. Bill Gates, the billionaire chairman of [Microsoft](#), received an honorary knighthood March 2, 2005 for his charitable work and his achievement in creating the world's most successful software company.

Mr. Gates and his wife, Melinda, met the Queen and the Duke of Edinburgh at Buckingham Palace for the ceremony. Despite receiving the KBE, or Knight Commander of the Order of the British Empire, Mr. Gates will not be known as 'Sir', a title reserved for British citizens.

Through the Bill and Melinda Gates Foundation, the couple has given away billions of dollars, most being spent on programs to improve health in developing countries.

Malaria and Aids have been a particular focus, as have childhood diseases. Recently the foundation donated \$750 million to the Global Alliance for Vaccines and Immunization, (GAVI) which Mr. Gates was instrumental in setting up.

Honorary knighthoods are awarded by the Queen, on the advice of the Foreign Office, to those who have made an important contribution to British interests. Microsoft directly employs almost 2,000 people in the UK, including 80 researchers at the Microsoft Research Cambridge, the company's first research laboratory outside the United States, which was set up in 1997.

Before his private audience with the Queen, Mr. Gates met Prince Philip, who was at the time, chancellor of Cambridge University, and spoke about the facility.

You may not realize it, but we are still subjects of the British Monarchy. American history books and classes indoctrinated (propaganda) us into believing we had won the American Revolution. But we didn't. We are still subjects of Queen Elizabeth (now King Charles).

The history books were written by the victors and their big publishing houses. And it was much easier to control the new colonies by letting them think they had won their independence, while the British Crown carefully laid their tentacles throughout America, tentacles that grew longer and stronger with every passing year.

We aren't the America we think we are. That's the big red pill. Most of us on planet Earth are still under the Queen's rule until her death. HRH Charles holds the "Golden Share" since his mother's death.

The wealth of the Monarchies is held outside of the countries that made the wealth. The British Crown's offshore banks hold the greatest personal wealth in the world estimated at \$35 trillion. Perhaps the British Crown still owns and controls its Commonwealth Nations, including the American "colonies."

The Commonwealth of Nations, previously headed by Queen Elizabeth II, is made up of 53 nations, spanning the globe, accounting for one-fifth of the land mass of the Earth, and a very high percentage of its strategic resources and population. The Queen was a Knight of Malta and has vowed allegiance to the Pope through the largest insider trading club on the planet. The British Crown Agents are, in fact, also agents of the Vatican's Knights of Malta. Donald J. Trump is a British Crown Agent. #### THE QUEEN WAS A KNIGHT OF MALTA

The Sovereign Military Order of Malta (SMOM) took control of the power and wealth of the Poor Fellow-Soldiers of Christ and of the Temple of Solomon from within the Roman system. The SMOM controlled the banking and military power for the Vatican for hundreds of years through the first central bank, the Vatican Bank.

The Roman Catholic priestly order of the Jesuits (Society of Jesus) subordinated the SMOM in 1798 aided by Napoleon Bonaparte. This would eventually lead to the Jesuits installing British control over the Island Malta and the founding of a Jesuit College manned by British Jesuits. The Jesuits became somewhat crippled by this suppression in Catholic controlled Europe, so in order for the Jesuits to secure South American wealth they used Protestant banking houses and formed an alliance with the Venetian influences over Britain like the Pallavicini family who control the Monarchy and Rothschild's.

The Jesuits in 1840 put the Haus Sachsen-Coburg und Gotha bloodline into the position of Monarchy of Great Britain. This house is known today as the Windsor House which still rules the UK and the Commonwealth Nations. The same fate would eventually happen to the Vatican itself after suppressing the Jesuits in 1773. The Jesuit Order took control of the Papacy by 1814 and had enacted revenge once again for their persecution.

The Order of Malta and the recognized protestant divisions all play a role commanded by the Jesuit Order. This includes The Most Venerable Order of the Hospital of Saint John of Jerusalem controlled by Queen Elizabeth II. If you look at the last Grandmasters of the Order of Malta you will notice they came from Britain. Former-Grandmaster Andrew Willoughby Ninian Bertie was a cousin to Queen Elizabeth II originated within the Grand Priory of England. The British arm of the Order of Malta controlling St John's Wood is known as the Grand Priory of England. This location was once also a Knights Templar headquarters in Britain. The Order of Malta even owned Londinium (TheCityofLondon). TheCityofLondon was eventually rented out by the Order of Malta as their headquarters. The Jesuits took over Londinium in 1825 aided by the Rothschild family who had become the most powerful economic force in England.

WHEN YOU TAKE A LOOK AT MANY OF THE INFLUENTIAL POSITIONS OF POWER TODAY, WHETHER IT IS IN BANKING, MILITARY, PHARMACEUTICAL OR INTELLIGENCE, YOU WILL ALWAYS FIND KNIGHTS OF MALTA.

The Knights of Malta are mainly involved in working for and with the Black Nobility (royalty without an active throne), the Vatican, and the various Papal and Royal Orders, especially the Jesuits who are ultimately in control of the Vatican and the Military Order of Malta. The SMOM's most powerful controlling inner-cores are the Order of the Garter and the Pilgrim Society which are controlled by the Queen; now by her son, HRH Charles.

When you look at who controls the financial world you will find it is the Equestrian Order of the Holy Sepulcher of Jerusalem, Order of Malta and Opus Dei through the City of London Corporation and The Worshipful Company of Mercers and the more recent The Worshipful Company of International Bankers.

THE QUEEN'S OFFSHORE KINGDOM



*“ONE THIRD OF ALL WORLD WEALTH IS HELD OFFSHORE, AND ABOUT HALF OF ALL WORLD TRADE FLOWS THROUGH THOSE TAX HAVENS.” – THE TAX JUSTICE NETWORK*

James S. Henry, former chief economist at McKinsey & Company, estimates that wealthy individuals have approximately \$35 trillion in private financial wealth tucked away in offshore havens with \$6.1 trillion in UK dependent states.

As a result of this offshore accounting, it is estimated that 60% of global trade now consists of internal transactions within multinational companies. In total, it is estimated that this complex corporate offshore accounting multinational corporations avoid paying about \$240 billion per year in taxes

The City of London UK is now the money laundering capital of the world with UK firms aiding corrupt officials and criminals from across the globe to hide trillions of U.S. dollars of ill-gotten gains. British-based banks have helped hide more than \$6 trillion in nefarious payments and criminal proceeds since 2000.

The Cayman Islands benefit from the added support of being a territory of the United Kingdom. The Caymans offer a number of tax-free incentives and little financial regulation and oversight. Today the country is the world's fifth largest financial services center. It plays host to over 10,000 mutual funds, over 200 banks, over 90,000 companies, and 140 trust companies. It's the world's top home for hedge funds and captive health insurance companies.

Bermuda is another piece of UK territory that has long been known as a tax haven. Bermuda's tax system puts taxes on staff payrolls, but not on corporate earnings or investment income. Its largest customer for offshore transactions is the United States.

Guernsey belongs to the British Crown but makes its own laws on matters such as taxation. The island of 65,000 people has made a big push towards being an offshore finance destination, and its main street is lined with private banks, law firms, and accounting firms.

Jersey is another small British Crown dependency in the English Channel. Jersey prints its own banknotes and makes its own tax laws. A culture of secrecy and non-disclosure in the island has resulted in Jersey housing an estimated \$5 billion dollars of wealth per square mile. Half of Jersey's tax avoidance trade comes from the UK.

#### THE “BRITISH” U. S. FEDERAL RESERVE

Using the first major corporation in England as their model, the British East India Company, warlord bankers start wars for profit. Slavery and the looting of mines, gold, diamonds, minerals, and land are all in a day's work for an imperialist. England's imperialism has worked into the economic and banking practices worldwide and the Queen's Crown Agents and Agencies have controlled global resources for centuries.

There is a linear connection between the Rothschild's, the Bank of England, and the London banking houses which ultimately links the stockholders of the Federal Reserve Banks to their subsidiary firms in New York and TheCityofLondonUK. The two principal Rothschild representatives in New York, J. P. Morgan Co., and Kuhn, Loeb & Co. were the firms which set up the Jekyll Island Conference at which the Federal Reserve Act was created and directed the subsequent successful campaign to have the plan enacted into law by Congress, and who purchased the controlling amounts of stock in the Federal Reserve Bank of New York in 1914.

These firms had their principal officers appointed to the Federal Reserve Board of Governors and the Federal Advisory Council in 1914. In 1914, a few families (blood or business related) owning controlling stock in existing banks caused those banks to purchase controlling shares in the Federal Reserve regional banks. Examination of the charts and text in the House Banking Committee Staff Report of August, 1976 and the current stockholders list of the twelve regional Federal Reserve Banks show this same family control.

To shorten this very long history, the term "Golden Share" was developed to describe special rights given to the Queen in a stock company that gave her special preferential rights over voting and profit distribution—and thus ultimate control—like she had before. HRH King Charles receives a percentage of every corporate transaction conducted around the world. Think 51% when the term "Golden Share" is mentioned.

The Queen's Pirbright Institute PATENTED the "CORONAVIRUS" on Nov. 20, 2018

The British government believed there was a good rationale behind using a golden share-strategy with its newly privatized companies. Golden shares would protect companies from hostile takeovers, especially from international bidders. This strategy is also true for public companies, allowing them to retain control of their interests in the face of competitors.

Queen Elizabeth II, Britain's longest reigning monarch, had a net worth of U.S. \$442.92 million (£340 million) with her fortune and assets set to be passed down to her son King Charles III, according to *'Business Insider'*. [ In numbers this = \$442,920,000,000 ]

An article published by the *'Business Insider'*, said her net worth, according to a 2016 estimate by *'The Sunday Times'* "is vastly more than any other member of the Royal Family, including the Duke and Duchess of Sussex, who have a shared fortune of \$30 million."

However, the assets the queen owned technically belong to the "Royal Firm," also known as "Monarchy PLC," and the sovereign doesn't have the right to sell any of them, including the palaces, to make a profit, as pointed out by the Business Insider.

According to *'Forbes'*, the Crown, through the "Firm," holds nearly \$28 billion in assets. These assets include the following: the Crown estate, worth \$19.5 billion; Buckingham

Palace, worth an estimated \$4.9 billion; the Duchy of Cornwall, valued at \$1.3 billion; the Duchy of Lancaster, worth \$748 million; Kensington Palace, estimated to be worth of \$630 million; and the Crown Estate of Scotland, worth \$592 million (all in U.S. dollars).

Here's a partial breakdown of the late queen's assets during her 70 years of reign that also acted as a source of income for her and the Royal household.

#### The Crown Estate

HRH King Charles III is now the owner of the Crown Estate, which is a corporation that manages a collection of properties and lands that belong to the sovereign, according to the U.K. government website.

*"The business generates valuable revenue for the government and over the last 10 years has contributed £2.6 billion,"* the government states.

However, the King is not involved in the estate's management, according to The Crown Estate website.

*"It is not the private property of the monarch — it cannot be sold by the monarch, nor do revenues from it belong to the monarch,"* it says. Rather, the ability to sell and the revenues belong to the Crown Estate.

The Crown Estate portfolio *"has a value of over £7.3 billion, from beef farms in the north of Scotland to Portland stone mining in Dorset,"* the Royal Family's website says.

When it comes to official duties, like public outings and events, the Royal Family is funded by what is known as the Sovereign Grant.

The Sovereign Grant is supported by the government and covers costs of royal travel, communications and information, and the maintenance of all royal palaces, according to the website.

A percentage of the profits from the Crown Estate revenue go into the Sovereign Grant.

#### Privy Purse and Duchy of Lancaster

The royals have private sources of income outside of the publicly funded Sovereign Grant. The Duchy of Lancaster is one such source, which belongs to the sovereign.

The Duchy of Lancaster contributes to the queen's — now the King's — private income and is used to pay for costs that the Sovereign Grant does not cover, including both official and private spending by the monarch.

According to the Royal Family website, the *"Privy Purse"* *"is a historical term used to describe income from the Duchy of Lancaster."*

The Duchy of Lancaster is a portfolio of land, property, and assets that belong to the reigning sovereign as Duke of Lancaster since 1399, according to the Duchy of Lancaster website.

It is not to be confused with the Duchy of Cornwall, which provides an income for the heir to the throne, the Prince of Wales — now William.

*“While the two Duchies have similarities, the management and control of the Duchy of Cornwall is entirely separate to that of the Duchy of Lancaster,”* the duchy’s website states.

According to *‘Business Insider’*, *“the Lancaster estate generated revenue of £24 million (about US\$28 million) last year, its financial records state, and the King is now entitled to its income.”* Think of it as pocket change for HRH Charles!

*“It had assets worth more than £650 million (\$754 million) at the end of March this year, the duchy’s website states. A law passed in 1702 forbids the monarch from selling any of the assets,”* the report added.

In 1993, the queen chose to pay income and capital gains tax on the estates, and according to *‘Business Insider’*, *“Charles may decide to follow suit.”*

Other than the Queen’s Privy Purse, Elizabeth II also owned the Balmoral and Sandringham Estates, which were passed down to her from her father.

What the queen didn’t own, however, are the official royal residences, most of the art in the Royal Collection, and the Crown Jewels, the Royal Family website points out. These expensive items cannot be sold and are to be passed down to her successor.

The Royal Family website outlines that the sources of funding, be it public or private, are *“used entirely to support The Queen’s work (now King’s) as Head of State.”*

*“This means that the money goes towards a number of resources that enable Her (His) Majesty to carry out her(his) official duties,”* it added.

These include royal travel for official engagements in the U.K. and overseas; the maintenance of royal residences, and salaries for employees of the Royal Household on top of what’s provided by the sovereign grant.

Charles as King inherited the assets of his mother and received them tax-free, but it’s not known what other royal members will inherit from the queen.

If her other children and family do inherit anything, they’ll be subject to the U.K.’s 40 per cent inheritance tax, according to Willful, a Canadian company that provides online estate planning service.

*“The rest of the contents of her will are likely to remain a secret — especially after Prince Philip passed away in 2021 and his will was sealed for 90 years,”* said the company told Global News in an email.

According to Stewarts, a U.K. law firm, *“royal wills have a long history of privacy, dating back to 1822.”*

*“In 1910, the court considered the position of members of the wider royal family, ruling that the will of Prince Francis of Teck, a brother of Queen Mary (consort of King George V), be ‘sealed’ and its contents kept private from the general public,”* the firm said in a blog.

*“Since then, this practice has become the norm for senior members of the royal family, and more than 30 wills have been similarly sealed,”* the firm added.

Part of a series of amendments being secretly negotiated and set to be put to a vote in late May of this year at the annual World Health Assembly in Geneva, Switzerland.

**The United Nations World Health Organization is secretly negotiating a set of amendments to the International Health Regulations (IHR) that would impose an invasive testing, vaccination and quarantine regimen on international travelers.**

Ongoing negotiations on these amendments were kept secret for more than a year until California researcher and journalist James Roguski uncovered the latest draft version of the amendments in February.

In a recent interview, Roguski said these amendments to the International Health Regulations are not so much an attack on national sovereignty as they are a *“dangerous expression of national sovereignty.”*

Most nations, including the U.S., already claim through various laws to have these invasive powers over their own citizens. What the IHR amendments are about is giving nations these same testing and quarantining powers over foreign nationals who legally enter as a tourist, business traveler or for any other purpose.

Exiting the WHO, as the U.S. did under the presidency of Donald Trump, will also not provide any real answers to this power grab, Roguski explained, stating that *“Unless every nation exited the WHO these rules would still apply.”*

That’s because the enforcement powers for these invasive methods are being given to nations not to exercise over their own citizens but over the citizens of every other country who are entering as foreign travelers.

The proposed amendments would include adding the terminology for so-called conveyance operators, which includes operators of planes, trains, subways, cruise lines, buses, etc.

These operators, both public and private, would have to comply with *“health measures which may include isolation and quarantine as required, for application on board as well and embarkation and disembarkation.”* That means you could be confronted both getting on and getting off of a plane, cruise ship or train, and asked to take a PCR test, or to show proof of vaccination against whatever disease they are looking for.

**Proposed changes to Article 27 of the IHR’s would add the words *“and quarantine”* to the powers already granted at ports of entry.**

*“So, the concern is that if you are traveling, they want to be able to make you take a test, and if you want to get off the cruise boat or plane, they may make you go into quarantine...It essentially says they can compel the traveler to undergo vaccination or other prophylaxis.”*

The next series of meetings for the IHR working group is April 22-26, where they will continue to negotiate, in secret, these draft amendments. The plan is to have them ready for approval by the WHO’s World Health Assembly in the final week of May.

*“In my opinion, adding more authority to nations to quarantine travelers, test and vaccinate people, is very dangerous. Especially with vaccines that don’t work and tests that are fraudulent,” Roguski said.*

He says awareness is key to defeating this power grab.

***“Identify your allies, don’t try to convince anyone who doesn’t want to know. It doesn’t take a lot. Become aware, make your own video, share. 99 percent of people are not going to comprehend the issue, and that’s OK. You’re looking for allies and I’m here to tell you there are millions of us who have had enough.”***

***“They’re trying to have secret negotiations to change international law on the right to quarantine people who travel based on vaccines or tests.”***

On the surface this might not sound so bad. It might even sound good to some gullible ears. But when you realize we are talking about unsafe and ineffective genetics-based vaccines and fraudulent PCR tests, it becomes a tyrant’s dream, and a freedom-lover’s nightmare.

**David Bell, of the Children’s Health Defense group wrote this in regards to the above draconian WHO plan:**

### **'Safe and Effective': CDC Releases Hidden COVID-19 Vaccine Injury Reports**

The agency was forced by a federal judge to disclose the reports.

**The U.S. Centers for Disease Control and Prevention (CDC) has released previously hidden reports of facial paralysis and other adverse events following COVID-19 vaccination.**



The 780,000 reports were received shortly after the COVID-19 vaccines were rolled out and show that people experienced a wide range of post-vaccination problems, including heart inflammation, miscarriages, and seizures.

*“Loss of consciousness and seizure immediately following injection. Went to ER by ambulance,” one person reported.*

*Another stated, “Diagnosed with Bells Palsy today due to left-sided facial numbness and paralysis.”*

People lodged the reports with V-safe, a text-message system created by the CDC to monitor for possible side effects of COVID-19 vaccines.

The CDC, for years, declined to make the V-safe data public, instead publishing [studies](#) that described the reports as providing reassurance about the safety of the vaccines. However, according to data released in 2022, nearly 8 percent of the 10 million users required medical attention or hospital care after vaccination, and many others reported missing school, work, or other normal activities.

That topline data came from check-the-box surveys.

The same judge who ordered the release of that data [ordered the agency](#) in January to disclose free-text entries from a different section in which individuals could describe their experiences. U.S. District Judge Matthew Kacsmaryk, appointed by former President Donald Trump, dismissed the government’s arguments that processing the responses and redacting sensitive information would require too much work.

The first two tranches, made up of 780,000 reports from some 523,000 people, include dozens of reports of heart inflammation, hundreds of reports of facial paralysis, and thousands of reports of tinnitus.

Multiple people said things were so bad that they were struggling with suicidal thoughts. *“For 24 hrs. after [the] shot I was so fatigued I could not stay awake. I also have some very strong suicidal thoughts. Zero appetite,”* one individual wrote.

Another person said they experienced symptoms of an allergic reaction.

*“I read where [sic] this vaccine should not be administered to anyone allergic to PEG and I am allergic to PEG. It would be incredibly reassuring if someone would call me as all I run into is dead ends,”* the individual said.

The free-text portion of the surveys was the only place for people to report adverse events, including heart inflammation, even though the CDC knew the vaccines might cause those events, previously released documents show. Other documents show that the CDC became aware of the vaccines possibly causing myocarditis, or heart inflammation, and a related condition called pericarditis early in 2021 but hid the knowledge from the public.

Judge Kacsmaryk’s order came in litigation brought by the Informed Consent Action Network (ICAN), a nonprofit that has compelled the release of a number of government files since the COVID-19 pandemic started.

*“ICAN had to sue the Centers for Disease Control in order to gain access to the COVID-19 shot V-safe adverse event data, which is yet another shameful chapter in the decades-long history of federal health officials trying to cover up vaccine risks by ignoring patterns of vaccine reaction symptoms in reports made to the government,”* Barbara Loe Fisher, co-founder and president of the National Vaccine Information Center, told The Epoch Times after reviewing the new data.

*“When people report the same symptoms over and over again after getting a biological product—in this case ‘shortness of breath’ and ‘heart palpitations,’ which are both symptoms of myocarditis that has [sic] been causally linked to mRNA COVID shots—the public should be warned, not kept in the dark. It raises questions about what else government health officials are hiding.”*

The free-text entries are not dated. Elizabeth Brehm, an attorney representing ICAN, said the group is seeking the dates of the reports from the CDC. The group does know that the entries are the earliest ones received by the CDC. V-safe was launched as the vaccines were rolled out in late 2020. The rest of the entries are expected to be produced on a rolling basis.

A CDC spokesperson declined to answer many questions, including those related to the dates of entries.

*“V-safe participants who reported that they received medical care after vaccination were called and encouraged to submit a [VAERS](#) report. If they submitted a VAERS report and the adverse events were classified as serious (as defined in the Code of Federal Regulations), CDC attempted to obtain additional information (medical records, hospital records, etc.) about the reported adverse event,”* the spokesperson told The Epoch Times. *“All data collected from VAERS is processed and analyzed for unusual patterns or unusually high numbers of rare and serious adverse events after vaccination.”*

She said the information from VAERS helped detect problems that the agency now acknowledges are caused by the vaccines, including myocarditis.

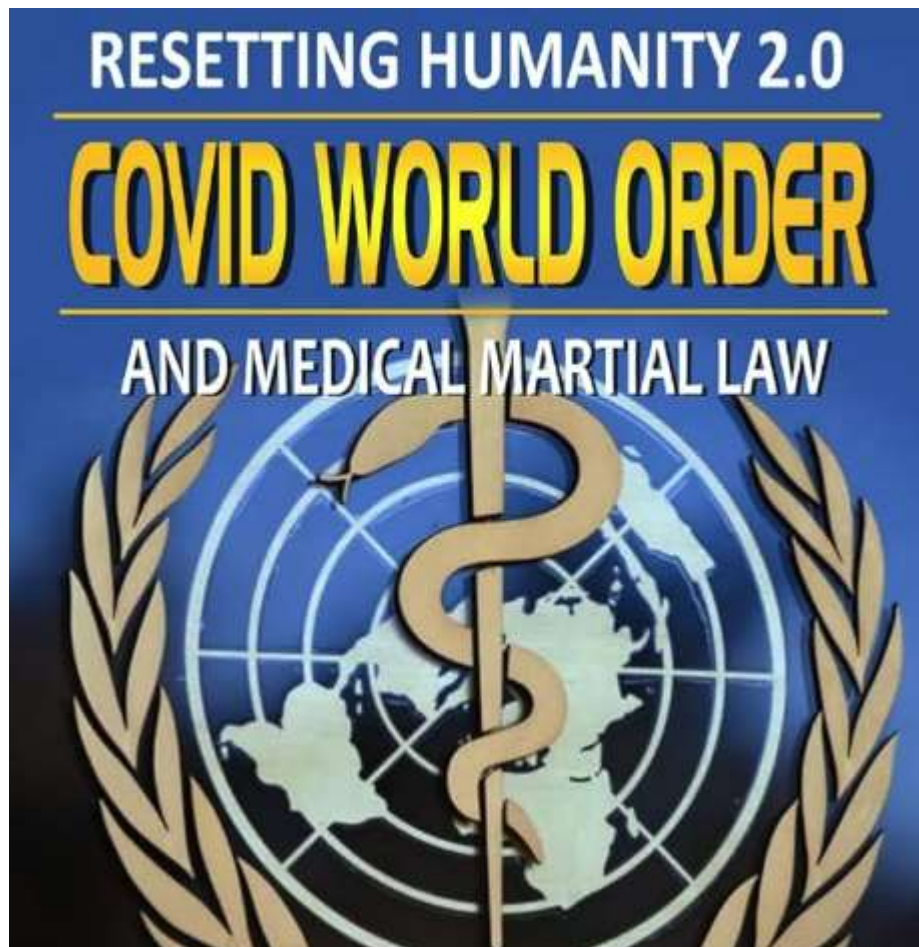
