“As In the Days of Noe”

“And as it was in the days of Noe, so shall it be also in the days of the Son of man.” –(Luke 17:26). The paragraph of Luke 17:22-30 is a specific section which hints to what constitutes the deeper allusions that Jesus was telling His disciples, and likely an inference to you and me about what we are to be watching for when the End Times occurs. We know it is a separate thought and statement by the fact that the verse begins with the word **“And”**, In Greek the word is **“Kai”**, the most frequent word in the entire Bible which is found over **28,364 times**, and **9,269X** in the New Testament.

But before going into the analysis and exegesis of this specific Scripture passage, I want to share some remarks I sent to a fellow brother in Christ who wanted to know if I was still looking at October 28th, 2020 for the Rapture. What I shared with him is relative to my doing a Part 31-E. My comments were to this effect:

“The word "coincidence" does not exist in Hebrew, and the culmination of several significant Biblical events along with the ramping up the global 5G system on October 28th or **Heshvan 10** gets my attention; especially **Heshvan 10** when Noah and family entered the Ark. Also, because of God's change of the calendar, the Resurrection of Christ Jesus was also on **Nisan 17**, as was the Ark coming to rest and Noah and his family leaving the Ark on **Nisan 17**. This “coincidence” is statistically and mathematically beyond chance or accident. This coupled with the significance of **Heshvan 10** suggests it was so much more than coincidence, i.e., but designed as part of a Greater Divine Plan. I have been doing the math on this and the odds of all this to be even greater than what my article **"God's Special Day"** calculates too, I did that article more than ten years ago and posted it about five years ago. The magnitude of zeros is astronomical. The odds of these “seven events” listed below all falling on Nisan 17 defy all human comprehension:

One in 783,864,876,960,000,000

The Bible records many miracles occurring on **Nisan 17**. No other day except Passover is mentioned as often in the Bible. According to the Torah and traditional Jewish sage's interpretation, other events that occurred on **Nisan 17** include the following:

- **Nisan 17**, Noah's Ark safely rested on Mt. Ararat -(Genesis 8:4) [Note that the seventh month was later designated as the first month at the time of the Exodus -\(Exodus 12:2\).](#)
- **Nisan 17**, Hebrews entered Egypt -(Exodus 12:40-41) 430 years before deliverance.
- **Nisan 17**, Moses led the Israelites through the parting of the Red Sea -(Exodus 3:18, 5:3).
- **Nisan 17**, Israel entered and ate the first fruit of the Promised Land -(Joshua 5:10-12).
- **Nisan 17**, the cleansing of the Temple by Hezekiah (eight hundred years after entering the Promised Land. -(2nd Chronicles 29:1-28).
- **Nisan 17**, Queen Esther saved the Jews from Elimination -(Esther 3:12, 5:1).
- **Nisan 17**, the Resurrection of Messiah (think about it). [Hugely significant!](#)

The odds of just two of these events both happening accidentally on the same day of the Hebrew year (360 days) [360 x 360] are one in 129,600. The odds of these seven events all happening coincidentally on the very same Hebrew calendar date above is beyond all mathematical comprehension and I can affirm that all mathematicians would agree to this as being beyond astonishing! They are all related in one way or another to the whole or larger picture. It is doubly significant that there is a collective imagery "theme" of a parallel "Type" of Rapture word-picture!

To refresh those of you reading this Blessed Hope #31-**E**, go back and examine closely Dan Matson's chart. Dan's chart notes the dates of **Heshvan 10** and **Nisan 17** on the visual time line. I find this to be extremely profound when we are seeing the "theme" of "Deliverance before Judgment" revealed in such awesome mathematical terms."

In doing an exegesis of **Luke 17:22-30**, I want to drill down a bit deeper in high-lighting this verse 26 further down, analyzing the Greek text word for word, in light of all the linguistic tools on the table I can draw upon. But first, let's look closer at the larger segment. This passage is a separate thought from within the rest of the chapter context, within a larger context.

17:22. The disciples' desired to see "one of the days of the Son of the man," has been interpreted by some to refer to their longing for "the good old days" with Jesus Christ. However, a better interpretation which fits the context is that Jesus was speaking of their longing for the beginning of the Kingdom Age. "One" (Greek, *mia* from *heis*) can mean "the first of the days." Believers should be longing for that day -(2nd Peter 3:13; 2nd Thessalonians 1:4-10; Revelation 6:9, 10). The term "**the Son of man**" is a messianic term -(Daniel 7:13-14; Luke 6:5; 9:58; 12:40; 24:7; and Matthew 26:64). When Jesus said "**Ye shall not see it,**" He meant that the Kingdom would come only at the appointed time rather than whenever they desired it.

17:23. Believers should not follow those who claim the Messiah is here or there. Jesus likewise predicted in the Olivet discourse that false Christs will come -(Matthew 24:24, 26; Luke 21:8). Paul warned believers that the Antichrist will deceive many -(2nd Thessalonians 2:8-12). Prince Charles really has deceived so many! The evidence is there to prove Prince Charles of Wales is Mr. "666" whether you want to believe it or not!

17:24. The coming of the Son of Man (the revelation of Christ, which will follow the Tribulation) will be an open event as lightning which flashes from one part of the heaven to the other, or from the east to the west -(Matthew 24:27). His coming will not be in obscurity as his first coming as an infant or limited to one locally, but all the **"tribes of the earth"** will see Him coming with power -(Matthew 24:30). The apostle John recorded that **"every eye shall see him"** -(Revelation 1:7).

The expression **"His day"** refers back to the "first of the days of the Son of man" -(verse 22). This term is not identical to the **"day of Christ"** -(1st Corinthians 1:8; 5:5; 2nd Corinthians 1:14) which speaks of the Rapture of the Church before the Tribulation period. This day will be part of the **"Day of the Lord"** which is that extended period of time which begins with God's dealing with Israel after the Rapture and extends through the Second Coming (when Christ returns to Earth with His saints who have been raptured), the Millennium, and until the creation of the new heaven and the new earth after the Millennium. The second coming of Christ is referred to as the "Day of the Lord" in Zechariah 14; 1-4.

17:25. The suffering and rejection of the Messiah was not understood by the disciples although Jesus had predicted these events many times. At one time when He predicted His death, they did not understand and were afraid to question Him about it -(Matthew 9:44, 45). When Jesus appeared to them after His resurrection, they doubted that He had physically risen from the dead -(Luke 24:36-43). He reminded them: **"These are the words which I spake unto you, while I was yet with you, that all things must be fulfilled, which were written in the law of Moses and in the prophets, and in the psalms, concerning me"** -(Luke 24:44). This reference is to the three sections of the Hebrew Bible which was composed of the Pentateuch, the Prophetic Books, and the Writings (historical books). This statement of Jesus demonstrates the truth that His death and Resurrection were predicted throughout the Old Testament. Peter later explained that even the Old Testament prophets had difficulty harmonizing the predictions of Messiah's suffering and reigning -(1st Peter 1:10, 11; compare Isaiah 9:6, 7; 52:13; 53:12; Psalm 22).

Jesus said that He would be rejected by **"this generation."** The word "generation" (Greek, **genea**) refers to a race, clan, or to one's contemporaries -(Acts 13:36). In this context the word refers to the generation of Jews then living who would reject Him - (John 1:11). Jesus referred to His generation as an **"evil generation"** -(Matthew 12:39), a **"wicked generation"** -(Matthew 12:45), an **"adulterous generation"** -(Matthew

16:4), and a **"faithless and perverse generation"** -(Matthew 17:17). Has it ever changed? I think not, and so, it has a veiled future meaning as well.

17:26. The next section -(verses 26-33) records our Lord's comparison of the period immediately before His second coming with the days of Noah and Lot. Jesus linked the two together for a purpose. Each of these events was preceded by warning from God, a rejection of God by the wicked, the long-suffering of God, and the judgment of God. There is more on this verse further down. I have extracted it for exegesis by itself apart from the context here in my overall analysis. So what I am doing is first looking at in its setting of **Luke 17:22-30**, and then down a bit further breaking the words down by itself, which is a specific thought within the larger context.

17:27. The indifferent attitude of the people of Noah's day is emphatically expressed by the use of four Greek imperfect verbs without any connectives. A literal translation would read: "They were eating, they were drinking, they were marrying, and they were being given in marriage." This combination of verbs stresses the fact that they were living life as usual, without any concern for the threatened judgment of God.

The indifference of the unsaved in Noah's day continued right up until the very day Noah entered the ark. The Genesis account reveals that God's long-suffering lasted for 120 years -(Genesis 6:3); prophetic number of 120 Jubilee cycles as well. Peter also wrote of this period of time -(1st Peter 3:20). God commanded Noah and his family to enter the ark and He himself shut them in -(Genesis 7:1, 16). The complete destruction of the human race and the world of Noah's day are attested to by the Word of God. Only Noah and his family of eight escaped -(1st Peter 3:20; 2nd Peter 3:4-9).

17:28. The attitude of the world in Lot's day was the same as in Noah's day. The imperfect verbs again emphatically stress the indifference of the people. A literal rendering would be: "They were eating, they were drinking, they were buying, they were selling, they were planting, they were building." The addition of activities from the previous illustration simply stresses the indifference of the people.

Jesus' allusion to eating, drinking, buying, etc., in the days of Noah and Lot was a further means of discouraging people from trying to date the Second Coming. The significance of eating, drinking, and selling was that they were engaged in everyday activities; it was life as normal. This is why Jesus' second coming is described as that of a thief in the night. Jesus' coming will be unexpected because humanity will be carrying on life as normal without considering God.

17:29. The indifference of Sodom continued until the very day that Lot was told to get out of Sodom and was shared by Lot's married daughters and their husbands -(Genesis 19:14). God destroyed them all with fire and brimstone -(compare Revelation 9:17, 18; 14:10; 19:20; 20:10; 21:8). The historicity of this event is emphasized throughout Scripture -(Deuteronomy 29:23; Isaiah 13:19; 49:18; Amos 4:11; 2nd Peter 2:6; and Jude 7). Do not forget God told Lot to get out of town before God destroyed Sodom!

17:30. Similar conditions will prevail when **"the Son of man is revealed."** The verb "revealed" (Greek, **apokaluptō** means "to uncover" or "unveil." The New Testament writers used this word to refer to the Rapture of the Church -(1st Corinthians 1:7; 1st Peter 1:7, 13; 4:13) and to the Second Coming as in this context -(2nd Thessalonians 1:7).

I will deal with Luke 17:26 in greater detail at the close of this segment. [Beginning on page 9 below]. The matter of 5G EMF wireless technology is of such a grave nature, and yet will easily be dismissed casually as insignificant due to the fact it is invisible to the human eye. I assure you it is not an insignificant issue and it may be the very issue that requires God to act in removing the global Church of born-again believers. For twenty years, I have been asking myself, what will be the straw that breaks the proverbial 'camel's back' that would necessitate God's intervention? 5G and its vast satellite network is a global system!

Since I first wrote and posted Part 31-D, the following information has come to light in the past week. This is significant for what are obvious reasons in what is referred to by many scientists and health professions as an **"Extinction Level Event!"**.

President Trump appointed a new FCC Chairman three weeks ago, who is an insider from the telecom industry and will rule on the 27th of October on the side of an industry that has \$2.7-Trillion dollars invested in the wireless "Internet of Things." The two previous chairmen of the FCC were also insiders from the telecom industry. The FCC is a captive agency. It is a prime example of institutional corruption. The wireless industry controls the FCC through a soup-to-nuts stranglehold on Congress. The telecom industry lobbyists spend \$50-million a year to buy congressmen votes. The first thing a congressman or woman does on the day after their election victory is to begin fund raising for his/her next re-election efforts. Because congressmen are elected for 2-year terms, they are in constant need of campaign re-election money. The telecom lobbyists over on J-Street in D.C., buy their votes with campaign donations that few can afford to turn down. This reality bodes ominously for your children mostly.

Cell phones are the cigarettes of the 21st century. Wireless communications is all about big business. It's not about public safety and health; it's all about the corporate bottom line, i.e. profits, and they are really huge profits. 5G wireless technologies will produce \$12.4-Trillion in global economic output yearly by 2030 and produce as many as 22-million jobs. When fully operational it will produce \$250-billion annually, and by 2023 just providing the services, all from their promotional ad plan, AT&T's plan of \$49.⁹⁹ monthly customer fee. Within the next two years, 50,000 5G satellites will be in low-earth-orbit (LEO). They are being launched weekly by AT&T, T-Mobile, Verizon, SpaceX, OneWeb, and Boeing. There is no opt-out of the Space Net. You could not escape it, even if you lived underground.

Even though President Trump says he will make 5G safe, this is not physically possible. A single piece of paper can block a 5G wireless signal, as does dust, rain, snow, fog, humidity, and sea spray. 5G is like a laser pen, a pin-point millimeter narrow beam signal and so it has to be modulated at 35-Ghz and higher in order to function

properly. EMF's higher than 10-Ghz causes DNA damage and other harm to the human body. There is no way 5G can be made safe at the light spectrum used for 5G band width. It is simply impossible and Trump knows it! When people start dropping over from EMF radiation, nobody is going to care; it will be blamed on Covid-19. Since last fall, all those places using 5G have been operating it at a lower modulation, much like a dimmer light switch in your home, but have you ever tried to read by a dimmer light switch at its turn-on point? Not easy or desirable.



Above picture shows five cruise ships being cut-up at a Turkish scrap yard. The three to the right sport the distinctive 5G EMF protective globe covers. Their 5G was installed in 2019.

Carnival Cruise line is selling 2 cruise ships and **selling 16 more cruise ships for scrap metal.** 2019 was the best year for the cruise industry in passengers, so why retire 16 ships to the scrap yards when the cruise industry is so prosperous? They can't keep this bottled up much longer. The date of October 28th has become significant in several ways. All efforts to stop 5G roll out had to be filed by a specific deadline of appeal. **This deadline is October 28, 2020! This date happens to have huge Biblical significance as I have noted above.**

Danger

Here is why 5G built into our electrical system is so dangerous:

- 4G is 7GHZ or less on its energy output.
- 4.5G (4G Plus) is 7-12 GHZ (typical of TSA airport checked bag scanner). Remember, when airport passengers and carry-on bags were scanned, TSA agents quickly in a matter of weeks to months were being diagnosed with cancer.
- 5G is 15-300 GHZ (this is determined by modulation of the controls). At 60GHZ, 98% of lung oxygen is consumed, resulting in instant death. Think of Wuhan, China, 2019.
- At 10 GHZ the human immune system starts to falter, sleep is impaired and healing is minimized.
- At 10-30 GHZ, disorientation sets in, feeling tired, drowsy, and weak, trouble sleeping, dry mouth, dehydration, poor cell turnover and lowered hemoglobin, depression, anxiety and other symptoms of radiation poisoning/ microwave syndrome.
- At 35 GHZ the oxygen molecules in the air and our bodies begin to spin, making it impossible for our hemoglobin to uptake oxygen causing hypoxia or asphyxiation. 75% of healthy people will die in the first 2-3 days of being exposed to 35 GHZ consistently. The healthiest will die within a week.
- At 50 GHZ, nothing survives, including birds, bees, trees, etc.
- At 60 GHZ everything goes up in flames (similar to the wildfires in the US right now in 5G areas).
- They are currently experimenting daily with frequency changes (My body feels every shift) to normalize people's symptoms and exposures so no one notices what is happening. They are experimenting to see how high they can go before people start noticing health issues.
- Many areas where the map shows only 4G or even 3G and yet they have 5G frequencies already pulsing, but modulated at levels of minimum risk.

- They increase the frequencies at night so people sleep poorly, causing a weakened society, and lower it during the morning, increasing again in the afternoon.
- 5G is the most dangerous large-scale and immediate-acting bioweapon in all of history. It was originally developed as a weapons system for the military.
- 5G is the equivalent of having a loaded gun pointed to every single one of our heads, no matter where you live, where you work, what your race, what your social status or how much money or skills you have, you are the mercy of that dial.
- If you have electricity right now, you can be killed in an instant if they blast the frequency through your home at anything over 25 GHZ.

There are 300,000 cell towers across the continental U.S., and everyone is an integral part of the 5G EMF wireless communications network system. There is no opting-out of 5G. The reason for this is related to the blanket of 50,000 low-orbit satellites forming a space fence. It will affect every square-inch of the continental U.S. Same is true in all industrialized nations of the world. The only area of the Earth free of 5G is the sub-Saharan desert and sub-China/Mongolian deserts.

The uber-rich elite have designated 5G safe zones where they can hide out until the culling of the world's mass has been put-down quietly with a silent weapon of invisible wireless energy, and not everyone will experience the same sicknesses. The 3G, 4G, and 5G wireless are of differing types. Each of us has a genetic pre-disposition to one issue or another. Switzerland has several cantons [states] which have forbidden 5G; these are where the world's elite live and control the world. They will ride-out the culling of 7-billion people.

This is the genocide agenda:

- All 5G infrastructure is already in place. Look at receivers already placed on your street lights, smart meters, your electrical outlets and appliances, the towers themselves, rooftop receivers, etc.
- Next is poisoning people with aerosols, and toxic food and water to falsify the second wave.
- Once people are in lockdown, they cannot leave their homes these areas are then easy 5G kill zones.
- The government can choose to increase the frequency anytime they decide and depopulate as much as they want, in any chosen area.
- Unless you are very far off-grid, without any electricity and no neighbors who have it either, you are, as we are, currently sitting in a potential kill zone.
- I have tried reaching out to colleagues, health pioneers and other popular leaders in the natural movement but everyone is afraid to share this as they feel they will be killed immediately and censored to block the sharing of this info.

Now let's return back to the most important passage for our present day and its implications regarding the Rapture.

Luke 17:26:

The most prominent feature of this subunit is its parallelism, drawing an analogy between the "**days of Noah**" and the "**days of Lot**" on the one hand, and "**days of the Son of Man**" on the other. The text is remarkable for the way it lists two series of verbs - in the Greek text even more than in the NRSV or any translation we would refer to, in staccato fashion, without conjunctions to interrupt their cadence - that describe in rhythmic repetition the activities of everyday life that are suddenly interrupted by something quite exceptional and cataclysmic.

God's judgment breaks inescapably, surprisingly, abruptly into the mundane of life. In spite of the proverbial wickedness of the people of Noah's day and of Lot's townspeople -(cf., e.g., Genesis 6:1-8; 18:16-21), such concerns do not at all seem to occupy center stage here. Eating, drinking, marrying, and giving in marriage -(vs. 27) - these are the stuff of everyday life and are not inherently wicked. To these are added commercial practices -(vs. 28), again not problematic in themselves.

Though not intrinsically evil, within their immediate co-text these practices are deemed as potential diversions. And this perspective is fully consistent with the portrayal of such everyday activities as eating and drinking and marrying, as well as of possessions, elsewhere in Luke's Gospel: not inherently bad, but potential distractions from the necessity of one's fundamental orientation toward the purpose of God. With these parallels from Israel's past, Jesus warns His followers about the dangers of the period before the end. This will be a time when life will be easily occupied with the everyday and the urgency of faith will easily be replaced with laxity.

17:26 - "And as it was in the days of Noe, so shall it be also in the days of the Son of man."

17:26 - "καὶ καθὼς ἐγένετο ἐν ταῖς ἡμέραις Νῶε οὕτως ἔσται καὶ ἐν ταῖς ἡμέραις τοῦ υἱοῦ τοῦ ἀνθρώπου"

Term used preeminently of Jesus Christ, as enjoying the supreme love of God, united to him in affectionate intimacy, privy to his saving councils, obedient to the Father's will in all his acts)

of man - ἄνθρωπος (a human being, whether male or female; A. generically, to include all human individuals; B. to distinguish man from beings of a different order, i. of animals and plants, ii. of from God and Christ, iii. of the angels; C. with the added notion of weakness, by which man is led into a mistake or prompted to sin; D. with the adjunct notion of contempt or disdainful pity; E. with reference to two fold nature of man, body and soul; F. with reference to the two fold nature of man, the corrupt and the truly Christian man, conformed to the nature of God; G. with reference to sex, a male II. indefinitely, someone, a man, one, III. in the plural, people, IV. joined with other words, merchantman.

In the above expression **“of the Son”**, I intentionally left off any underscoring so that the reader can see the complexity of translating from Greek to English. In translating the Bible, Hebrew or Greek, it becomes evident the issue is in choosing the appropriate word, since situations arise that become near impossible for the translator to select and use the correct word intended by the author. You may recall how former president Bill Clinton parsed the ‘definition’ of the word “IS” in reference to his relationship with his White House Intern.

Linguistics is the scientific study of language and its structure, including the study of morphology, syntax, phonetics, and semantics. Specific branches of linguistics include sociolinguistics, dialectology, psycholinguistics, computational linguistics, historical-comparative linguistics, and applied linguistics. With all the grammatical tools it still requires the art of our listening to the Holy Spirit to guide the trained language scholar.

When I, or someone else uses the expression “context rules” or “context, context, context” it is to add or to emphasize the paramount importance of translating in the context of the verse, which in turn may require the translator to expand the scope of selecting the nearest meaning to the context of the passage before and after the word of concern.

Without question, there is no perfect translation of the original Greek or Hebrew. Even the revered King James Bible is flawed, unintentionally so, since words, language, meanings, change with the changing culture or population. The KJV Bible stands apart from nearly all translations because the translators did a word-for-word translation; while most modern translations are a thought-for-thought translation. This is a risky practice nonetheless. Every word in a passage has to be translated using the basic principles of: Gender, Case, Voice, Mood, and Tense, as the starting point. That said, we should look at a dictionary to see how it is used in the present day usage.

How we understand this one-syllable word “as” .can have very profound importance. [**καθώς** - **kathōs**]. The first is the Greek alphabet spelling, the second is its English pronunciation.

If it is used as an adverb, examples below:

1. to the same degree, amount, or extent; similarly; equally:
I don't think it's as hot and humid today as it was yesterday.
2. for example; for instance:
Some flowers, as the rose, require special care.

When “as” is used as a conjunction, which it is in the case of **Luke 17:26**, these examples help to clarify its use and understanding in the KJV Bible.

1. (used correlatively after an adjective or adverb preceded by an adverbial phrase, the adverbial as, or another adverb) to such a degree or extent that:
It came out the same way as it did before. You are as good as you think you are.
2. (without antecedent) in the degree, manner, etc., of or that:
She's good as gold. Do as we do.

All that said, we have grammatical and linguistic reasons to infer the contextual passage of **Luke 17:22-30** strongly alludes to and supports a Rapture event of a parallel word-picture to that of the Noah and the Ark; the Israelite Exodus at the Red Sea crossing; and also like that of Lot departing Sodom!

God will undoubtedly outdo anything that Cecil B. DeMille Studios or MGM Studios could ever have imagined. The Rapture is going to be a huge event primarily because God requires the Glory be all His! Here, we report self-assembled quantum dot DNA hydrogels that exhibit both size and spectral tunability. We successfully incorporate DNA-templated quantum dots with high quantum yield, long-term photostability, and low cytotoxicity into a hydrogel network in a single step. By leveraging DNA-guided interactions, we introduce multifunctionality for a variety of applications, including enzyme-responsive drug delivery and cell-specific targeting. We report that quantum dot DNA hydrogels can be used for delivery of doxorubicin, an anticancer drug, to increase potency 9-fold against cancer cells. This approach also demonstrated high biocompatibility, trackability, and in vivo therapeutic efficacy in mice bearing xenografted breast cancer tumors. This work paves the way for the development of new tunable biotemplated nanomaterials with multiple synergistic functionalities for biomedical applications. The development of nanomaterials for imaging and drug delivery has been of great interest to the field. Here, the authors synthesized multifunctional enzyme-responsive hydrogels with self-assembling quantum dots for nucleic acid and drug delivery as well as having imaging capability.
